Pressure mounts, Akbar quits Govt

Defamation suit hearing to begin in Patiala House court today


Facing storm of sexual misconduct allegations against women journalists in his stint as editor of a newspaper, Union Minister of State for External Affairs MJ Akbar on Wednesday resigned from the Council of Ministers saying he was stepping down to "challenge false accusations" leveled against him in his "personal capacity".

The resignation came a day before Akbar's defamation suit against journalist Priya Ramani, who was the first journalist to accuse him of sexual harassment around 20 years ago, is scheduled to come up for hearing in the Patiala House court here.

Akbar first tried to dig in his heels, but with the allegations refusing to die down and even RSS backing the woman journalists, the Modi Government had few options but to give him marching order to contain growing adverse publicity. With the case slated for hearing on Thursday, Akbar would have found it difficult to defend himself in the court in such a sensitive matter in his capacity as a Union Minister.

"I deem it appropriate to step down from office and challenge false accusations leveled against me, also in a personal capacity. I have, therefore, tendered my resignation..." Akbar said.

He expressed gratitude to Prime Minister Narendra Modi and External Affairs Minister

Sushma Swaraj for giving him the opportunity to serve the country.

Akbar's lawyer Sandeep Kapur of law firm Karanjawala & Co said the private criminal

defamation case will come up for hearing on Thursday before additional chief metropolitan

magistrate Samar Vishal.

The lawyer also forwarded the brief resignation letter of Akbar who was associated with several media houses in the past.

Kapur said since the matter is subjudice, the law will take its own course.

"Since we have already filed the defamation case, we will pursue it in the court," he said.

Akbar on Monday had filed the criminal defamation complaint against Ramani alleging she "willfully" and "maliciously" made imputations against him with the ulterior motive of maligning his reputation and political standing.

As Akbar took the first step of filing the legal case, 19 women journalists who have worked with him in the past came out in support of their colleague Ramani.

The journalists have urged the court to hear their testimonies against Akbar, claiming that some of them suffered sexual harassment by the Minister and others have been a witness to it.

"Ramani is not alone in her fight. We would request the honourable court hearing the defamation case to also consider the testimonies of sexual harassment of some of us at the hands of the petitioner, as also of the other signatories who bore witness to this harassment," the journalists said in the joint statement under-signed by them.

"What Akbar has demonstrated through his legal actions is his refusal to introspect, acknowledge or atone for his actions that have caused immense pain and indeed harm to many women over the years.

"He himself, in the mean-

while, continues to enjoy enormous power and privilege as Minister and Member of Parliament," the statement said.

"When Ramani spoke out against him in public, she spoke not only about her personal experience, but also lifted the lid on the culture of 'casual misogyny, entitlement and sexual predation' that Akbar engendered and presided over at newspaper," it said.

The Akbar versus women journalists legal battle is set for a long haul as the cases are spread over to two decades. Ramani on Monday asserted that she was ready to fight the defamation complaint filed against her, and expressed disappointment over the Minister's statement, saying it paid no heed to the "trauma and fear of the survivors".

"I am ready to fight the allegations of defamation laid against me as truth and the absolute truth is my only defence," she had said.

The Congress termed as "victory of truth" the resignation of Union Minister MJ Akbar following charges of sexual harassment against him.

Congress spokesperson Priyanka Chaturvedi said she saluted those women who stood on their charges against the Minister bravely despite the "brazen" stance taken by the Government.

"This resignation is a vindication of the power of truth. More strength to India's women," she said.

Violent protesters stop women's entry in temple

Despite SC verdict, women fail to enter Sabarimala in face of local resistance

Amid massive protest and violent clashes, no woman from the "banned" age group could enter the hallowed precincts of Sabarimala temple when its gate opened on Wednesday evening for the first time since the Supreme Court allowed women of menstrual age to enter the shrine. "No girl or woman in the age group of 10 and 50 has so far visited Sannidhanam (the temple complex) so far," said a

senior official of the Travancore Devaswom Board, the body which manages the shrine.

Vastly outnumbered, police officials could do little to enforce law and order situation as protesters turned violent and roughed up journalists and pelted stones at the cops. Women journalists were heckled and their vehicles smashed. Young female Ayyappa devotees turned back as hordes of protesters besieged the road leading to the hill-top temple, abode to Lord Ayyappa, its eternally celibate deity, officials said.

The protesters enjoy political backing as both the Congress, the main Opposition party in Kerala, and the BJP, which is desperately seeking to expand its footprint in the State, have lent support to the agitation against the Supreme Court verdict.

Through the day, the road leading from Nilackal, the gateway to the shrine, to Pamba in the foothills from where the devotees start the arduous trek to Sabarimala, protesters and policemen fought pitched battles. Several protesters were seen being bundled into police vehicles, while siren blaring ambulances carried some to hospitals.

The protesters also raised slogans against the Left Front's Kerala Government incensed as they were with its decision not to file a review plea against the Supreme Court's September

28 landmark order. Simmering tension prevailing in Nilackal since morning erupted into raucous rowdiness as scores of activists of fringe groups heckled women journalists of at least four national TV channels and vandalised their vehicles.

National TV showed protesters wearing black and saffron turbans running after their cars, violently pounding and kicking the vehicles in a bid to stop them from proceeding to Pamba from Nilackal on way to Sabarimala.

At least 10 people from the media, including reporters and photojournalists, were injured and equipment of several of them damaged, senior Minister EP Jayarajan said.

Denouncing the attacks on media, he said cases were being registered against the suspects under sections relating to non-bailable offences. News agency PTI reported that unfazed by the unfolding violence, Madhavi, a gutsy woman from Andhra Pradesh in her 40s, tried to climb the Sabarimala hills to reach the Lord Ayyappa temple but was forced to return to Pamba, menaced by agitated male devotees.

Liby, a woman from Kerala's Alappuzha, also in the "banned" age group, was prevented from proceeding to Sabarimala at Pathanamthitta bus terminal. She was escorted to safety by police.

Titli toll mounts to 52; Property damages ₹2,200 crore | Full report to be prepared in 3 days: CS

As many as 52 persons have died and 10 others are still missing due to landslides and drowning in floodwaters triggered by the Cyclonic 'Titli' that hit the Odisha coast on October 11.

This was revealed at a review meeting held under chairmanship of Chief Secretary Aditya Prasad Padhi at the State Secretariat on Wednesday. The Chief Secretary reviewed progress of relief operation and restoration works. As many as 39 persons died in Gajapati district, 12 in Ganjam and one in Kandhamal. The Chief Secretary said the overall damage has been estimated at Rs

2,200 crore in three districts, Ganjam, Gajapati and Rayagada. Road damages have been estimated at Rs 500 crore, electricity infrastructure damages at Rs 133 crore, house damages at Rs 150 crore and crop damage at Rs 233 crore. A final report regarding the damages would be prepared within three to four days and assistance would be sought from the Centre accordingly, Padhi said. It was revealed that 95 per cent of damaged roads have been repaired. All embankment breaches and all 172 canal breaches have been repaired. Similarly, 6,97,000 of the 9,34, 493 affected consumers have been provided electricity

connectivity. A total of 52 mobile health units and 49 medical relief camps are working in the affected districts. As many as 153 veterinary doctors and 544 health assistants have been sent to the affected districts where a total of 599 animal health camps are working. Four Armymen booked for 2015 hospital rape

Army sets up CoI to look into divyang's complaint

Four Army officials were booked for allegedly sexually assaulting a 34-year-old speech-and-hearing impaired woman employee of a military hospital in Pune in 2015. Besides police investigation, the Army has instituted a Court of Inquiry (CoI) to ascertain the facts. The four accused worked in the same hospital where the woman was posted. The alleged incident took place between January and June 2015 at the Military Hospital Kirkee in Pune's Khadki suburb. The woman was working there since 2014. According to the woman's complaint, she was on night duty (at the hospital) when she was allegedly sexually assaulted by one of the accused, who at the time was posted at the hospital.

When the victim told another personnel about the incident, he reportedly initially told her that he would reprimand the "accused." "But, he



too sought sexual favours from her by threatening her to make the message viral, and allegedly raped her. After some days, two more personnel approached the woman and allegedly took advantage of her," the police said, according to PTI. The woman, a class IV employee at the hospital, had approached an NGO in Indore earlier this year. The NGO subsequently approached the Indore police. On Tuesday night, the Indore police informed their Pune counterpart about the matter, who have registered a case against the four Army officials under IPC Sections 376 (rape) and 354 (molestation), he said. Army Southern Command officials said they were conducting investigation into the matter, adding that the court of enquiry was initiated well before the police complaint was registered.

Mitra apologises for remarks against Odisha

Delhi-based journalist Abhijit Iyer Mitra, who was arrested after making derogatory remarks against the Konark Sun Temple and Odia culture, has apologised for his act and said that as being summoned he would appear before the State House Committee on October 23.

Odisha Assembly on October 23." He also "unreservedly" apologised for his "nasty" comments against Chief Minister Naveen Patnaik, the CM's office and members of the Odisha Assembly saying that he was under "immense stress" at that time. "I've always held Odisha in high regard. One of the reasons I visited was to look at (the State's) history and contributions to Indian culture. If you read my research writing, a lot of it is always praising Odisha. My Twitter account is more for fun, not professional," Mitra added. The Assembly Speaker had on September 28 constituted a House Committee to probe the derogatory remarks by Mitra against Odisha, its culture and the MLAs.

The committee headed by Leader of Opposition Narasingha Mishra had issued notice to Mitra to appear before the panel on October 11 for breach of privilege of the MLAs. He failed to appear, following which another notice was sent to him for appearance before the committee on October 23. Two FIRs have been registered against Mitra at the Konark and Saheed Nagar police stations under different Sections of the IPC. He was arrested on September 20 by the Odisha police in Delhi. Later, he was granted bail till October 5 by a Delhi court, which directed him to cooperate in the probe. The Supreme Court on October 4 had, however, refused to grant him bail.

₹5.5L brown sugar seized, 1 held in city

A special squad of the Excise Intelligence and the Enforcement Bureau seized brown sugar worth Rs 5.5 lakh from a person at Khandagiri Square here on Wednesday. Mahasaptami observed with religious fanfare

As Maa Durga worshipped at 2,600 pandals across State

Durga Puja has gripped Odisha with over 2,600 attractive pandals erected at different locations. While the sky is being reverberated with 'chandi paath' during day time, the night is dazzled with colourful lights and huge crowd visiting the pandals to have darshan of Maa Durga and enjoy the festival with friends and family members. The Mahasaptami Puja of Goddess Durga was conducted at pandals with spiritual fervour on Tuesday and the Mahastami rituals started on Wednesday. The devotees are

found rushing to the pandals to seek blessings of the deity during 'Sandhi Puja' (transition period between eighth and ninth day of Durga Puja), which is the most significant period for the devotees, who have been on fasting. This year, the puja pandals are decorated with unique themes in Bhubaneswar and Cuttack twin city. While budget for decoration and festival at major puja mandaps has been estimated between Rs 30 lakh and Rs 35 lakh each in the State capital, the puja is being held at small pandals at expenses of Rs 5 lakh. Total Rs 50 crore has been spent in 326 puja mandaps in Cuttack and Bhubaneswar. Remaining 2,300 puja mandap committees have spent Rs 115



crore each. If the budget of all the puja mandaps will be taken into account, it is believed to have crossed Rs 170 crore this year. In Bhubaneswar, the Durga

Puja is being held at 176 Puja Mandaps at expenses of Rs 30 crore. The 'Chandi Medha' at Sahid Nagar is the special attraction in the city. Maa Durga is being worshipped at 160 fabulously decorated puja mandaps in silver city of Cuttack at expenses between Rs 27 crore and Rs 30 crore. The city remains in the top with 'Chandi Medha'. The puja is being conducted at 104 mandaps in Rourkela. Baleswar tops the State in terms of districts organising the mega festival at highest numbers of 290 mandaps, followed by Ganjam with 193 mandaps. In Kendrapara, the Durga Puja is being celebrated at 165 mandaps at expenses of Rs 5 crore. Nuapada district is organising Durga Puja at 90

mandaps and Nayagarh at 81 mandaps. Similarly, the Goddess Durga is being worshipped at 93 pandals in Kalahandi, 73 pandals in Puri, 149 pandals in Jajpur, 61 in Keonjhar, 45 in Dhenkanal, 55 in Bhadrak, 46 in Angul, 22 in Khordha, 32 in Sundargarh, 29 in Gajapati, 91 in Balangir, 70 in Jagatsinghpur, 33 in Kandhamal, 54 in Sambalpur, 91 in Jharsuguda, 102 in Bargarh, 59 in Subarnapur, 13 in Boudh, 40 in Nabarangpur, 55 in Koraput, 26 in Rayagada, 100 in Mayurbhanj and 10 in Malkangiri districts. Besides, the nine-day-long Navaratri festival, which is an important feature of Durga Puja is being celebrated at temples and houses across the State with much fervour.

Kolkata girl lured to Konark for job, gangraped

Police on Wednesday rescued a young girl, who was kept captive in a room in the Konark Market Complex, just two km from the Sun Temple. DESPITE SEXUAL SLUR AGAINST FATHER Nandita to continue to back #MeToo move

Breaking her silence over the sexual harassment allegation against her father noted painter Jatin Das, actor and director Nandita Das has said she will continue to support the #MeToo movement. However, the painter refuted the allegation terming it as "ridiculous and vulgar."

2019 POLLS CPM to align with Cong against BJD, BJP



'MeToo' makes more news than Cyclone 'Titli'

Sometimes, it is evident that social media people write irresponsibly. There is big news now in print and electronic media that former journalist and present Union Minister MJ Akbar has employed a whopping 97 lawyers to fight against an accuser woman active on the 'MeToo' whirlwind which has turned out to be much more fierce than the Cyclone 'Titli' which blew over parts of Odisha just a week ago. The fact is Akbar has employed only two of the 97 lawyers at work in the law firm engaged to fight for him. The 'MeToo' campaign is a recently-witnessed phenomenon in India although it had started in 2006 by one Tarana Burke, a social activist and community organiser in the United States. She had begun using the phrase "MeToo" on the popu-

lar 'Myspace' social network to promote "empowerment through empathy" among women who have experienced sexual abuse, particularly within underprivileged communities especially after a 13-year-old girl confided to her that she had been sexually assaulted. She made a documentary film titled 'MeToo' then and the expression became madly popular. Later in October 2017, Alyssa Milano, an American actress, liberal activist and former singer encouraged using the phrase as a hashtag to help reveal the extent of problems with sexual harassment and assault by showing how many people have experienced these events themselves. On October 15, 2017, shortly after The New York Times and the New Yorker published their initial investigations into the allegations of monstrous behaviour by Harvey Weinstein, the actor Alyssa Milano sent out a Tweet: "If you've been sexually harassed or assaulted, write 'me too' as a reply to this tweet." That very suggestion sparked 67,000 replies and expanded the movement instantly. And the expansion, in turn, subjected #MeToo to the familiar physics of American politi-

cal entropy. The movement Burke had created about the survivors of sexual violence soon stretched far beyond sexual harassment and assault in purview: celebrities, and pay disparities, and power structures, and whisper networks, and affirmative consent, and the myriad ways American culture has dreamed up to tell the marginalised that their rightful place remains in the margins. Soon, millions of people started using the phrase across the globe and the purpose changed and expanded to mean different things to different people today. Tarana, however, is keen to return to the original, and specific, purpose of 'serving as a counter to sexual violence'. Tarana Burke says emphatically that the seismic power of women is immeasurable. A 2017 poll by the ABC News and The Washington Post also found that 54% of American women report receiving "unwanted and inappropriate" sexual advances with 95% saying that such behaviour usually goes unpunished. Others state that #MeToo underscores the need for men to intervene when they witness demeaning behaviour. Burke says sexual violence is usually caused by someone

the woman knows; so, people should be educated from a young age they have the right to say 'no' to sexual contact from any person, even after repeat solicitations from an authority or spouse and to report predatory behavior immediately. Burke says the current purpose of the movement is to give people the resources to have access to healing and advocates for changes to laws and policies, highlighting goals such as processing all untested rape kits, re-examining local school policies, improving the vetting of teachers, and updating sexual harassment policies. She has called for all child right education professionals to be fingerprinted and subjected to a background check before being cleared to start work. Burke supports the #MeToo Bill in the US Congress which would remove the requirement that staffers of the federal government go through months of "cooling off" before being allowed to file a complaint against a Congressman. A more aggressive Milano states a priority for #MeToo is changing the laws surrounding

sexual harassment and assault, for example, instituting protocols that give sufferers in all industries the ability to file complaints without retaliation. She supports legislation making it difficult for publicly traded companies to hide cover-up money from their stockholders and would like to make it illegal for employers to require new workers sign non-disclosure agreements as a condition of employment. 'MeToo' has triggered some policy-based changes too in the domains of managerial oversight; creating clear internal reporting mechanisms; more effective and proactive disciplinary measures; and creating a culture that encourages employees to be open about serious problems. In France, a person who makes a sexual harassment complaint at work is reprimanded or fired 40% of the time while the accused person is typically not investigated or punished. In the US, a 2016 report from the Equal Employment Opportunity Commission states that although 25-85% of women say they experience sexual harassment at work, few ever

report the incidents, most commonly due to fear of reprisal. There is evidence that in Japan, as few as 4% of rape victims report the crime, and the charges are dropped about half the time. A spreadsheet from the United Kingdom called "High Libido MPs" and dubbed "the spreadsheet of shame" was created by a group of male and female parliamentary researchers and contained a list of allegations against nearly 40 Conservative MPs. It is also rumoured that party whips maintain a "black book" that contains allegations against several lawmakers that can be used for blackmail. When it is claimed a well-known person's sexual misconduct was an "open secret", these lists are often the source. In the wake of #MeToo, several private whisper network lists have been leaked to the public. In India, a student gave her friends a list containing names of professors and academics in the Indian university system to be avoided. The list went viral after it was posted on social media. In response to criticism in the media, the authors defended themselves saying they were only trying to warn their friends, had confirmed every case, and several victims from

the list were poor students who had already been punished or ignored when trying to come forward. The main problem with trying to protect more potential victims by publishing whisper networks is determining the best mechanism to verify allegations in a way that is fair to all parties. Some suggestions have included strengthening labour unions in vulnerable industries so workers can report harassment directly to the union instead of to an employer. Another suggestion is to maintain industry hotlines which have the power to trigger third-party investigations. Interestingly, it has been noted that 1 in 6 men have experienced sexual abuse of some sort during their lives and often feel unable to talk about it. Tarana Burke and others have asked men to call out bad behaviour when they see it or just spend time quietly listening. Some men have expressed the desire to keep a greater distance from women since #MeToo went viral because they do not fully understand what actions might be considered inappropriate. For the first few months after #MeToo started trending, many men expressed difficul-

ty in participating in the conversation due to fear of negative consequences. So, it seems in India people including those in media are more interested in sensation than the primary objectives of the movement started by Burke in 2006. They find it easy to become prominent by pulling in celebrities and dignitaries the moment their names crop up on the wrong foot. Akbar, celebrated artist Jatin Das or a big number of male cinema stars may have erred in conduct, but the girls young or not so young are only engaging in shameful acts of shaming males only to provoke people to lose trust in the male species, believably to gain publicity apart from settling old scores. Yes, it's true they have gained courage to speak up when a safe mechanism came in handy, but some of the self-proclaimed preys might find it extremely difficult to bring the predators to book for lack of acceptable evidence. All the same, the 'MeToo' campaign is certain to make the 'womankind' a lot safer amid predators masquerading as saints, from hence. DURGA PUJA Animal sacrifice still a part and parcel

Despite ban in State

The Shakti Puja and Durga Puja celebrations are as old as the State's cultural heritage. During autumn, which falls in the month of Aswina, Durga Puja is celebrated all over the State with local variations. On the occasion, the deity is worshipped in Shakti shrines either as Ghata or Kalasa or in the form of earthen statues, called the 'Murmayee Pratimas' in several parts of the State. Usually, the celebration goes about for 10 to 16 days in prominent Shakti Peethas with strict Hindu rituals and traditions while it is held in fascinating puja pandals for 4-5 days in urban and rural areas. Amid these rich traditions, a cruel ritual that still accompanies the celebrations is the

brutal sacrifice of animal, which has been banned by the Orissa High Court since the year 2002. Despite the ban and a mass awareness drive against the cruel practice, animal sacrifices are made at several Shakti Peethas. On Tuesday, therefore the practice was held. Superstitious people find it hard to adhere to the ban on animal sacrifice. Historic evidences suggest that Shakti Puja or Durga Puja celebrations are going on for more than 100 years. Shakti Puja gained importance in the erstwhile State of Kalinga, which led to the mushrooming of a number of other Shakti shrines throughout the State. Historical data reveals that Durga Puja was celebrated since Ganga dynasty. Chodaganga Deva held the puja. However, the puja celebrations have immensely developed in Odisha since 16th

century. The arrival of the Bengali community during British rule gave a further impetus to the celebrations, informed historian Dr Bholanath Rout. Shakti shrines also act as the socio-cultural centres of the people in the State. Odisha has at least eight famous shrines and each one maintained its own independent identity, besides having all the incarnations of Devi Durga. The various forms of Shakti that are being worshipped in these shrines include as Bhagabati in Banapur, Biraja in Jajpur, Bimala in Puri, Mangala in Kakatpur, Sarala in Jhankad near Tirtol, Charchika in Banki, Sameleswari in Sambalpur and Hingula in Brahmapur. According to historians, goddess Biraja at Biraja Kshetra in Jajpur district and Maa

Bimala placed inside the famous Jagannath temple at Puri are the oldest deities of Goddess Durga in Odisha. Goddess Durga is considered to be an embodiment of the supreme divine power. People believe that Durga saves her devotees from danger, distress, difficulty, calamity, sorrow, obstacles, misfortune and fear and reincarnates to destroy the evil. Mythological stories related to the Goddess are depicted in the Vedas and Upanishads, the Ramayan, the Mahabharat, the Haribansa, the Srimad Bhagavat Gita, the Markandey Purana and the Chandī Saptasati, etc. These books speak of Maa Durga's triumph over demons, vices, evils, and how she restores peace, order and Dharma on earth. Artisans, blacksmiths, carpenters, and goldsmiths worship their instruments and

take rest during six days of the festival. On the day of Asvina Sukla Saptami, the idol is installed on Maha Ashtami when an animal or a bird is sacrificed or a Kushmanda (water gourd) is offered. On Dashami also called Bijaya Dashami after performing puja, the idol is immersed in river. One Keshaba Mohapatra from Raghunathpur area in Jagatsinghpur district moved court filing a PIL for a complete restriction of animal sacrifices at Sirlo Pittha where thousands of animals are killed during Durga Puja. Adjudicating the petition in the year 2002, the Orissa High Court had intervened in the matter and directed to stop the animal sacrifices in Sirlo Peetha and several other Shakti Peethas where inhuman practice had been running during Durga Puja.

IN BHAWANIPATNA Animals sacrificed at Chhatar Jatra

Defying restrictions imposed by the local administration, devotees sacrificed a large number of animals during Chhatar Jatra of Goddess Manikeswari here on Wednesday. The ceremonial Chhatar of the goddess was taken out in a procession to the Jena Khala on the outskirts of the Kalahandi district headquarters town from the Manikeswari Temple in the morning after performance of secret rituals. The return journey of the Chhatar to the temple is known as Chhatar Jatra. During the ceremony, thousands of devotees carry out animal sacrifice every year with a belief of fulfilment of their wishes by the goddess although the administration has restricted the practice since long ago.



JAJPUR GIRL HARASSMENT NHRC asks SP for action against IIC

The National Human Rights Commission has asked the Superintendent of Police, Jajpur to take appropriate action within eight weeks against Kaliapani police station IIC Jubaraj Swain for harassing a minor girl. The NHRC issued the order considering a petition filed Human Rights Watch Secretary Sangita Swain in this regard. In her petition, Swain alleged that the IIC has humiliated a minor girl, Rajashree Das of Koliposi, mentally and physically and a complaint filed in that regard on May 26, 2018 was yet to be registered. Though the FIR was given to the SP and the DGP, no action has been taken against the IIC. Arguing that the IIC has violated human rights of the girl by not registering a case Swain had urged the NHRC to direct the Odisha police to take criminal action against the IIC and order for payment of compensation of Rs 5 lakh to the girl.

Noisy pujas in S'pur houses raise eyebrows

This is to redeem sin of ill-gotten money!

It is seen that some individuals, particularly businessmen, are performing Navratra puja in their houses with ear-splitting chanting of Chandī patha and Durga stotra through loudspeakers. But neighbours who know

them well have raised eyebrows at their pious activities. "My daughter works with the person who is my neighbour and a civil contractor by profession. But the same person pays my daughter just Rs180 a day against the minimum wage of Rs 250 as fixed by Government of India. By cheating us, he is celebrating

Durga Puja. Maa will never get satisfied with these persons or their Puja," a local slum dweller said. It is further a difficult affair to translate what the old man exactly said. At the same time, he further said: "Even if we can't spend lakhs of rupees for Puja but Maa is sure to be satisfied with a flower from our hands. We are satisfied that we have not hit anyone's belly (livelihood) but our labour makes other rich and we always struggle to earn a good living

"The people indulged in illegal and corrupt works realize that what they are doing is wrong. They are sure that they commit mistakes and thereby cheat innocent people. And in order to redeem their sin, they do Puja," Prof Panda said in spite of hard labour."

But Dr Dillip Panda, an eminent economist cum social scientist, said that this is totally sick mindset of corrupt persons for showy reasons only. "The people indulged in illegal and corrupt works realize that what they are doing is wrong. They are sure that they commit mistakes and thereby cheat innocent people. And in order to redeem their sin, they do Puja," Prof Panda said. "Further by doing all these, they get also public appreciation and also support from their bosses to earn more. But

this is nothing but guilt consciousness of such people with backgrounds of wrong doings," he commented. But Pandit Amar Mishra said people with such dubious backgrounds can never save themselves by Puja to the mother; and she doesn't like the offerings of wrong doers. "One day or other they have to face the consequence of their misdeeds and sins. As one sows, so one reaps. Hence, they can't be saved and the mother will never excuse them," Mishra asserted.

'Odisha needs to harness alternative power sources'

The Indian power sector is facing a lot of challenges and hurdles. Investment is a key issue so far as development of new plants and upgradation of existing power stations is concerned. In an interview, former Director of State PSU Miraj Mishra talks to *The Pioneer*. Excerpts:

What is the present power scenario in Odisha, good or bad?
MK: (Laughs) It is neither good nor bad, rather I will tell its progressing in a positive way in a slow manner and the speed needs to be carried up by some expert planning and workouts.

Odisha is first in energy reforms. Are you satisfied with the condition and out-
Till now, we have not made any major power pro-

jects and most of the villages are not electrified also?
MK: Yes, you are right, we were trying for Sindhol project, but it was a failure. May be, due to lack of proper planning and political interest. It is practically difficult in Odisha in particular to make a major power project, due to problems in rehabilitation and finance. It is now call of the day to have alternative energy from solar, wind and biomass etc. It will take little long time to have all the villages electrified and the Government needs to boost up taking help of REC, NHPC and other public sector organizations.

What is your suggestion then?
MK: The Government should form a research cell, taking some power sector experts which will only concentrate on harvesting green energy in line with AHCC, Roorkee.

We are facing power cut and power shortage in Odisha; how to improve the conditions?
MK: As the environment is changing, affecting condition of reservoir and the power stations are old enough. We need to improve our generations by retreating the reservoir and renovating all the old power stations. It is high time to harvest from solar and wind in a big quantity. Form the T and D side all the grid substations and distribution networks are old enough. Though efforts are made to make new grid substation, all the assets and equipment in old substation must be replaced. All 33 KV lines and 11 KV lines should be replaced by underground cables. A proper plan must be made for this.

10 artists die in SUV-truck crash in Nuapada

As many as 10 persons, including four women, lost their lives after an SUV by which they were travelling collided head-on with a truck on NH-35 near Silada in Nuapada district late on Tuesday night. The tragedy took place at around 2 am when a group of ten artists hailing from Chhattisgarh were returning from Konna in Nuapada district after performing Bhajan at the Vaishno Devi temple on the occasion of Durga Puja. The ill-fated car and the speeding truck collided leaving all the ten persons dead on the spot. The impact of the accident was so severe that the SUV got severely mangled. The driver of

Police and Fire Services personnel reached the spot and recovered the bodies from the damaged vehicle. The bodies were sent to the Nuapada District Headquarters Hospital for postmortem.

JUVENILE IN JAIL FOR 14 YEARS

Petitioner submits age proof to NHRC | Seeks ₹28L aid for victim

Radhakanta Tripathy, a petitioner, who brought the issue of a juvenile being kept in jail for 14 years in Nayagarh district to the notice of the National Human Rights Commission, submitted a rejoinder to the commission recently in support of the victim's age proof.

Tripathy, a Supreme Court lawyer and rights activist, alleged that the district administration and jail staffs were responsible for keeping a minor boy, Bulu Biswal, along with other regular prisoners in a jail instead of sending him to a juvenile home and, thereby, causing harassment and torture to the victim.

The NHRC sought an action taken report (ATR) from the DGP and Women and Child Welfare Department

Secretary in the matter.

In response, Nayagarh had in October informed the NHRC that Bulu's birth year has been mentioned as 1977 in the record and was arrested on September 22, 2003, when he had already turned a major.

He is in Rampur Rampur sub-jail and undergoing the sentence of life imprisonment. In his rejoinder Tripathy

pointed out the Juvenile Justice Board has, after thorough probe, found that Bulu was a minor on the day of alleged commission of crime. He should have been tried before the Juvenile Justice Board not before the Sessions Court.

The juvenile could have been sentenced to maximum three years of imprisonment for any crime. His date of birth as per school record is April 19, 1986. Tripathy enclosed a copy of Bulu's school record.

Due to the mistake committed by the prosecution he underwent fourteen years imprisonment. He lost his precious youth in prisons due to the negligence of the State.

Tripathy requested the NHRC to direct the State to pay at least Rs 28 lakh to Bulu for the loss of 14 years in prisons and include him in other social welfare schemes.

PURI DALIT WOMAN'S SALE

Daughter tortured in MP, says mother

URGES ADMN FOR IMMEDIATE RESCUE

Following an allegation on Sunday of sale of Dalit woman, Daudi Mallick, of Puri Baliapanda Basti in Madhya Pradesh, her mother Rama Mallick said on Wednesday that her daughter is presently in grave danger and crying for early release from a house in

MP.

She told The Pioneer that she talked to her daughter on mobile in the afternoon and heard from her that she was being tortured.

"I was fortunately allowed only half a minute to talk with my daughter Daudi after a gap of a week.

She said she is severely being tortured in MP," said Rama requesting the police to rescue her daughter before

something happened to her there.

No response came from the Sadar Thana on Wednesday evening when officials were contacted to know what steps they have taken after such revelation of the victim's mother.

Puri Collector Jyoti Prakash Das assured the family not to worry as he has personally taken up the case. When asked, Das said that he

NEW DOCUMENTS CROP UP IN RAFALE DEAL

Explanation from no less than PM: Cong

With the surfacing of new documents in the Rafale fighter jet deal, the Congress on Wednesday upped the ante seeking an explanation from no less than Prime Minister Narendra Modi himself.

Congress spokesperson Randeep Surjewala said the Rafale scam is getting "murkier and muddier" by the day as fresh documents have reinforced that the Prime Minister "facilitated a sweetheart deal" with Dassault to "illegitimately" benefit a crony friend — Reliance Defence.

"Undisputed evidence now corroborates, brazen 'crony capitalism' and 'quid pro quo' by the Modi Government in the multi-crore Rafale scam. Time for Prime Minister Modi to break his silence," Surjewala said.

The Congress alleged the new set of documents reveal the truth of ₹30,000 crore 'off-set contract' and a ₹1,00,000 crore 'life cycle cost contract' to Reliance Defence establishment that the deal was a "compensation" brokered by Modi Government and states that "it was imperative and mandato-



ry for Dassault-Aviation to accept this counterpart.

Surjewala also asked who was brokering this deal bypassing the lone public sector company which has 60 years of expertise in manufacturing defence aircraft. He said the lid of the Modi Government's "murky sweetheart deal in the Rafale scam is now off" and asked whether Modi was Prime Minister of India or of Anil Ambani. The simple question that Modiji needs to answer is 'Are you PM of India or PM of Anil Ambani'? Are you 'chowkidar' of India or are you the 'chowkidar' (watchman) of business interests of Reliance group of Anil Ambani," he asked.

It also strongly underlines

ing held on May 11, 2017 between two such trade unions and Dassault Aviation's COO Loik Segalen lift the lid off the murky sweetheart deal of ₹30,000 crore" and according to minutes of the meeting with CGT, "Segalen is quoted as saying that 'it was imperative and

mandatory for Dassault-Aviation to accept this counterpart in order to obtain the export contract Rafale India," he said.

The minutes of the meeting with another trade union CFDT, state that "this is the inevitable consequence of the Rafale India contract which required making 'Make in India' to be signed, he said. Surjewala claimed this is the third confirmation after Hollande had clearly told a French outlet about Modi securing the deal for Reliance Defence.

The Congress leader asked if the BJP's and a slew of Ministers' claim that Dassault Aviation was free to choose its off-set partner, "why is it that Mr Segalen, the 2nd in command of Dassault state that 'it was imperative and mandatory for Dassault Aviation to accept this counterpart in order to obtain the RAFALE India export contract'?"

He also asked if Dassault Aviation willingly agreed to partner with Reliance Defence, why was it called an inevitable compensation? "Was it not deliberate squandering of HAL's interests," he asked.

India, China to resume joint anti-terror exercise in Dec

In an indication of a thaw in bilateral relations, India and China will resume bilateral joint anti-terror exercise 'Hand in Hand' in December this year in China. The annual drill did not take place last year due to 70-day stand-off between the two armies in Doklam in Sikkim sector. The impasse ended following intervention at the highest political and diplomatic levels.

Meanwhile, the Indian Army also conducted a tour of more than 100 defence attaches of various countries to Leh to familiarise them with the operating environment in tough conditions. This exposure to friendly countries about Indian armed forces in various operational areas takes place every two years with the last such event in Jodhpur.

The India-China exercise, a confidence building measure between the two neighbours who share a 4,200km long disputed boundary, will be held in Chengdu province of China, officials said here on Wednesday. More than 100 troops from each side will carry out anti-terrorism drills

in urban and rural scenarios during the 'Hand in Hand' exercise lasting about a fortnight.

The annual event takes place alternately in India and China and it was scheduled to hold exercise in 2017. However, the face-off in Doklam after the Indian army objected to the Chinese constructing a road in the strategically important region led to calling off the drill. The last joint exercise was held in Pune in 2016 and it was the sixth annual bilateral exchange. The first such exercise was held in Kunming, China in 2007.

With ties improving with the eastern neighbor, a Chinese army delegation also took part in yoga programme with Indian troops in Ladakh earlier this year on the occasion of International Yoga Day.

Moreover, then Eastern Command chief Lt General Abhay Krishna also led a high level delegation to China in August to interact with his counterparts. These interactions came about after Prime Minister Narendra Modi and President Xi Jinping decided to resume bilateral military ties. This decision was taken during

the meeting of the two leaders in Wuhan, China in April this year.

As regards the ongoing three-day visit of foreign attaches to Leh starting Monday, officials said despite cold climatic conditions, the tour evoked positive response from the attaches who were with their spouses. Diplomats from countries including US, France, Australia, Russia, South Korea, South Africa, Nigeria, Singapore and Hungary besides others were part of the entourage. They were familiarised with the working of field formations located around Leh.

On the upcoming joint exercises with some countries, officials said elite Special Forces of India and US will practice anti-terrorism tactics with latest weapons next month in drill named Vajra Prahar in India. Similarly, the three Services will have a joint exercise INDRRA with their Russian counterparts in December. This will be the second such exercise where the combined three services of two countries will participate. Earlier, each service used to have separate drills. India and Japan will also have a joint army exercise.

Akbar's resignation victory of truth, MeToo: Opp parties

Opposition parties termed as "victory of truth" the resignation of Union Minister M J Akbar following charges of sexual harassment against him. While Congress remarked that it salutes the women who stood on their charges against the Minister bravely despite the "brazen" stance taken by the Government, Left parties said it was victory for the #MeToo movement and the protests carried out by them against the journalist-turned-politician.

Aam Admi Party (AAP) too hailed the women who accused Akbar of "sexual harassment" and said his resignation "completely exposed" the 'Chaal, Charitra and Chehra' of the ruling BJP at the Centre.

"This resignation is a vindication of the power of truth. More strength to India's women," said Congress spokesperson Priyanka Chaturvedi. Mahila Congress chief Sushmita Dev termed Akbar's stepping down as a "moral victory" for everyone and sought support for the #MeToo movement across party lines.

The Congress leader hit out at Prime Minister Narendra Modi for what she said was his "silence" in the matter. "I salute these women who stood their ground despite the brazen stance of the GoI, silence of the PM who speaks about women empowerment, the arrogant misuse of power by deploying

a battery of lawyers against one woman and allowing the accused to linger in his role," Chaturvedi said.

The CPI and the women's wing of CPI-M, however, said Akbar should have resigned early and the action has come "too late". "I think the Modi Government was compelled to ask M J Akbar to resign from the Union Ministry as the #MeToo movement gained momentum in the country. He should have resigned on the first day when his former colleagues made sexual harassment allegations against him," CPI general secretary Sudhakar Reddy said.

CPI Secretary D Raja said, "The resignation can be called a moral victory for all those women who have suffered such sexual harassment". He said the social atmosphere in the country was such that women can get the confidence to speak up against the sexual harassment faced by them.

All India Democratic Women's Association (AIDWA) general secretary Mariam Dhawale termed Akbar's resignation as a victory of women bodies.

Reacting to Akbar's resignation, AAP spokesperson Dilip Pandey said the action was "not sufficient" and demanded criminal proceedings against him. "Mere resignation by Akbar is not sufficient considering gravity of allegations against him. Criminal proceedings must be started against him," Pandey said.

MUZAFFARPUR SHELTER HOME

ED registers money laundering case

The Enforcement Directorate (ED) has registered a money laundering case in the Muzaffarpur shelter home case relating to alleged rape of minor girls by the functionaries of the NGO. The ED will probe the money laundering aspect of the scandal.

The ED case follows a CBI

case to probe the scandal at the shelter home. The ED will soon issue summons to the accused persons including the owner of the shelter home Brajesh Thakur. The ED will probe if illegal funds were generated and laundered by the alleged criminal activity, officials said.

As many as 34 girls were allegedly raped at the centre run by Thakur, chief of the state-

funded NGO.

The alleged sexual exploitation of the girls was first highlighted in an audit report submitted by the Tata Institute of Social Science (TISS), Mumbai, to the Bihar Government's Social Welfare Department in April this year. An FIR was lodged on May 31 against 11 people, including Thakur and the probe was later taken over by the CBI.

Sexual abuse of 34 inmates out of 42 staying at the shelter home was confirmed in their medical examination while two others who were unwell were yet to undergo medical tests.

The NGO running the shelter home in Muzaffarpur was subsequently blacklisted by the State Government and the girls were shifted to shelter homes in Patna and Madhubani.

POST MCI DISSOLUTION

Glimmer of hope for non-medical teachers with new BoG

While the corruption-ridden Medical Council of India (MCI) no more exists following its dissolution recently, its ill-conceived proposals and Union Health Ministry's apathy have started rendering thousands of non-medical teachers (biomedical scientists with medical M.Sc postgraduate degrees) in the country, jobless.

Non-medical teachers are those having medical M.Sc degree/PhD in anatomy, physiology, pharmacology, microbiology and biochemistry from MCI-recognised colleges.

The recent replacement of the MCI with the Board of Governors (BoG) of eminent personalities, has, however, brought a ray of hope among the

non-medical teachers working in the non-clinical departments of medical and dental colleges across the States. Hitherto neglected by the MCI, they feel that the BoG will recognise the services of the biomedical scientists in medical education and healthcare.

Not without reason. Those pursuing medical M.Sc courses in medical colleges are trained and skilled to render their services as consultants in diagnostic laboratories, teachers in non-clinical subjects of medical colleges and scientists in research establishments, pointed out Dr Sridhar Rao, President, National MSc Medical Teachers' Association (NMMTA), a representative of persons having medical M.Sc postgraduate degree in from MCI-recognised medical colleges.

However, the 'hostile policies' of the ex-MCI have started taking toll on the profession, he rued.

The NMMTA wants striking down of the MCI's proposal that aims to reduce appointment of non-medical teachers in colleges to 15 per cent from 30 per cent as it has "jeopardises job opportunities for those having medical M.Sc postgraduate degrees".

Though the proposal has not seen light of the day till date, some of the medical colleges have on their own started cutting down their posts: hiring MBBS Graduates for the post of tutors, instead of medical MSc post-graduates who are specialists in their subjects.

Also, said Dr Rao, as those pursuing medical M.Sc courses can also be utilized for diagnos-

tics or research purposes given their academic background, ironically thousands of them with Ph.D are idle at medical college, who do only teaching.

He also alleged discrimination at various levels ranging from work place to responsibilities, salaries, promotions etc. Also, many non-medical teachers are denied regularisation of job, increments, promotion etc. They are given low wages and exploited heavily. There is no ombudsman for grievances, Dr Rao said.

"Once included in first schedule of IMC act, the MCI had silently removed medical M.Sc course and washed its hands off it. Until 1980s MCI used to recognise these courses and used to give medical colleges permission to run them, but not anymore," he said.

Modi: Cong in MP has 3 CM candidates, each pulling others down

As electioneering gains momentum for the upcoming Assembly polls, Prime Minister Narendra Modi on Wednesday took a dig at the Congress saying that it has three Chief Ministerial candidates with each pulling others down and that it cannot think of the State's development.

In a video interaction with party workers of five Lok Sabha seats, Modi claimed that more than a dozen Congress leaders were also nursing Chief Ministerial ambitions in the State which, has been transformed from "bimaru" (sick) to "bimisal" (unparalleled) by the Shivraj Singh Chouhan Government.

He said the Congress, which is out to challenge the BJP's 15-year-rule in Madhya Pradesh, was issueless in the poll-bound State and had become desperate due to all-

round development works of the ruling State Government.

In desperation after finding no issues to oppose the BJP, the Congress used photos from Pakistan and Bangladesh to target the State Government and also resorted to "fake news", he alleged.

Modi said he saw on a TV programme that over 90 per cent of first time girl voters, who had taken part in an event in Sagar in the State, supported the BJP.

"The Congress has three chief ministerial candidates and over a dozen are in queue," he said, apparently referring to Kamal Nath, Jyotiraditya Scindia and Digvijay Singh, three main leaders of the Opposition party in the State.

"When more than dozen people have chief ministerial ambitions, then they cannot think of people's development. You should expose their lies to public," he told the BJP workers.

Lankan PM to arrive on 3-day visit

New Delhi: Sri Lankan Prime Minister Ranil Wickremesinghe will arrive here on Thursday on a three-day visit which comes in the backdrop of controversial media reports that Lankan President has accused Indian intelligence agency RAW of plotting his assassination, a claim firmly rejected as "false" by Colombo.

Wickremesinghe, who will arrive here Thursday evening on a scheduled visit, will hold wide-ranging talks with Prime Minister Narendra Modi on Saturday. Sri Lankan President Maithripala Sirisena also called up

PM Modi Wednesday and "categorically rejected" the media reports about him alluding to the involvement of Research and Analysis Wing in an alleged plot to assassinate him and a former defence secretary, an Indian Government statement said.

"The President apprised the Prime Minister of the urgent steps taken by him personally and the Government of Sri Lanka to publicly reject these reports. In this context, he also recalled his meeting with the High Commissioner of India to Sri Lanka today morning," the statement said. PTI

600 CISF commandos take over security of Kannur airport

New Delhi: The CISF on Wednesday took over the security of the yet-to-be operational Kannur International Airport (KIAL), the largest civil air facility in Kerala, with the deployment of over 600 armed commandos, a senior official said.

This is the 61st civil airport in the country that has come under the cover of the Central Industrial Security Force (CISF) after the Union Home Ministry accorded manpower sanction for the purpose.

The CISF unit will be headed by a Commandant rank officer and the airport, spread over 2,330 acres with a runway length of 3,050 metres, will be operational from the first week of December.

KIAL is about 20-km from the popular tourist town of Kannur and will have common departure and visitor gates for international and domestic passengers and also a common check-in area. Kerala has three other major airports at Kochi, Kozhikode and

Thiruvananthapuram. "KIAL would be the first airport in India which would dispense with stamping of hand baggage from day one of its operations due to the surveillance systems in place," CISF spokesperson Assistant Inspector General (AIG) Hemendra Singh said.

The CISF is a federal security force which guards strategic installations including airports in the country. It has a special aviation security group for rendering this task. The security at the airport

would be similar to what is seen at 60 other civil airports, the CISF said, adding that quick reaction commando teams and other personnel would be deployed at KIAL to thwart incidents of terror and sabotage.

"In the light of the increased threat perception to the aviation sector across the country, security of KIAL is of utmost importance as thousands of tourists including foreigners will visit Kerala through this airport," Singh said. PTI

PNB fraud: ED attaches over ₹218-cr assets of Mehul Choksi, others

The Enforcement Directorate (ED) on Wednesday seized assets worth over ₹218 crore, including diamonds and flats abroad in the name of fugitive diamond traders Mehul Choksi and others in connection with the over ₹13,000 crore credit fraud case.

The ED said three provisional orders under the Prevention of Money Laundering Act (PMLA) were issued by the agency's zonal office in Mumbai for attachment of the properties.

Besides Choksi, the other beneficiaries include Mihir Bhansali, a close aide and US-based executive of prime accused in the case Nirav Modi, and a Hyderabad-based company named A P Gems and Jewellery Park linked to Choksi.

The total value of the attached and seized assets is ₹218.46 crore, the ED said.

The attached properties include a ₹51 crore flat of Bhansali in a foreign country and the agency said it was purchased by him and his wife jointly.

"Bhansali is a close confidante of Nirav Modi and beneficiary of the scam. He was



actively involved in the diversion of funds received from PNB's LoU's (letters of undertaking)," the ED said in a statement.

Similarly, a villa valued at ₹27 crore of Choksi in an undisclosed country has also been attached.

A 2,10,000 sq feet building on a 2.5 acre land in Hyderabad's posh Banjara hills has been attached and the agency said it is in the name of A P Gems and Jewellery Park.

Choksi holds 89 per cent of shares in this firm by way of a "convoluted structure and overseas entity". A flat worth ₹1.70 crore in Trump Towers in Mumbai in the name of Choksi's daughter has been also attached, the agency said.

Also, diamonds worth ₹18.76 crore belonging to the Firestar group of Nirav Modi were seized as part of the latest order. The total value of attachments in this case with this latest order stand at ₹4,488 crore now, the agency added.

Slash cap on anonymous donations to ₹2,000, EC urges law Ministry

New Delhi: The Election Commission has urged the Government to slash the cap on anonymous donations to political parties from the present ₹20,000 to ₹2,000 to usher in more transparency, a move which comes months ahead of Lok Sabha elections due next year.

In a letter to the Legislative Department of the Law Ministry last week, the commission pointed out that while its demand to cap cash donations to parties to ₹2,000 per person has been accepted and made part of the Finance Act, another demand to cap anonymous donations to ₹2,000 is still pending.

The poll panel had written

to the Government in the middle of 2017 to amend Section 29C of the Representation of the People Act, 1951 to put a cap of anonymous donations. The letter sent last week is a reiteration reminding the Government that its demand has not yet been acted upon.

"The commission feels that since donations up to ₹20,000 can be kept anonymous and need not be declared, there is a possibility that cash will also be accepted. This runs contrary to the bar on accepting cash donations beyond ₹2,000," explained a functionary.

There is no constitutional or statutory prohibition on receipt of anonymous donations by politi-

cal parties. But there is an "indirect partial ban" on anonymous donations through the requirement of declaration of donations under Section 29C of The Representation of the People Act.

But, such declarations are mandated only for contributions above ₹20,000.

According to Section 29 C of the law, the treasurer of a political party shall every financial year prepare a report on the contribution "in excess" of ₹20,000 received by it from any person.

As per the proposed amendment sent by the commission to the Government, "anonymous contributions above or equal to the amount of ₹2,000 should be prohibited."

Protests spread to neighbouring TN

Ayyappa devotees take to Chennai streets and temples chanting hymns

Agitation happening all over Kerala against the Supreme Court verdict allowing women in the age group of 10-50 to worship at Sabarimala Temple, the holy shrine in the Western Ghats has spread to neighbouring Tamil Nadu.

Hundreds of devotees including young and old women, took to the streets in various places in Chennai and elsewhere in the State demanding status quo and withdrawing the permission granted to young women to pray in the shrine. Demonstrations were held even at Lord Ayyappa Temples at Mahalingapuram, RA Puram, Anna Nagar and other temples in the capital city which drew hundreds of young and old women irrespective of caste, creed or even religion. "The sentiments of devotees have been hurt by the court judgment. These demonstrations were not organised by us. It was a spontaneous reaction from the women devotees without any persuasion and coercion. They only assembled in front of the temple to express anguish," said K Asokan, an office bearer of Mahalingapuram Lord Ayyappa Temple.

The same was the cases with other Ayyappa Temples in the city. The Mahalingapuram Ayyappa Temple is a "shrine" that draws thousands of devotees daily and acts as a hub for pilgrims to Sabarimala Temple. It is here the devotees perform all rituals which are mandatory for the annual pilgrimage to

Sabarimala. In addition to this what makes the temple a landmark in Chennai is the feeding of poor undertaken by it on a daily basis. Thousands are fed everyday with sumptuous breakfast, lunch and dinner free of cost by the temple authorities who make use of the donations received at the 'hundri'.

Vijayashree Ramesh, a young lawyer in Chennai said that the Supreme Court verdict was completely wrong and was delivered without understanding the ground realities. "Law can never over rule age old traditions and customs. It is not impossible to agree with the verdict delivered by Justice Deepak Misra," said Ramesh.

She pointed out that there was no ban on the entry of women in any of the Ayyappa Temples elsewhere in the world. "That is further proof that there is a difference in the sashtras governing each temple. Sabarimala shrine because of its own unique tradition and rituals is a no-go place for women devotees. But there is no embargo on women above the age of 50 from visiting it. Hence it is not gender discrimination but Sanadhana Laws which should be respected by all," said Ramesh.

The demonstrations held at Chennai were unique in all respects. "No slogans were raised by the demonstrators. The participants numbering thousands recited hymns in praise of Lord Ayyappa. This was a new experience to the city's population," said Pravin Pillai, an activist working with Hindu cultural outfits in the city.

Asokan said more demonstrations and protest marches have been planned in the coming days as the Travancore Devaswam Board and Kerala Government have become adamant in their approach to make Sabarimala Temple a commercial enterprise.

Woman thrashes bank manager for asking sexual favour

As the MeToo movement in India is growing strong taking a toll on senior scribe and Union Minister MJ Akbar, in Karnataka a woman thrashed a private financial bank manager for seeking sexual favour in lieu of sanctioning a bank loan. A 52-second video which went viral on local channels and social media where a woman seen dragging a man on the streets thrashing him with a stick has a sequel to the ongoing MeToo movement in India.

According to reports in the media, the incident took place on Monday in Karnataka's Davanagere, a Central Karnataka district, when the woman visited the Dewan Housing Finance branch to seek a loan. The on-duty manager assured to help her and agreed to approve her loan despite her poor financial condition.

However, to pass loan, he allegedly demanded sexual favours. The enraged woman dragged him on the street and thrashed him with a stick. The visual shows the woman held the managers collar and then beating him up with a stick and slippers. The woman can also be heard asking the man to come to the police station while thrashing him with a stick.

Dewan Housing Finance Corporation Ltd (DFHL) on Tuesday Soon after the incident came to light, sacked the employee and termed the incident as very unfortunate. In a statement the company said "in the light of the unfortunate incident at Karnataka's Davanagere, we have terminated the services of the employee with immediate effect. DFHL strongly promotes and cultivates an environment that is conducive for the safety of women."

The MeToo movement, which began in the United States just over a year ago in response to accusations of sexual assault and harassment in the entertainment industry, has hit the India and taken its toll. After Bollywood actress Tanushree Dutta accused film actor Nana Patekar, it has hit many big names which include MJ Akbar and many others.

More than a dozen men in politics, media, entertainment and the arts have been accused of a range of offences, with several prominent figures either resigning or being suspended as a result.

MeToo movement has become a mainstream media talking point and woman are coming forward to voice against the predators.

But two of those accused, M.J. Akbar and veteran actor Alok Nath, filed criminal defamation suits against the women who accused them. In India defamation provisions which classify it as a criminal offence punishable with a jail term of up to two years.

Akbar, who founded and edited several newspapers before joining politics, has been accused of inappropriate behaviour by at least a dozen women who had worked with him. He has called the accusations "wild and baseless". On Monday, he filed the defamation suit against one of his accusers, journalist Priya Ramani, at a Delhi district court. Ramani had "intentionally put forward malicious, fabricated and salacious" allegations to harm his reputation, the suit alleged.

Ramani said in a statement on Twitter on Monday that she was ready to fight the defamation allegation "as truth and the absolute truth is my only defence".

Pune Police's evidence against 5 activists flimsy: Defence

The letters seized by the Pune police from the five activists and being dubbed as proofs of their Maoist links are "flimsy and uncorroborated" evidence, a Pune court was told on Tuesday.

Defence counsel Yug Chaudhary, who is representing activist Sudha Bharadwaj, told Additional Sessions Judge KD Vadane that the activists arrested by the police were "eminent" people.

The court heard the bail pleas of Bharadwaj and another activist Vernon Gonsalves. The police had raided the homes of prominent Left-wing activists in several States in August and arrested at least four of them for their suspected Maoist links.

The raids were carried out as part of a probe into an event — Elgaar Parishad — organised in Pune on December 31 last year, a day before the caste violence broke out between Dalits and the upper caste Marathas at Koregaon-Bhima village near the city.

Near simultaneous searches were carried out at the residences of prominent Telugu poet Varavara Rao in Hyderabad, activists Vernon Gonsalves and Arun Ferreira in Mumbai, trade union activist Sudha Bharadwaj in Faridabad, and civil rights activist Gautam Navalakha in New Delhi.

Rao, Bharadwaj and Ferreira were subsequently arrested. Chaudhary argued that the present case involving some "sensational" allegations was referred to the Supreme Court which gave a split verdict on it at a premature stage.

"The case is extra-ordinary. As after four months of investigation, police arrested some eminent people without any evidence and the evidence (seized letters) that they are producing right now is flimsy," he said.

Chaudhary said the police arrested 60-year-old Bharadwaj, who is a professor

at the National Law College in Delhi "where children of the Supreme Court and high court judges study".

"You are arresting her on the basis of some undated, unsigned, unverified, uncorroborated, typed letters, which were found in someone's possession. On the basis of these evidence, the police are claiming that this lady makes bombs, plants booby trap, decides which weapons need to be procured," he said.

Chaudhary said Bharadwaj had appeared for state governments in various cases and was on a search panel for appointment of universities' vice-chancellors, besides being a representative of the President of India.

"You are arresting a lady whose organisation has received a grant from the high court," the defence counsel said.

Bharadwaj has no criminal antecedents and she has sacrificed her whole life for the marginalised, he asserted.

Bharadwaj is also the vice president of the Indian Association of Peoples' Lawyers (IAPL), headed by retired judge H Suresh, he said.

"The police are claiming that IAPL is the front organisation of the banned CPI (Maoist). The high court judges such as Abhay Thipsay and Ajit Shah had attended the IAPL event as speakers," he pointed out.

"Are you going to arrest justices (retd) Suresh, Thipsay and Shah also?" asked Chaudhary.

He said the police were "silent" on calling the IAPL the

front organisation of the CPI (Maoist) in the Supreme Court. Citing the apex court's order, he said the "divided verdict" in the case is itself a ground for the bail.

"The apex court has taken an extra-ordinary measure in the case by crafting the provision of house arrest and the reason behind it was that we could come and apply for the bail," he added.

He claimed the police did not specify the grounds for Bharadwaj's arrest and did not even produce the translated case diary in the magisterial court while seeking her transit remand.

Challenging the authenticity of the letters, allegedly seized from the activists, Chaudhary said, "Let the prosecution take as long as they want to verify and authenticate the letters and I will not press for the bail."

"Till they verify or authenticate the letters, do not reject or allow my bail application. Keep me on interim bail," said Chaudhary, arguing for Bharadwaj.

Before Chaudhary, senior advocate Dhairysheel Patil, who represented activist Vernon Gonsalves, argued for his bail.

"If the letters which were allegedly fabricated are thrown out in the case, the very foundation of the case will be collapsed," he said.

The prosecution will Friday argue against bail of five accused — Surendra Gadling, Shoma Sen, Arun Ferreira, Vernon Gonsalves, apart from Bharadwaj.

Gadling and Sen, arrested in the Elgaar Parishad case in March this year, are currently in judicial custody of Pune police. Ferreira, Gonsalves, Rao, and Bharadwaj are under house arrests at their respective residences.

The Supreme Court had on September 28 extended by four weeks the house arrests of Varavara Rao, Arun Ferreira, Vernon Gonsalves, Sudha Bharadwaj and Gautam Navalakha, who was subsequently freed by the Delhi High Court.

Vijayan had said on October 3 that each Minister would visit various countries from October 17 to 21, including in the Gulf and Europe.

The LDF Government had last month decided to raise ₹15,900 crore as loan from the World Bank, Asian Development Bank, and other funding agencies to rebuild the prime sectors of the State.

Police win laurels while jailers 'help' prisoner escape high security prison

Even as sleuths of Tamil Nadu Police made a big breakthrough late last week by arresting two persons involved in what is being described as the State's biggest "train robbery", another incident which went unnoticed has tarnished its image.

A team of investigators from Tamil Nadu Police created a record of sorts by solving a train heist which took place on August 8, 2016. Dacoits on the prowl decamped with ₹5.75 crore from the parcel van of the Salem-Chennai Express train without leaving trace of any clue.

The parcel van was transporting soiled currency notes worth ₹342 crore from various banks in Salem to the Reserve Bank of India office in Chennai.

Though the heist was believed to have taken place around 10 pm, the incident came to the notice of the authorities only by 11 am next day when the train reached Egmore Station. Someone had made a 2ftX2ft hole on the roof of the parcel van while the train was moving and removed as many

bundles of currencies they could lay their hands on.

With no clues coming in their way, the sleuths were almost on the verge of coming to a dead end when they chalked out a strategy in one of the brainstorming sessions. They analysed the calls made from mobile phones which were active at Salem Junction and in the Salem-Villupuram stretch on the day the heist happened.

"We came across some suspicious mobile phone numbers that were active at Salem Junction and along the route between Salem and Villupuram, the stretch where the heist has happened. That was the turning point in the investigation. Though it was a painstaking operation, it paid rich dividends," said one of the officials in the team.

The results took them to Ratlam in Madhya Pradesh from where they arrested Dinesh (38) and Mohan Pardi (29) members of a crime syndicate led by Moharsingh, a hard core criminal who has been imprisoned there in connection with another case.

Though the currency notes were accompanied by armed police guards, they were travelling in the adjacent compartment and did not

notice the operation happening at the roof top of the compartment. By the time the train reached Virudhachalam, the dacoits completed the mission successfully and made their way to safety.



Assuring that BJP will not go with congress and opposition Mizo National Front (MNF), he said BJP will contest all the seats on its own depending on the



strength of BJP workers.

He added, "When UPA government was in power there was 13th finance commission which allocated ₹19,974 Crore for Mizoram during NDA rule 14th finance commission doubled the allocation to ₹42,972."

Attacking the congress which is ruling the state for last 10 years, he said, "Congress is infested by the corruption and dynastic rule. Chief Minister, Lal Thanhawia wants to make his brother chief minister."

Shah said that Mizoram Government blocking implementation of 129 schemes meant for the State. "However after polls all these schemes will be implemented. Congress is worried for once these schemes are implemented, Prime Minister Narendra Modi's popularity will further soar in the State," Shah added.

ICG vessels avert apprehension of two Indian boats from Pakistan

GANDHINAGAR: Indian Coast Guard vessels averted apprehension of two Indian fishing boats from the grip of Pakistan entities.

ICGS 'Rajratan' while undertaking the notional International Maritime Boundary Line (IMBL) patrol got alerted by intercepting a VHF communication. The Pak warship was chasing the Indian Fishing Boats reportedly operating in Pakistan waters.

ICGS Rajratan is a Fast Patrol Vessel based at Porbandar operating in the area for maritime surveillance. It intercepted two Indian Fishing Boats namely Mayshab Maa (GJ-10-MM-3480) and Safina Al Tahir (GJ-10-MM-1761) both registered at Okha in Devbhoomi Dwarka district. There were total 19 fishermen onboard.

The reports also confirm that PMSA Basol, a Pakistan Maritime Surveillance ship 'Basol' has apprehended another IFB Khuda Dost Ka Karam (GJ-10-MM-3250) also registered at Okha with 11 fishermen at the mutually agreed No Fishing Zone (NFZ) about 9 nautical miles from the nearest Indian land and about 36 nautical miles from nearest base port of Jakhau. ICG ship is maintaining constant liaison with their PAK compatriots for the release of this boat as well. PNS

Surat tense after another rape of infant by migrant

Close on the heels of rape on a 14-months-old girl by a migrant worker near Himatnagar in North Gujarat, yet another incident of rape and murder of three-years-old girl that too by a migrant created tension in the diamond city Surat.

The incident of rape in Himatnagar resulted into backlash against Hindi-speaking labourers as the accused arrested by the police was hailing from Bihar. Due to continue attacks on migrant workers post the incident, exodus of nearly one lakh workers reported from Gujarat to their respective States. Now police have come into action to prevent similar situation in the South Gujarat's biggest town as in the fresh incident of crime against a toddler, once again a Bihar migrant identified as an accused.

Sources in the Surat police said that the toddler girl was missing from Sunday evening and her body was found in a gunny bag on the next day. The forensic reports revealed that the girl was not only murdered but also raped. During the investigation, the police found

a 22-year-old man as suspect. According to an official involved in the investigation of the case the accused hailing from Bihar had switched off his phone and probably went to his home-state. Couple of teams of Gujarat police have been sent to Bihar to trace the accused. The family of the victim has migrated from neighbouring Maharashtra to Surat.

Surat police commissioner Satish Sharma said that police were trying to nab the suspect and sections including rape, murder, atrocity and POCSO would be put against him. Sharma has also appealed the people to remain calm and not to harm innocent migrants. According to him as part of precautionary measure, extra police personnel have been alerted to prevent any untoward incident.

Meanwhile in another incident as many as six construction workers and a civil engineer, all hailing from Bihar were allegedly assaulted in Vadodara for wearing Lungi. The incident occurred when they were busy working at a construction site of a school building.

Maha cops bust int'l job racket, arrest 4 persons from B'luru

Gang duped job seekers by collecting lakhs of rupees, promising jobs in Canada, US, UAE, other countries

The Crime Branch-CID sleuths of the Mumbai police have blown the lid off an international job recruitment racket with the arrest of four persons, including a woman, from Bengaluru who had allegedly cheated scores of job seekers from several States in the country to the tune of several lakhs of rupees by promising jobs in Canada, US, UAE and other countries.

Acting on the complaint of a senior citizen who was duped while looking for a job after his retirement, the investigators carried out an elaborate investigations and tracked down four

persons from Bengaluru who had allegedly cheated scores of job seekers from Maharashtra, Punjab, Tamil Nadu and other states by promising "technical" jobs abroad. They had collected lakhs of rupees on several pretexts.

The four arrested youngsters were identified as Ajay Bhavanishankar Gupta (23), Cedric Domnic Robert (23), Vignesh Suresh KC (22) and Mrs Sneha Narendra Panchariya (23). All of them are residents of Easter Enclave at Hormulu in Karnataka's Bengaluru. While one of them was arrested in Mumbai, the remaining three were picked up from Bengaluru.

In August, 2018, a senior citizen who had earlier worked abroad was looking for job after his retirement came across an advertisement that read 'International Jobs and Free Recruitment' on a Facebook page which claimed that there were vacancies for technical posts with huge salaries in countries like Canada, United States, United Arab Emirates (UAE) and other countries.

The senior citizen concerned applied for a job in Canada and sent bio-data and other documents to the advertiser through email and WhatsApp. He began following up with the advertiser for the job through email and WhatsApp.

The advertiser concerned meanwhile set up a WhatsApp group with a fake job recruiting official as an administrator for those looking for technical jobs using an international mobile SIM card. The administrator concerned asked the job seekers to send a total money to the tune of Rs 1,54,000 each to the advertiser online.

However, the job seekers did not jobs as promised nor was the advertiser ready to return the money taken to the job seekers. When asked for return of money, the alleged recruiters began to threaten the job seekers.

With no alternative, the senior citizen concerned registered a complaint with the Mumbai police. The case was then transferred to Unit-11 of the Crime Branch-CID visited Bengaluru early this week and arrested the remaining three youngsters. The investigators have seized a laptop, mobile phone and other documents that had used for allegedly cheating the job seekers.

"The investigations have revealed that these four arrested youngsters have cheated scores of persons in Maharashtra, Punjab, Tamil Nadu and other states to the tune of lakhs of rupees, by promising jobs abroad," Crime Branch's Deputy Commissioner of Police Akbar Pathan said here on Wednesday.

The four arrested youngsters have been booked under sections 420 (cheating), 465 (forgery) 467 (forgery of valuable security, will), 468 (forgery for cheating), 471 (using a forged document), 34 (common intention) of IPC and sec 66 D of Information Technology Act.

PM's unveiling Patel's statue will be BJP's 2019 campaign launch

The Bharatiya Janata Party (BJP) is virtually kicking off its campaign for the 2019 general elections by taking out 'Ekta Yatras' across Gujarat in the run up to the unveiling of the 182-foot statue of Sardar Patel by Prime Minister Narendra Modi on October 31.

The Prime Minister will unveil the tallest statue in the world, Statue of Unity, on the birth anniversary of Sardar Patel at Sadhu Bet, near Narmada Dam.

The almost ₹3,000 crore statue is being projected by the BJP as a symbol of unity and as a message that the Congress underplayed the contribution of Sardar Patel towards the country in favour of the Nehru-Gandhi family.

As a precursor to the unveiling event, the Bharatiya Janata Party is taking out 'Ekta Yatras' across Gujarat from October 19 to 29. The yatras will carry a prototype of the Statue of Unity all through the length and breadth of the state.

Gujarat Chief Minister Vijay Rupani will flag off one such Yatra from the historical Bardoli town in South Gujarat where Sardar Patel launched his Bardoli Satyagraha.

Similarly, Deputy Chief Minister Nitin Patel will flag off another Yatra from Karamsad, the hometown of Sardar Patel. Likewise, many Ministers of the government will flag off other modules of the Yatra from different regions of the state. All these modules will tour around 5,000 villages of Gujarat through the 26 Lok Sabha constituencies of the state before the big event.

The ruling party also plans to hold get-together events at

district levels during this period. The party also plans to expand its reach to the public where district-level expansion officers will be appointed full time within six months.

"Through the Ekta Yatra, we will be reaching out to the villages and showcase the development we have carried out at the state and central level," says state BJP President Jitu Vaghani.

He added: "After independence, it is for the first time that the central government has announced minimum support prices (MSP) of 1.5 fold of the production cost of farm produce like paddy, maize and millet. The BJP is working for the development of the farmers and farming and we are receiving overwhelming response from them," Vaghani claimed. Even after the big event, the BJP government is gearing up for visits by state delegations to the tallest statue and the Narmada dam.

Right now, Gujarat Ministers are inviting Chief Ministers, Deputy Chief Ministers, Governors and other dignitaries, including the President and Vice President, to the statue site. The BJP ruled state delegations are expected to visit the statue during the entire November month, one by one.

"This is done so for the sake of convenience. We cannot accommodate and entertain them all of them at a single go. So the visits from them will be one after other," Nitin Patel told reporters.

Subsidy withdrawal posed no fiscal burden on Haj pilgrims in '18: Naqvi

Union Minister for Minority Affairs Mukhtar Abbas Naqvi said here on Wednesday that even after the withdrawal of subsidy during the current year, there "was no unnecessary financial burden on pilgrims", all thanks to the elimination of middlemen and "100 percent online and transparent" system introduced during the year for scrutiny of applications.

Unveiling "Haj-2019" plan at the Haj House in Mumbai, Naqvi said that during 2018 pilgrimage season when Haj subsidy was withdrawn, the elimination of middlemen and 100 percent online and transparent system ensured that there was no unnecessary financial burden on pilgrims.

"The Haj pilgrimage was successful during 2018. For the first time after the Independence, a record number of 1,75,025 Muslims from India performed Haj this year and that too without any subsidy. We are hopeful that a larger number of Indian Muslims will go to Haj 2019," Naqvi said.

Earlier in 2017, a total of ₹1,030 crore had been paid to the airlines as fare for 1,24,852 Haj pilgrims, where as in 2018, a total of ₹973 crore were paid to the airlines for 1,28,702 Haj pilgrims, going through Haj Committee of India. "This means, we paid ₹57 crore less this year even

after ending the Haj subsidy," the Minister said.

The minister said it was for the first time that preparations for next year's Haj (2019) had been started immediately after completion of the 2018 Haj pilgrimage process.

"The online application process for Haj 2019 will start from tomorrow (October 18), while offline application process will begin from October 22. A total of 3,55,604 applications had been received for Haj 2018 which included 1,89,217 male and 1,66,387 female applicants. We expect to receive more number of application for Haj pilgrimage," Naqvi said.

Naqvi said that early start of Haj process, there would be better facilities for the agencies in India and Saudi Arabia. "This year, we will get more

time to make arrangements. The process of airlines tender will be completed by November. The accommodation process in Makkah and Madina will be completed by December-January. The accommodation rates in Saudi Arabia will be same as it was in 2018. All 20 embarkation points will be functional and Haj pilgrims will also be able to go from Calicut airport," he said.

Meanwhile, Naqvi inaugurated 'Viewers' Gallery' at Haj House and unfurled a national flag on the roof top of Haj House, Mumbai. The unfurled Indian National flag is of size 20 feet by 30 feet with a mast of 20-meter height. The national flag installed atop the Haj House is at 350 feet height from the ground level.

NIIT Tech shares up over 5% as Q2 net profit jumps

REGISTERED 66.3 PER CENT JUMP IN NET PROFIT TO ₹111.8 CRORE

Shares of NIIT Technologies on Wednesday rose over 5 per cent after the company reported 66.3 per cent jump in net profit for the quarter ended September 30.

The stock soared 4.34 per cent to close at ₹1,189.60 on BSE. Intra-day, it jumped 6.56 per cent to ₹1,215.

On NSE, shares of the company surged 5.14 per cent to end at ₹1,198.

NIIT Technologies on Wednesday reported 66.3 per cent jump in net profit to ₹111.8 crore for the second quarter driven by strong demand across sectors like BFSI and travel and transportation.

The company had registered a net profit of ₹67.2 crore in the year-ago period, it said in a regulatory filing. The company's revenues grew 23.1 per cent to ₹907.4 crore in the reported quarter from ₹737.2 crore in the year-ago period.

ACC Q3 NET PROFIT UP 15 PC TO ₹209 CR

Cement maker ACC Ltd on Wednesday reported 15.20 per cent increase in consolidated net profit at ₹209.14 crore for the third quarter ended September 30, led by volume growth spurred by higher demand. The company, which follows January-December financial year, had posted a net profit of ₹181.53 crore during the year-ago period, ACC said in a BSE filing.

Total income from operations was up 10.35 per cent to ₹3,465.92 crore as against ₹3,140.76 crore in the September quarter of 2017. ACC's total expenses were at ₹3,160.38 crore as against ₹2,877.00 crore. During the quarter, ACC's cement sales were up 9.89 per cent to 6.55 million tonne (MT) as against 5.96 MT earlier.

"The company grew cement sales volume by 10 per cent during the quarter spurred by higher demand," said ACC in a post earning statement.

ACC MD & CEO Neeraj Akhoury said: "Despite continuing input cost headwinds, ACC has delivered consistent positive financial performance. We are also encouraged by the Government's push on infrastructure and affordable housing which is driving growth in cement demand."

During the reported quarter, revenue from cement was at ₹3,184.64 crore, while Ready Mix concrete contributed ₹303.33 crore.

"The company's Ready Mix concrete sales volumes grew 12 per cent driven by an increase in the sale of value added products and the addition of 8 new plants across the country," said ACC. Over the outlook, ACC said it will continue to maintain its focus on operating efficiencies to improve performance.

"Demand drivers including growth in affordable and rural housing segments as well as infrastructure projects will remain healthy. We are optimistic that cement demand growth will strengthen in the coming year," Akhoury said.

Essar Steel: ArcelorMittal to pay ₹7,469 cr to clear Uttam Galva, KS Petron dues

Following the October 4 Supreme Court order linking its eligibility to bid for Essar Steel through bankruptcy courts, ArcelorMittal Wednesday said it will pay ₹7,469 crore to the financial creditors Uttam Galva and KSS Petron, its two domestic subsidiaries from which it had claimed to have exited.

The NRI Laxmi Mittal-owned company, which is the world's largest steel maker, which has been on a murky legal battle with other bidders, especially the Russian VTB Bank-promoted NuMetal, had on April 2 submitted a proposal to take over Essar Steel.

Of the ₹7,469 crore payment, around 80 per cent will be used to settle the dues of Uttam Galva and the rest 20 per cent for KSS Petron, the company said.

ArcelorMittal has reportedly submitted ₹42,000 crore to the 10-million-tonne alloy mill in Gujarat, which is one of the newest steel mills set up by Essar Steel, which owes over ₹45,000 crore to a clutch of lenders.

"Our board believes that Essar Steel represents a unique and compelling opportunity for us to establish a significant footprint, with substantial expansion potential, in the high-growth Indian steel market.

"Given the significant benefits that Essar Steel would bring to ArcelorMittal, making this payment is an appropriate course of action under the circumstances," ArcelorMittal said in a statement.

As per the Supreme Court ruling, Essar Steel creditors now have an eight-week period to accept what it considers to be the best resolution plan from eligible applicants.

ArcelorMittal and Numetal, which was initially promoted by Revant Ruita's shell company and subsequently exited and taken over by the Russian lender VTB Bank and some others, have been in a bitter court battle to establish their eligibility to bid for the steel plant.

After losing their case in NCLT and NCLAT, they had moved the Supreme Court, which on October 4 had allowed them to bid provided they cleared their dues to their lenders.

ArcelorMittal is the world's leading steel and mining company, with a presence in 60 countries and an industrial footprint in 18 countries. When it comes to coal mining, it is the fifth largest globally.

Punjab Cabinet approves new sand and gravel policy

To bring further transparency in sand mining sector, the Punjab Cabinet on Wednesday approved major policy changes to enable the Government to grant contracts by auction of mining blocks in strategically established clusters through progressive bidding instead of the earlier process of auction by individual mines.

The decision came during the Cabinet meeting held Wednesday under the chairmanship of Chief Minister Amarinder Singh.

It was decided that the new policy would come into force two months after the Cabinet approval to the Punjab State Sand and Gravel Policy, 2018 and amendment to the Punjab Minor Mineral Rules, 2013, the statement said.

The move would help substantially increase the royalty receipt of the state exchequer, provide adequate supply at fair price to the consumer and curb illegal mining, an official statement said here.

It has also been decided that the department of mining would launch an online Punjab Sand portal for sale of sand to all the consumers.

All transactions/payments will be captured through an online real-time monitoring system.

The sale of sand would be controlled by electronic documentation linked to the central documentation, with modern facility, and the daily progress report would be uploaded on the portal.

As per the new policy, the mining rights of concession quantity of sand and gravel in mining blocks identified by a process would be put to bidding through transparent e-auction process, the statement said.

Only registered companies, partnerships, societies including cooperative societies, sole proprietorship, individuals and consortia of up to three such entities would be eligible to bid, subject to fulfilment of certain conditions.

The average annual turnover of the bidder during the last three fiscal ending March 31 should not be less than 50 per cent of the reserve price of the mining block he bids for.

Notably, during 2017-18, four progressive bid e-auctions of minor mineral mines were held. Due to speculative bidding in these auctions, it resulted in a significant number of mines being auctioned at increased prices.

However, many of the contractors failed to operationalise these mines, which led to dearth of supply of sand and gravel, causing the market price of these commodities to trade at higher levels, the statement said.

In the case of consortium, the combined technical and financial capacity of all the members would be considered for the eligibility, the statement said.

The new policy provides for the quantity of sand and gravel, to be called 'annual concession quantity', that the concessionaire shall be allowed to mine per annum from a block as detailed criteria given for seven blocks of the state, the statement said.

The estimated available quantity in each block is, however, indicative and it would be the responsibility of the bidder to make his own assessment of it before bidding.

The concessionaire would be responsible to identify the mines in the block allotted to him, obtain consent of the land owners, arrange for all the infrastructural requirements like a right of way and obtain all clearances before the starting of mining operations.

Both sand and gravel would not be sold by the concessionaire at the mining site at more than ₹9 per cubic feet, which includes cost of loading on the vehicle.

Sensex logs first fall in 4 days, tanks 383 pts on rupee woes

The BSE benchmark Sensex snapped its three-day gains, plunging 383 points due to heavy selling mainly in financial and auto stocks as rising crude prices and rupee volatility spooked investors.

The flagship index swung nearly 880 points both ways on alternate bouts of buying and selling during the session.

The NSE Nifty too fell by 131.70 points to slip below 10,500-mark.

Intense selling pressure was witnessed in select counters led by auto, realty and oil&gas stocks.

Sentiments were also hurt by liquidity concerns that dragged down non-banking financial stocks.

Meanwhile in the forex market, the rupee after showing strength in early session at 73.37, slipped 13 paise to 73.61 against the US dollar (intraday) too had its shadow on equities.

Overall sentiment was cautious as investors were on a wait-and-watch mode ahead of quarterly results from Reliance Industries, to be released later in the day, brokers said.

"Market slid below 10,500 mark as rise in oil price and volatility in the rupee influenced investors to book profit. Global market remain mixed ahead of the release of FOMC minutes later in the day to get cues about rate hike trajectory," Vinod Nair, Head of Research, Geojit Financial Services, said.

After a gap up opening at 35,543.38 points, the Sensex advanced to hit a high of 35,605.43 points in early trade on the back of better-than-expected Q2 earnings posted by tech major Infosys on Tuesday.

However, emergence of selling by investors across-the-board, mostly of a profit-taking nature, gave up session's gain to hit a low of 34,727.16 in late afternoon trade, before settling 382.90 points, or 1.09 per cent, down at 34,779.58.

The index had risen nearly 1,161 points in the past three sessions on the back of unabated buying by domestic institutional investors (DIIs) and rebound in global equity markets.

The broader NSE Nifty too dived by 131.70 points, or 1.24 per cent, to close at 10,453.05. Intra-day, it reclaimed the 10,700-mark to scale a high of 10,710.15 and a low of 10,436.45.

"A strong rupee and buoyant global markets set the stage for the Indian markets to trade cheerfully in the morning. Nifty did open with gusto, though could not sustain and fell more than 250 points from the highs," VK Sharma, Head PGC & Capital Markets Group, HDFC Securities, said.

Foreign institutional investors (FIIs) sold shares worth ₹1,165.63 crore, while domestic institutional investors bought shares to the tune of ₹1,059.44 crore on Tuesday, as per provisional data available on the BSE.

Shares of Reliance Industries after initial firmness, fell 1.27 per cent ahead of its September quarter results.

Punjab Govt to amend industrial policy, give sops on intra-State sales

The Punjab Government on Wednesday decided to amend the industrial policy to give investment incentives by way of Net SGST on intrastate sales to promote business enterprises in the State.

The State Cabinet meeting, chaired by Chief Minister Amarinder Singh, also approved global tendering for the upcoming hi-tech cycle valley on a 100-acre industrial park in Ludhiana, an official statement said here.

The Cabinet noted that since the Government could not give direct concessions to industry in matters of land acquisition, other incentives should be provided through amendment to the policy so that both the state and the industry get the best deal through measures such as global tendering.

The Cabinet observed that for effective implementation of the policy there was need to explicitly define and explain the term 'Net SGST Incentive'.

A series of meetings/consultations were held among departments of Excise and Taxation, Finance, Industries and Commerce and Investment Promotion, the statement said.

After deliberations, a detailed formula for different eventualities was finalized in the meeting under the chairmanship of the Finance Minister.

According to the new formula, incentive amount would be calculated based on output IGT (or CGST+SGST), that would be called GST rate for formula, the statement said.

Overall quantum and/or period for claim of incentives shall remain same as defined in IBDP-2017 (as amended from time to time) for the respective category.

Availing of incentives up to the overall ceiling i.e. 200 per cent/125 per cent/100 per cent of FCI, as applicable, shall depend on the capacity utilization of the unit during the eligibility period, the statement said.

The incentive under the present policy would only be applicable for such investment proposals where Common Application Form has been submitted by March 31, 2020.

Infosys shares end over 1% higher post Q2 results

Shares of Infosys ended over 1 per cent higher on Wednesday after the company posted a better-than-expected 10.3 per cent net profit growth for the second quarter.

The stock trimmed most of its early gains and ended at ₹704.50, up 1.16 per cent on BSE. Intra-day, it surged 3.53 per cent to ₹721. At NSE, shares of the company went up 1.47 per cent to close at ₹705.50.

In terms of equity volume, 11.46 lakh shares of the company were traded on BSE and over 2 crore shares changed hands at NSE during the day.

Sanjeev Hota, BNP Research at Sharekhan by AVP Paribas, said Infosys had delivered "better than expected numbers on topline and bottomline front for second quarter, though margins performance missed the mark."

India's second-largest software services exporter Tuesday posted 10.3 per cent net profit growth in the second quarter after margins were boosted by large deal wins and reiterated its revenue forecast for full year.

PNB fraud: ED attaches over ₹218-cr assets of Choksi, others

The Enforcement Directorate (ED) Wednesday seized assets worth over ₹218 crore, including diamonds and flats abroad, in the nearly ₹13,000 crore loan fraud case probe, the agency said.

It said three provisional orders under the Prevention of Money Laundering Act (PMLA) were issued by the central investigative agency's zonal office in Mumbai for attachment of the properties.

The beneficiaries of these assets put under attachment, it said, are absconding diamond jeweller Mehul Choksi, Mihir Bhansali, a close aide and US-based executive of main accused in the case Nirav Modi, and a company named A P Gems and Jewellery Park linked to Choksi.

The total value of the attached and seized assets is ₹218.46 crore, the ED said.

The attached properties include a ₹51 crore flat of Bhansali in a foreign country and the agency said it was purchased by him and his wife jointly. It was not immediately clear as to which country this asset is based in.

"Bhansali is a close confidante of Nirav Modi and beneficiary of the scam. He was actively involved in the diversion of funds received from PNB's LoU's (letters of undertaking)," the ED said in a statement.

Similarly, a villa valued at ₹27 crore of Choksi in an undisclosed country has also been attached.

Adani, Total join hands to set up retail network, LNG terminal

India's largest infrastructure conglomerate Adani Group and French energy giant Total SA on Wednesday announced a partnership to develop liquefied natural gas (LNG) import terminals and fuel retailing network in India.

Total, which had a few weeks back exited Royal Dutch Shell-led Hazira LNG import terminal in Gujarat, will join Adani in developing a 5 million tonnes a year import facility at Dhamra in Odisha.

The two will also set up a joint venture to roll out a fuel retail network of 1,500 outlets, mostly on highways, in the next 10 years, Adani and Total said in a joint statement.

While the two firms did not indicate details of the deal, including how much stake Total was picking up, sources privy to the development said the agreement signed was a preliminary collaboration pact and details would be announced later.

Also, Total is eyeing a stake in city gas distribution projects of Adani but talks are stuck on valuation.

"Adani and Total have signed an agreement to jointly develop multi-energy offerings to the Indian energy market. The diversified portfolio includes

LNG and fuel retail," the statement said.

Total, the world's second-largest LNG private player, and USD 11 billion Adani Group, which has interests in energy, infrastructure, ports and edible oil, "will serve the fast-growing gas demand of the Indian market," it said. "The partnership has set a target of developing various regasification terminals including Dhamra LNG on the east coast of India," it added. "Most essentially, it would be a big stride towards India's vision of achieving a healthier energy mix through the promotion of LNG."

Also, Total and Adani will create a joint venture to build a retail network of 1,500 service stations over the period of 10 years, on the main roads of the country such as highways and intercity connections to take advantage of a market that is growing at 4 per cent per year driven by the development of road infrastructures and the emergence of middle class.

"These new service stations, in line with international standards, will offer Indian customers Total's full lineup of fuels, lubricants, as well as a broad range of other products and services," the statement said.

Adani holds a 25 per cent

stake in just-completed 5 million tonnes a year liquefied natural gas (LNG) import terminal at Mundra in Gujarat. It is also building a similar capacity LNG import terminal at Dhamra in Odisha at a cost of ₹5,100 crore by 2021.

Sources said Total may take buy some of Adani's stake in the two terminals. It is also looking at buying a 50 per cent stake in under-construction LPG import terminal that Adani is building at Mundra in Gujarat as well as a stake in Adani's flourishing city gas distribution projects.

While the Mundra LNG terminal has Gujarat State Petroleum Corp (GSPC) as the lead partner, Adani is building a new LPG import facility at the same port with a total capacity to 3.56 million tonnes per annum. The LPG terminal is to be completed by next month.

Adani Gas, a subsidiary of Adani Enterprises Ltd, is development city gas distribution (CGD) networks to supply the piped natural gas (PNG) to industrial, commercial, domestic (residential) units and compressed natural gas (CNG) to the transport sector. It already has set up city gas distribution networks in Ahmedabad and Vadodara in Gujarat, Faridabad in Haryana and Khurja in Uttar Pradesh.

In the recently concluded CGD bid round, it won rights to 13 cities on its own and another nine in joint venture with state-owned Indian Oil Corporation (IOC). These are in addition to the 50:50 Adani-IOC joint venture winning rights to develop CGD network in Allahabad, Chandigarh, Ernakulam, Panipat, Daman, Dharwad, and Udhamsingh Nagar in previous bid rounds.

Total chairman and CEO Patrick Pouyanne had on Tuesday stated that the French company was "very interested" in investing in downstream sectors in India, including LNG terminals. "City gas is interesting business" that can use the imported LNG, he had said without giving details.

He had stated that Total does not qualify for a licence to retail petrol and diesel in the country as it does not meet the ₹2,000 crore minimum investment threshold set for such a permit. But with Adani, which has already invested many times more than that amount in oil and gas infrastructure, it will qualify for a retail licence.

India is looking at more than doubling the share of natural gas in its energy basket to 15 per cent in the next few years and is giving a major push to city gas distribution projects.

NIIT Tech Q2 net profit jumps 66% to ₹111.8 cr

NIIT Technologies on Wednesday reported 66.3% jump in net profit to ₹111.8 crore for the quarter ended September 30, 2018, driven by strong demand across sectors like BFSI and travel and transportation.

The company had registered a net profit of ₹67.2 crore in the year-ago period, it said in a regulatory filing. The company's revenues grew 23.1% to ₹907.4 crore in the reported quarter from ₹737.2 crore in the year-ago period.

On sequential basis, net profit was up 30.3%, while revenue was higher 10%. Digital revenues grew 11.6% sequentially contributing to 28% of the total revenues.

NIIT Technologies CEO Sudhir Singh said the growth had been driven by the restructured leadership team, differentiated strategy and focussed execution by the team. "The extremely robust 10% sequential revenue growth and the 217 basis points sequential improvement in operating margin is a reflection of the new normal as we target predictable and fast scaling profitable growth," he said.

Singh noted that the recent

rupee fall has not had a major impact on the numbers as on a constant currency basis, the company saw 7.6% sequential growth. He added that "broad-based de-risked growth" across all verticals and significant investments in building differentiated capability, while simultaneously improving margin profile were factors contributing to the strong set of numbers.

Singh said the deal pipeline remained strong across geographies with acceleration in demand for digital services.

The company booked fresh business of USD 160 million during the quarter, which included 10 new logos. Of this, USD 86 million was from the US, USD 39 million from EMEA and USD 35 million from Rest of the World (RoW). Order book executable over the next 12 months has expanded to USD 363 million, the company said.

"Significant increase in new logo acquisition, accelerating order book generation and new leadership firmly in position have materially improved the business profile of the company," said Arvind Thakur, vice-chairman and managing director at NIIT Technologies.

ANTI-MBS JAMAL KHASHOGGI MISSING MYSTERY

Trump criticises rush to condemn Saudi Arabia

AP ■ WASHINGTON

President Donald Trump on Tuesday criticised rapidly mounting global condemnation of Saudi Arabia over the mystery of missing journalist Jamal Khashoggi, warning of a rush to judgment and echoing the Saudis' request for patience.

In an interview with *The Associated Press*, Trump compared the case of Khashoggi, who Turkish officials have said was murdered in the Saudis' Istanbul consulate, to the allegations of sexual assault levelled against Supreme Court Justice Brett Kavanaugh during his confirmation hearing.

"I think we have to find out what happened first," Trump said. "Here we go again with, you know, you're guilty until proven innocent. I don't like that. We just went through that with Justice Kavanaugh and he was innocent all the way as far as I'm concerned."

Trump's remarks were his most robust defence yet of the Saudis, a US ally he has made central to his West Asia agenda.

They put the president at odds with other key allies and with some leaders in his Republican Party who have condemned the Saudi leadership for what they say is an obvious role in the case.

Trump appeared willing to resist the pressure to follow suit, accepting Saudi denials and their pledge to investigate.

The Oval Office interview came not long after Trump spoke Tuesday with Saudi Crown Prince Mohammed bin Salman of whom Khashoggi has been a harsh critic.

He spoke by phone a day earlier with King Salman, and he said both deny any knowledge of what happened to Khashoggi. After speaking with the king, Trump floated the idea that "rogue killers" may have been responsible for the disappearance. The president told on Tuesday that that description was informed by his "feeling" from his conversation with Salman and that the king did not use the term.

In Turkey earlier Tuesday, a high-level Turkish official told that investigators

Istanbul police search Saudi consul's residence

Turkish police on Wednesday began a search at the residence of the Saudi consul to Istanbul, in the investigation into the disappearance of Saudi journalist Jamal Khashoggi at the kingdom's consulate in the city, according to an AFP correspondent.

A team of a dozen police and prosecutors, including forensic experts in white overalls, entered the residence of Mohammed al-Otaibi, a day after he flew out of Istanbul for Riyadh. Earlier in the day, a Saudi delegation had also arrived at the building to take part in what is presented as a joint search with their Turkish counterparts. Turkish police had on Monday searched the consulate building itself for over eight hours, taking away soil and DNA samples for further examination.

searching the Saudi Consulate had found evidence that Khashoggi was killed there.

Also Tuesday, Secretary of State Mike Pompeo met with the king and crown prince in Riyadh and said the Saudis had already started a "serious and credible investigation" and seemed to suggest it could lead to people within the kingdom.

The secretary of state noted that the Saudi leaders, while denying knowledge of anything that occurred inside the consulate, had committed to accountability "including for Saudi Arabia's senior leaders or senior officials."

Pompeo was heading next to Turkey, where officials have accused the Saudis of using a 15-member team to kill Khashoggi inside the consulate.

Trump said he hoped the Saudis' own investigation of Khashoggi's disappearance would be concluded in "less than a week." In the meantime, there were signs at home that Trump's party was growing uncomfortable with his willingness to defend the Saudis.

Chinese mining firm successfully test-fires supersonic missile

Dragons may sell it to Pakistan: Report

A Chinese mining company has claimed to have successfully test-fired a supersonic missile, touted as a potential competitor to the Indo-Russian joint venture BrahMos missile, according to the official media here.

The test conducted on Monday at a discreet location in North China verified the launch, power and flight control systems, state-run *Global Times* reported while indicating that Beijing's all-weather ally, Pakistan could be one of its buyers.

All parameters for the supersonic flight of the HD-1 missile achieved their estimated values, it quoted a statement released by Guangdong Hongda Blasting Company located in southern China.

"The test flight shows that the HD-1's core components are now mature, with its aerodynamic design, materials and overall structure already proven viable," Wei Dongxu, a Beijing-based military analyst, told the daily.

Hongda independently invested in and developed the HD-1 missile, the statement said.

Wei said the mining company's move to build and test a supersonic missile is an excellent example of military-civilian integration.

Established in 1988,

Hongda is a mining company based in Guangzhou, capital of South China's Guangdong Province that also manufactures blasting and military equipment.

The HD-1's advanced solid fuel ramjet needs less fuel than its competitors, rendering the lighter missile able to fly faster and farther, Wei said.

After government approval, Hongda intends to sign deals and mass-produce the HD-1 for export, the report said.

There are not many such supersonic missiles available on the international defence market, Wei said.

Pakistan and West Asian countries are likely to show interest given the weapon's potential to break anti-missile systems at supersonic speeds, he said, claiming that the new missile could be cheaper than the BrahMos.

"The BrahMos missile is a more expensive, less useful supersonic cruise missile developed by India and Russia," Wei claimed.

Hongda will participate in Airshow China 2018 in Zhuhai, South China's Guangdong Province next month, a company spokesperson said.

The HD-1 is a comprehensive weapon system consisting of missile, launch, command and control, target indication and comprehensive support systems, Hongda had said in a separate statement released earlier.

The HD-1 can be adapted to aircraft and ships as well as the basic ground-based vehicle version, the company said.

The total investment in HD-1 is expected to top 1.3 billion yuan (about USD 188 million).

Ahvaz attack 'mastermind' killed in Iraq, says Iran

An Islamic State of Iraq and Syria (ISIS), which also known as Daesh, mastermind named as Abu Zahi and linked to a deadly attack last month in southern Iran, was killed along with "four other terrorists" in Iraq Tuesday, the elite Revolutionary Guards said in a statement.

The five were killed "during a reconnaissance and surprise operation by forces of the resistance this morning in Iraq's Diyala province," northeast of Baghdad, the statement said.

The attack on a military parade in the mainly ethnic Arab city of Ahvaz in southwestern Iran left 24 people dead last month

The "resistance" is a term used for militias operating in Iraq and Syria with Tehran's support, and trained by the Revolutionary Guards. Abu Zahi was "the mastermind of the recent terrorist crime in Ahvaz," the statement added.

The attack on a military parade in the mainly ethnic Arab city of Ahvaz in southwestern Iran left 24 people dead last month.

Claims of responsibility for that attack were posted by both the jihadists of the Islamic State group and by a separatist group calling itself Ahvaz National Resistance.

On October 1, Iran said it had struck jihadists in Syria with ballistic missiles and combat drones in retaliation for the September attack.

Tehran calls US sanctions 'blind vindictiveness'

Iran called new US sanctions against its paramilitary Basij group an act of "blind vindictiveness" on Wednesday.

"America's new sanctions are a clear insult to international and legal mechanisms and a result of the American government's blind vindictiveness against the Iranian nation," said Foreign Ministry spokesman Bahram Ghasemi.

He called Washington's "lack of adherence to international legal mechanisms" a threat not only "to the Iranian people's interests but also the world's stability and security."

On Tuesday, the US Treasury Department slapped sanctions on the Basij paramilitary group along with a network of more than 20 businesses that were providing it financing.

The US pulled out of nuclear accord between Iran and six world powers in May and is reimposing punishing sanctions on the West Asian country, hoping to pressure Tehran into what President Donald Trump calls a "better deal".

Iran stays quiet on Khashoggi's alleged murder

Tehran: Iran has been playing it cool as it watches the furor over the disappearance of writer Jamal Khashoggi create a crisis for its regional rival Saudi Arabia.

As of Wednesday, the Government had yet to make any official comment on the alleged murder of Khashoggi, who vanished after entering the Saudi consulate in Istanbul on October 2.

Barraged by questions at his weekly press conference on Monday, Foreign Ministry spokesman Bahram Ghasemi said only that Iran was monitoring events.

The Iranian press has been reprinting the gruesome claims from Turkish and other international sources that Khashoggi was tortured and dismembered inside the consulate, and on Wednesday alleged a cover-up by Riyadh and Washington.

"US, Turkey and Saudi colluding to close the murder case of Jamal Khashoggi," read the headline on Wednesday's *Jomhour-i Eslami* as it reported on US Secretary of State Mike Pompeo's visit to Riyadh and Ankara. AFP

US: SAUDIS PROMISE ACCOUNTABILITY BUT DENY KNOWLEDGE OVER MISSING SCRIBE

Saudi Arabia promised to Sensure a thorough probe and accountability over a missing Saudi journalist but stood by denials the kingdom killed him, US Secretary of State Mike Pompeo said Wednesday, as he paid a supportive visit to the under-fire ally.

President Donald Trump dispatched Pompeo on an urgent mission to Riyadh to defuse a crisis over Jamal Khashoggi, an insider turned critic of the conservative monarchy who was last seen on October 2 when he entered the Saudi consulate in Istanbul to sort out marriage paperwork.

After a full day of talks, a statement from Pompeo and a tweet by Trump said that the Saudi leadership "strongly denied knowledge of what took place" in the consulate, without outright rejecting that an incident occurred.

Officials in Turkey, where Pompeo heads on Wednesday, say that the Saudis killed Khashoggi inside the consulate.

Pak: Serial killer of minor girls executed

A serial killer of minor girls was executed at a jail in Lahore on Wednesday after he was convicted and sentenced to death by an anti-terrorism court for raping and murdering a seven-year-old girl, in an incident that sparked outrage and violent protests in Pakistan early this year.

Imran Ali, 24, who was convicted for the rape and murder of the minor girl in Kasur city, some 50-km from Lahore, was hanged at 5.30am in the presence of the victim's father Amin Ansari and magistrate Adil Sarwar in Kot Lakhpat Central Jail. The girl's uncle was also present at the jail.

A resident of Kasur, Imran was accused of being involved in at least nine incidents of rape-cum-murder of minors. The court has given its verdict in five cases. The incident triggered nation-wide street protests in Pakistan with people demanding a harsh punishment for the convict.

Lanka rejects reports on Sirisena's killing plot

Sri Lankan Government on Wednesday rejected as "baseless and false" the media reports that President Maithripala Sirisena accused India's Research and Analysis Wing (RAW) of plotting his assassination and he opposed awarding a key port project to India.

The media reports came ahead of Sri Lankan Prime Minister Ranil Wickremesinghe's visit to New Delhi for talks with Prime Minister Narendra Modi to speed up India-backed projects, including the East Terminal project, in the island nation.

Sirisena accused his senior coalition partner, the United National Party (UNP), of not taking seriously an alleged conspiracy to kill him and former secretary to the ministry of defence, Gobbhaya Rajapaksa, the economynext.Com reported quoting a ministerial source after a heated Cabinet meeting on Tuesday.

Canada legalises marijuana for recreational use

Nearly a century of marijuana prohibition came to an end Wednesday as Canada became the first major Western nation to legalise and regulate its sale and recreational use.

The change was praised by pot enthusiasts and investors in a budding industry that has seen pot stocks soar on the Toronto and New York stock exchanges, but sharply questioned by some health professionals and opposition politicians.

"We're not legalising cannabis because we think it's

good for our health. We're doing it because we know it's not good for our children," Prime Minister Justin Trudeau said on the eve of the reform.

"We know we need to do a better job to protect our children and to eliminate or massively reduce the profits that go to organized crime." The Cannabis Act, which fulfills a promise Trudeau made in the 2015 election campaign, makes

Canada only the second nation after Uruguay to legalize the drug.

Its implementation will be scrutinized and dissected by Canadians ahead of the next

election in 2019, as well as other nations that the prime minister has said may follow suit if the measure proves a success.

Trudeau himself admitted in 2013 to having smoked pot five or six times in his life, including at a dinner party with friends after being elected to parliament.

He has also said that his late brother Michel was facing marijuana possession charges for a "tiny amount" of pot before his death in an avalanche in 1998, and that this influenced his decision to propose legalizing cannabis.

A LOT LIKE LOVE

When the trailer of Amit Ravindernath Sharma's *Badhaai Ho!* aired, it created an instant buzz. The audience wondered about the repercussions of having a child late in life. What age is it too late to have a baby? When is a mother too old to have another child? Are your parents too old to still love each other and express it in bed? The idea wasn't something new but is a "real phenomenon" that is usually kept under wraps. Amit explains that the storyline originally came from Akshat Ghildial, the writer of the film, who had written it as an ad film in 2012 which was "luckily" never made. "In 2015, he narrated a one-line story of a 50-year-old mother getting pregnant. We realised that this hasn't been taken up and it's the only reason that it should be. We wanted to do a film that shows all these aspects but isn't vulgar. We didn't want to make anything serious. We worked on the script for two and a half years to give it a comic touch," he says. After the trailer launch, Amit reveals that they received a number of calls from people "who told us that the story looked identical to their lives. We just don't talk about it nowadays." He gives an example from his family, "My grandmother and her mother were pregnant at the same time." As was evident from the trailer, the film talks about the embarrassment an elderly couple, their children and family, neighbours and friends face. It makes one ponder about what happens if your parents get pregnant when you're already grown up? Amit says he doesn't aim to teach "ki abhi bhi iss umar mein bache paida karo (have babies in this old age), but we want to make the audience understand that if still there's love between your parents, what's the harm in it? We are not preaching. Everyone has a different point of view and the film aims to break the stereotypes." Talking about breaking taboos through progressive cinema, Ayushmann Khurrana is one of the first names that comes to mind. Many of his films like *Vicky Donor*, *Shubh Mangal Savdhaan*, *Dum Laga Ke Haisha* and now *Badhaai Ho*

venture into the territory. So why is it that we always find him unlocking such doors? Is there a particular selection process that he goes through while choosing his roles and films? For Ayushmann, a new concept is important and he believes that everyone should be selective. "To be clutter-breaking and to do something different, always attracts me." It's a two-way process. "I choose such roles because such films also come to me. When I started out, I was on the track of unconventional roles. I just wanted to have best script choices." He believes that actors become specific to "their kind of zones" after playing certain roles. For instance, if Varun Dhawan worked in *Sui Dhaaga* and *October*, Tiger Shroff is mostly seen in action films. "Hence, an actor starts to trend a journey from their first film. I did *Vicky Donor* and *Shubh Mangal Savdhaan*, and also *Andhadhun*, which is quite different from the other two. My zone and preference is to work on slice-of-life and taboo-breaking cinematic films. I am happy to be a part of progressive cinema. *Badhaai Ho!* is different." The film raises questions about old-age pregnancy which might make the audience think twice before heading to the theatres with their families. But the

role was the best experience in her acting career. "I have always wanted to do this kind of a role in a middle class background but was never offered one because of my image. I was really excited after reading the script." If you ask her about the problems that she faced while acting as an old and pregnant woman, she says, "There was a slight physical discomfort in the beginning around my waist due to the velcro that would pierce my skin and sometimes I would sweat, but then it grew into a habit. And the process became easier with time." As the #MeToo movement is increasingly gaining prominence in the country, the star cast trio share a word of what they feel about the revolution. Gajraj Rao, "It was overdue. Just like we do pest control in our homes every six months, it should be done in the human society as well. Now the way women and even men, to some extent, are coming out to speak against harassment and it looks like those who harassed are afraid to do anything. They will think at least 50 times before doing something. A young girl is told not to discuss if anyone harasses her. It is considered a taboo. But every child should be taught that it is important to speak up. She will be able to react at the right time when she grows up." Ayushmann adds, "It's not just in Bollywood but everywhere, and it should be everywhere. It's just that people in public eye have been affected the most since. We have a very strict patriarchal society since time immemorial. So it takes a lot of courage for a woman to come up about something that has happened to her in the past. It's a very good movement." Neena says, "It's a power game. Women are speaking up after 15-20 years because when it happened they were not in a position to speak up and nobody would have even believed them. The one in power would always try to shut them in public. But now that they are established and powerful enough, they feel empowered to speak. They are finally raising their voices and it is really good. We need to listen to them and believe them."

NO MORE SLEEPING EMPTY-STOMACH

The Union Minister of Agriculture and Farmer's Welfare Radha Mohan Singh, believes that efforts of many farmers and the techniques developed by the Indian Council of Agricultural Research (ICAR) have contributed to an increase in agricultural production and food security to remove the suffering from hunger and ensure food security and a nutritious diet for all. Zero hunger could save the lives of 301 million people a year and can help build a safer, more prosperous world for everyone. He was speaking at the two-day Agri Startup and Entrepreneurship Conclave on the occasion of the World Food Day celebrated at the NASC Complex, Pusa in New Delhi with a theme—'Zero actions are our future-A zero hunger world by 2030 is possible.'

On the occasion of World Food Day, a two-day Agri-Startup and Entrepreneurship Conclave was held in New Delhi which discussed India's progress towards eradicating hunger in the country and government's initiatives to incentivise the youth towards the agriculture sector

Agriculture: Transforming Indian agriculture for global environmental benefits and the conservation of critical biodiversity and forest landscapes. According to the fourth advance estimate, the food grain production is estimated at 284.83 million tonnes in 2017-18, an increase of over 20 million tonnes as compared to 2013-14. The horticulture crops, which contribute significantly to the nutritional security, have witnessed a record production this year at 307 million tonnes. The minister pointed out that India occupies the top spot in the horticulture production. In the year 2015-16, the production of pulses was 16.25 million tonnes, which increased to 25.23 million tonnes in the year 2017-18, which is about 9 million tonnes higher as compared to the production achieved in the year 2013-14.

The role of high quality crop variety, seeds and technology has been significant in increasing production. Singh added that 795 crop varieties were released for production during 2014-18 as compared to 448 crop varieties during 2010-14. The demand and production of breeder seeds during 2013-14 was 8,479 tonnes and 8,927 tonnes respectively which rose to 10,405 tonnes and 12,265 tonnes in 2016-17. Addressing the agricultural entrepreneurs present at the conclave, Singh informed that the government started the startup program to create an atmosphere for the agriculture startups to provide appropriate support to set up the enterprises. In this context, the Skill India Scheme was launched by the government on a large scale. He explained that there is a tremendous potential for startups in the field of seeds and plant production, food processing and post-mortgage management, veterinary, farm

machinery, poultry, fish production, biological products, bioplasty and so on. According to statistics, there is a requirement of 22 lakh skilled youth in the agriculture sector and to meet this demand, training and skill development is being conducted in various employment areas with the help of the agriculture department, ICAR and the Krishi Vigyan Kendras (KVKs). "Though a record of food grain production has been established in the country, the government is working very fast on the value chain. The recently launched Pradhan Mantri Kisan Sampada Yojana aims to create world-class food processing infrastructure. This is expected to leverage investment of five billion USD, benefit two million farmers and generate more than half a million jobs over the next two years." To attract the youth of

the country towards agriculture, a project called 'Arya' is being run through the KVKs and the Farmer Fest program is also playing a leading role in this direction. Singh also explained that through the mega food farms the government plans to link agro-processing clusters with key production centres. This will offer immense value proposition in crops such as potato, pineapple, oranges and apples. The farmer groups are being encouraged to set up units in these parks, thereby reducing wastage and transportation costs, and creating new jobs. On digitalisation in the domain of agriculture, the minister commented, "We plan to link our villages through broadband connectivity, within a clear timeframe. We are digitalising land records and providing various services to the people on mobile platforms. These steps are building momentum towards real-time transfer of information, knowledge and skills to farmers. The e-NAM, our national agriculture e-market, is connecting our agricultural markets nationwide, thereby giving our farmers the benefit of competitive pricing, and freedom of choice."



Griezmann adds to Germany's woe

French striker struck twice as Les Blues bounce back to beat Germany 2-1

Defiant Joachim Loew praised Germany's display in their 2-1 UEFA Nations League defeat by world champions France as he lamented "a totally unjust penalty" awarded to the hosts.

Antoine Griezmann hit a pair of second-half goals, including the winner from the spot, as France recovered from falling behind to a Toni Kroos penalty to inflict a sixth defeat on Germany in their past 10 matches on Tuesday.

The result eliminated Germany from Nations League title contention, and left them needing to beat the Netherlands in their final group match on November 19 if they are to avoid relegation from the top tier.

However, Loew insisted he was "very pleased" with the performance as Germany were much improved compared to the team that lost 3-0 against the Netherlands in Amsterdam.

"I'm disappointed with the result, although though I must say the defeat is different to Saturday's," said Loew.

"Not because of the result but because of the performance. I'm very pleased with the performance.

"I think we were on an even level with what is probably the best team in the world.

"But France has a lot of individual quality, and if you're not careful you'll get punished straight away." A first defeat to the neighbouring Dutch in 16 years prompted Loew to make five changes for the trip to Paris, as he injected additional pace into the attack with the inclusions of Leroy Sane and Serge Gnabry.

The Germans deservedly led through a Kroos penalty after a sliding Presnel Kimpembe handled a Sane cross, but Loew's youthful frontline was unable to capitalise on further opportunities.

"The negative point is the converting of our chances. We were unable to put the ball in the goal," said Loew.

"I think we deserved to win because we were the best team but that's not how things work.

"We lacked a bit of intelligence and sangroid. If we'd been able to score a second we could have played in a calmer manner and won the match."

Griezmann equalised with a magnificent glancing header from a Lucas Hernandez cross on the hour, and the Atletico Madrid striker won

the game for France with a penalty 10 minutes from time.

'SOMETHING TO BUILD ON'

Loew was particularly unhappy with referee Milorad Mazic's decision to award France a spot-kick after Blaise Matuidi went to ground after a tangle with Mats Hummels.

"The penalty was totally unjust," said Loew.

"I've watched it back on the replay. Mats didn't touch Matuidi. He stepped on Mats' foot and then slipped."

That grievance aside, Loew singled out the positive contributions of Bayern Munich winger Gnabry, who made his first Germany appearance since November 2016, as well as Paris Saint-Germain defender Thilo

Kehrer. "It was a really good display from the young players," said Loew. "Gnabry played well and Kehrer too, it was first time he has started."

"It was a very, very good performance and something to build on for the future." Didier Deschamps' France can clinch top spot in the group with a draw in their final game away to the Netherlands in Rotterdam next month.

"It's a good thing in terms of our aim of finishing top of the group but we were up against a very good German side today," said Deschamps.

"Hugo (Lloris) ensured it was only 1-0 to them at the break and that we were still in it." Griezmann admitted Germany's revamped set-up had knocked France off track initially, but he said a series of "calm" exchanges at half-time allowed them to regain their rhythm.

"We played poorly in the first half. I think we were disrupted by them playing three at the back, so we had to calmly speak a bit in the dressing and change two or three things tactically," Griezmann told French television.

"It was better afterwards. It's more than tactical, we weren't making the effort for one another."

KOEMAN'S DUTCH HOLD BELGIUM

The Netherlands continued their resurgence under Ronald Koeman as youngster Arnaut Groeneveld's first international goal secured a 1-1 friendly draw with Belgium in Brussels.

Dries Mertens fired the World Cup semi-finalists into a sixth-minute lead, but Groeneveld marked his full debut for the Dutch by equalising before the half-hour mark on Tuesday.

This was another strong performance for the Oranje after Saturday's stunning 3-0 Nations League victory over Germany, while Roberto Martinez's Belgium remain unbeaten at home since a loss to Spain in September 2016.

"I think there is still a lot of work to do, but we've shown that we've made good progress lately and at the end of the match we tried to play more offensively to try to win," said Koeman.

"We had the best chances and overall we can be very happy with the last 10 days." The hosts struck early through a fantastic goal from Mertens, as the Napoli winger pounced after some slack Dutch defending, curling the ball past goal-

keeper Jasper Cillessen and two men on the line, and into the top corner.

The 31-year-old continued to run the visitors ragged, stretching to dig out an excellent cross which Romelu Lukaku could only head over from less than six yards out.

The Netherlands almost levelled after a quick counter-attack, but Memphis Depay failed to get a clean connection on his shot and was denied by the legs of Simon Mignolet, making his first appearance in the Belgian goal since March.

But the Lyon forward cut open the home defence in the 27th minute, sending through a perfect pass for Nigerian-born winger Groeneveld to slide home on just his second international appearance after coming on as a substitute against Germany.

The visitors continued to slice through the Belgium defence with ease, and Quincy Promes saw a fierce long-range strike bounce back off the post with Mignolet scrambling.

Eden Hazard, who has already scored 10 goals this season for club and country, should have restored the Belgian advantage before half-time, but shot wide with the goal gaping after Lukaku's clever lay-off.

Miranda silences Argentina

Brazil snatched a dramatic 1-0 win over Argentina with an injury-time header from Miranda in their friendly match in front of a sell-out crowd in Jeddah, Saudi Arabia.

The Inter Milan centre-back was left all alone to thump in a 93rd-minute effort from Neymar's corner when the match between the fierce South American rivals seemed destined for a stalemate on Tuesday.

The lapse spoiled an otherwise strong defensive performance from Argentina, who contained Brazil for long periods.

He may be 34, but Miranda, whose career has also seen him play in France and Spain, says he is far from done in the yellow shirt of Brazil.

"Despite my age I've been able to show that I'm in good physical shape and, of course, I want to keep playing for the national team because I still have a lot to show in this jersey," he said.

With Neymar to the fore, Brazil exerted late pressure and could have scored in the few minutes before Miranda struck.

Casemiro came close with a 25-yard free-kick manufactured by Neymar that flew past goalkeeper Sergio Romero's left post. Then Nicolas Otamendi stuck out a boot to deflect a diverted shot from Richarlison in the last minute.

Argentina's best chance came during a period of pressure around the hour mark, when Leandro Paredes hit a swerving, dipping drive that had



Brazil keeper Alisson beaten.

But while Brazil named a strong team including Manchester City's Gabriel Jesus, Philippe Coutinho of Barcelona and Liverpool's Roberto Firmino alongside Neymar in attack, Argentina were without a host of top stars, including Lionel Messi.

"It's always difficult, but our team is better than theirs because we've had the same foundations for many years while they're in the process of a drastic renovation," Brazil's full-back Felipe Luis told TV Globo.

Missing from the Argentina lineup were also Manchester City's in-form forward Sergio Aguero, Paris Saint-Germain winger Angel Di Maria and AC Milan striker Gonzalo Higuain.

Messi has sat out Argentina's last four matches, all friendlies, since the country's disappointing last-16 elimination from the World Cup in Russia.

He is believed to have asked for some time off from international duty ahead of next year's Copa America in Brazil.

It was the 105th time the South American arch-rivals have faced each other in an official match, with Brazil marginally ahead on 41 wins to 38, with 26 draws.

The two sides last met in June 2017 in a friendly in Australia, won 1-0 by Argentina, but Brazil romped to a 3-0 success in their last competitive fixture, a World Cup qualifier in November 2016.

Champions Chennaiyin eye first win

This was India's second athletics medal after Suraj Panwar clinched a Silver on Monday.



But on the other end, Mumbai's another star on the field Rohit couldn't make much use of the opportunity to get match practice before resuming national duty and was bowled by Mehdi Hasan for 17 of 24 balls in the fifth ball of tenth over.

Hasan strikes again in the next over and this time he caught big fish Prithvi Shaw in the similar fashion, who was also sent to the dugout leaving Mumbai's scorecard read 82 for 2 in 11.5 overs.

Shaw's knock had eight fours and two sixes.

However after that skipper Shreyas Iyer and Ajinkya Rahane batted sensibly and didn't allow Hyderabad bowlers to do much damage.

Earlier, Hyderabad posted 246 for eight after Rohit

Rayudu scored a 132-ball 121, which went in vain.

The knock was studded with eight boundaries and four sixes.

Hyderabad had a dismal start with openers Tanmay Agarwal (11) and Akshath Reddy (7) returning to the pavilion early.

Rayudu and Bavanaka Sandeep (29) then stitched a vital 50-run stand for the third wicket. Tail-ender Mehdi Hassan made 23 off 17 to help Hyderabad put on board a respectable total.

For Mumbai, Tushar Deshpande was the lead wicket-taker with three wickets for 55 runs and Royston Dias bagged two for 43. Pacer Dhawal Kulkarni, Shivam Dubey and Shams Mulani snapped a wicket each.
