## PC on run as CBI-ED give chase

Ex-FM evades arrest after HC dismisses bail plea, SC refuses instant relief in INX Media case

PNS ■ NEW DELHI

Former Finance and Home Minister P Chidambaram is on the run from the law after the Supreme Court on Tuesday refused to come to his rescue following the Delhi High Court's dismissal of his bail plea in the INX Media bribery case. Soon after the apex court's denial of relief, sleuths of Enforcement Directorate and CBI landed at Chidambaram's home in Jor Bagh, but the senior Congress leader could not be traced.

Chidambaram, who enjoying interim protection from arrest from March 2018 onward, suffered a major setback on Tuesday afternoon after the Delhi High Court dismissed his anticipatory bail plea, paving way for CBI and ED to arrest him. The former Minister was on the Supreme Court complex throughout the day, awaiting the HC order, to approach the SC.

The High Court held that he was "prima facie the kingpin" in the INX Media bribery and money laundering cases and "simply because he is a Member of Parliament it would

not justify grant of pre-arrest bail to him". Holding that the former Union Minister's custodial interrogation was required for an effective investigation, the High Court said, "granting bail in cases like the instant one will send a wrong message to society".

Justice Sunil Gaur, who is due to retire on Thursday, said this court cannot permit the prosecution in this "sensitive case to end up in smoke like it

has happened in some other high-profile cases".

"Facts of the case prima facie reveal that petitioner is the kingpin, that is, the key conspirator in this case.

Law enforcing agencies cannot be made ineffective by putting legal obstacles," the judge said.

The High Court also said this was a "classic case of money laundering" and the twin facts which have weighed

to deny pre-arrest bail to him are "gravity" of the offence and "evasive" replies given by him to questions put to him while he was under protective cover extended to him by this court.

In the Supreme Court, all Congress lawyers were present before the Registry for urgent hearing. However, the apex court did not grant any relief, asking Chidambaram to mention the case on

Wednesday morning before a senior-most judge.

The High Court said, "It cannot be forgotten that the petitioner (Chidambaram) was the Finance Minister at the relevant time and he had given FDI clearances to INX Media Group for receiving overseas funds to the tune of ₹305 crore."

The 24-page judgment said the gravity of offence committed in this case amply justifies denial of pre-arrest bail and it was of the prima facie opinion that it was not a fit case for granting the relief to him.

It said, "Economic offences

constitute a class apart and need to be visited with a different approach in the matters of bail.

### Nath's nephew Ratul Puri held for bank fraud

The Enforcement Directorate (ED) has arrested Madhya Pradesh Chief Minister Kamal Nath's nephew Ratul Puri in a fresh case of money laundering linked to an alleged ₹354 crore bank loan fraud case registered by the CBI last week.

Puri was placed under arrest under the Prevention of Money Laundering Act (PMLA) late on Monday night after he appeared before the ED here which slapped a fresh criminal case against him and others, taking cognisance of the CBI FIR.

Puri was produced before Special Judge Arvind Kumar and the agency sought 14-day custodial interrogation in another money laundering probe related to AgustaWestland copter scam.

## PMO puts road projects on hold over finances

Due to fiscal implications, the PMO has put on hold all new projects as well as "in-principle approvals" already given to several State roads and national highways' projects. A high-level inter-ministerial panel headed by Cabinet Secretary PK Sinha will now prepare a new set of comprehensive guidelines for approving and announcing projects.

Sources said the PMO has acted to enforce fiscal discipline to avoid any burden on the exchequer at a time when the Ministry is facing fund constraints. The fund constraint has prevented private developers from bidding for projects. Bids have not been invited for at least seven projects in last one month, sources said.

The Road Transport and Highways Ministry recently expressed its desire to become the primary agency to manage the Central Road and Infrastructure Fund (CRIF or the erstwhile Central Road Fund). In the past, the funds were disbursed by the Finance Minister.

In an effort to strengthen the finances of Road Ministry, Gadkari went for raising resources through borrowings, including bringing in up to ₹60,000 crore from the National Infrastructure Investment Fund for Delhi-Mumbai Expressway, ₹25,000 crore from SBI, ₹7,000 crore from ADB, and a similar amount from World Bank, LIC, pension fund and Labour Ministry.

Road and Transport Minister Nitin Gadkari has taken steps to declare

### New panel to prepare norms for approval

State Highways as National Highways, which means roads being maintained or developed by States will directly fall under the jurisdiction of the Centre.

The PMO has asked the Road Ministry to review the whole process and seek approval from the PMO before making any further decisions. There are no guidelines for declaring a State road as NH and it happens after the States request the Centre for taking over their roads as NH.

Following a meeting in March, Nripendra Misra, Principal Secretary to the PM, had also directed the expenditure secretary to conduct an inquiry into the role played by the road transport Ministry's financial advisers in deviating from the existing system of declaring national highways.

Earlier in March this year, sources said, Principal Secretary in the PMO, Nripendra Misra, had asked the expenditure secretary to order a probe as to how the existing system of declaring NHs was violated. The probe is still on.

### Metro's Aerocity to Tuglakabad stretch to run above flyover

The Delhi Metro Rail Corporation on Tuesday issued tender for the construction of double viaduct corridor for the elevated sections of the Aerocity to Tuglakabad in Phase IV.

For the first time Delhi will have an elevated 4.2km long metro section and 2.4 km six-lane flyover on the second deck and a surface road below that. The four stations that will be constructed are Sangam Vihar, Khanpur, Ambedkar Nagar and Saket G Block.

Besides, a 430-metre six-lane underpass will be constructed at Saket-G at Mandir marg crossing.

On this section, the Metro viaduct shall be on the upper deck at an elevation of 18 metres, while the road flyover will be on lower deck at height of 9.3 metres.

## Sonia persuades Hooda to close ranks

A week after taking over as Congress' interim chief, UPA chairperson Sonia Gandhi swung into action on Tuesday reaching out to veteran Bhopinder Singh Hooda, who seemed determined to break away from the grand old party in the run-up to the forthcoming Haryana Assembly polls.

Sources in AICC said Sonia rang up Hooda in the afternoon and discussed the prevailing political turmoil in the poll bound State. After their telephonic conversation, sources said senior leaders of the party requested Hooda to postpone his scheduled Press conference in Chandigarh on Thursday.

AICC sources said Hooda wants to have a free hand in managing the Assembly polls and was fed up with State Congress leaders like Ashok Tanwar, who were not letting him have his way.

"It was a routine call from

Soniaji to Hooda to talk about State Assembly elections. Nothing should be read in between as Hooda was present at the AICC headquarters for the flag-hoisting by Sonia Gandhi on Independence Day," said the party sources.

Hooda and his son Deepender Hooda, along with a dozen MLAs, have been reportedly planning to leave the Congress to form a new party and tie up with NCP, AAP, and Dushyant Chautala's Jannayak Janata Party (JJP) for Haryana and Delhi Assembly polls. In Haryana, elections are scheduled to be held before November 2019, while in Delhi, it is due in February 2020.

On Sunday while appreciating the Modi Government's stand on abrogation of Article 370, Hooda indicated that he was getting ready to break free from the mother organisation.

With Hooda forming a committee and clarifying that

he would do whatever the committee conveyed to him, the ball was in Sonia's court.

Hooda's main contention is that State Congress presi-

dent Ashok Tanwar should be replaced immediately with a new one ahead of elections. He has been demanding this for more than a year.

## Yamuna to witness peak & trough today

### 14,000 living in low-lying areas along the river bank have been evacuated

With the water level in Yamuna rising on the second day on Tuesday after crossing the "danger mark", the Delhi Government has shifted people living adjacent to the Yamuna and in low-lying areas to relief camps.

The river was flowing a metre above the danger mark (206.25 metres) at 1 pm on Tuesday and may rise further after Haryana released 25,590 cusec of water from the Hathni Kund barrage on Tuesday. On Monday, the river crossed the danger mark of 205.33 metres at 6 pm.

The water level is further expected to touch 207 metres by Wednesday morning before beginning to recede.

Delhi Transport Minister

Kailash Gahlot inspected the relief camps set up by the Delhi Government at Haathi

Ghat and Kanchan Colony. "Inspected Relief Camps at Haathi Ghat and Kanchan Colony set up by Delhi Govt. Interacted with people who have been evacuated and now staying in relief camps. Have

directed area DMs to ensure availability of all the relief materials," Gahlot tweeted.

The administration has deployed 30 boats in low-lying areas prone to flooding to prevent accidental drowning.

Besides, 53 boats have been put on standby to tackle any eventualities. The authorities have alerted residents about increasing water level in Khajuri Khas, Wazirabad, Usmanpur, Mayur Vihar, Burari and Seelampur.

Meanwhile, the Northern Railway has restricted the speed of trains on the Yamuna Bridge to 20 kmph. Gearing up to tackle any eventualities, the Delhi Government has also set up tents opposite Mayur Vihar Extension with a capacity of accommodating 23,000 people during flooding.

On Tuesday, the Delhi Government agencies placed sandbags near the shores of Yamuna at the Loathian bridge and areas surrounding ISBT. To avoid any untoward incident, the BSES disconnected the electricity lines going below the Loathian Bridge and the e-erickshaw charging point near the bridge.

## Abhinandan's captor killed while trying to push in infiltrators

A Pakistani commando who was behind the capture of Commander Abhinandan Varthaman when his IAF jet crashed in Pakistani territory in February this year, and had reportedly tortured the IAF pilot, has been killed in firing by Indian forces along the Line of Control (LoC).

According to reports, Ahmed Khan, a subedar with the Pakistan Army's Special Service Group, was killed by the Indian Army in Nakyal sector of the LoC on August 17 when he was trying to facilitate infiltration into India.

In photos released by Pakistan after Abhinandan's capture on February 27, the bearded Khan can be seen behind the IAF officer. Abhinandan was captured after his MiG 21 was shot down by Pakistani forces when he went chasing after a Pakistani jet in the aftermath of the Balakot airstrike.

It is reported that Ahmed Khan used to facilitate infiltration in the Nowshera, Sundarabani and Pallan Wala sectors. He was specially roped in by the Pakistan Army to facilitate infiltration.

Sources said that Khan

used to mobilise well-trained militants of Jaish-e-Mohammed (JeM) outfit at a forward post as part of Pakistan's plan to keep terrorism alive in Kashmir.

On August 17, India retaliated fiercely to Pakistan launching a mortar fire attack on Indian forces in the Krishna Ghati sector in Poonch. Pakistan was firing mortar shells to allow infiltrators to enter India. Khan was killed in the return fire by India.

RAIN HAVOC IN HIMACHAL

63 people died this monsoon: CM

As many as 63 people have lost their lives in Himachal Pradesh this monsoon season, while 25 of them were killed in heavy rains in the last few days, Chief Minister Jai Ram Thakur informed the Monsoon Session of state assembly on Tuesday.

Replying to a discussion on the second day of the monsoon session, Thakur said the state suffered a total loss of ₹ 625 crore due to damaged roads, water lines and power transmission since July 1.

The state government is working on a war footing to restore all the damaged roads, water and power supply at the earliest, the chief minister said. Over 1,000 roads, several bridges, PWD property, water lines had been fully or partially damaged due to heavy rains, he said.

The public works department (PWD) suffered the highest loss of ₹ 323 crore, followed by ₹ 269-crore loss to the irrigation and public health department, he added.

MINISTER AIRLIFTED

Himachal Pradesh Agriculture Minister Ram Lal Markanda was on Tuesday airlifted to capital Shimla from tribal district Lahaul and Spiti. Talking to reporters outside the state Assembly, Markanda said Chief Minister Jai Ram Thakur had sent his helicopter to airlift him so that he could attend the ongoing monsoon session. Markanda, who is the legislator from Lahaul and Spiti, was stranded in the tribal district due to untimely snowfall. At least 150 persons are still stuck there and they will hopefully be

rescued by Wednesday morning, the MLA said, adding that almost all the roads in the district have been damaged.

MONSOON SUBDUED IN HIMACHAL

After three days of heavy showers which led to snapping of several road links following landslides, Himachal Pradesh on Tuesday saw subdued rainfall activity, the Met office here said. Most of the rivers that were in spate saw a decline in water levels. Traffic on a majority of the highways and link roads was restored.

Officials said there was no heavy rainfall in the state but precipitation occurred at some places in the state since Monday. Weather conditions would likely to be mostly dry in the state with light rainfall at some places.

Shimla got 32.3 mm of rain, while Manali received 16 mm, Dalhousie 9 mm and Una 5.2 mm.

Authorities said excess water was discharged from the Pandoh diversion dam, located 112 km upstream of Pong dam, as a precautionary measure.

CM campaigns, highlights achievements of Haryana Govt

He also inaugurated the upgradation of PHC Brara to CHC at a cost of about ₹ 675 lakh. Apart from this, he also inaugurated a new ITI in village Nohani constructed at a cost of ₹ 900 lakh. MPs Sanjay Bhatia and Nayab Singh Saini, MLA Aseem Goyal, and others were present.

IOCL to invest ₹800 crore in Punjab

Indian Oil Corporation Limited (IOCL) will soon invest nearly Rs 800 Cr. in Punjab and neighboring states, Subodh Dakwale, ED, Corporate Communications & Branding along with Sujoy Choudhury, ED, Punjab State Office for J&K, HP, Punjab and Chandigarh said here.

Addressing a news conference, they said the Company has already invested ₹ 220 Cr in bottling plants of Bhandina and Goindwal which will be operational soon. The capacity of the new plants would be 60 TMT per annum and would have 3 mounded LPG storage vessels of 600 MT each. The plants would be fully automated with provisions for solar lighting and rain water harvesting system.

Chaudhury said that out of total 134 lakh active LPG connections in PSO, IndianOil alone has 67 Lac connections with more than 50% market share. To ensure safe LPG usage among users, more than 70 LPG Panchayats have been held since April this year, he added.

**REPORT SOUGHT FROM AMRITSAR SSP, CS IN RAPE CASE**  
Chandigarh: Punjab State Women Commission, taking strong note of the matter casting serious aspirations on the role of district's police and district health authorities for not conducting the medical examination of the rape victims even after four days of the incident, on Tuesday sought detailed reports from Amritsar (Rural) SSP, and Amritsar Civil Surgeon by August 26. "The reports alleged that the Police, instead of doing its duty, was exerting pressure on the victim for compromise with the opposite party," said the Commission chairperson Manisha Gulati. She said that Amritsar Civil Surgeon was also directed to explain that why the victim was sent to Ajnala to procure the medical kit for medical examination which is 20 kilometres away from Amritsar. Likewise, the report was sought from Amritsar Rural Senior Superintendent of Police (SSP) by August 26.

# ₹1,700 cr loss in Punjab due to rains

The 72-hour incessant rain across Punjab has led to a loss of nearly ₹1,700 crores, as per the initial estimates. Even as the state witnessed no fresh spell of rain on Tuesday, the flood-like situation prevailed in many parts of Punjab with the administration ordering evacuation of several other villages in Fazilka. As many six-seven districts have been affected by the heavy rains that battered the state in the past three days. The rescue and relief operations, with the coordinated efforts by the district administration, army, and the National Disaster Response Force (NDRF), continued for another day. In Sultanpur Lodhi and Zira, as many as 60 persons were rescued in the wake of the floods triggered by incessant

rains and rising river water levels. On the 'no-rain-day', the water-level started receding in some of the affected areas. However, many villages in Ludhiana, Rupnagar (Ropar), and Jalandhar remained inundated due to breaches in bundhs (earthen dams) of the Sutlej river. The Union Cabinet Secretary PK Sinha also reviewed the prevailing flood situation in the state, along with Himachal Pradesh, Haryana, Uttarakhand and Delhi, during a high-level meeting of National Crisis Management Committee with the top officials. He also directed the officials to provide immediate assistance, as sought by the states, to meet the crisis while taking stock of the current situation, preparedness, rescue and relief operations.

Punjab Chief Minister Capt Amarinder Singh said that the damage caused in the State by the floods caused by the unprecedented rains is estimated to be around Rs 1,700 crores, but "the State Administration is fully geared to meet any eventuality and will safeguard the lives of the people at all costs". Following heavy rains in past few days and release of excess water from the Bhakra Dam, the swollen Sutlej river and its tributaries had inundated villages in several areas, including Ludhiana, Jalandhar, Ferozpur and Rupnagar, causing extensive damage to crops, especially paddy, and houses in low-lying areas. Rescue operations were being carried out in the affected villages by teams of the National Disaster Relief Force (NDRF), State Disaster Relief

Force (SDRF), which were assisted by district authorities in the affected areas. In Jalandhar, the Deputy Commissioner Varinder Kumar Sharma, along with Senior Superintendent of Police Navjot Singh Mahal, took stock of the situation on Tuesday morning in Mandala village where people were being rescued with the help of the NDRF. The officials said that boats were pressed into service to evacuate villagers from flood-hit areas. Due to breaches in earthen dams of the Sutlej river, Phillaur, Shahkot and Lohian Khas in Jalandhar were flooded. District authorities in the affected areas have set up relief camps in order to evacuate stranded villagers to safer places, the officials said, adding that all arrangements, includ-

ing food and water, have been made there. Only a day before, the Chief Minister had announced ₹100 crore for emergency relief and rehabilitation measures. The State Government had also declared the flood situation in the affected villages as a natural calamity. Keeping a close watch of the water levels in the reservoirs, the Bhakra Beas Management Board held a meeting of three partner states — Punjab, Haryana, and Rajasthan — to discuss the situation if the inflow into the reservoir continues unabated. Only a day before, the BBMB had decided to increase the release of excess water through spillway gates from 19,000 cusecs to 41,000 cusecs after water level in the Bhakra Dam crossed its permissible limit of 1,680 feet.

# Punjab Finance Minister urges people not to burn paddy straw

Punjab Finance Minister Manpreet Singh Badal on Tuesday exhorted the people of Punjab and Haryana not to burn paddy straw as that would be a true tribute to the Guru Nanak Dev, especially with the ongoing 550th Parkash Purab celebrations. Manpreet, talking to the media personnel after attending a public function at Bathinda, said that taking a pledge not to burn stubble and paddy remnants will be in tune with the message of 'Sarbat Da Bhalla'. "In this way, Punjabis could set a remarkable example of environmental consciousness and also spread the message of Guru Nanak Dev," he said.



Quoting Guru Nanak Dev, he said that the great guru has referred to air as guru, water as father, and earth as the great mother of all, "but by burning agricultural residues, we are defiling air, which has been described as our guru". Manpreet said that if the founder of the Sikh faith had treated air, water and earth with such reverence, "we

should follow the teachings and not defile and pollute our environment. By not following the message, we are drifting away from the path that has been so beautifully prescribed for us". Millions of pilgrims and general public from across the globe is expected to converge in Punjab for the auspicious occasion, he said.

# Punjab launches Sarbat Sehat Bima Yojna

In a tribute to late former Prime Minister Rajiv Gandhi on his 75th birth anniversary, Punjab Chief Minister Capt Amarinder Singh on Tuesday launched his government's flagship universal health insurance scheme 'Sarbat Sehat Bima Yojna', benefitting nearly 46 lakh families. E-cards were handed over to the first 11 beneficiaries from Mohali district to kick off the scheme, which would entitle beneficiaries to avail annual cashless treatment up to Rs five lakh per family per year, including pre-existing diseases, was aimed at ensuring the best possible treatment to the beneficiaries free of cost. With this scheme, covering 76 percent of its population, Punjab has become the first state in the country to offer medical insurance cover to the maximum number of its people, the Chief Minister announced, dedicating the welfare initiative to Rajiv Gandhi. His government was committed to fulfilling the aspirations of the people with the vision of the country's youngest prime minister, he added. Notably, the State Government had decided, a few months ago, to extend the



Pradhan Mantri Jan Arogya Yojana (PMJAY) to provide cashless health insurance cover of Rs five lakh per family per year to more 31 lakh families. While the cost of the premium for 14.86 lakh families, originally covered under PMJAY, as per SECC data, is being borne by the Centre and State in 60:40 ratio, for the rest of the beneficiaries, the state will bear the entire cost of the premium. "It took the Government several months to draw the roadmap for the implementation of the cashless treatment scheme to cover 76 percent of its population, in sharp contrast to the 12 percent that would have been covered otherwise

under the Central Government's PMJAY scheme. Similar schemes in other states had covered up to a mere 30 percent of their population," said Capt Amarinder. The Chief Minister recalled Rajiv's proactive role in sanctioning approval for setting the first multi-national project in Punjab in the form of Pepsi. "I was then Punjab Agriculture Minister and had submitted a proposal to PMO for setting up this plant, which was vital for state's diversification plans. I still remember how, exactly on the eighth day, I got a message that PM wanted to meet me and the project was approved," the Chief Minister said nostalgically. Giving details of the Sarbat Sehat Bima Yojna, the Chief Minister revealed that it would cover a total of 20.43 lakh smart ration card holder families, in addition to 14.86 lakh families enrolled as per Socio Economic Caste Census Data, 4.94 lakh farm holder farmer families, 2.8 lakh small farmers, and more than 2.38 lakh construction workers registered with the State Construction Welfare Board, besides 46,000 small traders. The scheme has also been extended to around 4,500 journalists accredited to the state or holding yellow cards, he said. Equipped with specially designed 1396 treatment packages, the scheme will be implemented through more than 450 empanelled hospitals, including 200 government hospitals. Of the total premium of Rs 333 crores under the Mahatma Gandhi Sarbat Sehat Bima Yojna, the state's share is 83 percent, which amounts to Rs 276 crores, while the Central Government would be paying the remaining Rs 57 crores. Surgical packages under the scheme also include the cost of pre-hospitalization for three days and post-hospitalization for 15 days.

# NGT calls for effective mechanism to check river pollution


The Monitoring Committee, constituted by the National Green Tribunal (NGT), on Tuesday emphasized the need to put in place an effective mechanism for cleaning of rivers to make Punjab clean, green and pollution free. Reviewing the progress of action plan chalked out for the cleaning of rivers in its sixth meeting, the monitoring committee chairman Justice (retired) Pritam Pal asked the renowned environmentalist Baba Balbir Singh Seehwal to ensure cleaning of Buddha Nullah in Ludhiana on the scientific lines besides roping in all religious, social and non government organizations to undertake this noble cause in a mission mode. He also asked the Punjab Pollution Control Board (PPCB) and Municipal Corporation Ludhiana to extend all possible assistance for the execution of this pious task likely to begin in the last week of September. To create awareness amongst the industrialists about the hazardous impact of pollution on natural resources and human life, the Committee also decided to organize a mega workshop at Ludhiana to

# Make necessary arrangements: Hry CM to DCs of flood-hit districts

With water level in the Yamuna rising, Haryana Chief Minister Manohar Lal Khattar on Tuesday directed all the deputy commissioners of the affected districts in the state to make necessary arrangements to deal with any adverse situation. Khattar spoke over phone with DCs of Yamunanagar, Kaithal, Kurukshetra, Karnal and Sonapat, giving them necessary instructions to extend all kinds of assistance to people affected due to heavy rains and floods in these districts, an official spokesperson said here. Directions had been issued to evacuate people from the affected areas of Yamunanagar, Kaithal, Kurukshetra, Karnal, Panipat and Sonapat. The water level of the Yamuna has recorded the "highest increase" till date, due to recent heavy rains, Haryana Chief Secretary Keshni Anand Arora said on Tuesday. In view of the prevailing flood situation, 25 families have been safely evacuated from Sonapat and Karnal districts. All arrangements have been made by the state government to deal with any adverse situation, she said. Arora informed this through video conferencing in a review meeting held on the flood situation in Haryana, Punjab, Uttarakhand, Himachal Pradesh and Delhi, which was held under the chairmanship of Union Cabinet Secretary, Pradeep Kumar Sinha, on Tuesday. During the meeting, Arora



said that 8.14 lakh cusecs of water was recorded in the Yamuna in 2013, which was the highest till that year. This time, the water level in the Yamuna has increased to 8.28 lakh cusecs, she said. Arora said that after Delhi, this water would reach Faridabad and Palwal districts of Haryana. Therefore, about



500 families have already been evacuated from low-lying areas along these two Haryana districts. She said Markanda, Tangri and Ghaggar rivers has also recorded slight increase in water level, but now the water level has started to recede. In the Yamuna, water level rose dangerously at Hathnikund

barrage in Yamunanagar on Sunday. Many rivulets also join the swollen Yamuna in Haryana and Uttar Pradesh before it enters the national capital. Haryana's Department of Revenue and Disaster Management had on Sunday issued a high flood warning, alerting Deputy Commissioners of Karnal, Panipat, Sonapat, Faridabad and Palwal. The Yamuna river discharge at 6 pm on Sunday was 8,28,072 cusecs which was categorised as a "high flood" situation. Arora said the water level of rivers is constantly being monitored. "Adequate arrangements have been made by the government to deal with any adverse situation," she said.

# Punjab CM slams Akalis for obstructing Bargari probe

Lambasting the Akalis for their "perverse and desperate" attempts to obstruct the investigations into the Bargari sacrilege case, Punjab Chief Minister Capt Amarinder Singh on Tuesday said that the State Government had already moved the court against the CBI closure report to enable the State to pursue the probe to its logical conclusion. Capt Amarinder, in an informal chat with media-persons after launching health insurance scheme, said that the then SAD-BJP government had deliberately hand-



led over the sensitive case to the CBI in the first place and the agency had played to the tune of its masters by closing the matter without completing the probe. In response to a question, Captain Amarinder also

lashed out at SAD president Sukhbir Badal for trying to manipulate the facts about the late former Prime Minister Rajiv Gandhi in the context of the 1984 riots. "Sukhbir himself was in the US at the time and had no clue what was happening in India at the time," he said, adding that Badal Junior was in the habit of blabbering without any substance. Asked to comment on the current state of the Indo-Pak relations, the Chief Minister hoped that Pakistan would honour its commitment and would complete the Kartarpur Corridor as planned.

# Animal adoption scheme fails in Hry; only 24 takers in 8 years

The animal adoption scheme which was launched by the Haryana department of Forest and wildlife in 2011 has failed to click in the state as only 24 people turned up in eight years. This include Ministers, Forest officers, retired judge and some local residents. This scheme was brain child of then Haryana Minister of Forest and Environment Capt Ajay Yadav. However, it did not find enough takers. All animals adopted are symbolic as they remain within the zoo premises. On condition of anonymity a department officer said that the Haryana government had launched the scheme taking a cue from Punjab but found few takers for it. Under the scheme, the department has so far received less than Rs 8 lakh, Rs 7,94,800 from 24 people in eight years. Haryana Principal Chief Conservator of Forests (Wildlife) VS Tanwar said, "In order to generate love for animals and birds among the people, Haryana department of



Forest and wildlife had started a scheme for the adoption of animals and birds in zoos and deer park of the State on January 7, 2011. People were motivated to adopt birds and animals though various mediums in the state. One can adopt any animal, big or small after completing necessary procedure," he said. The adoption programme enables individuals, corporations, schools, clubs, families and groups to participate and make a valuable contribution towards the care and enrichment of the animals living here, Tanwar said, adding the

adoption fee not only helps the zoo to take care of the animals, but also goes towards the protection of endangered species. All animals adopted are symbolic adoptions and remain within the zoo. Tanwar said that the adoption of animals by any person will not only show his/her love or fascination for wildlife conservation but will also inspire others to follow suit. The adoption of animals on ceremonial occasions like birthdays and anniversaries among others will prove to be unique gift for mankind towards Wildlife Conservation. He said that there are three mini zoos in Haryana at Pipli (Kurukshetra), Rohtak and Bhiwani. There is also one Deer Park in Hisar district located on Dhansu road. All the above zoos and deer park have wild animals and birds to educate the public particularly school children and farmers about habits and habitat of wildlife. Moreover, after launching the scheme, former Minister of Forest and Environment Yadav had set an example by adopting a Black Buck for Rs 22,500 at Pipli Mini Zoo for one year. Kurukshetra MP Naveen Jindal who paid Rs 5 lakh to adopt several animals like 10 Black-Buck, one Spotted Deer, one Hog Deer, two Barking Deer, five Bonnet Monkey, two Langour, two Silver Pheasant and six Cockatiel at Pipli Mini Zoo. Kumari Selja, former Union Minister of Social Justice and Empowerment had also adopted one Barn owl for Rs 12,000 at Bhiwani zoo. Five IFS officers -- Parvez Ahmed, SR Jotriwal, SS Jattan, RK Sapra and KS Chauhan had

also adopted the animals. While RK Sapra and SS Jattan shelled out Rs 10,000 each to adopt 10 birds each, Parvez Ahmed, CR Jotriwal and KS Chauhan paid Rs 22,500 each for Spotted Deer, Sambhar and Black Buck, respectively. A retired Sessions judge, Hari Ram also adopted a Baboon for Rs 8,500 while a psychologist Rajesh Kumar of Rohtak, adopted 25 budgerigars and a love bird for Rs 1300. Another forest officer said that one can contribute manifold in Wildlife Conservation



by adopting animals through providing feed for them monthly/annually. A day after Prime Minister Narendra Modi flagged the issue of Pakistan's rhetoric over Jammu and Kashmir during his telephonic conversation with US President Donald Trump, Defence Minister Rajnath Singh on Tuesday held talks with his US counterpart Mark T Esper on the phone and raised the issue of cross-border terrorism. The US Defence Secretary termed abrogation of special status under Article 370 for Jammu and Kashmir as internal matter of India.

ing to abrogation of provisions of Article 370 of the Constitution are internal matters of India.

He also said the steps to remove Article 370 are aimed at improving growth and economic development, democracy and prosperity for the people of Jammu and Kashmir. "The US secretary of defence appreciated India's position that the recent developments in Jammu and Kashmir are internal matter of India. He hoped that any issue between India and Pakistan will be resolved bilaterally," defence ministry officials said later.

Both the Ministers expressed happiness at the significant progress in bilateral defence cooperation and reaffirmed their commitment to strengthen and deepen the relations further. They exchanged views on a range of issues related to military-to-military cooperation, defence policy, R&D cooperation, defence trade, technology and industrial cooperation.

Earlier in the day, in an apparent reference to the Balakot air strikes to destroy

"We are all aware that the Indian (Air) Force is a techno-

logically advanced and extremely potent force. The recent offensive strikes against terrorist outfits in our neighbourhood speak volumes about the reach and lethality of the formidable arm of the Indian armed forces," Singh said in his address at an IAF seminar here on indigenisation and modernisation.

## IAF chief stresses on modernisation, says force still flying 44-yr-old MiG

New Delhi: Stressing the need for faster modernisation of the IAF, Air Chief BS Dhanoa on Tuesday said the force is still flying the 44-year-old MiG-21 fighter jets when "nobody is driving cars of that vintage". He said this in the presence of Defence Minister Rajnath Singh during a seminar on modernisation and indigenisation. The Air Chief said the basic version of the fighter jet will be phased out this year. "Hopefully, I will fly the last sortie in September, subject to visibility," he said. The aircraft was in service for decades because of the overhauling using Indian-made components. "Over 95 per cent of components required in overhauling is made in India. The Russians are not flying the MiG but we are because we have overhaul facilities," he said. The MiG-21s were inducted into the IAF in the early 70s and several aviation experts besides services personnel were for last many years stressing the need for phasing out the jet. More than 100 MiG-21s were upgraded in 2006 to MiG-21 Bison with powerful multi-mode radar, better avionics and communications systems. Dhanoa has flown the MiG-21. In May 2017, he led a four-aircraft 'Missing Man' formation in honour of the servicemen killed during the Kargil conflict.

### Athawle, Paswan dismiss Bhagwat's comment, say quota constitutional right

There is no need to discuss it: RPI, LJP leaders

In the backdrop of RSS head Mohan Bhagwat again stirring the reservation debate, the chiefs of the ruling National Democratic Alliance (NDA) constituents, Republican Party of India (RPI)'s Ramdas Athawale and Lok Janshakti Party (LJP)'s Ram Vilas Paswan, on Tuesday, dismissed any discussion on the issue saying "there is no need for it".

Both the Dalit leaders, who are also Union Ministers, asserted that reservation was a "Constitutional right" and there was no case for re-revisiting the subject.

Dalit group Bhim Army leader Chandrashekhar Azad also joined issue challenging the RSS chief to an open debate on the issue of reservation even as he sought a discussion on the abolition of caste system which, he said, has "hollowed out" the country.

Catering to the exclusive Dalit constituency, Paswan said that Prime Minister Narendra Modi has reiterated it many times that it cannot be tampered with. "There is no need for any debate on reservation. This is now available even to the upper castes poor so it is impossible that it will be ended," he told reporters.

Paswan, however, did not react directly to Bhagwat's comments, saying he had not got details of his remarks. "Opposition parties are trying to fuel a controversy. But I believe their lies are not going to cut ice with the people," Paswan claimed.

Union minister and RPI leader Ramdas Athawale also rejected the need for a debate on reservation in the country and said the Modi government should not be perceived as anti-Dalit.

Addressing a press conference in Kolkata, Athawale also said reservation has been pro-

RSS has dangerous intentions, says Priyanka Gandhi

New Delhi: The RSS' clarification notwithstanding, Congress leader Priyanka Gandhi Vadra on Tuesday accused the Sangh of having "dangerous intentions", and said its chief Mohan Bhagwat pitching for a debate on reservation was just an excuse but the real target of the RSS-BJP is social justice. "The confidence of the RSS is high and intentions are dangerous. At a time when the BJP government is throttling pro-people laws, the RSS has also raised the issue of debate on reservation," she said in a tweet in Hindi.

vided by the Constitution and no one can take it away from the backward section of the society. "Whatever Mohan Bhagwatji had said the RSS has clarified it. I want to assure the Dalits of this country that there is no question of debate or rethinking on the issue of reservation."

The RSS on Monday dismissed as "needless" the row over Bhagwat's remarks, asserting that he merely stressed on the need for mutual talks in harmony within society to address any issue.

Azad claimed that 54 per cent of the people belonging to Scheduled Castes do not own any land in the country, while a particular caste dominates and enjoys all privileges. "He (Bhagwat) wants the issue to be discussed among those who are against reservation. I challenge him to hold a debate in front of the media and all concerned. We want to tell people about all that we (Dalits) have suffered because of the caste system. He should come armed with all statistics," Chandrashekhar said.

Bhagwat on Sunday said there should be conversation on reservation between those who are in its favour and those who are against it. The RSS head hit a similar controversy when BJP was in the thick of Bihar electoral contest in 2015.

## 'Housing for All' target under PMAY-Urban will be achieved in 2020: Hardeep Singh Puri

Union Minister for Housing and Urban Affairs Hardeep Singh Puri on Tuesday said the target of 'Housing for All' under Pradhan Mantri Awas Yojana-Urban (PMAY-Urban) will be achieved in 2020, two years before the deadline. The Minister said that under the PMAY-Urban, 24 lakh houses have so far been handed over to beneficiaries and the number will soon reach 50 lakh.

There are 48 lakh houses which are currently grounded,

but this number will also rise to 75 lakh, Puri told reporters on the sidelines of an event.

"We had decided to build one crore houses by 2022. We have already sanctioned around 84 lakh houses and I am fully confident that by the end of this year, the entire one crore houses will be sanctioned," the minister said.

"We have also received additional assessment demand of constructing 12 lakh more houses...The target of 2022 will be achieved in early 2020," he added.

The minister exuded confidence that government will be able to fast track completion work of houses under the PMAY (Urban). Addressing the 15th National Convention of NAREDCO, Puri said the enactment of real estate law -- RERA, "builder-politician nexus" has been broken, and that home-buyers will no longer be at the mercy of anyone.

## Linking profile with Aadhaar: SC to hear FB's plea for transfer of cases

The Supreme Court on Tuesday agreed to hear a plea of Facebook Inc for transfer of cases related to demands for linking of social media profiles of users with Aadhaar number, pending before the high courts of Madras, Bombay and Madhya Pradesh to the apex court.

The top court issued notice to the Centre, Google, Twitter, YouTube and others and sought their response by September 13.

A bench of justices Deepak Gupta and Aniruddha Bose said the notices to unserved parties should be sent through e-mail.

The bench said the hearing in cases related to linkage of social media user profiles with 12-digit Aadhaar number, the Biometric Unique Identity, pending before the Madras

High Court will continue but no final order will be passed.

Attorney General KK Venugopal, appearing for the Tamil Nadu government told the bench that the Madras High Court has conducted 18 hearings so far and it should be allowed to conclude the argument and deliver the verdict in the cases.

Senior advocates Mukul Mohatgi and Kapil Sibal, appearing for Facebook and instant messaging app WhatsApp, respectively, said whether service providers can be asked to share data with probe agencies to help them in criminal investigation needs to be decided by the apex court as it will have a global effect.

They said that both Facebook and WhatsApp are international companies having their operation in over 150 countries and any findings by the Madras High Court would

have a bearing on their global operations.

Venugopal referred to the Blue Whale game and said several young lives were lost due to directions given by the curator.

He said governments did not get any clue about the curator in the Blue Whale game and therefore it is necessary to find out who is the originator of such messages on social media which are defamatory, terror-oriented or fake news.

Both Facebook and WhatsApp told the bench that Blue Whale game has nothing to do with their platforms and if data is shared with third parties, it will be a breach of privacy.

To this, the bench said it seems to be a conflict between right to privacy and right to govern the country and the court has to maintain a balance between the two.

## Non-inclusion does not mean declared foreigner: Home Min

Seeking to allay apprehensions, The Union Home Ministry on Tuesday said non-inclusion of a person's name in the final list of NRC does not by itself amount to him or her being declared a foreigner. It assured that adequate arrangements have been made for appeal against it.

The ministry also said it will amend the rules to increase the time limit of filing of appeals in foreigners tribunals (FTs) from 60 to 120 days for those who would be excluded from the final National Register of Citizens, a list of Assam's residents to be published on August 31.

The decisions were taken at a high-level meeting chaired by Union Home Minister Amit Shah and attended by Assam Chief Minister Sarbananda Sonowal and others here on Monday. In a statement, the ministry said under the provisions of Foreigners Act 1946 and Foreigners (Tribunals) Order 1964, only foreigners tribunals are empowered to declare a person for-

eigner. "Thus, non-inclusion of a person's name in NRC does not by itself amount to him/her being declared as a foreigner," it said.

In order to facilitate the persons excluded from NRC, adequate number of such tribunals is being established at convenient locations. "It has been decided that state government would also make arrangements to provide legal aid to the needy people amongst those excluded from NRC. As it may not be possible for all those excluded from final NRC to file the appeal within the prescribed time, the MHA will amend the rules to increase the present time limit of filing of appeals in FTs from 60 days to 120 days regarding exclusion from final NRC," the statement said.

At the meeting, it was also decided that adequate arrangements will be made by the state government to provide full opportunity to people excluded from the NRC list to appeal. "Every individual, whose name does not figure in the final NRC, can represent his/her

## Amit Shah holds meet with senior BJP leaders ahead of Assembly polls

## Amend discriminatory laws against leprosy patients, urges Min

Harsh Vardhan writes letter to Law & Social Justice Mins respectively

While on the one hand the Centre is taking all efforts to ensure early detection of leprosy cases given that the disease is 100% curable, on the other, there still exists at least 108 discriminatory laws--three Union Laws and 105 State laws--against persons affected by the disease. Through the number of leprosy cases have steadily declined worldwide, an estimated 2,00,000 cases continue to be reported every year, with India accounting for more than

a half mainly because of the prevalent stigma associated with the disease.

Taking the matter with the Union Ministers of Law and Justice and Social Justice and Empowerment, Ravi Shankar Prasad and Thawarchand Gehlot respectively, Dr Harsh Vardhan, Union Minister for Health and Family Welfare on Tuesday wrote a letter to the two Union Ministers as well as to the States urging them to amend the existing discriminatory laws against persons affected with leprosy.

"A leprosy affected person after treatment does not transmit the disease agent. Hence, there exists no justification for the continued stigmatisation of the persons affected by leprosy," Dr Harsh Vardhan pointed out.

"It will be a befitting tribute to the Father of the Nation

on his 150th Birth Anniversary if we can expedite the process and introduce in Parliament the Elimination of Discrimination against Persons Affected by Leprosy (EDPAL) Bill, which was drafted by the Law Commission of India", the Minister said as he recalled that the Global Leprosy Strategy, 2016 - 2020 target is to reduce the number of countries with laws allowing discrimination on the ground of leprosy to zero.

The Minister's letter comes months after the Lok Sabha passed a Bill doing away with leprosy as grounds for divorce. Gandhi Peace Prize winner and the World Health Organization Goodwill Ambassador for Leprosy Elimination Yohei Sasakawa too had recently stressed that discriminatory laws against people with leprosy that still

exists in India need to go immediately.

Dr Harsh Vardhan has also shot off a letter to the Chief Ministers of 23 States/UTs including Andhra Pradesh/Telangana, Karnataka, Tamil Nadu, Odisha, Goa/Daman & Diu, Kerala, Madhya Pradesh, Chhattisgarh, Sikkim, Meghalaya, Haryana, West Bengal, Uttar Pradesh, Gujarat, Assam, Maharashtra, Bihar, Puducherry, Delhi, Rajasthan and North Eastern Region and Governor of J&K to work for the amendments of the existing discriminatory laws against the sector.

On its part, the Union Health Ministry has initiated various measures under the National Leprosy Eradication Programme (NLEP) to control leprosy such as Leprosy Case Detection Campaign (LCDC) (specific for high endemic dis-

tricts), Focused Leprosy Campaign (for hot spots i.e., rural and urban areas), special plan for case detection in hard to reach areas, ASHA based Surveillance for Leprosy Suspects (ABSULS) that have contributed to early case detection.

"Moreover, leprosy has become fully curable by Multi-Drug Therapy (MDT), being available free of cost at all the government health care facilities," said Dr Harsh Vardhan.

Welcoming the Ministry's initiative, Sasakawa - India Leprosy Foundation (S-ILF) Executive Director, Dr Vineeta Shanker said that the passage of the Edpal bill will be a huge step forward in removing any legal basis for discrimination and will also help to change mindsets and social perception about the disease which is fully curable.

## Allegations of Extortion During Terror Funding Case Probe

### NIA begins enquiry against agency's three officials

The NIA has initiated an enquiry into allegations of attempted extortion by three officials of the agency during a probe into the terror funding by Pakistan-based Falah-e-Insaniyat Foundation, a front run by Lashkar-e-Tayyaba chief Hafiz Sayeed of 26/11 Mumbai terror attack infamy.

"In this matter, a complaint of misconduct was received by NIA. An enquiry into the allegations is being conducted by a DIG rank officer. In the meantime three concerned officials have been transferred out to ensure a fair probe," NIA spokesperson said in a statement.

The three officials under the scanner include an SP rank officer, one Assistant Sub-Inspector of BSF on deputation to the NIA and a finger print expert National Crime Records Bureau (NCRB) also on deputation to the counter-terrorism probe agency.

The allegation against them is that they had demanded Rs two crore bribe from a Delhi-based businessman under the NIA scanner in the FIF terror funding case for not naming him as a conspirator in the case, sources said.

The complaint against the trio was received by the NIA about a month back and they were transferred out on August

14, the sources said. The complaint originated from an agency official who was contacted by a friend of the businessman who was allegedly being sought to be blackmailed, they added.

This is the first instance wherein such an instance of alleged blackmailing by the premier counter-terrorism probe agency has come to the fore.

The Parliament recently empowered the NIA by enacting amendments to the Act strengthening the powers of the agency. The Unlawful Activities (Prevention) Act was also amended recently wherein the NIA is empowered to declare individuals as terrorists.

# Azad stopped at Jammu airport again, sent back

**Jammu/New Delhi:** Senior Congress leader Ghulam Nabi Azad was stopped at the Jammu airport on Tuesday and sent back to Delhi, a party leader said, the second time in a month the former Chief Minister was not allowed to visit Jammu & Kashmir.



"Azad sahib had arrived from Delhi at around 2.45 pm and was not allowed to move out from the airport and forcibly sent back in a return flight to Delhi at 4.10 pm," state Congress chief spokesperson Ravinder Sharma told PTI. The leader of Opposition in the Rajya Sabha was not allowed to go home or attend the party meeting at state Congress headquarters either, Azad's close aides said. The Congress leader will return back to Delhi in the evening through a GoAir flight. Earlier on August 8, Azad was briefly detained and sent back from the Srinagar airport after the administration imposed restrictions following the Centre's move to scrap the state's special status and bifur-

cate it into Union territories. "It is unfortunate that he (Azad) is not allowed into his home state in the past two weeks," Sharma said. "He is the former Chief Minister of Jammu and Kashmir, member of Rajya Sabha from the state and leader of the Opposition in Rajya Sabha." The Congress spokesperson said Azad just wanted to come and meet some people to know about the prevailing situation. "Denying him permission shows that how the mainstream national party is not being allowed to interact and discuss the current situation," he said, adding that the Congress and its leaders were not "trouble-makers" that the State was behaving like this. **PTI**

# BSY expands Cabinet, 17 MLAs join as Ministers

After 25 days of uncertainty, Karnataka Chief Minister BS Yediyurappa on Tuesday expanded his Cabinet by inducting 17 members with a major share to his Lingayat community, a BJP voter base in Karnataka. Apart from Chief Minister Yediyurappa, there were seven MLAs from the Lingayat community who took oath as Cabinet Ministers in the hour-long ceremony held at Rajbhavan with Governor Vajubhai Vala administering the oath of secrecy to the new Cabinet Ministers. In this, Lakshman Savadi is not a member of any house.

In his Cabinet, Yediyurappa has kept the caste matrix in mind with seven out of 17 belonging to Lingayats and 3 to Vokkaligas. There are 4 Ministers from the SC/ST community, 2 OBCs and 1 Brahmin Minister. 4 MLAs from Bengaluru have also been allotted ministerial berths.

Staunch RSS worker Suresh Kumar, a Brahmin from Bengaluru, made it to the Cabinet. Three Vokkaligas, R Ashok, CN Ashwathnarayana and CT Ravi have also been inducted into the new Cabinet. Govind

M Karjol, Prabhu Chavan and Independent legislator H Nagesh are from the Dalit community in the Ministry and account for nearly 25 per cent of the State's 6.5 crore population. B Sreeramulu, from the Valmiki community, is also part of the Ministry. MLA Shashikala Jolle is the lone woman Minister in the Cabinet.

Now 16 seats out of 34 are vacant as the BJP had assured the disqualified MLAs from the Congress and JD(S) that they would be rewarded for their help in forming the Government. However, it was not a smooth affair for Yediyurappa who had to face the wrath of some senior MLAs in the party who have abstained and openly

expressed their dissatisfaction.

BJP MLAs, including ministerial aspirants Balachandra Jarkiholi, Murugesu Nirani, MP Renukacharya, Basangouda Patil Yatnal, Umesh Katti, GH Thippareddy, and Goolihatti Shekhar have missed the swearing-in ceremony and openly expressed their displeasure.

The coastal region of the state where the BJP has a big following has one representative in the cabinet with MLC Kota Srinivas Poojary a member of the large backward caste Billava community.

In a clear sign of the BJP rewarding legislators who helped the party pull down the coalition Government last

month, Bangalore MLA Dr C N Ashwathnarayan, a Vokkaliga, who played a key role in moving rebel Congress and JD(S) MLAs to Mumbai for defection has been given a Cabinet berth. The Independent MLA from Mulbagal in Kolar H Nagesh, a Dalit, who has also defected to the BJP by quitting his Cabinet position in the coalition Government is being inducted.

The BJP veterans in the Cabinet are Basavaraj Bommai, Jagadish Shettar (former chief Minister), V Somanna, CC Patil, Laxman Savadi. The former JDU leader JC Madhuswamy, a Lingayat, who played a crucial role in the legislature to guide the BJP to a trust vote victory,

is also in the cabinet. The Dalit leader Govind Karjol, KS Eshwarappa a backward caste Kuruba leader, R Ashoka and C T Ravi both Vokkaligas, Suresh Kumar a Brahmin, and Bellary's B Sreeramulu from a Scheduled Tribe are the other BJP veterans in the Yediyurappa Ministry. Prabhu Chavan, a Dalit MLA is a new inductee along with the lone woman Minister Shashikala Jolle.

Supporters of Hosadurga BJP MLA Goolihatti Shekhar staged protest at Hosadurga in Chitradurga district over denial of the ministerial berth to their leader. Meanwhile, another senior BJP MLA Umesh Katti expressed displeasure over missing out on Cabinet berth. He said he was ignored even though he was a senior party leader. BJP MLA S Angara from Sullia (Dakshina Kannada) is one among several sulking leaders upset over not considered for ministerial berth.

Expressing his displeasure he said that the people of his constituency had hopes of him becoming a Minister. "I have worked hard for the party and followed all set principles but if those would not turn meritorious, then I don't know what to do," he said. The six-time MLA was speculated to become

Minister, filling in the slot for a Dalit Minister.

Yediyurappa, who took oath as Chief Minister on July 26 and proved his Government's majority on the floor of the Assembly on July 29. Narayan, Swamy, Chauhan and Jolle have become Ministers for the first time.

Yediyurappa became the BJP's first Chief Minister in south India after the party came to power for the first time on its own with a simple majority in May 2008. He, however, was forced to resign on July 31, 2011 after being indicted by the Lokayuktha, the State anti-corruption body, for his alleged role in the multi-crore mining scam that rocked the southern state for a decade between 2001-11. Jagdish Shettar was the BJP's third Chief Minister from September 2012 to May 2013, when the party was in power for the first time between 2008 and 2013. He has also been inducted as a Cabinet Minister.

Union Minister of Chemicals and Fertilisers DV Sadananda Gowda was the second BJP Chief Minister in the State from August 2011 to September 2012. Gowda is a two-time Lok Sabha member from Bangalore North constituency. **PTI**

# Kerala nun accuses catholic priest of 'humiliating' her on social media

**Kochi:** A Kerala nun, who supported a protest against a Bishop accused of rape, Tuesday accused a Catholic priest of Mananthavady diocese of using social media platform to "humiliate" her.

Sister Lucy Kalappura alleged that the priest, who is part of PRO team of the Mananthavady diocese of the Catholic Church, posted the CCTV visual of media persons visiting her in the convent in the social media platforms to "humiliate" her.

The nun was expelled by the Aluva-base Franciscan Clarist Congregation (FCC) early this month for her lifestyle 'in violation' of the proper law of the FCC.

Following her expulsion, the congregation had asked the nun to leave the nunnery.

The nun had on Tuesday alleged that the priest collected the CCTV visuals of media

persons visiting her at the convent and made a video aiming to humiliate her in public.

She alleged the CCTV visuals were collected with the help of her fellow nuns in the FCC convent at Karakkamala in Wayanad.

"In the video, he (the priest) used vulgar language to humiliate me. He did so to disgrace me, to humiliate me," Sister Kalappura told reporters outside her convent.

The nun said she would lodge a police complaint against the priest.

The Mananthavady diocese disowned the views expressed by the priest in the video, saying it was his personal views.

"Whatever the priest said in the video are his personal views. We were not consulted before posting such a video in the social media," PRO of the Diocese, Fr Jose Kocharackal, told PTI.

He said the priest, who

often reacts through social media platform on issues happening in his surroundings, is a member of the PRO team of the diocese.

The issue came to light a day after the Vellamunda police registered a case against the FCC convent authorities at Karakkamala following a complaint of illegal confinement by the nun.

Sister Kalappura had alleged that she was locked up in the Karakkamala convent by the convent authorities to prevent her from attending the mass at the church in the neighbourhood.

The Church authorities have rejected the allegations by the nun.

The nuns who went for the holy mass had locked the doors of the convent to ensure that the safety of one of their fellow nuns who had stayed back due to her illness. **PTI**

# Time to free Bengal from TMC: Former Didi aide

Former Kolkata Mayor and Sovan Chatterjee who last week left the Trinamool Congress to join the BJP on Tuesday said that an opportune time had come to liberate Bengal from the yoke of Mamata Banerjee Government which was even worse than the oppressive Left Front.

The former senior Trinamool leader said, "I worked with Mamata Banerjee since the inception of the TMC and did whatever she said without a question because we all had a dream of making a new Bengal but our dreams have shattered."

Banerjee's regime is "worse that of Left Front," he said adding "during the CPI(M) we did not see such organised violence being perpetrated on the opposition. All the Opposition parties and even those within the Trinamool Congress feel threat-

ened and suffocated."

Chatterjee was so close to the Chief Minister at one point in time that he was given to handle three important Cabinet portfolios along with the Mayor post apart from being entrusted with heading the South 24 Parganas district party unit.

"This is not the same Mamata Banerjee we started our journey with and this is not the same Trinamool Congress which it used to be," he said adding the party and the Government was perpetrating organised violence in the regions and "a time has come when the people should work together to liberate Bengal for the second time just as they did to free it from the Left rule in 2011."

The former Mayor had earlier said that he had raised questions "at the appropriate level" regarding rampant rigging in the rural elections where the TMC won 35 per cent of the seats unopposed.

## Bengal's personalities write open letter to Mamata

**Kolkata:** Ten personalities of West Bengal, including filmmaker Aparna Sen have written an open letter to West Bengal Chief Minister Mamata Banerjee expressing anxiety over the recent violent incidents in the State.

It also noted with concern that the administration has been resorting to undemocratic means of quashing protests by the use of police brutality.

The signatories of the letter were among the 49 who had written an open letter to Prime Minister Narendra Modi on July 24 in which they had voiced their concerns over alleged rise in incidents of mob lynching across the country triggering questions on their silence during incidents of violence in West Bengal.

Actor Kaushik Sen, who is

one of the signatories to the letter, told PTI on Tuesday, "We condemn the incidents of violence in West Bengal".

The letter, which was sent to Banerjee on Monday, said, "We would like to draw your attention to some extremely violent incidents that have recently taken place in West Bengal."

It referred to the police lathicharge on the demonstration by para-teachers at Kalyani in Nadia district on August 17 to press for increase in their salaries and urged her to resolve their agitation.

Some of the demonstrators had also been arrested by the police.

The letter written by 'Citizens Speak India' said, "We strongly condemn this attack by the police on educa-

tionists and earnestly request you to resolve the issue in a democratic manner at the earliest.

"We have been noticing with a great deal of anxiety that instead of trying to resolve the peaceful democratic protests of teachers of this state through sane dialogue and debate, the administration has been resorting to undemocratic means of quashing these protests by the use of police brutality," the letter read.

The other signatories of the letter to Banerjee were actors Parambrata Chatterjee, Riddhi Sen, the youngest to have won the national award for the best actor, activist Bolan Gangopadhyay, commentator and social worker Mudar Patherya and their personality Sohag Sen. **PTI**

# DMK lands in soup after leader's remark on J&K

The DMK, Tamil Nadu's principal Opposition party finds itself in an unenviable situation following the remarks made by the party spokesman in a channel debate. S Saravanan, the DMK's national spokesman said during a channel discussion that Jammu & Kashmir was not an integral part of India. The party spokesman found himself at the receiving end during the debate as DMK president MK Stalin has already declared his Opposition to the BJP-led Government's decision to revoke Art 370 of the Constitution which had granted special status to Jammu & Kashmir.

The BJP saw red in the statements made by Stalin as well as

Saravanan and has demanded legal action against the Dravidian party for its "anti-national" stance. Interestingly, the DMK leader Stalin has made it clear many times that his party was for a separate Dravidian nation incorporating Tamil Nadu. "It is there in the DMK constitution and it is a live issue," Stalin had said many times since 2018.

The DMK's stance on a separate Tamil nation and the party's sustained campaign for the immediate release of the assassins of former Prime Minister Rajiv Gandhi has put the Congress in a spot. While the Congress party has been attacking the BJP over the abrogation of the Article 370, it is silent on the DMK's demand for the release of the seven assassins.

# Schools in Muzaffarpur buying dry fruits for ₹1 per kg, eggs for ₹16 apiece

**Muzaffarpur (Bihar):** Cashew nuts and raisins are being procured at a dirt cheap rate of ₹1 per kg, in sharp contrast to the prevailing market cost, for more than a dozen girls residential schools in this north Bihar district.

The prevailing market price of the two is about ₹750 per kg and ₹450 a kg respectively.

These expensive dry fruits, however, seldom find their way into the kitchens of the 16-odd Kasturba Gandhi Balika Vidyalaya units in Muzaffarpur where items consumed in bulk come overpriced.

On the other hand, Chana (Bengal gram) is purchased at an exorbitant rate of

₹199 per kg and so is chana dal while eggs come at ₹16 apiece.

Chana and chana dal are available at a price of ₹80-90 per kg in the open market, while an egg could be procured for ₹6.

This is a huge scam and, if properly investigated, may turn out to be bigger and more bizarre than the infamous fodder scam, says local resident Rajesh Kumar Singh whose RTI query on the expenses incurred by these schools blew the lid off the irregularities.

Officials have been left red-faced and ordered a probe.

We have taken a serious note of the anomalies. An inquiry committee has been

set up and based on its report, action will be taken against those found at fault, Amarendra Kumar Pandey, district program officer, Muzaffarpur, told reporters Tuesday.

He added only those who were part of the purchase committee which approved the agency for supply of the items can shed more light on the matter.

Singh, meanwhile, is livid and has threatened if action is not taken within two days I will refer the matter to the vigilance department.

This is organised loot and I believe similar irregularities must be taking place in all the districts across Bihar. **PTI**

# Raj Thackeray urges party supporters to maintain calm

In a statement put out in Marathi and English through his official twitter handle, Raj said: "Right since the time of inception of Maharashtra Navnirman Sena, there have been numerous cases registered against you all and me. Each time, we have honoured the notices sent by the investigating agencies and courts of law. This time too we must honour the summons sent by the Enforcement Directorate".

"The past years have made us accustomed to cases and notices coming our way. Keeping that in mind, I earnestly request that peace and harmony is maintained on

August 22," he wrote.

"No harm or damage should come upon any public property and common man should not suffer in any way. Kindly ensure that this is followed diligently. Also, do maintain calm and peace even if provoked," the MNS chief stated.

Expressing his deep gratitude towards his party workers for their "constant love and care", Raj noted: "I would like to firmly state that no party worker or Maharashtra sainik should come or assemble near the ED office" on August 22.

Through a notice, ED has summoned the MNS chief for inquiries on August 22 in connection with a probe into an alleged IL&FS-related case. **PTI**

# Groom fails to provide NRC credentials, wedding called off

**Guwahati:** A family in Silchar in Assam has called off the wedding of their daughter when the groom failed to provide his citizenship credentials.

Dilwar Hussain Laskar, of Nayagram village near Silchar was in love with a local girl and the two families had agreed to their marriage.

But trouble arose when the girl's family wanted to know from his family on August 15 whether his name was in the citizens register.

"We wanted to check whether the person seeking to marry the daughter of the family is a genuine Indian citizen or an illegal foreigner staying in the country as the matter would impact her future," said



a member of the girl's family. But Dilwar's name was not in the draft NRC. He was among the 40 lakh people whose name was omitted from the draft citizens register which was published in July last year.

Dilwar's family claimed that the names of all his family members are in the NRC and were hopeful that his name will be included in the final NRC to

be published on August 31.

The girl's family was not convinced and called off the wedding.

The final NRC is set to be published on August 31 and little is known about what happens to those whose name do not figure in it.

They can appeal at the foreigners tribunal, move the Gauhati High Court and the Supreme Court but what happens to them in the interim period is again unknown.

According to villagers the couple has eloped and the police said the woman's family has filed an FIR at Silchar police station alleging Dilwar has kidnapped her.

Investigations are on, the police added. **PTI**

# DOCUMENT NAMING SCRIBES, OTHERS AS 'ANTI-NRC' PROPAGANDISTS

## NRC authority denies any involvement

**Guwahati:** The NRC State Coordinator's office in Assam clarified on Tuesday that it has nothing to do with the creation or circulation of a document on social media which names journalists and human rights activists who are allegedly involved in "anti-NRC propaganda".

"It has come to the notice of the NRC authority that a document naming some journalists as being involved in anti-NRC propaganda is being circulated in social media since August 17," the National Register of Citizens (NRC) Coordinator Prateek Hajela's office tweeted.

It said the clarification was issued in public interest. "It is clarified that NRC authority has nothing to do with its creation or circulation".



A document titled 'NRC: The Other Story- Truth, Reality and Conspiracy' contained several chapters on people allegedly involved in such propaganda. A chapter had the names of journalists and news organisations, while social and human rights activists and some organ-

isations figured in other chapters. The document, which had the NRC logo, was not attributed to any organisation or authority but was circulated on various social media platforms, including Facebook, Twitter and Whatsapp.

The NRC logo on the document led to the confusion that it was issued by the NRC authority.

The final NRC is to be published on August 31. It is being updated for the first time in Assam after 1951. The Supreme Court is monitoring the exercise aimed at identifying genuine citizens of the state, which has seen influx of illegal migrants from Bangladesh over decades.

In July last year, 40,07,707 people were excluded from the complete draft of the NRC, which contained 2,89,83,677 eligible persons out of a total 3,29,91,384 applicants.

An additional 1,02,462 people were added to the list of excluded people in June.

In an effort to allay fears,

the Union Home Ministry on Tuesday said non-inclusion of a person's name in the final NRC does not by itself amount to him or her being declared a foreigner, and assured that adequate arrangements have been made for appeal against it.

The ministry also said it will amend the rules to increase the time limit for filing appeals in foreigners tribunals (FTs) from 60 to 120 days for those who would be excluded from the final National Register of Citizens to be published on August 31.

The decisions were taken at a high-level meeting chaired by Union Home Minister Amit Shah and attended by Assam Chief Minister Sarbananda Sonowal and others in New Delhi on Monday. **PTI**

# Chandrayaan-2 enters Moon orbit

Focus now on soft-landing

**Bengaluru:** India's Chandrayaan-2 mission, aimed at soft landing a rover in the unexplored south pole of the Moon, achieved a major milestone as the ISRO successfully injected the spacecraft into the lunar orbit on Tuesday.

"Today, the Chandrayaan-2 mission has achieved a major milestone. The precise lunar orbiter insertion manoeuvre was carried out at 9 am for about 30 minutes, precisely... injected the Chandrayaan-2 in the designated orbit," Indian Space Research Organisation chief K Sivan said here.

The insertion manoeuvre reduced the velocity of the Chandrayaan-2 from 2.4 km per second to 2.1 km per second, he added.

"For 30 minutes, our heart almost stopped," he told a press conference where he briefed about the crucial operation.

Chandrayaan-2, launched on July 22 by India's most powerful rocket GSLV MkIII-M1, had entered the Lunar Transfer Trajectory on August 14, leaving the Earth orbit. It comprises an Orbiter, Lander (Vikram) and Rover (Pragyan).

The rover is set to make the soft landing on the Moon on September 7 and if successful the mission would make India the fourth country after Russia, the US and China to achieve the feat.

After Tuesday's exercise, the ISRO chief said the Chandrayaan-2 will go around the moon with an orbit of 140 km perigee (closest point) by 18,000 km apogee (farthest). He added that four more

will be separated from moon orbiter on September two.

From there onwards, the focus of ISRO will be towards the lander as all major operations will revolve around the moon lander.

A small retro orbit manoeuvre of about three seconds will be carried out on September 3 and on the next day another similar exercise of 6.5 degree will be taken up to put the lander in an orbit of 35 km perigee and 97 km of apogee.

From September 4 onwards, various parameters would be checked to ensure that all the systems were perfectly alright, Sivan added.

"Next three days, we will be taking the various parameters of the lander to ensure that everything is right and to check and verify again and again, the system is perfectly alright," he said.

"On September 7 at 1.15



manoeuvres will be carried out to achieve the perigee and apogee of 100 km X 100 km on September 1.

Giving an insight into the complexity involved, Sivan said there was a unique requirement for soft landing near the south pole of moon with an inclination of 90 degree, which no other missions in the past had ever achieved.

He said 'Vikram', the lander,

am the lander will be landing at a site 71 degree of moon's equator with 22.8 degree East", the ISRO chief said.

Underlining the significance of moon lander, Sivan said the landing will be a terrifying moment for him as well as the entire ISRO team given the challenges involved.

"Looking at what happened to the soft landing around the world, we are saying that the soft landing success rate is only about 27 per cent. But we have the confidence about our mission," Sivan said.

This is the second time that the ISRO has successfully carried out Lunar orbiter insertion.

Earlier in 2008, the Chandrayaan-1 spacecraft, India's first moon mission, was injected into the lunar orbit and it scripted history by making more than 3,400 orbits around the Moon.

# 10 districts of Valley yet to attain normalcy

On the 17th day of continuous lockdown in most parts of Kashmir Valley, the Jammu & Kashmir Government on Tuesday admitted life is yet to return to normalcy in at least 10 districts, mostly in Kashmir valley.

At the same time, the administration is struggling to reopen the schools as majority of parents have declined to send their wards to join class rooms under the prevailing security situation in different parts of Srinagar.

The situation on ground zero is showing no signs of improvement in South Kashmir districts as well.

Compared to Monday, the

Government authorities claimed the attendance in primary schools showed signs of improvement on Tuesday but ground reports suggested several schools remained locked down as they reported zero or thin attendance in parts of Srinagar.

The network services also remained suspended across Kashmir valley while strict security restrictions remain in place in vulnerable pockets of downtown Srinagar.

Addressing a routine press conference late Tuesday evening in Srinagar, Principal Secretary, Planning & Development, Rohit Kansal, who is also Government's spokesperson, said normal functioning of large parts of the State was reported today with 12 out of 22 districts

functioning normally".

He also maintained that out of 197 police stations across J&K, 136 police stations have no day time restrictions. Referring to Kashmir alone he said 50 out of 111 police stations have no day time restrictions.

Commenting on the situation of Kashmir valley, Kansal said that middle level schools would start functioning from Wednesday in the areas where primary schools resumed functioning from Monday.

He said public transport has also started plying in areas where relaxations have been provided and inter-district transport has also started functioning, adding that National Highway and Airports are functioning normally.

# Pak violates ceasefire along LoC, 1 jawan martyred

Situation along the Line of Control in frontier Rajouri and Poonch remained grim with fresh exchange of heavy firing in Krishna Ghati sector of Poonch on Tuesday. One Indian soldier attained martyrdom when Pakistan Army violated ceasefire agreement in Mendhar. Hitting back, Indian Army caused heavy damage to Pakistan Army posts and casualties to Pakistani soldiers.

Defence PRO in Jammu, Lt-Col Devender Anand said, "Pakistan Army initiated ceasefire violation in the Krishna Ghati sector around 11.00 a.m using small arms fire and shelling with mortars".

He said, in the exchange of fire in Mendhar sector, Naik Ravi Ranjan Kumar Singh attained martyrdom.

He said Indian Army gave befitting reply and retaliated strongly and effectively.

Naik Ravi Ranjan Kumar Singh, aged 36 years belonged to Village Gope Bigha, Tehsil Dehriwala, District Rotasa, Bihar and is survived by his wife, Rita Devi.

# Death sentence for one, life for seven in Bihar court blast case

**Ara (Bihar):** A court in Bihar's Bhojpur district on Tuesday gave death sentence to a man and life imprisonment to seven others in connection with the 2015 Ara civil court bomb blast case.

Additional District and Sessions Judge Tribhuvan Yadav gave capital sentence to Lambu Sharma after holding him guilty under various sections of IPC including 302 (murder), 307 (Attempt to murder), 326 (voluntarily causing grievous hurt), 353 (Assault public servant from discharge of his duty) and under some sections of Explosive Substance Act.

The court also imposed a fine of ₹22,000 on Sharma.

The seven sentenced to life imprisonment were Chand Miyan, Naem Miyan, Akhilesh Upadhyaya, Rinku Yadav, Pramod Singh, Shyam Vinay Sharma and Anshu Kumar.

The judge held them guilty under IPC section 302 (murder). The court imposed a fine of ₹42,000 on Akhilesh Upadhyaya and ₹40,000 on the other six convicted persons.

The court on August 17 had convicted the eight persons in the civil court bomb blast and

acquitted former JD(U) MLA Narendra Kumar Pandey alias Sunil Pandey along with two others — Sanjay Sonar and Vijay Sharma — for lack of evidence.

Pandey is currently in the Lok Janshakti Party (LJP). Chand Miyan surrendered in the court on Tuesday as he did not appear in the court on August 17. The court had issued warrant against him and had also ordered attachment of his properties for not appearing before it on August 17.

On January 23, 2015, a woman, identified as Nagina Devi, had come to the court premises as a suicide bomber with a design to set notorious criminal, Lambu Sharma, free from custody.

As the prison van reached the court premises, the woman triggered a blast. Taking advantage of the blast, Sharma, along with two others had fled.

The woman died on the spot, while a police constable, Amit Kumar, succumbed to his injuries.

The police had filed a charge sheet against 11 persons, including Pandey and had produced 39 witnesses in the case.

# Woman given 'triple talaq' for refusing chewing gum from husband: Police

**Lucknow:** A man allegedly gave 'triple talaq' to his wife right inside the civil court premises here in presence of her advocate after she refused to accept a chewing gum from him, police said on Tuesday.

Thirty-year-old Simmi of Amrai village was divorced by her husband Syed Rashid on Monday inside the Lucknow civil court premises where she had gone for the hearing of her case of dowry harassment she had lodged earlier against her in-laws, said the Indira Nagar police station SHO S B Pandey.

The woman was talking to her advocate when her husband offered her a chewing gum which she refused, said the SHO, citing the woman's complaint.

This threw Rashid in a fit of rage and he divorced his wife, uttering talaq-talaq-talaq, said the SHO. Simmi, married to Rashid in 2004, had lodged a case of dowry harassment against her husband and in-laws earlier, said SHO Pandey.

There have been several instances of men divorcing their wives with this outlawed oral diktat on queer pretexts.

# POST ABROGATION OF ARTICLE 370 First encounter in Baramullah under way

**Srinagar:** The gun battle between security forces and militants in Baramulla district of Jammu and Kashmir continued till late into the night on Tuesday.

Army authorities said there was heavy exchange of gunfire between both sides even as they refrained from divulging the exact number of terrorists that were involved in the encounter.

Security agencies, including

the Jammu & Kashmir police, were fighting the militants in the encounter.

"Firing began at 5 p.m. with the terrorists in Old Baramullah. The operation is under way," said a Army official.

The area was cordoned off for the public as soon as the gunfight began.

Ever since the Union Government abrogated special

category status to Jammu & Kashmir on August 5 by abrogating Article 370 of the Constitution, this is the first encounter between security forces and terrorists in the Valley.

As per sources around 2-3 terrorists were engaged in a gunfight as the joint operation between the Army, Jammu & Kashmir police and other security

agencies was launched. Baramullah is located around 54 km from Srinagar.

Kashmir Valley has been by and large peaceful barring stray incidents of stone-pelting and protests since August 5. The number of ceasefire violations by Pakistan across the LoC have increased, however, over the past week after a lull in the first fortnight of August.

## French eye

India to launch 8-10 satellites with France as part of a 'constellation' for maritime surveillance



Whatever be the domestic apprehensions about the many controversial moves of Modi 2.0, particularly over the revocation of Article 370 and reorganisation of Jammu and Kashmir, diplomatically it has managed to keep the opinion of the big power players on its side. Considering 14 of the 15 members at the UN Security Council were largely dismissive of Kashmir as a matter to be settled bilaterally and with China having no *locus standi* in the matter as it has been reorganising its own territories and legitimising PoK, India is moving to now matters maritime. And in a direct challenge to China's "string of pearls" approach in the Indian Ocean Rim (IOR), one that has its military and commercial facilities dotting our littoral states, from the Chinese mainland to the Horn of Africa, India is looking to France to narrow down its hawk's eyes. India's new space endeavour with France, where the two countries will launch 8-10 satellites as part of a "constellation" for maritime surveillance, will help safeguard strategic interests at sea. This new venture, to be finalised during Prime Minister Narendra Modi's visit to Paris, will provide an inside-out information about developments over, on and under the sea surface and coastal areas. This has become almost a necessity considering China is known to have built artificial islands over the last decade or so. Besides, its interest in the Scarborough Shoal near the Philippines and its military fortification of islands in the South China Sea have complicated the security environment. Considering that France has been supportive of India's position and has even spearheaded resolutions to protect it from Pakistan-sponsored terrorism in the UN, there could be no better ally in this project of a larger national security.

The Chinese belligerence on our waters is worrisome simply because sea lines run through several major maritime choke points such as the Strait of Mandeb, the Strait of Malacca, the Strait of Hormuz and the Lombok Strait as well as other strategic maritime centres in Pakistan, Sri Lanka, Bangladesh, the Maldives and Somalia. Right now, China has effectively encircled India and reinforced its superiority by setting up outposts and ports in countries which are beholden to it courtesy the economic projects under the Belt and Road Initiative. Apart from military muscularity, such control also bodes ill for the ease of trade in these waters. India itself conducts nearly 40 per cent of its trade with littoral nations along IOR and has been consistently working with some of them to preserve the integrity, inviolability and freedom of oceanic channels. While we have been conducting joint naval exercises, fact is our Navy is not as cutting edge as China's, hence the need for pre-emptive surveillance. The new age of conflicts means that we are as prone to the dangers of maritime terrorism, smuggling, transnational crime, drug trafficking, illegal immigration besides climate change issues. This satellite cluster will, therefore, monitor sea traffic management. While the IOR is of concern to India, France, too, has its territories spread across the Indian, Pacific and Atlantic Oceans and is seeking cooperation on its vigil campaign. India was a natural choice as a partner because France has had space cooperation with us for about six decades and is now involved even in ISRO's human mission programme, Gaganyaan. This alliance is expected to continue in our future interplanetary endeavours. Of late, India has found a strategic and technological sounding board in France as its relations with others have their own set boxes — Russia remains our oldest defence partner and despite leaning towards China for practical reasons, still honours the legacy of a shared past. China, despite everything that is disputed, remains our key trading partner and the US is a new-found ally. Over the decades, India and France have emerged as true democratic partners, who honour the spirit of international law, and have been developing cooperation in counter-terrorism, intelligence-sharing and cooperation on investigations and judicial processes. Despite global outcry over the nuclear tests in 1998, France was the first to resume nuclear talks with India and among the first to push nuclear trade in later years. One area that remains unexplored is that of bilateral trade between the two. On the basis of this trust, India may even become a middle power with its own bargaining chips.

The time has come now to provide a new orientation in China-India relations. In the economic field, bilateral trade between the two countries touched almost \$90 billion in 2017-18 but trade deficit increased to \$62.9 billion in China's favour. China must follow Lao Tzu: "If you do not change direction, you may end up where you are heading." It clearly has interests which are long term, given its ancient history and traditions and it is unlikely that it would think in terms of mere short-term benefits that could lead to friction and disputes. Our External Affairs Minister clearly mentioned that any bilateral differences should not become disputes. ## Squatters have no rights

The poor often get unfairly tarnished for squatting on public property whereas the worst culprits are entitled politicians



At the memorial of the late great Sushma Swaraj, many mourners noted how the former Foreign Minister had vacated her official accommodation soon after leaving the Government. Her actions are in direct contrast to the shameful and thuggish behaviour of Jat leader Ajit Singh, who tried to hold on to his official quarters even after being trashed at the hustings. He further tried to hire goons to threaten the Government back in 2014. Thankfully, Singh realised that he could not muster any public sympathy for his squat-

ting, which he tried to rationalise calling it a "matter of Jat pride" and left his house in a huff. But others like Adhir Ranjan Choudhury of the Congress, who refused to give up his ministerial quarters after his party's defeat in 2014, had to be physically evicted. Now in 2019, the Modi Government is taking it upon itself to ensure that Members of Parliament (MPs) do not overstay their welcome in Government housing. It has given errant MPs and former Ministers, several of them members of the BJP, a week to vacate their houses.

Frankly, this move was long overdue and there should be no quarter given. Several MPs have used all sorts of excuses to overstay their welcome. Some have moved the courts to get stay orders but after the Supreme Court ordered a cleanup in 2013, that avenue was closed. However, some high-security individuals, who are in the 'Z+' security category, such as LK Advani and Priyanka Gandhi, might be allowed to remain in exclusive housing because they are easier to protect. Government housing is a privilege that parliamentarians enjoy only for their term and this rule has to be enforced. If previous occupants do not leave, how will new MPs and Ministers function? Just because a person wants to retain a fancy New Delhi address, he/she should pay the same market rentals in private colonies that ordinary citizens do. Nobody should have an extremely inflated sense of self like Ajit Singh, a man now reduced to being a political nobody, ignored by the community for whom he said he wanted to keep his house. At the same time, the shortage of housing in central Delhi is also evidence of the need to build new and better housing facilities for Government servants, defence personnel and parliamentarians in the centre of the city. Several older Government colonies and many bungalows built in 'Lutyens Delhi' are showing signs of age. They are in desperate need of repair if not outright reconstruction. Old rules do not apply to housing anymore and old structures must be removed.

The outcome of External Affairs Minister S Jaishankar's visit to China has been positive, not only in terms of India explaining its stand but also clearing the air for future exchanges. The External Affairs Minister is not only a distinguished diplomat but having been India's Ambassador to China, he knows the system and personalities whom he has to deal with. One major point made by him to China's Foreign Minister Wang Yi was to emphasise that the future of the India-China relationship will depend on "mutual sensitivity" to each other's "core concerns." In return, Minister Wang Yi emphasised "the five principles of peaceful co-existence", which have "fundamental interest and long-term interest of our two peoples and also contribute to world peace and human progress." As an immediate measure, India and China signed four agreements covering cultural exchanges, healthcare, sports and cooperation in museum management. In particular, both Jaishankar and Yi emphasised the importance of cooperation in the field of traditional medicine, wherein both China and India, the two most ancient civilisations in the modern world, have cumulative knowledge.

The time has come now to provide a new orientation in China-India relations. In the economic field, bilateral trade between the two countries touched almost \$90 billion in 2017-18 but trade deficit increased to \$62.9 billion in China's favour. China must follow Lao Tzu: "If you do not change direction, you may end up where you are heading." ing when he predicted that for the civilised West "a time is coming when those who are in the mad rush today of multiplying their wants, will retrace their steps and say; what have we done.... Modern civilisation is such that one has only to be patient and it will be self-destroyed." What we find across the entire world, which is mindlessly aping the Western model, is human-induced climate change resulting from the burning of fossil fuels, a loss of biodiversity and destruction of the earth's ecosystems. China and India are large countries, which are also suffering from the consequences of these disastrous trends. As the Intergovernmental Panel on Climate Change (IPCC) has projected and as is becoming increasingly evident today, the frequency and intensity of extreme events is rapidly on the increase. These take place in the form of heat waves, extreme precipitation events and several sea level related disasters. There are areas which are suffering from prolonged drought, which at the same time, witness floods during certain seasons.

China already has a major problem of water scarcity, particularly in its western region. India, too, is suffering from the consequences of global climate change,

which clearly makes this a "core concern" for both societies. It is also important for the population of China and India to set a new path of development which is relevant not only for the two countries but also for the rest of the world. Together, China and India are close to three billion people in a world which holds today an estimated 7.7 billion. Clearly, therefore, whatever path is set by the two countries will have a major influence on the world as a whole.

An area in which cooperation is needed would be to develop and use renewable sources of energy. The IPCC has clearly assessed the reasons for the world to keep within the 1.5°C limit by the end of the century. It has also defined the implications of land use, including massive consumption of meat, which is totally unsustainable. Today, China has increased its consumption of all forms of meat to a huge level. However, fortunately, it is one of the leaders in the use of renewable energy where in both countries would derive mutual benefits from working together.

In Prime Minister Modi's Independence Day speech, he emphasised the need for water conservation, including precision agriculture, rainwater harvesting

and waste water treatment. He also highlighted the indiscriminate use of plastic. Additionally, he addressed the need for cutting down on the use of chemical fertilisers in agriculture by up to 25 per cent. He stated: "This would be a great service to the nation. This would be a great step in saving our Mother Earth."

China and India can work towards the use of bio-fertilisers, which would enable us to do away with chemical fertilisers. "Saving our Mother Earth" is clearly a core concern for both societies. This writer has interacted with those responsible for conceptualising a facility called "Science City", which is to be established outside Beijing over an area of 100 square kilometres.





### Strengthen data law

Sir — Agro-chemical products take a long time to grow. In addition, new molecules at present take about six to seven years to be registered. The bureaucratic process delays the delivery of the products to farmers, leaving them with no option but to buy cheaper, low-quality products. It is recommended that the Government look into this issue at the earliest.

Also, while Indian formulations are mostly generic products as research and development (R&D) is expensive, overseas companies frequently spread their assortment and are eager to invest in India on product R&D and marketing. Data selectiveness in the agrochemicals sector will not only delay the entry of generics by creating an additional period of legal monopoly but will also make agrochemicals or pesticides unaffordable to Indian farmers. Data protection or selectiveness will obstruct growth of indigenous manufacturers and will work against the Government's vision of "Make in India."

## Reunification of India a necessity

The idea of Indian reunification is one whose time has come though there's no doubt that it will take a long time to achieve. However, it must be under a strong, liberal leadership

For a long time, I have been propagating the idea that India, Pakistan and Bangladesh should reunite under a secular government for their mutual good (see the Mission Statement and articles on indianreunificationassociation.co.in). I have long said that India, Pakistan and Bangladesh are really one country, with a common culture, and were one for centuries.

Many people have criticised this idea, more so in light of the recent developments in the subcontinent. Many Pakistanis, including Pakistan Prime Minister Imran Khan, say that recent developments in the region prove that the founder of Pakistan, MA Jinnah, was right in insisting that Muslims get their own homeland otherwise atrocities (e.g. lynching, attacks and incarceration of Muslims for long periods on trumped-up charges) would be committed on them in a united India. So these developments prove that Partition was good for Muslims, and the idea of Indian reunification is only a pipe dream, they point out.

My reply is as follows: Our aim must be to create a highly industrialised country, because only then can we generate the wealth needed for the welfare of our people and give them decent lives. Only a high level of industrialisation can create millions of jobs to wipe out unemployment.

The Partition of India in 1947, and creation of an Islamic state, which was a historical British swindle on the basis of the bogus two-nation theory, was aimed at preventing this growth. If India emerges as another China, then, with its cheap labour, our industries will undercut their rivals from developed countries. Who will buy their costly goods then and won't their industries shut down? One China has become a headache for the West. Will they permit another?

So the secret understanding among developed countries is that India must not be allowed to emerge as a modern industrial giant like China. To prevent that, Indians must remain divided on the basis of religion, caste, region etc.

All this talk of improving relations between India and Pakistan (such as that touted by the campaign *Aman ki Asha*) is unrealistic and nonsense. The very purpose of creating Pakistan as an Islamic state was that there shouldn't be peace but hostility between the two neighbors and Hindus and Muslims. If there are good relations then the very purpose of creating Pakistan will be defeated.

Our common enemy is massive poverty, record unemployment, appalling child malnourishment, farmers in distress, spiralling prices, ignorance, lack of healthcare, unabated corruption, atrocities on minorities, etc. We waste our scant and precious resources fighting each other instead of joining hands and fighting against these problems that are our real enemies.

To say that Partition was necessary to safeguard Muslims is puerile. First, there are as many Muslims in India as in Pakistan (about 200 million in each). Second, Muslims in Pakistan may be safe from Hindu bigots, but are they safe from Muslim bigots? Are Ahmadis, Shias safe? Are Barelvis safe from Deobandis? They often bomb mosques, *dargahs*, etc. And are the Muslims there free from the evils of unemployment, price rise, malnourishment, ignorance, lack of healthcare, corruption, etc? It was a stupid idea that creation of Pakistan will keep Muslims safe. In fact Partition has increased the problems of Muslims, Hindus, Sikhs, Christians there.

So, unless we reunite, we will keep wasting our scant resources fighting each other, and will never become a highly industrialised country, and thus remain poor with many social evils. As mentioned earlier, we are really one nation with a common culture, and were befooled by the British into thinking we are each other's enemies. But how are we to reunite?

This can only be done peacefully and voluntarily, and will take a long time, maybe 10-20 years. The communal venom which was injected into our body politic by vested interests for over a century, will take a long time to be expelled. During this period, we must patiently explain to the masses the truth that we are really one nation, were one for centuries, and spread the idea of Indian reunification among them.

As Victor Hugo said, "There is one thing more powerful than all the armies in the world, and that is an idea whose time has come." The idea of Indian reunification is one whose time has come though it will no doubt take a long time to achieve.

We will be called daydreamers by many. But when Giuseppe Mazzini spoke of Italian unification, he too was called a daydreamer, though the dream became a reality thanks to the efforts of Count Cavour and Giuseppe Garibaldi. West and East Germany reunited in 1990 after partition in 1945. North and South Vietnam reunited in 1975 after a partition of over 21 years.

At present, all that needs to be done is to spread the idea of reunification, as is being done by the Indian Reunification Association. Later, when the idea has gripped the imagination and minds of the masses, then people will use their creativity and find ways to make a peaceful reunification a reality.

However, it's vital that such a reunification is under a liberal leadership, which while ensuring religious freedom does not tolerate religious bigotry from any quarter and crushes it with an iron hand. Such progressive leaders will rapidly ensure industrialization of the nation, provide for the welfare of the people and catapult India into the front ranks of the world community. How and when such a historic transformation will take place, who these leaders would be, is impossible to predict. But it is a necessity.

## The overleverage fix

More research must be done as to why firms become hooked to high debt. As they say about addiction, admitting you have a problem is the first step towards solving it

The recent suicide by Café Coffee Day owner jolted every coffee lover in the country and brought to the fore the grim reality that high debt can be dangerous for a company. A business is said to be overleveraged when it carries too much debt and is unable to make interest payments on loans and meet other expenses.

Overleveraged companies are often unable to pay operating expenses because of the burden brought on by debt in the form of interest payments and principal repayments. Overleveraging can sometimes lead to a downward financial spiral where the company cannot generate enough revenue to make the debt payments and pay its usual operating expenses. This leads to the company having to borrow more to stay in operation, and the problem gets worse. This spiral usually ends when the company closes its doors or files for bankruptcy protection.

A less leveraged company can be better positioned to sustain drops in revenue because they do not have the same expensive debt-related burden on their cash flow. Businesses that borrow money to add to a product line, expand internationally, or upgrade their facilities are often better able to offset the risk they take on when borrowing.

Leverage can be measured by financial leverage ratios, sometimes called equity or debt ratios, which measure the value of equity in a company by analyzing its overall debt picture. These ratios either compare debt or equity to assets as well as shares outstanding to measure the true value of the equity in a business.


This shows how much of the company assets belong to the shareholders rather than creditors. When shareholders own a majority of the assets, the company is said to be less leveraged. When creditors own a majority of the assets, the company is considered highly leveraged. All of these measurements are important for investors to understand how risky the capital structure of a company is and if it is worth investing in.

The most common financial leverage ratios are debt ratios, debt-equity ratios and equity ratios. Debt ratio is a solvency ratio that measures a firm's total liabilities as a percentage of its total assets. In a sense, the debt ratio shows a company's ability to pay off its liabilities with its assets. In other words, this shows how many assets the company must sell in order to pay off all its liabilities.

The debt to equity ratio is a financial, liquidity ratio that compares a company's total debt to total equity. The debt to equity ratio shows the percentage of company financing that comes from creditors and investors. A higher debt to equity ratio indicates that more creditor financing, i.e., bank loans, is being used than investor financing, i.e., shareholders.

The equity ratio is an investment leverage or solvency ratio that measures the amount of assets that are financed by the owner's investments by comparing the total equity in the company to the total assets.

In fact, some years ago, a team of financial scholars at Stanford Graduate School of Business and at Germany's Max Planck Institute studied banks and found that they have become "addict-



ed" to increasing their debt levels steadily. According to them, "leverage begets leverage". However, it was further analysed that other corporations have become addicted to debt, even when it reduces the total value of the enterprise. Once a company begins to take on debt, they say, the leverage becomes almost "irreversible." Shareholders will generally oppose measures that reduce debt and support moves to increase it whenever the opportunity arises.

According to Paul Pfleiderer, a professor of finance at Stanford, taking leverage is like eating potato chips. One cannot stick to the commitment of eating just a few chips. So, if one cannot stop after eating just one chip, one might be better off not eating them at all.

The authors argue that since reducing debt entails a transfer of risk - and wealth - from shareholders to creditors, there is a clear disincentive for shareholders to cut back on borrowing. If a company buys back its bonds, for example, bondholders will demand a premium above the current market price for those bonds. That's because bondholders will insist that the buyback price reflect the fact that the remaining debt will be at less risk of default.

In other words, bondholders get all the benefits of debt reduction and shareholders have to foot the cost upfront. Government tax policy makes companies even more biased toward higher debt, because it allows companies to deduct interest payments from their taxable income.

In theory, creditors can protect themselves by insisting on contracts or "covenants" that restrict a company's ability to increase its leverage in the future. Among other things, covenants can restrict a company from selling additional bonds or making big payouts to shareholders, which reduce the company's equity.

In practice, the authors argue, covenants are difficult to enforce. Most covenants give companies at least some discretion to take on more debt,

because companies need flexibility in dealing with new opportunities and problems. On top of that, the creditors are often dispersed and unable to take a unified position.

The most obvious risk of high debt is the increased danger of falling into financial distress or even bankruptcy. But on the other hand, rising leverage can also make companies reluctant to invest in promising new projects.

That's because part of the increase in value generated by an investment would flow not to the shareholders but to the creditors, because their bonds and loans would become more secure. Corporate boards take a hard new look at how much they compensate management through stock options and other grants of equity in the company. The more money managers earn from grants of stock and options, rather than from their salaries, the more they will align their self-interest with shareholders rather than creditors.

As bad as it may seem, at some point, almost all businesses must take out loans. Debt financing can be attractive to business owners because banks won't dictate how they should spend the money and they don't have to split up company ownership. Highly leveraged companies are very sensitive to economic declines and at higher risk for bankruptcy.

There are several problems of a highly leveraged company. First, the lenders require borrowers to pay back their loan in a timely manner. This becomes a problem for fledgling companies that borrow money for projects with long-term returns. If payments come due before the company starts seeing returns, loan repayments can be a crippling expense.

Paying back the loan on a regular basis means less money to finance operations and invest in growth opportunities.

Second, substantial loan payments can easily cripple a highly leveraged company. A company doesn't have an obligation to repay capi-

tal from equity sources.

However, banks and lenders have top seniority when it comes to repayment in the event of a bankruptcy. This means that lenders will get paid out before anyone else, including the company owner. If the company has a secured loan, the bank can repossess company assets. Depending on the business structure and the terms of the loan, the owner of the company may also be personally liable for the loan repayment.

Third, just like with individual lending, banks scrutinize corporate credit reports before doling out more loans. Banks are unlikely to provide further funding to highly leveraged organizations. Not only are these companies at high risk for bankruptcy, the new lender might not get paid back if the company goes under.

Older loans typically carry higher seniority compared to newer loans, so lenders are hesitant to put themselves at the bottom of the list for recouping their investment. In the event a bank does issue a loan, the interest rate will be high enough to account for that increased risk.

Fourth, one of the options a company has to reduce its financial leverage is to increase the amount of equity capital.

However, investors rarely give money to highly leveraged businesses. Investors avoid highly leveraged companies for all the same reasons lenders do, plus they're the last in line to get repaid.

If an investor is willing to invest in a highly leveraged company they'll expect to receive an especially large percentage of ownership in exchange for their money.

It's important that further research should be done to shed light on why companies can become hooked to high debt. As they say about other forms of addiction, admitting you have a problem is the first step towards solving it.

## Time to defuse population bomb

While Modi talked about India's demographic dividend in his first term, in his second term he has realised that though a large population may not be a bad thing, it has to contribute to the country's growth

Eyebrows were raised when Prime Minister Narendra Modi expressed concern about the population explosion in the country in his recent Independence Day speech. There was a feeling of surprise that the Prime Minister chose to bring up an issue that has been a 'No-No' for many politicians from the days of Emergency, when the Indira Gandhi government used coercive population control measures. Her Family Planning programme received widespread condemnation and effectively never realized its purpose. Later the ministry's name was changed to Family Welfare.

India's population is 1.34 billion, which is nearly a four-fold increase since Independence. Modi has reasons for concern as according to the World Population Prospects 2019 of the United Nations, India is expected to add

nearly 273 million people between 2019 and 2050. Inevitably, with these figures, "India is projected to surpass China as the world's most populous country around 2027", the report said. The biggest challenge for India is its unpreparedness to accommodate such a huge population. Looking at these figures, "The time has now come that we should take such challenges ahead," Modi said.

Interestingly, while Modi talked about India's demographic dividend in his first term, in his second term he has realised that though a large population by itself may not be a bad thing, it has to contribute to the growth of the country. This needs to be supported by capital, technology and infrastructure, as well as skills. That is why the Prime Minister is now talking of education as a means of both moderating the rising population and making it productive.

The country is already facing an acute drinking water crisis, garbage disposal and sewage treatment problems, inadequate rainfall, climate change, increased levels of pollution, high infant and child mortality rate and poor standard of living in the economically weaker sections.

The Prime Minister's speech was

mainly targeted towards these poorer sections of society and his appeal to them for keeping the family small was aimed at improving their standard of living.

He is aware that the poor are missing out on opportunities to climb up the economic and social ladder because they have too many mouths to feed. Making it a nationalistic issue, he said, "Those who follow the policy of a small family also contribute to the development of the nation; it is also a form of patriotism."

Why did Modi talk of population explosion now? It obviously stems from the fact that his hands are strengthened after the massive mandate he received in the 2019 polls.

Politically, Modi is much stronger today, while the Opposition is weak like never before. Add to that the Prime Minister's recent success in Parliament in getting controversial Bills like Triple Talaq and abrogation of Article 370 pertaining to the special status of Jammu and Kashmir passed, despite being in a minority in the Rajya Sabha.

Second, the Indian Right-wing, including the BJP, has always expressed concerns about the increasing minority population. They feel that the Muslims are trying to overtake Hindus in the country by multiplying fast. The

Rashtriya Swayamsevak Sangh (RSS) chief Mohan Bhagwat, during his annual Dussehra address some time ago, noted, "We need to rise above vote bank politics to formulate a holistic approach, equally applicable to all citizens, towards the population policy."

In Parliament too, BJP members have raised this issue. Recently Rakesh Sinha, a BJP Member of Parliament, introduced a Private Member's Bill to regulate population. Earlier, another BJP member Sanjeev Balyan, who is now a minister, had also introduced another Bill with the backing of 124 members.

The late BJP stalwart Atal Bihari Vajpayee too had made such an attempt in 2000 by bringing a forward-looking National Population Policy. However, it made the two-child norm a voluntary commitment for individuals. The Modi Government has also followed the same approach that the family planning programme in India is target-free and voluntary in nature.

Modi's speech has triggered speculation that a mild interventionist population policy is not far off. It is a very sensitive issue both at the state level as well as the religious level.

The North-South divide and the Hindu-Muslim divide are the two

issues that raise their heads whenever the spotlight is on population control. While the southern states feel that their great success in bringing down the population is costing them in terms of resources devolved from the Centre, the Minority Affairs Minister Mukhtar Abbas Naqvi has claimed this week that it is a social reform.

The Prime Minister is not one to waste words and he has used the Independence Day speech to prepare the country for population regulation, going forward. There is an urgent need to aggressively push concepts like the two-child policy, child spacing, increased use of contraceptives and voluntary sterilisation. The two-child norm should be made a uniform criterion for government jobs, getting aid and subsidies and other benefits. Perhaps incentives and disincentives might work better in containing the size of the family. The health ministry is already implementing many of these schemes, but much more will be needed to create awareness and to make an impact in the long run.

As India aspires to become a major economic power, it's time to define whether a growing population is an opportunity or a danger.

# No interim relief to Deloitte, BSR Associates in IL&FS case

The National Company Law Appellate Tribunal (NCLAT) on Tuesday declined to give any interim relief to auditing firms Deloitte Haskins & Sells LLP and B S R Associates LLP with regard to a ban imposed on them in the IL&FS case.

The NCLT Mumbai will continue its scheduled hearing in the case of their alleged role in the IL&FS fraud matter, a three-member bench headed by Chairperson Justice S J Mukhopadhyaya said.

The NCLAT, however, said that the NCLT will not pass any final order till its next hearing on September 20.

Listing the matter for September 20, the NCLAT also issued a notice to the Ministry of Corporate Affairs to file its reply within two weeks.

The NCLAT was hearing appeals filed by Deloitte and BSR against the order of the Mumbai bench of the National Company Law Tribunal (NCLT), which on August 9, rejected their pleas of challenging its jurisdiction to ban them from the business for five years for their omissions and commissions in the IL&FS Group scam.

The NCLT will hear the matter on September 5. The court had allowed the corporate affairs ministry to pro-



secute them along with 21 others in the same case, though the implementation of the same has been stayed after they sought time to challenge the order at the appellate tribunal NCLAT.

The ministry in June moved NCLT seeking a five-year ban on these auditors in the IL&FS fraud case.

The auditors — the local arm of the England-based Deloitte Haskins & Sells, which is one of the big four accounting firms, and BSR & Associates, which is the local affiliate of another big four, the US-based KPMG — had challenged the jurisdiction of the NCLAT to ban them under Sec 140(5) of Company's Act.

They had challenged the jurisdiction of the NCLT to ban them, saying section 140(5) of the Companies Act pertains to

auditors who are still auditing the company in question while they have already resigned from the service and thus cannot be banned under the given provisions.

While Deloitte had stopped auditing IL&FS Group, which owes over Rs 95,000 crore to lenders and other financial institutions, by the end of FY2017-18, BSR was the statutory auditor of IL&FS Financial Services (IFIN) and resigned only in June this year-nine months after the company was sent to the bankruptcy court.

The Serious Fraud Investigation Office (SFIO) in its investigation found them guilty of painting a rosy picture of IFIN despite being aware of the poor financial health of the company, triggering the ministry to seek ban on the auditors.

The i10 NIOS is the first launch of several new cars in the coming few days including Hyundai's sister company Kia's entry into India with the Seltos, Maruti-Suzuki's new XL6, Renault's Tribler and BMW launching the latest iteration of its iconic 3-series. The i10 NIOS has been priced between ₹4,99,990 to ₹7,13,950 for the petrol model and between ₹6,70,090 to ₹7,99,450 for the diesel model, ex-showroom,

all-India. Hyundai India managing Director, SS Kim said that 2019 has been a 'big year' for Hyundai with the launches of the second-generation Santro, the Venue SUV, the first electric SUV in the Kona and now the new i10. "We have become India's leader in the SUV segment after the Venue and have the most comprehensive SUV range," Kim told *The Pioneer*, "and we expect that our hatchback customers will also be excited with this fascinating

patible and the diesel engine will be made BS6 compatible in early 2020.

Speaking to *The Pioneer*, Je-Ruk Chun, Head of Engine Performance Test Group, Hyundai Motor Company said that this is because of pricing reasons, as meeting BS6 emission norms requires significant modifications to engines. # ₹ hits fresh 6-mth low of 71.71; dives 28 paise

The Indian rupee on Tuesday furthered its loss by another 28 paise to close at a new six-month low of 71.71 against the US dollar as economic uncertainties continued to weigh.

Investors remained risk averse considering a host of factors including fast-spreading economic slowdown, outlook on foreign fund outflows and weakness in most emerging market currencies, according to forex traders.

However, there are expectations that the government will soon come out with stimulus measures to arrest slowdown in consumer demand in various sectors.

Meanwhile, higher crude oil prices also had its impact on rupee's trading pattern.

Brent crude futures, the global oil benchmark, rose 0.07 per cent to trade at \$59.78 per barrel.

Starting off on a weaker note, the rupee fell to a day's low of 71.80 against the US dollar before settling at 71.71 against the US dollar, down 28 paise over the previous close.

This is the lowest level for the local unit since February 4, when it closed at 71.80 a dollar.

On Monday, the Indian rupee had settled at 71.43 against the US dollar. Meanwhile, the dollar index — which gauges the greenback's strength against a basket of six currencies — rose 0.06 per cent to 98.40.

The 10-year Indian government bond yield was steady at 6.58 per cent on Tuesday.

"Indian rupee declines for a second day as importers and foreign banks rush for the dollar amid recovery in crude oil prices. Market is also expecting fund outflows of around ₹102 million on the back of Shell selling stake in Mahanagar gas," said V K Sharma, Head PCG & Capital Markets Strategy, HDFC Securities.

The dollar Index hovered near a three-week high as expectations of fresh stimulus drove an improvement appetite for riskier assets and lifted US government bond yields, he said, adding that the next support for the rupee is seen at 72.5 odd levels.

# Govt allows airlines to use Jet slots till end Dec

The civil aviation ministry has allowed domestic airlines to operate the slots vacated by the now-defunct Jet Airways at various airports till December 31, said an industry source Tuesday.

Jet Airways, which is under insolvency proceedings, stopped flying from April 17, leaving hundreds of slots vacant at both domestic and international airports.

The government had allocated some of these slots to local carriers and allowed them to operate up to September 30 to overcome the capacity deficit.

It can be noted that a day after submitting the EoI, Vulcan Investments, an investment company funded Vedanta chairman Anil Agarwal's family trust, withdrew the same.

# Resolve stressed assets on time in your interest: RBI to banks

PTI ■ MUMBAI

Reserve Bank deputy governor NS Vishwanathan Tuesday exhorted bankers to ensure timely resolution of stressed assets under the new framework to extract the best value and underlined the need for dealing only in "genuine" cases.

The central bank will be coming out with the final guidelines for private and foreign bankers' compensation soon, he said, speaking at the annual industry event Fibac.

Vishwanathan said the RBI's revised framework on resolution of stressed assets introduced on June 7 is "less intrusive" as it gives banks the leeway to draft their own resolution plans for a particular case.

"Timely resolution is very important. I'd request you to ensure that the resolutions are done in time, not just for the regulatory requirement but also because it will result in better valuation going forward," he said.

"We've given a lot of freedom to banks to determine various contours. We are making less intrusive regulations and hope that banks will use this to deal with genuine stress in their balance sheets to address the problem," he added.

The RBI issued the new NPA recognition and resolution guidelines on June 7 after the Supreme Court had in April declared the earlier one issued on February 12, 2018 as ultra vires.

The new framework lays focus on better coordination between banks while dealing with a stressed assets by mandating them to sign inter-creditor agreements and decide on a resolution strategy in 30 days, which will have to be implemented in 180 days.

Meanwhile, Vishwanathan also said the RBI will soon be coming up with the final guidelines for top management compensation.

# Media & entertainment set for slowdown, may grow 12% in FY20

PTI ■ MUMBAI

Rapid growth in digital users, combined with growing regional demand and better monetisation, the media and entertainment industry grew 13 percent to reach ₹1,63,100 crore in FY19, and is likely to clip at a slower rate of 12 percent in FY20, says a report.

The report by KPMG, however, noted that it not been for the uncertainties created by Trai's new tariff order and the signs of economic slowdown, the industry would have grown by 1-2 percent more. In FY20, the industry is likely to grow at a slower 12 percent to ₹1.88 trillion, as it expects another round of regulatory changes.

"The growth would have even lower than 12 percent had not been for the gains from the higher ad spends during the April-May general elections and the cricket World Cup.

"TV faced major headwinds in FY19 and in fact grew at a lower rate than projected last year primarily on account of the delay in implementation of the new tariff order.

# Govt cancels coal block jointly allocated to NTPC, JKSPDC

The central Government has cancelled the joint allocation of a coal block in Odisha to state-owned NTPC and Jammu & Kashmir State Power Development Corporation.

NTPC and Power Development Department, Jammu and Kashmir, had earlier requested the coal ministry for cancellation of the coal block.

"It has been decided, with the approval of competent authority in the Ministry of Coal, to cancel the allocation of Kudanali-Luburi coal block jointly allocated to NTPC Ltd and Jammu & Kashmir State Power Development Corporation Ltd (JKSPDC)," the coal ministry said in a letter to both the companies.

The ministry further said there is no provision under the Mines and Minerals (Development and Regulation) Act, 1957, and the rules made thereunder to allocate fresh coal block in lieu of a cancelled coal block.

# Oriental Bank of Commerce launches Repo Rate linked Home Loan & Vehicle Loan

# SBI announces home, auto loans at cheaper rates during festival season

New Delhi (PTI): State Bank of India (SBI), the country's largest lender, on Tuesday announced a number of offers including cheaper rates for home and auto loan borrowers, to cash in on festival fervour. Customers can avail the cheaper loans with added benefits such as waiver in processing fees, pre-approved digital loans and loans with no escalation in interest rates spread across various categories, SBI said in a statement.

The bank has not specified the time period for which this festival offer would be valid. However, the move would be followed by the other lenders as well. "SBI has waived processing fees on car loans during festival season. The bank is offering lowest interest rate starting from 8.70 per cent to customers opting for car loan, with no

escalation in interest," it said. No escalation will ensure that the customer will not have to face fluctuation in the interest rate. For customers applying for a car loan online through the bank's digital platform like YONO or website, a 25-basis point concession on interest rate can be availed, it said.

The salaried customers can also avail the loan up to 90 per cent of the car's on-road price, it said. Recently, SBI reduced marginal cost of funds-based lending rate (MCLR) by 15 bps due to which overall home loan interest rate is now reduced by 35 bps since April 2019. Currently, the bank offers cheapest home loan with an interest rate of 8.05 per cent as repo rate-linked home loan and this rate will be applicable to all existing and new loan from September 1, it said.

# Central Bank to raise upto ₹3,000cr core capital from mkts

State-run Central Bank of India is planning to mop up around Rs 3,000 crore in core capital from markets in the next two months, a top official said.

This capital is excluding the fund infusion that is likely to come from the government, Pallav Mohapatra, managing director and chief executive, told reporters on the sidelines of the annual industry conference Fibac here Tuesday.

"We want to raise Rs 2,000-3,000 crore from markets apart from what we get from the government," he said, adding the money will be raised in the next two months either through a follow-on offer or a qualified institutional placement.

The bank has also made a funding request to the government from the Rs 70,000-crore it has budgeted, Mohapatra



said, refusing to disclose how much they have asked for.

He said the bank expects the money from the government to flow in by September and added that its capital raising plan from the market does not hinge on it. The money will be raised in tranches from the market.

The city-based bank is targeting a credit growth of 10 per cent during the fiscal, he

said, adding the demand is expected to pick up in the second half. It is expecting a credit growth of up to 15 per cent in the retail, agriculture and small businesses, while corporate will be slower, he said.

"As of now, credit growth coming from retail. There is demand in MSMEs, roads, renewables. In a few months from now, manufacturing also will be there," he said.

Mohapatra said the bank will be coming out with re-linked loans by September end in the retail segment for new loans and existing borrowers can also switch to the new lending benchmark for a fee.

On the government commitment of state-run banks buying out Rs 1 trillion worth of loan portfolios from the troubled NBFCs, Mohapatra said he will move the board with a request towards this next month.

# Samsung unveils Note 10, Note 10+

New Delhi (PTI): Tech giant Samsung on Tuesday said it is confident of cornering 65 per cent market share in the premium smartphone segment (Rs 30,000 and above) with the launch of its flagship Galaxy Note 10 and 10+ in India.

# US tests cruise missile after INF treaty exit

AFP ■ WASHINGTON

The US Defence Department announced on Monday the test of a medium-range ground-launched cruise missile, just weeks after tearing up the Cold War-era pact with Russia that eliminated such nuclear-capable weapons.

The missile was launched on Sunday from the US Navy-controlled San Nicolas Island off the coast of Los Angeles, California.

"The test missile exited its ground mobile launcher and accurately impacted its target after more than 500 kilometers of flight," the Pentagon said in a statement.

"Data collected and lessons learned from this test will inform the Department of Defense's development of future intermediate-range capabilities."

While the missile was described as "conventionally configured," meaning not nuclear-equipped, the launch was a sign of Washington beefing up its nuclear war-fighting



capabilities in the wake of the collapse of the Intermediate-Range Nuclear Forces Treaty on August 2.

The INF had banned all land-based missiles, conventional and nuclear, that could travel between 500 and 5,500 kilometers (310 and 3,400 miles), in an effort to abolish a class of nuclear arms deployed across Europe by the United States and the then-Soviet Union.

Many fear the end of the INF, which Washington accused Moscow of having

violated in recent years, will lead to a new and dangerous nuclear arms race.

On August 2, Secretary of Defense Mark Esper said the US, no longer bound by the INF, had already begun work to develop "mobile, conventional, ground-launched cruise and ballistic missile systems."

"Now that we have withdrawn, the Department of Defense will fully pursue the development of these ground-launched conventional missiles as a prudent response to Russia's actions," Esper said.

# Cameroon anglophone separatist leader gets life sentence

AFP ■ YAOUNDE

A military court in Cameroon on Tuesday handed a life sentence to the head of the country's anglophone separatist movement, Julius Sissiku Ayuk Tabe, in a move that analysts said could inflame the 22-month-old revolt.

Ayuk Tabe, a charismatic leader widely deemed as a moderate in the separatist movement, was convicted with nine others of charges including "terrorism and secession", the state's lawyer, Martin Luther Achet, told AFP.

They were given life terms. The sentences were confirmed by a lawyer for the separatists, Joseph Fru, who added the 10 had also been fined 250 billion CFA francs (USD 422 million, 381 million euros).

Fru condemned what he called a "parody of justice" and said the defendants refused to recognise the right of the military tribunal in Yaounde to try them. Their lawyers have yet to say whether they will file an appeal.

# Johnson issues backstop Brexit ultimatum, EU rebuffs

London: British Prime Minister Boris Johnson has issued an ultimatum to the European Union (EU) over what he has branded an "anti-democratic" Irish border backstop, which must be scrapped to negotiate a new deal before the October 31 Brexit deadline.

But the ultimatum was rejected by the EU as it restated its stand on the backstop being non-negotiable.

In a letter to European Council President Donald Tusk on Monday night, Johnson reiterated his "highest priority" was to achieve an agreement to avert a chaotic no-deal exit from the 28-nation economic bloc, but not with any kind of

backstop - designed to avert a post-Brexit hard border between EU member-country Ireland and British region Northern Ireland.

"The changes we seek relate primarily to the backstop. The problems with the backstop run much deeper than the simple political reality that it has three times been rejected by the House of Commons," writes the prime minister in his letter.

"The truth is that it is simply unviable... it is anti-democratic and inconsistent with the sovereignty of the UK as a state," he notes.

Tusk took to Twitter on Tuesday to rebuff the claims, accusing the British prime min-

ister of not proposing realistic alternatives to the backstop.

He said: "The backstop is an insurance to avoid a hard border on the island of Ireland unless and until an alternative is found."

"Those against the backstop and not proposing realistic alternatives in fact support reestablishing a border. Even if they do not admit it."

Johnson, who has been a vehement critic of the clause in the withdrawal agreement negotiated by his predecessor Theresa May, told Tusk that it locks the UK, potentially indefinitely, into an international treaty which will bind Britain into a customs union. **PTI**

# Gunman in Brazil holds 16 bus passengers hostage

Rio de Janeiro: A gunman is holding at least 16 bus passengers hostage in Rio de Janeiro on Tuesday, officials said, as police negotiate with the hijacker to try to end the standoff.

At least six people -- four women and two men -- have been freed so far from the vehicle that is stopped on heavily transited bridge connecting Rio with neighboring city Niteroi.

Heavily armed police including military and snipers have surrounded the bus as they negotiate with the gunman, who G1 news reported is

armed with a gun, a tazer and gasoline.

A live broadcast of the scene shows five ambulances parked near the bus, receiving hostages as they are released.

A series of gunshots have been heard, Globo TV reported. The gunman reportedly boarded the Rio-bound bus at 5:30 am (0830 GMT) and began threatening passengers.

Several lanes of traffic on the busy Rio-Niteroi bridge spanning Guanabara Bay have been paralysed during the ongoing hostage situation. **AFP**

# Russia, China blast US missile test

Moscow: Russia and China warned Tuesday that a new US missile test had heightened military tensions and risked sparking an arms race, weeks after Washington ripped up a Cold War-era weapons pact with Moscow.

The US and Russia ditched the Intermediate-Range Nuclear Forces (INF) treaty this month after accusing each other of vio-

lating the accord.

Washington said the agreement also tied its hands in dealing with other powers such as China. The US Department of Defense announced on Monday it had tested a type of ground-launched missile that was banned under the 1987 INF agreement, which limited the use of nuclear and conventional medium-range weapons. **AFP**

# Trump seeks to sue Google for 'manipulating votes' in 2016 polls

Washington: US President Donald Trump on Monday sought to sue multinational technology company Google for allegedly manipulating up to "16 million votes" in favour of Democratic presidential candidate Hillary Clinton in the 2016 elections.

The election results had surprised many as Clinton was tipped to win by the media and pollsters.

"Wow, Report Just Out! Google manipulated from 2.6 million to 16 million votes for Hillary Clinton in 2016 Election! This was put out by a Clinton supporter, not a

Trump Supporter! Google should be sued," Trump tweeted.

"My victory was even bigger than thought!" he said.

Trump was apparently referring to the work of Robert Epstein, a researcher with the California-based American Institute for Behavioral Research and Technology.

Epstein had testified in a Senate hearing in June that his research shows Google's search results pushed at least 2.6 million people to vote for Clinton in 2016.

Google CEO Sundar Pichai was asked about Epstein's work

# Seoul to fine Volkswagen over 'illicit' emissions devices

Seoul: South Korea said Tuesday it would issue fines and file criminal complaints against Volkswagen and its luxury arm, Porsche, for installing "illicit" devices that helped multiple diesel vehicles cheat pollution standards.

The environment ministry said over 10,000 vehicles sold in South Korea by Volkswagen and Porsche from May 2015 to January 2018 were fitted with the devices, resulting in 10 times

more nitrogen oxide emissions than standard levels.

The certifications for eight models -- including Audi A6, Volkswagen Touareg and Porsche Cayenne -- will be revoked and the carmakers will face an estimated fine of 11.5 billion won (US\$9.5 million), the ministry said.

"We plan to continue responding firmly to manipulation of gas emissions in future," a ministry official said. **AFP**

# Toll from attack on Burkina military base rises to 24

AFP ■ OUAGADOUGOU

The death toll from an attack Monday on a military base in northern Burkina Faso rose to 24, the military said, in an unprecedented blow to the army in its campaign against jihadist insurgents.

Seven people were wounded and five others missing, armed forces headquarters said in a statement Tuesday.

The previous toll from the attack, at Koutougou in Soum province near the border with Mali, had been given late Monday as "more than a dozen".

An "extraordinary meeting of the defence council" was underway at the presidential palace in the capital Ouagadougou, a security source told AFP.

The country's main opposition party, the Union for Progress and Change (UPC), said the government appointed by President Roch Marc Christian Kabore had "completely failed".

It called for a "new team, whose prime task will be to defend territorial integrity and protect the public."

Monday's attack came four days after suspected jihadists raided a village in the restive north, killing 15 people, plundering and burning shops.

A former French colony that ranks among one of the poorest countries in the world, Burkina Faso has been struggling with an Islamist revolt since 2015, which began in the north but has since spread to the east, near the border with Togo and Benin.

# Epstein signed will 2 days before jailhouse suicide

AP ■ NEW YORK

Jeffrey Epstein signed a will just two days before he killed himself in jail, new court records show, opening a new legal front in what could be a long battle over the financier's fortune.

Court papers filed last week in the US Virgin Islands list no details of beneficiaries but valued the estate at more than \$577 million, including more than \$56 million in cash.

The existence of the will, first reported by the New York Post, raised new questions about Epstein's final days inside the Metropolitan Correctional Center, where he was awaiting trial on federal sex trafficking and conspiracy charges.

Epstein signed the document Aug. 8. Less than 48 hours later, he was found dead in his cell, prompting an investigation that has cast a harsh light on staffing shortages at the Manhattan detention center.

# 'Good revision strategy is key'

With less than one month left for the JE CBT-2, students often start panicking. AKHAND SWAROOP PANDIT shares tips that will help them ace the exam

After the result declaration of RRB CBT — 1, the students are left with a very short period of time around twenty days to prepare for CBT — 2. Smart preparation and incorporating few techniques the students can ace the CBT — 2 exam as well. Here are seven tips and techniques to crack the RRB JE CBT — 2 exam.

**Analyse the syllabus:** First things first, it is advised that the students should first analyse the syllabus which is classified and concise. The preparation of RRB JE CBT-2 differs from SSC/GATE OR IES preparation. So, the students should stick to the syllabus and prepare smartly.

**Practice direct questions:** Students should focus on practicing direct questions rather than giving too much time to theory. Compared to reading theory, it will be beneficial for the students if they do solve direct questions as it may increase their efficiency also. Level of questions are expected to be moderate so high level questions should not be considered.

**Prepare a proper time table:** Student should make a proper time table including two-three subjects daily. It's always advised to study two-three subjects daily in loop than going for only one subject to maintain the efficiency. And, direct question should be practiced on a daily basis at least hundred to two hundred



questions.  
**Don't ignore the non-technical part:** Nontechnical part covers 50 marks and it needs to be practiced daily. Students to dedicatedly devote at least an hour daily to practice it, students who ace this section will definitely score well and get at the edge.  
**Revision strategy:** A good revision strategy is also important because without revision whatever the students study will be futile. So at least every third day student should revise whatever they have studied in past two days. This cycle of revision must continue till the exam.  
**Formulas are very important:** For RRB JE CBT-2, the numerical's will be mostly based on direct formulas and thus students must remember them. A simple hack to

remember all the formulas are that they can write all the formulas on a chart paper and paste them in front of their study table which will help them in daily revisions. This is an important step as in CBT-2 exam virtual calculator is allowed and mostly all the numerical's will be formula based and those formulas must be on your tips.

**Short notes and flash cards:** Students should revise from the short notes and flash cards to save time. The exam is all about smart preparation thus short notes & flash cards are always a better option.

Since the gap between CBT-1 and CNT-2 is very short the exam is expected to be easy. So, it is all about right preparation at the right time and you can score well.

## How do you look at IIT-Delhi's contribution towards furthering India's competitiveness among global economy evolution?

Of these, nearly 11,970 have graduated with BTech degrees, 3,541 received PhD degrees, and the remaining obtained Master's Degree in Engineering, Sciences and Business Administration. These alumni today work as scientists, technologists, business managers and entrepreneurs. They have contributed significantly to building of this nation, and to industrialization around the world. In fact, of the top twenty Indian Unicorn founders, eleven have been founded by IIT Delhi alumni. ## What are the focus areas for industry-academia partnerships in next few years?

The large numbers of young Indians can be a demographic dividend if they are educated well and have the skills to work in jobs likely to arise in the 21st century. Conversely, they may become a demographic nightmare if they don't have such skills. But what kinds of skills will students need to be successful in the 21st century?

## Understanding three kinds of skills

As an answer to this question first consider that there are three kinds of skills people have, namely internal skills, interpersonal skills, and effectiveness related skills. Internal skills include analytical skills, self-management skills, and planning and organization skills. Interpersonal skills are used to interact with

internal teams and external customers. Collaboration, networking, teamwork, and negotiation are components of interpersonal skills. Effectiveness skills make people effective at their job.

People with good effectiveness skills are good at their work. Effectiveness skills include virtual productivity. Because so much work is done online, people productive in the virtual world are more effective at their jobs. Critical thinking, problem-solving, and the ability to research and analyse data are also components of effectiveness skills. The ability to research and analyse data is important because there is a plethora of data, yet using data to gain insights and derive intelligence requires considerable skill. Finally, presentation skills and

communication skills are important skills as well because they help people produce better results crucial for success.

## Other crucial skills

All the above-mentioned skills to some extent are essential for young people to be employable yet young people need other skills as well. To see why consider that today large and small companies are impacted by global events. Every large company has a global footprint while smaller companies are also impacted by events on the other side of the globe. Hence the employees of tomorrow

need to be attuned to a worldview that they are global citizens. A feeling of global citizenship needs to be inculcated within them. Young people also need to be inculcated with environmental skills. The environment is in a precarious state, yet too many even now remain unaware of the harm they are causing the environment and of steps they can take to eliminate such harm.

Ethics and compassion will play an increasingly important role in the future. Leaders need to be instilled with a sense of ethics and compassion so they can lead effectively. Being compassionate and having

a solid ethical framework makes for sound leadership and allows leaders to make ethical decisions when faced with moral conundrums.

## Why these skills are necessary

Today the journey of many professionals is one paved largely with chance. There is little or no structure in place to ensure that a good education leads to commensurate life outcomes. Rather usually even highly educated professionals fail to reach their fullest potential.

Career progression is in effect a roll of the dice in which winners and losers are decided not by merit but mere happenstance. Because career progression depends on the roll of the dice, meritorious individuals often

don't reach upper echelons of organizations and don't make decisions that could produce benign and wide-reaching results that benefit more people.

Each of the skills mentioned should be taught at appropriate ages before students turn 16. When internal skills, interpersonal skills, effectiveness related skills, and awareness of global citizenship, the environment, and ethics and compassion are coded into individuals at a young age, their life outcomes will happen not by chance but design. This is why the mentioned skills are so essential to the success of young people today and for society to prosper in the future.

### QUEENSLAND VARSITY PARTNERS WITH INDIA

The University of Queensland (UQ) has identified India as an integral market for research collaboration, corporate partnership and student mobility. The UQ shares a valued relationship with India, strengthened by decades of academic and industry partnerships and student mobility opportunities.

### CONVERSION OF HEAT INTO ELECTRICITY

The Indian Institute of Technology (IIT) Mandi researchers are developing thermoelectric materials that can convert heat into electricity. While solar power has received a lot of attention, other alternative sources

are equally promising, even if less known. A research team led by Dr Ajay Soni, Associate Professor (Physics), School of Basic Sciences, IIT Mandi, is studying materials that can convert heat into electricity. About 70 per cent

of energy in the world is wasted as heat, one of the key players of global warming.

The conversion of waste heat into electricity can serve the dual purpose of energy-self-sufficiency and environmental preservation.

# 'Frightening' Archer won't let-up: Stokes

England's Ben Stokes has told Australia to expect more bouncers from Jofra Archer in the remainder of the Ashes.

"It's part of the game and a big part of Jofra's game, being aggressive, not letting batsmen settle," said Stokes.

Archer produced a hostile and compelling display on debut as the rain-affected second Test ended in a draw at Lord's on Sunday.

Not only did he take five wickets, he repeatedly unsettled Australia with a short-pitched ball. The 92mph bouncer that hit Steve Smith on the neck forced the star batsman to miss the last day with concussion.

"When someone takes a nasty blow no bowler is going to say 'I'm not going to bowl that again because I don't want to hit them again,'" Stokes, a lively seam bowler, added.

"The concern is always there when someone takes it, but next ball, when you get back to the mark, it's 'I'm going to keep doing it.'" Smith, who could be ruled out of the third Test at Headingley starting on Thursday as well, had earlier been hit a painful blow by Archer on his left forearm.

Marnus Labuschagne, Smith's replacement at Lord's as cricket's first concussion substitute, was then hit flush on the grille of his helmet second ball by another Archer thunderbolt.

All the deliveries are considered a legitimate part of a fast bowler's armoury and Stokes said Archer had no reason to change his approach in Leeds.

Stokes believes Archer's extra pace can help England overturn a 1-0 deficit in the five-match Ashes series following their 251-run loss in the first Test at Edgbaston.

"Everything is so rhythmical with Jofra it is tough to see when that bouncer is coming," said Stokes.

"There's no 'tell'. He bowled a lot of them, but they don't seem to pick it up.

"He gives another dimension to our bowling attack. The first innings he bowled 29 overs but his last spell of eight was one of the best out-and-out fast bowling spells I have seen since I started playing," he added.

"We've seen (Australia's) Mitchell Johnson do it to us,

especially in 2013, but Jofra just makes it look so easy. I'd rather have him on my team than have to face him. He's a frightening talent.

"The sky is the limit for him and he's a great addition to our Test team."

England's top order remains a concern but after all-rounder Stokes's elevation to number five in the second innings at Lord's, he scored an impressive 115 not out.

"It just depends on what happens in the game," he said.

"I went to six because my bowling workloads have gone up in the last few years. I'm sure it will change.

"We're a very versatile batting line-up, some days it might be Jonny Bairstow at five, some days Jos Buttler, some days me. We're all capable, it just depends on workloads."

## Eng need to preserve Archer: Akhtar

Former Pakistan speedster Shoaib Akhtar believes England have got a great weapon in Jofra Archer but they need to preserve him and manage his workload in a way that the 24-year-old doesn't get injured very often.

"Archer is an exciting talent. He is strong but I believe he is the perfect candidate for being injury prone. With his action and speed, I believe he can have back injuries, so he needs to be preserved," Akhtar said in a


video posted on his Youtube channel.

"My suggestion will be to play him in fewer matches, he should not bowl 27 overs in an innings. What he cannot do in 14 overs, he won't be able to do it 27 overs," he further said.

Akhtar also feels that Ashes, which is currently 1-0 in favour of Australia, would now take a turn with Archer's inclusion into the England lineup.

"I think Ashes will now take a turn. I believe fast bowlers should bowl with more intensity now.

Healthy rivalry augurs well for team's pace attack, says Umesh

Pacer Umesh Yadav says he has regained confidence after working on his erratic line and length in the time away from the Indian team and is confident of making the playing eleven in the Test series against the West Indies starting on Thursday.

Umesh, who took three wickets for 19 runs in the West Indies A first innings in the warm-up game which concluded on Monday here, said he worked on getting his rhythm back at the Vidarbha Cricket Academy with coach Subroto Banerjee in the last few months.

"As a fast bowler you have to practice and you need to set your rhythm, to know at what line and length you have to bowl. I have also tried the same, to get my rhythm right. I was preparing myself to do what I will be doing in a match situation," Umesh said after the drawn warm-up game.

"I went to Vidarbha Cricket Academy and worked with coach Subroto Banerjee there and asked him for his opinion. There were these issues of length of deliveries. It happens to a lot of fast bowlers, when you are playing a lot continuously, you're unable to settle into a specific line and length. I worked on that," he added.

He said he was able to bowl into the right areas during the warm-up game against the West Indies A team.

"I am playing a practice match after a long time. I had earlier come here to play for India A and I played one game. The wicket is not too different and it has swung.

"(In the warm-up game) I was focussing on the areas I have to put the ball. My mindset was to put the balls in those areas and bowl dot balls. I was being able to do that," he added.

The 31-year-old played his last Test in Australia in December 2018. He then played for Vidarbha in the domestic competitions and followed it up with a stint with Royal Challengers Bangalore in the IPL.

"After the Australia tour, I played in Ranji trophy and we (Vidarbha) won and then IPL came. In the two and half months after that, I gave myself some time to work on my errors and get my rhythm back. Accordingly, I prepared my mindset.

"I worked on bowling drills and trained a lot on whatever bowling problems which I thought I had. You need off-time because it is only during your off-time that you can re-shape your mindset on what needs to be done," he added, when asked about the drills at the Vidarbha academy.

Asked about the competition in the current Indian team in the fast-bowling department, he said, "When you know you're going to play back-to-back Test matches, you need that kind of benchmark strength.

"All the fast bowlers there is a good competition and that everyone is going to get an opportunity. Whoever does well, will get to play more. If we think in that manner, it's good for us because we will try to improve ourselves.

"It is a healthy competition and it is good for the team. It makes us more exciting and challenging and will improve our performance."

## McGrath loves what he sees in Jofra

The legendary Glenn McGrath is a big supporter of Jofra Archer and feels the England pace sensation is going to play Test cricket for a long time.

"I've been a big supporter of Archer for a long time and I love what I see there," McGrath was quoted as saying by BBC where he will be part of the Test Match Special commentary team and contribute a regular column to the BBC Sport website.

"It's quite rare to be able to bowl with pace and accuracy for such a long time. To have pace is so unique and with Archer, it is all natural. His action doesn't look too stressful, he has a nice, smooth run-up and goes through the crease really well.

It's a fairly stress-free action and he's young and fit. He keeps it simple: "He just comes in, bowls good areas and with good pace."

Archer took the cricketing fraternity by storm on his Test debut, bowling hostile spells which put even the likes of Steve Smith in all sorts of discomfort during the course of the game, reminding fans of the famous bodyline series.

"At Lord's he bowled some quite lengthy spells, but he main-

tained his pace throughout his overs. That is a brilliant sign that he can bowl long spells at top pace then come back and bowl second and third spells no problem at all," McGrath pointed out.

"With a guy with his action

and technique, I don't see any reason why he can't play plenty of Tests. It's just experience that he needs and he will be fine," said the former Australian fast bowler regarded as one of the finest the game has produced.

## Murray falls in first hurdle

Andy Murray on Monday fell in the first round of the ATP Winston-Salem Open, where the three-time Grand Slam champion was giving his surgically repaired hip just its second test in singles.

Britain's Murray, who feared in January that his hip trouble would end his career, accepted a wild card into this week's tournament in North Carolina after falling in his singles comeback in Cincinnati last week.

He again showed glimpses of his once-dominant self, but was inconsistent in a 7-6 (10-8), 7-5 loss to 73rd-ranked American Tennyson Sandgren in a match lasting 2 hours and 10 minutes.

"Some things were a bit better today I think," Murray said. "I was hitting the ball a bit cleaner than I did maybe in Cincinnati... I feel like I moved fairly well to some drop shots, which maybe last week I wasn't running to.

"So there's some good things in there but also some stuff I would like to do better."

### LANDMARK FOR LEE

Having said in Cincinnati he would discontinue doubles to focus on returning to peak singles form, Murray said he might consider playing an ATP Challenger Tour event before heading to Asia, where he is entered in September's Zhuhai Championships and the China Open.

"Maybe I need to play a level down to get some matches and build my

game up a little bit before I start playing on the tour again," he said.

In other action on a day when rain wreaked havoc on the schedule, South Korean Lee Duck-hee became the first deaf player to win an ATP Tour match, beating Switzerland's Henri Laaksonen 7-6 (7/4), 6-1.

"My message for people who are hearing impaired is to not be discouraged.

If you try hard, you can do anything," said Lee, who will next face third-seeded Hubert Hurkacz of Poland.

Lee was two points from victory when thunderstorms swept through.

When he and Laaksonen returned some five hours later, Lee quickly polished off a win he admitted he hadn't been expecting.

"I thought that I was just going to do my best and try to stay focused," Lee said. "But I came out a winner."



## Rashid to captain Afghans in B'desh
