## Booster shot for sagging economy

Super-rich surcharge on FPIs dropped; ₹70K cr infusion in banks to drop EMIs; ₹100L cr for infrastructure

After Chief Economic Adviser (CEA) Krishnamurthy Subramanian ruled out a major stimulus package for the economy triggering a massive sell-off in the equity market, the Government did just the opposite on Friday. Finance Minister Nirmala Sitharaman on Friday announced a slew of measures to perk up the economy and address the concerns of foreign portfolio investors, who pulled out nearly \$3 billion from the India stock markets ever since the Budget imposed surcharge on their investment. Relentless selling by the foreign portfolio investors (FPIs) and concerns about the health of economy saw sensex losing more than 4,000 points in less than two months.

The stimulus package included rollback of super-rich surcharge on FPIs, domestic investors on gains from stock market, frontloading of already announced ₹70,000 crore of recapitalisation package for PSU banks, CSR violation not to be treated as criminal offence, reduction on EMIs for housing loans, vehicle and other retail loans and providing protection to honest decision-making by bankers for boosting lending. Also it included additional liquidity support to HFCs raised to ₹30,000 crore, pending GST refunds to MSMEs to be paid within 30 days, amendment to MSME Act to move towards single definition to be considered, issue of IT orders, notices, etc through a centralised system to cut harassment, etc.

Besides, the Government said it will set up an inter-Ministerial task force to short-list infrastructure projects for its ambitious target of spending ₹100 lakh crore in the sector. With several major companies reporting sinking profit and announcing job cuts, the Government had a few options,

but to come out with some relief for both the equity market and corporates as well as commoners. The Finance Minister did try to cover all the key stakeholders within the constraints of not too rosy tax revenue scenario.

The reversal of FPI surcharge shows that the people engaged in the Budget making completely failed to understand the mindset of foreign investors.

It is also baffling why someone like the CEA made such a comment about no stimulus, the news was one of the prime reason of sail-off in the market and estimated loss of nearly ₹2 lakh crore of investors' wealth in a single day.

"In order to encourage investment in the capital market, it has been decided to withdraw the enhanced surcharge levied by Finance (No.2) Act, 2019 on long/short term capital gains arising from the transfer of equity shares/units," Sitharaman told reporters here.

The move will dent Government revenues by ₹1,400 crore.

Sitharaman had in her maiden Budget hiked the surcharge on income tax paid by super-rich individuals. The surcharge, levied on top of the applicable income tax rate, was hiked from 15 per cent to 25 per cent for those with taxable income of ₹2-5 crore and to 37 per cent for those earning more than ₹5 crore. This increased the effective tax rate for these two groups by 3.12 per cent and 7 per cent to 39 per cent and 42.74 per cent, respectively.

Some 40 per cent FPIs automatically came under the higher tax rate as they have been investing as a non-corporate entity such as trust or association of persons (AOPs), which in the Income Tax law are classified as an individual for the purpose of taxation.

Sitharaman also announced exempting start-

ups from the so-called angel tax. "To mitigate genuine difficulties of start-ups and their investors, it has been decided that section 56(2)(viib) of the Income Tax Act shall not be applicable to a start-up registered with DPIIT," she said.

The Government also announced several relief measures, including deferring one-time registration fee, lifting ban on purchase of petrol/diesel vehicles and allowing higher depreciation, but it remained non-committal on the demand for a reduction in GST rates.

In a bid to help clear rising inventory of BS-IV emission compliant vehicles, it said such vehicles purchased till March 31, 2020 will be allowed to ply till the validity of their registration. This is because the country is to leapfrog to selling only BS-VI emission compliant vehicles from April 1, 2020.

Auto sales in the country have been declining for almost a year now with the passenger vehicles (PVs) segment being the worst hit. Industry estimates suggest that 2 lakh jobs have been cut in the last three months as auto companies and component makers grapple with slow demand.

Finance Minister Nirmala Sitharaman said representatives from the automotive sector had held meetings - both as an industry and individually.

"BS-IV vehicles was a big issue. There was a confusion because the government wanted to make an announcement to encourage electric vehicles and electric batteries (production)... BS-IV vehicles, which are purchased up to March 2020 will all remain operational for their entire period of registration," she told reporters while announcing measures to boost the sagging economic growth.

The government also announced an additional Rs 20,000-crore liquidity support to the struggling housing finance companies (HFCs), a

move aimed at enhancing their lending capacity.

The additional liquidity support to be provided by the National Housing Bank (NHB) will help the real estate sector

which is facing a demand slowdown and cash crunch. The Rs 20,000 crore is in addition to Rs 10,000 crore support announced earlier by the housing sector regulator NHB.

Announcing this as part of measures to prop up the economy, the Finance

Minister said now the liquidity support for HFCs would be Rs 30,000 crore.

## Commercial vehicles sans RFID can't enter Delhi after 3 weeks

Till then they need to cough up hefty fine at toll gates as system comes into effect at midnight

The South Delhi Municipal Corporation (SDMC) on Friday announced that only those commercial vehicles which have radio-frequency identification tags (RFID) will be allowed to enter the national Capital after three weeks.

With the RFID system coming into force at 13 busy border points from August 23 midnight, non-RFID vehicles will have to pay penalties in order to enter the city. However, after three weeks, non-RFID vehicles will not be allowed to enter the city, SDMC authorities said.

"After three weeks, those without RFID will not be allowed to enter the city," a senior corporation official said.

The 13 entry points receive 85 per cent of the incoming traffic in Delhi. Once a person buys an RFID tag and it is pasted on his registered vehicle, the environment compensation charge will be deducted at the 13 toll plazas automatically.

The sale of tags will continue on the points-of-sale (POS) installed at 13 RFID toll plazas. Additional six points have been set up in satellite towns of UP and Haryana.

The SDMC had earlier extended the last date for pre-registration and subsequent issuance of RFID tags from August 16 to August 23, considering difficulties being faced by owners of commercial vehicles and taxis in getting pre-registered and subsequently obtaining RFID tags for entry



into Delhi from 13 toll plazas.

Additional Commissioner of SDMC Randhir Sahay said after Friday midnight, non-RFID vehicles will have to pay twice the basic amount of environment compensation charge in the first week. It will become four times in the second week and six times in the third week. "After three weeks, the entry of non-RFID commercial vehicles will be completely banned," he added.

Around 12 to 15 thousand RFID tags are being issued every day, Sahay said, adding that the civic body has issued 1.63 lakh tags and expecting the figure may cross around 1.75 lakh at Friday midnight.

RFID tag aided system facilitates entry of commercial vehicles without any stoppage at toll plazas, cashless transaction, and automatic deduction of the amount of the Environment Compensation Charge (ECC) and MCD toll, completion of the process within three seconds, permanent solution of the congestion at toll plaza and no visibility of long queues apart from containing air pollution, the official said.

The officials said that to recharge the RFID tags through mobile handsets, customers can download 'MCD Toll App' from the mobile play store by registering their number. The RFID system will help smoothen the traffic movement and bring down pollution levels, he added.


## Resounding mandate to build new India: PM Corruption, nepotism reined in like never before, says Modi

Prime Minister Narendra Modi on Friday said the resounding mandate to the BJP in the 2019 Lok Sabha polls was for building a "new India", and asserted corruption, nepotism, loot of people's money, and terrorism have been reined in like never before.

Addressing the Indian community at the UNESCO headquarters here, Modi also talked about "major decisions" such as banning of practice of triple talaq, taken by his Government.

In a veiled reference to abrogation of Article 370 in Jammu & Kashmir, Modi said, "There is no scope for temporary in India. You would have seen that a country of 1.25 billion people, the land of

Mahatma Gandhi, Gautam Buddha, Ram, Krishna, took 70 years to remove what was temporary. To remove temporary it took 70 years, I don't know whether I should laugh or

cry... Reform, perform, and transform and with permanent systems, the country is moving forward to achieve its goal."

Modi, who was in France on the first leg of his three-nation tour, said there have been a number of constructive changes in the last five years.

"India is racing ahead not because of Modi... It is because of the stamp of approval that the people of India have given in the form of their votes," the Prime Minister said amid loud cheering of "Modi hai toh mumkin hai" (it is possible if Modi is there) from the crowd.

He also asserted "in 'new India', corruption, nepotism, dynasty, loot of people's money, and terrorism have been reined in like never before."

## ED can't arrest PC in INX case till Mon, orders SC

In Aircel case, local court grants ex-FM protection from arrest till Sept 3

In a relief to former Union Minister P Chidambaram in the INX media scam, the Supreme Court on Friday granted him protection from arrest by the Enforcement Directorate till August 26. Chidambaram is in the CBI custody in the INX case till August 26.

In real term, the SC's decision does not matter much for Chidambaram as her is already in the CBI custody till August



Chidambaram and his son Karti on the pleas by the CBI and the ED, which sought the adjournment saying that another case pertaining to INX Media involving them was pending before the Supreme Court.

Special Judge OP Saini took strong objection to the agencies seeking repeated adjournments, saying "things have become very embarrassing for me".

The court then reserved order on Chidambaram's anticipatory bail plea for September 3 and extended the interim protection from Chidambaram's arrest by the agencies till then.

## SC to check validity of law making triple talaq punishable offence

The Supreme Court on Friday agreed to examine the validity of a newly enacted law which makes the practice of instant triple talaq a punishable offence entailing jail for up to three years.

A Bench of Justices NV Ramana and Ajay Rastogi issued notice to the Centre on a batch of petitions seeking to declare The Muslim Women (Protection of Rights on Marriage) Act 2019 as "unconstitutional" on grounds that it allegedly violates the provisions of the Constitution. "We will examine this," the SC told senior advocate Salman

Khurshid, who was appearing for one of the petitioners.

Khurshid said there were many dimensions, including making the practice a punishable offence and jail term of up to three years, which need to be examined by the top court.

He said the petitioners were concerned about making triple talaq an offence as the SC had already declared it to be null and void. "If there is no such thing as triple talaq then what are they making an offence," he told the SC and referred to a five-judge Constitution Bench verdict which had declared the practice of triple talaq null and void.

## Singhvi, Tharoor back Jairam on futility of demonisation of Modi

Congress leaders Abhishek Singhvi and Shashi Tharoor on Friday came out in support of party colleague Jairam Ramesh, saying demonising Prime Minister Narendra Modi was "wrong" and he should be praised for doing the right things.

While Singhvi said Modi's acts must be judged issue-wise, not person-wise, Tharoor said praising the PM for doing the right things would lend credibility to the Opposition's criticism of him.

"Always said demonising Modi wrong. Not only is he PM of the nation, a one-way opposition actually helps him,"



Singhvi tweeted while echoing Ramesh's views. "Acts are always good, bad and indifferent — they must be judged issue-wise and not person-wise. Certainly, Ujjawala scheme is only one amongst other good deeds," he said.

Tharoor also joined him saying, "As you know, I have argued for six years now that Narendra Modi should be

praised whenever he says or does the right thing, which would add credibility to our criticisms whenever he errs. I welcome others in Opposition coming around to a view for which I was excoriated at the time."

When asked to comment on the views expressed by these leaders, Congress spokesman Manish Tewari said they are best placed to clarify or amplify, add or subtract to what they have said. "As the Congress party, we believe the country is facing a grim economic situation that will affect the lives of millions and we are extremely worried about it," Tewari said at a Press briefing.

## Trump 'very focused' on Kashmir situation: WH

Donald Trump is "ready to assist" India and Pakistan on the Kashmir issue if both sides ask for it, a top White House official has said, underlining that the US President is "very focused" on the situation in the Valley in view of its "broader implications".

Tensions between India and Pakistan spiked after New Delhi abrogated provisions of Article 370 of the Constitution to withdraw Jammu & Kashmir's special status and bifurcated the State into two Union Territories on August 5. "The United States is watching the situation in Kashmir very closely. We are

continuing to call for calm and restraint, including on rhetoric," a senior administration official said on Thursday ahead of the bilateral meeting between Trump and Prime Minister Narendra Modi on the sidelines of the G7 Summit in France over the weekend.

India has categorically told the world that the scrapping of Article 370 is an internal matter and also advised Pakistan to accept the reality. "We note the broader implications of the developments in Kashmir and the potential for increased instability in the region. So the president is very focused on this situation," the official said.

# 5 officers found guilty of Budgam chopper crash: IAF report

## 6 IAF men died in friendly fire

A high-level probe by the IAF into the crash of a MI-17 helicopter on February 27 this year in Budgam in Jammu & Kashmir has held five officers guilty as it was found out that the helicopter went down after getting hit by an Indian missile, generally known as 'friendly fire'. The incident took place on the day when the

Pakistani jets intruded into India leading to a dog fight. All the six crew members and a civilian on the ground were killed in the crash.

These findings are part of the mandatory court of inquiry and its report is now with the Air Force headquarters for further action. The officers found guilty of negligence and not following procedures include one Group Captain, two Wing Commanders and two Flight Lieutenants, sources said here on Friday.

They also said the officers may face severe punishment as per provisions of the military law adding the IAF top brass

will decide on the quantum of punishment to those held responsible for the incident.

They also said the IAF will initiate action based on the report of the court of inquiry headed by an Air Commodore and the officers may face charges of culpable homicide not amounting to murder.

The inquiry found that the 'Identification of Friend or Fo' (IFF) system on-board the helicopter was switched off and there was a 'vital gap' in communication and coordination between the ground staff and the crew of the ill-fated helicopter.

The IFF helps air defence

radars identify whether an aircraft or helicopter is friendly or hostile.

In early May, the IAF transferred the Air Officer Commanding (AOC) of Srinagar base to ensure a thorough probe into the incident.

The helicopter crashed in Budgam on February 27 when Indian and Pakistani fighter jets were engaged in aerial combat, a day after India's air strike on a Jaish-e-Mohammed terrorist training camp in Balakot in Pakistan. The Pakistani jets unsuccessfully attempted to target various Indian military installations in Rajouri and Poonch sectors.

Officials said the Court of Inquiry was also specifically focusing on examining the role of various people, including those controlling the air defence system when the helicopter was hit by a surface-to-air missile.

Incidentally, the helicopter was shot down around the same time when Indian and Pakistani fighter jets were engaged in the aerial battle. Moreover, the incident took place when the Indian forces on their highest alert following the Pakistani aerial raid. The helicopter crashed within ten minutes of take off after getting hit by own missile.



# Rain, flood hit kharif sowing, tea plantation

The decline in the kharif crop sowing presents grim situation for economy. The sowing of rice and pulses has declined sharply due to floods and heavy rainfall in several parts of the country.

The Union Agriculture Ministry's latest data shows that planting of kharif crops sowing area has slipped below last year's cultivated area of July and August. There has been decline of 20 lakh hectare in rice cultivation and 5 lakh hectare in pulses in the country.

According to National Disaster Relief Force (NDRF), it is estimated that 6-7 lakh hectare under kharif crops have been affected due to flood and incessant rainfall. The final assessment is yet to be made by the inter-State ministerial group. Due to shortage of pulses, prices of arhar, moong and tur have been increased from Rs 50-60 per kg

to Rs 100 per kg. Flood has also affected the cultivation of tea this year as most of the tea plantation have been damaged in Karnataka, Kerala and West Bengal. This may impact the prices of tea in the retail market in the coming days.

India has seen large scale floods in several parts of the country this month. States like Assam, Bihar, Gujarat, Rajasthan, Madhya Pradesh, Karnataka and Kerala have been grappling with devastating floods.

The Agriculture Ministry's data shows that kharif crop planting has covered 975.16 lakh hectare land as compared to 997.67 lakh hectare a year earlier from June up to August 23, a decline of 22.51 lakh hectare so far.

Rice was planted on 334.92 lakh hectares as compared to 355.42 lakh hectare a year earlier, a decline of 23.03 lakh hectare. Bihar, Jharkhand, Tamil Nadu, Kerala, Arunachal Pradesh, Maharashtra and

Assam have reported less is covered under Rice due to flood and rainfalls. In some States, rice cultivation was badly impacted due to flood.

The area of pulse cultivation also dropped from 128.54 lakh hectare last year to 124.56 lakh hectare, a decline of 3.97 lakh hectare so far. Maharashtra, Gujarat, Chhattisgarh, Tamil Nadu, Sikkim, Andhra Pradesh have reported less cultivation this year. Due to shortage of pulses, the prices is expected to increase further in the coming days. Currently, the rate of Arhar, Moong and Urad have been touched Rs 100 per kg.

The area of coarse cereals cultivation is also less by 3.66 lakh hectare this year so far.

A good monsoon is crucial for the country's economy as farming sector accounts for more than 15% of the country's GDP but nearly half of the country's workforce is dependent on the agriculture sector. As many 1500 people died and over 60,000 villages are affected from flood in 14 states. It is estimated that 6 to 7 lakh hectare of agriculture land and 5 to 6 crore poultry destroyed in the flood.

With less than 37 days to go in the 2019 monsoon season, most regions across have record-

ed normal or above normal rainfall till August 23. India recorded surplus rainfall 658.5 mm as against the normal of 652.2 mm so far. Only east and northeast India, especially Jharkhand and Gangetic West Bengal, have recorded significant below-normal monsoon rain.

The countrywide average rainfall accumulation stood 10 percent more than usual in the third week of August. In the first and second week of August, India received 28% and 45 percent above normal monsoon rainfall. As many as 28 sub-divisions have recorded normal monsoon while eight received deficient rainfall.



# SC asks lawyer to be crisp in arguments on 11th day of Ayodhya hearing

New Delhi: The Supreme Court, hearing the politically sensitive Ram Janmabhoomi-Babri Masjid land dispute matter, told a lawyer for a Hindu party on Friday to be "pin-pointed" and "precise" in his submissions.

"Mr (Sushil) Jain, we look forward to your pin-pointed, crisp and precise arguments," the five-judge Constitution bench headed by Chief Justice Ranjan Gogoi said as soon as the senior counsel for the Nirmohi Akhara started advancing his submissions.

The Allahabad High Court, in its 2010 judgment on four civil suits, had partitioned the 2.77-acre disputed land in Uttar Pradesh's Ayodhya equally among the three parties -- the Sunni Waqf Board, the Nirmohi Akhara and Ram Lalla.

The Supreme Court bench, also comprising justices S A Bobde, D Y Chandrachud, Ashok Bhushan and S A Nazeer, had on Thursday asked Jain to explain as to how the Akhara could claim title over the disputed land in the capacity of a "shebait" of the deity.

Friday was the eleventh day of the hearing in the matter

before the apex court.

So far, the Akhara's arguments were contrary to the case it had built in the high court, the bench observed and asked Jain to "build" his case "on merits."

"While arguing, always keep in mind that we have already looked at large part of the documents," it told Jain.

On being told by the lawyer that a note was prepared and he would take around a week to conclude his arguments, the bench said, "You don't need a week, take a day and try your best to put forward the case."

The bench said it had perused many documents and asked Jain to supplement the arguments advanced by other Hindu parties.

"You say that you will do this, you will do that, but you do not start," the bench told the senior lawyer.

Jain said the Akhara was very poor, it had no money and its temple was taken away, adding that the Hindu body was entitled to put forward its case.

"Mr Jain, still you have not started the submissions," the bench said, leading to commencement of arguments. *PTI*



# Manmohan takes oath as RS member for 6th term

Former Prime Minister Manmohan Singh on Friday took oath as a member of the Rajya Sabha for his sixth term. Rajya Sabha Chairman M Venkaiah Naidu administered the oath in his chamber to 86-year-old Singh.

Leader of the House Thawar Chand Gehlot, Congress president Sonia Gandhi and Rahul Gandhi were present during the oath-taking. Leader of the Opposition Ghulam Nabi Azad, deputy leader of Congress in Rajya Sabha Anand Sharma, and Ahmed Patel were also present in the chairman's chamber.

Rajasthan Chief Minister Ashok Gehlot and his deputy Sachin Pilot, besides some BJP leaders were also present. Singh returned to the Upper House unopposed after getting elected from Rajasthan.

"Administered oath to Former Prime Minister Dr Manmohan Singh as Rajya



Sabha MP in my Chamber in Rajya Sabha today," Naidu later tweeted along with pictures of the oath-taking in which Singh's wife Gursaran Kaur was also seen.

In the August 19 by-election, necessitated by the death of BJP MP Madan Lal Saini, the seat went to the Congress which is in power in Rajasthan after last year's state polls. Singh's

tenure in the Upper House had ended on June 14. He had earlier represented Assam in Rajya Sabha for around 28 years.

He was elected to the Rajya Sabha in 1991, 1995, 2001, 2007 and 2013. He was also the Leader of the Opposition in Rajya Sabha during 1998-2004 and Leader of the House as the Prime Minister during 2004-14.

# CBI mulls confronting Chidambaram with Indrani

The CBI is likely to confront all the six signatories on the Foreign Investment Promotion Board (FIPB) file relating to alleged irregular clearance of FDI to the tune of Rs 300 crore by INX Media with former Finance Minister P Chidambaram who is currently undergoing custodial interrogation by CBI in the case.

The agency is also mulling whether to take Chidambaram to Mumbai to confront him with approver in the case Indrani Mukherjea or bring her here for confrontation with the former Finance Minister.

In view of the high profile nature and vast experience of Chidambaram as a lawyer, the investigators are grilling him under direct supervision of agency director RK Shukla, sources said.

Chidambaram has so far been denying the allegations during the questioning and has largely been evasive to the queries put forth by the agency sleuths, they said, adding, he is a tough nut to crack.

Meanwhile, the CBI is waiting responses to Letters Rogatory (judicial requests)

## Officials posted at particular branch for longer period concerns CBI joint director

CBI Joint Director Ajay Bhatnagar has flagged concerns over agency officials being posted at a particular branch for longer period which is "severely" affecting the conduct and work culture as also discipline of the agency.

"All HOZs (Heads of

Zones) are requested to review the posting particulars of each individual individual posted in their Zone and send a list of officers rank wise ... who are to be considered for rotation due to long tenure," Bhatnagar said in a letter on August 21 to his colleague Anurag.

# WHO for research into microplastics, crackdown on plastic pollution

Levels of microplastics—tiny particles smaller than about one-fifth of an inch—in drinking water don't appear to be a health risk. However, more research is needed to assess how microplastics may impact human health and the environment, the World Health Organisation (WHO) has warned.

Following the release of an analysis of current research related to microplastics in drinking-water recently, the UN health agency has also called for a reduction in plastic pollution to benefit the environment and reduce human exposure.

"We urgently need to know more about the health impact of microplastics because they are everywhere - including in our drinking-water," said Dr Maria Neira, Director, Department of Public Health, Environment and Social Determinants of Health, at WHO.

"Based on the limited information we have, microplastics in drinking water don't appear to pose a health risk at current levels. But we need to find out more. We also need to stop the rise in plastic pollution worldwide."

"We are not alarmed," WHO technical officer Jennifer

de France said. "With the data that we have, we can say that we believe the risk to be low, but at the same time, we can't rule out conclusively that there might never be a risk in the future."

According to the analysis, which summarizes the latest knowledge on microplastics in drinking-water, microplastics larger than 150 micrometres are not likely to be absorbed in the human body and uptake of smaller particles is expected to be limited. Absorption and distribution of very small microplastic particles including in the nano size range may, however, be higher, although the data is extremely limited.

Further research is needed to obtain a more accurate assessment of exposure to microplastics and their potential impacts on human health. These include developing standard methods for measuring microplastic particles in water; more studies on the sources and occurrence of microplastics in fresh water; and the efficacy of different treatment processes.

The WHO has recommended drinking-water suppliers and regulators prioritize removing microbial pathogens and chemicals that are known risks to human health, such as those causing deadly diarrhoeal diseases.



# Tiger reserves face staff shortage

The number of tigers in the country has increased but the manpower manning them has not. As per the latest tiger census, the number of the predators in the country has risen by 33 per cent in last four years to 2,967, however, on an average the tiger reserves are reeling under shortage of staff with 30 per cent posts lying vacant.

A senior Government official from the Union Environment Ministry said that vacancies pertain to forest guards, forest rangers, forest section officers who are essential for wildlife conservation, grassland management and rigorous protection from poaching and illegal tree-fellers lying vacant.

According to the recent data available from the



National Tiger Conservation Authority (NTCA), number wise, there are just 11,500 staff protecting manning the 2,967 big cats in the 50 tiger reserves across the country.

The tiger reserves are just

not the home of big cats but also the habitat of rich biodiversity and a considerable wildlife population, including big predators like leopards and faunas such as swamp deer, neel gai, hispid hare and stag,

to name a few, which needs conservation and protection from wildlife smugglers, the official pointed out.

Tiger reserves such as Sundarbans in West Bengal, Anamalai in Tamil Nadu,

Pakke in East Kameng district of Arunachal Pradesh in north-eastern India, and Kawal tiger reserves in Telangana have reported acute shortage of staff with half of the total sanctioned posts lying vacant.

Valmiki tiger reserve in Bihar which has 31 tigers and ten cubs is grappling with acute shortage of vacancy with 86 per cent posts yet to be filled, speaking volumes of existing gaps in the management.

Sources said that most of the employees at VTR are daily wagers and not permanent employees. They also lack the required skill and interest. In fact, the contractual staff are being deployed at most of the tiger reserves.

Vivek Menon, CEO of Wildlife Trust of India (WTI) said: "Forest guards are the backbone of India's wildlife and habitat protection system.

They are the guardians of its natural heritage and at the frontline of the fight against poachers and timber smugglers who are sometimes far better armed and equipped.

It is thus important that this force remains trained and highly motivated to tackle diverse threats it is being faced with. From time to time we have been conducting workshops with the State Governments to strengthen staff morale and sharpen their skills."

Interestingly, between 2012 and 2018, 657 tiger deaths were reported in India, most of them (48% or 313) due to natural causes and 21% or 138 due to poaching, NTCA data says. Of the 138 poaching deaths, Madhya Pradesh reported the most (22% or 30), followed by Karnataka (24) and Maharashtra (18).

# SECR collects ₹12 lakh as fine during ticket checking drive

In a separate operation, the cadre identified as Nanda Kunjam (25), a Maoists' Local Organisation Squad (LOS) member, was arrested by a team of local police from the forest near Potali village, he said.

Kunjam was carrying a reward of ₹1 lakh on his head, he added.

The new elector should attain 18 years of age on January 1, 2019 for enrolment. The primary publication of electoral roll will be done on September 6, after which electors can check their names in electoral roll.

# FATF Asia-Pacific Group puts Pak in terror list

The Asia Pacific Group of the FATF, a global watchdog for terror financing and money laundering, has put Pakistan in a terror 'blacklist' for its failure to curb funneling of funds to groups responsible for scores of attacks in India, officials here said on Friday.

While putting Pakistan in an 'Enhanced Expedited Follow Up List', the Financial Action Task Force's Asia Pacific Group also found that the country was non-compliant on 32 of 40 compliance parameters related to terror financing and money laundering, they said.

The FATF APG meeting was held in Canberra, Australia, and the discussions, which ended Friday, lasted more than seven hours over two days.

India is a member of both the APG and the FATF consultations and was represented by a team of officials from the ministries of Home, External Affairs and Finance.

Pakistan's multi-ministerial team at the APG meeting was led by the Governor of the State Bank of Pakistan.

"The APG has placed Pakistan in the Enhanced Expedited Follow Up List (Blacklist) for failure to meet its standards," an Indian official privy to developments said. He added that it had failed to stop funding to groups like the Lashkar-e-Taiba and the Jaish-e-Mohammed.

Actions demanding a review of Pakistan's compliance

record were pushed by the US, the UK, Germany and France.

Despite its efforts, Pakistan could not convince the 41-member APG plenary to upgrade it on any parameter, he said.

On 11 "effectiveness parameters" of terror financing and money laundering, Pakistan was adjudged low on 10.

Pakistan now has to focus on avoiding the FATF blacklist in October, when the 15-month timeline on the FATF's 27-point action plan ends, another official explained.

Pakistan has been under the FATF radar for its complicity towards terror groups LeT, JeM and others, he said.

It is almost certain that Pakistan will continue in its present status in the FATF 'Grey List' and there is every possibility that the country may further be downgraded into the FATF 'Black List' at its next plenary to be held in October in Paris, officials said.

Pakistan's continuance in the 'Grey List' means its downgrading by the IMF, the World Bank, the ADB, the EU and also a reduction in risk rating by Moody's, S&P and Fitch.

This will add to the financial problems of Pakistan, which is seeking aid from all possible international avenues.

During the FATF meeting, several countries voiced concern on the country's failure to do enough to contain terror funding on its soil.

According to officials, a key point made by these coun-

tries is the absence of a proper understanding in Pakistan of "transnational risk" — risk posed to neighbouring and other nations by designated terrorist organisations based in Pakistan.

In June 2018, Pakistan was placed in the 'Grey List' and given a 27-point action plan by FATF. This plan was reviewed at the last plenary in October 2018 and again in February, when it was again put into the 'Grey List' after India submitted new information about Pakistan-based terrorist groups.

In a bid to bluff the financial watchdog, Pakistani authorities have shown arrests of LeT, JeM, Jamat-ud-Dawah (JuD), Falah-e-Insaniyat Foundation (FIF) and Falah-e-Insaniyat Foundation (FIF) cadres, officials said.

However, most were apprehended under its Maintenance of Public Order (MPO) Act and very few under the Anti-Terrorism Act, 1997.

Under the MPO Act, authorities cannot hold a detainee beyond 60 days. Pakistan has detained JeM founder Masood Azhar and LeT founder Hafiz Saeed mostly under laws that provide for detention for apprehension of breach of peace.

Pakistan recently submitted a 450-page compliance document that details all the changes the government has made to existing laws, and actions against terror groups in the past year and a half.

# Opp leaders to visit J&K today, Rahul likely to join

A delegation of opposition leaders will visit Srinagar on Saturday to meet people and assess situation in the Kashmir Valley where restrictions are in place after the Centre withdrew special status to Jammu and Kashmir.

According to sources, some of the parties that will be part of the Opposition all-party delegation are Congress, CPI-M, CPI, RJD, NCP, TMC and DMK.

The sources said top Congress leaders who will visit Srinagar are Ghulam Nabi Azad and Anand Sharma. Rahul Gandhi is likely to accompany them. CPI-M's Sitaram Yechury, CPI's D Raja, DMK's Tiruchi Siva, RJD's Manoj Jha and Dinesh Trivedi from TMC will also be part of the delegation that will leave for Srinagar around noon from Delhi airport.

"Senior Trinamool Congress leader Dinesh Trivedi @DinTri to visit Srinagar on Saturday along with other Opposition leaders. They will see the situa-

tion in the valley after abrogation of Article 370," the TMC tweeted.

Senior Congress leaders were huddled in a meeting on Friday evening to discuss the issue within the party.

The sources said the leaders also intend to visit some other parts of the state, if allowed to enter.

So far, the Government has not allowed any political leader to enter the state ever since provisions of Article 370 were abrogated by the Centre.

Leaders of regional parties, including former chief ministers Farooq Abdullah, Omar Abdullah and Mehbooba Mufti, have been put under house arrest. Congress MP Azad was not allowed to enter the state and was stopped twice, both at Srinagar and Jammu.

Earlier, Raja was also stopped at Srinagar airport and sent back. Rahul had recently asked Governor Satya Pal Malik when he could come to the state and meet people without any conditions.

The Delhi Development Authority (DDA) had demolished the temple in Delhi's Tughlaqabad area on August 10 on the orders of the Supreme Court.

Responding to the issue raised in state Assembly by the leader of Opposition Mukesh Agnihotri, Thakur said, "The issue is very sensitive as it concerns religious sentiments of a section of the society. We will do whatever we can in this regard."

Earlier Agnihotri said the state government should write to the Centre to provide land for reconstruction of the temple.

AVAILABLE TO CONTROL FOREST FIRE

Himachal Pradesh Forest Department has no government vehicle to control forest fire, Forest Minister Govind Singh Thakur told the state assembly on Friday.

The minister gave this information in reply to a question by BJP MLA Jawahar Thakur and Congress MLA Ram Lal Thakur. "No government vehicle is available to control forest fires, tree felling or mining in any of the 198 forest ranges of the state," said the minister.

As per a remote sensing study conducted by the Forest Survey of India, Himachal's forest cover has increased by 2.67 percent (393 square kilometre) in two years from 2015 to 2017, he added.

The Forest Survey of India does forest mapping through remote sensing system in the country in every two years, he added.

There are 37 forests and six wildlife divisions in the state, he added. Further a total of 198 forest ranges exist in the state and 39 of them are sensitive forests ranges, he added.

"What he (Trump) has indicated that he is ready to assist if both sides are interested in helping to reduce their tension. But we just know that India has not requested any formal mediation," the official said, requesting anonymity.

The official said that President Trump, during his meeting with Modi in France will likely want to hear how he

intends to calm regional tensions in the aftermath of his decisions on Kashmir.

"The president will likely want to hear from Prime Minister Modi on how he plans to reduce regional tensions and uphold respect for human rights in Kashmir, as part of India's role as the world's largest democracy," he said.

Trump on Tuesday said that he was willing to either mediate or do something to resolve the Kashmir issue between India and Pakistan.

But New Delhi has made it clear to the US that Kashmir is a bilateral issue between India and Pakistan and there was no role for a third party. According to the official, in light of this significant move by Modi on Kashmir, the president is likely to stress the need for dialogue among all sides of the conflict and he hopes that India will lift communication and movement restrictions in Kashmir and exercise utmost restraint in dealing with potential protests.

Trump has said that he is

friends with both the leaders of India and Pakistan and "stands ready to assist if they both would like him to do so", the official said.

"Certainly, president Trump is also calling on Pakistan to prevent infiltration of militants across the Line of Control and to crack-down on groups on its territory that have attacked India in the past," said the official.

Trump, the official said, is very much looking forward to his meetings with Prime

Minister Modi where they will discuss the strategic partnership and how they can cooperate more closely on issues like defence cooperation, counterterrorism and trade.

"We expect the two leaders to build on a very productive discussion they had in Osaka at the G-20 as well as the phone call that they held earlier this week. They will look for solutions on the trade front. The US is looking to India to reduce tariffs and open its market," said the official.

The SC Bench said it would also hear a fresh plea filed by Chidambaram, challenging Thursday's order of remand passed by trial court by which he was sent to the CBI custody till August 26.

"In our view, having regard to the fact that the petitioner was also granted interim protection on July 25 and that the co-accused were also granted bail by the High Court, the petitioner is granted interim protection, insofar as the Enforcement Directorate case is con-

cerned...Till the next date of hearing. List the matter on August 26," the Bench said.

The court also sought reply of the ED on Chidambaram's plea by Monday itself.

As soon as the order was dictated, Solicitor General Tushar Mehta, appearing for ED, tried to hand over some documents in sealed cover to the court saying that the Bench should satisfy its conscience before passing an order granting protection from arrest to Chidambaram.

The move was objected by senior advocate Kapil Sibal, appearing for Chidambaram, who said the same thing was done by the ED before the High Court and a note was submitted after the arguments were over.

The Bench refused to peruse the documents at this stage and asked Mehta to submit them on

Monday, saying these are confidential and cannot be kept like this with the court.

The hearing led to several rounds of heated exchanges between Mehta and senior advocates and Chidambaram's party colleagues Kapil Sibal and AM Singhvi. Mehta vehemently opposed the order granting protection from arrest to Chidambaram in the money laundering case and said that the probe agency "has collected innumerable evidence to show that the money has been transferred from one company to another shell company."

Mehta said Chidambaram amassed 11 properties outside the country and has 17 bank accounts, not only in India but also abroad, and the money was transferred through a web of shell companies.

Mehta said that lot of "hue and cry" and "political vendetta" is alleged by petitioner (Chidambaram) and his party colleagues but "I am saying with a great sense of responsibility that this is a case of money laundering of a monumental magnitude."

He further asserted that custodial interrogation of Chidambaram was needed to unravel the truth. While being Union Finance Minister, Chidambaram had asked Indrani and Peter Mukherjee to "take care of his son" when she had met with him in 2007 regarding FIPB approval for their company INX Media, Mehta said.

The SG said they need to confront Chidambaram with the evidences collected so far, including some e-mail and money transaction, as several persons who have created the shell companies have executed a will in the name of Chidambaram's granddaughter.

Mehta said Chidambaram has been evasive in his replies, refused to divulge anything and has not cooperated in the ED probe. "Custodial interrogation of the accused is necessary to unravel the truth which cannot be done under the protective umbrella of anticipatory bail," Mehta said, adding, the court should go through the case diary and satisfy its conscience before granting any relief to the former Minister.

In his arguments, Sibal said that it is violation of his fundamental right under Article 21 of the Constitution that his petition challenging the High Court order was not heard by the apex court on July 20 and 21 and he was arrested on Wednesday night. "My rights under Article 21 cannot be frustrated", Sibal said, while rejecting the anticipatory bail plea, the Delhi High Court had taken on record a note submitted by the ED, which was not even argued, Sibal said.

"Word by word, comma for comma and full stop for full stop, even adjectives were copied as it was in the note and para-wise noting was done," Sibal said, adding, if the courts are going to copy-paste from a note of probe

agencies then how will common people protect themselves.

Singhvi said that in the anticipatory bail rejection order of the ED case, the High Court should not have made observations with regard to Aircel-Maxis cases. The apex court was hearing two separate petitions filed by Chidambaram challenging the Delhi High Court August 20 verdict by which his anticipatory bail was dismissed in the cases registered by both the CBI and ED.

To this the bench asked, suppose if a religious practice is declared as null and void and it is declared as an offence like dowry and child marriage, but if it still goes on then what is the remedy. Responding to the query, Khurshid said several aspects have to be examined and in the triple talaq matter the Constitution bench had already said the practice is void.

He said it has to be examined whether the religious practice denies the rights to the woman. The bench, while agreeing to examine the validity of the 2019 Act, observed that petitioners have also raised the issue of punishment of up to three years and grant of bail to the husband only after the woman is heard by the court.

A total of four petitions have been filed in apex court challenging the validity of the law.

Two Muslim organisations Jamiat Ulama-I-Hind and Samatha Kerala Jamiathul Ulama, a religious organisation of Sunni Muslim scholars and clerics in Kerala, have moved the Supreme Court this month challenging the law's validity. Jamiat Ulama-I-Hind approached the apex court on Thursday.

Ram Nath Kovind has given assent to the Act which makes 'talaq-e-biddat' or any other similar form of talaq having the effect of instantaneous and irrevocable divorce pronounced by a Muslim husband void and illegal. In the plea filed through advocate Ejaz Maqbool, Jamiat Ulama-I-Hind has claimed that since the pronouncement of talaq by a Muslim husband upon his wife had already been declared "void and illegal", there was no requirement to enact the law.

At a book launch on Wednesday, former Union Minister Ramesh had said Modi's governance model was "not a complete negative story" and added that not recognising his work and demonising him all the time was not going to help.

"Some self-propagating leaders in the party, who never fight elections and find a sanctuary in the Rajya Sabha, have hijacked the party," he said.

Modi's comments on corruption assume significance as they come two days after the high-profile arrest of senior Congress leader and former Union finance minister P Chidambaram by the CBI in a money laundering case, evoking a strong reaction from opposi-

tion parties which accused the Centre of misusing probe agencies for "political vendetta".

Hailing the move of doing away with the practice of triple talaq, he said how could a 'new India' accept such injustice to Muslim women.

"Inspired by the mantra of clear policy and right direction, one after another several major decisions have been taken by the government," he said.

Modi also asserted that India has embarked upon a journey of hope and aspirations, and with the collective efforts of 130 crore people, the country is moving ahead at a fast pace on the path of development.

"This is the reason that people have again given us a resounding mandate. This mandate is not just to run the government, but it is for building a new India. A new India of whose enriched culture, the world is proud of. A new India with a focus on ease of doing business and also ensures ease of living," Modi said.

"The 100-day milestone is yet to arrive. Mind you, the first 50-75 days are generally taken to plan things and get greetings and congratulatory calls, but we

did not get into that," Modi asserted.

Modi also said India will achieve most of the COP 21 climate change goals set for 2030, in the next year and a half.

India will be free of tuberculosis in 2025, five years ahead of the global target of 2030, he said.

Ahead of his address, the Prime Minister through a video conferencing inaugurated a memorial in honour of the victims of two Air India crashes in France in the 1950s and 1960s.

In his speech, he also listed a slew of measures taken by his government for development and empowerment of the people such as opening of bank accounts and the running of the "world's biggest health insurance scheme".

"In the last five years, we have red carved a number of bad practices from the country," he said while using a football analogy.

Modi also talked about his government's achievements such as forming of the 'jal shakti' ministry, pension for poor farmers and traders and doing away of the "inhuman practice" of triple talaq.

# BJP's popularity growing in T, membership 30 lakh now, says State party chief

BJP's membership has risen to 30 lakh in Telangana on the back of its "growing popularity" and it would form government after the next assembly elections in 2023, state party president K Laxman claimed on Friday.

Impressed by the Narendra Modi governments "good governance" and welfare measures, people were seeking a similar rule in Telangana and BJP would undoubtedly form the government, he said.

Flying TRS working president K T Rama Rao's reported remarks questioning BJP's figures of its membership, Laxman said the ruling party leader was "unable to tolerate the growing popularity" of the national party in the state.

"...BJP membership is not 12 lakh. It was already 18 lakh. Additionally, 12 lakh (enrolled in the latest drive). That means,

30 lakh membership. Our target is six lakh more... Our members are 30 lakh today, he told reporters.

Wondering whether Rao had any knowledge about BJP, he said it was the "single largest" political party in the world with a primary membership of 11 crore which would go up further after the just ended nation-wide enrolment drive.

Meanwhile, Laxman's allegations on Thursday of corruption in power purchases were countered by the officials of power utilities.

Transmission Corporation of Telangana (Transco) CMD D Prabhakar Rao asserted that they were open for any inquiry, either by CBI or a sitting judge, into PPA (Power Purchase Agreement) or any other matter.

Reacting to it, Laxman said officials perform their role and government leaders should speak on the matter.

# US officials confirm Israeli strike in Iraq

Attack marks significant escalation in Israel's campaign against Iranian military entrenchment in Iraq

AP ■ JERUSALEM

US officials have confirmed that Israel was responsible for the bombing of an Iranian weapons depot in Iraq last month, an attack that would mark a significant escalation in Israel's years-long campaign against Iranian military entrenchment across the region.



The confirmation comes as Israeli Prime Minister Benjamin Netanyahu is strongly hinting that his country is behind recent airstrikes that have hit bases and munitions depot belonging to Iran-backed paramilitary forces operating in Iraq.

The mystery attacks have not been claimed by any side and have left Israeli officials scrambling for a response, amid strong speculation that Israel may have been behind them.

Earlier this week, the deputy head of the Iraqi Shiite militias, known collectively as the Popular Mobilisation Forces, openly accused Israeli

drone to the Iranian-backed Lebanese Hezbollah group. He said the attack targeted the headquarters of the advisers and a weapons depot.

On August 12, a massive explosion at the al-Saqr military base near Baghdad shook the capital, killing one civilian and wounding 28 others. The base housed a weapons depot for the Iraqi federal police and the P.M.F.

The most recent of the explosions came Tuesday night, at a munitions depot north of Baghdad.

There have been weeks of speculation in Israel that the army is attacking targets in Iraq.

In an interview with a Russian-language TV station on Thursday, Netanyahu indicated the speculation is true.

"I don't give Iran immunity anywhere," he said, accusing the Iranians of trying to establish bases "against us everywhere," including Syria, Lebanon, Yemen and Iraq.

Asked whether that means Israel is operating in Iraq,

Netanyahu said: "We act in many arenas against a country that desires to annihilate us. Of course I gave the security forces a free hand and the instruction to do what is needed to thwart these plans of Iran."

Early Friday, *the New York Times*, citing Israeli and U.S. Officials, reported that Israel bombed an Iranian weapons depot in Iraq last month.

## Homemade bomb kills Israeli, wounds two others in West Bank

AFP ■ JERUSALEM

A blast from a homemade bomb killed one Israeli and seriously wounded two of her family members in an attack near a Jewish settlement in the occupied West Bank on Friday, officials said. Israeli security forces were deployed throughout the area of the attack near the settlement of Dolev, northwest of Ramallah, in a search for suspects.

# Sri Lanka ends state of emergency

PTI ■ COLOMBO

Sri Lanka has ended the four-month-long state of emergency imposed in the country following the Easter Sunday attacks that claimed 258 lives.

Officials sources said a government gazette which should have been issued on Thursday to extend the state of emergency by a further month was not issued.

"The president did not issue the gazette to extend emergency," they said.

President Maithripala Sirisena has been extending the emergency through a gazette notification every month since the bombings on April 21.

Sri Lanka initially imposed the emergency on April 23 to crack down on the nine suicide bombers who attacked three churches and as many luxury hotels, killing 258 people and injuring 500 others.

The ISIS terror group claimed the attacks, but the government blamed the local Islamist extremist group

The state of emergency gives sweeping powers to the security forces to arrest and detain people in the aftermath of the attack.

The tourism industry has been lobbying extensively to lift the state of emergency as it saw a surge in tourist cancellations.

The government initiated several high level probes to investigate the security lapses which led to the attacks despite prior intelligence warnings.

The worst affected area is White Nile state in the south but Khartoum and other regions have also been affected. "More than 37,000 homes have been destroyed or damaged," the UN said, quoting figures from the Government body it partners with in the crisis response.

## 22 MISSING AFTER INDONESIA FERRY FIRE

Jakarta: Nearly two dozen people are missing from the carcass of a ferry that went up in flames off Indonesia's Java island, a port official said on Friday. The boat was en route from Indonesia's second-biggest city Surabaya to Balikpapan on Borneo island with some 277 people aboard when it caught fire Thursday evening, according to the official.

## 17 DIE IN ROAD CRASH IN CENTRAL NIGERIA

Lagos: Seventeen people were killed when a passenger bus collided with an oncoming truck in central Nigeria, a road safety official said on Friday. The accident involving an 18-passenger Toyota bus and a truck transporting a container happened in Kwara state on Thursday.

# Amazon wildfires 'acute emergency', belongs on G7 agenda: Germany

AFP ■ BERLIN

The fires raging in the Amazon rainforest amount to an "acute emergency" and Chancellor Angela Merkel believes it should be discussed by world leaders when they meet for this weekend's G7 summit, her spokesman said on Friday.

"The extent of the fires in the Amazon area is shocking and threatening and not only for Brazil and the other affected countries, but also for the whole world," Steffen Seibert told journalists in Berlin.

"When the G7 comes together this weekend, then the chancellor is convinced

that this acute emergency of the Amazon rainforest belongs on the agenda," added Seibert, saying that Merkel backs French President Emmanuel Macron's call on the G7 to address the issue at the summit in Biarritz.

Macron's bid at rallying world leaders on the issue had been immediately blasted by Brazilian President Jair Bolsonaro, who accused the G7 summit host of having a "colonialist mentality".

Bolsonaro is facing growing criticism over his anti-environment rhetoric, which activists blame for emboldening loggers, miners and farmers in the Amazon.

# Putin vows 'symmetric response' to US missile test

Russian President Vladimir Putin said on Friday he has ordered the military to prepare a "symmetric response" after Washington tested a formerly banned missile.

Putin said he had ordered an analysis of "the level of threat for our country created by the actions of the US and to take comprehensive measures to prepare a symmetric response".

The US Department of Defense said Monday it had tested a type of ground-launched missile that was banned under the 1987 INF agreement, which limited the use of nuclear and conventional

# Japan leader says S Korea ending intel deal damages trust

Tokyo: Japanese Prime Minister Shinzo Abe said South Korea's decision to cancel a deal to share military intelligence, mainly on North Korea, is damaging mutual trust and vowed Friday to work closely with the US for regional peace.

Abe also accused South Korea of not keeping past promises. The intelligence agreement started in 2016.

"We will continue to closely coordinate with the US to ensure regional peace and prosperity, as well as Japan's security," he said ahead of his departure for the Group of Seven summit.

South Korea announced Thursday it would terminate the intelligence deal because Tokyo's decision to downgrade South Korea's preferential trade status had caused a "grave" change in the security cooperation between the countries. AP

# Yemeni Govt forces rout separatists from southern city

Forces loyal to Yemen's internationally recognised Government have taken full control of a key southern city after overnight clashes with separatists there, Yemeni security officials said on Friday.

Clashes over Ataq, the capital of oil-rich Shabwa province erupted late Thursday night and lasted until Friday morning, said the security officials, speaking on condition of anonymity because there were not authorised to talk to the media.

The city of Ataq was previously divided between the government forces of Saudi-backed President Abed Rabbo Mansour Hadi and a separatist militia, trained and armed by the United Arab Emirates.



# The new Dalit identity

Protests over Sant Ravidas's shrine show that SC/STs are becoming equally aggressive about identity politics



The political import of the thousands of Dalits marching in Delhi to save the shrine of their saint Ravidas is not just about claiming rights and space in a Brahminical order or the appropriation of land as evidenced by the parks of their supreme leader Mayawati. It is about equality and comparative weighing of scales, another form of minority assertion in the face of brute majoritarianism, a question mark on different approaches to the similarity of contexts, and another manifestation of identity politics. Besides, Sant Ravidas embodies a socio-cultural idea of India that undercuts the monolithic imposition of today. Born in the 15th century in Varanasi to leather makers, he denounced the Hindu Brahminical order, challenged deity worship and worked for an egalitarian society against a Hindu Rashtra, becoming the one voice of the marginalised. And such was the power of his messages that many of his disciples even found mention in the Guru Granth Sahib of the Sikhs. None can miss the impactful swathe of this man from Varanasi, unmistakably a prime political constituency today. Nor can the appropriation of the "mandir wahin banayenge" slogan be missed as an equal claimant as the Ram temple in Ayodhya. For starters, both have historicity of belief. Lord Rama was believed to be born in Ayodhya, Guru Ravidas was believed to have visited the Chamarwala Johar in Tughlaqabad 500 years ago. Like Ayodhya, this memorial site is disputed with facts of 1950 differing from facts of 1963, the latter being accepted by the court as encroachment and, therefore, a ground for demolition. Like Ayodhya, status quo has been continuing for years with no party, and even the Delhi Development Authority (DDA), carrying out any demolition on the ground. Like Ayodhya, protesters do not want the memorial shifted as a reconciliatory move and want it on hallowed ground, asking whether Ram temple activists would agree to a commensurate shift in venue? Besides, Dalit activists argue, the construction of Tughlaqabad Ravidas temple is not on the road or creating any obstruction to the general masses. In fact, it can even be part of the Centre's forest project and, without any other pressing logic, seems just another harassment play by the mainstream Right. The latest demolition follows two others by the DDA, one of Buddha Vihar at Devi Hill, and the other at Bhagwan Valmiki Mandir in Seemapuri. Which is why the Tughlaqabad incident has snowballed as a politico-cultural movement, linking both Ravidas and Babasaheb Ambedkar.

The latest round of protests also reflects the growing counter-muscularity in the Dalit leadership, being led from the front by Bhim Army chief Chandrashekhar Azad. His agitationist politics is finding resonance given the waning political influence of Bahujan Samaj Party (BSP) chief Mayawati, who, while arguing for the restoration of the temple, disagreed with the violence associated with it as diluting the key plank. Of course, Behenji still believes Azad to be a foisted creation of the BJP's ideological parent, the RSS, and there are still a lot of theories as to whether Guru Ravidas followers are being coopted into the Hindutva sub-culture. But considering Azad's traction among the youth across north India and a combined Dalit iconisation of all leaders, it is a constituency strong enough to negotiate with anybody, not only, as alleged by Mayawati many times, the BJP. Azad may have been deployed as a vote-cutter initially but now has a solid consolidation of Dalit youth, who are countering majoritarian celebrations by scaling up celebrations of Guru Ravidas, Valmiki, Dr Ambedkar, a signal that they do not want to be subsumed or Sankritised in their thinking. Now that the Bhim Army has started working nationwide, Dalit youth are being motivated to assert and not deny their ancestry. This is important given that the young Dalit vote could be a change-maker in the forthcoming Assembly elections. Only this week, Azad launched the Bhim Army Students Federation (BASF) and said he wanted students of Scheduled Castes (SC), Scheduled Tribes (ST), Other Backward Classes (OBC) and religious minorities to be aware of both their rights and duties. Clearly, he is creating a new swell in the existing discourse.

# Fire in the jungle

As a nation that will suffer the impact of global warming and climate change, India, too, must raise concerns



Smoke from the fires raging across the Amazon rainforest has blanketed several Brazilian cities, including Sao Paulo, in a choking haze — a sight familiar to residents of several north Indian cities. Thankfully, because Brazil is half a world away, the chances of the clouds of smoke, from what some are claiming to be the largest wildfire in recorded history, reaching Indian skies is remote. But that does not mean that India will not suffer the impact of these horrendous fires which have been allowed to continue for days, possibly due to acts of omission by the Brazilian Government, elements of whom want to open up the rainforest land to agriculture and pasture.

The Amazon Rainforest is called the "lung of the world" and while this is technically not true — biologists have learned that planktons, marine and freshwater organisms are the biggest oxygen generators — it does soak up large amounts of carbon. More importantly, it is home to the greatest diversity of plant, animal and fish life on the planet. Within those organisms might lie the cure for all sorts of diseases or amazing new materials unknown to mankind. These organisms will be wiped clean off the face of the planet without even being discovered. This should be a matter of global concern and Governments across the world should speak up about the tremendous destruction of nature. It is heartening to see that French President Emmanuel Macron has stood up and spoken about the wildfires and how they must be tackled. It would be good if Narendra Modi does the same. While political and economic decisions are the prerogative of national Governments, the state of the environment is a global issue since damage to it impacts all of mankind. At a time when Governments, from Brazil to India and the US, have all moved into a kind of hyper-nationalistic realm and bristle at any "intervention", the realisation has to come that the world must collaborate on these things — from the Amazon wildfires to the disappearing Himalayan glaciers and the tonnes of plastic in the sea — because when the catastrophe comes, it will be devastating for our species. And unless we figure out a way to reach interstellar space and propagate our species to other worlds, we run the risk of going extinct. The time for action is now because climate change is real.

# For the sake of democracy

Decades after the Indian republic was founded, citizens today are worried about the increasing erosion of credibility of elected representatives who continue enjoying legislative privileges

In a democracy, citizens enjoy the privilege of casting their vote to elect representatives. In India, we elect leaders right from the panchayat level to the Parliament. The right to vote is prized and all of us are taught about it in our schools and universities. We are also reminded about this by politicians of all hues before every election. It is also a well-established fact that the Indian voter is far more mature now and knows about the "power" of his/her vote. This was proved beyond any doubt to one and all — nationally and internationally — in 1977 when the citizens unseated Indira Gandhi from her traditional family fiefdom in Uttar Pradesh and simultaneously threw her out of power at the national level by decimating her political party. A very interesting interlude followed her defeat. People had high hopes from the next Government as it was supposed to work under the astute guidance of Jayaprakash Narayan. Those, who inherited power, could not manage the Government. They were assessed unfit by the people and Indira Gandhi was brought back to power within three years. People not only pardoned her but also taught a lesson to those who could not rise above petty personal feuds as they had not "learned to live and work together." All this, experts say, is the essence of democracy.

Democracy shines when a humble person, setting aside all his/her woes, concerns and stress of providing the next meal, enters the polling booth and puts his/her finger on the EVM button. Who can read or visualise what clouds their minds in the shape of a better tomorrow for him/her, the family and for the little world that deserves outside support on many counts. The voter is still far from the promises made in the Constitution of India. One more election opportunity and expectations soar again. The Indian voter has also witnessed how elected representatives have often let them down on several counts. Most of them vanish for five years, take more interest in their own welfare than that of the electorate, show little concern and connectivity to their electors, give no dignity to them and after five years, return with folded hands, pleading for "one more chance." But if one weighs the performance of elected representatives on Gandhian expectations, one would mostly be disappointed.

Winston Churchill never expected that India could manage its independence. He was convinced that Indians were unfit to govern themselves and, hence, the British had to stay on to look after them. It was not easy for him or those of his ilk to see beyond the cobwebs of the much-publicised altruistic perception that the British essentially travelled to India to "salvage the souls of the savages." One could claim with a sense of pride and achievement that whether Churchill liked it or not, India has established its credentials in "how to make its democracy operational in its minutest nuances." We could do it as it was not new to democratic practices of governance.

The Ganrajyas of Licchavi and Vaishali are well-known historical instances. Even at that time, education for preparing young ones



with a focus on "lot learn to live together" began in joint families that accommodated four generations under one roof. It was also a ground to teaching them to respect different viewpoints and accommodate the likes and dislikes of everyone. Respect for diversity and the realisation how essential it was, were inherent in the Indian tradition. Indian culture prepares its children for a duty-bound society that respects relationships within the family and beyond.

It will be worthwhile to remember what Churchill said: "Democracy is the worst form of Government, except for all others", which invites learned and informed deliberations even now. He viewed democratic politics not only as an "insurance" for future, against external dangers, but also against threats "scarcely less grave and much more near and constant" that threaten us all. India, like every other functional and dynamic democracy, must remain conscious of the dangers to its democracy that are emerging within the system from the very functionaries that are entrusted with the task of sustaining and strengthening democratic values.

We are all aware how traditional democratic values have confronted difficult situations in the era of globalisation and commercialisation. They stand overshadowed by emerging materialist values. On several occasions, elected representa-

tives, including those holding positions of greater political power, find it difficult to maintain the right balance between Indian perception of democratic public life and the lure of power and pelf — glamour and glitz in a globalised free-market world.

The chinks emerging in the Indian democracy are not unexpected. Mahatma Gandhi could envision in April 24, 1922, that "As we become independent, all the defects of the system of elections, injustice, the tyranny of the richer classes as also the burden of running administration, are bound to come upon us. People would begin to feel that during those days, there was more justice, better administration and peace and there was honesty to a great extent among the administrators compared to the days after Independence."

When I came across this part of Gandhian writing some four decades ago, my simplistic query to eminent Gandhian personalities was: How could Gandhiji cultivate such serious apprehensions about elections when we had no such experience in India? They were kind enough to enlighten me that Gandhiji had studied the British election system in-depth and could visualise what impact the taste of power produces on the majority of elected representatives.

Having elected 17 Parliaments and innumerable State Assemblies, district and panchayat level bodies, the Indian

treasure, *State of the Nation: Democracy Governance and Parliament*. Members of the Constituent Assembly were mostly freedom fighters and men and women known throughout the length and breadth of the country for the sacrifices they made. They worked tirelessly to give India its Constitution. They gave themselves a sitting allowance of ₹40 per day. Contrast this with their successors. The salaries and allowances of Members of Parliament Act, 1954, fixed a salary of ₹400 per month for an MP and a daily allowance of ₹21.

After this, there have been 29 upward revisions to the Act. There were members, whose conscience was pricked but their viewpoint was overlooked by the majority. Nanaji Deshmukh was one such exception. He raised this issue in 2004 and pointed out that "salaries and allowances of members had gone up 90 times during the first 50 years". But his words made no impact. These upward revisions invariably got a full-throated fast-track approval from the MPs. Kashyap describes the position in its totality: "At a time when the salary of a member was only ₹12,000 per month, Nanaji had estimated that the direct monthly expenditure on an MP was at least ₹3 lakh per month. Himself an MP, he knew first hand. On that basis, the present monthly cost of an MP must work out close to ₹10 or 15 lakh per month or more, which could be few hundred times the per capita income of an Indian."

Whenever issues related to MPs or State legislatures come up during discussions, I am invariably reminded of the Gandhian vision that defects of elections would weigh heavily on our people. The resilience of electors in democracy may have its upper limits. It is public knowledge that each candidate is supposed to submit a detailed statement of the expenditure incurred during election campaigns. They also know that it should always be within the limits prescribed by the Election Commission of India.

Every Indian voter would be willing to say "every one spends much more than what they claim to have spent", exceptions apart. Is this situation acceptable? May be, someday, some young elected representative will launch a campaign against this routine practice and be hailed as a "hero" striving to restore democratic values. This could be done by some young person, who remains honest, humble and humane as the representative of people.

The sequence of events leading up to Congress leader P Chidambaram's arrest by the Central Bureau of Investigation (CBI) and his incarceration in the investigative agency's headquarters had all the ingredients of a riveting drama. The sight of officials from the CBI and the Enforcement Directorate (ED) scaling the boundary wall to gain entry into Chidambaram's house, displaying alacrity and eagerness to please their political masters, was worthy of a movie scene.

It won't be an exaggeration to say that political vendetta is writ large on the exertions made to frame and fix Chidambaram, humiliate and hound him out of the political realm. What stands exposed is that the law does not take its own course but one that the Government of the day wishes. ## RSS roots for reservation

More inclusive than most, the RSS has always been supportive of reservation and there has been no incoherence in its thinking on the issue

The RSS has always been supportive of reservation and there has been no incoherence in its thinking on the issue. There's always an anxious attempt by a section of the media and the intelligentsia to manipulate the outlook of the Rashtriya Swayamsevak Sangh (RSS) on reservation. In my long-standing association with its political wing, the Bharatiya Janata Party (BJP), I have witnessed no incoherence in the thinking of the RSS on reservation policies. On the contrary, time and again, there have been assertions in favor of policies that give preferential treatment to marginalised sections in state-sponsored education and government jobs, among other things. In one of his Independence Day speeches from the ramparts of the Red Fort, former Prime Minister Atal Bihari Vajpayee said that the quota system is a form of historical compensation and shall continue until its purpose is served.

The RSS and its affiliated organisations have consistently worked for inclusion through representation of marginalised sections at meaningful places. Be it university policy-making or national politics, the RSS has established a semblance of social diversity at top positions through the Akhil Bharatiya Vidyarthi Parishad (ABVP), the BJP and a plethora of other organisations. It must be noted that both have the rare distinction of being the world's largest organisations.

While, the ABVP remains one of the oldest student-led organisations and largest in terms of membership and footprint, globally, the BJP with more than 11 crore members that are increasing daily, will remain the world's largest political party for the foreseeable future. It is impossible to achieve this feat right from universities to the Parliament with a myopic social vision. Hence, there is a robust modus operandi at an institutional level that ensures equitable representation of diverse social groups.

Vanvasi Kalyan Ashram, another affiliate organisation of the RSS has made deep inroads in tribal areas and has successfully created sustainable educational opportunities for tribal children. This is a silent revolution being heralded not in Delhi's posh Khan Market area but right from the jungles of Gumla and Simdega in Jharkhand to Malkangiri in Odisha.

There's much brouhaha over the appointment of D Raja as the General Secretary of the Communist Party of India (CPI). The commentariat is determined to present this as a watershed moment in the history of Dalit representation in national politics. It might be a remarkable event in the history of the leadership of the CPI as majority of the general secretaries of the party have been Brahmins, as was rightly observed by a senior journalist Kurban Ali in an opinion piece published in the *Prabhat Khabar*.

In contrast, the late Bangaru Lakshman holds the unique distinction of being the first Dalit to lead a national political party and the BJP is extremely proud of this significant fact as it took the party just 20 years to do what the so-called liberal and socially progressive CPI took more than nine decades to achieve. Much before the appointment of Meira Kumar, the late GMC Balayogi was the first Dalit to hold the esteemed Chair of the Lok Sabha Speaker in the BJP-led NDA government.

The social justice movement is at the crossroads today. The BJP is motivated by genuine impulse not illusion of inclusion that was created by the previous dispensations. It was the Narendra Modi-led Government at the Centre that gave a constitutional sanction to the National Commission for Backward Classes through the Constitution (123rd Amendment) Bill. Our purpose is firm in symbiosis and not symbolism. From Stand Up India to the Mudra Yojana, there is an everlasting commitment to make Dalits, OBC's and tribal communities partners and stakeholders in India's growth story.

Reservation, envisioned as a way to uplift people on the fringes has undoubtedly served its purpose. Dalits, socially marginalised groups and tribal communities now are satisfactorily represented and empowered to voice the concerns of their community. However, a lot remains to be done. There is still a glaring lack of social diversity in the judicial process, mass-media, civil society and industry.

I speak as a Dalit rights activist that no one family should be entitled to corner the benefits of reservation and accumulate wealth and political clout. At the provincial level, there have been policy experiments of bifurcating and trifurcating marginalised sections right from Andhra Pradesh to Bihar and Uttar Pradesh recently. The fruits of reservation must reach those at the bottom of the social pyramid. Conversations on reservation have already started within the community and no action on reservation will be initiated unilaterally by the Centre without consultations with stakeholders.

# Enforced altruism

CSR is more socially relevant when it is driven by welfare motives rather than being a mandated policy commanding philanthropy

When we flip through the world's business history, we find that all large mercantile communities were great patrons of the art of philanthropy. They regarded it a divine tradition. The world today is witnessing a growing realisation in enterprises of the importance of altruism. Hence, a great deal of money has been flowing into the social sector. Like individual citizens who have moral and social responsibilities, businesses are being perceived as corporate citizens who need to commit time, talent and resources for welfare of society as they draw their sustenance from it. This idea has now been corporatised under the appellation, Corporate Social Responsibility, better known as CSR.

**A social responsibility:** CSR is a concept whereby firms integrate social and environmental concerns into their business operations and is generally understood to be a tool for achieving a balance between economic, environmental and social imperatives, while addressing expectations of shareholders and stakeholders.

In the global economy, stakeholders include customers, suppliers, employees, communities, and financiers — shareholders, bondholders plus banks and other sources of capital — and they are all intertwined.

CSR is a very broad concept that aims at managing a business in a way that it contributes towards sustainable development by delivering social, economic and environmental benefits to all stakeholders. It addresses issues like human rights, corporate governance, health and safety, environmental effects, working conditions and contribution to economic development. Whatever the definition is, the purpose of CSR is to drive change towards sustainability.

We are seeing the emergence of a new crop of mega donors who are upending long-established norms in philanthropy. Not only are they increasingly willing to take on hot-button social and political issues, they also have a problem-solving and impact-making mindset. CSR is now being recognised as a critical component to an organisation's values, its operating ethos, its business strategies and its purpose. Businesses are being measured on financial and social metrics.

CSR is often used interchangeably for Corporate Citizenship and is also linked to the concept of Triple Bottom Line Reporting (financial, social and environmental), which is used as a framework for measuring an organisation's performance against economic, social and environmental parameters. In essence, CSR is about building sustainable businesses, which need healthy economies, markets and communities.

Over the years there have been many voices within the business community who believe that companies must break out of conventional preoccupation with profit and do more to address the world's pressing social needs. The chorus has been joined by leaders from civil society, governments, policy think tanks and world bodies on education, health and rehabilitation. Business leadership has acknowledged the demand for enlarged corporate responsibility in ways which can reflect a profound attitudinal change individually and collectively.

It is now widely acknowledged that CSR



should be a critical component to an organisation's operating ethos, its values, and its purpose. CSR existed earlier also, however, well-meaning but inappropriate programmes were foisted on communities without any dialogue. That was replaced by the writing of blank cheques to favoured groups, often without an accompanying structure. Today, however, enlightened companies engage in extensive dialogue and planning and are forming partnerships with governments, NGOs and communities to push a wider and deeper agenda.

For a long time, the general sentiment was that for businesses, earning a profit should take precedence over ideals like acting responsibly and ethically. Even today, many companies are paying just lip service.

**A legal mandate:** India is the first country to mandate that firms expend at least 2 per cent of their net profits on special development projects. Its unique law, Corporate Social Responsibility Rules in the Companies Act, 2013, came into effect on April 1, 2014.

However, there is a crucial difference between the way CSR is implemented in the West and in India. A generally accepted gold standard for CSR in the Western world is that it must be closely integrated with a firm's business strategy so that the programmes create a shared value for the company's shareholders. In India, this linkage is explicitly prohibited for CSR; the focus is restricted solely to contribution towards societal welfare.

Experience the world over shows that CSR is more socially relevant when it is driven by altruistic motives rather than being a mandated policy commanding philanthropy. It is very difficult to legislate since moral obligations have to be inculcated, not legislated. Laws can set the minimum standards, but they cannot create an environment or ambience for a philanthropic mindset. This is why we see marked aberrations in the CSR agenda of most corporations. Many businesses harbour a variety of secondary aims

and often use CSR for boosting their social profile and business markets. Such lack of well-intentioned commitment has been detrimental to this noble philosophy.

Companies are trying to dress up CSR as a business discipline and expecting that every initiative deliver business results. That is asking too much of CSR and distracts from what must be its main goal: to align a company's social and environmental activities with its business purpose and values. If in doing so, CSR activities enhance reputation, mitigate risks and contribute to business results, it is acceptable. But for many CSR programmes, those outcomes are becoming a spillover, not their reason for being.

**Challenges for socially responsible companies:** It is true that since there are so many causes competing for attention, it may not be possible for organisations to have a universally inclusive mission. Studies suggest that charity leaders have a geographic bias with corporations homing in on projects closer to their headquarters. Consequently, more remote regions where development aid is acutely needed are being ignored. Politics can also skew priorities, with companies looking to gain political goodwill by funding government-led projects rather than initiating more socially relevant initiatives which are thirsty for funds.

Even as annual CSR expenditure is on the rise, the impact on the ground remains a matter of debate. CSR has usually been peripheral in most organisations and it is not woven into the texture of business. Further, it is not always necessarily transparent or mission-oriented. It may be used for enhancing the brand reputation or to provide a cover of moral counterbalance for brushing off a besmirched public image or for camouflaging dark acts. There is always a creative tension between social mission and business goals.

Moreover, a significant amount of any CSR expenditure comes with strings attached. There are terms that dictate exactly where and how

funds must be used. While this may be appropriate in some cases, it reflects a serious lack of trust in the non-profit entities and hinders their ability to operate effectively. When donors insist that their money should go exclusively to the people served, there is not enough money left for the non-profit entities to focus on building their own organisations. They are, therefore, unable to invest in talent, technology, systems, or reporting. Reporting requirements are often an onerous administrative burden on these small organisations which have to devote their scarce skills to educated, English-speaking personnel for writing reports for the donors rather than running the programmes.

These development agents are the right conduits for reaching the deeper backwaters which have tougher geographical terrains and are centres of social schisms and extremist ideologies. In such regions donors also need to go beyond the sacred *trimurti*—sustainability, replicability and scalability—which should be restricted to mainland organisations. Too much insistence on technicalities leaves genuine development work out of the CSR net. A worm's eye view is as critical as a bird's eye view to ensure that projects deliver visible and lasting outcomes and leave a larger and lasting imprint.

A more important aspect of CSR that needs greater attention is the need for embedding CSR values in employees. It is only when employees align their social philosophy with that of their employers that the real benefits of CSR can materialize. A sincerely and honestly practiced charity always delivers rich dividends in the long run. That is the lesson we learn from both philosophers and business leaders. It is wise to remind ourselves again of the advice of Henry Ford, "A business absolutely devoted to service will have only one worry about profits. They will be embarrassingly large."

The time is ripe for companies to start using AI-based chatbots, which are significantly better. They can retain customer data, and customers do not have to repeat themselves every time. They can handle multiple customer requests at the same time, eliminating the wait time. They can also track the purchase patterns of customers, allowing businesses to revamp their marketing strategy and boost sales.

# Jawan martyred in J&K

## Pak targets civilian pockets along LoC

After failing on the diplomatic front, Pakistan is bent upon escalating tensions along the Line of Control in Jammu & Kashmir.

On Friday, Pakistan Army initiated 'unprovoked' ceasefire violation in which one Indian Army jawan attained martyrdom in Nowshera sector of frontier Rajouri district.

Pakistan Army is regularly targeting civilian pockets along the Line of Control to disturb peace in the region.

Traumatized local residents have been staying back inside their houses to ensure their safety but are worried a lot as on going work on completion of bunkers, sanctioned by the Union Government is going on at snails' pace.

Since August 17, three Indian jawans and one civilian have lost their lives in Pakistan firing along the Line of Control in frontier districts of Rajouri and Poonch.

Defence PRO in Jammu, Lt-Col Devender Anand said, "Pakistan Army resorted to unprovoked ceasefire violation along the Line of Control in



Nowshera sector of Rajouri district on Friday morning.

He said, in the exchange of fire, Naik Rajib Thapa attained martyrdom.

Hitting back, Indian Army responded strongly and effectively.

Defence PRO claimed, "Heavy damage was caused to Pakistan Army posts and casualties to Pakistan soldiers have been inflicted by the Indian army".

Defence PRO said, Naik Rajib Thapa, aged 34 years belonged to Village Mechpara, District Jalpaiguri, West Bengal and is survived by his wife, Khusbu Mangar Thapa.

Meanwhile, to take stock of the prevailing security situation on ground zero, Lt Gen Ranbir Singh, Army Commander,

Northern Command, accompanied by the White Knight Corps Commander, Lt Gen Paramjit Singh Sangha visited forward bases in Poonch and Akhnoor Sector to review the operational preparedness.

Defence PRO said, "During the visit to the sectors, the Army Commander was briefed by the commanders on preparedness of their formations".

Army Commander expressed satisfaction on measures adopted to strengthen counter infiltration posture with increased alertness and use of high-end technology. He also appreciated the aggressive domination of Line of Control adopted to give befitting response to adversary's CFVs and tactical actions.

# Violent protests, azadi chants grip Srinagar

Peaceful protests after the Friday prayers in Soura area of Srinagar have once again turned violent after a large number of local residents attempted to block entry of security personnel via bylanes to quell their protests.

According to eyewitness reports, "after the Friday prayers, a large number of people started shouting pro-Azadi slogans while passing through the streets of Soura area of Srinagar". To contain them, when security forces attempted to move in the area, they offered strong resistance and started pelting stones. Security forces had to resort to the use of teargassing, pepper grenades and pellet guns to contain the protesters. It could not be ascertained how many protesters received injuries during the protest demonstrations which continued for about 2 hours in the area.

According to unconfirmed reports, "large number of residents in the area also joined the small group of protesters who were pelting stones. Those who could not step out of their houses registered their protest by beating empty utensils and

joining the chorus of anti-India slogans".

A twitter handle of Kashmir Zone police late evening posted a message claiming, "situation in the valley has been peaceful. No untoward incident was reported today".

Meanwhile, worshippers spread across different parts of Srinagar and other district headquarters of Kashmir could not offer prayers for third week in succession inside historic mosques in their respective areas. Only small gatherings of

worshippers was permitted in vulnerable pockets in down town areas of Srinagar.

Elaborate security arrangements were made to prevent mass assembly of people in and around local mosques. Posters had also surfaced in

several areas, urging the local residents to march towards the office of United Nations to register their protest peacefully. The security forces had raised barricades blocking all the roads leading to the office of United Nations.

# BSF assistant SI, wife declared foreigners in Assam

**Golaghat (Assam):** An assistant sub-inspector of the Border Security Force from Assam and his wife were declared foreigners by a tribunal without their knowledge, his family claimed on Friday.

Muzibur Rahman, the BSF man who is now posted in Punjab, and his wife were declared foreigners by the Jorhat Foreigners' Tribunal in December last year but the family was informed about this only last month, they claimed.

Talking to reporters at Merapani in Golaghat district, Rahman's father Bapdhan Ali said except the two, everyone in his family have been included in the National Register of Citizens (NRC), the final version of which will be published on August 31.

"I request the government to take steps so that he contin-

ues to be an Indian," Ali told a news channel.

He claimed that their family members have legacy data and land documents to establish their Indian citizenship.

Ali said, "We are Indians. The name of every member of my family is in the NRC but not of Muzibur who is working in the BSF in the service of the nation, and his wife."

One person identified as the lawyer of the family said Rahman was declared a 'D' (Doubtful) voter in July 2018 of which he was not aware and then the Foreigners' Tribunal declared him a 'foreigner' in December.

But he did not get any summons to appear for hearing to present his case, the lawyer claimed.

The family said their village headman informed them on July 29 that Rahman and his wife were summoned to pre-



sent themselves in the Jorhat Circuit House.

As he was away in Punjab, his father and brother-in-law went there and they were told by Government officials that the two were declared 'foreigners' in December 2018. "Probably those engaged in

the NRC updating exercise have not done their duty properly. We want an error-free NRC and will always cooperate with the process. I urge the government to ensure that genuine Indian citizens are not harassed," Rahman told the channel over the phone from

Punjab. Earlier, Kargil war veteran Mohammad Sanaulah and Central Industrial Security Force jawan Mamud Ali were also declared foreigners by the Foreigners Tribunal.

Soon after the Sanaulah incident, Army chief Gen Bipin Rawat had said no jawan will be allowed to face any difficulties if his name does not come in the NRC and that the force will extend all assistance in this regard.

Names of over 40 lakh people were not included in the complete draft of the NRC published last year.

Assam, which had faced an influx of people from Bangladesh since the early 20th century, is the only state having an NRC which was first prepared in 1951.

It is being updated now under the supervision of the Supreme Court. **PTI**

# 2 women fall prey to triple talaq in Kota on single day

**Kota:** Two women fell victim to the outlawed custom of triple talaq on the same day in this district with their husbands allegedly divorcing them with the oral diktat.

Kota's Waqf Nagar resident Anisa Khan on Thursday alleged her husband Usman, a resident of Nagar area in Bharatpur district, divorced her for not bringing more dowry and turned her out of her matrimonial home, said police.

In her complaint to Kota's City Superintendent of Police Deepak Bhargav, Khan said her husband divorced her after raising the demand and beating her up.

On the SP's direction, an FIR was lodged under the Muslim Women (Protection of Rights on Marriage) Act, 2019 against Usman at the Dadabari



police station and the investigation was started, said SHO Tarachand Bansiwala.

## DENTIST BOOKED FOR GIVING INSTANT TRIPLE TALAQ

**Muzaffarnagar (UP):** A case has been registered here against a dentist for allegedly giving instant triple talaq to his wife over dowry, police said on Friday. Saira Bano, a resident of Mustafabad village in Muzaffarnagar area, was given instant triple talaq by her husband in April 16 after the dowry demands were not met, according to a complaint. **PTI**

A case was registered against Tahir Hasan under the Muslim Women (Protection of Rights on Marriage) Act at the New Mandi police station on Thursday, the police said. The couple, who got married in December 2015, are dentists and have a clinic in Deoband town of Uttar Pradesh's Saharanpur district. **PTI**

# Section of advocates come out in support of Justice Vaidyanathan

**Chennai:** A group of advocates has come out in support of Madras high court judge Justice S Vaidyanathan who recently withdrew his observation that co-education in Christian institutes was "highly unsafe" for the future of girl children and directed the court registry to delete controversial paras in his order.

In a representation to the Chief Justice, the Advocates For Reform, Chennai, comprising about 82 advocates, said while it is open to the legal fraternity to criticise a judgment on its merits, lawyers cannot claim any right to criticise judges in their personal capacity for the pronouncements made by them in the judgment.

A delegation of 64 lawyers led by senior advocate R Vaigai had earlier submitted a repre-

sentation urging the chief justice not to post any cases on Christian missionaries as well as women before Justice Vaidyanathan. The delegation had also requested the chief justice to counsel the judge to recall the order and delete some more paras in it. The Advocates For Reform said "When it is always open to the aggrieved parties to file an appeal if they are aggrieved by the judgment, the advocates have no right to demand the judges to recall the orders passed by them."

Such "unwarranted criticism" of the judges for the views taken by them in the judgments would undermine the independence of the judiciary, the representation said.

It would clearly amount to gross interference in the admin-

istration of justice and "is an attempt to virtually browbeat the judges for the judgments pronounced by them."

Senior advocate Vaigai had on Wednesday made a mention before the judge in the court to hear the case again for removal of some controversial paras in the order. When the matter came up on Thursday, the judge said, "The High Court Registry is directed to issue a fresh order copy after removing the expunged paras."

The judge had made the observations recently when refusing to quash a show-cause notice issued to a Madras Christian College professor facing sexual harassment charge from at least 34 girl students pursuing third-year Zoology course at the college. **PTI**

# MNS notices ED on non-Marathi name board

A day after its president Raj Thackeray was grilled by the Enforcement Directorate officials for more than eight hours for his alleged financial involvement in M/s Kohinoor CTNL, the MNS on Friday retaliated in an unusual manner by serving a "notice" on the ED for its failure to put up a name board in Marathi in front of its Ballard Pier Office in south Mumbai.

In a tweet put out through its official handle, the MNS stated: "The name boards of Government departments should be in Marathi. Perhaps, the ED office has forgotten it. We have made a complaint in this regard to the district collector's office. We have sent a copy of the notice to the ED office. Will the Marathi language department compel the ED office to put its name plate in Marathi?"

Raj was grilled for more than eight hours on Thursday for his financial involvement in M/s Kohinoor CTNL which is being investigated for alleged irregularities in the IL&FS's loans-cum-investments case. Raj, whose questioning by the ED officials began around 12 noon and continued till well past 8 pm, emerged out of the ED office at around 8.15 pm on Thursday.



Raj was responding to summons issued to him last week in connection with the investments that he had made in M/s

Kohinoor CTNL, a company funded by former Maharashtra CM Manohar Joshi's son Unmesh Joshi.

After his questioning by the ED in a loan default involving M/s Kohinoor CTNL, Raj had said that notwithstanding the inquiry launched against him by the central investigating agency, he would not shut his mouth but keep speaking against the Government.

"You may investigate me as much as you can, but I would not shut my mouth. But, I would continue to speak (against the Government)," Raj had said.

The ED is investigating the alleged irregularities in the IL&FS's loans and investments worth over ₹860 crore in M/s Kohinoor CTNL.

M/s Kohinoor CTNL has been under ED scanner for being a prominent defaulter of IL&FS, amounting to an estimated ₹135 crore.

Unmesh along with son along with IL&FS and Raj Thackeray-owned Matoshree Construction had in 2005 jointly had made a bid and bought for the NTPC's Kohinoor Mill's 4.8-acre property for ₹421 crore.

In 2008, the IL&FS reneged from the deal and surrendered its shares for only ₹90 crore, against an investment of ₹225 crore made in M/s Kohinoor CTNL. Following the IL &FS's exit, Raj also exited from the venture after selling his shares.

In 2017, M/s Kohinoor CTNL entered into an agreement to sell some commercial and residential properties in the upcoming Kohinoor Square Towers to IL&FS to settle outstanding of around ₹500 crore in loans. Following this, IL&FS extended another ₹100 crore to Kohinoor CTNL on which it defaulted. Jr Joshi's company is now under control of another company.

# Rakbar Khan lynching: 4th accused held

**Jaipur:** The fourth accused has been arrested in connection with the lynching of Rakbar Khan on the suspicion of cow smuggling in Rajasthan's Alwar district last year, police said.

Vijay Kumar was caught in Murtikala colony of Jaipur on Thursday and taken to Alwar. The fifth accused, Naval Kishore, is still absconding, police said. The police have already arrested Dharmendra Yadav, Paramjeet Singh and Naresh in connection with the case and filed a charge sheet against them.

Rakbar alias Akbar was beaten severely by a group of people on suspicion of cow smuggling in Alwar's Ramgarh area in July last year. On the night of July 20, Khan and his friend, Aslam, had allegedly purchased the cows from Ladpura village and were taking them to their village in Haryana through a forested area near Lalawandi in Alwar when the accused attacked them. Aslam managed to flee, but an injured Akbar died at a hospital in Alwar. **PTI**

# Guj women's panel summons IAS officer over bigamy charges

**Ahmedabad:** The Gujarat State Commission for Women has asked IAS officer Gaurav Dahiya to appear before it after receiving a complaint from a Delhi-based woman who has accused him of bigamy and cheating.

Chairperson of the commission Leelaben Ankoliya said on Friday that the summons was issued two days ago.

"There is no response from him yet," she said.

She did not specify when he was supposed to appear.

Meanwhile, the complainant woman, who had met Ankoliya on August 20 to make a representation, on Friday met Gujarat Chief Secretary JN Singh in Gandhinagar.

Addressing a press conference later, she reiterated her demand of DNA test of her eight-month-old daughter to establish that Dahiya is her biological father.

Dahiya, a 2010-batch Gujarat-cadre officer, was suspended by the state government on August 14 after the woman accused him of marrying her in 2018 by concealing the fact that he was already married.

"I have all the evidence to prove that Dahiya married me and we have a daughter together. If he claims he is innocent, he should come forward for a DNA test," she said.

Dahiya has denied that he every married her, and accused her of blackmailing him. **PTI**

# Maya appeals to Centre, Delhi Govt to find a way to reconstruct Ravidas temple

**Lucknow:** BSP president Mayawati Friday appealed to the Centre and the Delhi Government to find a way to reconstruct the Ravidas temple which was demolished by the Delhi Development Authority (DDA) on the direction of the Supreme Court recently.

Mayawati's appeal came a day after a Delhi court sent Bhim Army chief Chandrashekhar Azad and 95 others, arrested on charges of rioting and unlawful assembly following violent protest in Tughlakabad area, to 14-day judicial custody.

They were detained on Wednesday night after the protest against the demolition of a Ravidas temple.

The BSP president, who had distanced herself from the violent Dalit protest in

Tughlakabad area, Friday also appealed to both the Centre and the Delhi Government to find a way to reconstruct the temple and asked followers of Saint Ravidas not to take law in their hands. "Making the demand yet again from the Central and Delhi governments to find a middle path to expedite the reconstruction of the temple with government expenditure so that proper justice can be done. It should be remembered that the BSP government in UP had done many historical works in honour of, Sanit Ravidas," she tweeted. On August 14, Mayawati had asked the two Governments to find a middle path to get the temple constructed with their own resources.

In another tweet, Mayawati

also appealed to the followers of Saint Ravidas not to take law in their hands. "It is an appeal to the followers of the great saint Ravidasji that they should not get angry and take law in their hands for reconstruction of the ancient temple which was demolished in Tughlakabad, Delhi. The followers of Saint Ravidasji should follow the legal way and path shown by Tathagat Gautam Budh to serve their interests," she said.

On Thursday, she had said, "The incidents of vandalism that have taken place in Delhi, especially in Tughlakabad, are unfair and the BSP has nothing to do with it. The BSP always respects the Constitution and the law. The struggles of the party are carried out well within the ambit of law." **PTI**

# Lioness gives birth to 4 cubs; two of them die

**Vadodara:** A lioness gave birth to four cubs, three females and one male, in a wildlife sanctuary in Gujarat, but two of them died later, a forest official said on Friday.

The lioness, Sarita - kept at the Barda Wildlife Sanctuary in Porbandar district under a lion gene pool project - gave birth to the cubs in the wee hours of August 21, D T Vasavada, chief conservator of forest (Saurashtra), told PTI over the phone. However, the male cub and one of the female cubs died due to weakness on Thursday, he said. "Sarita was found to be weak and was not in a position to feed her newborn cubs for 12 hours," Vasavada said.

Veterinary doctors and officials from the Sakkarbaug Zoo at Junagadh checked their health

and gave them powdered milk, he said. However, two of them could not survive, the official said, adding their carcasses have been sent to the zoo's hospital for post-mortem.

The other two cubs are in good health, he said.

The chief conservator of forest said this was second time in less than five months that Sarita has given birth to cubs in the sanctuary. The lioness had given birth to two cubs on April 11, but both of them later died, Vasavada said. The sanctuary currently has two lions - Avon and Nagraj - and as many lionesses - Sarita and Parvati, he said. Sometime ago, Parvati had also given birth to a cub which was later shifted to the Sakkarbaug Zoo, Vasavada said. **PTI**

# 3 killed, 25 hurt in stampede in Bengal

**Kolkata:** At least three persons were killed and over 25 injured in a stampede near a temple in West Bengal's North 24 Parganas district on Friday, Chief Minister Mamata Banerjee said.

The mishap occurred at around 2.15 am near Loknath Dham (temple) at Kachua, around 50 km from the city.

A senior police officer told PTI that three persons have succumbed to injuries and another three are in a very critical condition and 10 critically injured have been brought to Kolkata for treatment.

The three dead have been identified as Aparna Sarkar, Tarun Mondal and Poornima Gorai, another senior officer of West Bengal Police said.

Lakhs of devotees gather at the temple every year on this day to celebrate the birth anniversary of Baba Lokenath Brahmachari, an 18th century Bengali saint who has followers in West Bengal and Bangladesh.

Banerjee, who rushed to National Medical College and Hospital in the city where some of the injured were admitted, told reporters that there was a large crowd at

Kachua Loknath temple this year and the devotees tried to take shelter in the makeshift bamboo stalls lining the narrow approach to it when it rained heavily in the early hours. These bamboo structures collapsed after the heavy rain.

"In the rush to escape from the place, a few people fell into the pond near the stalls. This created confusion leading to a stampede-like situation there," she said.

Senior ministers have been sent to Barasat Hospital, R G Kar Medical College and a hospital at Basirhat, where the

injured are being treated, she said.

"The mishap at Kachua is unfortunate and tragic. Occurred after heavy rain. I visited CNMC and SSKM hospitals to meet families of the deceased and injured. Every death is a tragedy. But what we can do is stand by the families in their moment of grief," Banerjee tweeted.

She expressed her displeasure over the existence of the makeshift bamboo and poly-thene stalls in the narrow lane leading to the temple.

"They (shopowners) set up

stalls using bamboos and poly-thenes. You will not be able to drive them away because if you do, it will lead to problems," she said.

The senior police officer said that some pilgrims visiting the temple in Basirhat police district had slipped due to the slush caused by the heavy rains.

The police rescued them and took them to a health camp at Kachua and then to a primary health centre, he said.

"The situation was immediately brought under control," he said.

Banerjee announced compensation of Rs five lakh to the next of kin of those killed in the mishap, ₹1 lakh to the critically injured and ₹50,000 for those with minor injuries.

State Food and Supplies Minister Jyotipriya Mallick held a meeting with the temple authorities later in the day and a decision was taken to erect two entry and exit points to the shrine.

On the stalls, he said these were built by locals.

BJP state president Dilip Ghosh criticised the state government for not setting up proper infrastructure to deal with the rush of pilgrims and

demanding immediate probe into the mishap.

"There is no point in (the CM's) running from one hospital to another now ... Why should the CM be going to hospitals?... The state government should have put proper arrangements in place keeping in mind the huge turnout on this occasion. There must be an investigation into the mishap," Ghosh said.

The state government had provided adequate security cover for the Haj pilgrims but when it came to providing security and services for Hindu pilgrims it turns indifferent. "I think there was some laxity in the arrangements which led to the loss of lives," he told newsmen.

Alleging that the accident occurred due to indifference and casual approach of the state government, he said had the state government provided enough security cover the accident could have been averted.

"We have no problems in Haj pilgrims getting security cover. But it is absurd that only Haj pilgrims get it and other amenities and the Hindu pilgrims are deprived of it," he said.

# 'Namak-roti' served as mid-day meal, two teachers suspended

**Mirzapur (UP):** A video of children being served salt and rotis in their mid-day meal at a Government-run primary school here has gone viral on social media, prompting the Congress to attack the Uttar Pradesh Government.

The video is of Siyur Primary School under Jamalpur block and it shows a woman distributing rotis and another woman giving salt to children as the mid-day meal. Authorities suspended two teachers, apparently in an immediate damage control exercise.

It was shared widely on social media on Thursday. Congress leader Priyanka Gandhi Vadra hit out at the State Government on the issue, terming the incident "condemnable" and said the facilities provided by it were becoming very poor.

Basic Shiksha Adhikari (BSA) Pravin Kumar Tiwari said on Friday, "Report about the incident was taken from the Block Shiksha Adhikari, Jamalpur, and two teachers found to be prima facie responsible were suspended."



Tiwari said instructions were to provide the mid-day meal as per the prescribed menu and efforts are on to ascertain whether seniors were informed that salt and rotis were being served.

Those who have been suspended are teacher incharge Murari and Arvind Kumar Tripathi, he said, adding that the incident could be an outcome of a local rivalry.

Priyanka Gandhi, the Congress general secretary, tagged the video on Twitter which showed the children, sitting having roti and salt.

"Students are being served salt and rotis in mid-day meals in a school in Mirzapur. This is the state of affairs of

BJP Government in Uttar Pradesh. The facilities provided by the Government are becoming poor and such treatment towards children is highly condemnable," she said.

As per norms under the Flagship Nutrition Scheme, pulses, rice, rotis, vegetables with fruits and milk on certain days are to be served to school-going children to ensure necessary nutrition to them.

The mid-day meal scheme is designed to provide a minimum of 450 calories per child per day, which should include at least 12 grams of protein as well. These meals should be served to each child at least 200 days a year.

# Maharashtra Govt appoints experts to present its case

**Mumbai:** The Maharashtra Government said on Friday that it has appointed experts to present its case before a local council which has sought to close down a memorial of Dr BR Ambedkar in north London.

The Chief Minister's Office (CMO) said the Government was taking all the steps to address the council's objections.

The Government has appointed a solicitor and two planning experts to present its case before the council, it said.

The matter will be heard by the council authorities in September, the CMO said in a statement.

Ambedkar House, a memorial of the Dalit icon, is part of a four-storey residential building at 10 King Henry's Road.



Dr Ambedkar had lived there in 1921-22 during his student days at the London School of Economics.

The local council recently rejected an application by the Indian authorities to convert the property into an official museum or memorial.

The property does not have the permission to be used as a museum and must be returned to residential use, the council officer's report with reference to the application said.

"Singhania & Co Solicitors have been appointed to present

Maharashtra government's case...Mr Steven Gasztowicz QC and planning expert Mr Charles Rose have been named in the committee formed to present the government's case," the CMO statement said.

"...Efforts will be made at all levels to complete the memorial work addressing the issues raised by the council," it added.

Leader of Opposition in the Maharashtra Assembly Vijay Wadetiwar termed the London council's decision as "unfortunate". "This structure which was made holy by Ambedkar's stay is a matter of faith for all. The government should speak to the UK government to ensure that the (building's) memorial tag remains intact," the Congress leader said.

# Didi pens poem on democracy

A day after entering a middleclass household in the beach town of Digha where she personally prepared tea for the inmates as a part of her outreach exercise, Bengal Chief Minister Mamata Banerjee has scribbled a poem on what she calls a "depressing state" of Indian democracy.

In the poem titled "Thikana" or "Address" where the poet apparently labours hard to find out the lost address of democracy that India used to be, Banerjee writes how the address of democracy has become unrecognisable. Incidentally, the poem came a day after the arrest of former Union Home Minister P Chidambaram.

Though the poet herself has not translated the lines into English, the basic import of the verse is somber as she sadly writes how "cawing crows have gone dumb and how the sparrows have stopped pecking at the

grains of rice."

The Chief Minister goes on to rue how in a forlorn democracy "justice has been nimbly curdled like sour milk" wondering why the "storm that has risen is not stopping." Rights, the poem says has been "crammed into a sack" and those who protest are in jail.

Despondency creeps in the poet's mind even as she helplessly tries to find out her address (read the address of democracy). "...Can't find my address" though "everything around is so familiar" they seem much "unknown."

And she ends with an appeal saying, "heart, find my address."


Incidentally, the Chief Minister had on Thursday reacted to the arrest of former Finance Minister P Chidambaram saying "I am depressed, I am sad" at how things have been done. Without delving much into the legality of the senior Congress leader's arrest she said "the process of his arrest is sad. It is

bad. It makes me depressed."

Hours after giving her reaction the Chief Minister whose own party colleagues including senior Trinamool leaders are facing graft charges and CBI probe wrote the poem.

Meanwhile, in an apparent bid to counter Trinamool Congress' reach-out measures like "Didi ke Bolo" through which the people are asked to dial a specific number to let the Chief Minister know about their woes for immediate redressal the State BJP has devised a series of programmes called "Cha Chakra".

State BJP president Dilip Ghosh on Friday said "we are going to launch Cha Chakra as a part of our mass outreach programme." He said that earlier only he used to involve people in Cha Chakra through which the people were engaged in brief tea sessions so that they could make their problems known. "But now the other leaders too will take part in Cha Chakra."

# After breach, Mumbai airport tightens security

The security agencies on Friday beefed up security both inside and outside the Mumbai Airport, following a security breach on Thursday when a "mentally ill" person jumped over a wall and took a stroll under a Spicejet aircraft.

As the Spicejet flight SG-634 Boeing 737 aircraft waited on the taxiway N1 to enter the runway for a take-off to Bengaluru, passengers and crew of the aircraft and others noticed an unauthorised person moving around on the ground below.

The man in question had on Thursday afternoon scaled the perimeter walls of the Mumbai Airport, jumped down, strolled nonchalantly around 50-metres to the taxi-

way, looked at the engine, touched the huge wheels and went around the undercarriage of the aircraft.

He waved at an airport jeep that reached the place to keep an eye on him. However, the security personnel did not step out of the vehicle to avoid getting too close to the aircraft engine.

Not satisfied, the man in question walked to the tail-end of the aircraft. He was later arrested by the security personnel present, minutes after he came on the scene. The incident was captured on CCTV cameras installed in the vicinity, while some passengers also shot the event through mobile phones.

Upon questioning, the apprehended intruder told the security personnel that he had

entered the restricted zone "only to see the airplane" at close quarters. He was later identified as a "mentally ill person aged 24 years from Sion in north-central Mumbai. He had been caught climbing atop a stationary BEST bus at Sion.

His family members told the police that he indulged in such questionable acts when he doesn't take his medicines on time. He is suspected to have entered the airport by climbing on the mobile toilets lining the airport wall.

The security breach involving the "mentally-ill" person came two weeks after the Centre's stringent directives on security matters in the wake of the scrapping of Article 370 of the Constitution which will remain in force till August 31.

# SBSP leader Rajbhar meets Akhilesh ahead of UP bypolls

**Lucknow:** Suheldev Bhartiya Samaj Party chief Om Prakash Rajbhar on Friday met Samajwadi Party president Akhilesh Yadav here, ahead of the impending bypolls to 12 Assembly seats in Uttar Pradesh.

Donning the trademark yellow scarf associated with his party, Rajbhar, a former UP cabinet minister, drove to the SP office and had a meeting with the Yadav for over half-an-hour, but neither of the sides divulged the nature of the talks.

The Assembly by-elections are due in 12 seats in Uttar Pradesh as sitting MLAs got elected to the Lok Sabha in the 2019 parliamentary polls.

The 2022 Assembly elections in the state might have cropped up during the discussion between the two leaders, an SP leader said.

Rajbhars constitute 20 per cent of the Purvanchal population and are regarded as the second-most politically dominant community after Yadavs in the

eastern UP.

A leader from the Rajbhar caste — Anil Rajbhar — was elevated as a cabinet minister from minister of stat (independent charge) during the Wednesday's reshuffle of the UP council of ministers.

He was allocated the Backward Class Welfare and Divyangjan Empowerment

ministry -- a portfolio held by Om Prakash Rajbhar earlier. The SBSP had won four seats in the 2017 UP assembly elections, though the party could not open its account in the 2019 Lok Sabha polls.

Om Prakash Rajbhar was dumped from the UP ministry by Chief Minister Yogi Adityanath just a day after the Lok Sabha polls ended for making embarrassing statements against the BJP.

MSMEs to get pending GST refunds within 30 days: FM

PTI ■ NEW DELHI

In a major relief to the MSME sector facing liquidity shortage, the government on Friday announced that all their pending GST refunds will be paid within 30 days.

Also, in future, all GST refunds of micro, small and medium enterprises (MSMEs) will be paid within 60 days from the date of application, Finance Minister Nirmala Sitharaman said while announcing a slew of measures to boost growth.

Reacting to the announcement, MSME Minister Nitin Gadkari said clearing GST dues within 30 days will be highly beneficial for the MSME sector and will also be instrumental in increasing job opportunities. The amount of pending GST refunds owed to MSMEs is 'significant', he told reporters here.

A top government official said the average amount of GST refund related dues at any given point in time is around Rs 7,000 crore. However, he did not share the exact amount of pending GST refunds for MSMEs.

"I would like to thank Nirmala Sitharaman. The mea-

asures taken by her will be quite beneficial for the MSME sector," Gadkari said.

In a tweet, he welcomed the decisions taken by the Finance Minister and said "this will boost the MSME sector and will be instrumental in increasing job opportunities".

The government would also consider amending the MSME Act to move towards a single definition.

Gadkari said this was under "serious consideration" and a decision will be taken in the next 10-15 days.

Speaking earlier at a press conference to announce measures to boost growth, Sitharaman said the decision on recommendations of the U K Sinha Committee regarding ease of credit, marketing, technology and delayed payments to MSMEs will be taken within 30 days.

She further said that to take advantage of liquidity with the public sector banks (PSBs) and last mile customer connect of NBFCs, the state-run lenders will fast track collaboration for loans to MSMEs.

The MSME sector, which accounts for about 29 per cent of the gross domestic product (GDP), is one of the largest job creators in the country.

cuts, faster recapitalisation of banks and external benchmarking of rates are likely to aid credit off take," Kapoor added.

She further said that most importantly, recognition of issues in the economy and the measures to address them is itself a positive signal and will help ease concerns on growth slowdown.

"Finally the government has taken measures to boost the economy and also address concerns raised by the tax payers and investors. Specifically to address the weakness in auto sector, there are number of steps taken to provide financing at lower interest rates and tax benefits. This should help the sagging auto sector," Gaurav Dua, Senior VP, Head - Capital Market Strategy, Sharekhan by BNP Paribas noted.

Though this will aid the sentiments, it is too early to take a call on the impact of the measures announced on consumer demand, corporate earnings and equity markets, he added.

"In an attempt to provide a stimulus to the economy and in turn to the automobile sector. Revision of one-time registration fees deferred till June 2020 — This according to us is a very important boost to the sector as this would have had a significant impact on demand in the short term," Ashwin Patil, Senior Research Analyst (Auto Sector), LKP Securities said.

"Surchage will no more be charged on short-term capital gain (Section 111A) and long-term capital gain (Section 112A) from the sale of listed equity shares and equity oriented mutual funds. However, surcharge chargeability will continue to impact the taxability on the income from derivatives and from unlisted shares," he said.

"Also it has to be noted that this surcharge goes only for capital gains generated on listed shares and not on unlisted shares," he added.

PV inches closer to elusive Gold; Praneeth breaks 36-year drought

PV Sindhu secured her fifth World Championships medal following a stunning comeback while B Sai Praneeth became the first Indian male shuttler in 36 years to grab a podium in the prestigious event here on Friday.

On a day of double delight for India, Olympic Silver medallist Sindhu staged a come-from-behind victory over Chinese Taipei's Tai Tzu Ying, before Praneeth ended an agonising wait with a straight-game win over Indonesia's Jonatan Christie.

Sindhu, who won back-to-back Silver medals in the last two editions of the tournament to go with her two Bronze, edged past world number 2 and Asian Games Gold medallist Tzu Ying 12-21, 23-21, 21-19 in a pulsating contest that lasted 71 minutes, inching closer to an elusive gold medal at the worlds.

World No 19 Praneeth, who got the Arjuna Award this year, notched up a 24-22, 21-14 win over Asian Games Gold medallist Jonatan in a 51-minute battle, joining Prakash Padukone in the medal list at the tournament.

Padukone was the first Indian to win a men's singles World Championships medal — a Bronze — in the 1983 edition.

In the women's singles, Sindhu showed tremendous grit after being blown away in the opening game, edging past her fancied rival, who enjoys an upper hand (10-4) after 14 career meetings.

"I think in the first game, I had given a huge lead and I couldn't cover. I was prepared for her deception but my shots were going to mid court. But the second game was anybody's game and I kept fighting and won the second. The

third game went same way, she was leading but I had hope. At 18-18, I had to be patient and keep the shuttle inside, there were long rallies and I am happy to win this," Sindhu said after the win.

"We keep playing each other, so we know each other's game. I needed to be positive. It was a really good match and taking out such close matches gives a big boost to the confidence and I hope I can prepare well and come back stronger tomorrow."

The 24-year-old Indian will take on the winner of the match between China's Chen Yu Fei and Denmark's Mia Blichfeldt on Saturday.

"I don't know whom I will play. Chen Yufei is doing well in recent times and Mia has beaten Saina yesterday. I will be playing them after a long time. Anything can happen, I just have to be there and focus on tomorrow's match," Sindhu said.



In the men's singles quarterfinals, Praneeth, who had won the Singapore Open in 2017 and finished runners-up at Swiss Open earlier this year, came into the tournament with a 1-2 head-to-head count against the Indonesian.

But the past record didn't matter as the Indian came out attacking to stave off a stiff challenge from Jonatan in the opening game and then blew him away in the second to find his place in history.

"It feels awesome. It feels great and I am happy to win today. I still have matches, so I have to focus on that and be fitter for tomorrow. We can talk about what medal later on," laughed Praneeth after the match.

Talking about the match, Praneeth said: "In the first game,

the rallies were going on really long and I was attacking a lot and there was a lot of pressure and it made me tired. It was crucial because if he would have won then it could have been different.

"Later Gopi sir told me not to attack and that changed the rhythm and I think those inputs helped me

a lot." Praneeth will take on World No 1 Kento Momota of Japan in the semifinals on Saturday.

"I think everybody is trying to find a way to beat him. It is not easy being the world No 1. You have to put him under pressure, so lets see how it goes. I will give my best"

Early Premier League leaders Liverpool and Arsenal face-off, while Frank Lampard is under pressure to deliver his first win as Chelsea boss at Norwich today.

One of the only two remaining 100 percent records in the Premier League will go at Anfield where the European champions will hope to continue a fine recent record against the north Londoners.

Jürgen Klopp has never lost in seven previous Premier League meetings against Arsenal and his side have beaten the Gunners 4-0 and 5-1 at home in the past two seasons.

However, Unai Emery's outfit are hoping a busy summer in the transfer window, while Liverpool did not strengthen, will have significantly narrowed the 27-point gap between the sides last season.

Emery could hand a first start to £72 million (\$87 million) club record signing Nicolas Pepe, while on-loan Real Madrid midfielder Dani Ceballos earned rave reviews by creating both goals on his full debut against Burnley last weekend.

However, it is at the back Arsenal need a drastic improvement and there is an early opportunity for veteran centre-back David Luiz to make his mark by halting the free-scoring trio of Sadio Mane, Roberto Firmino and Mohamed Salah, who combined for all five Liverpool goals when the sides last met.

Arsenal have some outstanding finishers of their own. Pierre-Emerick Aubameyang, who shared the Premier League Golden Boot with Mane and Salah last season, has scored his side's winner in the first two games of the campaign.

And on the evidence of Liverpool's first four games of the season across all competitions, a defence

that registered 20 Premier League clean sheets last season looks far less solid.

Alisson Becker remains sidelined with a calf injury, meaning Adrian — whose calamitous attempted clearance gifted Southampton a goal last weekend — will keep his place in goal.

Whist Liverpool and Arsenal have taken advantage of a couple of kind fixtures to get their campaigns off to a bright start, Manchester City, Manchester United and Tottenham all dropped points on matchday two.

The roles are reversed this weekend as United host Crystal Palace, who have yet to score this season at Old Trafford, City travel to Bournemouth and Spurs seek to dismiss Newcastle with the ease newly-promoted Norwich did last weekend.

**PUKKI TO PILE PRESSURE**

Lampard was not handed an easy start to life as Chelsea boss with a trip to Old Trafford followed by Liverpool in the UEFA Super Cup and the visit of an ambitious Leicester side to Stamford Bridge last weekend.

However, Lampard, who had just one year's managerial experience at Derby prior to taking over his old club, needs a win at Norwich to ease the questioning of his tactics.

The former England international has been accused of being too gung-ho in his approach as both United and Leicester cut Chelsea open relentlessly on the counter-attack and if he cannot tailor his approach, Norwich have a striker in form ready to take advantage. Teemu Pukki has scored four times in his first two Premier League appearances, including a hat-trick against Newcastle last weekend.

Juventus begin their Serie A campaign at Parma today looking to push their record Scudetto run to nine but with a different style of football under new coach Maurizio Sarri, who will miss the opening fixtures with pneumonia.

Behind, Napoli and Inter Milan are waiting in the wings hopeful that Sarri's arrival can lead to turmoil in Turin and a changing of the guard in Italy.

Carlo Ancelotti's Napoli have not won the title since 1990 and open at Fiorentina Saturday with Antonio Conte's Inter at home to promoted Lecce on Monday.

Coach Niko Kovac confirmed on Thursday Coutinho was not yet fit enough to play the full 90 minutes, and would start on the bench against Schalke.

The Croatian coach said his compatriot Perisic had better chances of making a first start for Bayern.

Perisic, 30, joined Bayern on a one-year loan from Inter Milan earlier this month, but was forced to sit out the season opener against Hertha Berlin due to a suspension carried over from Serie A.

That game confirmed a bumpy start to the new season for Bayern, as they were held to a 2-2 draw and immediately slipped two points behind title rivals Dortmund, who had beaten them in the German Supercup two weeks previously.

# Jadeja, Ishant lift India to 297

Shannon Gabriel and Kemar Roach after losing Rishabh Pant (24) in the second over of the day.

Jadeja's innings comprised six fours and a maximum before he became the last man to be dismissed in the Indian innings, leading to lunch.

India resumed the day at 203 for six with Pant (20) and Jadeja being the overnight batsmen.

While Jadeja justified his inclusion in the playing XI ahead of Ravichandran Ashwin with a gritty effort, Pant could not deliver for the team.

Roach got his fourth wicket of the innings when he dismissed Pant with a beauty from around the wicket that moved away enough to get the edge of the young wicketkeeper-batsman.

Pant was guilty of playing the ball with hard hands as skipper Jason Holder took a regulation catch at sec-

ond slip, leaving India at 207 for seven. It seemed India's brittle tail will not put up much of a fight yet again, but Jadeja and Ishant batted sensibly in their 116-ball stand, defying the West Indian pacers.

While maturity was expected from Jadeja, Ishant impressed with the way he dealt with the express pace of Roach and Gabriel. He was not afraid to come on to the front foot and was equally comfortable at tackling the rising ball.

The lanky India pacer, whose highest score is 31, was finally dismissed in the 90th over, playing on to a full slower ball off Gabriel.

Mohammad Shami joined Jadeja in the middle but his stay lasted only one ball as he offered a return catch to off-spinner Roston Chase.

Running out of partners, Jadeja showed urgency to collect some vital runs and brought up his 11th half-century with a slap to cover for four. The following ball, he swept Chase for a six over deep midwicket, giving the Indian innings a welcome flourish towards the end.

Vice-captain Ajinkya Rahane had made a crucial 81 on the opening day to help India recover from a poor start.

## I was thinking about team rather than hundred: Rahane

It's been two years since he last got a Test hundred but Ajinkya Rahane didn't want to be "selfish" thinking about his own milestone when the priority was to get his team out of the woods.

Coming in at a precarious 25 for 3 on the opening day of the first Test against West Indies, Rahane scored 81, an innings he values more than a hundred.

In fact, he knew a question would pop about missing out on a hundred, having last scored one against Sri Lanka back in 2017.

"See, as long as I am contributing for my team is what matters. Yes, I was thinking about my hundred but the situation we are in — 25 for 3 was tricky. As I have said, I just thought if I could contribute for my team. I am not too concerned about my hundred as that will come automatically," the 31-year-old said.

## Ganguly hopes India get past big games and win ICC trophy

Ganguly on Friday hoped the reappointment of the familiar Ravi Shastri as head coach will help India prevail in the "big games" and break the jinx of not winning a major ICC tournament in recent years.

"Ravi has been around for a while, five years he's completed so he's got an extension for two more years. Hopefully now India can go all the way in the two upcoming tournaments that are coming up, which is the T20 World Cup and the Champions Trophy which has now become a T20 format," Ganguly said.

"So I hope they do well, they're doing well, they get to the semi-finals.

"In 2015 in Australia they struggled, in 2017 (2016) in Mumbai, West Indies got the better of them and even in this World Cup. So, hopefully, they will get to the next step and create a winning combination."

India's last ICC tournament triumph was the win in the 2013 Champions Trophy.

"Hopefully they can get past the big games and win trophies in the next two years," said the former captain who is not the best of friends with Shastri.

Ganguly urged captain Virat Kohli to continue giving the new players a longer run to prove their mettle.

"This is one area where Virat (Kohli) needs to just be a

bit more consistent — pick players and give them a bit more opportunities consistently — for them to get that confidence, rhythm.

"I have said that before. You saw how Shreyas Iyer played in that ODI series (against West Indies), you pick him and you give him the freedom to play those matches and I think that needs to happen with a lot of players and I am sure Virat will do that," added Ganguly.

Ganguly was surprised to see chinaman Kuldeep Yadav and off-spinner Ravinchandran Ashwin being left out of the ongoing first Test against West Indies.

"Yes, I was also surprised to see Kuldeep Yadav left out because the last Test he played against Australia, he got five wickets, if you remember in Sydney on a good flat pitch, he picked up five wickets against Australia.

"But (Ravindra) Jadeja also has been in good form, the surface on Thursday at Antigua needed three fast bowlers because we saw the seam movement the fast bowlers got and it was a question of the spin.

"Ashwin's record is phenomenal to leave him out in the West Indies, so it's a decision which Kohli has made and we will find out in next couple of days whether how far Jadeja goes on to pick wickets on this surface."

After the fall of Panchal, the Karnataka batsman forged a 120-run partnership with Himachal left-hander Ankit Kalsi (48 not out, 171 balls, 4 x4) for the unbroken third wicket stand before rain and bad light ended play early.

INDIA BAGS BRONZE IN YOUTH C'SHIP

**MADRAS:** Indian junior compound men's team won a Bronze while Sukhbeer Singh assured himself of a second medal in the World Archery Youth Championships here on Friday. Playing in his first international event, Sukhbeer helped India open their medal account when he teamed up with Sangampreet Singh Bisla and Tushar Phadtare to shoot a flawless final round and beat Colombia 234-231 for the Bronze. Sukhbeer also assured himself of at least a Silver when he partnered Raginee Markoo to defeat Iranian duo of Geesa Bybordi and Danial Heidarzadehdehkordi 154-151 in the semifinal of compound junior mixed pair event. The Indian team will face Switzerland for a Gold on Saturday.

PAK TO HOST SL FOR LTD OVER SERIES

**KARACHI:** Pakistan will host Sri Lanka for six limited over internationals starting next month, the two cricket boards said on Friday, another step towards reviving international cricket in Pakistan after years of isolation. In a joint statement, the cricket boards said the One Day International series will begin on September 27 in Karachi where they will play the other two ODI matches on September 29 and October 2. The Sri Lankans will then move to Lahore for three T20 matches starting on October 5 and the final match will be on October 9, with the second match scheduled for October 7. This will be Sri Lanka's second tour of Pakistan since their team bus was attacked by militants during a Test match in Lahore in March 2009.

Australia's Josh Hazlewood took five wickets as England collapsed to just 67 all out on the second day of the third Ashes Test at Headingley on Friday.

Australia, who will retain the Ashes with victory in this Test, then strengthened their grip by reaching tea in their second innings on 82-3 — a lead of 194.

Marnus Labuschagne, whose first-innings 74 was seven more than England managed between them, was 13 not out and Travis Head 17 not out.

England, 1-0 down in the five-Test series, had dismissed Australia for a seemingly modest 179, with fast bowler Jofra Archer taking 6-45 on Thursday.

But thanks mainly to Australia's quick Hazlewood's figures of 5-30, England were bowled out inside 28 overs.

Joe Denly, with 12, was the only England batsman to reach double figures.

But whereas Labuschagne, in for concussion star batsman Steve Smith, and David Warner (61) fought hard during their first-innings partnership of 111, few England batsmen were as prepared to sell their wickets as dearily.

Indeed, several played key roles in their own dismissals, for all that Australia bowled well.

Hazlewood takes five as England derail in 3rd Ashes Test

Cup and the Ashes with a short turnaround between the two showpiece events, England had denied several batsmen proper first-class preparation for the very

different demands of Test cricket. By contrast, a number of Australians had played for English county sides — Labuschagne, the only batsman to so far score

1,000 first-class runs this season was with Glamorgan — or featured on the Australia A tour of England that preceded the Ashes. But England's batting woes

predate this season.

Friday's slump was the latest in a line of recent Test collapses that have seen England dismissed for 58 by New Zealand (Auckland 2018), 77 by the West Indies (Bridgetown 2019) and 85 by Ireland at Lord's last month.

But what made this woeful display all the more troubling was that the blue and sunny skies above Headingley on Friday ought to have made conditions for batting easier than the gloom of Thursday, when England captain Joe Root won the toss.

Opener Jason Roy took guard having made just 40 runs in four innings this series.

He fell for nine in familiar fashion when he edged a drive off a wide Hazlewood ball to Warner, holding the first of four catches at first slip.

Root walked out to applause from his Yorkshire home crowd but was out for a second ball nought — his second straight zero after a golden duck in the second innings of the drawn second Test at Lord's — when nicking a straighter Hazlewood delivery that seamed away to Warner.

Hazlewood had taken two wickets for no runs in three balls, with England 10-2.

All-rounder Ben Stokes came into this match following an unbeaten 115 in the second innings at Lord's.

But he all but gave his wick-

et away when he carved at a wide half-volley from fast bowler James Pattinson he could barely reach, with Warner holding a fast edge high above his shoulder.

Denly fought hard only for his 49-ball stay to end when caught behind following an inexplicably extravagant drive off Pattinson.

And 45-5 became 45-6 when Jonny Bairstow disappointed his home crowd by edging a good-length Hazlewood ball, with Warner holding another fine catch.

England were 54-6 at lunch and 54-7 off the very first ball afterwards when Chris Woakes was caught behind off Cummins (3-23).

Archer hooked a four off Cummins before his 'up periscope' attempt to duck a Cummins bouncer also saw him caught behind.

Hazlewood ended the innings when he clean bowled No 11 Jack Leach.

England did then reduce Australia to 36-2.

Stuart Broad had Warner lbw for nought and left-arm spinner Leach struck with his first ball of the match when a sharply turning delivery out of the rough bowled Marcus Harris.

The struggling Usman Khawaja was caught in the slips following a loose drive off Woakes but Labuschagne kept Australia in command.

## Boult, Southee rattle SL

Trent Boult and Tim Southee led New Zealand's charge against Sri Lanka on day two of the rain-hit second Test in Colombo.

The pacemen claimed two wickets each as Sri Lanka reached 144 for six at lunch when rain came down and no further play was possible.

Skipper Dimuth Karunaratne moved from his overnight 49 to score 65 and provided the only bit of resistance in the morning session, which saw 29.3 overs bowled.

Boult took two early wickets in one over after Sri Lanka resumed the day at 85 for two.

Dhanajaya de Silva on 32 and Dilruwan Perera on five were at the crease.

Southee, like Boult, also delivered a double-wicket maiden as the duo put on a superb display of seam bowling under overcast conditions.

Boult got overnight batsman Angelo Mathews caught behind for two to reach a landmark of 250 Test wickets — only the third Kiwi bowler to achieve the feat.

He trapped Kusal Perera lbw for nought after just three balls as Sri



Lanka slipped to 93-4.

Karunaratne also got a lifeline on 61 when Kane Williamson could not grab a tough chance at short midwicket off Ajaz Patel.

But the left-hander, who completed his 23rd Test fifty after resuming the day on 49, soon fell, caught behind off Southee for 65.

Southee struck again in the same over to send Niroshan Dickwella trudging back to the pavilion for nought.

Perera then played out the rest of the session with de Silva.

## SA name Klusener as batting coach

Former South Africa all-rounder Lance Klusener was on Friday appointed as the assistant batting coach of the national team for the three-match Twenty20 series against India in September.

Cricketer South Africa (CSA) also announced that former pacer Vincent Barnes will serve as the assistant bowling coach. While Justin Ontong will retain his position as the assistant fielding coach in Enoch Nkwe's Proteas management.

"In terms of the new team structure the Team Director appoints his three assistant coaches who have specific skills focus in the three key disciplines of batting, bowling and fielding," CSA Acting Director, Corrie van Zyl, said in a statement.

"Former Proteas all-rounder Lance Klusener will fill the role of assistant coach (batting) for the T20

Series only as he is currently not available for all formats."

Klusener, considered one of the best all-rounders of his generation, has collected 1906 runs and 80 wickets in Tests, as well as 3576 runs and 192 wickets in ODIs.

He took up coaching with domestic side Hollywoodbets Dolphins from 2012-2016 before being appointed as batting coach for the Zimbabwe

national team.

In July this year, he was appointed as the head coach of the Glasgow Giants for the cancelled inaugural edition of the Euro T20 Slam cricket tournament.

"His record as one of the best all-rounders in the world, particularly in white ball cricket, during his playing career speaks for itself and he also has extensive coaching experience both at franchise and international level," van Zyl said.

Barnes has a long history with the Proteas, having served as the bowling and then assistant coach from 2003 until 2011.

Ontong, who has represented the national side in all three formats, also served as South Africa's fielding coach under Otis Gibbs before the restructuring.

South Africa will travel to India for a three-match T20 series starting September 15. The two sides will then compete in a three-match Test series.
