Road accident deaths cross 1.51 lakh in 2018

NEW DELHI: Nov 19 (PTI) The number of people killed on Indian roads recorded a rise of 2.37 per cent to 1.51 lakh in 2018 and 70 per cent of the victims fell in the age bracket of 18-45 years, according to a report released by the highways ministry on

Tuesday.
A total of 1.47 lakh people were killed in road crashes in 2017, according to the annual report 'Road Accidents in India, 2018' brought out by the ministry's transport research wing.

"Road accidents in the country have increased marginally by 0.46 per cent during 2018 with the year seeing 4.67 lakh road accidents as against 4.64 lakh in 2017," the Ministry of Road Transport and Highways said.

RS chairman orders review of new uniform of marshals

NEW DELHI: Nov 19 (PTI) Rajya Sabha Chairman M Venkaiah Naidu on Tuesday ordered review of the new military-style uniform of marshals in the House, a move which comes following criticism by some ex-Army officers and remarks of opposition leaders. Uniforms of Rajya Sabha marshals were restyled from traditional Indian attire comprising turbans to dark navy blue and olive green military-style out-fits with caps. Naidu men-tioned in the House that the Secretariat of Rajya Sahba had come out with a new dress code for marshals.

Cong-NCP meet on alliance with **Sena called off**

NEW DELHI: Nov 19 (PTI) A meeting with the Congress scheduled on Tuesday to further discuss the possibility of government formation in Maharashtra was called off due to pre-occupation of Congress leaders with Indira Gandhi's birth anniversary events, NCP leader Nawab Malik said. He said Congress leaders requested that the meeting be postponed to Wednesday. The two sides have deputed leaders for holding talks on a possible alliance. NCP President Sharad Pawar had a meeting with Congress President Sonia Gandhi on Monday. Pawar said if the NCP-Congress have to take a view on government formation, they have to first discuss it between themselves.

Farmer attacks revenue office with petrol

In yet another incident that has sent shivers down the spine of already scared revenue staff, on Tuesday a farmer sprinkled petrol at a tahsil office here and allegedly tried to immolate a staffer, but was overpowered by other staffers in the nick of the

The incident occurred in Chigurumamidi mandal of Karimnagar district, triggering bitter memories of the murder of Abdullapurmet MRO Vijaya Reddy, who was burnt alive by a disgruntled farmer early this month.

The farmer concerned in Chigurumamidi, identified as Kanakaiah of Lambadipalli village, resorted to this act as he was unable to secure his Pattadar passbook. The farmer alleged that revenue officials were intentionally harassing him by delaying the issuance of the passbook.

Kanakaiah had made several rounds to the office over a long period of time, but his issue remained unsolved, sources said.

According to reports, he came to the office on Tuesday and sprinkled petrol initially on computers and furniture and later even on senior assistant Ramachandram. When he allegedly tried to torch the senior assistant, alarmed colleagues came to his rescue and caught hold of the farmer.

Police later went to the spot and initiated an inquiry.

Responding to the grouse of the farmer, revenue officials told the police that since a dispute among the family members of Kanakaiah was pending, the passbook was not issued to him.

The Joint Collector Shyam Prasad Lal took the issue to the notice of Collector Sarfaraz Ahmed. Revenue officials were instructed to lodge a

complaint against the culprit.

custody. The police are questioning him now.

Writ against privatisation of RTC routes premature: High Court

Says TS cabinet decision to privatise 5,100 RTC routes cannot be faulted

A two-judge bench of the Telangana High Court, hearing the cases pertaining to the TSRTC issue, on Tuesday suggested that the writ petition challenging the move by the State government to privatise certain RTC routes was premature. The bench, comprising Chief Justice Raghavendra Singh Chauhan and Justice A Abhisekh Reddy, pointedly asked the petitioner's counsel, Chikkudu Prabhakar, as to how the challenge was maintainable at this stage.

The bench was dealing with a public interest litigation plea, moved by retired professor P L Vishweswar Rao, challenging the intended action of the State government to privatise certain routes presently being run by the State-owned Corporation.

After prolonged arguments by the counsel on issues relating to effects and far-reaching consequences of privatisation, the bench pointed out that the decision of the State Cabinet was restricted to initiating the

"During the South-west Monsoon, 2019, a number of States and Union Territories are reported to have been affected by floods. As per information received from the States and UTs, 2,391 human lives and 15,729 cattle were lost, 8,00,067 houses were damaged and 63.975 lakh hectares of cropped areas were affected due to floods, cloudburst, landslide," Mr. Rai said replying to a written question.

India vulnerable to capital inflow shocks: YV Reddy

Former governor of Reserve Bank YV Reddy has said that recent developments around China, Iran and the Middle East have the potential to generate two types of shocks: oil and capital flows. And, India is vulnerable to both.

He was speaking at a programme organised by the Institute for Advanced Studies in Complex Choices (IASCC)

on Tuesday. Reddy said, "There is a new bi-polar world with USA and China leading each block. The difference between old and new by-polar world is that China and America have close economic integration. This complicates the fight for supremacy underway. The Belt Road initiative goes well beyond economic infrastruc-

He said that there were three economic challenges, which were global in the sense that they could be resolved only through cooperation and



concerted action on the part of all or most of the countries. He said, "Climate change is an area where collective action is inevitable, but it is becoming increasingly difficult. So, replacing Telugu medium with English medium could result in Telugu losing prominence on its own soil at the behest of the government. At the end of the day, the Jaganmohan Reddy government will be answerable to people on the repercussions of the dicey move in

Etela urges Center to sanction 7 medical colleges for Telangana

Health Minister Etela Rajender on Tuesday said that he lead a delegation to Union Health Minister Harshavardhan and sought establishment of medical colleges, among other things, in at least seven district. If not feasible, the delegation urged the Union Minister to sanction medical colleges in two or three districts at least.

The delegation pressed for Central assistance especially on five issues, he explained. The Center went on record expressing its intention to set up not less than 75 medical colleges across the nation. The delegation advised the Center to set up medical colleges one each in Khammam, Karimnagar, Sangareddy, Mancherial, Bhadrachalam, Bhupalapalli, and Tandur or Vikarabad.

A detailed project report would be dispatched to the Center soon, he said. However, the Center agreed to sanction two or three medical colleges to the state. Besides the medical colleges, the Government

Soups can help fight malaria, says study

To fight against malaria, home made soups might help as researchers have found that some of the soup recipes have anti-malarial properties. "Malaria kills more than 400,000 people per year and infects more than 200 million, yet resistance to our frontline drugs continues to emerge, said study lead researcher Jake Baum, Professor at Imperial College London, in UK.

'We may have to look beyond the chemistry shelf for new drugs, and natural remedies shouldn't be off our watch list," Baum added. For the study, published in the journal Archives of Disease in Childhood, researchers from Imperial College London with school children test their fam-



ily soup broths for activity against the malaria parasite. Several of the soup broths, collected from traditional family recipes that originated around the world, showed activity against the malaria parasite Plasmodium falciparum, either by curbing its

growth or preventing it from maturing. The soup recipes had been passed down through the generations for the treatment of fever. Five of the broths were able to curb growth of the parasite in its disease-causing stage by more than 50 percent.

For the study, published in the journal Archives of Disease in Childhood, researchers from Imperial College London with school children test their family soup broths for activity against the malaria parasite

Anees, a native of Uttarakhand. Police said that Anees, an alcohol addict. used to come home in an inebriated

condition regularly and rape his daughter. He even threatened her and made sure she didn't disclose the incident to anyone. Later the victim narrated the ordeal to her mother after which a case was registered and Anees was remanded to judicial custody and PD Act was invoked against him. During his judicial custody under PD Act speedy trial was conducted and ended up with 10 years Rigorous imprisonment and fined Rs 5.000.

Rash driving lands truck driver behind bars

Albrahimpatnam sentenced a truck driver to undergo two years imprisonment for rash and negligent driving leading to the death of a motorcyclist on Monday. The truck driver has been identified as 38-yearold Mohd Tabrez from NTR Nagar in Tandur village of Ranga Reddy district. According to the police, in February 2018, P Chandraiah and P Praveen Kumar were on a motorcycle and heading to Hyderabad to Nampally village in Nalgonda. Due to the impact of the crash, Praveen fell down on the road and died on the spot while Chandriah, who was riding pillion, escaped with fractures on his hands and legs. 'ZERO BUSINESS' TAKES A TOLL ON STATE'S GST REVENUE

'Zero business' going on in the city unhindered causing a dent in the revenue of the state government in spite of implementation of the GST. Business establishments have been allegedly avoiding payment of various taxes by recording sales transactions only on white papers and by not giving bills to consumers for the goods purchased.

Publicity by the Commercial Taxes Department advising the consumers to demand bill for the goods purchased, asking traders to pay taxes on time and take part in country's development appears to have no impact on the business community having very little or no impact on the target group.

The 'zero business' is being witnessed in all markets -Begum Bazaar, Koti, Sultan Bazaar, Abids, Mozamzahi Market, Troop Bazar, Secunderabad market, Malakpet Gunj market, Charminar market and Pather Ghatti market. Even some shopping malls are not giving bills for the goods sold, it is learnt.



Some traders are giving bills on demand by consumers otherwise, they are happy with doing 'zero business'. Even though the concerned Tax Department officials are well aware of the fact, they appear to be silent for obvious reasons. Several allege that the 'zerobusiness' is going on unhindered as the enforcement officials look other way upon greasing of their palms by traders.

Though the GST Act is in force, the 'zero business' is going on unchecked. The records of Commercial Taxes Department reflect only a portion of the sales. Bills are being given on white paper, which does not reflect the name of the shop, goods purchased and register number of the shop and so on.

The traders avoid giving bills because giving bills would

Some traders are giving bills on demand by consumers; otherwise, they are happy with doing 'zero business'. Even though the concerned Tax Department officials are well aware of the fact, they appear to be for obvious reasons

increase the price of goods because of the tax component. Therefore, the consumers are not demanding bills. The Taxes Commercial Department officials also know about it, but fail to take remedial measures. They apparently take no measures to increase the tax revenue to the government. This is helping the zero-business thrive like anything.

The Begum Bazaar, whose existence dates back to 1770, transacts business in lakhs of rupees across the shops in the bazaar. All shops are generally full with customers. The market is famous for all kinds of goods right from dry fruits and masala to gold. The market is the main supplier of all varieties of goods to districts. The Muktiyar Gunj, Kishan Gunj, Osman Gunj, Maharaj Guni and other adjacent markets are known for sale of millets, atta, rice, oil and so on. Here the traders give bill on white paper, but goods are supplied from godowns.

ment were put at Rs 60,000 crore in 2018-19 with Hyderabad markets along contributing to 60-65 per cent of the revenue to it. According to officials, there are over 2000 registered dealers of various goods and services who include retail as well as wholesale dealers. Some of them are not furnishing full data of sales records. The situation is more or less the same in all other markets.



GOVT MULLS HIKE IN LIQUOR PRICES

The State Government is likely to revise the prices of liquor being sold in the state and has plans to constitute a threemember Cabinet sub-committee to fix the revised prices, according to propaganda gained currency among excise

Chief Minister Chandrashekhar Rao is likely to take a decision on the basis of the recommendations of the sub-committee. In the light of new excise policy, the Excise Department did some homework and prepared proposals to hike the liquor prices by 5-10 per cent to net additional annual revenue to the state between Rs 1,200-1,700 crore.

Excise Minister Srinivas Goud and higher officials in the department deliberated on taking the proposals to the notice of the Chief Minister. The moment the proposals referred to KCR, a Cabinet subcommittee will be constituted and the Chief Minister will take a final call depending on the recommendations of the com-



mittee. However, the forthcoming municipal elections will affect the government's decision on hiking the liquor prices. Depending on the election schedule, the CM would take a decision, according to sources. If there is delay in issuing the election notification, the government wants to take a decision on the issue as early as possible. If the elections are notified immediately, the government would adopt a wait-and-watch attitude till the elections are over and then take

A notification inviting appli-cations to set up bars in all the 73 municipalities will be issued soon. The government will take a decision soon. Further, the government is toying with the idea of revise fees for staging various events in the state capital and on its outskirts. The government wants to generate additional revenue through hiking liquor prices, by issuing notification to set up bars in all 73 municipalities and by revising the fees for organisaing various events in the city and its

He wondered what is the conspiracy of the government in removing the SPG cover. Both Congress and DMK members walked out of the House on the issue of removing SPG cover from Gandhis. Confident that IITs, NITs will find solutions: Prez

President Ram Nath Kovind on Tuesday exuded confidence that the IITs and NITs, with their specialisations, will be able to find solutions to address the problem of air pollution as well as create sensitivity among students and researchers.

Kovind made the comments at the annual 'visitor's conference' at the Rashtrapati Bhawan, attended by directors of 23 Indian Institutes of Technology (IITs), 31 National Institutes of Technology (NITs) and Indian Institute of Engineering Science And Technology (IIEST), Shibpur.

This is that time of the year when the air quality of the national capital as well as of many other cities worsens beyond all norms. Many scientists and futurologists have painted doomsday scenarios. On days of smog and poor visibility in our cities, we fear the future might already be here,"



"I am sure that your institutes, with your various specialisations, will find a solution and take care to create a sensitivity and awareness among students and researchers towards our common future," he added.

With the air quality levels touching the "emergency" mark, various IITs have come forward to work on solutions to address the issue including identification of upwind districts in Punjab and Haryana from where crop burning contributes maximum to pollution in Delhi-NCR and a study on identification of brick kiln

clusters which contribute most to pollution levels in Delhi-NCR.
"We are facing a kind of that we have

challenge here that we have faced before. Hydrocarbon energy changed the face of the world in the last couple of centuries, but now it is threatening our very existence. The challenge is compounded for nations battling to bring substantial sections of populations out of poverty. Yet, we will have to find alternatives," Kovind said.

The president said that after the government's efforts to improve India's ranking on



the Ease of Doing Business Index, the aim is now to improve the Ease of Living for all citizens.

"How can we move forward in that direction, and make life easier for all, especially those on the margins of society? Draft guidelines for vehicle scrapping centres prepared, NGT told

The Ministry of Road

Transport and Highways told the National Green Tribunal on Tuesday that draft guidelines for setting up and operating vehicle scrapping centres has been prepared and uploaded on its website seeking public comments.

The Ministry told a bench headed by NGT Chairperson Justice Adarsh Kumar Goel that it has also circulated a policy paper on creation of an eco system for scrapping of old vehicles for transition to environment-friendly new vehi-

The tribunal was also informed by the Delhi Pollution Control Committee that a special task force, constituted by the NGT, is keeping an active and regular watch in Mayapuri area to take action against those who are dismantling vehicles on roads and



confiscate tools and vehicles on a weekly basis.

As per the draft authorised vehicle scrapping facility (AVSF) guidelines, individuals, firms, societies or trusts will be allowed to set up scrappage facilities subject to meeting the eligibility criteria and receiving authorisation from the licensing authority.

The authorisation will be valid for 10 years and can be renewed for another 10 years.

Prospective scrappers must have usable treatment facilities with a minimum area of 4,000 sq metre for small vehicles and

vehicles, as per the guidelines. Vehicles which have not renewed original registration, not been granted fitness certificate and those auctioned, impounded and abandoned by any enforcement agency, among others will be

The JNU fee hike could be reasonably negotiated but using force on students means undoing what we teach them to do



Student movements have had transformative and revolutionary power in world history, from 13th century Paris to the climate activism of Greta Thunberg. That's how our societal and education systems have raised our young to be, question the status quo if it is unjust, create a liberal order, chase passions and ideals that are yet uncorrupted by politics and do so with a "can do" spirit that has not yet been bartered away to compromise. That's why students have overturned

regimes across the world, because all they need is a generational contiguity to override everything else and generate a populist swell. At home, the Nirbhaya and Jessica Lal vigils, Dalit or gay rights would not have changed outcomes had the students not taken the lead. And they have all begun as non-violent, peaceful sit-ins and marches till retaliation was forced by State repression. However, one must cite the college students versus Government protests in Iran of 1999 during which Ayatollah Khamenei had to instruct the police to restrain itself even if it meant that students burnt his posters or tore them apart. This was remarkable in a regime intolerant of any kind of alternative discourse or dissent but Khamenei was aware that student activism had freed itself from State fear and politics and in the long-term could be a challenge if not accommodated. Suppression would only beget harsher rejection and counter-reaction. Therefore, such pragmatism should have also dawned on authorities in New Delhi before they used the police to literally beat up protesting JNU students wanting to march to Parliament and be heard on a surprise fee hike. Cracking down on them mercilessly has not only emboldened them further but shown up the Modi Government as a bulldozer of what JNU stands for, an institution of excellence and learning that attempts classlessness in thought and action, encourages free and radical thinking and a convergence of ideas fearlessly. The ostensible row over a fee hike has taken a back seat due to such mishandling. The Modi Government has clearly overlooked the practicality of raising fees and used it as a ruse to suppress what it really wants, take over and crush a seat of Left-leaning liberalism, one that its proponents dismiss as a despicable clan called "JNU type." Particularly, malign a university that bears the name of India's first Prime Minister. The Government is making a classic mistake of resorting to symbolism. Negotiations could have taken care of much of the problem. But the suddenness of the fee hike was clearly meant to provoke students and make them look like perennial trouble-makers who needed to be taught a lesson. The students' angst over the almost 300 per cent hike is understandable as it's astronomical and insensitive, instead of being graded and phased out as all transitions to a new protocol should be. For long, JNU has been offering succour to the poorest of families, who could not afford a respectable education for their children due to the hefty fees charged by other eminent institutions. It is also a fact that JNU had been operating under a differential fee regime compared to its counterparts. A room rent of just ₹20 per month for a single-seater or ₹10 per month for a double seater, that, too without any utility or service charge, is a dream in the heart of Delhi. This is the reason why students prolonged their stay at the hostels, enrolling in course after course while working part-time. Old students overstaying led to a chronic hostel shortage for newcomers. In this sense, it is welcome that the varsity has finally woken up to the dangers of big subsidies. Yet it must be accepted that a steep hike, coming after 19 years, is an injustice when not reasonably executed. No consultations were made with the stakeholders or the management council to arrive at a common ground. The partial rollback, again swiftly ordered, was cosmetic, according to students. And clamping them down with police action frankly gives more credence to their story of persecution than issues that matter.

Going by the recent past, students have won — those at Jadavpur University forced their Vice-Chancellor to resign, FTII students challenged the appointment of chairman Gajendra Chauhan and women students across the country began the Pinira Tod movement when Jamia Millia Islamia cancelled late nights for its girl hostellers. The Government may want to compartmentalise every part of our public life, saffronising education being a big part of it. Even if we were to follow the spirit of Vedanta truly as it wants, then we would realise that "each man is the power. There is no king. I see everybody equally the same." That's why Professor Firoz Khan of Banaras Hindu University may be a celebrated Sanskritist, who received awards in his subject, but is now considered untouchable.

Hong Kong crisis

Protests here have intensified and most citizens are in support of the young activists. Beijing is in a quandary



In the People's Republic of China (PRC) took over the administration of Hong Kong in 1997, it laid to rest a painful chapter of colonialism on the Chinese mainland. The UK had sought and won certain rights for the citizens of Hong Kong. The Chinese Government had promised "One country, two systems" for the citystate, which still maintained its judicial, economic and cultural identity. It even competes at global sporting meets independent of the PRC. Initially, the system worked well. Officials in Beijing had

a tough time grasping the concepts of free speech and expression in Hong Kong. They realised that the city and its vibrant stock markets and access to the Western capital allowed huge fund inflows into the PRC. Indeed, the PRC's massive growth in the decade following Hong Kong's return was fuelled by money that was routed through the city. However, things have taken a dark turn here under China's new strongman Xi Jinping, who wants the "Sinification" of the city to progress much faster than the promised 50 years. Instead of Hong Kong hoping that some of its free and open culture will be imbibed by China, Xi wants it to be under his thumb. He wanted to achieve this by essentially subverting Hong Kong's unique judicial system to that of China. Easy, peasy he must have thought, but he had not accounted for the citizens, particularly the students. They were loathe to give up the freedoms they have become accustomed to. Even under the heavy hand of the Hong Kong police, who used some of the latest facial recognition technology, the students have continued to resist. Xi's predicament has worsened because of Hong Kong's vibrant and free media, making the city's crisis a public relations nightmare for Xi and his minions.

Letting the students have their way would be akin to admitting defeat by Xi. However, he should learn that compromise is sometimes the best policy as is keeping one's promises, no matter how much one may not like them. Hong Kongers are proud to be citizens of the PRC as well but they were promised two systems and they want that much and no further. The sight of teargas shells being lobbed at students will not serve Xi well in the long run and might even make his economic diplomacy goals such as the rehabilitation of Huawei and selling the Belt and Road Initiative much more difficult.

Power shift in Colombo

Sri Lanka's new President Gotabaya has vowed to maintain neutral but friendly relations with foreign powers. He must be judged by his deeds, not words



otabaya (Gota) Rajapaksa's decisive victory in the presidential election was not entirely surprising though it has shocked the liberals in Colombo, becoming the most ethnically polarised verdict. Gota has shown that presidential elections can be won without the ethnic minority vote. Ever since the Mahinda Rajapaksa regime was voted out of power in 2015 and following the passage of the 19th Amendment, Gota's choice was natural as 19A had ruled out a third term for the President and raised the bar for age to 35 years, thus rendering Mahinda and his son Namal Rajapaksa ineligible for contesting the presidential election.

For an Army Colonel, Gota's decade as the Defence Secretary to elder brother and former President Maĥinda Rajapaksa facilitated the straightening of many wrinkles in defence and national security, though many of his Army colleagues and friends had turned adversaries. By the time Gota became a presidential hopeful, he was accused of corruption, human rights violations during the war, "white van" disappearances, murder of the editor of a newspaper and linkages to a Buddhist extremist group targetting Muslims. But his image as a war hero

Gota won exclusively on the plank of national security. The catastrophic Easter Sunday bombings by radical Islamists linked to Islamic State (IS) were the result of infinite bungling by an incumbent Government already charged with lackadaisical performance. The clamour for return of the Rajapaksas, who had ushered in a decade of peace, began to pick up. Gota sensed his moment. He blamed the Government for dismantling the intelligence apparatus he had established across the country for surveillance and early warning. The bombings were a clear systemic failure.

As President, Commander-in-Chief of the armed forces, Defence Minister or whichever portfolio he assigns to himself, Gota's first task will be to ginger up the intelligence network and reinstate the intelligence grid and to eliminate the residual sleeper cells of the IS linked to radicalised Muslims in Sri Lanka. The reorganisation of higher defence management, which had become esoteric under his predecessor, is bound to be revamped. The post-Easter Sunday appointments of the chief of national intelligence, Inspector General of Police and Defence Secretary, who report directly to the

Gen Shantha Kottegoda, whose term as Army Commander was prematurely terminated in mid-2000 to accommodate Gen Sarath Fonseka, is current Defence Secretary. The extended term of Chief of Defence Staff, Admiral Ravi Wijegunaratne, a war hero who had to go to jail, ends next month and he may get an extension. Army Chief, Lt Gen Shavendra Silva, another war hero whose

appointment in August attracted Western criticism on account of alleged human rights violations, will certainly get an extension beyond December.

As pledged, Gota will likely arrange the release from jail of military intelligence officials under trial. Similarly, he will end speculation over any domestic or international investigation about alleged war excesses and also close the United Nations Human Rights Council (UNHRC) resolution dated January 30, 2015, cosponsored with the US which has already quit the council - on post-war transitional justice and reconciliation. Most of the military is jubilant about Gota's return. So excited was the Army that it reportedly endorsed Gota's presidential candidature in a newspaper advertisement.

Simultaneous with alterations in defence and security architecture, Gota will use his executive and persuasive powers to change the Government Minister. This can happen in two ways: First by Prime Minister Ranil Wickremesinghe and his Cabinet resigning in the aftermath of his party's electoral defeat. Ministers aligned with the presidential loser Sajith Premadasa have already resigned and have urged

Being systematic has its benefits

Putting in money regularly through SIPs rather than trying to time a lump sum investment can help one become a more disciplined investor

Systematic Investment Plan (SIP) is an investment option offered by mutual funds to people where they can put in small amounts periodically instead of lump sums. They can do this by directly debiting a fixed amount of money from their bank accounts and investing in a specific mutual fund and allocating several units according to the current Net Asset Value (NAV). The frequency of investment could be anywhere from weekly, to monthly or quarterly.

There is no fixed period of investment in a SIP and it could range from as small as six months to forever. However, the shorter the investment period in equity mutual fund SIPs, the higher the potential gain. However, this is not without a higher risk. Research shows that there is a 16 per cent chance of losing more than 20 per cent in an equity mutual fund over a six-month horizon, whereas, there is a 90 per cent chance of positive returns in an average equity fund SIP of three years or more, making longterm investments more desirable.

Although most investors associate SIPs with equity mutual funds, investments into debt SIPs can be as effective. One of the fundamental principles of investing is to make money work as soon as possible. An investment needs time to grow, so the longer the money is in the market, the more chance one has of achieving one's goals. An SIP is an option for small investors who want to take advantage of investing for a longer-term but cannot put in a large amount or a lump sum. Surprisingly, sometimes making regular and small investments in the form of SIP can work in the favour of small investors, because of a concept known as "Rupee Cost Averaging."

Rupee Cost Averaging is an approach in which a person invests a fixed amount of money at regular intervals. This, in turn, ensures that they buy more shares when the prices are low and less when they are high. Let's take an example. Suppose Ram has a lump sum of ₹10,000 that he wants to invest in a particular stock or fund, valued at ₹100. He has two options: First, he can invest the full ₹10,000 in one go, buying 100 shares, at ₹100 each. But by doing this Ram is fully exposed to the movements of the market and the value of his investment will rise and fall in line with any share price changes. His second option is to invest $% \left(1\right) =\left(1\right) \left(1\right) +\left(1\right) \left(1\right) \left(1\right) +\left(1\right) \left(1\right)$ his money gradually and Ram may choose to invest ₹1,000 a month over 10 months. If the stock price stays the same, he will be able to buy 10 scrips each month at ₹100.

However, since share prices fluctuate frequently, regular investments by Ram will increase his buying power when the share price falls and he ends up buying more stocks and vice versa. With a drop in the share price to ₹90, he can buy 11 shares, whereas if it rises to ₹110, Ram will end up with nine.

Hence, by regular, small and pre-determined value of investments, Ram would be in a position to buy more shares when the price falls, thereby bringing down the average cost of purchase. When the stock price recovers to ₹100 in the last month, Ram's original investment would be worth ₹10,300. This means Ram would be ₹300 richer by investing regularly, compared to a lump sum investment in the first month by buying 100 shares.

However, there is a flip side to it as well. Ram could also lose money if the share price moves up and he ends up purchasing at a higher price for most of the months. However, we all know that stock markets rarely move in a straight line and price fluctuations are the norm rather than an exception.

By systematic investments over some time, one across a range of prices and effectively end up paying the average price over a fixed period, which can help smooth out market volatility. Trying to buy an asset when it is considered cheap, which is known as market timing, is tricky even for the most experienced investors. Just because a share has already fallen steeply in value, doesn't mean it won't drop further. Because of many market forces at play, nobody can predict perfectly how and when the price would

The decision to invest should be based upon market conditions and putting in money regularly through SIPs rather than trying to time a lump sum investment, can help one become a more disciplined investor and earn better returns in the long run. SIPs help in hedging the risk of getting the market timing wrong. They are also a good option for people with a regular income who want to allocate a fixed amount for mutual funds every month. Further, the choice of mutual funds should be based on one's risk appetite and investment objective.

A man-made crisis

Authorities were aware of the impending environmental hazard but instead of a well thought out long-term strategy to tackle air pollution, our approach appears to be a classic case of ad-hocism



The London smog of November 1952 is considered to be the worst-ever such case of environmental hazard which led to the death of a few thousand people. Winston Churchill, who was the Prime Minister at that time, himself suffered a bronchial attack due to the toxic air. Even

bronchial attack due to the toxic air. Even though the Clean Air Act came up only in 1956, stringent action had been initiated by the local authorities well before that, bringing in a dramatic improvement in the state of the environment in the city.

Back home, even though the National Green Tribunal (NGT), in the case of Ganga Lalwani vs Union of India (2015), had made burning of crop stubble a penal offence and additionally, formulated a National Policy for Management of Crop Residue, the result of the enforcement effort has been rather half-hearted and its dismal and disastrous results are being experienced by all of us in the form of a health emergency being declared in the Delhi-National Capital Region (NCR). According to medical experts, air pollution in Delhi-NCR is no longer just a health risk, it has become a hazard. Everyone in Delhi, particularly actions the statement of the pollular and the statement of the process of the pro become a hazard. Everyone in Delhi, particularly asthma patients, infants, children and the elderly are affected by this pollution. It doesn't matter whether a person is a smoker or not, the toxic air people are breathing in is equivalent to smoking 15 to 20 cigarettes a day.

Except for the States of Odisha, Andhra Pradesh and Tamil Nadu, where some seriousness has been shown in combatting air pollution, the enforcement of the NGT's orders and follow-up on the policy in some of the other States, particularly in Punjab and to some extent in Haryana, has been very poor.

However, according to an affidavit filed by the Central Government in the Supreme by the Central Government in the Supreme Court (SC), stubble burning has gone up by seven per cent in Punjab and gone down by 17 per cent in Haryana. In order to address this problem, a new Central scheme, "Promotion of Agricultural Mechanisation for In-Situ Management of Crop Residue in the States of Punjab, Haryana, Uttar Pradesh and NCT of Delhi," was approved in 2018.

This provided for subsidising machinary and the states of th

ery required for in-situ management of the biomass, for which a sum of ₹1,151.80 crore has been allocated for the period of 2018-2023. Out of this provision, Punjab has got the largest share. The objective of the scheme was to procure agricultural machinery and equipment for in-situ management of crop residue, create farm machinery banks and conduct multi-media awareness campaigns.

For the remaining, it is understood that twowheelers, whose number in Delhi alone is 88 lakh, happen to be the source of about 33 per cent of the pollutants, while four-wheelers, whose number is about 35 lakh are responsible for just about 15 per cent of it.

In these circumstances, forcing some four-wheelers to be off the roads is bound to have just a marginal impact.
On the other hand, as is well known,

the two-stroke two-wheelers and three-wheelers emit a far more hazardous mixture of hydrocarbons and nitrogen oxides, some of which like benzene are known to be carcinogenic, but their numbers continue to

In respect of automobile emissions, complete combustion within the engine is essential to reduce the extent of pollutants. The four-stroke engine is cleaner because it pure petrol; the two-stroke engine, on the other hand, burns a combination of lubricating oil and petrol and a fair amount of the oil is emitted as unburnt vapour.

Some 94 per cent of the two-and threewheelers in India are powered by two-stroke engines that are simple and compact in design, cheap and easy to maintain. But the conventionally-designed two-stroke engines produce high levels of hydrocarbons in exhaust emissions — 5,500 parts per million (ppm), compared to 850 ppm from fourstroke engines. According to a research at the Indian Institute of Petroleum at Dehradun, four-stroke engine-powered motor cycles have been observed to emit just onesixth to one-tenth of the hydrocarbons emitted by two-stroke engines. In addition, their fuel economy is better by 20 to 50 per cent. However, manufacturers prefer two-stroke

have greater pick-up. In the long run, electricity-powered two-wheelers could be a suitable alternative. The latest figures available for usage of public transport in Delhi indicate that the Delhi Transport Corporation (DTC) and Delhi Metro carry just 12 and 10 per cent respectively of the entire commuter traffic.

This is an extremely low proportion and obviously leading to a much greater usage of highly polluting two-wheelers. Obviously, we have to create conditions for encouraging greater ridership on public transport. At the same time we must ensure a larger number of Compressed Natural Gas (CNG) fuel stations so as to reduce the waiting time, since mostly these cater to public transport vehicles or taxis.

Last year a group of industries had conducted a pilot project in two districts of Punjab covering an area of 16,000 acres of farm land, where 25,000 tonnes of rice straw were processed and converted into fibre-based cellulosic products. The details of the project need to be analysed to enlarge its scope.

The apex court has pulled up the Government of India as well as the Delhi Government for "passing the buck" even as Delhi and nearby areas face a public health emergency due to the severe air pollution.

Further, the Centre has been asked to call environmental experts including those from the Indian Institutes of Technology so that their views on the current situation could be taken into account for suitable directives. It can thus be easily observed that a rational public policy based on scientific inputs needs to be operationalised while ensuring its stringent implementation and

What lies ahead for Sri Lankan Tamils?

ri Lankan People's Front candi-Sdate Gotabaya Rajapaksa, younger brother of former President Mahinda Rajapaksa, has now taken over as the country's President. A retired Lieutenant-Colonel, who presided over the country's Defence Ministry for a decade during his brother's tenure (2005-2014), Gotabaya swept the polls in the Sinhala-majority districts, while his main opponent Ranasinghe Premadasa, garnered most of the votes from the Tamil-dominated north and east of the country.

Gotabaya's victory would mean the return of the powerful Rajapaksa family as he is expected to appoint his brother Mahinda as the Prime Minister, sooner than later.

The new Sri Lankan President, known as "terminator" for his role in wiping out the Liberation Tigers of Tamil Eelam (LTTE) a decade ago, has faced lawsuits in Sri Lanka and in the United States (US) over allegations of staged killings of Tamil separatists, critics and journalists during the civil war.

In a fascinating interview with this journalist in 2014, Gotabaya revealed many things, including how he the then government finished off the LTTE. Giving a graphic description of what happened in the last days of the LTTE War IV, (the name given to the fourth phase of the armed conflict between the Sri Lankan military and the separatists), he pointed out that the biggest advantage was that his brother had full trust in him and the then Army chief Sarath Fonseka. Mahinda had the political will to neutralise the LTTE.


Second, the leadership agreed with the defence assessment that a large-scale expansion was needed within a very short period. "We briefed the President. It was not an easy thing to achieve. You need to recruit people, train them and also

equip them. But, we did it," he said. Giving details Gotabaya said that the President also created a core group to cut down red tape. "From our side it

was Basil Rajapaksa, Lalith Chandrakumar Weeratunga, who was President's Permanent Secretary and me. From the Indian side it was

their National Security Advisor MK Narayanan, Foreign Secretary Shivshankar Menon and Defence Secretary VJ Singh, who were in the loop. We coordinated everything. We went to India and they came to Sri Lanka. And we discussed everything, even the operational plan and intelligence inputs."

Gotabaya also exposed the double face of the then Tamil Nadu Chief Minister M Karunanidhi, who put tremendous pressure on the Manmohan Singh Government to stop the war on the LTTE, while the ruling DMK adopted a strategy of run-



ning with the hare Thiruvenkadam and hunting with the

Shivshankar Menon in his book, titled Choices: Inside the making of India's Foreign Policy, confirms that New Delhi was in "intense" and "constant" touch with Colombo. vividly

remember the atmosphere of the crisis that built up during that period and

repeated visits from and to Colombo in the first five months of 2009," Menon notes in his book, adding that by mid-January 2009, the Sri Lankan Army and leadership were convinced that they had the measure of the LTTE and the victory would be theirs. As a strategy, the Sri Lankan Army strongly occupied the north and the south so that the Tigers were kept away and were stopped from procuring military

As for the last phase of the Eelam War IV, Gotabaya noted, that even at the last minute

of the LTTE, broke from the line and went into the small island with his

bodyguards. Kandasamy Pathmanabha, a Sri Lankan Tamil rebel, founder of the Eelam People's Revolutionary Liberation Front and the LTTE's financier, spoke to Prabhakaran in January 2009 over the phone asking him to escape. We intercepted the conversation. Prabhakaran refused to hide at that time. Two weeks before the war ended KP spoke to him again and asked him to escape. The LTTE Tiger again refused," he said.

Gotabaya pointed out that, "Do you think that such a person will come out holding his hands up and surren-

The then Army chief Sarath Fonseka, in an interview to this journalist also observed that the strategy was to take on the LTTE in the jungles. "By May 17, 2009 the troops cornered the LTTE within an area of 400X400 metres. That night when they tried to escape they were prevented from doing so, by all three lines of defence put up by the Army.

Thiruvenkadam Velupillai "On the night of May 18, the top Prabhakaran, the founder and leader LTTE leadership divided itself into three groups. They attacked the Army's forward defence line along the Nandikadal lagoon and did manage to break through. Jeyam, Pottu Amman and Soosai led these three groups. Prabhakaran and his closest guards thought they would manage to escape but in reality all these LTTE fighters (around 250) had got trapped between the Army's first and second line of defence. "After fierce fighting that night, almost the entire leadership of the LTTE was eliminated in that area. "We discovered Prabhakaran's body on the morning of May 19. I got the news of his death around 11 AM. got a phone call from the Commander who gave me the information. Looking back, I was confident. I said I would finish the LTTE in three vears and I did it in two years and nine months," Fonseka said.

Those were different times but today it is a time for peace and as President how will Gotabaya deal with the Tamil minorities in Lanka now? The fact that the Tamils did not vote for him reveals their apprehensions.

Commercial vehicle sales. however, declined 23 per cent to 67,060 units as compared to 87.618 units in October last year. Three-wheeler sales saw an increase of 4 per cent to 59.573 units last month. Total sales across categories rose 4 per cent to 17,09,610 units in October, as against 16.38.832 units in the same month last year.

In September, the government had made it mandatory for traders to register themselves with SIMS to import 215 iron and steel products. 



Director Ravi Kiran speaks to NAGARAJ GOUD about his bumpy ride from receiving no support for choosing a career in films to the praises he has been receiving for his maiden film Raja Vaaru Rani Gaaru

ilmmaker Ravi Kiran Kola wasn't prepared for the response the teaser of his maiden feature film, *Raja Vaaru Rani Gaaru*, has received after it was released online last month. From Sukumar, Sreekanth Addala to Adivi Sesh and Bunny Vaas, everybody rang him up and showered praises. "It was a great welcome gesture for sure.

Impressed by the teaser, producer
Suresh Babu told me that he
would love to support the film in
every way possible. He watched it
in a special screening and decided
to give it a release under the to give it a release under the Suresh Productions banner. What more can a team of youngsters ask for?" he tells us in an exclusive

Ravi, a native of Bhadravaram village, East Godavari was drawn to films in school, courtesy Megastar Chiranjeevi. So eager to get into the industry that he landed in Hyderabad after completing his intermediate. His father was staunchly opposed to the idea, while his mother sup-ported his dream. "My father was the one who challenged me that I will not become a director. He was of the belief that since I knew no one in the industry and that I had no monetary support, it would be impossible for me to become a director," Ravi recalls.

conversation.

After receiving some good counsel, days after he reached Hyderabad, he decided to go back to his hometown, get a graduation degree before trying his luck in the film world again. While pursuing engineering, he made a short film which was picked for a festival in picked for a festival in Hyderabad. It helped him grab the attention of a prominent filmmaker, who asked him to pen a screenplay for his film.

"After completing my last exam in engineering, I straightaway took a bus and reached Hyderabad. I was with the director for a year but as the film couldn't move to floors. Heterogenees the straight was to floors. couldn't move to floors, I later directed a short film on Swachh Bharat with anchor Ravi in 2016. It was a period of boom for short films back then and I thought things would change for me, but that wasn't meant to be," he remi-

Later, he started penning the script of *Raja Vaaru Rani Gaaru* and things started falling into place. "With the film I wanted to connect to my roots and tell a tale honestly. I've seen a lot of Telugu films where some characters spoke in a East Godavari accent which is different from how it actually is. Maybe that was needed to generate comedy but *Rangasthalam* managed to break that. All the characters in my film speak in a slang that is

native to East Godavari. The film deals with fear of rejection. I've seen many late adolescents speaking to other girls from their class with relative ease but when it comes to speaking to their first love, they get nervous. The film follows Raja who fight to muster courage to tell how much he likes Rani. However, the story is not confined to them. There is a whole world around them and I

focused on it as well," he informs.
While casting his male lead, Willie cashing his hale lead, Kiran Abbavaram, was uncom-plicated, finding Rani proved to be easier said than done. Ravi was keen on a Telugu girl doing the part. "I went through almost 2,000 profiles for nearly four months, before zeroing in on Hyderabad-based Rahasya Ghorak. For the supporting parts of Raja's friends, Chowdary and Naidu, I've chosen my childhood buddies Rajkumar and Yajurved. We later conducted a workshop with almost all the cast members for 25 days. The film was shot in 40 villages around Ravulapalem for over 60 days," he says. One of the challenges he faced

on sets was to draw natural performances from his actors.

"I understood that they were used to a certain kind of style, acting-wise, because of the films they grew up watching. Once they got a wind of what I expected from them, it became easier.

Also, I like Malayalam films a lot and I wanted a similar colour tone for my film as well. However, weather in East Godavari is different to that of Kerala, so we waited for specific time periods in a day to shoot some portions to get the desired some portions to get the desired output. As we were not bound by time to complete the shoot, we could get what we want without any pressure. In fact, we waited three months for the monsoon to film some portions. Director Tharun Bhascker recently told me that I transported him to a *Premam* kind of world with the film," he informs, adding that he is writing on a political drama for his next. "It will have a mix of local and state politics," he says.

Wrist spinners difficult to pick with Pink ball: Harbhajan

t the floodlit Eden Gardens, wrist spinners landing the pink ball with scrambled seam will be far more difficult to pick than finger spinners, feels senior off-spinner Harbhajan

India will be playing its much-awaited first Day/Night Test against Bangladesh at the Eden Gardens from Saturday and there is a lot of curiosity regarding how the pink ball would behave.

"Wrist spinners will have one advantage if you see because it's going to be very difficult to pick the seam (with black stitches) of pink ball," Harbhajan told PTI during an interaction.

India has a wrist spinner in Kuldeep Yadav but Harbhajan didn't want to talk on selection mat-

"Well, that's the team management's call and I can't comment. But then Bangladesh need to play the Indian pacers on the seamer friendly track before spinners are fully operational," he said, referring to their performance against Mohd Shami and Co. In the first Test.

And also between 3.30 and 4.30 pm, the time of sunset in Kolkata where seamers are known to do maximum damage. But yes we need to figure out more about spinners if we want to play more D/N Tests in future.

He reminded how Kuldeep turned out to be lethal during the 2016 Duleep Trophy, played with the pink ball.

'If you remember Duleep Trophy, no one could effectively read Kuldeep from his wrists. Leg spinners got lot of wickets during that edition," Harbhajan said.

He explained why wrist spinners are more effective.

"When a finger spinner bowls, the ball is released with seam so that there is turn and bounce. When you are bowling the googly, the seam will be scrambled and very difficult to pick," he explained.

However, someone like a Muttiah Muralitharan might just be very effective.

"But there are exceptions like Muttiah Muralitharan, who could have been a killer with the pink ball despite being a finger spinner

because unlike other finger spinners, both his off break and doosra were released with scrambled seam," said one of India's greatest

However, the pink SG in general will be a challenge for the spinners with the extra lacquer that will be applied to keep its colour intact

"More lacquer means that you will not have a good grip on the ball, especially finger spinners. And the ball starts skidding from

He then went on to explain the fundamental difference between bowling with white ball and pink ball when the dew sets in.

'A lot of people think that the ball will be like a slippery soap bar as it happens with white ball in D/N games. It's not the same. The white ball becomes slippery because the white lacquer goes off the skin of the ball gets wet.

"With extra lacquer, pink ball's skin wont get wet but the stitches will be very soggy. And therein lies problem with finger spinners.

Also the format of the game When a finger makes it difficult. spinner bowls, the

"In 50 overs or 20 over cricket, whenever the ball gets wet, you can just alter the length a bit and let the batsmen play on backfoot getting those singles.

"But in a Test match, you will not have a field setting like that. You have to pitch it up. Now landing six deliveries on one spot while trying to grip a wet seam can be a challenge because trying the ODI length will be easy meat for

For spinners to be more effective, they have to play more games at the domestic level.

"If BCCI creates a window so that all top national players are available for a couple of specific rounds in Ranji Trophy, then you can learn more.

"Even Duleep can go back to pink ball but only if stars play. With no disrespect to any player, if top players dont play here, the purpose is lost and no advantage gained while playing next pink Test," he concluded.

Nur-Sultan to host Ind-Pak Davis Cup tie

Dismissing Pakistan's review appeal, the International Tennis Federation (ITF) on Tuesday announced Kazakhstan's capital Nur-Sultan as the neutral venue for the upcoming Davis Cup tie between India and Pakistan.

Pakistan Tennis Federation (PTF) had filed an appeal contesting the ÍTF Davis Cup Committee's November 4 decision to shift the November 29-30 tie to a neutral

PTF had argued that if Indian pil-grims can visit Pakistan without any security threat, why can't the Indian team play matches in Islamabad, but the Independent Tribunal of the world governing body kept the games at a neutral venue.

The Pakistan Tennis Federation (PTF) appealed the Davis Cup Committee decision to move the tie from Islamabad. The appeal was dismissed by an independent tribunal on Monday 18 November," ITF said in a statement.

"Further to the decision of the PTF not to nominate a neutral venue, in accordance with Davis Cup regulations, the Davis Cup Committee has voted in favour of the tie being hosted by the ITF on neutral ground at the National Tennis Centre in Nur-Sultan (previously Astana), Kazakhstan on 29-30 November," the statement added.

The matches will be played on indoor courts since extreme cold conditions there won't allow them to be staged outside.

'Playing indoor suits our players. It will work in our favour, not that our players can't play on grass but they a lot more comfortable on hard courts. The weather conditions are harsh and though we are playing indoors, it still affects the body," India coach Zeeshan

New Zealand and England will take their cricketing rivalry into the Test arena on Thursday after finding themselves evenly matched in recent limitedovers thrillers. England have bragging rights after

winning a rollercoaster World Cup final in July, then edging the Black Caps 3-2 in a desperately close Twenty20 series completed earlier this month. Both the one-day decider and T20 series needed tie-breakers to find a win-

ner and there will be no shortage of mutual respect when the rivals face off again on Thursday in the First Test at Mount Maunganui. On paper, there again appears to be

little to separate the teams, with New Zealand second in the Test rankings and England third. But England skipper Joe Root is painfully aware that his team underper-

formed when it lost a two-Test series in

New Zealand last year after underestimating the Black Caps' bowlers on their home turf. Pacemen Trent Boult and Tim Southee bundled the tourists out for 58

in the first innings of the opening Test as England tried to play what Root described as "fast forward" cricket.

England's skipper said his team would be taking a more measured

The series will not count towards the World Test Championship, giving new England coach Chris Silverwood room to experiment in his first Test series in

the first innings.

He is expected to hand opening

batsman Dom Sibley his debut, partnering Rory Burns, with Root moving down to fourth in the order New Zealand will take the oppor-

tunity to blood speedster Lockie Ferguson, who has already excelled in limited overs internationals and was described as "an extreme talent" by short-ball specialist Neil Wagner.

"I know he's raring to go. If he gets the opportunity he'll make the most of Wagner said.

New Zealand will also be bolstered the return of captain Kane Williamson, who sat out the T20 series with a nagging hip injury.

It will be the first Test match ever staged at Mount Maunganui's Bay Oval, which has been hosting limited-overs nternationals since 2014.

The beachside venue is Wagner's

Pakistan coach Misbah-ul-Haq said that pitching the ball consistently on the blind spot or near the top of the off stump would be key to dismissing Australian stalwart Steve

Smith returned to Test cricket by taking the Ashes by storm earlier in the year. In the five-match series that was held across August and September in England, Smith scored a whopping 774 runs at an average of 110.57. He carried the good form into the recently concluded T20I series against Pakistan at home.

"As far as Steve Smith goes, there's a blind spot for every top batsman in the world; as a bowler you're always interested in pitching the ball there," Misbah is quoted as saying by ESPNCricinfo.

"Ít's important that we bowl with consistency there. Our bowlers are

executing the plans very well right now, and hopefully we'll be able to build that kind of a pressure, and stay disciplined especially early in the innings. No matter how good a batsman is batting, it's about consistency and bowling the maximum balls in those areas that build pressure and the batsman respects you,

and you force him to make a

Pakistan are going into the series with a pace attack that consists of Mohammad Abbas, Shaheen Afridi, Muhammad Musa and the 16-year-old Naseem Shah.

"All the batsmen you talk to, any batsman in the world, that's the area where you have to defend a ball, and that is a six to eight metre spot where you have to play the top of off stump," he said. "That's the area from where if it's happening then that creates a great chance. Even if it's not happening, you have less chances to do anything with the ball.

"So it's about consistency, and top players in the world, if you miss those areas, that special length and line, then they are good enough to just cash in

on that. So you have to be very, very disci-plined, just keep the ball there, and if it's happening you are already in the game.
