## Pilot scores against Gehlot in SC

Top court refuses to stop Raj HC from announcing decision on petition by Pilot, rebel MLAs challenging disqualification notices for defying Congress

With all eyes on the Rajasthan High Court on Friday over the Rajasthan political impasse, Congress rebel leader Sachin Pilot on Thursday scored a point in the Supreme Court in his fight against Rajasthan Chief Minister Ashok Gehlot.

The Supreme Court refused to stop the Rajasthan High Court from announcing its decision on a petition by Pilot and 18 other rebel MLAs challenging disqualification notices served to them for defying the Congress.

The Rajasthan Speaker, who served the notices last week, had argued that the rebels cannot petition the High Court at this stage. The Rajasthan High Court's ruling will, however, be subject to the final order of the Supreme Court, which will take up the case on Monday.

Gehlot who wrote a letter to Prime Minister Narendra Modi complaining him about conspiracy to topple his Government, asserted that the alleged audio tapes that has surfaced with allegations of involvement of a Union Minister of payoffs to legislators is very much authentic and can be sent abroad for further authentication.

"It is the matter of just one

day. Why can't you wait," the Supreme Court asked the Speaker during arguments on blocking the Rajasthan High Court verdict. The judges also questioned why the Speaker, a neutral person, should approach the court at all.

"Assume a leader has lost the faith of persons. While remaining in party they cannot be disqualified. Then this will become a tool and no one can raise their voice. The voice of dissent in a democracy cannot be suppressed like this," said Justice AK Mishra, one of the three judges hearing the case, without referring to Rajasthan.

Justice Mishra was responding to the arguments of senior lawyer Kapil Sibal defending the Speaker's right to serve disqualification notices and ask the rebels why they skipped party meetings. "The High Court cannot give any protective order at this stage to the other camp. No court can intervene when the Speaker is deciding the case," Sibal said.

Speaker CP Joshi had served notices to 19 rebel MLAs, including Sachin Pilot, after they skipped two meetings of Congress MLAs called by Chief Minister Ashok Gehlot last week. The rebels argued in court that they do not intend to quit the party; they only want a change in the leadership. But Sibal said their act of not joining the meetings amounted to

giving up their membership.

The Speaker's sudden move to seek the SC's intervention reflects the Congress's worry that a legal victory for the rebels may endanger its Government in Rajasthan.

Ashok Gehlot's Government has a narrow lead in the 200-member Assembly — just one MLA over the majority mark of 101. If the Rajasthan High Court decides the Speaker can continue the process of disqualifying team Pilot's 19 MLAs, Gehlot can win more easily as the majority mark will come down.

If the rebel MLAs win their case and get protection from disqualification, they can vote against the Congress Government and make it tough for Gehlot to retain power.

### Can send Shekhawat tape to US for test to clear doubts: Gehlot

**Jaipur:** Targeting Union Minister Gajendra Singh Shekhawat, Rajasthan Chief Minister Ashok Gehlot on Tuesday said the audio clips which indicate an alleged plot to topple his Government can be sent abroad for forensic tests. Without taking the minister's name, Gehlot questioned why he is not coming forward to give a voice sample. "We can send it for FSL testing to America if they have no trust in the Rajasthan government," the Rajasthan CM said, adding that the Congress also did not trust the Centre.

### Credit society scam: Jaipur court directs probe into complaint against Shekhawat

**Jaipur:** A city court has directed that the Rajasthan Police should probe a complaint alleging the involvement of Union Minister Gajendra Singh Shekhawat in a credit society scam. The development comes amid allegations by the Congress that the Minister is involved in a bid to topple the Ashok Gehlot Government. The SOG has already sent a notice to the Minister in connection with a probe into audio clips which indicate efforts to lure away Congress MLAs.

## India asks China to walk the talk on LAC disengagement

India on Thursday categorically asked China to "sincerely" work for complete disengagement and de-escalation on the Line of Actual Control (LAC) in Ladakh.

Officials of the two Foreign Ministries under the aegis of the Working Mechanism for Consultation and Co-ordination on India-China border Affairs (WMCC) are likely to hold talks on Friday to break the logjam and pave the way for another round of Corps Commander-level parleys.

India's latest assertion came against the backdrop of the Chinese troops not honouring the agreements arrived at in the last round of talks between the two Commanders to withdraw additional troops from the front and "depth" areas.

China is yet to start the process to pull back its 40,000 troops leading to heightened tension on the LAC and India also forced ramp up its troop strength. Moreover, the Chinese side has also not removed its heavy guns and weapons as agreed upon, sources said.

This pact to thin out troops was projected as a major confidence building measure but the Chinese not withdrawing has raised alarm bells in the Indian security establishment, they said.

Given this actual scenario, the Ministry of External Affairs on Thursday said in order to bring restore normalcy,

respecting and strictly abiding by the LAC is the basis of peace and tranquility in the border areas. Several agreements concluded by India and China since 1993 firmly acknowledge this, Ministry spokesperson Anurag Srivastava said.

Reiterating the point that China triggered the eight-week old stand offs, he said, "In my

statement of June 26, I had noted that the conduct of Chinese forces this year, including the deployment of large body of troops and changes in behaviour, accompanied by unjustified and untenable claims, has been in complete disregard of all the mutual agreements.

## Pak offer of consular access to Jadhav farcical: India


India on Thursday charged Pakistan with blocking all avenues for remedy in Kulbhushan Jadhav case and said it adopted a "farcical" approach in granting consular access.

This strong statement came after Jadhav was denied consular access and Islamabad said July 20 was the last date for filing review petition by Jadhav against death sentence given to him.

Making New Delhi's stand clear, Ministry of External Affairs (MEA) Spokesperson Anurag Srivastava said India had requested Pakistan 12 times for consular access to Jadhav and Islamabad had not provided "unhindered and unimpeded access".

Srivastava also said Pakistan adopted a "farcical approach" in handling the case, adding India is exploring available options in the matter.

"Pakistan has blocked all avenues for effective remedy available to India. It stands in violation of International Court of Justice (ICJ) judgment and



its own Ordinance. India reserves its position, including right to avail of further remedies," the Ministry said on the Pakistan Government moving Islamabad High Court to appoint lawyer for Kulbhushan Jadhav.

The MEA Spokesperson further said India tried to file a review petition on July 18 for Jadhav but the lawyer appointed by India was told he has no "power of attorney".

Pakistan had earlier this month said July 20 is the last date of filing a review petition by Jadhav against the death sentence awarded by a Pakistani military court.

The 50-year-old retired Indian Navy officer was sentenced to death by the Pakistani

military court on charges of espionage and terrorism in April 2017.

India approached the International Court of Justice (ICJ) against Pakistan for denial of consular access to Jadhav and challenging the death sentence. The Hague-based ICJ ruled in July 2019 that Pakistan must undertake an "effective review and reconsideration" of the conviction and sentence of Jadhav and also to grant consular access to India without further delay.

The Pakistan Government has claimed that Jadhav refused to file a review petition or an application to reconsider the verdict. Pakistan enacted the "International Court of Justice Review and Reconsideration Ordinance 2020" on May 20 under which a petition for the review of a military court's decision can be made to Islamabad High Court through an application within 60 days of its promulgation.

Srivastava said India already shared its concerns to Pakistan in June knowing the "inadequacies and shortcomings" in the Ordinance.

## Community transmission in Telangana! It's official now

With Telangana recording a bigger spike everyday, the State health officials have admitted that the State was passing through the stage of community transmission of the outbreak.

Director of Public Health Dr G Srinivas Rao on Thursday said there were strong indications to show the presence of Covid-19 in the community across Telangana.



"The virus is in the community and all of us are doing our best to contain it. The State Government is pulling out all stops to prevent the virus from spreading. The general public must be very cautious in the next four to five weeks. Masks,

hand washing and physical distancing in every aspect of life are mandatory," Dr G Srinivas Rao said in Hyderabad.

Telangana has over 50,000 positive cases and nearly 450 deaths. The State faced huge criticism for not carrying out adequate number of test to track positive cases. Even now it is one of the worst States as far as testing numbers go.

### Recovered cop tests Covid +ve again, raises fear of reinfection

The case of a Delhi policeman having a relapse of the coronavirus has baffled experts and the doctors treating him and has raised the question whether a recovered patient can contract the infection again.

The policeman, 50, had tested positive for the virus in May and was treated at the Indraprastha Apollo hospitals

between May 15 and 22. Thereafter, he had tested negative and resumed duty.

However, on July 10, he again felt unwell with a fever and dry cough and got himself tested on July 13. The report came positive through the rapid antigen test as well as the RT-PCR test, said Dr Rajesh Chawla, Respiratory and Critical Care Medicine, Apollo Hospitals.

## Joshi deposes, claims Cong Govt implicated him in Babri case

Veteran BJP leader Murli Manohar Joshi on Thursday deposed before a special CBI court in the Babri mosque demolition trial and pleaded innocence and claimed that he was implicated in the case by the then Congress Government at the Centre. He dubbed the prosecution witnesses in the case as "liars".

While making his statement under section 313 of the CrPC through video conference to the court of Special Judge SK Yadav, the 86-year-old leader accused the then Congress-led Central Government of "falsely" implicating him in the case out of

"political vendetta". Former Deputy Prime Minister LK Advani, 92, too is slated to depose before the Lucknow court through video links from New Delhi on Friday.

"The entire investigation was conducted under the political influence and he was charged on the basis of false and fabricated evidence," Joshi told the court.

At this, the judge asked him why then the prosecution witnesses have deposed against him and Joshi retorted, "All the witnesses are liars. They have deposed due to political reasons and under the influence of police."

## Govt goes by SC, OK's permanent commission for women in Army

Abiding by the Supreme Court judgment, the Defence Ministry on Thursday issued orders to grant permanent commission to women officers in the Army. This major move will benefit more than 300 women officers right away serving in 10 streams of the force.

The order comes after the apex court in February this year directed the Government that women officers in the Army be granted permanent commission and command postings in all services. However, women officers as of now cannot serve in the combat arms like the infantry, artillery and armored corps.

Following the judgment, Army Chief General MM Naravane had said it was an enabling one and gives a lot of

clarity on how to move forward. He had stated that the same procedure for male Short Service Commission (SSC) officers will be followed for women to give permanent commission.



The Defence Ministry order on Thursday also said, "In anticipation, the Army HQ

had set in motion a series of preparatory actions for conduct of the permanent commission Selection Board for women officers. The Selection Board will be scheduled as soon as all affected SSC women officers exercise their option and complete requisite documentation."

## Shankaracharya says Aug 5 bhoomi puja date not auspicious, seers differ

Revered Shankaracharya Swaroopananand Saraswati on Thursday said in Varanasi that the time chosen for the "bhoomi puja" and laying the foundation of the Ram Temple is "inauspicious" as August 5 falls in the Dakshinayan Bhadrpad month and is the second day of Krishna Paksha. "In the Hindu scriptures, construction for home or temple is prohibited during the Bhadrpad month," he said, and gave an example of Vishnu Dharma Shashtra and the Naivagna Ballabh Granth to support his claim.

However, the Kashi Vidhyat Parishad termed Shankaracharya's claims as baseless, saying that Lord Rama is an universal hero and questions should not be raised on

construction of the temple. Ram Janmabhumi temple chief priest Acharya Satyendra Das has challenged the claim of Shankaracharya that Bhadrpad month is not auspicious for the bhoomi puja of the Ram temple.

Similar views were presented by Mahant Parhamans Das of Tapasvi Chavni of Ayodhya, who said the entire Bhadrpad month is auspicious for any religious work.

The Ram Temple, once ready, will be 161-feet high. This would be an increase of 20 feet from the original design that was readied in 1988.

It may be recalled that a five-judge bench of the SC led by then CJJ Ranjan Gogoi had in November 29 ruled in favour of Ram Lalla Virajman and allotted the entire disputed land in Ayodhya for temple.

# 1st container cargo from Kolkata via B'desh reaches Agartala

**New Delhi:** The first-ever container cargo from Kolkata via Bangladesh's Chattogram port has reached Agartala, the External Affairs Ministry said on Thursday, terming it a "historic milestone" in the Indo-Bangladesh connectivity and

economic partnership. Union minister Mansukh Mandaviya had last week flagged off the first trial container ship from Kolkata carrying cargo meant for Agartala that reached the city via the Chattogram port.

MEA Spokesperson Anurag Srivastava said it will help in further development of the northeastern region. "Another historic milestone in India-Bangladesh connectivity & economic partnership as the first ever container

cargo from Kolkata via Chattogram port reaches Agartala. This will help in further development of the north eastern region," he said in a tweet. India and Bangladesh have enhanced cooperation in ship-

ping and inland water trade in the recent years. Under the Protocol on Inland Water Transit and Trade, in addition to the six existing Ports of Call, five more in each country have been added recently, the Ministry of

Shipping said in a statement last week. A Port of Call is a place where a ship stops during a voyage to enable the loading and unloading of cargo. Dredging of inland waterway routes is ongoing under

a pact signed by the two countries on development of fairway in selected stretches of Bangladesh waterways, with the Government of India bearing 80 per cent of the project expenditure and the balance being borne by

the neighbouring country, it said. Cruise services have also commenced between the two countries, promoting tourism and people-to-people contacts, it said. **PTI**

## One more Cong MLA resigns from MP Assembly; third in 2 weeks

**Bhopal:** The Congress in Madhya Pradesh suffered yet another setback on Thursday after one more party MLA resigned from the Legislative Assembly, becoming the third legislator from the grand old party in the state to do so in less than two weeks. Narayan Patel, who represented the Mandhata constituency in Khandwa district, tendered his resignation to Assembly pro-tem Speaker Rameshwar Sharma, who accepted it. Talking to PTI on Thursday, Sharma said, "Yes, I have accepted the resignation of the MLA." The pro-tem speaker said that Patel had met him on Wednesday to submit his resignation, but he gave the MLA time to once again think about his move.

He added that as Patel was firm on his decision, he finally accepted the resignation on Thursday. With this, the Congress's strength in the House has come down to 89 now. Last Friday, Congress MLA from Nepanagar seat in Burhanpur district, Sumitra Devi Kasdekar, had resigned from the assembly and joined the ruling BJP. On July 12, another Congress MLA, Pradyuman Singh Lodhi, had resigned as a member of the Assembly. Lodhi, who represented Badamhera constituency, had also joined the BJP. With Patel's resignation, 27 out of 230 assembly seats in Madhya Pradesh are now vacant, for which by-polls will have to be held. The resignation of 25

MLAs and the death of two others earlier has brought the effective strength of the assembly down to 203. In March this year, 22 rebel Congress MLAs, loyalists of former Union minister Jyotiraditya Scindia, had resigned from the party, that led to the fall of the 15-month-old Kamal Nath government in the state. Following the rebellion of 22 MLAs, Kamal Nath had resigned as the chief minister on March 20, paving the way for the BJP to return to power. On March 23, BJP's Shivraj Singh Chouhan took oath as chief minister for the record fourth term. The ruling BJP has 107 MLAs. The Bahujan Samaj Party (BSP) has two legislators, Samajwadi Party one and four are independent. **PTI**

## Centre asks State to cover visually impaired people as AAY beneficiaries

Union Food Minister Ram Vilas Paswan on Thursday directed States to cover visually impaired people as beneficiaries under the Antyodaya Anna Yojana (AAY) and ensure supply of 35 kg subsidised foodgrains per family. The directive has been issued after taking "serious note" of the Delhi High Court order that said visually impaired people are kept outside the ambit of AAY category under the National Food Security Act (NFSA). The AAY beneficiaries are the poorest of the poor and continue to get a higher monthly quota of 35 kg foodgrains per family via ration shops when compared to other beneficiaries who get a monthly quota of 5 kg per person under the NFSA. "I have taken serious note of the Delhi High Court order. Visually impaired people are part of AAY. I have given all states a direction to cover them as beneficiaries

and ensure they get their monthly quota," Paswan said. It is the responsibility of state governments to identify AAY and priority household beneficiaries for providing ration cards, he said. "At any cost, the states should not exclude AAY category people," Paswan said. The states have also been asked to ensure visually impaired beneficiaries

also get the benefit of free foodgrain being distributed under the Pradhan Mantri Garib Kalyan Anna Yojana (PMGKAY) till November, he added. The minister further said that in 2003, the beneficiaries list was expanded under the AAY to include visually impaired people. A guideline was also issued to states for implementation of the same.

**From Page 1** Govt bans public procurement from China, other neighbours. The order takes into its ambit public sector banks and financial institutions, autonomous bodies, Central Public Sector Enterprises (CPSEs) and public private partnership projects receiving financial support from the Government or its undertakings, it added. Observing that State Governments also play a vital role in national security and defence of India, it said, "the Government of India has written to the Chief Secretaries of the State Governments invoking the provisions of Article 257(1) of the Constitution of India for the implementation of this Order in procurement by State Governments and state undertakings etc." For State Government procurement, it said, the Competent Authority will be constituted by the States, but political and security clearance will remain necessary. Relaxation has been provided in certain limited cases, including for procurement of medical supplies for containment of Covid-19 global pandemic till December 31, 2020. By a separate order, countries to which the Government of India extends lines of credit or provides development assistance have been exempted from the requirement of prior registration, it said. "The new provisions will apply to all new tenders. In respect of tenders already invited, if the first stage of evaluation of qualifications has not been completed, bidders who are not registered under the new Order will be treated as not qualified," it said. If this stage has been crossed, ordinarily the tenders will be cancelled and the process started de novo, it said, adding the order will also apply to other forms of public procurement. It does not apply to procurement by the private sector.

## Year's tuition fees of girls to be waived in Gzb Govt schools

**Ghaziabad:** It has been decided to waive the entire year's tuition fee for the daughters studying in half a dozen girl schools run by the Municipal Corporation in the city. Giving this information, Mayor Asha Sharma said that due to Covid 19, the family will be able to deposit the tuition fee of all the girls from their account. Mayor Asha Sharma said that due to the global epidemic Covid 19, the jobs of most people have been lost, families have ended and most families are going through economic crisis. Keeping these

circumstances in mind, it has been decided to waive tuition fees of poor girls studying in all the six girl child schools run by the Ghaziabad Municipal Corporation. The mayor also made it clear that those families who are able to deposit their daughters' tuition fees, come forward freely and submit tuition fees. The Mayor has written a letter to the Commissioner of the Municipal Corporation, Dr. Dinesh Chand Singh in this regard and has issued directions to take necessary steps. **PNS**

**From Page 1** During the court proceeding, the court posed as many as 1,050 questions to Joshi and he replied to each one of them. As the judge sought Joshi's comment over various pieces of evidence led by the CBI on the basis of different video clipping and newspaper cuttings, the former Union HRD minister said the entire evidence is "false and fabricated". During the proceeding, Judge Yadav apprised Joshi of the statement of a CBI witness, in which he had averred that Kalyan Singh was sworn in as UP chief minister on June 25, 1991 and went to the Ram Janmabhoomi site in Ayodhya the next day along with his Cabinet colleagues. The judge told Joshi that, according to the CBI witness, at the Ram Janmabhoomi site in Ayodhya, Kalyan Singh had pledged for building the temple at the very place, chanting "Ram Lala Ham Aeyenge, Mandir Yahi Banayenge (Lord Ram, we will come and make the temple here itself)". The judge then asked Joshi to explain the statement of the CBI witness. Joshi replied that it was true that Kalyan Singh had gone to Ayodhya but, he said, the rest of the averment of the prosecution witness was false. The judge also showed Joshi a photograph taken on June 26, 1991 at the Ram

Janmabhoomi premises, in which he is seen standing with the then Uttar Pradesh chief minister Kalyan Singh and asked the BJP leader to explain it. Joshi dubbed the photograph as "fake", pointing out that there was no negative of the photograph on the CBI records. The photograph was handed over by one Swapna Das Gupta to the CBI during the investigation. The judge also referred to many newspaper reports on alleged statements of former Dy PM Advani and Shiv Sena late chief Bala Saheb Thackeray on Ram Janmabhoomi issue and sought Joshi's response to them. Joshi asserted that the relevant news items were false and were made part of the investigation by the CBI due to "political malice and ideological differences". Joshi told the court that he would present evidence in his defence at the appropriate stage of the trial. After Joshi completed his deposition to the court, Judge Yadav asked his office to send a copy of his statement to the CBI in New Delhi. The CBI will then get Joshi's statement signed by him in New Delhi and send it back to the court in Lucknow. The court recorded Joshi's statement in the presence of his counsel Vimal Kumar Srivastava, K K Mishra and Abhishek Ranjan.

**From Page 1** The order specifies grant of Permanent Commission to SSC women officers in all 10 streams of the Indian Army in which they presently serve - Army Air Defence (AAD), Signals, Engineers, Army Aviation, Electronics and Mechanical Engineers (EME), Army Service Corps (ASC), Army Ordnance Corps (AOC), and Intelligence Corps in addition to the existing streams of Judge and Advocate General (JAG) and Army Educational Corps (AEC). The Army also said it is committed to provide equal opportunities to all personnel including women officers to serve the nation. About 322 women officers had approached the Supreme Court on the issue of Permanent Commission and the issue of command postings came up in the discussion on subsequent avenues after the grant of Permanent Commission. In its appeal the Government had cited "physical" and "physiological limitations" in granting command positions to women officers in the Army to which the Supreme Court had said there was need for administrative will and "change of mindset".

**From Page 1** The policeman, who has no other underlying ailment, complained of chest pain on July 16 and was admitted to the hospital, the senior doctor said, adding that he is stable and his vitals are being monitored. "The first time he was tested for coronavirus, he had no symptoms. There was a camp in the hospital and since his friend got tested, he also got tested and came positive," he told PTI. The second time the policeman was tested for antibodies too, but it was found that he did not have antibodies, he said.

What could be the reasons for the relapse of infection? "If it was within a month," said Dr Chawla, "I would have said that it was a dead virus that was giving a positive result. But that is not the case." "The other thing could be that it was a false positive when he was tested the first time, although it is very rare in RT-PCR test but still it can occur. The third, of course, is reinfection because he did not have antibodies. I have not seen any other such patient," he said. Dr Mugdha Tapdiya, Senior Consultant, Internal Medicine, Fortis Hospital,

Vasant Kunj, concurred with Dr Chawla. It is possible that a right level of antibodies was not developed against the virus which meant that when the patient was exposed again, he got reinfected, she said. She also did not rule out the possibility that the first result was a false positive. Earlier this week, a similar case had surfaced in the national capital after a nurse employed at a civic-run dedicated COVID-19 hospital had tested positive again after recovering. **From Page 1** "We have also made it clear that India is fully committed to observing and respecting the LAC and that we will not accept any unilateral attempts to change the status quo along the LAC." Referring to important talks between National Security Adviser (NSA) Ajit Doval and Foreign Minister Wang Yi on July 5, he said both the sides then agreed to work towards complete disengagement of the troops along the LAC and de-escalation from India-China border areas for full restoration of peace and tranquility. Doval and Wang Yi are Special Representatives of their respective countries to address the boundary issue. Stressing that both the countries are

keen to resolve the matter through dialogue, Srivastava said the fourth round of the meeting of the Senior Commanders was held on July 14, where they also discussed further steps to ensure complete disengagement. In this context, another meeting of the Working Mechanism for Consultation & Coordination on India-China Border Affairs (WMCC) is also expected to be scheduled soon, he added. "As we have stated earlier, the maintenance of peace and tranquility in the border areas is the basis of our bilateral relationship. Therefore, it is our expectation that the Chinese side will sincerely work with us for complete disengagement and de-escalation and full restoration of peace in the border areas at the earliest as agreed to by the Special Representatives," he said.

was nothing to worry as it is ostensibly the "dead virus" left in her body from the previous infection. The officials had said that her IgG antibody level is "very high, which also corroborates this explanation". Explaining the recurrence of the infection, Krishnan Harshan, a virologist with the Centre for Cellular and Molecular Biology, said these could be "sporadic cases". "There are two aspects to it. If the virus is found again in recovered patients, there is either some problem with the test or there is some issue with the immunity of the people who have been re-infected," he told PTI. The immunity against the virus also stays in the body for sometime, he said, adding that unlike the HIV, which is a latent virus and integrates with the genome of the host, the coronavirus doesn't show anything like that. Dr Tapdiya it has been a matter of study all over the world. "There have been a few places like Korea, China where there was recurrence or relapse of infection. Actually there are two sets of patients where it has been seen -- firsts the disease

was mild, and in the second episode, it became severe. In the second set of patients, the disease was moderate or severe in the first instance and then in the second instance also, it was severe. "But at no point in both the cases it was proven that in the first case when the patient was asymptomatic it was a false positive and when he came positive the second time, it was a true positive," she said. The senior doctor also said that recovered patients lower their guard and they become a little bold thinking they won't contract the infection again after catching it once. "It has also been seen that people who have had a milder infection or are asymptomatic, do not have enough immunity, which is also a theory proposed. "It is very important that for every mild and asymptomatic test beyond the 14th day, we should get an antibody test done for testing their immunity. At no point, they should lower the guard," Tapdiya added. "As of now, you are at an equal risk of contracting the infection again." **PTI**

# Sisodia meets students to encourage them for better result next year

Setting a target to achieve 100 per cent results in Delhi Government schools, Deputy Chief Minister and education minister Manish Sisodia on Thursday interacted with some of the Class XII standard students placed under 'Essential Repeat' category to take their feedback and assured assistance to achieve better results for next year.

Encouraging students, Sisodia said, "This year two per cent of students have not been able to succeed. If we look at it only as a figure, it is very less. We could have been satisfied with the 98 per cent result. But, for us, these are our students, not just a mere statistical figure. Every child is important to us. This is the reason this year I am meeting those children who, for some reason, have not been able to succeed," he added.

Sisodia said, "We pay equal attention to every child. But if for some reason, someone isn't able to get good grades, we have to have faith in them. We will have to work really hard on those students so that nobody lags behind. Mr. Sisodia said that many times failures come with an opportunity. Therefore, we have started gearing up for the next year."

He further said that if one misses a bus, it doesn't change their destination. There is always another bus coming next to take them to their destination towards success.

He encouraged students to ask many questions as they want and whenever in-need they should ask for help. "Today, we have not called any principal or teacher so that you can speak to me as your elder brother. There has been a drastic change in our schools but if there is still something missing, then we need your help in fixing it. If a student isn't able to succeed, then we want to understand what is still lacking in our system. We want every single child to achieve greater heights and it will be possible only when you will give us these inputs. We know you are disheartened but you can still help us," the education minister said.

"There is no such thing as failure. This is not the end of life, nor is it the destination. If you overcome your shortcomings, you may become a topper next year," he said.

The Deputy Chief Minister said that the students of class 12th of the government schools of Delhi gave a historic result of 98 per cent this year. Many students shared their interesting stories yesterday in a meeting with Chief Minister Arvind Kejriwal. Charu Yadav's story of Rohini was very inspiring. She left her studies in mid-way as she couldn't succeed in class XI. But her teachers encouraged her and this year she became a

topper in Humanities. Sisodia suggested the students to make a list of people around them who are called "successful" in business, jobs etc. and have advised them to understand the kind of struggles such people had to go through in their lives. Shri Sisodia said that people who have achieved greater heights also have to go through the lowest phases in their lives. He told students to talk to him frankly like an elder brother.

Students expressed themselves openly during this interaction. Students mainly talked about their family reasons or lack of interest in the subjects they took. Few of them had financial issues and someone had a single parent. There was a student whose mother was ill during the examination, another one's brother was going through the mental depression. Somebody got sick himself.

Thinking seriously on these topics, Sisodia said that family issues like having a single parent may hinder children's learning, we need to create a comprehensive support system for every child.

Many students shared their experiences. Another student said she wanted to take Humanities but she couldn't take it due to parental pressure. This is the reason she underperformed.

Sisodia said that we will emphasize that after passing class 10th, parents should also be counseled along with children so that every child is enrolled in the subject of their interest. Parents should also understand it's importance.

Atishi, former Advisor to the MLA and Education Minister, told students that it is wrong to say that a child has failed. Yes, it is necessary to get good grades, but no students can be fully assessed based on the result of a three-hour examination. Every child is unique. If anyone has failed, then we have failed ourselves, our school has failed, which could not help you reach your destination.

"Police have also recovered the mobile phone and one SIM card which were used in calling from the possession of the accused," he further added.

# Capital records 50% excess rainfall in July

Delhi has already recorded 50 per cent more rainfall than normal in July as heavy rain lashed the national capital this week. Rainfall recorded in the city in July till Saturday was just 47.9 mm, 56 per cent less than the normal for the period.

According to the India Meteorological Department (IMD) data, the Safdarjung Observatory, which provides representative figures for the city, has recorded 225 mm rainfall in July so far, which is 50 per cent more than the normal of 149.8 mm.

The Lodhi Road weather station has gauged 246 mm rainfall which is 64 per cent more than the normal of 149.8 mm.

The Palam weather station has recorded 37 per cent surplus precipitation -- 224 mm against the normal of 164.1 mm.

However, since Jun 1, when the monsoon season begins, the city has recorded 29 per cent less rainfall than normal.

Delhi received this season's first spell of heavy rains on Sunday which submerged low-lying areas in waist-deep water. Safdarjung, Ridge and Lodhi Road weather stations recorded 74.8 mm, 86 mm and 81.2 mm rainfall, respectively.

At least four people have died in rain-related incidents. Heavy rains drenched the city again on Wednesday, inundating many areas and affecting traffic movement.

The monsoon reached Delhi on June 25, two days earlier than the usual date of arrival. Despite that, rains remained subdued in the city in the absence of a strong supportive weather system such as moisture-laden easterly winds from the Bay of Bengal.

Earlier, the IMD had predicted normal rainfall in the national capital during the season.

# Paramilitary forces log 9,700 Covid-19 cases

The Central paramilitary forces have clocked over 9,700 Covid-19 cases with 4,300 of them being active even as the test reports of about 600 personnel are awaited. As many as 41 personnel have so far succumbed to the infection.

The Central Reserve Police Force (CRPF) has breached the 3,000-mark in terms of number of infected personnel and tops the list with 3,241 personnel testing positive for the novel Coronavirus infection till now. Of this, as many as 220 cases of infection were reported during the last 24 hours. Currently, there are 1,583 active cases and 1,643 patients have recovered and 15 have died due to the pandemic.

The Border Security Force (BSF) is just short of 49 cases in touching the 3,000 mark in terms of Covid-19 infection with a total of 2,941 personnel being infected by the viral diseases. Out of 2,941 positive

casualty due to the disease.

The National Disaster Response Force (NDRF) has reported 384 Covid-19 cases in its ranks of which 80 are active and 304 patients have recovered. Like the NSG, NDRF too has not reported any loss of life due to the pandemic.

As many as 9,703 cases of Covid-19 have been reported across the seven Forces till now of which 4,458 continue to be active and 5,204 have recovered from the disease.

Covid-19 test reports of suspected cases of infection of 596 personnel are awaited as on date.

During the last 24 hours, 495 cases of infection have been reported across the Forces with the CRPF alone reporting 220 new cases during the period. The National Disaster Response Force (NDRF) has reported 384 Covid-19 cases in its ranks of which 80 are active and 304 patients have recovered. Like the NSG, NDRF too has not reported any loss of life due to the pandemic.

As many as 9,703 cases of Covid-19 have been reported across the seven Forces till now of which 4,458 continue to be active and 5,204 have recovered from the disease.

Covid-19 test reports of suspected cases of infection of 596 personnel are awaited as on date.

During the last 24 hours, 495 cases of infection have been reported across the Forces with the CRPF alone reporting 220 new cases during the period. The BSF and ITBP reported 62 and 61 new cases respectively during the last 24 hours followed by 25 cases in CISF and 15 cases in SSB. The NSG reported one new case and the NDRF tested six positive cases during the period.

# 'Reducing dependency on Chinese API import not easy'

Against the backdrop of India's bid to become 'atmanirbhar' (self-reliant), one of the Government's own bodies has maintained that reducing dependency on the import of the Active Pharmaceutical Ingredients (API) from China is not going to be an easy affair. API is a chemical compound that is the most important raw material to produce a finished medicine. At present, 68 per cent of India's API need is fulfilled by China.

It pointed out that indigenously-manufactured drugs would be 20 per cent costlier than those available from the neighbouring country.

The Technology, Information Forecasting and Assessment Council (TIFAC), an autonomous body under the Union Science and Technology Ministry, in its report has now called for preparing a national stockpile of generic medicines for critical illness and ensure API security in view of changed global norms due to Covid-19 pandemic and border tiff with China.

The report also suggested that while India has the technology for production of many APIs, the production cost needs to be optimised to match the global norms largely by scaling up of operations. "Towards this, common facilities such as solvent recovery plant, distillation plant, power and steam units etc. should be established in bulk drug parks," said the report "Active Pharmaceutical Ingredients: Status, Issues, Technology 'Readiness and Challenges' as it dwelt in detail on the strength and limitation as well as emerging market scenario in the sector.

In 2019, India imported APIs worth ₹249 billion of which around ₹169 billion were from China itself, with the imports increasing steadily from just 0.3 per cent in 1991 to the current 68 per cent.

"Two-thirds of the total imports of APIs and drug Intermediates were from China. Out of the 373 drugs in the National List of Essential Medicines (NLEM), around 200 are imported as APIs, that too mostly from China. The import value of bulk drugs and

drug intermediates from China to India increased around 23 per cent from 2016-17 to 2018-19," said the report.

Despite a very strong base, due to low-profit margins and non-lucrative industry, domestic pharmaceutical firms gradually stopped manufacturing APIs and started importing, finding it a cheaper option with increased profit margins on drugs.

Dependence of India on China for the imports of critical key starting materials KSMs, intermediates and APIs has increased over the period. India also imports common raw materials, solvents etc, required for the production of drugs, said the report.

All the drug Intermediates are imported to India, of which 58 molecules are exclusively imported from China.

The global pharmaceutical market is USD 12 trillion with API market of USD 1,822 billion.

The pharmaceutical industry in India is third largest in the world, in terms of volume, behind China and Italy and fourteenth largest in terms of value.

The Indian industry has a

network of 3,000 drug companies and about 10,500 manufacturing units with Indian domestic turnover reaching ₹1.4 lakh crore (USD 20.03 billion) in 2019, with exports to more than 200 countries in the world.

Identifying a list of APIs which need to be taken up for prioritized manufacturing, the report compiled by scientists and pharma experts said that India needs a Mission mode Chemical Engineering with defined targets for uninterrupted synthesis of molecules and to create mega drug manufacturing clusters with common infrastructure.

"For those few APIs, for which we don't have technology, early stage research and development support should be provided for pilot development of APIs.

"At the same time, issues related to land acquisition, ease of doing business, environmental clearance, taxation, and R&D need to be resolved while a single window clearance system and priority license renewal system for companies manufacturing APIs need to be established," said the report.

# PM Modi is 100% focused on building his own image: Rahul

Former Congress president Rahul Gandhi on Thursday once again targeted Prime Minister Narendra Modi by alleging that the latter was "100 percent focused on building his own image" and did not have a vision for the country that had allowed China to take advantage.

"India's captured institutions are all busy doing this task. One man's image is not a substitute for a national vision," he tweeted along with his two-minute video as part of his ongoing series on different issues.

Former Union Minister Ajay Maken at a Press conference said since last one week, PLA is not withdrawing from the 'depth areas' as agreed in four rounds meeting of corps-commanders of India and China.

# NIT/CFTIs admission criteria relaxed in view of rising corona cases

In a significant development, the HRD Ministry on Thursday announced a relaxation in the admission criteria for NITs and Centrally-funded technical institutions (CFTI) in view of the Covid-19 pandemic by doing away with the requirement of minimum 75 per cent marks in Class 12 board exams.

"Due to prevailing circumstances, Central Seat Allocation Board (CSAB) has decided to relax the eligibility criterion for admissions to NITs and other centrally funded technical institutions," Union HRD Minister Ramesh Pokhriyal 'Nishank' tweeted.

"JEE Main 2020 qualified candidates will now only need to obtain a passing certificate in class XII examination irrespective of the marks obtained," he further said.

For admissions in NITs and other CFTIs, apart from qualifying the JEE-Main, the eligibility was to secure a minimum of 75 per cent marks in Class 12 board exams or rank among the top 20 percentile in their qualifying examinations.

# Ministry holds maiden Ind-SAT Test 2020

The Union HRD Ministry has conducted the first-ever Indian Scholastic Assessment (Ind-SAT) Test 2020 under its 'Study in India' programme. Nearly 5,000 candidates from Nepal, Ethiopia, Bangladesh, Bhutan, Uganda, Tanzania, Rwanda, Sri-Lanka, Kenya, Zambia, Indonesia and Mauritius appeared for the exam conducted in the proc-

tored internet mode by the National Testing Agency.

EdCIL (India) Limited, a PSU under the MHRD and the implementing agency of SII, handled the registrations and other aspects of the examination.

Ind-SAT is an exam for grant of scholarships and admissions to foreign students for studying in select Indian universities under the Study in India programme.

Due to the COVID-19 pandemic, the exams could not be held as per the schedule and the boards had to release the result on the basis of a new assessment scheme wherein the average marks secured by the students in the papers for which the exam was held were taken into consideration. Students who wish to improve their scores will be given a chance later.

# North-East regions have immense potential to spur India's growth: Modi

Prime Minister Narendra Modi on Thursday said India's north eastern region has immense potential to become the growth engine of the country. He talked about the potential of the tourism industry in the region and its development as a bamboo industry hub.

Regarding the massive development works taken up in Manipur, the Prime Minister said that the Imphal - Jiribam railways work is going on with an allocation of ₹14,000 crore while ₹3,000 crore has been sanctioned for the development of Imphal International Airport.

Laying the foundation stone of Manipur water supply project via video conferencing, the Prime Minister said that it has been designed to provide safe drinking water to every household of the State for the next 20-22 years



and lakhs of people will get access to clean drinking water and thousands of people will get employment.

Modi said that the mantra of peace, progress and prosperity is echoing in the Northeast, and day by day his faith is getting deeper because peace is now being established in the entire region. "While blockades in Manipur have become a part of history and Assam has not witnessed any violence for decades.

In Tripura and Mizoram too, youth have abandoned the path of violence. Now Bru-Reang refugees are moving towards a better life," he said.

# EC defers 8 bypolls as Covid, flood unabated

Due to a huge surge in transmission of coronavirus infections and deteriorating flood situation in several States, the Election Commission (EC) on Thursday announced the deferment of by-polls to one Parliamentary constituency and seven Assembly seats that were scheduled to be held by September 7. Bye-elections are due in 56 Assembly constituencies and one parliamentary seat. The remaining 49 bypolls are due after September 7.

The seats where the bypolls have been put on hold till September 7 are Valmiki Nagar in Bihar, Sibsagar in Assam, Thiruvattiyur and Gudiyattam in Tamil Nadu, Agar in Madhya Pradesh, Bulandshahr and Tundla in Uttar Pradesh and Chavara in Kerala. The EC has clarified that in any case, the deferring of eight by polls is only up to September 7, 2020. Seven of the bypolls had been necessitated by the deaths of the sitting legislators, while in Tundla constituency in Uttar

Pradesh, the MLA was elected to Parliament.

As per the electoral law, EC has to hold bye-elections within 180 days (six months) of a seat falling vacant, another official pointed out. The six-month deadline to hold by-elections in these eight seats was ending on different dates in July, August and September respectively. When the EC assessed the situation, it found that it is difficult to adhere to the six-month deadline in these seats, and approached the Union law ministry to defer the polls, EC officials said.

The EC said that the Commission has already taken a decision to hold all bye-elections as per provisions of Section 151A of the Representation of People Act, 1951.

The Commission will be taking up for discussion the matter of timing of the bypolls at its meeting to be held on Friday.

Sources said that flood situation in Assam has deteriorated to an extent that has necessitated by the deaths of the sitting legislators, while in Tundla constituency in Uttar

Bihar, Tamil Nadu, Uttar Pradesh, Kerala and Madhya Pradesh where the bypolls were due, witnessed huge surge in the coronavirus infections, making it difficult for authorities to engage poll duties and conduct of election procedures.

The continuing coronavirus situation has cast a shadow on the upcoming Assembly polls in Bihar, widely considered the most important electoral event in the country this year.

Political parties had been calling for deferment of the polls in Bihar as many of the opposition leaders in the state have said that having elections during the outbreak will put the lives of people at risk. NDA ally Chirag Paswan also in favour of deferring the assembly polls in the state due to coronavirus infections that will be on peak during elections in November-December.

Apart from these seats, 24 seats in Madhya Pradesh are up for by-elections due to Scindia's rebellion. As per Section 151-A of the Representation of the People's Act, 1951, ECI will conduct by-polls to 22 seats by September 10.

# Israeli team working with DRDO to develop 30-second Covid test kit

New Delhi: In an effort to jointly combat the novel coronavirus, Israel Thursday said it will send to India on board a special flight a research team which has been working with the Indian side to develop a rapid testing kit for COVID-19 which can give a result within 30 seconds.

In the coming weeks, Israel's ministries of foreign affairs, defence and health will lead an unprecedented anti-COVID-19 cooperation operation between India and Israel, an Israel Embassy statement said.

A special planned flight from Tel Aviv to New Delhi is set to carry a high ranking Israeli defence ministry research and development team which has been working with India's chief scientist K VijayRaghavan and Defence Research and Development Organisation to develop rapid testing for COVID-19 in under 30 seconds, it said.

Merging Israeli technology with Indian development and production capabilities aims to allow a swift resumption of normal life alongside the virus, the Israeli Embassy said.



The flight will also bring breakthrough emerging Israeli technologies for combating COVID-19, which have been donated by Israel's foreign ministry and private sector meant to bolster India's response to the outbreak.

"Finally, the plane will deliver mechanical ventilators which were given special permission by the Government of Israel for export to India," the statement said.

The past few years have cemented the strategic relations between India and Israel and have included two historical visits of the prime ministers in Israel and in India, the Embassy said.

Since the outbreak of the global pandemic, Israeli Prime

Minister Benjamin Netanyahu and Prime Minister Narendra Modi have held three telephonic conversations in which they promised mutual assistance in dealing with the virus and committed to joint technological and scientific research between the countries, the statement said.

Noting that India is currently facing over one million COVID-19 positive cases, the Israeli side said India seeks to integrate advanced technologies in its hospitals as they prepare to treat massive waves of COVID-19 patients on an Indian scale.

The Israeli companies chosen by the three ministries to be sent to India are potentially given unique access to one of the largest economies in the world to provide monitoring and treatment technologies while significantly reducing contact between patients and medical staff, the statement said. PTI

# 1,078 more test positive in Kerala

For the second day in succession, Kerala diagnosed more than 1,000 persons afflicted with Covid-19. "Today also we have tested higher number of patients with covid-19. On Thursday, 1,078 persons were diagnosed with Covid pandemic. The disease claimed five lives across the State during the last 24 hours," said Chief Minister Pinarayi Vijayan in his media briefing on Thursday. On Wednesday, 1,038 persons were found to be affected with Covid-19.

Out of the 1,078 persons tested positive for Covid-19 on Thursday, 798 were infected through contacts, said Vijayan. He also said that Thiruvananthapuram (222), Kollam (106) and Ernakulam (100) were the districts which tested higher number of patients.

The State has 16,110 Covid patients. Hospitals in the State have 9,408 patients undergoing treatment for the pandemic. The day also saw 432 persons getting discharged from

the hospitals after they were found to be fully recovered.

The Chief Minister said that the Council of Ministers which met on Thursday morning had asked the Governor to cancel the one-day session of the Legislative Assembly called for next week. "This is because of the unusual situation prevailing in the State and also due to the advanced age of some members of the legislative assembly.

EP Jayarajan, the Minister for industries and the second-in-command to the Chief Minister who briefed the media after the cabinet meeting in the morning blamed the media for spreading fake and false news about the Covid-19 situation in the State.

"There are many Opposition leaders who want the Covid-19 patients in the State should increase. They don't want the pandemic to subside and are interested in making political gains through the sufferings of the poor people," said Jayarajan.

# Virus claims 88 lives in TN while 6,472 test +ve

Hopes of any kind of respite from the coronavirus pandemic remained elusive in Tamil Nadu as 88 persons succumbed to Covid-19 in the last 24 hours while 6,472 new persons tested positive on Thursday.

A release by the Government of Tamil Nadu said the number of active patients in the city reached 52,939 by Thursday evening while the total number of covid-19 cases diagnosed till date crossed the 1.92 lakh.

With Thursday's 88 death, the fatalities in the State reached 3,232. The only news that offered some relief was in the number of patients getting cured and discharged from hospitals-5,210.

What was Thursday's cause of concern was the hike in the number of persons diagnosed with the pandemic in Chennai and the three neighbouring districts. Despite the claims by the Government officials that the number of patients in Chennai were coming down, the Metropolis tested 1,336 Covid cases on Thursday. For the last one week, Chennai's new covid cases were contained in the 1100-1200 range.

Similarly, the neighbouring districts of Chengalpatt (375) Kancheepuram (330), Thiruvallur (416) showed steep hike in the number of patients tested on Thursday.

The southern districts of Virudhunagar (480) and Thoothukudi (415) too tested unprecedented number of positive cases. The pandemic has reached the doors of Raj Bhavan in Chennai. A release by the Raj Bhavan said 84 personnel (mainly security and fire fighting staff) posted in the premises tested positive for coronavirus. But the Governor has not come in contact with those who tested positive for the pandemic, said the release.

# Major reshuffle in TMC organisational posts

Within 48 hours of blowing the poll bugle Bengal Chief Minister Mamata Banerjee on Thursday effected a major reshuffle in the ruling Trinamool Congress by infusing a mix of experience, youth, clean image and loyalty at the organisational level.

North Bengal and Jangalmahal in south-western part of the State where the TMC fared miserably—conceding a large bulk of seats to an emerging BJP in 2019 General elections—have found special focus in the new scheme of things.

Much in the line of the BJP's "Marg Darshan Mandli" a good number of TMC old guards who were functioning as district presidents' have been "elevated" as 'chairpersons' of the respective district units—a new designation with unspecific political potency.

The rejig exercise was conducted via a virtual meeting of senior leaders from the State and district, sources said.

Among the young leaders are former India cricketer and Bengal captain, Laxmi Ratan Shukla the present Sports Minister of Bengal. He has been appointed the president of Howrah city president removing power-

ful leader and Minister Arup Roy.

MP and senior leader Sudip Bandopadhyay who have been elevated as the chairperson of the North Kolkata district committee has also been asked to continue as the party president of the district until a new appointee takes over.

While in South Kolkata Debashis Kumar continues to remain the party president Nadia finds a new district chief in vocal MP Mohua Moitra.

The BJP has come up in a big way in Nadia which like North Bengal and Jangalmahal has seen the entire former Left leadership switching over to the saffron ranks.

In North Bengal, prominent civil society member and former MP Arpita Ghosh has been removed as the president of South Dinajpur district which went into the hands of BJP in the parliamentary elections.

Further north Coochbehar has seen a new face in Partho Pratim Mitra replacing seasoned leader and Minister Rabindra Nath Ghosh as the district president. Similarly Shyamal Santra, Swapna Debnath and Jiten Tewari have been made the district presidents of Bankura, East and West Burdwan districts while Ajit Maity has been given the charge in West Midnapore.

# 718 afflicted in J&K on Thurs

**Jammu:** The Union Territory of Jammu & Kashmir Thursday reported 718 positive cases of coronavirus while nine more patients died taking the total tally of cases to 16,429.

Out of these 718 cases, 98 were travelers while 620 cases were reported from different districts of J&K. Significantly, three districts of Srinagar, Kulgam and Shopian reported 158, 106 and 109 cases respectively.

According to the media bulletin, "the fresh cases include 117 from Jammu division and 601 from Kashmir. According to official sources at least 50 CRPF personnel tested positive before joining their duties.

In Jammu division, Jammu district reported 47 fresh cases followed by Ramban from where 20 patients tested positive while Rajouri district reported 15 cases.

# Crucial time for Vijayan as NIA begins questioning ex-Secy

The National Investigating Agency, probing the gold smuggling through diplomatic route in Thiruvananthapuram airport, on Thursday started questioning M Sivsankar, the suspended principal secretary of Chief Minister Pinarayi Vijayan.

Sivsankar reached the Police Club in capital city where a team of NIA sleuths were waiting for him. The session between the IAS officer and the NIA officials were progressing even at the time of going to Press.

It is after ten days of meticulous planning that the NIA team summoned Sivsankar. Last week saw Sivsankar, an official close to Vijayan being subjected to a marathon grilling by the Customs

officials at Thiruvananthapuram which lasted for more than nine hours.

The NIA had interrogated Sarith, Swapna Suresh and Sandeep Nair for many days before they took the decision to summon Sivsankar. Though the Customs and NIA officials remained incommunicado till date about the entire case, it is reported that they got valuable information linking the IAS officer with the trio in the smuggling operation.

The day began with news that Mohammed Yousuf, the Commissioner of Customs, issued an order transferring six superintendents and two inspectors probing the case.

Within minutes news channels aired the news that a cartel of businessmen from Muvattupuzha in Ernakulam district had smuggled 1,500 kg of gold using diplomatic immunity during the last three years. This is being seen as the shadow boxing happening in the Customs House between senior officials.

The Enforcement Directorate too pitched in with their share and registered the arrest of Sarith, Swapna and Sandeep in connection with the gold smuggling, making it the third agency probing the case. Meanwhile the Customs Department has approached the special court in Kochi to slap COFEPOSA charges on the three accused which, if approved would make it difficult for them to get bail for the next one year.

# Bengal Police takes stern action against lockdown violators

With apparent evidence that the Government meant business in implementing the "broken lockdown" the Bengal Police on Thursday ensured a complete closure of the State arresting about 650 people from various parts of Kolkata for breaking the lockdown protocols.

Bengal entered into a second phase of lockdown which will entail twice-a-week closure of business and offices save essential services. State will remain closed on Saturday too in this week. In the next week Wednesday will be a lockdown day.

The police were seen caning people who had aimlessly ventured out of their houses not only in Kolkata but in districts also. People were either sent back home or cases were registered against them before they were taken into custody. About 350 people were penalized for not wearing or "half-wearing" masks, sources said.

Apart from reinstating twice-a-week lockdown the Government has been continuing with lockdown in extended containment zones. This apart, full one-week lockdown has been declared in a number of municipalities like Barasat, Bongaon, Baduria, Barrackpore, Baranagar in North 24 Pargana district which is second to Kolkata in terms of severity of infections.

# Pak Army shells areas along LoC in Baramulla

The Pakistan Army on Thursday activated several sectors along the line of control (LoC) in Jammu & Kashmir and targeted civilian pockets in Poonch and Naugam sector of Baramulla district.

In response, the Indian Army hit back strongly and gave them a befitting reply.

Official sources on ground zero claimed, "for the last couple of days the Pakistan Army is aiming at upping the ante and desperately trying to push small batches of infiltrators inside the Indian territory". These sources claimed, "the handlers of various terror outfits sitting across the LoC are desperate to send fresh batches of terrorists to execute their sinister plot of targeting security forces and vital installations during the first anniversary of Abrogation of Article 370 and reorganisation of the erstwhile state of Jammu & Kashmir on August 5".

To foil their nefarious designs the foot-

diaries of the Indian army are maintaining a tight vigil.

Official sources said, "In the Poonch sector, the Pakistan Army is repeatedly targeting several civilian pockets to disturb peace in the region and trigger unrest among the local population". Five civilians have lost their lives in two recent incidents of ceasefire violations in Poonch.

"The Pakistan army is also attempting to push small groups of infiltrators via traditional routes of infiltration in Poonch sector", claimed sources on ground zero. The Pakistan army provides cover firing to these infiltrators to divert attention of the alert Indian soldiers.

Ministry of Defence spokesman in Jammu, Lt-Col Devender Anand said on Thursday, "two incidents of 'unprovoked' ceasefire violations were reported across Poonch district". He said the first violation was reported around 11.00 a.m in Qasba, Kirni sector and the second violation was reported in the evening around 5.15 p.m in Balakote sector.

# Bihar Govt starts 'Sahkaari Se Tarkaari Vaarta' initiative

In an unique initiative and perhaps the first of its kind in the country, the Bihar Government has started a direct connect with the vegetable growers and people involved in farming of vegetables only.

The movement titled 'Sahkaari Se Tarkaari Vaarta' movement has been designed to facilitate the vegetable cooperative unions and federation to regularly monitor the pulse of the farming community and to provide the farmer members a much-needed opportunity to voice their concerns related to vegetable production, pricing and supply chain.

Though the Covid-19 has limited the operation, the Department has not lost the zeal, feel and the essence of the Cooperative system," said the 2013 batch IAS of Bihar cadre.

# Maha: 298 die, 9,895 +ve

Maharashtra recorded the highest-ever 298 coronavirus deaths on Thursday, even as many as 9,895 more people tested positive in various parts of the State.

With 298 fresh deaths, the state surpassed its earlier record of 295 deaths recorded on July 4. With Thursday's fatality tally, the total number of deaths mounted to 12,854.

With the 9895 positive cases reported on Thursday, the total number of cases inched closer 3.5 lakh mark to touch 3,47,502. Of the 298 deaths, Pune accounted for 78 deaths, while Mumbai recorded 55 deaths.

Apart from 78 deaths reported in Pune and 55 deaths in Mumbai, there were 47 deaths in Thane, 25 deaths in Palghar, 15 in Nashik, 14 in Jalgaon, 10 in Aurangabad, 6 in Latur, 5 in Sangli, 4 each in Kolhapur, Nanded and Hingoli,

3 each in Raigad, Solapur, Beed and Jalna, 2 each in Dhule, Ratnagiri, Amravati and Yavatmal and one death each in Ahmednagar, Satara, Parbhani, Osmanabad, Akola and Nagpur. In addition, six persons from other states died in Maharashtra.

With fresh fatalities and infections in Mumbai, the total number of deaths in Mumbai rose from 5,875 to 5,930, while the total number of infected cases rose by 1,245 to touch 105,923.

With 81708 infected cases and 2193 deaths, Thane continued to be the second worst hit district in Maharashtra.

Pune, which has emerged as the third worst affected district in terms of spread of the pandemic, has recorded 66538 infections and 1592 deaths till now.

## This round to Pilot

SC says disqualification can't be based on dissent, asks why Speaker approached court when he should be neutral



Rajasthan Chief Minister Ashok Gehlot may have been a tad too offensive in seeking the court's intervention to deter his one-time deputy Sachin Pilot from challenging the disqualification notice sent to him and his loyalist MLAs under the anti-defection law. But the Supreme Court firmly underlined what democracy is, the kind Gehlot has been claiming to defend, and what constitutional processes are. "Assume a leader has lost the faith of persons. While remaining in the party, they cannot be disqualified. Then this will become a tool and no one can raise their voice. The voice of dissent in a democracy cannot be suppressed like this," said Justice AK Mishra as the top court refused to stop a High Court verdict on a petition by 19 rebel Congress MLAs, challenging their disqualification notices. Clearly, the court laid down the thin line between the democratic right to dissent, that is healthy for building participatory dialogue and one which deserves a listen, and an ego-driven revolt. And it went with Pilot's defence that the notices were an attempt to curb "freedom of speech." For the last few days, the Pilot camp has been challenging the showcase saying the House was not in session and they hadn't done or said anything to indicate they were parting ways with the Congress. Both Gehlot and Pilot camps have been seeking refuge in the interpretation of clause 2(1)(a) of the 10th Schedule of the Constitution. Going by the several Supreme Court judgments in the matter, it could be said that any anti-party activity was tantamount to voluntarily giving up the membership of the party. Gehlot has been building evidence of Pilot's breakaway moves since, like parading MLAs claiming bribery offers and releasing alleged tapes of senior BJP leaders coaxing rebels, to justify this argument. But Team Pilot argues that the clause cannot be overstretched to disallow the right to express one's opinion. Rajasthan Speaker CP Joshi, who served the notices last week, had argued that the rebels cannot petition the High Court before he took action. And that as a constitutional authority, he had the right to do so even when the House was not in session as the rebels had skipped two meetings of the legislature party. In fact, anticipating an adverse verdict, Joshi moved the Supreme Court even before the High Court could declare its ruling on the Pilot camp's plea. The Supreme Court even took note of this impatience to latch on to power. The court asked, "it is the matter of just one day. Why can't you wait?" And reminding the Speaker of his constitutional role, the judges asked why he, as a neutral person, should approach the court at all in a pre-emptive manner or appear partisan? The Supreme Court can anyway hear appeals against High Court rulings but why did the Speaker assume that the latter would be favourable to the rebels? This presumptive tactic might just impact all the other moves of Gehlot. So far, in a bid to save his Government, he has been aggressively taking on the BJP for another version of "Operation Lotus" and poaching a discontented and maladjusted Pilot. He even wrote to Prime Minister Narendra Modi, alleging the BJP's attempts to dislodge his Government, naming Union Minister Gajendra Singh Shekhawat and making Modi himself complicit in the goings-on in his party. But his adventurism on the rule of law has betrayed the maturity and astuteness with which he acted before the BJP could move in, herding legislators, furnishing numbers to the Governor and gathering evidence against Pilot. Getting the Speaker to defend the disqualification notices has clearly backfired and exposed his anxieties. Gehlot claims he has 106 MLAs on his side, still a narrow lead in a 200-member Assembly. If the High Court disqualifies Pilot and his 18 MLAs, the majority mark of 101 will come down and Gehlot will be safely home. If not, the rebel MLAs can vote against his Government and narrow the margins.

As Gehlot continues to prepare a back-up plan and publicly deride Pilot, it would have been better if he had accommodated him as shrewdly and continued his chief ministership. Now, it looks like he is the one impatient instead of Pilot. The younger Congressman and once an acolyte of the Gandhi scions cannot look back either as he has waded deep into the contest. He is drawing political sustenance from the grassroots where he has worked for the last six years or so. The Gujjars of three States — Rajasthan, Haryana and Uttar Pradesh — have amassed behind him just like they did for his father Rajesh Pilot. This means a sizeable votebank that could make Pilot attractive to the BJP. The fact that he changed his plea in the High Court and made the Centre a party to it is some indication that he will gravitate to the other polarity. That's the sad part, the assumption that Congress' breakaways, most of them talented with fresh ideas, will do better in the BJP than in the party that they had volunteered for. The example of Himanta Biswa Sarma in the Northeast shows that the BJP is consolidating with ex-Congress talent. Old Congresswallahs may say the young are pesky and impatient but the crossovers have meant that the Congress has lost Goa, Manipur, Uttarakhand, Arunachal, Madhya Pradesh and Karnataka. Is Gehlot's ego turf worth it?

## The Rafale arrives

India's long tradition of French fighter jets continues. The game-changer aircraft will boost our capabilities



In 1953, newly independent and democratic India placed a large order for fighter jets. The contract didn't go to the British. Instead, India ordered 70 Dassault Ouragan aircraft from France and a strange love affair developed between Indian fighter jocks and French jets. Over 140 Ouragans served the Indian Air Force (IAF) before they were replaced by Dassault Mystere IV aircraft of which India operated over 100. The latter distinguished itself admirably in the 1965 war with our unfriendly western neighbour. While India did not operate the legendary Dassault Mirage III and Mirage 5, which acquitted themselves with distinction over the skies of the Sinai peninsula during the two Arab-Israeli conflicts, we did order a small number of the Mirage 2000 aircraft. It quickly became a frontline fighter for us and played a critical role during the Kargil war. It even delivered the weaponry that destroyed a terrorist hideout in Balakot early last year. And now, India will start receiving the next generation of French fighting prowess, the Rafale.

The Rafale is a dramatic step up for the IAF. With its supreme weaponry and electronic warfare capabilities, it is far superior to anything that either of the troublesome twosome on India's eastern and western border have. It is an expensive plane and an initial planned order for 126 aircraft has been peeled back to 36. It is but certain that a follow-up order will be placed soon. However, India would do well to remember the acquisition problems it has faced in the past. With the Mirage 2000 and the Boeing C-17 Globemaster, a heavy lift logistics aircraft, India dithered with making its follow-up orders. Both aircraft had seen their production lines closed and India was left twiddling its thumbs. We cannot afford to vacillate like this with acquisitions again as the previous UPA administration hesitated for years over military hardware acquisition. As a result, it left gaping holes in India's security apparatus, which are only being patched up today. The Rafale is a great new addition to the IAF and will give India an edge both in weapons delivery and air-to-air combat. But they cannot come fast enough. However, India must not give in to knee-jerk reactions. Instead, we must plan out a thorough acquisition strategy with more domestic manufacturing, which will not only help the local economy but also develop India's military-industrial potential. The events of the past few months have taught us that we cannot trust the Chinese, particularly its President. We have to be prepared for the worst. The Rafales will help.

# opinion Farewell, my Queen

The Boeing 747 is being withdrawn from passenger service. It changed aircraft design, made flying affordable and pushed airports to improve their facilities

The British Airways' announcement that it is going to retire its fleet of Boeing 747s from commercial passenger services hit many aviation fans pretty hard. I have probably flown more passenger miles in the British Airways' 747 aircraft than on any other airline. In the past few months, two other iconic operators of the Boeing 747, Australian airline Qantas and Dutch airline KLM, also announced that they flew their last jumbo flights. In the last couple of years — thanks to the emergence of more point-to-point flying, higher frequency and the sheer efficiency of modern twin-jet aircraft like the Boeing 787 and Airbus A350 — more and more 747s are being retired across the world. Air India withdrew the jumbo flights operations a couple of years ago but has been using it for some Haj and Ummah-related duties. Most other American, Asian and European operators have retired the plane from service. However, there are exceptions like Air China, Lufthansa and Korean Air, which operate the newer 747-8 variant, and a couple of other airlines such as Thai Airways that operates the older 747-400. In fact, my last 747 flight was unexpectedly on the Thai Airways from New Delhi to Bangkok and back last year in October.

The global aviation industry is in a meltdown after the Wuhan virus laid waste to the global economy. Global aviation was a primary vector in the spread of the virus and many nations sealed their land borders. Others like India banned all flight operations though limited repatriation flights are still being carried out.

Many airlines have read the writing on the wall and they understand that even if a solution, such as a vaccine to this accursed pestilence is found, traffic will not recover for months, may be even years. The Boeing 747 is too large an aircraft for reduced traffic. This means higher operating costs. As for Airbus A380, airlines are quickly retiring these aircraft, too. Air France, the airline of the nation where the A380 is put together, just retired all of its Airbus A380 fleet, the youngest being a decade-old. Airlines will tell you that it is cheaper to fly two Boeing 787 Dreamliners than a single 747 or Airbus A380.

While cargo variants of the 747 are still flying in great numbers, both those built at the Boeing factory outside Seattle, Washington, and those planes converted from passenger operations to freight, have halted operations. After all, the 747 was initially conceived as a cargo plane and the iconic "hump" on the air-



craft was there to allow the nose to be lifted up for the cargo to be loaded. Cargo operations with the 747 are likely to continue for many, many years because there is no direct replacement for it. In fact, most international air cargo operators still follow a "hub and spoke" model for cargo travelling between major airports.

The last convoy carrying fuselage and wing sections of the A380 has reached the final assembly line in Toulouse and the aircraft will be completed in a couple of months. Even then, the single largest operator of the A380 aircraft, the Dubai-based Emirates Airline, is retiring its oldest twin-deck behemoths. But it is ironic that the Boeing 747, which undertook its maiden flight in 1969, would have significantly outlived the Airbus A380, a plane built with typical European arrogance to one-up the US. The A380 is undoubtedly an amazing engineering and technological achievement unlike the Boeing plane, but is an unmitigated commercial disaster.

The Airbus A380 line will close soon as the last nine planes are prepared for delivery. In the 15 years since the factory opened its doors, a mere 251 entered commercial service. Boeing is expected to close its 747 lines in 2022, with 16 aircraft (all cargo variants) remaining to be delivered. Around 1,558 planes have already been delivered since 1970. And while the current options such as the 747-8 have lit-

tle in common with the earliest model — 100 and 200 variants — just one look, and you know that it is 747. I think (I do not believe that I am alone here) this is the single most important reason that the 747 is seared into our memories; it looked unique when it was first flown and it still does with the hump at the front and its sharply swept wings.

There was an aesthetic beauty in the 747, which the A380 simply does not have. The latter is functional but not pretty. Truth be told, I rarely got to fly in 747s of late, the move to withdraw it from service across the world having begun in the early 2010s. Of course, those two flights to Thailand were a pleasant surprise, a couple of British Airways flights across the "pond" stuck in a middle seat less enjoyable. But I did experience that ultimate joy of an aviation fan. I have flown on the upper deck of a 747, which is one of the single most fun things one can do.

The last time I did that was on a British Airways evening service from Chicago O'Hare to London Heathrow. As far as my memory goes, I think I just slept throughout that flight. I never knew it was going to be the last time. Even as global air travel boomed during the past decade, a lot of that was due to the rise of low-cost airlines, hopping and skipping around the world with their gigantic fleets of Airbus A320 and Boeing 737 aircraft.

While it will be interesting to

see what happens to these airlines, even Indian ones, in the aftermath of the Chinese contagion, international air travel, too, has changed. In no small part, thanks to the emergence of more point-to-point flying and ultra-long-haul flights.

A decade ago, a non-stop flight to and fro from India to the US was just about possible with a load of penalties. Today's Boeing 777 and 787s and Airbus' A350 can make the crossing with a full load in just 16 hours. Imagine travelling from New Delhi to San Francisco in the 1970s and 1980s when the 747 had just begun service. An Air India or Pan American 747 would have taken you to New York's JFK after stopping at least two-three times. You would have to change planes at JFK and then make the cross-country hop across the US, may be with another stop or two. Travel time with stop-overs may have been around two days.

Before the pandemic started, both Air India and United Airlines had non-stop services between the two cities, 15 hours from take-off to touchdown. Sure, that might seem like a lot of time without any "fresh air" but there was no need to walk bleary-eyed with screaming children across a strange airport, dealing with security and waiting for hours through weather delays and the risk of lost baggage, thanks to the multiple connections. But without the Boeing

747, none of this would have happened. The 747 made large-scale international commercial travel viable; it democratised travel in a way that was previously unimaginable. It is because of the Boeing 747 that there was a huge wave of migration of engineers and doctors out of India in the 1970s and 1980s.

The 747 made flying affordable; it made global airports improve their facilities, jetbridges that connect planes to the terminal became a standard feature at airports as did massive automated baggage handling. Airports built bigger runways and larger infrastructure to cater to the masses that a single jumbo jet brought in. The 747 changed aircraft design; the high-bypass turbofan engines developed for it transformed aviation. It led to the development of the trijets Douglas DC-10 and Lockheed L-1011 Tristar by rival companies.

It is the development of the high bypass turbofan, which literally sips fuel compared to older engines, that led to the creation of all modern planes such as the Boeing 777, which has the largest engine in commercial service. The 747 was the "Queen" and the world of aviation comprised its subjects. Even though fewer and fewer 747s remain in the skies ferrying passengers, the legacy of the Boeing 747 is one that will continue for a long time to come.

### Oxford vaccine promising but let's be real

With 15 million cases and six lakh deaths globally, biomedical companies are under tremendous pressure to deliver a safe and effective vaccine for Coronavirus. While the outbreak is peaking by the day, a silver lining on the horizon is also flashing. A new vaccine development technology — RNA vaccine, also known as mRNA — is emerging as the front-runner to alleviate mankind's COVID-19-inflicted miseries. The three leading vaccines by Oxford — AstraZeneca, Pfizer-BioNTech and Moderna — are mRNA based and are also in the final phase of trials. The technology, capable of faster rollout at affordable prices, is versatile and promising. It is known to produce safe and long-lasting immune response in addition to better management of a class of white blood cells called T-cells. White cells, as we all know, help the body get rid of infected cells. That two dozen of the 150 vaccinations are mRNA driven is not surprising. All the three front-running vaccines score high on "dual immune response" comprising antibodies and T-cells.

Though some euphoria is justified, yet we must understand that vaccine development is a lengthy and painful process. Even the vast amount of data from clin-

ical trials is unable to justify the hypothesis the biomedical community has set out to prove. The durability of the regenerated T-cells together are concern areas. The universal safety of vaccines across age groups remains worrisome as representation of the vulnerable groups in the clinical trials is said to be limited. While the need for a safe and effective vaccine is a given, expediency cannot override quality. Being optimistic is good but being one with caution is better.

## India can exit fiscal tight spot

Prime Minister Narendra Modi and top Cabinet Ministers have spent the last fortnight talking to numerous stakeholders and potential investors across the globe and at various fora, trying to convince them that India has lifted the shutters and is ready for business. Nitin Gadkari, Union Minister for Road Transport & Highways and MSMEs, has talked about potential opportunities for investors on the Delhi-Mumbai, Delhi-Meerut highway corridors, the linked and now commercially-available waterways and has gone on record to promise daily, weekly and monthly returns from investments in India's infrastructure. Similarly, Minister of Communications, Electronics and Information Technology Ravi Shankar Prasad has announced an ambitious production-linked incentive scheme for large-scale electronics manufacturing firms, with potential financial incentives and sharp focus on high-value, globally-produced components of mobile phones and air conditioners.

Modi himself, at multiple fora and one-on-one conversations with top CEOs, has made a strong pitch for refuelling India with upgraded, long-term investments for a brighter future for enterprises and the global world order. Much of this effort has been made to keep the money coming in for Finance Minister Nirmala Sitharaman, who has been trying to find alternate sources of revenue during one of the biggest economic slowdowns India has seen in recent memory and to ensure that the State fulfils its commitment of providing basic amenities like food and medical care to a large section of the population. These efforts are the need of the hour for India, which is faced with the dual challenges of a raging pandemic and military/economic ambush from an aggressive neighbour, China. And there is still a large track left to be covered to become a larger than \$5 trillion economy in a very short period.

So, what can be done? To begin with, GDP growth and the economy have to be treated and run like a corporate house, hungry and lean. Some may argue that it could lead to overlooking the welfare of a vast majority of the population. In a democracy, this could lead to uncomfortable questions in Parliament at a time when elections in some States are around the corner. While I won't comment on the latter part of the argument regarding the politics behind stalling growth projects, the fact remains that there are many enterprises and cooperatives around the world where sustainable development of employees has gone hand in hand with healthy business growth.

To take an example, the Government has access to a vast amount of cash. It can very well enter into minority shareholding or profit-sharing arrangements with private fund managers and sovereign wealth creators, who can be tasked with bringing in high-value returns in a relatively short span of time. Of course, the challenge would be to put the perfect agreement papers in place, as too tight controls on managerial capacity could lead to efficient fund managers losing interest. On the other hand, too less control and the Government could be pulled up for corruption and collusion with wrong parties.

Second, the Government can again, by strategic choice, pick up a bunch of real estate and infrastructure projects stalled across the country due to lack of funds or slowing demand (even before the COVID-19 crisis began). The Government's track record of taking up construction has been much below market standards but it can make a fresh start by bringing world-class builders and infrastructure specialists on board. A leading example of bringing efficiency by smart partnering and teamwork is Delhi Metro, where both the Central and State Governments have an equal ownership but the money to build the 489-kilometre suburban railway network has come from Japan. The corporation thus formed runs with 10 nominees from the State and Central Government and eight (including the Managing Director) full-time Directors. What it ensures is equal say for most stakeholders and also brings the necessary momentum behind the wheels to tunnel through the toughest and most congested lanes of Delhi.

In a similar approach, Smart City, a pet project of the Government that is in tune with Digital India, can be broken into smaller self-sustaining, futuristic enterprises with an independent Board of Directors, equal nominees from the Union and State Government-concerned and a full time professional CEO (with a competitive salary to begin with). This team of approximately 20 people will have the task of converting an available chunk of land and its civic amenities into a global, high-tech piece of excellence, while empowered to raise funds for itself.

Modi has often been praised for his respect for the bureaucracy and bringing in the right talent for implementing projects on a mission mode. If he and his talented team put their mind to converting Smart City projects into globally-marketed profitable ventures in a relatively short span of time, it could be a game changer. It could help the country to come out of the current economic crisis and turn it into one of the biggest opportunities for the nation. (The writer is a policy analyst)

# FDI through front door

The Govt must allow 100 per cent FDI in retail as this will level the playing field for all, eliminate discretion of bureaucrats whose writ is all-pervasive and help small traders

On April 22, the California-based US internet giant, Facebook, announced its decision to buy 9.99 per cent stake in Jio Platforms Limited (JPL) paying more than ₹43,450 crore. JPL is a 100 per cent subsidiary of Reliance Industries Limited (RIL) and has in its fold a wide spectrum of businesses such as wireless broadband, home broadband, enterprise broadband, narrowband, internet-of-things businesses, a bouquet of digital applications, e-commerce and so on.

This was followed by a flurry of investments with big names such as General Atlantic, Silver Lake, Qualcomm, Intel, Vista, Google and so on, bringing in cumulative investment of over ₹1,00,000 crore, taking the total to ₹1,50,000 crore. In lieu of this capital, they get aggregate shareholding of 30 per cent or ₹5,000 crore for every one per cent, thus valuing the company at a whopping ₹5,00,000 crore.

Even as foreign investors see value in every segment of the business on this platform, at the centre stage is e-commerce, which is being powered by JioMart commerce platform — a unit of JPL. In fact, Facebook has come in primarily with an eye on tapping opportunities in this area and signed a comprehensive agreement with JPL to exploit synergies between the two conglomerates.

The duo intend to offer technology-enabled wherewithal to enable consumers access neighbourhood stores and have products delivered at their doorsteps. About 30 million of these stores will be empowered to digitally transact with every customer in their neighbourhood (over 400 million-strong Indian database of WhatsApp — a 100 per cent subsidiary of Facebook — will come in handy). JioMoney — RIL's payment platform — will be integrated into the JioMart venture to facilitate hassle-free seamless payment for transactions. The model operated by Reliance under JioMart is a combination of online and offline retail. Apart from Reliance Retail Limited (RRL), which has thousands of retail stores spread all over India and gets hooked on to the Jio platform, it will be serving tens of millions of neighbourhood stores in a variety of ways viz. handling, procurement, storage, payment, delivery and so on. Since all of this will be powered by a digital eco-system, the model is a hybrid of online and offline.

Two things are abundantly clear: Reliance Industries is deeply entrenched in Indian retail — already through RRL and now increasing its footprint exponentially through the Jio Platform. It is getting a massive injection of Foreign Direct Investment (FDI), with Facebook alone having pumped ₹43,450 crore into JioMart. But this is out of sync with the extant policy in regard to FDI in retail. For the purpose of FDI, unlike the international practice where retail is treated as a single homogenous sector without any distinction, the Indian Government has divided retail into several classes. In India, we have Single-Brand Retail (SBR) and Multi-Brand Retail (MBR) and there are sub-categories within each. Here, we deal with MBR or retail — as it is known in common parlance.

Within MBR, there is the "physical" format or offline, which takes two forms: The euphoric mom-and-pop stores, also nicknamed neighbourhood stores, and organised retail. Then, we have the online format, which has two sub-categories, the marketplace model and the inventory-based model.

In the physical format, as per a policy approved by the then UPA dispensation in 2012, as much as 51 per cent FDI is allowed but with a plethora of riders such as 30 per cent local sourcing, minimum investment of \$100 million and prior approval of the State where the retail shop is to be set up. In 2016-

17, an unprecedented 100 per cent FDI in food retail was allowed, subject to the foreign retailer selling items which are sourced only from Indian farmers and processed locally. Besides, 25 per cent of investment should be in agri-infrastructure like irrigation, farm machinery/implements and so on. In the online format, as per guidelines issued in early 2016, (Press Note 3) 100 per cent FDI is allowed under the so-called marketplace model. The marketplace is a platform where vendors sell their products to consumers even as its owner merely acts as a facilitator. The marketplace owner provides services such as booking orders, raising invoices, arranging delivery, accepting payments, handling rejections, warehousing and so on. But, s/he can't hold inventory and undertake direct selling.

The permission for 100 per cent FDI in the marketplace is subject to two main riders, that is "the entity cannot permit more than 25 per cent of total sales on its platform from one vendor or its group companies. Further, it can't directly or indirectly influence the sale price." Sans any specification as to "who the vendor is", a firm linked to the marketplace (either its subsidiary or a Joint Venture with an Indian company) is eligible.

Thus, contrary to the real intent of the policy, which disallowed the marketplace owner from direct selling to individual consumers, the fine print permitted them to do so — albeit by its subsidiary or JV. This is precisely what e-commerce majors such as Amazon and Flipkart/Walmart have been doing even though they came in as marketplace operators. They are operating as direct sellers, controlling inventory, giving discounts and so on.

A clarification to Press Note 3 issued on December 26, 2018 has not materially altered the position on ground zero. It says "the owner of the marketplace or its subsidiary or its JV with Indian compa-

ny can't have ownership of the seller." Further, "a seller/firm on the platform can't source more than 25 per cent of its inventory from a firm connected with the latter." The marketplace owner can get around both. First, by having less than 50 per cent shareholding in the seller firm and argue, he has no control (albeit majority) over the latter and second through the wholesale arm continuing supplies to the seller but within the 25 per cent threshold.

The clarification has not deterred their hold over Indian retail; they are dominant sellers themselves, giving little space to millions of small vendors for whose benefit this unique policy dispensation of the marketplace was designed. Disingenuous bureaucrats allowed them to do so by crafting policy architecture to suit them.

The small vendors, through their umbrella organisations such as All India Online Vendors Association (AIOVA), Retailers Association of India (RAI), Delhi Vyapar Mahasangh (DVM) and so on, have petitioned judicial authorities at various levels seeking action against Amazon/Flipkart for violation of FDI norms and indulging in unfair practices but have not got any relief. The sole reason is that the courts go by the fine print which suits these giants.

Unlike the marketplaces of foreign e-commerce majors, JioMart commerce platform floated by RIL holds the potential of giving a boost to the small vendors, but even this may not gel with the extant policy framework. Even as the main thrust of the policy is on "complete prohibition of FDI in direct selling to individual consumers", JioMart, which is deeply entrenched in direct sales, has received investment from Facebook — a foreign company.

Like Amazon et al, Reliance/Facebook may get around by citing that foreign shareholding in the seller firm is less than 50 per cent or a wholesaler linked to

JioMart owner Reliance/Facebook will keep its supplies to the vendor within the 25 per cent threshold. Or they may carve out a separate entity entirely for food retail where 100 per cent FDI is allowed. This way, the two would be able to demonstrate that they are not violating the rule book. But this is not the way to go.

Looking at what is happening on ground zero, it is abundantly clear that the Modi Government has no objection to permitting FDI in online retail and even in offline retail (albeit without any riders) as amply demonstrated by the treatment meted out to Amazon/Flipkart earlier and now to Facebook riding piggyback on RIL. If that be so, then why allow it to happen in a vague and convoluted manner? Why should the policy not be clear-cut and transparent? Why should FDI not be allowed through the front door?

The Government should shun the marketplace model. It should allow 100 per cent FDI in retail in both online and offline without any riders (the special categories such as 100 per cent FDI in food retail should go). This will level the playing field for all, online vs offline, food retail vs non-food, marketplace vs inventory and so on and eliminate discretion of bureaucrats whose writ is all-pervasive when it comes to grant of approvals.

It will help small traders by leading to all-round development of infrastructure and offering a wide range of choice for sourcing products. They can and will co-exist with big players — both foreign and Indian. It will be pro-consumer in the long-run with many players catering to their needs at competitive/affordable price. Sans these policy changes, under business as usual scenario, the consumers will pay a heavy price in the medium to long-term as Indian retail will be cartelised by a few players viz. Amazon, Walmart and Facebook/RIL.

## A flood of urban woes during the rains

Traffic snarls, waterlogging and the loss of lives show that a manageable issue has been allowed to deteriorate

might be, every passing year they bring in their wake the ever-growing problem of urban flooding.

This has been experienced for decades in India but sufficient attention has not been given to specific efforts to deal with it. In the past, any strategy on flood disaster management largely focussed on riverine floods affecting large extents of rural areas. Urban flooding is significantly different from rural flooding as urbanisation leads to developed catchments and in the event of heavy/high intensity rainfall, there is higher run-off, which increases the flood peaks from 1.8 to eight times and flood volumes up to six times. Consequently, flooding occurs very quickly due to faster flow times, sometimes in a matter of minutes.

The recent death of a mini-truck driver after his vehicle got submerged under the Minto Bridge after a spell of rain in Central Delhi underlines the growing threat of urban flooding. While most of the time urban India patiently endures huge volumes of



flooding and the resultant traffic snarls, when people start losing lives, it is time for the citizens and the authorities to consider the problem seriously and deal with it effectively. Though large cities like Mumbai, Delhi and Chennai go through urban flooding annually, the recurrence of the problem suggests that no lessons are learnt and no infrastructure is built or improved to prevent it. Just a few hours of hard rain in metropolitan cities can present a very embarrassing spectacle as daily life is thrown out of gear and the cities become unwitting

examples for the developed world to learn from. Another concerning aspect is that urban flooding increases the chances of contagious diseases like typhoid, cholera, leptospirosis, hepatitis and even COVID-19 spreading far more easily. For instance, floodwaters in Assam spread discarded medical waste and used PPE from hospitals and COVID-19 care centres, raising fears of infection among people in inundated areas.

One of the major reasons for urban waterlogging are the archaic sewer systems in our cities that are heavily choked with silt and garbage. Indian metros not only need regular cleaning of sewers and storm water drains, particularly before the onset of the rainy season, they also require an advanced system that is based on the latest technology and satellite data that can calculate the quantities of water run-off every monsoon and accordingly estimate the load factor on the sewerage and storm water system.

Another reason for flooding of cities is excessive concretisation and

paved areas in the urban landscape. This has not only resulted in exacerbating the heat island effect and causing a sharp spike in ambient temperatures but preventing rainwater absorption into the ground and recharging of the water table. This, too, increases the rainwater run-off, putting undue pressure on the drainage network.

The efforts to prevent urban flooding will be incomplete unless the ground water absorption rate of rainwater as compared to the run-off rate is balanced. Another issue pertaining to urban flooding is the role played by illegal construction and how it is impacting the storm water drainage system across India's major cities. As urban sprawls increase rapidly, unauthorised construction and unplanned digging by civic agencies are becoming two major issues that are further impacting our already overburdened drainage systems adversely. Flooding will continue to trouble urban citizens unless these impediments are addressed and removed.

We often marvel at infrastructure planning of ancient India, especially the drainage system of the Mohenjo-Daro and Harappa cultures that date back to 2400 BC. Sadly we are unable to replicate the excellence and success of the bygone era in today's time. Urban flooding is avoidable and in order to ensure safety of lives and property, it is essential for the Government to rapidly develop strategies that draw from the best of the world's benchmarking practices in urban rainwater management. We need city-wise protocols that cater to the typicality of the demographics and geography and automatically kick in when the area receives a certain quantum of rainfall.

Traffic snarls, waterlogging and the loss of lives due to urban flooding are a painful indication that a manageable issue has been allowed to deteriorate and get out of hand. It is time authorities around the country wake up.

# Closure of more Chinese missions possible: Trump

The US does not rule out the possibility of closing more Chinese diplomatic missions in the country, President Donald Trump has said, hours after Washington ordered the closure of Beijing's consulate in Houston to "protect American intellectual property and private information."

The US move came amid a growing number of disputes between the two countries over Beijing's increasingly aggressive actions that have led Washington to take strong actions, including closing the consulate in Houston, according to senior Trump administration officials.

The consulate in Houston, Texas, is one of five Chinese diplomatic missions in the US, not counting the embassy in Washington DC.

The US move came after the Justice Department said that hackers working with the

## Biden, Obama pair in socially distanced video to decry Trump

Democratic presidential candidate Joe Biden and former President Barack Obama stepped up their attacks on President Donald Trump and defended their time in the White House in a new video showing their first in-person meeting since the coronavirus outbreak began.

The 15-minute video, posted online Thursday, is the latest maneuver to get the former president involved in the 2020 campaign for his former vice president, as Biden tries to rebuild Obama's winning coalition in November.

The former president and vice president used the interview-style conversation to amplify Biden's arguments against Trump, with Obama emphasizing Biden's experience and personal attributes. They pointed to their administration's signature health care law and blamed Trump for stoking division and animosity among Americans from the moment he entered the 2016 presidential race.

Chinese Government targeted firms developing vaccines for the coronavirus and stole hundreds of millions of dollars worth of intellectual property and trade secrets from companies across the world.

"As far as closing additional embassies, it's always possible," Trump told reporters on Wednesday during a daily press briefing at the White House when asked if he is looking at closing more Chinese diplo-

## China cites 'malicious slander' as Houston consulate closes

Beijing: China said "malicious slander" is behind an order by the US government to close its consulate in Houston, Texas, and maintained on Thursday that its officials have never operated outside ordinary diplomatic norms.

Foreign ministry spokesperson Wang Wenbin said the order to close the consulate "violates international law and basic norms governing international relations," and "seriously undermines China-US relations."

"This is breaking down the bridge of friendship between the Chinese and American people," Wang told reporters at a daily briefing.

The order this week to close the consulate, one of China's six missions in the United States, is seen as escalating tensions between the world's two largest economies while President Donald Trump steers blame and punitive measures against China ahead of the November US election.

## Jow Biden calls Trump country's 'first' racist Prez

Joe Biden said on Wednesday that President Donald Trump was the country's "first" racist President.

The presumptive Democratic presidential nominee's comments came during a virtual town hall organised by the Service Employees International Union.

When a questioner complained of racism surrounding the coronavirus outbreak and mentioned the president referring to it as the "China virus," Biden responded by blasting Trump and "his spread of racism."

"The way he deals with people based on the colour of their skin, their national origin, where they're from, is absolute-

ly sickening," the former vice president said. "No sitting president has ever done this. Never, never, never. No Republican president has done this. No Democratic president. We've had racists, and they've existed. They've tried to get elected president. He's the first one that has."

Biden also suggested that Trump is using race "as a wedge" to distract from his mishandling of the pandemic. Many presidents — including the nation's first, George Washington — owned slaves. # US labs buckle amid testing surge; world virus cases top 15M

Laboratories across the US are buckling under a surge of coronavirus tests, creating long processing delays that experts say are undercutting the pandemic response.

With the US tally of confirmed infections at nearly 4 million Wednesday and new cases surging, the bottlenecks are creating problems for workers kept off the job while awaiting results, nursing homes struggling to keep the virus out and for the labs themselves as they deal with a crushing workload. Some labs are taking weeks to return Covid-19 results, exacerbating fears that people without symptoms could be spreading the virus if they don't isolate while they wait.

"There's been this obsession with, 'How many tests are we doing per day?'" said Dr Tom Frieden, former director of the Centres for Disease Control and Prevention. "The question is how many tests are being done with results coming back within a day, where the individual tested is promptly isolated and their contacts are promptly warned."

Frieden and other public health experts have called on states to publicly report testing turnaround times, calling it an essential metric to measure progress against the virus.

The testing lags in the US come as the number of people confirmed to be infected worldwide passed a staggering 15 million, according to data compiled by Johns Hopkins University. The US leads the world in cases as well as deaths, which have exceeded 1,42,000.

New York, once by far the US leader in infections, has been surpassed by California, though that is partly due to robust testing in a state with more than twice the population of New York. Guidelines issued by the CDC recommend that states lifting virus restrictions have a testing turnaround time of under four days. The agency recently issued new recommendations against retesting most Covid-19 patients to con-

firm they have recovered. "It's clogging up the system," Adm. Brett Giroir, assistant health secretary, told reporters last week. Zachery Warner knows it all too well.

The 30-year-old waiter from Columbus, Ohio, was sent home from work on July 5 with a high fever a few days after he began feeling ill. He went for a test five days later at the request of his employer.

Almost two weeks and one missed pay period later, he finally got his answer Wednesday: negative. Though Warner said most symptoms — including fever, diarrhea, chest tightness and body aches — stopped a few days after he was tested, he wasn't allowed to return to work without the result.

It was "frustrating that I've missed so much work due to testing taking forever," Warner said. "It is what it is... (but) I'm glad I'm negative and happy to be able to get back to work this week." Beyond the economic hurt the testing lags can cause, they pose major health risks, too. In Florida, which reported 9,785 new cases and a rise in the death toll to nearly 5,500, nurs-

ing homes have been under an order to test all employees every two weeks. But long delays for results have some questioning the point.

Jay Solomon, CEO of Aviva in Sarasota, a senior community with a nursing home and assisted living facility, said results were taking up to 10 days to come back. "It's almost like, what are we accomplishing in that time?" Solomon said. "If that person is not quarantined in that 7-10 days, are they spreading without realising it?"

Test results that come back after two or three days are nearly worthless, many health experts say, because by then the window for tracing the person's contacts to prevent additional infections has essentially closed. "The turnaround times, particularly across the South are too long," Dr. Deborah Birx of the White House coronavirus task force said on Fox.

Birx said the US had short-

changed turnaround times in April, May and early June, but that "this surge and this degree of cases is so widespread compared to previously," she said. Dr. Leana Wen, a public health professor at George Washington University said it's reasonable to tell people awaiting test results to isolate for 24 hours, but the delays have been unacceptable.

"Imagine you tell a parent with young children to self-isolate for 10 days or more without knowing they actually have Covid? I mean, that's ridiculous. That's actually absurd," Wen said. US officials have recently called for ramping up screening to include seemingly healthy Americans who may be unknowingly spreading the disease in their communities. But Quest Diagnostics, one of the nation's largest testing chains, said it can't keep up with demand and most patients will face waits of a week or longer for results.

Trump points at race protests, bar-goers, Mexico travellers for surge in Covid cases

WASHINGTON: President Donald Trump is casting wide blame for a nationwide surge in coronavirus cases, pointing to racial justice protests, travelers from Mexico and young bar-goers. Holding his second briefing on the virus in as many days after a three-month hiatus, Trump sought on Wednesday to explain the rise in confirmed cases across the nation's South, Southwest and West.

Trump says cases among young Americans first started to rise "shortly after demonstrations." He says the protests following the death of George Floyd "presumably triggered a broader relaxation of mitigation efforts nationwide." He also says a "substantial increase in travel" around Memorial Day and summer vacations was also a driver of new cases.

## Scientists develop safe, rapid Covid-19 antibody test

SINGAPORE: Scientists have developed a rapid test to detect antibodies in COVID-19 patients that specifically block the novel coronavirus, an advance that may lead to faster methods for estimating the population level infection rate of the disease.

According to the study, published in the journal Nature Biotechnology, a rapid test to detect neutralising antibodies — capable of blocking the novel coronavirus SARS-CoV-2 — is urgently needed to facilitate monitoring of infection rates, as well as to determine vaccine efficacy during clinical trials.

In order to facilitate this, researchers, including those from Duke-NUS Medical School in Singapore, developed a new assay which is much faster than conventional tests for neutralising antibodies, taking only one or two hours to complete. PTI

## Around the Globe

China continues to see newly confirmed coronavirus cases in its northwestern region of Xinjiang, with 18 reported on Thursday. More than 50 people have been infected in China's latest outbreak focused on Xinjiang's regional capital and largest city of Urumqi.

Three out of four Americans, including a majority of Republicans, favor requiring people to wear face coverings while outside their homes, a new poll finds, reflecting fresh alarm over spiking coronavirus cases and a growing embrace of government advice intended to safeguard public health.

Mexican President Andrés Manuel López Obrador on Wednesday downplayed the importance of wearing face masks during the pandemic, calling his treasury secretary's assertion that using them would be a factor in reactivating the economy "disproportionate." López Obrador had never been seen publicly wearing a mask until he flew to Washington earlier this month to meet with President Donald Trump.

British Prime Minister Boris Johnson claimed that the United Kingdom's response to the coronavirus pandemic has shown the country's "sheer might" as he sought during a trip to Scotland on Thursday to underline the bonds that tie the nations of the UK together. Johnson's visit does not include a meeting with Scottish leader Nicola Sturgeon, who countered his upbeat tone with a frosty tweet saying the prime minister's presence "highlights" the arguments for Scottish independence.

Dutch Prime Minister Mark Rutte didn't win many friends with his tough negotiating over the course of a marathon four-day European Union summit in Brussels. That didn't bother the three-term leader who is a veteran of plenty of past EU negotiations. "We are not here because we are going to be visitors at each other's birthday party later," he told reporters during a brief lull in the grueling series of meetings.

## FBI: Researcher being harbored at Chinese consulate in SF

Washington: The FBI believes the Chinese consulate in San Francisco is harboring a Chinese researcher who is charged in federal court in California with lying about her military background. Tang Juan lied about her military affiliation in a visa application last October to work at the University of California, Davis and again during an FBI interview last month, according to Justice Department criminal charges.

Agents found photographs of Tang in a uniform of the People's Liberation Army civilian cadre and news articles from China that identified her military affiliation. The FBI last month interviewed Tang, when she denied having served in the military or knowing the significance of the insignia of her uniform, and also found more evidence of her military affiliation when they later searched her home, according to a criminal complaint filed last month that charges her with visa fraud.

## Green Card waitlist for Indian is more than 195 years: US senator

The backlog for an Indian national to get permanent residency or Green Card is more than 195 years, a top Republican senator has said, urging his Senate colleagues to come out with a legislative resolution to address this problem. A Green Card, known officially as a Permanent Resident Card, is a document issued to immigrants to the US as evidence that the bearer has been granted the privilege of residing permanently.

Senator Mike Lee said on Wednesday that the current Green Card policy did nothing for the child of an immigrant whose dead parent's Green Card application was ultimately denied because his or her job was no longer available.

"Someone from India entering the backlog today would have to wait 195 years to receive an EB-3 green card. Even if we give their children this limbo status, none of them will have a prayer of becoming a US citizen," Lee said on the Senator floor. In fiscal year 2019, Indian nationals received 9,008 category 1 (EB1), 2,908 category 2 (EB2), and 5,083 category 3 (EB3) Green Cards. EB1-3 are different categories of employment-based Green Cards.

Lee, the senator from Utah, was speaking on the legislation moved by Senator Dick Durbin that seeks to protect immigrant workers and their children who are stuck in the green card backlog.

## China launches ambitious attempt to land rover on Mars

China launched its most ambitious Mars mission yet on Thursday in a bold attempt to join the United States in successfully landing a spacecraft on the red planet.

Engines blazing orange, a Long March-5 rocket took off under clear skies from Hainan Island, south of China's mainland, as space enthusiasts gathered on a beach across the bay from the launch site.

"This is a kind of hope, a kind of strength," said Li Dapeng, co-founder of the Mars Society, an advocacy group. He watched with his wife, 11-year-old son and 2,000 others on the beach. Launch commander Zhang Xueyu announced to cheers in the control room that the rocket was flying normally about 45 minutes later. "The Mars rover has accurately entered the scheduled orbit," he said in brief remarks shown live on state broadcaster CCTV.

China's space agency said that the rocket carried the probe for 36 minutes before successfully placing it on the looping path that will take it beyond Earth's orbit and eventually into Mars' more distant orbit around the sun.

Liu Tongjie, spokesman for the mission, said in a press briefing that the launch was a "key step of China marching towards farther deep space."

He said that China's aim wasn't to compete with other countries, but to peacefully explore the universe. It marked the second flight to Mars this week, after a United Arab Emirates orbiter blasted off on a rocket from Japan on Monday. And the U.S. is aiming to launch Perseverance, its most sophisticated Mars rover, from Cape Canaveral, Florida, next week.

# Sensex reclaims 38,000-mark

## RELIANCE RALLIES TO LIFETIME HIGH

PTI ■ MUMBAI

Equity benchmarks returned to winning ways on Thursday after a day's breather, propelled by market heavy-weight Reliance Industries which soared to its lifetime high.

After a subdued start, the 30-share BSE Sensex gained momentum in afternoon trade before finally closing at 38,140.47, up 268.95 points, or 0.71 per cent.

The benchmark ended above the 38,000-mark for the first time since March 5 this year. The wider NSE Nifty advanced 82.85 points, or 0.74 per cent, to finish at 11,215.45.

Reliance Industries accounted for the lion's share of the Sensex's gains, spurting

2.82 per cent to its record closing high of ₹2,060.65, following reports that Amazon was eyeing a stake in the conglomerate's retail arm.

SBI, ICICI Bank, Tech Mahindra, ITC and Kotak Bank were among the other winners, advancing as much as 3.28 per cent.

On the other hand, Axis Bank, HUL, Infosys, TCS, UltraTech Cement and L&T tumbled up to 3.80 per cent.

"Benchmark indices ended the day with gains, following positivity in the global markets. Global markets set aside the rising US-China tensions and focused on potential vaccine developments and better-than-expected earnings numbers.

"Domestically, except for IT, most major indices were in the gains. Liquidity seems to be driving the markets. Any dip looks like it will be bought into and is likely to be short-lived, especially in the current mood of the markets when the negatives are being overlooked," said Vinod Nair, Head of



Research at Geojit Financial Services.

BSE energy, healthcare, realty, auto, oil and gas, bank and metal indices ended up to 2.36 per cent higher, while IT, tech and telecom closed with losses. Broader BSE mid-cap and small-cap indices surged up to 0.98 per cent.

## ₹ gives up gains to end flat at 74.75 against \$

Mumbai: The rupee gave up day's gains to settle on a flat note at 74.75 against the US dollar on Thursday amid concerns over growing tensions between the US and China. At the interbank forex market, the domestic unit opened on a strong note at 74.65, but erased the gains to finally close at 74.75, unchanged from its previous closing.

During the session, the domestic unit witnessed an intra-day high of 74.52 and a low of 74.87 against the US dollar.

Forex traders said the uptick in the rupee during the day was supported by weak greenback, foreign fund inflows and positive domestic equities, but rising tensions between the US and China weighed on investor sentiment and restricted the gains.

Meanwhile, the dollar index, which gauges the greenback's strength against a basket of six currencies, rose 0.01 per cent to 94.99.

## 'No employee of Air India will be laid off'

No reduction in the basic pay, dearness allowance and house rent allowance of any employee

After strong reactions from its pilots, Air India on Thursday said that no employee of Air India will be laid off. "The meeting reiterated that unlike other carriers which have laid off large number of their employees, no employee of Air India will be laid off," the national carrier said on Twitter. It further added that there has been no reduction in the basic pay, dearness allowance and house rent allowance of any employee.

"Allowances had to be rationalised owing to the airline's difficult financial situation already exacerbated by the novel coronavirus pandemic, the statement added.

Air India further clarified that its flying crew will be paid as per the actual number of hours flown and the Board's measures regarding allowances will be reviewed as domestic and international flight operations expand gradually.

Earlier this month, India's national carrier approved a scheme enabling its Chairperson and Managing Director Rajiv Bansal to place employees on compulsory leave without pay for six months or a period of two years, extendable up to five years. The scheme was approved during the 102nd meeting of Air India's Board of Directors.

## GST, I-T mop up in Q1 very encouraging, indicates economic recovery: Finance Secy

Tax mop up in first quarter of the current fiscal is "very encouraging" and indicates that the economy is recovering sooner than what was anticipated at the time of imposition of lockdown, Finance Secretary Ajay Bhushan Pandey said on Thursday.

He said the Revenue Department wants to bring in self-compliance among taxpayers by making available data of all financial transactions via Form 26AS at the time of filing income tax (I-T) return.

Pandey, who is also the Revenue Secretary, said about 70 per cent of the ₹ 91,000 crore Goods and Services Tax (GST) collected in June is on account of transactions in May.

"For the month of June, going by the current trends, we have certain trend about how many people have made payment so far, and also the e-way bill...Truck movement...All these things are giving encouraging signals that the economy is coming back to the realm sooner than what was being anticipated when the lockdown was started in March," he said while addressing a FICCI event here.

Besides, income tax collection, by way of advance tax and TDS, in the April-June quarter was about 80 per cent of what was collected in the same period last year. "These two numbers - GST and income tax - are encouraging numbers and also gives us some hope that wherever possible businesses are finding

ways to get started. But there were certain sectors like hospitality, education, tourism, which are facing difficulty," Pandey added.

The Government had in May notified revised Form 26AS which would have additional details on taxpayers' high-value financial transactions like cash deposit/withdrawal, property purchases undertaken during a financial year, and would facilitate voluntary compliance and ease of e-filing of I-T returns.

Pandey said a person sees all his transaction at one place, it makes return filing easy and helps honest taxpayers. It also sends a message to those persons who are on the borderline, and they would also try to be on the right side of law.

"What we want to promote is self-compliance instead of somebody being sent a notice and then somebody going through some kind of harassment or difficulty, we are making all those information available," he added.

With regard to digital lending by banks, Pandey said if tax-payment profile of a loan applicant is made available to the banks, it would make it easier for lenders to assess how much loan can be extended.

"...We have all these informations, these information can be shared in a secured manner...We are working on that, we had several sounds of meetings with several stakeholders and we are working on this," he added.

## Indian economy set for post-Covid-19 rebound as FDI remains buoyant, says IHS Markit

New Delhi: The Indian economy is likely to rebound in the second half of 2020 as the impact of the COVID-19 pandemic recedes, and is projected to grow by 6.7 per cent in the next financial year, IHS Markit said on Thursday.

The pandemic resulted in severe disruptions in industrial production and consumption spending in India during April and May.

"The severe negative impact is expected to result in a significant contraction in GDP in the April-June quarter of 2020, resulting in a recession in the 2020-21 financial year with GDP expected to contract by 6.3 per cent year-on-year," it said in its outlook on the Indian economy.

However, as lockdown conditions have been progressively eased, early signs of recovery were evident in the most recent economic data.

The IHS Markit Purchasing Managers' surveys for India showed that economic momentum improved in June, reflecting the easing of COVID-19 related restrictions during May and June.

India imposed a total lockdown beginning March 25 and restrictions were eased from May. "IHS Markit forecast that the Indian economy will rebound as the impact of the pandemic recedes, with improving economic growth momentum in the second half of 2020 and positive GDP growth of 6.7 per cent in the 2021-22 financial year," said Rajiv Biswas, Asia Pacific Chief Economist at IHS Markit.

Despite the negative short-term shocks from the pandemic, total foreign direct investment into India has remained buoyant. Foreign direct investment by technology firms in the first seven months of 2020 has already reached around USD 17 billion, boosted by the USD 10 billion new investment announced by Google in mid-July.

## Jio tops Trai's 4G chart with 16.5 mbps download speed in June

Reliance Jio topped 4G speed chart with an average download speed of 16.5 megabits per second (mbps) in June, while Vodafone and Idea led in terms of upload speed, according to Trai data.

Idea followed Jio in download speed chart with 8 mbps speed,

the latest data published on Trai's Myspeed portal showed.

The Telecom Regulatory Authority of India (Trai) recorded average download speed of 7.5 mbps and 7.2 mbps on 4G network of Vodafone and Bharti Airtel in June.

For upload speed, Vodafone and Idea led the

chart with speed of 6.2 mbps each. Jio and Airtel recorded average upload speed of 3.4 mbps each.

Download speed helps in accessing messages, pictures, videos, etc., sent by others, while upload speed helps subscribers in sending messages, pictures, etc., to their contacts.

## Govt wants PSUs to trigger change in investment climate hit by Covid

Government has asked Public Sector Undertakings (PSUs) to complete all their planned capex for FY21 on time and become vehicles of growth for the economy hit by the coronavirus pandemic.

With private investment on a standstill, the Govt wants companies administered by it to change the mood in the country by stepping up expenditure and generating economic activity that results in income generation and job creation. At a review meeting held by the Finance Minister Nirmala Sitharaman on Thursday with Secretaries of Ministries of Civil Aviation, Steel, and the Chairman Railway Board along with the CMDs of 7 CPSEs belonging to these Ministries, the Finance Minister said that better performance of CPSEs can help the economy in a big way to recover from the impact of

COVID-19. In this regard, she said it is important that CPSEs ensure that capital outlay provided to them for FY21 is "spent properly and within time". Sitharaman asked secretaries to closely monitor the performance of CPSEs in order to ensure capital expenditure to the tune of 50 per cent of capital outlay by Q2 2020-21.

She said that to achieve this planning should be done in advance and all unresolved issues should be brought before the ministry for immediate solution. The concern this year is that sluggish economic activities on account of COVID-19 and sagging demand conditions may also push PSUs to step back on their investments. In FY 2019-20, against the CAPEX target of ₹30,420 crore for the 7 CPSEs, the achievement was ₹25,974 crore i.e. 85%. In Q1 (FY 2019-20) achievement was ₹3,878 crore (13%) and achievement of Q1 (FY 2020-21) has slowed down to ₹3,557 crore (14%).

## Green shoots of recovery to sprout faster in non-metro markets, says EY survey

The green shoots of recovery are expected to grow faster in non-metro markets due to "higher resilience" shown by non-metro cities during the COVID-19 pandemic, says a survey by consultancy firm EY.

The EY survey, which polled over 4,000 respondents equally divided between metro and non-metro markets, was conducted to ascertain the potential impact of pandemic-related disruptions on consumer sentiments, its report said.

Categories like consumer goods, travel, entertainment, automobiles and white goods are all expected to see increased and faster recovery of demand from non-metro markets post the lockdowns, it added. "Non-metro markets have shown higher resilience than metro markets in our study and could recover faster. The per-

centage of respondents who expected to spend more than before on a majority of categories was much higher in non-metro markets, indicating that when the lockdowns end, green shoots of recovery would probably sprout faster in these markets," EY said.

Respondents in non-metros are expected to spend much more on consumer goods, travel, outdoor and automobiles as compared to their metro counterparts, it said. According to EY India Partner and Media & Entertainment Leader Ashish Pherwani, the COVID-19 pandemic has radically shifted way of life.

"However, despite uncertain and challenging conditions, our research shows that non-metros express a higher degree of resiliency and a resolve to bounce back quicker compared to metros. We may see long-term and even permanent changes in consumption patterns," he said.

## Extend by 2 years compulsory gold 'hallmarking', urges CAIT

PIANS ■ NEW DELHI

Citing higher prices and low supply, the Confederation of All India Traders on Thursday urged the Centre to extend the provision for compulsory gold Hallmarking by two years, so that leftover stock can enter the market.

On Thursday, gold prices went up to ₹51,500 per 10 gram, while silver ended at ₹62,000 per kg. CAIT said adding that the safe asset class has gained demand as an outcome of the Covid-19 induced economic turbulence.

Accordingly, the confederation expects a sustained demand for gold and silver dur-

ing the festive season starting from Raksha Bandhan on August 3.

The confederation expects gold prices to touch ₹55,000 per 10 grams on Diwali.

According to Praveen Khandelwal, Secretary General, CAIT and Pankaj Arora, National Convener of All India Jewelers and Goldsmith Federation, silver price is expected to be in a range of ₹72,000 to ₹75,000 per kilogram. He was quoted as saying in a statement: "Gold has always been the best and safest choice of investment for the customers as gold prices generally keep on increasing whereas on the other hand, it

is also the most important investment for traders which is quite safe."

Prior to the lockdown, gold prices stood at ₹41,000 per 10 grams and that of silver was at ₹40,000 per kg and now in a period of just 4 months there is an increase of 28-30 per cent in gold and in silver the increase is of about 45 per cent, he said. The confederation said that to allow the jewellers to liquidate their old stocks, the Centre should provide a further extension of 2 years, in the view of Covid-19 disruption. Earlier, the Centre had made 'Hallmarking' on every gold item compulsory from January 15, 2021.

## Rossari Biotech makes blockbuster stock market debut, zooms 77 pc

New Delhi: Shares of specialty chemicals manufacturing firm Rossari Biotech made a stellar debut on the bourses on Thursday, and closed nearly 77 per cent higher against its issue price of ₹ 425 per share. The stock touched its highest trading permissible limit for the day on the BSE as well as NSE.

The stock listed at ₹670, registering a gain of 57.64 per cent on its issue price on the BSE. During the day, it jumped 89.17 per cent to ₹804 - its upper circuit limit. It finally closed at ₹742.35, up 74.67 per cent. On the NSE, it closed at ₹752, a gain of 76.94 per cent. During the day, it jumped 88.96 per cent to ₹803.10

The company's market valuation stood at ₹3,854.98 crore on the BSE. In terms of volume, 30.27 lakh shares were traded on the BSE during the day, while 3.57 crore shares changed hands on the NSE.

Aesthetics are a very personal thing but what is with car designers and big wide grilles?



Can you spot the similarity?

When I look at some modern cars, I get reminded of sharks. If you, like me, are an amateur shark scientist and loved Discovery Channel's Shark Week shows, you would know that there are over a thousand species of them. When you think of sharks, you tend to think of the Great White, leaping into the air a seal tightly grasped inside its jaw. Isn't it? The fact is that the 'agape' look on so many car grilles that I see today, reminds me of the Whale, the largest fish in the world. An impressive one, of course, but thoroughly harmless with a massive mouth at the tip of its head, not below like predatory sharks, but at the tip.

When you see a picture of a whale shark feeding and then look at what Hyundai has been giving us of late — the new Elantra coming in 2021 — will be interesting to say the least. Even Maruti, the facelift on the Dzire, makes things bigger. The MG Hector and Kia's 'tiger nose' on the Seltos and Sonet as well. Heck, Honda might stick a chrome slab through its mouth like braces on teeth, but they also have big mouths. And of course, there are the Germans. BMW's signature 'kidney grilles' have gotten a bit out of hand. Have you seen the BMW 4-series concept? I actually don't mind it on the 7-series and X7 because of their huge size, so there is a bit of proportionality. And then



there is Audi, the carmaker that started the trend of wide-mouthed sedans and SUVs with their 2004 line-up redesign starting with the A4 and A6. Of course, larger grilles allow for more area where designers can play around or stick a humongous logo, like MG and Mercedes-Benz do. Or like in the case of BMW, where the kidney grilles are a signature of the Bavarian carmaker. With three-dimensional light design killing off the other signature 'Corona' headlights, the grille is it. While I know that in India today, China-bashing is in vogue and I have personally also been guilty of that, here I really have to blame the Chinese. When they buy a product, they are not subtle about it. The Ralph Lauren logo on t-shirts grew bigger once that brand took off in China. Similarly, the brush Louis Vuitton logo, also thanks to that market. The tragedy of Montblanc putting their logo on everything from belts to wallets, yes, you guessed it, China. BMW once admitted this to me, during the 7-series refresh international drive in Algarve, that the bigger kidneys and the "12 per cent larger" nose logo was for the Chinese market. And

you know what? When that one market accounts for a third of your global sales, making those changes is perfectly logical for a carmaker.

There are friends of mine in automotive journalism who like the big kidney grilles on BMW. At the end of the day, we all have different aesthetic sensibilities. One lesson that I have learnt is that in India, we seek 'value' from a car rather than looks. The first-generation Santro, particularly early builds of that car were, for lack of any other word to describe it, ugly. The first generation WagonR seemed as if the design team was only given a ruler and a brief to avoid any sort of curve. These cars were not at all aesthetically pleasing. The Daewoo Matiz on the other hand, was quite cute. But you know the story, the Santro launched Hyundai allowing them to dazzle our eyes with the next-generation Elantra that you will see next year. Don't get me wrong, I love the product, but the next Elantra just like the facelift on the Verna looks like a Whale shark out of water.

Here is the funny thing, large grilles made sense when you had large naturally aspirated engines, big steel blocks with eight cylinders inside them. Those engines needed air and also a lot of cooling. But thanks to emissions norms, those engines are dying out in all but

some supercars. And BMW themselves have the F90 5-series which is by far and away the best looking car they make because it doesn't look like it went through rhinoplasty to get a boxer's nose. It is an aesthetically pleasing car. At a level this is a bit like planes, the Airbus A380 is a tremendous piece of engineering, but it isn't pretty. The Boeing 747 just has something about it, which is why it is called the 'Queen' of the skies and the A380, well, that is a whale (nothing against cetaceans by the way). When electric cars come along, what will happen to all these large grilles? Just look at Tesla's — a clean, proportionate design, no frills or huge kidney grilles. I mean, even BMW's electric warrior the i3 is not overdone on the nose front. So why on god's green earth did BMW give us the Concept 4-series?

Being passionate about cars and writing about them will necessarily make you ardent about car design. I do not like the way many cars look these days. I'm not saying that there are not some pretty cars out there but the attack of the large grilles is upon us. While I'm sure I will be pummelled into acceptance, as we all accepted the first-generation Santro, I'm not going down without a fight. Or in my case, without writing such columns.



# FROM CASK TO GLASS

**ANGAD SINGH GANDHI** talks about the evolution of single malt whisky, what makes it relevant and Glenfiddich's journey



People nowadays don't want to just clink glasses with their friends and family over an evening get together, rather they want to know more about the dram, the whisky notes, food pairings and so much more. Here is the history, evolution of single malt whisky, its relevance and Glenfiddich's journey in the making.

whisky was taken outside Scotland. The malt whisky was first called 'Pure malt' and then 'Straight malt'. Eventually the term 'Single malt' was coined which has stuck with us ever since then in our hearts (and glasses, of course).

## HOW DID THE WHISKY GET ITS FLAVOUR?

Where a whisky is born, what it's matured in and how old it is, all affects the flavour of the final product. With age comes character and complexity. To qualify as a Scotch whisky, it must be aged in an Oak barrel in Scotland for minimum of three years.

Water also plays a significant role in the making of the whisky. The William Grant & Sons family have owned the lands around the Robbie Dhu spring for a very long time, safeguarding the water for all its whiskies including the The Balvenie, Monkey Shoulder and others. Whisky is made entirely from barley. Barley from our specialist maltsters is ground into rough flour and mixed with heated Robbie Dhu springwater.

The key is in the cask. With a lot of flavour coming from the cask, the quality of the whisky depends on the quality of the wood it's matured in. A single malt may see several casks. It's a common misconception that single malt whisky is the product of one cask. In fact, two thirds of the flavour in a single malt comes from casks it's matured in and is the product of a single distillery and may come from sev-



eral casks within the same distillery.

A lesser-known thing about single malts is the angel's share. Angel's share is that portion of whisky which evaporates during the maturation process. The name comes from a tongue-in-cheek belief that those

'greedy angels' must be blamed for the diminishing level of tightly sealed whisky barrels. The approximate rate of loss of whisky due to evaporation is two per cent per annum in Scotland and nine to 10 per cent in India because of the warm weather conditions.

This means one can age a single malt in Scotland for 50-60 years while in India they can be aged for only 10-12 years. Skills, craftsmanship, specialist knowledge and wisdom, all go into the making of a whisky.

## BUILDING IT ON

Today, even in the twenty-first century, single malts continue to be a preferred spirit and are growing year-on-year. But the way the spirit is perceived and approached has changed radically. While the single malt drinker continues to be one who enjoys the finer things in life, they are no longer restricted to an older audience. Women are becoming an integral part of the category not just as consumers but also as distillers, enthusiasts, brand ambassadors and bartenders. The love for whisky is rising in younger people as well, they are replacing other spirits with whiskies. We see a growing curiosity and interest among the younger drinkers in knowing more about their spirit. This is due to the increased relevance being created by brands promoting cocktails and serves that make it intriguing and aspirational for the younger generation to opt for whiskies.

Innovation within the single malt category has been one of the key reasons for it to remain relevant through decades. Innovation across distilling, manufacturing, packaging and marketing have together played a crucial role. Experimental single malt variants have gained high prominence with the new age whisky drinkers that are willing to play with their single malts. Distillers too have kept up with this demand by introducing unique cask finishes such as beer, ice wine, tequila, mezcal and French cuvée casks, that add to the varied notes of the single malt.

The brands new experiments' which have been done keeping in mind India's rich culture, have brought to life a special India specific initiative that refined the rules of traditional single malt serve by exploring and handpicking unique and exotic Indian ingredients.

It is great to be on the lookout to create out-of-the-ordinary experiences that challenge people's perception and enthuse consumers to try something different.

## SAVOURING THE DRINK

While, the art of truly enjoying your single malt is a beautiful experience, it differs for everyone. Experiential tastings and pairings have helped in continuous consumer awareness and interest in the single malt category. Consuming your single malt with food opens a world of aroma and flavour opportunities. The goal is to pair with ingredients and spices that enhance the flavour of the single malt rather than overpowering it. Single malts surprisingly work well with desserts and fine teas. The varied styles of enjoying your single malts today are endless, be it through food or unique serves, that have kept the spirit from being enjoyed by both whisky and non-whisky drinkers alike.

Neat or Not? It's entirely up to you! Going neat may be the 'purest' way to enjoy a single malt, but it's not the only way.

I strongly believe, "To each its own!" Therefore, whatever you like is the best one for you. However, the best dram is the one enjoyed with friends and family over lots of banter and fun.

### CHICKEN KRAPOW

#### WHAT YOU NEED

- Chicken boneless: 130 gm
- Ginger (chopped): 4 gm
- Garlic (chopped): 5 gm
- Lemon grass : 3 gm
- Celery (chopped): 3 gm
- Onion (chopped): 8 gm
- Fresh red chillies: 3
- Boiled rice: 150 gm
- Salt: 3 gm
- Five spice powder: 2 gm
- Degi mirch powder: 3 gm
- Spichi stir fry sauce: 40 gm

- Basil leaves: 10 gm
- Refined oil: 10 ml
- Vinegar: 3 ml
- Chilli paste: 4 gm
- Cornflour: 5 gm
- Egg: 1

- Marinate chicken in five spice powder, salt, sugar and degi mirch.
- Heat oil in wok.
- Add chopped garlic sautee, ginger, celery, lemon grass and onion.

- Frozen sweetcorn kernels (thawed and drained): 400 gm
- Spring onions (finely

- sliced): 3
- Red chilli (seeded and finely chopped): 1
- Fresh coriander (chopped): 2 tbsp
- Cheddar cheese (finely grated): 1 cup
- Ground black pepper (Salt and fresh)
- Sunflower oil: 1 tbsp
- Mayonnaise: 150 ml
- Fresh parsley (chopped): 1 tsp

#### METHOD

- Sift the flour and baking powder into a large bowl. Make space in the centre and add the milk and eggs.
- Gradually, drawing in the flour from around the edges, beat together to form a smooth and thick batter.
- Add the sweetcorn, spring onions, chilli, coriander and cheese to the batter and season with salt and black

- pepper. Mix well.
- Heat a large, heavy-based frying pan and brush with oil.
- Drop large spoons full of the batter into the pan, making about four fritters at a time.
- Cook over medium heat for two minutes or until golden and firm on the underside. Flip the fritters over and cook for further two minutes until golden brown. Remove the cooked fritters from the

# On Klopp of the world!

## Dreams turn into reality as Jurgen's Liverpool lift Premier League trophy at the Kop

Liverpool manager Jurgen Klopp said having the opportunity to lift the Premier League trophy at Anfield meant the world to him despite having to do so in an empty stadium with fans shut out due to coronavirus.

The Reds sealed a first top-flight title for 30 years last month, but had to wait until after a thrilling 5-3 win over Chelsea in their final home game of the season to lift the Premier League trophy for the first time.

"You make the best of what you can," Klopp told *Sky Sports*. "Today our families are allowed to be there which is incredible. It means the world to me. Everything would be better with fans but for months we knew that would be impossible. A few months ago I thought it was impossible that we play football."

"I couldn't be happier to be honest, it would be perfect if the stadium would be full but we cannot change it. What we tried to do is make it clear to the people that we really do it for them. It's an absolutely great moment."

Despite pleas for fans to stay away on the night Liverpool finally got their hands on the trophy, supporters crowded around the stadium even prior to kick-off, while the second half was accompanied by the

constant crackling of fireworks lit by fans outside the ground.

On the field, Klopp's men ensured a memorable night was accompanied by a positive result after just two wins in five previous games since they clinched the title. And the German again promised the fans a proper party with a parade planned through the city once restrictions are lifted.

"You have to prepare for a party," he added. "When I don't know, when this virus is gone then we will have a party all together."

The result had far bigger consequences for Chelsea as they slip to fourth and leaves Frank Lampard's men still needing a point at home to Wolves at Stamford Bridge on Sunday to secure a place in the Champions League.

**'IN OUR HANDS'**  
"It's huge, we know the situation," said Lampard. "It's in our hands to get a result against a very good Wolves team."

Chelsea have already bolstered their attacking options for next season with the signings of Timo Werner and Hakim Ziyech, while they are reportedly closing in on a deal for the 90-million euro (\$103

million, £81 million) rated Kai Havertz of Bayer Leverkusen.

But it is at the other end Lampard clearly has to find solutions as they completed an entire league season with just one clean sheet away from home and have now conceded 54 times in the Premier League this season.

Liverpool were 3-0 up inside 43 minutes as sweet strikes from Naby Keita, Trent Alexander-Arnold and Georginio Wijnaldum gave Chelsea a mountain to climb.

They nearly did so even after Roberto Firmino scored his first league goal at Anfield all season restored Liverpool's three-goal cushion to cancel out Olivier Giroud's strike just before half-time for the visitors.

Christian Pulisic was surprisingly left on the bench by Lampard from the start and he changed the came after he was introduced alongside Tammy Abraham and Callum Hudson-Odoi.

The American skipped past four challenges before squaring for Abraham and then fired powerfully into the roof of the net with the Liverpool defence all over the place.

But Chelsea were undone again at the other end as a blistering break from inside their own box saw Liverpool surge forward and Alex Oxlade-Chamberlain smashed home Andy Robertson's cross at the back post.

## We should not stop because others will not sleep: Klopp

Liverpool manager Jurgen Klopp believes his side will need to keep improving to hold off the chasing pack next season after lifting the Premier League trophy.


Chelsea have already strengthened ahead of next season with the signings of a long-term Liverpool target Timo Werner and Hakim Ziyech.

Klopp also expects Manchester City and Manchester United to bolster their squads. But the German believes there is still improvement for his players to make despite becoming English, European and world champions over the past 14 months.

"We should not stop, we have internal challenges to improve," said Klopp. "We have the chance to make another step, but we have to because the others will not sleep. Chelsea is such a talented team, we had to bring everything on the pitch tonight. Man Utd, Man City (will contend), there are no guarantees for anything, but we will try."

Liverpool also beat Chelsea to lift the Uefa Super Cup at the start of the season to go with the Premier League, Champions League and Club World Cup and Klopp admitted he will take time for a special moment after an incredible run of success.

"We are champions of England, Europe and the world. We won four trophies, really big ones, so I couldn't be more proud," he added. "I'm usually not a person who needs pic-

tures but I will have a picture with all four trophies because it doesn't happen often, so we should."

Jordan Henderson had the honour of becoming the first Liverpool player to lift the Premier League trophy and the Reds' captain believes the manner of victory over a Chelsea side, who needed a result to confirm their place in the Champions League next season, bodes well for what can be achieved next season.

"It's been a journey and to finish it off like this is really special," said Henderson. "After this, next season is going to be a big challenge for us. But I thought tonight we showed the mentality to come and perform again and get the result we did."

## Lampard tells Liverpool not to get 'too arrogant'

Liverpool: Chelsea manager Frank Lampard has said Premier League champions Liverpool should not become too arrogant after being left unimpressed with the behaviour of their bench during Wednesday's 5-3 defeat.

Lampard was involved in an exchange with Liverpool's bench after a free kick was awarded against Chelsea's Mateo Kovacic. Trent Alexander-Arnold found the net from the free kick to make it 2-0.

"For me it wasn't a foul from Kovacic," Lampard told *Sky Sports*. "There were a lot of things that were ongoing and on the bench ... I've got no problem with Jurgen Klopp, he's managed this team and it's fantastic."

"Some of the bench, it's a fine line between when you are winning — and they've won the league, fair play to Liverpool Football Club — but also don't get too arrogant with it."

"That was my thing, but (it's) done. In match play you get emotional and that was it." AP

## Man Utd just a point away from CL

Solskjaer's team were well below their best against West Ham, but they are now unbeaten in 13 league matches and will complete an impressive surge into the Champions League if they emerge unscathed at Leicester.

They can also qualify for Europe's elite club competition if they win the Europa League in August.

West Ham's point ensured they are mathematically certain to avoid relegation.

## West Brom promoted as Brentford blow chance

Manchester: West Bromwich Albion won promotion back to the Premier League after a two-year absence, joining Leeds United in the top flight next season after a 2-2 home draw with Queens Park Rangers in a dramatic finale to the Championship season on Wednesday.

The point for Slaven Bilic's side was enough to ensure second place in England's second tier after Brentford blew their chance by losing 2-1 at home to lowly Barnsley.

A win for Brentford would have sent them into the top division for the first time since 1947.



Brentford will go into the playoffs along with Fulham and Cardiff City but in a huge swing in fortunes, Nottingham Forest missed out on goal difference with Swansea City grabbing the last slot in astonishing fashion. At the bottom, Hull City and Charlton were relegated along with Wigan Athletic.

Emery, who has coached Almeria, Valencia and Sevilla in the Spanish top-flight before, will be presented as Villarreal manager at their home ground on Monday.

### HALEP SIGNS UP FOR PRAQUE EVENT

PRAQUE: World No 2 Simona Halep on Wednesday said that she will play the WTA Prague clay court tournament in August, adding further doubt to her participation in the US Open. "Hi everyone. I can't wait to take part in the tournament in the magnificent city of Prague. See you in August," the reigning Wimbledon champ said in a video message. The Prague tourney runs from August 10-16.

### ICC POSTPONES TWO QUALIFYING EVENTS

DUBAI: The Covid-19 pandemic continued to take a toll on the sporting calendar with ICC on Thursday postponing this year's qualifying events for two separate tournaments due to the global health crisis. ### FIDE ONLINE CHESS OLYMPIAD FROM JULY 25

CHENNAI: The FIDE Online Chess Olympiad, which will feature top players like world No 3 Ding Liren and Viswanathan Anand among others, will be held from July 25 to August 30. Teams from 163 countries will take part in the first-ever online Olympiad. Russia is the top-ranked team, followed by China, USA, Armenia and Ukraine. The India team, captained by Vidit Santosh Gujrati, is the seventh-seed in the prestigious competition.

### MANANGOI SUSPENDED IN DOPING CASE

MONACO: Former 1,500-meter world champion Elijah Manangoi was provisionally suspended on Thursday for missing doping tests. The Athletics Integrity Unit said the Kenyan runner has been charged with "whereabouts failures." No timetable for his disciplinary case was given.

## Archer, Anderson, Wood return for series decider

## Inter draw clears title way for Juve

Inter Milan's goalless draw against Fiorentina on Wednesday left Juventus needing just one more win to claim a ninth consecutive Serie A title.

Juve are six points clear of second-placed Atalanta and can claim their 36th Scudetto on Thursday with a win at struggling Udinese.

Antonio Conte's Inter are third, one point behind Atalanta with three games to play, despite having dominated for long periods under the rain at the San Siro.

"Second place is for losers," said Conte, who coached Juventus to three of their current run of eight titles and then went on to win

the Premier League and FA Cup with Chelsea.

"I understand that there are those who are satisfied with this, but for me it is meaningless. When you leave points, it means that there are shortcomings."

A Romelu Lukaku header hit the woodwork after 18 minutes with Alexis Sanchez also missing a chance for the winner just after the break.

Fiorentina goalkeeper Pietro Terracciano pulled off a string of

saves denying Nicolò Barella and Lukaku from close range.

Inter's place in the Champions League next season is assured but they could now finish fourth, with Lazio four points back ahead of their match with 13th-placed Cagliari on Thursday.

Roma, meanwhile, move back fifth ahead of AC Milan after routing already-relegated SPAL 6-1. Bruno Peres scored a second-half brace with Carles Perez scoring his first Serie A goal for the visitors with Nikola Kalinic and Nicolò Zaniolo also on target.

Roma are two points ahead of Milan, with the two teams already assured of Europa League football next season.

## Amir cleared to join side in Eng

Pakistan left-arm pacer Mohammad Amir on Thursday was cleared to join the national side in England after his second test also returned negative for coronavirus.

"The PCB will now be making arrangements to send Amir and masseur, Mohammad Imran to England as soon as possible so that they can join the training camp in Derbyshire," the Pakistan Cricket Board (PCB) said in a release.

Amir, 28, left many people disappointed including the national team's head coach and chief selector, Misbah-ul-Haq when he announced his sudden retirement from Test cricket last year.

Former players are of the opinion that if Amir is available and fit, then he should also be considered for the Test series against England.

Amir in a recent interview had said that he had made a mistake playing all three formats after his comeback after a five-year ban for spot-fixing. "I should have first played one or two formats and checked to see how my body is doing and whether I could take the strain."



## IPL to start from Sept 19, final on Nov 8: BCCI sources

The eagerly-awaited Indian Premier League will start on September 19 in the United Arab Emirates with the final slated on November 8, well-placed BCCI sources told PTI on Thursday.

## NZC leave decision to join IPL on players

NEW DELHI: New Zealand Cricket (NZC) will issue No Objection Certificates (NOCs) to all its six international players set to compete in the IPL but said the "due diligence" on health safety protocols will have to be done by the players themselves.

The six New Zealand players who are set to play in the IPL are Jimmy Neesham (Kings XI Punjab), Lockie

Ferguson (KKR), Mitchell McClenaghan and Trent Boult (Mumbai Indians), Kane Williamson (Sunrisers Hyderabad) and Mitchell Santner (CSK).

While the NZC will be updating its players about the health safety protocols and latest Covid-19 related developments, the onus will be on the six individuals to do due diligence.

While there were speculations that 13th edition of IPL will start from September 26, the BCCI decided to advance it by a week in order to ensure that the Indian team's tour of Australia for four-match Test series is not jeopardised.

"The Indian team will have a mandatory quarantine of 14 days as per Australian Government

rules. A delay would have sent the plans haywire.

"The best part is that 51 days is not at all a curtailed period and there will be much less double headers. We could stick to original five double headers in seven week window," the official said.

It is expected that with each and every team needing at least a month's time to train, the franchises will be leaving base by August 20 which gives them exactly four weeks time to prepare for the glitzy event.

## Indian mixed relay team's Asiad Silver upgraded to Gold



"The additional medal takes our tally to 20, including eight Gold and nine Silver," said AFI President Adille J Sumariwalla.
