In Manarashtra, all malls, gyms, cinema halls and swim-ming pools located in Mumbai, Pune, Nagpur, Navi Mumbai and Pimpri-Chi-nchwad have been shuttered from midnight on Friday. In Karnataka too, all malls, theatres and pubs will remain shut for a week starting Saturday. The Delhi gov-ernment has decided to stop all sporting events, including IPL, conferences and seminars in the national capital. A total shutdown has been ordered in Kerala, where educational institutions and cinema halls will remain closed till March 31. The idea is to prevent mass gatherings as community transmission of the virus is now the main concern of health authorities.

The number of novel coronavirus cases on Friday rose to 81, which include 16 Italians and one Canadian, Health Ministry officials said.

Addressing reporters, Health Ministry Joint Secretary Lav Agarwal said coronavirus is not a health emergency and that there is no need to panic. He said seven more coron-

avirus patients have been cured and they will be discharged soon, while 71 are "clinically stable".

He said so far, India has evacuated 1,031 people, including from Maldives, US, Madagascar and China.

"An exercise will be undertaken on Saturday to bring back Indian passengers stranded in Iran. Àir India will also send a flight to Milan on Saturday to bring back stranded Indians. It will land on Sunday morning at Delhi airport," said Ministry of Civil Aviation Joint Secretary

Rubina Ali. A total of 4,000 people who came in contact with 81 positive cases are under vigorous observation across the country, Agarwal said. has led to more than 4,000

AP to implement Epidemic Diseases Act to contain spread of coronavirus PNS VIJAYAWADA

The Andhra Pradesh government on Friday decided to implement the Epidemic Diseases Act, 1897, as a precautionary measure to curb the possible spread of the novel coronavirus.

The decision follows a directive from the Union Cabinet Secretary Rajiv Gauba to all states to invoke the provisions of the Act.

State Special Chief Secretary (Health) KS Jawahar Reddy told reporters here that action would be taken as per Section 2 of the Act against those who did not follow the safety pre-

The state government has identified two quarantine facilities in Tirupati (500 capacity) and Visakhapatnam (200 capacity) and also two labs for testing Covid-19 cases.

"We have issued a set of guidelines for home isolation to be followed by those returning from foreign countries. They should confine themselves to home for 14 days and not meet anyone, including close family members,

Jawahar Reddy said.

"Also, precautions should be taken by all, particularly in crowded places like cinema halls and malls. If anyone is found violating the guidelines, we will initiate action as per the EDA," he said.

The state government has identified two quarantine facilities in Tirupati (500 capacity) and Visakhapatnam (200 capacity).

Two laboratories for testing Covid-19 cases have been established in Sri Venkateswara Institute of Medical Sciences, Tirupati, and another in Vijayawada, he said.

AP, TS govts should reject NPR: HRF PNS VISAKHAPATNAM

The Human Rights Forum demanded that Andhra Pradesh and Telangana governments pass resolutions in their Assemblies rejecting the National Population Register (NPR) exercise in its totality and not just limit themselves to reverting to the 2010 version of it.

In a release here on Friday, HRF Coordination Committee member VS Krishna said the NPR-NRC-CAA combine are inextricably linked legally. The parent law, the provisions of Citizenship (Amendment) Act-2003 under which NPR operates, explicitly envisions the creation of a National Register of Indian Citizens (NRIC). Rule 3 of the Citizenship (Registration of citizens and issue of national identity cards) Rules- 2003 under which the NPR process has been notified, mentions NRIC in the title. Sub-rule 4 of Rule 3 invokes the NPR process, while Sub-rule 5 of Rule 3 clearly states that "The



local register of Indian citizens shall contain details of persons after due verification made from the population register. Therefore, the population register provides the base for preparing a register of Indian citizens and NRC is the legal outcome of the 2003 amendment to the provisions of the Citizenship Act- 1955. The NPR amounts to an initialisation of an NRC.

He said time and again Union Home Minister Amit Shah has made clear, both in Parliament and outside, that the people would do well to 'understand the chronology' of the NPR-NRC-CAA process. In Parliament on Thursday, Amit Shah was lying brazenly when he asserted that the NPR process will not render any person as 'D' or 'Doubtful' in respect of their

citizenship. Sub-rule 4 of Rule 4 of the Citizenship (Registration of Citizens and issue of national identity cards) Rules, 2003, which invoked NRIC, clearly states: "During the verification process, particulars of such individuals, whose citizenship is doubtful, shall be entered by the local

registrar with appropriate remark in the population register for further enquiry and in case of doubtful citizenship, the individual or the family shall be informed in a specified proforma immediately after the verification is over.

Krishna said HRF believed that the NPR is a survey exercise that collects data for an NRC. In other words, data from the NPR will be used to identify 'doubtful' citizens and in turn create an NRC. An NRC, which is built on the NPR, will allow the executive to pick and choose whose citizenship it wishes to interrogate. It is evident that the dan-ger that this poses will not be limited to the minorities alone but a whole class of disadvantaged people in the country. ADMISSION TIME CBSE urges parents to check affiliation of schools

Alerting parents against unregistered schools, the Central Board of Secondary Education (CBSE) has asked them to check the affiliation status of a school before seeking admission to their children.

The National Board under the aegis of Ministry of Human Resource Development grants affiliation to schools on fulfilment of mandatory conditions as laid down in its bye-laws. In case of non-fulfilment of conditions, the application of

schools stand rejected. Such schools are not allowed to enrol their students for Board's examinations. It has come to the notice of the Board that some of the non-affiliated schools are misleading the parents by displaying various boards at schools.

Some of the schools show messages such as "to-be affiliated to CBSE", "CBSE Pattern", "Likely to be affiliated with CBSE" or "Running under the aegis of CBSE". The Board does not allow non-affiliated school to present the candidates to the Board Examination.

"Indeed, the application of such schools is either under process or rejected by the Board. Some of them may not apply for affiliation at all," CBSE Secretary Anurag Tripathi said in a statement.

So, the parents, who wish to admit their children in CBSEaffiliated schools, are requested to check the affiliation status (including up to what class the affiliation is given by the board) of a school. They may go through CBSE affiliation web site to find the list of affiliated schools

Of these, 43 people developed fever, cough, or shortness of breath were isolated and test-ed for SARS-CoV-2, as well as asymptomatic healthcare professionals. Scientists noted that all 75 individuals tested negative for SARS-CoV-2. Assessing the data, researchers observed that on December 25, 2019, the female patient travelled to Wuhan where she visited a hospitalised relative and other family members with undiagnosed respiratory illness. On her return to the US on January 13, 2020, the study noted that she experienced six days of mild fever, fatigue, and cough before being hospitalised with pneumonia and testing positive for SARS-CoV-2. Prior to hos-


pitalisation, she was living with her husband, who has chronic obstructive pulmonary disease (COPD) and chronic cough, it said.

These conditions, the researchers said, made it difficult to determine the timing of his symptom onset related to COVID-19. Eight days after his wife was admitted to a hospital, the husband was also hospitalised with worsening shortness of breath and coughing up blood, and also tested positive for SARS-CoV-2, according to the study.

The scientists said both patients recovered, and were discharged to home isolation, which was lifted 33 days after the woman returned from Wuhan, following two negative tests for SARS-CoV-2 taken 24 hours apart.

After being in home detention for over seven months, Farooq Abdullah was released on Friday with the government revoking the draconian Public Safety Act (PSA) against the former Jammu and Kashmir chief minister.

The 82-year-old National Conference(NC) leader was initially taken into preventive detention on August 5 last, the day the Centre abrogated Article 370 of the Constitution that granted special status to Jammu and Kashmir, and later slapped with the PSA.

Walking out of his Gupkar road residence in Srinagar where he was kept under detention, Abdullah demanded that his son and former chief minister Omar and PDP's Mehbooba Mufti, also a former CM, and other politicians lodged in various prisons in the union territory and outside should be released at the earliest to allow political

activities. "Today, I am free but this freedom is not complete. It will be complete when other leaders like Omar, Mehbooba Mufti and others in outside jails are released," a frail looking **OPPN LEADERS SAY 'LONG OVERDUE'**



Abdullah said, appearing before Magistrate Shahid Iqbal Choudhary visited the resi-dence of Abdullah and handed reporters at the lawns of his home after spending 220 days in over the release order to him. detention.

According to an order issued by the Union Territory's home secretary Shaleen Kabra, the PSA ordered by the district magistrate of Srinagar on September 15 and subsequently extended for three months each on December 13 and March 11 this year, stands revoked.

Abdullah was booked under 'public order' of the PSA, a provision that allows authorities to detain a person for three months without trial. This can be extended up to two years. Officials said District

Abdullah, who underwent an eye surgery earlier this week, expressed the hope that he would be able to attend Parliament so that he can raise the voice of the people there. Immediately after his release, the NC issued a statement wel-

coming the decision and also urged the Union Territory administration to release other political leaders including Omar political leaders including Omar Abdullah, who is party vice pres-ident. The NC said the release of its patron from detention was the right step towards restora-tion of a genuine political process in Jammu and Kashmir. It said the process would receive further fillip when Omar Abdullah and other political Abdullah, a Lok Sabha MP detainees are set free. "We urge the government to do so at the from Srinagar, was the first chief minister to have been earliest," it said.

Himachal govt mulls raising income criteria for pension

"The board sentenced both of them to three years in a 'vishesh' or 'surakshit grah' (special or safe home) in Jaipur," case officer subinspector Ram Kishore said.

He added that the two were minors when the crime was committed but were in the age group of 18-21 years now.

They were part of the mob that lynched Khan, a 55-year-old dairy farmer, in 2017, and were convicted last week.

The Indian Penal Code (IPC) sections under which they were held guilty are 302, 147, 323 and 341, according to Inspector General of Police, Jaipur, S Sengathir.

Sengar gets 10-yr jail for death of Unnao rape victim's father

PNS NEW DELHI

Disqualified BJP MLA Kuldeep Singh Sengar was on Friday handed down 10 years rigorous imprisonment, besides imposition of a fine of Rs 10 lakh, by a Delhi Court for the death of Unnao rape victim's father in custody, saying "no leniency" can be shown for killing a family's "sole bread earner".

Sengar, who has already been sentenced to the "remainder of his natural biological life" for raping the minor Unnao girl, was stripped of his membership on February 25 of the UP Assembly following his conviction in the rape case.

Pronouncing the sentence in a packed courtroom, District Judge Dharmesh Sharma also awarded 10 years jail term to Sengar's brother Atul Singh Sengar and five others for their role in the custodial killing of the father of the rape victim.

The court, which did not hold the accused guilty of murder under the IPC, awarded maximum sentence for the offence of culpable homicide



not amounting to murder to convicts under section 304 of the IPC after holding that there was not intention to kill. Sengar and his brother will have to pay Rs 10 lakh each as fine within three months to legal heirs of the deceased, including the rape victim, as compensation.

Considering the minor children (of the deceased) losing their father who was sole bread winner of the family and keeping in mind the fact that the victim's family has been uprooted from their native place, all the convicts in the case are being sentenced to maximum punishment," the

maximum punishment under IPC Section 304, said that the children of the deceased has lost the protective cover of their father

court said in its order.

The court said Sengar and the co-convicts, two police officials, being public servants were supposed to uphold the law but there was no denying the fact that they broke the rule of law. "The way crime has been committed, the victim's father was beaten up and paraded, no leniency can be given to the convicts and therefore, I am sentencing all the convicts to the maximum punishment, the judge said.

Survey of India team 'detained' in Bengal village over NRC

Burdwan: A Survey of India team was detained by villagers in West Bengal's Purba Bardhaman district on suspicion that they were collecting data for the National Register of Citizens (NRC), officials said on Friday. The incident happened in Bahirghanya village in Galsi 2 block on Thursday when the five-member team went there for fieldwork, they said. Locals said that members of the team were taking photographs of places of worship, raising suspicion that they were in the village for the NRC exercise. The surveyors told the locals that they were in the village to update the map of the area but it failed to convince them, officials said. When the locals

sought to see their identity cards, they refused, following which they were detained, officials said, adding that members of the team were then taken to the BDO's office. Block Development Officer (BDO) Shankhya Bandyopadhyay said members of the team clicked photographs of temples and mosques in the village. Since there is a panic over the NRC, the sudden visit by the team led to tension in the village, he added. "They showed me an order relating to the survey exercise, but there was no prior information about it."

Bandyopadhyay added. The officer said that a meeting was held with the locals and they were told that the survey was not related to the NRC.

Annual health checkups for govt officials suspended till June 30

New Delhi: The government has suspended till June 30 the mandatory annual health checkup of all its officials in the wake of coronavirus outbreak to avoid unnecessary strain on hospitals and ward off chances of them getting infected in health facilities, officials said Friday. Annual health checkup is a mandatory requirement for the appraisal of all central government officials above the age of 40 years and it is to be done by March 31 every year, they said. CENTRE: FENCING AROUND FOREST AREAS PERMITTED

The Centre on Friday said it has permitted fencing around forest areas to ensure safety of people living in adjacent villages from attacks by wild animals.

Responding to a question raised in the Lok Sabha, Union Environment Minister Prakash Javadekar said the government is providing financial and tech-nical assistance to state governments for activities like erection of physical barriers around forest areas to avoid man-animal conflict.

"The Central government supplements the efforts of state governments by providing financial and technical assistance to the state/UT governments under various censponsored trally schemes for management of wildlife," said of

the minister in his written reply to a question asked by BSP MP Malook Nagar. "Activities such as construction/erection of physical barriers, such as barbed wire fence, solar powered electric fence, bio-fencing etc. are permitted under the schemes for ensuring safety of people living near forest areas," he added.

Wall of shame

A poster war over civil protesters in Lucknow, despite court orders, shows the UP Govt's stubbornness and arrogance



he first record of bounty-hunting or putting the price on the head of a thief came from a graffiti in Pompei in 79 AD. Since then bounties and rogues' galleries have been used to crack down on criminals, demonise native Americans in the civil war, segregate immigrants and outcasts, tame rebels and break rival chieftains and warlords in a feudatory dispensation of justice across the world. Except that these medieval practices are well past their time; clannish societies have evolved into modern nationstates that address conflict and dissent within a

defined socio-political architecture. Nowadays, the most wanted list is usually issued by Interpol. As for shaming the most hated social deviants, even petty criminals have the privilege of covering their faces when they are being taken to and from courts. Yet the Yogi Adityanath Government in Uttar Pradesh overrode all democratic convention and decided to name and shame citizens who may not be guilty of any crime. As he refuses to pull down hoardings with pictures of anti-citizenship law protesters — some of them notables and proven civil rights activists despite a High Court order on dismantling them, he has thrown us back to medieval times and worse. For by putting out their names, details and addresses, he has placed the judgement call on a dangerous entity called the people's court, which can be easily swamped by the tide of majoritarian sentiment. Although he insists that exposing protesters is required simply because they fuelled riots and are, therefore, responsible for destruction of public property, no credible case for conviction has been made out against them yet. Besides, while the shaming walls claim that the cost of repairing damaged infrastructure should be recovered from them, there have been news reports of spot recoveries by the State police and musclemen claiming endorsement of the regime, which have been nothing but a sanctioned loot. The Lucknow administration has even served property attachment notices to several individuals. And should the courts limit it further, the State Government passed an ordinance on recovery of damage to public and private properties during political processions. So even the democratic right to dissent via sit-ins comes with caveats. Let us not even hazard a guess about the life threats we are exposing these people to officially, leave aside the incivility of an invasion of their privacy.

Much of the recent actions of the UP Government, be it against citizenship protesters or lynch mobs, would have us believe that it is a law unto itself. What prompts it to ignore the Allahabad High Court order to take the shame posters down as they "reflect colourable exercise of powers?" What compels it to be bull-headed about challenging the order in the Supreme Court despite the latter's declaration that there is no law to back such action? The intransigence of the Adityanath Government indicates that the "baying for blood" emotion is seen as legitimate redress by a society, which has completely bought into the finger-pointing propaganda of the times. By putting out personal details of protesters and dissenters, who are as much nationalist as any of us, there is an implied punishment of the educated and informed mind, a demonisation of it as anti-Hindu and classist. Suddenly, they are more dangerous than the criminals facing serious allegations, including murder, in Uttar Pradesh. There is a message and licence to the mob here, to do whatever they deem fit with the protesters, much like the anti-semitic posters exposed Jews as the enemy in Hitler's Germany. It is also a warning to and intimidation of potential dissenters that the establishment will go after them regardless of institutional checks and balances. Furthermore, it is consciously identifying and humiliating people for not being "Indian." By encouraging a mob hitback against the "guilty", the Adityanath Government could easily absolve itself of responsibility saying that matters went out of hand in a volatile scenario, just like it did in Delhi. Even if extremist elements of the Sangh Parivar get involved, they become faceless in a mob. There is, after all, a precedent of such perpetrators going unpunished. Posters and shaming walls, something that were so long confined to social media trolls, are now being made mainstream. The Samajwadi Party (SP), although belatedly, has launched a political counterpoint, putting up hoardings of accused ex-Union Minister Chinmayanand and jailed Unnao rape convict Kuldeep Singh Sengar, both former BJP leaders, lambasting the party's sexual offender list. Of course, they were just as promptly pulled down. Protest graffiti by civil groups are an expression of their angst because the law is often an utter failure. But when an elected Government resorts to such agitprops, it appears not a protector but a destabiliser of citizenry. And it sits smug, particularly when political gains are to be made in the end.

Given a rise in gig economy, the time is ripe to ensure that the next revolution in the labour force is one that is allowed to grow and prosper, ethically and responsibly



t is well known that Jews faced severe exploitation, insult, discrimination and abuse in Naziruled Germany. They were unable to hold any relevant job, other than menial ones that were assigned to them by the State. The fact that they were Jews deprived them of any chance of getting employed. German employers (most of them) would not hire them due to the existing systematic bias and propaganda that was fed to them by the State and its media channels.

Yet, a number of them, who were discriminated against, found a voice through other means - some through academics, others through literature — and ended up being pioneers in their respective fields. However, a large number of them were ultimately relegated to jobs in concentration camps, under the will of their oppressive rulers, or were left to die hungry. The success of the Jewish community brings to focus an issue that should require no debate: No one is inherently or genetically good or bad at most jobs. This episode highlights the manner in which a country views its minorities be it on the basis of religion, caste or gender. The effects are limited not just in the way they face discrimination, through hate speech for example, but in more significant ways like a chance to earn a livelihood or to own a house.

This is where the "gig economy," which has seen massive expansion over the past few years, provides a ray of hope if we are willing to grab it. This can broadly be defined as an area of work where short-term jobs are assigned to individuals through online platforms. These positions range from hiring people directly for the customers for everyday jobs, like a driver or a maid or a plumber, to businesses hiring people on a freelance basis to help enterprises.

There is an argument that these jobs actually erode human resource or take advantage of the workers since there is no obligation to pay for their provident fund or to provide them with health cover, among other things. This does shed light on a valid concern. However, I think the gig economy has the opportunity to ensure that people, especially those who are discriminated against, find a way to earn a living and play a constructive role in society. The discrimination at workplace against minorities has been proved statistically. A 2010 study by Thorat and Attewell observed that in the case of equally qualified Scheduled Caste (SCs) and upper caste (about 4,800 each) applicants, SCs had 67 per cent less chance of receiving calls for an interview. What is more disturbing is that a higher percentage of less qualified high castes (undergraduate) received calls compared with the more qualified SCs



(post-graduates). The numbers are indeed shocking. In the case of other communities, who, too face discrimination, enough statistical and anecdotal proof exists that employers are reluctant to hire people from minority communities (assuming all things being equal). This is why even as the Muslims constitute roughly 14 per cent of India's population, they only make up three per cent of India Inc. With workplace gender discrimination remaining an issue of much debate, there's hardly any impact on the ground. In fact, things are getting worse for the women. According to a Deloitte report, female labour force participation in India fell to 26 per cent in 2018 from 36.7 per cent in 2005.

These are worrying trends and this is where the gig economy has the potential to alter the situation. This is evident from the number of minority communities that are registered on various online platforms as participants of the gig economy workforce. What may have started as a compulsion, on being excluded from the regular work force, may present women, SCs, STs and Muslims an opportunity to thrive in the labour workforce.

Of course, this dream has some caveats. There have been instances in the past where we have seen discrimination on these platforms too. ne of the defining characteristics of the Indian State has been the humanitarian operations it has carried overseas to bring back stranded Indians whenever and wherever they may have been. The China rescue mission in the wake of the spread of Coronavirus was one that silenced naysayers. With minimal support from the virus-stricken country and much bickering, direct diplomacy helped us secure all our citizens back on home soil. The Government is now bracing up for the challenge to bring back its citizens from Italy and Iran, the second and

third most COVID-19 affected countries after China. While the Wuhan rescue operations were at the very initial stages, when the deadly disease didn't assume such alarming proportions confined as it was within the country, the current mission is being undertaken when COVID-19 has been declared a pandemic. Like in China, poignant stories abound of stranded Indians making desperate pleas, asking the Government some uneasy questions like where they are supposed to go and why they are being treated as smugglers. Panic-stricken students, fishermen and pilgrims in Italy are still not aware that they have to furnish a "Coronavirus negative" certificate before boarding a rescue aircraft. With the Italian health networks bursting at the seams, we are now flying out teams of doctors and virologists to test stranded Indians before bringing them back. This is a cumbersome process and in these stressed and stretched times, our embassies need to be proactive than protocol-bound in calming anxieties. Many Indians claim that their calls to emergency numbers, too, went unanswered. This suffering could have been avoided had the Indian embassy and by extension the Government ensured that the information about the requirement of the certificate from Indians returning from new Coronavirus hotspots had been disseminated properly. The embassy should have put up notifications on its website. A day-to-day interactivity should be immediately built in our response systems overseas and we should not be relying on SOS on social media, which is prone to fear-mongering than actual information.

India's first Land Records and Services Index is a way to gauge States' relative performance and help improve services on the ground

he National Council of Applied Economic Research (NCAER) recently released India's first Land Records and Services Index (N-LRSI), 2020, based on data collected over 2019-20 on two aspects of the supply of records — the extent of digitisation of land records and its quality. The first component, which aims to assess whether a State has made all its records digitally available to citizens, looks at three dimensions - the text (also called the record of rights), the official map associated with a land record (also called cadastral maps) and the property registration process. The second component of the index aims to assess if the data is comprehensive and reliable. Whether ownership details are updated as soon as a sale occurs; the extent of joint ownership; type of land use; size of the plot on the record and on the map and if encumbrances are being recorded (other claims on the property such as mortgages and court cases). All these elements are closely connected to property disputes and to the ease with which transactions can be completed, legally recorded and accessed. Madhya Pradesh, Odisha, Maharashtra, Chhattisgarh and Tamil Nadu are the five bestperforming States on the index.

One of the unique features of the N-LRSI, 2020 is its ability to assess the relative performance of States on various components and subcomponents of the index. There is no State/UT that emerges victorious on all the parameters of the index as they are at different stages of progress with regard to the extent of digitisation of records and the registration process. For improved land record management, laggard States should extract lessons from the better-performing ones on various parameters, which can possibly drive change in State-level policies. While for textual record digitisation, Dadra Nagar Haveli, Chhattisgarh and Goa appeared to be leading, Lakshadweep, Madhya Pradesh and Chhattisgarh topped the list for spatial record digitisation. For the registration component, Maharashtra emerged as the leader, while Jharkhand, Odisha and Chhattisgarh were front runners due to quality records.

The findings will enable States to make efforts in the direction of creating more comprehensive and accurate records, by adopting the initiatives that successful States have made. In addition, the index brings out certain areas where no State/UT has taken any initiative. Effective integration across departments is one such area. The N-LRSI analysis has brought out the poor synergy across land record departments - revenue department as the custodian of textual records, the survey and settlement department managing the spatial records and the registration department. The N-LRSI design entails a sub-component of updating of ownership (within Quality of Records component), which gauges the extent of integration between registration and textual records - swiftness of the process of updating ownership as the result of registration of a transaction, the phenomenon which is commonly known as mutation. The information obtained from all the State/UT sources in this regard revealed that no State/UT has the provision for mutation on the same day as the registration. Moreover, there are only seven States/UTs that have the second-best alternative wherein a note indicating the registration appears in the textual record copy. The study also brought out the weak linkage that exists between the revenue department and survey and settlement department. This creates a huge divergence between the land area reported by the textual and spatial record, enhancing the chances of legal disputes over the definition of boundaries and extent of a land plot. With such poor inter-departmental synergy, aspiring for updated and accurate records will always be a distant goal and States/UTs should strive to undertake necessary actions to have the appropriate systems in place.

With varied recommendations for land record management, the N-LRSI, 2020 holds immense significance for a number of related factors. It is likely to be a helpful tool to assess the quality of key Government services like PM-Kisan, that are dependent on land record details. The efforts by States to improve land record digitisation and guality are expected to increase the chances of accurate identification of PM-Kisan beneficiaries and enhance the scheme's effectiveness. The index can be a signalling factor for investors, as a clear title is one of the prerequisites for land acquisition that a firm envisions for setting up an industrial unit. An improved quality of land records, with accurate information that mirrors the ground reality, is expected to provide the necessary push to the underdeveloped mortgage market in India. As per the Committee on Household Finance, 2017 mortgages account for only 23 per cent of total liabilities in India. One of the primary reasons for this dismal situation is the inferior quality of land records, which are often not updated, indicating a high possibility of disputes. Without clear titles, it is not possible for banks to give out loans against the land/property. For instance, if the record does not get updated to reflect the subdivision of property, it cannot be used by the on-ground owner to request for a bank loan. With serious challenges of availability and use of data and information confronting the land policy and governance, the index promises to offer a pivotal solution to improve the existing situation.

Patching up lives

Quilting has not only become a powerful way to advocate change around the world, it has provided a healing touch to marginalised sections of society as well

n 2014, four years before the Supreme Court of India decriminalised homosexuality by declaring Section 377 of the Indian Penal Code unconstitutional in respect of consensual homosexual sex between adults, a group of people belonging to the LGBTQI community in Chhotaudepur, decided to step out of the shadows. Instead of using street protests to voice their opinions, the Gujarat-based group adopted a unique way to advocate their rights. With many of them being henna artists, the group used their artistic skills to design and stitch a patchwork quilt. Christened the "Henna Pride" advocacy quilt, their labour of love has since been taken around the world for creating awareness about the lives, trials and tribulations of its makers and for raising the issue regarding liberty for all com-munities, irrespective of their gender and sexual orientation.

Exhibited at the 2019 summit of the International Conference on Population and Development (ICPD+25) in Nairobi, the quilt drew attention to the challenges members of the LGBTQI community face in advancing their sexual health and reproductive rights, despite gains like the Supreme Court's landmark judgment

Quilting has not only become a powerful way to advocate for change, it has provided a heal-ing touch as well. Making the "Henna Pride" quilt was particularly liberating for the team from Vadodara-based Vikalp, a not-for-profit organisation that works with tribal and transwomen, as homosexuality was considered a crime in India at the time.

The whole process of coming together to make the quilt was empowering," says Maya Sharma, co-founder of Vikalp. "They didn't have a voice and finding that voice was important. The quilts gave them a sense of purpose and represented the change that happened within, just by coming together. Just the process of sharing their experiences helped transform their lives. Although Payal is one of the few educated, young tribals in his village, he had not been able to garner enough support to effectively combat stigma and discrimination. But joining hands with others like him boosted his confidence and selfbelief. Today, he is the leader of a group and helps young people in tribal areas around his village live a dignified life. Now, there is greater freedom to dress and feel like a woman and to dance and celebrate without facing any backlash. Payal's colleague, Dakshaben, who joined Vikalp nearly 15 years ago, has become a journalist in a small newspaper. Dakshaben, a survivor of domestic violence, initially worked at women's courts in Tilakwada to arbitrate cases of women like her, who were exploited and battered by their husbands. She brought a gender perspective to the quilting process, having been an outreach worker and possessing deep knowledge of her tribal community. Cast the food security net wide

The Government, the private sector, civil society organisations and agencies like the UNWFP can together achieve zero hunger and improved nutrition, leaving no one behind



ith remarkable progress in foodgrain production, India has made a successful transition from being a food-deficit nation to a food surplus one. However, efforts to address malnutrition have not manitained the same pace. According to the latest Comprehensive National Nutrition Survey, 34.7 per cent of children under five years of age are stunted, 17.3 per cent suffer from wasting and 33 per cent are underweight. There is also a high prevalence of anaemia and micronutrient deficiency disorders. This is the result of a multitude of underlying factors, including lack of access to health

and nutrition services caused by social, economic and geographical barriers, and inhibiting social norms and structures. Climate change further exacerbates the existing threats to food security. With one decade left to achieve the ambitious goals of Agenda 2030, which include an end to hunger and all forms of malnutrition, bold action by a variety of actors - including the Government, civil society and UN agencies - is needed.

The strong policies and pro-grammes put in place by the Government, including the implemen-tation of the National Food Security Act, 2013, the launch of the National Nutrition Strategy, 2017 and the flag-ship initiative of POSHAN Abhiyaan to improve nutrition in children, adolescents, pregnant and nursing women, are leading the way. Local action at the State level, with remarkable progress made by the 117 aspirational districts, is accelerating the process. Several States across India are in the process of

address food insecurity and malnutrition. If maximised, these have the potential to transform the current status of malnutrition in the country. The use of technology to improve efficiency of food safety nets is one example of this. While, at the Central level, the Government is implementing the One Nation, One Ration Card scheme, which allows migrants to access their public distribution rations anywhere in the country, States like Odisha have deployed mechanisms that ensure proper targetting of food even in case of authentication failures. Similarly, Uttar Pradesh has pioneered the use of an interactive voice response system that not only allows beneficiaries to register their complaints but also provides accurate and updated information to

In order to improve consumption patterns, diversify diets and enhance nutritional outcomes, it is crucial to focus on knowledge sharing. Behaviour change communication strategies to promote healthy eating habits can leverage the cultural and social aspiration of communities to encourage them to choose nutritious and appropriate diets. Eradicating malnutrition is an ambitious target, which individual entities cannot achieve alone. The private sector can bring in efficiencies and innovative solutions, civil society organisations have a key role to connect communities to the initiatives being designed and implemented for the most vulnerable and agencies like WFP can provide technical support and share international experience and best practices. Together, we can reach the goal of achieving zero hunger and improved nutrition, leaving no one behind.

ting lost." In Ajrak, the process of dyeing and printing the fab-ric is repeated again and again with different kind of dyes to achieve the perfect design. How challenging is it to deal with such a slow and time-consuming process and yet balance it with the deadlines? "Yes, it is an extremely tedious technique and requires a lot of atten-tion and care. We coat the fabric with a photosensitive material so that the design and the colours are exposed. The entire process can even take around two weeks to finally come to end. But once it takes shape, every design differs from each other in various aspects. That is the beauty of it," says Nida.

Eco-sensitivity forms the core of her collection as the techniques used for dyeing, printing and other surface ornamentation are sustainable. Even the process of Ajrak printing is long-last-ing as it uses colours from natural elements like turmeric, pomegranate, onion peels, tea leaves, beetroot, hibiscus, marigold, natural indigo and many others. "It is very important to consider the impact of the fashion industry on the land that we are living. This is an eco-friendly brand. We focus on circularity in fashion which promotes mini-mum waste and an optimum use of all resources. We make sure to constantly minimise the negative impact of any resources on environment," says she. While the designer is

known for introducing new trends in fashion, what has been her creative process? "I believe in following my heart as a creative person and the only rule is to not have rules. When one doesn't box oneself in the rules set by society or any indus-try, one is able to create work that is fresh and has an independent and fresh per-

spective," says she. As the fashion trends keep evolving with every season, a designer needs to constantly update his/her designs. What keeps Nida going? 

Matches in the English Football League, Women's Super League, all football in Scotland and international friendlies for England and Wales have also been suspended.


"Following a meeting of share-holders today, it was unanimously decided to suspend the Premier League with the intention of returning on 4 April, subject to medical advice and conditions at the time," the Premier League said in a statement.

Everton also announced a player is in self-isolation for seven days after reporting a high temperature.

The rest of their first-team squad and coaching staff have been told to stay away from all of the Merseyside club's sites.

Leicester City had three players go into self-isolation on Thursday and Bournemouth said goalkeeper Artur Boruc and four staff members were taking the same precaution.

However, the news of Arteta and Hudson-Odoi's positive tests in the last 24 hours forced the English football authorities to act.

Hudson-Odoi said he had already "recovered" from the virus but will continue to



self-isolate. "As you may be aware I had the virus for the last couple of days, which I've recovered from," the England international posted in a video on social media.

"I'm following the health guidelines and self-isolated myself from everybody for the week. I hope to be back on the pitch very soon?

All matches in Scotland, including Sunday's Old Firm derby between Rangers and Celtic, have also been indefinitely suspended.

'Today's announcement is made in the interests of public health but, equally, the health and safety of players, match officials, and staff across the game," said Ian Maxwell, Scottish FA Chief Executive.

'It is also why the Scottish FA is compelled to ensure that the suspension is cascaded through the non-professional and grassroots games until further notice."

"In the light of developments due to the spread of COVID-19 in Europe and related decisions made by different governments, all UEFA club competitions matches scheduled next week are postponed," UEFA said in a statement

"Further decisions on when these match-es take place will be communicated in due course.

The postponements also affect all the second legs of the Europa League last-16 round. Six of the eight first-leg matches were

played on Thursday, four behind closed doors. The other two matches, between Inter Milan and Getafe and between Sevilla and Roma, were called off.

UEFA also confirmed that the draws for the Champions League and Europa League quarter-finals, which were supposed to be held next Friday, March 20, were postponed as a consequence.

The body will hold a crisis meeting next Tuesday to work out a way forward for their club competitions and for Euro 2020, which could now be postponed by a year due to the pandemic.



No plans for Olympics without spectators: Japan AFP OLYMPIA

TOKYO: Japanese government officials insisted on Friday they have no plans to alter the Olympics, including holding it without spectators, after US President Donald Trump proposed a delay over the coronavirus.

The fate of the 2020 Games, scheduled to open in Tokyo on July 24, has been thrown into doubt by the outbreak of the virus, now dubbed a pandemic.

But organisers, Japanese government officials and the International Olympic Committee have insisted preparation for the Games is on track, with no expectations of a postponement or cancellation.

"There is no change in the government policy in that we closely cooperate with the IOC, the organising committee, and the Tokyo metropolitan government to steadily prepare for holding the Games as scheduled," government spokesman
