# Diluted lockdown till May 17


### Curbs stay in Red zone, buses can ply in Green zones at 50% capacity

The Union Home Ministry extended a diluted lockdown for two more weeks from May 4 by allowing a series of relaxations and classifying the districts into three categories — Red, Orange and Green Zones — for this purpose. Except in 130 Red zone district, major shares of normal activities will resume with different sets of restriction in 80 per cent of the country comprising 284 orange zones districts and 319 green zones dis-

Public movement will not be allowed for non-essential activities in all zones from 7 pm

In green zones, all activities are permitted except the limited number of activities which are prohibited throughout the country, irrespective of the zone. However buses can operate with up to 50 per cent seating and depots can operate at 50 per cent capacity.

In Red Zones which are high risk areas or containment zones, private vehicles are permitted with two persons and driver for four wheelers. Two wheelers can zip around without a pillion rider. Liquor shops, malls and barber shops will remain shut in red zone. However, liquor shops and pan shops will be opened in green

zones with a caveat that not more than five persons will be present there at a time. Since Delhi and all other metropolitan cities are Red zones, the booze lovers will have to keep waiting for further relaxation.

Red and Orange Zones are known as Containment Zones, where local administration is asked to ensure the usage of Aarogya Setu App by all, including daily monitoring and surveillance of Covid-19 situations on regular basis. Hotels, Restaurants, Cinema Halls, gyms, etc, are not allowed in Containment Zones.

Private offices with 33 per cent attendance will be permitted to open in Red Zone, but public transport, including taxis and even auto-cycle rick shaws will not be allowed.

**India split into 3** zones: 130 dists in Red, 284 Orange, 319 in 'free' Green

PNS NEW DELHI

As the total tally of coronavirus cases zoomed past 36,000 on Friday, the Centre split 733 districts across India into Red, Orange and Green zones, designating all metropolitan cities (Delhi, Mumbai, Chennai, Kolkata, Hyderabad, Bengaluru and Ahmedabad) into the "no activity" zone.

According to the list, there are 130 Red zone districts, where more stringent restric-tions will be enforced post May 3. However, there will be partial easing in Orange zones (284 districts) and liberal easing in Green zones (319 districts). Current classification is

based on the incidence of coronavirus cases, doubling rate, the extent of testing, and surveillance feedback.

In a letter to Chief Secretaries of all States and Union Territories, Union Health Secretary Preeti Sudan gave details of the grading districts in three categories, Red, Orange and Green.

According to the letter, Andhra Pradesh and Bihar each have 5 districts in the Red zone, Delhi has 11 while Iammu & Kashmir 4. Jharkhand has 1, Karnataka 3, Kerala 2, Maharashtra 14, Odisha 3, Tamil Nadu 12, Uttar

Pradesh 19 and Bengal 10. As per the letter a district will be considered under green zone if there are no confirmed cases so far or there is no reported case for the last 21 days in the district. "All States are accordingly

requested to delineate the containment zones and buffer zones in the identified red and orange zone districts and noti fy the same," she said. All the six metros — Delhi,

Mumbai, Kolkata, Chennai, Bengaluru and Hyderabad have been classified as red zone by the order.

# Special trains to take stranded back to home

After repeated flip-flops on the issue of mode of transport for millions of migrant workers stranded across the country in the lockdown, the Centre on Friday allowed using of trains for ferrying them to their home States.

Addressing a Press conference, Joint Secretary in the Ministry of Home Punya Salila Srivastava said stranded people such as migrant workers, tourists, pilgrims and students can now be transported using trains. "States and the Railway Board will make the necessary arrangements for the same," she

Only a day ago, the Centre said buses can be used to transport these workers. This was opposed by several States which demanded that special trains should be introduced to transport these migrant workers, claiming that it would be impossible to arrange tens of thousands of buses for this pur-

Before that the Centre repeatedly opposed the demand to send them back home, saying it would lead to spread of coronavirus

## 2,300 new cases in **12 hours on Friday**

### Maha adds over 1K; Telangana joins the race

PNS NEW DELHI

On a day the Centre extension by two weeks, the country saw its biggest single day surge of 2,300 plus new cases in just 12 hours on Friday with Maharashtra alone logging 1,008 new cases, taking

the tally of cases to 11,506. While 106 patients were discharged on Friday upon recovery, 26 Covid-19 patients died, the State Health Department said. The death toll in the State thus reached 485 and number of discharged patients reached 1,879.

Maharashtra continued to be the most affected State in the country with a total number of positive coronavirus cases jumping to 11,506 while the death toll stood at 485. For the first time Telangana became the latest State to cross more than 1,000 confirmed cases to touch at 1,044.

In terms of the cases reported, Maharashtra was fol-

lowed by Gujarat at 4,721 cases with 236 deaths, Delhi at 3,738 cases and Madhya Pradesh at 2,719 cases and 137 deaths. Gujarat added 326 new cases, Delhi and MP 90 respectively.

The other States th reported total cases in four digits were Rajasthan (2,642) Tamil Nadu (2,526) and Uttar Pradesh (2,328).

Tamil Nadu saw a major surge on Friday with day's cases soaring by 203 and Punjab added 105 cases to follow a worrying trend following several Takhat Sachkhand Sri Hazur Abchal Nagar Sahib pilgrims testing positive again on Friday.

In West Bengal, the official death count is 33 while the Government has said 72 others who had coronavirus and died, passed away because of their co-morbidities.

Among other major States, Andhra Pradesh has reported 1,463 cases and 33 deaths, Bihar stood at 426 cases and two deaths, Haryana at 313 and three deaths, Jammu & Kashmir at 614 cases and eight deaths, Karnataka at 576 and 22 deaths and Kerala clocked 497 cases and four deaths.

### In Red zones

- Movement of individuals and vehicles is allowed only for permitted activities, with a maximum of 2 persons (besides the driver) in fourwheeler vehicles, and with no pillion rider for two-wheelers
- Industrial establishments in urban areas, viz., Special Economic Zones (SEZs), Export Oriented Units (EOUs), industrial estates and industrial townships with access control have been permitted

### High test rate 2,300/million in Delhi: CM

A gainst the national average of 654 coronavirus tests per million population as on May 1, Delhi is conducting about 2,300 tests.

Capital has high number of Covid-19 patients, above 3,600, the high rate of testing every 10 lakh population can be one of the reasons for the high rate of coronavirus cases in Delhi, said Chief Minister Arvind Kejriwal on Friday.

"When we see this number, it seems that cases are rapidly increasing in Delhi. It is happening because we are conducting tests on a large scale in Delhi. We are conducting 2,300 tests per 1 million people in Delhi," said Kejriwal.

The CM also said that the Delhi Government will not stop clinical trials of plasma therapy to treat severally-ill Covid-19 patients as its initial results are good.

The announcement by the Delhi CM came days after the centre said that plasma therapy for treatment of coronavirus patients is at an experimental stage and it has the potential to cause life-threatening complications.

# **Gurdwara shut after 91** more pilgrims test +ve

Local authorities sealed Nanded's Hazur Sahib gurdwara on Friday, hours before Punjab reported that 91 more people who returned from the shrine in Maharashtra had test-

ed positive for coronavirus. So far, 197 pilgrims out of the 3,500 brought back from the Maharashtra gurdwara, among the holiest sites in Sikhism, have contracted the infection, according to authorities in

The returning pilgrims formed the bulk of 105 fresh

cases reported in Punjab on The 197 Nanded pilgrims are a third of the 585 confirmed coronavirus cases reported so far in Punjab. Taking into account the 20 deaths and people who have recovered, they represent about 40 per cent of

the "active cases" in the state. In neighbouring Haryana, 18 Nanded pilgrims are in quarantine, officials said.

Punjab had remained stranded for about a month at Hazur Sahib gurdwara in Nanded due to the nationwide lockdown to fight the coronavirus pandem-

Gurdwara Langar Sahib on the same premises, which serves food to all visitors, has also been

sed, officials said in Nanded. District and civic officials reached the gurdwara in the morning on Friday and directed that it be closed and the langar service be stopped," gurdwara superintendent Gurvinder

Singh Wadhwa said. The pilgrims heading back to Punjab had made halts at Indore, one of the country's worst coronavirus-affected Bhilwara Hanumangarh in Rajasthan, and Bhatinda, according to gur-

dwara functionaries. Baba Balwinder Singh of Langar Sahib said there are still about 175 people from different states in the complex.

Dal asked Amarinder Singh to apologise to the Sikh community for "mismanaging" the repatriation of pilgrims from

SAD leader Sukhbir Singh Badal demanded that Punjab Health Minister Balbir Singh Sidhu should be sacked for "failing" to ensure the pilgrims safety. In a video clip, Akal Takht jathedar Harpreet Singh on Friday claimed there was a conspiracy to "malign" the Sikhs just as the Muslims were after the Tablighi Jamaat episode. The reference by the Amritsarbased jathedar was to the Tablighi Jamaat congregation in Delhi in March. Hundreds of people who participated and then returned to their homes across the country had tested

"It is being propagated as if Takht Sri Hazur Sahib was the home to coronavirus and these people carried it with them to Punjab," he alleged.

### **Searches zoom for** ration dukaan, how to homeschool kids amid coronavirus

New Delhi: People turned to Google to search for ration dukaan (grocery store), how to homeschool kids and even, best trading platforms with these terms seeing a huge spike in the January-March — as people seek ideas on how they can stay productive indoors amid the coronavirus outbreak.

According to data released by Google, "near me" searches have seen a massive uptick, especially queries like "pharmacy near me" (58 per cent rise), "grocery delivery near me" (550 per cent) and "ration dukaan" (300 per cent).

It added that unlike 2019 when queries like "best headset" or best mattress" were popular, 2020 was all about "best movies" (35 per cent rise) and "Best trading platforms" (45 per cent

jump).
With a majority of users being homebound, there has also been high growth in queries like "learn online", "teach online, and "at-home learning". In fact, 1 out of every 2 consumers is seeking personalised information from brands by searching for queries like "how to homeschool kids" and "how to WFH", the data showed. Interestingly, queries in the health category have recently pivoted toward "immunity" (500 per cent rise). Searches for vitamin C, which grew by 40 per cent in 2019, have surged by over 150 per cent in recent weeks, as have queries for herbs with medicinal properties like giloy (380 per cent rise) and Ayurvedic home remedies like Kadha (90 per cent rise).

Bengaluru's Bannerghatta Biological Park (BBP) has come out with a programme during the lockdown period for those looking for an opportunity to conserve wildlife and adopt animals at the zoo.

Certain privileges such as gift voucher for zoo visit and display of name in adoption board would be extended for adopting an animal, depending upon the adoption amount.

The animal adoption programme is an opportunity for you to get involved in supporting feed and veterinary care expenses for zoo animals with provision for Income Tax rebate under 80G. There are 21 elephants which can be adopted online!" say zoo officials.

The BBP has released a list of animals that can be adopted.

One can adopt the likes of King cobra and Indian rock python for ₹3,500 per year, and jungle cat and Assamese Macaque for ₹5,000.

Adoption of black buck and

sambar will cost you ₹7,500 per year, Emu ₹10,000, spot-billed Pelican ₹15,000, Golden jackal ₹20,000, Indian leopard and sloth bear ₹35,000, Zebra ₹50,000, Hippopotamus ₹75,000, and Bengal tiger and Giraffe a flat ₹1 lakh, among others.

"The purpose of the adoption programme is to create awareness and connect with people involved in conservation activities, not just generating revenues," the Executive Director of the government-run BBP, Vanashree Vipin Singh told PTI on Friday. "We dont run this programme with profit motive."

The zoo, which sees an annual footfall of around 15 lakh, has been closed since the middle of March following lockdown declared in the wake of the Covid-19 pandemic. It received a record 23,000 people on a single day on January 1 this year.

The animal adoption initiative is part of the BBPs outreach programme as people are not able to visit the zoo due to the lockdown. In other times, interested people sign up to adopt animals during their visits to the zoo, she said.

### Two more cops probing Markaz case test positive

On March 31, Delhi Police's Crime Branch lodged an FIR against seven people, including Tablighi Jamaat leader Maulana Saad Kandhalvi, on a complaint by Station House Officer, Nizamuddin, for holding a religious congregation here allegedly in violation of the lockdown orders and not maintaining social distancing to contain the spread of coronavirus.

Earlier on Thursday, two police personnel from Khajoori Khas police station in Northeast Delhi were tested positive for Covid-19.

A letter from Muktesh Chander, Special Commissioner of Police, Operations stated that it has been reported that two police personnel from Khajoori Khas have tested positive for Covid-19. They were residing at Barrack Number 5 of PŚ Khajoori Khas.

"In the same barrack, the staff of Commissioner of Police reserve was also residing. It is important that they are also tested for Covid-19 and are quarantined immediately. Similar precaution need to be taken for all CP reserve staff at other locations too," the letter further stated.

In all zones, educational institutes, public and social religious gathering will not be allowed. The States are empowered to add Red or Orange Zones, but they can't decrease them. The Union Health Ministry will decide the classification of Red, Orange and Green Zones on weekly basis.

At present out of total 773 districts, 130 districts are classified into Red Zones and big cities like entire Delhi, Mumbai, Kolkata, Chennai fall under Red Zones. As many as 284 districts are under Orange Zones and rest 319 falls under Green Zones.

In all zones, persons above 65 years of age, persons with co-morbidities, pregnant women, and children below the age of 10 years, shall stay at home, except for meeting essential requirements and for health purposes.

Similarly, AMTZ will be supplying 13,500 ventilators, said Vaghela.

Also, "Over 4 lakh oxygen cylinders are available which is sufficient for today's requirements. Orders for more than 1 lakh oxygen cylinders have been placed and industrial oxygen is being converted into medical oxy-

Telangana to Hatia in Jharkhand on Friday morning, ferrying over 1,200 migrants in 24 coaches. The second train which ferrying over 1,200 migrants people has left from Aluva railway station, Ernakulam to Bhubaneshwar. 'These special trains will

be run from point to point on the request of both the State Governments concerned as per the standard protocols for sending and receiving such stranded persons. The railways and State Governments shall appoint senior officials as nodal officers for coordination and a smooth operation of these 'Shramik Specials," the Railways said.

According to the guidelines issued by the railways, the passengers of these trains

will have to be screened at the boarding points by the States sending them and only those found asymptomatic of Covid-19 will be allowed to

Governments will have to bring these persons in batches that can be accommodated in the train to the designated railway station in sanitised buses, following social-distancing norms and other precautions. It will be mandatory for every passenger to wear a face cover. Meals and drinking water would be provided to the passengers by the sending states at the originating stations.

Earlier, a spokesperson of the South Central Railway zone, said the special train from Lingampally to Hatia will reach on Saturday morning. The 1,140 migrant workers, all residents of Jharkhand, were stranded at the Indian Institute of Technology (IIT)-

Hyderabad campus at Kandi in Sangareddy district due to the lockdown. The 24-coach train, which usually seats 72 people in a compartment, contained only 54 people in each in accordance with social distancing guidelines. All passengers were also screened for symptoms before being allowed to board.

# 33% recovered, Delhi tops test ratio: CM

Citing Delhi's Covid-19 Chealth bulletin, Chief Minister Arvind Kejriwal said on Friday that out of 3,515 corona cases in Delhi, 1,100 patients recovered and were discharged from hospitals till Thursday. On Friday, 223 new cases were reported in Delhi taking the number to 3,738.

Elaborating virus testing in Delhi, Kejriwal said that testing rate in Delhi has increased and 2,300 tests per 1 million people are being conducted as against the national average of 500 tests per million people.

According to health department database, 59 people have lost their lives while 2,362 cases are active and being treated at various hospitals.

"Common perception would be that there is a sudden and steady rise in the number of Covid cases in Delhi, but we have also decided that we will increase testing in Delhi to monitor those who have been infected and treat them thereafter. This will also ensure the prevention of the spread of Corona from infected people," Kejriwal said.

While testing in Delhi is high pace compare to other states in India, Kejriwal said that the positive aspect of due to more testing it seems like cases are rising in Delhi. "The positive aspect of this, howev-



er, is that infected people are getting recovered. A total of 1,100 people have been cured and discharged to date. More recoveries are happening day by day." "59 people have lost their lives, which means that the death ratio is much less here as compared to other states and countries. "We are taking all possible steps to stop the spread of Corona. We have created containment zones, which are now getting de-contained because of all our measures. We have also deployed machines for sanitisation," he

"A cross-movement borders connecting Delhi have been restricted only essential services are exempted. We won't allow any unregulated movement through the border. This will help to curb the coronavirus spread," said Amit Deputy Commissioner of Gurugram.

"A case under section 186, 353, 307 of Indian Penal Code (IPC) and 25/27 Arms Act was registered against Shahrukh on February 26 at Jaffrabad police station and during investigation sections 147, 148, 149 and 216 of IPC were added," said police.

"The weapon of offence, a 7.65 mm pistol and two live rounds were recovered from Shahrukh in this case," police further said.

On February 23, clashes had broke out between pro and anti-CAA groups near Jaffrabad in northeast Delhi where a large number of people had gathered to protest against the Citizenship Amendment Act. Police fired tear gas shells as

members of the two groups pelted stones at each other in The 500-strong group dom-



# **Mask vital part of school** uniform post lockdown

### Centre devising new guidelines for functioning of academic institutionS

PNS NEW DELHI

With corona pandemic scare likely to impact functioning of all establishments and institutions for some time to come, the Centre is devising new guidelines for the modus operandi of academic institutions.

Sources in the HRD Ministry said that new seating arrangements in classrooms, hostels, common spaces, libraries and assembly among others keeping in mind the social distancing mantra to fight COVID-19 will be enforced when the classes resume.

For schools, suspension of morning assemblies and sports activities in the playground, norms for school buses, do's and dont's in washrooms and cafeterias and regular disinfection of entire buildings, could be part of the guidelines even as masks will be a mandatory part of school uniforms. For residential schools, guidelines will detail social distancing norms to be followed in messes and hostels.

A HRD Ministry official said whenever schools and colleges reopen, proper social distancing norms will have to be followed as health and safety of students have to be the prior-

The guidelines are being formed by the Ministry's Department of School schools and colleges. Education and Literacy for schools and by the University Grants Commission (UGC) for universities and higher education institutions.

Universities and schools across the country have been closed since March 16 when the Central Government announced a countrywide classroom shutdown as one of the measures to contain the COVID-19 outbreak. Later, a nationwide lockdown was announced on March 24, which was extended till May 3.

While the UGC has already recommended that academic session for freshers may begin in September and for enrolled students in August, schools are also doing teaching-learning activities through different virtual mediums.

"The guidelines will include a checklist and recommended measures to ensure student and staff safety. However, the COVID-19 situation in a particular area will also be have to kept in mind and the institutions will have flexibility to adapt to the guidelines accordingly

The Minister has reiterated many times that the safety and health of students has to be prioritised," said the official.

The total number of Covid-The total number of Covid-19 positive cases in 31 Battalion of CRPF reached 70 on Friday of which one has recovered and another has died leaving a tally of 68 active cases even as the ITBP has now contracted the viral disease with five personnel getting inflicted with the pandemic. Meanwhile, 49 personnel

including a Deputy Inspector General, of the Welfare Branch of CRPF headquarters here after Havildar showed symptoms of the pandemic on Wednesday even as his test report for Covid-19 is awaited.

In the Indo-Tibetan Border Police (ITBP), two personnel deployed here with the Delhi police company at Shastri Park and residing in Rohini area with the Company have been tested positive for the disease. Another three personnel tested positive for corona virus

# PPE not 100% skin injury-free for corona warriors

The protective gears meant to protect them during their fight against the deadly contagion are harming corona warriors globally in more ways than one. If the risk of falling prey to the deadly invisible virus wasn't enough, frontline healthcare workers are battling an altogether different problem their protective gears are leaving them bruised.

A new study of medical staff treating Covid-19-infected patients has found that 42.8 per cent experienced serious skin injury related to the use of (PPE), including masks, goggles, face shields, and protective

Researchers concluded that the skin injuries put staff at increased risk of infection, with insufficient prevention and treatment measures in place, according to the study published in Advances in Wound Care, a monthly peerreviewed journal from Mary Ann Liebert, Inc., publishers.



Injury Caused by Personal Protective Equipment Among Medical Staff in Fighting Covid-19: A Multi-Center, Cross-Sectional Study" was coauthored by Qixia Jiang, Nanjing University School of Medicine (Nanjing, China) and a large team of Chinese

pressure injuries; moist associated skin damage; skin tear.

Several factors increased the risk for skin injury: heavy sweating, greater daily wearing time, being male, and using grade 3 versus grade 2 PPE.

"These significant findings are consistent with independent observations in Europe and United States, and call for systematic studies addressing skin injury and repair in Covid-19+ patients as well as in their healthcare providers," said Editor-in-Chief Chandan K. Sen, PhD, Distinguished Professor at the Indiana University School of Medicine and Executive Director of Indiana University Health Comprehensive Wound Center, Indianapolis, IN.

### Five more States, including Bihar and Punjab, join 'One Nation-One Ration Card' system

vive more States, including Bihar and Punjab, have joined the 'One Nation-One Ration Card' system, taking the total ration card portability to 17 States and Union territories helping 60 crore beneficiaries. The food ministry is aiming to implement this facility across the country from June 1. "Today, 5 more States - Bihar, UP, Punjab, Himachal Pradesh and Daman and Diu - have been integrated with One Nation-One Ration Card System," Union Consumer Affairs Minister Ram Vilas Paswan said in a tweet.

Under the 'One Nation-One Ration Card' initiative, eligible beneficiaries would be able to avail their entitled foodgrains under the National Food Security Act (NFSA) from any Fair Price Shop in the country using the same ration card. Andhra Pradesh, Telangana, Gujarat, Maharashtra, Haryana, Rajasthan, Karnataka, Kerala, Madhya Pradesh, Goa, Jharkhand and Tripura are 12 states where ration card portability has been implemented. The beneficiaries can lift 50 per cent of their entitlement.

On January 1 this year, 12 states were integrated among each other and now 17 states are on integrated management of the public distribution system (PDS), also called ration shops/fair price shops, he

"About 60 crore beneficiaries from 17 states and UTs can benefit from the ration card portability and they can purchase the subsidised foodgrains using the existing ration cards, an official statement said.

According to the statement, the ministry has decided to integrate the five states after assessing their technical preparedness. The State officials were

given technical assistance and training for the same.

The five States have been asked to immediately begin monitoring of the new system, it said, and added that the Centre is pursuing with other states to join the ration card portability system at the earliest. There are over 81 crore beneficiaries in the country registered under the NFSA for subsidised foodgrains of 5 kilo per

As per the amended guidelines, Khadi and Village Industries Commission (KVIC), the nodal agency for implementing PMEGP scheme, after due diligence, will proposals/applications of the prospective entrepreneurs and will forward it to the Banks for taking credit decisions. As of now, the proposals were scru-

tinized by the District Level Collectors/Magistrates heading Task Force Committee the DLTFC were often preoc-(DLTFC) that often led to cupied with local administrative inordinate delays in sanctioning of the projects.

KVIC Chairman Vinai Kumar Saxena said a major bottleneck has been removed with the discontinuation of the DLTFC in approving the projects under PMEGP. He thanked Gadkari for taking swift action in the interest of

The government's move has come at a time when the employment sector has taken a hit due to nationwide lockdown in the wake of the Corona disease. The amendment in the policy would pave the way for swift implementation of projects and create new employment opportunities in rural and semi urban areas under the PMEGP

pending for several months. "We are grateful that the Hon'ble Minister accepted our request and decided to discontinue the role of DLTFC. This will ensure swift and timely implementation of the projects. The government's decision will safeguard the interest of lakhs of people in the country seeking employment opportunities under PMEGP." Saxena said.

As per the new guidelines, the KVIC after receiving the applications will scrutinize and examine the proposals and the corrected applications will be forwarded to the banks for tak-District ing credit decisions. Under the PMEGP scheme, loans up to Rs 25 lakhs are given for manufacturing and service industries, in which 15 to 35% subsidy is provided by the KVIC depending upon the area.

Since its launch in 2008, the PMEGP scheme was receiving an average of 35,000 applications per year. However, KVIC in 2016 developed an in house, user-friendly PMEGP portal and launched it in July 2016 to receive online applications under the scheme. The online facility received massive public response and the number of online applications increased manifolds up to four lakh applications per year, which itself shows the popularity of the

In 2019-20, the KVIC released over Rs 1951 crore margin money subsidy and set up 66,653 projects in the coun-

Dr C V Krishnaswamy, Dr Rajesh Kesavan and Dr Ranjit Vijayahari are of the view that the coronavirus in Chennai has entered the phase of community transmission, the health minister made light of the figures by stating that it was because of increased number of samples being tested that the numbers appear high.

"The disease could be checked only by following the social distancing per the guidelines. But what I see is a free for all crowd and shopping in Chennai. There were instances of genuine people on their way to hospitals being send back by the police while shoppers and loiterers going scot free," said Dr Krishnaswamy

Dr Renjit Vijayahari, gastroenterologist, closely studying the spreading of the coronavirus in Tamil Nadu is of the view that the pandemic has entered the phase-three of its spreading which means the Chennai is on the verge of community transmission. "The number of persons tested positive on Thursday and Friday are not the same people who were tested negative on Wednesday. The magnitude of testing is very low in India as well as in Tamil Nadu. Why the government is not accepting the fact that community transmission has set in is surprising Any person with basic knowl edge of diseases like coronavirus could make out that in a city like Chennai where the density of population is high, it is difficult to prevent the progress of the disease from reaching the community transmission," said Dr Vijayahari.

### 6 new Covid cases in T, tally touches 1,044 Hyderabad: Telangana reported six new Covid-19 cases on Friday,

After a sudden spurt with 22 cases on Thursday, the numbers again declined to single digit. Unlike the previous day when three fatalities were reported, there were no deaths on Friday.

# T industries to hit hard by exodus of migrants

of the industry in Telangana are likely to be hit hard by the exodus of the migrant workers, who constitute a major workforce in the state.

As the workers, majority of them belonging to northern and eastern states, begin to return home, industrial units in different sectors are keeping their fingers crossed on its impact and whether they will ever come back.

Industry representatives are unanimous that the return of migrants will hit different sectors, especially construction and manufacturing but are divided over the degree of impact. While some expect things to return to normal in a couple of months, others foresee a long-lasting impact.

After the lockdown began in March, Telangana had announced a series of measures to look after the migrant workers. Chief Minister K. Chandrashekhar Rao assured that no one will starve and termed the migrant workers and partners in the state's devel-

The chief minister had also announced 12 kg rice and Rs 500 for every migrant worker and asked the employers to give them shelter and provide them all necessary facilities.

The state authorities claimed to have identified 3.5 lakh migrant workers through a survey. However, following criticism from various quarters they revised the numbers.

The industry bodies say the actual number of migrant workers is more than eight lakh. Trade union leaders claimed that the government's help has not reached majority of the workers, forcing many of them to set on the risky journey of walking towards their "The impact will be severe,

especially in unskilled segments in construction, infrastructure, MSMEs, cement and steel plants," Ramakanth Inani, Senior Vice President, Federation of Telangana Chambers of Commerce and Industry, told IANS.

According to him out of 100 people employed in every Micro, Small, Medium Enterprise (MSME) in Telangana, 80 are migrants.

There are also workers from neighbouring states of Andhra Pradesh, Karnataka and Maharashtra.

K. Madhusudhan Reddy, director, Dwelton Reality Private Limited, believes the exodus of workers lead to slowdown in the sector

They will not come back easily because of COVID-19 fear. There is also awareness among them," he said. He believes there will not be much problems may remain for six months.

However, Confederation of Similarly, the migrant Real Estate Developers labourers constitute 90-95 per Association of India (CREDAI) Telangana unit president Ramchandra Reddy said the impact will not be much.

He pointed out that the migrant workers go to their native places for one to one-half month every summer. "This year the period has clashed with pandemic and the lockdown. As per our feedback they will come back. It depends on the lockdown situation," he said.

Telangana and Hyderabad don't have much unsold inventory, the impact on the sector will not be long-lasting.

CREDAI Hyderabad General Secretary Rajasekhar Reddy recalled that they were the first to suggest to the government to send back migrant labourers. "We had suggested that it is better to send them home. They will be happy with their families and when things settle down they can come

He pointed out that when the government ruled out this and asked the real estate developers to take care of their workers, they did everything possible to look after them.

"They were getting calls from their homes. They were sitting idle and it was stressful. Some started going on foot. We are saying that those who want to go, let them go," he said



### PAPER WITH PASSION **Makeover too late**

Well-meaning yes, but Rahul Gandhi needs to convince people with hands-on leadership than online conversations



■t is tough to be in Congress leader Rahul Gandhi's shoes these days. For no matter what his best intentions are, nobody buys his attempt to mean serious business in COVID-19 times. Or his effort to be a credible determinant of national revival as a concerned citizen-volunteer. The timing of the makeover is a tad too late, howsoever eager and convincing he might want to appear. Even if he does get the Congress' reins, there's a long way before he gets taken seriously as a national alternative. The way he handled the last Lok Sabha debacle of the Congress, bare-

ly able to demonstrate proof that his leadership did work in reinvigorating India's grand old party, hasn't been lost on people's minds, even among those willing to give him the benefit of doubt. Recalcitrance, of the kind he demonstrated by resigning and hiding in the woods of Wayanad simply because the old guard didn't go along with him, didn't show him up as a leader who could rebuild. Or take everybody along step by step despite the odds. Rather he was seen as a quitter who had plunged the Congress into a cesspool of stagnation topped by the residue of dynastic politics. Over months of absence from political life and pushing himself into an abyss of irrelevance meant he became the subject of public ridicule. Loyalist partymen may have tried projecting him as their prince but his wilful transgressions over the months have only lent credence to the BJP's campaign of him being a "Pappu." So though he is crafting an image change in the middle of a pandemic, appearing to contribute to the national revival effort, it's not reaping results. Particularly at a time when capable leaders of the Congress have proven their mettle as Chief Ministers in the battle against the pandemic, be it Rajasthan's Ashok Gehlot or Punjab's Amarinder Singh. Both incidentally are the old guard. So though Rahul has been making the right projections about the COVID-19 crisis in India since February and justifiably raised some questions before the Government on social media, his party colleagues on the ground got all the attention. Besides, the Opposition Chief Ministers, too, are going out an arm and a leg to contain the disease spiral and Rahul, at this point of time, doesn't seem hands-on enough. Even his think tank-like advisories seem too tutored and self-serving than well-meaning.

But to his credit, his recent attempts have been at least sincere. He performed creditably at a recent press conference, too, where he refused to be baited by journalists into commenting on the shortcomings of the lockdown. The Congress' latest plan to rebrand him as a serious ideologue and a thinking leader will see him participate in a series of online conversations with public intellectuals, the idea being to strip down his dynastic entitlements and project him as a leader who has every issue in his grasp. The first of these publicised dialogues got off with economist and former RBI Governor Raghuram Rajan. Not entirely a bad one as Rajan made some specific observations about a post-COVID scenario, like an infusion of ₹65,000 crore for the poor. But the point is Rajan has already made revival recommendations on various fora and will probably be heard and consulted. He won't need Rahul's forum to establish his credentials. On the other hand, when Rajan asked him to compare the response to COVID in India and the US, all Rahul could come up with was the social inequity in our country in getting treatment. Clearly, his critics made mincemeat of him for not seeing through the US oversight of the situation, Trump's flip flops and absurd theories and that nation's own discriminatory tests. Perhaps Rajan was a bit taken aback, too. And if the Congress had thought that appropriating Rajan would mean taking on the BJP, the economist himself was reasonably careful not to fall into that trap and said things like they should be at this moment of crisis. The Congress shouldn't try to make Rahul look "sharp" and then land with a PR disaster. Experts from India feature in world institutions and the Government could requisition their services anytime in rebuilding the nation. Rahul's conversations won't change that. But what he and his strategists must do is to diminish the trust deficit in him as a leader and build on his natural strengths like when he did padayatras and entered people's homes. Perhaps, he could lead a pan-India Congress community kitchen and health camp project to help the poor and migrants and rebuild the human touch that he had lost over the last few months. Perhaps, he could take up cases of starting up local economies. He has enough advisors, too, he just needs to show that he can be a leader through such simple connects.

## **Redoubling Reliance**

After a boom run lasting decades, is Reliance Industries

finally admitting that growth is slowing down?



f there is anything like a sure shot on the Indian bourses, it is the Reliance Industries' scrip. Even after being pummelled by the Coronavirus lockdown and crashing oil prices, its share price has recovered smartly over the past few trading sessions as investors believe that India's largest private company will emerge from the crisis stronger than before. That faith was redoubled after American technology giant Facebook made an unprecedented \$5.7 billion investment into Reliance Jio, the telecommunications arm of the conglomerate. So why is the firm raising

₹53,125 crore from the markets through the largest rights issue in Indian history? On the face of it, things are not going too bad for the company as despite the negative economic sentiment even before the Coronavirus impact, its consolidated profit was stable and revenues rose by over five per cent.

Well, Mukesh Ambani has stated time and again that he wishes the Reliance Industries reduces its debt load. After the Government first stalled the potential \$15 billion investment in Reliance's uber-profitable oil and gas business by the Saudi Arabian oil major, Aramco, it was speculated that things might not be all kosher between Prime Minister Narendra Modi and Ambani. While that is just speculation, the fact is that today, with a collapse in oil prices, Saudi Aramco may not be able to invest in Reliance in the first place. And while Reliance can raise debts across the world, even in India, with its stellar record of repayment, Ambani realises that it will likely be easier for him to capitalise on his company's reputation to raise funds much more easily. At the same time, raising money from investors will not increase the debt burden on the company, particularly when the economy will most likely be fragile over the next few quarters. At the same time, Ambani also likely realises that the world is pivoting away from oil and plastics, the two cornerstones of his business. The current pandemic might just be a turning point as to how the public consumes these products. Raising money now will likely keep Reliance's war chest ready as the company starts new consumer ventures over the next few years and prepares for a new world, a more sustainable one. But what impact will Reliance Industries' rights issue have on the overall capital market? It will almost certainly reduce the appetite for any new public issue over the next few quarters as it will suck a huge amount of money out of investors' pockets. That would have been the case in a healthy market, but in this market, it means that any other public offering will probably have to offer a deeper discount than earlier planned to get the public to bite.

# Frailty of man vs animal

As the debate continues over the origin of Coronavirus in Wuhan's wet markets, the fact is such places must be banned altogether given future threats to humans and animals as well

hile a contentious debate ages as to whether the COVID-19 emerged from a "wet' market selling live animals, including exotic ones, and their meat in Wuhan, China, or escaped/let out of a virology laboratory at the same place, the case for banning such markets in every country needs to be pursued vigorously. Simply put, these should not exist. There are two main reasons for this. Animals including crocodiles, deer, raccoons, pangolins and dogs — suffer horrendous cruelty. They are kept in utterly cramped and most unhygienic conditions, which cause them stress 24/7, and are grossly underfed. The stress factor is heightened by the fact that they often have to watch others of their species kept with them being slaughtered in their presence and their meat sold. In fact, wet markets owe their nomenclature to the blood spilled on the floor when animals are killed. Many in India, who have bought chicken meat from often-illegal roadside stalls, have seen it. Many buyers have also witnessed their feathers being plucked from them even when they are alive, with them screeching in agony.

All this is nothing secret. Worse, it comes at the end of the long journeys in the worst possible conditions of confinement involving dehydration and starvation. The inhuman manner of prolonged transportation, as well as the abominable conditions in which they are kept in the markets, weaken their immune systems and leave them most vulnerable to diseases. Besides, keeping wild animals along with domesticated ones enables viruses to jump species, including transmutation to affect humans, which has happened in the case of COVID-19. Not surprisingly, a number of epidemics, including that of SARS, have originated from such markets and will emerge again if the latter are not closed worldwide.

Apart from the medical consequences for humans, the existence of wet markets raises fundamental questions relating to their future. These exist because people not only eat meat but believe, consciously or sub-consciously, that they can treat animals which exist for their benefit — any way they want to. This, in turn, springs from the belief that they can treat nature, of which animals are a part, just as they desire, which, again, lies at the root of the environmental crisis which threatens humankind with extinction.

humankind's attitude to both animals and nature. The belief that animals are inferior to humans and meant for their benefit and, hence, can be treated in the cruellest manner, is a result of the Graeco-Roman, Judaeo-Christian and post-Renaissance-Enlightenment mindset which dominates modern discourse. Its essence has been best

expressed by Aristotle in Politics. He wrote that nature made all animals for the sake of man and that it was permissible to enslave people who did not possess reason as it was to enslave animals. Saint Augustine wrote in *The City* "when we read 'Thou shalt not kill, we do not understand this phrase to apply to bushes, because they have no sensation, nor to unreasoning animals that fly, walk or crawl because they are not associated in a community with us by reason...Hence it is by a very just ordinance of the Creator that their life and death is subordinated to us." Given such views, it is hardly surprising that Matt Carmill writes in A View to a Death in the Morning: Hunting and Nature through History, "animals were routinely treated with a mixture of brutal indifference and sadism" in the Graeco-

Roman world. The attitude continued beyond it. In *Eternal Treblinka*: Our Treatment of Animals and the Holocaust, Charles Patterson quotes Saint Thomas Aquinas, perhaps the greatest exponent of medieval Scholasticism, as saymals because "the life of animals .is preserved not for themselves but for man." He denied not only rationality but afterlife to animals. Patterson further points out, "Like Aristotle, whose work he incorporated in his theology, only the reasoning part of the

reason, he claimed that their souls, unlike human souls, did not survive after their death."

As it has been repeatedly shown, the characterisation of rationality as the defining attribute of humans, is untenable. People are equally prone to irrationality. Otherwise, they would not have supported creeds like Nazism and Fascism — or any of the fundamentalist religious doctrines of our time — and voted Hitler and Mussolini to power. Besides, rationality can hardly be regarded as a supremely laudable faculty in itself. It is an instrument for drawing conclusions from premises. The capacity for reasoning, which is central to it, can be used to justify both moral and immoral ends. Also, not all persons are equally capable of reasoning. Does one, who is less capable than others, deserve to be treated with the kind of horrifying savagery that is reserved for animals? If the answer is yes, the question arises as to what is that level of rationality below which such treatment to humans is per-

missible? came to be designated as mental illness at the end the 18th century, has been considered as something that puts a person beyond society's pale. As Michel Foucault points out in Madness and Civilisation: A History of Insanity in the Age of Reason, "in

the Middle Ages and the Renaissance a place of detention reserved for the insane..." There have been many definitions of madness. This writer believes that it is best considered as existence in a separate, personal reality very different from, and inconsistent with, what is accepted by the masses of people. The behavioural manifestation of madness lies in a person's reaction, which can be violent and/or disruptive when there is a clash between his/her and the society's version of reality. Thus, a person may consider himself to be Jesus Christ and fly into a rage if peo-

ple laugh at his claim.

Questions arise. What if a person's separate reality is the true one? There have been people in advance of their ages, such as Nicolaus Copernicus, whose model placed the sun rather than the earth as the centre of the universe and who held that the earth spun on its axis and orbited the sun annually. His doctrine, however, was pronounced heretical in 1616 and the Inquisition in Rome forced support of the Copernician view on June 22, 1633. In our time, we have seen dictatorial regimes like the Soviet Union silencing a dissident by proclaiming him/her insane and dispatching him/her to an asylum.

From this angle, it is quite

of unpardonably cruel way in which humans have been treating them. It is not just animals. There are implications for humans. Patterson points in *Eternal Treblinka*, "Since violence begets violence, the enslavement of animals injected a higher level of domination and coercion into human history by creating oppressive hierarchical societies and unleashing large-scale warfare never seen before." He further quotes the historian Keith Thomas as believing that domestication of animals created a more authoritarian attitude since "human rule over the lower creatures provided the mental analogue on which many political and social arrangements were

Clearly, human beings cannot escape the adverse consequences of their own inhumanity be it in respect of themselves or other living beings. We are in the midst of the devastating consequences of COVID-19 pandemic. What next? Two telling lines by a Carter Family song, beginning of The Fire Next Time, run, "God gave Noah the rainbow sign/ No more water but the fire next time." Will it be a virus instead of fire?

# Will private sector stand up?

Till now only Government healthcare professionals are combatting the pandemic. Where are the other stakeholders in the healthcare sector?

iven India's resource limitations and constraints, both at the Centre and State level, it is amply clear that the measures to battle the Coronavirus require more than just State efforts. There is a need for a comprehensive public health national policy to make adequate capacity available, in true letter and spirit, till the grassroot level. When the clock is ticking and much remains to be achieved to handle an unprecedented pandemic, it is the time for the private sector to stand up and be counted and open up for the public.

The present scenario: On the one hand, we hear that the pandemic will last up to 2024 and on the other, we are told that the virulence of the strain will be low but infectiousness high. This gives rise to so many questions. Is herd immunity the only answer for us? Who are the major players in India who are protecting the country from the shackles of this disease? We all know that the task at hand is humongous as we have to manage a population of 1.3 billion, discipline them, take care of their basic needs and provide them with appropriate healthcare. Even the fastest-growing trillion-dollar economy in the world will need help at a time like this. There is an old adage that, "Charity begins at home." Hence, the private sector, which gains a lot from the Government, must stand by it now and provide equal support to the country's infirm and powerless pop-

The role of the health sector: The Corona-warriors, hailing from the Government sector mostly, are giving their all in the fight against the pandemic but the resources are limited. Some private hospitals have come forward and they have been included in the list of hospitals approved by the Government for COVID-19 testing and treatment. They have the exact modules to be followed for treatment and submit daily data to the Director, Preventive Medicine. However, the big question is where are the others? Till now only Government healthcare professionals are combatting the disease. Where are the other stakeholders in the healthcare sector? If this were a war and all the security forces were not a part of it or doing enough, nobody would have spared the Government. This is a similar situation just that the warriors are from the medical uation, just that the warriors are from the medical fraternity. Whether a war happens or not, the military is trained for it. Similarly, these are the situations for which doctors/nurses are helped, given and educated to serve. Wha Hippocratic Oath that doctors take? If not in these situations, then when is a doctor supposed to protect patients? It's the same "Do or Die" situation for both, soldiers and medical professionals. It is the same threat to life and a family to provide for. It's the same as keeping the country before self. It's the same selfless and unconditional love for the countrymen that should be the guiding principle for healthcare professionals in the private sector now. The private sector hospitals should rise to the occasion now and take the responsibility of training healthcare staff, organising sessions and making their infrastructure available for the nation to fight this

The same goes for pharmaceutical giants. All grants, permissions, compensations and concessions were made by the Government to bring them to this stature. So what about their responsibility towards the nation? How come everyone is selling masks and sanitisers at double the cost? Where is the personal obligation and commitment to the country? Aren't we meant to give back to the country in times of need? What about the Corporate Social Responsibility (CSR) of these pharmaceutical companies and corporate hospitals? In spite of the present Financial Year 2020 CSR estimate of ₹2,000-₹3000 crore, this is only a drop in the ocean when

it comes to the support that is actually required on the ground to fight the pandemic. This is the time that India Inc. should give with both hands to support the populace and country which has made them what they are, in the first place. Sadly, there are very few examples emerging from this direction.

Also, now that the Government itself

has a PM Cares Fund dedicated for the COVID-war and is open to accepting all CSR funds, it needs to be decided whether these funds must be merged in the Central repository or used for welfare measures in States. There is a need for a centralised system which will reduce duplication of efforts and make the funds immediately available for use without disturbing the already planned projects. Major challenges: COVID testing,

even at subsidised rates and a cap of ₹4,500 class, let alone the underprivileged. Hence, the people who are most susceptible to disease will not have affordability or accessibility to these tests. How many tests can be done daily? And how many days will it take to screen the whole population? The Indian healthcare workforce of around four million is majorly employed in the private sector and that, too, mainly in metro and Tier-I and II cities.

This lopsided availability needs to be addressed once we are on our way to fighting COVID-19 throughout the country. The World Health Organisation (WHO) standard of 22.8 doctors and nurses per 10,000 population is met by India, keeping aside the distribution patterns. A whopping 70 per cent of the population lives in rural India, which is backed by only 33 per cent of the healthcare workforce.

The Primary Healthcare Centres (PHCs) are the ones on whom the onus of care lies in these testing times. These centres, which have been made outdated by private practice, now have to be at par to combat the disease. So where are the privileged and fund-surplus clinics and private practitioners now? If they cannot open their clinics to help the nation in its time of need, why can't they work in these PHCs? Primary healthcare workers are already scanning zones for Corona-positive cases. It is time for the specialised lot to come in and offer their services.

There is going to be an absolute dearth of ventilators, beds, ICU set-ups, nurses and doctors. COVID-19 has impacted hugely the supply of medical aids, be it electrical, mechanical, pharmacological or economical. The increasing demand needs to be taken care of and planned for, both in terms of availability and supply logistics. In an economic slump, how will the expenses be met, and on what opportunity costs? Pharmaceutical giants need to step in and take full responsibility for making supplies available with logistics, whereas the hospitals need to provide ser-

The Coronavirus crisis at the moment has an unclear path. Actions will depend on a hypothetical acceptance of either a delayed recovery or a prolonged contraction. Delayed recovery if we see a count rise till April, followed by control through social distancing, when the testing is fast and the virus is seasonal, will give an optimistic public approach by April.

Or else the prolonged contraction phase where peak is not achieved until May, with ineffective testing and failed social distancing, and the virus is non-seasonal, the virus will trail till the end of the year keeping all engaged and resources exhausted. In both the scenarios, the role of the private industry and pharmaceutical giants is large, with immediate action required. At the moment, the major challenges that are apparent are bridging the gap between knowing and doing. That the COVID-19 has an exponential growth is easy to know but tackling it is difficult unless similar experiences were seen and lessons were learnt in the past.

Response management: Private hospitals need to start planning critical care

in healthcare systems. Without this the number of deaths cannot be contained. Achieving it once can give us the confidence to fight resurgence later, if any. Capacity-building to empower the Government by private hospitals is required. Simple things being done religiously right in a controlled and quick manner is required. Surveillance of the dismanner is required. Surveillance of the disease, followed by contact tracing and then quarantine, needs all private hospitals, pharmaceutical companies and IT giants to step up together. The quicker and wider we screen, the better we can control the devastating outcomes. This will in turn relax social distancing measures once we are down the clone for positive cases.

massively to control the pandemic surge

are down the slope for positive cases. The credibility and accessibility to antibody test screening needs to be widely made available to understand zeroof herd immunity. If the private sector will not help now, it will become very difficult to restart the economy. The vicious cycle needs to break.

Corporate Social Innovation via philanthropy, media advocacy, social responsibility tasks and shared values by the private sector will need to leave a positive impact not only for the present but also for the future, when all will be well. It can also be taken as brand development.

If the private sector doesn't come to the aid of the nation on its own, then the Government will have to take over hospitals and laboratories for some time for creating ICUs, isolation wards and testing samples. Universal healthcare is everyone's right and the Government will need to ensure its availability across all strata of population throughout all geographical boundaries. It is time to double up the responsibilities. After all, we are all in this

# India must strike while the iron is hot

≺he lockdown has been extended yet again although this time there is a relaxation of some restrictions to enable economic activity. It will be interesting to see how the Government as well as the industry negotiate this challenge.

Despite the doom and gloom scenario in the country right now due to the lockdown, the fact remains that the current Corona crisis has provided an opportunity, too, for India. But for the country to take advantage of this spell, it would require major initiatives and that too, at a fast pace. COVID-19 has provided the muchneeded elbow room to the political leadership to push for transformation, more particularly land and labour reforms. If a Communist China can serve the economic interests of the capitalist West, then India is even better positioned to do that.

Now, more than ever, global firms are aware of the dangers of putting all their eggs in one basket and they must implement strategies to reduce that risk. It is quite surprising that the risk-governing framework of all these corporates didn't highlight the concentration of manufacturing in one territory as a key risk and even their boards overlooked this aspect. China has established

itself as the manufacturing hub for the global economy and it is also positioned as the first-tier supplier in the overall global supply chain. Even India is hugely dependent on China for raw material, chemical and engineering goods. Our telecom, pharmaceutical, power and mobile accessories sectors are largely dependent on China for raw material, semi-finished goods and skilled manpower.

It would not be easy for any country to replace China and position itself as an alternative to it, but we can start leveraging our competitiveness in areas like information technology, to gradually move in this direction. The world order is expected to change and diplomacy will play a key role in establishing India as an alternative, low-cost manufacturing destination. For this to happen, first

and foremost, Indian manufacturers

must start thinking globally. Integration with the global supply chain is the key to this and instead of just setting up assembly lines, our companies should start thinking of developing industrial clusters where India can be a first-tier supplier in the global supply chain. It is worthwhile to understand the difference between first-tier and second-tier supplier. All the entities and activities in the supply chain are dependent on the first-tier supplier and, therefore, placing India as one will provide sustainable economic development which can be enjoyed for decades.

This is a long-term task and apart from structural reforms (like land, labour, sanctity of contracts, tax certainty and so on), this will require skilled manpower and latest technol-

ogy, for which the Government and private players, both, must come for-

Some sort of additional tax incentives should be considered as a stimulus for local players to start investing in these areas. Friendly nations like Japan can be our potential technology ally and this would serve the economic as well as political interests of both the countries.

However, under all circumstances India must act fast to capitalise on flight of firms from China. Initial indicators are suggesting that we are unable to project ourselves as an alternative to China and Japan has already made a move in this direction by offering major incentives.

India is lagging despite lowering income tax rates last year, which has increased the competitiveness.

However, policymakers should understand that tax rates are just one among the various factors which a person looks at before committing his resources. As per a Nomura report, out of 56 companies which have decided to shift operations from China, only three have decided to come to India.

We can either continue to blame the bureaucracy or India Inc. can realise that it is high time to get the

bull by the horns. In 2017, Deloitte research identified five countries, which it dubbed the MITI-V (Malaysia, India, Thailand, Indonesia, and Vietnam) as an alternative to China in which India

was positioned at top. We have our advantage in terms of a young population, cheap labour, domestic consumer market, rising

income levels and so on, but this will remain in theory only till the time policy interventions grab the eyeballs of investors.

If we lose this opportunity, then we will lose out for at least the next three decades and provide millions of employment opportunities to our Asian peers.

India must take a host of measures and do it fast while the iron is still hot, to convince Western investors to come here and position itself as an alternative in the global supply chain. Initially our manufacturers can supplement the Chinese global supply chain but we should think of establishing ourselves as an alternative to China for all time to

Layoffs amount to 1 in 6 American workers and encompass more people than the entire population of Texas. Some economists say the US unemployment rate for April may be as high as 20% - a figure not seen since the Depression of the 1930s, when joblessness peaked at 25%.

Those guidelines encouraged people to work from home and avoid restaurants, groups and nonessential travel. The virus has killed over 2,30,000 people worldwide, the US, according to a tally by Johns Hopkins University. Confirmed infections globally topped 3.2 million, with 1 million of them in the US, but the true numbers are believed to be much higher because of limited testing, differences in count-ing the dead and concealment by some governments.



### **Fast, sensitive antibody blood** test for Covid-19 developed

**PTI** ■ BEIJING

Scientists have developed a quick, sensitive test for antibodies against the novel coronavirus in human blood that could help doctors track a person's exposure to Covid-19, as well as confirm suspected cases that tested negative by other methods. Because Covid-19 symptoms range from mild to severe, with some people apparently having no symptoms, the number of people who have been infected with the SARS-CoV-2 virus at some point is likely much higher than the number of confirmed cases, the researchers said.

Although more research needs to be done, it is possible

that people with antibodies to the virus could be immune to future Covid-19 outbreaks, according to the research published in the journal Analytical Chemistry.

To help identify people with current or past exposure to SARS-CoV-2, the researchers, including those from Southern Medical University in China, wanted to develop a fast, sensitive antibody test. They based their test on a

technique called a lateral flow immunoassay (LFA); a home pregnancy test is an example of this kind of assay.

The team attached a viral coat protein to a specific region on a strip of nitrocellulose, and then added human serum.

### Auto industry bodies: Allow entire value chain in automotive sector re-commence operations in unison

New Delhi: Three industry bodies of the automotive sector, SIAM, ACMA and FADA, on Friday asked the Government allow the entire value chain in the auto industry to re-commence operations in unison.

In a joint representation to Home Secretary Kumar Bhalla, the Society of Indian Automobile Industry (SIAM), Automotive Component Manufacturers Association of India (ACMA) and Federation of Automobile Dealers Associations (FADA) said if any of the segment does not commence operations the value

chain will not be able to re-start. They also said the sector is losing revenue to the tune of ₹2,300 crore per day and therefore starting of economic activity in the sector is critical.

'The automotive industry in India, which was already facing a severe downturn for over 15 months, with the lockdown, is now confronted with total disruption of its entire value chain," they said, adding with challenges of working capital across the sector, several of the players in the industry, right from the component suppliers to the dealerships, are faced with the challenge of staying solvent.

Asking the sector to be allowed "to resume operations in complete unison", the three apex chambers representing the entire automotive value chain said "the automotive value chain is highly complex, integrated and interdependent".

'A vehicle manufacturer cannot commence operations if any one of its suppliers is unable to undertake production. Further, production for a vehicle manufacturer would only amount to adding to inventory and thus blocking working capital in case dealers are unable to sell vehicles," the joint representation said. they said. 'The Government will wait till May 5 before announcing the collections," a source said.

For business activity in a particular month, GST return has to be filed in a staggered manner by the 20th of next month. Hence for transactions in March, GST return had to be filed by April 20, which was extended till May 5.

### UNIVERSAL CODE

This suite of four is an exercise in recall nd reflection. It highlights focus on the desperate and unchanging plight of migrants and refugees all over the world. Indeed, in the Coronavirus hyper reality, where there is tragedy upon tragedy, it adds historical context to the global story of humanity on the move their trials and tribulations.

The lot of migrants today in India and the rest of the world are unparalleled in human history. Their predicament presents profound challenges to the notions of

nation, community and citizenship. These images are a pictorial stamp of the current global flux of humanity. In many ways, Paul reveals the humanist element, dignity and simplicity of these subjects. With his unique vision and empathy, the eminent photographer gives us four pictures that echo enormous social and political transformations occurring in a world divided between excesses, utmost greed and greater needs. More than five decades after he captured these shots, the world has not changed.

By looking again at these images, we cannot help but reflect on the unchanging And you think of how this great lensman documented so silently the nomadic labour at the frayed - and distinct edges of humanity.

The journey of migrant labourers can be ruthless, with families often parting with life-savings to board hopelessly a dreamboat, of shattered dreams, steered by opportunists who care only about their own empires.

# This is my quest

Broadway actor BRIAN STOKES MITCHELL has been serenading the frontline workers battling Coronavirus, following his own personal battle with the illness

It's a stunning sound, emerging amid the clanging and the whooping and the banging and the honking at 7 pm each night as New Yorkers cheer front-line workers: the velvety, buttery baritone of Brian Stokes Mitchell.

For decades, Mitchell's voice has been one of the most celebrated in the Broadway

celebrated in the Broadway theater, evoking goosebumps in musicals like Kiss Me, Kate, for which he won a Tony, and Man of La Mancha, in which he played Don Quixote. Now, with Broadway's houses shuttered due to the Coronavirus, the voice rings out from a fifthfloor apartment on the Upper West Side — fittingly on Broadway, a couple miles up from the theatre district.

"This is my quest," Mitchell sings, leaning precariously out his window, launching directly into the meatiest part of *The* Ímpossible Dream.

Below and across the avenue in their apartments, neighbours cheer. But Mitchell, 62, is looking to serenade crews of ambulances, fire crews of ambulances, fire engines, police cars, or medical workers from the nearby urgent care facility. When they do stop and listen — as a city bus did recently — Mitchell sings directly to them. And when people clap, he sweeps his arms over the workers, as his arms over the workers, as if to say: "Not me. Them."

Mitchell's gratitude, expressed nightly the last few weeks, stems from a very personal ordeal. He himself is a survivor of the Coronavirus, falling ill in late March. One night, he had a fever nearing 105 degrees, and almost was hospitalised. He's been symptom-free for three weeks. "I'd been going to the window to applaud for the health care workers like everybody else in New York," he says. "Then one night I spontaneously thought, 'Oh, I think my lungs feel like

I can sing now." And so, he did. He thought it would be a

did. He thought it would be a one-night gig. He was mistaken. People kept coming.

"To fight for the right, without question or pause, to be willing to march into hell for a heavenly cause!" Mitchell smiles as he repeats the words, amaged at how appropriate amazed at how appropriate they are for medical workers fighting an "unbeatable foe." "People think it's just called *The Impossible Dream*, but it's also called "The Quest," he says. "It's not about doing the impossible. It's about trying."
It is, of course, a terrible

time for the theatre community, with arts institutions suffering severe economic loss. Mitchell is chairman of The Actors Fund, which helps performing arts and entertainment professionals. He's donating all profits from his latest album, *Plays With Music*, to the fund.

When the city shut down,
Mitchell was working on
numerous projects.

numerous projects.

"Everything was canceled," he says. "I have no idea when they'll come back. A year? Six months? Unfortunately I think our sector will be one of the last to come back fully."

For now, though, Mitchell feels busy with his unpaid gig. "Broadway's closed, but someone's still singing on Broadway!" he quips. His performance ends with a flourish: "And the world will be better for this, that one man, scorned for this, that one man, scorned and covered with scars, still strove, with his last ounce of courage, to reach the unreach-

Mitchell, though, adapts he lyrics to squeeze in words like "one first responder and health-care worker." The audience cheers. "It's three minutes," says onlooker Sari Rubin, "of me remembering that there's good in the world."

ormer Pakistan all-rounder Abdul Razzaq says Hardik Pandya is nowhere near the league of Kapil Dev and needs to work harder to become a world-class cricketer.

Razzaq also clarified that his "baby bowler" comment against lead India pacer Jasprit Bumrah was misconstrued.

One of the most prolific allrounders to have come out of Pakistan, the 40-year-old also said India will continue to enjoy an unbeaten record against his team at the World Cup, as Indians handle the pressure of the big game much better.

Talking about Pandya, who has been battling fitness issues of late, Razzaq feels the 26-yearold doesn't seem to be working hard enough.

"Pandya is a good player but he can be a much better allrounder. It is all about hard work. When you don't give enough time to game, it drifts away from you," Razzaq said. "He has to prepare better

mentally as well as physically. As you have seen, he has been getting injured a lot of late (underwent back surgery last year). When you earn a lot of money, you tend to relax. For every player it is the same. Mohammad Amir did not work hard enough and his performance dipped."

Pandya, who made his India debut in 2016, has drawn comparisons with the great Kapil, but Razzaq said it is way too prema-
