Making "self-reliance" as the new "mantra" in the "changed" by the unprecedented pandemic, Prime Minister Narendra Modi on Tuesday announced a ₹20 lakh crore economic package for what he called "Mission Self-Reliant India" to tide over the coronavirus crisis. In his address to the nation.

He said the economic package would be detailed by Union Finance Minister Nirmala Sitaraman on

Wednesday. The special economic package would be the main component of "Atma-Nirbhar Bharat", he said.

"This package is for migrants and farmers who work for the nation day and night, no matter the circumstances," he said.

"The package will focus on land, labour, liquidity and law; it will help small business, labourers and farmers. This will focus on the well-being of migrant workers too," the PM

He said now onwards "swadeshi" would be given key importance saying "be vocal for local and buy local products and publicise it", he said and give reference to the popular

ity of 'Khadi'.

He said "Make in India" need to be brought to the cen-tre-stage and pointed as how coronavirus prompted large-scale production of Personal Protection Equipment (PPE) and N 95 Masks which India did not manufactured earlier.

"Today everyday we are producing two lakh PPEs and two lakh masks. We converted crisis into an opportunity," Modi maintained.

He said, "A virus has ravaged the world, we have never seen or heard a crisis like this."

The only way for India to triumph over the crisis was to "strengthen our resolve so that our resolve is even greater than this crisis", he said

The PM said India must realise its potential as the lead player in the 21st century by focusing on its self-reliance.

He listed what he called five pillars for self-reliance: "Economy with potential for quantum jump, infrastructure, technology-driven system, demography and an intelligence-driven supply system."
The PM noted that sever-

al experts and scientists have said the virus is going to be part of our lives for a long time. But, it is also important to ensure that our life does-not revolve only around it. He exhorted people to work towards their targets while taking precautions like wearing masks and maintaining "do gaz doori".

On the fourth stage of lockdown, he said its contours will be completely different from those seen yet.

Ladakh still tense, India, China build up forces on LAC

IAF had to scramble **SU-30 fighter jets**

Situation remains tense in Ladakh even after stand-off including fisticuffs on May 5-6 ended with the Indian and Chinese Armies now maintaining vigil by shifting some distance away from each other. The face-off last even saw the Indian SU-30s flying sorties near the site when the Chinese deployed helicopters on their side of the Line of Actual Control (LAC). However, both the sides did not breach the air-

The two Armies came face to face on May 5-6 at a place called 'Finger 5' at the Pangong Tso Lake and in the ensuing stand-off blows were exchanged resulting to injuries suffered by some officers and soldiers. The matter was resolved at

the local level and the soldiers backed off from each other and are now some distance from the site, sources said here on Tuesday.

Initially, there were about a total of 250 soldiers involved in the face-off. The Chinese have now rushed more troops and their strength is over 2,000, sources said. The Indian side also responded by strengthening its force level though the

army says it has not done so. It also said, "There is no continuing face-off at the Pangong Tso Lake." Incidentally, this spot on the lake saw stone pelting and fist fights between the

two armies in 2017 and 2019. Maintaining that incidents of military face-off and aggressive behaviour occur on the LAC, the Army said on Tuesday patrols disengage after local level interaction and dialogue. "Temporary and short duration face-offs occur as boundary is not resolved. Troops resolve such incidents mutually as per established protocols," they said in response to reports of an ongoing standoff at the site.

This reaction came in the backdrop of two incidents of face-off between troops of India and China last week which resulted in injuries to several soldiers on both sides after scuffle. The first incident occurred on May 5 near Pangong Tso, Eastern Ladakh while the second face-off occurred on May 9 at Naku La, a mountain pass at height of

17% of Covid fatalities in suicides, migrants' death

Many workers died while attempting to return home

Coronavirus may have Claimed 2,414 deaths so far, but 418 people have died in accidents or committed suicide with causes directly linked to the pandemic. Majority of them are migrant workers those who committed suicide due to loss of jobs or in fear of infection of coronavirus.

Of the 418 deaths, 83 deaths occurred due to suicides for reasons such as fear of infection, alcohol withdrawal symp-

toms and due to loss of job. The number may be much higher as many cases in remote areas went unreported. A migrant worker died on board

Maharashtra again came in with 1,000 plus cases for the seventh straight day while Tamil Nadu witnessed 716 cases after reporting over 800 cases a day ago. Maharashtra tally of confirmed cases stood at 24,024.

1.5L book tickets, 8,000 travel in 8 trains on Day 1

Over 1.5 lakh passengers have booked tickets to travel on the 15 pairs of special trains to be operated over the next seven days, the railways said on Tuesday.

While three trains departed from the national capital on Tuesday, five started their journeys towards it. Around 8,000 passengers travelled on these eight trains that marked the resumption of passenger rail services since they were disrupted on March 25 due to the lockdown.

The bookings for these special trains began at 6 pm on

Monday. So far, 90,331 bookings (PNRs) have been generated for the next seven days, the railways said, adding that 1,69,039 passengers will travel against these bookings.

The railways issued guidelines on Monday for 15 special trains which will be operated.

Nearly 50 per cent prisoners incarcerated in jails across Maharashtra will be released. A high-powered committee appointed by the Maharashtra Government has decided to temporarily release them to decongest jails across the state in the wake of the Covid-19 pandemic.

The committee, comprising Bombay High Court Justice AA Sayed, Additional Chief Secretary of State Home department Sanjay Chahande and Maharashtra Director General Prisons SN Pandey, was set up after the Supreme Court in March called for decongestion of prisons across the country due to the coron-

The committee took a decision on Monday to release around 50 per cent of the prisoners from jails across the State on temporary bail or

decongest the prisons and about 50 per cent of prisoners out of the prison population of 35,239 are now expected to be released, the committee said. Maha reports 53 deaths, 1,026 new Covid cases

TN RAGHUNATHA MUMBAI

Maharashtra registered a record 53 Covid-19 deaths and 1,026 new infected cases on Tuesday, even as an undeterred Brihanmumbai Municipal Corporation (BMC) started to administer successfully a new injection "Tociluzumab" to coronavirus patients in four leading hospitals in Mumbai.

The State health officials were in shock as staggering 53 persons succumbed to Covid-19 in various parts of Maharshtra, which incidentally the high-ever day's tally of fatalities in the state.

Of the deaths, Mumbai accounted for 28 deaths, while there were six deaths each in Panvel town and Pune. Five deaths were reported from Jalgaon, while there were three deaths in Solapur, two in Thane and one in Raigad district.

With the new 53 deaths and 1026 infected cases, the total number of deaths mounted to 921 and infected cases to 24.427. Similarly, the total number of deaths in Mumbai rose to 556 and infected cases to 14947.

Of 2,21,645 laboratory samples, 1,95,804 tested negative while 24,427 samples tested positive for coronavirus until Tuesday. There are 1289 active containment zones in the state currently. Total 12,923 surveillance squads worked on Tuesday across the state and surveillance of 54.92 lakh popula-

As many as 5125 patients have been discharged till date after full recovery. Currently, 2,81,655 people are in home quarantine and 15,627 people are in institutional quarantine.

Meanwhile, the BMC has started using new medicine for severe Covid patients successfully. "To improve the condition of the patients with severe COVID disease, BMC-run medical college hospitals like Sion, Nair KEM and Seven Hills have started using the new drug "Injection Tociluzumab"," the BMC bulletin said.

He added that the fatality rate is 3.2 per cent and recovery rate is pegged at 31.74 per cent. He also added that (as of yesterday) there are 2.37 per cent active Covid-19 patients in ICU, 0.41 per cent on ventilators and 1.82 per cent on oxygen support. He also pointed out that testing capacity has increased to 1, 00,000 tests per day with 347 Government laboratories and 137 private laboratories. Cumulatively, 17, 62,840 tests have been done so far for COVID-19.

In Tamil Nadu, the coronavirus tally stood at 8,002 as the State Government attributed 'aggressive testing" behind this sudden spike in

Delhi with 7619 confirmed cases was at fourth position among the worst-hit States while Rajasthan surged to 4056 total cases as 68 new cases were reported on Tuesday itself. 115 people have died in the State.

Madhya Pradesh too is witnessing high num ber of deaths at 225 while new cases have added to tally of 3968. Similarly, for Uttar Pradesh, the situation was grim with 3573 total cases and 83 fatalities. West Bengal too presented grim picture with 110 new Covid cases pushing the fally to 2173 cases. Andhra Pradesh, Punjab, Jammu and Kashmir, Bihar and Karnataka also reported increase in number taking the total cases to 2051, 1914, 934, 830 and 925 respectively. More than 4.1 million cases of Covid-19 were recorded worldwide, including at least 285,000 deaths.

Post Covid: Civil aviation Min suggests no cabin baggage for passengers in initial phase

Mumbai: Filling up of a detailed questionnaire related to Covid-19, carrying no cabin baggage, using Aarogya Setu app and reaching airport at least two hours before a flight departure are among the suggested requirements for air passengers during the initial phase after resumption of commercial flights.

The civil aviation ministry has come out with a draft Standard Operating Procedure (SOP) for restarting commercial air passenger services in the country, which remain suspended since March 25 in the wake of the lockdown to curb spreading of coronavirus infections. "It is clarified that suggestions were sought on a draft discussion paper from airlines and airports. The suggestions have now been received.

The final SOP is yet to be issued," the ministry said in a statement.

No cabin baggage will be allowed while some snacks, however, could still be offered. Downloading the Aarogya Setu app will be mandatory for all the passengers. Passenger ID checks will also be not required so as to minimise the crowd at termi-

nal gates. The rules make it compulsory for all passengers to arrive at the airport only after completing their web check-in at home. The reporting time for travellers at the airport is proposed to be increased by two hours. Only passengers whose flights are scheduled to depart in the next six hours will be allowed inside the airports.

Cabin luggage will be disallowed, and only one piece of check-in baggage weighing less than 20kg will be allowed per passenger in the first phase of resumed airline operations. According to the draft

SOPs, only those with a "green status" will be allowed to enter the airport. Airlines have been asked to open check-in counters three hours prior to departure time and close them 60 to 75 minutes prior to departure. Boarding will commence an hour prior to departure time and the gates will close 20 minutes before.

Management graduate arrested for importing drug parcels from US



The Interpol has received reports from police in Ireland, Malaysia, Spain and the United Kingdom identifying delivery drivers transporting drugs such as cocaine, marijuana, ketamine and ecstasy.

In early April, the Spanish National Police identified and arrested seven individuals dressed as food delivery drivers in Alicante and Valencia.

Bengal to sub-divide Red zones into A, B, C categories

SAUGAR SENGUPTA KOLKATA

In a bid to organise microsurveillance of areas and at the same time allow partial economic activities during the lockdown period the Bengal Government has decided to sub-divide the Red Zones into A, B and C categories, Chief Minister Mamata Banerjee on Tuesday said.

While in the 'A' category areas the State will "enforce complete and strict lockdown and no movement of people will be allowed," in 'B' category there will be partial relaxation and the local police will decide the extent of such relaxation "provided the people follow the lockdown norms in the right manner," the Chief Minister said.

In the 'C' Red zones there will be substantial relaxation particularly for the smaller business. Banerjee said jewellery shops, electrical and electronic outlets and food stalls etc will be allowed to open from 12 in the noon to 6 pm. "... But no restaurant will

open. The people will only be allowed to take away food from the food stalls," she said adding how "it seems that the corona virus will continue for quite some time." As "it is not going away immediately we will have to revive the economy to some extent," the Chief Minister said once again attacking the Central Government for not clearing its dues.

Dwelling on her interaction with Prime Minister Narendra Modi during his video conference with Chief Ministers on Monday, Banerjee said Bengal gained nothing from the meeting and it returned "empty-handed." She alleged that the Centre

had "not cleared our legitimate financial dues" adding "I have raised several issues during the meeting with PM. But I must say we always return empty-handed after our meetings with PM. We are not beggars. We only want our dues from them. We have to serve a debt of ₹55,000 crore besides bearing the huge expenses to fight the pandemic

On the ongoing contro-

versy regarding the return of the migrant workers to Bengal the Chief Minister said already seven trains have been given and the people had started to return adding "the State has plans of giving 100 more trains for the held up workers to return," but cautioned the "steps bring people back have to be taken very cautiously because it may lead to further proliferation of the dreaded virus into the villages... the trains will be given in stages and people will be screened before entry."

In a related and significant development the Government transferred principal health secretary Vivek Kumar to the environment department, sources said adding he was likely to be replaced by Transport ecretary Narayan Swarup Nigam.

The development comes amid raging controversy over the State fudging corona relat-

ed facts. Kumar's transfer preceded the much controversy over conflicting reports placed by the Health Department stating

the number of corona cases to the Centre and the media.

On April 30, Kumar reportedly wrote to the Union Health Secretary putting total number of corona infections to 931. However the number provided by the Health Department for public consumption in Bengal stood at

Even as the Opposition parties including the BJP IT cell raised the issue the State Government had to face huge embarrassment. The transfer is an upshot of the incident, sources said.

The Kerala High Court on Tuesday asked the Union Government to submit details of the data privacy safeguards of Aarogya Setu App, the contact tracing app developed by the National Informatics A division bench consisting

of justices Anu Sivaraman and MR Anitha asked the Centre to make sure that the information collected by the Arogya Setu app would not be misuse and asked the Government counsel to file a detailed report. The court adjourned the case to May 18 for further hearing.

The observation and direction of the judges was in response to a public interest litigation filed by one John Dayal, said to be a social activist. The petitioner had sought an interim order against the 'mandatory imposition of the app' on Central Government employ-

Dayal's petition was a follow up to the Union Government's order making it mandatory for all Government employees and private citizens to make use of Arogya Setu app to counter the coronavirus pandemic. By an order dated April 29, the Centre has made it compulsory for all officers and staff of government establishments to download the Arogya Setu app in their mobile phones.

The Ministry of Home Affairs by its order on May 1 had made it mandatory for all employees in the central, State and private establishments to download the app and use it.

John Dayal's contention Judge Sivaraman told the was that the directives issued by

Arogya Setu app was violative of right to privacy and personal autonomy.

But Jaishankar Nair, the Government Counsel, told the court that Arogya Setu has been rated as the best app in the world fighting the Covid-19 pandemic. "With its help, more than 130 Covid-19 hotspots have been identified. About 10 crore persons have downloaded the App till Monday. On Monday, the empowered group on technology and data management has notified the Arogya Setu Data Access and Knowledge Sharing Protocol 2020 which lays down the guidelines for collection, processing, storage, sharing and anonymisation of the data," said the Government counsel.

He said the Union Government has made it clear that the App was a fool-proof mechanism to be used only for the purpose of fighting coronavirus and there was no possibility of it being misused.



Madras HC quashes Karti's plea in tax evasion case KUMAR CHELLAPPAN ■ KOCHI

Yet another attempt by the family of senior Congress leader and former Union Finance Minister Chidambaram to derail a case filed against them by the Income Tax Department came a cropper on Tuesday.

The Madras High Court on Tuesday rejected petitions filed by his son Karti Chidambaram and wife Srinidhi Chidambaram seeking to quash the cases against them by the Income Tax Department and also to dismiss the transfer of these cases to the Special Court constituted to hear cases against elected representatives

The case involves alleged Income Tax evasion by the husband-wife duo in connection with the sale of a plot of land owned by them at Muttukadu along the Bay of Bengal Coast

near Chennai. The IT Department had alleged that Karti did not disclose an income of ₹6.38 crore which he had received from the sale of the land in 2015. Kart's wife Srinidhi too did not disclose the details of the amount of ₹1.35 crore she had received from the sale deed.

The contention of the Income Tax department was that, Karti, elected to Lok Sabha from Sivaganga constituency in the 2019 elections, and his wife had received the amount in cash for the sale of land at Muttukadu years ago but allegedly did not disclose it in their I-T returns.

Karti objected to the case being heard by the Special Court set up to hear cases against MPs and MLAs on the ground that the transaction was completed and returns were filed in 2015 much before he was elected from Sivaganga constituency in 2019.

The Deputy Director of Income Tax Investigation (Chennai), had filed a complaint on September 12, 2018, against Karti and Srinidhi before the Additional Chief Metropolitan Magistrate Court-İI (Economic Öffenses) for offenses under sections 276c(1) and 277 of the I-T Act. The case was later transferred to the special court.

But the Madras High Court has stayed the proceedings twice against the Chidambarams in the months of January and February. Karti had fielded a team of eminent lawyers that included KTS Tulsi and Amit Desai along with Arun Natarajan, the famcounsel of Chidambarams. The Income

sented by M Sheela and N Baskaran while Vijaya Kumar appeared for the High Court Justice M Sundar pro-

The onus is on us

As lockdown 4 comes with easing of curbs, let us not undo gains with reckless behaviour. Self-control is the best preventive



nough the country is now going into lockdown 4, ostensibly at the request of States that have high cluster spirals and where containment is still a long-drawn problem, there is also a corresponding easing of restrictions to get the economy back on rails. So this lockdown is a lot about public behavioural discipline and compliance of norms and less of Government enforcement to ensure we slip into a culture of living with the virus. The Government would much rather focus on containing transmission of the disease with a targetted and focussed approach in containment areas

and allow resumption of the business of living in other areas. This, of course, does not mean a letting down of guard; the Government is keeping a watch but the onus of observance and vigil shifts considerably to citizens and local administrations. In fact, that is how things should be, a decentralised way of handling things. The Centre can only form broad policies but it is the States that are at the forefront of the battle against COVID-19, which is manifesting itself in different ways in different contexts and strains. This is one of the reasons why at the Prime Minister's teleconference with Chief Ministers, the latter argued that they be allowed to decide on zoning and easing of restrictions as they are best placed to assess and work on a situational report. It has taken Prime Minister Narendra Modi, usually known for his centrist and top-down approach, some effort to change himself and engage in consultative and cooperative federalism though all the "point taken" notes may not have reflected in policy always. But inputs now have to be matched with output. Which means the disease management has to be left to the wisdom of State Governments, irrespective of political affiliation or point-scoring. Central intervention can be limited to strategic management and lending expertise. Of course, it must now ramp up financial assistance within a reasonable range and work out a national fiscal stimulus, enable big bang reforms and launch economic correctives. Yes, things were mishandled in the beginning. The unplanned and sudden lockdown set off an unprecedented reverse migration of daily wagers, who were evicted from their livelihoods and settlements overnight. Now that there is a system of repatriating them through buses and trains with the Prime Minister himself acknowledging that the right to return home must be respected, one wonders why this could not have been done before when the disease burden had not quite bulged out of shape and a disciplined exit would have saved them from contracting infection at overcrowded camps and assemblage points. Even now this unanticipated exodus of labourers from cities to their villages continues unabated, shocking us out of our wits when they die along the way due to hunger, dehydration or accidents. Those who cannot afford a bus or train as daily earnings have meant no savings — a majority, in fact — continue to trudge hundreds of kilometres, over weeks, in the journey back home where they may have a hovel and live off the land. And if they had to be held back, there should have been assurances, job camps and soup kitchens, something that are being organised by some private organisations even as States like Haryana and Punjab are registering migrants on a portal to relocate them to safe working sites that are running now. While the lockdown has given us ample time for preparing counter-strategies and medical infrastructure, testing wasn't intensive or fast enough to trace a pattern of clusters and hotspots and map the spread early. And though the Government is relying on its response module of experts, it wouldn't be a bad idea to broadbase that and get the best minds in medicine, economics and social sectors to submit their recovery strategies, regardless of whether they have been approached or not. Be that as it may, course correction can begin even now and howsoever flawed, the lockdown was needed in a densely populated country like ours.

Also, let us not forget the resurgence of the disease, the second wave as it is called, in South Korea, Germany and even Italy, where lockdown exits have been allowed but have gone out of hand as people got into their old socialising habits at public spaces. India will have to be very careful about not losing the advantage so far by giving into abandon. It can learn from scenarios in various countries. For example, the UK has allowed people to meet friends or relatives in parks maintaining a twometre distance and will be permitting standalone shops, eateries and salons gradually thereafter. Of course, any spike will mean withdrawal of these freedoms. In the end, we have to reconcile that we have to mostly stay at home, even work from there and limit our public presence. This may seem a tall order but without a vaccine, our choices will shape our right to live.

Flying isn't a problem

The skies need to open again for the sake of the economy but the process might be complicated



The aviation sector has been among the hardest hit due to the Coronavirus pandemic. Even in those countries where air travel has not been completely restricted, passenger confidence has plummeted. Particularly as airlines became accustomed to shoving more and more people onto seats. social distancing onboard aircraft is being considered to be an impossibility now. Close proximity to strangers is the problem, or so we have been told over the past few weeks. And there are other things around, too. The huge lines at security and immigration points and at the check-in desk as well

as the luggage reclaim counters. And what about taking a bus to the plane? Or even a taxi to and from the airport? The fact is that the process of flying will not just expose one to the 200 or so people on an aircraft but potentially thousands, thanks to the airport and transportation links. But there's a spot of good news over here. Aircraft manufacturers and airlines are highlighting that the advanced air filtration systems they have onboard the aircraft are effective in stopping the spread of the virus. That may not help if someone around you sneezes but it should prevent an entire aircraft getting infected from a single passenger.

But how can an airline or even the Government assure hygiene within airports, buses and taxis? The problem may not be centred around the aircraft alone but the entire ecosystem. Controlling this might be a lot harder than it seems at first. So returning to the normal of having 10 million domestic air passengers every month is impossible. Starting up airlines will require an immense amount of coordination and planning if we do not want aviation to start spreading the virus again. It would be prudent to start flights similar to what the Indian Railways have done — limited numbers of flights to and from a limited number of airports. At the same time, only those who have the Aarogya Setu application on their devices for a certain period of time so as to get a bit of history, should be allowed to travel. Aggressive contact tracing might even need to be done through the use of Aadhaar, which is India's only reliable national identity card. Make no mistakes, civil aviation is vital. For a country as large as India, it offers the only fast, reliable and affordable way of covering large distances. If domestic tourism and business is to revive, aviation has to start soon. But we should not take any shortcuts or do any jugaad. We must ensure that all precautions are taken at the start.

Generalship hereafter

COVID realities have compelled the armed forces to make adaptive changes. For this, the leadership has to be politically literate, sophisticated but still daringly apolitical in its conduct





ike all domains, the armed forces will be forced into making adaptive reality. As a lean-mean fighting machine, the onus of recalibrating the Army's professional essentialities and sensibilities will not fall on "generalist" bureaucrats or the temporary politicos who hold the reins of the Defence Ministry but will rely on the senior leadership of the armed forces, euphemistically the "Generalship" of all fighting services. Over the years, the strategic thinking and calculus of the armed forces have evolved to incorporate the fluid reality and inevitability of diverse security realms. For example, nuclear threats, slow-bleed insurgencies, integrated commands and cyber warfare, among others. Now, to meet the COVID imperatives, the tradition-bound armed forces will require the most intellectual, innovative and convention-challenging strategic callisthenics that would be called upon such "Generalship."

The most reassuring starting point is the unmistakable calibre, ethos and conduct of the ranks and the junior-to-middle leadership, which require fundamental soldiering attributes ie, physical, psychological and moral discipline of the 'core" mass. The recent martyrdom of Col Ashutosh Sharma, Major Anuj Sood, Naik Rajesh and Lance Naik Dinesh (and Jammu & Kashmir police's sub-inspector Sageer Pathan) in Handwara was reflecve of the Indian Army's "unlimited liability" where the officer-cadres lead from the front, unlike any other military in the world. The already twice gallantry-decorated commanding officer, Col Sharma, is a personification of the long list of bravehearts like Colonel MN Rai, Major Mukund Varadarajan and countless others who have given the Indian armed forces the highest "officer-to-soldier" fatality ratio in combat operations compared to any counter-insurgency operation in the world.

The Kargil war was yet another display of the supreme valour, raw grit and unparalleled josh of the "core" junior-tomiddle leadership that defied conventional logic, firepower ratios and assumptions that typified the ground situation and prevailed before retaking those unforgiving heights. Yet, it is the peripheral tasks and expectations beyond this "core" of the Indian security framework that has not lived up to the parallel performance of the "core." Take the example of the muchindustry has repeatedly ensured that the country retains the dubious distinction and vulnerability as the world's largest

importer of weaponry. The winning USP of the tactical and operational competence of this "core" junior-to-middle military leadership must be force-multiplied with the matching



In today's context, the 'Generalship'' must demonstrate leadership beyond the tactical and operational realm that is managed exceptionally well by the "core" and envisage the higher orders of geo-strategic, geopolitical, cultural, social, psychological and even political impact of every institutional action and commitment. Routinely invoking and positing the strength of the "core" is certainly justifiable and expected but not enough.

The "Generalship" has to go beyond and contribute its own towards the readiness for tomorrow. All military commitments have a political nudge as the armed forces are the "sword arm" of the nation. But it is incumbent on the "Generalship" to manage, nuance and advise the civilian leadership of the long-term consequences. There are always personal, institutional and cultural concerns at play. Managing the competing expectations and outlook will always determine the steel of the "Generalship."

Manekshaw goes down in the annals of history as the complete "General" who did not succumb to political pressures. Instead, he pushed back the establishment for timing, wares and control levers that were in consonance with the basic mil-



Shot in the arm for Indian Army his refers to the editorial, "Pincer attack" (May 12).

Indian forces in the Kashmir Valley have tasted a great deal of success in the last three to four years. The much-acclaimed "Operation Jackboot" claimed its last high-value target in the killing of Hizbul Mujahideen chief Riyaz Naikoo. The elimination of dreaded terrorists like Hizbul commanders Burhan Wani, Zakir Musa and Sabzar Bhat, Lashkar-e-Tayyiba (LeT) chief commander Abu Dujana and South Kashmir LeT commander Abu Ismail, the mastermind of the 2017 Amarnath Yatra attack, were attributed to meticulous planning and clinical execution on the part of the armed forces.

A 35-year-old math teacher, who joined the militant ranks in 2012, Naikoo quickly rose to be the Hizbul Mujahideen's "operational commander" after incumbent Zakir Musa quit to form a separate outfit. Musa had replaced Wani in that role. Naikoo, after Wani, was said to be the "face" of the Hizbul. His ability to keep his flock together was considered as an asset in a rank divided by infighting. It was speculated that Naikoo's presence stopped splinter groups within the Hizbul from turning towards the slain Musa's outfit. The low-profile terrorist, who carried a bounty worth rupees ₹12 lakh, never attracted publicity, a "quality" that endeared



him to the Hizbul cadres. The killing of Naikoo is considered a shot in the arm for the armed forces. The surgical precision with which Naikoo has been gunned down points to the fact that the intelligence gathering network in Kashmir is now intensive and precise. Naikoo's killing may drive a wedge between different top terror organisations much to the glee of India's security forces. Additionally, his killing has created a vacuum in the higher rung of the Hizbul. The so-called homespun militancy wave seems to be on the wane.

Opportunity in a crisis

The Congress Party should give constructive cooperation to the Modi Government right now and lead the Opposition, too



hile there was disappointment within the Congress that interim president Sonia Gandhi was not very active and former chief Rahul Gandhi was indifferent to politics, the COVID-19 outbreak seems to have rectified that. Sonia and Rahul are being proactive again on the issues related to the Coronavirus pandemic and the Government's handling of it. And their return to form has boosted the morale of the demoralised party workers.

It may be recalled that in 2017, a day before handing over the reins of the Congress Party to her son Rahul, Sonia had said, "My role is to retire." Sonia said she wanted to spend her retired life reading books and spending time with her family.

The Congress media cell chairman Randeep Singh Surjewala had tweeted at that time, "Sonia Gandhi has retired as president of the Indian National Congress and not from politics." This proved to be true as the situation made it imperative for her to return as interim president in August 2019. Sonia has been playing an active role ever since she came back as interim president in August 2019, after Rahul resigned from his post as party chief, owning moral responsibility for the humiliating Lok Sabha election defeat

Sonia has always been a fighter and she has taken up the challenge of fighting the issues arising out of the COVID-19 outbreak, despite her health problems. She sent letters to Prime Minister Narendra Modi supporting the countrywide lockdown announced by him and assured him that the party was with the Government in fighting against the pandemic. However, as the days passed and there was some disappointment over the Modi Government's handling of the millions of migrant labourers left in the lurch by the sudden lockdown announcement and the suspense over the post-lockdown exit strategy, Sonia and Rahul got into action.

First of all, Sonia activated the party to fight the Coronavirus at the State-level. She also pushed the Congress Chief Ministers to provide succor to the needy. She involved senior party leaders in the initiative and held three Congress Working Committee meetings to discuss the party's COVID-19 strategy. She also held a virtual meeting with Congress Chief Ministers last week. Sonia has been asking the Modi Government about its plans for the future. "After May 17, what? And after May 17, how? What criteria is the Union Government using to judge for how long the lockdown has to con-

Initially, on March 25, she wrote a letter extending support to the three-week lockdown imposed by the Centre. Then, on April 7, she came out with five suggestions, including scrapping of the central vista project, banning Government advertisements to the media putting on hold official foreign trips and moving the PM CARES fund to the Prime Minister's National Relief Fund and other austerity measures, in response to Modi's telephone call to her asking for suggestions. On April 11, she formed a COVID-19 action committee for the party under the chairmanship of former Prime Minister Manmohan Singh and on April 13, she wrote a letter to Modi urging the Government to ensure that no one faces hunger during the lockdown necessitated by the country's fight against the Coronavirus. Hours before the Prime Minister's address to the nation Sonia sent a video message on April 14, "Today when the country is fighting such a huge battle, I want to assure you all that whether the Congress is in Government or in the Opposition, it is with you in this fight.' But the masterstroke came when she announced a week ago that the State Congress units would bear the cost of the train fare of the migrant workers heading back home. This forced the Modi Government to go back on its decision and allow the migrant labourers to travel on highly subsidised tickets.

Rahul is also actively supporting his mother, though he holds no official party position now. He is getting ready to take over the Congress once again. He has been quite visible on social media with his critical tweets. He believes that the COVID-19 situation is serious and the lockdown is only a "pause button." He has suggested a nuanced approach to fight the pandemic. Rahul believes that India will lose if the COVID-19 fight is restricted to the PMO and has suggested decentralisation of power to the district level. He has held interactions with the Press and economic experts like former Reserve Bank of India Governor Raghuram Rajan and Nobel laureate Abhijit Banerjee about the economic strategy in the post-lockdown period. Every crisis presents an opportunity and the Coronavirus has given the Congress a huge opportunity to revive. The party should give constructive cooperation to the Modi Government. The Congress must also lead the Opposition but sadly, the Opposition is not united. Each party is going its own way and there is no combined strategy. Last week six Opposition leaders submitted a memorandum on the migrant labour problem to the President. The Congress, while uniting the party, should also try to unite the Opposition and try to bridge the leadership vacuum in Opposition ranks.

Lay down the law

There is need for a comprehensive legislation encompassing all aspects of public life, stipulating rules and regulations vis-a-vis social distancing and crowd management

espite the fact that nearly three billion peoble are under lockdown globally, there has been no let-up in the number of Coronavirus cases. The world is still busy battling the Corona crisis as the number of cases has risen to 42,68,496 and casualties have touched the 2,87,463 mark globally. India, too, has seen the number of confirmed cases rise to 70,827 and deaths spike to 2,294 despite the prolonged lockdown the nation has placed itself under. As the world economy stumbles and the monetary security of many nations lies in tatters, more and more countries are coming round to the realisation that they will have to open up their economies sooner than later. Even India has decided that it needs to live with the Coronavirus and the Government has begun to ease restrictions slow-

As we gradually come out of the lockdown, there is a realisation that life is not going to be the same again. The world, as we know it, has changed as we have to live with the virus. The possibility of the invention of a vaccine as of now appears to be very remote. So, in order to survive, we just have to change the way we live our lives and bring in new legislation to enforce social distancing and crowd management, which are the two crucial aspects relevant to the control and the spread of

Albeit different legislations in relation to safety at the workplace and public places have been passed, they are directed only towards providing physical safety. These legislations, *viz.* the Municipal Corporations Act, Municipalities Act and certain other regulations relating to workplace hazards do not contemplate the requisite guidelines pertaining to social distancing and crowd management. Other statutes relating to workplace hazards contemplate only the steps to be taken in relation to the health of the staff *vis-a-vis* the nature

of work that is being done.
COVID-19 has compelled us to adhere to new norms in relation to health, irrespective of the nature of work, place of congregation, reason for the gathering and so on. Certain measures like maintaining hygiene, social distancing, wearing masks and restricting the number of people travelling in a car to three, have to be compulsorily adhered to.

pare for the pandemic and reduce the pressure on the healthcare system, but will in no way help end the epidemic. There is a possibility of an exponential increase in cases once the lockdown is totally lifted. As it is, we have seen a spike in cases after the Government eased some restrictions and allowed limited economic activity.

So, unless our conduct is strictly regulated, it would be very difficult to prevent large-scale community transmission of the dreaded virus. Highlyregulated social conduct is warranted to minimise the destruction that may be caused in future due

At present, the legislations are directed only towards workplaces. They are silent with regard to social distancing and crowd management. For instance while sanctioning permission for construction of a building to run a cinema hall, the requisite parameters taken into account would be the number of seats vis-a-vis the physical safety. But social distancing inter-se between the audi-

ence and the management of the crowd at the cinema halls is not stipulated in the legislation. It's the same in the case of religious places, schools, marriage halls, restaurants and so on.

Therefore, there is a requirement for a comprehensive legislation encompassing all the aspects of public life, stipulating rules and regulations vis-a-vis social distancing and crowd management. The said legislation should have an overriding effect over all the other Acts and anything done under the said Acts should be in consonance with such

a legislation.

It should provide for penal provisions in case of violations. The present enactments such as the Epidemic Diseases Act, 1897 and the Disaster Management Act, 2005 are not enough to control and enforce strict social distancing and crowd management in varplate these norms. In fact, these legislations are being invoked as a temporary measure now.

The Epidemic Diseases Act, 1897 is a very short legislation which can be enforced only when there is a pandemic but would not serve the purpose of preventing one. Similarly the Disaster Management Act, too, is directed mostly at post-disaster management and not at averting one.

The Epidemic Diseases Act, 1897 was enacted for the better prevention of the spread of contagions. Section 2 of the Act contemplates that, "When at any time the State Government is satisfied that the State or any part thereof is visited by or threatened with an outbreak of disease, the State Government may take, or require or empower any person to take, such measures and by public notice, prescribe such temporary regulations to be observed by the public by any person or class of persons as it shall deem necessary, to prevent the outbreak of such disease or the spread thereof. It may determine in what manner and by whom any expenses incurred shall be defraved.

Section 2A confers power upon the Central Government to take measures and prescribe regulations for the inspecand prescribe regulations for the inspection of any ship or vessel leaving or arriving at any port and for its detention. The said provisions do not contemplate any permanent regulations and the rules governing the field of social distancing. While enacting the said legislation, the draftsmen could not have visualised the present complex nature of development present complex nature of development viz. commercial and technological.

The Disaster Management Act, 2005 was enacted to provide for requiing up and monitoring the implementation of disaster management plans and ensuring measures for the prevention and mitigation of the effects of disaster and for undertaking holistic, coordinated and prompt response to any disaster situations. Section2(d) defines disaster as a catastrophe, mishap, calamity or grave occurrence in any area arising from natural or man-made causes or by accident or negligence, which result in substantial loss of life or human suffering. The reading of the definition shows that essentially the Act is directed towards post-disaster management.

Similarly Section2(e) which defines disaster management also shows that it is directed only in relation to post disaster management. Section 75 and 76 confer powers upon the Central Government to make rules and regula-

tions. Section 78 confers power upon the State Government to make rules but the said rules and regulations would be in relation to disaster management but do not take into their fold comprehensive guidelines to regulate social distancing and the crowd management at all places

of congregation.
As these two legislations cannot provide any regulation for social distancing and crowd management post the lifting

and crowd management post the lifting of the lockdown, there is a dire need for a comprehensive legislation to do that.

The statute would have to take into its fold various types of congregations and issue necessary guidelines to be followed for regulating social distancing and crowd management. What we require is the prevention of carried of any require is the prevention of spread of any virus/disease due to human contact directly or indirectly. To do this we need a comprehensive legislation stipulating conditions taking into its various spheres of congregation.

The said law should also contemplate the creation of an expert body to frame respective guidelines in relation to social distancing and crowd management at different places of congregation.

The action that has been initiated by the Central and State Governments at present is only for the purpose of controlling the spread of the virus during the lockdown period. Once the lockdown ends, and end it will one day, the parameters relating to social distancing and crowd management would be very essential. Therefore, unless such a legislation is brought into force it would be very difficult for us to live with the Coronavirus.

US will cross 10mn mark in conducting virus tests: Trump

Donald Trump has said the US has increased the COVID-19 testing capacity and the number of tests being conducted in the country will cross the 10-million mark this week even as the coronavirus deaths surged past 80,000 in the world's worstaffected nation.

"If we skip over the check-points in the guidelines...Then we risk the danger of multiple outbreaks throughout the country," Fauci wrote.

Terrorists storm maternity clinic in Afghan capital, kill 14

Kabul: Militants stormed a maternity hospital in the western part of Kabul on Tuesday, setting off an hours-long shootout with the police and killing 14 people, including two newborn babies, their mothers and an unspecified number of nurses, Afghan officials said.

While the battle was underway, Afghan security forces struggled to evacuate the facility, carrying out babies and frantic young mothers, according to images shared by the Interior Ministry.

But the day's spasm of violence extended beyond Kabul. A suicide bomber in eastern Nangarhar province — a hotbed of the Islamic State group — targeted a funeral ceremony, killing 21 people and wounding 55. And in eastern Khost province, a bomb planted in a cart in a market killed a child and wounded 10 people.

Govt does not release April inflation figures as lockdown prevents data collection

The Government did not release the April CPI inflation data on Tuesday as the nationwide lockdown prevented officials from collecting price data at various centres. However, the Consumer Price Index (CPI) data that could be collected telephonically has been released, the National Statistical Office (NSO) said in a release.

Usually, price data is collected from selected 1,114 urban markets and 1,181 villages through personal visits by field staff of Field Óperations Division of NSO on a weekly roaster. The data collected telephonically did show increase in prices of certain important commodities like milk products, fruits and vegetables in April over March.However, the press release said, "the General CPI and indices at State/UT level are not being released for the month of April, 2020."

In view of the preventive measures and announcement of nationwide lockdown by the Government to contain the spread of COVID-19, the collection of data on prices for CPI through personal visits of price collectors was suspend-2020. Online education is not confined to e-lectures. It also demands e-content, study material, a developed ed-tech base and an effective entrepreneurship to make it a success, says DR DNS KUMAR

caught people across the maps off-guard and is seen manifesting itself exponentially with every passing day. COVID-19 is not only impacting the economy of the countries but is also disrupting the basics of survival, with one of them being education.

The virus is to be held accountable not only for postponing the board exams and encouraging States to adopt social-distancing but is also intervening with the higher education of the aspiring students. With universities and schools shut across the country, the question arises — are we ready? The question stands to be if India is prepared to adapt to an online education system and encourage students to learn from the comfort of their homes? And if yes, how fertile is it going to be in the long run?

The answer somewhere reflects in the current statistics of the country. Even though India has been expanding its horizons of success and adapting to international ways of learning, what remains unchanged is the fact that only 45 crores of the total population in India can access the mobiles and thus hindering the purpose of elearning on the move or remotely. The students lying in the underprivileged section are still being deprived of the education online. The education system of India is branched into various kinds of educational institutions such as private, Government, rural, urban, government-funded; non-funded and many more. The entire cluster of educational stations requires concrete support to be able to make a fertile change in society.

The cycle of online education is not confined to e-lectures but also demands e-content, study material, a developed ed-tech base, effective entrepreneurship and much more to make it a success. However, India does not seem prepared in terms of resources as well as advancements to carry forward the westernised approach of e-learning for all, considering there lies a lot of obstacles in the same. This is where one realises that the need for the Government to step in. The Government is required to render its expertise and services and focus on the educational infrastructure



and facilities, irrespective of institution falling under the private or the gov-

Also, the fact that the country hardly has a handful of online platforms to guide students in their respective fields somehow negates the aim of online learning and e-education. Although India's budget 2020 talked of about ₹3,900 crore of the online education market, there is no denying that the providers did not emerge evidently and now, the pan-demic spreading across is also impacted in the economy, resulting in a slowdown and mass-panic — which again is a factor playing a significant role in the ed-tech sector not being developed

to handle e-learning comprehensively. Furthermore, existing educational institutions have had the desire to develop have a regulatory restriction as you have to specify a 3.50+ NAAC score to go fully on online mode; however, it isn't seen contributing to the current scenario and crisis heroically. Adding to the situation lies the fact that the e-content and ed-specific material is at the nascent stage of development and it will take quite some time or terms for India to become one of the doyens of the e-learning industry.

The advancements in IT sector and with an expected CAGR of 44 per cent in online between 2019-2024 might sound good enough for one to anticipate a productive future in the ed-tech and e-learning sector; however, the current situation stands way apart from that.

Adopting e-learning partially in the moment of crisis might seem like an idea which would steer us through the storm, but considering it an extensive plan in the term might sound like an exaggeration. The ray of hope, here, seems to be the fact that the country is collectively supporting fellow citizens and endeavouring to devise ways to get through the crisis and thus being the light at the end of the tunnel because 'this, too, shall pass'

Legal awareness is the domain of every citizen. Just like health and hygiene are taught to toddlers, legal awareness should also be included in the curriculum, says DR PURVI POKHARIYAL

With a large part of its population living in villages, India does not have a literacy rate to be proud of-it is barely 74.04 per cent. Most of the literacy figures pertain to those who can actually read, write or do basic arithmetic! Awareness about law and legal aspects is obviously abysmal to pathetic.

There have been several impediments to the issue of awareness of Legal Aid in India. The first and the foremost is the total lack of knowledge of the fact that legal aid is the provision of assistance to people who are unable to afford legal representation and access to the court system. This is followed by the mistaken notion that free legal aid is not compatible with quality of service rendered. The fact that remuneration to the lawyers imparting free legal service to clients pecuniarily handicapped is a pittance does not help much either, which is a cause of lack of interest of such lawyers handling such cases.

The Indian Constitution provides for its citizens a right to legal aid. This is guaranteed under Article 39-



A of the Constitution brought through by the 42nd Amendment in 1976, supported by Article 21. Right to free legal aid is also guaranteed by the European Convention (Article 6.3) of the Human Rights particularly in criminal cases wherein it is deemed essential to guaranteeing equal access to justice for all, especially to those citizens who do not have sufficient financial resources. The concept of pro bono is very much prevalent in the British judicial system which recognises this aspect and imparts free judicial service to its citizens through legal clin-

ics and Duty Lawyers. However, legal aid, without its awareness is an exercise in futility. The empowerment of the general mass is imperative to ensure that this aspect of legal aid is utilised to the fullest. Without legal literacy, the common

man is likely to get intimidated and alienated from the legal system and consequently get in conflict with their own law that is made to serve the interest of the common people with damaging and disastrous conse-

It is a mistaken notion that legal awareness is only meant for the law student. It is precisely here that the seeds of exploitation of the common man is sown. Legal awareness is the domain of each and every citizen of this country; just like health and hygiene is taught to the toddlers, legal awareness should also be included in the curriculum after the child reaches a certain standard. The student of political science is taught about the Indian constitution; how many are taught about the intricacies of the complex legal system? Such studies should be made the integral part of the curriculum wherein a student is made aware of all the nitty-gritty of the legal system, and above all, free legal aid is his right as imparted by the Indian constitution and he should demand it.

With the Coronavirus having irrevocably changed the nature of work and the state of mind of FYI, a health-tech community product, undertook a first of its kind survey conducted by MindMap Advance Research. As the country prepares for offices to open post the lockdown, the survey assesses the anxiety level of employees and records a strong desire to do what's right by their co-workers by complying to new health monitoring compliances, along with a high degree of awareness of changes in routine that await

The survey suggests that employees expect their employers to take responsibility environment for them. An overwhelming 93 per cent of employees are anxious to return to office, reveal the survey findings announced today. They fear is on account of their health being compromised.

Employees expect the new normal to bring changes and are cognizant of what these could be. 81 per cent said that employees would resume work only in batches, while 73 per cent expect employers to enforce work from home as an ongoing

A post pandemic world offers employers an opportunity to win the hearts of their employees and customers by deploying

stronger solutions for the overall well-being of their workforce, said a majority of the respondents. While 81per cent of employees strongly feel this will be the case, 16 per cent said that this has always been an expectation, regardless of recent events.

COVID-19 has left professionals anxious on several accounts. While a majority, 59 per cent are concerned about their health, 25 per cent said they are anxious about their financial situation, while 16 per cent fear that the crisis will be a prolonged one and this uncertainty lends to high anxiety.

"It may be an understatement to say that the COVID-19 pandemic has transformed the way we live and work. This event has very quickly served as a tipping

point to unprecedented change in the mindset and attitudes of people, to both life and work. The new priorities they would need to juggle when it comes to the health and safety of their employees. India Inc. employees are clearly stressed on account of their health and that needs to be managed on priority. Evidence supports the fact that happier and secure employees are more productive and perform their jobs better while those under stress, perform worse" said Yeishan Goel, Co-founder, FYI.

Addressing visa concerns, students with a temporary visa due to expire between April 1 and July 9, 2020 will have their visas extended to September 25, 2020. Adjustments are also being made for tertiary students who are

unable to leave and are no longer enrolled.

Work rights & subsidies New Zealand has also relaxed work rights for international students. As per the revised rights, international students in healthcare roles including aged residential care may work more than 20 hours per week for a period of three months.

To help students cope with

financial hardship, the Government is offering wage subsidies to those whose employment has been affected by COVID-19. Universities and student associations are offering budgeting or finance services, emergency payments from a hardship fund, or a food parcel. Students have been guided to their local Civil Defense Emergency Management Group for basic food, medicine and cleaning supplies. Free public healthcare is provided to international students if they think they have contracted COVID-

Hotline set-up

The hotline is a one-stop solution for international students with all kinds of queries. Students living in a hostel have been advised to check with their place of study to confirm accommodation arrangements that they have in place. Student hostels are strictly enforcing personal distancing and hygiene requirements, in accordance with Ministry of Health guidelines.

Students have additional support by the Tertiary Education Commission on a hotline number dedicated to them. If students are feeling anxious or lonely, there are several free counselling services they can use.

FIFA U-17 Women's WC from Feb 17

he postponed FIFA U-17 Women's World Cup in India was on Tuesday rescheduled to next year from February 17 to March 7 after the world body made a "thorough assessment" of the situation arising out of the Covid-19 pandem-

The tournament was originally scheduled to be held from November 2 to 21 this year but was postponed last month due to the coronavirus outbreak.

FIFA announced that the tournament will keep its original eligibility criteria and allow "players born on or after January 1, 2003 and on or before December 31, 2005" to com-

pete.
"Following a thorough assessment of the impact of the Covid-19 pandemic and the subsequent recommendations made by the FIFA-Confederations Covid-19 Working Group, the Bureau of the FIFA Council has taken the decision to confirm the proposed new tournament dates, subject to further monitoring," the FIFA said in a statement.

The tournament will be held at five venues in the country — Kolkata, Guwahati, Bhubaneswar, Ahmedabad and Navi Mumbai — and competed among 16 teams, with hosts India being automatic qualifiers in what will be the country's maiden appear-



ance in the U-17 Women's World

Promptly reacting to the development, Sports Minister Kiren Rijiju assured full cooperation and support to the tournament.

"I assure full cooperation and support to make it a grand success," Rijiju tweeted.

The All India Football Federation (AIFF) president Praful Patel, under whose leadership the country successfully hosted the men's U-17 World Cup in 2017, promised an

"Delighted to share the new dates for the U17WWC, which will now be held between Feb 17 to Mar 7, 2021. I would like to thank all our stakeholders for their continuous support over this period. AIFF & LOC remain committed to delivering a historic tournament," Patel tweeted.

The Local Organising Committee (LOC) welcomed the decision and assured full preparedness.

'The dates were confirmed after taking into account the time needed to complete the UEFA, CONCACAF, CAF, OFC, and CONMEBOL qualification tournaments as well as the best possible conditions in the country to host a successful FIFA U-17 Women's World Cup," the LOC said. Before the tournament was post-

poned, the only qualifying event that could be held was for Asia from which Japan and North Korea made

Five remaining qualifying events that of Africa, Europe, Oceania, South America, and Central, North America and Caribbean — saw a halt due to the ongoing global health crisis.

The LOC stated, "We are now

looking ahead and hoping to host a wonderful tournament that will give women's football in India, the perfect platform to grow and develop.

"All the Host cities have put in a lot of effort and commitment so far, and we are happy that the new dates will allow them to make up for the lost time and provide momentum going for-

The official schedule of the tournament was announced in February, and Navi Mumbai was to host the final

"All the stakeholders, including the Ministry of Youth Affairs and Sports, have been supportive of the decision keeping in mind the health, safety and security of everyone involved, especially the teams and fans," the LOC stat

"The LOC will continue to work together with FIFA, and we remain fully committed to hosting a memorable and successful tournament," the organising committee added.

When MS lost his cool

Mahendra Singh Dhoni has hardly lost his temper during his decade and a half long illustrious career but there have been a few exceptions when Captain Cool has let it rip, recall his former India teammates Gautam Gambhir and Irfan Pathan.

Recently, India spinner Kuldeep Yadav had revealed that he was mortally scared when Dhoni, by his own admission, had lost his cool for the first time in 20 years.

And the left-arm chinaman bowler was at the receiving end when he did not adhere to Dhoni's instructions while bowling during an ODI against Sri Lanka in 2017.

The 38-year-old Gambhir, who played 58 Tests and 147 ODIs for India, revealed that on couple of occasions he saw the veteran wicket-keeper batsman lose his cool.

"People say that they have never seen him (Dhoni) lose his cool, but I have on a couple of times. It was during the 2007 World Cup and in other World Cups, when we haven't done well," Gambhir said on Star Sports show Cricket Connected.

But in the same vein Gambhir also said that Dhoni was a human and was bound to react as well.

"He's human and he's bound to react as well. It's absolutely fair enough to do that. Even at CSK, if there's a misfield or if someone has dropped a catch...," added Gambhir.

Gambhir, who was often known to lose his cool, said that Dhoni was cooler than him. "Yes, he's cool, he's probably

much cooler than the rest of the other captains. Much cooler than me for sure!," said Gambhir, who also played under Dhoni.

Former Australia speedster Brett Lee agreed with Gambhir and said: "We want entertainers, we want people to do that and MS Dhoni is an entertainer."

"He never steps over the boundary. If he does, it's very rare. But we are all human as Gautam Gambhir said." In the IPL, the likes of

Ravindra Jadeja and Deepak Chahar all have faced Dhoni's wrath at some point or the In 2019, Chahar bowled consecutive no-balls against

Chennai Super Kings have rejected the idea of an IPL with only Indian players in the near future, diffranchise which is keen on the option given the circumstances caused by the Covid-19 pandemic.

The IPL, which is indefinitely postponed, can be held in the September-October window if the scheduled T20 World Cup in Australia doesn't take place.

"CSK is not keen to do an IPL with only Indian players. That way it would be playing another Syed Mushtaq Ali Trophy (domestic T20 competition). The franchise has not been in touch with the BCCI of late as the situation is worsening," a CSK "Let's hope we can have the IPL later this year," he added.

CSK are three-time IPL champions, making them the second most successful team in the event's histowon the tournament four times.

The BCCI is also very keen to stage the IPL but with Covid-19 cases continuing to rise in India, the board and IPL team officials see little point in discussing when the event can be

"There has been no discussion with the BCCI ever since it postponed the IPL. There is no point in discussing also as things are unlikely to be okay anytime soon," the CSK source said.

"We expect the BCCI to take the best possible decision when the time comes," he added.
