LORD VISHNU'S 1,300-YR-OLD TEMPLE DISCOVERED IN NORTHWEST PAKISTAN

Hindu temple, believed to have been constructed 1,300 years ago, has been discovered by Pakistani and Italian archaeological experts at a mountain in northwest Pakistan's Swat district. The discovery was made during an excavation at Barikot Ghundai. Announcing the discovery on Thursday, Fazle Khaliq of Khyber Pakhtunkhwa Department of Archaeology said that the temple discovered is of Lord Vishnu. It was built by the Hindus 1,300 years ago during the Hindu Shahi period, he said. The Hindu Shahis or Kabul Shahis (850 1026 CE) was a Hindu dynasty that ruled the Kabul Valley (eastern Afghanistan), Gandhara (modern-day Pakistan-Afghanistan), and present-day northwestern India.



BHUTAN DENIES CHINESE INCURSION; BLATANT UNTRUTH, SAY OBSERVERS

Maps bearing the official seal of the Bhutan government, accessed by NDTV, also indicate that this new Chinese settlement lies well within Bhutan's present claim lines. Major General Vetsop

Namgyel, Bhutan's Ambassador to India, said, "There is no Chinese village inside Bhutan." On whether Bhutan and China had reached any understanding on realigning the border in the contested area, the Ambassador said he "does not comment on border matters.

WHO ADVISES AGAINST REMDESIVIR FOR ALL HOSPITALISED COVID PATIENTS

 $G^{ilead's}$ remdesivir is not recommended for patients hospitalised with COVID-19, regardless of how ill they are, as there is no evidence the drug improves survival or reduces the need for ventilation, a World Health Organization panel said on Friday.

panel found a lack of evidence that remdesivir improved outcomes that matter to patients such as reduced mortality, need for mechanical ventilation, time to clinical improvement, and others," the guideline said. The advice is another setback for the drug, which grabbed worldwide attention as a potentially effective treatment for COVID-19 in the summer after early trials showed some promise



LORD MEGHNAD DESAI RESIGNS FROM UK LABOUR PARTY, CITES RACISM

Indian-origin economist, author and peer Lord Meghnad Desai has resigned as a member of the UK's Opposition Labour Party over its failure to effectively tackle antisemitic racism within its ranks. The 80-year-old peer said he has only ever

been a Labour Party supporter but was forced to take the decision to cancel his membership on Thursday after 49 years after former party leader Jeremy Corbyn was readmitted after just 19 days of suspension despite findings of "unlawful acts" by the country's human rights watchdog. "It was a very peculiar decision to allow him back without any apology. He has been refused the party whip in the House of Commons for a few months, but that is a very lame response to a very big crisis," Lord Desai said.

Covid test rates to come down more: Etela

The cost of COVID -19 tests in private labs may go down further in near future from the current level of Rs 850, Telangana Health Minister Etela Rajender said on Friday. According to a press release, the minister stated this while addressing a panel discussion organised by TRSMA (Telangana Recognised School Management Association) as part of the ongoing three-day hybrid exhibition PHIC (Preventive Healthcare and Infection Control Expo)-2020 here. "We never wanted to permit private labs to test COVID as they charge exorbitantly, but, because of various reasons, we were compelled to permit them. The prices were beyond the reach of many common people.

Now we have brought it down to Rs 850 just a few days back and it might go down further in next few days, maybe 10 days or more," the release quoted Rajender as saying.

Microsoft co-founder Bill Gates believes that a "lot of things" will be back to "normal" by the summer of 2021 if Covid-19 vaccine approvals don't turn up any nasty sur-"Very likely by the summer,

a lot of things will be back to normal... If vaccine approvals come along quickly," Gates said in a television interview on Thursday night. Two vaccines, one each from Pfizer and Moderna,

have already turned up more than 90 per cent efficacy results and are moving fast towards applying for emergency use approval. The first vaccinations are tipped to begin in the US late December.

We will be able to go back to offices and open up those



restaurants and bars and say okay, we are in a completely different stage than right now," Gates said about his summer of 2021 vision.

He thinks a 2021 school year that is "completely normal" is within reach.

Gandhi in her address to the Institute of Engineers - "unreserved faith in the programs they administer We must all have a commitment to the development of the country and a sense of personal involvement with the welfare of our people".

What are the reasons for such uneasiness by the top political executive?

As early as the 1950s, some of the basic reasons were identified by Paul Appleby, an academic commissioned to study the Indian bureaucracy. He found that administrators preferred "technique over purpose", looked for a "wholly scientific or technical and wholly right decision", and conceived of programme planning to be a "mechanical, merely technical, unvarying"

Later studies (e.g. Taub,

Potter) have shown that administrators have, by and large, continued to follow these methods of working. This in the face of accumulating evidence that effective decision-making required peoples' participation, political engagement, program advocacy and willingness to innovate and adapt to local contextual conditions.

If bureaucrats have to meet expectations most of the time, then they have to practice smart politics, find "champions for ideas", focus on citizen involvement, and follow up on implementation.

Smart politics is to step away from the technical rigour of rules and regulations and come to terms with political governance - working with political leaders, combining sound administrative practices and procedures with their development agendas,

and delivering on goals. Second, floating an idea is not enough and administrators have to go out and find support for their ideas because "no idea is good enough to succeed on the power of the idea alone". Ideas have to fit into ongoing development agendas, and

to be based on an understanding of what the political leaders and the citizens need and how to deliver on these.

During the process of championing ideas, relationships matter, and relationships mean emotions. And emotions are important because they lead to acceptance of new ideas by political stakeholders and citizens. Third, effective citizen par-

ticipation is required, especially in this internet-era of citizen involvement. This means respecting the decisions of the "publics" and learning to use citizen engagement opportunities to achieve goals. The standard way of citizen participation involves making people feel good by consulting them and seemingly listening to their concerns, but not taking their

opportunities to act on their own behalf.

However, real participation involves, "people who are organised and who become effective in rendering their environment relatively more malleable will begin to perceive themselves differently, as subjects not objects, as people who develop a vision of a better world and who can act coherently to achieve it".

Fourth, initiatives have to be developed and pursued because things don't get done on their own, and flexibility in making choices during implementation leads to goalachievement.

A crucial element is listening and acknowledging others' ideas. Often, that will mean that others will be given credit for your work, but in the end one has the satisfaction of knowing that the work

was done well.

All in all, a talisman for consistently effective performance is as follows: The starting point is to decide on a course of action based on a careful analysis of alternatives and projections of probable impacts. After this, step away from technicalities and come to terms with political governance — working with political leaders, combining sound administrative practices and procedures with development agendas, introducing ideas at the right time and chasing

Of course governance systems, values, and culture do vary in different states and within states, too. The good news is that it is possible to acquire these skills through constant practice.

GHMC elections signal end of 'coalition politics' era

The GHMC elections signaled the end of 'coalition politics' era in Telangana. For the first time, all parties are contesting elections on their own without forming any alliances. TRS, BJP, Congress and TDP have fielded their own candidates. fielded their own candidates. YSRCP and Jana Sena, branded as 'Andhra parties' have stayed away from the GHMC electoral battle. TDP though branded as "Andhra Party" by the ruling TRS is testing its electoral fortunes again in Telangana after it failed to contest Lok Sabha polls in Telangana for the first time in 2019 since its inception in

The era of coalition politics began in 2004 in undivided Andhra Pradesh in which Telangana region was a part. Congress party led by YS Rajasekhar Reddy forged an



alliance with TRS and Left Parties in 2004 to dethrone nine-year regime of TDP led by then AP CM N Chandrababu Naidu. YSR's 'coalition politics' worked and TDP was defeated in 2004 Assembly polls.

YSR became CM and could formed the coalition government with TRS for the first time in May 2014 though it's a different issue that TRS parted ways with Congress a little over a year in July 2005. Opposition parties stitched another 'coalition' in 2009 to dethrone YSR-led Congress regime in 2009 Lok Sabha polls. Then prime opposition in state TDP formed 'grand alliance' with TRS and Left Parties to defeat Congress. But the 'coalition politics' proved futile as YSR retained power for the second term in 2009. After the bifurcation of AP and formation of Telangana State in 2014, 'coalition politics' came

back to the fore again. This time, TDP and BJP

formed alliance to defeat Congress and TRS contested all the seats on its own. The 'coalition politics' failed yet again in 2014 as TRS emerged victorious and formed government on its own. The TDP-BJP alliance continued even in GHMC polls held in January 2016 but received a severe drubbing at the hands of ruling TRS and the alliance was confined to just single digit victory out of 150 wards.

Opposition parties stitched yet another 'grand alliance' to dethrone KCR-led TRS government in 2018 December Assembly polls. Prime opposition Congress formed an alliance with TDP, Left Parties and Prof Kodandaram's TJS for the purpose. However, the grand alliance failed miserably as TRS won Assembly polls with a landslide majority and retained power for the second term. The 'coalition politics' were never successful except in 2004.

The foreign secretary and top intelligence officials also attended the meeting. Sources said the investigation so far has indicated that the terrorists were plotting a strike on the anniversary of the 26/11 Mumbai attacks.

Two policemen were injured during the gunfight and the driver managed to escape. The police said it is likely that the terrorists were "planning a big attack" and that they were headed towards the Kashmir valley where local elections are due later this month. The encounter started at around 5 am after the truck in which terrorists were travelling was intercepted by security forces personnel near the Ban toll plaza in Nagrota.

'Tungabhadra Pushkaralu' a low-key affair this time

Amid Covid-19 restrictions, Tungabhadra Pushkaralu began on Friday in Telangana with Ministers A Indrakaran Reddy, S Niranjan Reddy and V Srinivas Goud taking a dip in the river in Alampur Jogulamba-Gadwal district. According to an official release, the state government made all arrangements for the event that recurs every 12 years. The Pushkaralu will be held till December 1.

Due to the prevalence of Covid-19, the state government issued guidelines for devotees wanting to take a holy dip in the river and visit temples in Alampur and other places. Pregnant women, children below the age of 10 and people above 65 years are advised not to participate in the Pushkaralu while devotees and pilgrims are requested to bring COVID-19 negative certificates for entry into pushkar ghats. Otherwise they would be allowed only after thermal



screening, an official release said on Thursday. Wearing a mask and maintaining a physical distance of six feet are compulsory at temples and bathing ghats, it added. Meanwhile, Andhra Pradesh Chief Minister YS Jaganmohan Reddy inaugurated the 12-day Tungabhadra Pushkaralu in Kurnool district on Friday. Reddy landed at 12.10 p.m. in a special flight at the Orvakal airport and headed towards Sankal Bagh Pushkar Ghat in Kurnool for the inaugural

'puja' (prayer) of Tungabhadra Pushkaralu (pilgrimage), said an official. He was scheduled to inaugurate the 'Pushkaralu' at 1.21 p.m., but arrived some minutes later.

According to pundits, post 1.21 p.m. on Friday, auspicious time will start in the Pushkaralu, which will last till December 1. Tungabhadra Pushkaralu is held once in every 12 years. This year the riverfront religious confluence is being held amid the shadow of the Coronavirus pandemic.

Star campaigner: Its implications

'Star campaigners' are those persons (usually celebrities or prominent faces) who are nominated by parties to campaign in a given set of constituencies. These persons are usually popular faces within the party. There is no specific definition according to law or the ECI. Actors, celebrities and senior political party members are the ones who are nominated to be star campaigners. This is because they are believed to be

more capable that others to attract votes for the political party concerned. How much does a star campaigner cost? Section 77 (b) of The Representation of People's Act, 1951 says that most of the expenses incurred by the campaigner "shall not be deemed to be an expenditure in connection with the election". In other words, all expenses will be borne by the respective

political party A case for PMs The MCC states that if the star campaigner is a PM or a former PM, then expenses incurred for bullet-proof vehicles required by centrally appointed security personnel will be borne by the government. If another political dignitary accompanies this candidate, then 50 per cent of expenses incurred for security arrangements will be borne by the candidate.

Officials have expressed worry that such processions could turn into super-spreader events.

Social distancing will have to be maintained as per Covid guidelines of the State government and Ministry of Home Affairs. This was viciously violated. Health experts say that crowds that politicians invariably attract during election time will complicate the efforts to slow the spread of Coronavirus. Government guidelines permit up to 200 people, or 50 percent of seating capacity at closed-door political events.

An official said, "Politicians have been in public since the pandemic started and several of them tested positive, but this didn't deter them from participating in events. It is important to follow covid precautions, especially lot of them are compromising with their masks. Often supporters behaviour ends up in a out-



Chouhan equates Gupkar alliance with 'intelligence' outfit



China's new game

Bhutan is most certain to emerge as the next flashpoint as Beijing makes territorial ingress near Doklam



nina isn't expected to concede any territorial advantage it has along its shared border with India and its continued depredations only prove the predictability of its acquisitive strategies and the futility of expecting talks to tame its expansionist ambition. That's why the report that it had infringed on Bhutan's sovereignty and set up a permanent settlement 2 km within its border, close to Doklam, didn't quite come as a surprise though subsequently this was denied by Bhutan's ambassador. Beijing has anyway mastered the art of smart tradeoffs with our allies. But satellite images have confirmed the report. The news of the Chinese settle-

ment very close to Doklam was first shared by CGTN news producer Shen Shiwei, a media organisation considered to be the Chinese Communist Party's (CCP's) stooge, but was later deleted. He had posted pictures of a neat residential settlement complete with amenities. Perhaps this was part of China's information propaganda war, creating a perception of and the desire for the goodness of the Chinese way of life and intimidating bordering nations to subscribe to territorial and economic transactions loaded in its favour. But that doesn't mean that it has lost sight of either Bhutan, where it has already ingressed into a wildlife sanctuary, or Doklam in particular. And given reports of the Chinese takeover of Nepal's bordering villages, the wolf warrior tactic is playing out both in the strategic and information domain. China will never give up Doklam though it simmered down tension with India after the standoff in 2017. That's because this patch of land is crucial for ensuring its unhindered road connectivity from Chumbi Valley to bordering areas of India and Bhutan. Without this cushion, it would be constricted by both India and Bhutan on either side and wouldn't like their hawk eyes on it. Similarly, the Chinese consolidation around Doklam threatens India's chicken neck access to the Northeast, particularly Arunachal Pradesh that China insists is "south Tibet." Beijing's desperation is evident from the fact that in 1996, it "offered" to "give up" its claims to the 495 sq km of land in the Pasamlung and Jakarlung valleys of Bhutan in return for 269 sq km in Doklam. And despite a breather to India, hoping to continue a frenemy relationship with Narendra Modi than any other Indian leader and, therefore, cooling down till the latter's re-election, it fortified its positions close to the site within a year. Its over-adventurism at Galwan eroded that understanding between the two leaders and its continued intransigence has only worsened equations. In fact, this is a pincer attack of sorts, drawing us to the eastern front and compounding pressure on us to vacate the Chushul heights in Ladakh, a strategic perch that allows us a privileged view of the Chinese road to Aksai Chin. China is revving up defence infrastructure along the Line of Actual Control (LAC). Post-Galwan, it has firmed up positions along the central, Sikkim and eastern sectors. It has been ramping up surface-to-air missile sites, increased the number of unmanned aerial vehicles (UAVs) and expanded air bases in Tibet.

Bhutan is most certain to emerge as the next flashpoint as China has never forgotten how the former chose to get close to India during the Tibetan annexation. China further refused to recognise the traditional watershed principle that had decided the boundaries between Bhutan and Tibet. And claimed there were perceptional differences over territory in much the same manner of its argument with India. Since 1981, we have had countless rounds of talks with China at different levels and 22 between Special Representatives alone since 2003. Still we have not resolved our territorial dispute, China now seeking legitimacy for its 1959 claim line. Already, it has browbeaten India at the talks table on Ladakh by calling for a buffer zone, which means our forces cannot patrol up to the points they used to because of the Chinese insistence on a no man's land. This would allow it to build resources on its side unmonitored and reverse any disengagement move at a short notice. This clause also makes Indian vigilance difficult besides stretching our alertness at all times. And now by pushing us off Chushul in exchange for withdrawing from some areas it has claimed, it is forcing us into a deal. India should not agree to any position that doesn't guarantee status quo ante across all sectors of the LAC. Both sides have considerable reasons to de-escalate. India, which is dealing with the pandemic spiral and rebuilding a battered economy, can't afford to devote significant resources to the military at this particular juncture. On the other hand, the Chinese Government wants to focus on its growing GDP, the only major economy to register a growth in a pandemic-hit year. However, earlier in September, after the meeting of the foreign ministers of the two countries, the Chinese Communist Party mouthpiece. Global Times, noted that the implementation of the agreement depended on whether India is able to keep up its end of the bargain. It said: "Unless India followed through, this would be little more than what he called paper talk." And on November 12, it claimed that reports of India and China having finalised a detailed disengagement were "inaccurate" at this stage. Till there is no signed agreement between the two sides on the logistics of the retreat, not much can be said. For now, India is being rightfully cautious. China has stepped up aggression in Hong Kong, virtually quietening the pro-democracy activists, is heaving down on Taiwan and is threatening Australia with brutal economic decisions for refusing entry of Huawei in 5G operations and investments. Beijing has never believed in "good faith" diplomacy. It will step up its multi-pronged offensive against us and choke our allies, too. It has already got to Bhutan.

No instant shot

Our pandemic-hit economy will continue to misfire for some time but that doesn't mean analysts can write us off



report by the global forecasting firm, Oxford Economics, predicting that India will be one of the worst-hit economies even after the worst impact of the pandemic is beyond us, has given Government baiters a new stick to beat it with. However, one must remember that several previous predictions of doom and gloom for India, either in terms of its caseload and number of deaths, have been proven to be premature fear-mongering. While the economic relief packages have been admittedly coming slow and staggered, one must not forget that several

prominent economists have argued that India has not rushed into any action and is waiting out to see what long-term impacts the Coronavirus will have before taking major action on reviving aspects of the economy. Currently, some structural reforms have been made to spur development. So one should treat all reports of what will happen four years in the future with a major pinch of salt.

It is true that manufacturing and services have been hard hit by the pandemic and while ratings agencies and the Government might quibble about the exact figures, India's economy will contract by around a tenth this year. Many sectors, such as aviation, travel and tourism, will take a good five-six years to return to prosperity that they had known and we are yet to see the worst of the jobs impact on the economy as various moratoriums come to an end. There are slight glimmers of hope though, including increased car and two-wheeler sales over the past few months. But there is also no doubt that a new tsunami of cases is upon us, whether we recognise it in the data or not, particularly in Delhi where public carelessness might have a fatal impact with specialised hospital beds beginning to run short. This has led to much speculation that Government authorities in India, like their counterparts across Europe, might need to declare a second shutdown. It would be prudent for forecasting firms, none of which saw the pandemic coming, to wait and watch as well and at least wait until the worst of the Coronavirus is past us before sounding the Doomsday alarms.

Seeding a new market

he Indian seed industry has made rapid progress over the past 50 years, maturing because of the ceaseless efforts of thousands of men and women, who have created a strong R&D base and given us a competitive advantage in ensuring quality. India is endowed with diverse agro-climatic conditions, high level of technology expertise, trained and skilled manpower, suitable land and abundant sunshine for agriculture. The country, therefore, has immense potential to emerge as the leading provider of seeds to the world. We can export varietals for all kinds of field crops, vegetables, forage crops and flowers.

However, considering the developments in terms of the new and emerging disruptive business operating models and processes aligned with innovative technology interventions, there is a need to invest in concrete initiatives for further strengthening the Indian seed industry as part of 'Atmanirbar Krishi.'

The Indian seed industry, as a sub-sector of the agri-inputs industry, has been the most vibrant in terms of innovation and growth over the past four decades, contributing to a significant increase in productivity and profitability of farmers in India. The well-balanced seed quality legislative framework, set up by the Seed Act, the New Seed policy, 1988 and National Seed Policy in 2002, boosted private sector participation in a sector that had its foundations laid by public sector seed systems. However, much needs to be done in terms of further reforms and policy interventions. The role of new technologies,

like molecular-marker based selection approaches to fast-track breeding programmes for development of new/superior plant varieties, needs to be further strengthened as an integral part of the seed industry. Also biotechnological improve the quality assurance systems. An emerging area, which utilises biotechnology and nanotechnologies and can contribute significantly to productivity and profitability of farmers, is seed treatment with biological inoculants. This can also be promoted on a large scale as part of seedapplied technologies

ic conditions. Currently, there are no significant export incentives available to the seed sector though the export potential is estimated at more than \$ 5 billion per year based on various industry estimates. India can offer seeds for export to many countries with suitable subtropical and tropical agro-climatic regions in Asia, Africa, Eastern Europe and so on at affordable prices similar to our pharma and agro-chemical sectors. The following incentives can help.

Incentive to the extent of 20 per cent of the seed value that is exported must be considered because in sectors like pharma tives have been available for a long time to encourage exports in the initial stages. These incentives can be gradually brought down to 10 per cent after five years. A provision of ₹100 crore may be adequate for the next five years and ₹100 crore for the next six to 10 years.

policy. It may be considered here, too, as the seed companies have to incur heavy expenses for variety evaluation, which is a pre-condition for obtaining export orders. This expense needs to be reimbursed at least to the extent of 75 per cent by the Government. A provision of about ₹100 crore may be adequate for the next 10 years for meeting plant variety evaluation expenses for export purposes. Seed manufacturers add to economies of the importing countries and help get more foreign reserves into the country.

India has lacked a seed export promotion council for a long time. The Government, under the trade and export promotion council, should institute one with industry representatives and ensure that seed exports amount to 10 per cent of total agriculture exports.

India has three major seed hubs in the country. But given our vast agro-climate, we can cater to demands from Africa to ASEAN countries. The Government needs to allow Indian and foreign seed compurposes in special agro-zones. These zones may function like SEZs. They need to be equipped with dry docks, good transportation, seed testing facilities and so on to facilitate swift exports. A single window clearance counter can be established for fast tracking permis-

An "Atmanirbhar Krishi" or

self-reliant seed sector needs the SAARC markets and good economic relations between SAARC countries. The Government and industry need to step forward and create a SAARC seed forum, which will help ease-of-doing-business in the sub-continent and also provide avenues for international trading without restrictions. This body should strictly be an economic one for policy and regulatory advocacy among the SAARC countries. The Indian seed sector will grow immensely if we can spearhead this drive.

Finally, climate change is causing a rapid shift in the demands of seeds globally. Very soon, many nations won't have the financial resources to evade this crisis. But we can be a hub for seed research for the world. Our versatile climate allows us to research and co-evolve new varieties that may be suited for many countries. For even one or two varieties at the right time can change the fate of the nation and bring millions of dollars into India. Hence the Government needs to provide development grants to Indian R&D companies so that they can track future challenges, assess demand and create a seed and ASEAN countries. The Government may also partner with African nations to outsource their seed R&D to us. This would boost innovation here while providing lesser developed nations an access to cheaper research and seeds.

Curb antibiotic pollution, now

Left unchecked, drug-resistant bacteria due to antibiotic pollution have the potential to unleash a much larger and deadlier pandemic

here was a time when antibiotic resistance in human beings and animal pathogens was not common. But today, multidrug resistant bacteria have become fairly commonplace, posing a major challenge to our healthcare providers and increasing human fatality rates. Scientific evidence is suggestive of the fact that antibiotic resistance genes and antibiotics in the environment are playing a major role in perpetuating a new health crisis. Some of the major sources are waste from large-scale animal farms, waste water from antibiotic manufacturing firms and refuse from hospitals. Manure, or compost especially, is a worrying source of this antibiotic contamination. With no standardisation or mandatory testing of the end product, the largely locally-produced manure and compost products that are used on a large-scale are replete with antibiotic residues and resistant bacteria.

As COVID-19 rages on, the probability of large-scale drug resistant infections suddenly seems very possible. According to the publication, Review on Antimicrobial Resistance, 7,00,000 people die each year globally due to resistant infections and this figure is only set to grow in the coming days. It further estimates that by 2050, a whopping 10 million lives would be at risk globally due to resistant strains of infections that would progressively weaken the immune system to such a level that the human body would find it difficult to defend itself against even small diseases such as urinary tract infections. This is because human bodies will become colonised by these harmful bacteria. Antibiotics also provide a selection pressure for environmental bacteria to maintain antibiotic resistance mechanisms.

Thankfully, there is an increasing awareness the world over concerning the spike in the presence of antibiotic-resistant bacteria in the environment. In the US, urban river bodies and river bed sediments in cities like Baltimore are already showing heightened levels of antibiotics. Following this, the city municipal councils, in association with the environment authorities in the US, are taking extraordinary measures to contain the pollution in local water bodies. India must look at the global developments and immediately undertake initiatives to understand the depth of antibiotic pollution in its own environment. This is critical because antibiotic pollution-triggered superbug infections are already wrecking havoc, with nearly 60,000 newborns dying each year in the country due to them.

To stem the proliferation of antibiotic pollution, India will need to list all the potential contamination and breeding hotspots. According to studies, antibiotic pollution is the highest in wastewater treatment plants, as this is the place where bacteria from the environment meets with human pathogenic ones, leading to the genesis of new and virulent strains. Apart from this, India, apart from China, happens to be the world's largest manufacturer of antibiotics and is known to discharge high levels of these waste effluents into the air and the water. This contamination has been happening for decades in the country and is understood to be the epicentre of the birth of superbug infections that are resistant to all known medication.

Albeit a little too late, the authorities in the country have woken up to the threat posed by this, especially through river bodies. A draft Bill issued in January seeks to limit the concentration levels of antibiotic waste released by manufacturing units into the environment in order to ensure that the risk to human health is minimised. Though it is late in coming, this development has immediately caught the attention of the international research community specialising in antibiotic pollution of the environment. The Department of Antibiotic Resistance Research at the Gothenburg University called the Indian Government's draft Bill a "great leap" forward" to contain the problem.

Though a welcome step in the right direction, the draft Bill still has a long way to go. The Government must initiate stringent crackdown on pharma units engaged in manufacturing antibiotics to regularly reveal the scale, quality and limit of their effluent discharge into the surrounding environment such as water bodies. Additionally, the information must also reflect on the official web portals of the said companies so that international and national clients are aware of the environmental accountability of the firm and transparency of data. Measures such as these will coerce these companies into following environmental and human health norms or be labelled as polluters and pay heavy fines.

Left unchecked, drug-resistant bacteria due to antibiotic pollution have the potential to unleash a much larger and deadlier pandemic. The consequences need to be understood and counter measures taken rapidly to avoid this eventuality.

The recent incidents cannot be viewed in isolation. History bears testimony to various such tragic events. A few years ago, the bombing of civilians in Oklahoma City (which left more than 200 people dead) sent shockwaves around the world. A mysterious gas attack at the main train station in a Tokyo subway, that killed 12 people and left nearly 5,000 hospitalised, also sent dangerous signals. All such acts were a violent culmination of plans that were carefully executed by terrorists. Similarly, most countries of the world, including India, Russia, Spain, the UK, US, Italy, Israel, and China, are suffering due to terrorist activities in one way or another. Although violence in itself is condemnable, very rarely is a terrorist attack a nihilistic act bereft of any deeper undercurrents. And the structure of violence is more often than not located in society and social conditions, which not only create them but also nourish and reinforce them. Recurrence of violence is symptomatic of a society's body politic, torn asunder by varied threats and tensions.

Very often, the social conditions that generate conflict and violence have external coordinates. To many experts dealing with the terror driven by religiously-motivated thinking, it is on account of new challenges the post-modern world is experiencing because of the past mistakes of not calling a spade a spade till the spectre started creating havoc in their own backyard. To many social scientists dealing with terrorism in a globalised world, the matrix of power rests on the highly-visible, unequal structure of the international economy. Such inter-relations between socio-economic conditions in different parts of the world are becoming more and more obvious daily. At another level, the post-Cold War international political-economic order is still a victim of the power

through increased inter-societal interac-tion at the international level, people in the underdeveloped countries are holding the "Big Powers" responsible for their inferior socio-economic positions. There has always been a smooth international network of collaboration among the various terrorist groups supported by a few coun-tries throughout the world. For example, take Pakistan's involvement in orchestrating terrorism in Kashmir and the Japanese Red Army's collaboration with Italy's Red Brigade. It is sometimes the wide coverage by the media which provides the rationale for terrorism and increases the problem by stimulating it. This is a classic example of how astute media management can reduce the level of moral opposition to counter-terrorism. The latest has been the obnoxious nexus between the Al Qaeda, the ISIS and LeT. Their deadly combination has laid siege to peace and security.

European nations alone have witnessed more than 8,500 terrorist incidents since 1990, representing about 29 per cent of the total global incidents. The situation has become vulnerable since 2016 and with the increasing rise in the cases of illegal migration across the European countries. The rise of modern terrorism with frightening ramifications has resulted in a demand for strengthening the national law and order machinery. Of late, the pressure on the police and security agencies has been mounting. But the existing laws still pose many problems. The use of police and paramilitary forces for combating terrormight lead to the oppression of the general populace. Surprisingly, a proper legal definition of terrorism is yet to be found. The widening gap between the various governments regarding evolving a common strategy for suppression of terrorism needs to be viewed in the context of the potential for threat that it holds. Even the European convention on suppression of terrorism is restricted by Article 5 and Article 13, which refuse the extradition of a terrorist on many grounds. In an environment where terrorist violence is endemic and the world stands hopelessly divided on various laws, all countries should shun their national prerogatives for dealing with terrorism.

Many efforts have been made by a number of nations to control State-sponsored terrorism, such as through economic sanctions, but so far they have not reached a consensus either at the nation al or global level. During the last two decades, increasing drug smuggling and the unholy nexus between drug smugglers and terrorists have posed a serious problem to the internal State-security networks and compelled various nations to organise themselves and wage a relentless war against such a nexus. But mere implementation of vigorous drug laws cannot become effective unless the judicial procedure is modified for ensuring speedy trials. The continuing uncertainties with regard to terrorism have encouraged various countries to launch psychological war-

fare against terrorism. The London Economic Summit Conference, organised by NATO States and Japan a few years ago, proved to be another landmark for the eradication of terrorism, which decided that unless we attack the roots of terrorism, only superficial relief could be seen but violence would increase in the total quantum of its ism has created an apprehension that it impact. Creation of general awareness and

organisation of public support against ter rorist acts could be of immense use.

While it is desirable to allow police and the armed forces to employ better informed judgment about local problems, there is, of course, a danger that this attempt of the Government could dilute the benefits to those deemed deserving and, thus, any possibility of peace and negotiation. Rapid international transportation and use of sophisticated weapons have helped the expansion of terrorist networks globally. Besides, the new suicide squads have left the entire security apparatus shocked.

As religiously-motivated attacks increase globally, the concept that one man's terrorist can be another man's freedom fighter must be done away with. The local populace should cooperate with the law enforcement machinery even at the cost of personal misery while prompt and strict decisions should be undertaken by various nations for controlling terrorists psychologically. In a changing environment, the security apparatus and police need to diversify activities by bringing together technical and professional expertise based on many decades of experience in maintaining internal security. In this regard, the most crucial aspect is to develop the capability to anticipate security

This is possible by conducting specialised courses for monitoring security situations. Unless we attack the roots of terrorism, we would have only superficial relief and terrorism would magnify in the total quantum of its impact. The need of the hour is international cooperation to tackle the menace and forming an integrated team after minutely comprehending the inner dynamics of the problem.

RCEP or not, India has to revive Plan process

The country needs to reorient policies for a long-term approach without ignoring short-term needs

reeping China out is the new trade policy of India. Its primary approach is that anything that opens the door to Chinese products is a "strict no-no." So it's no surprise that India is keeping out of the Regional Comprehensive Economic Partnership (RCEP) free trade agreement (FTA), an initiative New Delhi was engaged in since its inception. Theoretically, it comes at a minimum cost as India already has FTAs with all but three RCEP members.

Home Minister Amit Shah had last month told RCEP member countries that they would have to come around to accepting New Delhi's terms. "Considering India's growing stature, RCEP members can't afford to ignore it for long and will come around to agreeing to the

Meanwhile, the country has maintained successful economic relations with ASEAN by the means of FTAs," he said. The RCEP, too, has kept the doors open for India officially, if at all it wants to join the grouping without having to wait for 18 months, as stipulated for new members. As per the RCEP's decision, India can still participate as an observer.

India had taken the decision in November 2019 to keep out of the RCEP, with the partnership being seen as China-centric and due to the perception that it would boost sales of cheap Chinese products and harm the country's industries.

India's approach on the deal is the result of unfavourable trade balances that it has with several RCEP members, with some of which it already has FTAs. The Commerce Ministry says that the Compound Annual Growth Rate (CAGR) in trade with such countries was a mere 7.1 per cent. India has trade deficits with 11 of the 15 RCEP nations. This means that while the partners have access to our market, India has not penetrated theirs. Hence, it cannot further open up its

Government of India's terms. market for the advantage of others. Still India has agreements with the ASEAN, South Korea and Japan. It is negotiating deals with Australia, New Zealand and Singapore and there are treaties with Nepal and Bhutan. However, there are apprehensions that RCEP could impact the Australia-India-Japan network in the Indo-Pacific region. India and like-minded nations, particularly the Quad countries — Australia, the US and Japan — are keen to have resilient supply chains. Along with New Zealand, South Korea and Vietnam, they are negotiating with each other.

External Affairs Minister S Jaishankar, while delivering the Ramnath Goenka Lecture in 2019, had said that India's stance was a "clear-eyed calculation" of the gains and costs of entering a new arrangement. He also said that India would continue with its "act East" policy. It should also be remembered that the RCEP decision is linked to China's aggressive postures in the South China Sea and on the Line of Actual Control, including the June 15 Galwan incident in which 20 Indian and many Chinese soldiers lost their lives. It may

be recalled that Jaishankar even in January had said that New Delhi's doors to RCEP were not closed. But in September, he said, "You cannot be a rising power without being a rising economy, and to do that you have to build your domestic capacities." His views are not very different from that of the Swadeshi Jagaran Manch, which had been opposing most FTAs and stressing on improving the domestic economy.

It certainly has not been an easy decision. India would have to weigh the gains of a bulk agreement and individual treaties. A similar concern was expressed when New Delhi chose to opt out of the Belt and Road Initiative (BRI) in 2017. It was said that India might be isolating itself. Now after three years, like-minded democracies appreciate New Delhi for its prudent decision, which many now see as an exploitative Chinese diplomacy. Significantly, many members are not enjoying their stay in the BRI. There is the contrary view as well. It says that India's economic decline occurred even as China's economically and strategically important BRI went on to cover two-thirds of the

world's population. Beijing dominates the psyche of policymakers. India is highly dependent on China for imports of lithium ion batteries, antibiotics, personal computers, colour TVs, solar cells, toys and so on. Despite the recent initiatives by the Centre to improve domestic production in many of these goods, concerns remain. What China has done is to consolidate its economy since 1979. Thus, production cost is minimum and it has a pricing mechanism that happens to be the lowest in any country in the local cur-

İndia has to learn the technique of creating a vibrant domestic system with a market across the world. Chinese merchandise today decides international prices. While India successfully blocked imports of idols of Ganesh, Lakshmi and other deities, it could not succeed in lowering the prices of "Made in India" products. This cannot be considered good economy. Possibly for this reason, China looms large in reports submitted by eight Groups of Ministers (GoMs) formed during the ongoing pandemic. These GoMs have called

for a balance between supporting economic performance and geopolitics and most have focussed on ways to counter China. They call for contextualising issues like Chinese aggression on communication tools, need for specialised spokespersons on issues like China and the environment and many other dependencies on

The obsession with China is too apparent. Of late, despite all efforts, New Delhi's policy approaches are China-centric. India may have to revive the planning process it gave up in 2014 as the NITI Aayog has not been a proper replacement. The country needs to evolve a long-term policy prescription. India has to consider moving out of the growth-cen-tric approach and replace it with progress. So RCEP or not, India has to have a holistic approach towards the economy. It needs a wider vision and approach for progress and has to imbibe policies that could give it an edge. India needs to reorient policies for a long-term approach without

ignoring short-term needs. (The writer is a senior journalist)

They have, however, restored to calibrating the rates since the pandemic broke out with a view to avoiding volatility in retail prices.

The 58-day hiatus in petrol price revision and 48-day status quo on diesel rates was preceded by no change in rates between June 30 and August 15 and a 52-day status quo between March 17 and June 6.

In Mumbai, the petrol price on Friday was raised to Rs 87.92 per litre from Rs 87.74, while diesel rates went up from Rs 76.86 to Rs 77.11.

Petrol now costs Rs 84.31 in Chennai and Rs 82.79 in Kolkata. Diesel costs Rs 76.17 per litre in Chennai and Rs

Govt requests for user data up 23% globally in H1 2020

Government requests for Facebook user data increased 23 per cent globally in January-June 2020 with India occupying the second spot after the US in terms of such requests being made. According to Facebook's latest transparency report, total 35.560 requests were made by India in the period for 57,294 users/accounts. Some data was produced in 50 per cent cases, it added. In the first six months of 2020, government requests for user data increased by 23 per cent to 1,73,592 globally from 1,40,875 in the second half of 2019. The highest number of requests in January-June 2020 came from the US with 61,528 requests for 106,114 users/accounts, and some data was produced in 88 per cent of the cases, the report said. Germany, France and the UK followed the US and India in the tally. Facebook said it responds

to government requests for data in accordance with applicable law and its terms of service. Each and every request it receives is carefully reviewed for legal sufficiency and it may reject or require greater specificity on requests that appear overly broad or vague. "We do not provide governments with direct access or "back doors" to people's information. We believe that intentionally weakening our services in this way would undermine the security necessary to protect our users, Facebook VP and Deputy General Counsel Chris Sonderby said. During the period under review, the volume of content restrictions based on local law increased 40 per cent from 15,826 to 22,120 globally. The increase was in part related to COVID-19- related restrictions, Facebook said. India saw 824 pieces of content being restricted in the same period.

Sensex jumps 282 pts, Nifty up 87 points

TAX ABUSE BY MNCs

India losing \$10.3 bn in taxes per year

India is losing over USD 10.3 billion (about Rs 75,000 crore) in taxes every year owing to global tax abuse by MNCs and evasion by private individuals, a report said on Friday.

The State of Tax Justice report said globally countries are losing a total of over USD 427 billion in taxes each year to international corporate tax abuse and private tax evasion. This is costing countries altogether the equivalent of nearly 34 million nurses' annual salaries every year — or one nurse's annual salary every second.

With regard to India, the report said USD 10.3 billion, or 0.41 per cent of the USD 3 trillion GDP, is lost in taxes every year to global tax abuse.

Of this, over USD 10 billion is lost to tax abuse by multinational corporations (MNCs) and USD 200 million to tax evasion committed by private individuals.

The social impact of the lost tax is equivalent to 44.70 per cent of the health budget and 10.68 per cent of education spending. It also equals paying yearly salaries of over 42.30 lakh nurses.

'Draconian' data regulations will make operations difficult in Pak: Tech firms

Global technology companies have told the Pakistan government that its "draconian" data regulations would make it extremely difficult for them to continue their operations, two days after the IT ministry notified rules to define how social media will be governed in the country, according to a media report on Friday.

Under the new rules announced by the Ministry of Information and Technology on Wednesday, social media companies and internet service providers shall provide the designated investigation agency with any information or data in decrypted, readable and comprehensible format, the Dawn newspaper reported.

Subject to justifiable technical limitations, the information to be provided may include subscriber

information, traffic data, content data and any other information

In a statement, the Asia Internet Coalition (AIC), which exclusively represents leading global internet companies on matters of public policy, expressed its alarm over the scope of new law targeting inter-net companies, as well as the government's "opaque process" by which their rules were developed.

Earlier this year, Prime Minister Imran Khan promised to initiate a "broad-based" consultation on content regulation after a strong backlash from stakeholders over the release of formally known as the Citizen Protection (Against Online Harm) Rules 2020. Waterways has also hired existing executives and employees of Zen and Jurgen Bailom will continue as the president & chief executive.

PMFAI pitches for hike in import duty on pesticides to 20-30 pc



Pesticides Manufacturers and Formulators Association of India (PMFAI) on Friday urged the government to increase the import duty on technical and finished pesticides to 20-30 per cent to protect the domestic agro-chemicals

industry. Currently, 10 per cent customs duty is levied on import of technical grade and finished pesticide formulations. Before 1991, a customs duty of 40 per cent was levied on intermediates and raw material and technical grade pesticides used for manufacturing of formulations. However, in 2007, import duties on technical grade pesticide and finished formulation were brought at par. "There are a lot of anomalies in the current customs duty regime that favours the imports of pesticides rather than manufacturing in India. This gives an unfair advantage to MNCs and importers and defeats the vision of 'Atmanirbhar Bharat'," PMFAI President Pradip Dave said in a statement. The government must amend the current structure of customs duty and increase them to 30 per cent and 20 per cent for imports of finished pesticide formulations and technical grade products, respectively, he said.

ike how in a board game four players race their four tokens from start to finish according to the roll of a dice, Anurag Basu too has brought this classic game to life with actor Ishtiyak in the top trending movies of Netflix right now — Ludo. Since the time Ishtiyak Khan joined the movie industry, the world of staging has only helped him accomplish many of his goals. His slightly short stature in comparison with the hulks of the industry never hindered his personality from shining through.

Anurag *Da* is such a jovial man that he believes in spreading as much as glee he can by making it a carefree environment. There's a small child hidden in a 46-yearold man who wants his crew and cast to be jolly all the time and mind you without any superiority complex. Our working together was the deciding factor between success and failure hence by navigating the murky waters into a creative environment while keeping all of us organised and happy, *Ludo* is a success on OTT today," the actor

that is accrued to an actor showing up on an OTT platform is something else, he feels that ear-lier A-listed directors weren't taking web seriously but owing to the hardening situations of the pandemic now, OTT is nonperishable, there is no added burden of appointment viewing and a web platform like Netflix who is having a deep pocket brings the audience closer to cinema dynamics. "From YouTubers to mass entertainers, everybody can showcase their flair, basically all of us get to make the same leap which is an interesting potent here. It's a fair array! No star is a different commodity here, everyone is given their justified screen timing. I don't know till when will the OTT era last, nonetheless with the web, we got a sense that there is certain elbow room for experimentation," he adds. Giving a peek into the move to regulate OTT platforms, he voices, "I am of the opinion that to some extent it's advisable for the I&B ministry to play moral police for OTT as there is no limit to what digital platforms are streaming in terms of bold content. The regulatory approach of OTT streaming media shouldn't be any distinctive from offline broadcasting media. The government's intent to regulate OTT should not be confused with a restriction on nudity, language or violence but on content that counters its ideology, policy or killing any opposing narrative," he concludes.





Keeping Kohli quiet key to success: Cummins

Australia speedster Pat Cummins expectedly considers Virat Kohli the "big" wicket he would target in the upcoming series against India and said that keeping the visiting captain quiet would be crucial to the home team's chances.

"I think every side has that one or two batters and they are the big wickets. Most teams have their captain — Joe Root for England, Kane Williamson for New Zealand. You feel like if you get their wickets that goes a long way in winning the game," Cummins told Fox Cricket.

"He (Kohli) is always a big one. You commentators talk about him non-stop, so hopefully, we can keep him

quiet," he added. Cummins, who has been named in both the and redsquads as vice-captain, is one the Australian players currently quarantining in Sydney after returning from the UAE where he played Kolkata Knight Riders in

Their quarantine period will end on the eve of the opening ODI against India at the Sydney Cricket Ground.

Ćummins said Australia is well prepared to give India a tough fight in the series.

"It's going to be huge. Obviously, we're back here on home soil. Other than spending a lot of times in hotels and bubbles I feel like our preparation

has actually been really good. "We went over to the UK and had a good tour there. Most of the boys here have been playing 14 T20 matches in the last few weeks and the other guys coming in will be playing shrewd cricket. So, it feels like we are all firing up and got a lot of stuff behind us," he said.

"The Board confirmed that the ICC Women's T20 World Cup will move from its current slot at the end of 2022 to 9-26 February 2023," ICC said in a statement.

If not postponed, the year would have "three major events in 2022 with the Commonwealth Games in July 2022 and the ICC Women's T20 World Cup due to be held in November 2022."

"As there are currently no major women's events scheduled to take place in 2023 the Board confirmed the switch for the T20 World Cup to better support player preparation and to continue to build the momentum around the women's game beyond 2022," the apex body said.

Percentage of points to decide final WTC standings ported the approach of rank-

NEW DELHI: India on Thursday slipped to the second position in the standings of the ongoing World Test Championship (WTC) after the ICC decided to rank teams "in order of percentage of points earned" from the contested matches.

Australia (296 points from 3 series) toppled India (360 from 4 series) in the standing after the revision with a percentage of 82.22 compared to the latter's 75 per cent.

With the global Covid-19 pandemic disrupting cricket, "just under half of the WTC matches have been played, with that estimated to rise to more than 85% by the end of the competition window." According to current reg-

ulations, incomplete matches are treated as draw but after due deliberation, the ICC Cricket Committee, headed by Anil Kumble, recommended that the final WTC standings should be determined on the basis of matches played, which was approved by the Board.

"Both the Cricket Committee and Chief Executives Committee sup-

ing teams based on completed matches and points earned as this reflects their performance and doesn't disadvantage teams that have been unable to compete all of their matches through no fault of their own," ICC Chief Executive said.

"We explored a whole range of options, but our Members felt strongly that we should proceed as planned with the first ever World Test Championship Final in June next year."

Lockdown in S Aus provides best chance to host 1st Test

Adelaide: The six-day lockdown in South Australia to contain Covid-19 cases has improved Adelaide's chances of remaining the venue of the first Day/Night Test between India and Australia from December 17 even though the situation remains fluid, the state's top medical officer has said

South Australia has closed its borders after a sudden surge in Covid-19 positive cases, which stand at an overall 551 right now.

South Australia's chief public health officer Nicola Spurrier, during a press conference, admitted that there are no guarantees.
