### **SOME RECOVERED CORONAVIRUS PATIENTS MAY STILL CARRY VIRUS**

Some recovered COVID-19 patients may still carry the novel Scoronavirus, according to a new study which recommends that people leaving quarantine avoid close contact with others, wear a face mask, and possibly undergo an additional test to confirm if they are free of the virus. The study, assessed 131 COVID-19 patients who met the World Health Organization (WHO) criteria for discontinuation of quarantine, and found that close to 17 per cent of them, who were considered fully recovered, tested positive for the virus in follow-up screening. "Our findings indicate that a noteworthy rate of recovered patients with COVID-19 could still be asymptomatic carriers of the virus," said study co-author

Francesco Landi from Fondazione Policlinico Universitario in Italy.

### **US TO SCRAP COMPUTERISED LOTTERY SYSTEM FOR H-1B VISAS**

→he Trump administration has proposed to scrap the computerised lottery system to grant H-1B work visas to foreign technology professionals and replace it with a wage-level-based selection process, a move that is expected to counter the downward pressure on the wages of US workers. A notification on the new system is being published in the Federal Register on Thursday. Stakeholders have 30 days to respond to the notification, the Department of Homeland Security (DHS) said on Wednesday, less than a week before the US presidential election. Replacing the computerised draw of lots to decide on the successful H-

1B applicants, the DHS said it is expected to help counter the downward pressure on the wages of American workers that is created by an annual influx of relatively lower-paid, new cap-subject H-1B workers.

The unemployment rate since the unlock process in the state has gone down to 3.3% in September from nearly 5.8% in August, as per the Centre for Monitoring Indian Economy. During the lockdown months-

- April, May and June, Telangana reported 6.2%, 14.7% and 10.6% unemployment rate. Post re-opening, the numbers in the state went down, as the unemployment rate in July and August were around 5.4% and 5.8% respectively.

Telangana has overtaken Gujarat in unemployment numbers. Gujarat, which had an unemployment rate of 1.9% in the past, registered 3.4% in October. Only Assam (1.2%), Chhattisgarh (2.0), Odisha (2.1%) and Karnataka (2.4) are ahead of Telangana as per CMIE. The unemployment rate in the state is much below



the all-India estimate of 6.7% at the same time.

The unemployment rate is slowly coming down also in Andhra Pradesh, which was at 6.4% in September, though it was 7.0 in August and 8.3 in July. During April and May i.e. during the Covid-19 induced lockdown period, the unemployment rate in Andhra Pradesh was at 20.5% and

17.4% respectively.

Krishank Manne, TRS leader said, "These figures from CMIE itself explain Telangana standing low at the unemployment rate faring exceptionally well than prominent states. It was achieved only because of the Government's focus on creating job opportunities and skill training".

### Demand for contract jobs high in Hyderabad

**HYDERABAD**: Hyderabad is among the top three cities which recorded the highest postings January and July this year. The city is preceded by Bengaluru and Mumbai in top three positions, according to a new report by job search portal Indeed.com. However, when compared to previous years, all three cities witnessed overall degrowth from last year. While the demand for contract workers has risen steadily since January 2020, month on month comparisons between 2019 and 2020 showed that hiring for contract jobs more than doubled in June and July this year, at 110% and 143% respectively.

## NGT halts AP's RLIP project

PNS HYDERABAD

The National Green Tribunal on Thursday ordered a stay on construction work of the Rayalaseema Lift Irrigation Project (RLIP) proposed by the Andhra Pradesh government across the River Krishna in the backwaters of Srisailam reservoir to draw three tmc ft of water per day to irrigate parched lands of Rayalaseema.

Acting on a petition filed by a Telangana activist Gavinolla Srinivas, the green tribunal made it clear to the AP government that it should not go ahead with the construction of



Rayalaseema lift scheme, unless it obtained all clearances from the Centre, including environmental clearance.

It also directed that the AP government submits a detailed project report (DPR) to the Ministry of Jal Shakti and unless the project report is approved, it cannot take up construction work.

## Isn't Google violating users' rights by 'controlling' choices?

### **TN govt takes** executive route **to 7.5% quota**

PNS CHENNAI

The Tamil Nadu government on Thursday issued an order notifying 7.5 per cent quota for students of state-run schools in admission to undergraduate medical courses from the current 2020-21 academic year.

Since the National Eligibility-cum-Entrance Test (NEET) results have now been declared and the admission process has started, there is an 'urgency' to decide on this issue, the Government Order (G.O) said.

The move came as a bill passed by the state assembly last month envisaging the horizontal reservation is awaiting assent from Governor Banwarilal Purohit.

As per the G.O, 7.5 per cent of seats shall be set apart on a preferential basis to government school stu-dents qualifying in NEET, in admissions to MBBS, BDS, BSMS, BAMS, BUMS, and BHMS from the academic year 2020-21.



The HC order concerned students of Telangana Open School Society (TOSS) and those who were to write the Intermediate Public Advanced Supplementary Examinations, but were instead promoted with 35%. Apart from those who secured 45% marks, the orders relaxing criteria will apply to students who have passed Intermediate examination and those who could not take the examination, but were awarded 35% marks.

This year, the state government promoted several students without conducting the exams and they were awarded minimum marks. Thus, many students who qualified in the EAMCET could not get the ranks as they failed to meet the eligibility criteria of 45 per cent marks in Intermediate.

As per rules, TS EAMCET candidates should obtain at least 45 per cent marks (40 per cent in case of candidates belonging to reserved category) in the subjects specified taken together at 10+2 pattern, except for B Pharmacy course.

This is a one-time measure in the wake of the ongoing pandemic situation.

This order applies only for this year i.e. 2020-2021 as a special case and shall not be made as precedent in future, and shall not be applied from 2021-2022," the order read.

### **TS reports** 1,504 new cases, 5 deaths

PNS HYDERABAD

Telangana has reported 1,504 fresh Covid-19 cases, as the Health Department cautioned people against the second wave of the pandemic. The state's Covid tally on Thursday mounted to 2,35,656 while five more deaths during the last 24 hours have pushed the toll to 1,324, health officials said. The fatality rate remains unchanged at 0.56 per cent against the national average of 1.5 per cent. According to officials 44.96 per cent of the deaths were due to Covid while 55.04 per cent of deaths were due to comorbidities.

During the last 24 hours that ended at 8 pm on Wednesday, 1,436 people have recovered from the virus, taking the total number of recoveries to 2,16,353. The recovery rate jumped to 91.80 per cent against the national average of 90.9 per cent. The state now has 17,979 active cases, of which 14,938 are in home or institutional isolation. After a drop for last few days, the number of cases surged again in Greater Hyderabad and other districts. Greater Hyderabad reported 288 cases. Meanwhile, officials have warned the people against second wave of Covid-19 in the state.

## Special sanitation drive to ensure flood-hit areas return to normalcy

In order to ensure that all the waterlogged colonies return to normalcy due to recent floods in view of heavy rains in the city, a special sanitation drive was started in the highly affect-ed 235 colonies under GHMC limits, on a mission mode approach, by hiring addition-

al vehicles and manpower. While 242 vehicles were already existing in the GHMC, an additional 495 vehicles were engaged and a total of 737 vehicles, with 177 JCBs, 26 bobcats, 258 tippers, 96 six tonners, 126 ten tonners and 44 tractors are working round the clock along with 334 pumps for de-watering and desledging operations at a record pace, GHMC officials said on Thursday.

Around 1008 men of monsoon emergency teams and an additional 1522 men were hired solely for the purpose of special sanitation.

## 'Can excessive media reporting hinder justice?'

Mumbai, Oct 29 (PTI)The Bombay High Court on Thursday

asked the Union government to clarify whether "excessive" reportage by the press on an ongoing investigation amounted to interference in the administration of justice under

the Contempt of Courts Act.
A bench of Chief Justice
Dipankar Datta and Justice G
S Kulkarni asked the government to state by November 6 if such reportage adversely affects the probe and subsequent trial, and if the court should lay guidelines on media reporting.

"If there is excessive reporting, that can put an accused on guard, and he may resort to destroying evidence or absconding. Or if that person is actually innocent, the

excessive media reporting can damage his reputation," it

"We would not like the



"We would not like the media to cross it boundaries and we would also like to be within our boundaries," the court said and asked the state if such reportage would amount to interference

and we would also like to be within our boundaries," the court said and asked the state if such reportage would amount to interference and if the government thought the HC had the jurisdiction to frame guidelines.

It also asked the govern-ment's counsel, Additional Solicitor General (ASG) Anil Singh, to consider scenarios where such reportage on an ongoing probe, where a charge sheet was yet to be filed, influenced the investigating officer, or resulted in a witness being threatened

It asked if the court must step in and formulate guide-lines to regulate the press to avoid such scenarios.

"If media identifies that a person is a very vital witness, he could be won over, threatened, or he could be even physically harmed so that he does not give evidence," it said. On the possibility of the

press influencing an investigating officer, the HC said, "Think of a police officer. Can anyone guarantee that he will not be nfluenced?"

"He may be following a particular track. Media says no no this must be the track. He loses track and rounds up an innocent person," it said.

## Centre introduces new law to tackle pollution in Delhi

In a bid to tackle the persistent problem of air pollution in Delhi-NCR, the Centre has introduced a new law through an ordinance which comes into force with immediate effect.

Violation of the provisions entails a punishment of a jail term up to five years or with fine up to Rs one crore or with both, the ordinance released by the Ministry of Law and Justice on Thursday said.

on Thursday said.

"The ordinance may be called the Commission for Air Quality Management In National Capital Region and Adjoining Areas Ordinance 2020. It shall apply to national capital region and also al capital region and also adjoining areas in so far as it relates to matters concerning air pollution in the NCR. It shall come into force at once," it said. The ordinance was signed by the president on Wednesday. As per the ordinance, the adjoining areas where it shall be in force include Punjab, Haryana, Rajasthan and Uttar Pradesh, adjoining areas of the NCR and Delhi where any source of

pollution is located which is causing an adverse impact on air quality in the national capital region. The commission will consist of over 20 members who will ensure strict compliance."Any non-compliance or contravention of any provisions/rules or order/direction of the

Commission will be an offence punishable with a jail term up to five years or with fine up to Rs one crore or with both," it said. The members will include a chairperson, who is or has been a secretary of Government of India or chief secretary of a state, a representative of Environment secretary and five ex-officio members who are either chief secretaries or secretaries in charge of the environment departments of Delhi, Punjab, Haryana, Rajasthan and Úttar Pradesh, it added.

The commission will also include two full- time members who have been joint secretaries to the central government, three full-time independent technical members who have specific scientific knowledge regarding air pollution and others.

The Union Ministry of Home Affairs (MHA) has upheld the suspension of senior Madhya Pradesh IPS officer Purushottam Sharma, who was seen purportedly thrashing his wife in a video that went viral last month.

In a letter issued to the Madhya Pradesh chief secretary on Wednesday, the MHA also directed the state government to chargesheet Sharma by November 27. The state government had suspended Sharma from the post of special director general on September 29 following his viral video, in which he was seen beating his wife after she confronted him at the house of a news anchor with a regional channel. After the incident came to light, Sharma had said that it was a family dispute which would be sorted out.

## SC stays summons to Delhi resident over objectionable post

The Supreme Court has granted an interim stay on summons issued to a Delhi resident dent, accused of allegedly making an 'objectionable' Facebook post against the West Bengal Government, by an investigating officer in the

Chandrachud and Indira Banerjee said the court should restrain the exercise of judicial review in the matter of police investigation. However, it must safeguard the fundamental right to the freedom of expression under Article 19(1)(a) of the Constitution.

There is a need to ensure that the power under section 41A CrPC is not used to intimidate, threaten and harass, the bench said. Section 41A of



CrPC deals with notice of appearance before a police officer. "We are, however, of the considered view that to require the petitioner at this stage to comply with the summons under Section 41A during the pendency of the proceedings before the High Court would not be justified in the facts as they have emerged in this case. "Hence we grant

an ad-interim stay against the implementation of the direction of the high court requiring the petitioner to appear before the Investigating Officer at Ballygunge Police Station," the bench said. This is subject to the condition that the petitioner undertakes to respond to any queries that may be addressed to her by the Investigating Officer and, if so required, attend to those queries on the video conferencing platform with sufficient notice of twenty-four hours, the apex court said.

Senior advocate Mahesh Jethmalani, appearing on behalf of the petitioner, stated that the petitioner would cooperate in all respects though after the order of 5 June 2020, no query was addressed to the petitioner, despite five months having elapsed since then.

## Remdesivir: SC seeks Centre's reply

The Supreme Court Thursday sought the Centre's reply on a plea alleging that two medicines Remdesivir and Favipiravir, are being used for treatment of COVID-19 without approval.

A bench headed by Chief Justice S A Bobde issued notice to the Centre on the plea and sought its response in four weeks

Advocate M L Sharma petitioner in-person referred to the bench, also comprising Justices A S Bopanna and V Ramasubramanian, the World Health Organization (WHO) report of October 15 and said that nowhere these medicines are designated officially as medicines for coronavirus. The bench said it is

only going to make the central government aware of it and therefore issuing notice.

On September 16, the top court had said that there was an approval by the central government on use of Remdesivir and Favipiravir, as medicines to treat COVID-

The top court was hearing a plea seeking registration of an FIR by the CBI against ten Indian pharmaceutical firms for manufacturing and selling these two medicines for treating COVID-19 patients allegedly without valid

Remdesivir and Favipiravir are antiviral drugs and their efficacy in treating COVID-19 patients has been a matter of debate among medical

## Covid positivity rate declining: Govt

In a statement, the Health Ministry said 15 lakh tests can be done everyday now.

"The declining trend of cumulative positivity rate in the past three weeks is a testimony of the wide expansion of the country's testing facilities," it said. "With 10,75,760 tests conducted in the last 24 hours, the cumulative tests have 10.65 crore



(10,65,63,440). Nearly 11 lakh tests have been conducted daily on an average during the past six weeks," it added. Giving break-up from the

states, the ministry said 79 per cent of the new cases are from

10 states and union territories. "Kerala continues to be the state reporting a very high

more than 8,000 cases, followed by Maharashtra with more than 6,000 cases," it said.

The ministry said the declining trend of the active cases is supported by the rising number of recovered cases. "The total recovered cases have crossed 73 lakh (73,15,989). The gap between recovered cases and active cases has crossed 67 lakh (67,12,302). With an increasing number of recoveries, this gap is contin-

uously widening," it said. A total of 56,480 people have recovered and discharged in the last 24 hours whereas the new confirmed cases stand at 49,881, the ministry said.

### **Delhi court closes defamation** complaint against Kapil Mishra

PNS NEW DELHI

A Delhi court has closed a criminal defamation case against BJP leader Kapil Mishra after he tendered an unconditional apology to AAP leader and Delhi Health Minister Satyendar Jain.

The complaint was filed by Jain against Mishra in 2017 for his defamatory statements against him and Chief Minister Arvind Kejriwal.

The case was closed on Wednesday after Mishra agreed to tender an unconditional apology before Additional Metropolitan Magistrate, Vishal Pahuja.

"It is submitted by the accused (Mishra) that he is ready to make a statement before the court tendering unconditional apology. Complainant (Jain) also submitted that in case the accused gives his statement before the court, he shall withdraw the present complaint," the Court recorded. After recording the state-

ment of Mishra, as well as Jain, the Court disposed of the defamation complaint as withdrawn. In a press conference held

in 2017, Mishra had accused Jain of handing over a bribe of Rs 2 crore to Arvind Kejriwal.

## **Jyotiraditya's test**

The MP bypolls would prove if he can indeed get even with former CM Kamal Nath and earn his stripes in the BJP



he byelection in Madhya Pradesh may have got swamped by the Assembly polls in Bihar and its results may not threaten the ruling BJP Government in the State. But it is significant in deciding the political future of stalwarts both within the BJP and the Congress. The number game is fairly settled. The BJP currently has 107 seats in the 230-member Assembly, with the support of Independents, Samajwadi Party (SP) and Bahujan Samaj Party (BSP) MLAs. So, given its ambition to do without props of any kind and consolidate its position as the single largest party, it would just about need to win nine of

the 28 seats going to the polls and cross the half-way mark. The Congress has 88 MLAs after Jyotiraditya Scindia revolted and took 22 loyalists with him to the BJP, toppling the Kamal Nath Government. It would need to win all 28 seats to cross the halfway mark, a tall order, though party hopefuls are arguing that even 20-plus seats could keep it in the running as it could manage the deficit by co-opting smaller parties. This presumptive logic isn't much to bet on. The desperation of the Congress is understandable considering it wants to prove a point to Jyotiraditya that his exit hasn't really affected the party's grassroots matrix. In one word, therefore, the bypolls are his test. He may have defected with his loyalists but can he ensure vote transference with such ease? Particularly when the Congress is relentlessly calling him a traitor, even drawing on his family history to show how the Scindias betrayed Rani Laxmibai. Besides with most of the seats going to the bypolls being located in the Gwalior-Chambal region. which has the highest number of caste atrocities and violence and where the Dalit vote swing matters politically, Jyotiraditya has to have an umbrella appeal to win and not just depend on his legacy. His being in the BJP could actually be a liability as this is a BSP bastion and its people were at the forefront of protests against the dilution of the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act in 2018. Besides, the BSP is contesting all seats here this time and unless, as a kingmaker, its chief Mayawati decides whom to side with in the event of a mixed verdict, the going could be tough for Jvotiraditya. Of course, his staunch follower and Dalit candidate. Imarti Devi. whom Kamal Nath insulted, could mop up some of the sympathy votes from the community at the expense of the Congress. The BJP has obliged Jyotiraditya for catapulting it back to power by giving tickets to the rebel MLAs loyal to him. This has not been to the liking of its Chief Minister Shivraj Singh Chouhan, who wouldn't want Jyotiraditya to challenge his stature. So the latter has to prove his mettle in his adopted party by ensuring the maximum wins. If he does, his stakes will rise but if he fails, then he could be badly marginalised. As it is, the State BJP campaign is still pivoted around Chouhan and has hardly taken note of the new entrant. This is Jyotiraditya's big chance to prove his political currency and if he fails, he will be of no use to any party. Not even Congress. In fact, if Jyotiraditya succeeds, it would be the most effective message of getting even with Kamal Nath and convincing the grand old party of the need for a generational change. If he does really well, he could even get a Central Ministry, something he has been wanting since he crossed over.

Though the BJP needs single digits to coast home, Chouhan wants to win at least half of the seats to show that he is not dependent on Jyotiraditya's clout. Having conceded tickets and ministerial berths to the young leader's group following Central pressure, the Chief Minister wants to show he is in command. But Chouhan is caught between the criticism of his handling of COVID-19 and the challenge from Union Agriculture Minister Narendra Singh Tomar, who has the blessings of the Central party leadership to undercut him. As far as Kamal Nath is considered, the bypolls are his last chance to take another shot at chief ministership. But with below the belt attacks and scorning a woman legislator, he may have just scripted his own downfall. Kamal Nath has an axe to grind with Imarti Devi, who is a Jyotiraditya Scindia loyalist and defected with him to the BJP. In fact, the sexist remark against her came days after and probably as a hitback to her accusation that Nath bribed MLAs when he was Chief Minister, that he gave cash doles of ₹5 lakh to Congress MLAs who could not be granted ministerial posts. In retrospect, her needless victimisation only drew attention to his greed for power by managing numbers. Ut course, the seasoned politician he is, he knows how to work the arithmetic in case of an adverse scenario. But the old-style politics may not work at a time when the BJP won't be sparing any resources either to ensure that one party-rule flows from the Centre to other States.

## **DU** imbroglio

The power tussle between the Vice-Chancellor and the Pro-VC only harms the most prestigious university



elhi University (DU) is not only India's largest and most prestigious Central university, home to several top colleges of the country, it is also the most politically active. However, what is happening in DU right now is unprecedented in its 98-year history as President Ram Nath Kovind has ordered an enquiry against Vice-Chancellor Yogesh Tyagi on the grounds of "misconduct" and "dereliction of duty." Tyagi has been suspended till the probe is completed since he can influence the investigation while in office. Much of this has been precipitated by the health of the Vice-Chancellor, who had to be admitted to AIIMS

on emergency grounds back in July and a Pro-VC, Professor PC Joshi, had to be appointed. However, after Tyagi returned to work, he tried to invalidate several appointments made by the Pro-VC, even those that had been cleared by DU's Executive Council. The row escalated when Tyagi appointed Professor PC Jha as the interim Registrar despite the Union Ministry of Education's claims that the new order was not effective as the VC was still on leave while issuing it. However, the Executive Council resolved that Professor Suman Kundu would continue as Director, South Campus and acting Registrar till a permanent Registrar was appointed. This was followed by Tyagi removing Professor Joshi as Pro-VC and appointing Geeta Bhatt in his place. Meanwhile Joshi had notified the appointment of a new Registrar, Vikas Gupta, whose interview had been completed and appointment cleared by the Executive Council. This is a truly bizarre and ridiculous situation, particularly when the 2020-2021 academic year is about to start. By initiating an enquiry against Tyagi and completely clipping his wings, his term is as good as over. However, the Ministry should take its fair share of the blame here. When the V-C was admitted to hospital in an emergency condition, it should have stepped in to put a system in place. At the same time, it has consistently overlooked past lapses flagged against Tyagi, including not filling vacant positions, delay in redressal of sexual harassment cases and vigilance complaints in university, mishandling of the issue of ad-hoc teachers, which led to a massive agitation, and non-submission of detailed plans for implementation of the Institution of Eminence (IoE). The last straw came in the form of certain appointments he made while being on medical leave.

This mess needs to be immediately rectified by the Ministry and if Tyagi is to be removed, a new V-C must be found post-haste. This is a situation that is unprecedented and if elections and a pandemic were not ongoing, this would be the top headline of the day. This development is not surprising after decades of Ministers and bureaucrats striking at the autonomy of Central universities. Institutions of higher learning thrive when they are allowed to function independent of the Government and where the V-C is prided for his integrity and not seen as a political appointee.

# Nobody's child

Fuelled by a pandemic-hit economy and the lack of personal accountability, India's child trafficking problems have further worsened

∎n mid-October, a 17-year-old girl, Neema (name changed) was found by the Uttar Pradesh (UP) Police in a dazed state, hungry and delirious. Sold to traffickers by her poverty-stricken parents on the advice of "well-meaning" neighbours in her village in Madhya Pradesh, the teenager had escaped from her tormentors in Delhi. Neema walked and hitch-hiked for three days to cover a distance of 200 km before she was spotted by concerned passersby and the police in Hathras. Unaware of her whereabouts and determined to reach home, she was still 794 km short of her home in Mandla district when she was rescued. The girl told the police that there were 12 other minors like her, confined to one room in Delhi. Fortunately, they all managed to escape.

Neema is not the only child

from her village to have been traf-ficked. Several others like her have been sold by needy parents. This story is repeated over and over again in India, particularly in rural areas. India is starving and its children are bearing the brunt of this hunger. They are being sacrificed at the altar of the crippling poverty that has worsened because of the sucker punch delivered to the already tottering economy by the Coronavirus. As feared by the experts in the field of rescue and rehabilitation of trafficked children, the number of minors, particularly girls, sold to traffickers for as little as ₹10,000-₹50,000, has grown alongside the number of people rendered jobless by the pandemic. As a result, desperate parents, having to choose between survival of the family for a little while longer and their love, chose the former. So many girls and boys were sold to traffickers across the country.

This is despite the fact that Articles 23, 39, 14 and 21 of the Constitution guarantee every child freedom from exploitation in any form. The Immoral Traffic ed in pursuance of the International Convention signed at New York on May 9, 1950 and it was amended in 1986 to widen its scope to cover all citizens. However, according to rights advocates, the Act has glaring lacunae as it fails to define the term "traffic" or "trafficking" and aims to penalise those who aid and abet commercial sexual exploitation. Therefore, its focus on the def-

inition of the term brothel leads to the inference that commercial sexual exploitation takes place only in a brothel and not in other places, such as in a house. The Act is clearly not victim-centric as women and children, who are forced into prostitution, are also treated as criminals and arrested when raids are conducted.

Similarly there are several other laws to protect the rights of children, such as the Commissions for Protection of Child Rights Act, 2005, the Right of Children to Free and Compulsory Education Act, 2009, the Protection of Children from Sexual Offences Act, 2000. The rights of child labourers can be adequately secured only if the monitoring and controlling provisions contained in the said statutes are fully implemented. However, they are not despite the Supreme Court insisting upon their applicability.

In 2013, the top court lamented that despite its directions, little or no progress was made by the States in protecting the rights of children. Thus, we have horror stories emerging from across the country. Desperate children, sold to traffickers by impoverished parents, making hopeless bids to return home to the same parents who pushed them into the hell in the first place.

others like her have escaped for now, not everyone is so lucky. Thousands of children are being trafficked globally for initiation into the sex trade, to be recruited as bonded labour, drug runners, child terrorists or human shields. The International Labour Organisation has predicted that with the pandemic ravaging economies globally,

the world may witness an increase in child labour for the first time in 20 years and there is a huge risk of years of progress in this arena being reversed. First, it was hunger induced by the lockdown that fuelled the trafficking. And now that the economy has opened up, it is the demand for cheaper labour and bigger margins by businesses. Closer home, ever since the lockdown was imposed and then eased a few months later in phases, Delhi-NCR has become a hub of trafficking as more and more children are being rescued from factories and brothels.

The Delhi Commission for Protection of Child Rights rescued 93 children from gold and jewellery factories in Karol Bagh in May. Of them, 57 were below the age of 14 and some were even 10-year-olds. The rest of the children were between 14 and 18. Then in July, nine child labourers were found working at several scrap shops in North East Delhi's Mustafabad. But these rescues are like a drop in the ocean as the lockdown slowed down such initiatives as well. There was a time when only 27 per cent of the Anti-Human Trafficking Units were functional. Thankfully, in September, 36 children under 14 years were rescued from bangle-making Jahangirpuri area where they were made to work for 15 hours a day and sleep in the same dingy room. All lured or sold on the promise of food and a roof over heir heads.

Nobel laureate Kailash Satyarthi, Chairperson of NGO Bachpan Bachao Andolan, estimates that in Delhi, "at least five lakh children are in full-time jobs. That means every sixth child is out of school and working somewhere."

Every time we hear such statistics, we are shocked and angry. Even more disturbing is the fact that these children are there in our midst, suffering abuse, hardship, deprivation and long hours of work in dingy, dark and polluted places where they have no business to be. We are blissfully ignorant of this invisible, silent and hapless workforce. The tiny factory workers, who are well hidden from our sight, toil to pander to our penchant for buying things at discounted prices, the cheaper the better. But we are content sweeping our collective guilt under the carpet, simply because they do not torment us

We do know that certain industries traditionally employ children. Like bidi factories, the carpet industry, the garment sweatshops, incense and firework factories, brick kilns, the farm sector and so on. But when buying these products, do we ever take the pain to ensure that the brand that we are purchasing has nothing to do with child labour? It is our demand for cheaper products that in turn creates the demand for child labour as businesses then can keep the cost of production don't bother to boycott goods over unethical trade practices. If we did so, the factory owners would have revised their norms. So, by extension, we are as guilty as the perpetrators of the crime of trafficking and hiring child

And what about child labourers, who are staring us right in our faces? What of the minor hired to "baby-sit" children? Or the ubiquitous chotus (apprentices/assistants) all over India, selling chai at the local tea shop and even delivering it to our offices and at the railway station? What of the little boy cleaning the car in the neighbourhood, his little hands and muscles straining to carry a heavy bucket full of water? Or the shoeshine boy, the child manning a roadside dhaba, serving food to customers? Have we ever bothered to question the people who hire them or even inform the law enforcement authorities about their presence? Clearly we do not want to get out of our comfort zone and easily attribute it to a societal crime, without realising we form the society that condones it. We could have picked up the phone and called the NGOs and rights activists who can help the child in distress. But we don't do that either.

And what about children caught in the sex trade? If people stop watching child pornography, there will be no market for it. If men stop violating minor girls for a price, there will be no market for it again. So, on all counts, society is as guilty as the criminals who traffic chil-

Apart from a mindset change, there has to be community ability by each citizen. There must be non-Governmental and Government intervention to ensure that hapless parents do not take the extreme step of trading their children for a dole. There is no time to be lost, else a nation will forget the meaning of bachpan.

## Make the right policy choices

A continued prosperity for nations will only be achieved by allowing and championing a global open market for trade, goods and digital services

t is festival time globally, and not just the religious and fun variety but also the vital festival of democracy or elections. It is for the first time in our lifetimes that festivities, mostly associated with huge crowds jostling to reach the ballot box or *bedi* (the pedestal on which the idols of deities are kept), are taking place in the shadow of a raging global pandemic. Forced departures from well-known rituals associated with festivals make these times a case study for future generations. Many would have seen a video on social media of an idol being immersed using mechanised trolleys, with least human intervention, in the recently-concluded Durga puja festivities. Now switch to the theatre of democracy in Bihar, where Assembly elections are being held. The common thread between the two festivals is, technology. Bihar, would perhaps be the first State in the country where technological interventions played a key role in the elections.

First, the Election Commission (EC) allowed online filing of nominations for candidates and many political parties chose to reach out to their constituents through virtual rallies and put up huge LED walls for public viewing. Given the absence of many veterans active in Bihar elections for at least three decades, most of the young scions of the colourful, vociferous and politically-influential families were suddenly catapulted to the centrestage of a new narrative. This young brigade of Biharis, technologically more versatile than their parents, sought votes on issues. Something hitherto unheard of in a State, known for its divisive caste and religious biases. It was surprising to see rival candidates promise lakhs of jobs to young voters in a State grappling with the problem of the jobless migrant labourers.

The most welcome aspect of this election has been the reliance on technology in a State which could well be a case study on the digital divide between India and Bharat. Many statisticians will point to a survey which revealed that more than half of Bihar's women and around 40 per cent men have no access to mass media. This, when extrapolated over digital media, means a significant part of the population can either be completely insulated from the impact of technology or could be the next addressable unconnected millions, who need to be put on the information technology expressway of pros-

Now let's jump across the Pacific to the US, which, too, is about to witness one of the fiercest and cacophonic elections on November 3 amid the COVID threat, deaths and economic destruction. The common binary binding Bihar elections, Durga Puja festivities and US elections is again, technology. After all, the new dominance game and the race to be a global superpower is now increasingly getting defined by your first tap on a smartphone, first digital payment/electronic transaction, first contact-free shopping for world-class brands from the comfort of your home and perhaps the first digital date after months of trying to understand each other's typos and abbre-

Therefore, restrictions on digital applications, depending on the country of origin, to applying the same principles to hardware solutions in technical infrastructure, to forming an alliance of like-minded technology fraternity of nations were some of the key highlights in the election campaign of the two presidential candidates of the world's richest democracy. What it also highlighted was the fact that increasingly, the physical restrictions (read policies) of trade and commerce dominating economic relations between a bunch of nations will now be enthusiastically copy-pasted in the digital arena to prevent loss of sovereign powers and dominance at the global high tables.

COVID has put the spotlight on public policy issues, which, till February, were still in advanced stages of intellectual discourses. It has challenged our ability to adapt and eventually recover from the disease. And the only sector which has truly helped this advancement is technology. It reacted quickly and ensured teachers, parents and children were handed online course materials for seamless academic learning and doctors were given online tools for initial digital health interventions for patients. It gave the Government effective platforms for interaction and empowered it to push critical policy goals. Technology enabled digital live darshans of beautiful but deserted pandals and online delivery of prasad for the religious, too. If the human race has been pushed ahead by three decades in one stroke by the lockdown and technology has taken centrestage, it is also time to think and refresh many global policy challenges and perhaps release an update. Policymakers have to realise that imposing strict restrictions, based purely on case-by-case models, and having a physical worldview of digital policy issues can be self-defeating in the long run. A continued prosperity for nations will only be achieved by allowing and championing a global open market for trade, goods and digital services. It must be kept in mind that the new normal for policy-making at sovereign-level negotiations must be dictated by a set of principles. This must be compulsory in all digital agreements between consumers and technology providers, governments and their counterparts across borders. A multi-lateral approach must be championed. It is time to click on the right button.

# Graft-free governance

A metrics-based system for oversight over governmental processes will bring transparency and spur digital innovation to make any administration robust without inhibiting public interest



mong the issues in public discourse that have caught the attention of the country is the prob-lem of corruption, which elicits strident crit-icism. The issue has triggered a slew of reforms aimed at strengthening the fabric of integrity, like the enactment of the Public Procurement Bill, the Lokpal Act incorporating, inter alia, the public disclosure of assets by public servants, reforms in higher judicial appointments and so on. While anti-graft activists differ in terms of strategies and focus areas, there is a unanimous acceptance of the fact that technology and e-governance promote greater transparency. gy and e-governance promote greater transparency. The rationale is very simple. Deny the opportunity for manual manipulation and replace it with technology, crafted around well-defined protocols and legal safeguards with minimal human intervention. It has been five years since India adopted the UN's 17 Sustainable Development Goals (SDGs). Corruption in general and venality in public life in particular adversely affect the fulfilment of these SDGs. Therefore, a proactive and preventive vigilance

SDGs. Therefore, a proactive and preventive vigilance regime forms the backbone of good governance and is critical to their realisation. How then do we make governance more effective without inhibiting its objectives? Today, administrative affairs grapple with leakages in public delivery of welfare and development goals on account of manual processes that can be manipulated. But by leveraging technology, these leakages can be plugged. Incremental improve-ments to technology should continue to be the mainstay of advancements in administration.

In the recent discourse on procurement methods, transparency of policy, procedure and practices is increasingly being seen as an imperative of using public monies to remove any allegations of opacity and inconsistencies in decision-making. Achieving transparency ensures that procurement is open to public scrutiny, which results in best value for public monies. For example, the transparency of procedure as achieved in online applications is one of the simpler yet effective features of digitisation, as it shifts the onus of submitting correct information and data to the applicant. This, once verified by the public servant, retains the maker-checker wedge in a direct way.

In an effort to plug leakages in procurement systems, the Government launched the Government E-Marketplace (GeM) in 2016 as an end-to-end marketplace for goods and services required by Central and State Governments as well as Public Sector Undertakings. As per an assessment by the Centre for Public Impact, the savings impact of GeM has been substantial, wherein a maximum price reduction of approximately 56 per cent of goods and services, coupled with demand aggregation, has already led to savings to the tune of ₹40,000 crore annually. Given the fact that the public procurement economy constitutes about 20 per cent of India's GDP, it is imperative to build on this initiative through amplified efforts and bring as many goods and services on board as possible. And in order to make the platform more robust, addressing the issue of quality control should be the next level of sophistication that GeM should aspire for.

In the next 10 years, the business of Government will experience massive disruption. This comes on the back of technological enhancements that reduce the need for intermediaries and ensure that the sanctity of process remains unimpeachable. One such technology which has been discussed widely in recent times is blockchain. A NITI Aayog discussion paper has identified use-cases where the technology can potentially improve governance, ranging from tracing of drugs in the pharmaceutical supply chain to verification of education certificates. The three key principles of the blockchain technology are: Transparency, decentralisation and accountability.

Permanent Settlement of Bengal in 1793, the issue of land records has occupied the administration and citizenry with its complexities, misgivings and fraud. The system is riddled with inefficiencies that reduce trust in the Government. Currently the UNDP is involved in certain Proof of Concept (POC) pilots across India. The underlying theory intends to create an immutable history of transactional records that helps in checking authenticity; a tam-per-proof system to avoid forgery; a dis-tributed ledger so that all stakeholders see the same information; and a secure encrypted environment, where updates are available in near real time. The NITI Aayog paper also identifies this value proposition. For example, the paper notes that, in order to ensure that transactions are not fraudulent, the physical presence of witnesses is mandated at the time of sales deed registry. Deployment of blockchain would potentially eliminate the need of these processes while maintaining the sanctity of the transaction.

This helps create a tamper-proof audit trail that allows for tracking decisionmaking and ensures that they are in accordance with anti-corruption principles. It addresses concerns around cyber security. Currently there are interesting pilots being conducted across the world, where deployment of blockchain is being tested for public procurement, wherein systems are being built in to identify graft with a view to disincentivise corrupt actors from accessing the system at the outset.

From the perspective of Internal Controls and Governance (Vigilance), it is strongly recommended to employ a fivepart test while assessing such deviations from process: Whether the issue being pursued has corrupt connotations; the general reputation of the employee involved; whether better options were available and ignored without valid reasoning; whether the situation inhibited the selection of any

Deployment of technological solutions like blockchain can potentially remove the need or significantly reduce the time taken for making such assessments. In a recent paper released by Denmark's Ministry of Foreign Affairs, titled Code to Integrity, the authors have highlighted how blockchain can be a powerful tool in the fight against Government corruption. The report cites case studies of countries like Kenya, Rwanda and Ghana where Government records pertaining to court systems, edu-cation and land rights are migrating to distributed ledgers.

However, a significant factor in blockchain's success will be a country's ability to develop/reform laws and build robust data protection and maintenance regimes. Till such time we address these issues, blockchain is not likely to have a monumental impact in creating an integrity-first governance ecosystem.

The general environment now is in favour of a regime which ensures that companies not only do profitable business but do so in a manner which is ethical. The United Nations Convention against Corruption, ratified by India in 2011, as well as the anti-corruption principles expounded by the Organisation for Economic Cooperation and Development (OECD) cover a wide gamut of vulnerable areas and aspects of business operations, including anti-bribery, public procurement and conflict of interest. More and more countries in the coming years will be obliged to establish laws and mechanisms in place to ensure clean business operations as well as seize and confiscate assets derived from corrupt practices.

India, too, needs to review its existing legal framework to address issues around data security, corrupt practices and corporate governance with a view to address our anti-corruption objectives and provide the necessary guidance to well-intentioned officials in the Government.

to the Prevention of Corruption Act in 2018. The element of intention has been added under definition of criminal misconduct. Similarly, broadening the definition of "unfair advantage" and introduction of corporate criminal liability will go a long way in apprehending or deterring bad actors on both sides from indulging in bribery. The amendments also have ensured that our obligations under the UN Convention against Corruption are adequately addressed and bring us closer to leading anti-bribery legislations in the world such as the UK Bribery Act.

While these amendments will go a long way in guiding the work of internal control agencies, it would be important to institutionalise a system, wherein compliance against said legislation and established processes can be checked and quantified. A metrics-based system for oversight over governmental processes will bring transparency, build trust and spur further digital innovation to make any administration more robust without inhibiting public interest-oriented decision-mak

It would be incorrect to end this discussion without addressing the wellintentioned public servant who finds the processes leading to greater transparency and ensuring value for taxpayers' money cumbersome and time-consuming and who is, therefore, tempted to short-circuit it. Well-intentioned though it may be, but any attempt to overwrite the processes, despite even demonstrable honesty of purpose, carries the major risk of opening up the system to misuse by corrupt players and would lead to eventual loss of public trust and decimation of the structure of public procurement. Thus, the intent of processes involved is to keep the proverbial Caesar's wife above suspicion. Through robust yet streamlined procedures, a bureaucrat can achieve the intended outcome and avoid unintended consequences.

## Nurture e-retail in a post-pandemic world

This approach would be in keeping with the Centre's focus on a Digital India where citizens are able to leverage their connectivity into better opportunities

ost nations imposed some form of shutdown to limit the spread of the Coronavirus. India's lockdown, which involved a near cessation of all movement and economic activity, has been rated as one of the most stringent across the world. Not surprisingly, it had a severe impact on our economy

A sector that was hit particularly hard is retail. This is due to several reasons. First, shops and warehouses were closed during the initial phases of the lockdown. This brought the

operation of both physical and digital retailers to a standstill. Second, restrictions on inter-State movement of goods and the opening of only specific industries disrupted supply chains. For instance, the Centre recognised both medicines and processed foods as essential goods and allowed their sale. However, similar status was not granted to units which manufacture the packaging for medicines and processed foods. Hence, sellers of these goods found it difficult to operate. Third, the system of issuing passes and permits to personnel working for physical and digital retail was not well-implemented. It was unclear which authority would issue the passes and for how long they would remain valid. Further, personnel having to travel across districts were required to obtain separate passes from the authorities for each district. Fourth, the Ministry of Home Affairs issued an order directing all employers to ensure full payment of wages to all employees even if they were unable to work.

As a result of the order, several migrant labourers returned to their towns and villages once restrictions on movement of persons were lifted. A survey of retailers selling their products online, conducted as part of the Esya Centre's report on e-commerce, shows that nearly 60 per cent of such entities will be unable to recover losses suffered because of the lockdown. Given that people are likely to be wary of entering shops and stores even after lockdowns are eased, it is important to explore different avenues through which retail outlets can avoid further

One such avenue is e-retail. A report by Global Trade and Regional Integration Unit of the World Bank highlights the utility of e-commerce in the post COVID normal. Not only can e-commerce help reduce the risk of new infections and preserve jobs, it can also increase the acceptance of prolonged social distancing measures among the population. Further, previous research has shown that there are

numerous benefits for MSMEs that adopt e-commerce, in the form of better price discovery, access to new consumers, support with logistics and inventory management. It is in recognition of the above that several nations, such as the United Kingdom and New Zealand, have given preference to digital forms of retail both during and after the lockdown. However, India is one of the few countries that has not leveraged the numerous benefits that e-commerce brings, particularly during a lockdown.

Policy-making towards e-commerce, both before and during the lockdown, may have hindered the operation of e-commerce entities. Prior to the lockdown, legacy government rule-making on e-commerce presented several barriers to the growth of the sector. These included everchanging FDI rules, unresolved issues of data localisation and source code disclosure as well as the over-regulation of platforms. During the lockdown, the Government failed to adopt a clear and consistent approach to policy formulation vis-a-vis retail. As an example, both physical and digital retailers were only allowed to sell essential goods in the initial phase of the lockdown. This continued till about mid-April, when the Government issued a notification which allowed eretailers to deliver non-essential items from April 20. In conformity with this order, e-commerce firms began to make predations to resume their full scale of operations. However, on April 19, the Government withdrew its notification, seemingly under pressure from industry organisations that represented small and medium traders. Subsequently, relaxations regarding delivery of non-essential items were first given to physical outlets while eretail continued to be limited to essential items for 8-10 days thereafter. The zonation framework introduced by the Government additionally preferred physical outlets in Red zones, as they could sell a wide range of merchandise while e-retail tasks were limited to

essential goods. As pointed out, e-commerce enjoys numerous advantages over physical retail, particularly in a situation where social distancing continues to be important. Hence, there is a need to provide a policy environment that fosters the uptake and adoption of ecommerce by both consumers and sellers. To achieve this, we recommend a five-step recovery process. The first steps are geared towards fostering an atmosphere of trust and credibility between the Government and market entities.

This can be achieved by holding regular consultations, opening avenues for feedback and providing sufficient notice before major changes. Further, policy actions should not skew competition between physical and digital business models. Instead, both models should be allowed to leverage their respective strengths. Finally, the Government must reassess what it seeks to achieve through its proposed e-commerce policy. In the current sce-

nario, a policy framework governing e-retail or e-commerce in general, should look to assist small enterprises in capacity-building for a digitally enabled future through the provision of finance, skill development and underlying infrastructure. There is, therefore, a need to move away from legacy regulatory institutions, based on licensing and control, to an entity that actively participates in capacity-building and development of small and medium retailers in India. In this context, it is worthwhile to explore the role being played by digital economy development authorities in countries such as Malaysia and Vietnam, which actively promote the adoption of digital solutions and e-commerce for SMEs as well as consumers. ## Eight core industries' output contracts 0.8 pc in September

Contracting for the seventh consecutive month, the output of eight core infrastructure sectors dropped by 0.8 per cent in September, mainly due to decline in production of crude oil, natural gas, refinery products and cement.

The production of eight core sectors had contracted 5.1 per cent in September 2019, data released by the Commerce and Industry Ministry showed on

Thursday.
The decline in output during the month under review was lowest since March.

Barring coal, electricity and steel, all sectors -- crude oil, natural gas, refinery products,



fertiliser and cement -- recorded negative growth in September 2020.

During April-September, the sectors' output dropped by 14.9 per cent as compared to a growth of 1.3 per cent in the same period of the previous year. The output of crude oil, natural gas, refinery products, fertiliser, and cement declined by 6 per cent, 10.6 per cent, 9.5 per cent, 0.3 per cent, and 3.5 per cent, respectively.

so loyal (to the Super Kings). That's why MS has given everything: heart and soul, his sweat, sleepless nights — I'm sure he must have had sleepless nights while he has continued captaining CSK."

Earlier, the CSK management has said that Dhoni would be retained at the next mega auction, which is likely to be held in 2022.
