Aarey forest stays, car shed goes

Metro car shed will now be located at Kanjurmarg, additional 200 acre at Aarey Colony to be declared forest, announces Maha CM

TN RAGHUNATHA MUMBAI

More than 10 months after he stayed its construction in the wake of protests by environmentalists, Maharashtra Chief Minister Uddhav Thackeray on Sunday announced that the proposed car shed for the Metro phase-III project would now be located at Kanjurmarg in north-east Mumbai to save forests at Aarey Colony at Goregaon in north Mumbai, where the project was initially located.

Meanwhile, former Chief Minister and senior BJP leader Devendra Fadnavis – under whose regime the Mumbai Metro –III car shed construc-tion started — slammed the Uddhav Government for its decision to shift the project, saying its re-location would result in an additional cost of ₹ 4000 crore.

Addressing the people across the State through social media, Uddhav said the Maharashtra Government would not spend any money for acquiring the land for shifting the Metro phase-III car shed project from Goregaon and locating it at Kanjurmarg as it owned land at the new location.

"We will now shift the car shed for the Metro phase-III project from Goregaon and locate it at Kanjurmarg. We will Government had declared ear-

The State Government will not do anything that would affect the lives of Adivasis living in the Aarey forest area. We will take all steps to protect the animals in the Aarey forests," he

"After the shifting of proposed car shed Metro phase-III, the two Metro corridors — Colaba-Bandra-Seepz (Line 3)

and Swami Samarth Nagar-Vikhroli (Line 6) will be integrated," Uddhav said.

The CM — who in his first major decision taken after assuming the highest office in the State had on November 29 last year stayed the work on the construction of a car shed for Metro phase-III at Aarey Colony in the wake of Shiv Sena-supported protests said his Government had already withdrawn cases filed against all the green activists who had opposed the location of Metro car shed at Aarey

Colony.
It may be recalled the MVA Government's decision to stay the construction of Metro the construction of Metro phase-III car shed project and order a review of the project should be seen in the developments that took place in the run-up to the October 21 Maharashtra Assembly polls.

The Shiv Sena had vehemently opposed "illegal" tree falling at Aarev Colony to paye

felling at Aarey Colony to pave way for the construction of a car shed for Metro phase-III.

After the Bombay High

Court on October 4, 2019 dis-Court on October 4, 2019 dismissed all petitions challenging the proposed felling of 2,646 trees in Aarey Colony at Goregaon, the Mumbai Metro Rail Corporation Limited (MMRCL) felled 2,141 trees on October 4 and 5 following the HC's order upholding of the BMC's Tree Authority's permission to fell 2,185 trees at

Aarey Colony.

After the MMRCL felled the trees indiscriminately at Aarey Colony on the night of October 4, 2019, the Shiv Sena, which was ruling the State in alliance with the BJP then, had two days later joined the activists and various political parties against the tree felling and also the arrest of 29 activists who had resisted the tree felling by the workers hired to fell the trees on the previous night.

Article 370 will be restored with China's help: Farooq

Sitting Member of Parliament from Srinagar and former Jammu & Kashmir Chief Minister Dr Farooq Abdullah on Sunday made yet another provocative statement claiming China "never accepted" the Abrogation of Article 370 and hoped that it will be restored

with China's support.


It is for the second time Farooq has attempted to link the issue of Abrogation of Article 370 and the Chinese aggression at the Line of Actual Control in Ladakh.

In the last week of September 2020, Farooq had also claimed in an interview with a news portal that after the abrogation of Article 370, the Kashmiri people "do not feel or want to be Indian" and they would rather prefer to be ruled by China, instead of India. Speaking to a reporter of a private news channel on the sidelines of a function in Srinagar on Sunday, the National Conference president, wearing a black hat, also held the Centre's decision to abrogate Article 370 responsible for the Chinese aggression at the Line of Actual Control in Ladakh.

Further provoking New Delhi, Farooq went on to claim that China "never accepted" the Abrogation of Article 370, and hoped that it will be restored with China's support.

"Whatever they are doing at LAC in Ladakh all because of the abrogation of Article 370,

which they never accepted. I am hopeful that with their support, Article 370 will be restored in J&K," Farooq said.

Taking a dig at Prime Minister Narendra Modi, Farooq claimed, "I never invit-ed the Chinese President, it was the Prime Minister who not only invited him to Gujarat but did jhoola sawari with him.

He even took him to Chennai and had food with him. Even then the decision (Abrogation of Article 370) taken by the Government was not unacceptable to them".

Referring to the recent Parliament session, Farooq

said he was not even allowed to speak on the problems of Jammu & Kashmir in Parliament. In his brief speech inside the Parliament on September 22, Farooq had sought the restoration of

August 5 last year.
"There will be no peace in Jammu & Kashmir unless decisions taken on August 5, 2019 are not revoked and the region's special status is restored".

CBI takes over Hathras case

The Central Bureau Investigation (CBI) on Sunday registered an FIR under Indian Penal Code (IPC) Sections related to gang-rape and murder among others, and the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act and took over investigation into the alleged gang-rape and murder of a Dalit woman last month in Hathras district of Uttar Pradesh.

The agency assigned the case to its Ghaziabad unit with a special team to investigate the crime that has led to a nationwide outrage, officials said.

The 19-year-old girl was allegedly raped by four men on September 14. She succumbed to severe injuries at a hospital here a fortnight later. Her death culminated in reportedly a hushed up cremation at night allegedly at the behest of the district administration. The political slugfest was further accentuated following the controversial statement by the State police claiming there was no evidence of rape. The brutal injuries suffered by the victim and the local administration's

Farmers can use Agrix1 drone sans Govt nod to protect crops ARCHANA JYOTI ■ NEW DELHI

Tech-savvy farmers in the country can now look towards using an indigenously-manufactured microdrone. 'Agrix1', equipped with multispectral sensors and artificial tools, to identify crop diseases and pests and take timely remedial steps to boost their agriincome. And in doing so, they need not require the Government's permission.

Agrix1 drone is the first remote-controlled unmanned vehicle in the country under the micro category to get the Directorate General of Civil Aviation (DCGA) nod for the agriculture sector, requiring no special permit for flying.

'It can be flown without requiring a special UAOP permit from the Government. In other words, farmers do not need to seek special pilot crop diseases up to 10 days

approval and can fly them on their own. However, since the technology is new, we are interfacing with the interested farmers," said Ashish Sinha, CEO of Omnipresent Robot Technologies which has launched the micro agriculture drone with multispectral capa-

Priest shot at in Gonda

Unidentified miscreants shot at a priest of the famous Ram Janki temple in Gonda district late Saturday night when he was sleeping inside the temple premises.

The priest, identified as Samrat Das alias Chhote Baba, is junior to the head priest of the temple, Mahant Sitaram Das, and was shot at from close range, He suffered injuries on his shoulder.

He was rushed to the district hospital from where he was referred to the KGMU Trauma Centre in Lucknow in view of his serious condition.

Police suspect the priest was attacked over a dispute involving the temple's land which is said to be of several acres and costing several crore rupees. The temple is situated in the Ityathok police station

The doctors attending on the priest at the Trauma Centre said his condition was improving and he was out of danger.

The Mahant Sitaram Das alleged that the local village pradhan and others were involved in the attack.

He said that land mafia were trying to grab 100 acres of land of the temple. The temple is controlled by the Tapsvi Chhavni Math of Ayodhya.

Recently, a brawl had taken place over the grabbing of the temple's land.

Two home guards were deployed for the security of the temple, but they could not prevent the attack.

The attackers scaled the boundary wall of the temple and reached the place where

Positivity rate in district comes down to 5.1 pc

The positivity rate in Lucknow has come down to 5.1 per cent while fatality rate is 1.5 per cent, which is below the state average of 1.6 per cent. The CMO office released these figures and the status of contact tracing in the district on Sunday.

As per figures, the total number of samples tested in the district this month so far is 98,706 and 5,000 have come out positive, giving a positivity rate of 5.1 per cent.

A senior official at the CMO office said it was a good sign because earlier, the positivity rate of the district had been bordering around 10 per cent. "Lucknow is second in the state in terms of the positivity rate this month while the first is Gautambuddh Nagar with 5.9 per cent," he said.

Lucknow is followed by Meerut with 5 per cent positivity rate, Prayagraj 4.5 per cent and Ghaziabad 4.1 per cent. However, Kanpur Dehat has the lowest positivity rate at 0.3 per cent, followed by Hathras 0.4 per cent, Baghpat 0.5 per cent, Shrawasti 0.5 per cent and Pilibhit 0.6 per cent.

The official said one reason why the positivity rate of Lucknow is higher than that of other districts is that more RT-PCR tests than antigen tests were carried out unlike other districts.

In July, the fatality rate of Lucknow was 1.1 per cent, which increased to 1.4 per cent in August, then to 1.3 per cent in September and 1.5 per cent this month.

For the 403 cases which were detected in Lucknow on October 10, contact tracing of 366 were done and the number of contacts traced within 24 hours was 4,469. As many as 247 contacts were traced after 24 hours. The total number of

The senior official said that for bringing down the number of deaths in the district, they were working at two levels. "In tackling the curative part, we are ensuring that rapid response teams visit patients in home isolation on the first fourth and seventh day," he

He further pointed out that in terms of treatment, their effort was that the patient should be sent to SGPGI or KGMU. "For controlling deaths, we want patients to be taken to these hospitals for treatment," he said.

The official said that with schools re-opening on October 19, they were making a plan to contain the spread of virus. "We are making a concrete plan on how to manage Covid with

strict guidelines framed. A unit will be created with a staff nurse at all the schools and we will be screening all the children so that no symptomatic child is allowed," he said.

The senior doctor said they have noticed mental alterations in some Covid patients who get delirious in the ICU. "There could be several reasons for this change of

This could be due to ICU-induced psychosis where patients do not like the closed environment, falling levels of oxygen in the brain which affect its functioning of the brain and drug-induced behaviour, wherein the steroids and other medicines can cause these changes. One cannot say that because of coronavirus only," he said. Dr Himanshu said that they were still collecting data for the

To win the confidence of the victims, they would call them to meet outside Secretariat and take them inside. They would take Rs 4-5 lakh for a post of clerk and Rs 2-3 lakh for the post of peon. The money earned through illegal ways used to be distributed between them.

In another case, two property dealers were detained on the charges of harassing three girls who had gone shopping at a mall in Gomtinagar on Saturday night. Police said they were being interrogated. Reports said the accused were stalking the girls for hours and were trying to get close to them. A polygon team spotted the girls desperately looking for help and sought to know the reason. Central Institute for Subtropical Horticulture (CISH) is engaged in training and demonstrations for conversion of organic wastes into quality compost, wherein these crop residues can be utilised in compost production.

CISH director Shailendra Rajan said these organic wastes can be converted into useful agri-inputs for the agricultural system. "This has become more important because compost pits have disappeared from villages due to declining domestic animal population. Using organic material for different farm inputs will not only improve the soil organic carbon but also reduce the pollution caused by burning of organic matter which has a lot of value for sustaining

fertility," he said. At CISH, RA Ram is prois conducting on and off-farm training and technology transfer. Specialised courses are conducted on organic input preparation from farm waste. Package of practices for organic cultivation has been developed and shared with the farmers," he

"Crop residues and organic wastes can effectively be used as mulch in fruit trees. Mulching is helpful in weed management, reduces evaporation, minimises soil erosion, maintains soil temperature and improves physical, chemical and biological property of the soil," the CISH director said.

He said rotavators can be used after harvesting of paddy as well as wheat ploughing of field as it breaks crop residues in small pieces and this can be followed by the irrigation of field with bio-enhancers which helps in fast decomposition of organ-

"Bio-enhancers can easily be prepared at the farm and used in crop production. They con-

moting organic cultivation tain fast fermenting and beneficial microbes. In-situ decomposition of organic waste improves soil as well as crop

> He added that stubble burning is banned, farmers find it easy and practice for preparation of the field before wheat sowing. "In rural India, thousands of tonnes of organic waste is being burnt to clean the places or get rid of organic waste. Farmers are aware about the importance of manure and compost but most of the time they ignore and don't value the organic residue produced on the farm from different crops. This can be converted into valuable inputs required for the cultivation of crops," he

> He pointed out that crop residue burning has become popular in north-west India where wheat and rice are harvested and threshed mechanically. "Several years ago, animals were a part of the farmers' family and most of these wastes were used as feed. Compost pits were common in each and every household used for production of organic manure mostly using cow dung," he added.

Maha new cases drop to 10,792

The Covid-19 infections dropped below 11,000mark in Maharashtra for the second time in less than a week on Sunday, even as 309 more people succumbed to pandemic in various parts of the state. Six days after the state recorded a daily infection tally of 10,244 on October 5, as many as 10,792 people tested positive for Covid-19 in the

With the fresh infections, the total infected cases in the state jumped from 15,17,434 to 15,28,226. Similarly, with 309 new deaths, the Covid-19 toll in the state mounted from 40,040 to 40,349.

On a day when 10,461 people were discharged from various hospitals in the state, the number of people discharged from various hospitals

after full recovery since the second week of March this year went up to 12,66,240. The recovery rate in the state rose from 82.76 per cent to 82.86

per cent. Of the total 309 deaths reported on Sunday, Mumbai accounted for a maximum of 42 deaths, followed by 35 deaths each in Thane and Nagpur, 30 in Pune, 25 in Kolhapur, 20 in Satara, 19 in Ratnagiri, 15 in Sangli, 14 in Solapur, 11 each in Nashik and Ahmednagar and 10 deaths in Nanded.

In the lower range, there were 9 deaths in Raigad, 5 in Jalgaon, 4 each in Palghar and Akola, 3 each in Beed and Gondia, 2 each in Amravati, Bhandara and Gadchiroli and one death each in Aurangabad, Jalna, Latur, Osmanabad, Yavatmal and Chandrapur. In addition, two persons from outside the state died in Maharashtra.

With 42 deaths, the Mumbai Covid-19 toll went up from 9,391 to 9,433 while the infected cases rose by 2,170 to trigger a jump in the total number of infections from 227,276 to 229,446.

Meanwhile, the mortality rate in the state stood at 2.64 per cent. The authorities pegged the number of "active cases" at 2,21,174.

Pune district, which continued to be the worst-affected city-district in Maharashtra, saw the total number of cases to up to 3,15,774, while the total number of deaths in Pune increased increased to

has no idea of constitutional laws. He should know that before imposing Article 356 there is an advisory needed under Article 355," Roy said wondering whether in Uttar Pradesh where one person had killed 8 cops President's Rule had been imposed. He also said "the murder of Manish Shukla was an affair among the Bahubalis (strongmen) which however is being investigated into by the CID."

He further said that union minister was making "absurd claims to hog attention, as he is not in good terms with State BJP president Dilip Ghosh which is why he is not getting any

prominence in his party."

Incidentally a BJP delegation led by its all-India vice president Mukul Roy on Sunday met Governor Jagdeep Dhankhar with a demand for a CBI investigation into the Shukla murder case. This even as BJP strongman and MP from Barrackpore Arjun Singh on Sunday alleged that the State Government was trying to implicate him in the murder case.

Shukla, a former TMC leader like Singh, was considered the right hand man of the



AAREY FOREST STAYS, CAR SHED GOES

Yuv Sena leader Aditya Thackeray, who had steadily been opposing the tree felling at Aarey Colony and was among the first lot to raise a protest against massive tree felling that took place on the night of October 4 2019, had tweeted, "A project that should be executed with pride, the Metro 3, @MumbaiMetro3 has to do it in the cover of the night, with shame, slyness and heavy cop cover. The project, supposed to get Mumbai clean air, is hacking down a forest with a leopard, rusty spotted cat and more".

On the following day, Aditya had come out with one more tweet, "The use of a large number of police personnel. Hacking trees in the dead of the night, even after winning in court (then why not broad daylight) and detention of peaceful protesters and citizens. Who is authorising this? During Code of Conduct? All these powers handed to MMRC?' Later on October 7 2019, the Supreme Court

had restrained the MMRCL from cutting any more trees at Aarey Colony till October 21. Hours after the apex court restrained it from cutting any more trees till October. On its part, MMRCL had said that while it "respected" the apex court's order, it had already felled 2,141 trees on October 4 and 5 following the Bombay High court's order upholding of the BMC's Tree Authority's permission to fell 2,185 trees at Aarey

However, on October 21, 2019 the Supreme Court clarified that the controversial Metro car shed project in Mumbai's Aarey Colony could continue, but the freeze on tree cutting would remain. The apex court had also asked for a White Paper on the issue, seeking details on the trees cut, transplanted and those that survived the transplant.

Subsequently, a day after it assumed office, the Shiv Sena-led MVA Government assumed office had on November 29 last year, Chief Minister Uddhav Thackeray stayed the work on the construction of a car shed for Metro phase-III at Aarey Colony in north Mumbai, pending

a total review of the project.
Within a couple hours after assuming the office at Mantralaya (State Secretariat), Uddhav said, "I believe in fulfilling promises I make... I have been thinking what to do for Mumbai... You may remember the Mumbai car shed issue had generated considerable heat during the elections..

As a first, I have stayed the Metro car shed at Aarey Colony. The car shed work will not resume till we take a full review of the project." Speaking to mediapersons after he was felic-

itated by the State Secretariat and Legislature Reporters' Association on his assuming the office, Uddhav said: "This (the review of Metro car shed work) is essential. I read news reports today that some trees were felled at Aarey Colony last night. I will not allow this kind of butchering of trees. I will take a total review of the whole thing," the Chief Minister had said.
Indicating that he was per se not against the

Metro project, Uddhay had said, "Whatever necessary will happen. I am all for development. I have not given any stay on the development work. But, I do not want any development that comes at the cost of our precious assets. Hence I have given direction to the people concerned that not even a leaf is removed from Aarey Colony". "Unfortunate decision to shift Metro CarShed from Aarey to Kanjurmarg and that too just to satisfy ego. This decision will increase the cost of the project by at least Rs 4000 crore and this cost escalation is assessed by the committee appointed by this Government," Fadnavis

"This means that the Metro project, which would have been in the service of Mumbaikars just next year, has now been postponed indefinitely. Rs 400 crore was already spent for Aarey Car Shed, Rs 1300 crore wasted due to staying of project & additional cost escalation of Rs 4000 crore... Rs 2400 crore cost burden if in case Kanjurmarg land dispute remains as it was. What will be today's cost?," the former chief minister

"Metro project delayed for indefinite period. What exactly does the state Govt want to achieve by blocking the seamless journey of Mumbaikars? MVA Govt misleading Mumbaikars," Fadnavis added.

FARMERS CAN USE AGRIX1 DRONE SANS GOVT NOD TO PROTECT CROPS

Sinha pointed out that the Artificial Intelligence software called 'Nerve Centre' (developed by his firm) helps quickly identify crop diseases from UAV data and automates the

process of digitisation and classification of crops. Given that at least 50 per cent of India's GDP is still agriculture-based, it is hoped that such drones can play a big role in boosting agriculture yield by 10-20 per cent. Crop diseases and pests have become a major headache for the farmers in recent years due to pollution and climate change impacts.

However, as Indian farms tend to be small and a single farm's plots are often scattered throughout a region, Agrix1 is currently helpful for large agricultural areas only.

To this effect, Omnipresent is working jointly with a large agriculture industry player in Telangana using the drone. "We are developing machine learning algorithms to quickly identify diseases in crops using large amounts of training data. Additionally, we plan to deploy a sprayer drone for taking appropriate corrective

action on affected crops. "Automated disease identification and remedial measures using drones would be a big game changer for the agriculture industry and farmers and we are looking forward to disrupting this segment," said Sinha.

No road tax for battery-operated vehicles in Delhi

AAP Govt's EV Policy aims to register 5L vehicles by 2024

The Transport Department I of the Delhi Government has issued a gazette notification stating full waiver on road tax on the battery-operated vehicles under the electric vehicle policy of the Delhi Government. The decision was taken on the direction of Chief Minister Arvind Kejriwal.

The Department has also sought suggestions from the public on the exemption on the registration fee even as the orders to waive off the fee will be issued in the next three days.

Kejriwal had announced the Delhi Electric Vehicle Policy (EV) 2020 last month with a focus to increase the adoption of electric vehicles in Delĥi by incentivising the purchase and use of the EVs. The policy aims to register five lakh electric vehicles in the city by 2024.

Taking to twitter, Delhi Transport Minister Kailash Gehlot said, "Congrats Delhi! As promised by CM @ArvindKejriwal when announcing landmark EV Policy, Delhi govt has exempted road tax on Battery Operated Vehicles. With right incentives & supporting infra, we are determined to ensure Delhi leads the country in electric by 2024.

He said the emphasis of the World Mental Health Day was that each one should identify such persons who were under great mental stress. He said such people, if counselled time-

He said one must remove thought of suicide and bring in positive thoughts for survival and enjoying life happily.

Additional City Magistrate Mahesh Kumar said in the present time of stress and race of materialism it was very necessary for every individual to find time for self and also to learn the art of living sans

He said it was essential to include yoga and exercise in daily life as health in fact meant being healthy physically, mentally and socially. He said absence of disease did not mean one was healthy. He advised people to ensure they

were healthy in the three ways.

Chief Medical Officer Dr AK Mishra said World Mental Health Day was observed and the theme for this year was 'Mental Health for All — Greater Investment, Greater

He said the whole world had been hit by the coronavirus pandemic which had caused immense mental stress and there had been a rise between 18 percent and 28 percent in mental health problems during the last six months.

He said a recent survey in India reported that more than 80 per cent of the participants experienced anxiety and preoccupation with contracting COVID-19, while 12.5 percent faced sleep difficulties and 34.6 ed to social media.

He further said it was a matter of great concern as it represented a greater demand on the limited mental health care resources, over and above

the existing treatment gap. He said COVID-19 pandemic had changed the circumstances in which people live and had led to increase in stress levels. He added that there was reportedly a significant effect of COVID-19 pan-

demic on mental health. He said the pandemic continued to affect all segments of the population since its origin and while dealing with such public health emergencies, the

He said for the general population at large, the mental health effects of COVID-19 were as important to address as were the physical health effects.

He said there had been a sudden surge in domestic violence and child abuse incidents in the midst of the COVID-19 crisis and during the lockdown, there had been a number of stresses which had caused distress amongst population, for example, quarantine, pay-cuts, unemployment, uncertainty, fear, violence,

He said while quarantine was a necessary preventive this infectious disease, many studies had reported a negative psychological impact of quarntine on individuals. He said lockdown had aggravated the situation for victims of domestic violence according to the statistics released by the National Commission for

The CMO said the total complaints from women rose in the period between March and September 2020. He said the increase had been attributed to abusers being confined in homes with no outlet to their anger or frustration and the helplessness of the victims to share their grief or travel to

He said in India, 10 percent of the population had common mental disorders and 1.9 percent of the population suffered from severe mental disorders like schizophrenia, bipolar affective disorder, depression, anxiety disorders, psy-choses, phobia, suicide, mood disorders, neurotic or stress related disorders, post-traumatic stress disorder, marital disharmony, sleep disorders,

alcohol dependence and sub-

stance misuse and dementia.

Dr Kalim Ahmed said the biggest challenge faced by the Indian mental health system was lack of knowledge about the mental illnesses as well as lack of adequate mental health services. He added that due to attached to mental illnesses resulted in poor utilisation of the available services and problems continued to compound and persist.

He said there was a need for effective engagement of communities in preventing and promoting mental health of the population. He said in context of the present COVID-19 situation where there was likelihood of grave mental health problems in communities, with the given challenges it was going to be a difficult task for the nation.

Stay away from crowds, follow Covid guidelines: Min

As India gears up for a string of festivals against the background of rising coronavirus cases, Union Health Minister Dr Harsh Vardhan on Sunday urged people to stay away from large congregations and diligently follow Covid19 guidelines, saying no religion or God asks people to celebrate ostentatiously.

He also warned that upcoming winter season may see increased rates of transmission of the novel coronavirus, citing the nature of such pathogens.

Requesting people to celebrate the approaching festivals at home with their loved ones instead of going out to fairs and pandals, he said fighting against Covid-19 is everyone's foremost "dharma" and as the country's health minister it is his "dharma" to mitigate the virus and prevent deaths at any cost.

He invoked Bhagwad Gita message to make his point saying that the "Bhagwat Gita condones war for the warrior class. So, there is no need to

congregate in large numbers to prove your faith or your religion," he said during the fifth episode of 'Sunday Samvaad', a virtual interaction with people on social media.

"Extraordinary circumstances must draw extraordinary responses. No religion or God says that you have to celebrate in an ostentatious way that you have to visit pandals and temples and mosques to pray," Dr Harsh Vardhan underlined.

He also discussed the possibility of increased novel coronavirus transmission during the coming winter season as transmission of respiratory viruses is known to increase during the colder weather.

These viruses are known to thrive better in the cold weather and low humidity condinot be wrong to assume that the winter season may see increased rates of transmission of the novel coronavirus in the Indian context too, he noted.

He stressed that if people congregate in large numbers to to celebrate festivals, "we may be heading for big trouble". India has recorded 70,53,807 Covid cases while deaths have climbed to 1,08, 334 as on Sunday.

"Lord Krishna says concentrate on your goal...our goal is to finish this virus and save humanity. This is our religion. The religion of the whole world,"

Answering questions on the efficacy of AYUSH formulations in the treatment of Covid-19, Dr Harsh Vardhan explained the concept of Salutogenesis and how these formulations target holistic recovery of patients.

Pointing to in-depth study of literature and scientific evidence generated from in silico studies, experimental studies, and clinical studies, he said, Guduchi, Ashwagandha, Guduchi and Pippali combination and AYUSH 64 have a sub-

tory, anti-viral, antipyretic and anti-inflammatory properties.

On progress about the indigenously developed Feluda paper strip test for SARS-CoV-2 diagnosis, he said it could be rolled out in the next few weeks.

Presently Covid-19 vaccines are in various stages of phases 1, 2 and 3 of human clinical trials, the results of which are awaited. "Adequate safety and efficacy data is required for emergency use authorisation, vaccine approval for ensuring patient safety. Further course of action will depend on the data enerated," the Minister under-

Categorically rejecting speculation that the government is prioritizing young and working-class for the Covid-19 vaccine for economic reasons, Vardhan said, "The prioritisation of groups for Covid-19 vaccine shall be based on two key considerations -- occupational hazard and risk of exposure to infection, and the risk of developing severe disease and

Asked how the government plans to roll out the Covid-19 vaccine, he said that it is anticipated that supplies of vaccines would be available in limited quantities in the begin-

ning.
"In a huge country like India, it is critical to prioritise vaccine delivery based on various factors such as the risk of exposure, comorbidity among various population groups, the mortality rate among Covid-19 cases, and several others," the minister said.

Vardhan also highlighted the need for massive advocacy for building community sensitization activities to understand the reasons for vaccine hesitancy and address them appropriately.

Referring to reports of reinfection surfacing in various states, Vardhan said an analysis by the ICMR has revealed that many cases reported as COVID-19 reinfection have been misclassified because RT-PCR tests can detect deadvirus shed for prolonged periods after recovery.



Major spike in pulses' price

A fter vegetables, it is the turn of the pulses to witness a major spike in their prices. In the retail markets, tur (arhar) is being sold between ₹120 and ₹140 a kg while dhuli urad is between ₹90 and ₹120 a kg.

As per the Ministry Consumer Affairs (MoCA), the wholesale prices of gram, tur and urad is ₹6,700, ₹9,700 and ₹9,700 per quintal in the markets. Besides tur and dhuli urad, masoor dal prices increased from ₹60 to ₹80 per kg and moong dal prices increased from ₹80 to ₹90-100 per kg. The prices of kabuli chana (chickpea) and gram dal are also skyrocketing in the retail markets.

Traders say prices of pulses are rising due to short supply. Another reason is that there is a possibility of a further increase in pulses stocks. The rainfall in Maharashtra and Madhya Pradesh has led to the low production of pulses. The traders complain that the speedy increase in prices has reduced the sale by 60 percent. They added that the price hike has taken a toll on retail business with the con-

Tust two years ago, nobody had even thought that the marginalised potters' community in Bihar would have their day. But life is changing for hundreds of them now thanks to the "Kumhar Sashaktikaran Yojana" launched by Khadi and Village Industries Commission (KVIC) to empower the Kumhar community in Bihar.

"It was the dream of none other than Prime Minister Narendra Modi to empower the Kumhar community through modern technology and revive the dying art of pottery making in the country," says KVI chairman VK Saxena. Saxena points out that one

such beneficiary of the program is Jai Shankar Pandit, a potter in Muzaffarpur district of Bihar who along with his father used to work earlier on stone chaak. His life has changed after he received an electric potter wheel from KVIC. High productivity and higher income are all that he can boast of now. And the family has a unique way to express their gratitude to the Prime Minister.

Jai Shankar is now making the idols of the Prime Minister and also earning a respectable livelihood by selling them in Bihar and West Bengal. Pandit could now also earn a sustainable livelihood. "The idols of the PM are selling in good numbers and fetching me good



piece," Saxena points out.

Keeping in view the festive season and the ban on Chinese clay items by Modi, he is also making idols of deities - Durga, Laxmi and Ganesh - and a variety of diya (earthen lamp) and decorative items to reap maximum advantage.

Prevention vs cure

Govt, IMA clash on Ayush COVID protocol; doctors say evidence merely anecdotal and a placebo, not clinically proven



hen Kerala, the hub of Ayurveda with some of the best practitioners, arrested the spiral of the pandemic in the early stages, its Health Minister KK Shailaja made a crucial observation. That once the disease had set in, there was no alternative to the clinically proven and medically tested protocols. And that traditional systems of medicine, like Ayurveda and homoeopathy, were good for overall well-being and body resistance. So they could be used only as part of a protective or convalescent routine. The deadly virus itself had to be treated with proven drug combinations. This distinction is very important in a country growing up in

a culture of naturopathy and home remedies, and, therefore, prone to trusting conventional wisdom. But this is a novel virus we are dealing with. There is no doubt that traditional systems of medicine in India have not only survived but flourished over the centuries and there are virtues embedded in our huge herbal heritage that are good for disease prevention, improving immunity and overall health management. So far, the evidence of their curative potential has largely been anecdotal than empirical. But overplaying our herbs as part of a COVID-19 medicare protocol, when they are yet to cross the threshold of medical reason, comes with the attendant ills of misconception that they are just as effective as allopathic drugs. Particularly in a country where most cannot understand the fine line between preventive care and cure. This is the reason why the Indian Medical Association (IMA) has taken umbrage to Health Minister Harsh Vardhan's upgradation of protocols on October 6 for managing and treating COVID patients with mild symptoms in AYUSH (Ayurveda, Yoga and Naturopathy, Unani, Sidda and Homoeopathy) hospitals and by AYUSH practitioners. It asked the Minister to authenticate efficacy claims made from studies done on asymptomatic COVID patients, make them public and available for scientific scrutiny or else be responsible for "inflicting a fraud on the nation and gullible patients by calling placebos as drugs." In a sharp attack, the IMA asked how many of Vardhan's ministerial colleagues have so far made the informed choice of getting treated under these protocols. It wondered if the proponents of this claim and his Ministry would subject themselves as volunteers to an independent prospective double-blind control study in the prevention and treatment of COVID. This is a pertinent question considering almost all of our Ministers have chosen private multi-speciality hospitals with advanced allopathic protocols to treat themselves when they got infected. The IMA even asked what was stopping the Minister from handing over COVID care and control to the AYUSH Ministry. The problem with the AYUSH protocol at hospitals is that it legitimises Ayurveda as a line of treatment when fact is that there has not been a sustained trial and a consistent similarity of results to prove that it works in arresting the spread of the disease. Till then, AYUSH treatments can at best be prophylactic in nature and must be emphasised as such in officialese.

It is true that a few Ayurveda pharmaceutical companies have been working on simulation studies where few plant molecules have shown the ability to halt the alarming multiplication of the SARS CoV-2 virus in an Artificial Intelligence (AI) modelling. Researchers at IIT Delhi, in collaboration with Japanese scientists, have found that properties of the Ayurvedic herb Ashwagandha have "therapeutic and preventive value" against COVID-19 infection. But they are working on more conclusive proof that could allow for pharmacological interventions. Let us not forget that callous official endorsement can lead to outrageous claims like the recent one made by Yoga *guru* Baba Ramdev that he had found two new medicines — Coronil and Swasari — that had shown a 100 per cent recovery rate in patients within just 14 days. He quoted clinical trials at the Jaipur-based National Institute of Medical Sciences and Research (NIMS) which denied it subsequently. He applied for a licence duplicitously, claiming that his was a cold, cough, fever drug with immunityboosting properties. And once the licence was got and the time for a rollout came, he claimed it was a cure. Besides, Ramdev's Patanjali group sidestepped the Drug Controller General of India, whose approval must be sought before a medicine is put out in the market. In our search for a cure among herbs, we are doing a disservice to what Ayurveda stands for. It is not just about COVID prevention but a holistic system of medicine involving herbs, diet, lifestyle and other measures that helps the body fight off all kinds of pathogens and diseases. Ayurveda has never been in conflict with science and is actually about scientific management of life. The IMA statement is all the more significant because it draws attention to the flawed pandemic management in India as we race to become the worst affected country. With the disease expected to see a painful peak by November, in no small part aided by the festive season and the opening up of every sphere of human activity, spare a thought for our overworked healthcare personnel. Most of them are battling depression, exhaustion and pay cuts even as the stream of patients is constant. Hundreds of them have lost their lives while on frontline duty and the IMA has been demanding martyr status for them as they went down fighting a new age battle. The infrastructure, even in bigger cities, is still short of handling a bad winter surge should it happen as predicted. Rather than upgrading AYUSH protocols, we need to upgrade practical solutions.

The hunger project

World Food Programme rightfully wins the Nobel Peace Prize



as it fights a global nutrition crisis caused by the virus and war It was a long time coming but in the end, the United Nation's (UN) World Food Programme (WFP) was awarded the coveted Nobel Peace Prize 2020 for its efforts to combat hunger, its "contribution to bettering conditions for peace in conflict-affected areas and for acting as a driving force in efforts to prevent the use of hunger as a weapon of war and conflict." It is in a long time that a cause has been prioritised over a face. The WFP, which was set up in 1961 at the behest of then US President Dwight Eisenhower, combines humanitarian work along with ensuring peace in war-torn regions because it firmly believes that without tackling war, hunger

cannot be eradicated. How much effort the WFP puts in and how much the world needs its help can be gauged by the fact that there are 690 million hungry people around the world and around 60 per cent of them live in conflict-torn nations. In 2019, the WFP assisted 97 million people, the largest number since 2012, in 88 countries. It manages one of the world's largest logistics chains as on any given day, it has 5,600 trucks, 30 ships and nearly 100 planes on the move. The Nobel Peace Prize to it couldn't have come at a better time as the UN has been under a cloud with its health watchdog, the World Health Organisation (WHO), mishandling the Coronavirus crisis. The honour is also a validation of the UN's yeoman's service to humanity and has silenced its detractors.

Like all other countries that have benefitted from the WFP, India, too, has a long association with it. The aid organisation has been working with respective governments to eradicate hunger since 1963, when India was a major food importer and was battling shortages. Now the WFP is working to reform our notorious Public Distribution System (PDS) through its Annapurti initiative whereby automatic grain dispensers — or ATMs for rice — will be set up across States. It is also working on fortifying food distributed under the mid-day meal scheme. Now, with the pandemic disrupting food security, it is setting up supplementary nutrition production units in Uttar Pradesh. Its mobile storage units in Odisha have contained starvation deaths there. The Nobel Peace Prize, which has often been under a cloud of controversy due to the selection of people who are deemed "undeserving" or "unworthy" of it, will be heartily endorsed by the global community, which owes the WFP a lot. This year the selection committee has got it bang on.

olitics is the engine of ociety. The best of cariages, bogeys and saloons would come to naught if the engine was not maintained well. India has had satisfactory governments and poor ministries but still little thought has been given to the quality of men and women who should govern the country. Neither voters nor parties and their leaders or even our political scientists have given much thought to this subject. If the latter have thought about it, they do not seem to have written or propagated any ideas about it.

Indian elections have experienced positive polling, negative voting, voters choosing with their feet and polarised mandates, caste, class or community-wise. People have been heard saying that they voted to feel safe as a country after Indira Gandhi's assassination in 1984. Never have I heard anyone saying that he/she voted to try and ensure good governance. Although after the 2019 polling, I did hear some Kolkata voters say that they voted for Narendra Modi for he was the fittest ruler among the choice before us at the Centre, although they did not agree with his party's

That a successful democracy needs an effective Opposition is universally agreed. To add, a credible Opposition should also have an inner-party democracy. Out of the 68 years of India's democratic functioning, most of the time we have either not had an adequate Opposition or the main Opposition party lacking internal democracy that would have injected fresh energy and perspectives. Lately, we have the doubtful benefit of hereditary parties or family-led organisations. The flip side to this problem is that most politicians in recent decades belong to mainly three categories — a family tradition, the unemployables and the freaks. Most others and their parents prefer secure careers or pursuits. Even -to-do financia ilies do not encourage their offspring to risk years in politics. Yet it is the same India which sent out their best youth, grown-ups and old, women and men to agitate for freedom. Was this patriotism spontaneous to the people or was it inspired by the leadership of Mahatma Gandhi? Before 1920, there was no tradition of such mass participation in the country's polit-

tainly large swathes of it, was under the heels of invaders since the 12th century. And soon after 1947, the patriotic enthusiasm began to dry up. Independence from the

British did not mean that freedom was guaranteed or even secured forever. Retaining freedom is more important than winning it. Therefore, the best talent in the country should try going into politics. Everyone would not nned Iroun up my commercial career and came to Delhi nearly 40 years ago en route Gujarat. In those vears caste mattered so much that even the most generous political party could not allot any seat (Lok Sabha). I, therefore, held back in Delhi and worked here quietly for 16 years and then got to the Rajya Sabha for a part term as a result of a byelecI performed. We must remember that while business management is a game of selection, politics is one of elimination and in business one generally succeeds without grabbing anyone else's money. between 1929 and 32, he often said he would return to India and join the Congress party. Gandhi was already an acclaimed leader and yet the reaction was often, "After such expensive studies, why go to politics?" Yet the American standards are reasonably good.

Our voters should be more demanding and not so tolerant of standards as they often can be. Take the issue of dynasty. In May 1981, when Rajiv Gandhi was contesting his first byelections from Amethi, I spent a few days motoring through the constituency accompanied by a colleague. At least Rajivji had to come and get elected again and again to get the people's approval."

Coming to corruption, we came across a lucid explanation on the outskirts of Malihabad in the 1984 General Election. Again a dhaba discussion, State Cabinet, was being praised for being such a good and honest man. One of the participants lost his patience and intervened to ask, "Yes, Anwar Saheb is very upright and honest, he has been a Minister for 10 years but has not been able to build a house for his family. If a person cannot do this least bit for his wife and children, what can he do to help common people like you and

What management is to a company and its success, the Government is to a country. Yet most of our people do not connect the country's stake when they go to the ballot box. The debacle of 1962 caused by unpreparedness needs recollection. The Indian Army did not have mountain guns or howitzers to fire in mountainous NEFA. The second batch of troops that was sent up to 16,000 feet had canvas shoes, no gloves and ordinary woollen pullovers. General Rob Lockhart, the interim Commander-in-Chief of the Indian Army Independence, said that we are a peace-loving nation. We do not the police is sufficient for our purpose. After all this, the same political party was re-elected in the following election. And in the 1990s, our Prime Minister told in a reply to a journalist that India is too large a country to worry about terrorism.

Some hope in grim times

In these difficult days, there is reason to believe that the tribe of progressive social critiques is still heard

he COVID experience has been unique in more ways than what most of the webinars are talking about. For example, social media is not exactly known to elaborate concepts. However, the online versions of printed news media platforms appear to have widened and deepened their reach and impact as compared to the pre-Coronavirus era. The galloping use of smartphones in the country has enabled the reach and availability of news through a large part of the day, beyond the morning. At times, the impact is even clearer. Thankfully, the print media has not fallen prey to that claim that resonates through the elec-

tronic channel news daily: The phenomena called "breaking news." The concept of "breaking news" has undergone a sea change over the years and it doesn't even titillate like before. "Breaking news" in years past used to be the equivalent of "Stop Press" in the print media, when they used to stop the printing presses because something of phenomenal importance just had to be reported in the next day's newspaper. For instance a war, or the declaration of Emergency, or demonetisation or the assassination of an important leader. Now, like many advertisements, "breaking news" seems more like an attempt to grab attention rather than share any meaningful news story that is unfolding at that

Then there is the claim of "impact-making" news. For instance, the gate of a VIP's residence was plastered with a quarantine notice, which was found to be very embarrassing by the bureaucrat who lived there. Reportedly, the notice was torn away. One of the news channels picked this story up and ran a campaign on "differential treatment." Soon after, the notice was restored by the authorities that be. Subsequently the news channel claimed to have run an "impact-making" story. Maybe, it was because of the news coverage of the channel that the notice was restored. Maybe it was not. Maybe colleagues persuaded the bureaucrat to tone down the reaction to the quarantine notice. Or maybe the bureaucrat's good sense prevailed in the end. However that may be, not long thereafter, the practice of pasting quarantine notices on the entrance of households with Coronavirus patients was reportedly discontinued by the Haryana Government.

The impact may not be monocausal. There may be many claimants to the impact and many perspectives. Be that as it may, one thing is obvious that the media does carry a clout, though one-to-one impact-change correlation is difficult to establish. However, when one notices a change after reading something in news columns, it does raise the possibility that the writing made an impact and caused the change.

In these columns on September 28, para three of the text said "...even today in a city that is the proverbial centre of power, pick up a phone and call a landline of the metropolitan telephone service, the ring is preceded by a recorded voice message which, when translated into English, goes something like this: 'In the entire country the process of un-lockdown has begun. In such circumstances, move out of the house only when it is totally necessary.' What followed was a light-hearted banter on the intended impact of the message. Several days later that message was replaced by one from a well-known voice from Bollywood. Significantly, the text of the new message on the telephone service resonates far better than the preceding one. Now the person holding the telephone is reminded that not only India but the whole world is grappling with the impact of the Coronavirus.

The purpose of the above narrative is not to claim that the September 28 write-up in this column triggered this modification. Far from it! However, it pleases one to note that somewhere, someone has contributed towards a change for the better. In the past, too, I have flagged such correlations. It is possible that others have written on similar things, too. Others may have talked or others may have noticed what I noticed too. The important thing is we should be proud of having a responsive governance system at least in some kind of experiences and cases. Once should notice the brighter aspects of public life in an otherwise grim scenario. It keeps hope alive. Hope need not come in large parcels or in areas where someone feels fatigued. It is just the indicator of life. In these difficult times, there is reason to believe that the tribe of progressive social critiques is still heard. Whether it is heard often or not often enough is a matter of perception and appetite for favourable response. For some it is still a matter of joy that sometimes those who matter do hear and do respond.

Cancel culture decoded

hat an innocent sounding word, "cancel", has come to define contemporary culture in modern democracies may sound rather baffling to a lay person. The fact that it actually has, at least in select spaces involving debate and dialogue, reveals the degeneration of those spaces, theoretically given to welcoming diverse opinions. In everyday usage, cancel may mean withdrawal or scrapping of a contract, but the "cancel culture", which unfortunately has become the logic of an impatient generation, has many more layers of meaning that generation, has many more layers of meaning that are interlocking and complex. Regardless of its advocates from contrasting ideological umbrellas, "cancel culture" implies that the country and its institutions have failed the people, prompting the militantly "conscientious" groups to take over. Needless to say, such campaigns remain predominantly urban and middle-class. Analysts have traced the prevalence of this culture as definitive of our intellectual reality to the #MeTon campaign in the LIS. A powal reality to the #MeToo campaign in the US. A powerful and perfectly legitimate movement slowly became the weapon of a generation glued to the internet, though without any sincere commitment to the cause that defined earlier generations of protesters, involving marches or picketing, which were demanding in terms of time and energy. Before we realised its frequent occurrence and increasing moralising tendency, it had become part of our cultural sphere and expressed itself through withdrawal of support, challenging authority and advocating suspension of the offender. Thus, Starbucks was targetted for asking its employees not to wear "Black ives Matter" badges, a gym club brand, Equinox, faced backlash after its owner was found collecting donations for US President Donald Trump. Opinion writer Bari Weiss resigned from her job when her employer, The New York Times, failed to protect her from constant harassment by her colleagues for holding on to different political values. JK Rowling was "cancelled" because of what was seen as her intolerance of trans-women

The war among liberals: In-built into "cancel culture" is an ethical imperative on the part of the people championing it, who see themselves as the defenders of democratic ethos, prompting them to raise their voices against what they feel is unjust. What is ignored in this so-called ethical order is the anti-democratic force that bet erance of difference and disagreement. That explains why the same group of people demanding freedom end up cancelling conservative intellectuals. So "cancel culture" remains anti-democratic and promotes a culture of purity where being different and adversarial are offensive. with Chomsky, Fukuyama, Rushdie, Atwood and so on, and called out this "cancel culture" as intolerance in an open letter published in Harper's Magazine, she was, to some extent, joining hands with those who gave oxygen to such a culture. They wrote, "Censoriousness is spreading more widely in our culture: An intolerance of opposing views, a vogue for public shaming and ostracism, and the tendency to dissolve complex policy issues in a blinding moral certainty." What these people often forget is that writing such letters is always more about protecting their authority over liberalism than the cause itself. If they suddenly realise the violence of "cancel culture", they should not look beyond themselves to find its provenance. "Cancel culture" is a product of their mus-

Even as "cancel culture" is a product of liberal discourse, it poses an existential threat to that discourse in its demand for a forced outcome rather than a processoriented approach. It is equally protestant in nature in the sense that it has scant respect for liberal idols and high priests who symbolise entitlement. In fact, we may discern inter-generational conflict within this liberalism or a kind of castration anxiety (in Freudian terms). It marks the coming of age of the next generation of relatively young champions, who see their ideological fathers as patriarchs who have always benefitted from peddling liberal wares. Unlike political parties or sports teams, the "liberal progressive" shop has the same set of owners who refuse to allow the new generation to replace them. Impatient, restless, combative and young, "cancel culture" warriors cannot see themselves waiting perpetually to be counted as intellectual adults. When Pankaj Mishra took issue with Rushdie for being called "the voice of the continent", he was protesting against an intellectual culture that condemns authors like him (Mishra) to the waiting room of intellectual history. The Indian story: In India, unlike the

US, this culture has traversed both Leftand Right-wing narratives as well as not so politically-conscious actors. In the recent Bloomsbury controversy relating to a book on Delhi riots, the first move came by backlash from the non-Left quarters, who took issue with Bloomsbury's cancellation and then cancelled Bloomsbury as a publisher of their choice. The death of actor Sushant Singh Rajput (SSR) also created a polarising climate where the outsiders to Bollywood, such as SSR, were pitted against the privileged insiders, who took their stardom for granted. This infuriated and angry group collectively trashed Sadak 2, a movie made by one who is seen as a promoter of nepotism.

However, it will be off the mark to project this as the expression of Right-wing angst. On most occasions Bollywood prima donnas of liberal hue have voiced their opinion against politicians, fellow actors and producers and whoever they values. The present polarisation of

"Cancel culture" in India remains derivative of American leads, as in the "Black Lives Matter" movement being converted into "Dalit Lives Matter." However, the cultural Right is learning from its past mistakes and using the vocabulary of democracy and victimhood for its own purpose. Like its Left adversaries, its supporters are writing letters to the public or to the President to raise awareness. They are writing books and speaking from public fora and forcing the Left to dehumanise itself by turning violent. Even as the Right is learning from the Left, the latter is getting into the slush of what it accused the Right to be. The liberal Left, which claimed to have exclusive right over free speech, now understands that liberty and free speech are no longer its excluomaine I efficte fear that be effectively used by the Right and this makes it suspect liberty as an impediment to its ideals of democracy and justice.

Economic imperative: There is yet another dimension of "cancel culture", namely the economic imperative. Sometimes, acting on public outrage, as in sacking an employee for contrarian political values or insensitive posts, organsations seek to arrest a backlash or cash in on public outrage or hold on to their clientele. Given that the US intellectual sphere is totally dominated by the Left and the so-called multi-culturalism complex, and common people do not care much until election time, the media and publishing industry actually gain from this competitive outrage. In Índia however, due to its millennia old culture that has been evolutionary rather than revolutionary, such disruptive changes remain confined to select, elite spaces.

Understand psychology for better decision-making

This approach can help in reducing stock market movements and losses on the bourses



ets have huge upswings or downswings? Most of the times, they are like a domino effect, a chain reaction, caused by herd behaviour. Herding is an inclination of investors to follow the crowd, thus destabilising stock prices. It is a very powerful bias, and in the process of mimicking each other, the impact on the stock prices gets intensified, leading to bubbles when the demand is high and crashes when investors detect overpricing.

This is contrary to the classical finance theory, which believes that investment decisions are taken by rational investors. But are investors really rational? A Boston-based research group reported in 2007 that

an average stockholder earned 4.3 per cent per annum returns where the returns of American S&P 500 Index averaged at 11.8 per cent per annum. The reason for this variance was the irrationality of investors of

buying high and selling low. A peek into the past can show that players in the stock market have been irrational since the time the bourses have existed. One of the earliest instances of unreasonable herd behaviour is the Dutch tulip bubble of the 1630s, also known as "Tulip Mania." When the tulip was introduced as a new variety of flower in the Netherlands, the Dutch people, because of some strange reason, became excited about this new exotic flower and vied to invest in tulip

Progressively, the investments grew huge and at the pinnacle of this mania, a single bulb was sold at a price that was more than ten times the annual income of a skilled worker. But when people realised that investments in tulip bulbs were way more than their actual worth, they panicked and started selling tulip stocks, leading to a sharp fall in the

stocks, resulting in huge losses.

This and many other subsequent events after this, like the dot.com bubble and the more recent real estate bubble, have led to the belief that investors do not behave rationally and that their decisions are mostly driven by emotions like panic, fear and greed. These instances are in contradiction of the traditional financial theories that are based on efficient market hypothesis, that assume that all the information is reflected in the stock prices efficiently and in a timely manner. So much so that the investors are unable to make any abnormal profits by buying stocks. There are four pillars of traditional finance: Rational investors; efficient markets; traditional portfolio designs; and linear expected returns-risk relationship.

However, stock markets in reality are largely inefficient, which is evident due to various market anomalies, speculative bubbles and over or muted reaction to any new information about stocks. These prevalent conditions in the stock markets suggest that investors are more emotional than rational about their investment decisions, leading to creation markets and provides a realistic

A bubble is created when the stock price is driven higher than its fair value as people invest in these stocks, neglecting the fundamental valuation. Such investments strengthen the overpricing even more and put pressure on the stock prices to generate higher returns for investors, failing which, the selling starts and picks up momentum when investors follow one another, leading to the bursting of the bubble. Behavioural finance, as a discipline, emerged as an attempt to explain the psychology of financial decision-making and how the human angle affects the same. Several researchers believe that principles and morals of people influence their economic, social and financial decision-making. Sentiments like pride, shame, insecurity and egoism also play an important role in investment decisions. By accepting the fact that investors are irrational and have biased decision-making, behavioural finance entends the limitations of traditional finance theories into possible inefficiencies in the financial

Research has identified two types of behavioural biases. The first one, a heuristic-driven bias, also known as cognitive bias, acknowledges that investors are investigative in nature and use rules of thumb to process data for decision-making. For example, people predict future performance of stock market movements through historical data. Emotions like overconfidence, anchoring and adjustment, reinforcement learning, excessive optimism and pessimism form a part of this bias. The second one, frame-dependent bias, is where the investors' decision-making process is affected by the way they frame their options, like narrow framing, mental accounting and the disposition effect.

It can be concluded that awareness about behavioural biases is indispensable since it is unequivocally associated with human beings and its implications are far and wide. Ignoring such behaviour of the decision-making process can prove to be quite expensive in the financial markets as it can result in stock market

anomalies. Financial investment managers and advisors can identify investment mistakes if they have a good understanding of this behaviour of retail investors and become more effective by understanding their clients' psychology and needs. It helps them in creating a behaviorally-adjusted portfolio, which best suits their clients' requirements. Investment bankers can put this knowledge to use by correctly timing the IPOs and understanding the general sentiment in the stock markets. Behavioural finance also helps financial analysts in forecasting future stock market movements and recommending appropriate stocks for investments. Finally, individual retail investors can use this expertise to make wise, rational and effective financial decisions.

Investors, financial advisors and fund managers are all humans and are subject to biases. Understanding the psychology of financial decisionmaking can help in reducing the stock market movements and reducing losses on the bourses.

GST Council to discuss compensation issue

THIRD TIME IN A **ROW ON MONDAY**

The GST Council in its meeting on Monday is likely to discuss the suggestion of non-BJP ruled states of setting up a ministerial panel to develop consensus on the issue of compensation, sources said.

The Council, chaired by Union Finance Minister Nirmala Sitharaman and comprising of State finance ministers, will for the third time in a row discuss the issue of funding the shortfall of Goods and Services Tax (GST) revenue of

While some opposition ruled states are demanding that a Group of Ministers be set up to arrive at a decision on the

pensation shortfall, BJP ruled states, which have already opted for the borrowing option given by the Centre, are of the view that they should be given a go ahead so that they can get money quickly.

The single agenda 43rd meeting of the Council will discuss on the way forward, sources said.

In its previous meeting last week, the Council had decided to extend the surcharge on taxes on luxury goods such as cars and tobacco products beyond June 2022, but failed to reach a consensus on ways to compensate states for loss of tax

The projected total compensation shortfall in current cal stands at ₹2.35 lakh crore.

The Centre in August gave two options to the states to borrow either ₹97,000 crore from a special window facili-

crore from market and had also proposed extending the compensation cess levied on luxury, demerit and sin goods beyond 2022 to repay the bor-

Following demand by some states, the amount of ₹97,000 crore was increased to ₹1.10 lakh crore. As many as 21 States -which are BJP ruled or have supported it on various issues -- have opted to borrow ₹1.10 lakh crore to meet the compensation shortfall. The Centre has released ₹20,000 crore to the states towards compensation shortfall so far in the current fiscal. Under the GST structure, taxes are levied under 5, 12, 18 and 28 per cent slabs. On top of the highest tax slab, a cess is levied on luxury, sin and demerit goods, and the proceeds from the same are used to compensate states for

As the pandemic has severely hit businesses and more so in the case of automobiles, hospitality and real estate sectors, a PwC report has sug-gested the suspension of Goods and Services Tax (GST) on these sectors for a minimum of six months.

The report titled "Reimagining GST@3" said that such a measure will provide much-needed cash liquidity to these sectors and ensure business continuity.

It noted that considering the impact on the economy, the Centre provided relief to the industry by extending deadlines for payment of taxes. Businesses were allowed to delay their tax payments for 15 days without incurring interest.

"However, several sectors such as hospitality, automobile and real estate have been severely impacted and the gov-

pending the GST payments of these sectors for at least six months," it said. It has also recommended the implementation of a facility to deposit GST to the government treasury on cash basis and suggested dis-pensation of credit reversal requirement on expired stock during this period. Among other suggestions, the report has also recommended expand

ing the tax base under GST.

It noted that a reason for the implementation of GST was to levy a single tax on all goods and services, resulting in free-flowing credit in the country. However, at present, certain items such as petroleum products -- petrol, diesel, aviation turbine fuel and natural gas -and alcohol are outside the GST net. To reassure states regarding protection of their fiscal autonomy, the government had initially decided to keep petroleum products, which form a major part of ambit of GST till revenue collections stabilise.

However, it is notable that due to the inward supplies of these sectors being subject to GST and the output supplies being beyond the scope of GST levy, the tax incidence in these sectors is significantly high, it said, adding that moreover, their compliance-related requirements have become fairly complicated. "This is to some extent defeating the Government's purpose of implementing the new tax regime. Representations have been made to bring industrial fuel, including natural gas and

ATF, under the GST net," it said. Noting that bringing the petroleum sector within the GST net requires more consensus-building, however, in the absence of constitutional limitations, it is only a matter of time before this shift takes place and states are assured that they can maintain their levels

Govt may consider allowing GST deposit on cash basis: PwC report

The Government may con-■ sider allowing India Inc to deposit GST on cash basis to help them tide over the liquidity woes during the Covid-19 pandemic, a PwC report said.

It said while formalising

its support strategy for the industry in the next phase, the government could also consider suspending GST payments for select sectors during the COVID-19 period.

In its report titled 'Reimagining GST@3', PwC said cash liquidity support schemes that advance business continuity are the need of

'The government has announced a timely budgetary support scheme in line with the relief packages of various developed nations. Despite these steps, much ground remains to be covered," it said.

The report said that some key issues which require immediate attention of the government before taxpayers get entangled in long-drawn litigation include eligibility of ITC on expired stock, intermediary services and taxability of discount schemes.

'The government should consider issuing clear guide-lines around these critical issues, keeping in mind the evolving international taxation principles and business models prevalent in the trade and ndustry," it said.

With regard to suggestions to overcome the current crisis, the PwC report suggested some measures the government could consider while formalising its support strategy for India Inc in the next phase.

These are facility to deposit GST to the treasury on cash basis, suspension of GST payments for select sectors during the COVID-19 period, dispensation of credit reversal requirement on expired stock

It also suggested one-time dispute settlement scheme under Goods and Services Tax (GST)."The government can consider introducing a scheme under the GST regime for voluntary disclosure of tax payments before the taxpayer undergoes GST audits. The GST law has evolved over the past three years and the government has clarified several provisions after its introduction. Therefore, a one-time scheme to clear previous irregularities can be considered, which will help the industry in clearing past baggage and reduce litigation," it said.

PwC India, Partner & Leader, Indirect Tax Pratik Jain said with the wealth of data available with the government and measures such as coordination between direct, indirect tax administrations and technological advancements such as E invoicing and E waybills, tax base is likely to

expand further. "We now need a 'white paper' articulating what is the form of GST we want in the next few years. The regime requires more stability, simplicity and transparency. The report provides some food for thought as we reimagine the new and much improved GST regime," Jain added.

Digital payments soar manifold in 5 years to FY20: RBI

oncerted efforts by the Reserve Bank to move to a non/less-cash economy by pushing digital payments have begun to pay rich dividends as the volume of such payments has jumped manifold in the past five years, the latest data from the central bank showed.

Between 2015-16 and 2019-20, digital payments have grown at a compounded annual growth rate of 55.1 per cent - from 593.61 crore in the year to March 2016 to 3,434.56 crore in the year to March

In absolute terms, value has grown from ₹920.38 lakh crore to ₹1,623.05 lakh crore during this period, clipping at an annual compounded rate of

Giving a year-wise data, in 2016-17 digital payments jumped to 969.12 crore from 593.61 crore in the previous vear in volume terms, while in value the same rose to ₹1,120.99 lakh crore.

Similarly, the numbers continued to scale new peaks with volume growing to 1,459.01 crore and value jumping to ₹1,369.86 lakh crore in

Come 2018-19, the numbers clipped at a faster pace with volume jumping to 2,343.40 crore transactions while the value rose to ₹1,638.52 lakh crore.

However, FY20 saw a massive spike in volumes over the previous year to 3,434.56 crore but in value slipped down to₹1,623.05 lakh crore, which can be attributed to the steep

and the massive job losses, forcing people to spend less and preserve more cash.

Yet from a five-year growth perspective, the numbers shine with an annual growth rate of 55.1 per cent in terms of transaction volumes and 15.2 per cent in terms of value, show the RBI data.

Given the pandemic and the lockdown restrictions, digital payments volumes are set to jump manifold while the value could see a further plunge given the mammoth crisis that everyone faces following the pandemic.

Mobile operators' revenues to improve in Q2 on more recharges, reverse migration: Analysts

Revenues for mobile opera-tors are expected to improve sequentially in September quarter, as factors reverse migration, and easing of lockdown curbs helped overcome what is otherwise a seasonally weak quarter, say sector analysts.

In its note on earnings preview, Axis Capital said revenue for wireless service providers is expected to improve in the second quarter on increased recharges as lockdown restrictions eased.

"Subscriber addition expected for RJio/Bharti Airtel (though at muted levels), while Vodafone Idea to continue losing subscribers," it said adding that margin improvement from revenue increase is likely to be partially offset by higher commissions, and sales and marketing cost.

The Axis report said Jio will benefit from higher subscriber addition than competi-



tors, as well as per user realisation improvement from addition of higher ARPU Jio Fiber

Festive season: Majority to shop online, 80% to look for local items

nline shopping is likely to coming festival season, as around 51 per cent consumers are likely to shop online during the period, according to a recent survey.

In the 2019 survey of 'LocalCircles', only 27 per cent of those planning festive spending had indicated using ecommerce sites as their primary channel for shopping.

"This shows that 51 per cent of those doing festive shopping this year will use ecommerce sites and apps as their primary channel, a sizable change from previous years," said the 2020 survey for festival season by LocalCircles.

Further, on the question of willingness to buy from MSMEs, small businesses, emerging brands, weavers and artisans, around 80 per cent said a definite 'yes' while only

10 per cent said 'no'. Around 10 per cent were unsure.

The survey received over 330 districts of India.

In the survey, 61 per cent consumers have indicated that they will engage in festive spending this year, a reduction from 2019 when 78 per cent consumers had indicated that they will shop during the festival season.

'When consumers in the 2020 survey were asked about the primary channel they would use for their festive shopping, in response, 26 per cent said e-commerce sites and apps, 11 per cent said they will call local retail stores and get home delivery, 25 per cent said local stores and ecommerce sites, while 24 per cent said they will visit malls, local retailers, and markets. Only 14 per cent were unsure about it," said a statement by LocalCircles.

It said that dedicated standalone microinsurance institutions can play a major role in such situations by making insurance affordable and available to low-income families, thereby providing a measure of risk mitigation and

Regulatory and Development Authority of India (IRDAI) license such businesses which can cater to the low-income segment," it said.

Recommending a cut in the capital requirement, the report said that the minimum capital requirement of Rs 100 crore stipulated under the Insurance Act has acted as the biggest impediment to the expansion of the microinsurance market.It also recommended that the risk-based capital (RBC) approach should be adopted to enable the progressive growth of the microinsurance business while maintaining the highest prudential standards. Further, microinsurance companies should be allowed to act as composite insurers to transact both life and non-life business through a single entity.

Global PC market growth breaks 10-yr record with 13% rise

The global PC market a year ago to reach 79.2 million units in the third quarter of this year, registering the highest growth the market has seen in the past 10 years, according to the latest report from Canalys.

After a weak Q1, the recovery in Q2 continued into Q3 this year in which Lenovo regained the top spot, showed data released by the analyst company. Global notebook shipments touched 64 million units -- almost as much as the record high of Q4 2011 when notebook shipments were 64.6 million -- as demand continued to surge due to second waves of Covid-19 in many countries and companies continued to invest in longer-term transitions to remote working.

Shipments of notebooks and mobile workstations grew 28.3 per cent year-on-year.

FPIs pump in net ₹1,086 cr so far in October

 $F^{\text{oreign portfolio investors}}_{\text{(FPI) have invested}} \ \ {\tilde{\textbf{1}}}_{\text{1,086}}$ crore on a net basis so far in October in Indian markets, tracking encouraging factors including improved GST collection, acceleration in economic activity and positive global cues.

According to the depositories data, overseas investors pumped in a net ₹5,245 crore into equities and withdrew ₹4,159 crore from the debt market during October 1-9. This translated into a total

net inflow of ₹1,086 crore. In September, FPIs were net sellers at ₹3,419 crore.

Harsh Jain, co-founder and COO at Groww, said that both domestic as well as global factors contributed to net inflow so far in October.

"Better than expected Q2 (earnings) performance, rising

GST collection and a general opening up of the economy are helping India in becoming an attractive investment destination," Jain said. In addition, the global

markets are performing at pre-COVID-19 levels, he added. Few of the Asian markets

like Japan, S Korea and Taiwan also saw positive FPI flows this week. The reversal of INR Vs USD from 74 to 73.1 and correction in the dollar index have been supportive for FPI flows into India," Rusmik Oza, executive vice president, head of fundamental research - PCG Kotak Securities Ltd, noted.

Going forward, continuation of accommodative stance by global central banks may ensure flow of foreign investments into emerging markets including India, said Himanshu Srivastava, associate director - manager research, Morningstar India.

Multiplexes still awaiting approval from State Govts to resume operations

Multiplexes, cinema halls and theatres have been allowed to reopen from October 15, with up to 50 per cent of their seating capacity. Standard operating procedures (SOPs) have been issued by the central government.

Though the Ministry of Home Affairs (MHA) has given its go-ahead to resuming cinema and theatre activities under Unlock 5.0, it has left for the states to take a final call in this regard. Multiplex chains including

PVR, Inox, Cinepolis and Mukta A2 Cinemas are all set to re-open their cinema halls from october 15 with half of their seating capacity while ensuring contactless operations and maintaining social distancing norms. These oper-

ators have lined up "promising contents" to entertain the audiences in the coming months.

Leading multiplex operator PVR, which operates 875 screens in 22 states, would be able to open only 496 screens as only 14 state governments have granted permission to re-open its multiplexes, according to its CEO Gautam Dutta.

The company is yet to receive any direction from the government Maharashtra, where it operates the highest number of screens. Maharashtra is an extremely important market

for us, occupying the largest

percentage of our screen share," Mexican movie theatre chain Cinepolis said the company is fully ready and would abide by the directions issued by the government.

We welcome the move from the central government. Almost 75 per cent screen of the 350 screens, which we operate in India would be open. We are requesting the other state governments to

The company is yet to receive any direction from the State Government of Maharashtra, where it operates the highest number of screens

Upon arrival at the theatre, customers will be able to self-check by scanning a QR code. Social distancing will be also be maintained during screenings, with occupancy of the cinema hall capped at 50 per cent," Puri said.

Inox will also keep PPE kits available for purchases, which would include a mask, a pair of gloves and sanitiser. It would also provide a web link to its viewers through SMS to access the food and beverage menu to place order.

Many cinema halls were closed even before the lockdown period started.

Several states including Delhi, Kerala, J&K, Maharastra etc had directed to close the cinema halls between March 11 to 16 for a temporary period, till March 31, 2020.

Later, the central government had directed a complete lockdown of the country, effective from March 25.

According to estimates, India has a total number of around 8,750 screens, in which 3,100 are in multiplexes and balance 5,650 are single screens operating mostly in small tier II, III and below cities.

Donald Trump has alleged that Democratic presidential candidate Joe Biden in his previous capacities as Senator and vice president was busy shipping jobs to China, prompting the latter to hit back.

Biden said Trump will be the first president in modern American history to "leave office with fewer jobs than when it began".

Making his first public address from Blue Room Balcony of the White House after being discharged from hospital where he was treated for COVID-19 infection, Trump charged Biden and his campaign of taking the country on the path of socialism, which he vowed would not let

"The Democrats' is a socialist program and platform -- and it really is more than socialist. It's not just socialist; it's beyond social-

As one member from the audience screamed "communist", Trump said, "Communist. That's about right."

Biden, who was campaigning in Erie city in the battleground state of Pennsylvania, on the other hand alleged that Trump was only protecting the interests of the rich and bil-

will be the first presidency in modern American history to leave office with fewer jobs than when it began. And President Trump is leaving us a 'K-shaped' recession, where those at the top keep going up, while everyone in the middle and below are seeing things get worse," Biden said.

"It means that while the top 100 billionaires in America have done pretty well, they're up more than USD 300 billion this year -- you get the bottom half of that K-shape. The downward slide. Azerbaijan, Armenia report shelling of cities despite truce

on Sunday accused Armenia of attacking large cities overnight in violation of the cease-fire deal brokered by Russia that seeks to end the worst outbreak of hostilities in the separatist Nagorno-Karabakh region.

Azerbaijani authorities said that nine civilians were killed and more than 30 others wounded after Armenian forces fired missiles at Gania, Azerbaijan's second-largest city, and hit a residential building. The city of Mingachevir also came under missile attacks, according to Azerbaijan's Prosecutor General's office.

Nagorno-Karabakh's military officials denied attacking Ganja and said the territory's army is observing the cease-fire. They added that during the night Azerbaijani forces shelled Stepanakert, the region's capital, and other towns in violation of

The recent bout of fighting between Azerbaijani and Armenian forces started Sept. 27 and left hundreds of people dead in the biggest escalation of the decades-old conflict over Nagorno-Karabakh since a separatist war there ended in 1994. The region lies in Azerbaijan but has been under control of ethnic Armenian forces backed by

The foreign ministers of Armenia and Azerbaijan signed a truce in Moscow after Russian

President Vladimir Putin had brokered it in a series of calls with Azerbaijani President Ilham Aliyev and Armenian Prime Minister Nikol Pashinian.

The ceasefire took effect at noon Saturday, after talks in Moscow that were sponsored by Russian Foreign Minister Sergey Lavrov. The deal stipulated that the ceasefire should pave the way for talks on settling the conflict.

If the truce had held, it would have marked a major diplomatic coup for Russia, which has a security pact with Armenia but also cultivated warm ties with Azerbaijan. However, minutes after the cease-fire took force, both sides accused each other of continuing attacks in violation of the deal. The situation in the region was "relatively calm" on Sunday morning, according to NagornoKarabakh leader Arayik Harutyunyan, with only minor hostilities along the front line. But it was unclear whether the calm would last, he said.

"There is no shelling of our towns and villages. At the front line, there is some shooting with the use of artillery. There are some skirmishes on the border," Harutyunyan said. "Since the morning, it seems calm, but within minutes the situation can change?

Nagorno-Karabakh's army in a statement Sunday promised a "disproportionately harsh" response if Azerbaijan "continues to violate the cease-fire." The Azerbaijani Defense Ministry said that "the political and military leadership of Armenia bears the responsibility for the aggravation of the situation in the region."

Iran-backed militias offer truce for US troop withdrawal

Baghdad (AP): Iraqi militias backed by Iran have agreed to temporarily halt attacks targeting the American presence in Iraq on the condition that US-led coalition troops withdraw from the country in line with a parliamentary resolution, three of the militia officials said Sunday.

The militia officials spoke to The Associated Press just hours after a roadside bomb targeted a convoy transporting equipment for the US-led coalition on a highway south of Baghdad, damaging one vehicle, an Iraqi army statement said.

The attack prompted questions over whether such a truce could hold across all militia factions.

Roadside bombs and especially rocket attacks targeting the US Embassy located inside the heavily fortified Green Zone in Baghdad have become a frequent occurrence and have strained ties between Baghdad and Washington.

The militia factions offered a truce and will refrain from targeting the US in Iraq, including the the US.

Embassy, on the condition that American forces withdraw ceptable timeframe said Mohamn spokesman for the powerful Iran-backed Kataib Hezbollah.

If it does not withdraw, the resistance factions will resume their military activities with all the capabilities available to them, he said. Two other factions from different Iran-backed groups echoed Mohie's comments, without specifying a length of the truce, and said it was open-ended.

They spoke on condition of anonymity because they were not authorised to give statements.

Iraqi lawmakers vote in January on a non-binding resolution to oust US-led coalition troops in the country, following a Washington-directed drone strike that killed Iranian general Qassim Soleimani and Iraqi militia commander Abu Mahdi al-Muhandis outside Baghdad's international airport.

The militia factions' comments indicate some deescalation following weeks of tensions.

The Trump administration has warned Iraq's leadership it would close the US Embassy in Baghdad if the militia groups

American officials have said that while it was a serious threat, it was not an imminent ultimatum.

China backs Iran nuclear deal, calls for new Middle East forum

Beijing: China's Foreign Minister Wang Yi has called for a new forum to defuse tensions in the Middle East after a meeting with his Iranian counterpart where he reiterated Beijing's support for Tehran.

Wang and Javid Zarif also reaffirmed their commitment to Iran's 2015 nuclear deal with world powers, according to the Chinese foreign ministry, an implicit rebuke of the United States for abandoning the accord during their Saturday meeting in China's southwestern Tengchong city.

Iran has been locked in an acrimonious relationship with Saudi Arabia, the other major Middle Eastern power, over the war in Yemen, Iranian influence in Iraq and Saudi support for Washington's sanctions on

"China proposes to build a regional multilateral dialogue platform with equal participation of all stakeholders," said the Chinese foreign ministry state-

The forum would "enhance mutual understanding through dialogue and explore political and diplomatic solutions to security issues in the Middle East", the statement added.

Wang added that support for the Iranian nuclear deal, negotiated by the Obama administration but ultimately abandoned by Donald Trump, would be a precondition of entry to the forum.

Zarif said on Twitter his "fruitful talks" with Wang amounted to a rejection of "US unilateralism" and had also focused on strategic ties and collaboration on the development of a coronavirus vaccine. AFP

KEEP THE SPIRIT ALIVE

A teenage activist from Palghar, SALONI TODKARI uses Gandhian methods to fight for the rights of children and raise social concerns. By ALKA GADGIL

he law of love could be best understood and learned through little children," believed Mahatma Gandhi who always had a special place for children in his heart. His immense belief in children has, undoubtedly, inspired generations and the values he had advocated continue to guide the young minds even today. One such young mind following the teachings of Gandhi is Maharashtra's 16-year-old Saloni Todkari.

"Non-violence is a successful strategy. It is a tool that we use to fight for our rights such as right to education and right to healthy childhood," believes Saloni who has been protesting against injustice using Gandhian methods since she was just 12

Saloni's journey into "activism" began when she had started attending the Baag Shala (garden school) of Maitrakul — a residential study centre for students run under the aegis of Chhatrashakti Sanstha. Maitrakul is an abode for children from the weaker sections who find it difficult to pursue school education due to challenging circumstances at home. Here, the children study in a local aided school. In 2014, Maitrakul boarding was established by Kishor at Bapgaon, Kalyan in Thane dis-trict realising the need for a shelter for the children coming from low-income background such as Saloni's. Originally from Virar, a town in Palghar district, Saloni convinced her mother to allow her to relocate to Thane. Her mother Manali Todkari who works as a domestic help understood her daughter's dream and helped her achieve

After moving there, Saloni started attending the local secondary school not very far from the boarding. While she was studying in Class 10th, she learnt that students wanting to appear for the Secondary School Certification (SSC) Board exam directly had to fill the form 17 exam form through a school. Although the charge for the form is ₹400, the schools were overcharging these adolescents around ₹4000-5000 per form. When Saloni noticed the exploitation, she raised the issue with the school administration but they dismissed her concerns. Looking at the administration's response, she and the fellow students decided to peacefully protest against the SSC Board.

'We tried to seek an appointment with the SSC Board officers but to no avail. We wrote several letters but didn't receive any reply. As our pleas were falling on deaf ears, we staged protests outside the board office. Even after days of protests when the board refused to act, we decided to change our strategy. We created a trophy — an effigy of a beggar with a note pasted on its torso



that read: "Since the officers don't get paid, they have turned to begging" and entered the office. We wanted to present the tro-phy to the officer but we were whisked away. Although none of the office bearers met us, the board took cognisance of our grievance and acted on the schools which ere overcharging the students for the form," remembered Saloni.

She also informed about the protocols they had followed while organising the protests. "We had informed the nearest police station about our plans. We went by the regulations and used peaceful methods for making our voices heard," explained she emphasising on the need of following the constitutional norms while organising

Known for her understanding, peaceloving and empathetic nature at the boarding, Saloni was entrusted with the responsibility of reaching out to the neighboring Katkari Wadi (Hamlet), under Maitrakul's Chiranjeevi programme. The Katkaris are an aboriginal forest tribe who continue to live in abject poverty even today. Parents go for work leaving behind young children at home. It was found that schools in and around the area had limitations in meeting their educational needs and almost no



Katkari child was enrolled in school.

When Saloni entered the hamlet, she was welcomed with mud and stones, hurled at her by older children. Saloni persisted and tried to broker a truce with the children by proposing to play games. Soon, the children were playing games with her. In a month's time, she was able to hold an exercise on alphabets with them in the Katkari Wadi. Since then, regular Baag Shala is being organised by Maitrakul activists here.

As she grows older, her grasp on social concerns especially on the challenges faced by the deprived children has also matured. On her way to school, Saloni started noticing the child beggars stalking the walkers on the street for money and food. She felt for the children who have been robbed of their right to live with dignity.

Swayed by the issue, Saloni decided to act by staging a protest outside Kalyan station. Maitrakul backed the decision as she went on to fast for three days against the insensitivity of the administration, police and public regarding child beggars. Her protest and fast against child begging attracted the attention of the administration, media and political leaders. Saloni was just 15 when she launched the agitation and fast for the cause. But how did she cope

with the pangs of hunger?

"When I decide, I act. There were friends from Maitrakul who joined my agi-tation and they took turns to fast for a day with me. When my mother came to see me, she was shocked and broken but didn't discourage me. She understood that I was doing it for a good cause and gave me her blessings," shared Saloni.

On the third and the last day of the fast,

the local corporators and members of political parties came to meet her and promised to address the child beggars' issue. The fast was undertaken in the second week of March after which the pandemic had set in. Saloni has not been able to pursue the issue of child beggars since then but she keeps the issue alive by fasting once a month. Other children at Maitrakul also join her for the cause.

'Saloni is not all agony and anguish, she's fun loving and easy going. She's a good actor and a performer. Her coordination skills are great; she plans the schedule, helps in contacting the resource persons and seeks police permission for the camps," shares Ashish Jadhav, one of the functionaries of Maitrakul.

This adolescent is one of the many young minds who are trying to keep alive the spirit of the father of the nation by walking on the path of Satyagraha and

Our request was fulfilled and now all the girls of the village go there and use the services available," adds Mausam.

Poonam Muttreja, Executive Director of Population Foundation of India is delighted with how the show has given voice to young girls and women. Says she, "I am glad that the show is impacting their lives. That is our goal precisely. Through the character of Dr Sneha Mathur, the protagonist of the series, we have initiated difficult but important conversations about sex selection, violence, gender discrimination, safe sanitation, family planning, spacing, child marriage, mental health, drug abuse, nutrition and adolescent health."

change unfold are recognising the shift in the conversation around menstruation. Community member Sangeeta Devi observes, "In the past, we used to suffer silently during menstruation. Our daughters told us about napkins. We also saw the show and felt encouraged."

The show revolves around the inspiring journey of Dr Sneha, a young doctor who leaves behind her lucrative career in Mumbai and decides to work in her village. It focusses on Sneha's crusade to ensure quality healthcare for all. Under her leadership, village women find their voices through collective action.

Over three seasons, it has dealt with various issues. The first season comprising 52 episodes discussed issues like child marriage, sex selection at birth and gender discrimination. The second season focussed on youth and adolescents. Season 3 of the show was produced with support from the REC Foundation and Bill & Melinda Gates Foundation (BMGF). The first 104 episodes were supported by DFID (UK's Department for International Development) and BMGF also supported 27 episodes of Season 2.



RISE IN MENTAL HEALTH CASES DUE TO COVID

Dublic health experts have flagged a manifold increase in mental health cases amid the Coronavirus pandemic, with many attributing the rising stress and anxiety levels to isolation, loss of loved ones, economic uncertainty and the fear of contracting the disease.

According to a survey by the World Health Organisation (WHO), the pandemic disrupted critical mental health services in 93 per cent of the countries worldwide. World Mental Health Day is observed on October 10 every year with the objective of raising awareness about mental health, global mental health education, awareness and advocacy against social stigma.

During the pandemic people have been experiencing anxiety, fear,

At a webinar hosted by Suresh Chitturi, Chairman of the International Egg Coordination Committee (IEC) along with Tim Labert, former chairman of IEC, Dr Raghav Sunil, MS Orthopaedics, and Sanjoy Mukerji, CEO, Indian Poultry Review, they discussed case studies and shared business insights about the industry during the new normal.

Suresh Chitturi noted that the egg supply chain remained strong in 2020 and even during the pandemic, egg farmers worked with gusto with their partners to deliver fresh, local, high-quality eggs in India.

PREGNANCY ISSUES MAY UP STROKE RISK

Researchers have found that pregnancy complications such as miscarriage, pre-eclampsia, diabetes in pregnancy (gestational diabetes) and pre-term birth are linked to a heightened risk of heart disease or

stroke in later life. Several other factors related to fertility and pregnancy also seem to be associated with subsequent cardiovascular disease, including starting periods early, use of combined oral contraceptives polycystic ovary syndrome, and early menopause, the study published in the journal The BMJ, reported.

However, a longer length of breastfeeding was associated with a reduced risk of cardiovascular disease.

Previous research has suggested that risk factors specific to women may be linked to cardiovascular disease and stroke but clarity on the quality of the evidence is lacking and on how the findings can be translated into public health and clinical

According to the study, published in the journal ACS Nano, injuries in which a peripheral nerve has been completely severed, such as a deep cut from an accident,

However, the surgery does not always restore function, and multiple follow-up surgeries are sometimes needed.

"The report was made by the on-field umpires according to the IPL's Suspected Illegal Bowling Action Policy. Mr Narine will be placed on the Warning List and is permitted to continue to bowl in the tournament," read a statement from the IPL. "Another report will result in Mr. Narine being suspended from bowling in the Dream11 IPL 2020 until cleared by the BCCI Suspect Bowling Action Committee," it added. In 2015, Narine served suspension from bowling in international cricket after his action was declared illegal by the ICC.
