India urges non-aggression at SCO meet

Rajnath meets his Chinese counterpart Wei at SCO Defence Ministers' conclave; they agree to resolve border differences through dialogue

PNS/AGENCIES NEW DELHI/MOSCOW

In the first signal of thawing of tension between two countries, Defence Minister Rainath Singh met his Chinese counterpart Wei Fenghe on Friday in Moscow on the sidelines of the Shanghai Cooperation Organisation (SCO) Defense Ministers' conclave. The two leaders held talks on the issue of the ongoing situation on the Line of Actual Control (LAC) in eastern Ladakh and agreed to resolve the differences through dialogue at all levels.

Till late at night, neither side issued any formal statement about the outcome of the meeting which lasted 45 minutes starting 9.30 pm IST. This was the maiden meeting between the two leaders since the stand-offs began more than four months back in early May.

It is understood that both sides consented to abide by the bilateral agreements and protocols to bring peace and tranquility at the border. The meeting came following the request of the Chinese authorities, sources said here.

Incidentally, Rajnath and Fenghe had taken part in a celebration to mark 75 years of the end of World War II and Victory Day parade in June in Moscow but did not meet each

The meeting comes even as India at the last moment pulled out of the multi-nation military exercise under the aegis of the SCO in southern Russia. The official reason for the step was corona pandemic but sources said since China was also participating in the drill, India decided not to go in the backdrop of ongoing tension at the

The 15-day long exercise begins on September 14. India had taken part in this exercise last year when China and

with his Chinese counterpart Wang Yi in Moscow. This meeting will also take place on the sideline of the External Affairs Ministers' meet under the aegis of the SCO.

Cautioning that the ongoing scenario was more serious than even 1962 recently, Jaishankar said here on Thursday in an event this was "not the easiest of times" in the bilateral relationship with China. He also said he had known the Chinese foreign minister for a long time.

Stressing the point that he was not underplaying the challenges of the LAC, the Minister,

however, said, "I am convinced that the solution to the situation has to be found in the domain of diplomacy."

Similar views were expressed by Foreign Secretary Harsh Shringla here on Friday when he said, "It is an unprecedented situation; we have never had this kind of situation since 1962. We have lost for the first time, lives of soldiers which has not happened in the last 40

He also said, "As far as we are concerned, there will be no compromise in our sovereignty & territorial integrity. At the same time, as a responsible

nation, we are always willing to talk. Our communication lines are open.

Meanwhile, earlier in the day Rajnath called for "climate of trust, cooperation and non-aggression without making any direct reference to China". He also said the need of the hour is to honour international rules and norms.

While participating in the ongoing three-day meet of Defence Ministers in Moscow, Rajnath emphasised that peaceful, stable and secure of Shanghai region Cooperation (SCO) member States — which is home to over 40 per cent of global population demands a climate of trust and cooperation, non-aggression, respect for international rules and norms, sensitivity to each other's interest and peace ful resolution of differences."

Rajnath made these points while addressing the Combined Meeting of Defence Ministers of the SCO, Collective Security Treaty Organisation (CSŤO) and Commonwealth

Independent States (CIS) Member States. China and Pakistan are members of the SCO. Rajnath also said, "If I may borrow an idea articulated by our Prime Minister in a different context, our goal should be 'Security and Growth for all in the Region."

In a day of dramatic developments that began with the raids carried out on their residences and seizure of electronic devices allegedly containing incriminating evidence, the the Narcotics Control Bureau (NCB) on Friday night arrested late Sushant Singh Raiput's house manager Samuel Miranda and actress Rhea Chakraborty's brother Showik in connection with a drug case registered in connection with the Sushant death case.

After the day-long questioning during which they allegedly confessed to having procured drugs for late Sushant, Showik and Samuel were booked under various relevant sections of law for drug procurement and abuse.

next year. WHO WHO spokeswoman Margaret Harris said none of the candidate vaccines in advanced clinical trials so far has shown a clear signal of effi-

cacy at the level of at least 50%. "We are really not expecting to see widespread vaccination until the middle of next year," Harris told a UN briefing in Geneva

'This phase 3 must take longer because we need to see how truly protective the vac-cine is and we also need to see how safe it is," Harris added.

A fter adding half-a-million cases in just one week, India on Friday crossed the four-million Covid-19 count and raced towards replacing Brazil from the second spot.

India has been adding

more than 75,000 new cases and around 1,000 death every day in the last three weeks. The last few days saw the country crossing 80,000 Covid cases daily, which is nearly 35,000-40,000 cases more than that of the USA and Brazil on a daily

India is now just around one lakh cases behind Brazil, which is the second worstaffected country after the USA. With the rate of infection wildly moving up, India should be able to pip Brazil to the second

SC rejects plea to review its order on holding JEE, NEET

The Supreme Court on Friday dismissed the pleas, including the one filed by Ministers of six Opposition-ruled States, seeking review of its August 17 order which paved the way for holding NEET and IEE. NEET and JEE.

A bench of Justices Ashok Bhushan, BR Gavai and Krishna Murari, which considered the pleas in-chamber, said there was "no merit" in the review petitions. The SC also rejected the applications seeking listing of the review petition in the open court.

"Applications seeking permission to file review petitions are allowed. We have carefully gone through the review petitions and the connected papers. We find no merit in the review petitions and the same are accordingly dismissed," the bench said in its order.



National Testing Agency (NTA) which conducts both the exams is holding JEE Main from September 1-6, while NEET will be held on September 13.

The review matters in the apex court are usually considered "in-chambers" through circulation of petition among the judges of the bench. The judges then decide "in-chambers" whether there is any merit in the review petition to re-examine the case in open court hearing.

SC rejects Sajjan Kumar's plea for interim bail on health ground

Friday dismissed the plea of former Congress leader Sajjan Kumar, who is serving life imprisonment in an 1984 anti-Sikh riots case, seeking interim bail on health grounds.

"Sorry. We are not inclined. Dismissed," a bench headed by Chief Justice S A Bobde said. Senior advocate Vikas imposed by the court. Singh, appearing for Kumar, argued that interim bail be granted to Kumar on health grounds as he has been in jail for 20 months, has lost nearly 16 kg weight and needs to recover from past ailments. Singh said Kumar would abide by all the conditions which would be

Senior advocate H S Phoolka, who has been appearing for some of the riots victims, opposed the plea and said the required treatment is already being given to Kumar at hospi tal."We will hear you finally someday but cannot grant you bail like this," said the bench,

sentenced Kumar to imprisonment for "remainder of his natural life" in the case saying the riots were a "crime against humanity" perpetrated by those who enjoyed "political patronage" and aided by an "indifferent" law enforcement agency.

The investigations should be in the context of the fact that Rhea, Showik and Miranda were among the closest to actor Sushant Singh Rajput, who allegedly committed suicide by hanging himself to a ceiling fan in his closed room of a duplex flat at Mont Blanc building at Bandra's Carter Road on

During her interviews with television channels, Rhea had claimed that Sushant used to smoke marijuana.

The investigations by the NCB are focused on the procurement of the contraband and supply to the 34-year-old Sushant.

Meanwhile, Abdel Basit Parihar, an alleged drug peddler, has been remanded in NCB custody till September 9. Parihar was made to join the

investigation based on Zaid Vilatra's interrogation. Both Basit and Zaid are understood to be involved in the alleged drug peddling and supplying contraband to high-profile peo-

On his part, Sushant's father Krishna Kishore Singh has blamed the former's live-in partner Rhea Chakraborty behind the death of the actor.

During the raids, digital devices of Showik and Miranda were checked. The WhatsApp chats of Showik, Rhea and Miranda, accessed by the Enforcement Directorate (ED) and passed onto the NCB, had earlier revealed the drug angle in the Sushant Singh Rajput deadth case.

In a related development, Sushant's sister Shweta Singh Kirti tweeted: "Good going NCB... Thank You God."

On Thursday, a Mumbai court had remanded an alleged contraband dealer Zaid Vaitra (21), who has been arrested in connection with the drugs trafficking case linked to the case of actor Sushant Singh Rajput's death, in the custody of the Narcotics Control Bureau (NCB) till September 9.

The NCB had said on Wednesday it had arrested Vilatra and one Basit Parihar in connection with the Sushant death-linked drug trafficking

"We have recovered Indian currency worth Rs 9,55,750 and foreign currency (USD 2,081, 180 British Pounds, 15 dirhams), which the NCB claimed are "proceeds of drug peddling", were recovered from Vilatra," a NCB official had

Zaid runs an eatery at Bandra in north-west Mumbai which, he said, the NCB was not giving any pecuniary gains since lockdown. The NCB official said Zaid

was allegedly into drug peddling, especially bud, through which he used to earn a substantial amount of money. A resident of suburban

Bandra, Parihar is "learnt to have linkages" with the narcotics case registered against Rajput's girlfriend and actress Rhea Chakraborty and others, officials said.

The role of Rhea's brother Showik Chakraborty and his purported links with people nabbed by NCB are under the

Rhea, her parents Indrajit and Sandhya Chakraborty, her brother Showik, Sushaant's exmanager Shruti Manager Shruti Modi and others have been named in an FIR lodged by the actor's father KK Singh with Rajiv Nagar police station in Patna. It was on the basis of this FIR that the Supreme Court ordered the transfer of the Sushant Singh Rajput death case to the CBI on August 19.

Rhea, her parents, her brother and others have been booked as part of this FIR under sections 341 (wrongful restraint) 342 (wrongful confinement, 380 (theft), 406 (breach of trust),420 (cheating), 306 (abetting suicide) and 120-B (conspiracy) of the Indian Penal Code. The CBI, ED and NCB are investigating the case from different angles.

Cops go into tizzy after hoax call of terrorist in Gorakhnath temple

Gorakhpur: Police went into a tizzy after they received a phone call, which later proved hoax, that a terrorist had entered the famous Gorakhnath temple here.Uttar Pradesh Chief Minister Yogi Adityanath is the head priest of the temple.

After getting the call on Thursday night, the police swung into action and SP City Kaustibh along with CO Gorakhnath Ratnesh Singh led a strong force to search the entire temple. But they did not find any suspicious thing or man inside or outside the temple, the police said here on

They said someone from the Bansgaon area informed the police control room over the phone around 10 pm on Thursday about the presence of

a terrorist in the temple. However, his family members told the police that he was suffering from mental dis-

"With a dog and bomb squad the entire Gorakhnath temple was searched and after watching CCTV footage and also asking people, no suspicious thing or man was found. With the help of surveillance, police traced that Shivendra Pratap Singh of Bedouli village under Bansgaon police station trol room and gave fake information about the terrorist," the CO said.

'The man was not found at home and his family claims that he is under treatment for mental disease for the last 10 years. Police are investigating the claim of his family," he added.

The Gorakhnath temple is a temple of the Nath monastic order group of the Nath tradition. The name is derived from medieval Gorakshanath, a yogi who travelled widely across India and authored a number of texts that form a part of the canon of Nath Sampradaya.

Referring to the threats faced by the world, Rajnath said, "We need the institutional capacity to deal with both traditional and non-traditional threats - above all, terrorism, drug-trafficking and transnational crime. As you all are aware, India unequivocally condemns terrorism in all forms and manifestations and condemns its proponents. India values the works of SCO Regional Anti-Terrorism Structure (RATS). We laud RATS' recent work in the cyber domain to prevent the spread of radicalism and extremism. The adoption of anti-terror measures by the SCO Council to counter extremist propaganda and de-radicalisation is a significant decision."

He reaffirmed India's commitment to the evolution of a global security architecture which will be open, transparent, inclusive, rule-based and anchored in international laws. Rajnath is on an official visit to Moscow from September 3-5 at the invitation of Russia Defence Minister General Sergei Shoigu.

The bypolls were scheduled to be held earlier this year. But they had to be deferred due to Covid-19 pandemic situation.

The vacant Assembly seats include 27 in the Madhya Pradesh Assembly, after former Congress leader Jyotiraditya Scindia and the MLAs supporting him quit the party and their posts as legislators in

March this year. Besides Madhya Pradesh, bypolls in eight seats in the Gujarat Assembly are pending as well. However, increasing patients from outside Delhi is a cause of big concern for the state government. Sources in Delhi government said that 33 percent of the beds have been occupied by people outside of Delhi. Moreover, in private hospitals 70 percent beds are occupied by outside patients.


Delhi government's response came as the National Capital recorded its highest single day increase in coronavirus cases in 67 days.

According to State (Delhi) Heath Department, out of 14,000 beds in Delhi, around 4,500 are occupied of which 1,500 (33%) are occupied by those outside Delhi.

A senior government official said, "Around 4,500 beds are occupied at present and out of it, 1,500 are occupied by those outside Delhi. "Nearly 70percent of beds in Delhi are still vacant. Only 3 of the 131 Covid hospitals (private and government) are full. There's no shortage of beds right now but increasing number of patients from outside Delhi is

worrying".

With metro services resuming on September 7, the Gurugram district administration will appoint a nodal officer who will be in touch with Delhi Metro Rail Corporation (DMRC) officials in order to facilitate metro

operations in the city.

The DMRC had halted Metro services during the nationwide lockdown in view of the coronavirus pandemic.
The DMRC has five metro

stations in Gurugram. These are Huda City Centre, Iffco Chowk, MG Road, Sikenderpur and Guru Dronacharya metro stations.

"For smooth operation of the Delhi Metro we have decided to appoint a nodal officer who will remain in touch with Metro officials for smooth metro functional in Gurugram," said Amit Khatri, deputy commissioner of

The deputy commissioner further stated that the DMRC should formulate a plan to divide the crowd at different levels so that the passengers do not gather at any one place.

An adequate number of teams should be installed at the

Metro station for the thermal scanning of passengers.

He further said steps would also be taken so that autos and rickshaws outside stations are regulated in a proper manner and the commuters do not face any problem in last mile connectivity.

Virender Yadav, civil surgeon, Gurugram, said that the health department will provide a list of all health centres that are near the five metro stations in the city. "If any passenger shows flu-like symptoms, they can be sent immediately to the public health centre," said

Necessary arrangements have been made to ensure that passengers do not gather at one place at the Metro station. Also, passengers should try not to stand at the station for much longer.

Speaking about DMRC preparations, Rishabh Singh, Assistant Manager of DMRC said, "Passengers will be thermal scanned at the time of entry in the station premises. Travelers who show signs of coronavirus infection will be referred to the nearest health center or COVID-19 hospital".

Doctor, aide held for giving forged Covid test reports of the diagnostic centre that no test reports to more than 75

The Delhi Police has arrest-■ ed a 34-year-old doctor and his associate for allegedly providing forged Covid-19 test reports to people in the national Capital. Police said that the doctor had given forged Covid-19 test reports to more than 75 patients using names of several diagnostic centres in the

The accused have been Parashar, a resident of Malviya Nagar, and his associate Amit Singh.

According to Atul Kumar the Deputy Thakur, Commissioner of Police (DCP), South district, a complaint was received from a reputed testing lab regarding forgery of

COVID-19 test reports, following which a case under relevant sections of Indian Penal Code (IPC) was registered at Hauz Khas police station. "On August 30, one person,

who runs a business of providing nursing staff to patients, asked doctor Parashar for COVID-19 test reports of his two nursing staff before they were engaged in the job," said the DCP.

"Parashar forged the reports and sent them to the businessman who, in turn, sent it to his client on her mobile. Spotting a mistake in the name in the report, the client contacted the diagnostic centre and asked for a new report with

correction," said the DCP. "On verifying the details of the patients, it came to notice

such patient exists in their record. Later, a case was registered at Hauz Khas police station. The accused were arrested on Thursday," said the DCP.

"During interrogation, it was revealed that Parashar used to recommend patients for COVID-19 tests and collect the sample. With the help of coaccused Singh, he used to make forged test report of the renowned diagnostic centre or of the labs as desired by the patients," said the DCP.

"As the reports were prepared in PDF format on a computer and same were sent to patients on WhatsApp, it was difficult to differentiate between the forged and the genuine report. Parashar admitted that he had given forged COVID-19 patients using names of diagnostic centres such as CRI Diagnostics Lab, Modern Diagnostics and Research Centre, Dr P Bhasin Pathlabs (P) Ltd and Prognosis Laboratories," said the DCP. "Parashar also told police

Don't be Singhams, be yourself: PM to IPS officers

Prime Minister Narendra Modi on Friday had a word of caution for young IPS probationers: Don't fall for creating a filmy Singham-like image for yourself, rather respect your job and show the human face inside your khaki uniform.

Interacting virtually with the 2018 batch IPS probationers during the "Dikshant Parade Event" at the Sardar Vallabhbhai Patel National Police Academy in Hyderabad, the Prime Minister said, "Some policemen who join new duty want to first show-off ... Scare people... And anti-social elements should shiver from hearing my name itself.... After watching films like

'Singham', it gets over their mind and because of it those works which need to be done get missed out."

He counselled them not to be influenced by films that portray supercops, saying some police personnel want to first show-off but miss out on main aspects of policing.

Yours is a profession where the factor of encountering something unexpected is very high and all of you must be alert and prepared for this. There is a higher degree of stress and which is why it is important to keep speaking with your near and dear ones. From time to time, maybe on a day off, meet someone like a teacher or some-one whose advice you value,"

PM Modi said detailing the ideal work culture and need of good policing. He told the women officers

to engage with mothers of children in Jammu & Kashmir to prevent the youngsters from taking the "wrong path". Responding to a woman probationer, Modi heaped praise on the people of Kashmir, saying they are 'lovely' people and having special ability to

learn new things.

"All of us together, we have to work towards stopping the children from taking a wrong direction. And this can be done by our women police officers efficiently. Our women force can effectively work in educating the mothers and bringing

back those children. I am confident if you do that, in the initial stage itself we can prevent our children from getting into

the wrong path," Modi said. As many as 131 probationers, including 28 women, of the IPS 2018 batch successfully completed their training in the academy. Kiran Shruti DV, the best all-round probationer of the batch, led the parade. Union Home Minister Amit Shah, MoS G Kishen Reddy and Home Secretary, Ajay Bhalla also attended the conference.

Shah encouraged the young IPS probationers to be proud of being part of a service that is continuously working to ensure safety and security of the people.

Covid recoveries cross 30-L mark

■ndia on Friday crossed a positive **⊥**milestone as its total Covid-19 recoveries crossed the 30-lakh mark. With it, the country's recovery rate has now gone past 77 per cent, which the Union Health Ministry showcased as a positive sign even as it asserted that India's fatality rate was lower than the global average and only a minuscule percentage of patients were on ventilator support.

One of the goals of the 'Test-Track-Treat' strategy of the Centre is to reduce Covid mortality and keep the case fatality rate low, the ministry said in a statement. There has been sharp attention on

sustaining high levels of recoveries and to strengthen the clinical treatment protocols to provide a uniform standardised level of medical care to save lives, it said.

"Not only is India's case fatality rate lower than the global average and progressively declining (current figure is 1.74 per cent), but a very small proportion of active cases, amounting to less than 0.5 per cent, are on ventilator support," the ministry said.

As a result of these measures, India's total Covid-19 recoveries crossed 30 lakh (30,37,151) on Friday. With the recovery of 66,659 patients in the last 24 hours, India has

continued its trajectory of posting more than 60,000 recoveries for the eighth consecutive day, the ministry said. The recovery rate amongst Covid-19 patients is 77.15 per cent demon-

strating that the number of patients

recovering is steadily rising over the past several months, it said. The higher number of recoveries has also led to a steady enhancement in the difference between the recovered and active cases, and this differ-

ence has crossed 22 lakh, as on date. This ensured that the actual caseload of the country (8,31,124 which are under active medical care). has reduced and currently comprises only 21.11 per cent of the total positive cases.

Congress hits out at Centre over poverty, unemployment rate

Kharif sowing touches new record

As on Friday, the total Kharif crops sowing was reported at 1,095.38 lakh hectares against 1,030.32 lakh hectares during the corresponding period last year - an increase by over 6.32 per cent. This is despite the fact 5-6 lakh hectare crops have been reportedly damaged due to floods in 11 States. The previ-2016 when farmers had sown

Kharif crops in a total area of 1,075.71 lakh hectare. According to Union

Agriculture Minister Narendra Singh Tomar, there was no impact of Covid-19 on progress of area coverage under kharif crops as on date. This is expected to increase further as the sowing of paddy and other crops are still going on. The final sowing figures for the current kharif season will be closed on October 2. Kharif sowing begins with the onset of southwest monsoon from June and har-

vesting from October onwards. As per the Government data, agriculture growth in the ous record was achieved in first quarter of 2019-20 was 3.4 per cent at constant prices.

However, the growth, driven largely by a bumper rabi harvest and facilitated by relaxation in lockdown, may not have resulted in a big rise in income for a section of farmers. India's rabi production in the 2019-20 crop year (July to June) is estimated to be around

149.60 million tonnes, 4.10

per cent more than the previ-

ous vear.

As per the data, total area sown to rice has increased by 8.27 per cent to 396.18 lakh hectare so far in the current kharif season from 365.92 lakh hectare in the year-ago.

There has been a substantial increase in planting of paddy in many States that

received bountiful rains so far like Telangana, Madhya Pradesh, Bihar and Jharkhand. Among the other States that have planted paddy in more area are West Bengal, Odisha and Karnataka compared to same period last year. Surprisingly, the paddy area in Punjab has come down by 1.78 lakh hectares from the last kharif season.

Area under pulses has increased by 4.67 per cent to 136.79 lakh hectare as against 130.68 lakh hectare, while that of area sown to coarse cereals increased by 1.77 per cent to 179.36 lakh hectare area as against 176.25 lakh hectare in the year-ago.

Will talks work?

While Rajnath Singh shared a platform with his Chinese counterpart in Moscow, the border is still hot. India must not budge




hina had probably not anticipated that India would continue with its robust defense. Actual Control (LAC) instead of blinking after Galwan. Or that it would need to pump in more resources and troops in Ladakh, where it has so far used perceptional differences on what should be the border on the ground to usurp land. It certainly had not bargained for India ramping up its border infrastructure and its soldiers meeting it eye to eye in mountain warfare. Or expected its unilateral adventurism to be challenged. But more importantly, it realises that an Asian split between its top two powers would only damage it strategically, politi-

cally and economically. And that its imperial dream of Asian domination would be unrealised if India increasingly gravitates towards the US and the West, pushing the world to unipolarity. Already, the combined Indo-US strategy to challenge Chinese access to their technology market is a precursor of a longer-term hit on its digital monopoly. And if China doesn't have a transactional relationship with India and engages with it somewhat, then it would be difficult for it to convince smaller Central and Southeast Asian nations to accept its overlordship in the region. Already some of these nations are part of the US-India axis in stalling Beijing's designs in the Pacific. Perhaps that explains why the Chinese side conveyed its keenness to have a meeting with India on the sidelines of the Shanghai Cooperation Organisation (SCO) session in Moscow. And following the ban on Chinese applications, its spokesmen struck a reconciliatory note and resorted to soft diplomacy, referring to the cultural assimilation that has seen Rabindranath Tagore, yoga and Bollywood occupy centrality in Chinese life. The SCO provided the platform for Defence Minister Rajnath Singh's first meeting with his counterpart Wei Fenghi after the Ladakh standoff. And though India has emphasised that it would like to settle the border issue within the framework of diplomacy and dialogue, the fact that Chinese troops are still stationed within our artillery range in the south of Pangong Tso should remind us that the dragon still has a forked tongue and can spew fire. Singh, of course, set the tenor at the ministerial meeting itself, saying non-aggression and trust were the key to regional peace and stability. Clearly, the message is it cannot be business as usual.

Perhaps China is hoping that this heavy duty presence and its continued aggressive pile-up along the LAC would compel India to cede some ground at the talks table. Its rhetoric that India is being provocative points to an assumption that its presence there has always been legitimate, though this has never been a point of dispute since the 1962 war. It has now significantly enhanced its presence in the Depsang area, closer to the Daulat Beg Oldie airstrip. This shows that the Chinese will never reconcile to losing the strategic advantage in Ladakh because of the DSDBO road that allows India troop parity in this sector. Besides, China wouldn't want the Indian shadow over the Karakoram, particularly between Gilgit-Baltistan in the west (Pakistan-occupied Kashmir), where China is heavily invested in the China-Pakistan Economic Corridor (CPEC), and Aksai Chin in the east. So India must stay the course and insist on status quo ante. Post-Galwan, it has already yielded some ground by agreeing to pull back from old observation posts and creating a buffer zone. This would let the Chinese mobilise easily unmonitored. The 1993 agreement signed during the Narasimha Rao-Jiang Zemin era made it absolutely clear that both sides would scale down troops at the LAC to a "minimum level" as a confidence-building measure and strengthen bilateral ties by looking beyond the boundary arc. That has only resulted in our trade dependency on China without any let-up in its hegemonic intentions. India is already more vigilant in the Indian Ocean region, with our Navy watching every movement along the Malacca Straits, a key strategic and economic transit corridor for China. It has got more active in the Quad initiative with US and Japan and begun using its international goodwill as a nation that respects "rule-based order" to build a case against China's "wolf warrior" tactics. And it must add the boundary question to negotiations, insist on marking the LAC on the ground. We must also join the global chorus against Tibet or Xinjiang, something that riles up China no end and could be used as a bargaining chip. This counterweight would work better than just relying on the US, which beyond the point of internationalising an issue, wouldn't stay invested as it is too remote for its domestic concerns. Russia, which wants the SCO to work, so that it can fob off the preponderance of the US and the West, is compromised by heavy Chinese investment in its infrastructure and gas lines. It does need India to counterbalance itself against Chinese heft but cannot force China's hand on the border issue. Already, it has classified the standoff as a matter of bilateral concern between both countries. Russia is keeping itself updated about the sensitivities involved and the fact that Singh decided to attend the RIC meeting and the Moscow Victory Parade despite the COVID pandemic is indication of the strategic depth India attaches to Russia. The latter acknowledges India's insistence on sticking to defence deals despite US pressure. Will it be able to convince China about a need for status quo in the interest of a multi-polar world? A tall order really. India needs to watch out for its own interest.

n men's tennis, discussions around who is the "Greatest Of All Time", the so-called "GOAT", can become very animated between supporters of Roger Federer and Rafael Nadal. In women's tennis on the other hand, there is no competition. Serena Williams stands heads and shoulders above players from not only her generation but also the likes of Steffi Graf and Martina Navratilova from years past. It would not be a stretch to say that Williams is one of the greatest sportspersons of all time with only the likes of Michael Phelps and Lionel Messi for competition. And keeping her competitive nature going even after

becoming a mother is remarkable. Although the Belgian ace Justine Henin was the first "mother" to win a Grand Slam in the modern era, she did so at a time when for a female athlete, getting pregnant was a signal to retire. But now, Serena, Victoria Azarenka and Tsvetana Pironkova, all post-partum athletes, have marched into the next round of the US Open tennis tournament, the first major post-Covid tournament in that sport, proving that women, just like men, are extending the prime of their careers and even "post-prime" by being more selective about where and how often they play. Our own Sania Mirza won the Hobart doubles title after having a baby. And boxer Mary Kom set new records post-motherhood in a high-performance sport. Gone are the days when women's tennis was about a succession of lissome teenage blondes from the erstwhile Soviet bloc nations. Today's players are older, stronger and will not let marriage (or divorce) and motherhood stop their success.

But as discussed on these pages earlier, how will an increasing number of older athletes staying on in their sports, irrespective of gender and sport, from tennis to even cricket, impact up and coming stars. Of course, the best will still shine through but sports is reflecting the realities of modern life. Model Padma Lakshmi celebrated her 50th birthday recently by announcing that the 50s were the new 30s. This, however, should create opportunities for more leagues and more sports across the board. But we will also see more and more mothers competing in top-flight sports; no longer is having a baby considered the end of any career, whether in movies or in sports. And players like Serena Williams should be an inspiration not just to other mothers but women of all ages.

Harvest of domination

Humankind has identified progress with mastery over nature. It destroyed and subordinated nature at will. COVID-19 is just one manifestation of this horror

ne does not quite know what the shape of the world will be after the COVID-19 pandemic is over. The several informed speculations at hand — including the one that it would eventually be like it was may or may not come true. The only thing that is reasonably certain is that the virus COVID-19 emerged in bats, infected another animal and, through it, humans. By all accounts, the infection among humans began to spread from a market selling live animals in Wuhan, China. It is also widely known that viruses breed and spread in the unbelievably over-crowded and insanitary conditions in which animals are kept there, with some of them -COVID-19, for example — transmuting themselves and becoming capable of infecting humans.

Two things are important to note. First, COVID-19 is not the only virus originating in animals and affecting humans. Other deadly diseases include Ebola, which belongs to the category of filoviruses or thread viruses and includes three sub-types of Ebola viruses and one known as Marburg. Named after Ebola River, which meanders through northern Zaire in Africa, it first emerged in 1976 in 55 villages near the banks. Fruit bats are believed to be its natural carriers. The virus, which spreads through human to human contact, is a killer; the death rate so far has been 88 per cent of those infected. As the disease progresses, persistent fever is followed by a strange combination of haemorrhaging and blood clotting all over the body, especially in the spleen, liver and brain, in what is known as disseminated intravascular coagulation. Death comes from haemorrhaging and shock.

Severe Acute Respiratory Syndrome (SARS), Middle-East Respiratory Syndrome (MERS), and West Nile Virus have also originated in animals. SARS coronavirus emerged in China's Guangdong province in 2002. First identified in 2003, it most probably originated in bats and then spread to other animals like civet cats before cases of the disease in the 2003 epidemic, which affected 26 countries. Transmitted from person to person, its symptoms are similar to those of influenza — fever, muscle pain, headache, diarrhoea and shivering. Subsequently, there can also be coughing and shortness of breath.

Dromedary or Asian or Arabian camels are a major repository of MERS Coronavirus or MERS-Cov which spreads through human-to-human transmission. Fever, cough, shortness of breath are among its symptoms, as is diarrhoea. Patients often develop pneumonia. Birds, particularly crows, are the natural hosts of West Nile Virus which causes neurological diseases that can be fatal. It is commonly found in Africa, Middle East, North America, Europe and West Asia and spreads though infected mosquitoes biting humans. Eighty per cent of the peotion benefiting humans.

ple infected by the West Nile Virus do not show any symptoms. About one-fifth of the infected develop fever and headache, body ache, vomiting, diarrhoea and or rash. Less than one per cent of those infected develop illnesses like encephalitis or meningitis involving inflammation of the brain. Apart from the symptoms described above, those seriously ill suffer from stiff neck, tremors, vision loss, numbness and paralysis.

Rabies, originating among other species, in dogs and monthrough vaccination, is perhaps the most talked about of the number of zoonotic diseases affecting humans. The question is, how do these come to infect people? While transmission modes may differ, the basic circumstance is proximity to animals who are "hosts" to the viruses concerned. The nature of this proximity is influenced by the way that most humans regard animals, which is that they can be treated any way people like they can be killed for fun as in the criminal activity that goes by the name of hunting, for food, savagely hurt in the name of fun bull fights in Spain, Jallikattu in parts of South India, or cockfights and dogfights in many parts of the world. They are made to pull or carry heavy loads that make them stagger and undergo horrendous suffering in the name of medical experimenta-

Of course, animals are not the only living beings that humans treat horribly. We treat the whole of nature, of which animals are a part, in the most cruel and exploitative manner. The worst victims are plants which are feeling, communicating, mutually caring and benevolent living beings that need to be treated with respect, and forests, which provide a wide range of environmental benefits, including attracting rainfall and preventing soil erosion. They are, however, casually felled in India prises and coalfields when coal, a highly polluting source of energy, is increasingly in disuse everywhere.

Underlying such conduct is not only callousness but sadism, to which animals can be subjected without attracting the kind of condemnation and punishment that similar action towards humans do. True, humans treat other humans too in pretty awful ways. Otherwise, there would not be crimes like slavery and incarceration in concentration camps but murder and genocide. Nevertheless, as often as not, perpetrators of such crimes against ĥumans are punished. Mussolini was shot while on the run; Hitler had to commit suicide. Several German perpetrators of war crimes and crimes against humanity during World War II were brought to justice at the Nuremburg trials. More recently, most perpetrators of war crimes during Bangladesh's Liberation War in 1971 have been sentenced, a few to death.

No murderer of a tree or the perpetrator of the genocide of a forest has been given similar punishment. This is because trees, forests and the rest of nature, including other nonhuman living beings, are generally held to be existing for human convenience alone and, hence, have been put outside the universe of morality that people have created for themselves. Thus, while the punishment for killing killing an animal is a fine and a laughably short stint in jail.

The attitude towards nature described above has been compounded by the adversarial view of it that emerged during the long struggle for human survival and progress, which included the establishment of human settlements and farms for food, the domestication of animals, use of the latter in wars, controlling of rivers for irrigation and floodprevention. The result of all this has doubtless been the enormous material progress witnessed from the emergence of the initial tribal communities to the establishment of the complex modern civilisations of the information age. This in turn has led to the identification of progress with mastery over nature. The latter was not the matrix to live in harmony with but to be destroyed and subordinated at will.

What was forgotten in the process was that humankind emerged from the cradle of nature, which included all nonhuman living beings as well, and has existed in the supportive environment provided by it. Destruction — even severe damage to the latter — could threaten its very existence. The devastating effects of climate change, including extinction of species, and the cyclones and tidal waves that are increasingly playing havoc, are widely known. Now the abominable conditions existing in Wuhan's live animal mar-19 virus on humans. This is unlikely to be the last zoonotic or natural calamity visiting our world. There will be others, and perhaps even more catastrophc, if we do not mend our ways.

China schooling the Mongols

There is a growing sense of insecurity in the ruling elite that makes it impatient to stamp out differences and deviations from the norm



esidential schools were a common feature of European settler societies (except New Zealand) until quite late in the 20th century, and their purpose was not just to educate but to "deracinate" their aboriginal pupils: That is, to cut them off from their roots. The Chinese Government would reject the analogy with its last breath, but it is now doing the same thing. Last week, in China's Inner Mongolian Autonomous Region, ethnic Mongolian parents began holding rallies and keeping their children home from school in protest against new measures to reduce teaching in the Mongolian language in favour of Chinese. Under the new rules, history, politics, language and literature will be taught in Mandarin Chinese, not in Mongolian.

It has not been reported in the Chinese media, of course, but the BBC reports that students at one demonstration chanted "Our language is Mongolia and our homeland is Mongolia forever!" At another school, only 40 students registered for the autumn term instead of the usual 1,000 — and most of them left after the first day. It should be noted that in Inner Mongolia, ethnic Chinese (Han) people are a four-fifths majority of the 25 million residents. The province is beyond the Great Wall and was once almost entirely Mongolian, but it was already majority Han before the current Chinese Communist regime came to power in 1949.

Most of China's five million Mongols are concentrated in three eastern districts of Inner Mongolia, but even there they are not a majority of the population — and many of these Mongolian-speakers are urbanised people who are fully bilingual and intermarry freely with their ethnic Chinese neighbours. The core of the unrest is among the million or so who still pursue a modified version of the old "nomadic" culture. They are the traditional Steppe-dwelling people who follow their herds on horseback or in all-terrain vehicles through their seasonal rounds. Unlike aboriginal languages, Mongolian has been written in its own script for many centuries, and Genghis Khan's empire once briefly ruled about a quarter of the world, but the "nomadic" Mongols do depend on boarding schools

Such schools are simply a practical necessity for people who live in small groups and move frequently, and in the Chinese case, they were not originally conceived as instruments of cultural genocide. Until recently, in fact, they operated entirely in Mongolian, with Chinese taught as a second language. The Chinese policy towards "tribal" minorities has traditionally been more tolerant than the US or Canadian policy towards native Red Indians, the Australian policy towards Aborigines, the Scandinavian policy towards Sami (Lapps) or the Russian policy towards Siberian native peoples. All of those unlucky people got the kind of residential schools that aimed at cultural assimilation and religious conversion.

The children spent most of the year in boarding schools, not with their families. They were taught the religion of the settlers, not that of their native culture. They were forced to use the language of the dominant European group and forbidden to speak their own. And most of them were subjected to violence. (Yes, most.) Many of the adults who emerged from this ordeal were tormented men and women, and their legacy of alcoholism, drug abuse, child abuse, nihilism and despair is still being passed down the generations. Nothing of the sort has happened to the Mongols of Inner Mongolia, so far as is known but something bad is starting to happen to them now. The Chinese culture has always been patronising towards the minorities living within China's borders, but it didn't usually see them as threats. They aren't threats now, either, but there is a growing sense of insecurity in the ruling elite that makes it impatient to stamp out differences and deviations from the norm. You can see it in Tibet, where the screws have been turned so tight on dissent that more than a 100 people have burned themselves to death in protests since 2009. You cannot avoid seeing it in Xinjiang, where more than a million Uyghurs have been sent to concentration camps that operate like residential schools for adults, trying to separate the residents from their religion, language and values.

And you can detect it in a minor key even in Inner Mongolia, in a needless, destabilising attempt to force Mandarin down the throats of loyal, innocent people who pose no threat whatever to the State. What drives President-for-Life Xi Jinping and his advisers to such ridiculous and counter-productive extremes? The only plausible answer is fear that history will repeat itself. China's rulers are all Communists in theory (though how many still really believe it is another matter), and so they rightly worry that what happened the communist parties of Europe in 1989 could also happen to them. However, two years after that the Soviet Union broke up as well. It's really unlikely that China will ever do the same, because more than 90 per cent of the

population is ethnic Chinese, but the guilty flee where none pursue. (Gwynne Dyer's new book is 'Growing Pains: The Future of Democracy and Work.')

The gift of autonomy

Today the educationally best performing nations have no Govt interference in schooling. India needs this, too, if we are to compete globally

deachers are the fulcrum around which any progressive and vibrant society moves. Look at countries and compare their rate of growth and the scale of teachers' status in the society; it will be apparent that both go up and down together. India had a great guru-shishya parampara and teachers were highly revered by the students and civil society. Respect for teachers was not ornamental but real in those days. The educators were revered in the true sense as even the king would not take decisions without the consent of the Raj Guru.

Even though the Raj Guru is often depicted as a poor person in popular culture, the king would invariably receive the guru by standing up from his seat. The teacher in turn would often visit the king's court in moments of crisis to counsel the ruler. Sadly, those days are long gone.

We need to understand today as to why the judgement of teachers was final in the days of yore. To be precise, the objective of the king (or in today's parlance the politician) is to remain in power. Similarly, the aim of the common people is to be rich or famous or powerful. However, the objective of a teacher is nothing but to see his/her students grow and achieve what they aspire to. This is the only profession where the individual works not for oneself but for other people's growth and success and derives pleasure in the attainments and achievements of the students whom s/he teaches. However, to expect such dedication we, too, must have complete trust in teachers and grant autonomy in pedagogic activities; as individuals and as a system.

In India, we celebrate Teachers' Day on the birth anniversary of Dr Sarvepalli Radhakrishnan, a scholar of philosophy and a great teacher loved by all who had the good fortune to be taught by him. Radhakrishnan taught Indian philosophy and religion at many British and Indian universities. He later joined the freedom struggle, because he believed that to serve a foreign rule was "irreligious" or *adharm* in the Hindu tradition.

Radhakrishnan pursued his study of Indian philosophy while continuing to make his continuin tribution to the freedom struggle. He was in a relentless search for the ultimate truth, which he believed was the pursuit of every Hindu scholar i.e. Sa Vidya Ya Vimuktaye (attaining salvation Radhakrishnan became the Vice-Chancellor of the prestigious Banaras Hindu University on the invitation of Pandit Madan Mohan Malviya to succeed him in 1938. It was a position that Radhakrishnan occupied till 1948. Once India became independent, Radhakrishnan became the chairman of the first commission on education to be set up to revamp the higher education system of the country.

The report presented by him is popularly known as the Radhakrishnan Commission Report. It is a comprehensive one but today it is vital to remember that this report stressed on the importance of education being grounded in the Indian tradition. The Radhakrishnan Commission Report was also of the view that school education must be given emphasis and revamped so that deserving students could enter higher education institutions.

This Teachers' Day has special significance

for us all. The Narendra Modi Government issued its New Education Policy 2020 (NEP) on July 29, after a mammoth discussion nationwide for five long years. The Ministry of Human Resource Development (MHRD), now renamed the Ministry of Education (MoE), had started the discussion in 2015 and people at the grassroots level were consulted through 33 identified areas or themes; and then a committee under TSR Subramanian (a retired bureaucrat) was asked to prepare a draft on the basis of all the documents and feedback that were collected.

However, this report was widely criticised and was largely unacceptable to most stakeholders. So, a new committee was constituted to prepare a Dr Krishnaswamy Kasturirangan, (a space scientist of global repute). The draft report was submitted to the Government on May 31, 2019. The final document, prepared by the Government on the basis of all the data and feedback collected through the two drafts, was released in July. This document is extraordinary in many respects. The previous documents ran into hundreds of pages but this was presented in just 62 pages. Beside other things, the policy focusses on educators, right from pre-school teachers to the ones teaching in universities.

This Teachers' Day the educators must rejoice at the appearance of the Prime Minister in a conclave of teachers on August 6, only a week after the new national education policy docu-

ment was released. Talking about the NEP while addressing the conclave, Modi had said, "Today, there are views and opinions coming from all across the India. People are sharing their thoughts on this. It has been widely welcomed and one thing that has been observed is that no one is saying that this policy has any bias towards any one area... that is a great thing. Now everyone's focus is on how this will be implemented. As far as the political will to implement this is concerned, I want to assure you that I am fully with you... all

He called upon the educators to own the policy and implement it in let-ter and spirit. The message conveyed was that the nation has realised that the like all the previous policies, if the educators don't own it. A policy document on education will have to be owned and implemented by teachers and teachers alone. Plans prepared on the basis of the policy will have to be implemented in the classrooms which teachers alone handle. It is noteworthy that in his speech, the Prime Minister addressed principals who are the key players in transforming schools. If this is not just rhetoric, then we can indeed look forward to a "year of the teachers." This Teachers' Day can perhaps then be seen as a landmark one in the history of education in India.

The Mudaliar Commission on school education was constituted as a corollary to Radhakrishnan's report. This commission suggested the forma-

tion of an independent body to coordinate school education among the States of India. This, it said, was necessary because education is a national concern and the major responsibility of maintaining quality and content of school education as well as higher education rests upon the Union Government. The University Grants Commission (UGC) was established on the recommendation of the Dr Radhakrishnan Commission but the School Education Commission (SEC) has not been established till date. We need to get this going.
The best tribute to Dr

Radhakrishnan would be to give school teachers an independent statutory body to regulate themselves instead of have been shouting against Macaulay's policy of controlling teachers and schools because the gurukuls (residential schools of ancient times) and the madrasas were the places which produced the best minds of the nation. However, Macaulay planned and destroyed the indigenous school sys-

Today the educationally best performing nations have no Government interference in schooling. India needs this too if we are to compete globally. Modi had also expressed the importance of good quality teachers on several occasions. Hope he gets his policymakers to walk the talk.

This recommendation sets benchmarks regarding the rights and responsibilities of teachers and standards for their initial preparation and further education, recruitment, employment, teaching and learning conditions.

However, in India it is celebrated on September 5 to mark the birth anniversary of Dr Sarvepalli Radhakrishnan, who was a teacher par excellence. When he became the President of India in 1962, his students and friends sought permission to celebrate his birthday. However, Dr Radhakrishnan politely requested them to celebrate his birthday as a day dedicated to all the teachers in



The former President of India, Dr APJ Abdul Kalam, once said, Teaching is a very noble profession that shapes the character, calibre and future of an individual. If the people remember me as a good teacher that will be the biggest honour for me."

A teacher, who may give us a piece of advice and the lessons of a lifetime, is always considered a highly honoured person in every commu-

In India, the teacher-student relationship has a special religious and social bond and significance. Since ages, the story of Eklavya has come to define exemplary discipleship. This story is an example of dedication, hard work, obedience and paying the guru his due. This also shows that acquiring or gaining knowledge is not possible without the teachings and blessings of the guru. In ancient times, a common practice

in learning was *guru-dakshina*, where a student would offer a gift or fee for the knowledge gained by him. Washington: Slamming China's plan to further tighten control over Tibet, Issues, and insist that the Chinese government restore access to Tibet for US Democratic presidential candidate Joe Biden has said that if voted to power, his administration will sanction Chinese officials responsible for human rights abuses in the remote Himalayan region.

Noting that the Chinese Government recently announced plans to further tighten control over Tibet, thereby continuing to erode the human rights, religious freedoms, and dignity of the Tibetan people, the former US vice president said that these are only the latest efforts by Beijing to crush ethnic minorities that seek to preserve their distinct culture, language and beliefs.

"My administration will sanction Chinese officials responsible for human rights abuses in Tibet, and step up support for the Tibetan people, including by expanding Tibetan language services at Radio Free Asia and Voice of America to get information from the outside world into Tibet," Biden said.

To encourage alternative fuel, the Government has decided to allow automakers meeting certain criteria to set up own fuel pumps, provided they sell green fuel too, Gadkari said, asserting that carmakers could easily introduce flex engines on par with Brazil, the US and Canada if they could leapfrog from BS-IV norms to

crore can start their own petrol/diesels pumps but the condition is that they should have alternative fuel pumps also," Road transport minister Gadkari said addressing SIAM's 60th annual convention 2020 -'Rebuilding the Nation, Responsibly through video conference.

Gadkari, who also holds the MSME portfolio, said the vision was to make the Indian automobile industry number one manufacturing hub in the globe and cut on huge annual crude imports bill to the tune of ₹7 lakh crore by promoting alternative fuel. Wondering when automakers like BMW, Mercedes, Hyundai, Honda, Toyota and Suzuki could manufacture flex-engine vehicles for the US, Canada and Brazil, Gadkari asked why couldn't they start production in India. Mumbai: The Reserve Bank has expanded the scope of priority sector lending to include start-ups funding up to ₹50 crore, and loans to farmers for installation of solar plants and compressed biogas plants.The Priority Sector Lending guidelines have been comprehensively reviewed and revised to align it with emerging national priorities and bring sharper focus on inclusive development, after having wide ranging discussions with all stakeholders, the RBI said on Friday. "Revised PSL guidelines will enable better credit penetration to credit deficient areas; increase the lending to small and marginal farmers and weaker sections; boost credit to renewable energy, andhealth infrastructure," the RBI said in

India extends anti-dumping duty on Chinese float glass for 3 months till December 7

PTI ■ NEW DELHI

India has extended anti-dumping duty on imports of float glass from China for three months till December 7, as per a notification.

The move is aimed at guarding domestic industry from cheap imports from China. "...The anti-dumping duty imposed under this notification shall remain in force up to and inclusive of the 7 th December, 2020, unless revoked, superseded or amended earlier," the Department of Revenue said in the notification. Float glass, made by floating molten glass on a bed of molten metal, is used in sectors like construction.

The duty of USD 218 per tonne was imposed for the first time on September 8, 2015 for five years.

It was extended after the recommendation of the commerce ministry's investigation arm Directorate General of

Trade Remedies (DGTR). In a separate notification dated September 2, the department has imposed provisional antidumping duty on imports of Ciprofloxacin Hydrochloride medicine from China for a

period of six months. It is used to treat different kinds of bacterial infections.

DGTR had recommended the anti-dumping duty after conducting a probe into alleged dumping of this medicine from China. The directorate had in June concluded that the medicine has been exported to India from China at dumped prices, due to which the domestic industry has suffered material injury.

The duty imposed is in the range of USD 0.94 to USD 3.29 per kg.
"The provisional anti-

dumping duty imposed under this notification shall be effective for a period of six months (unless revoked, amended or superseded earlier)," it added.

OUT OF THE SHADOWS

September 6 will mark the second anniversary of the decriminalising of Section 377 by the Supreme Court. CHAHAK MITTAL speaks to some activists to find out how, even though there's still a lot to achieve, the LGBTQIA+ community has found freedom from humiliation, workplace opportunities and a new identity. And above all, it has found hope

with their hand gestures, particularly a swaying, loud clap. This pejorative implication was first questioned and opposed by Indian again and again. When we'd go to transgender activist, Lakshmi Narayan Tripathi, who discouraged the use of this clap as an identity marker.

However, newer perceptions are transforming such negative connotations into something beautiful. A recent viral video on social media talked about the LGBTQ community and how it should not be ostracised. One of the lines in the documentary said, "Taali toh sab bajate hain par jab kinnar bajaye toh galat kyun?" There have been several campaigns, poetry, films and even performing arts which are now normalising transgenders in maindiscourse #ChangeTheClap has caught on like wildfire.

Activists believe that such a change has come about after the landmark judgement by the Supreme Court on Section 377, which decriminalised homosexuality. On September 6, the verdict will turn two years old.

Harish Iyer, Gay Rights Activist, appreciates the wider

we often use body lan-guage to judge and label people. And over time, conversations on the subject. He says, "I come from a time when there weren't many voices to raise we've stereotyped transgenders awareness. The LGBTQ commucolleges or schools for awareness and to speak about issues, there was only a bunch of common faces I saw. Now, I see a lot of new voices coming up, and they create awareness through many different ways — poetry, writings and performing arts. And that's

important." LGBTQ rights activist Mohnish Malhotra recalls that it vas in 2009, when the Delhi High Court first struck down Section 377, that its draconian status began to diminish by a quantum leap. He says, "Up until then, this law was used by the authorities to blackmail, bully and extort the LGBTQIA+ community. After 2009 verdict, things began to change. Dr Ramachandran Siras' case from Aligarh Muslim University is an excellent example. Since then, many individual stories have come out in the public eye and our LGBTQIA+ brothers and sisters found the courage to come out of the shadows and have chosen to ask for their due rights. The NALSA Judgment, that recognised the trans community



2014 and singer Sushant Divgikar feels that a surge of LGBT-friendly content on OTT platforms, films and television is a huge recognition. He feels that digital content is increasingly helping this acceptability and hence, his recent song, in collaboration with MTV Beats, Love-Duet, tries to normalise same-sex love and relationships. "I have stepped out of my comfort zone and created this song, which furthers the idea of

oneness and equity."

While looking at what has changed, one of the first things one should notice is the number of people who walked the pride marches without a mask on. Well, the verdict certainly made the community stop walking under the fear of being judged or looked at as a criminal. Since time immemorial, loving for them has just been a criminal activity and

have been many baby steps taken towards ensuring the community's inclusion and recognition in the public sphere, a lot still needs

to be done, point out experts. "The verdict actually put the onus on the Government to ensure that the judgement is known by everybody and there is less discrimination. However, very little has moved towards that direction. I think there needs to be a widespread awareness and, especially, students need to be educated in schools and colleges about the LGBTQ community and the years of humiliation they've faced. There needs to be a psychological counselling for both the bullies and those who get bullied," says Iyer.

WHERE DID THE PHOBIA **COME FROM?**

ties, which, unfortunately, we lack higher education. There are inherited and decided to keep after we achieved Independence. It was a draconian piece of legislation showcasing the extremely narrow-minded thought process of the Britishers. So when the people of India say that homosexuality is a foreign import, I'd like to correct them and state this fact. I would like to tell them that Homophobia, in fact, is a foreign import! We have always celebrated sexual diversity until the Britishers came in and rained on our parade," says he.

WORK TO BE DONE ON WORKPLACE

After the Transgender Protection Act 2019, many work opportunities have opened for the community. Mohnish says, "Certain state governments and corporates have opened up offers for employment to the members of the trans community," mentioning the Employee Resource Groups (ERGs), which have been established to support LGBTQIA+ communities.

Amid the increasing workplace inclusivity, however, lies another major challenge — discrimination. LGBTQIA+ activist and writer Maya Sharma says, "Actually, workplaces are changing but these are formal sectors where the employer-employee relationship is visible and exists

these small but many problems, which act as the barriers to growth. But I also believe, positive judgments strengthen one's ability to survive if not live a fuller life

as a legitimate citizen." For Iyer, "Every organisation should have a non-discriminatory clause. And its workplace harassment policy should include all genders, including the transgenders. That's the need of the nour because trans people face the brunt of this everytime. There are trans men and women who get harassed and are asked for sexual favours by their bosses or seniors. And there is a whole range of transphobic and homophobic comments that are made

FINDING LIGHT AT THE END OF THE TUNNEL

Maya talks about the campaign, 'Hum agar uthhe nahin toh... (If we do not rise), which is aimed at uniting voices against the targetted attacks on the Constitutional rights of the peoble of India. Women's groups, LGBTQIA+ communities and human rights organisations are, today, organising this day of resistance to safeguard the Indian Constitution and its values, which will include a range of recent subjects — Expediting transgender inclusion in Gujarat, the new National Education Policy, etc. "We must realise that this is

a process and to unlearn what we have been force-fed for more than a century, and have been conditioned to falsely accept, will take time to undo. We are in this together. When we say we are part of the society, we need to work 'with' the society and not against it. People are changing their rigid fallacies to actually understand queer people and respect us, which is a positive sign. I would only say, education is key," says Sushant.

Mohnish is "an eternal optimist." He says, "Having witnessed the 2009 Delhi High Court verdict and then losing that victory in 2013, I say we should start to cherish what we have at the moment. Many lives have been lost to homophobia, bullying and stigma — at the very least, the apex court has removed the criminal status quo of the LGBTQIA+ community. This is a first step to the long process of ensuring equal rights to all citizens granted by our Constitution. That said, the community is preparing the future road map to appeal the court again for more demands."

Well, even though we can't say how long this will take, however, the way 2018 verdict was delivered, it does indicate light at the end of this tunnel.



TUG OF WAR 15 MINUTES


The last few months have seen relent-**▲** less attacks on the reputation of the Indian film industry across all media. The tragic death of a promising young star has been used by some as a tool to defame and slander the film industry and its members. A picture has been painted of the industry as a terrible place for outsiders to aspire to; a place that treats those who dare to enter it with contempt and derision; a murky den of substance abuse and criminality. This narrative is salacious enough for the media to exploit to great effect in order to boost its ratings, readership and page views.

But it is not the truth. Like any other sector there is no doubt that the film industry has its imperfections, and there must always be an ongoing attempt by any industry to improve upon itself, learn and evolve, while weeding out unsavoury elements or improper practices that hold it back. But to paint an entire industry with the same brush is a gross misrepresenta-

tion of reality. The film industry employs hundreds of thousands of people, boosts travel and tourism and is one of the most important sources of soft power for India across the

world. It has entertained hundreds of millions of people for over a century and has brought joy, honour and glory to the nation. It has welcomed and embraced talent from across the country — from the worlds of literature, poetry, art and music and has drawn them in to create a unique cinematic language. This has ensured that we are one of the few countries in the world to still have a vibrant and thriving local film industry across multiple languages, despite the decades-long onslaught of Hollywood. The industry has contributed generously to national causes in times of need, and has readily offered its resources — name recognition, time and funds — whenever called upon to do so, and often even without having to be called upon.

We do not negate the personal experiences of anyone from the industry, and undoubtedly many of those entering the business and seeking to establish themselves have faced numerous hardships, struggles and disappointments in the course of building a career here. But that is no different from the challenges and obstacles faced by new entrants in any field that they are not born into — be it poli-

tics, law, business, medicine or the media. However, a concerted effort has been made to single out the film industry as one that specifically inhibits and prohibits new talent from the outside from thriving. This could not be further from the truth. There are scores of talented actors, directors, writers, musicians, cinematographers, editors, sound designers, production designers, costume designers, art directors and numerous other film professionals across multiple disciplines who have had absolutely no connection to the industry, but who have flourished and produced inspiring and pathbreaking work, which has defined, and then redefined, Indian cinema. Being born into the industry most definitely affords you the privilege of access and a first break, but after that it is up to each individual's talent, hard work and drive to propel them forward. This is to let all aspirants to the film

industry know that they should not be misled by the clickbait journalism current-ly being peddled to advance the sensation-alized narrative that the film industry is a terrible place to aspire to work in. This is a place that ultimately rewards your talent, work ethic and ability to connect with

an audience - regardless of your religion, gender, caste or economic strata. While it is undoubtedly more difficult for those on the outside to get that first chance to display their talent - with perseverance, persistence and a little bit of luck - you can and do succeed. There are too many examples to enumerate across more than a century, of outsiders to the industry who are shining testament to this fact.

These are difficult times for our country and the world, so rather than venting our fears and frustrations on each other with vile and vicious trolling, it is more important than ever to come together instead of tearing each other apart. Members of the industry on both sides of this debate, especially women, have been subjected to rape threats and death threats. This is unacceptable and must stop now.

The media must look in the mirror and stop fanning the flames. There are some things more important than advertising revenues and ratings — things like common human decency. Let's show we

A WALK TO REMEMBER

This Teacher's Day, let us recall Dr APJ ABDUL KALAM whose goal was to be known as a teacher. The CEO of Kalam Centre and his close advisor, SRIJAN PAL SINGH, shares how the Missile Man inspired youngsters to aspire, think and act

The light of the world, the beacon in the dark and the hope that gives us strength to survive, is our teacher. On this occasion, let us convey our wishes to all the teachers and Dr APJ Abdul Kalam who has given impeccable contribution in shaping today's youth.

The CEO of Kalam Centre and his close aide and advisor who accompanied him on his travels and assignment for many years, wrote a book What Can I Give: Life Lessons from My Teacher, in the memory of Kalam. Excerpts:

What Will I Be Remembered For?

Dr Kalam often ended his speeches addressed to youngsters with one question: What would you like to be remembered for?' It was a powerful way of imbuing young students with energy and dreams. It inspired them to aspire, think and act.

The first time I encountered this Kalam hallmark was in 2008, when I was a student at IIMA. Dr Kalam did not stop with that one question, he went on to share with us a list of fifteen career options from which we could choose our answer. I am putting down some of them

Would you like to be remembered for pioneering action in interconnecting waterbodies and solving the problem of flood and drought in the nation?

■Would you like to be remembered for ensuring that our country is self-sufficient as far as energy consumption is concerned

■Would you like to be remembered for creating a unique venture which can result in hundreds of enterprises?

■Would you like to be remembered for leading a movement of a 100 million youths for nation building?

□Or will the future generations remember you for having revitalised the public healthcare system?

Later in 2009, when I started working with him, I began to realise that this was speeches he delivered in schools and colleges. He would end by saying, 'Tonight, before you go to sleep, take a piece of paper or your laptop. Write down the answer to this question and mail it to me. If your answer is good, I will send you an autograph and a photograph!'



Most of the students he met had posed this question at least once. But since I worked with him, I used to receive this question every now and then, sometimes once every week. And each time, after hearing my answer, he would say, 'Oh, you fellow! Build on it further. Enrich it from the last time. Add more value.' This went on and on for a good six months, till I reached a point where my 'answer enrichment centre' was exhausted.

I was simply out of ideas. One day, on our way to an event in Kerala, Dr Kalam asked me his trademark question yet again. This time I decided to throw the ball back in his court. It was part things.' And then, in an excitdefence and part exhaustion. ed tone, he disclosed, 'I want so many times. Why don't you answer this question for a change? What would you like I had indeed missed the most to be remembered for?' I couldn't help but smile at my cheeky response.

There was a short, unusual silence. So I continued, 'Let me make it easier for you. Would you like to be remembered as a missile man, a nuclear man, a rocket engineer, a Bharat Ratna recipient,

a President or an author?' I thought I had covered all his achievements but I still had a lot to learn about him. And that day I got a peek into his innermost thoughts, into the recesses of his mind. 'All your options are wrong,' he declared, taking me by surprise. I started recollecting all the facts I knew about him but I could not understand which aspect of his life I had missed.

He cleared my confusion in the next sentence. 'The right option is not there in your list. I do not want to be remembered for any of these That is my goal.'

It occurred to me then that obvious fact. Back in 2008, Dr Kalam was first introduced to me as my teacher, and it was the most significant role he played in my life, as he did in the lives of many others. I did not stop my questions there.

keep evolving. But I will tell you this. Get a diary or a notebook. Give it a name something which is close to your heart, something which will remind you of what you want to become. Make it a habit to write down everything you learn, everything that inspires you, even things that trouble you, and everything you do to reach your long-term goals. Record all the small steps you take in your long and difficult journey. Especially keep a record of the times when you fail, so you remember your stumbling blocks. 

The above is an extract of the detailed format of financial results for the quarter ended June 30, 2020 filed with the Stock Exchange under Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015. The full format of financial results for the guarter ended June 30, 2020 are available on the Stock Exchange websites (www.bseindia.com and www.nseindia.com) and the Company's website (www.simbhaolisugars.com).

Indian sugar industry has been facing difficulties on account of high sugar production in the country since 2016-17 resulting in surplus sugar and lower prices. For last several quarter, the Company has incurred losses due to high sugarcane costs fixed by the state government, and comparatively lower prices of finished goods which are also regulated and controlled. The operations of the Company remained intact and robust, due to stated reasons it has incurred continuing losses and its net worth has been fully eroded. This has resulted delays in meeting the payment obligations to the lenders and sugarcane farmers in terms of their respective agreements and understanding.

Recognizing the status of the sugar industry, the state and central governments have taken a number of measures to improve the financial health, support for liquidation of cane arrears, fixing minimum obligation for exports to manage the sugar inventory and providing subsidy to meet export expenses, fixing minimum support price of sugar, and mandatory blending of ethanol with petrol with long term tendering and remunerative price of ethanol etc. Pursuant to an order of Hon'ble high court of Uttar Pradesh, the sugar industry as well as the Company is confident to receive accrued benefits from state government under the erstwhile sugar promotion policy (2004-09).

All these measures are expected to reflect in the revival of the sugar industry and the Company in time to come on sustainable basis. Based on these steps, along with other internal measures being undertaken, the management believes that the regula operations at its manufacturing facilities shall remain continued in the near foreseeable future.

On account of delays in servicing of loans, certain lenders to the Company have initiated recovery proceeding at various forums including filing of applications before the National Company Law Tribunal under the Insolvency and Bankruptcy Code, 2016 and approached debt recovery tribunal. Against a criminal complaint filed by one of the lenders with the investigating agencies, the enforcement directorate had passed an attachment order against certain assets of the Company to the extent of Rs. 109.80 crores, against which the Company has preferred an appeal with the appropriate authority and the matter is sub-judice. Enforcemen directorate had proceeded to take the constructive possession of the attached property on which an interim stay has been granted by the Hon'ble Appellate Tribunal.

The Company is continuing to pursue a comprehensive debt resolution proposal with all the lenders. Majority of commercia lenders have shown their inclination to accept the debt resolution proposal of the Company.

Considering the steps initiated for achieving turnaround of the company and sugar sector, ongoing discussions with the lenders for resolution of their dues and continuing manufacturing operations in near foreseeable future, these financial statements are continued to be presented on going concern basis, which contemplates realization of assets and settlement of liabilities, in the normal course of business.

Impact of COVID 19 Pandemic

The Company has considered the potential impact of COVID 19 and related restrictions on the carrying amount of inventory, and financial and non-financial assets and based on the information available to it up to the date of approving the financial results written down the value of inventory to net realizable value, wherever required, and made provisions in respect of financial and non-financial assets. However, the impact of COVID 19 as well as negative outlook of sugar sector on the carrying amount of its property, plant and equipment's and consequential impairment could not be ascertained and provided for due to non-availabilit of requisite information on account of lockdown restrictions.

The outbreak of pandemic COVID 19 has impacted the sector with regards to slower off take of sugar and ethanol, logistic issues and fall in consumption particularly by the bulk consumers. As the date of approval of these results, it is not possible to reliably estimate the future financial effect of the COVID 19 situation on the Company. The impact assessment is a continuing process given the uncertainties associated with nature and duration of current situation. The eventual impact may differ fron what has been assessed by the Management as at the date of approval of these financial results. The Company will continue to closely monitor any material change in future economic conditions and take appropriate action as may be required.

The Credit Facilities availed by the Company have been classified as non-performing assets (NPA) by all the lenders and interest thereon is not being charged to the loan accounts by commercial lenders as per circular of RBI. The Company has submitted comprehensive debt resolution proposals with all the lenders to commensurate with its future cash flows. Majority of commercial lenders have shown their inclination to accept the debt resolution proposal of the Company and some of them had accepted the offered Earnest Money deposit. Accordingly, interest expenses pertaining to commercial lenders, for the ensuing uarter ended June 30, 2020 amounting to Rs. 3,593 lacs (previous quarter and year ended March 31, 2020 amounting 3,430 lacs and Rs 13,146 lacs respectively and corresponding preceding quarter ended June 30, 2019 amounting to Rs. 3,160 lacs) has not been recognized in profit and loss account. A total amount of Rs. 41,048 lacs towards accrued interest has not been provided for in the books of accounts as on June 30, 2020.

The Hon'ble High Court of Uttar Pradesh had directed the state government to determine the interest liability for the period of delayed payments of sugarcane price to cane growers for sugar seasons 2012-13 to 2014-15 by the UP sugar industry. No demand, pursuant to the order and for subsequent period has been received by the company. Considering this and also prevalen past practices, no provision towards the interest on delayed payment of cane price has been made in the accounts.

In the consolidated financial results of the Company for the Quarter ended June 30, 2020, the financial results of Simbhaol Power Private Limited (SPPL), a material subsidiary has not been consolidated, as the quarterly financial results of SPPL have not been finalized and approved till date by SPPL. The consolidated financial results of the Company as at quarter and year ended March 31, 2020 have also been prepared by consolidation based on the figures reported in the limited reviewed standalone balance sheet of SPPL as at December 31, 2019.

The transactions entered into between the Company and SPPL for the ensuing quarter ended June 30, 2020 which have not been eliminated in the consolidated financial results, have resulted in increase in the Total Revenue by Rs. 454 lacs (previous quarter and year ended March 31, 2020 amounting to Rs. 1366 Lacs) and Expenses by Rs. 404 lacs (previous quarter and year ended March 31, 2020 amounting to Rs. 734 Lacs).

In the limited reviewed standalone balance sheet of SPPL, statutory auditor of the SPPL drawn Emphasis Of Matter in respec of following "During the quarter ended September 30, 2019, Uttar Pradesh Electricity Regulatory Commission ('UPERC') has notified UPERC (Captive and Renewable Energy Generating Plants) Regulations, 2019 ('CRE Regulations 2019') which has inter alia, reduced the tariff applicable to bagasse-based generation plants in the state of Uttar Pradesh w.e.f. April 1, 2019 which is significantly lower than the prevailing tariff. As per CRE Regulations, such reduction in tariff was made by UPERC citing lower fixed and variable costs for these power plants. This reduction in tariff may have an adverse impact on the business and operations of Simbhaoli Power Private Limited ("SPPL"), a subsidiary company. The management of SPPL believes that there are anomalies in the process of tariff fixation and this reduced tariff notified by UPERC is based on unrealistic assumptions and is contrary to past practices. SPPL, along with bagasse-based co-generators operating in the State, have filed a writ petition with Hon'ble High Court of Allahabad, Lucknow Bench, challenging CRE Regulations 2019 which have been accepted by the court Pending outcome of the petition, the management of SPPL basis on opinion of legal counsel, is confident of relief from the Hon'ble High Court and suitable modification in CRE Regulations 2019 and thus does not expect the financial implications of this, if any, to be material.

SPPL has accounted for revenues from operations from April to September, 2019 at or basis pre CRE Regulations 2019 tariff rates. W.e.f. October 01, 2019, SPPL has billed and accounted for sale of power to the Uttar Pradesh Power Corporation Limited ('UPPCL'), the customer of SPPL, at reduced tariff rate under protest and subject to outcome of Hon'ble High Court decision or

SPPL's computation, shows that revenue from operations for the nine months ended December 31, 2019 would have been lowe by Rs. 797 lacs and cost of material consumed for the nine months ended December 31, 2019 would have been lower by Rs 52 Lacs, if accounted for at or basis reduced tariff as per CRE Regulations 2019.
