

# **RAGHUVANSH, WHO QUIT LALU** YADAV'S PARTY DAYS AGO, DEAD

reteran Bihar politician and ex-RJD leader Raghuvansh Prasad Singh - his V June resignation letter to Lalu Prasad Yadav emerged Friday - died Sunday morning at AIIMS in Delhi. He was 74 years old. Less than an hour later a shocked Lalu Prasad tweeted: "Dear Raghuvansh babu! What did you do?" Mr Singh tested positive for COVID-19 in June, after which he was admitted to the All India Institute of Medical Sciences (AIIMS) in Patna. He was re-admitted to AIIMS in Delhi, where he was being treated for post-Covid complications. His condition deteriorated rapidly over the past two days and he was placed on a ventilator.

# TS,AP headed for financial crisis?

Telugu States seem headed for debt trap, going by details in the latest bulletin for the month of September released by the Reserve Bank of India (RBI).

The central bank's September 12 bulletin has brought to light the grave financial crisis presently being faced by the Telugu States due to overdrafts, full utilisation of Ways and Means advance, huge amounts being spent on DBT

in the name of welfare schemes and other reasons. According to the bulletin, Telangana Štate took Rs 286

crore overdraft for 10 days in July, while Andhra Pradesh took Rs 233 crore overdraft for two days. Similarly, Telangana had availed RBI's 'ways and means' advance to raise Rs 1,278 crore for 29 days, while AP raised Rs 1,359 crore for 26

#### PNS HYDERABAD

Thousands of students from Telangana took the National Eligibility cum Entrance Test (NEET) conducted on Sunday by the National Testing Agency from 2 pm to 5 pm in 112 test centres across the state.

The examination had been previously postponed twice due to the pandemic. In all, 55,800 students had registered from Telangana.

Several parents were seen accompanying their children to the examination centres in Hyderabad. In view of the pandemic, the authorities took measures to disinfect the centres' floors, walls, doors and even gates.

Students were asked to stand at least four to five feet apart. They were given a new mask, checked for temperature, and sanitised right at the entrance. Only then students

were allowed to go inside oneby-one, and that too after the one going inside had occupied his or her seat.

According to students who appeared for the examination, the question paper was 'very easy' and had almost 'zero difficulty'.

Says Ch Varun, who wrote the exam in a centre at Chilkur, "The paper was very easy, especially the Biology part. I am sure I will get a good rank.' Giving an overview of the analysis, D Sankara Rao, Dean of Sri Chaitanya, Kukatpally, says, "Generally NEET question paper has tricky questions. However, this time they stuck to the NCERT syllabus, and hence the paper was very easy. There were three to four questions which could have been difficult for average students. Physics and Chemistry also

#### All in awe of 'Al'

A new name, nay just initials, is making rounds in the top administration of AP, though nobody knows where exactly he fits in when it comes to the pecking order or power structure, be it real or just public facing. All they know is that he, like James Bond, is a smooth operator oozing charm that is simply irresistible. The name is Avinash Iragavarapu, to put it a la Bond. Hangers-on at CMO know that he is not one of those powermongers who, gnash-ing their teeth, bark orders and expect total, selfeffacing surrender, not just obedience. Avinash is a rather cool dude whose reputation as an election campaign strategist arrived before him. Never the one who blows his own trumpet, Avinash is naturally less known, even in the higher echelons of babudom. Not many know that he, apart from being an ace election strategist, is close to American President Donald Trump and has worked as the executive director of the Arizona Republican Party. He was associated with Kamal Haasan's political party Makkal Needhi Maiam for some time.

Nicknamed 'AI' (his smart initials, not the IT variant) in the corridors of power, he has been scanning political developments in the country and providing strategic inputs for helping YSRCP adopt advance as well as counter strategies. Avinash has been privy to most important meetings held by Chief Minister YS Jaganmohan Reddy, including highly confidential intelligence briefings. Given his unassuming personality and rare trait to keep an extremely low profile, it is not a co-incidence that the media has missed his otherwise commanding presence during closed-door confabulations. Scribes with bull-dog tenacity can and do ferret out such concealed power centers. What if they are, or choose to be, fully insulated from media and public glare?

# **Beware of red mercury** fraud, warn cops

Social media has become a hub for fake news these days. So many rumours and speculations are also transmitted on chatting apps like WhatsApp. The latest rumor that's taking a tour on the internet is the red mercury, which is mostly found on old electronics such as CRT televisions and FM radios.

Some fraudsters are offering Rs 1 crore for red mercury found in old radio and TV sets. According to the propaganda by these unscrupulous elements on social media, gift running into several lakhs of rupees or crores are being announced on social media if anyone fetches the red valve which is found in TVs and radios dating back to 25 to 30 years.

Things have become so unethical that some people have even got infected with COVID-19, just so that they can sell their plasma to patients and make some money.

Akhil Ennamsetty, first donor for plasma trials in the state, however, says that the number of people selling plasma has come down significantly. "Back in the days people weren't too sure about whom to approach. But now, each person knows at least one person who was infected and got cured of COVID-19. So, there are fewer cases of selling plasma now," he says, adding that though many people had raised their voice against this a few months back, the Telangana govern-ment had not taken any steps to stop the practice.

# 11 deaths, 2,216 new cases in TS

Telangana reported 2,216 new Covid-19 cases, pushing the infection count to 1,57,096, while 11 fatalities took the toll to 961 on Sunday, the state government said. The active cases under treatment stood at 31,607 after cumulative recoveries of 1,24,528, a bulletin providing data as of 8 PM on September 12, said. Greater Hyderabad Municipal Corporation (GHMC) Corporation

accounted for the highest number of cases with 341, followed by Rangareddy (210), Medchal Malkajgiri (148), Nalgonda (126), Karimnagar (119), Khammam (105) and Warangal Urban (102) districts. All 33 districts reported cases in double digits. As many as 56,217 samples were tested on September 12, taking the total number of specimens examined so far to 21,34,912. The samples tested per million population was 57,504, it said.

# **Despite sharp rise in Covid cases,** demand wanes for hand sanitisers

#### PNS HYDERABAD

The sales of hand sanitisers have come down from the last week of August. It is very disappointing as the distributors are returning sanitisers to companies as the sales dropped to 30 per cent of what it was in June and July. Prior to outbreak of Coronavirus, sanitisers were only limited to hospitals and doctors.

In the wake of the Corona threat, sanitiser has become one of the most essential products. People purchased them and kept them everywhere, including their cars and even they carried small bottles to sanitise their hands frequently. In one way, it became an essential commodity.

Somehow at once the people developed dislike for the sani-

tiser, after which the sales dropped to 30 per cent. There was severe shortage of

sanitisers in the months of June and July. Now there are no takers for sanitisers. As such the



distributors are returning the stocks to the manufacturers. The manufacturing sector

reeled under severe crisis in the wake of the Coronavirus. While small manufacturing

units suffered severe blow due to the Covid impact, some of them used the situation as a Godsent opportunity and started manufacturing sanitisers, setting aside their main pro-duction activities. Prior to the Coronavirus, only two or three prominent distributors distributed sanitisers in the market.

After the spread of Coronavirus, at least 10,000 persons became distributors of sanitisers. Whereas some firms, used the revenue gained with the sale of sanitisers to pay wages to their employees.

In June, 5 litre cans, each selling at Rs 2,000, were sold like hot cakes. Daily the distributors used to sell at least 8 to 10 such cans. Similarly, they used to sell 100 ml sanitiser bottles up to 300 a day and 200 ml bottles up to 100-200 a day.

In July, the Centre regulated sanitiser prices as such the prices dropped to Rs 1,000 a can. By August, the cans are being sold at Rs 400 a piece.

These cans have piled up in medical shops unsold. Therefore, the shops are forced to return them to the distributors or manufacturers.

This is attributed to people reducing their fear for Coronavirus, unlike the early days of the outbreak, even as the cases increase enormously these days.

People are of the view that the Coronavirus is similar to an ordinary fever. The recovery rate in Telangana has reached 77 per cent. The death rate due to the virus is abysmally low. As a result, the people are no longer panic buying sanitisers, leading to drop in the sales.

# Heavy rains to continue for next 48 hours in state: IMD

The Indian Meteorological Department (IMD) has forecasted heavy to very heavy rains in different parts of Telangana for the next 4 days.

IMD said Adilabad, Komarambheem, Mancherial, Peddapalle, Karimnagar, Siddipet, Jayashankar Bhupalapalle, Mulugu, Bhadradri Kothagudem, WarangalRural Warangal Urban, Mahabubabad, Jangaon, Bhuvanagiri, Khammam, Suryapet and Nalgonda will receive heavy to very heavy rains in the next 48 hours.

It also predicted thunderstorm accompanied by lightning to occur at isolated places over Telangana. IMD said light to moderate rain or thundershowers will occur in the city for the next two days. The IMD also warned that rainwater may inundate the roads in low-lying areas. It urged people to restrict their movement.

# Works on villas at Yadadri nearing Completion PNS HYDERABAD

Construction of presidential suits and villas at the famous pilgrimage centre of Yadadri is nearing completion. It may be recalled that 14 villas and a presidential suit are being built in over 13.26 acres. All buildings, barring a village, have been executed completely.

# **Telangana, Andhra present** contrasting Covid picture PNS HYDERABAD/ AMARA-

Telugu states of Telangana and Andhra Pradesh present a con-trasting picture of Covid-19 situation. While one state with continuous surge has climbed on to the second position in the country in terms of number of cases, the other has succeeded in controlling the pandemic. At least this is what the statistics suggest. Both the states claim to be handling the situation well. Andhra Pradesh attributes the high number of cases to massive testing while dismissing the criticism for fewer tests and allegations of hiding deaths and underreporting cases, Telangana claims that its strategy helped in containing the virus.

As of September 12, Andhra Pradesh with over 5.57 lakh cases stood second on the list of states with most cases, next only to Maharashtra, which so the first states to report Covid



far saw 10.15 lakh cases. cases in early March, Telangana is at ninth place in the list of Andhra Pradesh has been states with highest number of infections. With 950 deaths, it adding 10,000 cases and reporting 70-80 deaths every day for the last few weeks. With 4,846 is also at ninth spot in terms of deaths, it also has the fourth fatalities. 

# Coronavirus takes a toll on Delhi slum-dwellers

#### PNS NEW DELHI

The COVID-19 pandemic took away her family's livelihood 48-year-old and now Veeramma fears she will lose her roof in the wake of the Supreme Court ordering the removal of 48,000 slum dwellings along railway tracks in Delhi. "My husband was born here. My son was born here. My in-laws breathed their last in this house. This is all we have," said Veeramma as she sat on crushed stones outside her home at a slum cluster alongside a railway track near Jal Vihar in Lajpat Nagar.

The 48-year-old, who works as a domestic help, said her employers haven't called her back to work yet.

"My husband cannot move. My son is a daily wager, he doesn't have much work, too. We don't have enough ration to feed the family for another week," said Veeramma looking at her two-year-old granddaughter, a third generation to be born in the slum cluster.

"We don't have the money for my granddaughter's milk. Even if we beg, we won't get anything. The times were never so bad," she said. The Supreme Court had on August 31 ordered the removal of 48,000 slum dwellings along railway tracks in Delhi within three months. As per rough esti-

# **Sanitised session**

In the rush to clear pending Bills, the Govt has shrunk debate space but the Opp is working on a joint strategy to make itself count



iven the deliberative nature of democracy, the "sani-tised" monsoon session of Parliament is expected to rob all the colour and fire of debate and mostly go about the tepid business of pushing necessary legislation. Yet it is an experiment in the new normal with both Houses conducting sessions at different time slots and shifts and sharing their chambers and galleries for purposes of social distancing. The Parliament will be going paperless with members given login IDs to access the relevant portals of documents, there will be audio-visual exchanges between them given the spread out nature of proceedings and they will be partitioned by fibreglass

barriers. Of course, e-participation was once considered to ensure vibrancy but turns out the Government's video-conferencing platform can only accommodate 600 people at one time. Besides, senior parliamentarians, who literally command the floor with their speeches, will be absent as most of them have preferred to stay away for health reasons. The limitations of a truncated timeline and the shadow of the pandemic would undoubtedly help the Government wiggle past the discomfort of facing questions on its crisis management, the economic slump, GST compensation, the migrants' exodus and the border standoff in Ladakh. As it is, it has structured a schedule favouring itself. Apparently, it wants to avoid a larger discussion on the Ladakh incursion, preferring to keep the negotiations with China backdoor, with Defence Minister Rajnath Singh making just a statement. Although the Government had suspended Question Hour initially, it buckled to Opposition pressure and has now allowed 30 minutes of it for only unstarred questions, thereby escaping the live grilling and the verbal duels that starred questions demand. Unstarred questions seem rather anodyne as the MPs need to submit them digitally to the presiding officer, who gets the written response from Ministers. This then would become a bland handout affair as cross-questions and counter-arguments actually show up the strength of logic of both the ruling party and the Opposition and help the citizenry judge for themselves. Apart from unstarred questions, up to 10 special mentions would also be taken up to bring matters of importance to the Government's notice. The Government, lest it be accused of pushing through its agenda in a rush and in an autocratic manner, has provisioned for shortduration discussions and calling attention notices but without the latitude and depth of time, these too would be chaperoned exercises, more in the nature of convention followed than actually letting others to hold it to account. It's not that a live Question Hour was impossible. It anyway has a structured format, with MPs required to submit a questionnaire 15 days in advance. So there could have been a staggered roster of Ministers and their officials to answer them. Besides, even the nature and tenor of questions are regulated by several rules before they are cleared and scheduled. The Trinamool Congress had argued that considering the Parliament's overall working hours would remain the same and no private members' Bill would be moved, a regular Question Hour was not difficult to factor in. The Question Hour is the only time that allows the Opposition equal standing and allows it to keep a check and balance on the executive. A legislator asks questions on behalf of the constituents who elect him and any democratically-elected Government is, therefore, duty-bound to respond. Without a healthy Question Hour, there will be no accountability. And if the pandemic continues its run till 2022, as experts are suggesting, then this democratic convention could become a casualty. Of course, safety is important but can't live televised debates be possible in a digital India?

Of course, there's the urgency of clearing legislation. Around 40 Bills are awaiting deliberation and passage by one or both Houses. Five of these are still being processed before parliamentary committees. And some of these are of sensitive nature, including the ones on DNA technology, social security and personal data protection. Of basic rights concerns, the Pension Fund Regulatory and Development Authority (Amendment) Bill 2020, Foreign Contribution (Regulation) Amendment Bill 2020, Assisted Reproductive Technology (Regulation) Bill 2020, Prohibition of Employment as Manual Scavengers and their Rehabilitation (Amendment) Bill and the Juvenile Justice (Care and Protection of Children) Amendment Bill need attention. The 11 ordinances that the Government promulgated during the lockdown, related to agricultural markets, insolvency proceedings and economic policy, are likely to be used as ammunition by the Opposition. It has already moved statutory resolutions against these. Farmers are unhappy about the corporatisation model implied in farm reforms and could set off a new pan-India stir and allied politics. In fact, the Opposition, which had in the past disrupted the Question Hour repeatedly, is now committed to making use of the limited time and is avidly working on a joint floor strategy to nail the Government. Congress president Sonia Gandhi, who recast her party on the eve of the session to work up a sense of urgency, has asked senior leaders to contact UPA allies and like-minded parties to put up a united fight against the Government, both inside and outside Parliament. Will the post-pandemic session be an adhesive for the Opposition that it desperately needs? Or will the Government sail past by heaving down with its executive powers?

# Regulate non-personal data

Even seemingly benign data on communities can lead to collective harm. Demographic census data can be used to target communities based on social or religious lines

he Committee of Experts on Non-Personal Data Governance Framework was formed last year to advise the Government on various aspects of non-personal data. It released its draft report in July and is currently accepting public feedback. Among other things, it recommended that a new legislation be drafted and a new regulator be set up to operationalise the framework

The committee defines nonpersonal data as anything that is not defined in the Personal Data Protection Bill, 2019, and that does not contain personally identifiable information. This would cover a wide array of information, including, example, for anonymised datasets that companies collect from their users or customers, traffic pattern and weather data, agricultural data and datasets containing information that is not directly linked to an individual. Given that datasets are an important aspect of many businesses today, any non-personal data regulation would affect most companies and entrepreneurs. They would also have significant implications for providing benefits and enabling individuals and communities to exercise their civil liberties, due to the inferences that can be drawn even from data that is anonymised.

This is especially the case because most datasets in use are "mixed," containing a combination of personal and non-personal data. For example, datasets collected by banks could contain client and transaction details as well as aggregated information on overall demographics and transactions. It is important to note in this context that the Personal Data Protection Bill, 2019, which is set to regulate personal data, is currently being deliberated by a Joint Parliamentary Committee. The finalised legislation and the Data Protection Authority which is



irreversible and the risk of reidentification of individuals is a real concern. Moreover, even seemingly benign data on communities can lead to collective harm, such as if data on average income is used to decide interest rates for those living in a certain area, or demographic census data is used to target communities based on social or religious lines.

It is also clear that algorithms can exacerbate existing biases unless there are sufficient technical and human-based safeguards. Using such analysis to make public service delivery decisions, for example, can also perpetuate discriminatory practices. Importantly, the framework suggested by the committee also allows the Government wide-ranging access to datasets. When combined with data that it already has access to, this carries significant surveillance risks which can endanger civil liberties.

Given the potential for such harms, it is essential that a key focus of any regulatory framework is on instituting safeguards, with clear accountability and redressal mechanisms. The primary goals of non-personal data regulation are to unlock the economic ue of data create ing field for digital businesses and protect the interests of those providing the relevant data. Unfortunately, there are a few significant issues with the framework proposed to achieve these aims. First, crucial parts of the framework are vague. For example, one of the key concepts discussed by the commit-

tee is that of a "community." This is relevant both from the view of protecting collective privacy and for assigning rights and obligations accruing on the basis of data generated by communities. The draft report defines a community as a collection of people bound together by a common purpose, THE MANDATORY objective, or geography, which means that an individual can **DATA SHARING** potentially be a part of hundreds of communities. The authorit also tasked with setting standards of anonymisation, even though penalties for re-identification are prescribed under the PDP Bill Similarly, regulating competition concerns to "level the playing field" falls squarely within the purview of the competition law framework and the Competition Commission of

India. The mandatory data sharing mechanisms outlined in the draft report do not engage with proprietary rights that datasets are subject to and are likely to conflict with intellectual property laws. Such regulatory overlaps are likely to lead to conflict, litigation on the boundaries of each regulator's mandate and higher compliance costs for companies. Third, although the com-

mittee recognises the potential for harm and the need for safeguards in a non-personal data framework, it does not account for these in its report. For instance, when exploring the concept of collective privacy, it recognises that non-personal data can provide insights that allow for collective harm such as discrimination and states that safeguards are necessary. Unfortunately, the committee does not explore any specifics. Even though it proposes that a new regulator is set up, there is a marked lack of engagement with regulatory design best principles to ensure accountability, transparency and independence of the regulator, and effective grievance redressal. Given the overlaps in ambit, it is also not clear that a separate regulator is even required to specifically regulate non-personal data. New regulatory frameworks will also have to recognise that given the range of activities that are moving online, regulating issues in the "digital" space cannot be done in silos and will require cooperation and collaboration. Experience in India and other countries, where such collaboration occurs, indicates that there must be robust, binding processes that are built into regulatory frameworks themselves.

The committee would have done well to explore some of these aspects and other best practices in regulatory design, and more deeply consider the best ways to achieve its stated aims. For instance, instead of mandating data sharing, it could focus on leveraging the intellectual property law framework to incentivise data-sharing without contradicting existing copyright laws. More generally, the committee must specifically address the areas of overlap with other regulatory am

# **Apocalypse now**

In the midst of the pandemic, let us not forget about a disaster called human-driven climate change



nilicon Valley, home of many of the world's most valuable companies, including Apple, Facebook and Google, woke up to some truly apocalyptic scenes. The blue sky had been replaced by an orange haze as wildfires burnt down some of the oldest temperate forests in the world and the US state of California reeled from the worst of such disasters in its history. The fires are so intense that they have now covered the length of the state and are spreading into the north as well, making this late summer the worst blaze season ever recorded. California is not unique. Earlier this year, the southeast Australian seaboard, where three-quarters of that

# FIRSTCOLUMN Managing Covid the Indian way

The *desi* variant of regulation has many unique characteristics, namely observing the format even if the content sounds silly

he last six months have seen exponential growth in the use of internet-enabled platforms for communication purposes. More webinars have been, perhaps, held per week than were seminars held per month, in each of the preceding years, with any month being taken as an example. This is understandable because after the initial severity of the lockdown began wearing off and the overenthusiasm of regulations without back-ups created its own long-term damages, gradually a greater sense of realism became a part of the scene. Dealing with a pandemic where — at the best — mitigation was the only strategy (and inexorable personal disaster a real possibility), there was little option but to allow life to begin limping towards the so-called "new normal." If in the process infection multiplied and unmanageable risks erupted, it was a price which could not be avoided.

The eateries started opening up and public transport was back on the wheels. Those who could not do without air travel went back to flying. The standards were more of a lip-service, than being implemented seriously. Reports had it that two twin airports, called "sister airports" and managed by identical agencies, manpower and serviced by identical airlines, at least on September 10, offered two diametrically opposite scenes. Long queues at Jammu airport, more organised systems at the Srinagar airport. At the Jammu airport, people were reconciled to standing shoulder to shoulder. If in the process they contracted or passed on the virus, how could it be helped? The system wanted to know personal details, including the mobile number. How could one know whether this was a genuine mobile number?

The Indian variant of regulation has many unique characteristics, namely the form must be observed even if the content sounds silly. This is truly an understandable approach because the circumstances demanded that procedures be shown to be observed. Once in a while somebody talks of increasing medical literacy in the extension mode and somebody else notches up a point by talking of public healthcare systems. Once in a while, somebody even talks of some modifications in the medical education curriculum. Truly speaking, nothing much seems to have been seriously attempted. At the time of writing this column, guidelines were being issued for re-opening of higher educational institutions: "Staggering of classroom activities to be done with separate time slots to allow for adequate physical distancing and disinfection of classroom premises...and so on." It has been directed that a distance of six feet would be observed between desks. It is mandated that academic scheduling should have an intermix of regular classroom teaching and online teaching and assessments. What has been missing is a back-up calculation to assess how many square metres of space does an average educational institution have? The smugness of powers that be is touching. It is duly leavened by people willing to sing praises to it in the hope of some compensating privileges coming their way. The guideline document is a delight to read: "Institutions conducting skill or entrepreneurship training, higher educational institutions conducting doctoral courses and postgraduate studies shall specifically ensure online and distance learning...." The document even goes on to suggest the "utilisation of any outdoor space by relocating equipment outside like in veranda, courtyard, shed and so on." This kind of wisdom eludes comment.

The truth of the situation is, in the absence of any standards in a verifiable sense, one cannot sense what the future would look like. The efforts seem to measure up only to a format. It is little wonder then that on September 9, India had the highest number of cases in a single day of any country on this planet. The official response was swift, pointing to "the low percentages of fatalities." This debate should not even have begun. In reality, no real teaching has begun in many places. There is much drumming up of the "hybrid approach" but the contents of the curriculum have not even been touched. Education as a domain is not a fallow field where anyone can walk all over with command and confidence. It is management of an expert system and the identification of genuine experts in sufficient numbers to plan, develop and execute is an important pre-requisite. The powers that be claim that the education policv had comments from over two lakh individuals. This is fabulous. Who were the core group of people — with what expertise - to screen their reactions? Nevertheless a good aspirational document has emerged. What is now required is its conversion to an operational level. A rebirth is possible provided the envisioning is clear and process issues clarified.

# ICT unshackling subalterns

Is the information society selling a justifiable hope for liberation and empowerment to the marginalised in post-truth India?

nformation and Communication Technologies (ICTs) are providing an enormous platform to re-arrange societal contours, by abandoning the primitive, time and space-driven edifices of epistemology to develop some new sets of normative standards, for citizens in the information age. Citizenship assumes geography, which is later underlined as a nation-State. This understanding, however, becomes inept in times of a new digital citizenship under the sovereign ruling of ICT. This has paved the way for the subaltern's voice. For ages, socially-acceptable and prestigious spaces/institutions were devoid of subordinate voices. Digital social media platforms via the inter-net have considerably enabled them to mature a first-hand collective consciousness to authorise a distinctive, shared philosophy (through Facebook, WhatApps, Twitter and so on) deeply interwoven in democratic traditions. Digital windows have arguably helped diverse online communities to materialise their life.

online communities to materialise their life-world experiences and advance a fresh alternative and corresponding model of living. Information society theorist Manuel Castells recognises the lib-erating outcomes of ICT. Subalterns are taking epistemic responsibilities in socio-technical processes of the information society, conditioned on epistemic justification to rectify injustice done to them.

ICT and empowerment: Subalterns have utilised digital platforms more suitably to reveal their experiences, ideas, concerns and aspirations and explore unsung heroes, weave stories and preserve oral traditions. These include their life experiences, cultures, traditions, beliefs, languages and ethics, despite the anxieties from the existing dominating political entities. Information technology enabled subalterns with the required information, without much obstruction, to get closer to the pur-suit of truth and justice. Information/knowledge systems of a large section of the Indian population possibly would have been isolated by the mainstream content drivers to sustain dominant conceptual accounts and discourses/narratives. Meanwhile, cyberspace is offering sizeable avenues to freely communicate with local and globalised communities.

Subaltern news outlets: Subaltern presence is notable in online news portals, though not adequately enough. Some channels like Dalit Dastak, National Dastak, Bahujan TV, National India News, The Shudra and Dalit Camera: Through UnTouchable Eyes have started generating content. They have subscribers/viewers in millions from various social groups. Notably, sub-alterns have utilised digital media to constructively choose relevant, valuable and meaningful information, more than ever to educate themselves.

ICT and subaltern causes: With collective struggle, subalterns are reaching at the centre of democratic knowledge production and content generation, challenging the discriminatory and hegemonic patterns of the State. Leaders became irrelevant and, despite that, it could become the largest unprecedented movement of this scale, in recent years, by subalterns. Why is information society more liberating to subalterns? In agricultural societies, they could not acquire the land. On the contrary, in the information society, they could secure key positions from content generators to content managers and owners. However, the lack of financial resources limits them from projecting their accounts as general mainstream opinions. At the epistemological front, they have had considerable accomplishments by acquiring digital space but do not possess materialistic

resources to take the ownership of big mainstream media. The information society, further, has been converted into a revered room that furnishes more substance of respect and dignity to an ordinary subaltern. Fundamentally, the information society is based on ideals of inclusivity, mutual collaboration, open and free access to reliable data. The subaltern people's reliance is diminishing on mainstream news channels. This will further translate into the development of community-owned and driven online media outlets, leading to active involvement and participation of outcasts and subordinates. More so to democratise the media space in the information society. Subaltern hyper self: In an information society, people use the new social channels (Facebook, WhatsApp, Twitter, Instagram, YouTube and so on) to self-

using obscure user presences - from chat room names to avatars who look nothing like us — allows us to literally reconceptualise ourselves." It testifies the departure from the earlier mode of existential self to the digital self, which is attributing more meaning to a digital subaltern self.

Indian and Western digital self: Culturally, individuality is not sup-pressed largely in the West due to an individualistic understanding of the self, rooted in the Cartesian self. In India, desires, fantasies and aspirations are peculiarly anchored by external factors other than an individual. People will, therefore often go and selves and put fake/distorted/misinformation about their identities to cherish what they always wanted to be without revealing much about themselves. It has given them more freedom to express, which has resulted in the online social selves dominating the real ones. Sometimes, the social self overpowers the real existential self. In general terms, humans are living in a world of "double social self." The former springs from physical social space, the latter is caused by ICT and made compulsory due to economic and political compulsions. Novel digital subaltern metaphysics has yet to be thoroughly comprehended in India. It could empirically be concluded that the information society sells a justifiable hope of liberation and empowerment to subalterns in India.

vidual content providers and senior journalists devoted to maintaining the integrity of their profession, and their incessantly digitally-widening audience, attests to the fact that subalterns and ordinary citizens receive more reliable information from them than from mainstream news outlets. In the present scenario, formal education is less required to produce creative content. On the contrary, industrial society is engrossed in ownership of talent. The information age does not need a bulky investment of academicians for information; rather it independently cultivates a new digital forum. It is also not purely social-capital caste driven. In this way, the creator of information will enhance balance in society. The embryonic subaltern epistemology adheres to different ideas and figures, which might be in stark contrast to some widely-considered knowledge structures. This will actually induce those, who remained at the helm of social and political affairs/narratives, to incorporate burgeoning criticism and demands of subordinates to enable the substantial democratisation of ICT.

idea of self could be reformulated on a digital platform to generate meaning and accomplish freedom of speech in soci-Thai philosopher Soraj Hongladarom in his seminal work, The Online Self, maintains "viewing the self as made up of information makes it easier to account for the self in the online world." # Karachi: A metropolis in a watery mess

Its problems of infrastructure can be traced back to its sudden transformation into a major city and to the lack of attention paid to its planning

arachi is Pakistan's largest and the world's sixth-largest city. It is the provincial capital of Sindh province. Known as Pakistan's economic hub, it generates up to 65 per cent of the national revenue. It is also Pakistan's major port city. It is a fact that only during disasters, such as the recent urban flooding, do most Karachiites realise that there is not one political or administrative authority in Karachi but many. The city Government, the Sindh Government, the federal Government and various local administrative bodies. The administrative structure of this mammoth metropolis is thus complex and multi-layered, with some absurd overlaps. Karachi is also Pakistan's most ethnically diverse city. Even though this diversity continues to sustain the city's

metropolitan status, and its rather pragmatically formulated pluralistic culture, it can also make the city's many political and administrative stakeholders pull their individual weights in opposite directions. This makes it almost impossible for them to strike any workable consensus.

This is reflective of the city's segregated ethnic construct. Ever since the 1980s, various ethnic communities have ghettoised themselves in their areas of numerical influence. During times of ethnic tussles over the city's resources, ethnic groups prefer to remain in their areas. However, since economic survival demands venturing out and interacting with other groups, bridges do emerge and communities return to interact with each other. No matter how pragmatic the nature of this interaction, it often results in the creation of an overarching culture of interaction and inclusiveness, only to recede

once again during ethnic commotions. Common economic interests are what drive this interaction, until one community begins to suspect the motives of the other. The suspected motive is usually about usurping more than one's unsaid share of economic

resources. But there are no such bridges between those who administer this city. Communication gaps remain and in case of emergencies, these cause uncoordinated, chaotic responses and futile finger-pointing. The city's ethnic diversity works in a curious manner, generating an always-

squabbling pluralism. Most large cities, even in developed countries, face a plethora of administrative and infrastructural problems. But lessons and data from their historical evolution aid them to adjust and resolve these problems. But unlike most cities, Karachi did not evolve as a city, as such, but it imploded into existence. Twice.

The region that became Karachi has an obscure history till the 18th century. According to ancient Greek texts, the Greek commander Nearchus, who accompanied Alexander during his invasion of India in 326 BC, called the region "Krokola", a place by the sea inhabited by a tiny community of "primitive people." However, 16th century Turks and Arabs called it "Kaurashi." But it does not appear on any map until Sindh's Kalhora dynasty annexed it in 1759. It was "gifted" to

Balochistan's Khan of Kalat in 1767 before being annexed by Sindh's Talpur dynasty in 1794. By all accounts, it was still a small fishing town with less than 10,000 inhabitants, mostly Sindhi and Baloch, who called it "Kolachi."

The British invaded and occupied Karachi in the early 1840s and then annexed the rest of Sindh. They made Karachi and Sindh parts of the Bombay Presidency. The British rapidly developed Karachi's port and infrastructure. This led to migrations from the rest of India. From a population of less than 15,000 during the time of the British takeover, it witnessed a manifold increase. By 1856, the population had jumped to 57,000.

Suddenly, within a matter of a few decades, the rugged fishing town of 15,000 people became a rapidly-emerg-ing port city. By the 1930s, the British were calling Karachi the "Queen of the East" and praising its enterprising, tolerant and diverse character. The city's sudden urban emergence and swift increase in population did create issues but the British introduced an effective model of city governance that continued to upgrade Karachi's infrastructure. The city governance system eschewed

politics based on religion or ethnicity and succeeded in managing the city's resources in such a manner that major and minor stakeholders felt included. In 1936, Sindh was restored as a province and Karachi was made its capital. According to the 1941 census report, Karachi's population then was 435,887. Over 50 per cent were Hindus, 40 per cent were Muslims, while the rest comprised Buddhists, Zoroastrians, Christians and Jews. Over 65 per cent spoke Sindhi.

In 1947, the city imploded into another form of existence, this time as a capital of Pakistan. Karachi's demographics witnessed a dramatic shift when millions of Urdu-speaking Muslims (Mohajir) migrated to it. There was a 161 per cent increase in Karachi's population. The infrastructure left behind by the British could not accommodate the massive increase, and began to crumble.

In 1958, the Ayub Khan Government chalked out a resettlement plan which was to be accommodated by an ambitious industrialisation project. New low-income housing schemes emerged but factories and businesses were slow to reach these areas and there

Punjabi migrants also began to arrive in droves. Slums began to sprout. Failure to effectively adjust the city's infrastructure to accommodate these changes led to ad hoc arrangements. In 1965, Karachi witnessed its first ethnic riot. In 1970, it once again became the capital of Sindh. In 1972, it witnessed another round of ethnic riots. Unable to check the influx of more inner-Pakistan migrations to Karachi, and stall the mushrooming of slums, the ZA Bhutto Government, in 1975, devised a "Karachi Master Plan" to upgrade the

city's failing infrastructure. It planned to build new road networks and housing; construct transport terminals, warehousing, mass transit and so on. But the plan was not implemented after the 1977 coup of Zia-ul-Haq. This resulted in the growth of the informal sector and mafia that emerged to serve a growing population of a failing city. Across the 1980s and 1990s, Karachi witnessed brutal ethnic and sectarian violence. Ethnic communities and mafia fought running battles to gain access to the city's dwindling resources. In 2000, the Musharraf dictatorship launched a Karachi

was lack of transport. Pashtun and Development Programme. But this plan departed from the "social democratic" tenor of the previous (unimplemented) plans and adopted "neo-liberal" ideas. This meant putting more money in extravagant building schemes and less on the city's degrading infrastructure. For example, according to Hasan, whereas in the past slums became the source of clogging drains with sewage, in the last two decades, the same is being done by high income

Construction of residential areas, both high and low income, on natural drainage routes also continues. Due to clogged drains, these natural routes now go through residential areas and roads, flooding them over and again. Rain run-offs have used these routes for thousands of years but builders fail to take this into account by building on them without any adequate drainage facilities. Ancient Greek texts quote Nearchus as saying "a great storm was raging" when his army reached Krokola, and the storm waters were emptying into the sea. Of course, at the time, there was nothing coming in the way of these waters.

# **Banks sanction Rs 1.63** lakh cr to 42 lakh MSMEs

The finance ministry on Sunday said banks have sanctioned loans worth over Rs 1.63 lakh crore to more than 42 lakh business units under the Rs 3lakh crore Emergency Credit Line Guarantee Scheme (ECLGS) for the MSME sector.

On the disbursement front, however, over Rs 1.18 lakh crore doled out to 25 lakh MSME units, till September 10, which were hit by the COVID-19 pandemic and ensuing lockdowns.

The scheme is the biggest fiscal component of the Rs 20lakh crore Aatmanirbhar Bharat Abhiyan package announced by Finance Minister Nirmala Sitharaman in May to mitigate the distress by providing credit to different sectors, especially micro, small and medium enterprises



under the schemes Aatmanirbhar Bharat Abhiyan package.

As of September 10, as reported by public sector banks (PSBs) and top 23 pri-vate sector banks, "additional Sharing details of other schemes being implemented by credit amounting to Rs 1,63,226.49 crore has been the finance ministry, the statement said banks have approved purchase of portfolio of Rs sanc tioned to 42,01,576 borrowers", the ministry said in a 25,055.5 crore under Rs 45,000-crore Partial Credit 'Amount of Rs 1,18,138.64 Guarantee Scheme 2.0 for NBFCs, HFCs and MFIs to do crore has been disbursed to 25,01,999 borrowers," it said fresh lending to MSMEs and while sharing the progress of individuals scheme as on implementation of various August 28.

Lenders are currently in the process of approval/negotia-tions for additional Rs 4,367 crore, it said. Talking about income tax refunds, it said the department has issued Rs 1,01,308 crore to more than 27.55 lakh taxpayers between April 1, 2020 and September 8, 2020.

"Income tax refunds of Rs 30,768 crore have been issued in 25,83,507 cases and corpo-rate tax refunds of Rs 70,540 crore have been issued in 1,71,155 cases. In fact, all corporate tax refunds up to Rs 50 crore have been issued in all cases, wherever due. Other refunds are under process," it said. With regard to Rs 30,000 crore Special Liquidity Scheme for the stressed non-banking financial companies (NBFCs)/housing finance companies (HFČs)/micro

finance institutions (MFIs).

Discoms' outstanding dues rise 36% to Rs 1.29 lakh cr

Power producers' total outstanding dues owed by distri-bution firms rose over 36 per cent year-on-year to Rs 1.29 lakh crore in July 2020, reflecting stress in the sector.

Distribution companies (discoms) owed a total of Rs 94,704 crore to power gener-ation firms in July 2019, according to portal PRAAPTI (Payment Ratification And Analysis in Power procure-ment for bringing ment for bringing Transparency in Invoicing of generators).

The portal was launched in May 2018 to bring in transparency in power purchase transactions between the generators and discoms.

In July 2020, the total overdue amount, which was not cleared even after 60 days of grace period offered by generators, stood at Rs 1,16,817 crore, as against Rs 75,411

crore in the year-ago period. According to the latest data on the portal, total outstanding dues in July has decreased over the previous month. In June 2020, total outstanding dues of discoms stood at Rs 1,30,118 crore. However, the overdue amount in July 2020 has increased from Rs 1,15,623 crore in June 2020.Power producers give 60 days to discoms for paying bills for the supply of electricity. After that, outstanding dues become overdue and generators charge penal interest on that in most cases.

In order to give relief to power generation companies (gencos), the Centre enforced payment security mechanism from August 1, 2019. Under this mechanism, discoms are required to open letters of credit for getting power supply. The central government had also given some breathers to discoms for paying dues to power generating companies (gencos) in view of COVID-19-induced lockdown. The government had also waived the penal charges for late payment of dues in the directive.

# Credit guarantee for startups soon

The Department for Promotion of Industry and Internal Trade (DPIIT) is working on two schemes -- credit guarantee and seed funds -- to support startups in the country, a top government official has said. DPIIT Secretary Guruprasad

Mohapatra said that an interministerial consultation process is on to work out the contours of the two schemes. We are working on a credit

guarantee scheme and a seed fund scheme. Both are under inter-ministerial consultations," the secretary told PTI. He said there would be a

corpus in the credit guarantee scheme which would be given to banks and they will leverage that to lend to startups. This scheme would give banks a

comfort to lend, he said adding that it is for credit not for venture capital.

"This is for capex credit," Mohapatra added.On the seed fund scheme, Mohapatra said that most startups actually face problems in raising finance or funds in the ideation to the proof of concept stage. Some states like Gujarat and Kerala already have schemes like seed funds, but they are small, he said. "The central government ministries also have, but we want to put a pan India scheme," the secretary said. Both the schemes would require approval of the finance ministry and then the DPIIT would seek nod of the Union Cabinet for these two schemes. The department is encouraging states to develop their startup policy to promote budding entrepreneurs.

# India's coal import drops 35% in Aug

India's coal import declined by 34.9 per cent to 12.46 million tonnes (MT) in August on account of subdued demand for the dry fuel from consuming sectors like power and cement.

The country imported 19.14 MT of coal in August last year, according to provisional compilation by mjunction, based on monitoring of vessels' positions and data received from shipping companies.mjunction, a joint venture between Tata Steel and SAIL, is a B2B e-commerce company that also publishes research reports on coal and steel verticals. Also, the first five months of the current fiscal saw 32.51 per cent decline in coal import at 73.08 MT, over 108.29 MT during the year-ago period, it said. Coal India (CIL), which accounts for over 80 per cent of domestic coal output, has been mandated by the government to replace at least 100 million tonnes of imports with domestically-produced coal in the ongoing fiscal.

Attributing the rise in inflation to supply-side frictions, Chief Economic Adviser K V Subra manian has exuded confidence that retail inflation will come down in the days ahead with the easing of lockdowns. According to the government data, retail inflation rose to 6.93 per cent in July, mainly driven by rising prices of food

items like vegetables, pulses, meat and fish. However, wholesale pricebased inflation declined 0.58 per cent in July, even as food items turned costlier.

"If you look at inflation ... it's primarily because of those supply-side frictions, but as local lockdowns are actually being reduced, these frictions should basically go down," he told PTI. "Overall, the difference between wholesale and retail inflation is primarily due to supply-side factors which should decrease and therefore going forward even the retail inflation should ease," Subramanian said.

There are fears that retail inflation would remain at an



of the year limiting the scope for the RBI to further ease the benchmark interest rate.

The six-member Monetary Policy Committee (MPC) headed by the RBI Governor has been given the mandate to maintain annual retail inflation at 4 per cent until March

31, 2021, with an upper tolerance of 6 per cent and a lower tolerance of 2 per cent. Retail inflation so far has

been in the tolerance range of MPC except for breach in July. In June, retail inflation was 6.09 per cent. At the same time, WPI

inflation in June was at (-) 1.81 per cent, while for the month of May and April it was (-) 3.37 per cent and (-) 1.57 per cent respectively. anufacturing shrank 39.3 per cent, construction contracted 50.3 per cent,

mining output fell 23.3 per cent, and electricity and gas elevated level during the rest segment dropped 7 per cent.

SBI Card is in the process of enrolling "delinquent" customers, who did not repay after the end of moratorium, in the RBI restructuring scheme or its own repayment plan to provide them more time for repayments, a top company official said.Due to the moratorium, a number of customers had not been paying for the first three months and the company treated them as standard accounts in line with the entire industry. However, since then, as the first moratorium ended, SBI Card made it a customerled enrolment in the second moratorium in which a lot of customers did not enrol, SBI Card Managing Director & CEO Ashwini Kumar Tewari

said. "Therefore, we had a large chunk of customers who came out of the moratorium. A lot of them paid up but many of them did not pay also. And these became what we call as more delinquent customers.

"So with these delinquent customers, we are now working to enrol them either into



the RBI restructuring scheme or our own repayment plans so that they get more time and better interest rate to pay their

dues," Tewari, who took charge over a month ago, told PTI in an interview. According to the company, it had Rs 7,083 crore under

moratorium in May which came down to Rs 1,500 crore in June. Those who would be availing the company's restructuring plan will have a benefit over the RBI restructuring plan as SBI Card will not report such cases to the credit scoring agency CIBIL. In March, the RBI had

allowed the first three-month moratorium on payment of all term loans due between March 1, 2020 and May 31, 2020.

Later on, it was extended for another three months till August 2020.

The process of restructuring is going on currently, Tewari said, adding a large number of accounts are to be enrolled and the company needs to make a 10 per cent provisioning on these accounts as per the RBI guidelines.

Besides, there are some accounts that surely have become NPA (non-performing) due to the pandemic and therefore additional provisions need to be created for that, he said. "However, we will be very cautious, even if we get to that number (provisioning), we would still like to provide more because the future is still uncertain," he added.

State-owned UCO Bank has not been able to make an analytical study of its asset quality even after the end of the loan repayment moratorium period on August 31, heeding a Supreme Court directive that no accounts shall be downgraded for now, an official said. On September 3, in a relief to stressed borrowers who are facing hardship due to adverse impact of the COVID-19 pandemic, the top court had said that accounts which were not declared as non-performing assets till August 31 this year, shall not be declared NPA till further orders. The apex court had also





With millions around the world stuck at home due to the pandemic. "plane cafes" in Thailand are offering customers the chance to pretend they are in the sky -- and the

On board a retired commercial airplane in the coastal city of Pattaya, coffee drinkers make themselves comfy on first-class-style seats and pose for photos by the overhead lockers. Boarding passes in hand, some "passengers' even opt for a tour of the cockpit. "With this cafe I can sit in first class and also mess around in the cockpit pretending to be the captain of the plane," 26-year-old Thipsuda Faksaithong said. "It's a lot of fun." Chalisa Chuensranoi, 25, said her visit was as good as any trip she had taken before the pandemic, which shuttered Thailand's borders in March. "Sitting right here in the first-class section... really gives me the feeling of actually being on a plane, cruising through the air," she said. In another cafe at the headquarters of national carrier Thai Airways in Bangkok, hungry diners appear even to have missed plane food as they gobble up spaghetti carbonara and Thai-style beef served on plastic trays by cabin crew. But for Intrawut Simapichet, 38, who came to the cafe with his wife and baby, the experience is about more than a meal.
