Kumbh ends after Modi's appeal 10 lakh new cases in Covid test, quarantine just 7 days in India After PM's urge, opinion grows in favour

of holding rest of Shahi Snans symbolically

PNS HARIDWAR/NEW DELHI

fter Prime Minister After Filme Manager to keep the remaining part of Kumbh Mela symbolic con-sidering the surging Covid-19 cases, the Juna Akhada Acharya Mahamandaleshwar Swami Avdheshanand Giri on Saturday announced the formal conclusion of the Maha Kumbh for the Akhada.

Panch Dash Nam Juna Akhada is the largest of the 13

Swami Avdheshanand Giri said the remaining Shahi Snan of the Kumbh should be observed symbolically on April 27 and later tweeted that protecting the lives of Indians is

"our first priority".

"Considering the rising threat of Covid-19, we have for-mally immersed the various deities invoked for the Kumbh Mela," he said.

Earlier in a tweet in Hindi, the PM said, "I prayed that two 'Shahi Snan' have taken place and Kumbh (participation) should now be kept symbolic. This will boost the fight against this crisis."

Later, Modi thanks all the sants for cooperation with the administration and expressed

his gratitude for their gesture. Thousands of Kumbh visitors have tasted Covid-19 positives and dozens of seers have

succumbed to the virus during the last two weeks inviting both domestic and international outrage for allowing such massive gathering at the time when the second wave of Covid-19 was spreading like wildfire across the country.

Earlier, addressing the media here, Giri said the PM had telephoned him to enquire about the Kumbh Mela and the health of the seers. The PM had also requested that since the main Shahi Snans have concluded, the remaining Kumbh should be observed symboli-cally. The Juna Akhada head said he would request devotees from across the nation to visit Haridwar only in small numbers, adding that the remaining Shahi Snan will be observed

only symbolically

The remaining Snans are to be observed mainly by the Bairagi Akhadas. Earlier, the Niranjani Akhada had asked its Sadhus to leave for their respec-tive destinations on April 17 considering the Covid surge. The Anand Akhada had also supported this view.

A majority of the 48.51 lakh people who took part in the last two royal baths (Shahi Snan) held on the occasion of Somwati Amayasya on April 12 and Mesh Sankranti on April 14 were seen openly violating Covid norms like face masks and social distancing.

The Kumbh has already

been shortened this year to just one month from April 1 to 30 due to the pandemic.

# to welcome returning devotees back home

The ordeal of Covid-19 test and quarantine awaits thousands of devotees who are returning home after attending the Maha Kumbh at Haridwar. As India grapples with a devastating second wave of the coronavirus and States imposing lockdown, several States and UTs, including Karnataka, Madhya Pradesh, Maharashtra, Delhi and Gujarat, have made Covid-19 test mandatory for Kumbh returnees. Some States are also keeping the returnees in mandatory quarantine.

Thousands of Kumbh vis-

itors and hundreds of "sadhus" who attended Kumbh Mela in Haridwar have tested positive for the coronavirus disease On Saturday alone, 175 "sadhus" who attended Kumbh Mela have been found infected from coronavirus.

Gujarat on Saturday declared that all devotees returning to the State from Kumbh Mela will have to undergo a mandatory RT-PCR test before they are allowed to enter their respective cities and villages.

Maharashtra Minister Anil Parab has announced those coming into the State from Kumbh Mela will be quarantined. Nasik district adminis-tration is also taking necessary steps for quarantining those coming from Kumbh

Earlier, Brihanmumbai Municipal Corporation (BMC) mayor Kishori Pednekar claimed on Saturday that the devotees returning from the Kumbh Mela will distribute coronavirus like "Prasad" and said they should be quarantined "at their own cost" on their arrival

The Madhya Pradesh Government has issued order to put those returning from Kumbh in quarantine or self-

# **Record over 2.6L** cases in a day; Delhi, Maha too see highest rise

India added nearly 10 lakh cases in just seven days ending April 17 as the country recorded over 2.6 lakh new Covid-19 infections and a record 1,493 deaths during the last 24 hours on Saturday.

The addition of nearly

25,000 new cases over the previous day count amounts to a rise of nearly 10 per cent, which shows that the growth of Covid-19 has more than dou-

Covid-19 has more than doubled during the last two weeks.

Amid the alarming rise in new infections and deaths, the country is battling a paucity of hospital beds, oxygen supply, ventilators, and life-safe antiviral drug Remdesivir. A major-

ity of the State have also complained of a shortage of vac-cines and shut down several vaccination centres.

Several States have belat-edly imposed lockdown restriction to tackle the surge, but it is too early to see if these are going to work effectively at this stage on the ground.

Delhi and Maharashtra

recorded their biggest single-day rise in coronavirus cases since the beginning of the pandemic in January 2020. The national Capital registered over 24,375 new cases, taking its tally to 8,27,998, while Maharashtra's count rose to 3,7,70,707 with 67,123 new infections. The death count in Delhi rose to 11,960 with 167 fatalities

# Maha threatens to seize Remdesivir exporting stocks

# **CM** complains of shortage of liquid oxygen, anti-viral drug

fter a bitter stand-off over After a bitter stand on one that the alleged discrimination in the distribution of vaccines, the Maharashtra Government on Saturday flagged the shortage of liquid medical oxygen and Remdesivir in the State and even threatened to seize the stocks of Remdesivir from the exporting firms and supply them to the needy

On a day when Chief Minister Uddhav Thackeray charged that he could not speak to Prime Minister Modi over the immediate requirement of liquid medical oxygen and Remdesivir vials as the latter

was pre-occupied with West Bengal Assembly elections, senior Minister Nawab Malik accused the Modi Government of meting out "step motherly" treatment to the State over the

supply of Remdesivir vials.

Not to be outdone,
Minister of Railways, Commerce & Industry Piyush Goyal launched a virulent attack on Uddhav whom he attack on Uddnav whom he accused of indulging in "petty politics" and said "he (the Chief Minister) needs to stop his daily dose of shameless politically and the stop of the

itics and take responsibility." Earlier in the day, Uddshav said, "Yesterday evening, I dialled him (Modi) but I could not speak to him as he was busy in West Bengal elections." Uddhav said he wanted to discuss the issue of shortage of liquid medical oxygen and Remdesivir injection vials, both live-savers in case of critical Covid-19 cases. He, however, said the State Government was receiving cooperation from the

# **Remdesivir price** drastically cut on **Govt intervention**

In the wake of increasing demand for anti-viral drug Remdesivir from across the States, the Centre on Saturday urged the injection makers to slash its price considerably. The Union Health Ministry in its "Clinical Management Protocols for Covid-19" has recommended the use of Remdesivir in patients in the moderate stages of the illness.

According to a statement

from the Government, the Union Ministry of Chemicals & Fertilisers, Department of A rertinsers, Department of Pharmaceuticals, NPPA -Advisor (Costs) NI Chowdhury on Saturday ordered all pharma compa-nies to comply with the revised norms with immediate and retrospective effect. retrospective effect.

Pharmaceutical companies have reduced the price from 25 per cent to up to 68 per cent.

According to the details shared by the NPPA, Cadila



Healthcare has reduced the price of its REMDAC injection to ₹899 from ₹2,800 earlier.

Similarly, Syngene International has cut the price of its brand RemWin to ₹2,450 from ₹3,950 earlier. Hyderabad-based Dr Reddy's Laboratories has cut the price of REDYX, which used to cost ₹5,400 earlier to ₹2,700 now. Similarly, Cipla has reduced price of its CIPREMI brand to ₹3,000 from ₹4,000 earlier. Jubilant Generics has cut the price of its remdesivir brand to ₹3,400 from ₹4,700

# Delhi gasping for oxygen: C City logs 24,375 cases in 24 hrs; Kejriwal seeks Centre's help

Terming the situation serious in the national Capital, Arvind Kejriwal on Saturday said, "In the last 24 hours, there have been around 24,000 cases. A day before, there was around 19,000 cases. So, the tally spiked only in a matter of 24 hours."

The Delhi Chief Minister said he has spoken to Union Health Minister about the extreme shortage of oxygen beds in Delhi, and added that in November last year, the Central Government allotted the Delhi Government 4,100 beds at a peak of 8,500 cases, however, this time, they have only provided 1,800 beds, even after this wave being three times more fatal than the pre-

"Delhi is facing a shortage of oxygen, Remdesivir, and Tocilizumab, which must be made available by the Central Government for adequate treatment of corona patients, Kejriwal said.

Meanwhile, the weekend curfew aimed at breaking the

resumed to resolve the issue. Vij had said he was concerned as a large number of farmers were sitting on

Harvana's borders amid a surge in Covid-19 cases in the State. Haryana Chief Minister

ML Khattar had also urged farmers and the Centre to resume talks. "I would like to bring to your kind attention that our

Annadattas' are on roads at Delhi border agitating in respect of newly enacted three farm laws of the Central government. It is a matter of concern that such agitation is going on for more than a hun-dred days," Chautala wrote in the letter. Chautala said he believes every problem has a solution by way of mutual dis-

# Recovery percentage drops, Doon, Haridwar reel under the onslaught of contagion

 $B^{\text{reaking all records of numbers and fatalities the con-}}$ tagion of novel Coronavirus (Covid-19) has gathered explomomentum Uttarakhand. The state health department reported 2757 cases of the disease with 37 casualties. The state now has 121403 (cumulative) cases of the disease while the death toll has mounted to 1856. deteriorated.

The health department discharged 802 patients from different hospitals of the state following their recovery from the disease on Saturday. A total of 101659 patients have recovered from the disease in the state and the recovery percentage has now dropped fur-ther to 83.74 and the sample

positivity rate is 3.68 percent.
The provisional state capital Dehradun, Haridwar, Udham Singh Nagar and Nainital districts are continuing to reel under an onslaught of the disease. In Dehradun 1179 cases of the disease were reported while 617 new patients surfaced in Haridwar district on Saturday. The

authorities also reported 265 patients from Udham Singh Nagar, 248 from Nainital, 155 from Pauri, 79 from Rudraprayag, 51 from Almora, 50 from Tehri, 44 from Champawat, 28 from Chamoli. 15 from Bageshwar, 14 from Uttarkashi and 12 from Pithoragarh. The senior BJP leader Bachi Singh Rawat was airlifted to AIIMS Rishikesh on Saturday after his condition

erioratea. The Sushila Tiwari vernment Hospital Government Haldwani reported an unprecedented number of deaths on Saturday. Here 16 patients of Covid-19 were reported dead on Saturday. Three patients each were reported dead at the Himalayan hospital and Mahant Indiresh hospital Dehradun on the day. Similarly two patients each died at All India Institute of Medical Sciences (AIIMS) Rishikesh, Government Doon Medical College (GDMC) hospital Dehradun, Mahant Indiresh hospital, Military hospital Dehradun and Arihant hospi tal Dehradun. One patient each succumbed to the disease at

Nainital, SDH Narendra Nagar, district hospital Chamoli, District hospital Gopeshwar and HNB Base hospital Srinagar on Saturday.

The state now has 15386 active patients of the disease. Dehradun continues to be at the top of the table of active cases of the disease with 6398 patients, Haridwar has 4481, Nainital 1577, Udham Singh Nagar 866, Pauri 599, Tehri 399, Almora 230, Champawat and Rudraprayag 219 each, Bageshwar 123, Chamoli 110, Pithoragarh 87 and Uttarkashi 78 active cases of Covid-19. In the vaccination drive

40309 people were vaccinated in different parts of the state on Saturday. In the state 232177 people have been fully vacci-nated so far as they have received both the first and second dose of the vaccine.

Employees of industrial units where work is done in shifts, movement of people and goods for emer-gency operation on national and state highways, those involved in loading and unloading of goods carriage vehicles, those going to their destination after deboarding buses, trains and flights, and those involved in marriage functions will be allowed relax-ation during the restrictions. Citizens aged above 65 years, those with comorbidities, pregnant women and children aged below 10 years are advised to remain indoors and venture out

only if necessary.



The director of the AIIMS Rishikesh Dr Ravikant said that the strain of the virus has undergone mutation. He added that the patients are not getting enough time for treat-ment as the initial symptoms are not clearly visible. The AIIMS director stated that the new virus is so deadly that it is able to infect people at a speed of about five times more than the first wave

# A saga of confusion & changed strategies

PM Modi's tweet on symbolic Kumbh vindicates stand taken by former CM Trivendra Singh Rawat on organising a limited Kumbh

The appeal of the Prime Minister Narendra Modi for a symbolic Kumbh in Haridwar in the wake of grim situation of pandemic of Covid-19 has not only highlighted the failure of authorities concerned in ensuring a safe Kumbh but also vindicated the stand taken by former chief minister Trivendra Singh Rawat on the manner in which the grand event should be organised. The experts believe that a change in strategy on the organisation of the Kumbh with the change of chief minister last month also created a situation of confusion among the Kumbh Mela authorities which also resulted in late and faulty planning and its imple-

It is well known fact that the former CM was in the

favour of a limited Kumbh to minimise the chances of the event becoming a super spreader of Covid-19. Though his stand had annoved some sections of the religious fraternity but the government during his tenure was firm on giving pri-ority to safety over the religious sentiments. It should be recalled that in the first week of February when the signs of second wave of Covid-19 were clearly visible in some states, the Uttarakhand government had made plans to put a cap on number of devotees for the Kumbh. The chief secretary Om Prakash had even requested the Indian Railways not to run any special trains for the event. The state government had taken a stand that pilgrims would be allowed to enter Haridwar only on production of a negative report of RT-PCR test. This plan of action for a limited Kumbh got changed with the change of chief minister Immediately after assuming charge, the new chief minister Tirath Singh Rawat announced that there would be no unnecessary restrictions on the pilgrims as the mega reli-

gious event is organ-ised after a gap of 12 years. He however stressed that Covid-19 protocol would be followed and authorities would enforce a safe Kumbh. The change in the plan also created confusion among the organisers. On the intervention of Uttarakhand High Court (HC) which ordered that the negative RT-PCR test report should be mandatory for the pilgrims, the admin-

istration made preparation of checking the borders. The HC also directed that the authorities should ensure at least 50,000 Covid-19 tests daily on the borders during the Kumbh, however this figure was not achieved by the Mela authori-

With the advent of Kumbh which saw congregation of about 50 Lakh pilgrims on two Shahi Snans on April 12 and 14 the contagion of the Covid-19 also gathered

momentum. Many saints including the President of Akhil Bharatiya Akhada Parishad (ABAP) Swami Narendra Giri became positive for the disease during their stay in Kumbh. The data of the state health department clear-ly show that the number of cases of Covid-19 in Haridwar

with the progress of Kumbh. On March 31, a day before the Kumbh started the state health department reported only 70 cases of the disease.

This figure bounced to 149 on April 1 and climbed to 613 on April 15, a day after the Shahi Snan of Baisakhi. The founder of the Social

Development for Communities (SDC) foundation, Anoop Nautival said "The fact that PM nad to make an appeal to curtail Kumbh vindicates that the state government and Kumbh Mela authorities failed in ensuring a safe Kumbh. Their claims of making adequate pandemic safety preparations have fallen flat."

# Safety of people should be priority: Trivendra

In an attempt to garner sympathy of voters the BJP has fielded Mahesh Jeena who is the elder brother of Late Surendra Singh Jeena from Salt. Though the result of the By-election would have no impact in the assembly where the BJP enjoys an overwhelming majority, the prestige of chief minister Tirath Singh Rawat, former CM Harish Rawat and newly appointed state chief of BJP Madan Kaushik is at stake here

# Haryana records highest single-day spike of 7,717 infections

Thirty two more fatalities due to the viral disease were reported in the State in a span of 24 hours, pushing its overall death toll to 3,386, according to a health department bul-

Of the fresh cases, Gurugram, the worst-hit district in the state, accounted for 2549, its highest single-day spike so far. Among other districts that reported a big spike are Faridabad (987), Karnal (477), Sonipat (646), Panchkula (349), Hisar (507), Ambala (173), Kurukshetra (201) and Sirsa (231), the bulletin said.

On Friday and Wednesday, the State had recorded 6277 and 5858 coronavirus cases

Among the latest deaths, five each were from Faridabad and Panipat, three were from Hisar, Karnal, Rohtak and two each from Gurugram, Ambala, Panchkula, Palwal and Jind. One each from Fatehabad. Yamunanagar, Kurukshetra

The number of active Covid-19 cases in Haryana stands at 38558. So far, 3,07,850 people have recovered from the disease, and the state has a recovery rate of 88.01 per cent, the bulletin said.

Amid rising COVID-19 cases in the State, the Harvana government has decided to allow officials equal to the rank of under secretary or below to work from home and restrict their physical atten-dance in offices to 50 per cent. A letter in this regard has been issued by the Chief Secretary's

Officers of the level of deputy secretary, equivalent and above are to attend offices on a regular basis, it said. According to the order, rosters



to be prepared by divisional and wing heads and if required, they can call for more than 50 per cent physical attendance on administrative grounds. Officials who do not attend office on a particular day will make themselves available on phone and other electronic means of communication at all times from their residence and work from home, it said.

PUNJAB REPORTS HIGH EST SINGLE-DAY SPIKE OF 4498 CASES, 64 MORE DIE Punjab's daily Covid-19 cases

on Saturday, taking the State's cumulative tally to 2,95,138, according to a medical bulletin.

The state's previous biggest jump of 4333 Covid-19 cases was reported on April 15 while 3,477 cases on April 12. Punjab's death toll climbed to 7834 as 64 more people succumbed to the disease, the bulletin said. The number of active cases increased to 32499 There are 46 critical patients who are on ventilator support while 401 are on oxygen support, it said.

Ludhiana reported the

highest number of fresh cases at 835, followed by 790 in SAS Nagar, 449 in Jalandhar, 372 in Patiala and 352 in Amritsar. Of the latest fatalities, 10 were reported from SAS Nagar, seven from Patiala, six each were reported from Amritsar, Ludhiana and Gurudaspur; four each from Tarn Taran and Bathinda.

A total of 2615 coron-

avirus patients were discharged after they recovered from the infection, taking the total number of cured persons to 2,54,805. So far, 65,61, 028 samples have been collected for testing in the state, it added.

431 CASES, 2 DEATHS IN

CHANDIGARH Chandigarh on Saturday reported two deaths and 431 cases of coronavirus, taking the infection count to 33,309 in the joint capital of Punjab and Haryana. It had on Friday recorded 481 Covid-19 cases, the highest single-day since global pandemic struck. Last year, on September 13, Chandigarh logged 449 cases.

With two deaths, so far, 410 people have died from the infection in the union territory, according to a medical bulletin. The number of active cases stood at 3414. A total of 438 patients were discharged after they recovered from the infection, taking the number of cured persons to 29,485. A total of 3,58,865 samples have been taken for testing so far.

12 DEATHS, 1,392 NEW

CASES IN HIMACHAL The COVID-19 death toll in Himachal Pradesh rose to in Himachal Pradesh rose to 1,167 on Saturday with 12 more fatalities, while 1,392 new cases took the infection count to 75,587, an official said. The active cases in the state climbed to 8,444, the official

Special Health Secretary Nipun Jindal said three people each died in Shimla and Kangra, two in Solan and one each in Sirmaur, Mandi, Kullu and Lahaul-Spiti districts. Meanwhile, 647 people recov-ered from the disease in the past 24 hours, he added.

Punjab procures 86% of wheat arrived so far in mandis, Sangrur leads

Punjab Government on Saturday said that 29.65 LMT of Wheat has arrived so far in mandis across the State of which 25.61 LMT i.e 86.37 per cent has been procured within a period of just one week from April 10 despite the challenging task amid Covid-19 pandemic. Expressing satisfaction

over the ongoing wheat pro-curement operations and arrangements put in place to facilitate all stakeholders, the Secretary Mandi Board and Director Food & Civil Supplies Ravi Bhagat pointed out that district Sanguru is leading in terms of Wheat arrival where 4.76 LMT of Wheat had arrived in the mandis, followed by Patiala and Mansa with 3.87 LMT and 2.32 LMT respectively. He said that the targeted procurement of Wheat in the state is 130 LMT during ongoing Rabi Marketing Season. He said that 5.74 lakh passes have already been given to farmers through Arthiyas by Mandi Board and various Market Committees in view of wheat due to Covid-19.
Regarding the problems faced by farmers and delay of crop payment, Bhagat pointed out that the DBT system had been introduced for the first time from this season, adding that there were some teething prob-lems due to some technical issues, which were being resolved at the earliest by the Food and Civil Supplies Department on priority so that this system to be made more streamline and also to ensure timely payment to the farmers.

The Secretary Mandi Board today visited the Mandis of Shaheed Bhagat Singh Nagar district to take stock of the ongoing procurement operations. During interacting with Various stakeholders in the T Sharma | Pioneer Photo | Rahon, Nawanshahar and

Balachaur mandis, the Secretary clarified that there is no shortage of Bardana and state has sufficient stock and need now worry about it. He also assured that the Government was fully committed to procure every single grain the farmers produce in

these difficult times.

Emphasizing the need to Emphasizing the need to strictly adhere to the health protocol especially the social distancing, Bhagat appealed to all the stakeholders to comply with these preventive mea-sures for their health and safe-ty. Divulging details about the preventive measures being taken in view of coronavirus, the Secretary said that Punjab Mandi Board has also made

elaborate arrangements to strictly observe health protocol. By providing 10,000 masks (N-95) and 10,000 bottles of sanitizers to its 5600 officials/staff so as to ensure smooth and hassle free pro-curement of wheat in difficult phase due to COVID-19 pandemic. Mandi Board also arranged another one lakh masks and 35,000 liters sanitizers for providing to the farmers during their arrival in purchase centres.

#### SAD ASKS PUNIAB GOVT TO REMOVE HURDLES IN WHEAT PURCHASE

The Shiromani Akali Dal (SAD) on Saturday said the Congress-led government in Punjab must remove "hurdles" in wheat procurement or else it would hold state-wide protests.

Even though wheat pro-curement started 10 days late, it was further delayed due to "lack of preparedness" on the part of the state government, SAD leader Prem Singh Chandumajra said in a statement issued here. He claimed that "severe shortage" of gunny bags was set to lead to a glut in mandis (agricultural markets) which are already fac-

"In this regard, a team consisting of three to four senior cabinet ministers may lead the delegation for resuming talks with farmers so as to bring an amicable conclusion in this issue," he wrote in his letter dated April 15.

The deputy chief minister wrote the letter days after state's home minister Anil Vij's missive to Union Agriculture Minister Narendra Singh Tomar, saying talks with peasants should be resumed to resolve the issue. Vij had said he was concerned as a large number of farmers were sitting on Haryana's borders amid a surge in COVID-19 cases in the state.

Haryana chief minister Manohar Lal Khattar too has appealed to the farmers to end their agitation due to the increase in the number of Covid cases in the state.

Himachal Pradesh Chief Minister Jai Ram Thakur on Saturday said over 90 per cent of the Covid patients are under home isolation in the Presiding over a virtual

review meeting of Covid-19 sit-uation in Sirmour district from Nalagarh, he said special thrust must be laid on increasing the number of tests to detect covid-19 patients besides strengthening the mechanism of home isolation in the State.

He said that doctors must ensure proper treatment and regular monitoring of the patients under home isolation, adding that the health department must regularly monitor health parameters of the patients under home isolation He said that elected representatives of the panchayati raj institutions must also be involved to keep a watch on the health conditions of those under home isolation.

Thakur said that the indus-trialists of Kala Amb and Poanta Sahib areas must be asked to ensure that the workers in their units strictly follow the SoPs and guidelines issued by the State Government to check the spread of this virus He said that focus should be laid on contact tracing of the covid-19 positive patients.

# Every second Covid-19 infected patients admitted at PGIMER: PGI Dean (Academic) Dr GD Puri

GD Puri, Dean Dr GD Puri, Dean (Academics) and Head, Department of Anaesthesia and Intensive Care Post Graduate Institute of Medical Education and Research (PGIMER) on Saturday said that every second Covid-19 infected patient admitted at PGIMER, Chandigarh is below 45 years of age. He said the new strain apparently affected younger patients and spread much faster than the earlier strain Patients (young) should saturation falls below 94 per cent or drops after walking and immediately report to PGIMER, he adds.

He says that Punjab and Chandigarh region is now witnessing peak of the second wave of covid-19 pandemic. This peak may continue for another couple of weeks. The decline of Covid-19 cases in this region may witness after mid-May onwards, he adds.

Dr Puri further says that both the vaccines Covishield and Covaxin are very much effective against new variants. The Covid vaccine reduces severity of illness, even if the rson gets an infection after taking the vaccine, then it reduces the chances of hospi talisation. The vaccine will help to build the herd immuhence it would help to contain the pandemic. In an interview with The Pioneer, Dr GD Puri talks about Covid situation in Chandigarh after confirmation report of UK variant as well as arrangement for Covid-19 and non-Covid-19 patients at PGIMER, Chandigarh: Excerpts from the interview:

The number of Covid-19 cases in Chandigarh is increasing. How do you read the new numbers? Is UT now witnessing the peak of the second wave of pandemic?

Yes, this region (Punjab and Chandigarh) is witnessing the peak of the second wave of covid-19 pandemic. This peak may continue for another couof weeks. We may see a decline of Covid-19 cases after mid-May onwards. As much as people will continue to adhere to Covid appropriate behaviour, the pandemic will be contained at the earliest.

How is the second wave of covid-19 different from the first wave of the pandemic?

In the first wave of the pan-demic, the Covid-19 illness used to give a time of seven days, and the condition of patients used to deteriorate after the seventh day. This time, a lot of younger patients are deteriorating faster in just 4-5 days. In the first or second CT scan itself, lung involve-ment is diagnosed in patients. Patients are complaining with Covid pneumonia, breathless ness, chest tightness and abdominal symptoms like diarrhoea. The cough is coming late in these patients and high grade fever is there. This strain is highly contagious as all fam-

ily members are getting infected, including children. Getting a flu shot lessens the risk of severe influenza (flu) among adults, including reducing the risk of hospitalisation and admission to the intensive care unit (ICU), and also decreases the severity of illness. We all must wear face masks, maintain social distancing and adopt hand hygiene daily otherwise we will continue to face many more waves of the contagion.

Some people including Chandigarh DGP Sanjay Beniwal were infected by covid-19 even after taking both the doses of the vaccine What would you say?

It is early to say anything on. Both Covishield and Covaxin are very much effective against new variants. Getting a flu shot decreases the risk of severe influenza (flu) among the people and also the severity of illness. The vaccine will help to build the herd immunity hence it would help to contain the pandemic. Both Covishield and Covaxin are very much effective against new variants. One should follow Covid Appropriate behaviour even after vaccination because it will take time to develop antibodies against the virus. The priority groups of the population should get vaccinated against Covid-19 disease which will help to protect against this disease and reduce the intensity/severity of the disease which will further help in breaking the chain of the Covid-19 transmission.

Do you think, Covid-19 cases increased in Chandigarh due to the UK variant? Which age groups of people are infected more from the UK variant? Covid- 19 cases surging at

wave than the first wave in this region and UK variant could be responsible for this faster rate as it was proved by the latest findings of the PGIMER samoles sent to National Centre for Diseases Control (NCDC), New Delhi. UT and neigh bouring States including Punjab had witnessed the first wave of Covid-19 peak in September last year. Currently, this region has been witnessing the second wave of Covid-19 peak. 50 percent of total patients having

moderate and severe symp toms of Covid-19 admitted in PGIMER are below 45 years of age. A lot of younger patients need intensive care treatment and many of them are in their 20s or 30s only. The patients are deteriorating faster than before and developing severe illness. The deterioration was slow last time as the oxygen saturation used to dip at a slower pace. This time, the oxygen saturation dips faster as soon as it dips below 95 if there is lung involve ment. Considering the high transmission and faster spread of Covid-19 by the UK variant, it is suggested that everyone follow Covid should Appropriate Behavior.

After a confirmation report of UK variant among Covid-19 patients in Chandigarh, what are the additional arrangements made at PGIMER?

Only, patients having moderate and severe symptoms of Covid-19 are admitted at Covid hospital in PGIMER which has increased its beds for Covid-19 patients from 200 to 300 out of which 50 are of ICU beds. We are seriously following Centre Government's

guidelines including 'Test, Track and Treat' to stop this emerging peak of the virus. have scaled up the rate of RT-PCR tests, with a special focus on those areas where positive rates are high in Chandigarh. We are taking all measures to ensure that every patient can get treatment.

Whether any health workers of PGIMER are infected to

Covid-19? PGIMER has about 2000 doctors and 2000 nurses. Around 250 health workers of PGIMER have isolated them selves in the last one and half months (second wave of the pandemic). In the first wave of Covid-19, around 1500 health workers were infected to covid-19. We have a sufficient number of health workers to take care of the patients admitted here in PGIMER.

Amid a surge in Covid-19 cases, Chandigarh administration imposed weekend more steps should be taken to contain the peak of the pandemic?

The need of the hour is to

contain the peak of the pandemic. We must take precautions as the cases are on rise again. Chandigarh administration has taken several steps including shutting down gymnasium and spa among others to contain the pandemic. At the same time, people must adhere to the safety protocol like washing hands thoroughly with soap or using sanitizer, wear masks and maintain social distancing.

# Wearing 2 face masks more effective in beating Covid: Study



Wearing two face coverings or masks can nearly double the effectiveness of filtering out SARS-CoV-2-sized particles, preventing them from reaching the wearer's nose and mouth and causing Covid-19, as per a recent study.

The findings published in JAMA Internal Medicine also

states that the reason for the enhanced filtration is not about adding too many layers of cloth but eliminating any gaps or poor-fitting areas of a mask.


"The medical procedure masks are designed to have very good filtration potential based on their material, but the way they fit our faces isn't per-fect," said Emily Sickbert-Bennett, PhD, associate professor of infectious diseases at the UNC School of Medicine and lead author of the study

# **DRDO** setting up hosp in Ahmedabad for Covid patients

he Centre has conveyed to the Gujarat Government 900-bedded hospital in Ahmedabad to cater to the "alarming surge" in Covid-19

The Union Home Ministry has also directed the Central Armed Police Forces (CAPFs) or the Central paramilitary forces to spare 25 doctors and 75 paramedics and ensure that they report by April 21 to man the hospital in Gujarat.

'The hospital is being established at the Gujarat University Convention Centre, Ahmedabad to cater to the alarming surge of the Covid cases there," reads an order issued by Additional Director General (Medical) of CAPFs under the Union Home Ministry on Friday. It has further been decid-

ed and conveyed that CAPFs are required to provide 25 medical officers and 75 paramedical/nursing staff, reads the order.

"It is, therefore, requested that the following number of doctors and paramedics/nursing staff be detailed for the purpose please," it said.

The detailed staff should report to the nodal officer (Colonel B Chaubey, DRDO Hospital, Ahmedabad by April

21 positively, it said.

Mukesh Saxena has also named officer for making logistical arrangements at Gujarat University.

The letter has been circu lated to Inspector General (Medical) of the Border Security Force (BSF), Centra Reserve Police Force (CRPF) and Sashastra Seema Bal (SSB) The BSF will send 10 doc

tors and 30 paramedics, the CRPF) will spare 10 doctors and 25 nursing staff and SSB to chip in with five doctors and 20 paramedical personnel for the DRDO hospital in Ahmedabad.

Through the communication to the heads of CRPF, BSF and SSB, the Ministry has asked them to send their team on priority and the doctors and paramedics have to report to the nodal officer of the said hospital latest by April 21.

The Defence Research and Development Organisation (DRDO) hospital set to be operationalised by late next ek, officials said.

private vehicle does not A come within the expression of a "public place" as per the explanation given under the Narcotic Drugs and Psychotropic Substances (NDPS) Act, the Supreme Court has said.

A bench comprising justices U U Lalit and K M Joseph made the observation while deciding an appeal challenging an order passed by the Puniab and Harvana High Court affirming their conviction and sentence

The trial court, after considering the evidence on record, acquitted accused Major Singh but convicted accused Boota Singh, Gurdeep Singh and Gurmohinder Singh, under the NDPS Act and sentenced them to rigorous imprisonment for 10

They were also asked to pay a fine of Rs 1 lakh, failing which they were directed to undergo further rigorous

imprisonment for two years.

There are some discussions within the government about the need, shape and timing of a fresh fiscal stimulus

package.

The source said that any such package, if finalised, would come up later this month or next month.

The Union Finance Ministry has so far not indicated about any new stimulus to contain the disruptions caused by the fresh Covid-19

# Indian pharma exports grow at 18% to 24.44 bn USD in FY 21

Pharma exports from India P witnessed over 18 per cent growth to USD 24.44 billion during the last financial year against USD 20.58 billion in FY20, Pharmaceuticals Export Promotion Council of India (Pharmexcil) said on Saturday.

"We have observed a big leap in our exports in the month of March 2021 which is USD 2.3 billion (figures for March are provisional) and is highest among the exports of all the months of this financial year, the growth rate for this month is 48.5 per cent against the exports in March 2020 (USD 1.54 billion)," Udaya Bhaskar, Director General of Pharmexcil said in a release.

Growth rate seems relatively big as the exports of March 2020 was crunched due to lockdown across the world and supply chain disruption, he

was quoted as saying.
When the global pharma
market is negatively grown by
1-2% in 2020, there is a big
surge in demand for Indian made generics owing to its quality and affordability, the official said adding Drug for-mulations and Biologicals is the second largest Principal commodity being exported by India.The Pharma exports body is expecting big growth in Indian vaccine exports in the coming years and the govern-ment policy on PLI (production Linked Incentive) scheme

# Crude to be around \$60 a barrel in 2021

Global crude oil prices are expected to be in the range of \$60 a barrel over the long term period as OPEC+ decision to cap supply until demand recovers and the pandemic continuing to keep a check on consumption.

According to a research report by ICICI Securities, Brent has recovered and is over \$ 60/bbl since February, 21 vs April, 20 low of \$ 21/bbl driven by demand recovery from lows and OPEC+ capping sup-ply to ensure supply deficit since July last year.

"OPEC+ capping supply until demand recovers is esti-





The releases were announced on state broadcast-

er MRTV, which said that junta chief Senior Gen. Min Aung Hlaing had pardoned 23,047 prisoners, including 137 foreigners who will be deported from Myanmar. He also reduced sentences for others.

The move comes as daily protests against the February 1 ouster of the elected govern-ment of Aung San Suu Kyi continue, as does the use of deadly force against them.

According to the Assistance Association for Political Prisoners, which monitors casualties and arrests government forces have killed at least 728 protesters and bystanders since the takeover. The group says 3,141 people, including Suu Kyi, are in deten-

the possibility that for a short period of time, there will have to be some additional enabling capabilities added to Afghanistan, to help effect a safe, orderly, and deliberately planned drawdown of every body by the president's deadline, early September, Pentagon spokesman John Kirby told reporters at a news

conference on Friday. However, Kirby did not elaborate on the nature of the increase in US troops. "I can't speak today with exactly what that would look like, how many, when they would be going in. But as we transitioned out of Iraq, of course, it's logical to assume that you may need some logistics help, maybe some engineering help," he said.

"You may have to add

some force protection capabilities, temporarily, just to make sure that the drawdown goes in a safe, orderly, and effective way. Again, we'll know more as we get closer, but that would not be out of the realm of possibility," Kirby said.

Responding to a question, Kirby said that the Department

of Defense is still working out

what the future bilateral security relationship is going to be with Afghanistan.

"We're going to transition to a bilateral relationship, a military relationship that's more akin to the kinds of relationships we have with other countries," he said.
"It will not include a US

military footprint on the ground in Afghanistan with the exception of what's going to be required to support the diplomatic mission there. All that's still being worked out. So, I can't speak with specificity today about what contract sup-port the Afghan security forces are going to need going forward," he said.

The United States, he said, will maintain counterterrorism capabilities to continue to prevent Afghanistan from becom-

capabilities available to us and we're not going to speak to the details of exactly how we're going to maintain those capabilities and utilise those capabilities," he said.

# Worldwide Covid death toll tops a staggering 3m

The global death toll from the coronavirus topped a staggering 3 million people Saturday amid repeated set-backs in the worldwide vaccination campaign and a deep-ening crisis in places such as Brazil, India and France.

The number of lives lost, as compiled by Johns Hopkins University, is about equal to the population of Kyiv, Ukraine; Caracas, Venezuela; or metropolitan Lisbon, Portugal. It is bigger than Chicago (2.7 million) and equivalent to Philadelphia and Dallas combined.

And the true number is believed to be significantly higher because of possible gov-ernment concealment or the many cases overlooked in the early stages of the outbreak that began 16 months ago in Wuhan, China, at the end of 2019. Around the world, the race to bring it under control vary widely from country to

Japan and the US will take the lead to promote the vision through concrete efforts. We will also cooperate with other countries and regions, includ-ing the ASEAN, Australia, and India," he said. "We also had serious talks

on China's influence over the peace and prosperity of the Indo-Pacific and the world at large. We agreed to oppose any attempts to change the status quo by force or coercion in the East and South China Seas and intimidation of others in the

region," Suga said. Beijing claims almost all of the 1.3 million square mile South China Sea as its sover-eign territory. China has been building military bases on arti-ficial islands in the region also claimed by Brunei, Malaysia, the Philippines, Taiwan and Vietnam.

# After outcry, White **House says Biden will** lift refugee cap in May

AP WASHINGTON

F acing swift blowback from allies and aid groups, the White House said President Joe Biden plans to lift his predecessor's historically low cap on refugees by next month, after initially moving only to expand the eligibility criteria for reset-

In an emergency determination signed by Biden earlier Friday, he stated the admission of up to 15,000 refugees set by former President Donald Trump this year "remains justified by humanitarian concerns and is otherwise in the national interest." But if the cap is reached before the end of the current budget year and the emergency refugee situation persists, then a presidential determination may be issued to raise the ceiling.

That set off a deluge of criticism from top allies on Capitol Hill such as the second-ranking Senate Democrat, Dick Durbin of Illinois, who called that initial limit "unacceptable." White House press secretary Jen Psaki said later that Biden is expected to increase the refugee cap by May 15, though she didn't say by how much.

Biden has been consulting

with his advisers to determine what number of refugees could realistically be admitted to the United States between now and October 1, the end of the fiscal year, Psaki said.

'Ġiven the decimated refugee admissions program we inherited," she said it's now "unlikely" Biden will be able to boost that number to 62,500, as he had proposed in his plan to Congress two months ago.





# TELLING THE TALE OF HERITAGE

Stories are an excellent mode of keeping the history of heritage alive, writes SUTAPA BASU, as she shares her impressions on the importance of making heritage a part of contemporary storytelling

tories have disseminated consciousness of our past cultures since times immemorial. Whether through cave paintings or oral narrations, the earliest mode of passing traditions, history, customs, and rituals through generations has been only through storytelling. Before written language was discovered, even certain work skills were passed from father to son through stories. The reason is simple, anything woven into a story is unforgettable.

Storytelling is a powerful tool that has massive lasting impact. When we listen to stories or read them, they boost our feelings of trust, compassion, empathy and positively influence our social behaviour. Storytelling has a unique ability to build connections. When we hear a well-told story, your brain reacts as if we are experiencing it ourselves. We respond to stories because they cultivate a sense of togetherness. Thus, stories that tell us about our past or what we have inherited from our ancestors make us feel, we are part of something bigger than ourselves.

#### **WHAT IS HERITAGE?**

Heritage is the complete scope of inherited traditions, monuments, objects, and culture. Most significantly, it is the range of contemporary activities, meanings, and behaviour that we draw from them. Heritage includes, but is much more than just preserving, excavating, displaying, or restoring a collection of old things.

Heritage is tangible as well as intangible. Monuments, artifacts, books, archived records of events are tangible while traditions, lifestyles and mannerisms are some of the intangible elements that we inherit. We can explore heritage through excavations, conservation, restoration and display of concrete objects. However, history of songs, recipes, cuisine, nuances of language, dances dress and other conventions of legacy need to be perceived and appreciated. An excellent mode of keeping the history of heritage alive, generation after generation, is through stories. For what is history but story telling?

Let's see how some of the palpable as well as abstract elements of heritage have benefited through telling stories.

#### **ARCHITECTURE**

Old forts and castles, mansions and monuments are natural source for stories, myths, and tales. When I visited Chittorgarh fort, one of the myths I heard was about how the religious fervour of Meera Bai, the Princess of Mewar, had kept intact her chamber in the huge palace though the rest of the royal residence had been flattened. Obviously, I went back and read up everything available about the history of the palace and fort. I discovered more such myths

In The Pillars of the Earth, author Ken Follet

describes in great detail how a 12th century cathedral is built. He makes a tale of its unusual architecture, politics and weaves civil war, famine

and religious strife around it.
Bimal Mitra's Bengali novel Saheb, Bibi, Golam made into the famous film, Sahib, Bibi Aur Ghulam is set in a zamindari mansion that resonates with the culture of the period. His entire story is about the feudal and patriarchal traditions which emanate from the mansion.

Another story like that is Shatranj Ke Khilari about the nawabi culture that has been filmed in the old palaces of Lucknow.

## CUISINE

An amazing story that revolves around food, its concoction, history and influence is Like Water For Chocolate by Laura Esquivel. Tita, the tragic protagonist of the story, is only able to express herself when she cooks. The chapters even carry recipes. They fascinated me and I even cooked some of them. The stories about food gave me a wonderful view of regional cuisine.

Another book that has enamoured me is The Flavour of Spice by Marryam H Reshi that gloriously celebrates spices. Reading her book, I embarked upon a delightful foray into the heritage of Indian cooking as she traces history of spices as far back as possible.


Reading Gone With The Wind by Margaret Mitchell gives the reader an excellent insight into lifestyles, dresses, social customs and attitudes prevalent in southern parts of USA during the American Civil War in the 1800s. The book has become a reference point for scholars of that

Vikram Seth's novel A Suitable Boy brings us the perfume of courtesans and old-world charm of the pre-independence period. It gives us a peep into lifestyles, notions and sentiments of a bygone culture.

#### DRESS

Dramas written by playwrights such as Shakespeare, Kalidas or Anton Chekov, when staged, are a feast for costume designers. They display the fashions worn during a specific period in a certain parts of the world where the dramas are set. However, stories are created not only by writers but are also told by raconteurs.

When the Ramcharitra Manas or Meghdoot is recited there are vivid descriptions of garments, headdresses and weapons which make them come alive through mental visuals for the listeners. History and heritage of dresses come alive only through these descriptions. We can then compare them and find out what of that heritage still remains in our fashions today.

#### **MEANS OF TRANSPORT**

Read Pride and Prejudice by Jane Austen and we find out about chaises, stagecoaches, barouches, phaetons, and curricles. What about 20,000 Leagues Under the Sea by Jules Verne to know about submarines or fictional wonder vehicles such as the muggle car from the Harry Potter

Pather Panchali by written by Bibhutibhushan Bandhopadhya and put on cellu-loid by Satyajit Ray shows its protagonist's obsession with the train that passes his village. Since his only travel experience had been on a bullock cart, the speeding train enthralled him.

# **TRADITIONS**

Dickens' A Christmas Carol is a wonderful cameo on the traditional Christmas spirit. Similarly, Sense and Sensibility by Austen profiles the Victorian custom of older men marrying young girls. Emily Bronte's novel Wuthering Heights is all about how social class creates con-

flicts among its characters. Khushwant Singh's *Train to Pakistan*, Ihumpa Lahiri's Namesake and The Lowlands are excellent profiles of traditions and rituals in different parts of India. Arvind Adiga's The White Tiger gives insights into class disparities of an India of a decade ago. Chitra Divakaruni's Palace of Illus takes the reader back to the rituals of the Mahabharata period of Indian history while Before We Visit the Goddess is about multi-generational bonds, that rise from the countryside of Bengal, India and sweep into the streets of Houston, Texas.

# **NUANCES OF LANGUAGE**

Mark Twain's The Adventures of Tom Sawyer is a wonderful study of the use of dialect by different social classes in nineteenth century America. In fact, introducing dialect into literary writing goes back to Chaucer. Non-standard spellings and slang are used often in literature to delineate characters and give them identity.

Evolving language is one of true measures of heritage. Do you remember Eliza Doolittle in George Bernard Shaw's *Pygmalion*? If only learning the correct dialect could make a flower girl into a lady of consequence, how important can language be in the reconstruction of society?

Ruskin Bond often uses regional nuances and dialect to create atmosphere and build his characters. Many of his stories are set in the terai of the Himalayas and his villagers often use words in their own dialect in dialogues.

With such eminent authors to light up my path, I have included many features of heritage in my books to build ambience, build characters and bring authenticity to my storytelling. In all

my historical fiction books, I create the historical period through visual pen pictures of the dress, cuisine and traditions of the period and place. In The Curse of Nader Shah, I have exposed Nader Shah's obsession with the colour red on his garments and his creation of the four-cornered hat, the *kulah-e-naderi*. In *The Legend of Genghis Khan*, I have described the wide range of knives that the Mongols always carried on their belts and their varied purpose. *Padmavati* has numer

ous regional words sprinkled across the story for the sake of authenticity.

My latest book, *The Cursed Inheritance* focuses on the city of Kolkata and its cultural nuances. The *zamindari* mansions that dot the city inspired the setting of this cozy mystery inside a dilapidated yet grand mansion of Kolkata, called Sarkar Bari. I describe egg concoctions being cooked that are special to Kolkata as well as a coal stove built inside an iron pail, a common cooking implement in Bengal.

Kolkata is one of few cities which still has the hand-pulled rickshaws. Mentioned numerous times in my new book, is Kolkata's iconic vehicle though the protagonist also emp emaciated pullers and their livelihoods. I have chronicled the tradition of celebrating the festival of Durga Puja in the mansions of old zamindari families in this novel. Belief in tantric practices and demons as guardians of treasures is one the regional features of rural Bengal which has been exploited to the hilt.

Stories, narratives, and storytelling are central aspects of all cultures and thus, a part of heritage. For the storytelling to become an effective propagator of cultural history, it must engage the listener or reader, and provide a narrative that is both cognitively and emotionally compelling. People are natural storytellers. They tell narratives about their experiences and the meanings that these experiences have in their lives. All cultures and societies also possess their own stories or narratives about their past and their present, and sometimes about their view of the future. The memories and retelling of the past provide a sense of security in an uncertain world. Stories both written and verbal, are veritable source for

Stories are a thread of timelessness that runs through a rapidly changing environment. Hence, stories revolving around heritage bring a special sense of belonging and of continuity. It reduces global conflict and brings empathy for co-existence. All said and done, storytelling is one of the dominant means of preserving heritage and passing down of values and traditions that make the global social fabric stronger.

# LOKAS 2: WHAT EXISTS ABOVE

vou have suffered enough and built a resolve to change, do you set an opportunity to get birth on the *Bhulok* or Earth. This is supposed to be true for most of the lokas and for movement from one to the other, either upwards or downwards. Only the Earth dimension provides the infrastructure for the relevant criss-cross Visas. This is the Karma loka, where there is opportu-

nity to go against your nature and qualify for the better.

Higher *loka* beings descend downwards often to fulfil their own completions and final attainments. Many gurus are obligated to take the rebirth to uplift their disciples and help them gain completion. They do so to manipulate a change in their gunas through example setting, motivation, counselling and sharing their

I have in the vision state visited a few lokas but never connected the dots rew lokas but never connected the dots and never pondered on the subject. Remember this is a world ruled and perceived by senses. Our senses do not offer us more than 5% to 10% of reality. Between the *Bhuvarlok* and

the Swalok or Swarg, the difference is quite huge.

At the Bhuvarlok, we have a slightly different set of off loads because this is a loka of intellect, memory, relationships, heroic attitudes, and emotions. On the other hand it is also a loka of attainment.

And then Swarlok is a place where you can spend your cosmic currency earned and stored. It is a place of immense pleasure and beauty. Seva leads to Swarg or beyond. It's a place where spiritual understanding and aspirations begin. People learn detachment and how to focus on the purpose of the self. They also prepare for rebirth on *Bhulok* when spiritual assets dwindle. They get born as kings and queens or administrators and dominating personalities maybe as celebrities as well. If they are phil-anthropic and kind, they retain their loka status. If not they catch a snake ride. If they are those who out do expectations, the ethereal ladder appears and the ascent is in order.

The ascent is to the Anahta chakra

or the 'Maharlok' which lies beyond the 'Dhurv Tara' or the Pole star. Mahar is the land of the wise and balanced with qualities of selfless service compassion and self-love. However, inactivity and observer capability is still one *loka* away. Birth on Earth comes as teachers, reformers, saintly people, healers etc.

Karmas are not doable at the level of these higher *lokas*. When one qualifies beyond devotion and beliefs and attains the status of knowing or of the 'Janalok'. In the microcosm, this loka is at the level of the Vishudhi Chakra. One needs to be a sincere practitioner of spirituality and dispassion to qualify for a seat here. Till you harbour emotions, don't attain Gyan or intuitive knowledge, you can read about this loka but not live here. The senses especially the sense of sound and hearing needs to be history at this

And he warned that the bare ones are the higher ones, and we should avoid getting stuck due to our sense of sight.

re, human beings, are programmed to fear. Why blame God for this? What do we do with our children? We instil discipline in them by scaring them. This process of scaring into submission is reinforced is not paying proper attention to his studies, his parents may paint a very dark picture of his future. # Importance of behavioural economics during Covid

The coronavirus pandemic has not only grabbed the headlines but has also thrown the global health emergency care in disarray. The ubiquitous virus has not spared anyone, not even the most prosperous economies of the world

Studies have shown that people living with comorbidity (i.e., concomitant morbidity) are under high risk of falling critically ill or succumbing to coronavirus. They are dying from the in-hospital complications and a high incidence of mortality. The comorbidity is mostly of non-communicable diseases (NCDs), such as diabetes, hypertension, obesity, cerebrovascular accident, malignancy, asthma, cardiovascular disease, chron-ic kidney and obstructive pulmonary diseases, etc.

Moreover, persons with diabetes have been in the limelight since the inception of the pandemic as the epidemiological data have revealed their high risk of several clinical adversaries (The Lancet, 2020). As per the statistics, 71 per cent of deaths are owing to NCDs globally, 41 million people every year, of which 15 million are under the age of 70 years. Moreover 8.5 million cases are from low and middle income countries.

The Lancet Diabetes & Endocrinology published its findings based on 61 million individuals in England on their absolute and relative risk of mortality due to Covid-19 and the type of diabetes. It finds that the odd ratio of in-hospital deaths is 3.51, and 2.03 for persons with type-1 and type-2 respectively. diabetes, Information from 1561 Covid-19 patients from two hospitals in Wuhan showed that those with diabetes (9.8%) were more likely to need admission to the intensive care unit or to die, and similar cases are also noted

from other parts of the world. However, despite having a high percentage of diabetes, the

reported cases of mortality in India, Bangladesh and Pakistan are comparatively low so far. The climatic and geographical factors have some bearing on this low fatality rate in this region. (Apicella et. al., The Lancet, July 17, 2020).

Using the Longitudinal Aging Study in India (LASI, 2017-19) database of the Harvard, IIPS and the University of Southern California on disease and health condition of the popu-

we estimated that 18.28 per cent have comorbidity. About 60 per cent of the patients with diabetes have high blood pressure, while 17.32 per cent of patients with high cholesterol levels are suffering from chron-ic heart diseases. This cooccurrence of more than one disorder in the same individual is a matter of utmost concern during the raging pandemic. Our results also demonstrated that 75 per cent of the indi-

viduals suffering from comorbidity are hardly ever or never engaged in vigorous physical activities. Out of total patients suffering from comorbidity, about one-quarter indulge in substance use. Cases among females are more than males and it increases with the rise in income from the second to fifth income quintile.

The Government's initiative to prioritise the people with comorbidity in this age group on the vaccination list is the

need of the hour and has been followed from March 1 to curb the second wave of covid.

However, the public spending on NCDs is less than 0.5 per cent of GDP in India. The findings of the National Family Health Survey (NFHS) of 2015-16 state that obesity has given a steep rise to hypertension among people with BMI more than 30. While 11 per cent of the eligible women (i.e, age 15-49) have hypertension, including 7 per cent having stage-1

hypertension, and stage-2 and stage-3 hypertension at 1 per cent each. On blood pressure parameter, it finds 61 per cent women as compared to 43 per cent men, but only 1 per cent of them take anti-hypertensive

The National Programme for Prevention and Control of Cancer, Diabetes, Cardiovascular Disease and Stroke (NPCDCS) has been executed by the Ministry of Health and Family Welfare to

raise awareness regarding risk factors and establishment of NCD clinics, cardio care centre and screening at primary health-care level. The National Action Plan has also been conceived along the global monitoring framework to reduce the premature deaths from NCDs to 25 per cent by 2025. However, the Covid-19 pandemic has militated against Government's efforts of integrating NPCDCS with National Health Mission and AYUSH to promote a healthy lifestyle and strengthening infrastructure to detect NCDs

at an early stage.
The focus of the healthcare system in India at present lies on four important directions -- intervention in maternal and child health, preventive and affordable healthcare, medical infrastructure, and communicable and non-communicable diseases. Under the aegis of Ayushman Bharat Scheme, the Health and Wellness Centres, Primary Healthcare Centres, Community Health Centres are providing free diagnostic services for the NCDs.

Simply designing and implementing policies are not sufficient to weaken the bond between Covid-19 and comorbidity. There is a need to eliminate practical and psychological barriers to healthy behaviour, which is possible by the adoption of a behavioural economics approach. Integration of these idiosyncratic approaches into policymaking will illustrate its ability to improve both the effectiveness and efficiency of policies through well-designed interventions in curtailing the comorbidity, especially during the second of Covid-19.

Every death is a tragic loss; every death impacts people and families in ways that go unreported. With over 1.69 lakh lives already lost to the pandemic, there is urgent need to embrace the nationwide vaccina-

The nation's resilience and prompt action has seen it record among the world's lowest number of cases and deaths per million of the population, but we must continue to build on this through the most effective and safe tool that science has developed — prompt vaccination.

After all, vaccines have helped

contain several contagious diseases. The fact that we are smallpox free is just one example of how successful vaccination campaigns have enabled the nation to address pressing health-

While the first dose of smallpox vaccine reportedly arrived in the country in 1802, the country's first national campaign in 1962 enabled us in achieving the desired effect through the tireless efforts of volunteers and a greater awareness among the public on the need to be vaccinated.

We have seen similar success in venting tuberculosis through the BCG vaccination programme. Further, from being hyperendemic for polio in the early 1990s, India's success in eliminating wild polioviruses is another inspiring example of the success of the children vaccination programme and awareness campaigns. These successful

vaccination campaigns have helped save millions of precious lives.

What is common across all successful vaccination campaigns is the fact there has been strong grassroots acceptance. With no clear sight on when the Covid-19 pandemic will end, and if the world will ever go back to the place as we knew it, it is crucial to take the jab.

Let us take a moment to look back on the same period last year: There was no hope in sight as the pandemic wreaked havoc across the world. What is the key to the success of this vaccination mission is that every member of the public plays a key role in contributing to it. From the early-





omplex dynamics of man and the universe calls for necessary aware-ness. Mind it: By birth one begins with a clean slate, apparently not carrying any impression of worldly object or experience in mind that could serve as a guiding principle. The purpose, obviously, is to invoke the spirit of an honest seeker as is usually evident in a curious child. In the process, the seeker develops enough of mental and moral control. That enables him/her to put in all acts together to pur-sue the learning process in the right spirit following an open enquiry system. The seeker, thus groomed, qualifies to easily grasp true import of the lessons impart ed, both explicit as well as hidden

between the lines. It is pertinent to note here that in the ancient India's tradition, most of the knowledge treasures were purposely scripted in formulated language. It was supposedly done so in order that one could have in store, enough of memory implants in the least possible space and words possible. It needs to be appreciated here that but for honing one's intellect thoroughly well, it would not be possible to see through the truths veiled under the express words.
