# 7 killed in Kabul airport evacuation chaos Imran hails Taliban, asserts

Thousands of Afghans rushed onto the tarmac of Kabul's international airport on Monday, so desperate to escape the Taliban capture of their country that they held onto an American military jet as it took off and plunged to death

in chaos that killed at least seven people, US officials said.

two-decade campaign in which the US and its allies had tried to transform Afghanistan. The country's Western-trained security forces collapsed or fled, ahead of the planned withdrawal of the last American troops at the end of the month.

Residents raced to Kabul's international airport, where the "civilian side" was closed until further notice, according to Afghanistan's Civil Aviation Authority. The US military and other Western forces continued to organise evacuations.

Videos circulating on social media showed hundreds of people running across the tarmac as US troops fired warning shots in the air. One showed a crowd pushing and shoving its way up a staircase, trying to board a plane, with some people hanging off the railings.

In another video, hundreds of people could be seen running alongside a US Air Force C-17 transport plane as it moved down a runway. Some clung to the side of the jet just before takeoff. Another video showed several falling through the air as the airplane rapidly gained altitude over the city.

Senior military officials, who spoke on condition of anonymity to discuss the ongo-ing operation, told The Associated Press that the chaos left seven dead, including several who fell from the flight.

The storming of the airport, seen from space by passing satellites, raised questions about how much longer aircraft would be able to safely take off and land.

Shafi Arifi, who had a ticket to travel to Uzbekistan on Sunday, was unable to board her plane because it was packed with people who had raced across the tarmac and climbed aboard, with no police or airport staff in sight.

'There was no room for us to stand," said the 24-year-old. "Children were crying, women were shouting, young and old men were so angry and upset, no one could hear each other. There was no oxygen to

# 'shackles of slavery' broken

Pakistan Prime Minister Imran Khan on Monday seemed to endorse the heavily armed Taliban taking over Kabul by saying that Afghanistan has broken the 'shackles of slavery" in the neighbouring war-torn country.

The longstanding war in Afghanistan reached a watershed moment on Sunday when the Taliban insurgents closed in on Kabul before entering the city and took over the presidential palace, forcing embattled President Ashraf Ghani to join fellow citizens and foreigners to flee the country.

Khan made these remarks while addressing a ceremony to launch the first phase of the Single National Curriculum (SNC) from Grade 1 to 5, which was part of the manifesto

# Ready for Pegasus probe panel: Govt

## **Petitioners ask Centre to file** affidavit whether it used Pegasus

PNS ■ NEW DELHI

The Centre on Monday expressed its willingness to constitute a "committee of eminent experts" to examine all the aspects of Pegasus snooping controversy related issues, saying the matter is a "highly technical issue" which needs expertise. However the petitioners objected to the Government's affidavit and said it has not answered the basic question whether or not the Government purchased and used Pegasus spyware.

The bench headed by Chief Justice NV Ramana was told by Solicitor General Tushar Mehta that any discussion on these issues would involve the aspect of national security and termed the matter as sensitive.

The bench said it is not saying anything against the Government, but there are issues about areas in which the committee cannot go into. Mehta said the SC may lay down the terms and references of the committee. "We are dealing with a sensitive matter and the attempt appears to be to make it sensational," he said. The bench, also compris-



ing justices Surya Kant and Aniruddha Bose, deliberated upon the aspect of whether the Centre, which filed a short, limited affidavit, should file a detailed affidavit in the matter. The Court has given 24-hour time to the Centre to decide on filing an extended affidavit. The arguments will continue

on Tuesday Senior advocate Kapil Sibal, appearing for veteran journalists N Ram and Sashi Kumar who have filed one of the petitions in the matter, said the Centre should clearly state whether the Government or their agencies have used Pegasus. The bench told Sibal



said Government will appoint neutral eminent experts from the field and they would examine it and place it before the top court. "I do not think the Government can be more transparent and fairer than this," he said, adding that response given by the Information and Technology Minister in Parliament on the issue deals with every aspect.

Sibal argued that the Centre should file an affidavit and state on oath whether the Government or its agencies have used Pegasus or not. He said the limited affidavit filed by the Centre in the matter did not answer the issues raised by them. "The matter, in my respectful submissions as an officer of the court and not as the one representing the Government, cannot be as simple that you file an affidavit whether Pegasus was used or

## **Explain why Tribunals Reforms Act 2021** brought in: SC to Govt | due to O2 shortage

The Supreme Court on ■ Monday asked the Centre to explain the reason for bringing in the Tribunals Reforms Act, 2021, which received Presidential assent on August 13, 2021. The court also wanted to know whether any Parliamentary debates took place before the passage of the law to overcome the top court's directions.

Chief Justice of India NV Ramana observed that many

provisions of the law run contrary to the mandate of the SC judgment regarding tenures of service of tribunal members.

The Supreme Court had on July 14 struck down the newly inserted Section 184 of the Finance Act, 2017, as amended by the Tribunal Reforms (Rationalisation Conditions of Service) Ordinance, 2021 (Ordinance) to the extent that it fixed the tenure of members and chairpersons of tribunals at 4 years. # **Fate of Af officers in IMA** hangs in balance

With the Taliban taking control over the whole of Afghanistan after the meek surrender of the Afghanistan National Army (ANA) the fate of about 60 officers undergoing training at the prestigious Indian Military Academy (IMA) hangs in the balance. The authorities at IMA are in constant touch with the Army Headquarters on the issue. A red alert is said to have been sounded in the academy and the Foreign Gentlemen Cadets (FGCs) of Afghanistan are being kept under strict vigil.

Their trainers are said to be taking good care of the FGCs of Afghanistan who are concerned with the turn of events in their country. According to reliable sources these cadets are and are undergoing training at an undisclosed location.

The dilemma of the authorities is understandable since the Indian government has not recognised the Taliban so far which has vowed to rename the country as Islamic State of Afghanistan. In such a situation the fate of these cadets in IMA remains shrouded in suspense. It is pertinent to mention here that the Taliban forces are antagonistic to the ANA and in such a situation these officers face the prospect of detention once they return training at IMA. to their own country.

Under the initiative to forge better relationships with friendly foreign countries, the Ministry of External Affairs undertakes the Indian Technical and Economic Cooperation (ITEC) pro-

## **Explain why Tribunals Reforms...**

The top court had ruled that Section 184(11) of the

Finance Act, which prescribes a tenure of four years for members, was contrary to the principles of separation of powers, independence of the judiciary, rule of law, and Article 14 of the Constitution of India as well as the judgment of the apex court in the Madras Bar Association III case. In an ongoing case, the Supreme Court expressed dis-

pleasure on non-filling of vacancies in many tribunals.

Meanwhile, Congress leader and Rajya Sabha MP, Jairam Ramesh has filed a petition before the Supreme Court challenging the constitutional validity of the new Tribunals Reforms Act. The plea filed on Monday said that Section 3(1) along with Sections 3(7), 5 and 7(1) of the Tribunal Reforms Act, 2021 violate Articles 14, 21 and 50 of the Constitution. "The petitioner is aggrieved by the Act abrogating the principle of judicial independence, and its passage being a deliberate attempt to legislatively override the judgement of this Court in Madras Bar Association v. Union of India (July 2021 judgment) which set aside provisions identical to those being impugned, without removing the basis of the judgment," the petition said.

Ramesh submitted that Section 3 (1) of the Tribunals Reforms Act, 2021 is flagrantly unconstitutional in so far as it violates Articles 14 and 50 of the Constitution. The provision bars appointments to tribunals of persons below fifty years of age. This, the petitioner said, undermines the length/security of tenure and violates both judicial independence and the principle of separation of powers, it was contended.

Jain gave a number of important directions to officials for fast tracking the pending works. He instructed the officers to work vigorously and concertedly towards the scheme saying only strong will makes impossible tasks possi-

The meeting was convened to talk about the ongoing work of underground reservoirs and for reviewing other pending works. "All work related to 'Underground Reservoirs'



(UGRs) boring, tube-wells and sewage treatment plants should be completed in time so that the objectives of Yamuna cleaning and 24x7 water supply can be achieved," said Jain.

The minister further said, "Local augmentation should be done at underground reservoirs wherever groundwater levels are high for increasing the underground reservoir

He also added that 'reverse osmosis' systems wherever required will be installed along with the tube-wells to ensure best quality water for the peo-

Speaking at the flagging off ceremony, Gahlot said "Under the visionary leadership of Chief Minister Arvind Kejriwal, since March 2020, the Delhi Government has launched 452 BS VI compliant buses including 32 that are being dedicated to the people of Delhi today. "Equipped with world-

class latest technology, special care has been taken for the comfort, convenience and safety of the passengers in all these buses," he said. He also said that the safe-

ty of female passengers has been ramped up. "If a female passenger feels any discomfort, she can press the panic button.
On pressing the panic button, an alert goes to the command



centre and all the agencies that are there get to know the live location of the bus," he added.

The first lot of 100 AC low floor buses was launched on the city route network in February 2020 under the cluster scheme. During the pandemic period from March 2020, 452 new buses have been inducted under the cluster The total number of DTC

and cluster buses running on Delhi's road till now is 6793 of which DTC is having 3760 buses and the cluster is having 3033 buses. Currently, Cluster buses are operated on 306 city routes network in Delhi. The additional 32 buses will be deployed on four additional routes - 993,380,390 and 244.

"These BS VI compliant buses feature modern technology, including real-time passenger information systems, CCTV cameras, GPS, fire detection and suppression system, live video streaming in case of emergency, pink seats reserved for ladies, panic buttons for women's safety and

19 fresh cases of dengue reported in National Capital, tally reaches 127 **STAFF REPORTER** ■ NEW DELHI

With 19 fresh cases reported last week, the number of dengue patients has reached to 127 in the national Capital, according to a report released by the South Delhi Municipal Corporation (SDMC) on Monday.

The number of dengue cases for January 1-August 7 period is also the highest this year since 2018 when the count had stood at 64 in the same duration.

Three cases were reported in the month of August, according to the report. No cases were recorded in January, two in February, five in March, 10 in April, 12 in May, Seven in June and 16 in July and 16 in August, the report said.

In the previous years, the cases in the same period were 171 in 2016, 251 in 2017), 64 in 2018, 47 in 2019 and 35 in 2020, it said. However, no deaths have been reported due to dengue in the city till now, it added.

According to the civic report released on Monday, 62 cases of malaria and nearly 25 cases of chikungunya have also been reported till August



14 this year. Malaria, dengue and chikungunya are accompanied with high fever and therefore, doctors feel that people might suspect that they ave contracted COVID-19.

Concerned over the rising number of cases of vector borne diseases, the South Delhi Municipal Corporation (SDMC) last week carried out a special campaign to detect mosquito breeding and control measures against the same in the police stations/maalkhana in the jurisdiction of the civic

A senior SDMC official said that a total of 118 police stations were checked out of these, 62 police stations were found positive for mosquito breeding due to collection of rainwater.

Under this project, 5,000 diesel three-wheelers will be replaced in Gurugram and other metropolitan cities of Haryana, Khattar said during the inauguration.

Under this initiative, an eauto rickshaw in place of diesel three-wheelers will run in Gurugram, which is a joint effort of the Municipal Corporation of Gurugram (MCG), Regional Traffic Authority Gurugram and Traffic Police Gurugram.

According to MCG officials, the zone covers Udyog Vihar, Ambience Mall, DLF Phases 1, 2, 3 and 4, DLF-5, Cyber City-Golf Course Road stretch, Mall Mile, Huda City Centre (HCC), sectors 28 and 29, and Wazirabad.

Diesel and CNG autorickshaws will not be allowed to operate in the zone, they said.

Speaking on the occasion, Chief Minister Manohar Lal said that environmental pollution is a matter of concern and vehicular

pollution is a big problem. "Under the Parivartan project, it has been started from Gurugram today and a target



has been set to run 5,000 evehicles. He said that this project would be started not only in Gurugram but also in other metropolitan cities of Haryana," Khattar told

## IIT-Mandi develops smart road system to reduce road accidents at blind turns

ndian Institute of Technology (IIT), Mandi, has developed a Smart Road Monitoring System (SRMS) that would help reduce manual intervention in traffic management and prevent accidents caused at sharp or blind turns.

According to the team of researchers at IIT Mandi, the system can be used for speed detection, vehicle counts, enhanced traffic control and road usage, by employing the Micro-Electro-Mechanical Systems (MEMS) and Internet of Things (IoT) technologies. The team claimed that besides being mechanical in nature, the developed system can work in any weather including rain, snow, fog or other poor visibility conditions and the data can be encrypted and shared to only appropriate stakeholders. "With a surge in traffic, the

manual interface becomes a challenge to control and prevent road accidents, and traffic management especially in the hilly terrains. Traffic Police intervention, convex mirrors installation, and other techniques, though helpful in these situations, become difficult to manage in severe and extreme conditions like rainfall, snow, foggy weather and high number of sharp curves," said K V Uday, Assistant Professor, School of Engineering, IIT Mandi.

Uday explained that the developed system comprises two layers of detection units on each side of the turn and two signalling units to alert the drivers. When a vehicle passes through the two consecutive layers of detection units, the sensing system detects the speed, direction and type of vehicle (two/ four/multiple wheels). The technology has also acquired a patent for the

The detected direction con-





firms if the vehicle is advancing towards the turn, and a corresponding signal (light, sound or barrier) is displayed on the other side to alert the drivers of an oncoming vehicle. If the vehicle moves away from the curve, no signal is displayed.

## It's sin to remain silent when rights trampled upon: Sonia to Indians

o mark the 75th year of Independence, Congress chief Sonia Gandhi on Monday urged people to introspect what freedom means and told them it is a "sin" to remain silent when fundamental rights and the Constitution are 'trampled upon". In a statement, Sonia also said the country's democracy needs repair-

"When fundamental rights of people, guaranteed by the founding fathers of our Constitution, are being trampled upon, it is a sin to stay silent," Sonia said. When the Government "attacks" Parliament and "tramples upon" its traditions, "enslaves" democracy, attempts to "violate" the Constitution and 'shackles" institutional autonomy, the people of the country need to introspect what freedom means to them, she said. The Congress chief also

alleged that currently journalists do not have the freedom to write, TV channels the freedom to show the truth, and writers and thinkers the freedom to express themselves. She alleged parliamentarians don't have the freedom to express their views, people affected by the oxygen shortage crisis and GST do not have the freedom to speak and the states, in a federal structure, do not have the freedom to demand their rights.

She argued that Indian democracy is in need of repair and "We must undo the damage." She said the progress achieved in the last few decades has been reversed under the present government which indulges in "hollow slogans, event management and brandbuilding" at the cost of gover-

"After decades of progress



towards an India of our dreams, why is our democracy in danger? It is because tangible achievements have been substituted by hollow slogans, event management and brandbuilding only to benefit those in power - at the expense of governance. It is because symbolism has triumphed over meaningful action. It is because democracy is sought to be replaced by an autocracy. Today's symbolism and reality is that Parliament House is being turned into a museum," Sonia Gandhi said in the statement shared by the Congress.

"We must not be swayed by hollow attempts to appropriate our icons by those who made no contribution to our struggle for independence. They may borrow Gandhiji's eyeglasses but their vision for our country remains Godse's. Our founders rejected that divisive ideology 74 years ago, and we must reject it once again," Sonia said.

"The recently concluded Monsoon session of Parliament displayed the disdain of the present government towards parliamentary processes and building consensus," Sonia said. She claimed that the opposition was repeatedly denied an opportunity to raise issues of national importance.

"Increasingly over the past years, laws have been passed without debate in the House or scrutiny by a Committee, effectively turning Parliament into a rubber stamp," she alleged.



## ₹267.35 crore allocated to Covid-hit Kerala to spur health infrastructure

The announcements followed after Mandaviya met with Kerala's Chief Minister Pinarayi Vijayan, State Health Minister Veena George and other State officials in Thiruvananthapuram. The Central minister is currently in the State to discuss the Covid-19 situation.

For the past several months, Kerala has been continually reporting a high number of daily new infections of Covid-19.

"Central Govt allocates ₹267.35 crore to Kerala under Emergency COVID Response Package- II. It will strengthen the state's health infrastructure & effectively manage #COVID19. Additionally, Rs 1



crore will be made available to each district of Kerala for creating a medicine pool," Mandaviya tweeted following the meeting.

Mandaviya said that a centre of excellence that caters to telemedicine facilities in every district would be created. Also, a paediatric intensive care unit would be established in district hospitals to prioritise the health of children, he added.

"Central Govt will ensure creation of a Centre of Excellence that caters to Telemedicine Facilities in every district in Kerala. For prioritising health of children, paediatric ICU to be established in district hospitals with 10 kilolitre liquid oxygen storage tank facility," he said in a subsequent tweet. Further, the Union gov-

ernment has also assured all ossible assistance to Kerala, including providing Covid-19 vaccines, he added.

On Sunday, 18,582 people tested positive for the disease with a high test positivity rate (TPR) of 15.11%, which accounted for more than half of the national tally of 32,937

Following the meeting, the Union minister had lauded the steps taken by the state government in preventing the disease. He had also praised the lack of vaccine wastage in the state and also assured availability of vaccines to the state. The central ministry's data showed that 24,271,938 doses of the vaccine have been administered in Kerala as of 7am on Monday.

## Bharat Biotech working on Covaxin-nasal jab combo for booster shield against Covid

PNS ■ NEW DELHI

Hyderabad-based Bharat Biotech is working on a combination of Covaxin followed by nasal vaccine which if administered can act as a booster dose and protect a person from getting infected, according to its chairman Krishna Ella.

The company expects significant data on the combination in the next two months which can then drive the future course of action based on regulatory approvals and policy decisions regarding booster

"We are working on a combination of Covaxin followed by nasal, so that Covaxin primes the system of innate immunity and then the boost by the nasal which produces three immune responses — the IGG, the IGA and mucosal immunity. All three immunities are powerful and can protect a person from getting infected," Ella said.

Even as Covaxin is found to be significantly effective

against the dominant Delta virus, the Government will take the final call on whether there is a need for a third dose of Covaxin to enhance the immune response for a longer time, Ella said underlining that data will be submitted to the Government.

"I think we have done a waiting for the results, but if you recommend a booster dose, there will be a shortage of vaccine. So, it's a complicated situation. We are therefore adopting an innovative method," he said.

According to Ella, if the nasal vaccine works out well, production capacity is also likely to double.

Åt present, Bharat Biotech is supplying around 2 — 2.5 crore doses of Covaxin per month, which is projected to increase to around 5.8 crore doses over the next few months.

On WHO approval for Covaxin getting delayed, he said that it was because the company had to do efficacy trials separately and during the second wave, which involved cases of Delta variant.

The 3,81,947 active cases, down from 3,85,336 on Sunday, comprise 1.18 per cent of the total infections in the country, the lowest since March last year. The national recovery rate stands at 97.48 per cent, the highest since March last year.

The daily positivity rate was recorded at 2.79 per cent. It has remained below 3 per cent for the last 21 days. As many as 11,81,212 Covid-19 tests were conducted on Sunday, taking the total number of tests conducted so far in the country to 49,48,05,652.

Around 54.58 crore COVID-19 vaccine doses have been administered under the nationwide vaccination drive so far with more than 55 lakh vaccine doses administered on Monday itself.

Of the total 4,31,642 deaths reported so far in the country, 1,35,039 from were Maharashtra, 36,979 from Karnataka, 34,519 from Tamil Nadu, 25,069 from Delhi, 22,784 from Uttar Pradesh, 18,601 from Kerala and 18,303 from West Bengal. The Union Health Ministry

has stressed that more than 70 per cent of the deaths occurred due to comorbidities. The country's active caseload currently is 3,81,947, the lowest in 145 days. The active cases constitute 1.18% of total cases,

## Scientists find BCG vaccine helpful in reducing inflammation in healthy elderly people

The Bacillus Calmette-Guérin (BCG) vaccine, which was first used in 1921 against the deadly TB and is on World Health Organization's list of essential medicines, could help reduce inflammation in healthy elderly people and can protect them against Covid-19, a team of

BCG is considered to be one of the most broadly used vaccines in the world, with around 130 million infants receiving this vaccine every There is improved interest

Indian scientists has found.

in BCG vaccination of elderly population, especially in countries with a high number of reported Covid-19 cases. Immunity produced by some already available vaccines such as BCG has been recommended to be used as a conceivable protective approach against Covid-19 to bridge the period until a specific vaccine is avail-

The scientists from the ICMR-National Institute for Research in Tuberculosis and the ICMR-National Institute of Epidemiology, both in Chennai said that the vaccine dampens inflammation by lowering the levels of inflammation-related marker proteins. It also checks the secretion of specific proteins discharged during lung inflammation.

These findings, the researchers say, show that the vaccine could potentially be used to protect elderly people against COVID-19, which primarily affects the lungs. The findings are published in the

Recent studies have indicated that the BCG vaccine enhances antiviral immune responses, making it a likely candidate in the fight against Covid-19. However, it remains unknown how the vaccine generates such immune responses.

journal Science Advances.

To investigate it, scientists vaccinated people between 60 and 80 years old living in Covid-19 hotspots. They then measured the levels of inflammation-related proteins such as cytokines, acute-phase proteins (APPs) and matrix metalloroteinases (MMPs) in their blood before and one month after vaccination.

The researchers found that the vaccine reduced the immune responses in all the vaccinated individuals. BCGvaccinated individuals exhibited decreased blood levels of cytokines, APPs and MMPs compared with unvaccinated

Specific small inflammation-related proteins, which have roles in Covid-19, were decreased in the vaccinated individuals. The vaccination also decreased the levels of specific inflammation-related growth factors. The results from this study

not only corroborate the immunomodulatory properties of BCG vaccination but also reveal a clear effect of (non)specific immunogenicity of BCG vaccination on systemic inflammation, the researchers said.

## Centre's OBC amendment pure fraud: Pawar TN RAGHUNATHA MUMBAI

Charging that the Centre's Crecent Constitutional amendment restoring power to the States to make their own OBC lists was a "fraud" on Other Backward Castes (OBCs), NCP chief Sharad Pawar on Monday demanded that the Centre come out with "caste-based" census, provide empirical data on OBCs to the States and relax the 50 per cent cap on reservations to ensure

Talking to media persons here, Pawar said: "The Centre's amendment to restore the states' power to make their own OBC lists is like tying someone's hands first, then calling the individual for lunch and serving him or her food".

"Recently the Centre amended the Constitution to give powers to the state to make their own OBC lists. As a result, there is a misunderstanding in the minds of the people that the Centre has taken a landmark step on the OCB reservation front. But, the reservations," Pawar said. centre's move was nothing but a fraud on the OBCs in the country," the NCP chief said.

Alluding to the December 1992 landmark Supreme Court judgement in the Indra Sawhney v Union of India & Ors case which had put a 50 per cent on reservations, Pawar said: "Unless the 50 percent quota limit imposed by the Supreme Court in its 1992 landmark verdict is relaxed, own lists of socially and educationally backward classes (SEBCs). In other words, the Maratha quota cannot be restored unless the 50 per cent reservations cap is relaxed".

"In reality, Amendment will be of no use. Because, the Centre took away the rights of the states a couple of years ago to prepare and maintain their SEBC lists and that has been restored now. The government has betrayed the OBCs. Today almost all states cent quota limits, the findings of the Justice N.G.

The ED had initiated investigation on the basis of FIR, registered on July 9, 2020 and chargesheet dated December 29 last year filed by the National Investigation Agency (NIA).

"It was alleged in the chargesheet of NIA, that the terrorist gang of NSCN (IM) was carrying out well organized extortion racket in Manipur and Nagaland, resulting in diversion of Government funds, that in pursuance of their conspiracy for terrorist acts, the terrorist gang of NSCN (IM) had been criminally intimidating Construction Companies, undertaking the road construction project in Manipur and collected huge sum as illegal "tax" (extortion)," the ED said in a

statement Investigation under Prevention of Money Laundering Act revealed that the district in-charge of four administrative



districts of Manipur like Tamenglong, Senapati, Ukhrul and Chandel, were reporting to Rayilung Nsarangbe, as he was the Treasurer of "the Collective Leadership", it said.

The District Representatives of the outfit were submitting the extorted money along with the details of collection made by them from various economic activities to Rayilung.

It is also revealed that the huge amount of extortion or the illegal "tax" was being directly collected by Rayilung. Major part of the extortion amount was being utilised as per the direction of the Collective Leadership and part of it, was being deposited in the bank accounts maintained in the name of Rayilung and in the name of Ruth Chawang, his wife and Apam Muivah.

Gangtok Smart City Development has got the permission for drone-based aerial survey for its smart city project, the ministry's statement mentioned. It said SAIL has got the permission to use drones to conduct "perimeter surveillance" of its steel plant in Burnpur, West Bengal.

# 10 organisations Isoflavones rich diet could help against MS

PNS NEW DELHI

Adiet rich in isoflavones (compounds found in soybeans) could reduce the severity of multiple sclerosis (MS), a degenerative disease, by boosting the abundance of specific isoflavone-metabolising gut microbes, a study has found.

Such a diet and the abundance of the gut microbes reduced severity of experimental autoimmune encephalomyelitis (EAE) that mimics MS in mice, an international research team has found.

These findings could potentially be useful for developing dietary and gut-microbes-based therapies for MS and other diseases, the researchers said in a study published in Science Advances.

MS is the most common cause of progressive neurological disability in young adults across the world.

Patients with MS show a reduction in microbial diversity in their gut. Diet has been shown to alter and even restore gut microbial diversity.

However, the effects of diet on gut microbes remain largely unexplored To find a link between diet, gut microbes and MS, the scientists, including a researcher from the Birla Institute of Science &

Technology in Goa, India, fed female

mice either an isoflavone-rich diet, an isoflavone-free diet, or a standard diet with moderate levels of isoflavones for six weeks

They then induced EAE in these

Mice fed an isoflavone-free diet showed severe disease and mice on the standard diet showed intermediate disease, while mice on the isoflavone-rich diet exhibited greatly diminished disease severity.

The researchers found that consumption of isoflavones increased the diversity of specific species of gut bacteria. These bacteria broke down isoflavones into equols that checked the infiltration of specific immune cells into the CNS of EAE-afflicted

This, in turn, lowered inflammation and improved their health. There's no cure for multiple sclerosis.

However, treatments can help speed recovery from attacks, modify the course of the disease and manage symptoms.

Signs and symptoms of MS vary widely and depend on the amount of nerve damage and which nerves are affected. Some people with severe MS may lose the ability to walk independently or at all, while others may experience long periods of remission without any new symptoms.

## Maha deaths dip to 100, new infections down

The daily Covid-19 deaths dropped to 100 and infec-

tions went down to 4,145 in Maharashtra on Monday, even as 5,811 patients were discharged after full recovery from various hospitals across the State.

A day after the state logged 130 fatalities and 4,797 infections, the daily deaths dipped by 30, while fresh cases came down by 652 With 100 fresh fatalities

reported on Monday, the total number of deaths in the state increased from 1,35,039 to 1,35,139 while the infections with 4,145 new cases - went up from 63,92,660 to 63,96,805. As 5,811 patients were dis-

charged from the hospitals across the state after full recoverv, the total number of people discharged from the hospitals since the second week of March last year increased from 61,89,933 to 61,95,744. The recovery rate in the State dropped from 96.83 per cent to 96.86 per cent.

The total "active cases" in the state dropped from 64,219 to 62,452. The fatality rate in the state stood static at 2.11 per

## **The Afghan mess**

The situation is precarious. The future under the Taliban is neither clear nor secure

rospective refugees are just about the only people seen moving around Afghanistan's capital Kabul, trying to procure passports and visas in order to have a place to flee to. They fear the Taliban may close down the city and clamp down on the airport any time. The other set of people moving in the bylanes towards the near highway out of the capital is the citizens who cannot afford to fly and have to cross the border on foot. The most poignant movement of refugees is currently on in Afghanistan, the like of which was in the recent past seen in the Rohingya march out of Myanmar. What galls these Afghans is that their President fled the country to safety while the Americans are in the process of leaving once and for all. They are literally stranded today as the world looks on, with no one extending a helping hand. The only silver lining is the call by some countries to not turn



away Afghan refugees. Seventeen years after it was established under the benevolent eye of the United States, the Islamic Republic is, for all practical purposes, dead. The Taliban, but for an unforeseen circumstance, are intent on the return of the Islamic Emirate and its regressive ways of social order. Women have begun to face the brunt of the Taliban already, with reports of women employees in offices and banks asked to go home and not to return. Parents have stopped sending girls to schools before any such Taliban diktat is announced.

Those who gained prominence in the previous regime or were known to have helped the nationalist forces against the Taliban are simply awaiting their fate if they have not managed to flee. The only peace in the region exists on a piece of paper called the Doha Agreement former President Donald Trump signed along with the Taliban in Qatar. His successor, President Biden, would have to answer if he was aware this would be the catastrophic result of his decision to withdraw the US troops. He would also be asked about the quality of training and equipment given to the Afghan defence forces, given the fact that the Taliban ran through them easier than a knife through butter. Were they even trained to defend their nation or merely to handle emergency situations? Was it the war on terror the Americans came to Afghanistan to finance two decades ago or was it to ensure that the democratic values the Afghans for the first time learnt to enjoy in this period were sustained and protected? Afghanistan's neighbours, particularly Pakistan, would be called upon to answer for how long they plan to deny their role in aiding and abetting the Talibani attempts to take over Afghanistan. The next few days will see how the Taliban set up their Government. The onus will then be on the world community whether to recognise the Taliban Government or ignore the anti-democratic fervour they stand for.

# Opposition must be serious about its role - PRAFU



The non-ruling parties and members ought to respect the platform the parliamentary floor offers to discuss Bills and legislate responsibly

he Opposition needs the legislature much more than the Government. Ministers can pass Bills in a few minutes at a time, especially if the Opposition does not pay attention to legislation and remains distracted by agitation. Rushing into the well need not necessarily provoke adjournments. A few agitating members can, upon the Speaker's orders, be taken away by the marshals. This used to be done in the earlier years of Independence. Recalcitrant members were carried out physically.

Some Opposition parties and members just do not appreciate the gift the parliamentary floor is. The opportunity it gives to MPs to express themselves and their policy views is phenomenal. One reason could be that Opposition leaders do not study enough and do not therefore have anything substantial to say. The 2019 general election was fought by the leading Opposition on the slogan 'Chowkidar chor hai', implying that the Government had pocketed money from payments made to France for Rafale warplanes.

However, the Supreme Court declared the deal as clean. The Opposition allegation was based on the habit of politicians lining their pockets whenever a sizeable deal happened. After the 2019 election results, one survey agency said the party bandying the chor slogan lost quite a few votes for repeating this slur ad nauseum. The ruling party could have easily countered this with Gali gali mein shor hai ke Rajiv Gandhi chor hai'. The Opposition parties

should have a think tank-like secretariat for national policies, which can help its leaders to introduce Bills based on the think tank's findings. Parties on the Opposition benches should have shadow ministers, starting with a shadow PM (leader of Opposition), a finance minister, defence minister and so on. Informed and intelligent debates would then be possible. Parties then would be equipped with knowledge, and read instead of shouting only allegations and frequently walking out. Currently, the impression is

that they pocket hefty emoluments but do little work.

Once the late Union Minister Anil Madhav Dave had lunch at my home. The BJP was in Opposition then and did walk out occasionally. My emphatic suggestion was his (and also my) party's method should be no or rare walkouts. Whenever the BJP had a grouse against the Government, its members should wear black armbands. Other methods of protest can be wearing half-black attire or members sitting in the aisles.

Right from the beginning, there has been no tradition of parliamentary party offices doing ideological or academic work. The Communist parties did something, but one doesn't know if they did any fresh thinking or merely repeated what Marx and Lenin said or wrote. Else, why were these parties clueless after the Soviet Union disintegrated in 1991? Nowhere in the world have the Communists found any alter-

In Britain, not only do the Conservative and Labour Parties (perhaps also the Liberals) have shadow ministers but also constituencies allocated to their members. who are supposed to be in touch with their constituency and are expected to hold small

meetings so that the party knows what is going on in each constituency. The particular member works as though he would stand from the constituency in the next election. This may not be possible for a party like the Congress as early allocation of a seat could result in fights among aspirants. The Congress therefore does last-minute allocations to avoid trouble.

The quality of political candidates in the West is overall superior to those at the bottom of the rung in India. Education used to be a problem earlier. There is hardly any on-the-work training on the Constitution or parliamentary articulation.

A quick tour of books by every new MP would be useful. There would be some well-travelled, knowledgeable MPs who would know quite a bit of the country. But most aren't aware of every nook and corner of India. Yet they are elected to debate and legislate for the country. A brief history of post-Independence India and a quick look at the armed forces during the five wars we have fought must be provided in the two weeks during the first gap between two House sessions, so that MPs are wellequipped to debate national issues. Minus this, the members either remain silent or

talk nonsense.

In my years, I came across some MPs who for two consecutive sessions (10 years) did not speak at all. They were from Gujarat, knew their State, but not enough about other places. Two members I knew had asked for starred questions; they were excited about their chance to speak and rehearsed for several evenings. Their problem was language. They could hold huge crowds in Gujarati. They knew adequate Hindi to converse but not enough to make speeches in Parliament. There must have been many such sad specimens from other States who kept silent, talked nonsense or simply shouted down members on the opposite side of the House. Or when they got bored, they played a role in the adjournment of the House. There are other members who do not have a language problem but suffer from knowledge-cum-information deficiency. Then there are others who talk loosely before the media. The anti-Government media — whether Indian, American or European — laps this up to malign India in front

## **FIRST COLUMN US-INDIA COOPERATION IS NOW STRONGER**

The commitment to democratic values reflects India's pluralistic society and history of harmony



emocratic values and free citizenry bind India and the US together, Secretary of State Antony Blinken said in Delhi at the end of talks with External Affairs Minister S. Jaishankar on July 29. The two sides discussed cooperation on a wide range of issues, including Afghanistan, countering Covid-19, the Indo-Pacific strategy, and the Quad. Blinken also met Prime Minister Narendra Modi, National Security Adviser Ajit Doval, members of civil society and a representative of the Dalai Lama.

Modi appreciated US President Joe Biden's "strong commitment to strengthen the India-US strategic partnership that is anchored in both countries' shared democratic values and is a force for global good".

The relationship between the two countries is important because it is a relationship between two democracies. One of the elements that Americans admire most about India is the steadfast commitment of its people to democracy, pluralism, to human rights and fundamental freedoms. Blinken pointed to the free press and independent judiciary as part of the "self-correct-



ing mechanism" that he said could repair challenges to any democracy.

Jaishankar said he had responded to the US concerns on certain issues, making it clear that the "quest" for a more perfect democracy applied to both the US and India. He said the Modi government's policies "of the last few years" had been done to "right wrongs done historically", and that while freedoms are important, they should not be "equated with the

In response to international criticism of the Citizenship (Amendment) Act and the government's moves on Article 370 in Jammu and Kashmir, the External Affairs Minister has in the past referred to the burden of "accumulated problems" of history, and has defended Internet restrictions as required for maintaining law and order.

On Afghanistan, Blinken and Jaishankar agreed that there was no "military solution" to the conflict, and that taking over the country by force would not help the Taliban gain the "international recognition" or "legitimacy" it desires, including the lifting of sanctions and travel bans against the Taliban leadership. In a reference to Pakistan, Jaishankar said one neighbour of Afghanistan was an "exception" to the consensus for a peaceful political settlement. An Afghanistan that did not respect the rights of its people, and an Afghanistan that committed atrocities against its own people would not be part of the global community, Blinken said.

Both the dignitaries also highlighted cooperation in the Indo-Pacific as part of the 'Quad' with Japan and Australia, which Blinken said was "not a military alliance" at all. The two sides also spoke about the Quad's initiative to provide Indian-made vaccines in the Indo-Pacific region.

Unfortunately, China opposed contact between foreign officials and the Dalai Lama after Blinken met a Tibetan Buddhist monk during his India visit. Blinken met Geshe Dorji Damdul, current director of Tibet House in New Delhi, what was seen as a big political message to China. Damdul, the former interpreter of Tibetan spiritual leader Dalai Lama, was a part of a group of civil society leaders who met US Secretary. Damdul is a director of Tibet House, which was founded in 1965 by the Dalai Lama to preserve and disseminate the unique cultural heritage of Tibet

Meanwhile, Blinken after the meeting civil society leaders, including the Tibetan monk, said that US and India share a commitment to democratic values, which is the bedrock of their relationship and reflective of India's pluralistic society and history of harmony. Civil society helps advance these values," Blinken had tweeted.

# Sun-set on LPG subsidy



The overarching focus of the Government should be on giving relief to consumers sans subsidy as that will be in sync with fiscal consolidation

rom June, 2020, the Union Government stopped depositing LPG subsidy in the accounts of eligible beneficiaries and the position continues till date. Even as the budget for 2021-22 has provided for Rs 14,000 crore under this head (down from Rs 36,000 crore during 2020-21), it is unlikely that any payments will be made during the current year. What has prompted this move? Was it orchestrated earlier but put into effect only now? To understand, let us reflect on some

Since January 1, 2015, the Modi-government has been running a scheme for direct benefit transfer of LPG. Nicknamed PAHAL (Pratyaksha Hastaantarit Laabh), under it, three major oil marketing PSUs -- Indian Oil Corporation Limited, Bharat Petroleum Corporation Limited and Hindustan Petroleum Corporation Limited
-- deliver LPG to the target beneficiaries at full cost-based price which is arrived at by adding to the refinery-gate price freight, marketing costs, marketing margin, dealers' commission and taxes and duties. They follow it up by depositing subsidy - as notified by the Union Government from time to time - in beneficiary accounts and claim reimbursement from the latter.

Even prior to this, the Union Government was giving subsidy on LPG but the manner of administration was different. For comprehension, that period can be bifurcated in two sub-periods -- prior to 2002-03 and between 2002-03 and 2014.
Prior to 2002-03, sale of LPG was sub-

sidized under an administered pricing regime. Under the APR, oil marketing PSUs sold these products at a low price unrelated to the cost of supply which was higher. The shortfall was made up by higher prices charged on sale of products such as naphtha, ATF and fuel oil. This cross-subsidy was managed through the 'Oil Pool Account' maintained by the Oil Coordination Committee in the Ministry of Petroleum and Natural Gas. The system was prone to misuse as a lot of low priced products found their way to the market using modus operandi such as fake beneficiaries or diversion of stocks straight from the

In 2002-03, the then NDA Government dismantled the APR and along with it the OPA. Yet, it decided to continue subsidy on LPG, diesel and kerosene but on a commitment that money would be aid 'directly' from the Budget. The idea wa to make these subsidies 'transparent' and to eliminate over time. Brushing aside this major reform, in 2004, the UPA-government continued with sale of these products at subsidized price sans any support from the bud-

For funding the subsidy, it resorted to disingenuous means such as ordering upstream oil PSUs such as Oil and Natural Gas Corporation and Oil India Limited to supply crude oil to the refineries of IOCL, BPCL, HPCL at discounted price and issue of oil bonds to the latter. This dispensation

continued till 2014-15, in the process, inflicting huge losses on the former (for instance, ONGC gave cumulative discount of over Rs 200,000 crore) besides imposing perpetual burden on the central exchequer

towards servicing of oil bonds.

Meanwhile, the government deregulated and abolished subsidy on petrol in June 2010 and diesel in November 2014 whereas in case of LPG, it initiated switched over to DBT in mid-2012, a process that was consummated in January 2015.

After running the scheme for 6 years now if the government is saying good-bye, this was not unexpected. An indication was given in the 2002-03 decision of the then NDA-regime under Vajpayee. A decade later, the Kelkar Committee also recommended removal of 25 per cent of LPG subsidy in 2012-13 and 75 per cent in the following 2 years. As per this road-map, the subsidy should have ended by March 31, 2015; instead, the exit is coming with a delay of 6 years.

At the time of launch (January, 2015), the total number of beneficiary nousenoids under the scheme was around 185 million. Since then, about 45 million fake beneficiaries were eliminated, 10 million surrendered under Modi's "give up" campaign and 15 million rendered ineligible because of annual income > Rs 10 lakh bringing down the total to 115 million. At the same time, about 80 million households (albeit poor) were added taking the total to around 200 million.

To assess whether the Government is justified in withdrawing subsidy, the Economic Survey (2015-16) offers some clues. According to it, only 0.07 per cent of LPG subsidy in rural areas went to the poorest 20 per cent households. In urban areas, the poorest 20 per cent got only 8.2 per cent of subsidies. One does not need any further proof to recognize that in rural areas, the poorest had no access to subsidy at all, whereas in urban, they got a miniscule portion of it.

True, between 2015-16 and 2019-20, there has been significant increase in the share of poor households in the beneficiary basket (savings of about Rs 70,000 crore due to elimination of fake stuff is bonus). Still, the better-off households continue to get a major portion of LPG subsidy. In this backdrop, exit from the scheme makes sense as this will help in getting rid of the nondeserving at one go. As for the poor and deserving, the government can explore some other option to support

At present, retailing of petroleum products is monopolized by oil PSUs. Together, they account for about 90 per cent of the total petrol pumps. A major reason behind this is routing of subsidies only through them which puts private firms to a serious disadvantage as without subsidy, they are unable to match the effective price (cost-based price minus subsidy) offered by PSUs. After subsidy is abolished, their disadvantage will go away and there will be increased competition leading to lower price.

Meanwhile, in 2019, the government had dispensed with the requirement of minimum investment of Rs 2,000 crore in oil or gas infrastructure — in hydrocarbon exploration and production, refining, import terminals, and transportation to grant a retail pump license. Henceforth, "the applicant needs to have minimum net-worth of Rs 250 crore and commit to invest in the marketing of at least one new generation alternate fuel such as CNG, LNG, biofuels and open 5 per cent of total outlets in rural areas"

This was a good move to encourage private players enter the business. However, no less crucial is the need to ensure hassle free access to the supplies and infrastructure for storage, handling and distribution. To achieve this, the government should decanalize POL imports and hive off the infrastructure to an independent entity which should make it accessible to all players on 'common carrier' principle in an 'equitable' and 'non-discriminatory' manner.

Above all, there is an urgent need to take measures for increasing domestic production of oil and gas (currently, India imports 85 per cent of its crude requirement; 55 per cent in case of LPG) to reduce dependence on import, prevent exploitation in international market and lowering the price to consumers. All POL products including LPG should be brought under GST as this will help in reducing their price.

While steering various measures, the overarching focus of the Government should be on giving relief to consumers sans subsidy as that will be in sync with fiscal consolidation.

# The conquest of Mexico: Some history is inevitable

#### The capital of the Aztec empire, Tenochtitlan, fell to the invaders after a long siege, and became Mexico City instead

Priday, 13 August, is the 500th anniversary of the Spanish conquest of Mexico. The capital of the Aztec empire, Tenochtitlan, fell to the invaders after a long siege, and became Mexico City instead. It was a major historical event, still mourned by millions and celebrated by millions more five centuries after it happened. But was it actually inevitable?

Laurent Binet doesn't think so. The French writer's novel 'Civilisations', which started winning prizes as soon as it was published in 2019, has now been translated into English and offers an alternate history in which the Incas and Aztecs conquered Europe. It's fiction, of course, but it makes you think.

Binet starts 1,000 years



ago with the Viking voyages to 'Vinland' (Newfoundland), an interesting historical fact that had no known impact on the rest of the world. But in Binet's version a single band of Vikings sails all the way down the coast and up the Amazon River, finally conquering and intermarrying with a native Amerindian group.

This is the key plot device, because this stray Viking group not only gives the locals the technique for making iron tools and weapons. It also gives the native Americans all the Eurasian quick-killer diseases: smallpox, cholera, influenza,

bubonic plague, typhoid, etc. The first generations of local victims die in swathes, but by 500 years later their



when Columbus shows up in the Caribbean in 1492, the local people are as well armed as his crew, they don't fall ill, and they eat the European explorers for lunch (metaphorically, of course). Then an exiled Inca ex-

monarch in Cuba has his men reverse-engineer Columbus's ships, builds some of his own, and sets out to Europe to see what he can conquer or steal. There follows a picaresque story in which a band of 300 descendants have all the same Inca 'conquistadors' first overthrows the King of Spain and may be true, but is not very then, modestly reinforced by other Inca adventurers, takes over Italy, Germany and the

Netherlands as well. There's plenty to amuse the casual reader. Francisco Pizarro, conqueror of Peru in fact, becomes the personal fixer of the Inca king Atahualpa, ruler of most of Europe. The Aztecs are horrified by the way that the Christians burn their human sacrifices (the heretics) alive rather than just cutting their hearts out like sensible people do. And so on.

The message seems to be that native Americans, given the opportunity, would have been slightly nicer and more enlightened imperialists than the Europeans who filled that role in the real history. Which tlements were so far from

relevant, since the whole scenario is entirely incredible.

Not much in history is inevitable, but the conquest of the Americas was. It might have been done by the Chinese or the Muslims rather than by the Europeans, but whichever of the older Eurasian civilisations reached the Americas first was bound to supplant the local, younger

civilisations The problem was the sheer biological vulnerability of 'New World' populations to people coming from the 'Old World', and Binet's device of having Greenland Vikings accidentally bestow immunity on the New Worlders 500 years before Columbus just doesn't work. The then new Greenland setEurope, so small, and so rarely visited that they lacked lasting immunity themselves.

Moreover, their explorations in Newfoundland and around the Gulf of St. Lawrence were undertaken in the hope of finding some valuable resource that they could trade with Iceland and Norway in return for all the things they could not produce themselves.

As soon as the Greenland Vikings found something that filled the bill closer to home walrus and narwhal ivory from Disko Bay on Greenland's north-west coast - they shut the Newfoundland base down and stopped sailing westward. The idea that they could ever have reached the Caribbean, let alone the Amazon, is preposterous.

The New World's popula-

tion in 1500 was probably around 50 million people, mostly living in the big but relatively new mass civilisations. That population fell by about 90 per cent in the following century. So many farms were abandoned that the global temperature dropped (the 'Little Ice Age') as the forests grew back and absorbed enormous amounts of carbon dioxide.

What killed those 45 million missing people? Maybe one million died at the hands of the European invaders, but the vast majority fell victim to the Eurasian quick-killer diseases. If the Chinese had crossed the Pacific and reached the Americas first, the result would have been exactly the same. Those civilisations were doomed.

Afghanistan, she said.
"The situation in
Afghanistan has experienced major changes. We respect Afghanistan's people's will and

choice," Hua said. The war in Afghanistan has lasted over 40 years. To stop the war and realise peace is the wish of the 30 million Afghan people and the aspiration of the international community and regional countries, she said.

The US has said it would deploy 6,000 troops at the vital Kabul airport to ensure the safe departure of American citizens and its allies from Afghanistan which has been taken over by the Taliban, in a sudden and unprecedented collapse of the elected regime led by embattled President Ashraf Ghani.

The Taliban insurgents swept into Afghanistan's capital on Sunday after the government collapsed and president Ghani joined fellow citizens and foreigners to leave

US Secretary of State Antony Blinken made a series of calls to his counterparts of

US' key allies. India was not among them. Simultaneously, more than 60 countries led by the US and the European Union issued a joint statement, urging those in positions of power and authority across Afghanistan to bear responsibility and accountability for the protection of human life and property, and for the immediate restoration of security and civil order.

"At present, we are completing a series of steps to secure Hamid Karzai International Airport to enable the safe departure of US and allied personnel from Afghanistan via civilian and military flights," said a joint statement issued by the US Department of State and the Defence Department.

## **Malaysian PM** resigns after failing to get majority support

**AP** ■ KUALA LUMPUR

Malaysian Prime Minister Muhyiddin Yassin resigned on Monday after less than 18 months in power, apologizing for his shortcomings

but blaming those "hungry for power." Muhyiddin conceded that he had lost majority support to govern, making him the country's shortest-ruling

"I have tendered my resignation as prime minister and also for the entire Cabinet ... Because I have lost the majority support of lower house members," he said in a televised final message after meeting the king. "I take this opportunity to seek for-

giveness ... For all my mistakes and weaknesses during my tenure as prime minister. I and my Cabinet colleagues have tried our best to save and protect lives ... In this period of crisis. However, as a human being, we are bound to make mistakes so I apologize." He said he had hoped to stay on

until the country's coronavirus vaccination program is completed and the economy has recovered, but was thwarted by those "hungry for power." Muhyidddin's departure plunges

the country into a new crisis amid a worsening COVID-19 outbreak. Political leaders have already begun to jostle for the top post, with his deputy, Ísmail Sabri, rallying support to succeed Muhyiddin and keep the government

The palace said the king, Sultan Abdullah Sultan Ahmad Shah, accepted Muhyiddin's resignation and appointed him as caretaker prime minister until a successor is found, in line with the constitution.

### Detainee says China has secret jail in Dubai, holds Uyghurs

**Beijing:** A young Chinese woman says she was held for eight days at a Chinese-run secret detention facility in Dubai along with at least two Uyghurs, in what may be the first evidence that China is operating a so-called "black site" beyond its borders.

The woman, 26-year-old Wu Huan, was on the run to avoid extradition back to China because her fiancé was considered a Chinese dissident. Wu told The Associated Press she was abducted from a hotel in Dubai and detained by Chinese officials at a villa converted into a jail, where she saw or heard two other prisoners, both Uyghurs.

She was questioned and threatened in Chinese and forced to sign legal documents incriminating her fiancé for harassing her, she said. She was finally released on June 8 and is now seeking asylum in the Netherlands.

## **Veteran Opp** leader wins Zambia's **Presidency**

Hichilema, a 59-year old businessman contesting the presidency for the sixth time, got more than 2.8 million votes to President Edgar Lungu's 1.8 million votes, achieving one of the biggest electoral wins in Zambia's history. Hichilema garnered more than 50% of the nearly 5 million votes cast to win the presidency outright, without having to go to a runoff election.

## Pakistani model killed by stepbrother for 'honour'

Lahore: A Pakistani fashion model, who was found dead at her house here last month, was killed by her stepbrother for "disgracing the family's honour", police said on Monday.

On her return from Dubai the 29-year-old model, Nayab Nadeem, was found strangled at her house in Lahore on July 11 and a murder case was registered on the complaint of one of her two stepbrothers.

Punjab police spokesperson Rana Arif told PTI on Monday that the mystery of this blind murder has been solved as the victim's stepbrother turned out to be her murderer. The model's stepbrother,

Muhammad Aslam, has confessed that he first strangled her and then stripped her dead body naked to mislead the police and show that it was a rape-cum-murder case. PTI

## No room for cut in excise duty on petrol, diesel: FM

Finance Minister Nirmala Sitharaman on Monday ruled out a cut in excise duty on petrol and diesel to ease prices, which have touched an all-time high, saying payments in lieu of past subsidised fuel pose limitations.
Petrol and diesel as well as

cooking gas and kerosene were sold at subsidised rates during the previous Congress-led UPA government. Instead of paying for the subsidy to bring parity between the artificially suppressed retail selling price and the cost that had soared because of international rates crossing USD 100 per barrel, the then government issued oil bonds totalling Rs 1.34 lakh crore to the state-fuel retailers.

These oil bonds and the interest thereon are being paid

"If I did not have the burden to service the oil bonds, I would have been in a position to reduce excise duty on fuel,' she told reporters here. "Previous government have made our job difficult by issuing oil bonds. Even if I want to do something I am paying through my nose for the oil

Sitharaman, who had

diesel to record high to shore up revenue collections last year, said the interest on oil bonds paid in the last seven years totalled Rs 70,195.72 crore.

Of the Rs 1.34 lakh crore of oil bonds, only Rs 3,500 crore of principal has been paid and the remaining Rs 1.3 lakh crore is due for repayment between this fiscal and 2025-26, she said.

The government has to repay Rs 10,000 crore this fiscal year (2021-22). Another Rs 31,150 crore is due to be repaid in 2023-24, Rs 52,860.17 crore in the following year and Rs 36,913 crore in 2025-26.

"A significant amount is going for interest payment and principal repayment. What unfair burden on me," she Opening balance in 2014-

was about Rs 1.34 lakh crore and interest repayment was Rs 10,255 crore. Since 2015-16, interest burden each year is Rs 9,989 crore.'

The collections from the hike in excise duty far exceed the amount due to be paid to oil companies.

Excise duty on petrol was hiked from Rs 19.98 per litre to Rs 32.9 last year to recoup gain arising from international oil prices plunging to multi-year

raised excise duty on petrol and low as pandemic gulped demand.

Minister of State for Petroleum and Natural Gas Rameswar Teli had last month told Parliament that the Union government's tax collections on petrol and diesel jumped by 88 per cent to Rs 3.35 lakh crore in the year to March 31 from Rs 1.78 lakh crore a year back.

Excise collection in preoandemic 2018-19 was Rs 2.13

The hike in taxes last year did not result in any revision in retail prices as they got adjusted against the reduction that was warranted because of fall in international oil prices.

But with the demand returning, international oil prices have soared, which have translated to record high petrol and diesel prices across the country. More than half the country has petrol at over Rs 100-a-litre mark and diesel is above that level in Rajasthan, Pradesh and Odisha.

Sitharaman said the Centre has kept open the option of inclusion of petroleum products under the Goods and Services Tax (GST) regime.

## Fuel demand recovery continues in August, diesel sales fall by 8% from that of pre-Covid-19 level

PTI NEW DELHI

ndia's fuel demand recovery continued in August as sales of the nation's most used fuel, diesel, inched towards pre-Covid levels on easing of pan-demic-related restrictions, preliminary sales data showed on Mondav

Petrol sales are already above pre-Covid levels and diesel is 8 per cent short.

State-owned fuel retailers sold 0.98 million tonnes of petrol in the first half of August, up 9.4 per cent from the yearearlier period. It was 3.7 per cent higher than pre-Covid petrol sales of 0.95 million tonnes in August 1-15, 2019. Sales of diesel - the most

used fuel in the country - rose 18.5 per cent to 2.11 million tonnes during August 1-15, 2021 over the previous year, but was down 7.9 per cent from August 2019.

Last month, diesel consumption was 11 per cent lower than pre-Covid levels. This is the third straight month that showed a rise in consumption since March.

Fuel demand had recovered to near-normal levels in March before the onset of the second wave of COVID-19 infections led to the re-imposition of lockdowns in different

states, stalling mobility and muting economic activity.

Consumption in May slumped to its lowest since August last year amid lockdowns and restrictions in several states. Fuel demand showed signs of resurgence in June after restrictions began to be eased and the economy gathered pace.

On July 30, S M Vaidva. Chairmán óf India's largest oil firm IOC, had stated that petrol consumption has risen over pre-Covid levels as people prefer personal transport over public transport.

Diesel sales, he said, were likely to return to pre-pandemic levels by Diwali in November if a third wave of Covid infections does not lead to the reimposition of lockdown.

ATF consumption, which had seen the most severe fall as air travel was restricted beginning March 2020, is likely to return to normal by the end of the current fiscal in March, he

Consumption of LPG, the only fuel which showed growth even during the first lockdown because of free supplies by the government to the poor, rose 6.5 per cent year on year to 1.06 million tonnes in August 1-15. It was however 2.5 per cent lower than August 2019.

Sectorally, BSE metal, energy, oil and gas, FMCG and finance indices rose up to 1.79 per cent, while telecom, auto, capital goods and power indices fell up to 0.99 per cent.

cap indices underperformed the benchmark, shedding up to 0.57 per cent.

Markets traded lacklustre and ended marginally higher, in absence of any major trigger. Inflation in crude petroleum and natural gas was 40.28 per cent in July, against 36.34 per cent in June.

In manufactured products, inflation stood at 11.20 per cent in July, against 10.88 per cent the previous month.

WPI inflation scaled double digit in April at 10.74 per cent, rising to a record high of 13.11 per cent in May. In June it eased to 12.07 per cent and further moderated to 11.16 per cent in July. ICRA Chief Economist

Aditi Nayar said the core-inflation is likely to have peaked at 10.8 per cent in July 2021.

The rapid rise in the core-WPI inflation from August 2020 onwards as well as the impact of concerns related to the Delta plus variant on commodity prices are likely to gradually soften the core print going ahead, she said.

 $S_{\text{the public through mobile}}^{\text{upply of drinking water to}}$ tankers or dispensers by a charitable organisation is taxable at 18 per cent under the GST, AAR has ruled.

The Andhra Pradesh bench of the Authority for Advance Ruling (AAR) has ruled -- in the case of Vijayavahini Charitable Foundation -- that since the organisation is supplying purified water, hence it is exemption.

Vijayavahini Charitable Foundation had sought an advance ruling on whether the supply of groundwater after undertaking purification through Reverse Osmosis to the general public either through the dispensing unit or mobile tanker at a concessional rate is exempt from Goods and Services Tax

The AAR said the principal supply undertaken by the organisation is a supply of purified water, which is taxable at 18 per cent, while the service of distribution through mobile units is an ancillary service and taxable at 18 per cent.





## World Mosquito Day is on August 20. MUSBA HASHMI speaks with doctors to bring you facts about one of the most dangerous creature in the world, and also tell you the reason behind low Dengue cases this year

t is nothing short of a surprise that a tiny creature like mosqui-on the earth. What makes them so? Their small size and the ability to spread vector-borne diseases in a jiffy. This is not the only interesting thing about the insect. There is, of

The vectors during a blood meal from an infected host ingest disease-producing microorganisms and transmit into a new host causing symptoms. Interestingly, more than 17 per cent of all infectious diseases are caused due to vector-borne diseases which lead to more than approximately 7,00,000 deaths annually. There is some more.

"Only female mosquitoes bite and they can lay up to 100 eggs every third night after mating only once. The lifespan is about 50 days for female mosquitoes and about 10 days for male," Dr Vineeta Singh Tandon, Consultant, Internal Medicine, PSRI Hospital, New Delhi, tells you.

Dengue and Malaria causing mosquitoes, Anopheles mosquito, which is the main culprit for causing Malaria, is active during the night while the Aedes Aegypti mosquito, which is responsible for Dengue, is active during the day. "It is dark coloured and has typical white markings on the legs. It can be easily identified," Dr Col Vijay Dutta, Senior Consultant, Internal Medicine, Indian Spinal Injuries Centre, tells you.

According to World Health Organisation estimates, Malaria caused due to the Anopheles mosquito leads to almost 4,00,000 deaths per year globally. Similarly, Dengue is responsible for around 40,000 deaths per year.

"The only way to prevent this is to keep the surroundings clean, there should be stagnant water near to your place or at home, making sure the water in the cooler and plants is not stagnant. Mosquitoes generally lay eggs in the stagnant water. Using sanitiser may also help," says Dr Parinita Kaur, Consultant, Internal Medicine, Aakash ealthcare Super Specialty Hospitals.

Singh adds and tells you that personal protection from mosquito bites can be done by using repellents, in places where a higher number of mosquitoes are expected. Keeping the doors and windows of houses and cars closed is also important.

"Children and people at risk should be encouraged to wear clothing that covers their hands, arms, and legs to avoid mosquito bites," says

The earliest sign of dengue, he says, is high fever, followed by joint aches, severe headache and retro orbital pain (pain behind the fever, because the bones ache a lot. This is all in the the initial signs of dengue, now it has four stages. One, only Dengue fever. Two, dengue with Thrombocytopenia means Dengue with decrease in platelet count. Three, dengue hemorrhagic fever — in this there is hemorrhage because of the decreased platelets. The hemorrhages can be on skin or may be in the eye. The most dangerous and life threatening of all is the dengue hemorrhagic shock syndrome where the blood pressure and all the organs: the heart, kidneys, liver and lungs are involved. This is called as the multi organ dysfunction," Dr Sanjay Gupta, Senior Consultant, Internal Medicine, Paras Hospitals,

Gurugram, tells you. But, amidst all this hustle and bustle of the pandemic, what became a victim of oblivion is Dengue and Malaria. Surprisingly, there are very less cases and deaths reported. Now, whether the low cases this year was a result of COVID induced antibodies or not, is still a matter of question. "There can be several reasons responsible for the decline in dengue cases like staying at home and reduced outdoor exposure due to lockdown restrictions, environmental sanitisation and fumigation drives. Public awareness also plays a major role. Whether COVID antibodies have played a role or not requires further research and analysis on various parameters and is still questionable," opines Singh.

Kaur agrees with Singh and says that the possible reason behind the low cases is that people have become more self-aware about hygiene and also the Government is effectively rounding clean. "It's the awareness about one's health and making it a priority that has helped the nation to keep other diseases at bay, which is a positive thing. And like every time dengue changes species and maybe it did this time too, hence there are less cases," she says.

Gupta, too, believes that COVID antibodies are totally different from the ones which are produced by Dengue disease. Hence, the two are not related. "The cases of Dengue has drastically reduced without any doubt given that there were cases of water logging in Delhi recently, but it can be attributed to the greater awareness about the disease, and not COVID immu-

tific studies that have stated that performing regular and mild exercise lead to the reduction of oxidative stress. Exercise gives rise to natural antioxidants in the body and decreases the damage caused by the oxidative stress. Even a regular meditation practice can reduce oxidative stress.

■Say no to smoking: There are chances that smoking may enhance oxidative stress not only through the production of reactive free radicals but also through weakening of the antioxidant defense systems. One should also stay away from second-hand smoking.

■Take adequate sleep: Having a sound sleep is essential for striking a balance among all of your body systems. DR NEERJA AGGARWAL, a rehabilitation and adolescent psychologist, talks about how parents can help adolescent deal with this sensitive period of their life

**■**How has the pandemic affected the mental health of adolescents?

Adolescence is a sensitive period of life, it is an age of transition when the body and brain go through critical development stages. This process lasts till they are in their 20s. In this phase our socio-emotional brain matures earlier than our rational brain. So, during the adolescence period, a child is emotionally vulnerable. During these times adolescents can be more aggressive, more anxious, more enthusiastic and more euphor-

their anxieties, which cannot find an outlet because of the restrictions and confinement it has imposed. They are uncertain about their education and career. It can increase their anxieties, they can experience signs of OCD, depression, eating disorders and self-harm.

■How can we minimise this impact? What do you think can be done at the family, community, and Government levels?

This is the age when one should be actively involved in various activities — academic, games and extracurricular. We need to channelise their energy into constructive work. At home, parents or caregivers can help them in structuring their routine, involving them in family activities and discussions. If we can make them aware

and involve them in mental health counselling, it will help them understand various issues related to the pandemic, finances and mental health better. Besides, we need to make mental health counselling accessible to adolescents through various online mediums so that they can share their issues and seek help as and when required.

It is also important to create awareness about the National Mental Health Programme that was launched in 2014 so that people affected by mental illness and their families can get benefits of the programme that ensures socio-economic inclusion of persons affected by mental illness by providing accessi-

Life saving surgery at SRM MCH&RC

At SRM Medical College Hospital and Research Centre (SRM MCH&RC), Kattankulathur, a 76-yearold male came with a huge intra-abdominal tumour. On examination, doctors found a mass over the right side of his abdomen, associated with pain and distension.

A huge mass of about 20 cm by 15 cm was noted occupying almost the entire right hemi-abdomen. A CT scan showed a retroperitoneal tumour which was pushing the intestines to the left and compressing on other abdominal organs including the kidney and the ureter. "Managing large intra-abdominal masses through surgery can be challenging as these people have associated cardiac and respiratory issues as well, and need intensive and optimised care," said Dr R Balamurugan, Deputy Medical Superintendent,

SRM MCH&RC. The patient developed intestinal obstruction due to the compressive effect, he



gency surgery, and a retroperitoneal tumour weighing almost 5kg was resected meticulously. The tumour contained about 1.5 litre of fluid as well. Postoperatively the

patient was closely monitored and he recovered well. Pathological examination confirmed the diagnosis of a retroperitoneal sarcoma. They are rare tumours, comprising about one per cent to two per cent of all malignancies, and can grow up to significantly large sizes before diagnosis. Pro Vice Chancellor of





## Virat's pace quartet bowls out England for 120 on final day to script historic win

ndia's world class pace attack pulled off an incredible heist with the bat and then a magnificent performance with the ball to decimate England by 151 runs in the second Test here on Monday. Monday

The fifth day at the hallowed Lord's was as good an exhibition of Test cricket with India bowling out England for 120 as they tried to bat it out without going for a chase of 272 in 60 overs. It was a match where odds

were in favour of England but the cricketing Gods wanted Virat Kohli's men to script another golden chapter in the history of

Mohammed Shami (56 not out & 1/13 in 10 overs) and Jasprit Bumrah (34 not out & 3/33 in 15 overs) played innings of their lives and then rocked the England top-

in 10 overs) and Mohammed Siraj (4/32) played their part to perfection to give the visitors a 1-0 lead in the five-match series.

This is India's third Test

match win at Lord's having won earlier in 1986 and 2014 series and they now have six points in the World Test Championship. First Shami and Bumrah achieved the unthinkable of bat-

ting England out of the contest by conjuring a record stand of 89 which took team's total to 298 for 8 and made the target of 272 in two sessions look fairly impossi-Then the duo was joined by

the 'daddy of the pace pack' Ishant as they had a serious shot at a memorable win after Joe Root's (33) dismissal of a 'jaffa' from Bumrah had England on the mat at 67 for 5 just after tea.
