# Jab for 15+ from Jan 3, says Modi

'Boosters for 60+, frontline staffers from Jan 10'

PNS NEW DELHI

In an address to the nation late Lon Saturday evening, Prime Minister Narendra Modi announced that children between 15 and 18 years will be vaccinated from January 3 and booster doses will be given to health and frontline workers and those above 60 with other health

problems from January 10.

The PM said the Government has decided to go for vaccination of children after holding wide-ranging consultation with scientific advisers. The PM's announcement coincided with the drug regulator's granting approval for giving vaccine to children above 12. The move has to be cleared by the Government.

Modi also said, "Precaution doses" will be started for health care and front-line workers from January 10.

Those over 60 with other health problems will also receive extra doses from January 10 on their doctor's advice, he said.

Modi said global experience showed following all preventive measures was a big weapon to fight Covid. "Coronavirus is not gone... The



world is now talking about Omicron. Today is Atal Bihari Vajpayee's birthday and Christmas, so we decided to announce this step today," he said. Asking the people not to panic in view of the Omicron threat, the PM said, "In India, many people have been found to be infected with Omicron. I would urge all of you not to panic, be careful and alert. Remember to wash hands and mask," he said.

When virus is mutating our self-confidence and pre-paredness is also multiplying," the PM said and informed that "country has 1,80000 isolation beds, 5 lakh oxygen supplied beds, 140000 ICU beds, 3000 O2 plants..." to counter any new threat from the virus.

Modi said all States have been given enough vaccination doses and testing kits. Besides, he said "we are at missionmode in vaccine production"

The PM announced soon we will have nasal vaccine and world's first DNA vaccine in the country. Modi said, "There are different opinions on Omicron Indian scientists are working on it."

The PM said after 11 months vaccination experience in the country "the Government today decided that children in the age group of 15 to 18 years will be vaccinated from January 3 which will answer the concerns of the parents of schoolgoing children".

Modi said vaccination in the country was started on January 16 and till date 141 crore doses have been given with 61 per cent of adult population receiving both of it. He said while 90 per cent adults have one dose, States like Goa Uttarakhand and Himachal Pradesh have 100 per cent sin gle dose vaccination.



Around 185 terrorists have been eliminated this year in counter terrorist operations.

According to police the terrorists killed in Chowgam area of Shopian have been identified as Sajad Ahmad Chak son of Bashir Ahmad Chak resident of Braripora, Shopian and Raja Basit Yaqoob son of Mohd Yaqoob Najar resident of Achan Litter, Pulwama. Both the slain terrorists were categorized terrorists linked with Lashkar-e- Taiba. They were also involved in severál

Security forces also recovered 02 AK series rifles, 4 AK Magazines and 32 rounds from the encounter site.

## Omicron cases in Maha cross 100-mark

The total number of Omicron cases in Maharashtra rose to 110 on Saturday, as two more cases were recorded in Aurangabad. Of the total 110 Omicron

cases recorded, Mumbai accounted for a maximum of 46 cases, followed by Pimpri-Chinchwad: 19, Pune rural --15, Pune Municipal Corporation (PMC)—7, Satara -5, Osmanabad—5, Kalyan-Dombivali, Nagpur and Aurangabad--2 Buldhana, Latur, Vasai-Virar, Navi Mumbai, Thane Municipal Corporation (TMC), Mira-Bhayandar and

Of the total cases, 57 patients have been discharged after a negative RT-PCR test.

Ahmednagar—1 each.

The two persons who were diagnosed positive for Omicron virus were men of 50 and 33 years of age. "Both are fully vaccinated. Öne is asymptomatic, while another patient had mild symptoms.

Of the two cases reported, one had a history of travel to Dubai, while another is a contact of an international passenger.
Meanwhile, the authori-

ties said the total number of passengers who arrived at Mumbai, Pune and Nagpur airports since December 1 was 1,70,587 (24,922 from At-risk countries and the rest 1,45,665 are from other countries), while passengers whose RT-PC tests have been done are 32,086 (24,922 are from high-risk countries and 7164 are from other countries). Similarly, RT-PCR positive and samples sent for genomic sequencing was 208 (153 are from at-risk countries and 55 are from other countries).

Additionally, field surveillance of all international passengers who have arrived since 1st November is underway.

"Through airport and field surveillance, 729 samples have been sent for genomic sequencing. The results of 162 are awaited so far," the daily health bulletin said.

# Woman, her mother among four held for kidnapping employer's son in city

woman and her three Aassociates were arrested for allegedly kidnapping her employer's son from Ghazipur Rs 50 lakh of the Rs 1-crore ransom they had demanded, police said on Saturday.

The accused were identified as Richa Sabarwal, her mother Anita, her boyfriend Gurmeet Singh and Kamal Bansal, they said.

On December 18 at 3.45 pm, a caller, Vikas Aggrawal, informed the Patpargani Industrial Area police station that his son Kinshuk had been kidnapped at gunpoint (using a toy gun) from flower market, Gazipur, and was released later after paying a ransom of

Rs 50 lakh, police said.

Kinshuk, a resident of Shalimar Bagh, said that he, along with Richa, who works as flower decorator at his father's banquet, and driver Jitender, went to the Gazipur market for purchasing flowers, police said. police said.

As they entered the car after buying flowers, a person wearing black hood jacket, cap and mask, also barged into the vehicle and pointed a gun at the driver and asked him to speed away towards Ashok

On the way to Ashok Vihar, the kidnapper made a WhatsApp call to Vikas from Kinshuk's mobile phone and After a negotiation, Vikas paid Rs 50 lakh at Ashok Vihar. Thereafter, the kidnapper released Kinshuk, Richa and driver Jitender and asked Vikas to drive the car, the officer said.

The kidnapper then asked ikas to take them towards Dhaula Kuan and got down from the car near Radisson Hotel in Pashchim Vihar after threatening him to pay the remaining Rs 50 lakh, the officer said.

During investigation, police checked around 150 CCTV cameras covering around 70-kilometer distance and identified one suspected scooter. On the basis of the route followed by the scooter, Bansal was arrested.

Later, Gurmeet Singh, Richa and her mother were also arrested, Deputy Commissioner of Police (East) Priyanka Kashyap said.

During interrogation, Gurmeet said that he is the boyfriend of Richa, who is an employee of Vikas. Richa was under a debt running into

# Baby-trafficking ring busted in Capital, six women held

The Delhi Police has arrested six women members of a gang for allegedly trafficking in infants, officials said on Saturday.

trafficking of over 50 infants, used to procure them from the parents belonging to poor inancial background by offering them money and further sold the babies to childless couples for a hefty amount, police said.

On December 17, police were tipped off that the members of the gang would come near Shamshan Ghat, Gandhi Nagar, around 3.30 pm to sell

an infant. Thereafter, a raid was conducted and three women, having a seven to eight months old boy with them, were apprehended from the spot. Three more members of the gang were arrested the next day and one baby girl was rescued, Deputy Commissioner of Police (Crime) Rajesh Deo

said.

Those who have been arrested were identified as Priya Jain, Priya, Kajal, Rekha, Shivani and Premvati, the officials said. During interrogation, the accused revealed that a few of them had come in contact with an IVF centre and started donating their eggs to be used in IVF process. In this process, they came in contact with several couples who had no children of their own and could not even get through the IVF process, police said.

The gang would identify a pregnant woman having a poor financial background and strike a deal with her and her husband. When the child was born, they used to keep it in their custody, police said.

They would simultane-

ously identify several possible buyers and circulate the child's photograph among all touts through WhatsApp and sell the child to one who agreed to buy, the DCP said. Kajal and Priyanka are the mastermind of the gang. It is also suspected that their network is spread in other states as well. The accused revealed that Maheshwari provided the account number and the ATM card in which the money was deposited by the complainants, police said.

# **CRPF** reactivates Covid monitoring cell

## To track Covid situation in its ranks in view of Omicron rise

The Central Reserve Police Force (CRPF) has reactivated the Covid Monitoring Cell to track the daily situation reports of the pandemic in its ranks at its headquarters here "in view of the sudden rise in Covid-19 (Omicron) variant at the pan India level."

The Cell was deactivated on November 18 amid declining case count in its rank. All the formations have been asked to send daily situation reports of Covid cases to the Cell till further orders. The CRPF has only 44 active cases in its ranks at present, according to the directive circulated on Friday,



officials said quoting from the circular sent across all the CRPF establishments across

"The directive has been sent to all the formations of the

CRPF across the country asking them to update the Covid Monitoring Cell with the case counts on a daily basis so as to keep close tabs on any possible surge of the deadly viral disease

in the paramilitary ranks," an official said.

The Cell was reactivated within just five weeks of the closure of the Covid monitoring mechanism at the CRPF direc-

As on Friday, a total of 127 paramilitary forces' personnel were active cases of Covid-19, including eight men who con-tracted the disease during the last 24 hours. While a maximum of 44

Covid patients are in the CRPF ranks, the Central Industrial Security Force (CISF) has 36 cases followed by 32 in the Border Security Force (BSF), six in Sashastra Seema Bal (SSB), five in Indo-Tibetan Border Police (ITBP) and two each in National Disaster Response Force (NDRF) and the National Security Guard

Till Friday, the cumulative number of Covid cases in the paramilitary ranks stood at 88,584 out of which 88, 109 patients have recovered and 348 personnel have succumbed to the disease besides 127 patients continue to be actively infected with the contagious

### New Delhi: An application has been filed in the Supreme Court seeking early hearing on a petition challenging the Delhi High

Court's 2005 verdict which quashed all charges, including against the Hinduja brothers, in the politically-sensitive Rs 64 crore Bofors pay-off case. The application, filed by advocate Ajay Agrawal, has said

that the apex court had on November 2, 2018 dismissed the CBI's plea against the high court verdict and had said that the probe agency can raise all grounds  $\bar{i}n$  the appeal filed by him against the same judgement. Agrawal said he had filed

the petition in the top court against the high court verdict in 2005 itself and over three decades have gone by since the matter came into light.

"It is expedient in the interest of justice that the matter be heard at an early date," the application said, adding that there have been "recurrence of

hearing of plea against Delhi HC verdict scams" in the defence sector since the accused in the Bofors case "have not been punished".

It said three years have gone by since the top court had passed the November 2018 order and the matter has not been listed for hearing.

In its November 2, 2018 order, the top court had rejected the CBI plea seeking condonation of 13-year delay in filing the appeal against the May 31, 2005 judgement of the high court saying it is not convinced with the grounds furnished by the agency.

"We are not convinced with the grounds furnished by the petitioner for the inordinate delay of 4,522 days in filing the present Special Leave Petitions," the apex court had said in its order.

The high court in its 2005 judgement had quashed all charges against the three Hinduja brothers -- S P Hinduja, G P Hinduja and P P Hinduja -

and the Bofors company.

Before the 2005 verdict, the high court had on February 4, 2004, exonerated former prime minister Rajiv Gandhi in the case and directed the framing of charge of forgery under section 465 of the Indian Penal Code against Bofors company.

The Rs 1,437-crore deal between India and Swedish arms manufacturer AB Bofors for the supply of 400 units of 155 mm Howitzer guns for the Indian Army was entered into on March 24, 1986.Swedish Radio on April 16, 1987, had claimed that the company had paid bribes to top Indian politi-

cians and defence personnel.
The CBI on January 22, 1990, had registered the FİR for alleged offences of criminal conspiracy, cheating and forgery under the Indian Penal Code and other sections of the Prevention of Corruption Act against Martin Ardbo, the then president of AB Bofors, alleged middleman Win Chadda and

the Hinduja brothers. It had alleged that certain public servants and private persons in India and abroad had entered into a criminal conspiracy between 1982 and 1987 in pursuance of which the offences of bribery, corruption, cheating and forgery were committed.

The first charge sheet in the case was filed on October 22, 1999 against Chadda, Italian businessman and alleged middleman Ottavio Quattrocchi, the then defence secretary S K Bhatnagar, Ardbo and the Bofors company. A supplementary charge sheet was filed against the Hinduja brothers on October 9, 2000.A special CBI court in Delhi on March 4, 2011, had discharged Quattrocchi from the case, saying the country could not afford to spend hard-earned money on his extradition which had already cost Rs 250

# Bofors case: Application filed in SC for early | PIL in SC seeks direction for uniform procedure for case registration in HC

New Delhi: A PIL has been filed in the Supreme Court seeking directions to the high courts to take appropriate steps to adopt a uniform procedure for case registration and to use common judicial terms, phrases and abbreviations.

The plea, filed by advocate Ashwini Kumar Upadhyay, has also sought directions to the Law Commission to prepare a report in consultation with the high courts to ensure uniformity in judicial terms, phrases, abbreviations, case registration process and court fee.

"The terminology used by different High Courts for different types of cases is not uniform. This non-uniformity causes inconvenience not just to the general public but, in many cases, to the advocates and the authorities as well.

"Not just the terms used by

Teams deployed in 10 States with

them to refer to the same types of cases are different but even the abbreviations used to refer to these terms are different in case the same term is used. It is inexplicable as to why there is a difference in terminologies, procedure, court fees etc., within courts when all are governed by the same laws," said the plea filed through advocate Ashwani Kumar Dubey.

It said not only are the high courts adopting different norms and procedures for case registration and using different judicial terms, phrases and abbreviations but are also charging different fees, which is against the rule of law and the right to justice.

The petition stated that all 25 high courts across the country have different usage of phrases when it comes to identifying different cases. PTI

# JNUTA demands better guidelines for viva voce, evaluating candidates

New Delhi: The Jawaharlal Nehru University Teachers' Association on Friday demanded that a consultation be held across the varsity to evolve guidelines for conducting viva voce and evaluating candidates in a fair manner. The demand comes in the backdrop of allegations by students and teachers that there were anomalies in the process of admission to PhD programmes of the university. in particular, the discrimination faced by students belonging to

marginalised sections. "All data, in the past, pertaining to the final selection, including the marks obtained by candidates in written and viva voce examinations were posted on a notice board by the administration. However, this practice was stopped a few years back and candidates are now only provided information about their own marks," the JNUTA said. The teachers' body

demanded that the university administration make public all data regarding the marks scored by various candidates as was done in the past. "JNUTA also demands that a university wide consultation be initiated so as to evolve guidelines for conducting viva voce and evaluating performance of applicants in a fair manner. At the moment, there are no clear guidelines in the university about how interview boards should be constituted and candidates be evaluated," it said

# Covid puts damper on Christmas eve again around world

 $F^{\text{rom}}_{\text{Frankfurt to London and}}$ Boston, the surging coronavirus put a damper on Christmas Eve for a second year, forcing churches to cancel or scale back services and disrupting travel plans and

family gatherings.

Drummers and bagpipers marched through Bethlehem to smaller than usual crowds after new Israeli travel restrictions meant to slow the highly contagious omicron variant kept international tourists away from the town where Jesus is said to have been born.

In Germany, a line wound halfway around Cologne's massive cathedral, not for midnight Mass but for vaccinations. The offer of shots was an expression of "care for one's neighbor" that was consistent with the message of Christmas, cathedral provost Guido Assmann told the DPA news agency. Around the world, people weary from nearly two years of lockdowns and other restrictions searched for ways to safely enjoy holiday rituals."We can't let the virus take our lives from us when we're healthy," said Rosalia

Lopes, a retired Portuguese government worker who was doing some last-minute shopping in the coastal town of

She said she and her family were exhausted by the pandemic and determined to go ahead with their celebrations with the help of vaccines and booster shots, rapid home tests and mask-wearing in public. She planned a traditional Portuguese Christmas Eve dinner of baked cod.

In New York City, where omicron has spread widely, people waited in long lines to get tested, many doing so as a precaution before traveling to reunite with family.

But holiday travel was dealt a blow when major airlines canceled hundreds of flights amid staffing shortages largely tied to

Sadia Reins arrived in New York City from Alexandria, Virginia, on Friday to be with with her 75-year-old mother. Reins said the two haven't spent Christmas together in two years, and despite the risks in traveling during the out-break, she couldn't bear to be apart from her mother again this year. "We're going to cry," she said, adding: "We talk on the phone all the time, but it's not the same as looking at someone."In Britain, where the coronavirus variant is ripping through the population, some houses of worship hoped to press on.

At St. Paul's Old Ford, an Anglican church in East London, priests planned to hold services on Christmas Eve and Christmas Day. But to protect parishioners, the church called off its Nativity "You might have to cancel the service, but you can't cancel Christmas," said the Rev. April Keech, an asso-

# 1st White House Christmas less merry

Washington: So long eggnog, shrimp cocktail and pet-shaped sugar cookies. It's been a less merry holiday scene at White House this year under COVID-19's shadow. President Joe Biden and first lady Jill Biden have replaced packed parties and overflowing buffet tables of the past with food-free open houses, face masks and testing for the unvaccinated.

Beyond the impact on Biden's first Christmas in office, the virus and its variants largely put kibosh on entire White House social scene for 2021, starting with an inauguration that positioned flags in place of people on the National Mall. "I think it's been really tough on them," said Philip Dufour, who was Vice President Al Gore's social secretary. He noted that many events were not held while president and first lady did others over Zoom. Major social events scrubbed from calendar

included White House ball for nation's governors and Easter Egg Roll, the second straight year that springtime ritual has been cancelled.

The Democratic president also has yet to toast a foreign counterpart at a glitzy White House state dinner because he has yet to invite a world leader for a state visit. In fact, months passed before Biden was able to welcome a foreign leader to the Oval Office for even lower-key talks.Still, the White House managed to pull off some events despite pandemic, such as bill-signing and Medal of Honor ceremonies.

The Bidens also hosted large receptions for Hanukkah and for artists recognised by John F. Kennedy Center for Performing Arts. But pandemic's biggest blow to calendar came at Christmas, forcing White House to overhaul its holiday entertaining—and trim the guest list.

# Covid-19 makes Biden's On Christmas, Pope prays for pandemic's end, peace dialogues

Rome: Pope Francis prayed Saturday for an end to the coronavirus pandemic, using his Christmas Day address to urge health care for all, vaccines for the poor and for dialogue to prevail in resolving the world's conflicts.

Amid a record-setting rise in COVID-19 cases in Italy this week, only a few thousand people flocked to a rain-soaked St Peter's Square for Francis' annual "Urbi et Orbi" ("To the city and the world") Christmas address. Normally, the square would be packed with tens of thousands of holiday wellwishers. At least they could gather this year. Italy's 2020 holiday lockdown forced Francis to deliver a televised address from inside the Apostolic Palace to prevent crowds from forming in the square. Although Italy this week counted more than 50,000 cases in a single day for the first time, the government

has not ordered another lockdown.The pope's Christmas Day speech gives him an opportunity to draw a global audience's attention to conflicts big and small. This year was no different.

Francis lamented ongoing conflicts in Syria, Yemen and Iraq, newly flaring tensions in Ukraine and Ethiopia, and an 'unprecedented crisis" in Lebanon."We have become so used to them (conflicts) that immense tragedies are now being passed over in silence; we risk not hearing the cry of pain and distress of so many of our brothers and sisters," he said from loggia of St Peter's Basilica as Swiss Guards stood at attention in square below. Francis warned of pandemic tendency to withdraw and isolate, urging instead dialogue to try to resolve world conflicts. He prayed in particular for those most affected by virus, including women and chil-

dren who have suffered increased abuse during lock-downs. "Son of God, comfort the victims of violence against women, which has increased in this time of pandemic. Offer hope to young children and adolescents suffering from bullying and abuse," he said. He prayed for "consolation and warmth" for older adults who are alone, as well as for health care workers who "generously devote themselves" to caring for the sick. # Bangladesh ferry fire: Search operations on for missing passengers

Massive search operations continued for the second day on Saturday for the missing passengers of an overcrowded three-storey ferry carrying around 800 people that caught fire on the Sugandha River in southern Bangladesh, killing at least 41 people and injuring over 150 others. The fire broke out around

3:00 am (local time) on Friday in the engine room of the Barguna-bound MV Abhijan-10 launch that started a journey from Dhaka. Scores of passengers went missing in the mishap, police and fire service officials said.

"Coastguard, fire service officials and police are still looking for bodies as we are unsure about the exact number of the missing passengers," a district administration official told reporters in Ihalakathi district in southern coastlines. the river bank and joined the rescuers in engine-run boats to look for their missing relatives, officials said.

11 The record suggests 310 listed passengers were travelling in the ferry, but we assume the actual number was much higher," junior minister for shipping Khaled Mahmud Chowdhury told reporters after he visited the accident site on Friday.

Fire service officials earlier said most of the victims were burnt to death or died inhaling hot smokes as they were trapped inside the vessel, while many passengers jumped into the river but some of them could not swim ashore or be rescued. Officials said most of the dead passengers were assumed to be residents of Barguna where 37 bodies were sent for burial but relatives could identify only 14 of them.

"We have handed 14 bodies to relatives after mass funeral (in line with Muslim rituals)...The rests were buried under official arrangement as nobody could identify them," Barguna's deputy commissioner Habibur Rahman told reporters.

He said doctors have, however, kept the DNA specimen of the unidentified bodies so that the relatives might identify them in future. A seven-member commit-

### **China's Communist Party removes top Xinjiang official** sanctioned by US

**PTI** ■ BEIJING

The ruling Chinese Communist Party (CPC), headed by President Xi Jinping, has abruptly replaced its chief in volatile Xinjiang province, Chen Quanguo, who was sanctioned by the US over alleged human rights abuses against Uyghur Muslims in the region. Chen no longer serves as Secretary of Xinjiang Uyghur Autonomous Regional Committee of the CPC, state-run Xinhua news agency reported on Saturday.

Ma Xingrui, who was governor of Guangdong province, has been appointed as new party chief for Xinjiang. The CPC Central Committee has decided to give Chen another appointment, the news agency said in a brief report.

Chen has been accused by US, the UK and European Union of widespread human rights abuses against Uyghurs, but he is tipped for a promotion, Hong Kong-based South China development.

Last year, the US government had slapped sanctions against Chen and several other Chinese officials in-charge of Xinjiang Uygur Autonomous Region, stating they were "believed to be responsible for, or complicit in unjust detention or abuse of Uyghurs, ethnic -Kazakhs and members of other minority groups in Xinjiang".

The three Chinese officials banned by US were Chen Quanguo, CCP Party Secretary of Xinjiang Uyghur Autonomous Region, Zhu Uyghur Hailun, the then Party Secretary of Xinjiang Political and Legal Committee and Wang Mingshan, the Party Secretary of Xinjiang Public Security Bureau.

On Friday, Russia's Justice Ministry added two more rights groups to the registry of foreign agents: Coming Out and Revers, which advocate for LGBT rights and provide assis-LGBT community. Russian law mandates a

non-governmental organisation, a media outlet, an informal movement or an individual to be listed as a foreign agent for having received foreign funding — even a small donation from a foreign national counts — and engaging in loosely defined political OVD-Info, together with

other rights groups, launched a campaign in September to abolish the "foreign agents" law. As of late December, more than 240 organisations and over 260,000 individuals had signed a petition that describes the law as "discriminatory and unlawful.

## Greece: Death toll from capsised migrant boat rises to 16

Athens: At least 16 people died after a migrant boat capsized in the Aegean Sea late Friday, bringing the three-day death toll from such shipwrecks in Greek waters to at least 30.

The deadly accidents came as smugglers who arrange sea crossings for Europe-bound asylum-seekers increasingly favour a perilous route from Turkey to Italy, avoiding Greece's heavily patrolled eastern Aegean islands that were a prime destination for years.

The Greek coast guard said Saturday that 63 people were rescued after a sailboat capsized late Friday some 8 kilometers off the island of Paros, in the central Aegean.

The coast guard reported 13 deaths as of late Friday, but three more bodies were found early Saturday. Survivors told the coast guard that about 80 people had been on the vessel. The boat was towed to a nearby port, and authorities said the search for survivors and victims continued.

# Report: Women, kids among dozens killed in Myanmar

Myanmar government troops rounded up villagers, some believed to be women and children, fatally shot more than 30 and set the bodies on fire, a witness and other reports said Saturday.

The purported photos of the aftermath of the Christmas Eve massacre in eastern Mo So village, just outside Hpruso township in Kayah state where refugees were sheltering from an army offensive, spread on social media in the country, fuelling outrage against the military that took power in February.

The accounts could not be independently verified. The photos showed the charred bodies of over 30 people in three burned-out vehicles.

A villager who said he went to the scene told The Associated Press that the victims had fled the fighting between armed resistance groups and Myanmar's army near Koi Ngan village, which is just beside Mo So, on Friday. He said they were killed after they were arrested by troops

while heading to refugee camps in the western part of the township.

The government has not commented on the allegations, but a report in the state-run Myanma Alinn daily newspaper on Saturday said that the fighting near Mo So broke out on Friday when members of ethnic guerrilla forces, known as the Karenni National Progressive Party, and those opposed to the military drove in "suspicious" vehicles and attacked security forces after refusing to stop.

The newspaper report said they included new members who were going to attend training to fight the army, and that the seven vehicles they were travelling in were destroyed in a fire. It gave no further details about the killings.

The witness who spoke to the AP said the remains were burned beyond recognition, and children's and women's clothes were found together with medical supplies and food. 'The bodies were tied with ropes before being set on fire," said the witness, who spoke on condition of anonymity because he feared for his safety. He did not see the moment they were killed, but said he believed some of them were Mo So villagers who reportedly got arrested by troops on Friday. He denied that those captured were members of locally organised militia

Myanmar's independent media reported on Friday that 10 Mo So villagers including children were arrested by the army and four members of the local paramilitary Border Guard Forces who went to negotiate for their release were reportedly tied up and shot in the head by the military. The witness said the villagers

and anti-government militia groups left the bodies as military troops arrived near Mo So while the bodies were being prepared for cremation. The fighting was still

intense near the village. "It's a heinous crime and the worst incident during Christmas. We strongly condemn that massacre as a crime against humanity," said Banyar Khun Aung, director of the Karenni Human Rights Group. Earlier this month, government troops were also accused of rounding up villagers, some believed to be children, tying them up and slaughtering them. An opposition leader, Dr Sasa, who uses only one name, said the civilians were burned alive. A video of the aftermath of the Dec 7 assault - apparently retaliation for an attack on a military convoy - showed the charred bodies of 11 people lying in a circle amid what appeared to be the remains of a hut.

Fighting meanwhile resumed Saturday in a neighbouring state on the border with Thailand, where thousands of people have fled to seek shelter. Local officials said Myanmar's military unleashed airstrikes and heavy artillery on Lay Kay Kaw, a small town controlled by ethnic Karen guerrillas, since Friday.

The military's action prompted multiple Western governments including the US Embassy to issue a joint statement condemning "serious human rights violations committed by the military regime across the country".

## Four policemen killed in shooting by colleague in Sri Lanka: Official

A Sri Lankan policeman opened fire on a group of his fellow officers, killing four of them and wounding three others in eastern Sri Lanka's Thirukkovil town, a senior official said on Saturday.

The incident happened on Friday evening at Thirukkovil police station when police sergeant had opened fire at his colleagues killing three on spot. while another died in hos-

pital due to critical injuries."Four policemen were killed in the incident that happened on Christmas eve on Friday," a senior police officer

# Indian electronics mfg sector to touch ₹7 lakh cr next fiscal

New Delhi: Buoyed by the Government's ₹2.3 lakh crore policy push for self-reliant India, the domestic electronics manufacturing industry is expected to see 30 per cent growth in the next fiscal to be worth nearly ₹7 lakh crore.
While the Government

continues to make efforts to move up in the global electronics supply chain and is expected to come up with new policies and incentive schemes for wearables and IT hardware, the immediate challenges are those around electronic components, mainly electronic chips, and potential threats from the coronavirus pan-

"The value addition from local manufacturing units is expected to go up to 25 per cent next year from 18 per cent at present. The government is aiming to grow overall electronics production in the country by 30 per cent to over ₹ 6.9 lakh crore next year," a senior Ministry of Electronics and IT (Meity) official told PTI.

The Meity has proposed a PLI scheme of about ₹22,000 crore to promote wearables as well as enhance incentives for IT hardware manufacturers in

to increase electronics exports from India by 50 per cent.

According to industry body ICEA, whose members include Apple, Foxconn, Wistron, Lava and Vivo, mobile phone production in the country peaked at ₹ 2.2 lakh crore in 2020-21 and is expected to cross ₹ 2.75 lakh crore by March 2022.

Chinese players like Xiaomi, BBK Electronics group firms Vivo, Oppo, Realme and Iqoo dominate the smartphone segment with about 70 per cent market share.

'Chinese companies are only focussing on catering to the Indian market requirement. Therefore, they have not participated in the PLI scheme. We expect Indian companies to do well and become global champions," the Meity official

When asked about the contribution of Indian companies in electronics production, India Cellular and Electronics Association Chairman Pankaj Mohindroo said the share has come down from 47 per cent of volume in 2016 to under 8 per cent now.

The Government has

the next financial year as it aims already introduced a significant measure in PLI wherein under the USD 200 (about ₹15,000) segment is reserved for Indian companies. A slew of other support measures is also being planned and we are sure that not only will Indian companies have a share of the domestic market but they will also emerge as global champions at least in the entry level segment," Mohindroo said.

The electronics manufacturing growth in the country remained almost between ₹5,33,670 crore in 2020-21 and ₹5,33,550 crore in 2019-20.

'Today we are exporting 50 lakh phones, including smartphones. However, the concern remains that we are not still close to a strong electronics brand emerging out of India which could cater locally as well as become India's face lobally," market research firm Techarc Founder and Chief Analyst Faisal Kawoosa said.

The import of electronics n 2020-21 reduced to around 2.85 lakh crore from about ₹2.9 lakh crore in 2019-20 due to an increase in local manufacturing of consumer electronics items especially LED television sets and electronic



However, the import in the IT hardware segment increased to around ₹ 79,000 crore in 2020-21 from about ₹68,400 crore in 2019-20. MAIT CEO George Paul said that the digital infrastructure supported economic activity across the world during the lockdown which resulted in a boom in demand against a scaling down of worldwide semiconductor capacity.

Paul said that the shortage of semiconductors is because of a combination of the US-China trade war and the outbreak of COVID and the

forecast of a possible deceleration of global demand.

Infineon Technologies India Managing Director Vinay Shenoy said the demand for semiconductors remains extremely high and is by far outstripping supply.

He said that the imbal-

ance between supply and demand will continue for several quarters and will persist

BenQ India & South Asia managing director Rajeev Singh said that in the short term, the situation is gradually becoming better as trade gateways are getting aligned.

The government has made a third attempt to attract electronics chip makers in the country with Rs 76,000 crore incentive schemes spread over a period of six years and is confident of attracting 100 companies in the next 4 years under the package.

The Government expects two companies manufacturing electronic chips and two companies for manufacturing display units to set up their units in the country within four years with investment in the range of Rs 30,000 crore-Rs 50,000 crore. "In the context of the pre-

vailing geopolitical situation as well as pandemic pressures on electronics supply chains, there is a greater emphasis on diversification and building region-"In this context, India's initiative to build an end-to-end semiconductor manufacturing value chain in India from fab to box offers an unparalleled opportunity to establish India as a global electronics manufacturing hub, CMR Head of Industry Intelligence group Prabhu Ram

According to the electronics industries association Rajoo Goel, besides shortage of semiconductors, the industry is facing an unprecedented shortage of even multilayer PCBs (motherboards) and copper clad laminates.

"There is an equally severe shortage of raw materials such as Ferrite Powder which is impacting a large section of the Indian component sector viz transformers, inductors and coils where we have a significant presence," Goel said.

He said that some of Elcina members' companies are seeing over 20 per cent increase in the price of electronics components.

The mobile phone segment, which is a major consumer of semiconductors and the biggest contributor to 'Make in India' electronics segment, remains optimistic of facing the crisis as most of the players manufacturing their devices in the country are the global majors who procure electronics chips on a regular basis with prior commitments to their ven-

Mobile phone company Realme India CEO Madhay Sheth said that since the onset of this shortage, realme has been looking at and working on collaborations with chipset manufacturers who can provide processors to us without compromising performance.

"India is a key market for us, and therefore, we do not want our consumers to witness any shortage of products. We are also in conversations with mainstream chipmakers to keep ahead of the curve with new and powerful 5G chipsets," Sheth said. Lava International said that the challenge of semiconductors continues but they have made alternate arrangements to ensure continuity of the business but they had to increase the price of their devices due to the rise in the price of components.

"We believe that we can navigate through the current chipset shortage scenario by maintaining an optimum balance between demand and

supply.

"We have been successful in doing this pre-emptively and efficiently, which is reflected in the recent quarters where we have been able to cater to the market demand," HMD Global vice president for India and MENA region Sanmeet

# Govt to tweak subsidy policy to promote local production of P&K fertiliser

**New Delhi:** The Government on Saturday decided to make changes to the existing nutrient based subsidy (NBS) policy to promote domestic production of phosphatic and potassic (P&K) fertilisers amid a sharp rise in global prices. A decision in this regard was

taken in a high-level meeting chaired by Union Minister for Chemicals and Fertilizers Mansukh Mandaviya. In the meeting, "...It was

decided to continue support to the domestic industry for production of P&K fertilisers and propose additional provisions in the present NBS Policy to promote domestic production of P&K fertilisers in the country," an official statement said.

This decision will help in utilising the unutilised domestic production capacity of these fertilisers and promote 'Atmanirbhar Bharat', it added. and

Under the NBS policy, being implemented since April 2010, a fixed amount of subsidy which is

decided on an annual basis is provided on P&K fertilisers depending on their nutrient content. Under this policy, maximum retail price (MRP) of P&K fertilisers is fixed by the fertiliser companies as per the market dynamics at reasonable levels which is monitored by the gov-However, in the current

2020-21 fiscal, the government notified NBS rates for P&K fertilisers twice in order to keep

domestic prices of these soil nutrients reasonable to farmers and ensure adequate supply.

Keeping in account high global prices, the Centre has also provided a special one time package for additional subsidy over above the NBS rates for period from October 2021 till March 2022 for Diammonium Phosphate (DAP) and three most consumed NPK fertilisers.

The government has also included potash derived from

molasses under the NBS scheme with effect from October, 2021.

The country imports P&K fertilisers to meet its domestic demand. Global prices of these soil nutrients have increased continuously since early this

For instance, global prices of DAP had increased to USD 730 per tonne in September from USD 565 per tonne in May.

# NCLAT stays CCI order imposing ₹873 cr penalty on UBL, other beer makers

New Delhi: The National Company Law Appellate Tribunal (NCLAT) has imposed a stay on the orders passed by the fair trade regulator CCI slapping penalties on several beer makers, including United Breweries Ltd that faces a fine of ₹ 751.8 crore.

Passing an interim order, a two-member NCLAT bench has directed parties, including United Breweries Ltd, to deposit 10 per cent of the penalty amount by way of 'Fixed Deposit Receipt' within three weeks.

Competition The Commission of India (CCI) on September 24, 2021, imposed penalties totalling over ₹873 crore on UBL, Carlsberg India, All India Brewers' Association (AIBA) and 11 individuals for cartelisation in the sale and supply of beer.

The said order was challenged before the NCLAT, which is an appellate authority over the CCI. It hears appeals against any direction issued or decision made or order passed by the CCI.

... During the pendency of the Appeal, to prevent an aberration of justice and to secure the ends of justice, stays the impugned order dated 24.09.2021 in suo moto case no. 6/2017 subject to the payment of 10 per cent of the penalty amount levied by the first Respondent/CCI, by way of 'Fixed Deposit Receipt' to and in favour of the Registrar, NCLAT, New Delhi, within three weeks from the date of passing of this order," said an NCLAT order passed on December 23

The NCLAT has also directed the CCI and the All India Brewers Association to file replies over the notices issued by it.

The appellate tribunal has directed to list the matter on March 29, 2022, for admission. Confirming the development,



UBL in a regulatory filing said it received an order passed by the NCLAT, staying the CCI order upon a condition of predeposit of 10 per cent of the penalty amount imposed on the company.

The company will comply with the directions and the said 10% amount shall be deposited through a fixed deposit receipt within stipulated time as mentioned in the Order,' UBL had said, now controlled by Dutch-based multinational Heineken.

Earlier this year, Heineken had acquired additional ordinary shares in UBL on June 23 taking its shareholding in the company from 46.5 per cent to

61.5 per cent. The CCI had passed the final order against United Breweries Ltd (UBL), SABMiller India Ltd, now renamed as Anheuser Busch InBev India Ltd (AB InBev), and Carlsberg India Private Ltd (CIPL), among other entities. In its 231-page order, which had come nearly four years after ordering a detailed probe, the CCI had also directed the companies, associations and individuals to "cease and desist" from anti-competitive practices in the future. The period of cartelisation was considered to be from 2009 to at least October 10, 2018, with Carlsberg India joining in from 2012 and AIBA serving as a platform for facilitating such cartelisation since 2013. All three beer companies were lesser penalty applicants before



Throughout the world, 5,410,984 people have died so far from the coronavirus COVID-19 outbreak as on December 25, 2021 including 4,79,520 in India. Total Coronavirus cases in India till date are 34,779,815.

Omicron virus is a new mutant of SARS-CoV-2, which was first documented in South Africa on November 24, 2021. On November 26, 2021,WHO declared it as variant of concern.

India has so far recorded 415 cases of the Omicron variant across 15 States and Union territories. Omicron has more than 50 mutations with more than 30 being in spike protein itself which makes it highly transmis-

"In countries with documented community spread, doubling time of Omicron is one-and-a-half to three days. Omicron spreads three times faster than the delta virus which caused the brutal second wave in India. Omicron infected cases. Still vaccination would prevent severe disease, hospitalisation and deaths in infected

In India, more than 80 per cent have taken a single shot of COVID vaccine and about 50 per cent are fully vaccinated. Those who have not yet got vaccinated should get vaccinated.


"Wearing a mask properly, keeping a safe distance of six feet, maintaining hand hygiene, avoiding gatherings and crowded places and social meetings would prevent spread of this disease. It is expected that about 1.5 to 1.8 lakh cases per day would be recorded by the end of February 2022," Dr Gurmeet says.

# **ADHERE TO PROTOCOLS**

The third wave could be larger than the first two. To combat this, we strongly advise everyone to get vaccinated with two doses of the vaccine. The general public should also take extra precautions against new viruses and variations of novel coronavirus. Private healthcare companies are already providing the Government all of the resources it requires, including testing, isolation beds for treatment, medical personnel, and equipment at Government Covid-19 hospitals. ## **HEALING TOUCH**



# From the fastest growing economy in 2015, India became one of the slowest in the world in 2020 as its growth plunged to -7.3%, compared to the global fall of -3.1%. That tells its own tale, writes PRASANNA MOHANTY

The government thinks a 1.6% growth in FY22 over FY20, when growth was just 4%, is back to high growth. But India's annual average growth for 15 years before FY20 was 7%. To reach that level, it will have to address many structural challenges

fter claiming a V-shaped recovery ("India will be among only a few economies in the world to rebound strongly from COVID-19 induced economic contraction of 2020-21") and that India would become "the fastest growing one in the world" — all on the basis of first two quarters of GDP numbers for FY22 — the Finance Ministry's November 30, 2021 report gets factual: "The MPC (RBI's monthly monetary policy committee report) in its December statement has maintained the growth forecast of 9.5 per cent during FY 2021-22 (full fiscal), implying a full recovery and a 1.6 per cent growth over pre-pandemic GDP level of FY 2019-20." (emphasis added). But, what does the above sentence actually mean?

### ILLUSIONS OF A V-SHAPED RECOVERY

It means, the growth for full FY22 will be 9.5% (over -7.3% in FY21) but this would translate to only 1.6% growth over FY20. The FY20 growth was 4%.

This is hardly inspiring, especially since India's average annual GDP growth during the previous 15 years, between FY05 and FY19, was 7%.

All economies were hit by the pandemic. The IMF's World Economic Outlook report of October 2021 (which uses official data of all countries) says, global GDP will bounce back from -3.1% in 2020 (the pandemic year closest to India's FY21) to 5.9% in 2021 (India's FY22); advanced economies (average) from -4.5% to 5.2%; emerging economies (average) from -2.1% to 6.4% and India will bounce back from -7.3%to 9.5%.

From the fastest growing major economy in 2015, India became one of the slowest in the world in 2020 (ranked 142 out of 194 countries) as its growth plunged to -7.3%, compared to the global fall of -3.1%. That tells its own tale.

Now let us see the actual quarterly GDP numbers released in November 2021. It shows in the first two quarters (H1) of FY22, the GDP at constant price was ₹68.1 lakh crore. This is lower than ₹71.3 lakh crore in H1 of FY20. So, the GDP hasn't yet reached the FY20 level at this stage. Whether it will do in the full fiscal is purely speculative.

The official data also reveals that private consumption (PFCE), the most powerful growth engine contributing 55% to the GDP, is far off from FY20 level — ₹37.3 lakh crore in H1 of FY22 against ₹40.4 lakh crore in H1 of FY20. Actually, it is less than ₹37.9 lakh crore of H1 of FY19 too. This means, consumption demand

hasn't recovered to the FY19 level.

When demand engine slows down, it drags down other growth drivers: production of goods and services, capital expenditure (investment) and imports. Even this H1 GDP numbers don't reflect the real state of the economy.

That is because quarterly GDP is estimated mostly from organised/formal sector numbers (high-frequency indicators). The pandemic hit the unorganised/informal economy, which contributes nearly half of the GDP, the harder. Therefore, the quarterly GDP is likely an overestimation

There is enough evidence to show unorganised/informal sector grew in size due to the pandemic — explained later — thereby making the quarterly GDP numbers even more off the mark.

Yes, stock markets boomed during the pandemic crisis (2020 and 2021) but stock markets are disconnected from the real economy as economic literature tells. Further, the pandemic saw massive loss of lives, jobs and businesses (loss of income) and the economy plunging to new lows and yet stock markets boomed.

### WHY DID THE PANDEMIC HIT INDIA HARDER?

The reasons are several; one being low government (fiscal) spending. The Finance Ministry's March 2019 report had already warned that only this engine (government spending) was working, the three other engines — private consumption (PFCE), capital investment (GFCF) and net exports (exports minus import) — had sputtered out.

That is why eminent economists Amartya Sen, Abhijit Banerjee and Raghuram Rajan repeatedly pleaded for higher government spending. The government ignored them and its massive ₹23.66 lakh crore pandemic relief and stimulus packages of 2020 had fiscal spending component of just 1.6% of the GDP. In contrast, developed nations spent much more, the US, for example, spending more than 10%.

The budget for FY22 saw a minor correction with budget expenditure going up by just 1% over FY21 (RE) level. Given that government expenditure (GFCE) contributes about 11.5% to the GDP (in H1 of FY22), a 1% increase is too small to boost significant growth in FY22.

The two pandemic waves saw more than 4,75,000 deaths (third highest after the US and Brazil) and more than 34 million cases (second highest after the US). Since 60 million Indians slip into poverty every year due to 'catastrophic' healthcare cost in normal times, as the government admits, this means the pandemic (higher cost of treatment) would have pushed several multiple of this number into poverty. The Pew Research said the first wave alone might have pushed 75 million into poverty (with incomes of \$2 or less a day) — contributing "60% to the global rise in poverty."

A study by the Azim Premji University showed15 million jobs were lost permanently

(by the end of December 2020); there was 50% rise in informal workers as salaried/regular wage jobs shrunk and workers migrated to informal self-employment (30%), casual (10%) or informal salaried (9%) work and 90% people survey said their food intake had reduced.

The OECD countries saved 50 million jobs during the pandemic in 2020, India didn't any. It doesn't even have data on job or business losses/closures. Other than subsidised ration (which didn't reach migrant workers due to lack of data), the government offered little help to poor households who suffered the most.

As a result, India was the only country to witness massive distress migration to rural India and the demand for menial work under the MGNREGS went up dramatically. The number of households worked under this scheme rose from 54.8 million in FY20 to 75.5 million in FY21 and the number of individuals from 78.9 million in FY20 to 111.9 million in FY21. The trend continues in FY22 too (63.3 million and 90.7 million by December 13, 2021).

The people and the economy received a far bigger shock also because of gross incompetence of the government, which centralised all powers invoking the National Disaster Management Act of 2005, in handling the pandemic. There was no planning, no strategy and no preparations in announcing the lockdown. The same was the case with the unlocking and the second wave of 2021 which had been forewarned. Then, the second wave saw super spreader events like the Kumbh *mela* and month-long election rallies in West Bengal.

The pandemic crisis also saw a focus shifting to long-term "reforms" like new farm laws, new labour codes, declaration of *en masse* privatisation of public assets, monetisation of existing brown-field infrastructure (roads, ports, railways etc.) and inward-looking import substitution policy, instead of fire-fighting the pandemic called for. But the plunge to -7.3% in FY21 wasn't all because of the pandemic mismanagement.

#### PRE-PANDEMIC SLOWDOWN

India was already in a prolonged slowdown when the pandemic hit in early 2020.

This slowdown was due to a series of manmade disasters: the twin shocks of demonetisation and GST (both hurt poor households and informal economy); shutting down policy and planning body (Planning Commission of India) without a suitable replacement (NITI Aayog cheerleads the government, rather than provide rational policy inputs); fudged 2011-12 GDP series which inflated growth rates by 2.5 to 3.7% percentage points during FY12-FY17, as former CEA Arvind Subramanian pointed out; corporate tax cut of ₹1.45 lakh crore amidst fiscal constraints in 2019 and lack of critical data (impact of these pre-pandemic disasters on jobs and

businesses) for policy making. The combined impact was: • GDP growth fell from peak of 8.3% in FY17 to 4% in FY20.

• Growth in private consumption (PFCE) fell from peak 8.1% in FY17 to 5.5% in FY20.

• Growth in overall investment (GCF) fell from

a peak of 14.5% in FY18 to 5.4% in FY20.
Capital investment (GFCF) fell from a peak of 9.9% in FY19 to 5.4%.

• Net exports from a peak of 17.4% in FY18 to -0.8% in FY20.

• Household savings fell from 24% of GDP in FY11 to 19.6% in FY20.

A study by Ashoka University-CMIE showed that during the five fiscals between FY12 and FY21, jobs shifted from formal to informal sector. It noticed three disturbing trends:

• Manufacturing jobs nearly halved (fall of 46%) in five years

• Agricultural jobs increased by 4% (from 36%

to 40% in total employment)

Overall employment fell by 7% during the

period (from 407 million in FY17 to 378 million in FY21).

The PLFS of 2019-20 (pre-pandemic) showed a similar trend, as did the Azim Premji University study mentioned earlier, leading to a sharp decline in income and rise in poverty level.

#### THE ROAD AHEAD

Once the above facts and evidence are acknowledged, the road ahead becomes obvious. There is a need for both short and long-term

The short-term measures are to address the pandemic distress and hence, should focus on direct income support (cash transfers) to poor households as well as to struggling SMEs. This will revive consumption demand. A national employment policy (NEP) to focus on creating jobs, particularly in urban areas, should also get

The long-term measures are to address structural challenges that have emerged and caused the prolonged slowdown. This calls for a complete overhaul of the extant economic thinking. The focus needs to shift from promoting growth of top 10% or top 1% in the economic pyramid to the rest 90-99% of people who also constitute the economy. Without improving the social and financial health of 90-99% of the population, no economic growth will be sustainable in the long run.

Such policies then relook at skewed tax regime (tax burden less on those who can pay); indiscriminate handing over public assets to private business; industries running banks; laws that hurt the interests of farmers and workers and self-defeating import substitution and many more.

eventy one years after his demise, Sardar Vallabhbhai Patel occupies prime position in the national narrative. Interestingly, the Sardar has been brought to mainstream discussion, since *The Pioneer* had carried a report in 2012 about the memoirs of late MKK Nair, a Madras cadre IAS officer of the 1947 batch who had close rapport with the Sardar since 1942. Nair was a civilian officer in the then British controlled Government, posted at Hyderabad. His expertise as a bridge player helped him establish friendship with the close relations of the then Nawab of Hyderabad. The junior Nawabs, during the game of bridge after their quota of 'sundowners' fed Nair with all palace secrets which were transmitted by the latter to Sardar Patel. It was the memoirs of Nair that revealed the greatness of Sardar Patel to our generation.


History books in our schools and colleges are silent about the Iron Man while they sing paeans to Jawaharlal Nehru and Indira Gandhi. That is highly reprehensible because the role of Sardar Patel in Índia's freedom movement remains as important as that of Nehru. The second book on Patel was authored by Balraj Krishna, a well known journalist. Krishna's 2005 work India's Iron Man told the world about the unseen nature of the man with the stiff upper lip. The author has reproduced the words of Sir Hugh Garrett, ICS, who wrote a 'short but sweet letter' to Krishna in which he has said: "Of all Indians, I ever met, I place Sardar Vallabhbhai Patel as the greatest". Balraj Krishna belonged to that genre of writers who had direct access to the Sardar, which made him rarest of the rare journalist.

In most of the modern history works, Sardar Patel makes a brief appearance while Nehru is portrayed as the superstar. After reading the books like A Glimpse of World History, authored by Nehru, one gets the feeling that the first Prime Minister of India is an over rated character and his only advantage was that he had become a protegee of Mahatma Gandhi, the father of the nation. Moreover, Motilal Nehru, his father, was always around to ensure his coronation as the 'undisputed', 'unquestioned' and 'unchallenged' leader. Those were the days when politics had titans like Sardar Patel, Rajagopalachari and Kamaraj to save



the Indian National Congress from a total rout despite the efforts of certain section in the party to make it

The fact that there was an attempt by this cabal to distort history and belittle the role played by Sardar Patel has been proved beyond doubt by many instances. The person whom Mahatma Gandhi trusted and always turned for guidance and help in critical junctures was honoured by Bharat Ratna, India's highest civilian award only in 1991, more than four decades after his passing away. 

He has examined all the documentary evidences presented before him by historians and political commentators who never had any prejudice and whose minds were narrowed by family interests. The Justice sounds aghast at the way Nehru took over the princely state of Jammu and Kashmir on October 31, 1947, without informing Sardar Patel, who as the then Home Minister was in charge of that geographical entity. The Justice expresses his dismay as Nehru failed to make use of the United Nations Resolution of 13 August, 1948 that asked the Pakistani Army, tribal invaders and Pakistani nationals to leave the State of Jammu and Kashmir. The Prime Minister who rushed to the UN to complaint to the global community about Pakistan's illegal annexation of J&K failed to make use of the 13 August 1948 resolution which was offered on a platter to India. 
# A thriller that rewrites history

Based on events which are easily recognisable, Murali Murti's Supersonic is a fast-paced, racy political thriller which unfolds in the shadows of the corridors of political power, writes NARAYANI BASU

*Supersonic* is the story of India's first fighter jet: the HF-24 Marut. Told by Murali Murti, an academic when he is not an author, this is a fast-paced, racy tale which unfolds in the shadows of the corridors of political power. The inspiration for Supersonic lies in the greats of the genre that is the political thriller: Frederick Forsyth, Michael Crichton and George McDonald Fraser. Murti brings the same style, scope and scale that these stalwarts are renowned for to Supersonic, which opens at the height of the Second World War. It begins as all good stories do: with a murder and an undelivered letter which, had it reached its destination, would presumably have altered the course of history.

For a change, this is no exaggeration. Murti's story contains no fictional protagonists, basing itself instead on events which are easily recognisable. The narrative begins in 1955, when Indian Prime Minister Jawaharlal Nehru's sole focus was to not only build a vibrant democracy but to also try to position India as a global leader of a "third bloc" of nations that would stay neutral during the ongoing Cold War. In order to posit itself as strategically capable, India would need not only a domestic arms industry, but an indigenous fighter jet. Supersonic takes the reader — at an almost bruising pace — Delhi to cocktail clubs in Madrid, to private meetings in the Pentagon and faceless, nameless Soviet agents. Elaborately described espionage and secret political power-plays make up the fabric of this plot, but truth is another skein that runs through the narrative.

Since India's independence, Jawaharlal Nehru and his Defence Minister, V.K. Krishna Menon were united in their decision that India's power should be showcased in its own domestic programme: an indigenous multi-role fighter jet, capable of high altitude interceptions and strike missions. Enter Kurt Tank, the brilliant German aviation expert who had designed the Luftwaffe's prize FW-190 fighter during the Second World War. With Tank at the

helm of affairs, India began its journey to develop what it would need to face a modern, post-war world: a supersonic fighter jet, a missile programme and a nuclear weapons programme. Murti uses these events — replete with photographs, mock-ups and footnotes — to tell a fictional story of corporate and political espionage and a race against time. The characters in Supersonic are rich and colourful — ranging from newly dethroned Indian royals finding new ways to pay for their princely lifestyles to anonymous bureaucrats, and a shadowy German consortium that insisted on being a global puppet-master. Murti writes with a flair for the backdrop against which he sets his story — moving from the Marbella in Madrid to the Pentagon in the United States with ease.

Given the mystery that shrouds these events, it is a clever trick to base fiction on fact as it opens up a subject to new debate and questions, especially when it is based on empirical evidence.

Yet despite these setbacks, India's search for a capable indigenous fighter jet never stopped. Murti takes the reader over the 1970s, right through till the 1990s. The stage changes with fluid ease, introducing new players — Adnan Kashoggi and A.Q. Khan — against the backdrop of a changing world order:



NATO, Britain, France, Israel and Sweden. Murti's understanding of the shifts in technology and geopolitics is excellent, and it lends itself well to this fast-paced narrative of prowess and espi-

Supersonic closes four decades after independence, with the arrival of HAL's multi-role supersonic Tejas fighter on the scene. With it, India joined an elite group of countries that demonstrated the capacity to develop and manufacture socalled fourth generation fighters. There have been questions — there always will be, as *Supersonic* will tell you — on the procurement of international parts for what is called an indigenous fighter jet. But it is a huge step forward for India's military and strategic prowess.

Both Jawaharlal Nehru and Kurt Tank would have been proud.

# Beijing destroying Hong Kong's democratic future

The latest elections to the Hong Kong Legislature (known as Legislative Council or Legco) have clearly indicated how China is fast taking control over the island territory. Popularly termed as the first "patriots only" election for Hong Kong, it witnessed a record low voter turnout after the complete overhauling of the city's existing electoral system. Many China observers say that this trend has reflected a steep decline in the civic and political engagement of the Hongkongers in a largely orchestrated electoral process of the territory. According to a government media release, the 30.2 per cent turnout was far lower than the earlier record low of 43.6 per cent in the year 2000. It must be noted here that the last legislative election five years ago recorded a polling percentage of 58 per cent.

This election is a historic one for Hong Kong. This is the first election conducted after passing the infamous National Security Law on June 30, an hour before the 23rd anniversary of the city's handover to China by Britain in 2020. Officially it is known as the Law of the People's Republic of China on Safeguarding the National Security in the Hong Kong Special Administrative Region (HKSAR).

The law empowers Beijing to handle all the troublemakers in the island, particularly the pro-democracy activists and their supporters. Further, the law creates four prominent offences, namely secession, subversion, terrorism and collusion with foreign forces to endanger national security. Many say that this law will bring an end to Hong Kong's autonomy and democratic future forever. The island will fast turn into a Communist fiefdom. And the first signal has been directly sent by the results of this election only.

Also, this is the first election that took place after the massive pro-democracy movement of June 2019 when millions marched across the island territory, protesting against Beijing's intervention and demanding more autonomy as promised under the Basic Law under which Hong Kong had to be governed with "One Country, Two Systems" till 2047. electoral process as it is carried out under new stringent electoral reforms initiated in the month of March 2021. The reforms under the new electoral system offered the Government more vetting powers and it directly reduced the citizens to elect the candidates of their own choice. The new system simply allows the candidates screened by the government i.e. the "patriots", those exclusively loyal to Beijing and the Communist Party of China (CPC) to stand in the electoral fray. Previously, the half of the 70 seat Legco members were elected by the people directly and the other half were selected by trade and industry lobbies, mostly loyal to mainland China. The worst part is that under the new electoral system, the Legco half of the seats are filled by pro-Beijing trade and industry

protest that was extended up to open to popular public voting. And this has been observed as the lowest number of seats for popular representation of the commoners since the handing over of the territory to China in 1997. It is clear now that Hong Kong's pro-democracy movement will have to find other way out to fight the Xi regime and its tight National

Security Law. Further, this election will add more credibility to Carry Lam, the fourth and the current Chief Executive of Hong Kong since 2017 as she can show to Beijing that normalcy has returned to her city. Moreover, today the issue in Hong Kong is not freedom, basic rights and increasing intervention of Beijing over the autonomy of the island promised under the Basic Law. Crippling rent and large wealth inequality are simply making life unbearable in the city for the public. These are pressing issues beyond democracy. Thus, Beijing and the HKSAK administration under Lam hope that issue of survival will certainly bother more tic rights and freedoms. And, hence, the patriots may get a fair chance to deliver the goods and services to the needy in the days to come.

Thus, Lam said that 'it was an important election following the improvements to the electoral system to implement the principles of patriots administering Hong Kong". In the guise of bringing more locals into the city administration, Beijing is simply turning the Legco into another committee of the National People's Congress.

In a 1984 speech, the legendary Chinese leader Deng Xiaoping said, "We are convinced that the people of Hong Kong are capable of running the affairs of Hong Kong well, and we want to see an end to foreign rule. The people of Hong Kong themselves will agree to nothing less." But what Deng pronounced 13 years before the induction of the island into the People's Republic of China (PRC) seemed completely different as the Hongkongers gradually moved on with the archaic Communist system of Beijing.

Today, Chinese President Xi Jinping's only intention is to

display Beijing's money and muscle power and to claim as many territories as possible. In fact, his extremely aggressive foreign policy is stimulating increased global opposition both to the country and to the CPC. Succinctly, it is directly undoing decades of efforts by the PRC to assuage its neighbours that a stronger China will always be peaceful and absolutely non-domineering. Xi's predecessor Hu Jintao especially espoused the dictum called Hepen Queqi (Peaceful Rise or sometimes quoted as Peaceful Development) to convey to the world and its neighbourhood that China's fast growing political, economic and military might would not pose a threat to world peace and security. The policy was articulated by China to counter its so-called "Threat Theory". By 2004, then Chinese Premier Wen Jiabao said that China's rise "will not come at the cost of any other country, will not stand in the way of any other country, nor pose a threat to any other country". But what we have witnessed today is completely the opposite of all

these Chinese Communists

had preached before to mask the whole world. Not only its neighbours, but also its own rebel territories like Hong Kong and Taiwan, and precisely its own Uyghur Muslims in the westernmost Xinjiang Province are bearing the brunt of Xi's vastly militarised statecraft. Needless to say, Uyghur genocide is fast threatening the survival of the community in this restive region. Therefore, Hongkongers may also encounter the worst forms of Chinese atrocities in the days to come unless the CPC mends

its ways sooner or later. Meanwhile, the joint statements released by the G-7 and members of the Five Eves Alliance countries (Australia, New Zealand, Canada, the UK and the UK) criticised the Legco election that drew a record low turnout of voters in the recent history of the island. On a separate note, the EU, the UK and the US also denounced the results of the election. To all of them, the new changes imposed by the Communists in Beijing are simply eliminating any meaningful political opposition in the HKSAR.

Finally, one must say that

example for all that one can and should do to stand up for freedom in the face of an authoritarian regime of immense brutality. This dedication and bravery of the islanders must be cherished and celebrated. But as of now what has been observed is that no one could help the Hongkongers except they themselves. However, the UK is the only nation in the world that could legitimately step into the current crisis, simply because China's actions towards the island territory are directly violating the principles of the 1997 Sino-British Declaration. But Hong Kong people kowtowing to the wishes and commands of the CPC will lead to the death of another democratic challenge against China. It will indeed be a failure of the global liberal order if millions struggling for their basic rights and freedoms are not supported. What is fast taking place in this island is nothing but the brutality and total disregard for humanity kept covered under the rubrics of Xi's massive expansion plans. The road ahead for Hong Kong would be tumultuous. Sadly, most of the pro-democracy activists and lawmakers are today either in prison or in exile. China's mindless violence, spying tactics and massive surveillance system have already worked

. What Franklin D Roosevelt once said seemed appropriate for today's Hong Kong, "In politics, nothing happens by accident. If it happens, you can bet, it was planned that way." Hong Kong's current fate is all what the Mandarins have been planning quietly since the days of Deng to Xi now.

# Hybrid hearing: Way forward for justice delivery system

The adaptability of a hybrid format facilitates versatile case management in these uncertain times where social distancing restrictions may be relaxed or tightened at short notice. However, a clear-cut policy is required to promote transparency and consistency in the process of determining which elements of a case are suitable to be heard remotely and which are

ourts which have tradi-halls have switched over perforce onto virtual screens of desktop computers, laptops and the smartphone. But, how smart or truthful is such a mouse operandi for delivering justice has become the moot question today.

Since the year 2020, courts of India and also those in many other parts of the world have undergone a sea change in the mode and manner of dispensation of justice. The Covid-19 pandemic resulted in lengthy lockdown periods that almost knocked down the "rule of law" made by man to set right society. As it is, courts across all

rungs of the hierarchy are bogged down with an ever-burgeoning litigation. The reasons for this elephantine burden on courts are not far to seek, be it bad laws, poor enforcement or a rank failure on part of establishments to check corruption. This essay is an effort at trying to look at the brighter side of a dark scenario and to help nip the menace of "Lis pendens" or cases pending at courts of law by advocating the refined variety of "hybrid

hearings". During this period of suspended life in society, proceedings were largely curtailed or limited to those held over remote links. And, as proceedings recommence post lockdown, it becomes important to consider the legality as well as the future of such remote proceedings.

Even though it is my personal opinion that justice can only be dispensed to a large extent only in personal courtroom trials, hearings and arguments, many deliberations are on to evaluate whether remote hearings can be adapted into an effective and beneficial longterm initiative? The higher judiciary has

been expressing its views from the Bench and so have we practitioners of law. But, what about the litigants viewpoint?

Using technology to conduct trials and hear arguments from confines of remote homes was unthinkable as a normative practice even three years ago. Final hearings and also hearings with contested evidence are inevitably being conducted remotely using technology for otherwise there will be no hearings and access to justice would be a mirage.

The courts exist to resolve disputes. The default position now in all jurisdictions is that a hearing should be conducted with one, more than one, or all participants attending

In practice, many questions arise. Whether a particular hearing should be adjourned if the case cannot be heard face to face, or whether there should be a remote hearing even where several parties to the case are involved?

The continued administration of justice must be the overriding factor to determine this question. Justice delayed is justice denied even when the delay results from a response to the prevailing extenuating circumstances.

Nevertheless, it is equally important for a court to remember that there will be cases where the court cannot be satisfied that a fair evaluation of facts or resolution of disputes can be achieved by way of saying remote hearing. The appropriateness of the nature of proceedings should be individually assessed by the court.

A virtual or remote hearing, where it is appropriate, can only replicate some and not all of the characteristics of a fully attended hearing in the court hall (a postage stamp image of a particular attendee at the remote hearing is definitely a poor substitute to seeing that person fully present in flesh and blood, in the court).

Much may be lost in a remote hearing. The intervention of technology between the viewers and viewed, sterilises the exchange, removing a critical dimension of human interaction. The whole experience becomes literally and figuratively two-dimensional.

It is easier to lie to a machine than to someone's face. The truth does not hit you in the same way through a screen. The impact of both examination-in-chief and the cross-examination gets diminished. Vulnerable witnesses via video-link can prove to be a challenging task unless a closeup gaze of the camera is revealing. It is difficult to pick up on subtle emotional cues at a distance. This is important not just for the assessment of witness testimony but for proper client care, and for the ends of

This being so, cases that do not involve hearing or weighing live evidence are clearly more suitable for remote determination. Interim order hearings, directions hearings, case management hearings and prehearing reviews are natural contenders for continuing to be heard remotely. Simpler review and substantive hearings such as conviction, performance or health cases where impair-

ment is not contested can also be dealt with effectively without requiring attendance. Similarly, remote hearings are more suited to short cases. Remote hearings are easier to arrange at short notice. The litigants and witnesses do not need to arrange travel and accommodation, saving time, expense and expanding avail-

Added point is that a few have suitable private space at home to engage in private link without interruption for days

Herein comes the need for a hybrid system of court hearings. Instead of a presumption of a hearing in person, case hearings could be held remotely where it is possible and fair to do so: working from a staring point of the "due process of law" that is possible for proceedings to be held remotely, parts can then be "hived off" into sections where attendance would be required or advantageous in the interests of justice.

Some cases may be conducted in person until all witnesses, including parties to the litigation, have given evidence testimony, with the remainder proceeding remotely. Eventually almost all cases would lend themselves to some form of such hybrid solution to the odd

situation continuing to prevail worldwide. Thus, a hybrid hearing involves conducting all or a part of the proceedings without all the parties being present in person, physically in the court hall. Submissions, determinations and even the questioning of witnesses, where appropriate, can all be performed or delivered via alternative remote means.

Hybrid hearings introduce a greater element of flexibility, allowing the participation mode of various parties to be blended according to the circumstances of the particular case. They offer a compromise position which sits between the rigid choices of the hearing being conducted either fully

remotely or fully attended. The adaptability of a hybrid format facilitates versatile case management in these uncertain times where social distancing restrictions may be relaxed or tightened at short notice. 



# Dhyana brings out one's best

nce mind settles down, following the process suggested in the previous issue, a favourable inner mental climate gets created which is suited to pursue dhyana in right earnest. For, our restive mind becomes free from all the inconsequential thoughts, many negative, playing at the sub-conscious level, go out of reckoning. Mind-space thus becomes available to absorb fresh educative inputs, objectively process fresh thoughts and conduct sensibly. You will still continue to have in store, thought seeds parked at deeper layer of mind that hold the key to your habit tendencies. To get over them, you need to move to the next stage of the process — Detoxification of Mind.

The process is purposely so designed as to consciously invoke all instore thought seeds that keep driving us crazy, so as to resolve them through fresh educative inputs. At this stage, Guru will give you a two syllable/words mantra. Now sit comfortably, close your eyes and turn your attention inwards. The focus

has to be once again on the breath cycle — inbreath and outbreath. Now begin reciting the mantra inwardly — one sylla ble/word with inbreath and the other with outbreath. Mantra as such has no

religious implication; it actually has energy connotation. When you recite the opening syllable/word with the inbreath, you draw extra life forces from nature. That triggers the inlaid memory imprints registered in energy format — meaningful ones as positive energy and unseemly as negative energy. The churning that follows expels negative imprints, bringing into focus your limiting habit tendencies. Vibration of the second syllable/word helps drive away the negative energy. The process needs to be continued for at least 20 minutes every day. The two steps followed thus far correspond to Pratyahara.

It's time now to move on to work towards attaining the state of one-pointedness, which corresponds to 'Dharana' the 6th step of Patanjali's 8 fold path. The process is designed to induce value to the thought process through self-reflection on fresh educative inputs and give a positive turn to mind. The process has two working tools — a fresh *Mantra* and an iconic figure carrying valuable educative import. The two have to be individual specific, as prescribed by the Guru, which is based on the callings of your inherent frame of mind, particularly its wanting



*Mantra*, you may know, is actually a set of syllables placed in a logical sequence to create a particular sound effect, which as a sequel to stress created and uttered by mouth is heard by ears, and apprehended by the mind. Mantra is so called, because it comprises of 'mana' out of 'manana' and 'tra' out of 'trana'. Mana in Hindi lingua franca means mind; manana implies reflection in mind; and trana stands for liberation. So chanting of *mantra* helps attain liberation from mental limitations. Mantra in fact is a radiant energy, rather a sound body of consciousness set in correspondence with the consciousness of related imagery in focus. Repeated chanting of the mantra, with focus on the related imagery, consciousness of the seeker comes to terms with the *mantra* and the imagery in focus. You may still continue to be confronted with distracting thoughts. Try to remain disengaged from them. For, unless you pay attention to something, it may not affect you. Also, try to bring your attention back again and again to your focal point. Gradually, the distracting thoughts may go out of reckoning. Let me add here that when the sound note of the mantra resonate to the

imagery in focus, over a period of time, you may get so involved, that distracting thoughts, if any, may go out of reckoning. When you get fully established in the process, your mind will become one pointed, and you may remain focused for considerably a longer stretch of time.

As you graduate further in the process, the seeker is in harmony with the imagery and its educative import, as well as the resonating mantra. As you further get established in the process, a stage is arrived at when the mind, the *mantra* and the imagery turn into a seamless awareness. The state of dhyana is thus arrived at. You may then remain effortlessly focused for long, and at will. Mind then comes out with its optimum best, when its fully expanded vision would know no limits. Wherever you pay attention, the underlying truth comes out

With these words, I wish the valued readers to get geared up to grab the opportunities coming your way and brave challenges ahead in the New Year.
