The State government also declared three days of mourning, it said. The funeral would be held on Sunday afternoon.

Congress sources said Rosaiah's mortal remains would be kept at Gandhi Bhavan, the party head-quarters in Telangana, on Sunday to enable party leaders and workers to pay their last respects.

Rosaiah died while being taken to a private hospital here after he fell ill on Saturday morning, Cong sources said.

India's fourth Omicron patient in Mumbai, travelled unvaccinated

PNS NEW DELHI

33-year-old man from Mumbai from South Africa via Dubai and Delhi late last month has tested positive for the Omicron variant of the coronavirus, in the fourth such case confirmed in India.

On 24th November, the passenger reported mild fever after landing in Mumbai. He had not taken any COVID-19 vaccine. However, no other symptoms were observed. "This mildly symptomatic patient is being treated at the Covid Care Centre in Kalyan-Dombivali," a

government note said. Twelve of the passenger's highrisk contacts and 23 low-risk contacts have been traced and all have tested negative for COVID-19. Additionally, 25 of his co-passengers from the Delhi-Mumbai flight have also tested negative. More contacts are currently being traced.

Big relief as Jawad weakens

PNS VISAKHAPATNAM

Andhra Pradesh and Odisha coastal belts heaved a sigh of relief as the severe cyclonic storm Jawad weakened into a deep depression by Saturday evening and it was Visakhapatnam at 5.30 pm on Saturday. According to the Indian Meteorological Department (IMD), the system will further weaken into a depression in the morning hours of December 5.

The cyclone alert had created panic in the coastal areas of north Andhra Pradesh and south Odisha. The IMD alerted both governments about the danger bells from the system.

The Andhra Pradesh government, remembering the disaster brought by the recent Rayalaseema floods and heavy rains, alerted the coastal district administrations and made elaborate arrangements to deal with emergencies.

However, the system has developed into a depression, deep depression and intensified into a

cyclonic storm. As the entire cycle of the system developed, not coming too close to the shore, it has weakened in the sea itself. After weakening into a depression, according to the IMD predictions, it would move towards Puri of Odisha and further towards the

West Bengal coast.

However, under the influence of the cool climate conditions, the IMD has predicted heavy to very heavy rainfall at some isolated places in north coastal districts during the next 48 hours. Meanwhile, the condition of the sea is still very rough and it has been advised to fishermen to postpone their voyages till December 6.

APEPDCL gears up to deal with cyclone impact

The Andhra Pradesh Eastern Power Distribution Company elaborate arrangements to attend to the impact of Cyclone Jawad in the north coastal districts. Considering the distance travelled by the cyclone, it is likely to move towards Puri of Odisha. However, heavy to very heavy rainfall has been predicted in the north coastal districts, particularly Srikakulam and Vizianagaram. Also, extreme rainfall has been predicted at isolated places in the region during the next 48 hours.

The APEPDCL has identified 43 mandals to be affected by the cyclone in five districts. Special teams have been deployed and on Saturday, all the teams have reported at their appointed stations.

DISCOMs refund true-up charges to consumers

> Bringing a big relief to the power consumers across the State, DISCOMs have refunded to customers Rs 200 crore that was collected in the form of true-up

> charges. According to sources, DISCOMs collected the true-up charges from about 1.4 crore consumers in the September and October months along with the current consumption (CC) charges.

Out of the total Rs 200 crore collected as true-up charges by the DISCOM, the APEPDCL collected Rs 126 crore while APSPDCL



collected Rs 72 crore. The remaining Rs 2 crore was

collected by the APCPDCL from the consumers during the last two

As per a letter from the Andhra Pradesh Electricity Regulatory Commission (APERC) dated November 30, the true-up charges collected in September and October shall be adjusted.

The commission has informed that the APSPDCL and the APEPDCL have already adjusted the collected true-up charges in subsequent CC bills of the consumers, whereas APCPDCL will be adjusting the same in the bills issued to its consumers in December as intimated by the DISCOM.

India's tour of South Africa confirmed

India's tour of South Africa will go ahead "as originally scheduled" despite concerns over a new COVID-19 variant, Cricket South Africa confirmed through a press release on Saturday. The South African board, however, said that a few adjustment to the logistical arrangements have been made with arrival timings of the Indian team "moved out by a week". India will play three Tests and as many ODIs in South Africa as scheduled but the four-match T20I series will be held at a later date. "Cricket South Africa can confirm that the India Tour will continue as originally scheduled, with a few adjustment to the logistical arrangements, such as the arrival time of the India Team

CSA said in a media release. "The tour is now confirmed and the arrival timings of the India team will be moved out by a week, to allow for effective logistical planning," added CSA.

The South African board also confirmed that the tour will take place under the strictest COVID-19 guidelines.

He said the principles of scrutiny, monitoring and accountability have become part of governance system through a mechanism of parliamentary committees.

The PAC Centennial Celebrations are a testament to how successfully these principles have stood the test of time

He referred to the challenges affecting the implementation of the PAC recommendations. It was important to prepare a monitoring framework to assess how governments have implemented the PAC recommendations.

He said, "We are using the Audit Monitoring System Portal to monitor the submission of replies online in real time on the action taken by the concerned Ministries and Departments on the PAC recommendations, but there are two major issues that hinder



the effective functioning of this

Vijayasai Reddy suggested that the PAC should expand its powers in the matter of selection of items. Although the PAC has the authority to review CAG reports, it does not have the authority to refer to CAG for investigation of certain matters. Therefore, by allowing the PAC to recommend CAG subjects as decided by the majority of members, greater flexibility in PAC performance can be ensured.

"By following the PAC of Victoria (Australia)'s selfappraisal model in our country, the PAC can publish an annual agenda outlining its performance targets for the coming year and statistics on past performance. In particular, PAC members were advised to appoint technical advisors to understand the audit report," he opined.

"It may be worthwhile to recall that the failure of mediation led to disastrous consequences," he said.

The reasons for conflicts are many, including misunderstandings, ego issues, trust and greed. Ultimately, small differences of opinion can lead to a big conflict and even big conflicts can be resolved with some effort in understanding one another, he said.If conflicts arise in personal life, they can be resolved by avoiding the people we do not like or by sacrificing some money to get mental peace, among others,

A prudent person tries to

find ways to resolve conflicts amicably, he said.

But in a business, money, honour or reputation cannot be lost and the interests of business or industry cannot be sacrificed. In such a situation also, an easy way of settling disputes without wasting much time or money or losing peace of mind can be thought of, he said.

"Now to come back to the reality, in business you might have a difference of opinion and disagreements. One would usually start by initiating a dialogue to clarify issues. If it doesn't happen, you may still look for people who can help you resolve such issues by negotiating. If this also doesn't work, then

Anil takes a dig at Shekhawat, Naidu for remarks on AP floods

Minister for Water Resources Dr. P Anil Kumar Yadav slammed the leader of the opposition, Chandrababu Naidu, for politicising floods and stated that it was a flash flood, a nature's calamity, and not a man-made disaster.

Addressing a press conference, the minister also condemned the remarks of Union Water Resources Minister Gajendra Singh Shekhawat stating that he had ignored the facts and got carried away by the TDP agents. Recalling the Uttarakhand glacier incident that took place this year, the Minister said that it was a similar incident as floods, where 150 people had died but no one accused the Centre of trying to hide the truth. He said that TDP agents who joined BJP have been trying to mislead the Union Minister.

He clearly explained that the Annamayya project received high inflows which and caused flash floods beyond the capacity of the project gates, even if the fifth gate of the project is opened the outflow capacity of



the gate will only be 40,000 cusecs. He slammed the Opposition for trying to politicise the issue and mislead the public by blaming the government. He stated that the previous government ignored the proposal of constructing a new spillway of the Annamayya project and even failed to repair the damaged gate when there were no water

Minister Anil said that the Chief Minister continuously monitored the flood situation and took all the possible mea-

the opposition is slinging mud on the government by picturising it as a man-made disaster. He said that there was no prior warning of the flood, as such a large flood had never occurred since 1882 and stated that Chief Minister YS Jagan Mohan Reddy had already sanctioned funds for the construction of flood bank in Nellore during Nivar cyclone, and was about to open tenders on December 6.

Elaborating on the tragic flood, he said that the incident was caused due to unprecedented heavy rains in a short span of time, which led to the flooding of villages downstream following a breach to its bund. The inflows to Annamayya reservoir crossed 3.2 lakh cusecs, by November 19 morning, while its discharge capacity was only 2.17 lakh cusecs, and the entire capacity of the project is only 2.2 TMC. The huge amounts of inflows, there resulted in a breach of the project, causing unfortunate damage, said the Minister adding that it was purely a natural calamity.

Known for his incisive criticism, keen observation, and excellent recall of past events to put forth his views in a manner in which even his political opponents could not fault him, Rosaiah's long innings as an MLA, MLC, and MP would serve as

He was known for his wit, satire, gift of the gab, clear diction and clarity of thought. Age never interfered with the veteran Congress leader's stamina for debates and discussions. Accessible, humble and down-toearth, Rosaiah indeed remained a towering personality with his distinct stature and demeanour, reflecting Telugu culture, and would share several wise-cracks with legislators from all parties and media persons and would share valuable insights without ever criticizing the party'sdecisions.

Born on July 41, 1933 in Vemuru of Guntur, Rosaiah was the disciple of freedom-fighter and farmer leader N G Ranga and maintained a distinct identity and dignity which he imbibed from him. He entered the Legislative Council first time in 1968 and again in 1974 and 1980. He served in the cabinets of several Chief Ministers in the combined State from T Anjaiah, Kotla Vijayabhaskar Reddy, Marri Channa Reddy, N Janardhan Reddy to Y S Rajasekhar Reddy and became a confidante of every CM, particularly late YSR who used to regard him as a

father figure.

Although he handled various portfolios- Transport, Commercial Taxes, Home, Health, Education, Power, he left an indelible imprint as Finance Minister. He had the unique distinction of presenting the State Budget in the combined State for 15 times and seven times consecutively in YSR's Cabinet.

After the sudden demise of Chief Minister YS Rajasekhar Reddy in a helicopter crash senior leader Rosaiah was made Chief Minister by the Congress high command. If someone else had been the CM other than Rosaiah at that time AP politics would have been different.

After YSR became Chief Minister a second time after winning the 2009 Assembly elections the TRS was in trouble. During the YSR government, the TRS was on the verge of disappearing from politics as YSR had taken a firm decision against AP bifurcation.

At that moment, Rosaiah became Chief Minister and the decision on bifurcating AP was

left to the Congress high command and to the Central government led by the Congress.

When asked about the stand on state bifurcation, chief minister Rosaiah had said, "Sitting here, there is no chance for us to say yes or no. If it is an issue that could be decided by me or someone else here we can do it. But this is an issue that has to be looked into by the Centre and they will have to give us a permanent solution."

While YSR took a firm decision against AP bifurcation Rosaiah always said that this is an issue that has to be examined by the Centre. Understanding the mood of Rosaiah, the TRS intensified its movement for a




There was no peace in J-K under Article 370: Amit Shah

Article 370 was in place for decades but was there peace in Jammu and Kashmir, Union Home Minister Amit Shah asked Saturday, asserting that the 2019 abrogation of the Constitutional provision has ushered in peace, good business investment and an influx of tourists.

Shah made these remarks during an interaction at the HT Leadership Summit here, referring to a statement by former

ment will not be able to bring peace in the union territory until Article 370 is restored.

There was Article 370 for the last 75 years. Why was there no peace? If there is a relation between peace and Article 370, was the Article not in place in 1990? It was there in 1990 why there was no peace? Even if we include figures of targeted killings, we are not even close to 10 per cent. This means there is peace," Shah said at the event where he also delivered the keynote address.

Earlier in his address, Shah said no one believed that Article 370 and Article 35-A could ever be abrogated, and he referred to a conversation with his English professor who had been maintaining that the promise of removing Article 370 by the BJP will be passed on as it is to the next generation.

"I am happy that Prime Minister Narendra Modi abrogated Article 370 from the Constitution on August 5, 2019. Kashmir is at peace now, investment is

taking place, tourists are visiting and Jammu and Kashmir is gradually

Article 370, a temporary provision in the Constitution, gave special status to the erstwhile state of Jammu and Kashmir while Article 35-A prohibited people from the rest of India to buy properties in the erstwhile state.

stand united with the rest of the country,'

Both provisions were abrogated on August 5, 2019 and the state was divided into two Union Territories -- Jammu and Kashmir and Ladakh.

Shah said a common statement was issued against him and Prime Minister Narendra Modi that curfew was imposed for so long in J&K and Internet services were blocked in Jammu and Kashmir.

'When I went there and asked youths if we had lifted curfew, who would have lost lives? There was initial silence but then they said on video conference they would have been killed. Then I asked whom did Modiji save by imposing curfew. They said they were saved. Then I said the people of the country have to decide what do people, who oppose curfew, want," he said.

On the demand of J-K political parties that elections should take place after statehood is restored, Shah said Parliament has passed the act that elections will be followed by delimitation exercise.

Cyclone threat: Bengal govt evacuates thousands in coastal areas; heavy rain

The West Bengal government on Saturday evacuated thousands of people in South 24 Parganas and Purba Medinipur districts and urged tourists in popular sea resorts to stay away from beaches, as cyclone 'Jawad' loomed large over the Odisha-Andhra Pradesh coast.

Several places in the metropolis, North and South 24 Parganas, Purba and Paschim Medinipur, Jhargram, Howrah and Hooghly districts received light rainfall since morning, the weather office

said.
"'Jawad' moved slightly northwards with a speed of 4 kmph during the past six hours and lay centered about 230 km south-southeast

Vishakhapatanam (Andhra Pradesh), 340 km south of Gopalpur (Odisha), 410 km south-southwest of Puri (Odisha) and 490 km southsouthwest of Paradip (Odisha) at 5.30 am," the IMD said in a

The administration in South 24 Parganas and Purba Medinipur districts evacuated around 11,000 people from the coastal areas to safer locations, while boats with fishermen returned in Kakdwip, Digha, Shankarpur and other coastal belts, an official said.

"The system is likely to move north-northwestwards and reach west-central Bay of Bengal and thereafter is likely to recurve north-northeastwards, move along Odisha coast reaching near Puri around December 5 noon, and weaken gradually," a met office spokesman said.

However, the cyclone may weaken into a deep depression by the time it reaches the Puri

Rescue teams were seen asking scattered groups of tourists and locals to vacate beaches in Digha, Shankarpur, Tajpur and Bakkhali. A total of 19 teams of the National Disaster Response Force have been deployed in the state in the

Singh urged the MSMEs to invest more in research and development as it would help strengthen the nation's securi-

"You should bring new technologies, new products. You should not think that just because of your small, you cannot do great innovation," he added.

Around 12,000 MSMEs have joined the defence industry due to the government's initiatives,

development and the number of startups have increased in the defence industry due to these initiatives, Singh said.

In a meeting chaired by Chief Minister Yogi Adityanath, the Cabinet on Friday gave its nod to implement Atma Nirbhar Krishak Integrated Development Scheme in Uttar Pradesh from 2021-22.

Under this scheme, 1,475 Producer Organisations (FPOs) will be formed in the next three years in each development block of the state, the UP government

said in a statement. The state government is likely to bear an expenditure of Rs 1,220.92 crore for implementation of the scheme from



financial year 2021-22 to 2031-

The scheme will also help in achieving the target of utilising a budget of Rs 12,000 crore allotted to the state by the Centre under Agriculture Infrastructure Fund(AIF).

On July 8, 2020, the Union Cabinet had approved the AIF scheme. The scheme shall provide a medium to long-term debt financing facility for

investment in viable projects for post-harvest management infrastructure and community farming assets through interest subvention and financial support.

Under the scheme, Rs 1 lakh crore will be provided by banks and financial institutions as loans to Primary Agricultural Credit Societies, Marketing Cooperative Societies, FPOs, Self Help Groups, farmers, joint liability groups, multipurpose cooperative societies, agri-entrepreneurs, startups, aggregation infrastructure providers and central/state agency or local body sponsored Public Private Partnership Project.

All loans under this financing facility will have interest subvention of 3 per cent per annum up to a limit of Rs 2 crore. This subvention will be available for a maximum peri-

Over 550 applicants for BEE energy awards

Mangalore Refinery to acquire subsidiary's 1,000 cr bonds Mangalore Refinery



Petrochemicals Ltd on Friday said it has received board approval to acquire debentures worth up to Rs 1,000 crore issued by its subsidiary ONGC

Petrochemicals Limited (OMPL). "...the Board has approved...acquisition of up to 100% of CCD issued by OMPL, a wholly owned subsidiary of the Company, from the debenture holders, for an aggregate consideration of up to INR 1,000 crores," MRPL said in a regulatory filing. The company board also discussed raising of funds by issuance of perpetual bonds and advised the management to have further consultations with the proposed investors. "Accordingly, no decision was taken in respect of issuance of perpetual bonds," it added.

China's Didi to leave US stock market

China's dominant ride-hailing service, Didi Global Inc., has said it will pull out of the New York Stock Exchange and shift its share trading to Hong Kong as the ruling Communist Party tightens control over tech industries.

Didi gave no explanation, but China's leaders increasingly fret about who controls information gathered about its public by e-commerce, ridehailing and other tech companies. Beijing sees that as a valuable asset and security risk.

Regulators said in July they would step up scrutiny of tech companies with shares traded abroad and their information security and cross-border data

Didi's share price fell 25 per cent after regulators launched an investigation into its handling of customer data following its June 30 stock market debut.

conscientious "After research, the company will start delisting operations on the New York Stock Exchange immediately and commence



preparations to list in Hong Kong," Didi said on its social media account on Friday.

A separate statement said U.S. shares would be converted into "freely tradable shares" on another "internationally recognised" exchange.

Hong Kong is Chinese territory but has a separate regulatory system that allows foreigners to invest in its stock market. Mainland markets are mostly off-limits to foreign capital.

Tech entrepreneurs who are largely shut out of the state-run financial system have raised billions of dollars abroad. But the ruling party worries about how that affects control of their companies. It is promising

more access to capital within China.

Didi Chuxing raised about USD 4.4 billion in its market debut. The company earlier denied a news report it planned to buy back its U.S. shares.

Other companies including Alibaba Group, the world's biggest e-commerce company, and Tencent Holding, which operates the popular WeChat message service, also have been hit by data security and anti-

monopoly probes. Investor jitters about the crackdown have knocked more than USD 1 trillion off the total market value of Chinese tech companies on U.S. and other foreign exchanges.

Didi was founded in 2012 by Alibaba veteran Will Wei Qing Liu, a former Goldman Sachs managing director and the daughter of Liu Chuanzhi, founder of computer maker

Lenovo Group.
It expanded abroad in 2018 by acquiring Brazil's 99 Taxis and set up operations in Mexico. Didi operates in 16 countries, though almost 90 per cent of the 493 million customers who used the service at least once in the past year are

Didi acquired rival Kuaidi in 2016 and Uber Technologies Inc.'s China operation the following year. Other competitors in the USD 50 billion-a-year market include Caocao Chuxing, a unit of automaker Geely, and Hello Chuxing, backed by Alibaba.

Following its investigation, China's cyberspace regulator said in July "serious violations" were found in how Didi collected and stored personal information. Didi was later ordered to remove 25 of its apps from online stores.

Singapore stops VTL travel for work pass holders

Singapore government on Saturday said employers of S Pass and work permit holders in construction, marine shipyard and process sectors will not be allowed to make new applications for their employees to enter the country via the vaccinated travel lanes (VTL).

The decision by the Ministry of Manpower (MOM) comes in the wake of rising concern over the Omicron variant globally.

On Friday, Singapore had announced the tightening of rules for VTL travellers in view of the new variant (Omicron). The S Pass allows mid-level skilled foreign staff to work in Singapore.

The ministry said that S Pass and work permit holders in the construction. marine shipyard and process sectors, as well as other dormitory-bound workers, should come in via the work pass holder general lane.

They may also enter Singapore via ongoing industry initiatives such as programmes with "upstream testing" and isolation in the source country, it said.

The number of workers entering under these lanes meet industry needs while allowing the entry of these workers to be done at a pace where they can be safely onboarded before entering the dormitories and worksites as these are higher risk settings," the Channel News Asia quot-

ed the MOM as saying. The entry of workers under these lanes is done at a pace where they can be safely onboarded before entering high-risk settings like dormitories and worksites, said MOM in a statement. For instance, workers have to show verification of vaccination and go for medical examination under these lanes.

The Ministry said workers, who have obtained approval prior to the effective date to enter Singapore via VTLs, will still be allowed to do so.

Delhi Customs intercepts Pakorigin smuggled cosmetics



Delhi Customs has intercepted Pakistanorigin smugaled cosmetic goods weighing 2,800 kg worth Rs 1.2 crore, the finance ministry said on Friday Acting on specific intelligence, officers of the Air Cargo Export

Commissionerate intercepted an import consignment at New Courier Terminal on November 29. "A case of outright smuggling of Pakistan origin cosmetic products weighing 2800 kg was detected. The goods were being routed through Abu Dhabi under the guise of household articles to evade detection," the ministry said in a statement. The seized smuggled goods are worth Rs 1.2 crore, it added. A lot of 87 consignments had arrived from Abu Dhabi. Upon examination, 84 consignments were found to contain cosmetics of Pakistani origin, while three consignments were of perfume concentrate from Bahrain. "Any imported goods originating from Pakistan attract Basic Customs Duty at the rate of 200 per cent of the value of the goods. "The goods were attempted to be cleared through courier mode by misdeclaring the origin and description of goods, value and, thus evading the applicable customs duty and IGST leviable.

Growth in US services sector reaches new heights in Nov

Growth in the services sector, where most Americans work, hit an all-time high in November, overtaking a record that was set the previous month.

The Institute for Supply Management reported Friday that its monthly survey of service industries increased by 2.4 percentage points in November from the October record to a reading of 69.1 percent. Any reading above 50

indicates growth. Some of the strength in the services sector is coming from supply chain troubles that are making it harder to meet increased demand

'India exemplary in publishing its forex moves'

India has been exemplary in publishing its foreign exchange market intervention, the US Treasury Department said on Friday adding that New Delhi should allow the exchange rate to move flexibly to reflect economic fundamentals.

'The (Indian) authorities should allow the exchange rate to move flexibly to reflect economic fundamentals, limit foreign exchange intervention to circumstances of disorderly market conditions, and refrain from further significant reserve accumulation," it said.

"As the economic recovery progresses, the authorities should continue to pursue structural reforms that can help lift productivity and living standards, while supporting an inclusive and green recov-



er," the Treasury said. In its semi-annual Report to Congress on Macroeconomic and Foreign Exchange Policies of Major Trading Partners of the United States, the Treasury reviewed and assessed the policies of its major trading partners, comprising more than 80 per cent of its foreign trade in

goods and services, during the

four quarters through June

In accordance with the Omnibus Trade Competitiveness Act of 1988 (the 1988 Act), the Report concludes that no major US trading partner manipulated the rate of exchange between its currency and the US dollar for purposes of preventing effective balance of payments adjustments or gaining unfair competitive advantage in international trade.

However, it found that 12 economies warrant placement on the Treasury's "Monitoring List" of major trading partners that merit close attention to their currency practices: China, Japan, Korea, Germany, Ireland, Italy, India, Malaysia, Singapore, Thailand, Mexico, and Switzerland. All except Switzerland were on the Monitoring List in the April 2021 Report.

"India has been exemplary in publishing its foreign exchange market intervention, both monthly spot purchases and sales and net forward activity, with a two-month lag. While the RBI frequently intervenes in both directions, the RBI purchased foreign exchange on net in 10 of the 12 months through June 2021, with net intervention reaching USD 131 billion, or 4.6 per cent of GDP," it said. "The RBI made large pur-

chases between July 2020 and February 2021, followed by modest sales in March and April this year as India's second outbreak took hold and net foreign portfolio flows turned negative," it said.

Observing that India has battled two outbreaks of COVID-19 since the onset of the global pandemic in March 2020, the Treasury said India's large second outbreak in the second quarter of 2021 weighed heavily on growth.

With cases coming down significantly from the May peak as of end-October, high frequency indicators suggest economic activity has been rebounding quickly since early in the third quarter, the report

Dish TV to hold AGM on **December 30**



convening of the 33rd AGM of the equity shareholders of the company on Thursday, December 30, 2021," said Dish TV in a regulatory filing. Earlier on November 29, Dish TV had postponed its AGM for a month after getting regulatory approval from the Registrar of Companies, Mumbai. The AGM of the Essel Group firm was scheduled to be held on November 30, 2021. Dish TV is facing a notice from Yes Bank Ltd (YBL)to remove its Managing Director Jawahar Goel and four other directors from the board. YBL, which holds a 24.19 per cent share of Dish TV, has moved National Company Law Tribunal (NCLT) after the board of the Essel group firm rejected YBL's requisition notice to convene EGM to reconstitute the board. Earlier on October 29, Dish TV had said it will seek time till December 31 for conducting AGM amid the pendency of a petition filed by Yes Bank before the NCLT. In September, RoC had already granted Dish TV a two-month extension. Dish TV's AGM was earlier scheduled to be held on September 27 and was postponed after getting above mentioned two-month extension. INNER PEACE LEADS TO OUTER PEACE


We can develop our spiritual side. By learning meditation, we can spend some time each day coming in contact with God within ourselves. As God bathes us in love and bliss, we are

COMING OF AGE: THE 21ST INDIA-RUSSIA SUMMIT

ENERGY, TECHNOLOGY, TRADE

The primary driver of the India-Russia strategic partnership is its contribution to the transformation of the two countries in the 21st century. Bilateral cooperation in energy, technology, and trade to achieve this objective is a priority for both countries. The Summit is expected to endorse three energy cooperation projects, viz. investments by ONGC-Videsh, Indian Oil and Oil India into Russia's Rosneft owned Vostok which has an estimated reserve of about 6 billion tonnes of crude oil; potential Indian investment into the Arctic LNG-2 gas field in Siberia which has 461 billion cubic metres of natural gas; and possible Russian investment into the Paradip cracker plant in Odisha, which will open a new avenue of cooperation in petrochemicals.

Nuclear energy, with its strong linkage with international security, plays a big role in India's energy security framework. Today, Russia is the only major nuclear power partnering India after the historic 2008 waiver given by the Nuclear Suppliers Group. India's largest nuclear power plant at Kudankulam in Tamil Nadu is an India-Russia project for six nuclear power reactors of 1000W each, of which two units came on stream in 2017, two more are expected to be operational in 2027, and construction of the fifth and sixth units was begun on 29 June 2021.

Three areas with a strong technological imprint, viz. cooperation in outer space, the digital economy, and the Blue Economy, are expected to transform the contribution of India-Russia scientific and technological collaboration to the strategic partnership. Space cooperation has built upon on existing satellite launches, the GLONASS navigation system, and cooperation in training India's astronauts in Russia for India's first manned space mission (Gaganyaan) due to be launched in late 2022 or early 2023. Digital cooperation is spearheaded by youth-driven digital innovation involving India's Atal Innovation Mission and Russia's Sirius, and encompasses areas such as additive manufacturing, 3D printing, blockchain, Artificial

Intelligence, and Big Data Analytics. Cooperation in the Blue Economy, as part of India's SAGAR Indian Ocean policy, will look at deep sea research and shipbuilding. The Summit is expected to agree to establish a Joint Commission on Science and

The 2019 Vladivostok Summit's target of reaching \$30 billion two-way trade by 2025 has been set back by the unexpected contraction of the economies of both countries due to the Covid pandemic. In the financial year ending March 2021, two-way trade was valued at \$9.31 billion, with Russian exports to India accounting for \$5.83 billion and Indian exports to Russia \$3.48 billion, mostly the result of public sector led trade. Despite a growth of about 30% in the first six months of 2021 compared with the same period in 2020, the Summit will need to find ways to significantly increase private sector participation from both countries in trade and investment relations, including through greater financial sector cooperation.

PEOPLE TO PEOPLE

On 22 January 2020, India hosted the first Ganga-Volga Dialogue, an idea that emanated from discussions between President Putin and Prime Minister

Modi.The Dialogue touched upon four broad themes in the context of India-Russia bilateral cooperation; viz. education, culture, and civilisation; entrepreneurship and innovation; trade routes including inland navigation; and India, Russia and Greater Eurasia. The Summit's endorsement of this initiative will be a major impulse to encourage greater people-to-people interaction and sustain their strategic partnership.

On 8 July 2021, speaking at the prestigious Primakov Institute in Moscow, External Affairs Minister Dr S Jaishankar identified "geo-political compatibility, leadership trust and popular sentiment" as the key drivers of the India-Russia special and privileged strategic partnership. Both India and Russia seek a multi-polar world, where "no single country is able to impose its will through domination or through military force." This will be the key takeaway of the 21st India-Russia Summit.

Artah worshippers

Driven by needs/difficulties, the artah stage of a soul marks the start of spiritual journey, writes AJIT KUMAR BISHNOI

This Sanskrit word means distressed, troubled, etc. Lord Krishna refers to such persons in the verse # 7.16 of the *Bhagavad Gita*, when He refers to four kinds of virtuous people, who worship God. Lord Krishna commends them as really noble, because they choose to seek help from God (7.18) Three kinds of sufferings are common to everyone on this planet earth, which the Lord has described as impermanent place of miseries. (8.15) These are what we get due to punishable acts (karmas) done in the past, which include previous lives. Then, others give us trouble. And natural forces also cause sufferings, like this pandemic.

The artah stage of a soul marks the start of his spiritual journey. Yes, it is driven by material needs/difficulties, but such persons have taken the first step out of four steps needed to reach the final stage of being a wise person. Then, one becomes just like God, that is his consciousness is yoga-based and he remains well established only in God-the supreme destination. (7.18) In the artah stage, the consciousness is much lower, and is influenced by all the three modes, with the lower modes still playing substantial roles. In comparison, a person becomes wise after having transcended all the three modes. Some advanced artah persons also possess attributes of the next two stages, that is of being seekers of wealth and being inquisitive about God.

Though artah stage is the initial stage in the spiritual journey, such persons have faith in the existence of God. That is the reason they approach God for relief. They are aware that God is supreme. However, what everyone does not realise is that the "karmapha-



la principle" is being administered by higher authorities. And they act strictly as per guidelines set by God. Another mistake by most people is to assume world to be a place of fun. Both India and Russia seek a multi-polar world, where "no single country is able to impose its will through domination or through military force". This will be the key takeaway of the 21st India-Russia Summit scheduled to be held on December 6, writes ASOKE MUKERJI

he 21st bilateral India-Russia Summit scheduled for December 6, 2021 marks the coming of age of the special and strategic privileged partnership between the two countries. This will be President Vladimir Putin's second foreign visit after the onset of the Covid pandemic in March 2020, and his first to any country in Asia, signaling the salience and resilience of the India-Russia strategic partnership. The annual summit mechanism, proposed by Russia's President during his first official visit to India in October 2000, has vindicated its role in steering the India-Russia strategic partnership through the momentous changes of the past two decades.

BACKGROUND

The 2019 India-Russia Summit at adivostok charted innovative approa sustain and broaden India-Russia relations. These included the long-term participation of both countries in each other's strategic sectors such as defence, energy, and technology. The resource-rich Russian Far East was added as a new dimension for trade and economic cooperation between enterprises of India's constituent states and Russia's eastern regions, pushing cooperation in Asia as the new frontier of India-Russia relations. A \$1 billion Indian line of credit was earmarked to implement this initiative, which would be sustained by a new maritime link between Vladivostok and Chennai through the Pacific and Indian oceans.

THE COVID PANDEMIC

The unexpected Covid pandemic created a barrier to the smooth implementation of these objectives, leading to the postponement of the 2020 India-Russia Summit. Despite this setback, the close personal interaction between Prime Minister Narendra Modi and President Putin, who have met 19 times since 2014, bridged the physical gap by using digital communications technologies to maintain the momentum, trust, and dialogue that are the hallmarks of India-Russia strategic relations.

A phone conversation on March 25, 2020 between the two leaders resulted in an agreement on ways to maintain the progress and warmth of bilateral relations. A joint response to the pandemic began in April 2020, when India lifted its ban on export of medicines to Russia to mitigate Covid. By mid-2020, the Gamaleya Research Institute of Russia developed the Sputnik-V human adenovirus vector platform vaccine against Covid. In April 2021, after clinical trials in India, the Sputnik-V vaccine joined Covishield and Covaxin on the list of vaccines registered for emergency use in India. In May 2021, joint manufacturing of the Sputnik-V vaccine in India through the Russian Direct Investment Fund (RDIF) was initiated, adding to the pool of Indian manufactured vaccines against Covid for domestic and international use in third countries.

DEFENCE AND FOREIGN POLICY DIALOGUE

President Putin and Prime Minister Modi agreed in a telephone conversation on April 28, 2021 to institutionalise a 2+2 Ministerial India-Russia Dialogue on foreign and defence cooperation to anchor the bilateral strategic partnership.The first India-Russia 2+2 Dialogue is expected to take place on the margins of the 21st

The ferocious border confrontation between India and China in May 2020 at Galwan caused another challenge for India-Russia relations, as Russia was chairing the trilateral Russia-India-China (RIC) grouping in 2020. However, by participating in the RIC videoconference meeting of foreign ministers on June 23, 2020, and subsequently in a physical ministerial meeting in Moscow on September 10, 2020, Indian and Chinese foreign ministers were able to hold a bilateral "frank and constructive discussion" and agree on the need for new confidence-building measures. India has acknowledged its appreciation for Russia's regular arms supplies to India for Russian origin defence equipment during this period.

The focus on long-term India-Russia defence cooperation benefited from regular interaction between India's Raksha Mantri Shri Rajnath Singh and Russian Defence Minister General Sergei Shoigu during the past two years. The Raksha Mantri participated in the events in Moscow marking the 75th anniversary of the Soviet Union's victory over Nazi Gerr June 24, 2020, and interacted bilaterally with his Russian counterpart during his visit to Moscow for the Shanghai Cooperation Organisation (SCO) Defence Ministers meeting on September 3, 2020, and the SCO Defence Ministers meeting in Tajikistan on July 28, 2021.

The outcome of this interaction includes the first manufacturing joint venture between India and Russia with transfer of technology for about 600,000 world-class AK-203 Kalashnikov rifles at the Korwa Ordnance Factory in Amethi, Uttar Pradesh. Other outcomes include the manufacture and co-production of four Project 1135.6 naval Frigates; the supply of 400 more T-90 tanks; additional supplies of Su-30 MKI, as well as the MiG-29 aircraft; and additional supplies of the MANGO ammunition & VSHORAD systems. The supply of the first unit of the S-400 air defence systems from Russia to India contracted in 2018 is to be completed by the end of 2021. India and Russia are expected to sign an agreement on reciprocal logistic support for each other's armed forces that come for exercises in either country.

The current value of India-Russia defence contracts is between \$9-10 billion, making Russia a top defence partner of India. By participating in the Make in India programme, Russia has committed to the transfer of defence technologies to India that it does not share with other countries, while Russian investments in Indian defence production will generate employment and boost defence exports. This approach mirrors India's investments in Russia's defence manufacturing sector two decades ago, which resulted in the supply of technologically advanced equipment for all three services of India's armed forces, including the BrahMos missile system. The Summit is expected to extend the mandate of the India-Russia Military Technical Cooperation platform chaired by the two Defence Ministers by ten years to 2031.

A similar process of regular interaction between India's External Affairs Minister Dr S Jaishankar and Russian Foreign Minister Sergei Lavrov has enabled the India-Russia strategic partnership to respond in a calibrated manner to international challenges. Besides the RIC meeting of 2020, India's foreign minister has visited Moscow for the SCO Foreign Ministers meeting in September 2020 and for a bilateral visit in July 2021, while the Russian foreign minister visited India in April 2021. The two ministers have interacted in the Brazil-Russia-India-China-South Africa (BRICS) framework twice through videoconferencing during Russia's chairmanship in 2020, and once in 2021 under India's chair-

This interaction has been buttressed by consultations on India-Russia engagement on bilateral, regional, and multilateral issues. Experts

dinate views on issues on the UN Security Council (UNSC) agenda, while discussions on the 21st Summit were held at foreign secretary level in Moscow in February 2021. The convergence of Indian and Russian positions in the UNSC on Myanmar, Syria, Yemen, Palestine, the UNSC Taliban sanctions regime, and UN peacekeeping operations during 2021 reflect the outcome of this cooperation.

MARITIME SECURITY AND CONNECTIVITY

The strategic rapport between the top leaders of India and Russia was on international display on August 9, 2021, when Prime Minister Modi chaired a special meeting of the UNSC on maritime security. President Putin was the only Head of State of a UNSC permanent member who spoke at this meeting, which endorsed a holistic approach to maritime security.

Russia's proposal in August 2019 to establish "a security and cooperation organisation in the Gulf" has assumed a deeper significance for the India-Russia strategic partnership in 2021. Apart from its impact on stability in the Gulf region including Iran, such a regional structure can generate confidence in two major connectivity projects that India and Russia have pursued in recent years — the International North South Transport Corridor (INSTC) linking Russia through Iran with India proposed in 2000, and the Chabahar project linking India, Iran, Afghanistan, Central Asia, and Russia proposed

Greater regional cooperation in the western Indian Ocean will provide stability for the free flow of navigation along two major sea lanes of communication through the Red Sea and Yemen, and through the Straits of Hormuz. These routes transport a significant volume of India's international trade, energy imports and international digital traffic.

A similar holistic approach to maritime security will sustain the Eastern Maritime Corridor proposed by the India-Russia Summit in 2019 to link Russia and India through the Pacific and Indian Oceans as part of India's Act Far East policy. The first steps to modernise the port infrastructure of Chennai and Vladivostok have been initiated during the past six months. Eventually, the Eastern Maritime Corridor will connect India to ports in the Arctic.


India has emphasized the "centrality" of the ASEAN in any sustainable maritime security arrangement in the Indo-Pacific. The first-ever Russia-ASEAN naval exercises off Sumatra in early December 2021 demonstrates a similar emphasis on ASEAN-centrality, leading to India-Russia convergence in the maritime domain.

AFGHANISTAN AND COUNTERING TERRORISM

President Putin and Prime Minister Modi held a telephonic conversation on August 28, 2021 on the unexpected takeover of Afghanistan by the Taliban disregarding calls for an "inclusive" government. The leaders agreed to cooperate in countering the common threats emanating from Afghanistan, such as terrorism, drug trafficking and the impact on Central Asian security. This objective has been integrated into the India-Russia strategic partnership by the first meeting of the India-Russia High Level Mechanism on Afghanistan on September 8, 2021, India's official participation in the Moscow format talks on Afghanistan in Moscow on October 20, 2021, and Russia's participation at the National Security Advisers Conference on Afghanistan hosted by India on November 10-11, 2021, in which Iran and the five Central Asian states participated, but Pakistan and China did not.

World Health Organization has declared Omicron (B.1.1.529) a variant of concern. Preliminary evidence suggests there may be an increased risk of reinfection among elderly and the immunocompromised. SUPRIYA RAMESH speaks with experts to bring you a report



fter Delta, any other variant which has stirred fear among people is the new Omicron mutant. Originating in South Africa, it has now spread to 24 countries including India. On December 2, 2021, the country observed and confirmed its first two cases in Karnataka. One of them was a South African national.

Based on the evidence presented to the World Health Organization's Technical Advisory Group on Virus Evolution (TAG-VE) that Omicron has several mutations that may have an impact on how it behaves, on November 26, 2021, WHO designated the variant Omicron (B.1.1.529) a variant of concern (VOC) on the advice of TAG-VE. According to WHO, this variant has a large number of mutations, some of which are concerning. Preliminary evidence suggests an increased risk of reinfection with this variant, as compared to other VOCs.

Scientists are still gathering data to establish how contagious Omicron is, and the severity of the illness it causes. "Omicron variant has a large number of mutations, some of which are concerning. Researchers around the world are conducting studies to better understand transmissibility, severity and immune escape capabilities of Omicron. WHO commends countries which have been able to quickly detect and report cases of the new Variant of Concern," says Dr Poonam Khetrapal Singh, Regional Director, WHO South-East Asia Region.

Talking about the severity of infection, Dr Anurag Aggarwal, Consultant Internal Medicine, says, "This variant has a large number of mutations, some of which are concerning. Preliminary evidence suggests an increased risk of reinfection with this variant, as compared to other variants of concern."

Aggarwal, citing Professor Tulio de Oliveira, the director of the Centre for Epidemic Response and Innovation in South Africa, tells us that there was an 'unusual constellation of mutations' and that it was 'very different' to other variants that have circulated. "It is incredibly heavily mutated. There were 50 mutations overall and more than 30 on the spike protein, which is the target of most vaccines and the key the virus uses to unlock the doorway into our body's cells. Further, the receptor binding domain (that's the part of the virus that makes first contact with our body's cells) has 10 mutations compared to just two for the Delta variant that swept the world," explains Aggarwal.

After travel rules easing down post-second wave, it is obvious that people would travel everywhere after being caged for more than a year. With that, it is understandable that people will carry the virus from one place to another, even after the major chunk of the population is vaccinated.

"The confirmation of the Omicron, a variant of concern today by India, the first two cases in WHO South-East Asia Region, was not unexpected in view of the interconnected world that we live in. This emphasises the need for all countries to step up surveillance, to be on alert and rapidly detect any importation and take measures to curtail further spread of the virus," says Singh.

She adds that the response measures for all variants, including Omicron, is the same as that for SARs CoV2. Comprehensive and tailored public health and social measures by Governments, and strict adherence to preventive and precautionary measures by individuals, is a must. People must wear a well-fitting mask which covers their nose and mouth well, keep distance, avoid poorly ventilated or crowded spaces, keep hands clean, cover cough and sneeze and get vaccinated. And continue to take all precautionary measures even after getting vaccinated. All travelers must adhere to public health and social measures at all times and remain vigilant for signs and symptoms of COVID-19.

Talking about the number of mutations, Dr Arunesh Kumar, HOD & Senior Consultant- Pulmonology tells us that this new variant is a matter of concern in India too. It has more than 30 mutations. With time, we will get to know more about this new variant. "This virus can invade our immunity. Therefore, we need to follow

COVID appropriate behavior" he says.

The existing vaccines might or might not be effective against the Omicron variant and extensive research is being done to find out the same. "It is still to be known how effec-

Talking about the new wave smashing Europe, Kumar says the main reason behind the new COVID wave in Europe is people not wearing masks. From the last couple of months, many Governments have put leniency when it comes to wearing masks. This actually has led to a new wave. "If we don't let our guards down, we can control COVID," he adds.

Dr Shuchin Bajaj, Founder Director, Ujala Cygnus Group of Hospitals says, "This is the 5th variant of concern and overall the 15th variant of COVID-19. We already have flights being banned and travel restrictions in place. Therefore, we need to follow COVID-appropriate behavior like wearing masks, following social distancing, and regular use of sanitizer.

With the festive season upon us, we need to make sure that we take proper measures and keep safe as much as possible. "Although the so-called third wave has not eventuate as yet, the sudden appearance and the spread of omicron – a new variant of COVID-19 – across several countries has brought back memories of the second wave and its visibly devastating all-round consequences on people in the country. This means that we must shake off the complacency which was creeping in and instead get back to observing the same COVID-appropriate protocols and behaviour as we did before with utmost seri-ousness and discipline. So, while we resume wearing double masks, using sanitizers and maintaining social distancing, because of the fact that the virus can be airborne and transmitted through the air, we must also continue to employ indoor air purification systems in order to pre-empt any threat from the new strain, or any strain of the virus for that matter. Since people are now more likely to stay indoors for a greater duration due to the newly-perceived threat from the new variant, the role of indoor air purifiers with their ability to inactivate microbial pathogens including viruses and bacteria will continue to be critical to people's health," says Himanshu Agarwal, CEO, Magneto

HIGH RISK AMID OMICRON SCARE

PEOPLE MISSING, HUNT IS ON

n Uttar Pr<mark>adesh's Meerut,</mark> 13 of nearly 300 people on Lflights originating outside the country disappeared after providing false addresses and contact information. Seven flew in from South Africa, where the Omicron variant was first reported, news agency ANI reported. Officials are trying to track and test them for COVID-19, ANI said.

Chandigarh officials have registered a case against a woman who returned from South Africa and broke quarantine rules on landing in India. The woman landed Wednesday and tested negative on arrival. She was asked to home quarantine for a week, but she broke isolation the following day to check into a hotel before returning home. As many as 10 passengers - reportedly South

Africans - have gone missing from Bengaluru airport. Karnataka Revenue Minister R Ashok said airport security, police and the health department are working to track them down and carry out Covid tests.

This comes after a 66year-old South African -Índia's first confirmed Omicron Covid case - "fled" the country a week after landing in Bengaluru. The man, who had received both vaccine doses, tested positive on arrival and (because he was asymptomatic) asked to self-isolate. His samples were sent for testing.

12 suspected Omicron cases have been admitted to a Delhi hospital after arriving on international flights over the past few days. Eight have tested positive for Covid. Results for the other

four have not yet been released. Samples have been forwarded for genome sequencing to confirm the strain on Friday, two international passengers, including a child, coming from an 'at risk nation tested Covid positive on arrival at Chennai airport. Samples have been sent for sequencing. The Tamil Nadu govnment has denied reports they are Friday, nine members of a Jaipur family tested positive days after four returned from South Africa. The latter four have been isolated at a government hospital in Jaipur and samples from all nine have been sent for DNA sequencing, news agency PTI sa

Double vaccinate against Covid first, experts say amid calls for booster shots

ndia should prioritise double vaccinating its Leligible population against Covid over booster shots given the large number of people still to get the base layer of protection against the infection, say scientists.

Concerns over the Omicron variant and waning vaccine-induced protection against the infection have highlighted the need for boosters to protect the most vulnerable. And while many countries have already started giving booster shots, several experts here said the priority in India has to be different given that large-scale immunisation programme began only six-eight months

In advocating putting boosters on the back-burner for the moment, the experts' opinion runs counter to the Indian SARS-CoV-2 Genomics Sequencing

Consortium (INSACOG) that has recommended a booster dose for those above 40 years in high-risk and

high-exposure populations. The INSACOG is a network of national testing labs set up by the government to monitor genomic variations of COVID-19.

"We have a large proportion of our population in the below 18 age-group. Until that is achieved, a uniform policy for second booster, or a third dose, is not advisable," immunologist Vineeta Bal told PTI, pointing out that large-scale vaccination in India began only in March

What we should focus on, she said, is fully vaccinating all the eligible population in India and pushing for vaccination of the under 18 age group on a large scale.

Consistent finding with breakthrough infections is

that these episodes are less in unvaccinated. That still confirms that immunity does exist in vaccinated individuals in India," Bal, guest faculty at Pune's Indian Institute of Science Education and Research, told PTI.

Satyajit Rath, from New Delhi's National Institute of Immunology (NII), added that it is not clear yet if boosters are needed for any vaccine worldwide yet. "The duration of immune responses and protection are beginning to show differences, too, in recent studies. So I would be loath to jump the gun and say anything very definitive about boosters based on these data," he told PTI.

Bal agreed that there is no solid data on waning immunity in India. In principle, of course, immunity will wane with time.

"Antibody levels in serum



will be lower six months down the road than soon after vaccination but that is not the only and adequate evidence of significant lowering of protective immunity which is based on immunological memory," she added.

The AK-203 assault rifles will replace the INSAS rifles that have been in service for over three decades. The modern version of the Russian-origin rifle has an effective range of 300 metres or more than three football fields, is lightweight and robust.

The modern technology used in the new rifles will enable them to use hi-tech add-ons like special sights and grips, useful for special forces missions. The assault rifles will enhance operational effectiveness of the Indian Army in counter insurgency and counter-terrorism opera-tions, the government said in the

acquired at least one of its mutations by picking up a snippet of genetic material from another virus possibly one that causes the common cold - present in the same infected cells, according to researchers.

This genetic sequence does not appear in any earlier versions of the coronavirus, called SARS-CoV-2, but is ubiquitous in many other viruses including those that cause the common cold, and also in the human genome, researchers said. By inserting this particular snippet into itself, Omicron might be making itself look "more human," which would help it evade attack by the human immune system, said Venky Soundararajan of Cambridge, Massachusetts-based data analytics firm nference, who led the study posted on Thursday on the website OSF Preprints.

This could mean the virus transmits more easily, while only causing mild or asymptomatic disease. Scientists do not yet know whether Omicron is more infectious than other variants, whether it causes more severe disease or whether it will over-

the Omicron variant of the virus that causes COVID-19 likely take Delta as the most prevalent variant. It may take several weeks to get answers to these questions.

Cells in the lungs and in the gastrointestinal system can harbor SARS-CoV-2 and common-cold coronaviruses simultaneously, according to earlier studies. Such co-infection sets the scene for viral recombination, a process in which two different viruses in the same host cell interact while making copies of themselves, generating new copies that have some genetic material from both

This new mutation could have first occurred in a person infected with both pathogens when a version of SARS-CoV-2 picked up the genetic sequence from the other virus, Soundararajan and colleagues said in the study, which has not yet been

peer-reviewed. The same genetic sequence appears many times in one of the coronaviruses that causes colds in people known as HCoV-229E - and in the human immunodeficiency virus (HIV) that causes AIDS,

Soundararajan said. South Africa, where Omicron was first identified, has the world's highest rate of HIV, which weakens the immune system and increases a person's vulnerability to infections with common-cold viruses and other pathogens. In that part of the world, there are many people in whom the recombination that added this ubiquitous set of genes to Omicron might have occurred,

Soundararajan said. "We probably missed many generations of recombinations" that occurred over time and that led to the emergence of Omicron, Soundararajan added.

More research is needed to confirm the origins of Omicron's mutations and their effects on function and transmissibility. There are competing hypotheses that the latest variant might have spent some time evolving in an animal host.
