

STATUE OF UNITY GETS MORE TOURISTS THAN STATUE OF LIBERTY: PM MODI



"A total of 447 AEFI have been reported on January 16 and 17, out of which only

three required hospitalisation. Most of the AEFI reported so far are minor like fever, headache, nausea," he said.

He said a meeting was held with all states and union territories on Sunday to review the progress of the drive, identify bottlenecks and plan corrective actions.

The Supreme Court is scheduled to hear on Monday the pleas relating to controversial farm laws and the ongoing farmers' protest at Delhi borders. The apex court may take into account the matter of recusal of a member of the committee set up by it to resolve the impasse. The SC would also hear the plea of the Centre, filed though the Delhi Police, seeking an injunction against the proposed tractor march or any other kind of protest by farmers which seeks to disrupt Republic Day celebrations on January 26.

In an "extraordinary" interim order on Jan 12, a be-nch headed by Chief Justice S.A. Bobde had stayed the implementation of the new farm laws till further orders and had constituted a four-member panel to listen to the grievances and make recommendations to resolve the impasse.

Jagan to launch door delivery vehicles on January 21

Chief Minister YS Jaganmohan Reddy will inaugurate 2,503 door delivery vehicles at Benz circle on January 21. The vehicles would delivery essential commodities to the beneficiaries under public distribution system (PDS) across the state.

The government's latest move will revolutionise the public distribution system as essential commodities will be delivered at the doorsteps of the white ration card holders from February 1. Of the 2,503 vehicles, 817

are allocated to Krishna and 902 to Guntur districts, while the remaining 784 will be delivering services in West Godavari district. The state government will be launching as many as 9,260 special delivery vehicles across the state for delivering the essential commodities to the beneficiaries.

All the vehicles would reach their respective places by




January end and from February 1, the vehicles will be delivering quality rice and ernment on subsidy. other essential commodities.

The beneficiary of the vehicles would bear 10 per cent of the vehicle cost and 60 per cent will be offered as loan by banks with six-year term, while remaining 30 per cent will be subsidy. The authorities are making all arrangements for the programme with all precautionary measures, said the Civil Supplies Commissioner,



What a colourful change!

A British politician once compared civil servants with 'white rats' that run away to safer places much before an earthquake or Tsunami. This trait certainly holds water in the case of IAS officers in India. As soon as the Dubbak bypoll result came out, some officers in Telangana State started airing their views about the 'present state of administration in TS'. After GHMC results were out, their voices gained more decibels. Some officers, short of wearing saffron attire, are confirming with their media friends to clarify their own wishful thinking that such 'anti-establishment' feelings could be pervasive in Telangana. Without wording it as anti-incumbent wave or some such newsy term, they are predicting 'far more negative results' for the ruling TRS party without mincing words. Believe it or not, even those who were earlier branded as dyed-inthe-wool hardcore pink party supporters, who had backed the Telangana movement that resulted in the formation of the separate state, are now expressing views that are quite colourfully different and quite contradictory. A couple of officers scaled up their self-promotional ladder by reconnecting with their old pals in BJP and offering support to them in the hope of 'big' and 'fetching' postings in future. Apart from this bottom-up approach of many ambitious babus, those believing in top-down approach are trying for an opportunity to talk to BJP brass in the state to express their solidarity with them. They are obtaining numbers from the right saffron 'brigadiers' to contact the self-proclaimed desh bhakts. All along this chameleon-like change, amid the snakes and ladders game in babudom, was unheard-of in a state where the regional party has had a vice-like grip over the administration over the past six years.

Meticulous Chief Minister!

When the new AP Chief Secretary Adithyanath Das issued an order on communal harmony and appointment of harmony committee in G.O. No.6, everyone in the administration was surprised to see it laced with political comments. Opposition parties raised a hue and cry over the comments in question since the order, after all, was intended to ensure peace. The non-official comments, made in what looks like an unofficial manner, would have hurt Adithya much more because of his track record. For, when Chandrababu was the chief minister and wanted to release 'White Papers' on each department with the underlying aim of maligning the previous governments, Adithya refused to do it. delighted 9.36 lakh state government employees on December 29, 2020 by announcing salary and pension hike as "New Year 2021 gift". The gift means substantial increase in salaries for employees and hike in pensions for retired employées (pensioners) as per new the Pay Revision Commission's recommendations. He also declared the government's intention to increase the retirement age for government staff from the existing 58 years to 60 or 61 years etc. However, perhaps believing in the dictum 'Intezar ka phal meeta hotha hain', he charged a committee with the specifics and modalities of handing over the gifts. This implied that the beneficiaries cannot open their gift wraps till there is a nod from the committee, which has to await a

The three-member committee, led by CS Somesh Kumar and comprising principal secretary (finance) K Ramakrishna Rao and principal secretary, water resources development Rajat Kumar as members, has still not found time to open the 'sealed cover' in which the PRC chairman, led by CR Biswal, submitted the PRC report to the CS on December 31. Such covers are not sealed with a kiss; yet, they have a lot of emotional content. The CM did give timelines for the panel to come out with its suggestions by the end of January 2021, after talking to representative of unions on matters such percentage of salary/pension hike, extent of enhancement in retirement age, revision of service rules, revised policy for promotions, and the strategy to be adopted to obviate legal problems while implementing zonal system etc. in the context of increased number of districts.

As of today, employees unions waiting to unwrap their gifts do not know whether the PRC 'sealed cover' was opened. The CS is deemed to be currently busy with the vaccine rollout. His peshi merely says "CS has no time till January 21". Will not staff know how sarkari timelines work? They don't expect to open their gift wrap in January. The committee comprised Bhupinder Singh Mann, national president of Bhartiya Kisan Union; Dr Parmod Kumar Joshi, Director for South Asia, International Food Policy Research Institute: Ashok Gulati, agricultural economist and former chairman of the Commission for Agricultural Costs and Prices; and Anil Ghanwat, president of Shetkari Sanghatana.

The court had said it would hear the pleas against the farm laws after eight weeks when the committee would give its suggestions to resolve the impasse after talking to the protesters and the govern-

The court's efforts seem to have hit a hurdle as Mann recused himself from the committee on January 14.

A bench, also comprising justices L. Nageswara Rao and Vineet Saran, may take into account the issue of recusal of Mann from the committee and take remedial actions like appointing a person to replace him in the panel.

According to reports, he was convicted for crimes, including sexual assault, sexual abuse of minors, fraud and attempted political and military espionage. During the trial, Oktar

told the presiding judge that he had close to 1,000 girl friends. Along with him, two of his executives, Tarkan Yavas and Oktar Babuna, too have been sentenced to 211 and 186 years of imprisonment respectively. Reeking of alcohol not 'drunk driving'

In a recent judgment, the Kerala High Court has held that in order to attract the offence of drunken driving under Section 185(a) of the Motor Vehicles Act, the accused should have been subject to a breathalyzer or any other test, including a laboratory test, and his blood must be found to contain alcohol exceeding 30 mg per 100

The bench of Justice V.G Arun in its order dated 8th January in a case of drunken driving, Manoj Kumar K Vs. State of Kerala, observed that the prosecution was based on the doctor's opinion who stated that the 'accused smelled like he had drunk' and observed that to prove the offence under Section 185 (a) of the MV Act. the aforementioned tests were mandatory.

Despite price cap on RT-PCR test, labs exploit patients

PNS ■ HYDERABAD

Despite the Telangana state government issuing a GO reducing the reverse transcription polymerase chain reaction (RT-PCR) test charges, several labs in the city have been charging at least Rs 2,000 per test from passengers scheduled to travel abroad. The passengers are aghast at the extortion of money in the name of the tests at the airport.

The state government has revised the charges to be collected by corporate hospitals and private diagnostic labs. The government initially has slashed the rates for RT-PCR testing for Covid-19 in private labs from Rs 2,200 to Rs 850. For samples collected at home,

the charges have been reduced from Rs 2,800 to Rs 1,200. Later, it asked to collect only Rs 500 if the test in the lab and Rs 750 if the sample was collected at the residence of the patient, as against the previous Rs 850 for giving the sample at the lab and Rs 1,200 for collecting it at home.

Several private diagnostic laboratories in Musheerabad and other areas have been collecting old charges to conduct the RT-PCR tests at labs and for collecting the samples at home. In spite of the violation,



political arena on March 28 1982. He launched a political party and took on the till then, undefeated, Congress. He campaigned hard in his Chaitanya Ratham on dusty roads covering 35,000 miles, and rode to power in 1983 with a thumping majority.

As Chief Minister, politics was a distraction for NTR. He

had an abiding faith in dharma and that was the touchstone of his public policy. He was in a hurry to build a society free from social and economic injustice.

He tilted the social and political power in favour of the people belonging to the underprivileged and backward classes, giving voice to the voiceless. He awakened the weak and the poor who felt equal and confident like never before.

NTR unveiled scores of welfare schemes of which subsidised rice scheme, clothing for the poor and shelter for the marginalised sections stood out. He legislated equal right for women in property in 1984, a historic step to empower women. The Central Government followed his example after two

decades. NTR abolished village hereditary posts and created mandals to bring administration closer to the people. Realising that education is the driver of social change and economic progress, NTR laid emphasis on quality education.

Primary education in Telugu was his major concern and as one who knew the potential of cinema, his fertile mind ushered in video lessons for children, a pio-

neering effort. He established residential schools (gurukuls), a boon for the children of disadvantaged sections. He carried out diligent nation-wide search for persons of integrity and proven eminence to head he universities.

This is only a small list of his many path-breaking initiatives.

Ruthlessly honest, NTR expected his legislators to be clean. This created problems and he was overthrown. But he scripted perhaps the finest chapter in democracy by returning to power in 1984 in what has come to be known as the struggle for restoration of democracy.

NTR was not always right. He was obstinate sometimes. He was often too sure of himself. But his intentions were never suspect. His public life was an open book, the under song of which was Telugu pride and self-respect. His was a well lived life worthy of emulation.

'Every man is guilty of all the good that he didn't do,' said Voltaire. NTR was not guilty of this. He accomplished a lot both in films and politics. No wonder then that NTR is fondly remembered even 25 years after his death. Apt to say a hero like NTR

Courts must be open to public scrutiny, criticism: Salve

Senior Supreme Court lawyer Harish Salve has said courts must be open to public scrutiny and criticism as "institutions of governance". Addressing a lecture organ-

ised in Ahmedabad through video-conference on Saturday, Salve said criticism of judges, judicial overreach and the manner of functioning is not scandalising courts, and the language in which such criticism is addressed should be treated with a grin.
"We today have accepted

that judges, or rather courts, and especially constitutional courts, have become institutions of governance. As an institution of governance it must be open to public scrutiny and public criticism," he

"We have always accepted

that the decisions of courts can be criticised, including in language which may be impolite. So the decisions can be criticised. Can we criticise the decision-making process?

Why not?" Salve said. He was addressing the 16th Justice P D Desai Memorial Lecture on Criticism of iudiciary, contempt jurisdiction and its use in the age of social

"Governance has to be under the sharp blaze of sunlight...in fact, I think a time may come when the Supreme Court may seriously consider a very large number of provisions of the Official Secrets Act, how far do they square with democracy," he said.

Most of them have fallen into disuse, said Salve, who was last year appointed the Queens Counsel for the courts of England and Wales.

More than 3,600 birds rescued in 2020: Delhi Fire Service

Firefighters in the national capital rescued more than 3,600 birds between January-December last year, officials

said on Sunday. The maximum number of such cases were reported around Independence Day in August when people traditionally fly kites and the strings remain suspended on trees and poles creating a death trap

According to data shared by

the Delhi Fire Service (DFS), the firefighters in the national capital responded to 25,416 distress calls last year, of which 3,691 were for rescue of birds and 2,902 for animals.

The maximum distress calls were received in November (2,652), October (2,521) and August (2,466), the data showed.

These calls were related to fire, building collapse, bird and animal rescue among various other assistance sought by different agencies.



According to data, August saw a rise in bird and animal rescue calls due to kites flown around Independence Day. We received the highest

number of calls seeking assis-

tance for rescuing birds and animals in August last year. We rescued 882 birds and 345 animals in the month of August alone," Garg said.

"This is usually the trend seen during Independence day when most of the people indulge in flying kites and in many cases, we have observed that these birds get stuck or entangled on electric wire or a tree due to stray strings," he

'Farmers prepared to protest till May 2024'

Bharatiya Kisan Union (BKU) leader Rakesh Tikait on Sunday said farmers are prepared to protest against the Centre's new farm laws "till May 2024", and termed the ongoing agitation by peasants at Delhi borders as an "ideological revolution".

Addressing a press conference in Nagpur, Tikait said they want a legal guarantee on Minimum Support Price.

Farmers have been protesting near Delhi since November 26, 2020, demanding scrapping of the three new farm laws, which have been projected by the Centre as major reforms in the agriculture sector that will remove the middlemen and allow farmers to sell anywhere in the country.

However, the protesting farmers have expressed apprehension that the new laws would pave the way for eliminating the safety cushion of the MSP and do away with the



mandi system, leaving them at the mercy of big corporates.

The Supreme Court last Tuesday stayed the implementation of the three new farm laws till further orders and decided to set up a four-member committee to resolve the impasse over them between the Centre and farmers' unions protesting at Delhi borders.

Asked how long will farmers will sit in protest, Tikait said, "We are prepared to sit in protest till May 2024...our demand is that the three laws be taken back and the government provide a legal guarantee on the MSP."

The next Lok Sabha elections in the country will be due around April-May 2024. Dismissed allegations that

the protest was being fuelled by "rich farmers", Tikait said people from villages and various outfits have joined the protest."This is an ideological revolution of farmers started from Delhi and will not fail. Farmers from villages do not want us come back until the three farm bills are taken back " he said

SC to hear pleas after recusal of panel member

Newsprint cost up 20% in 3 months; publishers seek waiver in import duty

PNS NEW DELHI

Cost of paper used to publish newspapers and magazines has jumped 20 per cent in the past three months due to demand-supply imbalance following the pandemic, prompting news publishers to rush to the government seeking waiver of 5 per cent import duty to help cut cost.

An industry that was facing headwinds from a slowing economy even before the pandemic, was hit hard when most readers stopped buying newspapers and magazines on fears of them being carriers of

While there are no medical studies that have established the virus transmission theories, sales did not pick up even after



lockdown restrictions were relaxed, industry leaders said. Now, the rising cost of newsprint created due to a drastic fall in supplies after 3 million tonnes of manufacturing capacities were either closed or converted to brown paper grades worldwide has dealt a second blow that is threatening the survival of the industry.

Indian Newspaper Society (INS) President L Adimoolam said most newspapers have stopped sending the hard

copies to the rural areas with readership of less than 50 copies, to reduce the distribu-

In a representation to Finance Minister Nirmala Sitharaman, INS has suggested cutting customs on import of newsprints. They also want a fiscal stimulus package for the industry or raising tariffs of government advertisements by 50 per cent.

"If working out a stimulus package for print media is difficult at this juncture, DAVP may please consider releasing advertisement for all its departments to all publications with an increased tariff of 50 per cent, which would be highly helpful for the industry as a whole," the INS representation

It's here!

India kick-starts the world's biggest inoculation drive to beat Coronavirus but we must still follow the protocol



ime: A little after 11 am on Saturday. The nationwide anti-COVID vaccination drive began with a sanitation worker at Delhi's All India Institute of Medical Sciences (AIIMS), who became the first person in the country to receive a shot. "I was not reluctant (to get the vaccine shot)... people should not be afraid," Manish Kumar said. It was thus that nearly a year after reporting its first case of Coronavirus, India kicked off the world's largest immunisation drive against COVID-19 when Prime Minister Narendra Modi launched the offensive at the click of a button through video conferencing. As part of its plan to bring the pandemic under control with two locally-produced vaccines, Covishield and

Covaxin. the Government inoculated lakhs of healthcare and frontline workers, such as sanitation and security workers, to a collective sigh of relief that this could finally be the beginning of the end of the COVID-19 trauma. The next in line are Indians above the age of 50 or those considered as high-risk individuals due to pre-existing medical conditions. Around 100 persons received a vaccine at each of the 3,006 sites across India on the first day. As feared, there were some glitches but it's nothing considering the vast topography of the nation. Union Health Minister Harsh Vardhan visited the vaccination sites at Sir Gangaram Hospital and AllMS, Delhi, and described the COVID-19 vaccines as "sanjivani" in the fight against the accursed virus as he urged people not to heed hearsay and, instead, put their faith in experts and scientists. "It's a historic day. We have been blessed by the Prime Minister all through our fight against COVID-19. It's the largest Coronavirus vaccination programme in the world," Vardhan said. "We have been able to put up a valiant fight against the disease during the past year. Adopting a pre-emptive and proactive strategy has resulted in a good performance. We have probably the lowest fatality rate in the world," he said. In a message to the nation's population, he said that nobody should indulge in spreading or believing rumours pertaining to the efficacy of either vaccine.

In the national Capital, the vaccination exercise was carried out at 81 sites across 11 districts. Six Central Government hospitals — AlIMS, Safdarjung, RML, Kalawati Saran Children Hospital and two ESI hospitals — had been chosen as sites for the drive. Besides these, Lok Nayak Jai Prakash Narayan Hospital, the Delhi Governmentrun GTB Hospital, Rajiv Gandhi Super Speciality Hospital, DDU Hospital, BSA Hospital, Delhi State Cancer Institute and the ILBS Hospital are among the vaccination sites. Then there are private facilities — Max Hospital, Fortis Hospital, Apollo Hospital and Sir Ganga Ram Hospital — which have also been chosen as sites for the exercise. However, many people at the RML Hospital were apprehensive, with some of them reluctant to go for the shot, and then there were others with mixed feelings. Dr Sharmila (name changed) of the hospital, who has been working in the COVID department, said: "I am scared as the vaccine's efficacy is not yet proved but this is my best bet. It is my leap of faith...l will take the plunge. Dr (Randeep) Guleria (AlIMS director) has also taken the shot; I believe in him." The day was also not bereft of politics — with Congress spokesperson Manish Tewari training the guns at the Government and referring to the Norway incident where 23 deaths occurred after taking the anti-COVID jab manufactured by Pfizer — but we, as a people, strongly believe that such bumps would not be able to derail the massive campaign that aims at achieving health for all its citizens.

Recasting Delhi

Narendra Modi wants to leave his imprint on central Delhi; the new Central Vista will be quite a mark



n the auspicious day of Makar Sankranti, the day millions of Indians worship the Ganga, construction began on India's new Parliament building, the first of several projects that will define New Delhi in the latter half of the 21st century. Many individuals and organisations have questioned as to why such an expensive infrastructure undertaking is being started now, as India's economy limps back into action following the pandemic. The fact is that large infrastructure projects have always been used by nations, whether it was Germany or Japan following the World War 2 or the United States during the Great Depression, to turbo-charge economic recovery as these projects provide large volumes of

employment and leave behind a considerable legacy. Delhiites themselves have never denied heritage its place — Rajput, Islamic, European or Colonial — and made it a part of their living history, one where Lutyens' Delhi is a key chapter. The cluster of offices would undoubtedly change the skyline as we know it and their ramped-up security would rob us of an indulgent spread in the heart of the city. But was this particular infrastructure project needed?

There is a simple answer to this, asking anyone who has either worked or has visited any major Government office in New Delhi. While the buildings of Lutyens' yore are amazing pieces of architecture, structures like the North and South Block are awfully dilapidated and the post-Independence buildings such as Shastri Bhawan and Udyog Bhawan are downright awful. They are inefficient as modern working spaces and, worse still, environmentally unfriendly in terms of energy consumption. These buildings needed a thorough revamp at the very least and one could argue that they needed to be broken down and rebuilt. And it is the latter path that this Government is undertaking. However, as the Supreme Court has pointed out, this has to be done thoughtfully so as not to destroy the history and heritage dating back over a century when the colonialists rebuilt the Capital in the 1900s. But to argue that India does not need this, because it is Narendra Modi and his Government who are undertaking such a project, is nothing more than petty jealousy. The same people would have made completely different arguments had a Congress-led administration carried out the rebuild. India's Parliament too needs an urgent makeover. The Central Vista revamp is massive as it envisages a new triangular Parliament building with a seating capacity for 900 to 1,200 MPs and synergised administrative blocks, to be completed by August 2022. On its part, the Government had been arguing for a makeover of this part of Lutyens' Delhi for its functionality and efficiency, claiming that it would create spaces for a more streamlined operation of Ministry offices and free up more citizen-friendly spaces. It is the Modi regime's attempt to overwrite our Colonial past and redesign an institution as wholly Indian, as representative of its people and epoch-making simply because no Government had thought of this before. While the existing building, based on the 9-12th century CE circular Yogini temples, is a tremendous structure and a temple in its own right, if India is to have a larger Parliament that is representative of her population, a new building is essential. It was vital that this rebuild happens and while the public relations could have been better, this reconstruction of Delhi was needed. And it will leave Narendra Modi's mark on Delhi for years to come, whether some people like it or not.

Trends to look out for

China will remain saboteur number one of global recovery in 2021 even though the new decade brings optimism and new vaccines

cautious and forced optimism pervades the start of 2021. As Lenin aptly said: "There are decades when nothing happens, and then there are weeks when decades happen." The year 2020 was one such when the velocity in medical science and tech adaptation crammed a decade's evolution nto a single year.

That the vaccine would be the panacea for the economic woes of 2020 is not certitude, given the emergence of the mutating COVID-II strain. A second cycle of virulence could further burden healthcare systems, severely reversing the economic recovery. Confronted with multiple challenges, recovery even in the developed world is not anticipated before 2021 end despite their Governments' sustained stimuli on all three fronts: fiscal, monetary and credit. This is because the COVID-induced hysteresis will keep the growth rates suppressed much after the crisis recedes, as it did during the 2008 financial meltdown.

Set against the grim spectre of job and income losses and the inequality exacerbated by the crisis, there have been only two gainers during the lockdown of 2020: China as a country, and the American big tech oligarchs as a business class. Today, Apple, Amazon, Google, Facebook, Microsoft, Netflix and Twitter's combined market capitalisation is \$8 trillion, which is more than double the size of India's national GDP. This is attributed to big tech's stakes in the online world of contactless social media and e-commerce which helped them increase their net worth by a whopping 30 per cent, to touch \$4 trillion.

And China's export-led economy rebounded the fastest due to being able to fill the void in global supply-chain disruptions as the country remained on a manufacturing overdrive while the rest of

the world was in lockdown mode. Broadly, the predictive global contours of change in 2022 will be seen in the spiralling of sovereign debt to GDP ratios; a partial revival of globalisation and a return to multilateralism with the advent of Joe Biden; a high rise in manufacturing productivity levels, yet conversely, a shrinkage in job creation due to digitisation and AIled automation; and permanent changes in consumer behaviour.

Another dominant concern at the start of the year is with the surreal valuations of global stock

markets due to surplus liquidity infused by the Central bank's quantitative easing. This will likely fuel the next asset bubble and lead to a repeat of the 2008 phenomenon once stimulus measures are withdrawn toward the end of the year.

OER ARMOUR

There are other anticipated trends that are likely to play out in the economy with the consumer and with corporates in 2021. For one, there are fears that the very country that unleashed the virus could sabotage global recovery by covertly unleashing another virulent strain so that the offender nation retains its economic heft. And, sadly, the optimism is

further watered down due to the lack of a unified action plan amongst like-minded coalition partners or allies to rein in an expansionist China. A multilateral and punitive response is needed to hold China accountable for subverting a rules-based economic international order and calls for an international backlash for its abuses on maritime and terrigrotesque human rights abuses on Uighurs, or for the Chinese Communist Party's crackdown on democracy in Hong Kong and Tibet.

China's treatment of business magnate Jack Ma being browbeaten to "embrace supervision" (the Chinese synonym for detention) should have sent shock waves to the global investor community. But, to the contrary, the West is hesitant to decouple from China. While the Biden Administration will persist with Trumpian-era tariffs and technology restrictions on China, the attraction of the Chinese market for the US and the EU investors is too strong to cut the cords of economic activity on grounds of geopolitical aberrations alone. The EU, which is the largest trading bloc, has recently approved a comprehensive investment agreement while American fund houses continue to solicit Chinese savers retirement funds.

When the strongest democracies are in descent and disarray, it has the propensity to embolden rogue dictators. More so after the theatre of the absurd that played out at Capitol Hill with Trump's "Be there, be wild" melee that pushed lawmakers to invoke the 25th Amendment to remove a sitting President from office. A weakened US then portends ominous signals in being able to contain an aggressive China, free market economies.

And if the Capitol Hill was under siege, a similar kind of anarchy is being played out on the borders of the Capital of the largest democracy in the world, with the non-negotiable stance of the farmers' protest nearing two months. Anarchist trends in democracies are now a symptom of a deeper underlying

malaise, with a thin line demarcating excessive freedom of expression or the right to dissent from chaos, vandalism and lawlessness.

Dominant India-centric themes expected to play out

Coming to India, while the economists predict a strong rebound, it is important not to confuse rebound with growth in "absolute" terms. The World Bank estimates the growth in India to recover to 5.5 per cent in FY22, so the recovery from a lower base naturally quantifies as a higher rise. Herein, the speed of the vaccines' rollout and their efficacy will of course increase economic activity due to increased mobility, which will drive recovery in the nonfarm sectors with the exclusion of the contact-intensive services sectors.

According to a McKinsey report, "Indian businesses have the potential to create economic value of about \$635 billion by 2030 if they can tap into the shifting preferences of Indians aspiring to a higher standard of living". The areas are in businesses that provide higher-quality urban environments, cleaner air and water and more convenience-based services in the new ideasbased economy which can potentially create millions of productive jobs. Another dominant trend

is one of growing indignation against the "privately owned, unelected, unaccountable American tech companies, who can unilaterally exclude anyone on Earth out of the internet". The other countries must unite to regulate these monopolistic internet giants who evade taxes in host countries, have a predatory, buy-out strategy towards startups which pose a threat to them in order to curb competition and have now self-appropriated

the right to restrict freedom of

expression at will. Lastly, mainstreaming Environment, Social and Governance (ESG) will be one of the enduring hallmark business trends of post-pandemic prioritisation. The ESG verticals can vary from supporting sustainable natural materials, water conservation and CO2 reductions or espousing social causes such as human rights and poverty alleviation. We have to recognise that zoonotic diseases will continue to rise till the time we do not shift to sustainable production and consumption patterns.

Peering through the fog of conjure what the post-vaccine world will look like. But, for sure, what we will encounter on the other side of the tunnel will in no way resemble the pre-COVID world order.

The COVID-19 pandemic has changed the scenario, but for worse. Online classes for students have now become the norm but it is a setback to the privacy of



A new medium of expression

When the pandemic struck the world, it took several months to realise how dramatically the nature of communication would change

The most common topics on which training programmes are held are leadership, communication, management of self and so on. In a programme on communication one of the essential topics is to explore the relationship between the message and the medium. One of the commonest statements is: "The message is the medium and the medium is the message." Typically, if a notice board is a medium and the message conveys affection or is proposing a marriage, no one uses a notice board for such a communication. The softer messages are usually more appropriate to convey with a flourish or a card, note, in person and in today's world on a personal chat. This would add a certain degree of gentility.

In the choice of the medium, too, there are at times flourishes that are used. Typically the use of calligraphy with a thick nib goes well with certain sentiments. There was a time in courts where after writing a death sentence, the judge would break the nib to underscore that he considered the task distasteful and did not want to write another such verdict. However, the COVID-19 pandemic has taken a toll on such approaches or sentiments. Messaging online has become a universal medium demanding some appreciation of technology and some familiarity with the computer keyboard and smartphone keypads. Those with a receding vision or limited understanding of the workings of the keyboard and smartphone increasingly face less tolerance.

Technology itself is a recent phenomenon in public spaces in India. In the early '70s even a photocopier was unknown in most public spaces of learning institutions. A microfilm reader was the acme of technology in an archival space which couldn't cope with heavy binding or with pages that were getting too brittle for regular use. Five decades down the line, even the storage disc has undergone multiple changes in size, density and machine.

Similarly, recording instruments have evolved, too. Those who could not detect how totally extinct an extant technology of storage could become, lost much data. That is a story which has often unravelled silently, with very little to evoke even a small interest in the theme of a technology which gets outdated with time. Indeed there were disc manufacturing enterprises enjoying a flourishing business, that were almost wiped out before they realised what hit them. New chapters on return on investment had to be written and the short, half-life of technology was difficult to keep pace with for most businesses. As a result, the impact was huge on Information Technology-related businesses and many suffered losses.

When the COVID pandemic struck the world it took several months to realise how dramatically the nature of communication would change. There was something rolling out which had no space in conventional learning, skilling or training. There was a mass exodus to online processes. Those who got left out belonged to a bygone era or were on the fringes of society.

Online learning, skilling, training were not all that new but never was it such a "no-choice" situation. I was a member of a policy group of educational governance dealing with management education, about 30 years ago. The role demanded me to become the chairman of a sub-committee on technology in management education. One of the recommendations was that online technology in management education would be a matter of bandwidth availability. Nearly 30 years later, many of the semi-baked management professionals were discovering that "online teaching is quickly becoming bandwidth intensive." It was also being discovered that reliable connectivity to the internet and multiplicity of web servers would be needed for prompt "net response and reliable service." The message was simple: The lack of a clear sense of direction when it could have happened led to a crash crescendo. Responding to this crash crescendo became fanciful and avant-garde. The truth was, it was a response to a miserable learning situation which no one was expecting or was prepared for.

Hence, what was often projected as a modernisation of the learning process had strong possibilities of becoming a learning disaster. Skilling was equally affected. What can be shared in skilling on the online medium would not be adequate for "operational skilling". simply because of the need to focus on competencies.

Similarly, the process of training landed in the deep end. Any person in the profession of training would know that there is very little substitute to personalised interaction, particularly in a short learning event like training. More problematic fallouts of such a situation can be flagged. For the present, suffice it to say that even the need to limit the losses in such sudden shifts - voluntary or otherwise — is slow to be registered or be acted upon. Hopefully some in the profession will awaken to this need, sooner than others.

Mobile money is new cash

The Coronavirus pandemic has shown that the trend towards greater digitalisation of financial services in the country is here to stay



obile finance finds itself at an inflection point as the world continues to tackle the socio-economic fallout of the COVID-19 crisis. In these critical times, mobile money has helped governments in navigating the financial dystopia and addressing the practical challenge of delivering affordable and efficient financial services. Mobile currency is as an effective and physical distance friendly option to tive and physical distance triendly option to avoid cash, which can act as a carrier of the Coronavirus. Contactless digital payments at the point of sale with the help of facial recognition, Quick Response (QR) codes or near-field communications (NFC), drastically reduce the possibility of the spread of the contagion.

Digitisation has turned a smartphone into a wallet, a chequebook, a bank branch and an accounting ledger. The ubiquity of the mobile phone has made it possible to deliver financial services to people for whom a bank account is a distant dream. Frictionless, real-time payment through smartphones is already ensuring that the financially excluded section is thinning fast. Mobile transactions can create the next wave of Mobile transactions can create the next wave of financial inclusion if we prudently address the concerns of consumers.

For instance, people in far-flung areas of the country and remote villages are now able to make payments, deposit money, transfer funds, receive social benefits and wages and buy rations — affordably and reliably without the hassle associated with the opening of a bank account. In emerging and developing economies, millions have cellular phones but no bank accounts, credit cards or debit cards. For them, mobile money has begun filling the gaps in financial services. It serves as a lifeline, bringing those who currently lack access to banking into the financial mainstream.

Further, the penetration of cellular phones puts developing countries in an advantageous position where making a quantum leap in financial inclusion is concerned. For communities with low literacy levels and sporadic incomes, digital money can transform the socio-economic landscape. Mobile banking is enabling women to overcome common barriers. It reduces the to travel long distances to ac facilities and also ensures a level of privacy and

In reality, despite the best of intentions banks cannot afford to set up branches in every nook and corner of the country as there are logistical, economic and security constraints. The high cost of building infrastructure for bank branches has been a major obstacle in extending financial services to the poor and the underserved in remote locations. Ĉellular phone banking eliminates the problem of geographical inaccessibil-

ity and high set-up cost of bank branches. Banks, mobile operators and third-party providers are all leveraging technologies on mobile phones to offer basic financial services at a lower cost than traditional banking allows. Several new types of delivery channels are emerging such as managers, agent networks, payment aggregators and others who are helping in building a more far-reaching and efficient digital finance ecosystem.

Digital mobile finance offers at least three major advantages over traditional financial

models. First, digital transactions are essentially free. In-person services and cash transactions account for a majority of routine banking expenses but mobile finance clients keep their money in digital form. They can send and receive money without incurring transaction costs from their banks or mobile service providers.

Second, mobile communication generates copious amounts of data which banks and other providers can use for developing more profitable services. It even acts as a substitute for the traditional credit scores.

Third, mobile platforms link banks to their clients in real time. This means that banks can instantly relay account information or send reminders vices on their own.

Further, digital footprints and transaction data can be of great help to assess individual creditworthiness. Mobile network operators are teaming up with banks, financial-tech companies and data analytics specialists to use the customer information to gauge their credit risk and offer microfinance products to some who would otherwise lack any proof of their capacity to repay

If the customer is a regular user of a digital money transfer service, the operator may also be able to assess how much disposable income they have. In fact, mobile operators' data can

be good enough to lower the lender's risk significantly, enabling interest rates to fall and making microfinance a more attractive proposition for small businesses and individuals.

But such success stories do not

happen in a vacuum. To begin with, everyone needs a cellular phone with an affordable data plan. It is entrusted upon governments and non-governmental organisations to extend mobile networks to remote areas. Governments must also ensure that networks between banks and telecommunications companies are interoperable otherwise, widespread use of mobile phones for financial services and payments would be impossible.

Mobile money transactions will also have to address the limitations which prevent countrywide adoption of the channel. Exchanging mobile money for cash can still be expensive.
And digital and financial illiteracy are known to hinder adoption of digital remote areas may lack network coverage, easy access to money agents, or simply electricity. A robust identification system, widespread, consistent internet access and trustworthy ways to get money into digital formats could be important for digital payments to thrive.

Women's access to mobile finance is affected by the fact that fewer females possess a mobile phone as compared to men. The promises of mobile finance are certainly very seductive. However, the reality is much harder than we can imagine. It is easier to spread technology than to bring about extensive change in social and individual attitude.

Although mobile telephony might entail initial fixed costs, the variable costs associated with their use are significantly lower, enabling an overall reduction in transactions costs. Mobile

banking can be a strong income stream for telecom operators, helping them to counter slowing subscription growth and growing competition in traditional niches. The key is information technology spending in annual fixed costs for a mobile banking system. Again, that spending is significant for small providers, but is minimal for large players. This means financial firms looking to expand into emerging markets via mobile banking would require good financial stamina.

Since success is in everyone's best interest, mobile and financial industries and regulators should work collaboratively with each other to unlock the transformative social impact of cell phone money. It is only then that we will be able to deliver life-changing mobile financial services to millions of people across the world, who still have no access to traditional banking.

The pandemic has shown that the trend towards greater digitalisation of financial services in India is here to stay. The ongoing crisis is certainly going to test the way various players in the digital and financial ecosystems respond. Governments must close the digital divide to reap the benefits of digital financial services. This means finding the right balance between enabling financial innovation and addressing several risks: Lack of financial and digital literacy, insufficient consumer protection and unequal access to digital infrastructure and data

To boycott, or not to boycott polls, that is the question

Radicals feel that shunning elections is vital to delegitimise a regime and claim the polls to be bogus. But evidence indicates that the cons outweigh the benefits

n January 1, the multiparty Opposition alliance, the Democratic Movement (PDM) announced that it would participate in the forthcoming by-elections and did not rule out taking part in the Senate polls, too.

After completing the first phase of its protest movement with a flurry of large rallies against the Imran Khan Government, the PDM is now entering the second phase of its initiative to oust the Prime Minister. The PDM has been claiming that Khan's Government was installed through a rigged election in 2018 by the military establishment. The alliance sees Khan as a willing marionette of the establishment that, it claims, is pulling his strings.

The PDM's decision to contest the by-polls and then possibly the Senate elections is being looked at with suspicion by some analysts. Some of them are not very fond of Khan's regime (and vice versa). Yet, they haven't held back in explaining the possible move by the PDM as an attempt to strike a deal with the establishment to oust Khan without having to resort to more extreme measures. They see a clash emerging within the PDM between the Zardari doctrine and the Nawaz doctrine.

It was the Pakistani Muslim League-Nawaz (PML-N) chief Nawaz Sharif who initially set into motion the PDM's startling antiestablishment agenda, which has clearly unnerved the regime and its non-civilian backers. Asif Zardari, the chief of the PDM's second-largest party, the Pakistan People's Party (PPP), has advised a more gradualist approach. It was on this advice that the PDM agreed to contest the by-elections. But certain observers believe that the PPP, which is heading the provincial Government in Sindh, is hoping to come to some sort of an understanding with the estab-

The PDM's more radical sympathisers were expecting a clear boycott of the by-polls and the Senate elections. It has been a long-established understanding within the PPP that election boycotts do not work. In her 1988 biography 'Daughter of the East', former chairperson of the PPP, the late Benazir Bhutto, wrote that one of the biggest mistakes of her political career was the boycott of the 1985 elections held during the Ziaul-Haq dictatorship.

At the time, her party was heading an alliance of anti-Zia parties, the Movement for the Restoration of Democracy (MRD). According to Benazir, MRD's boycott allowed easy access to pro-Zia elements to the corridors of power. Ironically, one of these elements was Nawaz Sharif.

In 2007, when an anti-Musharraf multiparty alliance, the Alliance for Restoration of Democracy (ARD), decided to boycott the 2008 general elections, Benazir disagreed with the decision. She insisted that the boycott would facilitate General Musharraf to continue ruling the country as a dictator, with the help of parties that were already support-

For Benazir, a boycott would have aided these parties to retain their hold on the Assemblies and continue to legitimise the Musharraf regime. Benazir was able to convince Sharif's PML-N to contest. Both the parties not only went on to win the majority of seats in the elections, but were also able to gather enough clout to force Musharraf to resign.

In a 2017 essay for the Journal of Theoretical Politics, G Buttorff and Douglas Dion wrote that the decision to take part in elections organised by an authoritarian set-up often poses a dilemma for parties opposed to such a set-up. The question is, will their participation in elections, which are likely to be engineered, legitimise the polls, or will a complete boycott of the elections fortify the possibility of the boycotting parties gaining political influence? Benazir believed that MRD's 1985 boycott relinquished its political influence to those who were handpicked by Zia to strengthen his position.

According to Dion and Buttorff, one of the main reasons that parties boycott elections is to expose "the bogusness" of a tampered electoral forward by those who want the PDM to boycott the by-elections and Senate polls. They believe no elections in Pakistan can be trusted to deliver a fair verdict if they continue to be "engineered" by the establishment and held by a "hybrid regime" like the one headed by Khan. But Dion and Buttorff add that the other reason parties sometimes boycott elections is that they fear "devastating electoral losses.

This reason can be understood on two levels. First, parties can tactically boycott elections if they believe that their vote-bank has weakened. Instead of confessing to this, they announce that they are not taking part in the polls because they fear it will not be fair. The Jamaat-i-Islami (JI) boycotted the 1997 elections because, as exhibited by the rout the party suffered in the 1993 polls, its vote-bank had shrunk considerably.

The party felt that another rout could plunge the outfit into a serious existential crisis. The JI also boycotted the 2008 elections. Imran Khan's Pakistan Tehreek-e-Insaf (PTI), too, boycotted the same elections because, at the time, it was a tiny

PTI claimed that it was boycotting the polls because they were being held by a dictatorship. However, in 2002, both the JI and the PTI had taken part in elections held during the same dictatorship. Second, even parties with strong vote banks can withdraw from elections because they believe that their defeat, engineered by fraudulent polls, can dent their reputation. The PML-N harboured this fear in 2007. Benazir helped Nawaz overcome this fear, despite the fact that the PPP could have easily won Punjab had the PML-N not participated in the 2008 polls. The goal was to continue having at least some influence and presence, even in an engineered Parliament headed by a common foe.

To Dion and Buttorff, an elections boycott aims to disrupt a setup that Opposition parties do not trust. The boycotting parties believe that once the electoral process is proven as bogus, those engineering it would be forced to back down. But



even though, along with the JI, the shows that boycotts were unable to trigger any serious disruption, and many parties that had boycotted elections returned to contest them despite the polls being held by the same regimes they claimed were undemocratic.

According to Frankel, many boycotts lead to neither reform nor regime change, and leave Opposition parties worse off than they would have been had they participated. In a 2010 policy paper for the Brookings Institute, Frankel writes, "The boycotting party often becomes completely detached from the organs of power, setting itself up for further set-

In her book 'Faith in Moderation', the political scientist Jillian Schwedler writes that, if the holding of elections offers a way for authoritarian regimes to maintain power, it also opens up a host of new opportunities for the regime's opponents. Once in, the Opposition has a better chance of utilising non-electoral options to push out a regime, than it has after completely shutting itself out through

Finance Min looks at BIC model for affordable capital infusion

The finance ministry is looking at other avenues for affordable capital infusion, including setting up of a Bank Investment Company (BIC), as the RBI has raised concern over the issuance of zero coupon bonds for recapitalisation of public sector banks (PSBs), sources said.

Setting up BIC as a holding company or a core investment company was suggested by the P J Nayak Committee in its report on 'Governance of Boards of Banks in India'.

The report recommended transferring shares of the government in the banks to the BIC which would become the parent holding company of all these banks, as a result of this, all the PSBs would become 'limited' banks. BIC will be autonomous and it will have the power to appoint the board of directors and make other policy decisions about sub-

The idea of BIC, which will serve as a super holding company, was also discussed at the first Gyan Sangam bankers' retreat organised in 2014, the sources said. They added that it was proposed that the hold-



ing company would look into the capital needs of banks and arrange funds for them without government support.

It would also look at alternative ways of raising capital such as the sale of non-voting shares in a bid to garner afford-

With mounting capital requirement owing to rising NPAs, the government resorted to recapitalisation bonds with a coupon rate for capital infusion into PSBs during 2017-18 and interest payment to banks for holding such bonds started from the next financial year.

This mechanism helped the government from making capital infusion from its own resources rather utilised banks' money for the financial assistance.

US biz advocacy group urges Minister Sitharaman to lower tariff in Budget

A top India-centric American business advocacy group has suggested Finance Minister Nirmala Sitharaman to lower tariff in the Union Budget if the country wants to compete with China-backed mega free trade agreement Regional Comprehensive Economic Partnership (RCEP).

China and 14 other countries in November last year established the world's largest trading bloc that represents roughly 30 per cent of the world's GDP and population.

India walked out of the mega free trade agreement as negotiations failed to address New Delhi's outstanding issues and concerns.

The members of RCEP are 10-nation bloc ASEAN (Indonesia, Malaysia, the Philippines, Singapore, Thailand, Brunei, Vietnam, Laos, Myanmar and Cambodia), China, Japan, South Korea, Australia and New Zealand.

If India can focus on a much more predictable environment from a policy framework it will give more confidence to the investors. Bringing a sense of transparency in policy making also sends a very positive signal. Luxury carmakers seek reduction in taxes on automobiles in Budget

Luxury car makers Mercedes-Benz, Audi and Lamborghini expect the government to lower taxes on automobiles in the upcoming Budget, saying the premium segment of the auto industry has not been able to grow due to high taxation besides being hit hard by coro-

Any hike in taxes on luxury cars will hit demand and prevent recovery from the disruptions witnessed last year, according to senior officials of the companies.

"Anything which is a deter-rent to the demand in the sector we should stay away because at the end that will cause problem," Mercedes-Benz India Managing Director & CEO Martin Schwenk told

query on the company's expectations on the tax front from the government in the upcom-



Seeking a reduction on taxes on the auto sector, Schwenk said, "Already the auto industry is highly taxed...from the import duties to GST and cess which is 22 per cent (on luxury cars). I think the target should actually be to support the growth of the sector and reduce tax. We should try find an avenue.

Expressing similar sentiments, Audi India head Balbir Singh Dhillon said the chalges for the luxury car seg ment, which is recovering from the COVID-19 induced disruptions, in 2021 are "more or less the constants from the past".

"One is of course the high taxation on luxury cars, including cess. That remains a challenge because what it has done is that it has not let luxury cars grow beyond 1 per cent (of the total automobile markets in India). It is just hovering around 1 per cent and in last year 2020 it could have dropped probably 0.7-0.8 per cent. That (high tax) remains the biggest challenge," he added.

Lamborghini India Head Sharad Agarwal said the expectation of the super luxury segment players from the government is to maintain a consistency because the segment has suffered a lot in 2020.

"We want the segment to at least bounce back to 2019 level in 2021. We are still not expecting growth to come back but we want to touch 2019 level in change (increase) in the tax structure in the segment it is going to hit the segment very negatively," he added.

'2021 to be good year for Indian IT'

The year 2021 will be good for India's information technology sector and most of the companies in the space are expected to clock high single digit growth, according to IT industry veteran V Balakrishnan.

Founded by Ashneer Grover and Shashvat Nakrani in 2018, BharatPe offers merchants a single interface for all UPI apps like Paytm, PhonePe, Google Pay, BHIM, Mobikwik, Freecharge and others. It also facilitates loan facility for its merchant partners.

Speaking to PTI, BharatPe

co-founder and CEO Ashneer Grover said Rs 90 crore in debt came from Alteria Capital, while the remaining Rs 49

We have committed ourselves to provide USD 700 million of loans to small merchants and kirana store owners by March 2023 and are hoping to onboard more institutional debt partners in the near future," he said.

'Kerala must use virus as opportunity to reskill non-residents'

Amidst the return of a massive number of non-resident Keralites to the state following the pandemic, a renowned expert on migration has urged the state to use the calamity as an opportunity to re-skill these returnees/ prospective migrants so that it continues to lead the

human exports market. Official data from the state shows that as of January 7, as much as 8.7 lakh NRKs (nonresident Keralites) have returned to the state from overseas, mostly from the Gulf since the first week of May last.

What is more, in a job-starved market like Kerala, a vast majority of them (5.7 lakh) have cited job loss as the sole reason for their return, ringing alarm bells in the government corridors and

among the planners.

More than a fourth of the over crore Indians in the Gulf are from Kerala and of them around 7.5 lakh have returned to the state which heavily depends on their remittances, making it the highest in history since the Gulf boom started in the late 1950s.

The pandemic has forced a whopping 8.7 lakh Keralites to return home from abroad, mostly from the Gulf, since last May when travel began after the first lockdown was lifted, and pertinently a vast majority of them, 5.67 lakh to be precise, cited job loss as the sole reason for their return, show the data from the Norka (Non-Resident Keralites Affairs)

The same data also shows 1,11,151 of the 13,27,330 returned from within the country cited job loss as the reason



for their return, Overall, 21.89 lakh Keralites have returned to the state

According to Norka, 40 lakh Keralites are living/working abroad and 13.73 lakh elsewhere in the country. The state

However, S Irudaya Rajan, a renowned expert on international migration, doesn't agree with the official numbers especially on job losses, saying tens of thousands have already returned, some of them even with new jobs. Also, he says the data shows only the number of returnees and do not include those who have gone back.

"The good news for all us is that migration is picking up and it will pick up more as the pan-Rajan, the chair professor at demic recedes with the vaccina-

tion progressing. Kerala should think of a new migration policy to help them upskill and reskill so that we can resurrect the migration market again," Rajan told PTI. We should not be worry too

much on how many have come back, as many are are going back or have gone back already. We should instead worry about how to help them better, how to make them more skilled, thus helping better migration later,"

he added. "We should work towards sending our human talent to other countries also but as better skilled," he said, and called up on the state to urgently unveil a policy to ensure that the state has direct flights to key European and US cities and not just to the Gulf as is the case







Can you tell us about your journey as a marine biologist and what led to resource marine conservation India?

I learned how to scuba dive when I was 16. I think a lot of what drove me towards learning diving was the incredible nature documentaries that I've watched before, like the original Blue Planet and oceans and all the BBC documentaries, narrated by Sir David Attenborough.

Watching them really inspired me

learn how to dive. And once I started diving, because I was very passionate about it that I became a scuba diving instructor. After working as a scuba instructor for a few years, I realised how our life on lands were impacting the ocean and especially coral reef ecosystems. That's when I became very passionate about conservation, and that's what led me to study marine biology and then work with Reef Watch.

Tell us about the various initiatives undertaken by Reef Watch Marine Conservation India?

We have two sort of key field placements. One is in the Andaman Islands, and the other on the coast of Karnataka, to the West coast of India. In the Andaman, we work a lot with coral reef restoration and conservation. So, we have various ongoing projects where we are looking at different ways to regrow and repair the damaged reef areas. In another mainland, on the West coast, the work that we're doing is to do with injured and stranded marine megafauna, like sea turtles, dolphins and even whales. We have a lot of them on our ports, even on the mainland, and a lot of them often get stranded on land, either dead or sometimes alive and injured. So, we have a project where we look after the injured or ill megafauna that come up to our coast and study the

ones that was wash up dead.

What is your take on the show
Blue Planet Revisited? Do you
think shows like this one help
people understand oceans and
its life better?

Yes, and this is one of the main reasons I am associated with the channel, to talk about this show, because my

own journey began very much with shows like these. A lot of what I knew before I did my masters on the subject, a lot of what I knew about the ocean and the animals that live in it came from shows like this. Such shows also help dispel a lot of myths and bring things into the right perspective for a lot of people. One of the episodes of the show is about sharks. I believe they are one of the most misunderstood animals on our planet today, so many people are terrified of sharks. I was just telling somebody earlier that when I worked as a full time instructor, the question I was asked most frequently was, 'are there sharks in these waters and are they going to attack me?'

Shows like this and nature documentaries teach people a lot about these animals. They teach them which animals are dangerous and which ones are not. They create a lot of excitement and curiosi-ty, leading to more people exploring these spaces in real life. It's wonderful to have such shows. One of my greatest dreams is to make

Can you tell us about some of the astonishing encounters in your journey underwater? What keeps you going in this field?

a documentary about India's coast

specifically.

One of my most memorable diving experience ever, was when I got to do something very similar to what they have shown on this show about the sharks in the Bahamas. A few years ago I got to dive in Galapagos Islands, which is another sort of shark sanctuary we have on our planet today. So, I

got to dive with hundreds of different species of sharks. And, I could see these really powerful, magnificent beings swimming around me — I can never forget that moment in my life. So, it was really cool to see something similar like that on a particular episode of the show.

What is the future of our islands and marine world, especially in India?

I've been working as a diver and then as a conservationist for the past 10 years. Over the years, I have seen a lot of damage to our oceans. Areas that boasted of a lot of sharks are completely fished out of it now. I've seen a lot of coral reefs being degraded over the vears. There's an increasing amount of litter and plastics on our coastline and waters. It is very concerning, but the silver lining here is that I've seen a surge of young children concerned about the environment. They get in touch with me, wanting to be marine biologists or wanting to come and volunteer with the organisation or know how they can organise a beach clean-up in their city. Indians are coming in to learn how to dive and surf and just interact with the ocean more. This is really encouraging. Right now, the interest of youth in all of this is rising, if more people connect with the ocean and want to preserve it, things can change. We still have coral reefs in the Andaman, have sharks in our ocean, whales in the sea, and sea turtles along the coastline. This is really the time for us to act. If we as a society realise the importance of a healthy ocean and come together we can change.

ebutant Washington Sundar and Shardul Thakur punched above their weight with splendid halfcenturies to keep Australia at bay and India bullish after an engrossing third day's play in the series-deciding fourth Test here on Sunday.

Australia's openers — David Warner (20) and Marcus Harris (1) — saw out six overs, and extended the home team's lead to 54 by stumps after India's first innings ended at 336.

However, Australia's lead could have been much more had it not been for a delightful 123run partnership for the seventh wicket between Washington (62) and Shardul (67), who defied and then attacked the rival bowling attack with gusto.

Pacer Josh Hazlewood finished with a well-deserved 5/57 for Australia, a reward for consistently bowling with an impeccable line and length at a brisk

Symbolising the courage shown by the visitors, now rendered almost second-string owing to a plethora of injures suffered by their top players through the four-match series, Washington and Shardul mixed caution with aggression to bail their team out of a precarious 186 for six.

First, they turned unlikely saviours after three soft dismissals pushed India on the back foot, and in the final session, the two opened up and went after the world-class Australian attack.

If his nine fours were not enough, Shardul bludgeoned off-spinner Nathan Lyon, holder of 397 wickets, for a maximum over long-on to reach his maiden Test fifty in style in only

Making a successful comeback after '10-ball' debut is dream come true moment: Shardul

rndia fast bowler Shardul Thakur had a nightmare of a Test debut in 2018 as he got injured after bowling just 10 balls but on Sunday said his dream came true after doing well with both bat and ball in the ongoing fourth Test against Australia here.

Shardul took three wickets with the ball in Australia's first innings and then top-scored for India with a 67 as he got involved with Washington Sundar (62) in a fine rear-guard fightback to keep India in contention.

"It was not easy to bowl those 10 balls and get injured. I went back and grinded out in domestic cricket and whatever opportunities I got," Shardul said in an interview taken by senior spinner Ravichandran Ashwin, posted on *bcci.Tv.*

"Waiting for two years to play Test cricket again and getting the wicket (of Marcus Harris) in the very first ball, it is a dream come true. I am happy to contribute to the team's cause.

In October 2018, Shardul was forced to leave the field due to a groin strain after bowling just 10 deliveries on the first day of the second Test against the West Indies in Hyderabad.

But on Sunday, he and Washington rescued India from conceding a huge lead to Australia. After India were reduced to 186 for 6 in reply to the hosts' 369, the duo stitched 123 runs for the seventh wicket and defied the Australians for 36 overs.

In fact, Shardul began his innings with a six and also got to his half-century by hitting a stunning six.

Asked about it, he said, "At that point of time I was not looking to hit a six but it was more of a reaction. I saw the ball and played it instinctively. It came out well for me. I am happy



On the cover drives he hit, Shardul said, "Honestly, I have not done practice for that but it was one of the days when I was batting really well. I did not want to miss any opportunity and any loose ball. I felt like putting it away. That is it."

Washington said Shardul was trying to hit a six off Nathan Lyon and he was not surprised when his batting partner reached to his 50 with a six.

For Washington, it was also a memorable debut as he got his first Test wicket in the form of Steven Smith and then got a half century.

Asked about it by Ashwin,

Washington said, "Test cricket is the toughest format. I am very happy to start off in this fashion. God's grace and a lot of support from the family."

Another debutant, pacer T Natarajan said he did not try too much for his three wickets in Australia's first innings.

"I did not try too much. I came around the wicket because the plan of the team was that."
