The Civil Supplies Department made drastic changes during the procurement of rice by reducing the husk and broken rice to a great extent.

For the first time, quality sorted rice is being given to the cardholders, with zero percent of stones and less than one percent of dyed or damaged

Health worker dies after jab

A 42-year-old healthcare worker in Nirmal district of Telangana, who received COVID-19 vaccination, died early Wednesday after complaining of chest pain, with preliminary findings suggesting the death is unrelated to the vaccination, a health official said.

The worker was vaccinated at about 11.30 AM on Tuesday at a Primary Health Centre (PHC) in the district and he is said to have developed chest pain at around 2.30 AM on Wednesday.

He was brought dead to

the district hospital at about 5.30 AM, state Director of Public Health G Srinivasa Rao said in a press release.

"Preliminary findings suggest that the death seems to be unrelated to vaccination,"

another three weeks.


Earlier, the High Court had directed that no action shall be taken against ABV for two weeks after the ACB sought that much time to file



Indian farmer at crossroads: Market, state or collective action?

Parmers are protesting against laws that deregulate the sale of crops, allowing private buyers free rein in a marketplace that has long been dominated by government subsidies. Farmers say the reforms that have long protected small landholders' place in the market will put them at risk of losing their businesses and land to big corporations.

However, what is missing in this narrative is the culpability of the market in the mess that the agricultural profession is in today, as well as evidence on whether, and how, the state and market have responded to the agrarian crisis that germinated over six decades.

The results after decades of agriculture development suggests that farmers continue to be vulnerable to frequent episodes of losses in their economic activity that neither the state nor the markets have been able to mitigate.

Market Economy and State

(published in 1776), Adam Smith explains that in a market economy, guided by the motive of self-interest, individual decisions collectively determine the economy's allocation of scarce resources through free markets for the social good. In other words, operation of demand-and-supply forces, through a perfectly competitive market, results in optimal allocation of resources and a perfect market leads to social efficiency and maximum social welfare.

But, in the real world, perfect competition is not so 'perfect' as it appears at first. That means unless demand and supply reflect, respectively, all the benefits and all the costs of producing and consuming a product, the prices determined in perfect competition may not necessarily be 'perfect' or 'right'

If so, perfect competition cannot ensure maximum social welfare or markets fail to achieve social efficiency.

Economists call this 'market failure'. ket failure means that prices fail to provide the proper signals to economic agentsconsumers and producers—so that the market does not operate in the traditional way. This is also precisely reflected in agriculture markets in India, where neither the producing farmers nor the consuming citizenry is satisfied with the

However, government policy interventions, such as taxes, subsidies, wage and price controls, and regulations, may also lead to an inefficient allocation of resources, or government failure. Given the tension between the economic costs

caused by market failure and costs caused by "government failure", policymakers attempting to maximise economic value are sometimes faced with a choice between two inefficient outcomes, i.e., inefficient market outcomes with or without government inter-

Government should play an important role in banking and securities regulation, channel investment support through direct transfers to enforce contracts and property rights. The real challenge today is about finding the right balance between the market and government and to



explore farmers' own institutions beyond the market and the state

AGRICULTURE, ENVIRONMENT AND COOPERATION

Collective Action and **Cooperative Economics**

The collective action or cooperative approach demonstrated by Elinor Ostrom and others challenges the current economic orthodoxy that there are indeed alternatives to state, privatisation and markets in generating wealth and human

wellbeing.
As is known, between the individual/market/government a range of voluntary, collective associations, producer organisations, cooperatives, and producer companies can evolve efficient and equitable rules to get the most out of common resources. We know that today there is an alternative secure, stable and sustainable model of business owned and controlled by 800 million people worldwide. Cooperatives with over 400-million-member farmers are responsible for over 50% of agricultural production and marketing in the world. It is no coincidence that the world's most successful and stable economies generally also happen to have the world's most co-operative economies.

Farmer collectives are therefore viewed as an important element in linking smallholders with modern markets (input and output) as they provide many benefits for this interface. Further, primary producers' organisations or collectives are being correctly argued to be the only institutions that can protect small farmers from ill-effects of globalisation or make them participate successfully in modern competitive markets. Producers' organisations not only help farmers buy or sell better due to scale benefits but also lower transaction costs for sellers and buyers, besides providing technical help in production and creating social

A striking example is The Gujarat Co-operative Milk Marketing Federation with 28 lakh milk producers whose Amul brand is a household name. It transfers 82% of its retail price to farmers in the supply chain. A number of equally successful cooperatives are running today in India and the need to promote them in the interest of small and marginal farmers is

A unique initiative of Farmer Producer Organisations (FPOs), which are memberbased farmers' institutions with the objective of integration of

smallholders into agricultural value chain, was taken by Government of India, NABARD over the last 10 years. About 5,000 FPOs were formed, of which around 3,200 are registered as Producer Companies which require not only technical handholding support but also adequate capital and infrastructure facilities including fair market linkages for sustaining their business operations. Such basic model of "beyond markets and states", is possible in communities with high levels of autonomy and internal trust when people have a reasonable expectation of influence over the things that affect their

This is because unlike the market or state it is only collective action and cooperation where efficiency and equity can be combined and the profits arising out of their business are returned to those who trade with the business, thus keeping the wealth generated by local businesses in the local community for the good of the local environment and families.

The framework is updated to include globally considered parameters for measuring innovation, such as the percentage of GDP spent on research and development, while keeping them specific to the Indian

Niti Aayog CEO Amitabh Kant said, "I hope that the India Innovation Index 2020 can help the country recognise the key areas of developmental intervention, with innovation as the central driver for growth. YSRCP Govt's failures reason for farmer suicides: Lokesh

TDP MLC Nara Lokesh on Wednesday accused the Jaganmohan Reddy Government of not taking remedial measures to prevent farmer suicides on account of rising debts and failure of

crops.
Lokesh expressed concern over how tenant farmer Katta Lakshminarayana ended his life at Chandarlapadu in Krishna district and left behind a letter narrating his woes. The tenant farmer happened to be a sympathiser and supporter of the ruling YSRCP, Lokesh claimed.

In a statement, the TDP MLC deplored that though over 753 farmers committed suicide, the Government was not taking any steps to prevent the crisis.

The anti-farmer policies of the Jaganmohan Reddy government has been causing distress among the cultivators, Lokesh claimed. He said



that the farmer from Chandarlapadu wrote in his letter that he was not able to clear his mounting debt.

Lokesh lauded the Amaravati farmers for continuing their agitation for the past 400 days despite the harassment and false arrests made by the Government. The farmers, women, youth and workers in Capital City were waging a relentless battle for justice and fulfilment

of promises made on Amaravati by all the parties, he said.

Stating that the YSRCP lacked sincerity when it came to service, Lokesh said that the CM was solely focused on making easy money by selling cheap liquor but not taking steps for the supply of potable drinking water. The Eluru public health

Union leaders reject suggestion of alternative route for rally

Farmer unions opposing the Centre's new agri laws on Wednesday rejected a suggestion by police officers to hold their proposed January 26 tractor rally on the Kundli-Manesar-Palwal Expressway instead of Delhi's busy Outer Ring Road, sources said. Union leaders and officers of the Delhi, Uttar Pradesh and Haryana police forces had met at the Vigyan Bhawan here to discuss the route and arrangements of the proposed rally on Republic Day. The sources said that the farmer leaders were suggested by the police officers to take out their rally on the KMP Expressway, but they did not agree. The Outer Ring Road passes through several areas of Delhi such as Vikaspuri, Janakpuri, Uttam Nagar, Burari Peeragarhi and Pitampura. There might be another round of talks with the police officers on Thursday, a farmer leader, who attended the meeting, said. Thousands of farmers, mostly from Punjab and Haryana, have been protesting at several Delhi border points against the laws for the last 56 days and unions representing them have begun holding tractor rallies at villages in Punjab to mobilise people for the demonstration on Republic Day. During the meeting, "we discussed several points with police officers on our tractor rally on January 26", a senior farmer leader said. Joint Commissioner of Police, S S Yadav coordinated the meeting from the Delhi Police, according to the sources.Police officials from Haryana and Uttar Pradesh were also present at the meeting, they said. Active caseload slips below 2 lakh after nearly 7 months

India's COVID-19 active caseload has fallen below the 2lakh mark after nearly 7 months and comprises just 1.86 per cent of the total infections, the Union Health Ministry said on Wednesday.

It said that 72 per cent of the active cases are concentrated in Kerala, Maharashtra, Uttar Pradesh, Karnataka, West Bengal.

Thirty-four states and UTs have less than 10,000 active

"The active cases have fallen to 1,97,201. This is the lowest after 207 days. The total active cases were 1,97,387 on June 27, 2020," the ministry underlined.

A total of 16,988 people have recovered in a span of 24 hours. This has led to a net decline of 3,327 from the total active caseload, it said.

India's daily new cases are on a steady decline which has also contributed to the shrinkage in active caseload, it underscored.

"Globally, India has one of the lowest daily new confirmed COVID-19 cases per million population in the last 7 days," the ministry said.

As on January 20, 2021, a total of 6,74,835 beneficiaries have received the vaccination. In a span of 24 hours, 2,20,786 people were vaccinated across 3,860 sessions. A total of 11,720 sessions has been conducted so far. The total recovered cases stand at 1.02 crore.

"The total recovered cases have crossed the active caseload by one crore a few days ago. The gap presently stands at 10,048,540," the ministry highlighted.



Loss of smell may be best sign of Covid, research confirms

Loss of smell may be the best predictor of COVID-19 among patients with symptoms of respiratory diseases, according to new research. The findings of two new international studies, published in the journal Chemical Senses, show that there is frequent loss of smell in COVID-19 patients which often lasts for a long time. Over 4,500 COVID-19 patients from a total of 23 nationalities responded to the researchers' questionnaire. The studies found that the average loss of the sense of smell was 79.7 on a scale from 0-100, indicating a large to complete sensory loss. "This emphasises how important it is to be aware of this symptom, as it may be the only symptom of the disease," said Alexander Wieck Fjaeldstad from Aarhus University in Denmark. The research found that only around half of patients with a

"This differs from the picture we see with other viral infections and causes long-term discomfort for patients, both in relation to food and social contact, while at the same time causing them worry. Fjaeldstad said. The researchers also found that the sense of taste was also significantly reduced, to 69.0 on a scale from 0-100, adding the remaining sense of feeling in the mouth was also reduced to 37.3 on a scale from 0-100. "While the loss of smell in itself removes the ability to sense the aroma of food, the simultaneous loss of the other senses make it difficult to register what you're eating. Putting food in your mouth can The study is of interest both to



Biden's immigration bill proposes to eliminate per country cap

■ WASHINGTON

Joe Biden, hours after being sworn in as the 46th President. will send a comprehensive immigration bill to Congress which among other things proposes to eliminate the per country cap for employmentbased green cards, a move that would benefit hundreds and thousands of Indian IT professionals in the US whose current wait period for legal permanent residency runs into several decades. Called the US Citizenship Act of 2021, the legislation modernises the immigration system, according to an incoming White House official.It prioritises keeping families together, grows the country's economy, responsibly manages the border with smart investments, addresses the root causes of migration from Central America, and also ensures that the US remains a refuge for those fleeing persecution, said the official, who spoke on condition of anonymity.

Describing this as a commonsense approach to solving immigration challenges, focusing on what works, the US Citizenship Act 2021 creates a roadmap to citizenship for a population that lives and works in the United States. January 1, 2021 is the cut-off date for those undocumented workers. Two-thirds of undocumented immigrants have been in the US for 10 years or longer. It provides an immediate pathway to green cards for individuals who meet certain criteria as they were dreamers or have been recipients of the Temporary Protected Status (TPS), or are farm workers and meet certain criteria. They can apply for citizenship three years later. For those who don't meet those qualifications, there will be another path to citizenship, where they would be in an interim status for five years. Afterwards they would be eligible to apply for citizenship within three years after becoming green card holders.

2021 Assam polls to be held keeping in mind Rongoli Bihu, CBSE exams

hief Election Commissioner Sunil Arora on Wednesday Said the 2021 Assam assembly polls will be held taking into consideration the Rongali Bihu festival in April and the CBSE board examinations for students of class 10 and 12. The assembly elections will be completed before the CBSE board exams which are scheduled between May 4 and

June 10, he said. "We have already taken the festival into consideration before coming here for the review meetings," he told reporters here. The commission is aware of the festivals held in the states, the CEC said. He said the commission has also held discussions with CBSE officials to decide on the poll schedule."We have decided that the election process will be completed before the board exams which will start from May 4," he said. The elections will be held in strict adherence to COVID-19 protocols, Arora said, adding that the number of auxiliary polling booths would be increased. "The number of electors at each polling station has been restricted to 1,000 as against the existing 1,500," he said. He also urged the state election authorities and the people to ensure "fair, peaceful and COVID safe polls". The full bench of the commission, on a three-day visit to the state since Monday, had held discussions with the representatives of political parties and officials of the government to review poll preparedness.

Joe Biden nominates transgender woman as assistant health secy

President-elect Joe Biden has nominated Rachel Levine. currently Pennsylvania's top health official, as the next Assistant Health Secretary of the US, a move that could make her the first openly transgender federal official to be confirmed by

the Senate. Describing the nomination of Levine for the post as historic, Biden said she would lead his administration's health efforts amidst the pandemic. Let the leaders lead

Like elsewhere, prominent personalities of India should get the shots so that the common citizen feels reassured



Then the virologists in different countries developed vaccines for Coronavirus, there was a sense of relief and jubilation globally and people could not wait for the inoculation drives to begin. However, that euphoria turned into fear, distrust and vaccine hesitancy when side-effects and deaths began to be reported in nations like Norway, the UK, the US, and so on. In India, too, two people died after getting vaccinated on January 16 but, after the post-mortem reports came in, the Government declared that the deaths were in no way related to the COVID-19 jab, but to cardiopulmonary disease. Of course, the sceptics will take this statement with a pinch of salt. However, even if we were to attribute these deaths in India to

the vaccines, we must not let such incidents cloud our vision. If one were to look at the larger picture, the number of infections and deaths globally due to the pandemic till now is 96,700,231 and 2,067,913, respectively. In India, the number of infections has been 10,596,442 and the casualties have touched the 152,754-mark. As compared to this, of the 6,31,417 healthcare workers who have been vaccinated so far across 11,660 sessions in India, only nine adverse events requiring hospitalisation were reported. So, just 0.18 per cent minor adverse events have been reported and only 0.002 per cent of them needed to be hospitalised. According to the Health Ministry, this figure is in fact the lowest, so far as we know, in the world. So, it does not take a genius to understand that the advantages of getting the jab far outweigh the disadvantages. Plus, in such huge vaccination drives as the world is undertaking right now, adverse effects and some casualties are to be expected, particularly among the old, infirm and people with allergies. But the fact remains that globally, scientists and Governments are responding very quickly and, apart from the strong adverse event surveillance, they are being flexible and vigilant to finding out the causes and issuing directives on who can safely take the vaccine and who cannot. For instance, Norway has adjusted its advice on who should be administered the vaccine by giving individual doctors the discretion to make this decision.

In India too, Bharat Biotech, the company that developed Covaxin, is warning people with weak immunity and other medical conditions to consult a doctor before getting inoculated and, if possible, to avoid it altogether. However, till now the other vaccine that is also being used, AstraZeneca's Covishield, has seen a good response. Though India is battling vaccine hesitancy even among healthcare workers, the Centre plans to press on with the inoculation drive. This is because the Government realises that pandemics can be contained only when people become resistant to the disease-causing pathogen. There are two ways to acquire herd immunity: One, on exposure to the pathogen, people develop antibodies and immune response in the body and; second, the body develops antibodies when the vaccine is administered. Allowing the natural spread of a disease to generate herd immunity is not desirable as it comes at the cost of avoidable morbidity and mortality. With mass vaccination against COVID-19, the Government is determined to protect the people. We must help it in every way possible. We are a big country, and rolling out vaccines to 1.3 billion people is not an easy task. But we are a very determined country that successfully eradicated smallpox and polio. We have the resources and the experience. With the hard work of those leading and implementing the campaign and with the support of people, we are bound to succeed in our gigantic vaccination drive. However, if the Government truly wants the people to embrace the immunisation drive, prominent leaders of the country should get the shots like they did in other nations, so that the common citizen can feel reassured. The leaders of the country need to lead from the front and not let the common man feel like the proverbial guinea pig.

What's in a name?

Rather than quibbling over Netaji's birth anniversary, the Governments should have celebrated the event together



n the face of it, one would consider it a matter of great national pride and patriotism, though a little belated, that the Union Government has decided to celebrate the birth anniversary of one of India's greatest nationalist icons who worked hard in the quest for the nation's Independence. Netaji Subhas Chandra Bose, on January 23 as 'Parakram Diwas'. However, the political controversy the announcement has kicked off is quite unnecessary and unsavoury, to put it mildly. There are allegations and countercharges that the decision has been taken to usurp the legacy of the revolutionary leader, who was actually born in Cuttack, Bengal Presidency, British India. While the Mamata Banerjee-led Trinamool Congress (TMC)

Government in West Bengal and the NDA Government at the Centre are in tandem on the issue of celebrating Netaji's birth anniversary, the bone of contention is the nomenclature the event should have: The Centre wants to call it 'Parakram Diwas' while the TMC and the All India Forward Bloc — which was founded by Netaji and emerged as a faction within the Indian National Congress in 1939 — demand that the day be celebrated as 'Desh Prem Diwas'. Both the parties are also angry that they were not consulted when the decision was being taken. The Culture Ministry recently issued a notification stating that in order to "honour and remember Netaji's indomitable spirit and selfless service to the nation", the Government has decided to celebrate his birthday every year as 'Parakram Diwas'. But the TMC leaders are sticking to their guns that it should continue to be called 'Desh Prem Diwas' (the State-level celebrations have been held at Darjeeling since 2014) and that January 23 should be declared a national holiday as Netaji was a national leader and the head of the Azad Hind Fauj, and "these two aspects are not clearly reflected" in the name 'Parakram Diwas'.

With West Bengal Assembly elections on the cards, and especially when it comes to Netaji's birth anniversary, no party wants to let the opportunity to lure the voters slip from its hands. The State is expected to go to the polls in the first half of this year with the BJP hoping to wrest power from the TMC after emerging as the second-biggest party in Bengal in the 2019 general elections. The regional party's leaders have gone so far as to claim that it was a "stunt" by the NDA Government keeping in mind the upcoming Assembly poll in West Bengal, and "not a mark of respect" to Netaji. The family members of Netaji also put their weight behind 'Desh Prem Diwas', saying that the name would have been more appropriate "but we're happy with the announcement". Hectic preparations have already commenced for the 125th birth anniversary of Netaji in Kolkata, both by the State Government and the Centre. While the TMC Government has planned a massive procession in Kolkata, the Centre is also making preparations for a grand event at the Victoria Memorial Hall, where Prime Minister Narendra Modi is expected to be present. Petroleum Minister Dharmendra Pradhan will participate in a programme in Cuttack, Odisha, where Bose was born. Another programme will be held in Haripura village in Gujarat's Surat district where Bose was elected the president of the Indian National Congress in 1938. But the bottom line remains that the true respect and honest tributes to Netaji had been if both the Governments had joined hands to celebrate the 125th birth anniversary of one of India's greatest sons who strove to free India from the iron clutches of the British Empire.

The usual suspects

The SC-appointed panel to talk to farmers comprises a neo-con economist, a seed terrorist and a policy sahib, which has given rise to mistrust

s 2021 began, the Supreme Court (SC) appears to have got a taste for drama as it pitched a "biased committee' against the revolutionary, but peaceful, farmers camping on Delhi's borders. Why biased? Because all the four original members had unequivocally supported the farm "reforms". But the apex court believes that they will remain neutral; and Chief Justice of India SA Bobde orally observing that if a person on a panel has expressed views on the matter, it should not become ground for his disqualification from a committee and that "committee members are not judges; they can change their views". Meanwhile, Bhupinder Singh Mann rejected the SC's offer to be part of the committee and said he stands with Punjab. The three remaining members, who pledge to be "non-partisan", have only added to the mistrust of farmers because the media may see them as honourable but, to farmers, they are simply a neo-con economist, a known seed terrorist and a policy sahib.

Let us go back to the start of this mess. After repeated failure of talks between the NDA Government and the farmers, petitions were filed in the SC which gave them a patient ear and even admonished the Centre for its "handling of the issue". There was some jubilation when farmers were teased by names such as "P Sainath" to be included in the committee. But the celebration was short-lived; it was as if the SC was testing the waters before delivering the master-stroke: Four pro-Big Ag names were invited to the committee. They being men of the law, we can't expect the judges to understand much about agriculture but whosoever advised them, has put the integrity of India's top court in quagmire. Mann's polite refusal provides grist for this fact. Recently, committee member Anil Ghanwat has expressed fears that the farmers may not even

With a demonstrated history of promoting and advocating for Big Ag and USstyle liberalisation, the apple doesn't fall far from the tree. Ashok Gulati, our neo-con economist, despite having worked in the Government for decades, is noto-

Ag in India. His policy recommendations are hailed by the industry and vehemently opposed by farmers, whether on GM crops or farm-gate liberalisation. His economic models, to many farmers, are allied to the US industry interests and not to the welfare of Indian farmers and consumers. Gulati's models are a disservice to Gandhi's bread labour. Some would go so far as to say that his economic schizophrenia is so advanced for what he called the "1991 moment" for Indian agriculture, has turned out to be the biggest farmers' revolution in the history of our world.

'seed terrorist' Anil Ghanwat, who is the president of Shetkari Sangathana (SS). This erant (HT) cotton variety that is unapproved by the Genetic Engineering Appraisal Committee (GEAC). The SC's technical committee on GM crops had also a few years ago put a moratorium on HT crops due to bio-safety issues. Despite this, Ghanwat's organisation has been unabashedly part of a criminal conspiracy to contaminate our native cotton seeds and biodiversity. Last year alone, he caused a damage of over ₹400 crore to the legal seed businesses, from Maharashtra to Telangana. They continue to do irreversible damage to our environment and health. The seed officials have booked various members for some of these offences, yet the ring leader — instead of being reprimanded — has been elevated to a power position.

The judiciary is an independent pillar of Indian democracy, and in no way should it be under pressure to echo the will of the Government of the day. For, if they acquiesce, Indian democracy will be dented. By appointing a committee without consultation, the SC may also have committed the same mistake as the Government. The CII, if he wants the farmfaith in the judiciary, should disband the committee for now and evaluate the members' profile. People like Ghanwat and his organisation who openly defy the rule of law, should be punished, not honoured.



A risky business

Share redemption is like a double-edged sword. The very advantage associated with it can backfire and become a major disadvantage

he recent announcement by the Gas Authority of India Limited (GAIL), pertaining to its share buyback worth over ₹1,046 crore as it looked to return surplus cash to bondholders — the biggest being the Centre — is perfectly in tune with the Government's efforts to raise funds for containing the rising fiscal deficit. The company's Board approved repurchase of the ₹6.97 crore dividend, which is about 1.55 per cent of the total paid-up capital, at a price of ₹150 per share. The Indian markets may see similar announcements by other Public Sector Undertakings (PSUs) like Coal India Limited, National Thermal Power Corporation Ltd and National Mineral Development Corporation in days to come. GAIL has also declared an interim dividend of ₹2.50 per share for the coming year. This share buyback forms a part of the target set by Finance Minister Nirmala Sitharaman for raising ₹2.1 lakh crore from the disinvestment of PSUs in 2020-21. Share redemption is the process by which companies buy their own dividends which are traded on the bourses at the market value, and in addition to its stock, is a preferred way to repay cash to the shareholders. Paying dividends to bondholders is an expensive affair as it increases the cost of equity. Therefore, paying off shareowners through buybacks is less expensive and reduces the overall cost of the capital. Since 2016 through 2018, it was one of the most favoured ways of returning excess cash to bondholders. In 2018, Indian stock markets witnessed bond repurchases worth ₹54,600 crore. This run was somewhat stalled in 2019 by the Government's decision to tax these transactions. As many as 70 companies announced share buybacks to the tune of ₹35,460 crore in the first half of 2019. In the 2020 Budget, however, the new tax regime made share buybacks lucrative once again.

There are several reasons why firms buy back shares. First, to consolidate their stake as diverse and numerous policyholders or owners make it difficult for the company to take an undisputed decision, as numerous stakeholders with voting rights indulge in a power tussle. By redeeming shares, companies increase their voting rights and exercise more control over governance. For instance, OYO's share buyback from Sequoia and Lightspeed in 2019 increased the stake of Chief Executive Officer Ritesh Agarwal from a meagre 10 per cent to 30 per cent, increasing his say in decision-making. Second, by redeeming its shares, a firm sends positive signals about its future prospects and growth potential. A company may also believe that the current stock price is undervalued and takes it as a good opportunity to increase its bondholding keeping in mind future prospects This is known as the signaling effect. Third, share repurchase is one of the best uses for any idle cash reserve companies might have, especially when there are not enough chances to invest the excess money.

However, share redemption is like a double-edged sword. The very advantage associated with it can backfire and become its disadvantage. While competing in a high growth industry, buyback may not be considered a positive step as it may give an impression that the firm does not have enough avenues to invest its idle cash reserve. Long-term investors respond to such share buybacks by selling their stakes. For instance, IBM's buyback announcements between 1995 and 2000 made investors apprehensive about the company's ability to bring out new products and services. Further, share repurchase is not an isolated event and has to be always viewed in conjunction with other performance parameters. For instance, it will not send a positive signal about the future growth potential to the investors if profitability is declining or the financial outcomes are showing otherwise.

Basically, there are three ways in which companies buy back their shares. Open market repurchase is the most common buyback mechanism in which tirms announce regemption ot a certain number of bonds through a Press release but do not give details of price, timing and execution of the deal. In fixed-price tender offers, companies invite shareholders to sell their dividends to the firm at a fixed price, generally at a premium rate to the prevailing market price, within a given time frame. While in auction-based tender offers, firms disclose their willingness to pay a premium and seek tenders from owners for certain portion of shares. It is the responsibility of the shareholders to respond to the company about the quantity of shares to be sold within a specified time period. Studies on the impact of share buyback have found that share redemption boosts operating performance due to an increase in earnings per share, return on equity and return on assets, rise in stock prices and shareholders' value. But negative effects of share repurchase on the stock prices of the firms have been reported, too. Although buybacks bring a positive sentiment to the bourses, their attraction for firms and shareholders depend on factors that are unique to each case. The management has to decide the proper use of its funds — either to reinvest in its business or return cash to the shareholders — creating a balance between future growth and stockholder's value creation.

Don't be an anti-vaxxer

There have been minor adverse events across India since the vaccination drive began on Jan 16. However, surveillance has been strong and will remain so in future, too

Taccines go a long way in managing, control-ling, eliminating deadly, sometimes debil-itating infectious diseases. Smallpox was the first example of a dreaded disease, with a mortality rate as high as 30 per cent, being eradicated by a vaccine. But it was a long journey from the development of the vaccine to the elimination of the disease. Edward Jenner, an English physician, was the first to demonstrate the effect of a vaccine in

The World Health Organisation (WHO) initiated a campaign to eradicate smallpox in 1959, but despite their best efforts, smallpox was still widespread in 1966, causing regular outbreaks in multiple countries. Then in 1967 efforts were intenmultiple countries. Then in 1967 efforts were intensified and scientists came up with a higher quality freeze-dried vaccine, bifurcated needle and a stringent surveillance system. India achieved the target of eradication of smallpox in 1975 after a very intense vaccination and containment campaign. So, it took almost 200 years, when on May 8, 1980, the 33rd World Health Assembly officially declared the world free of the disease ly declared the world free of the disease.

Smallpox is not the only example. Over the years, vaccines emerged as a powerful tool to protect populations against various disease-causing organisms. Our scientists have developed vaccines that provide complete or partial protection against diseases such as plague, cholera, rabies, polio, measles, rotavirus and influenza among others.

When COVID-19 hit the world last year, scientists across the globe came together to develop an effective vaccine against it. Interestingly, within 10 months of decoding the virus' genome sequence, many vaccines were not only developed but tested for their safety and efficacy. With vaccines we have achieved an important milestone in our fight against COVID. It is a matter of pride that two vaccines have become available in India. One has been fully made in India and the other has been developed in partnership and manufactured in the country. Till now, India had been trying to slow the spread of the infection and control the number of Coronavirus cases without a vaccine through conventional and known approaches like using masks, social distancing, hand hygiene, detection of cases, isolation, contact tracing and testing. Progress in medical management through modern as well as traditional medicine systems has also contributed to prevention and improved treatment outcomes in the

While all these methods will remain relevant till the virus is defeated, building the immune capacity of individuals and the population through vaccination can prove to be another highly effective shield against COVID. We are at an important juncture in our fight against the Coronavirus. On January 16, the Government rolled out the vaccines across the country. Its plan to inoculate 30 crore people in the first phase of the vaccination drive is an ambitious one, especially when the vaccine has to be given in two doses, at an interval of four-six weeks.

To execute this drive effectively, the Government has recruited an army of vaccinators, on-ground staff, experts to keep a watch on the adverse events that have been reported from many places, specialists to address these adverse events in the shortest possible time and data specialists to analyse the large amount of data the nationwide

vaccine drive would generate. It has also created the physical infrastructure for the storage and transportation of the vaccine.

There are many pockets in the country which are still not exposed to the virus. We don't know how the virus is going to behave in the coming months. It can come back in small waves, then spread to newer areas and we may also see another severe wave. Hence, we need to put in practice all the lessons we have learnt during past vaccination drives. There are many historical examples of such lack of communication or miscommunication becoming barriers in India which could be overcome by establishing good connection with people and their leaders. Hence, peoples' concerns OVID-19 is concerned. should be identified, addressed as fast as possible by sharing scientific facts with understand. Providing mation in an effective way, maintaining the confidence of people in information from authorised Government sources as well as the mainstream media is as important as the logistics of providing vaccines with highest standards of quality. This was done effectively in the past and hopefully it will be done so now too, especially as there is already a lot of reluctance across the country to take the shots after a few adverse incidents. However, the fact remains that only nine adverse events following immunisation that required hospitalisation have been

recorded so far in India. Second, adverse event surveillance after the vaccination has been strong so far. It will continue to remain so as the drive goes forward. Besides, real-time analysis of the reports as well as data generated from the various vaccine sites across the country will be important to further ensure the safety and efficacy of

the vaccine as we go into the mass vaccination phase.

Whether it is smallpox or polio, we were able to eradicate the disease with a targeted approach. First, implement it at a wider scale. Slowly, identify the problematic areas. There could be places where the disease prevalence could be higher than the rest of the country, target that area. Then there could be pockets where people would be more hesitant to vaccines, target that area with clear communication strategies. Communicate with the community, the local leaders, address their concern. After some time, the country could face yet another wave of COVID, or issues of

mutant variant(s) may emerge. We need a robust disease surveillance mechanism to handle any such situation and contain the outbreak before it spreads. Pandemics can be contained only when people become resistant to the dis-

ease-causing pathogen. There are two ways to acquire herd immunity-one, on exposure to the pathogen people develop antibodies and immune response in the body and second, the body develops antibodies when we give the vaccine. Allowing the natural spread of disease to generate herd immunity is not desirable as this comes at the cost of avoidable morbidity and mortality. With mass vaccination against COVID-19, the Government is determined to protect the people. We must help it in every way by getting rid of our vaccine hesitancy.

All the Australian experts and former cricketers had written off the Indian team by predicting a fourzero whitewash. All of them had forgotten that the trophy is still with India and times have changed. The Australian bowlers, with their shortpitched bodyline bowling reminded one of the bodyline tactics of England's cricket team for their Ashes Tour of Australia in 1932-33, in order to control the skills of the awesome Don Bradman.

The way India had batted in the second Test at Melbourne and the way Jadeja had launched a counterattack with great courage and with an excellent exhibition of technique lower down the batting order, gave sufficient hints to Australian players that no matter what happened to them earlier in the Test, the Indians were determined to undo that ignominious defeat.

This was proved with sufficient firepower by our so far "secondstring bowlers" who gave it back to the Australians and won India the



second Test and created a scare in the Australian camp in the third and

fourth Test. The way the Sydney Test was turned into a draw by the stubborn batting of an injured Hanuma Vihari and Ravichandran Ashwin, aided by Pujara and skipper Rahane, is the stuff of legends. They had taken several blows from the rising bouncers and short-pitched balls of Australian pacers, who left no stone unturned to intimidate the Indians.

In fact they were caught in their own game and the Indians resolutely defended and batted the whole day to deny the home team a victory. This solid batting by injured Indians will

be remembered for a long time by both the teams and the cricketing

However, the victory in the series clincher fourth Test outclassed the Australians by all means, in all the fields of the game. The second-string bowlers showed the Australians that they too, were top quality players and matched their rivals on all fronts of the game. The batsmen, led by a gritty Pujara who exhibited an unparallel determination to guard his wicket, laid the foundation for others to complete the unprecedented task of snatching victory from Australia.

This Test series will be noted for the emergence of the young and dashing Shubman Gill as an elegant and technically-competent batsman who, if handled carefully, will be one of the batting superstars of the game along with an aggressive Pant.

On his part Pant, too, played positively and handled the bowlers with contempt and confidently scored runs in all directions with his determined and aggressive batting. He shattered the confidence of Australian bowlers and their Captain, too. This Test also revealed the makings of a world-class batting and pace that 'The Wall' himself would have

bowler in Shardul Thakur, who will in all probability find himself in the same league as the great Kapil Dev

in the future. 'Indian insurers prepared to withstand economic downturn'

Indian insurance firms are geared to withstand the ecogrowth in general insurance segment will remain in positive territory and life premiums will stay broadly flat despite the weakening economy, Moody's Service Investors Wednesday said.

"Although the economic slowdown has had an adverse impact on Indian insurers, with general insurance growth slowing to 2.5 per cent and life insurers' new business premiums falling by 1.7 per cent in the nine months to December 2020, we expect general insurance premium growth to remain in positive territory," Moody's VP and senior analyst Mohammed Ali Londe said.

This premium growth will be driven by strong demand for health and protection cov-

erage, he added. In the nine months ended December 2020, health premiums grew by 13.7 per cent, helped by rising consumer awareness of these products during coronavirus pandemic and regulatory actions that enabled insurers to offer pro-



tection against the virus.

"We expect health premiums to continue growing strongly into 2021, when we anticipate that India's GDP growth will rebound to 10.8 per cent, leading to a gradual normalisation of economic activity," the agency said.

The growth prospects for general insurance are particularly positive, with the country's general insurance penetration rate standing at just 0.9 per cent. This is less than half the rate for China (2 per cent), which in turn lags behind developed markets such as the said. According to Moody's, insurers in the country have also responded to the crisis by rapidly developing appropriate products and improving their digital offerings.
"This has led to an increase

States' fiscal deficit seen spiking to historic high of 4.7%: Report

The combined fiscal deficit of the states will hit a peak of Rs 8.7 lakh crore or 4.7 per cent of their GDP this fiscal on the back of steep fall in tax collections due to disruptions inflicted by the pandemic, according to a report.

Revenue of the states have so badly fallen that as much as 70 per cent of the fiscal deficit is contributed by revenue deficit, which normally used to be only around 15 per cent, a Crisil study said on Wednesday.

Economic activity slumped from late March last when the country was brought under a lockdown, and subsequently improved as the restrictions were eased.

While the first quarter saw the economy tanking by a historic -23.9 per cent, by the sec-

ond quarter the contraction narrowed to 7.5 per cent and now analysts are expecting Q3 and Q4 to print in the green.

The pandemic has hit tax collections of the states and resulted in a near four-fold spike in their revenue deficits this fiscal over FY20, the report said. This will not only expand states' aggregate gross fiscal deficit to an all-time high of Rs 8.7 lakh crore, or 4.7 per cent of their gross state domestic product or GSDP but also skew its composition towards revenue deficit which is relatively less value-accretive towards future tax potential, it added.

Though tax collection may slowly recover with improving economic outlook, higher interest burden, because of the high debt funding of this year's gross fiscal deficit, coupled



with sticky revenue expenditure, may keep revenue deficit high for the states and the deficit composition skewed over the next two-three years,

the report said, adding that this will, in turn, increase their credit risk. The analysis is based on the data from 18 large states, which account for over 90 per cent of

aggregate gross state domestic product, the agency said. According to Manish Gupta,

a senior director at the agency, composition of gross fiscal deficit of the states apart from its level, is one of the critical indicators of credit quality. The higher contribution of Capex in a state's deficit composition is viewed positively as

tion and improves its tax potential. This fiscal, revenue deficit

would contribute around 70 per cent of fiscal deficit, sharply higher than the average 15 per cent seen over the last five fiscals, he said, adding this is because of a 15 per cent onyear decline in revenue this fiscal. Revenue expenditure may also remain sticky as these are either committed (related to salaries, pension and interest cost), making it difficult to cut or have been necessitated by the pandemic (such as grantsin-aid, medical and labour welfare-related expenses), the report noted.

High revenue deficit will also compel states to moderate their Capex so that they remain within fiscal borrowing limits, thus aggravating gross fiscal





Warne predicts huge fall out in Oz team | We were scared to lose: Clarke

dhe legendary Shane Warne believes the embarrassing Test series loss to an under-strength India will result in a "huge fallout" in the Australian team and said a few heads could roll in the coming days.

India recorded one of their most memorable wins on Tuesday when they defeated a full-strength Australia by three wickets in the fourth Test here to pocket the four-match series 2-1 and retain the Border-Gavaskar

Trophy.
"I think there'll be a huge fallout from this (defeat). There's not too many times that you lose to the second or third (choice) side," Warne was quoted as saying by Fox Cricket.

'Their (Australia) tactics will come into question, and they have to. Bowlers will come into question, people's spot in the team will come into question. It has to. You can't just deflect it and flick it off and say India were too good for us," he added.

Warne was, however, effusive in his praise for the Indian team which braved injuries to its key players and absence of regular skipper Virat Kohli after the first Test on paternity leave to emerge triumphant.

That's not taking anything away from those Indian guys that played but their first selection side, there's probably only two or three players in that side who would play."

The spin legend said Australia didn't grab their chances in the series.

Yes they were, but Australia had so many chances in this series to bury it and crush India, but they couldn't do it. They just couldn't do it," he said. Warne was also critical of Tim Paine's captaincy and said the wicketkeeper didn't own up responsibility for his failed tactics.

"I think at times their tactics haven't been good enough, and I suppose that's got to come down to Tim Paine as captain," he said.

"It's not just Tim Paine's fault, the bowlers are allowed to say 'Tim I want to do this, so it's a combination between the bowlers and the captain. But at the end of the day, you are captain, you have to take responsibility. He'll be disappointed."




