BJP mulls Lingayat strongman's replacement

As the longest-serving BJP Chief Minister and 'Lingayat' strongman BS Yediyurappa readies to pave the way for a new incumbent, the BJP central leadership on Sunday considered candidates for the top post who may lead the party in the 2023 Assembly polls in the State which is the BJP's "gateway" to South India. Yediyurappa, 78, on Sunday gave enough hints that he has been calculated in the state of the stat

he has been asked to exit after completing the two-year term of his fourth tenure at the helm which falls on July 26 (Monday)

With the countdown for the change of guard nearing, several names are doing the rounds including those of central leaders from Karnataka.

Given that 'Lingayat' seers are demanding that there should not be any change of

leadership, the BJP continued to play subtle and soft with BSY, as he is fondly called by people. On Sunday, BJP president JP Nadda said in Panjim, that Yediyurappa was doing good work and there was no leadership crisis in Karnataka.

Be that as it may, a change of guard seems inevitable with the BJP top leadership shortlisting the names of frontrunners for the Chief Minister's

job. These include Basavaraj Bommai ('Lingayat'). At present he is the Home Minister of Karnataka and a close confidant of Yediyurappa.
Then there is the Mines

and Geology Minister in the Karnataka Government Murugesh Nirani ('Lingayat') who is considered close to Union Home Minister Amit Shah; two-time MLA Arvind Bellad ('Lingayat') backed by

the RSS; BJP general secretary (organisation) BL Santhosh (Brahmin); Union Minister Pralhad Joshi (Brahmin) and BJP general secretary CT Ravi (Vokkaliga).

The final decision would be taken by Prime Minister Narendra Modi, Shah and the RSS' general secretary and second-in-command Dattatreya Hosabale, according to sources.

Police stations on frontiers to form 2nd line of defence

A mid hyper activities by Chinese PLA all along the Line of Actual Control, the Centre is creating a "border belt" comprising all the police stations adjoining the frontiers that will act as a second line of defence after respective frontier guarding forces across the land border with various countries.

Typically, the Central paramilitary forces designated for the various border security roles are also known as border guarding forces like the BSF and the ITBP among others, and act as the first line of defence. The border guarding forces are also designated as the Lead Intelligence Agency on their respective operational frontier. While the ITBP secures the frontier with China, the BSF is deployed along the borders with Pakistan and Bangladesh. The Sashastra Seema Bal secures the borders with Nepal and Bhutan. The Assam Rifles is deployed along the border with Myanmar.



the border belt is underway. This will help identify the police stations, districts, area, length of the border under their jurisdiction and the population covered by the border belt," a senior security official said.

The Union Home Ministry will coordinate with the police chiefs of the States and Union Territories along the border to initiate action in a time-bound manner.

As part of the overhaul of the police stations along the borders, the development of infrastructure is also being included in the Border Area Development Programme funded by the Centre. The Station House Officers of the border police stations are also proposed to be given a fixed two-year tenure to maintain continuity of the development The SHOs of such police stations are also proposed to be

included in the meetings of the Lead Intelligence Agency. Officers from the Crime Investigation Department (CID)/State Intelligence are also proposed to be posted in the border police stations. For this, the Union Home

Ministry, Intelligence Bureau and police chiefs of the States and Union Territories will coordinate to implement the proposals in a time-bound manner, they said.

In addition, use of optimum technology, technological surveillance solutions like anti-drone technology, foliage penetration radars, sensors, surveillance cameras and intrusion detection systems among others have been deployed for effective border management.

Holiday turns nightmare as landslide kills nine

Three hurt as boulders fall on vehicle in Himachal

Troubleshooting begins in Raj Cong; bid to pacify Pilot

After resolving the Punjab political crisis, the Congress high command is simmering tension Rajasthan by suitably rehabilitating Sachin Pilot.

The Central leadership of the Congress on Sunday convened a meeting of party MLAs and Rajasthan Chief Minister Ashok Gehlot to reach for an amicable solution to resolve the 18-month-long political turmoil in the State.

The Congress is taking steps to resolve the internal crisis in several States, including Punjab, Uttarakhand, Assam and Manipur.

In the meeting at Jaipur chaired by AICC General Secretary Organisation KC Venugopal and AICC in-charge Ajay Maken, all the party MLAs were instructed to be present in Jaipur as the Cabinet expansion is likely to take place on Wednesday. Pilot too was

After Punjab PCC change of guard, Cabinet rejig likely

All eyes on Capt who is expected to reshuffle his Ministers' Council

PNS CHANDIGARH

A fter witnessing a change of guard in the Punjab Congress unit with the appointment of Navjot Singh Sidhu on the apex post, all eyes are now fixed on Chief Minister Amarinder Singh who is expected to reshuffle his Cabinet soon.

Amid the changing political equations not only in Punjab but also within the Congress State unit, Captain Amarinder is expected to replace a couple of his Ministers by inducting new faces in his Council of Ministers.

Available information sugests that the names of Vidhan Sabha Speaker Rana KP Singh and senior MLA Raj Kumar Verka are in the reckoning.



While Rana KP is an OBC leader, Verka hails from the Dalit community

Sources within the Congress Party also informed The Pioneer that the Chief Minister may also drop some of his Ministers. For the same, the names of Revenue Minister Gurpreet Singh Kangar and Technical Education Minister Charanjit Singh Channi are doing the rounds.

It has also been learnt that Channi, if removed from the Cabinet, may be appointed as the Vidhan Sabha Speaker. Notably, Channi had all along

been strongly backing Sidhu's elevation to the Punjab Congress' top post. Channi was also among the

few party leaders, including Ministers, who have openly questioned the Chief Minister several issues, including sacri-

At the same time, it would be interesting to see if the Chief Minister would take the party high command into confidence before making changes in his Cabinet. On the other hand, the newly-appointed party president, who completely enjoys the high command's backing, may also make an attempt to intervene in the Cabinet reshuffling process.

Notably, the party high command appointed Sidhu as Punjab Congress president along with four working pres-idents — Kuljit Singh Nagra, Sangat Singh Gilzian, Sukhwinder Singh Danny, and Pawan Goel — on July 18 brushing aside all opposition by Amarinder.

No follow-up results after meeting with PM: Abdullah

Srinagar: A month after Prime Minister Narendra Modi's outreach to mainstream leaders of Jammu and Kashmir, National Conference president Farooq Abdullah said on Sunday that there has been "no follow-up results" on the ground.

Adbullah said this in reference to the prime minister's remarks at the June 24 meeting in New Delhi that he wanted to win the hearts of the people of Jammu and Kashmir and remove "Dilli ki doori" (the distance from Delhi) and "dil ki doori" (distance between hearts).

"That was a welcome statement but there is no effort on the ground to win the hearts of the people. People continue to be locked up and dissent is not tolerated. We want to see the change on the ground, a visible effort to win back the people who went through the trauma of their state being dismembered, its special status removed in one sudden blow," the three-time former chief minister told PTI

"...We are yet to see any fol-low-up results even after a month," he said. "Trust is something that has been missing from both sides (Delhi and Srinagar). Successive prime ministers -- Jawaharlal Nehru, Narasimha Rao, Atal Bihari Vajpayee -- made promises but the trust deficit has persisted," he

The 83-year-old veteran politician said that he and his party had attended the Delhi meeting because it was an invi-

tation from the prime minister although he had no expectations from it. Yet, he had hoped for steps to win the hearts and minds of people but nothing had happened

Abdullah insisted that restoration of "full, undiluted" statehood to Jammu and Kashmir should precede the elections to its Assembly. All major parties have demanded that and the Centre should prove its bona fide by agreeing

Asked if his party would take part in the elections if the statehood was not granted before that, the NC president said, "We will decide at that time when the bugle is blown. We will then sit down and decide what we should do.'

In UNSC, India provided vital balance vis-a-vis members and their inter-se fissures: Tirumurti

United Nations: A country of the size of India with its independent foreign policy has been a welcome entrant into the UN Security Council, providing "much-needed" balance vis-a-vis the powerful UN body's five permanent members and their inter-se fissures, New Delhi's envoy to the UN said ahead of its Presidency of the Council in August. India will assume the rotating Presidency of the UN Security Council on August 1, the country's first Presidency during its 2021-22 tenure as a non-permanent member of the 15-nation UN body.

India will again preside over the Council in December next year, the last month of its twoyear tenure. "We are in the Security Council at a very significant juncture where we are

not only grappling with the unprecedented Covid pandemic, but also dealing with fissures, both in the Security Council and outside, which need to be bridged through greater collective action rather than individual initiatives," India's Permanent Representative to the UN Ambassador T S Tirumurti told PTI in an exclusive interview.

In response to a question on how India will work to bridge differences and divisions among UNSC members as Council President at a time when the UN body has been found to be divided on several issues, Tirumurti said India has not hesitated in taking a "principled position" on a wide variety of issues over the last seven months of its tenure in the Security

NCB arrests 3 drug peddlers, seizes charas worth ₹17.5 L

 $\mathbf{I}^{ ext{n}}$ a daring operation that saw one of its officials jump from the first floor of a building to catch hold of a fleeing drug peddler, the Narcotics Control Bureau (NCB) arrested three notorious drug suppliers with a huge quantity of drugs and a cash of ₹17.5 lakh at Jogeshwari (East) in north Mumbai.

Identifying the three arrested notorious drug peddlers as Sameer Mukhtar Sayyed alias Sam Langda, Zakir Sayyed alias Zakir Takla alias Zakir Chikna and Mohammed Amed Shamsuddin Shaikh, NCB's Mumbai Zonal Director Sameer Wankhede said that 1.2 kgs of Charas of commercial quantity, intermediate quantity of Mephedrone and a cash

NCB kept a watch on the three near their building at Jogeshwari (East), intercepted the trio and took them into custody. The operation was conducted in the intervening night of July 24 and 25.

An action drama preceded the arrest of three as one of the drug peddlers identified as Zakir jumped from 1st floor of the building they were holed up. Without losing any time, one of the NCB officers jumped from the first floor and caught hold of the fleeing Zakir.

NCB sources said that Sam Langda waS a notorious gangster in the organised drug mafia. "He is a specially-abled person. In the garb of being challenged, he was running his notorious drug trade," a senior NCB officer said.

Sam Langda is wanted by the NCB in a previous case. In that case, NCB Mumbai seized a total 15.1 kgs of Charas (Hashish) along with Cash Rs. 4.40 lakh and arrested 5 persons. Sam Langda was running a cartel which consisted of various drug peddlers and criminals under his

NCB Mumbai had received a lot of complaints from Residents of Jogeshwari regarding drug activities of Sam Langda and his activities involving children in drug trafficking.

Zakir Takla is historysheeter and was earlier booked 2 NDPS cases in 2010 over seizure of 10 kgs Charas and in 2016 for seizure of 250 grams by Anti-Narcotic Cell (ANC) of Mumbai Police.

Assam failed to settle irregularity queries of ₹2,15,286 cr in 25 yrs: CAG

Guwahati: The Assam Government is yet to settle queries regarding alleged irreg-ularities to the tune of ₹2,15,286 crore highlighted by the CAG in various departments over a span of 25 years since 1994, according to the latest report of the public auditor tabled in the state assembly

In its report on social, economic (non-PSUs) and general sectors for the financial year that ended on March 31, 2019, the Comptroller and Auditor General of India (CAG) said that the alleged irregularities were pointed out in 2,734 inspection reports (IRs) issued between 1994-95 and 2018-19 covering 55 departments of the state government.

"We report that on IRs issued up to December 2018, 39,479 paragraphs pertaining to 6,385 IRs were outstanding for settlement at the end of June 2019," said the report, which was tabled during the ongoing Budget Session of the Assam assembly.

These IRs are related to various departments like Public Health Engineering, PWD, Water Resource, Irrigation and Inland Water Transport, and other civil departments, it said.

Of these, 1,208 IRs containing 5,262 paragraphs had not been replied to/settled for more than 10 years.

Sena compares snooping with Hiroshima bombing

Mumbai: Shiv Sena MP Sanjay Raut on Sunday asked who funded the alleged snooping of politicians and journalists by Pegasus and compared it with the Hiroshima bombing, saying while the attack on the saying while the attack on the Japanese city had resulted in death of people, the spying by the Israeli software led to "death of freedom".

"The modern technology has taken us back to slavery," Raut said in his weekly column 'Rokhthok' in the

Sena mouthpiece Saamana. He said the Pegasus case is "no different from the atomic bomb attack on Hiroshima".

"People died in Hiroshima, while in the Pegasus case, it led to the death freedom," he claimed. He said politicians, industrialists and social activists fear they are being spied upon, and even the judiciary and media are under the same pres-

"The atmosphere of freedom in the national Capital ended a few years ago," said Raut, who is the executive editor of Saamana.He also sought to know who paid for the alleged snooping by the Israeli spy-

Quoting a media report, he said the Israeli company NSO charged Rs 60 crore annually as license (fee) for the Pegasus software. By way of one license, 50 phones can be hacked. Hence, to tap 300 phones, six to seven licenses are required, the Rajya Sabha member said. "Was so much money spent? Who paid for it? The NSO says it sells its software only to

Gautam Gambhir presents report card of his work in East Delhi constituency

India's lone goal came from the stick of Dilpreet Singh in the 34th minute. India had earlier defeated New Zealand 3-2 in their opening fixture on Saturday. The Manpreet Singh-led side will next play Spain on Tuesday The eight-time former champions looked completely off colour from the first whistle and the team's backline was put under relentless pressure by the Australians. In the first quarter, the Indians put up a semblance of fight but in the next 15 minutes it was all Kookaburras, pumping goals at will.

However, it was India who earning a penalty corner in the eighth minute, but Harmanpreet Singh failed to execute from the set piece.

Two minutes later, Australia surged ahead when Beale deflected in Jacob Whetton's strike after a poor penalty corner execution.A minute later, Dilpreet missed a golden chance from close range to level the scores.India custodian PR Sreejesh then made a double save to keep the Australians at

India were unlucky not to have equalised just seconds from the first quarter when Rupinder Pal Singh's low flick from their second penalty corner was brilliantly saved at the goalline by Andrew Flynn Ogilvie.

But the second quarter completely belonged to Australia as they scored three goals in a span of five minutes to take the game away from their opponents. First Hayward found the net from Australia's third penalty corner and then Ogilivie slammed home from top right corner of the circle with a fierce hit past Sreejesh in front of the Indian goal.

If that was not enough, Beltz added to India's misery with a fourth goal, four minutes before half time with a reverse hit. The Indians showed some spark after the change of ends and attacked the Australian goal secured three back-to-back penalty corners but wasted all of them. Four minutes into the third quarter, Dilpreet infused some life into the game by pulling one back for India, beautifully deflecting in Rupinder's defence splitting pass from the India wasted another penal-

ty corner in the 40th minute when Mandeep Singh failed to deflect in Amit Rohidas' lay-off.

But that was all India could manage as Australia slowly tightened their defence and withstood the pressure.

The Kookaburras managed to turn the tide and scored three more goals to hand India a humiliating loss.

Metro to run with 100% seating capacity: DMRC

s the Delhi Government Aannounced further lifting of restrictions on Saturday in view of an improved coronavirus situation, the Delhi Metro Rail Corporation Limited (DMRC) is running maximum trains, performing over 5,100 trips with highest frequency daily as was available during pre-Covid time.

The Delhi Metro in a statement said its services will now run with full seating capacity from July 26, but there will still be no provision for standing travel for commuters.

The DMRC reiterated that a maximum 50 passengers per coach are permitted even with these revised guidelines as against 300 prior to Covid-19. `Though the queues may



slightly reduce but they might still be there outside stations especially during peak hours owing to the compliance and adherence to the Covid appropriate behaviour inside metro premises," it said.

DMRC once again pealed to the public to travel by the Metro only when it is absolutely necessary and observe all Covid related travel protocols in place for their

own and everyone's safety in this fight against pandemic.

Metro services were fully suspended from May 10 in view of the Covid-induced lockdown in Delhi. It was first imposed on April 19, and successively extended by the city government.

Its services initially ran partially, catering only to peo-ple from the field of essential services, but from May 10, it was suspended in view of the rising cases amid the second wave of the coronavirus pandemic. However, from June 7, it has been running with 50 per cent seating capacity and no provision for standing travel for

The DMRC has 10 lines spanning 242 stations, and 264 stations, including the Rapid Metro in Gurgaon







India, US to discuss Afghanistan, Covid crisis during Blinken visit

India and the USA will dis $oldsymbol{1}$ cuss the fast deteriorating situation in Afghanistan and the ongoing fight against the coronavirus pandemic during the two-day visit of US Secretary of State Anthony Blinken beginning Tuesday, July 27. During his talks with External Affairs Minister S Jaishankar, terrorism emanating from Pakistan funding of terror groups will also figure. Blinken will meet National Security Advisor(NSA)Ajit Doval and call on Prime Minister Narendra Modi too.

Given the growing strategic and defence ties over the past few years, the two sides are also likely to explore ways to further strengthen relations including exercises and transfer of technology. The two delegations will also do the groundwork for the ourth 2+2 dialogue of defence and foreign ministers to be held in the US later this year.

Highlighting some of the key features of Blinken's visit, the first ever to India after assuming new charge, sources

said here on Sunday Jaishankar is in regular touch with him for the past few months through telephone conversations. The two leaders met when Jaishankar visited US in May and later on the sidelines of the G-7 and G-20 summits in UK and Italy respectively.
Indicating US President

Joe Biden's keenness to have strong relations with India, the US Secretary of State is the third senior member of the Biden administration to visit India after defense secretary Lloyd Austin in March and special presidential envoy for climate John Kerry in April.

While the two sides are likely hold intensive review of

the situation in Afghanistan and the Taliban controlling major part of the country, India will also convey its concern about the instability in Afghanistan spilling over into the Indian subcontinent. Moreover, Lashkar-e-Taiba(LeT) and Jaish-e-Mohammed(JeM)terrorists now currently fighting along-

The two sides will also take forward the Quad vaccine partnership, which was launched at the first virtual summit of the group in March, to enable the supply of made-in-India Covid-19 vaccines to countries in the Indo-Pacific from early 2022.

Jaishankar and Blinken are also likely to lay the groundwork for the Quad summit and bilateral meetings between Prime Minister Narendra Modi and U.S. President Joseph Biden due to be held in Washington later this year, sources said.

Asked about Parliament IT panel head Shashi Tharoor's remarks that the subject is already on the mandate of my committee and a JPC is not required, Chidambaram expressed doubts whether the IT panel with a majority of BJP members will allow a full investigation into the matter.

"The parliamentary committee rules are rather strict. For example they cannot take evidence openly but a JPC can be empowered by Parliament to take evidence in public view, to cross examine witnesses, and to summon documents. So I think a JPC

will have far more powers than a parliamentary committee," he said. At the same time, he said

he is not diminishing the role of the parliamentary committee to the extent it can probe the matter and is welcome to

Posing questions for the government, he asked whether there was surveillance at all and whether snooping was done through Pegasus.

"If Pegasus spyware was used, who acquired it? Was it acquired by the government or by one of its agencies," he asked.

The Rajya Sabha member also asked the government to come clean on the amount paid to acquire the spyware.

RS member John Brittas seeks SC-monitored probe into spyware snooping

New Delhi: Rajya Sabha member John Brittas has moved the Supreme Court seeking a court-monitored probe into reports of alleged snooping of activists, politicians, journalists and constitutional functionaries using Israeli spyware

A massive political row has erupted after media reports was used to conduct surveillance on about 300 Indians, including ministers, political leaders, government officials and journalists.

Brittas, who has filed a public interest litigation in the Supreme Court, said that recent allegations of snooping has caused concern among a large section of people in India and that snooping would have a chilling effect on free speech and expression.

He has sought a courtmonitored investigation into allegations of snooping using Pegasus spyware.

In a statement on Sunday, Brittas, who is a CPI-M member, said that despite the very serious nature, the central government has not cared to investigate into the allegations involved in the issue but "made only a hopeful hope that the time tested processes in our country are well-established to ensure that unauthorised surveillance does not occur".

"Therefore, the queries were raised in the Indian Parliament with respect to this leakage. But the government has neither denied nor admitware," he said.

Amid a row over the Pegasus spyware issue, the government had said that illegal surveillance was not possible with checks and balances in the country"s laws and alleged that attempts were being made to malign the Indian democracy.

On July 19, IT Minister Ashwini Vaishnaw told the Lok Sabha that media reports on alleged snooping published a day before the start of the Monsoon Session of Parliament "cannot be a coincidence" and stressed that there is "no substance" behind the sensationalism.

However, the minister did not specify whether the Indian government was using Pegasus spyware. PTI

At a time when several States are alleging vaccine supply shortage and have even temporarily called off vaccinations on this very ground, the Centre on Sunday claimed the States/UTs and private hospitals combined have nearly 3.30 crore vaccines available with

According to the health ministry, over 45.37 crore vaccine doses have been provided to the states and UTs so far through all sources and a further 11,79,010 doses are in the pipeline. Of this, the total consumption, including wastage, is 42,08,32,021 doses (as per data available at 8 am Sunday), the ministry said. More than 3.29 Cr (3,29,38,559) balance and unutilized doses are still available with the States/UTs and private hospitals to be administered, the Ministry said.

As part of the nationwide vaccination drive, the government has been supporting states and UTs by providing them COVID-19 vaccines free of cost. In the new phase of the universalisation of the vaccination drive, the Union government will procure and supply (free of cost) 75 per cent of the vaccines being produced by the manufacturers in the country to the states and UTs. The new phase of universalisation of COVID-19 vaccination commenced from June 21.

India has added 39,742 new cases of coronavirus infection taking the total tally of COVID-19 cases to 3,13,71,901, while the death toll rose to 4,20,551 with 535 fresh fatalities in the last 24 hours. ¬he toll in the rain-flood Travaged Maharashtra mounted to 149 on Sunday, even as the number of people evacuated from the affected areas of the State climbed to 2,29,074 and the various agencies continued relief and rescue operations in the State.

A day after the rain-flood mishap casualties rose to 112, the various central and state agencies recovered 37 more bodies, taking the total number of people killed in landslides, house crashes, floods and various other rain-related incidents to 149.

While a maximum of 60 people were killed in Raigad district in Konkan region, Satara district in western Maharashtra

With the floods having not receded in most parts of the coastal Konkan region, the relief and rescue agencies evacuated as many 2,29,074 people to safer places in western Maharashtra and Konkan region. The worst flood-hit district of Sangli in western Maharashtra accounted for a maximum 1,69,998 evacuations, while 40,882 people were shifted to safer places in the neighbouring Kolhapur district. trictsm is as follows: Satara-7530, Thane-6930, Ratnagiri-1200, Sindhudurg-1271, Raigad—1000 and Pune—263.

Maharashtra Chief Minister Uddhav Thackeray, who visited flood-affected district of Ratnagiri, said merely for the sake of getting some publicity, he would not make any announcement about compensation to the affected people immediately, but would such an announcement after taking stock of the rain-floods situation in the entire State.

'The rain and the consequent floods wreaked havoc in places like Chiplun, Mahad and Khed. The people have suffered huge losses. The state government will do everything to ensure that you are back on your

Engineers, PGs apply for lab assistants' job in WB

In what could come as an egg on the face of the ruling Trinamool Congress— credited with introducing a number of pro-people schemes like free ration to free health —which has won the recently concluded Assembly elections by a huge thumping majority qualified engineers and postgraduates have swelled the ranks of 8,000 applicants for the posts of lab assistants popularly called "Doms" in the mortuary parlance.

According to reports about 100 engineers, 500 postgraduates and 2,200 graduates have applied for the job of so-called "lab assistants" in the Forensic Medicine and Toxicology Department of state-owned Nil Ratan Sircar Medical College and Hospital, a senior official said adding out of the total number of applicants 784 people including 84 women had been called for written test scheduled on August 1.

This is quite surprising because overqualified including engineers, postgraduates and graduates have applied for this post... whereas usually relatives of 'lab assistants' who are used to do such jobs only apply for these posts This has happened for the first time," the

The authorities had last December issued a notification seeking application for the post of lab assistants entitled to a monthly remuneration of ₹15,000 per month.

The notification for the job-seekers was put at "at least class 8 pass" who had to be between 18 and 40 years old.

Several applicants are overqualified for the job. It is quite a shock that engineers, postgraduates and graduates have applied for this post. This has happened for the first time. We generally get applications from people whose family members have been working as "dom"," the official added.

When contacted one of these applicants said he had no other option but to apply for the job because he had to take care of his old parents and pay off the loans taken for studying engineering. "I have to pay the loan ... there is no job for me here in Bengal ... I am a mechanical engineer and had been working with a private bank's insurance department on commission basis ... I earn roughly about ₹8,000 which has further dipped in corona times ... I cannot go to Bangalore or elsewhere leaving my parents ... so I had to apply for the post," said the candidate.

Another aspirant a postgraduate in Education said he was working in a private school for ₹2,500 per month "but now even that is gone because of on-line classes ... I had been earning some money giving tuitions but that too has been stopped due to pandemic ... There is no hope in getting scanty government jobs which are either sold or get entangled in court cases ... what do I do ... I have to feed my family."

West Bengal Transport Department excludes Guv, CM, Speaker in list of VIPs who can use beacon lights

"It is going to be the future as conventional medical methods are way put," said Prof

Dr Rajendran opined that National Medical Commission should seriously consider declaring Music Therapy as a diagnostic and curing process like what they have done in USA. "We have a vast repertoire of music in the subcontinent ranging from Lok Sangeeth. There were instances when patients undergoing chemotherapy told me that their anxiety, depression and tension reduced by more than70 per cent when the process was accompanied by Music Therapy. While working in Mount Sinai Hospital in New York, I witnessed music therapists using interventions such as Gato box and Ocean disc for premature babies to heartbeats and timbre of the whooshing amniotic fluid as how they would listen within the uterus," she said.

According to Dr Rajendran, these interventions along with parent-preferred lullabies, positively influenced the infants' autonomic nervous responses and sucking reflexes.

Citizens Education Society, Malayalam-speaking linguistic minority students in Tamil Nadu and Karnataka, has sought to intervene as a party in a pending PIL on grant of minority benefits to Hindus in 10 states including Punjab and Mizoram.

The apex court, in August last year, had issued notice to

lawyer and BJP leader Ashwini Upadhyay seeking directions for framing of guidelines identifying minorities at the state level claiming that the Hindus are in a minority in 10 states and still they cannot avail benefits available to minorities like Muslims, Sikhs and Christians in running educational institutions.

No laxity

All signs say the third wave of COVID-19 is on its way; India must keep its guard up

he second wave of COVID-19 is supposed to be abating since June 25, but the sense of relief is not reflected in either the total number of cases or the observations of the anti-pandemic strategists. The national count of fresh cases is over 39,000 and rising. And the empowered strategy group tells the Government not to allow the count to cross 50,000 a day. Should this be taken as a warning to the Government that the third wave may well be on the way? Yes, it is. For the first time, the strategists have given an early alert. For the first time, too, the country's anti-COVID policy is being directed by scientific rather than administrative considerations. The earmarked limit sends two messages. One, that the second wave has abated as much as it can in the country though the surge is largely limited to two States — Kerala and Maharashtra. Two, the breach of the 50,000-case limit will



mark the beginning of the stress on medical infrastructure. The strategists appear to be playing it safe and assuming that the peak of a future wave would see four-five lakh cases a day, nearly 10 times the new case limit. That should give the Union and the State Governments a clear picture of how much additional infrastructure they should organise in the next couple of months.

The example of the UK should show how they are dealing with a situation where the daily cases have crossed 50,000. People are testing positive at an alarming rate. Nearly 650,000 people are esti-

mated to have tested positive in the second week of July. Admissions are rising in hospitals. And yet, the Government has eased all restrictions. Social distancing is no longer mandatory, face masks are no longer required by law, and the ban has been lifted on large gatherings of people. The British Government is facing criticism for the complete unlock, but its confidence perhaps stems from two sources. One, that over 46 million people in the UK or 87.6 per cent of the adults have received their first dose and 35.5 million, or 67.5 per cent, are fully vaccinated. The high number of vaccinations and the presence of antibodies in the infected unvaccinated is said to reduce the severity of infection and the need for hospitalisation, and lower the chances of death. Secondly, thousands of people using the NHS COVID App are receiving self-isolation alerts every day, informing them they have been in close contact with a positive case. The UK is highly vaccinated and has rid itself of safety protocols and the cases are growing. Indian vaccination levels are low and the protocols are violated more and the cases are growing. This goes on to show that an either-or attitude towards vaccination and safety measures is a sure-shot invite to a third wave of the pandemic. The mandatory requirement is a combination of both and that is what the Indian strategists should emphasise on.

In a hurry?

The Delhi Govt allowing public transport to ply at 100% capacity raises a number of uncomfortable questions

nother step towards unlocking Delhi would take place today, Monday. Indeed, people will welcome it that buses are plying at full capacity though standing passengers would still not be allowed. Cinema halls are also opening after a long gap. The Delhi Metro would operate at 100 per cent capacity. This would truly bring Delhi closer to normalcy. The Capital has already suffered a great deal due to the COVID-



19 pandemic. Though Corona's second wave is ebbing and very few cases are being reported on a daily basis, the threat of the third wave is looming large. In this situation, going for almost complete unlock does not seem reasonable as the experts have warned that the third wave could be here sooner than later. It would have been better had the Delhi Government waited at least three more weeks, until August 15, to open up public transport and recreation centres. The Delhi Government officials say that the restrictions have been eased as the number of cases is falling. But we have seen even in the second wave that the scenario can

change very fast and cases can shoot up within a matter of days.

This is certainly not the time to take the pandemic lightly, especially since we are on the verge of defeating the virus. It would not at all be prudent to let the guard down. Apart from these concessions, 100 people will now be able to attend funerals instead of the earlier 20. A similar number of people can now attend weddings instead of the earlier 50. This would indeed expose people to risk. One can understand that people would welcome these steps but the Government should think beyond that. One can understand people's mounting economic hardships but totally unlocking Delhi might not be the solution. That must be dealt with at a different level. It defies logic why the Government is in a hurry to open cinemas, theatres and multiplexes in the national Capital. The Government's first and foremost responsibility is to save lives and, therefore, it should not put people's lives in danger by going for such-scale unlocking at this moment. Mercifully, the Delhi Government has not yet made plans to open schools and colleges, which may have serious consequences. The Government must work for people and should not play to the gallery, making policy decisions to win accolades and public support.

China's 'friendship must bother Putin

ate last month, Russia and China renewed their friendship treaty for a further five years. Comrade Putin appears to be making a dangerous mistake by ignoring the potential threat from China. He was only 17 when the Soviet Union fought a seven-month mini-war across the Ussuri river, which is located in Russia's Siberia (Sleeping Land). How big was Beijing's ambition one does not know, but the Soviets had to convey an implicit nuclear threat to the aggressor. To save face, Mao Zedong, through his Premier Zhou en Lai, threatened a "People's War", which meant that hundreds of thousands of Chinese soldiers would swarm Soviet tanks as they had done with the Americans in the Korean War in 1951-52. The Chinese leader's belief of convenience was the superiority of man over machine. The People's Liberation Army (PLA) did demonstrate its idea of warfare on one of the islands on the Ussuri by ambushing Soviet

In the end, China gained quite a few islands on the river, which were a loss for the Soviet Union. Logically, more conflict lies ahead. China is a much bigger nuclear power than it was in 1969. Its ambitions have grown and, by current indications, it wishes to become a superpower. We have to remember that Siberia is over 13 million sq km with a sparse population, whereas China is bubbling with people but is short of arable land. Incidentally, the Yellow Giant gained several hundred islands in the midst of not only the Ussuri but also the Amur and Argun rivers. This gain by China and loss by the USSR were after decades of harrowing negotiations which ended in 2004.

With climate change and the earth getting warmer, Siberia can well become more hospitable. Today, the whole region is considered hostile due to its very low temperatures in winter. With global warming, Siberia is likely to become attractive for China to occupy. The region is rich in coal, natural gas, diamonds, iron ore, scenario of China forcibly occupying Siberia can no longer be

looked upon as hypothetical or imaginary. Patrick Prinston, a Western columnist, informs us that a Chinese portal *Jinji Toutiao* published an article, the author of which calls Siberia "Chinese land". The Chinese media regularly praises Russian ruler Vladimir Putin and how cleverly he puts the West in its place. Simply, from the point of view of Beijing, Russia is not only a good friend but also has an excellent potential prize. 'There are no countries around the world that are always friendly or, conversely, always hostile to each other. In the past, Siberia was conquered by the Mongols and, therefore, in fact, is Chinese territory." This is increasingly becoming China's refrain.



ndia as an entity has existed for several millennia. The concept of a unified territory from the 'seas to the horizon'has been documented at least from the time of the Gupta Empire in the 4th century AD). India has seen different models of administration, including those of the Mauryan and Harshaempires, the Cheras, the Cholas, and the British.

India came under the British Crown in 1857 and was known as 'British India'. The rule lasted 90 years. There is a notion that this imperial state unified India administratively. It is a myth. British India was initially ruled from Calcutta and then the capital moved to Delhi. Besides the territory under direct British rule, there were hundreds of princely states with various degrees of administrative and revenue autonomy: Travancore-Cochin, Baroda, Jammu and Kashmir being among them. The British withdrew from India with a strange term that the princelystates could secede to either of India and Pakistan. It was an attempt to restore the status quo ante to 1857.



The British administered India with the help of the Indian Army and an institution called'The Indian Civil Service'. After Independence, the service metamorphosed into the Indian Administrative Service.

The story of Indian unity post-independence is a saga that many have testified to. Sardar Vallabhbhai Patel was the chief architect of the merger of the princely states with India. Some territories also merged with Pakistan by a wafer-thin majority. The first few years of Indian independence were also spent on reorganising the Indian Union into linguistic states and the states into districts. The story still continues with new states emerging and the districts of the states being reorganised.

Two administrative reforms commissions have been set up since independence and their recommendations used to carry out administrative restructuring. Appraisal systems of IAS officers have been thoroughly revised and the writer has been involved with some of these efforts. It is not sufficiently recognised that every IAS officer does not automatically graduate to the level of Secretary to the Government of India. There are institutional filters, evaluations, barriers, and in-built learning opportunities

After 1947, the nascent Indian Administrative Service, through special recruitment, spread across India. However, a few thousand civil servants, definitionally, could not fully administer all aspects of a nation's life. Their expansion no matter how planned was bound to leave gaps.

One of the first felt needs was for an 'Indian Foreign Service' which would handle external affairs. An all-India competitive examination was conceived and the Union Public Service Commission was entrusted with the task of holding it and selecting recruits depending on their need.

Administering India is not just a simple function of civil administration. The railways have to run, health and education need policy attention, information needs handling, etc. So, separate services like the Indian Railway Service and the Indian Information Service were created while

IRS and IPS became essential collaterals of the Indian administration. Over time, administrative groups were created, with IAS, IPS, and Indian Forest Service officials coming under Group A. However, because of their coordinating role, IAS officers remain prima donnas. Their perks and salary structures are also superior.

Gradually, the states developed their own civil service to look after their administrative needs. Provision is there for movement from state service cadre to central service cadre after due evaluation. Domain specialists began to occupy specialised administrative positions, especially in the departments of science and technology, biotechnology, taxation, and customs. The message is simple: the Indian Administrative Service, in its fullness, is amongst the powerful sections that admin-

Pegasus affair is an assault on privacy

 n a sensational international news break last week, it was revealed that over 300 Indians were being surveilled through an Israeli spyware called Pegasus. This software had the ability to hack into phones and be able to access files, documents, voice calls, and videos of the hacked individual. Those on the list were journalists, opposition voices, activists, and cabinet ministers. Most of the names were anti-establishment and their investigative stories uncovered the various failures of the gov-

The Pegasus scandal has once again opened the floodgates of the notion of privacy and to what extent can the state abuse privacy rights. While the history of snooping is not new in India, this is the first occasion of sophisticated technology meant for defence and national security purposes unethically used to get access to all the communication of those who are anti-government. Anyone defending this will be slipping down a steep slope of undermining the basic rights of an individual and also the democratic principles of the nation.

Ever since the controversy has broken, the IT Minister's only defence has been that there is a law in place to protect the privacy of individuals and for the government's need to surveil. The surveillance in India takes place under two laws - the Telegraph Act and the Information Technology Act. While the Telegraph Act deals with audio call records and interception, the IT Act deals with all electronic communication. However, loopholes exist in both Acts and they have not yet been addressed by the Centre and that gap is exactly what it uses for snooping and silencing oppo-

India is a democratic nation. At the heart of democracy are its people. When incidents like this (Pegasus snooping) happen, it infringes on the basic fundamental rights of the citizens. The right to privacy, though not explicitly mentioned in the Constitution, is inherent under various provisions of the Constitution. The unanimous Supreme Court of India Judgement in 2017 recognised the Right to Privacy as a fundamental right despite the Union government asserting to the contrary. Article 21 of the Constitution of India includes the Right to Privacy nich is mentioned in the Puttaswam Judgment as "the right of an individual to exercise control over his personal data and to be able to control his/her own life would encompass his right to control his/her own life and his/ her existence on the internet".



With an increased population that is now using smartphones, we in India have no Data Protection Policy in place. ny organisation is an ongoing concern and has to make decisions, either big or small, daily. These decisions converge towards its overall goal. So, what should be the overarching goal of a firm from the point of view of financial management? Financial managementis a critical branch of economics that makes profit maximization the main goal of any firm.

Profit, as an accounting term, is the excess of income generated by sales over the expenses incurred from the overall operation of a business. Any business is said to be in a loss if the expenses are consistently more than the income. And it is said to be profitable if the income is more than the expenses. Therefore, in the context of economics, the goal

of a firm should be to maximize profits, or to say in simple terms, to realize a large amount of profit. Profit maximization can

be achieved in two ways: enhance revenue and minimize costs. Therefore, to maximize profits, many firms minimize their costs and boost their revenue. The problem, however, with such a goal is that it is short-term in nature and banks on extreme measures to reduce costs, like cutting down and paring advertisement budgets, employee training, development expenses, research and development expenditure, customer care budget, employee salary, or bonuses.

In some cases, firms, in an attempt to maximize profit, may also neglect the safety,



welfare, benefits of the environment, and their different stakeholders. These knee-jerk reactions are short-term in nature and can be efficient for the near future but in the longrun, these measures slow down the sales, which in turn diminishes the profits and dwindles the overall value of the firm. Therefore, the objective of profit maximization has a myopic outlook towards the long-term growth of the firm.

Over the years, when financial management became independent from economics

own, the objective of the firm witnessed a steady shift from profit maximization to share-This is a comprehensive approach focusing on the longterm growth, profitability, and the value of the firm. This goal focuses on wider objectives and includes the welfare of employees, communities, and society at large. It is a fact that wealth or value is a long-term concept and for the firms, it is reflected in the market price of its shares that in turn depends on the success and expectations of the future success of a firm. Firms with higher performance receive a higher valuareflected in the increase in the share prices as compared to the initial listed value. Therefore, long-term vision acknowl-

and became a branch on its the value of a firm is a dynamic function of the overall performance of the firm and the rationality of the firm's invest-

holders' wealth maximization. ment, financing, and dividend In a way, shareholders' wealth maximization is also associated with intangible assets like goodwill, branding, good customer relations, a significant and loyal customer base, committed employees, and intellectual property rights. This concept also overarches and includes community and social welfare. Therefore, firms are moving away from the goal of profit maximization that has a short-term approach, ignores tion from investors which is any risk or uncertainty, and overlooks the timing of returns. In comparison, a

edges risks and uncertainty and considers the overall shareholders' wealth and not just profits.

This concept of shareholders' wealth maximization is mainly applicable to large firms where there are a large number of shareholders, including promoters, financial institutions like banks and mutual funds, foreign investors, and retail investors. The managers' actions should enhancethe value of the firm to benefit all shareholders. But does this concept apply to small businesses, where the owners are the managers and there are no diverse set of shareholders, excepts family members or partners?

The situation for small businesses is also different as they are not listed on the

stock markets. In the absence of external shareholders, the objective of profit maximization appears to be the correct approach. For small businesses, the availability of funding or capital is difficult, which is not a constraint for many large firms and they can invest in other stakeholders and efficient business processes. This improves the overall value of the firm and increases the wealth of the shareholders. Since surviving is the main goal of small businesses, they are more inclined towards profit maximization by reducing costs or enhancing revenue. As and when these small businesses start to grow and achieve a sizable expansion, the concept of shareholders' wealth maximization should be the way to go forward.

International Criminal Court is currently investigating allegations of war crimes and serious human rights abuses by all parties to the conflict, including the Taliban. Human Rights Watch said the Taliban have reportedly killed some detainees, including relatives of provincial government officials and members of the police and army.

The watchdog body said that after Taliban forces took control of Kandahar's Spin Boldak border crossing with Pakistan on July 8, 2021, and the Spin Boldak district center

UK parliamentary report finds bullying, harassment of women in military

Sixty-four per cent of female veterans and 58 per cent of currently serving women reported experiencing bullying, harassment and discrimination (BHD) during their careers in the UK military, according to a new parliamentary report put out on Sunday.

The House of Commons Defence Sub-Committee on Women in the Armed Forces, in its report entitled 'Protecting Those Who Protect Us: Women in the Armed Forces from Recruitment to Civilian Life', said that the Ministry of Defence (MoD) and military services are "failing to protect female personnel and to help servicewomen achieve their full potential". While most servicewomen

and female veterans that were consulted for the report, nearly 90 per cent of respondents to a survey, would recommend the Armed Forces as a career,

more than 3,000 (around 84 per cent) reported that female service personnel face additional challenges relative to

their male counterparts.
"Women are integral to our military's success and our country's security, yet women in the Armed Forces carry additional burdens to that of their male colleagues," said Conservative Party MP Sarah Atherton, Chair of the Sub-Committee.

'Women face barriers to promotion, issues with families and childcare, abuse and inappropriate behaviours, and an overrepresentation in the Service Complaints system. Female veterans face distinctive challenges when transitioning into civilian life and have specific needs, different

to male veterans, that cannot be dealt with by broadbrush, one-size-fits-all

veterans' services," she said. A female veteran herself, Atherton said the sto-

ries the committee heard "paint a difficult picture" for women in the military. Accounts of bullying, harassment, discrimination, "laddish" behaviour, and sometimes serious sexual assault and rape were among

the complaints.

The complaints system, as it stands, is woefully inadequate and leaves most feeling unable to come forward. We also heard accusations of senior officers sweeping complaints under the rug to protect their own reputations and careers. While many commanding officers want to do the right thing, it is clear that, too often, female service personnel are being let down by the chain of command," she added. The Sub-Committee recommends that the MoD create a specialised Defence Authority to handle BHD complaints and that the MoD better resource the Complaints Ombudsman and make their decisions binding.

Global coronavirus caseload tops 193.6 mn

 $T^{\text{he overall global Covid-19}}_{\text{ caseload has topped 193.6}}$ million, while the deaths have surged to more than 4.15 million and vaccinations soared to over 3.81 billion, according to the Johns Hopkins University.

In its latest update on Sunday morning, the University's Center for Systems Science and Engineering (CSSE) revealed that the current global caseload, death toll and the total number of vaccine doses administered stood at 193,633,246, 4,151,311 and 3,815,028,866, respectively. The US continues to be the

worst-hit country with the world's highest number of cases and deaths at 34,426,844 and 610,833, respectively, according to the CSSE. In terms of infections,

India follows in the second place with 31,332,159 cases. The other worst countries



with over 3 million cases are Brazil (19,670,534), France (6,041,146), Russia (6,025,698), the UK (5,694,163), Turkey (5,574,997),Argentina (4,839,109),Colombia (4,716,798), Italy (4,312,673), Spain (4,280,429), Germany (3,761,869), Iran (3,664,286) and Indonesia (3,127,826), the CSSE figures showed.

In terms of deaths, Brazil comes second with 549,448

Nations with a death toll of over 100,000 are India (420,016), Mexico (237,954), Peru (195,243), Russia (150,583), the UK (129,416), Italy (127,942), Colombia (118,538), France (111,800) and Argentina (103,584).

French President Macron calls Israeli PM Bennett on allegations of snooping

French President Emmanuel Macron has spoken to Israeli Prime Minister Naftali Bennett on reports that Morocco's security forces may have used the Pegasus spyware to snoop on his cellphones, according to a media report.

A global media consortium last week reported that 50,000 cellphone numbers were being spied on using the Pegasus malware, which has been developed by Israeli cybersecurity company NSO Group. The mobile phones of French President Macron and 15 members of his government may have been among potential targets, according to a member of the media consor-

Macron Bennett on Thursday and asked him to ensure that "the issue was being taken seriously", Israel's Channel 12 reported on Saturday evening.

The Israeli Prime Minister said that the allegations are from a period when he had not assumed office but gave an assurance that the required conclusions on the matter will be reached upon.

Macron had called an urgent national security meeting on Thursday to discuss the Pegasus spyware after reports about its misuse in France emerged.The Moroccan government has denied reports that the country's security forces used the spyware to eavesdrop on the French President. Similarly, the NSO Group has denied that the French President was targeted.

We can "specifically come out and say for sure that the President of France, Macron, was not a target," Chaim Gelfand, Chief Compliance Officer at NSO Group, told Israeli television network i24news on Wednesday.

California's largest fire torches homes as blazes burn West

 $F^{\text{lames racing through}}_{\text{rugged terrain in Northern}}$ California destroyed multiple largest wildfire intensified and numerous other blazes battered the US West.

The Dixie fire, which started July 14, had already levelled over a dozen houses and other structures when it tore through the tiny town of Indian Falls after dark. It was burning in a remote area with limited access, hampering firefighters' efforts as it advanced eastward, fire officials said.

The blaze has charred more than 181,000 acres (73,200 hectares) in Plumas and Butte counties and prompted evacuation orders in several small communities and along the west shore of Lake Almano, a popular getaway. The fire was 20% contained as of Saturday night.

Meanwhile, the nation's largest wildfire, southern Oregon's Bootleg fire, was near-



halfway surrounded Saturday as more than 2,200 crew members worked to corral it in the heat and wind, fire officials said. The growth of the sprawling blaze had slowed, but thousands of homes remained threatened on its eastern side, authorities said.

"This fire is resistant to stopping at dozer lines," Jim Hanson, fire behaviour analyst, said in a news release from the Oregon Department of Forestry. "With the critically dry weather and fuels we are experiencing, firefighters are having to constantly reevaluate their control lines and look for contingency options."

In California, Gov. Gavin Newsom has declared a state of emergency for four northern counties because of wildfires that he said were causing "conditions of extreme peril to the safety of persons and property." The proclamation opened the way for more state support.

Such conditions are often from a combination of unusual random, short-term and natural weather patterns heightened by long-term, human-caused climate change Global warming has made the West much warmer and drier in the past 30 years.

Tens of thousands march for LGBTQ rights at Berlin parade

Around 65,000 revellers marched for LGBTQ rights at Berlin's annual Christopher Street Day celebration on Saturday, more than three times as many as expected.

It was the biggest demonstration in Berlin since the start of the coronavirus pandemic.

The parade started with a call from Klaus Lederer, Berlin's senator for culture, to make the city a "queer-freedom zone" in response to deteriorating safety for gays and lesbians in Hungary and neighbouring Poland.

"LGBT-free zones" have been declared in parts of Poland, while Hungary recently passed a law banning the depiction of homosexuality or gender reassignment to minors that has been denounced as discriminatory by human

Lederer said the situation

in the two EU members "sends shivers down my back. The senator also noted that the pandemic had been particularly hard for some gays and

still much work to be done." Police spokesman Martin Dams initially told The Associated Press that an estimated 35,000 people were taking part in the parade, but this figure was revised upwards later Saturday. Organizers put the figure at 80,000.

There was no parade last year due to the pandemic so many people took advantage of the warm sunny weather.

CBIC does away with renewals of licences

New Delhi: The Central Board of Indirect Taxes and Customs (CBIC) has abolished the requirement of periodic renewal of licence and registration issued to Customs Brokers and Authorised Carriers.

This move is expected to help reduce the compliance burden cast on the trade, which had to otherwise file applications and submit numerous documents to renew their licences/registrations.

The changes have been made effective from July 23,

The net effect of the amendments carried out to the Customs Brokers Licensing Regulations, 2018 and Sea Cargo Manifest and Transhipment Regulations, 2018, is that the existing licenses/registration would have a lifetime validity.

Another change that has been introduced is to allow a licensee/registration holder to voluntarily come forward to surrender his licence/registration. Also, a provision has been made to invalidate licences/registrations that are

inactive for more than a year.

These steps would prevent misuse of dormant licences/registrations by unscrupulous persons who mis-declare import or export or wrongly obtain export refunds/incentives and when caught, put the burden on the original licensee/registration holder, a Finance Ministry statement said.

At the same time, the interest of genuine trade is safeguarded by empowering the Commissioners of Customs to revalidate the licence/registration in case the inactivity is for

The life-long validity of licences/registrations is expected to provide a major relief to the trade by reducing their compliance burden and promoting ease of doing business in India.

Removing the requirement seeking periodic renewals also reduces the interface between the Customs and the trade, which is a deliverable of the CBIC's 'Contactless Customs' initiative, a critical component of its flagship Turant Customs programme. IANS

With as many as 28 per cent Indians planning to travel in August-September, which is also the time for some of the major festivals in the country, the risk of the third wave of the pandemic is set to rise, according to a survey.

The survey received over 18,000 responses from citizens residing in 311 districts, with 68 per cent of respondents men and the rest women.

LocalCircles said 28 per cent citizens are planning to travel during August-September though only five per cent have made their bookings. It added that during the second wave of the outbreak, many citizens faced teething issues to cancel their travel plan for the

On an aggregate basis, if the data of those planning to trav-el in August-September is analysed, it indicates that 54 per cent plan to "visit family and friends", 26 per cent will be travelling to "holiday destinations", and 32 per cent will be undertaking other kinds of travel, according to the statement.

In summary, with the decline in daily COVID-19 caseload, 28 per cent citizens plan to travel in August-September. As indicated by the findings of the survey, 23 per cent of citizens plan to travel in the next two months, though they haven"t booked their tickets yet and only 5 per cent of citizens surveyed have booked their tickets and accommodation, it stated.

Of those who are planning travel, the majority of 54 per cent citizens are planning to meet their friends and family, while 26 per cent plan to travel to a holiday destination, LocalCircles said.

biodiesel from chicken waste

PTI WAYANAD (KERALA)

After waiting for more than seven years, John Abraham, a veterinary doctorturned-inventor, has finally received the patents for inventing biodiesel from slaughtered chicken waste that offers mileage of over 38 km a litre at around 40 per cent of the current price of diesel and lowers pollution by half.

After seven-and-a-half years, the Indian Patent Office finally granted us the patent on July 7, 2021, for inventing biodiesel produced from rendered chicken oil', Abraham, an associate professor at the veterinary college here under the Kerala Veterinary & Animal Sciences University, told PTI from Wayanad.

The invention is an outcome of his doctoral research at the Namakkal Veterinary College under the Tamil Nadu Veterinary & Animal Sciences University.

He said the patent was delayed as permission from the National Biodiversity Authority was needed because the key raw material going into the patented invention was a biological material locally sourced.

During 2009-12, Abraham pioneered research on pro-ducing biodiesel from the

slaughter waste of broiler chicken and dead poultry birds. He completed the research under the guidance of the late Prof Ramesh Saravanakumar (passed away awaiting the patent in November 2020), who had filed for the patents in 2014 on behalf of the Tamil Nadu Veterinary & Animal Sciences University, Abraham

After his research, Abraham joined the Pookode Veterinary College, near Kalpetta in Wayanad, and in 2014 he set a Rs 18-lakh pilot plant at the college campus with funding from the Indian Council for Agricultural Research.

Following this, Bharat Petroleum's Kochi Refinery in April 2015 had issued a quality certificate for the biodiesel he invented and since then a college vehicle was being run on this fuel only, he said.

When asked why chicken waste, he said birds and pigs have single stomach which offer higher fat saturation and this is easy to render oil under room temperature.

Three of his students and

Abraham are now working on developing biodiesel from pig

He said 100 kg of chicken waste, procured from slaughter

houses for which he gets paid up to Rs 7 a kg, can produce 1 liter of biodiesel, which offers over 38 kmpl and can be sold at 40 per cent of the diesel price

The higher mileage and lower pollution is due to the fact that chicken waste contains 62 per cent fat, offering the key energy content of Cetane at 72, while in normal diesel it is only 64. It also increases engine efficiency by 11 per cent due to the presence of more oxygen, and reduces smoke levels by over 47 per cent, Abraham said.

The high Cetane value of 72 in animal fat bio-diesel leads to shorter ignition delays, providing more time for fuel combustion, leading to more efficiency and less exhaust emission, he explained.

On blending side, he said, for old diesel engines his biodiesel can be blended at a ratio of 80:20, while for new CDREi engines, it the reverse-

About commercialisation, he said a team from Hindustan Petroleum visited him last Friday, adding after the lockdowns he and the HPCL team would meet the Tamil Nadu veterinary university to negotiate the commercials as the patent is granted to the varsi-

India's gold imports surge in Apr-Jun, silver imports fall

 \mathbf{I} ndia registered a manifold raise in import of gold during the first three months of FY22 on a year-on-year basis, to nearly \$7.9 billion.

This rise in gold imports can be attributed to low imports during the same peri-od last year owing to the nationwide lockdown and the revived consumer demand in this financial year. During the same period

last fiscal, gold imports stood at \$687.83 million. As per data from the Commerce Ministry, import of the vellow metal in July also registered a nearly 60 per cent rise to \$969.87 million. Silver imports, however, have declined this fiscal.

During Q1FY22, silver imports stood at \$39.39 million, 93.15 per cent lower than in April-June FY21. In June, silver worth \$11.83 million was imported, against \$137.22 worth of the metal imported during the same month last fiscal.

India, a major importer of gold, exports gems and jewellery. In April-June, gems and jewellery worth \$9.17 billion was exported, 244.29 per cent higher on a year-on-year basis.

E-commerce rules: CAIT says draft norms to end crony capitalism

Pandemic-hit Govt finances to get crude shock as crude set to get more expensive

m pl}$ oil market may not present an advantage to India as it provided during the pandemic-hit fiscal 2020-21, the countrys oil import bill in the first three months of current fiscal has increased close to three times to reach scales not seen in past few years.

As per recent numbers on oil trade, the country's oil import bill has risen to \$24.7 billion in the April-June quarter 2021-22, a whopping growth of over 190 per cent over \$8.5 billion worth of imports made in Q11 of the last fiscal year FY21.

And the high growth in oil bill during the first three months may just be the beginning as crude is set to get more expensive in coming months with a rise in global demand and falling inventory levels of the US.

This despite the oil cartel OPEC agreeing to raising crude production by 400,000 barrels per day stating August to increase production by 2 million barrels a day by the end of the year.
"The way the oil market is

giving signals now, crude may remain range bound between \$70-75 a barrel this fiscal. This could add significant jump in the country's oil import bill as

average crude oil purchase price stood at mere \$45 a barrel in FY21 and May be above \$70 a barrel in FY22," an oil sector expert from one of the four largest global consultancy firms said on the condition of anonymity.

If the projections for average crude prices to be over \$70 a barrel in FY22, the country's oil import bill could once again shoot above the \$100 billion mark. It last remained at that level in FY20 at \$101.4 billion.

The government received big advantage of softer oil prices in the pandemic hit FY21 when it had to pay just \$62.7 towards oil import bill with overall import quantity also sliding with demand as lockdowns eroded demand. This also helped the government to raise level of taxes on auto fuels petrol and diesel and earnings from there contributed significantly towards Covid-19 relief and stimulus measures that the Centre announced in FY21.

The problem of higher imports at expensive prices is already becoming real this year. The first quarter over 190 per cent growth in import bill is based on average crude price of \$67.5 a barrel. If the projections for crude at \$70 a barrel stays, the import bill will be even higher in Q2 and the remaining months of the year.

RBI's central board short of 9 non official directors

The central board of the Reserve Bank of India (RBI) is facing shortage of nine non-official directors, including seven from the category of people of eminence from various fields.

The central board is the highest decision making body of the apex bank headed by the RBI Governor. According to the RBI Act,

the Government nominates 10 eminent persons from various fields to the central board of the RBI, besides four directors (one from each of the four local boards). The Government is yet to appoint seven non-official directors from the category of people of eminence from various fields while representations from local board from western and southern areas are missing. Currently, only three emi-

nent personalities -- Tata Sons Natarajan Chairman Chandrasekaran, seasoned banker S K Marathe and chartered accountant and RSS ideologue Swaminathan Gurumurthy -- are serving the central board. They are nominated under Section 8(1)(c) of the RBI Act, 1934, according to the RBI's website.

About 90% Indian consumers willing to pay a premium for purchase of EV: Survey

With global electric vehicles (EVs) sales expected to boom in the next 12 months, nearly 90 per cent of consumers in India are willing to pay a premium for buying an EV, according to a survey by consultancy firm EY.

The EY Mobility Consumer Index (MCI), a survey of more than 9,000 respondents from 13 countries, including 1,000 respondents from India, also found that 40 per cent of the respondents were ready to pay a premium of up to 20 per cent. The survey concluded in the second half of July.

"Among the car buyers in India, 3 in 10 respondents would prefer to buy an electric/hydrogen vehicle," the survev said. A majority of the respondents surveyed in India consider a driving range of 100 to 200 miles from a fully charged EV, EY said. It further said, "Nearly 90

are willing to pay a premium for buying an EV and over 40 per cent of respondents are ready to pay a premium of up to 20 per cent. Existing and future EV owners, who intend to buy a car, have a relatively higher

compared to the existing and future ICE owners.

Commenting on the findings, EY India Partner and Automotive Sector Leader Vinay Raghunath said, "The reducing gap in cost of ownership between electric and other technology platforms and the increasing segment of consumers vocal about environmental impact will drive a fundamental change in consumer buying behaviour for electric vehicles.'

He further "Consumers are willing to pay extra for an added value of being environmentally responsible."

According to the survey, the top reason for buying an EV is environmental concern, with 97 per cent also stating that the COVID-19 pandemic has heightened awareness and concerns about environmental issues. About 67per cent of those looking to buy an EV feel it is their responsibility to reduce their personal environmental impact, and 69 per cent feel buying an EV is one way to achieve this goal.

When it comes to charging, the survey found that "nearly a third of the existing EV owners expect vehicle charging to take less than an hour compared to 45 per cent of the respondents who are planning to buy an EV".



MATURE CATARACT ON THE RISE

he number of cases of dry eyes and digital eye strain has gone up during the pandemic period, said a top official of Dr Agarwal's Eye Hospital

The cases of digital eye strain and dry eyes seen a significant rise as a result of excessive exposure to light-emitting digital screens as people adapted to work-fromhome and study-from-

home scenarios, said Dr Amar Agarwal, Chairman.

According to him, the cases of matured cataracts surged from 10 per cent of the total cataract cases in the last quarter of 2019 to over 50 per cent during the same period

Citing an internal study conducted in 2020, he said that the delay in seeking medical interventions during the first wave of the pandemic - due to lockdown restrictions or fear of infection risks, had severely deteriorated the eye

conditions of many patients. Hence, without ignoring any eye issue, patients should seek medical intervention at the earliest.

GLOBAL WARMING MAY LIMIT SPREAD OF DENGUE

lobal warming could limit the spread of dengue fever but Gould also affect Wolbachia as a biological control agent, according to new research. Researchers, at the Pennsylvania State University in the

US, found that infection with the bacterium Wolbachia. which has recently been used to control viral infections in mosquitoes, also increases the thermal sensitivity of the insects. Wolbachia have been shown to prevent viruses,

point to increasing frequencies of extreme temperature events, making short


exposures to high temperatures a threat to the survival of dengue and Wolbachia infected mosquitoes, the researchers "At lower temperatures, we know that dengue virus

HYPERTENSION, DIABETES AMONG TOP NCDS

he Associated Chambers of Commerce and Industry of India (ASSOCHAM), as part of its 'Illness to Wellness' campaign, unveiled India's largest primary healthcare survey report on the rising burden of non-



The report titled Non-Communicable Diseases in India covered 2,33,672 people and 673 public health offices in 21 states to analyse the rising cases of NCDs in the country and the social profile of suffering households.

Report prepared by Thought Arbitrage Research Institute (TARI), the survey report observed that India's noncommunicable disease burden is growing at an alarming rate with the average age for onset falling sharply.

It reported that NCDs increase after 18 years and show a quantum leap when an individual crosses the age of 35 years. It found that more than 2/3 of the individuals suffering from NCDs are in the most productive-life age groups i.e., between 26-59 years. This is an alarming trend and points to



The Ganga river is polluted with multiple kinds of plastic, I with the highest concentration at Varanasi, and microplastics samples being found at Haridwar, Kanpur and Varanasi, a new study by Toxics Link has found.

Micro-plastics are defined as plastics less than five mm in length and recognised as a major source of marine pollution due to their persistence, ubiquity and toxic



Plastic products and waste material released or dumped in the river break down and are eventually reduced to micro particles and the river finally transports significantly large quantities downstream into the ocean which is the ultimate sink of all plastics being used by humans.

"Essentially all along micro-plastics are flowing into the river system. It does reflect or suggest a direct linkage between the poor state of both solid and liquid waste management; hence, it is critically important to initiate steps to remediate it," said Priti Mahesh, Chief Coordinator at Toxics Link.

Tokyo: Six-time world champion M C Mary Kom (51kg) powered into the Olympics' prequarterfinals with a superb tactical victory over Dominican Republic's Miguelina Hernandez Garcia but Manish Kaushik's (63kg) Games debut ended in disappointment following a hardfought opening-round loss on Sunday.

The 38-year-old Mary Kom, who is a 2012 Olympic Bronze-medallist and a multiple-time Asian champion, prevailed 4-1 against a rival who is 15 years her junior and a Pan American Games Bronze-medallist.

But Manish, a Commonwealth Games Silver-medallist and a world championship Bronze-winner, went down 1-4 to Britain's Luke McCormack in an edge-of-the-seat clash.

Mary Kom was the first to step into the ring and in a bout that was also exciting from start to finish, the Manipuri displayed some brilliant tactics to overcome the fight that Garcia put up.

She will next be up against third-seeded Colombian Ingrit Valencia, who was a Bronzemedallist at the 2016 Rio Games.

Mary has beaten the Colombian both times the two have faced, including the 2019 world championship quarterfinals.

T have all the medals in my hand. Olympic medal (Bronze) from 2012, Commonwealth Games Gold, six-time Gold at world championships. It's not easy to count them, but the difficult part is continuously winning and performing, it's not easy," she said.

Manika rises to the occasion

Manika Batra made a stunning comeback against world number 32 Margaryta Pesotska to reach the women's singles third round but G Sathiyan succumbed to the pressure on his Olympic debut to exit the men's singles competition on Sunday.

While the 26th seed Sathian was expected to beat world number 94 Hong Kong's Siu Hang Lam in his second round match after getting a first round bye, the same cannot be said about Manika, whose gritty approach under pressure proved decisive against her higherranked opponent from Ukraine.

Manika, ranked 62, made a remarkable comeback after losing the first two games to prevail 4-11, 4-11, 11-7, 12-10, 8round match that lasted 57

Govt exempts Olympic returnees from RT-PCR test

Tokyo: Athletes, officials and media returning to the country from Tokyo Olympics will not be required to produce RT-PCR negative test reports for Covid-19 before their departure from Tokyo, the Government of India said on Sunday.

The decision was intimated in an official letter by Lav Agarwal, Joint Secretary in the Ministry of Health and Family Welfare after the Indian Olympic President Narinder Batra had earlier in the day requested the Government to exempt returnees from the Tokyo Games to produce RT-PCR negative report before boarding their flights.

The Health Ministry official, however, said that only those individuals who have returned negative in the saliva-based test prior to their departure to India will be allowed to board the flight. Besides, all those returning from Tokyo will be retested upon landing in India.
