'2/3rd Indians have Covid antibodies'

40 crore people are still at risk, says sero survey by ICMR

PNS NEW DELHI

 $T^{\text{he fourth round of the}}_{\text{national sero survey conducted by the Indian Council}}$ of Medical Research (ICMR) that covered 70 districts across 21 States in June-July showed that two-thirds of the country's population aged above six has developed antibodies against the coronavirus. The findings imply that a third of the population did not have antibodies against the Covid-19 which means that about 40 crore Indians are still vulnerable to the virus.


Releasing the findings of the survey, the Director-General, ICMR, Dr Balram Bhargava, said on Tuesday that the latest national sero survey included children between six and 17 years of age and it was found that two-third of the general population, i.e., above the age of six years had SARS-CoV-2 infection. This was first time that children above six years were included in national sero prevalence survey. The highest sero-prevalence was

found in the age group 45-60 years (77.6 per cent), followed by those above 60 years (76.7 per cent) and those in the age group 18-44 years (66.7 per cent). In the survey, children were divided into two age groups: 6-9 years and 10-17 years. Sero-prevalence in the 6-9 years category was 57.2 per cent and in the 10-17 years category, it was 61.6 per cent.

Dr Bhargava said implications of the fourth sero survey clearly showed that there was a ray of hope, but no room for complacency. "We must maintain Covid-appropriate behaviour and community engagement. The national-level sero survey is not a substitute of the State/district-level sero sur veys," he added.

K'taka netas were spied upon Pegasus snooped just before JD(S) Govt fell: Report

The third part of the Pegasus telephone snooping report released on Tuesday showed that ahead of the toppling of the Congress-JD(S) Government in Karnataka, telephones of several important leaders of the ruling alliance and their staffers were under surveillance. These include the likes of Deputy Chief Minister G Parameshwara and the personal secretaries of Chief Minister HD Kumaraswamy and former Chief Minister Siddaramaiah.

Former Prime Minister and JD(S) president HD Deve Gowda's security officer Manjunath Muddegowda's phone number was also targeted for snooping.

The report published by
The Wire portal suggested

that the surveillance took place during July 2019, when the BJP was planning to top-ple HD Kumaraswamy's coali-Government in tion Karnataka.

The BJP's operation to topple the JD(S)-Congress bore fruit with the defection of 17 MLAs during this period. The report also said that this period also coincides with the selection of a new phone number that Congress leader Rahul Gandhi used after discarding an earlier one he had been operating, and which had been on the

prised to know that Pegasus compromised my phone when I was Deputy Chief Minister and that of Siddaramaiah and the Chief

Minister's secretary.

The snooping activity by

I condemn this... They have misused their power to topple Governments in this country," said Parameshwara.

The phone number of former Congress Chief Minister Siddaramaiah's personal secretary Venkatesh was also added in same period. Sources close to Siddaramaiah said that former Chief Minister hasn't been using a personal phone for many years, and relies on his aides for phone conversations.






Paris: Prosecutors in Paris said Tuesday that they had opened a probe into allegations that Moroccan Intelligence services used the Israeli surveillance software Pegasus to spy on several French jour-

The investigation will examine 10 different charges, including whether there was a breach of personal privacy, fraudulent access to personal electronic devices, and criminal association. Investigative website Mediapart filed a legal complaint on Monday over the spying claims, which Morocco has denied, and the satirical weekly Le Canard Enchaine has said it plans to do so as well. A collaborative investigation by The Washington

Post, The Guardian, Le Monde and other media outlets, based on a leaked list of 50,000 phone numbers, claimed Monday that spying worldwide using the technology from the NSO Group had been far more extensive than previously thought.

Mediapart revealed that the phones of its founder Edwy Plenel and one of its journalists were among those targeted by Moroccan intelligence services. In an article published Monday, it said that Morocco had "violated the privacy of two journalists, undermined the profession of informing people and the freedom of the media, stolen and exploited personal and professional

Global tender for six desi submarines worth ₹50K cr floated

Tn a major boost to indigenisation, the Government on Tuesday floated a global tender for construction of six submarines in the country. These submarines will be built under the Strategic Partnership (SP) model where in Indian manufacturers will tie up with foreign builders for production here. The deal is worth over Rs 50,000 crores.

The Defence Acquisition Council (DAC) chaired by Defence Minister Rajnath Singh in June this year had approved the floating of the tender. The public sector Mazagaon Docks Limited (MDL) and private player Larsen and Toubro were selected for the mega project.

They will now tie up the foreign original equipment manufacturer (OEM) to build



the diesel powered submarines within the country. Five global giants are in the race for bagging the big-ticket deal.
Giving details of the latest

order, Defence Ministry officials said here on Tuesday the Government has issued Request of Proposal (RFP) or tender for the first acquisition programme under the Strategic Partnership Model for con-struction of six air independent propulsion (AIP) fitted Conventional Submarines named Project 75(India) [P-

PM on Covid fight: All Govts must work as team | SC terms Kerala Govt's Rise above politics, Modi says as Cong skips all-party meet

PNS NEW DELHI

With some Opposition parties, including the Congress, skipping an all-party agement, Prime Minister Narendra Modi on Tuesday called for the Centre and States to work together as a team and rise above politics to combat the pandemic.

Speaking at the meeting called by the Central Government, Modi said India was in a better position than many other countries in terms of the ratio of the population hit by the disease but underlined the need to remain vigilant as he cited the resurgence of the infection in some countries like the UK. He said vaccines from more companies are likely to be available in some time and spoke about the push being given by the Government to vaccination.

The PM said that the pandemic should not be a matter of politics and is a matter of

concern for entire humanity. He added that mankind hasn't seen such a pandemic in the last 100 years. He also spoke about the efforts being made to ensure one oxygen plant in every district across the coun-

Modi informed leaders about the rising speed of India's vaccination programme and how the first 10 crore doses took around 85 days while the last 10 crore doses have taken just 24 days. He also informed the leaders that the daily closing stocks show an average of more than 1.5 crore vaccines at the end of the day throughout

the country. Modi stressed the need to properly plan the vaccination drives at the district-level based on the advance availability

indicated by the Central Government to ensure no inconvenience to the people. The PM said that it is a

matter of concern that a significant number of healthcar workers and frontline workers are yet to get the vaccine even after six months of the commencement of the inoculation drive and added that States need to be more proactive towards this.

He also spoke about the need to stay vigilant looking at the situation in various countries. Modi added that mutations make this virus very unpredictable, and hence "we all need to stay together and fight this disease."

Earlier, as the Congress disrupted the Parliament proceedings for the second-day and took potshots at the Government's Covid-19 management, Modi accused the Opposition party of "spreading lies" and "politicising" the Covid-19 pandemic and asked the party MPs to counter it.

Kundra 'key conspirator'

relaxations for Bakrid 'wholly uncalled for'

 $T^{\text{he Supreme Court on}}_{\text{Tuesday termed "wholly}}$ uncalled for" the Kerala Government's relaxations for Eid-al-Adha (Bakrid) in areas with high Covid-19 positivity rate and said giving in to pressure from traders discloses a 'sorry state of affairs".

Pressure groups of all kinds, religious or otherwise, cannot in any manner interfere with the most precious fundamental right to life of all the citizens of the country, the apex court said.

The apex court directed the Kerala Government to give heed to Article 21 (protection of life and personal liberty) of the Constitution and follow the law laid down in its orders passed in Uttar Pradesh

Kanwar Yatra matter. While hearing the Uttar



Pradesh Kanwar Yatra matter on July 16, the top court had observed that all sentiments, including religious, are sub-servient to the Right to Life. A Bench of Justices RF Nariman and BR Gavai noted it is "extremely alarming" that in category D areas, where infection is the highest at 15 per cent, a full day of relaxation was granted in Kerala on Monday.

Bezos has a blast in space with young and old alike

Teff Bezos blasted into space Tuesday on his rocket company's first flight with people on board, becoming the second billionaire in just over a week to ride his own spacecraft. The Amazon founder was accompanied by a hand-picked group: His brother, an 18-year-old from the Netherlands and an 82-year-old aviation pioneer from Texas — the youngest and oldest to ever fly in space.
"Best day ever!" Bezos said

when the capsule touched down on the desert floor at the end of the 10-minute flight. Named after America's first astronaut, Blue Origin's New Shepard rocket soared from remote West Texas on the 52nd anniversary of the Apollo 11 moon landing, a date chosen by Bezos for its historical significance. He held fast to it, even as Virgin Galactic's Richard e Modi Ministry.

Ckeletons began tumbling Out of the arrested businessman Raj Kundra's closet on Tuesday, as the police told a city court that Kundra and his brother-in-law Pradeep Bakshi were allegedly involved in the streaming of pornographic videos through an app called "Hotshots".

A day after they arrested actress Shilpa Shetty's husband Raj Kundra in connection with the alleged racket involving the making of pornographic content, the Mumbai crime branch sleuths named him as a "key conspirator" and Bakshi Continued on Page 11 | as co-conspirator involving the

creation and publication of pornographic films through some apps.
Simultaneously, the inves-

tigators arrested Kundra's aide Ryan John Tharpe, a techie who looked after Kundra-Shetty's companies, from Nerul in Navi Mumbai, for his alleged role and involvement in this

pornographic scam. Kundra and Ryan were produced before a Mumbai court which remanded them in police custody till July 23. With the arrest of Kundra

and Ryan, the number of arrests made in the scam involving the creation and cir-culation of pornographic content has gone up to 12.

The crime branch sleuths

told the court that the role of Kundra, Ryan and Bakshi came to light after they arrested nine persons, including Gahna Vashisht and Umesh Kamat. Gahna and Kamat were both involved in producing and shooting porn, writing scripts; they also sent copies of their scripts to Kundra.

Kundra is the owner of Viaan Industries Ltd, jointly promoted by the couple, while Bakshi — a British citizen, who is married to Kundra's sister - is the Chairman of Kenrin Ltd., London.

SC seeks reply of **Manipur Govt on** compensation to released activist

PNS NEW DELHI

The Supreme Court on Tuesday asked the Manipur Government to file its response on granting compensation to political activist Leichombam Erendro, who was released last evening from detention after being booked under the National Security Act for having criticised BJP leaders on the use of cow dung and urine as cures for Covid-19.

A bench of justices DY Chandrachud and MR Shah told Solicitor General Tushar Mehta that it was a serious issue as someone lost his liberty since May and the petitioners have prayed for a grant of compensation to Erendro for detention. The bench said it was issuing notice to the State Government and posted the matter for further hearing after two weeks.

Yogi slams Oppn for uproar in Parl over Pegasus spying scandal



hief Minister Yogi Adityanath attacked opposi-Ction parties over the uproar over the Pegasus espionage scandal in Parliament, saying that the opposition leaders were engaging in negative politics and bringing disrepute to the country.

Addressing a press conference in Lucknow on Tuesday, the chief minister said, "The opposition has become a part of a conspiracy to defame India. Similar conspiracy was hatched during the India visit of former US President Donald Trump. The opposition is defaming democracy as well. This is part of a bigger conspiracy where such fabricated allegations are made even before the commencement of the session of Parliament."

Yogi further said, "Farmers issues and coronavirus catastrophe are to be discussed in this session of Parliament but the opposition is bent on disrupting the session. This is an insult to democracy. This malicious thinking of the opposition to defame the country will never succeed."

Slamming the Congress, the chief minister said that when the US President came to India, riots were

planned at that time.

"All this is an attempt to disturb the country. The opposition is maligning the image of the country. They do not want the people of the backward society of the country to come forward. This is the reason that when ministers from Dalit and Backward Classes were to be introduced on the first day of Parliament session, there was a lot of uproar. They are misleading the farmers but these people will never succeed in their cause," he added.

Yogi said that he had been a member of Parliament for 19-20 years and it was a tradition for the prime minister to introduce the new ministers

to the House at the beginning of the session.
"The opposition did not allow the prime minister to introduce leaders from deprived sections who have been made ministers. The opposition should tell the people as to why they did not allow the proper introduction of ministers," he said.

Referring to the ongoing farmers' protest, the chief minister said that the agitation had also been turned into a protest against India due to the oppo-sition's negative politics. "The people of India will respond in the same manner as they did in 2019,"

'RESOLVE PROBLEMS OF STATE EMPLOYEES

Whether it is the issue of pay discrepancy, delay in promotion or any other problem related to the government employees, they will be resolved without any delay as Chief Minister Yogi Adityanath has directed that one day of the week will be reserved for redressal of such issues in government departments.

"In every office, high officials should take cognisance of the problems and complaints of employees for one hour a day in a week. Reserve the last one hour of the office hours of the day to resolve these issues," Yogi said in a high-level meeting held at Lok Bhawan on Tuesday.

Focused sampling to prevent third wave 70 new +ve cases in UP

Indiranagar and surrounding areas, which recorded over 16,172 cases in the second Covid wave, is gearing up to prevent the devastation in the third wave. Superintendent of Indiranagar CHC Dr Rashmi Gupta said focused sampling is being carried out in the hotspot areas on a daily basis to ensure that the local areas which had the second highest Covid cases in the second wave could be able to prevent the third wave. She said they have identified 6-7 hotspots where they are maintaining

She said that the total population sne said that the total population coming under the Indiranagar CHC is around 4,17,912 and the number of vaccine doses administered since January 16 is 1,32,750. Talking about the second wave, she said: "It was a situation where every house had patients. We are where every house had patients. We are now carrying out focused testing in all the 6-7 hotspots which we have identified. Focussed sampling is being carried out in the residential apartments and in A, B & C blocks which are adjacent to Bhoothnath market."

She said they have 11 teams that have been sent for the targeted sampling on a daily basis. "We have not had a single case in the past four to five days. One case was detected today and the patient had been to Uttarakhand. We have sent teams for contact tracing," Dr Gupta said. Regarding why cases were high in both the first and second waves, she said the area has a large number of senior citizens whose children are settled out-



immunity as compared to those living in slum areas. Also, there is a lot of movement of children of these residents through air, rail or bus which makes them more vulnerable," she pointed out.

She said they were trying to have a maximum coverage in terms of testing. 'This, despite the fact that we are facing challenges when health workers reach the houses of people and they say side. "These people may have lesser that they don't want to get tested and

they do not require testing," Dr Gupta said. Dr Gupta said they were also carrying out vaccination to prevent or delay

the third wave as much as possible.

"If we get sufficient doses, we would be able to vaccinate more than 600 people at the CHC itself because we have the rapid response teams and also the vaccinators. We would also get the vaccination done at the 7 primary health centres (PHCs) which we

minimum of 200 vaccinations can be carried out at each of these centres if we have more vaccines," she said.

Dr Gupta said nigrani samitis are also active and they give information regarding the residents having cough and other health problems, and the CHC then sends the rapid response teams to give them medicines. "These teams are also distributing medicines for children since it has been predicted that the are likely to be the worstaffected in the third wave," she added.

Meanwhile, a free vaccination camp was organised at CSIR-CIMAP on Monday. "To ensure immunisation and safety of scientists, staff, research scholars and project staff against Covid-19, the Central Institute of Medicinal and Aromatic Plants scheduled a free vaccination camp in scheduled a free vaccination camp in which around 300 people were vaccinated. The camp was organised for maximum immunisation of the institute employees and the support was provided by BRD Hospital, Mahanagar," CIMAP director Dr Praboth Kumar Trivedi said.

Meanwhile, teams from the district administration and Health department are applying the T3 formula (testing, tracking and treating) at all the transit points such as airports, railway stations and bus stations. Seventy new cases of coronavirus infection were reported in Uttar Pradesh during the last 24 hours while 155 infected persons recovered, according to Additional Chief Secretary (Information) Navneet Sehgal.

At present, the number of active cases of coronavirus infection in the state is 1,093. In the last 24 hours, 2,36,546 Covid tests were conducted in the state. So far, a total of 6,28,26,817 Covid tests have been conducted in the state. The recovery rate of coronavirus infection in the state is 98.6 per cent. Chief Minister Yogi Adityanath, who reviewed the COVID-19 situation in the

state on Tuesday, said that due to the active efforts of the state government, the coronavirus epidemic had been effectively controlled. It was informed in the meeting that there is not a single patient of COVID-19 in Shravasti, Sant Kabir Nagar, Mahoba, Lalitpur, Hathras and Aligarh districts. These districts are free from coronavirus infection. No new cases of coronavirus infection have been found in 41 districts, while in 33 districts fresh cases are in

single digit. It was also informed in the meeting that more than 98 lakh Covid vaccine doses have been given so far in the month of July. So far, more than 4,10,51,000 vaccine doses have been given in the state.

Elaborate security arrangements for Eid-ul-Azha

 $E^{\text{laborate security arrangements have been made}}_{\text{in the wake of Eid-ul-Azha on Wednesday. A}}$ meeting to review arrangements for law and order and traffic movement was held under the chairmanship of Commissioner of Police DK Thakur.

A spokesman said two officers of additional deputy commissioner rank, an assistant commissioner of police, two additional superintendents of police, four deputy superintendents of police, four companies of PAC, one platoon of paramilitary force, 10 inspectors of commissionerate police, 50 subinspectors, 172 head constables/constables and 15 women constables have been deployed for the west zone of Lucknow commissionerate. Besides, quick response & polygon teams and mounted police will also be deployed.

The police earmarked the sensitive places in the city and the deployment will be made accordingly. The west zone has been earmarked as sensitive and senior police officers will be keeping a close watch on the minutest of developments.

The police have been asked to ensure Covid pro-

tocol and remain in contact with the district administration. "People celebrating Eid-ul-Azha have been asked not to assemble in a group of over more han 50 at a place at a time wh (qurbani) should be done at houses instead of public places," the spokesman said.

The police have been asked to remove remains or vestiges of the sacrificed animals immediately and on the same day by coordinating with the district administration.

Earlier, the commissioner of police held a meeting with senior officers, including the joint commissioner of police (law and order), DCPs of all the five zones, DCP (Traffic) and DCP (Intelligence), and asked them to keep a close watch on the minutest of developments in each zone and supervise the working and security arrangements assigned to the subordinates and local police station incharges.

On Tuesday evening, senior police officers swung into action to comply with the instructions of the CP. Officers of DCP rank held meetings with their subordinates and supervised the arrangements made to ensure peaceful celebrations.

Christianity arrested on HJM complaint

ix Dalits, who had embraced **S**Christianity, were arrested on charges of rioting and acts to outrage religious feelings after a Hindu Jagran Manch member, Arvind Kumar Gupta, filed a complaint accusing them of converting Dalits to Christianity at Sikandarpur Vaish police station of Kasganj.

The police, however, said that there was no evidence to suggest that the group of men was involved in religious conversion and said that the charges were being probed.

As per reports, Shrinivas, Kuldeep, Rahul Kumar, Shiv Kumar, Durgesh and Kishan, all in the 30 to 50 year age bracket, are Dalits who converted to Christianity. On Sunday, they visited Gangpur village to meet a friend Rampal, when five of them were arrested on the basis of Gupta's complaint who claimed that he saw them distributing money and religious literature among the villagers. One of the accused Kishan, however, managed to evade arrest by slipping away from the scene. While the complainant Gupta wanted them to be

All eligible residents of Kharela village in Jhansi have been vaccinated with the first dose against COVID-19, making it a model village for Uttar Pradesh and setting the bar high for vaccinating rural masses.

"With the sustained efforts of the UP government and awareness campaigns by Surveillance committees, all 310 eligible beneficiaries of Kharela village were administered the first dose of Covid vaccine. The village located in Moth block has a population of around 568 inhabitants, out of which 310 were eligible to be vaccinated The Jhansi district administration managed to successfully help the villagers in overcoming vaccine hesitancy," a government spokesman said in Lucknow on Tuesday.

Expressing happiness over the feat, Jhansi's District Magistrate Andre Wamsi said,

The internecine conflict within Uttar Pradesh Congress Committee (UPCC) came out in the open in November 2019 when the state party chief Ajay Kumar Lallu unceremoniously expelled 11 veteran Congress leaders, including 87-year-old Ram Krishna Dwivedi, once a trusted aide of former Prime Minister Indira Gandhi, for six years. The leaders who were expelled included Santosh Singh (former MP), Ramakrishna

A police spokesman said Abhay Srivastava (20) of Indiranagar worked in a toy shop at Patrakarpuram crossing. Serious lapses in screening of passengers

The guidelines being given at railway stations seem to be third wave of COVID-19. The authorities concerned are apathetic about screening of the passengers. Dozens of trains pass through Maharashtra at Prayagraj Junction and Prayagraj Chheoki station. The orders to check all the people entering UP are limited to papers only.

The situation is that passengers are not even wearing face masks in the trains. At the same time, health teams are deployed at the stations. But, only 10 percent of the passengers are being screened.

When 01071 LTT-Varanasi Kamayani Express reached Prayagraj Junction, the negligence was visible in the coach. Far from physical distance, most of the passengers did not even wear face masks whereas the railways has allowed travel on reserved tickets with compliance with the Covid



protocol. In anticipation of the third wave of Covid in Uttar Pradesh, people arriving from Maharashtra, Kerala and Tamil Nadu will be allowed entry only after showing the test report or certificate of both doses. Most of the passengers do not even have test reports.

Dozens of trains going to

various cities of Maharashtra including Mumbai and Pune pass through Prayagraj Junction and Prayagraj Chheoki everyday. About 12,000 to 14,000 people come daily by these trains. Mobile teams have been deployed in two shifts by the district administration to check the

passengers. These teams are able to take samples of about 600 to 1,000 people every day for examination.

KANPUR (PNS): The Uttar Pradesh government will run a special campaign to create awareness among the masses about viral hepatitis which of late has emerged as the major public health challenge that requires an urgent response. Viral hepatitis causes a large number of deaths and it is estimated that 325 million people worldwide are living with chronic HBV or HCV infection. This was stated by Dr AK Gupta from the SPM department of GSVM Medical College while informing press persons about the 10-day drive to combat viral hepatitis in Kanpur Nagar and surround-

ing districts. He said many viral hepatitis patients in India usually approached traditional healers as there was a belief that allopathy had no cure for this disease. He said people reached modern system health facilities only if there were complications, like liver failure or primary cancer of the liver and

that too in urban India. He said due to paucity of data, the exact burden of the disease for the country was not established. He said it was estimated that in India, approximately 40 million people were chronically infected with Hepatitis B and 6-12 million people with Hepatitis C and chronic HBV infection accounted for 40 per cent of hepato-cellular carcinoma (HCC) and 20-30 per cent

Dr Gupta said in Uttar Pradesh more than 20,000 cases were identified annually, 26.96 per cent of them caused by HAV (hepatitis A virus) which was the most common cause of acute hepatitis,.

The North Eastern Railway (NER) has secured a remarkable achievement in the direction of efforts being made for ensuring safe rail trans-portation. At all the stations of NER electronic interlocking of signalling system has been done and the stations have been equipped with suitable equipment for 25 kV (AC) rail electrification. Chief Public Relations Officer (CPRO) Pankaj Kumar Singh said due to the provision of electronic interlocking at Ramnagar, the last remaining mechanical interlocking station in Izzatnagar division, now there is no mechanical interlocking station left in NER. This work



has been completed with full quality even before the targeted date. With the completion of this work, all the broad gauge

equipped with colour light signal. It may be pointed out that here the panel interlocking of Gorakhpur railway station was done in the year 1984. In the old signalling system in the yard the maximum speed 50 km/h per hour only was permissible whereas in the new system the maximum speed 110 km/h. per hour is permissible. The signalling process in the old system took more time and required more maintenance, whereas in the new system it is less time consuming and is also maintenance-free. The night visibility of the colour light signal is also much better than the old semaphore signal. With interlocking along with safety the speed of trains increases in the yard.

The brain-based approach is an integration of biology and cognitive processes. BBIT is based on the theories and systems of brain mechanisms responsible for cognitive processes that are localised in different brain areas.

Besides the traditional use of tests of intelligence/cognitive abilities, BBIT will be of tremendous use for predicting school achievement and career

al strength such as relative strength and weakness in STEM or humanities. It will also be useful for cognitive profiling of those with learning and intellectual disabilities, traumatic brain injury, neurological impairments, and

No State/UT reported death due to 02 shortage: Govt

Refutes Opp charges of suppressing data, says only compiles data sent by States

Despite the hullabaloo over the issue during the second wave of Covid-19, it turns out, States and UTs did not report any death due to lack of medical oxygen. "The State Governments of Maharashtra and Odisha have requested to collect caste details in the forthcoming Census. The Government of India decided as a matter of policy not to enumerate caste wise population other than SCs and STs in Census," the MHA said in the Lok Sabha.

In March this year too, the

Parliament that it was not planning to release the data on caste Census collected as part of the 2011

The then Minister of State for Home had told the Rajya Sabha that the Socio-Economic and Caste Census (SECC), 2011, was carried out by the Ministry of Rural Development (MoRD) and the then Ministry of Housing and Urban Poverty Alleviation (HUPA) in rural respectively.

'The raw caste data has been provided to the Ministry of Social Justice and Empowerment (MoSJE) for classification and categorisation of the data. As informed by MoSJE, there is no proposal to release the caste data at this stage," the minister had stated in a written reply to a question.

Later, reports had suggested that the Government had decided not to update the SECC as the Central Government was not keen on maintaining caste data in the

NIA files chargesheet against CPI ultra

The case was originally registered on November 1, 2019 at Pantheerankavu Police Kozhikode City Kerala against Allan Shuaib Thwaha Fasal and CP Usman for their role in furthering the activities of CPI (Maoist), a proscribed terrorist organiza-

The case was re-registered by NIA on December 18, 2019. After investigation, the agency had earlier filed chargesheet against three accused persons on May 27 last year, the NIA

Further Investigation has revealed that Vijith Vijayan was an active member of CPI (Maoist) and was part of the publication division.

SC upholds cooperative societies' amendment

But annuls part relating to their functioning

New Delhi: The Supreme association or unions or Court on Tuesday in a 2:1 majority verdict upheld the validity of the 97th Constitutional amendment that deals with issues related to effective management of cooperative societies but struck down a part related to their set-

ting up and functioning.

A Bench of Justices R F Nariman, K M Joseph and B R Gavai said, "We have struck down part IX B of the Constitution related to cooperative societies but we have saved the amendment".

Justice Nariman said, "Justice Joseph has given a partly dissenting verdict and has struck down the entire constitutional

The 97th constitutional amendment, which dealt with issues related to effective management of co-operative societies in the country was passed by Parliament in December 2011 and had come into effect from February 15, 2012.

The change in the Constitution has amended Article 19(1)(c) to give protection to the cooperatives and inserted Article 43 B and

Part IX B, relating to them. While Article 19(1)(c) guarantees freedom to form

cooperative societies subject to certain restrictions, Article 43 B says that States shall endeavour to promote voluntary formation, autonomous functioning, democratic control and professional management of cooperative soci-

The Part IX B of the Constitution inserted by 97th amendment deals with incorporation, terms of members of board and its office bearers and effective management of cooperative societies.

The Centre has contended that the provision does not denude states of their power to enact laws with regard to

The apex court's verdict came on the Centre's plea challenging the Gujarat High Court's 2013 decision striking down certain provisions of the 97th constitutional amendment while holding that Parliament cannot enact laws with regard to cooperative societies as it is a state

The top court also examined a question whether the provision denuded states of their exclusive power to enact laws to deal with management of cooperative soci-

Recklessness

Owing to laxity by the States and citizens, the Supreme Court is forced to intervene

oes the Supreme Court have to stand between India and a third wave of the COVID-19 pandemic? It appears so, considering the casual approach of some States and the people alike to respecting the safety protocols. The apex court on Tuesday rapped the Kerala Government for bowing to traders' pressure and ordering relaxation of the lockdown in view of Eid. It was "shocked" by the "sorry state of affairs" and warned Kerala that action will be taken against it if the relaxation is found to have led to increased COVID-19 positive cases. As it is, Kerala is registering a steady rise in the number of cases. As late as on Monday, the Kerala Government was explaining to the court that the pre-Eid relaxations were a humanitarian gesture as well as an economic necessity. Uttar Pradesh needed a prodding from the Supreme Court before it announced that the Kanwar Yatra was being deferred as a precau-



tionary measure. Till then, it was preparing for the vatra and, at one point of time, even asked the neighbouring Uttarakhand to hold the yatra. The Supreme Court's concern is not misplaced as after a steady tapering of the second wave of the pandemic, cases are beginning to rise again even if the rise is limited to Kerala and Maharashtra, for now. The intervention of the courts and some alert State Governments last fortnight ensured that the assembly of thousands of tourists at hill stations was prevented with stricter safety measures.

Reacting to the current situation, the Institute of Mathematical Sciences said active cases persisting for a long time can create conditions for a super-spreader that can lead to another pandemic wave. The Supreme Court's attention needs to be drawn yet again to the vaccine shortage that is hitting the States. In Delhi, several vaccine centres were reported shut last week. The Health Minister of Maharashtra claimed some centres were operating below their capacity because of shortage of stock. Rajasthan and Punjab are also reporting similar situations. The apex court is aware of the pace at which vaccines are being procured. An affidavit filed by the Union Government also spells out the true picture about the availability of vaccine doses for the period between August and December. In the last week of June, the pace of vaccination came down by 39 per cent. It went up by six per cent in July first week, with an average of 42 lakh doses administered per day, before falling again. Reports reaching us from the US and the UK under the circumstances do not bode well for India. In the US, where the cases are rising fast, nearly all the new ones involve unvaccinated people. And in the UK, ironically, its Health Secretary tests positive after getting both doses even as the Government lifts all remaining restrictions. The two instances only reinforce the fact that a faster pace of vaccination and strictly following safety protocols are the only ways to avoid a third wave.

The fifth coming

Nepal's new PM must work hard to repair ties with India and to regain his people's trust

inally, Sher Bahadur Deuba has made it to the Nepal Prime Minister's seat for the fifth time, easily securing the confidence of the Lower House in the country's Parliament. The road back to the throne, making a stubborn and resilient KP Sharma Oli fall by the wayside, has not been easy but it certainly gets harder from here. Deuba has several challenges to address. First, there are voices for him to step



down as the president of the Nepali Congress Party as there are demands for a younger leadership. Therefore, putting his party in order before anything else will be an arduous task. Second, there are big payoffs pending for other parties supporting the Nepali Congress, and one single dispute may jeopardise Deuba's position. Maoists are unpredictable as they had supported the Nepali Congress in 2016, yet joined KP Oli in 2017 despite being in the Government. Third, the foreign policy of Nepal is clearly in a shambles with no clarity on friends or encroachers. Then, Deuba

is seen as leaning towards India and that sure isn't pleasing for China that has been pumping in finances and building infrastructure in

the Himalayan country to maximise its influence in the region. As Nepal acts as a buffer between the two Asian giants and can't afford to antagonise either, it would be a tightrope for the new Prime Minister though he has already traversed this path four times. However, Beijing's frustration and belligerence at the elevation of Deuba and the humiliating ouster of its protégé Oli is already showing. In an article titled 'China-Nepal ties solid despite pro-India leader', the Global Times reported on Monday that "Observers believe the Nepali Congress will likely lead Nepal's foreign policy toward a favorable direction for India". Pointing to the congratulatory messages by US ambassador Randy Berry and Indian envoy Vinay Mohan Kwatra to Deuba, the paper surmised that "their eagerness to promote ties with the new Prime Minister is quite obvious". Putting up a brave face despite China's clear and resounding failure in retaining Oli in the Prime Minister's seat, the article mentioned that Nepal's foreign policy has already taken shape. However, Deuba and Narendra Modi have already spoken on the phone and talked about "working together to further enhance the wide-ranging cooperation between India and Nepal". Let's hope for happier times ahead!

Contouring strategic studies in our country



In this time and age, nobody can afford to be aloof from international politics. That's why a closer strategic understanding through various tools is important

n a tumultuous world order facing the challenges of COVID-19, terrorism, border disputes, political instabilities, religious extremism, climate change and so on, the world may seem more at peace than in the previous decades. Yet, tensions between and among the nations are far higher at present. From two World Wars to Cold War, Globalisation to Great Recessions, there have been drastic changes in the world order. However, the contest for the apex title continues to be the same. Although the ongoing decade has so far avoided a war-like situation globally, the conflicts in Africa, West Asia and other parts of the world have impacted the global community one way or another. With none aloof from the happenings of international politics, be it individual or countries, understanding the global political system is the utmost need of the time. Political scientists have theorised, conceptualised, argued and defined the politics, State, power, system and overnance according to their understanding of contemporary international politics. In the meantime, it has impacted almost every ountry's bilateral and multilateral relations with the rest of the world. It needs closer scrutiny through the tools of diplomacy, foreign policy, strategy, geopolitical analysts and strategic understanding of the situation. While members of the diplomatic community, intelligence agencies, political leaders/spokespersons and journalists remain at the forefront to assess the situation, dedicated institutions help these agencies or individuals to prepare better to deal with the issues.

By the first half of the 20th century, India found herself as the epicentre of the South Asia region, encircled by landlocked countries (Bhutan and Nepal), small island nations (Maldives and Sri Lanka) and politically volatile Myanmar and Pakistan and a giant in the form of China next door. Amid this background, India had set up the Indian Council for World Affairs, Indian School of International Studies, followed by many other independent think tanks working towards understanding the events of international politics and helping the Government in assessing the risks involving while pursuing national interest. Since then, the

As the Army chief stated that "India is a land of great strategic thinkers and scholars", and with thinkers like Chanakya, Manu, Tiruvallur and in the modern day K Subramaniam, India needs to evolve and

retrace this knowledge. International relations and strategic studies are vital components of various professional courses and career-oriented examinations either by the Union Public Service Commission, State Service Commission or Staff Selection Boards. With the JNU in north India, Jadavpur University in the east and Pondicherry University in South hosting the Schools of International Studies, Mumbai being the HQ of Western Naval Command of Indian Navy and Naval Way College of Elegan and Naval War College, affiliated to the University of Mumbai, Pune HQ of Southern Command of Indian Army, the National Defence Academy and College of Military Engineering setting up the School of International

Relations and Strategic Studies at the University of Mumbai, Mumbai brings together the armed forces, thinkers, research scholars, academicians and journalists to study and discuss the future of strategic studies in India.

With India as a hub to prominent think tanks like the Manohar Parrikar Institute for Defence Studies and Analysis, IDSA, New Delhi, United Service Institute, Centre for Land Warfare Studies (CLAWS) and Centre for Airpower Studies, an active infrastructure at the university level in teaching and training the future generations of strategic community will help India to seek and secure its national interests. India also has fine journalism, and global events infrastructure is an integral part of their print and visual reporting. Therefore, professional training in this regard, especially in cities like Mumbai, is the need of the hour. Also, in the near future, India will need more aspiring diplomats and strategic thinkers. Clear the air over Pegasus affair



he term 'Pegasus' is now finding its place in India's political lexicon; it is gaining wide currency. The latest startling revelation that Pegasus, a penetrative, powerful and sophisticated software developed by NSO Group, an Israeli company, was used to snoop on Indian citizens for questionable motives clearly shows that the Modi Government does not believe that snooping is unethical and antithetical to high standards of democratic practice.

The Government's rebuttal that the allegation is without substance is belied by clear forensic evidence of Pegasus infections. Union Home Minister Amit Shah's statement that it was done by "disrupters for obstructers to show India in bad light and to derail India's development tra-

jectory" was unconvincing. India is defamed on the international stage more by the act of snooping than by its disclosure. Being a client of Israel's NSO Group, which owns Pegasus, is not something to be proud of.

In this digital era, hacking smartphones and other devices for political ends is nothing short of weaponising technology. Illegal snooping or surveillance is a cybercrime: it invades privacy. it infringes on civil liberties, it puts phone and computer users in a very vulnerable position in terms of personal safety and security; it gives prior information and an undue advantage to the ruling party in the game of politics: it is unbe-

coming of a democratically elected Government. The question arises as to whether or not Prime Minister Narendra Modi knew of the largescale snooping. AFGHANISTAN: AFTER THE FALL

Everybody in the Afghan national army already knows that the war is lost



ive times in the past two weeks, government soldiers in Badakhshan and Takhar provinces in northern Afghanistan have fled across the border into Tajikistan after clashes with Taliban militants. They didn't lose the firefights, and they're not cowards; 1,600 trained soldiers - over 100 a day - just fled abroad to avoid further combat. Nobody wants to be the last man to die in a lost war. Everybody in the Afghan national army already knows that the war is lost. So, the U.S. intelligence reports predicting that Ashraf Ghani's puppet government (the term is not too harsh) could fall within six to twelve months of a U.S. troop withdrawal are too optimistic. The last German, Italian and British troops left Afghanistan last week, and the last US troops are leaving right now, apart from some 650 soldiers to guard the American embassy and the airport. (Always hold the airport, because people lined up on the embassy roof waiting for the last helicopter out is a bad look.) But Kabul may fall in a lot less than six months.



The Taliban already hold at least half the country. The army is just melting away, and the air force will be grounded within weeks once the foreign technical support goes home.

The mujahideen group that became the Taliban spent ten years fighting the Russian occupation, then seven years fighting the local regime and rival mujahideen groups; then five years in power; and then another twenty years fighting the US occupation. Unsurprisingly, they have learned a few things in that time. Most importantly, they have expanded their membership and influence among the non-Pashtun groups: the northern provinces that are now falling to them so fast are the areas they never controlled during their last time in power.

Then there will be a period of vengeance-taking in which 'traitors' who worked for the Americans or other NATO countries will be hunted down and killed. Women will be driven out of the work force, girls' schools will be closed, music will be banned, and men will be beaten for not wearing beards. The Taliban's extreme version of Islam will reign unchallenged. The notion that Afghanistan will become a major terrorist base again once the Taliban regain power is based on the foolish belief that it was an important base for terrorist activity the first time around. Terrorists don't actually need 'bases'; the essence of the enterprise is to be invisible until you strike, and the weapons you need are neither large nor hard to obtain. Most of the 9/11 hijackers got some 'training' in Osama bin Laden's camp, but they were Arabs, not Afghans, and how much training do you need to hijack an airplane? Well, OK, four of them needed flight training, but they did that in the United States. Bin Laden was only in Afghanistan because American pressure got him expelled from his previous 'base' in Sudan. The Taliban leader, Mullah Omar, let him set up in Kandahar because the two men had become close friends when working in the 1980s in the American-backed jihad against the Russians in Afghanistan.

But did Bin Laden tell Omar about his plan to kill thousands of Americans by hijacking commercial aircraft? The first principle of all secret work is 'need to know', and Omar didn't need to know, Indeed, he might have objected if he did know, because he would have realised that Afghanistan would get invaded if the 9/11 attack went ahead. Afghanistan wasn't a 'major terrorist base' in the past, and it probably won't become one in the future. And if it does, so what? At least then you'll know where they are.

Is honesty alone enough for officers?

s mentioned in the previous article, "Honesty Still Pays" (published on July 13, 2021)
bureaucracy may be condemned, criticised, castigated, and ridiculed all around the world but it has not withered away. In fact, it has retained its significance as an essential tool to carry out the business of governance. However, as I point out in my book, "Ethical Dilemmas of a Civil Servant" released last year, in order to do that effectively, the bureaucracy has to not only survive but also thrive in the interest of the country and its people. But that cannot happen on the strength of honesty alone. Honesty is necessary but not a sufficient condition for the welfare of the people.

A civil servant is paid to perform, to deliver. Ironically, though, on account of the emerging socio-political environment, this performance is not always expected to be for the public good. It is also a pity that, on occasions, the civil servant is expected to ensure to uphold the interest of a selected few. Unfortunately, such occasions are increasing by the day and those civil servants who do not conform are not only shown the door but are also inevitably harassed. What is even more appalling is the fact that far from recognising good performance, there are instances of officers being penalised for doing what they had taken the oath to do. Needless to say, such signals do not augur well either for the system or for society. However, all is not lost. There is still a huge area where such pressures either do not exist or, if they do, can be managed tactfully.

However, it would also be wrong to assume that all honest officers fall into a single category. There are honest officers who think that the entire world around them is falling apart. They then take upon themselves the task of cleansing the system. The 'crusader' in them gets the better of them and media attention adds fuel to fire. A campaign is launched against those whom they perceiveas dishonest. Honesty becomes an end in itself. Such 'honest-only' officers forget the fact that they are paid not merely to remain honest but to perform as well. They evaluate their performance in terms of punitive actions that they take against others, i.e., the number of people or institutions they expose (becoming quintessential whistle-blowers, a role that brings 'name' and 'fame' to them), the number of disciplinary proceedings they get initiated, and the number of First Information Reports (FIRs) they lodge. In fact, in the final analysis, such precipitate actions by these 'crusaders' do not even serve their professed goal of cleansing the society. In their enthusiasm to hunt down the bad guys, they end up making no effort toward sevolving systems that can reduce, if not eliminate, the

Even for projects which doget delivered, it usually is too late to attain the desired impact. More often than not, these situations result in 'paralysis of analyses'. For him, honesty pays because he leads an honourable life as an honest officer. He revels in being recognised by many as a crusader against the dishonest, his professional achievements being the trophies of the victims of his crusade. In this way, he does a huge disservice to his 'Key Responsibility Area, i.e., service to the nation and its people. Moreover, he also does precious little to encourage initiative or instill motivation among those working with him.

A civil servant, especially in the higher echelons, has to evolve as a leader and has to cultivate such leadership qualities as to not inspire awe or fear but respect. This is done through leading by

example, with focus, objectivity, consistency, empathy, commitment to the tasks, and an everburning desire to make a real difference. All these are essentialvirtues that need not necessarily be consumed in the crusade against the dishonest. These virtues need to be used for evolving better systems and for inspiring colleagues to perform. Fortunately, there are a number of civil servants who are honest and efficient. They may not be as visible as those who are going hammer and tongs afterthe 'dishonest'. They are not 'crusaders'. They are the 'doers'.

Tackling India's growing population

The Prime Minister should try to form a national policy on population and bring a consensus on the issue of managing its growth

There is a raging debate about regulating the population growth in India. Three BJP-ruled States Uttar Pradesh, Assam, and Karnataka — intend to bring a two-child policy norm with incentives and disincentives. Even though they have not openly spelled out that the measure is meant to send a signal to the Muslim community, the message is clear. Some BJP MPs are preparing to push for a national population control law through private members' Bills during the monsoon

Successive Union governments have tried to regulate population growth. It became a sensitive political issue after the compulsory sterilization drive during the Emergency in 1975. The P-word is ano -no' for many political parties. No politician wants to touch it after that forced sterilization drive. The Union health ministry has even changed the name of Family Planning Department to Family Welfare Department.

India's population, which was just 30 crore at Independence has now become 1.34 billion. In contrast, China's population had doubled over the same period. The pace of India's population growth, now at 15 million per year, is the world's fastest. It is projected to reach 1.8 billion by 2050. Millions still do not have access to clean water, proper meals, healthcare, and education. The unmanageable number and more mouths mean more strain on the resources.

Had the population even doubled since 1947, it would have been manageable, but it has grown almost five times,

which should be a cause for concern.

The opponents of the population policy point out that national fertility has been declining steadily. Over the past decade, the trend has been a steady decline in the reproductive rate, with the southern states registering a steeper decline than the Hindi heartland in the north.

States like Bihar, Uttar Pradesh, Madhya Pradesh, Rajasthan, Jharkhand, and Chhattisgarh account for nearly half of India's population (48 percent). They continue to have very high fertility rates. States like Kerala, Karnataka, Maharashtra, Tamil Nadu, and West Bengal are now well below replacement fertility. Almost all central states have

experienced a significant decel-

eration in population growth and the pace of net addition is decreasing.

The opponents are also are against any harsh measures to contain the population. They argue that the one billion-plus population would yield a demographic dividend. For poor families, more hands mean more income. Also, it has brought in higher per capita entitlements. The migration from the northern and the eastern states has helped maintain growth in the south and the west, where

fertility rates are low. However, it is necessary to manage the population growth. More positive steps are needed to control it. The best way to do so would be to create awareness, provide education for the lower strata of society,

and more incentives for voluntary family planning. It should not be compulsory at all costs, or it will be a repeat of 1975.

It has to be remembered that India is expected to add nearly 273 million people to its population between now and 2050, according to a 2019 UN report. If no steps are taken, India will overtake China to become the most populous country and likely to hold the number one rank throughout the 21st-century, according to

population experts. The narrative needs to be changed for the better. After consulting all other political parties, the prime minister should try to form a national population policy and bring a consensus on this issue. Above all, no policy would succeed without people's cooperation.



Pegasus: TMC seeks Shah's resignation

SC examines if a person getting quota benefits in undivided State, loses it upon reorganisation

 $W_{son\ availing\ of\ reservation}^{ill\ a\ Schedule\ Caste\ perion}$ efit in the successor State upon reorganisation of the parent state, the Supreme Court examined the "peculiar question" on Tuesday.

The apex court said that such a question has cropped up before it for the first time and there are no case laws available as far as substance of the case is concerned and therefore it would like to examine the matter threadbare as the issue can happen anywhere.

It has sought the assistance of Attorney General K K Venugopal, who submitted that reservation in bifurcated states for Scheduled Caste and Scheduled Tribe (SC/ST) would remain the same as the conditions of backwardness, which affected members of particular castes would be nearly identical for residents in the erstwhile unified state.

A bench of Justices U U Lalit and Ajay Rastogi was faced with question while examining an appeal filed by Pankaj Kumar, an SC who has challenged the Jharkhand High Court's order of February 24 last year.

The high court's 2:1 majority verdict held that the peti-

of reservation in both Bihar and Jharkhand and hence cannot get qualified for state civil service examination.

Kumar was born in 1974 in Hazaribagh district of Jharkhand and at the age of 15 in 1989 shifted to Ranchi, the state capital which came into effect after Bihar"s reorganization on November 15, 2000.

He was appointed as assistant teacher in a school in Ranchi from December 21, 1999 and continued his job as teacher till 2008 in the same school. In 2008, Kumar applied for the 3rd Combined Civil Services Exam in Jharkhand and was called for an interview.

He has submitted his Caste Certificate dated January 12, 2007 showing him as resident of Ranchi along with his application for the Civil Services, which showed his 'original residence' as Patna.

Additional General for Jharkhand, Arunabh chowdhury said the state is supporting the majority verdict of the High Court and is of the view that Kumar cannot be allowed to avail the benefit of reservation in both Bihar and Jharkhand.

The bench said that it agrees with the contention that a belonging to SC or ST cannot of reservation in both the states but since the caste of Kumar is recognised as scheduled caste by both Bihar and Jharkhand, then why can't the benefit be extended to people of both the states, as they may belong to same clan.

It said that sometimes area specific reservation is given to the SCs or STs; in that case, Parliament clearly specifies that the quota will be given in

that particular state.
Chowdhury referred to earlier verdicts of the top court dealing with related issues and a circular said that even if a particular caste is reserved in both the States, the place of permanent residence will hold importance and not the place of temporary residence.

He said the court has to take into account that Jharkhand has the highest percentage of Schedule Tribe population in the country.

The bench said that people belonging to the same caste irrespective of their residence in both the states should get the same benefit like it was given during the unified state.

Dealing with Kumar's case, the bench said that he was born and brought up in Hazaribagh and in a way his family tree has two branches one in Patna, other in Jharkhand.

Srirangam township dismayed over selling of temple's cows to slaughter houses

A sense of uneasiness and silent resentment is discernible in Srirangam township Tiruchirappalli district. Home to the historical Sriranganathar Temple, known as one of the Divya Desams (Divine Land), devotees of the presiding deity as well as local population are upset over the handing over of cows from the temple's Goshala to slaughter

According to Rangarajan Narasimhan, a Vedic scholar based in the township, the cows were offered to the Sriranganatha Temple by devotees to meet the daily pooja requirements of South India's leading Vishnu Temple. "Only a fraction of the milk is being used for pooia rituals. Rest of the milk per the directives in Rig Veda," arasimhan told The Pioneer.

But officials of the Sriranganatha Temple have sold off more than 100 cows to slaughter houses, alleges Narasimhan whose daily life commences and concludes by worshipping in the temple. "The Vedas prescribe that cows reared in the Goshalas are not to be sold to anybody. The donors of these temples are expected to



visit the temple regularly to monitor the well being of these cows. But what has happened is that the temple authorities are disposing infirm, old and dried up cows to slaughter houses which is against the directives mentioned in Vedas," said Narasimhan.

Endowment Department of Tamil Nadu Government that administers the temple said that 60 cows were recently handed over to the poor archakas and priests to help them supplement their livelihood. "The cows were handed over as per the rules of the HR acs CE Department," said a release issued by the joint commissioner of the temple.

Narasimhan and other

devotees are questioning the veracity of the joint commissioner's version. "These are cows that have stopped yielding milk. In what way the poor priests would get additional income from non-milking cows?" asks Narasimhan.

Parthasarathy, another Officials of Hindu devotee in the temple premisprobe should be ordered into the affair as the cows have been disposed of in violation of the Sasthras and Vedas.

Narasimhan says a government order issued in 2013 (which has been accessed by The Pioneer) says that cows from Goshalas in major temples could be donated to priests of other temples so that they could use the milk from these cows for rituals in their temples.

TN auto drivers quitting profession over rising fuel prices, post-Covid issues

With fuel prices touching an all-time high and Covid-19 leading to shutdown of businesses, auto drivers in Tamil Nadu are calling it a day.

Trade Union leaders and activists are of the opinion that a large number of autorickshaw drivers in the southern State have quit and are selling their autos at low prices.

Mohammed Shabeer, an auto-rickshaw driver from T. Nagar in Chennai, told IANS, "Yes I have already sold my auto and am planning to work in some shop to support my family. Fuel prices are touching an all-time high and are increasing daily so we don't have any other option other than quitting. I have not paid my EMI for the past four months and have sold all the gold available at home. Hence, I thought that it is better to quit rather than

move on with huge losses." "Banks never showed any leniency even after the markets were shut for more than two months due to Covid-19 coupled with hiked fuel prices. I have decided after long thought to call it a day. I can't carry on with these liabilities," Shabeer added.

The trade unions are of the opinion that the auto-rickshaw drivers are not in a position to carry on their day-to-day activities after the daily fuel price



union leader associated with the All India Trade Union Congress (AITUC), who lives in Kanyakumari told IANS, "The union has strongly recommended to the state government to somehow settle this issue. The Union government is creating problems by unnecessarily hiking fuel prices and there is no hope for the auto-rickshaw drivers."

The auto drivers complain that while they fill their fuel tanks with petrol worth Rs 400, they did a business of Rs 200 to Rs 300 only. This has led to many auto drivers looking for other work.

Selvaraj Manicakam, Centre of Indian Trade Unions (CITU) leader and auto-rickshaw union General Secretary at Madurai, speaking to IANS said, "A rough estimate finds that nearly 15 to 20 per cent of the auto-rickshaw drivers have quit the profession and have sold their autos to settle the liabilities and are scouting for other jobs. The decade-old unrevised fares are the main reason for this and with a heavy hike in fuel prices and post-Covid shutdown, the auto drivers are a harried lot. We are submitting a detailed memorandum to the government to revise the fares.

After Tamil Nadu announced free travel for women in state-run buses, they are not using auto-rickshaws. Most of the women are now travelling in buses.

Kumar Ganeshan, an autorickshaw driver at Pammal in Chennai, told IANS, "I am selling my auto and even at a reduced price, takers are less. Prices of fuel are at an all-time high. Shops and establishments were closed for the past two months due to Covid-19 and we didn't have any work.

12,900 companies struck off records in 2020-21

s many as 12,889 compa-A s many as 12,000 companies were struck off from official records in the financial year ended March 2021 and 87 companies dissolved during the same period, according to official data.

As per the data provided by the corporate affairs ministry to Rajya Sabha on Tuesday, a total of 2,38,223 companies were struck off and 651 dissolved during the period from 2018 to June 2021 under Section 248 of the Companies Act, 2013.

Under the Section 248, a company can be struck off the official records subject to certain conditions. These include

instances where the Registrar of Companies has a reasonable cause to believe that companies that are not carrying on any business or operation for two immediately preceding finan-cial years and has not made any application within such period for obtaining dormant company status would be struck off after following the due process

Further, companies are dissolved through amalgamation or otherwise with the approval of courts. In 2020-21, a total of

12,889 companies were struck off and 87 companies dissolved, as per the data provided along with a written reply by Minister of State for

Corporate Affairs Rao Inderjit Singh.

"Thus, it cannot be said that 13,000 big companies and lakhs of small and tiny companies have shut down during 2020-2021," Singh said.

He was responding to a question on whether it is a fact that over 13,000 registered big companies and over lakhs of small and tiny industries have shut down operations in 2020-21, including 1,200 companies based in North India.

The minister also noted that big companies, small and tiny industries are not defined under the Companies Act, 2013, and that the term 'closed company' is also not defined under the Act.

Employees giving away over 11 hrs/week for free on average to their employers in India: Report

The amount of unpaid overtime that workers around the world are doing has soared in the past year and in India, employees are giving away more than 11 hours per week for free on average to their employers, according to a report. According to a new study by the ADP Research Institute titled 'People at Work 2021: A Global Workforce View, the average amount of "free time" worked has increased by

almost two hours per person per week since Covid-19 hit. The "free time" worked can

range from working over breaks and starting early or staying late, to regularly putting in extra work for no additional pay.

Globally, the average amount of free overtime being worked each week is now 9.2 hours per person - up from 7.3 hours prepandemic, according to the findings of the survey of more than 32,000 workers in 17 countries.

Moreover, given the demanding nature of their jobs, essential workers are putting in more unpaid overtime than non-essential workers — at 10.1 hours per week on average, compared to 8.1 hours. The pandemic has also made individuals more digitalsavvy, and about 50 per cent of the respondents started using mobile applications or tools to manage their finances.

3 rockets land near palace

Attack took place before Af Prez Ghani's Eid address

t least three rockets hit near At least three rockes in the the presidential palace on Tuesday shortly before Afghan President Ashraf Ghani was to give an address to mark the major Muslim holiday of Eid al-Ádha.

There were no injuries and the rockets landed outside the heavily fortified palace grounds, said Mirwais Stanikzai, spokesman for the interior minister.

No one immediately claimed responsibility for the rocket attack, but police quickly fanned out across the area. One car parked on a nearby street was completely destroyed; the police said it was used as launching pad for the rockets. The palace is in the middle of a so-called Green Zone that is fortified with giant cement blast walls and barbed wire, and streets near the palace have long been closed off.

The barrage came as the US and NATO complete their final withdrawal from Afghanistan.

Many Afghans are worried whether their war-ravaged country will fall deeper into chaos and violence as foreign forces withdraw and the Taliban gain more territory on the ground, having captured several districts and key border crossings with neighboring

countries over the past weeks.

The withdrawal is more than 95 per cent complete and the final US soldier will be gone by August 31, President Joe Biden said in an address earli-

"This Eid has been named after Afghan forces to honor their sacrifices and courage, especially in the last three months," Ghani said in his address to the nation following morning prayers for Eid al-Adha, or the "Feast of Sacrifice."

"We have proven that we have the intention, the willingness and have sacrificed for peace."

However, Afghan forces have complained about being left without reinforcements and supplies, often running low on food as the Taliban advanced. The two days of meetings in Doha — the highest level of negotiations between Kabul and the Taliban so far — aimed at jumpstarting stalled talks but ended with a promise of more high-level talks.

Biden admin urges court to extradite Rana to India

The Biden administration has urged a federal court in Los Angeles to extradite Pakistani-origin Canadian businessman Tahawwur Rana to India where he is sought for his involvement in the 2008 Mumbai terror attack.

Rana, 59, has been declared a fugitive by India, where he is facing multiple criminal charges for his involvement in the 2008 Mumbai terror attack in which 166 people, including six Americans, were killed. He was rearrested on June 10, 2020, in Los Angeles on an extradition request by India

In a submission before the US District Court, Central District of California in Los Angeles, the US government argues that India's extradition request contains sufficient evidence of probable cause on each of the criminal charges for which India seeks Rana's extra-

"Having found that all of the requirements for certification of extradition have been satisfied, the Court certifies the extradition of Tahawwur Hussain Rana to the Secretary of State and commits him to custody pursuant," according to a draft order proposed by the US attorney in his submission before the court last week.

"Based on the evidence submitted by India, RANA allowed fraud against the Indian government to occur through the creation and submission of forged documents. The purpose behind such fraud is irrelevant under the Indian criminal provisions," said the document titled proposed findings of facts and conclusions of

law. Rana is wanted by the Indian authorities for his alleged involvement in the deadly attacks that are sometimes referred to as India's 9/11. An Indian warrant for his arrest was issued in August

Indian authorities allege that Rana conspired with his childhood friend David Coleman Headley to assist the Pakistani terror group Lashkare-Taiba (LeT), or Army of the Good, in the orchestration of the 2008 terror attacks in Mumbai.

"In any event, RANA knowingly allowed Headley to obtain the business visa and the cover that he needed to conduct terrorism-related surveillance operations in India, ultimately leading to the three-day terrorist attacks in Mumbai. Accordingly, the Court finds there is probable cause that RANA conspired to forge a document for the purpose of cheating and use a forged document as genuine, in violation of IPC 120B, 468, and 471," it

According to the court document, the evidence establishes that the Mumbai attacks

were committed by LeT, a terrorist organisation targeting India. Thus, an attack on Indian soil, especially one that would result in mass casualties, injuries, and damage to property, would strike terror in the Indian people.

'Rana was aware that Headley was involved with LeT, and that by assisting Headley and affording him a cover for his activities, he was supporting the terrorist organisation and its associates. Rana knew of Headley's meetings, what was discussed, and the planning of the attacks, including some of the targets. Further, it was foreseeable that these attacks would lead to death, injury, and destruction of property," it said. "Accordingly, this Court

finds that there is probable cause that Rana committed the crimes of conspiracy with the object of committing a terrorist act, in violation of IPC 120B and UAPA 16, and conspiracy to commit a terrorist act, in violation of UAPA 18. The court further finds that under an agency theory or an abetting theory (as contemplated by UAPA 16), there is probable cause that Rana committed the substantive crime of commission of a terrorist act in violation of UAPA 16," said the document submitted by the US

India has charged forgery for purposes of cheating, in vio-lation of IPC 468, as an object of the alleged criminal conspiracy. India also charged the crime of using as genuine a forged document or electronic record, in violation of IPC 471, as an object of the alleged criminal conspiracy.

Pak Min says Afghan envoy's daughter wasn't kidnapped; urges her to join probe

Islamabad: Pakistan's Interior whose vehicles she used on that Minister Sheikh Rashid on Tuesday reiterated the police's claim that the daughter of Afghanistan's ambassador was not kidnapped even as he urged her to come forward and join the probe, in a case that has further soured relations between the two neighbours. His statement came a day after the police in Islamabad said that they have found no evidence that Silsila Alikhil, the 26-year-old daughter Pakistan Najibullah Alikhil, was abducted from the capital city, an incident that has triggered a major diplomatic row between the two neighbouring nations.

The Minister told the media that she used four different taxis to commute to different locations in Islamabad and neighbouring Rawalpindi and police have all

details of her travels. "Nobody sat in her car. There is no case of kidnapping. We have given FIR as per laws. And hope that she will join the probe and come forward to recognise the four tax drivers day," Rashid said.

He said that the Pakistan government was fighting her case but it would have been better if the Afghan ambassador and his daughter had not gone back.

Aman tried to stab Mali's transitional President Col. Assimi Goita Tuesday at the Grand Mosque in the capital amid celebrations for the Muslim holiday of sacrifice, Eid al-Adha.

The attempted stabbing happened after the holiday prayers and sermon at the mosque and the imam went to to witnesses. One man with a knife and another with a gun participated in the attack, said the witnesses. Goita was not hurt and his security team quickly took him away, but one person was injured, they said.

This attempted attack on the interim president comes as Mali has seen several attacks by jihadis in the central part of the country in recent days.

Col. Assimi Goita grabbed ower in August 2020 by overthrowing Mali's democratically elected president. He eventually agreed to a transitional

government led by a civilian president and prime minister but on May 24 he ousted those civilian leaders after they announced a Cabinet reshuffle that sidelined two junta supporters without consulting him.

Goita was then sworn in as president of the transitional government in June. He has pledged to keep the country on track to return to civilian rule with an election in February

Mali has been unsettled since 2012 when mutinous soldiers overthrew the president of a decade. The power vacuum led to an Islamic insurgency that took control of the country's northern cities, including Timbuktu and Gao. A Frenchled campaign ousted the jihadis from the northern cities in

A peace agreement was signed in 2015 by three parties the government, a coalition of groups that seek autonomy in northern Mali, and a progovernment militia.

America asks Pakistan to keep working with FATF To 'swiftly complete' its 27-point action plan

The US has urged Pakistan to continue working with the FATF to "swiftly complete" its 27-point action plan by demonstrating that terrorism financing probes and prosecutions target senior leaders and commanders of the UN-designated terror groups.

ing last month, the Paris-based Financial Action Task Force (FATF) retained Pakistan on its 'grey list' for failing to check money laundering, leading to terror financing.
It asked Pakistan to inves-

tigate and prosecute UN-designated terrorists based in the country like Jaish-e-Mohammad (JeM) chief Masood Azhar and Lashkar-e-Taiba (LeT) founder Hafiz

The global body against money laundering and terror financing also asked Pakistan to

work to address its strategically important deficiencies.

At his daily news conference on Monday, State Department spokesperson Ned Price said while Pakistan had made progress on its first action plan of the FATF, it needed to work on its second action plan.

"We do recognise and we efforts to satisfy those (first action plan) obligations. Pakistan has made significant progress on its first action plan with 26 of 27 action items largely addressed," Price said. "We encourage Pakistan

to continue working with the FATF and the international community to swiftly complete the remaining action item by demonstrating that terrorism financing, investigations and prosecutions target senior leaders and commanders of UN-designated groups," he

The UN-designated terrorists based in Pakistan include Jaish-e-Mohammed (JeM) chief Azhar, Lashkar-e-Taiba (LeT) founder Saeed and its 'operational commander' Zakiur Rehman Lakhvi.

Azhar, Saeed and Lakhvi are the most wanted terrorists in India for their involvement in numerous terrorist acts, including the 26/11 terror attacks and the bombing of a CRPF bus in Jammu and Kashmir's Pulwama district in 2019.

Price also said the US encourages Pakistan to expeditiously work on its new second action plan.

Pakistan was placed on the grey list in June 2018 and asked Islamabad to implement a plan of action to curb money laundering and terror financing by the end of 2019 but the deadline was extended later on due to the Covid-19 pandemic.

Similarly, Apple and Google have removed the app because of the pornographic content in it.

Talking to media persons here, Joint Commissioner of Police Milind Bharambe said: "We found agreement papers, emails, accounts WhatsApp chats and pornographic clips from his office during the search". Confirming the removal of the app from the Apple and Google play stores, Bharambe said: "The free-to-download app was removed by both Apple and Google play store for the type of its content. We have recovered incriminating evidences like several HotShot films, video clips, WhatsApp chats, etc. during the investigation". However, the police said that investigations had not revealed any role of

Shilpa Shetty in the scam. On his part, 46-year-old Kundra has denied any involvement and has claimed that he had sold the "Hotshots" app to Pradip Bakshi. However, the police said

Kundra was kept in the loop about the finances of the app.

The police said that Kundra had

allegedly also set up a WhatsApp group on which matters relating to the production, distribution and selling of Hotshots clips were discussed.

Kundra, who lives in Mumbai with his wife Shilpa Shetty and two children, has been booked under various sections of the Information Technology Act, 2000, Indian Penal Code and the Indecent Representation of Women (Prohibition) Act for alleged cheating and "obscene and indecent advertisements and displays" If convicted, Kundra may end up being chind the bars for five to seven years.

Among other things, the investigations have revealed that Kundra-led company paid Rs 10,000 to the female artists for the clips. Some of them alleged that they were lured into the scam with offers of roles in web series. However, the hired artists were forced to shoot for porn films.

However, the police have clarified that investigations have revealed no active role of Shilpa Shetty.



Then, game based learning, which is now a reality, in a classroom can make lessons fun, which students actually look forward to taking most as the joy quotient is high.

Creative learnings, which may become a task when attempted offline can be an immersive experience digitally. These include storytelling, PowerPoint presentations, using video streaming to share global content, visiting digital museums, showcasing digital sketching so on and so forth.

Then there are certain subjects which are in fact better off taught online. Nothing exemplifies this trend as the subject geography. With such advancements as digital maps, GPS, online routing and satellite imagery becoming commonplace, learning geography through digital means is the best

Next, by using tech, students acquire vital soft skills which come in effect later. These are researching on net, understanding keyboarding, clicking, surfing, navigating etc.

Students being encouraged to undertake content creation through own recordings lays the foundation for their podcast, vlogging careers later. So rather than being merely consumers, they are shaped to be leaders.

Then, engaging social media for academic learning opens children to the making healthy use of seemingly addictive mediums. Another area where tech-

nology can help education is by reaching those who cannot come to schools for any reason. Having said that, on-boarding tech and expanding its

scope in education will need better smartphone and laptop access to students, not to mention high speed internet con-Also, digital learning cannot

fulfil outcomes in various sub-

jects requiring practical training

and physical doing. These include physical education, sports, lab experiments, handling biological matter. Moreover, when a student puts pen to paper, they are actually honing their hand eye and

hand brain coordination, sharpening their rational mind and intellectual center. So, computerisation might not offer a viable substitute for this. In summation, technology

is transforming education, drastically altering how, when and where children learn and empowering them to be more creative and ready for the techtonic shift that today's jobs demand.

All about post-study visas

Overseas education gives students international exposure to a cutting-edge curriculum. MAYANK SHARMA tells you how post-study visas work in different countries

experience by exposing them to various cultures, life experiences, and education methodologies. Often, numerous students like to continue their career pursuits in the countries where they complete their higher education. Understanding this trend, Governments across the world have been providing post-study visas and study permits to attract and retain the best international talent.

Here is how post-study visas and work permit processes work in different

United States: International students who want to attend universities in the US need to apply for an F1 Visa. However, if they want to gain a few years of work experience after their studies, they have two options they could pursue. The first one is to apply for an OPT extension and another is to get the H1-B visa. OPT extension to the F1 visa allows post-graduation students to work temporarily for a year in their major areas of study; or opt for an H-1B visa, which is a non-immigrant visa provision.

This application is not submitted by the student, but by the sponsoring employer, which provides a guarantee that the applicant will work during the stay. While OPT extension is provided only to those who are studying or who have completed their study, the H-1B visa is for those who are sponsored by their employers, irrespective of their field of study.

 $F^{lying \ abroad \ for \ higher \ education \ can}_{give \ students \ an \ amazing \ academic} \quad \text{Even though the US allows students to stay for a year (under OPT \ extension)}$ stay for a year (under OPT extension) after completion of their course on their F1 visa, those who are studying STEM courses (Science, Technology, Engineering, and Mathematics) are eligible to get a 24-month extension.

United Kingdom: The UK has brought back its Post-Study Work permit visa in 2021 after suspending it in 2012. Under this provision, students with an undergraduate or master's degree can stay back and work for two years, while those who completed their PhD can work for three years. These provisions are allowed for students who have a valid UK immigration status and are graduating in July 2021 and later. Students who applied online for degree courses from their home countries due to the pandemic restrictions, or who had to go back home, can also apply for a work visa. The Post Study Work permit also allows students to switch to a skilled work visa and provides worker rights for their dependents and access to the UK Labour market.

Canada: A student wishing to study in Canada usually has to apply for a Canada Student Visa, which is similar to Visitor Visa or Electronic Travel Authorisation, except that it includes a

Students graduating from Canadian universities can stay for up to three years with a work permit to explore employment opportunities, depending upon the duration of the course. The PostGraduation Work Permit Program is applicable only if the duration of the course is a minimum of eight months. If the course is between eight months and two years, the permit will be for the duration of the course. However, if the course duration is of two years or more, the permit will be applicable for three years, which can be an added advantage to students pursuing a two-year master's degree or equivalent. However, one of the biggest advantages of applying for a work permit is that the experience gained through it may qualify the students to apply for per-

manent citizenship in the country. France: In France, a student who has completed a professional bachelor's degree, post-graduate or higher degree course needs to apply for a job search or business creation residence permit, if (s)he wants to stay for an additional 12 months to look for a job. According to an agreement signed with France in 2015, Indian postgraduate students are allowed a benefit of a two-year special residence permit to stay after their studies.

Germany: A student who completes his graduate or higher courses in Germany can apply for a temporary residence permit, which is valid for 18 months, during which the student can search for job opportunities. If a student wants to accept a job role, (s)he can apply for a German residence permit or an EU

'Faster, Higher, Stronger - Together', | Shooters feeling the 'heat' **Oly motto gets Covid-era makeover**

The Olympic motto was **L** amended to 'faster, higher, stronger — together' during the International Olympic Committee's session in Tokyo on Tuesday as the world waited for the pandemic-hit Games to begin on July 23.

The word 'together' after a hyphen has been added to the earlier motto, which was made up of three Latin words — Citius, Altius, Fortius, translating to 'Faster Higher Stronger' in English.

The proposal to include the word together was made by IOC President Thomas Bach, which was endorsed by the body's Executive Board (EB) in April.

Bach had suggested the motto should become 'faster, higher, stronger — together' in response to the Covid-19 crisis.

The motto now reads 'Citius, Altius, Fortius -Communis' in Latin.

The IOC members unanimously approved an amendment of the Olympic Charter.



Deepak Chahar and Suryakumar Yadav slammed their maiden ODI fifties as India registered a series-clinching three-wicket win over Sri Lanka in the second ODI in Colombo.

Chasing 276 for a win, the Indian top-order failed to fire but a middle and lower order resurrection saw the visitors cross the finishing line, reaching 277 for 7 in 49.1 overs. After Suryakumar Yadav's 44ball 53, Deepak Chahar remained not out on 69 off 82

Leg-spinner Yuzvendra Chahal led India's decent effort with the ball as a self-destructing Sri Lanka slipped to 275 for nine in the second ODI here on Tuesday.

Pretty much like the series opener, most of the Sri Lankan batsmen got starts but failed to capitalise after the hosts opted

Avishka Fernando (50 off 71) and Charith Asalanka (65 off 68) struck fine half-centuries but the home team wasn't disciplined enough to post an imposing total.

Chamika Karunaratne (44 not out off 33) came up with another timely cameo to take the team past 270. Chahal (3/50) was the

pick of the bowlers while pacers Deepak Chahar (2/53) and Bhuvneshwar Kumar (3/54) too got wickets primarily due to profligacy of the home team batsmen.

Openers Fernando (50 off 71) and Minod Bhanuka (36 off 42) took Sri Lanka to 59 for loss in the first 10 overs.

The momentum shifted India's way drastically after Chahal removed Minod and Bhanuka Rajapaksa off successive balls in the 14th over. In Minod's case, it was a soft dismissal as the well set southpaw charged down the wicket and flicked an eventual full toss straight to Manish Pandey at

The next one from Chahal was a beauty which held its line to a take faint outside edge of Rajapaksa's bat and wicketkeeper Ishan Kishan managed to clutch onto the catch.

Sri Lanka, who are among the worst performing teams in the middle overs, struggled again in the crucial stage of the game. They took 97 balls to take find their next boundary after the eight over.

From 77 for no loss in the 14th over, Sri Lanka slipped to 134 for four in the 28th over.

Asalanka and skipper Dasun Shanaka tried to resurrect the innings but their 38run stand ended with the captain falling to a flatter one from Chahal.

Chahar took his second wicket with a perfect knuckle ball that crashed through Wanindu Hasaranga's

Asalanka played some bold strokes alongside Karunaratne to give the innings some impetus towards the end.
