US SECRETARY OF STATE BLINKEN TO VISIT INDIA FOR TWO DAYS FROM JULY 27

S Secretary of State Antony J Blinken will visit India on July 27 and 28 to discuss a range of issues including the recovery from the coronavirus pandemic and the situation in Afghanistan and the Indo-Pacific, the Ministry of External

Affairs announced on Friday. It will be Blinken's first visit to India after assuming charge as and the second by a highranking official of the Biden administration since it came to power in January. "US Secretary of State, Antony J Blinken, will visit India on July 27 and 28," the MEA said. A statement by the US State Department said Blinken will also meet Prime Minister Narendra Modi.

he cumulative Covid-19 vaccine doses administered in the country has exceeded 42.75 crore, the Union health ministry said on Friday. Nearly 38,87,028 vaccine doses have been administered on Friday, according to the 7 pm provisional report. The

ministry said 18,09,954 vaccine doses were administered as first dose and 1,92,363 vaccine doses given as second dose in the age group 18-44 years on Friday. Cumulatively, 13,52,21,119 persons in the age group 18-44 years across states and union territories have received their first dose and total 57,54,908 have received their second dose since the start of phase-3 of

NO PLANS TO SUSPEND NEET, OTHER COMMON ENTRANCE EXAMS: GOVT

he Union government does not have any plans to suspend NEET and other common entrance examinations, Minister of State for Health Bharati Pravin Pawar informed Lok Sabha on Friday. The National Eligibility cum Entrance Test (PG) and NEET (Undergraduate) 2021 examinations are scheduled to be held

this year on September 11 and 12, respectively, she said in a written reply. The examination shall be conducted with all due precautions and following all protocols, including maintaining Covid-appropriate behaviour, Pawar said. Further, the additional protective measures for candidates and examination personnel are proposed towards the safe conduct of the exam, she stated.



FCONG SAYS HUGE RISE IN NSC GRANT IN 2017-18, ASKS IF IT WAS FOR 'PEGASUS'

mid the Pegasus snooping row, the Congress Friday claimed the grant allocation to the National Security Council secretariat went up to Rs 333 crore in 2017-18 from Rs 33 crore the year before, and asked if this hike was related to "purchasing" the Israeli spyware.

Congress spokesperson Pawan Khera said the UPA government in 2011-12 had allocated Rs 17.43 crore to the National Security Council Secretariat in terms of grants. This amount was marginally increased to Rs 20.33 crore in 2012-13 and further to 26.06 crore in 2013-14, he said, noting that National Security Council Secretariat is largely concerned with administration and co-ordination.

As inflows surge, 70 Prakasam barrage crest gates partially lifted

inflows. The water level in major reservoirs in the upper riparian States is expected to rise in the next few days as Indian Meteorological Department predicted heavy rainfall in these states. According to Friday's report, Prakasam barrage received 61,311 cusecs of inflow, the outflow was 59,750 cusecs. For agriculture purposes, 1,561 cusec water was released from the Krishna. The total storage capacity was 3.07 trnc ft. To release floodwater from Prakasam barrage, 10 crest gates were lifted up to two feet while another 60 were lifted by one foot. Officials were alerted to evacuate the people living in the low-lying areas downstream Krishna River. Irrigation officials concerned were taking measures time and again on the outflow from the barrage, said Mangalagiri MLA Alla Ramakrishna Reddy

NGT tells KRMB to visit RLIS without AP ML MELLY MAITREY

In what can be construed as a shot in the arm for the Telangana government, the National Green Tribunal's southern zone bench at Chennai on Friday directed the Krishna River Management Board to visit the Rayalaseema Lift Irrigation Scheme (RLIS) project site "independent of the AP government" and submit a detailed report upon inspection of the works taken up there.

Till date, there had been no progress on the petitions filed in the National Green Tribunal, including the contempt of court petition filed by the Telangana government against the ongoing work on the RLIS taken up by the Andhra Pradesh government in violation of Tribunal's orders.

The Contempt of Court petition came up for hearing in the NGT,

Chennai on Friday.
The Tribunal, in its previous order on July 12, directed the Krishna River Management Board and the Central Environment Department to visit RLIS project site and submit a report if indeed work was going on without any approvals as complained initially the individual petitioner G

Srinivas and subsequently by the Telangana government.

affidavit stating that the Andhra Pradesh government was not cooperating for their proposed visit to the project site. The Central Environment Department, however, did not file its response on

However, the Andhra Pradesh government on Friday submitted an affidavit against the Contempt of Court petitions denying that it had violated the NGT orders and stated that only works related to Detail Project Report had been taken up. Telangana Additional Advocate

General Ramachandra Rao then submitted to the NGT that it should send its own team to the controversial work site, considering that the AP government had not been cooperating with the KRMB.

He said that the Telangana government was ready to provide helicopter and other facilities for the NGT team to visit and inspect the project site.

However, the Tribunal again ordered the KRMB to visit the project site independent of the AP government and submit a detailed report, after carrying out an inspection of the RLIS.

CM to unveil spruced up Nadu-Nedu schools, launch phase-II on Aug 16

Chief Minister YS Jaganmohan Reddy will dedicate to the State on August 16 the schools spruced up under first phase of 'Nadu-Nedu' programme while inaugurating the second phase of the scheme on the same day.

Chairing a review meeting at his camp office here on Friday, the Chief Minister discussed Nadu Nedu (education), New Education Policy (NEP) and Vidya Kanuka schemes with officials.

It was decided that the second phase of Nadu- Nedu would be launched the day the schools reopen and the gov-ernment would also provide Jagananna Vidya Kanuka kit and further announce details of the NEP.

Classification of schools will be finalised according to the NEP and with regard to this, the Chief Minister directed the authorities to complete the process by August 16.



The NEP includes six types of schools from PP-1 to 12th grade. Satellite Foundation Schools will be offering PP-1, PP-2, Foundation Schools offer PP-1, PP-2 and classes 1 and 2, Foundation Plus Schools that offer PP-1, PP-2 and Classes 1-5, pre-high schools which provides PP-1, PP-2, and Classes 1-7, high schools from Classes 3-10 and High School Plus which has Classes 3- 12.

The Chief Minister said that English medium will be started from Anganwadis, which will be transformed into Satellite Foundation Schools and shall be guided by Foundation Schools to ensure best teaching available.

Foundation Schools will be set up within the radius of a km and high schools in a three-km radius, said the Chief Minister and added that there will not be a single school beyond the three-km range, bringing down the travel dis-

AP logs 1,747 new Covid cases, 14 deaths

The cumulative coronavirus positives shot up to 19.50 lakh in Andhra Pradesh with the addition of 1,747 afresh on Friday. With 2,365 more patients getting cured in 24 hours, the total recoveries went up to 19,14,177.

The latest bulletin said 14 people succumbed to Covid-19 in the state in 24 hours ending 9 AM on Friday, taking the gross toll to 13,223. The state now has 22,939

active cases, it said. Chittoor district reported

the highest number of 293

fresh cases, followed by SPS Nellore (239), East Godavari (234), Prakasam (223), West Godavari (215), Krishna (127) and Visakhapatnam (109) in a day. Three districts logged between 50 and 90 while the remaining three registered less than 50 each, with Kurnool reporting just nine new cases in a day, the lowest

Around 150 acres of land has also been earmarked in Malavalli, located in Krishna district. The land parcel, a part of Andhra Pradesh . İndustrial Infrastructure Corporation (APIIC) industrial area has been acquired and is in possession of APIIC.

As per the assessment report, construction period for MMLP at Vijayawada would be 18 months in each phase with about capital expenditure of about Rs 865 crore and construction cost would come around to about Rs 770 crore. It was assessed that the occupancy rate would be 35 percent in the first year going up to 65 percent in the last year of operations for the first phase of development with an expected Internal Rate of Return (IRR) of 16 percent in 30 years.

Notably, Vizag already has a multi modal logistics park being operated by Concor. The Concor MMLP, developed in a 108 acre land parcel in Viman Nagar opposite the Vizag airport, began operations from February 2017.

Special GP C Suman, appearing for the government in these cases, informed the court that about 240 people had been evacuated from the area and all of them had been given compensation along with house sites. He brought to the notice of the court that if the appellants were allotted temporary houses separately, the others would also move court.

Counsel for the petitioners Srinivasa Rao denied the claim that 240 people had been evacuated and that temporary shelter would be set up in the allotted space if 2 to 3 months were given to them.

The judge said that since the petitioners had accepted compensation, they have forfeited their rights to the area. The court directed the residents that they would be given till August 6 to vacate the houses and directed the government not to take any action till then.

Meanwhile, 11 petitioners filed a Writ Petition bringing to the notice of the court that compensation was not paid by the government to them. Responding to this, the court gave two weeks to the GP to file counters.

Godavari in spate, projects get inflows

With incessant rains across Telangana and extensive rains in Maharashtra and upper riparian States, the Godavari River is in spate with the water level rising steadily at Bhadrachalam.

Ministers in the districts in the catchment areas of the Godavari and Krishna rivers are constantly monitoring the situation as directed by Chief Minister K Chandrasekhar Rao.

Ban on plastic sticks used in candies, ice-cream from NY

PNS NEW DELHI

Candy sticks and ice-cream sticks made of plastic may get phased out from January 1, 2022, the Centre informed Parliament on Friday. Responding to a query on

the phasing out schedule of single-use plastic, Minister of State for Environment Ashwini Choubey said as per the draft notification issued earlier this year, manufacture, import, stocking, distribution, sale and use of some of the identified single-use plastic items are proposed to be prohibited by January 1, 2022.

Earbuds with plastic sticks, plastic sticks for balloons, plastic flags, candy sticks, icecream sticks, polystyrene (thermocol) for decoration are proposed to be phased out by January 1, while single-use plastic (including polystyrene and expanded polystyrene) items - plates, cups, glasses, forks, spoons, knives, straw, container and container lids, trays, plastic/PVC banners less than 100 microns and stirrers are expected to be phased out by July next year.

Single-use plastic items expected to be phased out by September 30 this year include carry bags made of virgin or recycled plastic less than 120 microns in thickness and nonwoven plastic carry bag less than 60 GSM, the minister informed Lok Sabha, adding that the provisions shall not apply to commodities (including carry bags) made of com-

postable plastic material. The MOeF had issued a notification containing draft provisions on March 11, 2021 for amending Plastic Waste

Management (PWM) Rules, 2016, inter alia prohibiting the use of identified single-use plastic items by 2022 for pubic consultation. Replying to another query

on the steps taken to strengthen the implementation of Plastic Waste Management Rules, 2016 and also to reduce the use of identified single-use plastic items, the minister said the states/UTs have been requested to constitute a special task force under the chief secretary or the administrator.

"Already, 14 states/UTs have constituted the special task force till date. A national level task force has also been constituted by the ministry for taking coordinated efforts to eliminate identified single-use plastic items and effective implementation of Plastic Waste Management Rules, 2016," he said.

A-G defends appointment of Sawhney as AP poll panel chief

PNS VIJAYAWADA

Advocate General S Sriram on Friday justified before the Andhra Pradesh High Court the appointment of former Chief Secretary Nilam Sawhney as the State Election Commissioner, saying that it was in line with the Constitution.

The A-G put forth his arguments on a petition filed against the appointment of Sawhney as the State Election Commissioner. Sriram said that senior and retired IAS officers were chosen and appointed as SEC by other States also as they have vast experience. "On the other hand, there is no rule that retired and senior IAS officers should not be appointed to the SEC," the A-G said.

He said that the Chief Minister's letter to the Governor indicatively informs about the litigation of the exercise of appointments and the pending SLP in SC, while suggesting three names is not inconsistent with the scheme of the Constitution.

The Governor did not limit his consideration only to those names and applied an objective parameter amongst 11 officers to come to the conclusion that Sawhney was the right person for the job and thus it cannot be kept as a challenge, the A-

"It cannot be contended by



the petitioners that only by reason of Nilam Sawhney having been appointed as an adviser to the Chief Minister, her neutrality is under question. In all the Constitutional appointments and appointments to neutral office, any appointment is required to be based on suitability of the officer in the opinion of the Governor. Neutrality and performance of an independent officer are matters to be determined after the completion of the appointment of that officer," the A-G

Answering the question as to why only the names of IAS officers were nominated for the post of SEC and why he not even mentioned the names of those from other sectors to the seek a writ of Quo Warranto on the grounds of assumed lack of neutrality which is beyond the scope of writ for Quo Warranto which is sought by the petitioners, he said. It was brought to the notice

of the court that it is under the Constitutional scheme, entirely within the discretionary space of the Chief Minister to decide on appointment of the suitable advisors to advice on various issues which would be involved in the policymaking of the Government and the same is not contrary to any of the provisions of the Constitution or any Legislation and it has also been in continuation of the past conventions and appointment of advisors per se and that space will have to be conceded to the Chief Minister in the existing scheme of the Constitution.

As egards the role of the respective advisors, it was brought to the notice of the court that it is not to assume that advisors in the past have not been addressing the media and in fact they have been only in the media all through in the past. The present challenges and the present circumstances in the state cannot be judged with reference to any past situation and therefore no advisor could be considered unnecessary or a burden on the exchequer.

Pending paddy arrears push ryots into debts in E Godavari

The farmers in East Godavari district had taken up paddy cultivation in 1.60 lakh hectares and they had yielded 13 lakh metric tonnes of paddy produce. The Civil Supplies department has procured 8 lakh metric tonnes of paddy from the farmers.

As per the government norms, money should be disbursed to the farmers within 72 hours after purchase of the paddy produce. The officials had taken the bank passbook and Aadhaar card from the farmers stating that the money



would be e-transferred but they failed to do so till date. In East Godavari district

alone, Rs 1,300 crore arrears accumulated. The farmers have not been paid money for their paddy produce since May 29. Talking to this correspon-

dent, a paddy farmer Nalla Annavaram said that the farmWe have been to the paddy purchase centres and Rythu Bharosa Kendras (RBKs) every day for our money," he lament-

A woman farmer Peddireddy Mahalakshmi said that the officials promised to the farmers that the money would be disbursed within 72 hours but even after 45 days the money had not been paid.

Significantly, Janasena party chief K Pawan Kalyan issued an ultimatum to the government to disburse money to all paddy farmers by the monthend. If the government failed to do so, he himself would come into the streets on the issue, he warned.

The ultimatum of Pawan Kalyan has raised hopes of paddy farmers that they would receive their money soon.



Any attempt of booth-capturing, bogus voting should be dealt with iron hands: SC

Any attempt of booth capturing or bogus voting should be dealt with iron hands because it ulti-mately affects the rule of law and democracy, the Supreme Court said on Friday while dismissing an appeal of a man convicted for rioting at a poll booth in Jharkhand. Referring to its earlier verdicts, a bench of Justice D Y Chandrachud and Justice M R Shah said freedom of voting is part



of freedom of expression. "The essence of the electoral system should be to ensure freedom of voters to exercise their free choice. Therefore, any attempt of booth capturing or bogus voting should be dealt with iron hands because it ultimately affects rule of law and democracy," the bench said. The apex court said the secrecy of casting votes is necessary for strengthening the democracy. Observing that in elections to the Lok Sabha and state legislatures maintenance of secrecy is a must, the bench said in democracies where direct elections take place it is important to ensure that voter casts his vote without fear and being victimised if his vote is disclosed

3 cases registered for violation of HC order on animal sacrifice for Bakri Eid

At least three cases have been registered so far against people who violated the Bombay High Court's order by offering animal sacrifice at temporary slaughterhouses for Bakri Eid in Bhiwandi of Maharashtra's Thane district, an official said on Friday. The three offences have been registered under sections 188 (disobeying order issued by a public servant), 429 (mischief by killing, maiming cattle) among other provisions of the IPC, Cruelty to Animals Act, Maharashtra Police Act and Disaster Management Rules, at Shanti Nagar and Narpoli police stations, the official said. The Bombay High Court had earlier set aside an order



issued by the commissioner of the Bhiwandi Nizampur Municipal Corporation (BNMC) permitting the setting up of 38 temporary slaughterhouses for offering animal sacrifice for Bakri Eid. The court had stated that these temporary spaces were not licensed slaughterhouses and hence, could not be allowed to operate, as the ritual can take place only at designated, pre-licensed slaughterhouses, in accordance with law.

Don't indulge in politics over Covid vax: Mandaviya

Union Health Minister Mansukh Mandaviya on Friday appealed to Opposition parties not to play politics on the issue of COVID-19 vaccines and asserted that everyone should work together to ensure people are vaccinated against coronavirus.

Responding to supplementaries during Question Hour in Lok Sabha, the minister said the government is still in talks with US company Pfizer with respect to making its vaccine available in

There should be no politics on the issue of COVID and vaccination. The prime minister has said this several times," Mandaviya said in response to a question asked by Shiv Sena MP Rahul

"I will also not want to indulge in politics on this issue but I want to present the facts," he said, adding that the prime minister till date has held over 20 meetings and discussions with the state governments and chief ministers.

He said some opposition-ruled states raised the issue that health is a state subject and they should



be taken into confidence. "Many said Health is a state sub-

ject, states said we also need permission to buy vaccines. We said that we have no problem with this. The states said that we want to go out for tender to buy the vaccine. Modi ji said that we are ready to do whatever help is needed," the Health minister said.

He said accordingly, the states were allowed to buy 25 per cent and 25 per cent by the private (sector). The Centre was to procure 50 per cent for the people.

"For the 25 per cent, states

issued tenders and we said we will provide all possible help. The suppliers were limited and the Indian government too was holding talks," he said.

Many issued global tenders. But there were only two Indian companies which had started vaccine manufacturing, the Serum Institute of India (Covishield) and Bharat Biotech (Covaxin), Mandaviya said.

Carrying a banner which read "#PegasusSnoopGate We demand Supreme Court Monitored Judicial Probe", the MPs raised slogans like "ye jasoosi bandh karo (stop this spying)".

Opposition parties have stalled proceedings in Parliament alleging the union government's involvement in the alleged snooping following reports that nearly 300 mobile phone numbers including of journalists, activists, opposition leaders from India and even of union ministers fig-ured in a list of potential snooping targets by Israel's NSO group which sells its Pegasus spyware only to "vetted" governments and government agencies.

The government and the ruling BJP have dismissed the Pegasus Project reports as concocted and evidence-less.

The media reports have been published by The Wire in collaboration with 16 other international publications including the Washington Post, The Guardian and Le Monde, as media partners to an investigation conducted by Parisbased media non-profit organisation Forbidden Stories and rights group Amnesty

Bhabha Atomic centre scientist develops superabsorbent cotton to tackle oil spills

The city-based nuclear research has developed a cotton-based superabsorbent which will help tackle oil spills on water. The cotton is highly efficient

super-hydrophobic or water disliking and also super-oleophilic or oil liking, and has been developed using radiation technology, an official statement said. There is no absorbent cur-

rently available that can remove floating oil from water surface and sediment oil (underwater) simultaneously," A K Mohanty,

the director of Bhabha Atomic Research Centre, said.

He added that the 'superab-Sudhendu Ray Chowdhury, a scientist working BARC's Isotope and Radiation Application division. The innovation has already received a national award from the Union Ministry of Chemicals and Fertilisers in 2019.

One gram of the material can pick up a minimum of 1.5 kg of oil from water media which can be collected by simple squeezing or compression from the super-

absorbent cotton, it said. The cotton is biodegradable



and can be used up to 50-100 times, it added.

J&K police shoots down drone carrying IED material in Jammu, uncovers terror plot

Castle in the air

The Delhi High Court has told political leaders that they must honour the promises they make

It took 89 pages of a Delhi High Court judgment to tell politicians holding high positions in Governments that they cannot go on making promises to people and not honour these. The judgment, in a case relating to a promise made by Delhi Chief Minister Arvind Kejriwal, sends the message that it is important to bridge the gap between law and morality and let the authorities, who are either elected to public positions or who hold positions of power, realise that they "are answerable to the people, especially once they undertake or agree to do or not to do a particular thing" and that the citizens would expect that the Government would implement the promises made. The judgment, by Justice Prathiba M Singh, opens with a telling comment that reflects the mood of the society: "The saying 'Promises are meant to be broken' is well known in the social context." The judgment unambiguously says that promises made by the Government or its



officials are "judicially enforceable" if these are broken. The judgment reminds the political leaders of things enshrined in the business of governance but forgotten in the melee of politics. One is that good governance requires the said trust to be maintained between those who govern and those who are governed. Two, the sustenance of this trust coupled with the legal certainty of an assurance given, cements the relationship between the citizen and the Government.

Three, citizens repose a lot of trust in a promise made by those who hold Government positions and an assurance given is like an undertaking that is com-

patible with public duty. One powerful conclusion is derived from the judgment: Once a representation is made by a high-ranking official, it comes within the scope of its authority. It will have a far-reaching impact on the Indian polity which is used to most politicians in power resorting to populism as forethought and governance as an afterthought. A cursory glance through a day's newspapers will throw up scores of promises made by elected representatives of the people that are meant to remain unfulfilled. The present case relates to some poor labourers petitioning the court that Kejriwal should be asked to fulfil his promise of paying the house rent on their behalf if they were unable to pay it because of COVID-19 exigencies. Kejriwal did make that promise in March 2020 but did not pursue the matter further. The court correctly observes, in the context of the case, "that 'puffing' which may be permissible in commercial advertising, ought not to be recognisable and permissible in governance". The judgment is a serious caution to politicians for whom people are merely voters, not citizens. There are millions of political and electoral promises that remain ignored because there is no law to punish politicians, in power or seeking to be in power, who routinely evade accountability. The judgment should prod those in power to desist from playing with people's legitimate expectations.

Glitz and guts

The Tokyo Olympics have started. Only blood, sweat and tears will lead to glory

he greatest sporting spectacle in the world has begun in Japan, even though under the scary shadow of the pernicious SARS-Cov-2 virus. Over the next two weeks, the best athletes from around the world will compete in 33 sports and 46 disciplines. As always in the 125-year modern history of the Olympics, the global audience will be wowed by the superhuman performances of the athletes, wondering how some



people — with the same number of limbs, developed more or less in the same proportion and living on the same planet as us - can achieve the seemingly unattainable or near-impossible. But, put in a nutshell, that's what the Games are about. However, never before in the history of the modern Olympics have the Games ever been organised in an odd-numbered year even though these have survived boycotts, natural calamities and man-made wars. Another first is that no spectators would be present inside stadia, thanks to the raging COVID-19 pandemic. Think about it, the world's biggest sporting stage, and not a single soul to cheer

the athletes, say, the fastest woman and man on Earth? In a way, it's poignant. Focusing on India, a total of only 20 Indian athletes from seven sports (besides six officials) participated in the opening parade on Friday evening. India is being represented by more than 125 athletes in this instalment of the Olympics, with the overall contingent size being 128 members. The parade number was deliberately thinned owing to COVID-19 concerns and the deputy chef de mission had already made it clear that the athletes who have competitions lined up on Saturday — primarily, archery, hockey, shooting and badminton — would stay away from the opening ceremony festivities. From the men's hockey team, only captain Manpreet Singh participated in the event as he was India's flag-bearer along with pugilist MC Mary Kom when Team India proudly walked out into the stadium at number 21st as per the Japanese alphabetical order. The expectations of 130 crore Indians must be weighing heavy on the Indian contingent as it tries for the first time ever to take its medals tally into double digits. So far, our best showing was in the 2012 London Olympics, where Indian athletes managed to scoop up six medals, though none of them was gold. Hopefully,

things will turn better this time around. Meanwhile, let the Games begin!

The human-animal conflict on the rise



There's an urgent need to stop designating animals as 'vermin' as it takes the protective shield of the wildlife Act away from animals

practice that continues despite strong and reasoned opposition is that of proclaiming species of wild animals as "vermin" and thus putting them out of the ambit of the protective umbrela of the Wildlife (Protection) Act, 1972, the principal instrument for protecting wild animals in India. The wild boar and nilgai have been proclaimed as vermin" in Uttarakhand, the nilgai and boar in some districts of Bihar, and the rhesus macaque in parts of Himachal Pradesh.

The Act does not define the term "vermin" in terms of what it connotes. It just states in Section 62: "The Central Government may by notification declare any wild animal other than those specified in Schedule I and Part II of Schedule II to be vermin for any area and for such period as may be specified therein and so long as such notification is in force, such wild animal shall be deemed to have been included in Schedule V." Animals included in Schedule V can be freely hunted.

The Central Government declares an animal as vermin following requests from State Governments and the ground which has been invariably cited is that it causes damage to crops and poses a danger to human life. There have no doubt been cases in which the Centre has withheld permission. The fundamental question, however, is whether there should at all be a provision for designating an animal as "vermin". There are several reasons for

asking this. For one thing, an article by Anupam Chakravartty, Rajeshwari Ganesan and Rajit Sengupta, published under the heading 'Enemies of the state?' in the *DownToEarth* on June 15, 2016, cites animal rights groups as saying that the drive for killing then underway was based on popular perception rather than data. The country had no data both on the populations of animals proposed to be killed and the extent of crop damage they were supposed to be causing. The article stated that, in fact, Uttarakhand's proposal on the basis of which the Centre permitted the killing of wild boars, clearly said, "There is no scientific survey or census of the wild boar population that has

been carried out. However, since the crop damage caused by wild boar is increasing, the wild boar is estimated to be

overpopulated."
Further, experience shows that once killing is permitted, villagers or designated hunters have frequently not followed the methods prescribed. An example is the case in Kerala where a pregnant cow elephant died following several days of intense agony after she had bitten on a pineapple filled with explosives. Enquiries revealed that the pineapple was intended to kill a wild boar which, as a species, had been declared "vermin". Also, such a barbaric way of killing was not permitted even in the case of wild boars.

State Governments have doubtless laid down restrictions on the methods and guidelines governing killings such as only rifles and pistols to be used and no killing of injured animals running away to forests, and hunting only after receiving permission from the forest department concerned and the village pradhan. But who is to ensure compliance? The fact is, methods that are not permitted are often used. These include laying out live wires

for animals to be electrocuted, trapping them for murder and poisoning them. There is no guarantee that animals other than those declared as "vermin" would not come into contact with such wires or consume the poison.

The argument that State forest department personnel should watch out for the transgressors and deal harshly with them hardly holds water. It would take a very large number of people and vehicles for doing that. Given that most forest departments have to make do with numerically inadequate staff, deployment on such an errand would leave them with very few people to carry out essential functions like curbing poaching and preventing illegal felling of trees. The result may be a serious diminution of protected species like elephants (for tusks), rhinos (for their horns) and tigers for their body parts which are sought for the manufacture of socalled aphrodisiacs.

Apart from the fact that declaring an entire species of wildlife as vermin is contrary to the spirit and content of Article 51 A (g) of the Constitution which enjoins upon both the Government and all citizens to show compassion to all living creatures, animals can hardly be blamed for damaging standing crops and attacking people. The loss of the vegetation they feed on following the destruction of their habitats through encroachment by expanding human settlements, roads and industries, as well as droughts and forest fires, has driven them to

agricultural fields for food. Humans do not realise that their own predatory exploitation of nature is increasing areas of humananimal conflict and making non-human species extinct at the rate of 3,000 a year. In this process, they are also destroying the environment and the conditions that have made human life possible. They need to realise that they are not the lords of the universe and must live in harmony with the world around them, including plants and animals. The Greek sophist Protagoras' famous aphorism "Man is the measure of all things" needs to be amended to read, "Humans are the preservers and protectors of



Painting murals to welcome tourists back to their village

fter a gap of nearly six months, Abakash Nayak, 54, a sea-A soned Pattachitra artist of Raghurajpur, the nationally acclaimed heritage village in Odisha's Puri district has picked up his brush, but this time to paint on the walls of his house. He is painting Lord Ganesh on one wall and Ardhanariswara (a traditional form of Lord Shiva and Parbati) on another. "I am happy like the rest of the artists of Raghurajpur village that we are being asked to paint murals to decorate the walls of our houses. Once the lockdown will ease and tourists will start returning to our village, they will witness the fresh look of the village," he said. The artists of this village have been sitting idle with no work at hand since March last year after the nationwide lockdown was announced. Recently, the State government declared financial assistance of ₹10,000 to each of the 150-odd families to decorate the walls of their houses with Patta paintings, bringing smilesto their faces. In Raghurajpur



crafts village, almost all family members are involved in Patta painting, sculpture work, and paper masks. Patta paintings are made on a piece of cloth known as Patta, or on a dried palm leaf which is first covered with a mixture of gum and chalk. Over the prepared surface, colourful and intricate pictures of gods and goddesses, and scenes from mythological scriptures are painted. The village saw no tourists after March 2020. In November, some tourists started visiting, but the second wave of the Covid-19 pandemic in February spread among the artists. Banamali Maharana, a Shilpiguru awardee, recalls the times when visitors could see all the family members doing artwork, sitting on the porch of their houses. "We are artists...How are we supposed to pick up spade leaving paint and brush?"

The male members mainly do the painting work, while women prepare traditional colours, the base of the paper mask, and other additional work. Some women have also started Patta paintings. Earlier, they would earn between ₹15,000 and ₹20,000 per month. With overseas buyers, they would earn a little more. Now incomes nave drastically dropped. Initially, they managed to make ends meet through loans but money lenders have now stopped giving them money. A few "kind-hearted" art lovers help them out financially. In 2019, Cyclone Fani devastated this artisans' village. All the artwork were damaged. When they began to restart their art, the coronavirus struck. Some started selling vegetables, some opened "paan" shops, or started working as daily wage labourers. But the second wave put paid to these efforts too. Villagers are at present getting vaccinated to fight the virus. "Once unlock happens, the tourists will start coming to our village again. Our vaccination will send a message of reassurance to these tourists," said villager Jitendra who believes that the government should also arrange a vaccination drive for the artists. Raghurajpur is now preparing to welcome tourists with murals on walls. The Department of Language, Literature and Culture in association with Odisha Lalit Kala Akademi has come up with an innovative idea to encourage and support the artists. Each family will receive ₹10,000 as financial assistance while the best five will be awarded after being selected by a special committee. Meanwhile, the younger generation is exploring selling the artwork online. Many have also shifted to the virtual mode to teach Pattachitra-making online. They want the government to train them and arrange for a platform to sell their products to e-commerce

Cairn looking for arbitration money?



Cairn Energy has submitted a detailed series of proposals to the Indian Government for settlement of the case

n the very same day that Prime Minister Narendra Modi effected a massive reconstitution of his council of ministers, India got in the shock in the form of a French court freezing residential properties belonging to the Indian government in Paris following a retrospective tax dispute with British power and energy giant Cairn

The decision will impact 20 properties valued at Euro 20 million (₹177 crore), as part of a guarantee of the debt owed to Cairn that exited India a few years ago. The company with a market capitalisation of £755 million (about ₹7,800 crore) - has filed cases in several countries to pursue the unpaid international arbitration award of \$1.7 billion (₹13,750 cm.) The contribution of \$1.7 billion (₹13,750 cm.) (₹12,750 crore). The company also filed cases in New York, seeking judicial confirmation that Air India can be classed as the alter ego of the Indian state and thereby jointly liable for the arbitral award.

The French court decision is unfortunate as it is feared it can start a new diplomatic conflict and it also impinges on the sovereignty of the country. It might create an image that India can be taken lightly by MNCs and other private play-


And that is what exactly happened. A case similar to Cairn is that of Devas Multimedia, floated by ex-ISRO executives. It had entered into a deal with ISRO's Antrix Corp. and the National Company Law Tribunal said the 2005 spectrum lease deal was fraudulent. Deutsche Telekom later picked up its

Devas moved an arbitration tribunal saying that its multi-million-dollar investments lost value because of the annulment. In 2020 the tribunal awarded Devas \$1.2 billion. It is now seeking payment from India (now stayed by Supreme Court) in a New York court, asking Air India to pay the amount or forfeit its property, including planes, cargo handling, equipment, and artwork.

In both cases, the authorities in India bungled in pursuing the case. In the case of Cairn and Devas, they moved the courts in Germany and The Hague even as the Indian arguments on jurisdiction and criminality in two arbitrations under Bilateral Investment Treaty (BIT) under India-Mauritius and India-Germany agreements were lost.

Cairn and Devas have chosen flagship Air India planes and its prime property as a pressure tactic to force India into payment negotiations. Trying to seize planes or property to realise unpaid dues may be an extreme tactic but there are precedents. Aircraft are valuable, mobile, and relatively easy to sell. A few years ago, US hedge fund Elliott Capital Management seized an Argentine naval vessel to collect on bonds on which the country defaulted in

recently mentioned by President Ramnath Kovind, retrospective tax, and confusion on predating taxes is an unresolved quagmire. There is an OECD move to have a global minimum tax on corporates at 15 per cent or higher. The UPA government introduced the controversial retrospective tax in March 2012. The NDA II was expected to correct it after 2014 but the bureaucratic system continued

with the supposed oddity.

The Supreme Court of India on January 20, 2012 ruled in favour of Vodafone overturning a 2010 decision of the Bombay High Court which ruled that Vodafone was liable to retrospectively pay \$2 billion income-tax because Indian capital gains taxes (CGT) applied on the share transfers between two non-resident entities

But the smitten tax officials took a different route to circumvent the SC ruling with the introduction of the retrospective tax in March 2012, allowing the government to levy CGT — a move that was piloted by former finance minister Pranab Mukherjee in 2012.

In March 2018 the then finance minister, the late Arun Jaitley, said that the decision to tax Vodafone retrospectively by UPA was erroneous and also that the "present government will not be going down that path". On July 18,

2014, he had said that India would trust of its shareholders. not levy any tax with a retrospective effect that creates an additional burden. But Jaitley made no move to repeal the 2011 law.

The statements of Jaitley and Prime Minister Narendra Modi pledging not to use retrospective taxation to overturn on Cairn Energy were used by a threemember tribunal at the Permanent Court of Arbitration in The Hague on December 20, 2020, to rule that the 2006 reorganisation of Cairn Energy's India business before listing on local bourses was not "unlawful tax avoidance" and ordered the tax authorities to drop the tax demand. This did not happen due to bureaucratic audacity.

Cairn has moved for implementation of the arbitration award in several jurisdictions on different continents, including the US, the UK, Canada, Singapore, Mauritius, France, and the Netherlands as the company intends to focus on high-value assets. Cairn has submitted detailed series of proposals to the Indian government for settlement of the case. The NDA government is now opposing its stand apparently under pressure of officials.

It rattles India. Would the country lose its flagship aircraft carrier and other prime assets? Technically it maya be so but authorities say that they are yet to receive a notice or communication from the French court and the government would vigorously defend its case. It translates into more litigations as well as negotiations. Director of Cairn's corporate communication David Nisbet says that the company is keen on an agreed settlement with India and keep the

So, it has identified \$70-billion worth of Indian assets to retrieve the \$1.7 billion award. However, an international company knows that while it is important to contest governments, it also needs their goodwill to be in business.

The government is also in negotiations since January 2021, even before the present French order was flashed. It may give Cairn Energy one of the surrendered oilfields — Ratna R-series in the Arabian Sea that was taken away from Essar-Premier Oil in 2016 instead of an arbitration payment. Cairn had spudded the biggest inland oil wells in Barmer, indicated in a survey by NGRI. It exited the country after it was given ₹10247 crore retro-tax demand. Apparently, the government wants that the biggest oil company with one of the lowest operational costs come back to India to shore up its image as also create a show window for the international investors.

It is also looking at the other option of giving it the Barmer oileld. Vedanta, which now operates the field, has so far has not agreed to the government conditions for extending its contract. Under Vedanta, Rajasthan oilfields have seen a steady decline in output. Cairn has protested against the high \$9 cess per barrel on the oil produced.

India has seen a "significant improvement" in the UNESCAP's Global Survey on Digital & Sustainable Trade Facilitation with a 90.32 per cent score.

After evaluation of 143 economies, the Survey 2021 has highlighted India's significant improvement in the scores on all five key indicators -- transparency, formalities, institutional arrangement and cooperation, paperless trade and cross-border paperless trade.

India has scored 90.32 per cent in the global survey on Digital and Sustainable Trade Facilitation. This is a remarkable jump from 78.49 per cent

Under the transparency indicator, the country scored 100 per cent in 2021, up from 93.33 per cent in 2019. The score for 'paperless trade'

improved to 96.3 per cent in 2021, from 81.48 per cent in 2019. The score in the institutional arrangement and cooperation indicator improved to

cent in 2019. In a statement, the Finance Ministry said that India has seen "significant improvement"

The 2021 Survey includes an assessment of 58 trade facilitation measures covered by the WTO's Trade Facilitation Agreement. A higher score for a country also helps businesses in their investment decisions.

Textile Ministry likely to get Cabinet nod for MITRA scheme

The textile ministry is in the process of obtaining approval of the Union Cabinet for the proposed Mega Investment Textiles Parks (MITRA) scheme, under which seven such parks will be set up in the country over the next three vears, Parliament was informed on Friday.

Minister of State for Textiles Darshana Jardosh said the scheme was announced in Union Budget 2021-22.

"Ministry of Textiles is in the process of obtaining approval of the Cabinet for the proposed scheme. Once, the proposed scheme is approved and modalities are finalized, the details of location, government funding structure etc. will be decided," she said in a written reply to the Lok Sabha.

In a separate reply, the minister said during the pandemic, CCI (Cotton Corporation of India) procured 20.72 lakh bales valuing Rs 5,615 crore from 4 lakh cotton farmers.

However, during the entire cotton season 2019-20, CCI



made a record procurement of 105.15 lakh bales (equivalent to around 546.80 lakĥ quintal kapas) and an amount of Rs 28,500 crore was disbursed to around 21.50 lakh cotton farmers directly into their bank accounts, she said.

"During current cotton season 2020-21 (October 1, 2020 to September 30, 2021), CCI opened more than 450 procurement centres in all cotton

growing state. CCI continued its procurement of cotton under MSP operations since beginning of season to avoid the eventuality of distress sale by farmers and has procured 91.89 lakh bales so far (equivalent to around 482 lakh quintal kapas)," Jardosh said.

Timely refund by online retailers must be a criterion: Nasscom

Rationalising obligations in line with activities of relevant entities, and limiting fallback liability of online retailers to ensuring timely refund to consumers are among the recommendations suggested by Nasscom to the proposed ecommerce rules.

The IT industry body on Friday said its recommendations on the proposed e-commerce rules "focus on strengthening consumer protection, ensuring that the obligations are proportionate to the underlying risks and are unambigu-

The draft e-commerce rules released by the government on June 21 propose to ban fraudulent flash sales and mis-selling of goods and services on ecommerce platforms.
Appointments of chief compliance officer/grievance redressal officer are among the key amendments proposed under the Consumer Protection (E-Commerce) Rules, 2020.

Nasscom said some of the



proposed amendments "appear to be beyond the scope of the Consumer Protection Act 2019 (COPA19) and are instead a subject matter of either the Competition Act, 2002 or the Information Technology Act, 2000...in our submission, we undertook a clause-by-clause review of the proposed amendments and suggested the way forward".

The government on Monday extended till August 5 the deadline for public comments on pro-

posed amendments to the Consumer Protection (E-Commerce) Rules, 2020. Earlier, the last date for public comments on the draft e-commerce rules was July 6.

Some of the recommendations include removal of the word 'own' from the definition of an e-commerce entity.

"This is with the aim of excluding from the scope those technology entities that own the digital platform and license/provide it to e-commerce companies.



Almonds, a saviour for AI to monitor, identify youngsters with prediabetes

years, the number of people living with dia-betes globally has quadrupled and this upward trajectory is particularly steep in India. Indians have the highest annual progression to type 2 diabetes from pre-diabetes (about 14-18%), which calls for lifestyle interventions to help reverse this trend.

When it comes to snack choices, almonds may be one easy — and tasty — dietary strategy. A new study showed that almond snacking helped improve glucose metabolism in adolescents and young adults in India with prediabetes.

This randomised controlled clinical trial aimed to determine the effect of almond consumption on factors of metabolic dysfunction including blood glucose, lipids, insulin, and selected inflammatory markers in adolescents and young adults (aged 16-25 years old) with predia-betes, who resided in Mumbai, India. The study was a randomised, parallel trial of 275 participants (59 male, 216 female) with impaired glucose metabolism (prediabetes). At the start of the study, partici-pants' weight, height, and waist and hip circumferences were measured, and fasting blood samples were taken. Participants also underwent a glucose toler-ance test and their lipid

profiles were assessed. The almond group (n=107) ate 56 grams (about 2 one-ounce servings, or ~340 calories) of unroasted almonds every day for three months and the control group (n=112) consumed a savory snack with the same number of calories. The consumption of almonds as snacks was tested in the almond group, while the control group consumed a savory snack that is commonly consumed by this age



group in India. Both the almond and savory snacks accounted for ~20% of participants' total calorie intake.

Throughout the duration of the study, partici-pants were monitored to ensure they were compliant in eating their snacks. At the end of the study, participants completed dietary intake assessments and the same measurements and blood tests were performed again.

In the almond group, HbA1c (a measure of longterm blood sugar control that also serves as a diag-nostic criterion for prediabetes and diabetes) decreased significantly compared to the control group. Improving blood sugar levels at the pre-diabetes stage may help prevent or delay the development of diabetes. Additionally, almond consumption reduced total cholesterol and "bad" LDL-cholesterol signifi-

cantly compared to the control group, while maintaining 'good' HDL-cho-lesterol levels. There were no changes

in measures of weight, height, waist, or hip circumferences or biochemical markers nor macronutrient intake between the almond group and the control from the start to post-intervention. İnflammatory markers (TNF-a and ÍL-6) decreased in the almond group and increased in the control group, but this was not a statistically significant result. Fasting blood glucose levels were significantly reduced in the control group compared to the almond group post-intervention. In the almond group, FG:FI ratio (fasting glucose: fasting insulin) decreased while it increased in the control group but was not statistically significant.
"Lifestyle changes

including improved nutri-

tion and exercise targeted at teens and young adults have the potential to halt the progression from prediabetes to type 2 diabetes. Results from this study show that the change does not have to be a major one — simply including a twice-daily snack of almonds can make a difference. The study results are very promising in showing how almonds improved total and LDLcholesterol levels and reduced HbA1c levels in just 12 weeks of consumption," said principal investigator, Dr. Jagmeet Madan Ph.D., Professor and Principal, Sir Vithaldis Thackersey College of Home Science (Autonomous), SNDT Women's University (Mumbai).

Further research is needed to investigate the effects of almond consumption on the same measures in other age groups and of different

ethnicities. This research joins another study investigating the potential role of almond consumption in younger people. Researchers at the University of California Merced, in a study funded by the Almond Board of Ćalifornia, demonstrated that for those college students who skip breakfast, a morning snack of almonds can be a smart option. Among predominantly breakfast-skipping college freshmen (73 males and females, 18 to 19 years old), including a morning snack — either of almonds or graham crackers reduced total cholesterol and improved fasting blood sugar levels, but the benefits were greater with almonds. 
esearchers from the UK's prestigious University of Sheffield have developed artificial intelligence which they say can effectively monitor a person's snoring levels and identify sleep disorders.

Professor Guy Brown and Dr Ning Ma from the University's Speech and Hearing Research Group, can monitor a person's snoring levels and identify sleep disorders such as sleep apnoea, the university said in a press release.

The technology is being commercialised through a new app - SoundSleep — available on iOS devices and soon to be available on Android, it said. Currently, the app uses Sheffield AI to enable people to monitor the sounds they make while sleeping through their smartphones. The app records and tracks snoring levels and provides nightly reports to help people discover the causes, factors, and solutions. However, the Sheffield team has now developed the AI to be able to diagnose sleep apnoea caused by sleep disorders, the release said.

Sleep disorders affect people across the globe, with approximately 2.5 million people in the UK suffering from sleep disorder conditions, including obstructive sleep apnoea (OSA). Sleep apnoea causes a person's breathing to stop and



start while they sleep and they may also make gasping, snorting, or choking noises, wake up a lot and/or snore loudly. Without treatment, the condition can lead to high blood pressure, a higher chance of having a stroke, depression, mood swings, difficulty concentrating at school or work, and an increased risk of having a serious accident due to

tiredness. Sleep disorders such as sleep apnoea are usually diagnosed in specialist sleep clinics, but these can be expensive and also disruptive for patients as they usually have to wear a range of devices that can feel uncomfortable or invasive. Many sufferers of sleep disorcould improve their condition without the need for treat-

To address these challenges, the University of Sheffield researchers launched a project to enhance the AI they had already developed for SoundSleep so it can identify sleep disorders from the sounds people make while sleeping.

This more sophisticated AI will soon be added to the app so that people can monitor their sleep and identify sleep disorders using their smart-phones in their own homes, the release said. The app could also help them make changes to their lifestyle or bedtime routine to help them get a better night's sleep, according to the university press release.

'We understand that finding that secret to a good night's sleep can seem stressful and confusing, so what we are trying to do with our research is use the latest, state-of-the-art artificial intelligence to help people get to the bottom of what is preventing them from getting a good night's sleep as easily as possible," Dr Ning Ma, Research Fellow in the University of Sheffield's Department of Computer

Science, said.



The sound of music



Recently, they made headlines for their work on Amit Masurkar's Sherni, headlined by Vidya Balan, which won accolades not just for its hard-hitting performances and gripping nar-rative but also for its haunting background score. Just a fort-night after the release of the film, the pair were in the news for their work on the score for Hungama Hai Kyon Barpa from Ray, an anthology based on the works of Satyajit Ray. Going through their itinerary, we knew we had to talk to them before they get any bigger than they already are.

Not much is known about how their collaboration came to be and when we ask them Benedict shares that ever since they were introduced to each other by another musician, Salome Rebello, they got along really well. "It wasn't one definite moment that initiated our alliance. We both floated the idea in different contexts... about trying different things we were interested in that had come up in conversation. The first instance I remember was Benedict coming in to join the rehearsal for a play we were developing. We work-shopped viola and acting improv together and it went incredibly well. This led to more conversations and here we are today," adds Naren, with a smile.

Indeed, the conversations led to an official collaboration in 2010 for Anurag Kashyap's *That Girl In Yellow Boots*, but how did

Naren reveals, "I had worked on the music for a theatre piece Anurag had produced, *The* Skeleton Woman by Kalki Koechlin and Prashant Prakash. He heard the music and asked me to score the film. As soon as he did, I asked Benedict if he'd like to work on it with me."

While most of us have adapted (more or less) to the WFH culture over the past year in light of the pandemic, the two have been working remotely all along. And they have been doing it splendid-

Known for stitching their genre-bending music according to the director's vision, Benedict says that it is just how they work. "We embark on a voyage of discovering new sounds, playing with different elements, with each project. However, it has to be said that we enter the realms of the unknown with our working styles in place — which we've spent time refining — and with those foundations, we can then work individually with each director to realise his/her vision of what the music should be like," he reveals. Naren goes on to add, "With each project, our process changes slightly with the director we work with. However, our journey always starts by gaining clarity on what role music needs to play in the film and what we instinctively feel usually works. It is always about finding musical solutions to the right questions. There is trial and error but it's directed in a specific direction with the hope of

finding what we're looking for."
When we ask them if they have any favourites that they regard as the cream of the lot from their growing repertoire of composition, Benedict has a very fitting response, "Impossible to pick one, as you take a great deal from each project. In any project, there are always elements you're thrilled with and things vou'd like to change, but that's the nature of the work. Plus, importantly, every project is so different. If I listen to *Paatal Lok* one day, Ray the next, and Tryst the day after, I'll be entering drastically different worlds, all of which serve a certain purpose."

As we wrap up our conversation, Naren shares that both of them spend time making their own music. "While Benedict produces a lot of singles and albums, we are currently working on a body of work as a duo for release outside of the scoring arena," he tells us.

We don't press for more information since there is no doubt they have a nice surprise in store





Olympics were declared open in an eerily empty stadium on Friday after defying a year's pandemic delay and lingering coronavirus threats that will make them perhaps the most unusual Games in

Japan's Emperor Naruhito made the announcement against the backdrop of thousands of vacant seats at Tokyo's 68,000-capacity Olympic Stadium, after Covid-19 forced organisers to ban spectators at all but a handful of venues.

"I declare open the Games of Tokyo," said the monarch, wearing a white surgical mask.

The stripped-down ceremony, simplified to reduce coronavirus risks, unfolded in front of fewer than 1,000 VIPs and several thousand athletes.

A reduced parade of about 5,700 athletes, far lower than the usual numbers, filed into the stadium, not all of them socially distanced but all wearing

International Olympic Committee president Thomas Bach acknowledged the Games would be very different from what all of us had imagined."

But "today is a moment of hope", he said in an address.

The 16-day Games, with 339 Gold medals across 33 sports, have a surreal air after the pandemic compelled organisers to make this the first Games with virtually no spectators.

Tokyo: Entering the Tokyo Olympics on the back of an unprecedented run that began sometime after the inexplicable meltdown in the Rio de Janeiro Games, Indian shooters bagging a medal or two, or, even three to four, is a tangible reality.

All of the 15 shooters are capable of winning medals, but few are seen as sure shot to secure podium finishes in the events that start on Saturday.

One among them is the highly-skilled Saurabh Chaudhary, who will have a few Olympic and world champions standing in his way to glory at sport's biggest showpiece.

Alongside Abhishek Verma, audhary will be part first competition day action in the men's 10m air pistol event.

But before that, the fate of Apurvi Chandela and Elavenil Valarivan — in the women's 10m air rifle event — will be decided. A good outing for either of them means India will have won their first medal in these Games.

Both Chandela and Elavenil will enter the competition with plenty to look forward to, despite the occasional blips here and there. The 21-year-old Elavenil, world number 1 and considered one of the country's finest rifle shooters after some fine performances since breaking into the senior team, will certainly fancy

her chances. On the second competition day, India will have the sensational Manu Baker and the hard-working Yashaswini Singh Deswal representing the country in the women's 10m air pis-



tol competition.

The women's 10m pistol event has attracted maximum number of entries but that should not worry the two Indian shooters given their skills and consistency over the years.

In the men's 10m air rifle event, India will have the teenaged Divyansh Singh Panwar and the experienced Deepak Kumar, with the former especially seen as a strong contender after his superb run of form since breaking into the

Indian archers brace up for Korean challenge

Tokyo: World No 1 Deepika Kumari was inconsistent but the male archers' performance was simply underwhelming in the Olympics' ranking rounds, prompting a rejig of India's mixed pair combination on a topsy-turvy day at the Yumenoshima Park on Friday.

The Koreans, who stayed away from all International competitions in the build-up to the Olympics since 2019, reigned supreme, including a top-three finish in the women's section where young sensation An San shattered a 25-year-old Olympic record.

The Indian men's team of Tarundeep Rai, however, did not post particularly impressive scores and just about managed to sneak into top 10 in the team rankings.

Deepika slipped from fourth at the halfway mark to finish ninth with 663 points which was way below her best International ranking score of 686. "I feel my performance was good as well as bad...It was in between I would say," Deepika said.

Deepika's biggest challenge is likely to be in the last-eight where she might run into San who is making her Olympic debut. "I want to show my best performance here and İ will show that in my next rounds," Deepika vowed to come back
