# Govt orders 44 cr doses Vaccine prices capped of Covaxin, Covishield

216 cr dosages will be made available between August and Dec, Govt had said earlier

PNS NEW DELHI

A fter claiming that 216 crore dosages will be made available for vaccination between August and December, the Government on Tuesday said it has placed orders for 44 crore doses of Covishield and Covaxin to be delivered during that period.
In total, 127.6 crore vac-

cines will be supplied to the Centre, including the previous orders, said Dr VK Paul, member (Health) Niti Aayog, at a Press conference here.

Additionally, 30 per cent of advance for procurement of both the vaccines has been released to Serum Institute of India and Bharat Biotech, a move aimed to fast track the availability of the jabs.

Dr Paul said a few days ago an advance order to purchase 30 crore doses was placed with Biological E's vaccine, which will be available by September. "By July, we hope to get 53.6 crore doses of vaccines," said Dr

On May 14, Dr Paul at the Press conference said at least 216 crore doses are likely to be produced between August and

doses of Covaxin. Presently only these two vaccines are being provided under the national vaccination pro-gramme that was launched on January 16. Dr Paul had also said Russian anti-Covid vaccine Sputnik V will be made available by May 22, but it is yet to make its entry in the market.

On Tuesday, Dr Paul maintained, "In immediate followup of the Prime Minister's announcement of these changes in the guidelines of national Covid vaccination programme yesterday, the Centre has placed an order with Serum Institute of India for 25 crore doses of Covishield and with Bharat Biotech for 19 crore doses of Covaxin. Additionally, 30 per



cent of the advance for pro-curement of both the Covid vaccines has been released to the two manufacturers."

More orders could be placed with both the companies as the 18-44 age group has been also added under the Centre's

Amid allegations that private hospitals are engaged in brazen profiteering in the midst of such humanitarian crisis, the Government has fixed the price of Covishield at ₹780, Covaxin at ₹1,410 and Russian vaccine Sputnik V at ₹1,145 a dose. This includes taxes as well as a

### 3rd wave won't affect children more: Guleria

 $E_{\text{gearing up to ramp up}}^{\text{ven as various States are}}$  medical facilities for children in anticipation that health threat to them will be severe in the third wave, Dr Randeep Guleria, Director of AIIMS, Delhi, on Monday allayed the fear saying there is no data any-where in the world to corrob-

orate these claims.
"It is a piece of misinformation that subsequent waves of the Covid-19 pandemic are going to cause severe illness in children. There is no evidence to show that the third wave of Covid-19 infections will affect children more than others," Dr Guleria said while addressing the Health Ministry's Press conference on Tuesday.

"If we look at all data, including Indian data from the first and second wave or even global data, there is nothing to show that either the old or new variants led to more infection among chil-

dren," Dr Guleria said. He added, "According to the second wave data, out of all the children admitted to hospitals with Covid-19, 60-70 per cent had co-morbidi-ties or low immunity, some were on chemotherapy. Most healthy children who were infected recovered without the need for hospitalisation." "We see waves of infection

in the case of respiratory viruses because the virus mutates and human behaviour changes during a pandemic," he said.



## Haryana CM dismisses CMIE data on high unemployment rate in State

Haryana Chief Minister Manohar Lal Khattar on Tuesday debunked the data related to the state's unemployment rate at 29.10 percent and claimed that the CMIE

report is factually wrong.

The Chief Minister was responding to the latest data of the Centre for Monitoring of Indian Economy (CMIE) for the month of May which has put the rate of unemployment in Haryana at 29.10 percent. Citing the report, Congress general secretary Randeep Singh Surjewala has accused the BJP-JJP led State Government of pushing the future of the state's youth into

Khattar, while talking to the mediapersons in Panchkula said that the CMIE report claiming that Haryana has a very high unemployment rate

states, he alleged.
The Chief Minister said that the State Government has the data from Parivar Pechchan Patra (family ID cards) in which people who say they are unemployed have given selfdeclaration. As per the data, about 5-6 lakh are those who

call themselves unemployed. Out of these 5-6 lakh too, 2 to 2.5 percent are those who remain unemployed for a brief period, eg. while changing jobs or for a few months after com-pletion of their graduation, he

On unemployment rate in the state, Khattar further said that five to six per cent unemployment rate overall can be there in the state and that too includes factors impacted by COVID situation.

Unemployment figures like 30 percent, 35 percent or 40 per cent, which means more than not correct. We don't have such big numbers of unemployed people in Haryana, he claimed.

He further said the State Government has been constantly making efforts to create job opportunities for the youth through various initiatives like skill development and training

Everyone cannot get gov ernment jobs. Out of our total population in the state, 3 to 4 lakh are associated with the government sector, he

**And fixed** power charges on trade and industry for a year

Shiromani Akali Dal (SAD) president Sukhbir Singh Badal on Tuesday demanded the Congress Government waive off property tax and fixed charges on electricity bills for the industrial sector as well as shops, hotels, and restaurants for one a period of one year to compensate them for the losses suffered by them due to repeated lockdowns.

He said that the Chief Minister Capt Amarinder Singh had promised to waive off fixed charges on power bills for a two month period

and did not implement the

"Besides the industrial sector, the trade and hospitality sectors have gone into red. It is absolutely essential to give them a breather by waiving off fixed charges for these sectors for one year starting from April 1, 2021, to March 31, 2022," he said adding that similarly, one year property tax waiver should also be implemented for the trade and industry sectors to help them tide over the current COVID-19 induced crisis.

At the same time, Sukhbir announced that in case the Congress Government remained insensitive to the suffering of the trade and industry and refused to extend any relief to these sectors, the SAD would implement these waivers once it assumed power in the State in 2022.

53 unreported deaths added to death toll on **Tuesday**

 $T^{\text{he state health department}}_{\text{reported 546 new cases of Covid-19 and 13 deaths from}$ the disease in Uttarakhand on Tuesday. The authorities also reported 2,717 recoveries from the disease on the day. The state now has 3,34,965 (cumulative) patients with the disease while a total of 6797 patients have succumbed to the disease so far. A total of 2,717 patients have so far recovered from the disease and the recovery percentage has climbed to 92.63 per cent. The samples of 25,474 suspected patients were sent for testing on Tuesday and the sample positivity rate is at 6.69 per cent. The recovery percentage from the

disease in the state is 92.63 per

Out of the 13 deaths reported on Tuesday, six occurred at All India Institute of Medical Sciences (AIIMS) Rishikesh. Sciences (AIIMS) KISHIKESII. Similarly death of two patients each occurred at Mahant Indiresh hospital Dehradun and HNB base hospital Srinagar, Pauri Garhwal.
The authorities also added

53 deaths in the toll which had occurred in the past but were not reported earlier. Incidentally 40 of these deaths were reported from Dehradun district alone. The AIIMS Rishikesh reported 25 deaths which had occurred in the past on Tuesday.

The provisional state capital Dehradun reported 136, Pithoragarh 88, Haridwar 69, Nainital 56, Almora 43, Udham Singh Nagar 41, Tehri 33, Chamoli 23, Rudraprayag 16, Bageshwar and Champawat 13 each, Uttarkashi eight and Pauri

The state now has 11,885 active patients of the disease. Haridwar is the top position in the list of active cases with 1,998 cases. # Jab wastage major issue, to hit allocation negatively: Centre

Wastage of vaccine will affect the allocation negatively, the Government cau-tioned States on Tuesday in the "Revised Guidelines for imple-mentation of National Covid Vaccination Programme," issued by the Union Health Ministry. Further, in a move aimed to ensure that vaccines are distributed as per the need and are not wasted, the Centre said the doses provided free of cost will be allocated to States based on criteria such as population, disease burden and

their vaccination progress.

Vaccine wastage has been a major issue in the vaccination programme, with some States reporting much higher wastage than the national average. The Health Ministry and Prime Minister Narendra Modi have repeatedly called for reducing

vaccine wastage.

As announced by the Prime Minister on Monday, the revised guidelines stated that the Government of India will procure 75 per cent of the vaccines being produced by man-ufacturers in the country.

"The vaccines procured will continue to be provided free of cost to states and UTs as has been the case from the commencement of the national vaccination programme. These doses will be administered by the states/UTs free of

cost to all citizens as per priority through government vacci-

nation centres.
"Within the population group of citizens more than 18 years of age, states/UTs may decide their own prioritisation factoring in the vaccine supply schedule," the revised guidelines

In order to incentivise production by vaccine manufacturers and encourage new vaccines, domestic vaccine manufacturers are also given the option to provide vaccines directly to private hospitals. This would be restricted to 25 per cent of their monthly production, it stated.

Further, at a time of acute vaccine shortage, the continuation of such a policy will dilute and weaken the need for universal vaccination essential to prevent a third wave of the Coronavirus. for the private hospitals permitted by the Government," said CPI (M) in a statement.

CPI national secretariat said making free vaccines available to all citizens of the country is the responsibility of the Central Government and not at all an act of charity. "The party feels that there is no logic in allowing private hospitals to provide 25 per cent of vaccines and vaccination with a charge of Rs.150. The party emphasises that the entire vaccination must be free and be the responsibility of the central government," the CPI said.

## e-vouchers to help poor get vaccine at pvt centres

Use of non-transferable electronic vouchers approved by the Reserve Bank of India (RBI) will be encouraged to enable people to finan-cially support Covid-19 inoculation of economically weaker sections at private centres, according to the revised guidelines issued by the Centre on

While the Co-WIN plat-

form provides every citizen the facility of conveniently prebooking vaccination appoint-ments, all Government and private vaccination centers will also provide onsite registration facility, available both for individuals as well as groups of individuals, for which detailed procedure is to be finalised and published by states/UTs, said the guidelines.

The Covid vaccination in the country commenced with vaccination to all healthcare workers.

The program was expanded with time to include vaccination of frontline workers.

and power. I will take into confidence all factional leaders and work for bringing the Congress back to its golden days in Kerala," K Sudhakaran told reporters immediately after the announcement was made by the Congress High Command in New Delhi.

Thiruvanchur Radhakrishnan MLA and former minister, said the appointment of Sudhakaran marked a transitional change in the Congress. "We will extend all help and cooperation to the new president," said Radhakrishnan during his interaction with the reporters.

As on date there are two prominent factions in the Congress in Kerala which are led by Oommen Chandi and Chennithala respectively. Chennithala had raised a rebellion against the High Command for overlooking him and appointing V D Sathishan ized that the new generation of party workers wanted a fresh face.

Though Sudhakaran is 70, he is liked by party workers cut-ting across factions because of his bold and frank approach to all issues. The immediate task of Sudhakaran is to make the party ready for the 2024 Lok Sabha election. The Congress is yet to recover from the shock debacle it faced in the hands of the CPI(M)-led LDF in the recent assembly election and the party's popularity has sunk to its lowest ebb.

Senior leaders like P J Kurian, K V Thomas, V M Sudheeran and M M Hassan have welcomed the appointment of Sudhakaran and assured him of all cooperation. The immediate task before Sudhakaran would be the balancing of the communal equations in the Congress as the party chief and Leader of the Opposition are from the Hindu

 $B^{\text{JP's Leader of Opposition in Bengal}}_{\text{Suvendu Adhikari on Tuesday}}$  termed the political situation in the State worse than the one that should demand implementation of Article 356.

Soon after emerging from a meeting with Union Minister Amit Shah in Delhi the senior BIP leader said "though I should not air my personal opinion and though our national leadership will take a decision in this regards ... I can only say that the situation in Bengal is worse than the one that demands imposition of Article 356."

Saying that the Mamata Banerjee Government had been using the entire State machinery including IAS and IPS officers "to perpetrate State terror" the Opposition Leader said "the situation is unprecedented ... Bengal had not witnessed similar situation before where the people are being persecuted just for being in the opposition camp." He however warned the "people who are perpetrating this terror raj in

In a development that will in likelihood lead to her disqualification as a Lok Sabha member, the Nagpur bench of the Bombay High Court on Tuesday quashed the caste certificate used by \*former actressturned-sitting Independent MP from Amravati constituency Navneet Kaur Rana making a "fraudulent claim" that she was from "Mochi" Scheduled Caste (SC) to contest 2019 LS polls.

In its ruling on an election petition filed by former MP and Shiv Sena leader Anandrao Adsul challenging Navaneet Rana's election to the Lok Sabha, a HC division bench ordered the "cancellation and confiscation" of her "fraudulently obtained caste certificate ordered her to surrender the certificate and a pay a fine of ₹2 lakh to the Maharashtra Legal Services Authority within a fortnight.

remained silent on the disqualification of Navneet Rana as an MP, a HC bench of Justices R. D. Dhanuka and V. G. Bisht indicated as much when it ruled: "It is declared that all consequences in law, which may occur on cancellation and confiscation of the fraudulently obtained caste certificate by the respondent no.3 (Navneet Rana) would follow". Navneet Rana is the wife of

independent MLA from Badnera Ravi Rana, who is the founder of Yuva Swabhiman Party (YSP). She is a relative of the yoga guru Ramdev Baba. Contesting the 2019 Lok Sabha polls from Amravati (SCreserved) constituency, she had defeated veteran Shiv Sena leader and former Union Minister Anandrao Adsul.

"In our view the caste claim made by the respondent no.3 (Navneet Rana) for obtaining a caste certificate as schedule caste itself was fraudulent and Though the judgement was made with intention to

obtain various benefits available to a candidate from such schedule caste category knowingly well that she does not belong to that caste. The application thus itself was made intentionally to make a fraudulent claim to enable the respondent no.3 to contest an election for Member of Parliament on the seat reserved for a scheduled caste candidate," the judges observed. Quashing the order passed

by the District Caste Scrutiny Committee on November 3 2017 validating Navneet Rana's claim that she was from "Mochi" community, the HC bench noted: "The said caste certificate obtained by the respondent no.3 from the com-petent authority was obtained fraudulently and thus it was the mandatory duty of the Caste Scrutiny Committee to cancel the said fraudulently obtained caste certificate and ought to

have been confiscated". It may be recalled that the caste certificate was issued to

Navneet Rana by the Deputy Collector of Mumbai in Aug. 2013 and validated by the District Caste Certificate Scrutiny Committee (DCCSC), Mumbai Suburban, on November 3, 2017, which was challenged by Adsul and a social worker Ŕaju S. Mankar of Amravati.
Adsul contended that

Navneet Kaur hails from Punjab and belongs to the Labana Caste, which does not fall in the SC category in Maharashtra.

Passing strictures against the District Caste Scrutiny Committee that validated Navneet Rana's caste claim, the HC bench noted: "We would also like to remind the Caste Scrutiny Committee that since it is endowed with the power of validating or otherwise of the Caste Certificate, a solemn duty is cast on it to be more cautious and careful and must considerate all attending circumstances so as to enable it to validate or otherwise the Caste Certificate

"In the present case we do not find any such judicious approach on its part to say the least and rather seems to be swayed away by extenuating circumstances, keeping aside the application of judicious mind," the Judges observed, as they hoped that the scrutiny committee would henceforth 'take all caution and guarded approach before validating the Caste Certificate.

Quoting an SC judgement in the State of Tamil Nadu and others v/s. A. Gurusamy, AIR 1997 case in which the apex court held that the courts would not lend assistance to perpetrate fraud on the Constitution, the Nagpur HC division bench noted: "Fraudulent acts are not encouraged by the Courts. The constitution does not postulate conferment of any special benefit on those who do not belong to the category of SC/ST people for whom the provision was

## Wide angle

Hurting the BJP outside West Bengal seems to be the TMC's game plan

the Trinamool Congress harbours political ambitions outside West Bengal. Nothing new, but the fresh assertion by Mamata Banerjee's nephew, the newly-appointed party general secretary Abhishek Banerjee, smacks of a spirit to take on the BJP rekindled by its resounding return to power in the State. For the record, the younger Banerjee says: "...If we decide to launch ourselves in other States, we will do so not to win few seats or to increase our vote share but to win power in that State by taking the BJP head on." The Trinamool Congress appears to have a game plan to influence politics in areas where Bengalis reside in large numbers. One will have to watch how the Trinamool Congress plays the electoral game in next year's Assembly polls in Uttar Pradesh, Uttarakhand, Gujarat and Goa where the BJP is in power. It cannot make much of a difference in any of these States other than giv-



ing Mamata a much bigger national profile and keeping her in the news. That would suit her game plan to emerge as a possible face of the Opposition in the 2024 elections. If it sticks to this plan, it will be venturing out far from its moorings, where its local politics is tethered to linguistic and regional identities. The Trinamool Congress has a limited area to explore outside West Bengal, specifically the north-eastern States and possibly Jharkhand where there is a sizeable Bengali population.

The Trinamool Congress has a history of stepping into electoral waters in these particular States.

It got the national party status in 2014 while, in 2016, it was recognised as a State party in Tripura, Arunachal and Manipur apart from, of course, West Bengal. Way back in 2001, the Trinamool Congress had won a seat in the Assam elections. In 2010, it engineered a Congress split in Tripura to directly fight the CPM. In 2012, it was the main Opposition in Manipur. It fielded candidates in Arunachal Pradesh. In these States, it was the BJP that triumphed, the Trinamool Congress becoming a victim of ayaram-gayaram politics. The party has consistently backed Bengali culture in these States. For instance, after the killing of five Bengalis in Assam in 2018. Abhishek, speaking in Kolkata, famously bound Bengal and the BJP to the Trinamool Congress's external politics: "This is a fight to preserve the Bengali culture. This is a fight for the rights of Bengalis. This fight is against the BJP's politics of oppression and forcible occupation." Between 2022 and 2024, in the run-up to the general elections. several north-eastern States will also hold elections where the Trinamool Congress would want to project the image of pitting itself against the BJP on equal terms. The name of the game is: You become my rival in my State, I will become yours in others. If that provokes the "insiders" of these States to criticise the foray of "outsiders", the Trinamool Congress would not be unnerved more than it already is by native criticism to perceived opposition by Bengali chauvinism.

## **Safety first**

As booze shops open, the Delhi Govt is ensuring strict compliance of COVID-appropriate behaviour

hile frequently at loggerheads with the Centre over the issues of its constitutional powers, medical oxygen supply, the dearth of vaccine doses and the delivery of ration at the citizens' doorstep, the Arvind Kejriwal-led Delhi Government has taken a couple of laudable decisions pertaining to its excise policy in the last week. First, at the start of the month, it permitted home delivery of Indian and foreign liquor through online portals and mobile apps under its amended excise policy. It came as a big morale booster for the Bacchus devotees in the Capital as COVID-19 restrictions at the time continued to be in place, even though the decision



didn't serve any real, practical purpose. Under the new rules, liquor home delivery was allowed through mobile app and portals, though this does not mean that liquor shops across the city would be allowed to deliver alcohol. Only sellers with the L-13 licence will be allowed to start the home delivery. The hitch the connoisseurs faced was that the facility to start home delivery was to be allowed only after 1-13 licences are given to proprietors but no such licence had been issued, as a result of which no such app was available. Basically, it was a classic case of so near, and yet so far!

Two, now that the lockdown has been partially curtailed, the city Government has ordered the liquor

vends to deploy marshals at the shops for ensuring COVID-appropriate behaviour. There are around 850 such vends in the city, including the Government-owned, and nearly 40 per cent of the total number are operated by private players. Under the second phase of unlock, the Government has allowed the liquor shops to reopen. Now, these have been directed to ensure compliance of the anti-COVID norms including wearing of masks, maintaining social distancing, regular use of sanitiser, no consumption of alcohol or tobacco substances on or near the premises. All this means that the city Government has its heart, and its pocket, in the right place since rather than encouraging bootlegging and cross-border trips to buy a bottle, it can fill up its coffers and, at the same time, ensure that people can buy their tipple in comfort and safety, especially in these times of the deadly virus.

# A salad coalition can lead Israel?



The nation is facing a chronic problem of splintered democracy. Can the new disparate coalition deliver a stable Government or will Likud spring back?

he four elections to the Knesset (Parliament) within two years— between April 9, 2019, and March 23, 2021 — notwith-standing, the political picture in Israel is still unpredictable. A delicate and disparate coalition of the Centrist, Conservative and Arab parties is poised to replace the Centre-Rightist/Zionist Likud-led Government that has been in power for 12 years now

Benjamin Netanyahu, Israel's longest serving Prime Minister, is not taking his imminent departure kindly. He has blamed Yair Lapid of being "unprincipled" and "unscrupulous" in joining forces with ideologically disparate elements. Despite an intensely secular outlook, journalist-cum-politician Yair Lapid who heads the Centrist Yesh Atid ("There is Future") Party, has roped in Naftali Bennett, a mil-lionaire tech entrepreneurturned-Conservative leader, who might soon be made Israel's first kippa-wearing Prime Minister. To add to the numbers, and the drama, the ruling coalition will feature, again for the first time, an Arab party, Mansour Abbas, the leader of Israel's United Arab list, is likely to join the salad coalition as a Minister.

Netanyahu is banking on people's revulsion to prevent this coalition from assuming power. Simultaneously, he has lleged an "election fraud". One hopes, by "election fraud" he means manipulated mandate, not actual forgery. One could hardly allege that elections are rigged, more than two months after the declaration of results. Israel has no permanent Election Commission, and few electoral reforms have taken place since

Israel undoubtedly is an island of democracy, in the Middle Eastern wilderness of Sheikdom, demagogues, civil wars and Ayatollahs. Despite war clouds perpetually looming, democracy has not been eclipsed for a single day in this Jewish country since its independence on May 14, 1948. Israel actually tends to suffer from too much democracy. The political space is

crowded by parties/parlia-mentary groups of all hues. Members are never elected to the 120-member Knesset territorially or individually but as part of rosters of specific lists submitted by different political parties/alliances. The elections are held on the basis of a proportional representation system whereby the entire Israel is deemed as a single constituency. The registered electors vote for political parties/alliance of parties rather than for candidates.

AB Magil, a Marxist journalist and himself an American Jew, who witnessed Israel's War of Liberation (1948) could not cease to wonder at the political scenario in the newly independent State: "The visitor to Israel never fails to be astonished at the complexity of its political life. It is not easy to find one's way amid the welter of parties, electoral blocs, political sects and schisms. In the first Israeli elections, voters numbering 450,000 were presented with no less than 21 tickets to choose from... The fragmentation of political life is largely a reflection of the fragmented people from whom the nation Israel has been assembled" (Israel in Crisis, P.111).

Crisis' (1950) appeared merely a year after the first general elections in the newly independent nation on January 25, 1949. In those elections, the Labour Party (Mapai) with 34.7 per cent votes resulting in 46 seats, and United Workers Party (Mapam) with 14.5 votes resulting in 19 seats, were the leading elements. For 15 years since March 1949, the Mapai (Labour Party) gov-erned Israel with David Ben Gurion, Moshe Sharett and Levi Eshkol as successive Prime Ministers.

The Governments, however, proved less durable than Knesset terms. Thus, by the time of the sixth Knesset, the 12th Government was in office. Then in November 1965, Levi Eshkol formed a new alliance, Alignment, com-prising Mapai and Ahdut HaAvoda. The most famous Prime Minister (1969-74) of Alignment was Golda Meir.

The control of Mapai has been near absolute over national institutions, economy, Army, media and education. Gil Samanov, in his recent book Netanyahu and Likud's Leaders (2020), has called it "totalitarian" as in the Communist countries. The shock of the Yom Kippur War

(1973), which Israel ultimately won but with considerable fatalities, had a major fallout on the national psyche. The time was ripe for Menachem Begin (1913-92), a die-hard anti-Mapai politician, to turn around the political scenario. Begin discussed his plans for a nationalist formation with Major General Ariel Sharon (Retd), leading to the foundation of Likud (Consolidation) in 1973. Likud's rise spelt Mapai's end. As the Prime Minister, Begin had to sign the Camp David Accord (1978), surrendering the Sinai Peninsula captured by Israel in 1967. On the positive side, it led to the Egypt-Israel Peace Treaty (March 26, 1979), the first recognition of Israel's right to exist by an

Arab country.
Will the latest coalition lead Israel into the future or will the Likud defy destiny again, like it did when one of its founders, Ariel Sharon, broke it to form a moderate Kadima party in 2005 that decided on Israeli withdrawal from Gaza with no sub-stantial benefit?



## **COP 26: WILL CDM REGAIN FOCUS?**

CDM is an effective tool to facilitate low-carbon transition and helps in technology transfer



he 2021 UN Climate Change Conference, better known as COP 26, will be hosted by UK in Glasgow in November. On-going discussions emphasize on re-strategizing climate policies in this new normal scenario. While a trade-off of pertinent issues is imperative, establishing an international carbon market is exigent, considering its economic significance to drive sustainable growth. Under Article 6 of Paris Agreement, countries agreed to set up an international carbon market to help countries decarbonize their economies at lower costs. But COP 25, held in 2019, failed to address this owing to disagreements concerning non-inclusion of unsold credits under the Clean Development Mechanism (CDM).

The CDM is a flexible mechanism in the Kyoto Protocol (KP) that allows a developed country with an emission-reduction commitment to implement projects in developing countries where the cost of mitigation is lower. However, under the Paris Agreement implementation rules are yet to be framed. CDM has been the biggest issuer of carbon credits measured in certified emission reductions (CER), with almost 50 per cent issuances from projects in renewable energy, industrial gases and fugitive emissions. Several developing economies have



already accumulated huge credits. However, post 2012 the number of registered projects under CDM have rapidly dwindled. A credit that used to be traded at \$25 per CER now trades at 25 cents, hardly covering the transaction cost. The decline in CER prices is attributed to myriad economic factors, the prominent ones being policy uncertainty regarding the international carbon market, lack of robustness of monitoring and verification mechanisms, lack of environmental integrity, and economic slowdown. Roughly, around 4 billion credits remain unsold globally, of which India holds 750 million worth of CERs.

Contrarily, with dwindling prices of CERs, voluntary markets have gained prominence post 2015. Voluntary markets are known to offer some advantages over the CDM owing to lower transaction costs, shorter time frame for project approvals, and increased emphasis on Sustainable Development Goals (SDGs). The prominent crediting mechanisms under this include Verified Carbon Standard, Gold Standard, Climate Action Reserve, and American Carbon Registry. India has registered 526 projects (earning 89 million credits) through the voluntary market. Interestingly, VCS has issued more credits globally in 2019 than the CDM. However, a large volume of these Verified Emission Reductions (VERs) remain unsold. It is unclear whether unsold CERs will be included in case CDM is renewed and if included will it dilute the value of new CERs to be issued under new regime. In case a new CDM-like mechanism comes up, it needs to address the fundamental flaws of the older system taking into account first, strict selection of projects based on 'additionality' requirement to account for real emission reduction; second, inclusion of the aviation sector; third, take measures to register projects especially from Small Island Developing States (SIDS), Least Developed Countries (LDCs) and African countries; fourth, devise accounting standards for verification and monitoring of CERs; fifth, ensure avoidance of double counting; and sixth, consider transitional credits up to 2023 till the global stocktaking takes place under Article 14 of the Paris Agreement. The demand for credits is likely to rise given the efforts undertaken to decarbonise economies.

# Person in control: New entity in charge



SEBI wants to shift focus from promoters to controlling shareholders or the so-called 'person in control' (PIC), but is the new breed willing to take charge?

aving the way for a major change in the way the promoters and over 4,700 listed corporates function in the country, in a consultation paper, the Securities and Exchange Board of India (SEBI) has proposed doing away with the concept of promoters and moving to 'person in control' (a threeyear transition is recommended for the switch over). It has also suggested doing away with the current definition of promoter group with a view to rationalize the disclosure burden. The view to rationalize the disclosure burden. The other proposals include (i) reducing the minimum lock-in period(the time period an investor can hold on to the shares) post an initial public offer (IPO) for promoters' share of minimum 20 per centfrom existing three years to one year (locked-in for holding in excess of 20 per cent is proposed to be reduced from existing one yearto six months);(ii) reducing lock-in for pre-IPO shareholders (those shareholders who invest in the company even shareholders who invest in the company even before it goes for public issue) from existing one year to six months.

The concept of promoter is legacy from the past when a corporate entity or a group of entities (say, an industrial house viz. Tata, Birla and so on) would set up a business enterprise; for instance, a power or steel or fertilizer plant, committing conceptible of its own and finding the mitting some capital of its own and funding the balance of the project cost by borrowings from banks and financial institutions besides raising funds from the capital market. Does SEBI really intend them
to be in this role (read: PIC)? From its proposals on minimum lock-in, it does not appear to be so. Post an IPO, it permits promoter to shed its share of minimum 20 per centwithin one yearagainst the existing three years(holding in excess of 20 per centcan be shedin 6 months down from one year). It is even contemplating to completely dispense with the requirement of minimum shareholding for a person to qualify as promoter. If, an entity say, PEF, can sell its share-holding acquired before IPO (albeit large enough to give it the status of a promoter) within one year of the public issue or the requirement of minimum shareholding itself is waived, how can it be expected to do justice to the role of a 'person in control'?

Ironically, the regulator does not even want the public to know the identity of investors behind the issuer. Under the liberalized disclosure requirements, the issuer need not give financials of group companies linked to the one being listed; it need not name financial investors as promoters in IPOs and it need not mention specific corporate bodies which are part of the promoter group. How can an enti-ty whose source of funding is shrouded in secrecy instill confi-

Most listed companies today are professionally managed and much of the activity is centered around the Board of Directors (it includes a number of independent directors) and the CEO assisted by various committees including audit committeeand remuneration committee etc for transparent functioning. Could the PIC role be assigned to the CEO/BoD? The answer to this is in the negative.

The CEO and other members of the Board are professionals. They are appointed and derive their authority from the shareholders - albeit by majority vote or any other mechanism agreed to by them. If the majority shareholders

existing CEO/BoD will continue. Moreover, if the former exit within a short period(very likely under the new rules mooted by the regulator), then the case for CEO/BoD for acting as PIC is weakened further.

To conclude, when the person who started the company (read: promoter) is reduced to a minority and the new breed of shareholders who have majority stake are unwilling to slip into the former's shoes, it will tantamount to pushing the listed firm literally into the status of 'a ship without a commander'. This is totally unaccept-

What then is the way forward? SEBI needs to take a re-look at its proposals keeping two cardinal principles in mind (i) 'the voting/controlling power of an investor has to be proportional to his investment or the shares held by him'; (ii) stability of the management. In the current scenario, where largest/majority shareholding is vested in PEF/AIFs et al, they should be made to take on the role of PIC and stay invested in the company over a reasonably long period. The regulator must not reduce the lock-in period. Itshouldalso not do away with requirement of minimum share-holding for an entity to be remain full transparency on funding

Sidhu started dreaming of becoming chief minister after he gained access to Priyanka Gandhi and Rahul Gandhi Senior leaders who are in the queue to succeed the Captain are dismayed with this. Sidhu also wants to become the PCC president though he does not have the capacity to take everyone along.

Among the solutions being considered by Congress high command are a cabinet reshuffle, representation to more castes, and a bureaucratic reshuffle to give a free hand to elected representatives. There is

a proposal to form a new campaign committee. The dissidents will sought to be accommodated with these changes.

Factionalism is not new to the Congress party. But a weak leadership cannot continue to treat the states or encourage dissidents as it did earlier because the party needs unity. There are not many options left for the

While the Akali Dal has severed its connection with its long-time ally the BJP last year on the farm bills issue. the two parties have declared that they would go it alone in the upcoming polls. Therefore, Punjab is likely to face a multi-cornered fight. The BJP's expansion plans are aggressive. The Captain and a united party seem to be the best bet for Congress.

## World Bank projects India | Global economy expected to expand to grow at 8.3% in 2021

The World Bank on Tuesday projected India's economy to grow at 8.3 per cent in 2021 and 7.5 per cent in 2022, even as its recovery is being hampered by an unprecedented second wave of the Covid-19, the largest outbreak in the world since the beginning of

the deadly pandemic.

The Washington-based global lender, in its latest issue of Global Economic Prospects released here, noted that in India, an enormous second Covid-19 wave is undermining the sharper-than-expected rebound in activity seen during the second half of Fiscal Year

2020/21, especially in services. "India's recovery is being hampered by the largest out-break of any country since the beginning of the pandemic," the World Bank said.

In 2020, India's economy is estimated to have contracted by 7.3 per cent while in 2019, it registered a growth rate of four per cent, the World Bank said, adding that in 2023, India is expected to grow at 6.5 per

In its report, the Bank said that the global economy is set to expand by 5.6 per cent in 2021 - its strongest post-reces-

year 2021/22 starting from April 2021 is expected to expand 8.3 per cent," it said.

Activity will benefit from policy support, including higher spending on infrastructure, rural development, and health, and a stronger-than expected recovery in services and man-ufacturing, it said.

Although the forecast has been revised up by 2.9 percentage points, it marks sig-nificant expected economic damage from an enormous second COVID-19 wave and localised mobility restrictions since March 2021, the report

# 5.6% in 2021, says World Bank

The global economy is expected to expand 5.6 per cent in 2021, the fastest postrecession pace in 80 years, largely on strong rebounds few major economies, the World Bank said on Tuesday, noting that despite the recovery, global output will be about two per cent below pre-pandemic projections by the

end of this year.

In its latest edition of Global Economic Prospects, the World Bank said that at the same time many emerging markets and developing economies continue to struggle with the COVID-19 pandemic and its aftermath.

"While there are welcome signs of global recovery, the pandemic continues to inflict poverty and inequality on people in developing countries around the world," said World Bank Group President David

Malpass.
"Globally coordinated efforts are essential to accelerate vaccine distribution and debt relief, particularly for lowincome countries. As the health crisis eases, policymakers will need to address the pandemic's lasting effects and take steps to spur green, resilient, and inclusive growth while safeguarding macroeconomic stability,"

Malpass said.

The report also noted that per capita income losses will not be unwound by 2022 for about two-thirds of emerging market and developing economies. Among low-income economies, where vaccination has lagged, the effects of the pandemic have reversed poverty reduction gains and aggravated insecurity and other long-standing challenges.

Among major economies, US growth is projected to reach 6.8 per cent this year, reflecting large-scale fiscal support and the easing of pandemic restric-tions. Growth in other advanced economies is also firming, but to a lesser

Among emerging markets and developing economies, China is anticipated to rebound to 8.5 per cent this year, reflecting the release of pent-up demand, the Bank said in its report.

Emerging market and developing economies as a group are forecast to expand 6 per cent this year, supported by higher demand and elevated

commodity prices.

However, the recovery in many countries is being held back by a resurgence of COVID-19 cases and lagging vaccination progress, as well as the withdrawal of policy sup-

port in some instances, said the

report.
"Excluding China, the rebound in this group of countries is anticipated to be a more modest 4.4 per cent. The recovery among emerging mar-ket and developing economies is forecast to moderate to 4.7 per cent in 2022. Even so, gains in this group of economies are not sufficient to recoup losses experienced during the 2020 recession, and output in 2022 is expected to be 4.1 per cent below pre-pandemic projections," it said.

Per capita income in many emerging market and devel-oping economies is also expected to remain below pre-pan-demic levels, and losses are anticipated to worsen deprivations associated with health, education and living

The Bank said growth in low-income economies this year is anticipated to be the slowest in the past 20 years other than 2020, partly reflecting the very slow pace of vac-cination. Low-income economies are forecast to expand by 2.9 per cent in 2021 before picking up to 4.7 per cent in 2022.

# 'firmly' if UK doesn't honour Brexit deal

he European Union's chief The European Union's ciner Brexit negotiator says the bloc is ready to act "firmly and resolutely" if the UK fails to honour its commitments under the divorce deal that was supposed to keep trade flowing after Britain left the

Maros Sefcovic's comments, published Tuesday in the Daily Telegraph newspaper, came a day before he holds talks with his U.K. Counterpart on implementing

The relationship between the two sides has grown tense amid concerns over the socalled Northern Ireland proocol, which was designed to protect the peace process in Northern Ireland while pre-serving economic links with the Republic of Ireland, an EU member state.

The protocol has sparked anger in Northern Ireland because it creates a customs border between the region and the rest of the UK, but the EU says the provisions are needed to protect the bloc's single market.

The UK angered Brussels earlier this year when it uni-laterally extended a grace period delaying the inspection of many supermarket items shipped to Northern Ireland from England, Scotland and Wales. The Telegraph reported that the UK may extend this action to include chilled meats such as sausages and ground

Sefcovic cautioned against such action, saying negotiators should strive to achieve mutually agreed compliance paths. "If this does not happen,

and if the UK takes further unilateral action over the coming weeks, the EU will not be shy in reacting swiftly, firmly and resolutely to ensure that the UK abides by its international law obligations."

While Sefcovic didn't

specify what those actions might be, the Times of London quoted an unidentified EU official as saying the bloc was ready to impose trade sancand retaliatory

### Only ₹10k cr more needed for vaccines; fiscal impact just 40 bps more: Report

The Government's move to I freely supply coronavirus vaccines to the States for universal inoculation and extend free rations to help the poor tide over the pandemic will only add an additional 40 bps of GDP to fiscal deficit, says a report, which also called for more transparent vaccine distribution plan for efficient vaccine allocation to the states.

The increased allocation of free vaccines to all above 18 years coupled with extending free food and grain supplies through rations will add only 40 bps to the overall fiscal deficit in FY22, which poses upside risks to the estimated of 6.8 per cent of GDP, Tanvee Gupta-Jain, the economist at UBS Securities India said in a note on Tuesday.

Assuming an average price of Rs 150/dose, with a similar amount incurred on logistics and supply charges, we estimate the total fiscal cost to the Centre will be Rs 40,000-45,000 crore or 0.2 per cent of GDP and of this Rs 35,000 crore have

already been provided in the budget, which means that the Centre will have to allocate a maximum of Rs 10,000 crore

The much-delayed move announced on Monday, which came days after the Supreme Court said the vaccine procurement policy of the Centre was arbitrary and sought all file notings on the issue, she said it will ensure that vaccine distribution is now predicated on need, rather than the purchasing power of the states.

#### The cancellation of Class XII Boards has received mixed reactions. MUSBA HASHMI speaks to experts and students about what the decision means and its implications

**♦**he cancellation of Class XII Boards have brought relief to many students, while anxiety to some. With one confusion being cleared, several others have popped up. What happens to my col-lege admission? Can I still go abroad to study? These are some of the questions that must have popped up in every student's mind at least once.

Dr Glen Besterfield, Dean of Admissions, University of South Florida tells you that the cancellation is of special significance to students who have applied to foreign universities as they may otherwise have had to put their plans on hold as they would have ended up missing important deadlines and mandatory enrolment

the Fall semester begins in August, by now students would have already got admission offers from them. Some may be conditional pending their Class XII results, but several universities, including ours, have already admitted students from India — and awarded many of them scholarships — for the Undergraduate programme starting in Fall 2021, based on Class X Board exams and marks through Class XI," he

He adds that their university need the Class XII transcripts and a high school com-pletion certificate to finalise this admission and confirm their enrolment. the next semester (Spring -January). This gives you an idea of how much this decision means for students going abroad for further studies.

While, for foreign universities the decision has brought in clarity, but for Indian colleges and universities, it has opened a plethora of confusion. Rohit Jain, CEO and Co-Founder DUX Education, says that now we need a ready plan for how the university admis-sions will happen. "This has to be done quickly. Students are still hanging mid-air since they have zero clarity on what is to happen next. I hope the board results will be calculated in an objective and comprehensive manner as far as possible. This decision will help streamline the academic calendar to some extent and reduce

anxiety among students, parents, and teachers." He adds that the admission process will gain momentum as the focus of students and parents will shift from Board exams to choice of college or university. It serves as a ray of hope in these times of helpless-

Shishir Dixit, Founder & Director, Centurion Defence Academy, tells you that stu-dents should not be disappointed and should view this situation as an experience.

"The situation is that we

should not be disappointed or negatively affected by it and that we should instead view it as a great experience. Students with potential can still have a bright career path ahead. They can put their talents and expertise to good use because they were already studying for board exams. Because they have the-oretical knowledge, they can brush up on their skills for competitive tests. They can pursue a variety of job options,"

e opines.

Krishna Thakur, a student of SLS DAV Public School, feels that every decision needs proper planning and questions if this one falls in the list.

'The cancellation was inevitable, but the negative effects of this move could have

been avoided if the boards and Government could have done their jobs planning backup options beforehand. The solutions discussed within CBSE either includes internal assessment or cumulative markings of previous three years, but the issue with both is we didn't know that a school test held two years ago will play a major role in your chances of getting your favourite college," he says.

Thakur adds that every school conducted the online examinations differently last year. "Some kept open the scope of cheating, while others were strict enough to eliminate even the slightest chance of the use of any unfair means. With this level of non-uniformity in schools and miscommunication, it will be not less than a

crime with students," he opines.

# Secrets of war-room

#### A centralised war-room or command centre has proven to be crucial at the time of any crisis, says ASHVINI DANIGOND

 $T^{\text{he importance of data-dri-}}_{\text{ven insights in strategic}}$  and operational decision-making remains crucial in mounting the fight against the novel coronavirus. A centralised warroom or command centre has proven to be crucial at the time of any crisis as it helps to streamline the capacity and efficiency of the response team while providing real-time data visualisation of key perfor-mance metrics across the healthcare network. This includes data pertaining to availability of beds, drugs, and consumables, supply of medical oxygen, and infection spreadrelated statistics in a particular private hospitals.

As India grapples with the second wave of Covid-19, several districts and cities have set up war-rooms, which are addressing the various con-cerns of the citizens related to the pandemic. A war-room generally features large dash-boards, geographic information system (GIS)-mapped data for facilities connected and natients and monitors, which help healthcare administrators to review the performance of cities or districts at the central level and it remains a single point of all data, IT, and coordination for a city or districtlevel overview.

Also, the capability of a war-room solution needs to have predictability and forecasting models. In fact, predictive analytics has a crucial role to play in making informed needs to have connected facilities with real-time data across the healthcare network. It also involves integration with other disaster management process es like ambulance movement. traffic, and weather, to list a few. There is also a need for the dissemination of real-time data flowing into a war-room while patients being moved or trans-



ferred to a healthcare facility. Also, in the case of India, while the country had developed the Aarogya Setu App in order to help with the contacttracing of individuals suffering from Covid-19, it leaves scope for improvement for technical details like identifying some-thing like a Covid-19 hotspot

Need for strong early alert

In fighting the spread of the novel coronavirus, data and science form the most critical elements of decisionmaking. However, the void of reliable real-time information has been a global challenge during the Covid-19 pandem-

Many of the health crises have been identified and mitigated with the adoption of preventative measures, including airport and port of entry screening, temperature checks and convincing the public to wear masks. Building a system for defence against the Covid-19 pandemic, especially in the case of new strains or mutants

of viruses, requires an outermost perimeter that serves the purpose of an early alert system. Deploying an early alert system would also require cooperation from an empowered task force (ETF) comprising virologists, scientists, and epidemiologists.

Enabling effective contact tracing

Contact tracing relates to a rocess by which every newly discovered infected case or individual is mapped on to all the persons that might have been potentially infected by The ministry of health in

Singapore considers data from multiple formats and sources to track the movement of a pos sibly infected individual and determine their contagion foot-print. Such real-time data feeds, including multimedia data streams, are then combined with a tracking mechanism developed by a technical agency of the government. A contact-tracing smartphone app also helps to identify indi-viduals that have been within least 30 minutes for follow-up action by contact tracers. Such highly developed digital capa-bilities of the nation given a shot in the arm to the capabilities of the administration.

Adoption of privacy-pre-

serving technologies While several technological tools could be deployed to help control a public health crisis, those tools are only beneficial provided the technologies could both be trusted and readily deployable. A major concern has been that there has been a general lack of reliable, real-time threat information sharing, contact tracing, and during this pandemic has meant people and public health authorities have been mostly relying on backward-looking reporting of confirmed cases which has hampered the fight against Covid-19 severely.

It is also a known fact that a large-scale deployment of an information network would carry the risks of cyber-attacks. These risks could be akin to those faced by financial systems, public transportation systems, or the power grid. Robust protections required, both for the physical security of the information processing network as well as the privacy of individuals from overreach by commercial entities and administrators. These information networks can be made considerably less vulnerable by building resiliency and redundancy and highly distrib-

uted processing capabilities. Also, it needs to be kept in mind that any epidemic pre-paredness starts years before an outbreak. A densely-populated remain prepared to effectively ward off a health crisis considering that this is not going to

be a one-off situation.

reputed and affordable higher education system is a strong rea action system is a strong rea-son for you to consider France for increasing your lifelong employa-bility value. This is precisely the rea-son why 3,58,000 international students are at present studying in France which ranks fifth globally. In recent years, France has made a

great effort to attract and recruit international students. The French government has simplified the visa applica-tion process and for example France was the first country to reopen its visa section to facilitate the entry of Indian students after the start of the COVID-19 pandemic.

The country has a twofold structure for higher education: Universities and Grandes Ecoles (elite private schools); For medical and law studies, there are no Grandes Ecoles, but universities have a separate selection. More than 3,500 public universities and elite private schools offer a wide range of study options for students (most graduate engineering and business studies are in English). Whereas universities in general offer a more relaxed entrance process, the private have strong selection entrance exams. The private system is primarily focused on scientific and business studies.

On top and above the subsidised higher studies, the French administra-tion, as well as universities, and private schools offer numerous scholarships to international students to help them study in France. There are numerous public and private scholarships available for Indian students. Scholarships range from being fully funded, partially funded to tuition support. Scholarships.

Students from a country that concluded a bilateral agreement with France (regarding professional migrations) benefit from more favorable issuance conditions. Good

## Lectures on education after COVID

The 10th edition of the University Distinguished Lecture (UDL) Series, organised by SRM University-AP, expounded on a pertinent problem of the current time, "Higher Education in India in the Post-COVID-19". Prof Anil Sahasrabudhe, Chairman of All India Council for Technical Education (AICTE), delivered the Distinguished Special Chief Secretary, Higher Education, Government of Andhra Pradesh, gave a special address. In his welcome address, Prof D

Narayana Rao, Pro-Vice-Chancellor of SRM University-AP, set the context of the event, emphasising on how the unprecedented COVID-19 crisis has resulted in the temporary closure of about 1000 universities and about 40,000 colleges in the country, severely disrupting the teaching and learning process and research activities.

The transition to Learn From Anywhere happened overnight and people had to get used to it. The National Education Policy (NEP) 2020 recognises the importance of leverag-ing the advantages of technology while acknowledging its potential risks and

Online education calls for carefully designing and appropriately scaled studies to determine how the benefits of online/digital education can be reaped while addressing or mitigating the downsides. There is a need to estab-lish a "Digital and Online Wing" in the Departments of Education in different

Prof Sahasrabudhe in his Distinguished Lecture, delineated that the use of technology in the education environment has been initiated in the pre-COVID days. Platforms such as Swayam, National Programme on Technology Enhanced Learning (NPTEL) came into existence to digi-

tally bring quality education to everyone. Digital education carries a boon that no one can ignore, i.e. making physical distance irrelevant in education. Digital education has the ability to reach students anywhere and everywhere provided they are equipped with gadgets and internet connectivity. Thus, the Government has under-Bharat Net, Unnat Bharat Abhiyan to connect every corner of India through the internet.

Prof Sahasrabudhe accepted that all subjects cannot be taught online, especially lab-based practical courses that will have the need to attend physical classes. Moreover, a digital class can never replace the bonding humans tend to develop while working in close proximity. However, it cannot be debated that the education system has changed. The future of education comes with a

blended environment.
Fortunately, NEP 2020 envisioned the change long ago and introduced a relevant policy to ensure the educational growth of the country. Multidisciplinary Education and Research Universities (MERU), Academic Bank of Credits, National Academic Depository are some of the revolutionary changes that are going to benefit the next generations in the post COVID days.

The Government has already established National Research Foundations to support mega research projects, which may need several crores of

Prof Sahasrabudhe emphasised that studying in one's native language is an essential requirement that NEP looks into. He asserted that proper administration, governance and autonomy are some of the deciding factors for the education sector in the coming

Tamara becomes first Slovenian woman to reach Grand Slam semis: Pavlyuchenkova also end poor quarterfinals record

efore the French Open, Tamara Bilder the Field Open, familia Zidansek had never advanced past the second round at any Grand

The former snowboarder has now become the first woman from Slovenia to reach the semifinals at a major tournament. Spurred on by the vocal support of her

coaching team on Court Philippe Chatrier, the 85th-ranked Zidansek defeated Spanish rival Paula Badosa 7-5, 4-6, 8-6 Tuesday at the clay-court tournament.

"It feels overwhelming," she said. The French Open is the only remaining Grand Slam where tiebreakers are not played in the last set. Wimbledon recent-ly installed tiebreakers at 12-12 in the final

After splitting the first two sets, Badosa violently threw her racket in anger at the changeover after Zidansek held for a 6-5 lead in the third. She regained her composure but Zidansek then saved three break points to take a 7-6 lead and converted her second match point with a big forehand in the next game.

Zidansek, a three-time national junior snowboarding champion in Slovenia, will now face Anastasia Pavlyuchenkova for a spot in the final at Roland Garros.

In perfect weather conditions, both players pulled off some spectacular winners but also hit a lot of unforced errors. Badosa. who was among the six women in the quarterfinals at a major for the first time, said

"I didn't feel myself in the whole match," she said. "I'm a little bit sad about that, because I think I played maybe the worst match of the tournament and of the clay season, but sometimes it's like that.'

Badosa applied pressure from the start with a flurry deep groundstrokes from the baseline. The strategy worked as Zidansek dropped her first service game and then trailed 3-0. But an error-strewn game from Badosa gave her rival a break and a boost.

Zidansek started to return better and went for her shots, linking attacks with bold moves at the net to even the score at 3-3. Badosa saved a set point in the 12th game with a forehand attack but could not fend off the second as her poor drop shot ended up in the net.

Badosa trailed 4-2 in the second set after a series of unforced errors but Zidansek could not build on the momentum and struggled with her serve, too.

The Spaniard rallied, made the deci-

sive break in the ninth game at love and sealed the set with a big forehand.

The 23-year-old Zidansek opened this year's tournament by upsetting seventh-seeded Bianca Andreescu in the first round for her first career win over a top-



10 player. In that match, she was two points from defeat in both the second and third

Zidansek reached a career-high rank ing of No 56 in June 2019.

Later, Anastasia Pavlyuchenkova has also reached the first Grand Slam semifinal of her career by coming back to beat doubles partner Elena Rybakina 6-7 (2), 6-

The 31st-seeded Pavlyuchenkova entered the day with an 0-6 record in previous singles quarterfinals at all major tour-

That included a loss at that stage in 2011 at Roland Garros.

But the 29-year-old Pavlyuchenkova came out on top at Court Philippe Chatrier in a match that lasted more than 2 1/2 hours and ended on a double-fault by

The 21st-seeded Rybakina eliminated 23-time Grand Slam singles champion Serena Williams in straight sets in the fourth round.

Pavlyuchenkova and Rybakina are scheduled to be on the same side of the court as a team in the doubles quarterfi-

nals on Wednesday.
On Monday night, defending champion Iga Swiatek reached the quarter-finals with a 6-3, 6-4 victory over Ukrainian

teenager Marta Kostyuk.

The eighth seed from Poland has won 22 straight sets at Roland Garros and will take on Greek world number 18 Maria

Sakkari for a place in the last four. Sakkari knocked out last year's French Open runner-up Sofia Kenin earlier in the day, leaving Swiatek as the highest-seeded player remaining in the draw.

Swiatek, 20, is aiming to become the first woman to defend the title in Paris since Justine Henin won the tournament three times in a row from 2005 to 2007.

She extended her winning streak to 10 matches, having captured the Italian Open title in Rome last month.

The 18-year-old Kostyuk, ranked 81, was making her first appearance in the last

"Yes, sometimes it will be tough as there will be a bio-bubble but that is not a big problem, our main target is to achieve a gold in Paralympics."

Robinson, who made an impressive Test debut with a match-haul of 7 wickets against New Zealand at Lord's, has been suspended by the country's apex cricket body for some of his offensive tweets dating back to 2012-13, for which he has already tendered an unconditional public apology.

Anderson threw his weight behind Robinson dur-ing an interaction with the British media. Asked whether Robinson's apology has been



accepted by the team or are some players still uneasy about it, he said, "No, I think it's been accepted."
"He stood up in front of

the group and apologised and you could see how sincere he was and upset he was, and I think as a group we appreci-ate that he is a different person now. He's done a lot of maturing and growing since then, and he's got the full support of

The UK's political class also weighed in on the issue urging the England & Wales Cricket Board (ECB) to reconsider its decision of suspend-ing the fast bowler for something he has done years ago as a teenager. Anderson was also asked

about the impact of the player's suspension on the team. "Well yeah, I think it's a...

You know it is a difficult time. I think as players we're trying to learn from this really.

"We realise that it's impor-tant to try and get educated around these issues, which we're continuing to do with the ECB and the PCA we've already been doing workshops before this series to try and help improve ourselves as peo-ple basically, to try and make sure that this sort of thing doesn't happen."

## Deepak pulls out of Poland Open due to elbow injury

Singh also dismissed suggestion that it was a made-up injury to get a specific draw at the Olympics. "Nothing like that. We are not looking that much ahead," he said.

The Wrestling Federation of India (WFI) confirmed the sequence of events.

"Yes we had given him a choice. We do not want to put pressure on wrestlers, Olympics are near, so no point in taking risks," said WFI Assistant

Secretary Vinod Tomar.
Punia will remain with the team till July 5 for the training camp that has been organised by

the Polish Federation The WFI is also trying to negotiate with Turkey, Romania and Russia to organise training camps for India's Olympicbound wrestlers.
