There is good news for consumers who are going to junk their old vehicles and buy a new one under the Vehicle Scrapping Policy as automakers will give about 5 per cent rebate on the new purchase, Union minister Nitin Gadkari has

The voluntary vehicle scrapping policy announced in the Union Budget for 2021-22 provides for fitness test after 20 years for personal vehicles while commercial vehicles would require it after the completion of 15 years.

"Automobile manufacturers will provide about 5 per cent rebate on new car purchases" to the consumers in lieu of scrapping of the old, Road Transport, Highways and MSMEs Minister Gakdari

"There are four major components of the policy...Apart from rebate, there are provisions o green taxes and other levies on old



polluting vehicles. These will be required to undergo mandatory fitness and pollution tests in automated facilities. For this automated fitness centres would be required through out in the country and we are working in that direction," Gadkari said.

Banks slash home loan

For banks, housing loans are safe bets in the current scenario as the risk of default is minimal with a gross NPA of just 0.67 per cent for SBI which leads the market and for HDFC too this NPA is under 1 per cent.

Banks are hoping that the nascent economic recovery will lead to more home purchases, which has been faltering since last March. With corporates demand still a far cry and down in the dumps from an NPA point of view, for banks the biggest reason to push home loan is its risk-free nature. Unlike personal loans, housing loans involve a collateral. In case of default, banks can seize the asset and auction it off.

At Rs 14.17 lakh crore as of November 2020, live housing loans account for more than half of personal loans for banks.


Reacting to the developments, Farhan's elder brother Fulqan alleged that the media was blowing up "a small incident" since Farhan is the grandson of Home Minister.



Is CMO cleansing in the offing?

After CMO PRO Vijaykumar came under cloud and was asked to go, the scene has now shifted to the babudom in Telangana to rid it of elements leaning towards the saffron brigade and those who are believed to have leaked sensitive information mainly to discredit the gov-

The intelligence report that was submitted recently to the Chief Minister is learnt to have dope on the widespread presence of people believing in RSS' ideology at various levels. It is now being determined whether these far right forces are working as 'conduits' for passing sensitive information to trouble-makers that be. It appears that some of those frequenting Pragati Bhavan have a soft corner towards RSS and BJP. So, in retrospect, dependable babus are wondering how vulnerable crucial government and political information has been for the ruling TRS party all these days. Chief Minister K Chandrasekhar Rao is expected to take up spring cleaning to shunt out these inimical forces. The process of identification of the black sheep is on, with a senior official coordinating the activity under the directions of the Chief Minister. A little bird told us that CMO will now take more precautions to ensure 100 per cent confidentiality on all matters related to government policies and key decisions. From the party side also steps have been initiated by the TRS leadership to identify the 'conduits' of information leak.

Is Covid chasing finance officials?

Due to a strange coincidence, Covid-19 seems to be after those holding the purse strings. The virus, all along deemed to be impartial, has noticeably targeted finance officials in both Telugu states. Initially principal finance secretaries of both states were infected and they recovered from Covid. Later, the second rung officials in the department were infected by the virus. Ever since Coronavirus landed in India, several finance officials at various levels have been infected, keeping them out of duty for prolonged periods. With the virus completing one year of its spread in multiple waves, more and more finance officials are falling prey to the deadly virus. TS finance head K Ramakrishna Rao was out of duty for almost one month and now AP finance chief SS Rawat has been out of action, citing Covid infection as the reason, for almost a month. In Andhra special secretary Satyanarayana also got infected by coronavirus, leaving the entire department headless. While contractors and suppliers have been moving around freely to go to the Secretariat and other government offices without any fear of contracting Covid, the Finance Department officials are taking extra precautions not to meet any of them, citing Covid as the official reason.

Contractors may or may not be the asymptomatic carriers of the virus. Since the officials are keeping contractors and others away without any observable symptoms or evidence of their possible infection, those who could not get their payments from the Finance Department due to non-availability of the officers are alleging that the real intention of the absentee babus is to hold or deny their payments, with Covid coming in handy to shoo them away. Who is telling the truth needs to be verified.

From disaster to disaster Being clean is OK, but self-proclamation of

that trait, and that too as a loner in a group where others are shady, is not so. A babu in AP has learnt this the hard way.

The agonizingly long wait of senior IPS officer Madireddy Pratap for posting has come to an end. Having fallen out of favour with Chief Minister YS Jaganmohan Reddy after a disastrous press conference, he had been without any posting for more than eight months. His abrupt transfers, twice in less than a week, took in July last year. He was finally asked to report to GAD, where he could do nothing but await posting. At last, he has now been posted as Director General, Andhra Pradesh State Disaster Response & Fire Services.

Pratap was shifted from his last post as the Additional DGP (Director General of Police), APSP (Andhra Pradesh Special Police) Battalions, and asked to report to GAD, following his distasteful (to powers that be) statements at a press meet after his ouster from his previous position in APSRTC. Pratap, who had assumed charge as the Vice-Chairman and Managing Director (VC & MD) of Andhra Pradesh State Road Transport Corporation (APSRTC) in January last year, was transferred in less than seven months for reasons that could not be fathomed by him or others. Pratap then held a press conference, where he said that he had received the transfer order unexpectedly and that it was "a surprise" for him. While underlining his commitment to work, he recalled his close association with Chief Minister Jaganmohan Reddy's late father and former undivided AP CM Y S Rajasekhara Reddy. While referring to the ED cases against Jagan, Pratap merely boasted: "Many officers and political leaders were jailed ... The CBI conducted inquiries with officers who had worked in the CM office at the time ... But during that time, if there was one person who was never suspected for his involvement, it was me". This did not trigger any 'me too' movement in babudom, but the remarks singed Jagan. After almost eight months of hibernation, Pratap got

the new posting.

Srilakshmi as Special CS

The babudom in Andhra Pradesh is still watching keenly what will happen to the state government's recommendation promoting senior IAS official Y Srilakshmi to the level of Special Chief Secretary. In January, the Jaganmohan Reddy government issued orders promoting her to the Above Supertime Scale (HAG Scale). However, the GO came with a rider that the promotion would be effected, subject to the outcome of all the court cases that are pending against her. And it is learnt that the Centre too had pointed to the cases pending against her, while considering the state government's recommendation. The 1988 batch IAS officer is an accused in the quid pro quo case filed by CBI against Jagan and was lodged in jail. After Jagan became the Chief Minister she evinced interest to shift to Andhra Pradesh cadre and, using the good offices of the Jagan government and the CM's rapport with the Centre, got herself shifted from Telangana to Andhra Pradesh cadre. She was given posting as the MA & UD principal secretary in December last year. It is learnt that Jagan has assured her that he would make her the Chief Secretary.

City turns hub for fake certificates

Police officials arrested a Railway employee, along with four other people for making fake university certificates in city recently.

In the very next month, an Army personnel was arrested for possessing more than three hundred fake university certificates.

These two are not isolated These two are not isolated cases, but part of several gangs now operating out of Hyderabad, particularly the Old City, busy making fake degree certificates to help unscrupulous students get admission in universities here and jobs abroad. Primarily, the fake university certificates relate to B Tech and MBA, the two streams of study that can fetch jobs in the marketplace.

On an average, as per Osmania University and JNTUH sources, close to 300 fake certificates get detected during certificate verification process conducted for admission to higher education courses every year. During the pandemic the number of fake certificates detected was however, much less - only 120.

For getting high salary jobs and also for getting seat in good universities, students are

approaching the fraudsters involved in making fake certificates," said an Osmania University official. On some occasions the fake certificate issue had come to light in connection with government job recruitment drive too.

According to informed sources, students are shelling out in the range of Rs 50,000 to Rs 1,00,000 for a single fake certificate that looks exactly like the original one. It would

take an expert however, to detect the small changes that mark the difference between the original and the fake cer-

These fake certificates, as has already been mentioned, are used to get jobs abroad. Earlier, the foreign companies only used to check student's marks memo for recruitment purposes. However, following several complaints from the American Consulate regarding

Congress spokesperson said. Apart from Saikia, legislators who were renominated are former minister Rakibul Hussain in Samaguri, Md Nurul Huda in Rupohihat, Rupjyoti Kurmi in Mariani, Roselina Tirkey in Sarupathar and Durga Bhumij in Doomdooma.

Golaghat is witnessing interesting developments as former minister and sitting MLA Ajanta Neog quit Congress to contest the polls on a BJP ticket, while

former AGP candidate Bitupan Saikia, who joined the BJP after being defeated by Neog in the 2016 elections by a narrow margin of 5,213 votes, switched over to the Congress and was given a party ticket.

■ Recall Bapu's visit to Patna Medical College and Hospital in 1947

Three months before India's independence, Mahatma Gandhi had visited the Patna Medical College and Hospital for an appendicitis surgery of his grand-niece Manu, and so worried Bapu was that he sat next to her, wearing a surgical mask and watched the entire procedure in the operation theatre.

Seventy-five years later, Gandhian scholars and his admirers are now concerned over the fate of the over 100year-old Bankipore General Hospital building in which the operation took place on May

Risky resolve

Will Mamata's decision to contest Nandigram backfire or bring her back to power?

•lectoral politics is a tricky game and, for political parties that are practically a oneperson show, it's especially important for the supremo to choose to contest from such an Assembly seat that it sends a strong message among the masses that the leader is attached to the grassroots and doesn't hesitate to take the rivals head on. This has a psychological impact on the voters, not only in the particular constituency the leader contests from but across the State, which helps consolidate the vote bank in that party's favour. TMC chief Mamata Banerjee seems to have hit the right note by deciding to contest from Nandigram, the seat held by her one-time confidant Suvendu Adhikari who dumped the TMC to join the BJP in December. By doing so, Mamata —



who is beleaguered by a spate of defections from the TMC in the five months preceding the Assembly elections — has taken the fight to the BJP's camp and tried to project a pro-poor image by returning to her political roots. The Trinamool's sweep of Nandigram in 2007 is one of the key factors that paved the way for her political resurrection and catapulted her to power in 2011. Adhikari, who wields considerable influence in the constituency, had thrown down the gauntlet to Mamata to contest from the seat. Now, Mamata seems to have accepted the challenge and asserted that "this is a smiley election". It might appear to be a case of simple political enmity but

there is no denying that it has deeper political connotations. With almost 40 per cent Muslim voters and a sizeable number of Dalits in the constituency, Mamata might be confident of her win and Adhikari, after all, may not have very bright prospects of defeating her but the contest here will certainly be demanding on her in terms of time, energy and attention to other seats; in other words, a victory in Nandigram might cost Mamata a few other constituencies. At a time when Didi is already licking the wounds inflicted by scores of defectors, her special focus on Nandigram might cost the Trinamool dear in West Bengal. Undoubtedly, Adhikari — who was the architect of the ouster of the Left from Nandigram in 2007 — is the BJP's biggest acquisition but the saffron party's real objective is to oust the TMC from power and not just win the battle of prestige. So, from this viewpoint, Mamata's decision to contest from the constituency might actually serve the BJP which has already launched its "Mission 200+". Moreover, Mamata's dropping out of Kolkata's Bhowanipore seat, which she represented for two terms and where her party trailed in the 2019 general elections by a few thousand votes, has given the saffron party ammunition to mock her by saying that it shows her nervousness. Whether it is Didi's apprehensiveness or a bold, calculated move, or the BJP's ploy to make Mamata channelise all her energy and focus on to Nandigram, thus making her a spent force elsewhere, is the moot question which only voters will answer. For now, with the recent turn of events, West Bengal has become a hot spot of politics with the parties doing all that they can to win the elections.

Diabolical dowry

A young woman's recent suicide in Ahmedabad must jolt our conscience and nudge us to correct course

e are living in the 21st century but it seems, for a majority of women in India, we are still living in ancient times when a woman's worth was quantified by the amount of dowry she brought along at the time of marriage. What else can explain the shameful fact that when women are going into space, working as scientists and leading countries and global bodies, young women in our country are forced to end their lives



because they are unable to bear the harassment meted out by their husbands and in-laws over "inadequate" dowry? The latest in the long line of victims of a despicable and archaic system, which was abolished and criminalised in India in 1961, is a 23-year-old woman from Gujarat who ended her life by jumping into Ahmedabad's Sabarmati river. Before dying, she shot a video and made an impassioned plea to all Muslims for ending the dowry system as "it is illegitimate and forbidden". Though the woman's husband was arrested for abetting her suicide, and many prominent leaders from the community have condemned those who take dowry and asked people to end this social evil, it will not bring the woman back.

Dowry is a blot on our society and country where we worship goddesses and women are considered the incarnation of Lakshmi and Durga. It is a shame that in a nation whose Prime Minister has given a clarion call for "Beti Bachao, Beti Padhao", our daughters are either killed or forced to commit suicide over dowry. The National Crime Records Bureau's 2017 report is an indication of the gravity of the situation as India recorded nearly 7,000 dowry-linked deaths. Also, dowry deaths rose from 19 per day in 2001 to 21 per day in 2016. As usual, the fingers will point towards weak law enforcement and non-implementation of laws, but the fact remains that the laws are adequate to end this malaise. The Supreme Court recently made it abundantly clear that it will not tolerate harassment of women for dowry. It is we, the people, who have to change. Parents must educate their daughters and stop seeing them as a burden. If you have a selfreliant daughter with good education and a job, you don't have to pay someone for her upkeep. Women, too, should refuse to marry men who seek dowry. It is only when the parents and women grow a spine that this evil practice will end. Don't expect anyone else to come and help you. This Women's Day, do take a pledge to help yourself.

Exorcising the OROP conundrum





guishes the Narendra Modi Government from its earlier iterations is the manner in which it has used the military, quite successfully at that, to portray an apparently muscular for-eign policy, not least for the domestic audience. This has allowed it to reap rich dividends at the hustings. Yet ironically, apart from praising the military in public, Modi has done little for them on the ground, displaying little concern for the morale or well-being of its personnel. Take the issue of welfare of

servicemen. Government has reduced Canteen facilities, is intent on opening up and monetising Cantonment lands, adding to the insecurity of families of servicemen separated over long periods due to their spouses being deployed either operationally or on training. In addition, he has refused to authorise the Non-Functional Financial Upgrade (NFFU), which is authorised to other Central Government services, including the Central Armed Police Forces, thereby lowering their status and emoluments in comparison to the other services. The plain fact is that the grant of NFFU to bureaucrats allows them to get OROP, through the back door as it were, because nearly all of them now retire in the Apex Grade.

All these little pinpricks rankle and more so this Government's unwillingness to implement OROP in letter and spirit as envisaged by the Parliamentary Committee headed by veteran BJP MP Bhagat Singh Koshyari: A definition that had been accepted by both Houses of Parliament and the then UPA Government in power. What is particularly galling is that Modi used this very issue to galvanise the serving and vetercommunity during the 2014 general elections.

His sanctioning of a distorted version of what had been promised earlier forced the veterans to launch peaceful protests on June 14, 2015, which contin-



At the end of the day, the issue is very simple. All that the veterans demand is a chance to live out their retirement with dignity, feasible only if their pensions are protected from rising inflation as the majority retires relatively young; that this Government is unwilling to do so reeks of hypocrisy.

For example, even while this Government opposes OROP for its military veterans, it lost little time in ensuring that all Members of Parliament receive pensions calculated in much the same manner that military veterans have been demanding. In 2018, it amended Clause 8A of 'The Salary Allowances and Pension of Members Act, 1954, to provide for an increase in the authorised pension every five years on the basis of the Cost Inflation Index, which clearly links pensions for all former members to what is received by the incumbent.

This unfair treatment, espe-

cially the Government's refusal to put in public domain the Justice Reddy Committee (to look into anomalies in OROP) Report, submitted in October 2016, forced the military veterans to approach the Supreme Court. Over four years later, the case has made tardy progress mainly due to the

Government's efforts to delay. By not taking cognisance of this issue, the Bench has not been kind to the veterans, who continue to suffer and lose hope as each day passes. What is worse, the Justices hearing the case, now in the final arguments stage, have repeatedly postponed the hearing on the grounds they have not had the requisite time to study and understand the case in detail. The next hearing is in a few days and one hopes the Bench will actually hear the case and not kick it down the road.

Oddly enough for the vast majority of us, not particularly conversant with the intricacies of the judicial process, this hearing in itself appears to be completely superfluous. This is pecause the Supreme Court had on September 9, 2008, in its judgment in the case of Union of India and Maj Gen SPS Vains and Others, ruled: "No Defence personnel senior in rank can get lesser pension

than his junior irrespective of the date of retirement and similarly placed officers of the same rank are to be given the same pension irrespective of the date of retirement." These are directions that the Defence Ministry has yet to fully implement and which in no uncertain terms accede to what the veterans have been demanding.

Interestingly enough in 2014, when the Supreme Court was passing directions to the Government to correct the anomalies in the pensions of High Court Justices, then Chief Justice of India P Sathasivam directed that "one rank one pension must be the norm in respect of a constitutional office", a benefit which Justices of the Supreme Court already enjoyed.

Finally, can it really be the case that in a democracy like ours, the constitutional authorities do not see themselves as mere public servants and believe themselves to be superior to other Government servants and ordinary citizens?

Defying norms for better lives



Sadly, in spite of women's foray into many non-traditional fields, only one-quarter of Indian women, compared to 82 per cent of men, are in the labour market

This year, two women created history by joining the Telangana Southern Power Distribution Corporation Limited (TSSPD-CL) as junior powerline workers and becoming a part of a workforce that has solely comprised men in the State. The women did so after qualifying tests, including climbing up an electric pole. Still the job didn't come on a platter. The duo had to knock on the High Court's door, challenging the corporation's stand that "such posts are reserved

Nevertheless, despite such occupational segregations and archaic rules, many women dared to storm male bastions. Surely, Delhi's Mehrunnisha Shokat Ali is one of them. She has been working as a bouncer for the last 15 years, demolishing the notion that women belong to the weaker sex and need men's protection. "I was always fascinated by people in the Army and the police. But I couldn't nurture any such ambitions as my highly orthodox father was totally against giving any of his daughters an education. Thankfully, my mother sent us to school", reminiscences Mehrunnisha. "When I joined the NCC in school, my father got furious and burnt my uniform. However, after her father suffered a loss in business, the responsibility of becoming the family's breadwinner was thrust on her. Luckily she met Arun Rana, who owns a security agency and a restaurant in Hauz Khas, South Delhi. Rana engaged her in his restaurant as he was "looking for women bouncers to put female customers at ease and found her very capable of easing any tension." Now, in her mid-30s, Mehrunnisha, who maintains a strict workout regime, has earned the experience of working with many high-profile women and men in the world of film, entertainment and business. She looks forward to launching her own security agency with her sister Tarannum, who is also a bouncer.

Unlike the Ali sisters, for 24-year-old Sabina working for a top global brand in Gurugram, the path was less bumpy. Sabina confidently says: "I learnt martial arts in order to become a bouncer. I am not in the profession for money alone, I get a lot of respect in my workplace. I shall marry, only if I am allowed to work." Now, the vice-president of a security agency with a pan-India clientele, Sabina admits that "there is a growing demand for women security personnel and many clients consider them safe, more disciplined and efficient."

The security business is not the only glass ceil-ng that women are breaking. While, in the Indian psyche, alcohol, cocktails, booze are still taboo words and going to a bar is a strict "no, no" for girls, there are many women like Delhi's Suchana Bera Sharma, who are breaking the barriers here too. A management degree-holder, Suchana is a mixologist and currently the India brand head of a major player in the global spirits industry. Leaving behind their traumatic past, all of them got their training under the 'Women at the Wheels' programme of the Azad Foundation, a multi-city-based NGO. Anjana, who has been driving commercial cabs for the last eight years, now confidently says that, "I enjoy my work. I got my heavy vehicle driving licence in 2020 and am ready for any challenging job." Trapped in an unhappy marriage with a drunkard husband who had no fixed income. Aniana was desperately looking for a job to feed her two children when Azad Foundation came to her aid. Anjana, now, in her late-30s, says that "my life's only mission is to fulfil the dreams of my two children. My husband no longer interferes in my life, though the separation suit is still pending in the court." Manasi, a victim of child marriage, proudly says, "I use my Alto 300 car for commercial rides, which I got under the

West Bengal Government's Gatidhara scheme in 2019. This way I can feed my family." She lost her husband even before her first child was born. Manasi was soon thrown out of her in-laws' house, while, her impoverished father was equally unwilling to bear her burden. In search of a living, she left her father's home for Kolkata, got a job at a loan financing company for a paltry sum, which enabled her to put her son at a care agency. In her lone struggle, she was duped by an unscrupulous man with false promises of marriage, who deserted her once she became pregnant. The local church came to her rescue and her life got irrevocably changed once she came in touch with the Azad Foundation. Now, her elder son is in a boarding school, the younger one studies in a reputed school in Kolkata and Manasi is saving money for a house

While, Ganga's poor father married her off at an early age, and at her in-laws' place, she faced continuous harassment, initially, for dowry, and later, for giving birth to two girl children. When she came to live with her husband in his workplace at Jaipur, she attempted to commit suicide along with her daughters when she couldn't bear the mental and physical torture any more. She was rescued from the railway station and given shelter at a welfare home, where she worked for some time, and put her daughters in an orphanage. Today, her daughters stay with her, study in good schools, and she is the owner of two cars. She drives one herself while the other one is driven by her sister. Ganga says that "I don't want to look back, and I would like to help more women who suffered like me."

Amrita Gupta, director, research and advocacy, Azad Foundation says that in order to encourage resource-poor women, who are mostly first generation learners, a flexible training mode is followed, covering technical skills for the licence test, and also transformative aspects like spoken English, selfdefence, basic etiquette. On an average, about 300-400 women get training every year and about 50 per cent of them get placements.

Sadly, in spite of women's foray into many non-traditional fields, only one-quarter of Indian women, compared to 82 per cent of men, are in the labour market, says a World Economic Forum, 2020 report, Worryingly, this is likely to shrink further by 23.5 percentage points in the post-pandemic phase, says

This major gender gap in employment can only be reversed by turning the focus on women in economic revival strategies and adopting a gender-sensitive approach in a post-pandemic world. Only then will we be able to create a 'New India.'



When the unsung dare to dream and sing despite all odds


If we look around us, in the communities closest to us, we may find many such women shining beneath the rubble of class, caste and poverty

simply held me spellbound. It was powerful, it was musical and it was like liquid gold. Not a note out of place. And the felicity with which she sang English songs quite took my breath

Shilpa was never interested in studies but completed her school education till the 12th standard. Hearing her talk in English and listening to her sing, in three

different languages with equal fluency, I understood as never before that the university of life is as educative as actual institutions of repute and

Shilpa tells me, and I quote her own words, in English, "I did not learn to sing. I used to sing on my own and listen to the songs on radio and TV. I heard a

The 30-share Sensex plummeted by 440.76 points or 0.87 per cent to close at 50,405.32, continuing its falling trend for the second day on Friday due to concerns over bond yields. The NSE barometer Nifty ended lower by 142.65 points or 0.95 per cent at 14,938.10.

'In the coming week, the market will be mainly focusing on the expectations on whether the Fed, in its upcoming meeting, will maintain its accommodative stance in a rising bond yield market. Additionally, Fed's measures to maintain lowinterest rate and high liquidity will also provide relief to the market sentiments," said Vinod Nair, Head of Research at Geojit Financial Services. On a weekly basis, the Sensex gained 1,305.33 points

PVR to invest Rs 150 cr to add 30-40 screens next fiscal

Multiplex major PVR plans to invest Rs 150 crore to open up to 40 screens across the country in the next fiscal.

The company's target of having 1,000 operational screens has been pushed by a year due to the outbreak of the COVID-19 pandemic to the end of fiscal 2022-23, a top company official has said.

"We had to push back our plan by exactly a year because of the pandemic ... By the end of the financial year 2022-23, we should be able to reach 1,000 screens," Sanjeev Kumar Bijli, Joint Managing Director, PVR Ltd told PTI.

The company, which added 9 new screens this week in Mysuru and Kanpur, plans to add 30-40 new screens in the next financial year beginning April 1. Bijli said Rs 150 crore would be outlay for the opening of new screens in the next fiscal.

PVR at present operates over 844 screens at 177 properties in 71 cities (India and Śri Lanka). Bijli said a strong content pipeline of star-studded Indian and regional films as well as foreign language films along with an aggressive vaccination drive in the country will bring back audiences to the cinema

"We have had a mixed couple of last months. Not very exciting because no big Hindi movie got released. Hindi movies will start releasing from March 11. We have a strong content pipeline. The year (next fiscal) looks very promising," he added.

When asked if the company is also looking for acquisition opportunities for adding screens, Bijli said the company always looks at the options available.

"There is no one approach for growth. We keep an eye out for all sorts of opportunities as long as they make sense in

terms of numbers, location," he noted. The multiplex industry has been one of the worst impacted segments due to the outbreak of the COVID-19 pandemic. The government allowed cinema halls across the country to operate at full capacity from February 1 with adherence to COVID-19 safe-

ty protocols. Prior to that, multiplexes and cinema halls were operating at 50 per cent sitting capacity in accordance with the Únlock-5 guidelines issued by the government following the pandemic. Multiplexes and cinema halls were closed for almost seven months and opened in October last year.

NTPC resumes power supply after Sikkim assures payment

TPC has restored power supply to of paying the outstanding amount of Rs 89-crore in a time-bound manner, a company official said on Sunday. From midnight of March 3, the country's largest power producer NTPC had stopped 105 megawatt (MW) of power supply to Sikkim



because of non-payment of Rs 89 crore outstanding dues. Despite the requirement of a Letter of Credit, Sikkim was not maintaining the same. "NTPC Ltd has today (March 7) restored power supply to the state from 00:00 hours," the official said. Sikkim has committed to releasing the outstanding amount within the time frame of six months. It has opened a Letter of Credit (LC) and the state has paid bills for two months to NTPC, the official informed. The power distribution utilities are mandated to open a Letter of Credit for getting power supply from generation firms. NTPC, under the Ministry of Power, is India's largest power producer.

India Inc's overseas investment declines 31 pc to USD 1.85 bn

The company, which had earlier planned to launch the e-tron towards the end of the last year, had to alter the plan in the wake of the coronavirus pandemic and is now planning to launch the two EVs under the e-tron range simultaneously as it bets big on electric mobility in India. Globally, Audi had announced a fiveyear plan under which it would launch 30 electrified vehicles.

Toyota plans to take rural road to realise sales potential of Glanza

Having established its presence in urban centres, Toyota Kirloskar Motor (TKM) is now looking to expand its sales network in rural areas in the country as it aims to tap demand for its entry-level products like Glanza and Urban Cruiser in such locations.

The company, a joint venture between Japanese auto major Toyota and Kirloskar Group, plans to ensure that a major part of any future investment on sales network expansion is now directed towards smaller cities and towns.

"We now plan to go into interior parts of the country as we have already established our sales network in the big cities," TKM Senior Vice President Naveen Soni told PTI in an interaction.

The company needs to bolster its presence in smaller cities, towns and rural areas as Glanza and Urban Cruiser is much stronger in such areas, he added.

"A and B vehicle segments are the primary domain of smaller cities where we do not have adequate presence right now. We are trying to have dealership expansion in such a manner that we can meet the market requirements," Soni

The company currently has around 419 dealers across the country. Last year it opened around 50 outlets of which 70-80 per cent were in the rural areas.

'We are now making a plan for this year. The most important thing that we are proposing now is the focus on smaller townships, the rural India. It is where we are going to focus. It is in such locations where our new products from the alliance partner will be more accepted," Soni said.

As per a global collaboration

Cruiser in the domestic market. TKM also gets MSI's premium hatchback Baleno under the same arrangement and sells it as Glanza in the market.

When asked about future products it expects to get from the alliance partner , Soni said the company would continue to evaluate the market and see which products fit its requirement. He however noted that SUVs continue to dominate sales in the country.

"Already one-third of the passenger vehicle sales are driven by SUVs. That being the case SUVs would play an important role in any automobile company's portfolio," Soni said when asked about the company's plans regarding expanding its SUV portfolio in the country.

With the onset of COVID-19 and the focus towards digitisation, the report said it believes the next 12-24 months will see a significant shift towards open banking amongst Indian FIs. Companies will invest in building core capabilities to address customers' immediate needs

Manjari Biche and Gargi Biche, Pune


Famous mother-daughter duo Manjari and GargiBiche, who have been riding for five years now, are an inspiration

"I'm passionate about motorcycling, which is why I have undertaken various expeditions to raise awareness about sign language and deaf women's empowerment. I'm also the co-founder of a company called Silent Expeditions for bikers with an emphasis on those with disabilities. In 2018, I rode

Bengaluru to Leh covering 8.400 kilometers in a single shot to spread awareness about sign language and deaf women's empowerment," shares she.

Archana's aim is to motivate future generations and dismiss all the stereotypes regarding disability, especially disabled women.

Jesslina Nayyar, Delhi

Jesslina Nayyar, a model, an influencer and an avid rider is breaking stereotypes to change her life and inspire other women and girls around. A passionate Royal Enfield enthusiast, she turned her passion for travel and riding into her success story, Jesslina is breaking barriers and is up for any adventure.

Iesslina feels riding is still a male dominate space. She says, "Although our society



has linked motorcycling with males, riding is beyond discrimination. It is still a maledominant space and there is a yawning gap between male and female riders in India."

Sharing about the kind of discrimination women riders face, she says, "Day after day, every day! I was once at a motorcycle shoot and considering the fact that it was for a motorcycle shoot, I assumed

the client has selected me because they knew I ride motorcycles! During the start of our shoot, he was so scared watching me sit on the motorcycle. He thought I was too fragile to handle the bike. As soon as we started shooting, he saw me riding and being in total control of

the bike and his jaw dropped. He later came and apologised for being sexist."

Having grown up living all over India since her father was in the Indian Army and is a biker himself, Jesslina's motorcycle journey began at the age of 18, when she got her hands on her father's motorcycle that was completely modified into a whole new cafe racer. How empowered does she feel getting onto a bike and going places, she shares, "So, many women are constantly told they can't do certain things and some of them end up believing it. I think that riding a bike is one of those few experiences in life that allow you to take the handle-

bars and define your own

my own path along this journey!" Concluding the conversa-tion with the change she wishes to see among Indians, Jesslina says, "A lot of people only go to watch a film, and some of us get to star in one. Riding a motorcycle is like starring in a film. Everything around you is so real and you can feel things differently! I think oftentimes in life, everyone wants to just play it safe and we don't want to get out of our comfort zone. Honestly, women are hardest on themselves, people are

always going to talk, you don't need to prove anything to anyone, you don't need to be the "first" to do anything anymore! You are what you are and that's your power! So you can make your own choice to see where that road is going to take you, and I've

a choice where I don't know

Hvderabad Kiran, like most of us, has a regular job. She is a psychologist by profession and a voracious reader who would want to own a mini library at her place. She has a knack for music, dance, and loves playing guitar in her leisure time. Kiran may be a perfect example of how she is breaking stereotypes in this world of

motorcycling predominately spearheaded by men. She recalls her incredible first ride to Kanyakumari to Kashmir which coincided with World Motorcycling
Day. She cruised herself up to Kanvakumari through the rains and her eagerness was to reach Kashmir by July 18, as it happened to be her birthday. Speaking of how women are faring in motor-cycle riding and the kind of support they receive, Kiran says, "When I say riders, I am referring to those who hold the spirit. Not those who just do occasional 10-20km rides and come for meets. So if we are looking at riders who have done some remarkable rides, they are hardly 1%. Support for female riders

Kiran covered approx. 14000 km in her maiden ride and became the first woman from Telangana and Andhra Pradesh to have covered Kanyakumari to Kashmir in her first solo trip. Her convenient escape on her Watson (her Royal Enfield Thunderbird motorcycle) are the mountains in Coorg, Madikeri, and the Western Ghats. She rode solo to Khardongla and is the second woman in India to have achieved this feat. She feels that Motorcycling is an art and how riding can be both liberating and meditative.



India Eves suffer heavy loss on return
