# PM skips meet

#### **No tradition of PM** attending all-party meeting, says BJP

PNS NEW DELHI

Prime Minister Narendra Modi on Sunday skipped an all-party meeting called by his Government, a day before the start of the Winter Session of Parliament. The Aam Aadmi Party (AAP) staged walk-out and the Congress-led Opposition demanded a law for the Minimum Support Price (MSP), compensation for the families of 'martyred' farmers and a discussion on fuel prices and inflation.

The violence in Tripura, the Pegasus spying controversy and the safeguards to prevent a potential third Covid-19 wave are on the Opposition's agenda for the Winter Session of Parliament. The session comes barely a few months before the crucial Assembly polls to the five States of Uttar Pradesh, Uttarakhand, Goa, Manipur — ruled by the BJP — and Punjab run by the Congress.

The Government is looking for a smooth session of Parliament after it 'bowed-down' to farmers' demands to scrap the controversial farm laws.

In addition to the withdrawal of the three farm laws and the Cryptocurrency Bill on the first day itself, the Government has listed as many as 26 Bills for introduction in Parliament during the Winter Session, which is set to take place from November 29.

## TMC to skip Opp meet in Parl called by Cong today

The differences in Opposition ranks, namely between the Congress and the TMC after the poaching of leaders by the latter from the grand old party — came to the fore on Sunday with the TMC saying it was "disinterested" in coordinating with the Congress during the forthcoming Winter Session of Parliament. The TMC has decided not to attend the meeting of Opposition floor leaders called by the Leader of Opposition Mallikarjun Kharge of the Congress on November 29 ahead of Parliament's Winter Session. At the same time, Mamata Banerjee's party maintained that it would cooperate with other Opposition camps on various issues concerning people's interests.

"I think all the Opposition parties should come to the meeting on Monday to create a consensus over the issues to be raised in Parliament. The issues that are on priority shall be discussed in the meeting," Kharge said reacting to the TMC's stand.

The reaction from the grand old party came even as the TMC attended the all-party meeting convened by the Union Government earlier in the day.

The Congress, in its Parliamentary party meeting chaired by party president Sonia Gandhi had expressed anger over the way the TMC has been poaching Congress leaders, including Sushmita Dev, Kirti Azad Ashok Tanwar, Mukul Sangam and others in the last few months.

We invite every party in the Opposition for an exchange of views before the start of the Parliament session. But it is up to them (TMC) whether to attend or not," the leader of the Congress in the Lok Sabha Adhir Ranjan Chowdhury said. Kharge has called for a meeting of the Opposition parties to discuss the issues to be raised in Parliament during the forthcoming session.

## 'Omicron spike mutations may hit jab efficacy'

PNS NEW DELHI

Underlining the grave threat emerging from the new Omicron variant of the coronavirus, AIIMS Director Dr Randeep Guleria has said the effectiveness of the vaccines against the new mutant will have to be critically examined since the variant has reportedly got over 30 mutations in the spike protein, giving it the noescape mechanism.

The presence of spike protein facilitates a virus' entry into the host cell and is responsible for making it transmissible and causing infection.

"The new variant of the coronavirus reportedly has got more than 30 mutations at the spike protein region and, therefore, has the potential of developing immunoescape mechanisms. As most vaccines (work by) forming antibodies against the spike protein, so many mutations at the spike protein region may lead to a decreased efficacy of Covid-19 vaccines," Dr Guleria said.

In such a scenario, the efficacy of vaccines, including those in use in India, needs to be evaluated "critically", he said.



The future course of action will depend on what more data on its transmissibility, virulence and immunoescape shows, he said.

The Indian SARS-CoV-2 Genomic Consortia INSACOG is closely tracking the new variant of Covid-19 called B.1.1.529 and its presence has not been detected yet in the country, officials have

Dr Guleria emphasised the need to be very vigilant and having an aggressive surveillance both for international travellers and in the region where there is a sudden increase in the number of cases.

## Sidhu slams Dy CM over STF report

ontinuing to corner his Own party's government over the issue of drugs, Punjab Congress president Navjot Singh Sidhu on Sunday slammed Deputy Chief Minister-cum-Home Minister Sukhjinder Singh Randhawa over his decision to set up a three-member committee under Chief Secretary to probe the delay in initiating action against drug peddlers.

Sidhu also lashed out at Randhawa over his remarks to "once again" urge the Punjab and Haryana High Court to open the "sealed" report. The report was submitted by the then chief of Governmentconstituted Special Task Force (STF) on drugs in the Court in a sealed cover in a drugs mat-

Sidhu, who had recently threatened to go on a fast-untodeath if the drug report was not made public by the State Government, on Śunday asked the Government why it was pleading in the High Court when the Court had directed it to take the lead and open the

Sidhu took to Twitter to share the relevant parts of the High Court directions passed in this context to attack the party's government over the drugs issue. "...if there is nothing in the report, then let the captain be accountable, if there is anything then take immediate action," said Sidhu.

Ahead of the 2022 polls,

the drugs issue is once again taking political hues. Sidhu has all along been raising the issue to act against the "kingpins" of the drugs menace that ruined Punjab's youth, while pressuring Congress-led Punjab Government to open the ŚTF report, that is with the High Court in a sealed cover.

Citing High Court's observations, Sidhu maintained that the Court had handed over a copy of this report to the Punjab Government, through the Advocate-General, and nowhere the High Court had stopped this report from being made public.

## The Concept of Atman in Hinduism

The doctrine of atman is **⊥** accorded a position of paramount importance in the philosophical and theological beliefs of Hinduism. The Sanskrit word atman (translated in English as soul or the spirit) refers to the self-existent essence of all beings including the cosmos itself. At the individual level, it represents one's inner self. It symbolises one's

true nature which is distinct from his ego and intelligence etc. The soul is the very foundation of all living beings. The soul is which possess-

es consciousness and infuses the same into the mind-body complex. It is the very source of consciousness. It is also consciousness. Without it, the body can have no life. But, the changeless soul is forever distinct from the bodies and the mind which are always in flux. The soul expresses that

subtle aspect of beings, which though invisible and inconceivable, is most vital. It is the spiritual spark which breeds consciousness (or awareness) in a living being. It gives rise to varied experiences of life. The atman is the subject which is aware of all the objects around man, including his own body. mind and intelligence etc. etc. Human beings are selfaware. They are aware not only of the world around them, but also of themselves - their bodies, their thoughts, their activities and their emotions etc. They know that they are thinking beings. They are aware of themselves. They reflect upon their own thoughts. Though the subject, they are themselves the object of awareness.

To put it slightly differently, one's material existence such as his ideas, views and beliefs etc. keep on changing from time to time; but the sense of his own self, which is aware of all these thought processes, never changes. That is why the self is called one's true essence.

Broadly speaking, consciousness can be divided into three levels - atman, jivatman and Paramatman. Atman is a generic term. It refers to the soul as such. Jivatman (jiva plus atman) alludes to an embodied

soul (the self). Jiva here refers to an incarnated being. Paramatman (param plus atman) refers to the highest spirit i. e. the Supreme Self. Jivatman makes various organs and faculties of a person function in the same manner as Paramatman underlies the working of the cosmos. Whereas the embodied soul after the demise of the body either transmigrates to a new life or attains freedom (moksha) from the bondage of material existence; the Supreme Self is the unchanging universal spirit which forever continues to bear all things and beings.

Different schools of Hindu philosophy have viewed the relationship between the indidifferently. The school of advaita Vedanta (non-dualism) believes that the two are completely identical. The jivatman

#### merges into Him when a person achieves liberation. Dvaita Vedanta (dualism) school of philosophy, on the other hand, considers the two to be entirely separate. It believes that the jivatman and Paramatman represent two different realities. Even upon liberation, the two continue to remain distinct. The school of vishisht-advaita (qualified dualism) believes that the differences between the Supreme Self and the individual self are only temporary. The jivatman remains distinct from the Paramatman in the beginning, but upon liberation becomes one with Him. Whatever their separate perceptions, all streams of Hindu thought accept the reality of the atman and agree upon its imperishable and eternal

## **Haryana honours doctors** above 75 years of age

PNS CHANDIGARH

Haryana Chief Minister Manohar Lal Khattar on Sunday said that the process of opening one medical college in every district is underway to meet the demand of doctors in the state.

A target has been set to prepare 2500 doctors every year and for this, the MBBS seats have been increased to 1685 from 700 in 2014, the Chief Minister said while addressing the 'Doctors Day Award function' organized under the aegis of Haryana Medical Council at Indradhanush Auditorium in

On the occasion, the Chief Minister Manohar Lal and Health Minister Anil Vij honoured 90 doctors above the age of 75 years by presenting them with the 'Vat Vriksha Award'. The 92-year old Dr RS Sangwan from Sirsa, was also among those who received the honour.

The Chief Minister said that the doctors of today's generation should take inspiration from the doctors of the older generation and serve humanity with the same spirit and devotion.

He said that at present, the number of doctors in both the private and government sector in Haryana is about 13,000-

14,000, whereas according to the UNO norms, there should be one doctor per 1000 population. If we consider the population of Harvana as 2.70 crore in 2021, then 27,000 doctors are required.

To meet this demand, a target has been set to produce 2500 doctors every year, he added. Khattar said that required

support and cooperation is also being received from the Central Government in the medical sector. The National Cancer Institute has been established at Badsa in Jhajjar district. Apart from this, the process of setting up an AIIMS each in Rewari and Panchkula is going on. The land measuring 25 acres in Panchkula has already been handed over to the Central Government, he said. The Chief Minister recalled that when he himself was admitted in Medanta for the treatment of COVID-19, he had closely observed the spirit of serving doctors.

Vij said that out of the 2.83 crore vaccine, 90 percent that is 1.84 crore people have got the first dose and 49 percent people have got the second dose in

The Minister said that many people have sacrificed their lives during this Corona period, out of which 28 people belong to the Health Department. In their memory, Wall of Memory' will be built in the headquarters and district hospitals, he said.

More than 70 percent of the population of the pre-school children and 60.6 percent women in Haryana are anaemic. Also, 56.5 percent pregnant women in the state have anaemia. This worrying trend is revealed in the National Family Health Survey – 5 (NFHS), a 2020-21 survey, released by the Union Ministry of Health and Family Welfare. Contrary to the claims of

the State Government of improving health indicators in the state, the NFHS-5 has revealed poor nutritional status in the state's population. 70.4 percent children (6-59 months) including 68.1 percent in urban and 71.5 percent in rural areas are anaemic in the state. Not only this, 60.4 percent women (15-49 years/all women) have anaemia while 56.5 percent pregnant women (15-49 years) including 54.6 percent in urban areas and 57.2 percent in rural Haryana were also found to be anaemic.

The health indicators have recorded only a slight improvement from NFHS-4 anaemic pregnant women has increased from 55 percent recorded at that time.

Only 11.8 percent children

to be receiving an adequate diet, as per the NFHS-5. The prevalence of anaemia among men, the data show, is significantly lower compared to other groups in the state i.e. 18.9 per cent in the age group of 15-49 and 29.9 per cent in the age group of 15-19 years. According to the survey, the state has recorded a high infant mortality rate ( the number of infant deaths for every 1,000 live births) at 33.3 percent, an increase from 32.8 percent in NFHS-4.

The neo-natal mortality rate has gone down to 21.6 (deaths per 1,000 live births in the first 28 days after birth), from 22.1 in NFHS 4 and the under-5 mortality rate now stands at 38.7 — a drop from 41.4 in NFHS-4. The NFHS-5 fieldwork for Haryana was conducted from January 12, 2020 to March 21, 2020 prior to COVID-19 triggered lockdown and then from December 21, 2020 to April 30, 2021 post lockdown gathering information from 18,229 households, 21,909 women, and 3,224 men in the state.

Nutritional status of children and vaccination

The state has improved its performance in nutritional status of children and vaccination. 27.5 percent children (under five years of age) were

percent in NFHS-4. The number of wasted (weight for height) children has also declined from 21.2 percent in 2015-16 to just 11.5 percent. Of all under-five children in Haryana, 21.5 percent are underweight. The percentage of fully immunized children (12-23 months receiving BCG, measles and 3 doses each of polio and DPT) stood at 76.9 percent, an increase from 62.2 percent registered in the last survey. Apart from this, 94.9 percent institutional delivery including 57.5 percent at public facilities were registered in the state."

## Will act according to the Centre on cases registered against farmers, says Haryana CM

Haryana Chief Minister Manohar Lal Khattar on Sunday said that the State Government will take a call on the demand for withdrawal of police cases against farmers according to the instructions of the Centre.

"When this issue (farm laws) will reach finality, what the Centre says at that time, we will decide accordingly," the Chief Minister said while talking to the mediapersons here.

The Chief Minister was responding to a query that Union Agriculture Minister Narendra Tomar had said the withdrawal of cases against the farmers protesting the Centre's farm laws is in the domain of State Governments and they have to decide on it.

The Samyukt Kisan Morcha, an umbrella body of

farmer unions spearheading the farmers' stir against the three farm laws, have said that they will continue their agitation until the Centre accepts their demand of a legal guarantee for minimum support price (MSP) and withdrawal of cases against farmers, among In Parliament's winter ses-

sion, a bill to repeal the three farm laws, against which thousands of farmers have been protesting for the past year, will be introduced by the Central Government. When asked that the farm-

ers' stir is still on, the Chief Minister said that it is for them (farmers' unions) to decide on it but the law and order situation should not be

disturbed. registered against protesting

the state. The farmers had been booked under sedition, attempt to murder, rioting, unlawful assembly, criminal intimidation, damage to public property among other related charges since the beginning of agitation against central farm laws during November last year.

Responding to another question on the alleged scam in recruiting dental surgeons in Haryana, in which the opposition has demanded an independent probe, Khattar said that the government has given full freedom to the Vigilance Bureau to investigate the case. The investigation agency is conducting an in-depth probe into the scam, he said.



## **Over alleged irregularities in deal with Future Group**

#### Senior executives of Future Group also summoned under FEMA

PNS/PTI ■ NEW DELHI

The Enforcement Directorate has summoned Amazon India head Amit Agarwal next week over alleged irregularities in a deal with Future Group. The agency has also summoned the senior executives of the Future Group.

The executives have been summoned along with documents under the provisions of the Foreign Exchange Management Act (FEMA), sources said.

Amazon India head Agarwal, some other senior officials of the company and those of the Future Group have been called, the sources

The investigation is being conducted under various sections of the FEMA after the federal agency received a communication from the Commerce Ministry early this year seeking "necessary action"



against e-commerce players like Amazon and Flipkart pertaining to certain multi-brand retail businesses and an observation made by the Delhi High Court in relation to Amazon.

The HC had said that the attempt made by the US-based firm to control Future Retail through a conflation of agreements it has with an unlisted unit of the Indian company will be considered as violative of the FEMA and foreign direct investment (FDI) rules.

The executives have been asked to join so that investigation can be taken forward. The agency has gathered details from the documents submitted by the companies earlier and other sources over the last few months, agency sources said. An Amazon spokesperson said they were examining the

ED summons.

"We are in receipt of summons issued by the ED in connection with the Future Group. As we have just received the summons, we are examining it and will respond within the given time frame,' the spokesperson said in a statement. The Kishore Biyaniled Future Group did not respond to the queries over the development.

Amazon and Future Group have been battling it out in courts after the Kishore Biyani-led group in August last year agreed to sell its assets to billionaire Mukesh Ambani's

basis for Rs 24,500 crore.

Earlier this month, a promoter entity of Future Retail Ltd (FRL) had been asked by the ED to provide documents pertaining to the 2019 deal with Amazon. FRL had noted that it has not received any direction to provide any document.

The independent directors of FRL have approached the Competition Commission of India (CCI), urging it to revoke the approval it had given to the Amazon-FCPL deal in 2019, alleging the ecommerce major of making false statements before it.

Amazon has also written to the independent directors of FRL, alleging "significant financial irregularities", and said this warrants a "thorough and independent examination' of relevant facts and related party transactions between FRL and other Future Group

It has also reached out to CCI, requesting it to "act in aid of the binding injunctions operating against FRL, FCPL and the Biyanis, in terms of the EA (emergency arbitrator) Order and the Order on Vacate Application and recall the Observation Letters forthwith".

## Low pressure area forming over south Andaman Sea



In its latest weather bulletin, the Meteorological Department (IMD) said that a low pressure area is likely to form over the south Andaman Sea around November 30 and this system is likely to become more marked and move westnorthwestwards during subsequent 48 hours. This has the potential to intensify into a cyclonic storm in due course.

"Under its influence, isolated heavy rainfall has been predicted for Andaman and Nicobar Islands on November 30. Rainfall is likely to increase over North Coastal Andhra Pradesh and Odisha from the night of December 3," the IMD

October to December is among the favourable months for the development of cyclones in the Bay of Bengal and the Arabian Sea. This year, no cyclonic storm formed over the Bay of Bengal in October and



the bay was cyclone Gulab in late September when the southwest monsoon was still active over the region. Cyclone Gulab made landfall over north Andhra Pradesh on September 26. Later, the remnants of the storm entered the Arabian Sea and intensified into a severe cyclone, Shaheen.

About 80 cyclones are formed around the world annually, out of which five are formed in the Bay of Bengal and the Arabian Sea, together known as the North Indian Ocean. India's east and west coasts are prone to cyclones with the maximum associated hazards—rain, heavy winds and storm surge— faced by coastal districts of West Bengal, Odisha and Andhra Pradesh.' Cyclones in the North Indian that is, they occur during two seasons— April to June (premonsoon) and October to December (post-monsoon). Of these, May and November remain the most conducive for the development of cyclones," IMD said. The IMD has also issued

an orange alert for coastal districts in south Andhra Pradesh and north Tamil Nadu as the rain continued in the two southern states with the activity expected to reduce over Tamil Nadu by the end of this month. An orange alert usually indicates heavy rain accompanied by thunderstorms and lightning. According to the police the mini truck was carrying about 35 people while it hit a stationary truck laden with stone chips killing 12 people on the spot. Locals said the accident site was terrifying because the mini truck had turned into a mangled metal trapping most of the victims.

### If there's no law on MSP, expect tractor morcha in Delhi on Jan 26: Tikait to Govt

ontinuing his aggressive posturing over the various demands of the agitating farmers, Bharat Kisan Union (BKU) leader Rakesh Tikait on Sunday warned the Government that if it did not mend ways and bring in a law guaranteeing Minimum Support Price (MSP) to farmers, the farmers' unions would not have any alternative but to organise tractors' mocha in the national Capital on the next Republic

On a day when a Kisan Mahapanchayat called for the defeat of the ruling BJP in the forthcoming State Assembly elections and other local body polls, Tikait said: "Despite having been called traitors, we have raised the farmers' demands.... Declare us as traitors and put us behind the bars. Let the Government mend its ways.. Let them know that their intimidating tactics will not work with us. Farmers have suffered a great deal during the last one year. Let them bring in a law guaranteeing Minimum Support Price (MSP) to farmers. Otherwise, January 26 is not far away, our four lakh tractors and farmers are very much around".

A day after the Samyukta Kisan Morcha deferred its tractor mocha to Parliament on the first day of the winter session after urging Prime Minister Narendra Modi to fulfil their six demands, the farmers and workers attending a Kisan Mahapanchayat organised by the Samyukta Shetkari Kamgar Morcha (SSKM) at Azad Maidan in south Mumbai celebrated its year-long agitation which saw the Government announce its decision to repeal the three controversial laws.

The farmer leaders vowed to continue their agitation till the Government settled their remaining demands. Apart from a law guaranteeing MSP for formers, withdrawal of the Electricity Amendment Bill, removal from the Cabinet and arrest of "butcher of Lakhimpur Kheri" Union Minister Ajay Mishra Teni, repeal of the four Labour Codes, an end to sale of pub-

lic undertakings through privatisation, halving of the price of diesel, petrol, cooking gas and other essential commodities, doubling the days of work and wages under MNREGA and extending it to the urban areas.

In a call given by the farmers' joint body that may be a major cause of concern for the ruling BJP ahead of the crucial Assembly elections in Uttar Pradesh, Uttarakhand, and Punjab, the Mahapanchayat called for the defeat of the BJP in the forthcoming State Assembly elections in three states and local body elections in Maharashtra.

### Anger among Hindus in TN over | BJP ruined democracy, says reports of demolitions of temples

There is an all-round resentment and anger ▲ among Hindus in Tamil Nadu thanks to the social media that beam views and news stocking religious sentiments. Reports about deliberate demolition of temples across the State since M K Stalin became Chief Minister in May 2021 have reached a peak.

R Ananthanarayanan, an entrepreneur in Chennai specialised in yacht and boat building wears an agitated look when he recounts the haste with which the State administration demolished the Ambal temple in Thiruvallur district on

"The proprietor of the temple, who built it from scratch was told at 3 pm that the structure would be demolished since it has been built on Government land. The officials came to the temple in an hour's time and much to the dismay of the devotees the building was razed to the ground," Ananthanaravanan told The Pioneer. He said nearly 20 temples have been demolished in the State since the month of May.

Krishnaswamy, the owner and priest of the illegally on government land. "When we were told by the Revenue Division Officer that the temple was being demolished as per Government order, we pleaded with folded hands to grant us a day to furnish the relevant documents. But by 4 pm, everything was over," said the priest.

Gauthaman Ramakrishnan, director, Vedic Science Study Centre, Chennai, described the government action as unilateral and violative of the law of the land. "If the authorities felt that the temple has been constructed in poramboke land, the trustees should have been asked to vacate the premises within a stipulated time. Whatever has happened is despicable and unfortunate," said Gauthaman.

An intelligence official in Chennai who is privy to the law and order situation in the State said that tension was brewing up in the community. "The State administration should do something to douse the flames before it emerges as a communal flare".

He pointed out that the action of Vasantham Karthikeyan, DMK MLA from Rishivandiyam , paying cash compensation of Rs 5 lakh to the Church in lieu of the Government demolishing an illegally built prayer hall has antagonised the majority community. "They demand the Government should behave in a justifiable manner while demolishing places of worship. There cannot be separate laws for Hindus and Christians," he said.

But Rangarajan Narasimhan, a Tiruchirappalli based Vedic scholar had a different version to tell. "I understand that the temple was built on a waterbody. The social media actions of the bureaucrats," said Narasimhan.

Hundreds of cases of Brahmin priests get ting bashed up by Dravidian activists are pouring in from across the State. Though the chief minister has warned of stern action against the perpetrators of such crimes, it is yet to make any impact on the pattern of attacks. "The DMK Government should understand that it won the 2021 election because the Hindus too voted for the party," said Gauthaman.

chief Jayant Chaudhary to contest the elections, the party's Uttar Pradesh unit chief Masood Ahmad told PTI in an interview, adding that if the kin of farmers who died during the farm laws protest are willing to contest on an RLD ticket, the party will take a decision based on their winnability. Masood, however, cate

gorically stated that if the SPled alliance is voted to power in Uttar Pradesh, Akhilesh Yadav will be its chief minister and the RLD a partner in the governof western Uttar Pradesh have been identified from where the RLD will be fighting. These seats are spread across Saharanpur, Muzaffarnagar, Meerut, Shamli, Bulandshahr, Hathras, Mathura, Agra, Aligarh, Moradabad and Amroha. The total number of seats on which the party will

contest in the upcoming assembly elections is likely to go up further," he said. Asked if Jayant

Chaudhary will be deputy chief minister if the SP-led alliance wins, Ahmad said, "I don't know whether Jayant ji will contest or not. Almost three months ago, when I asked him if he would contest the 2022 Uttar Pradesh assembly elections, he had said no. But in politics, things change fast."

The entire party wants him to contest, and there are many seats Chaudhary can choose from, he said, adding, "I am willing to offer him the Tanda assembly seat (in Ambedkarnagar district)."

The RLD and the SP are yet to announce a seat-sharing arrangement for next year's election to the 403-member Assembly. The RLD has one MLA in the outgoing assembly Sahendra Singh Ramala from the Chhaprauli assembly constituency in Baghpat.

### Honour killing case: Casteism not annihilated even after 75 yrs of Independence, says SC

New Delhi: Incidents of caste-motivated violence show that casteism has not been annihilated even after 75 years of independence and it is high time civil society reacts and responds with "strong disapproval" about the ghastly crimes committed in the name of caste, the Supreme Court has

The apex court, which delivered its verdict on a batch of pleas in a 1991 Uttar Pradesh honour killing case, in which three persons, including a woman were killed, said it had earlier issued several directions to authorities to take strong measures to prevent honour killings.

Those directives should be carried out without any further delay, it A bench headed by Justice L Nageswara Rao also said that to avert trial getting tainted and "truth becoming a casualty", the State has a definite role to play in protecting witnesses, to start with, at least in sensitive cases involving those in power who have political patronage and could wield muscle and money

It said that "bigotry" perpetuated by caste-based practices, which are prevalent even today, impedes the Constitution's objective of equality for all citizens.

"Two young men and a woman were physically assaulted for nearly 12 hours and killed by the accused for violating caste-ridden societal norms. These episodes of caste-motivated violence in the country demonstrates the fact that casteism has not been annihilated even after 75 years of

independence," the bench, also comprising justices Sanjiv Khanna and B R Gavai, said

The top court, while upholding the Allahabad High Court verdict with regard to conviction of 23 accused in the case, acquitted three persons in view of ambiguity in their identity. Referring to the aspect of witness protection, the bench noted that 12 prosecution witnesses in the case turned hostile.

"Even if the witnesses have turned hostile, their evidence can be accepted, if they are natural and independent witnesses and have no reason to falsely implicate the accused," it said.

The apex court said the right to testify in courts in a free and fair manner, without any pressure and threat whatsoever, is "under serious attack today", and if one is unable to testify in courts due to threats or other pressures, then it is a clear violation of the rights under articles 19 (1) (a) and 21 of the Constitution.

"Right to life guaranteed to the people of this country also includes in its fold the right to live in a societv which is free from crime and fear. and the right of witnesses to testify in courts without fear or pressure," it The bench said one of the main reasons why witnesses turn hos-

tile is that they are not accorded appropriate protection by the State. It is a "harsh reality", particularly, in cases where the accused are influential people and are tried for heinous offences and they make attempts to terrorise or intimidate

witnesses, the bench said.

#### Nearly all terrorists involved in civilian killings in J&K last month neutralised: Sources

**New Delhi:** Nearly all the terrorists involved in the killings of civilians in Jammu and Kashmir last month have been neutralised and the armed forces are now focussing on intelligencebased "surgical operations" involving smaller teams to deal with terror activities in the Union Territory, sources in the security establishment said on

They said a "refined" approach to deal with terrorism has been put in place under a more nuanced framework of better coordination among the Jammu and Kashmir police, the intelligence agencies and the Army with an aim to minimise collateral damage.

After a spell of relative calm, Jammu and Kashmir witnessed a spate of killings of innocent civilians last month, triggering apprehensions of an intense cycle of violence and turmoil in the region. The sources said a major focus of the anti-terror drill has been to achieve "zero loss" of innocent lives and all wings of the security forces have been trying to achieve

That is why the focus has been on "intelligence-based surgical operations" involving smaller teams, with a focus on drawing support from the local population to such actions, they According to intelligence inputs,

Pakistan-based terror handlers have instructed their proxies operating in Kashmir to ensure at least 10 civilian deaths whenever the security forces undertake counter-terror operations, the sources said.

They said 24 civilians were killed

and 49 injured in various counter-terror operations in 2018.

Over the past three years, the security forces undertook a series of measures to ensure minimum collateral damage and as a result of such efforts, only two civilians were killed and two received minor injuries in

2021, the sources said. Asked about the encounter in Srinagar's Hyderpora, they said a certain section is focussing on it to occupy "lost space". Jammu and Kashmir police chief Dilbag Singh on Thursday said the ongoing investigation into the Hyderpora encounter suggests that the terrorists were supported by a network in carrying out terror activities.

The sources said the security forces have been getting support, including actionable intelligence, from the locals in several parts of Jammu and Kashmir as they have rejected the 'false propaganda" unleashed by Pakistan. There were instances of terrorists

even being allowed to escape when there was a threat of collateral damage or when the lives of innocents were assessed to be at risk," said a source on condition of anonymity. The sources claimed that the sit-

uation in Jammu and Kashmir has been under control and pointed out that compared to the 318 terrorrelated incidents in 2018, only 121 incidents were reported in 2021. 'Similarly, while 202 stone-pelting

incidents were reported in 2019, only 39 have been reported in 2021," said

#### Bengaluru police denies permission to Munawar Faruqui's show, stand-up comedian says 'I'm done'

**Bengaluru:** The Bengaluru police have denied permission to Munawar Faruqui's stand-up comedy show in the city on Sunday amid protest by the Hindu right wing outfits who alleged that the artist had hurt the Hindu sentiments in one of his shows. "Yes, we have denied him permission. He will not perform any public show today," a senior police officer told PTI on condition of anonymity.

Faruqui also shared a statement on social media confirming that his Bengaluru show that had sold "600 plus" tickets was cancelled Sunday in the wake of the "threats to venue vandalism" and said he was "done".

"My name is Munawar Faruqui. And that's been my time, you guys were (a) wonderful audience. Good bye, I'm done," he said. The proceeds from the show were supposed to be donated to late Kannada star Puneeth Rajkumar's charitable organisation.

In the same statement, the 29-yearcomic said they initially did not want to reveal that the show was for charity. "Putting me in jail for the joke I never

did to cancelling my shows which has nothing problematic in it. This is unfair. This show has gained so much love from people in India irrespective of their religion. This is unfair (sic)" he added in his Twitter statement. Faruqui claimed that his 12

shows were called off in the last two months because of the threats to the venue and audiences. The e comedian also claimed they have a "censor certificate of the show", which proves there was "nothing problematic" in the stand-up act.

#### Over 30% women from 14 States, UTs justify beating by husbands: NFHS

New Delhi: Over 30 per cent women from 14 of the 18 states and Union Territories that were surveyed justify men beating their wives under certain circumstances, while lesser percentage of men rationalised such behaviour, according to the recent National Family Health Survey (NHFS).

According to NHFS-5, over 75 per cent women justified men beating their wives in three states -- Telangana (84 per cent), Andhra Pradesh (84 per cent) and Karnataka (77 per cent).

Manipur (66 per cent), Kerala (52 per cent), Jammu and Kashmir (49 per cent), Maharashtra (44 per cent) and West Bengal (42 per cent) were the other states and Union Territory where a large number of women justified men beating their wives.

To a question by the NFHS, "In your opinion, is a husband justified in hitting or beating his wife...?", over 30 per cent women from as many as 14 states and Union Territories

The survey put forward the probable circumstances under which a husband beats his wife: if he suspects her of being unfaithful; if she disrespects in-laws; if she argues with him; if she refuses to have sex with him; if she goes out without informing him; if

she neglects the house or the children; if she doesn't cook good food.

The most common reasons given by the respondents to justify beating were neglecting the house or children and showing disrespect to in-laws.

Of the 18 states, women respondents in 13 -- Himachal Pradesh, Kerala, Manipur, Gujarat, Nagaland, Goa, Bihar, Karnataka, Maharashtra, Telangana, Nagaland and West Bengal -cited 'disrespect to in-laws' as the main reason to justify beat-

The lowest population of women that justified beating by husbands was in Himachal Pradesh (14.8 per cent). Among men, 81.9 per

cent respondents from Karnataka said such behaviour is justified as against 14.2 per cent in Himachal Pradesh. Ushasree, director of

'Roshni', a Hyderabad-based NGO which provides counselling and other services to those in emotional distress. said her organisation has seen a rise in sexual abuse and domestic violence during COVID-19. "Some men appear to vent

## **Impending crisis?**

The new mutation of Coronavirus signals danger and we are not prepared to tackle it, yet again

■ n India where normalcy has come to by and large mean rejecting COVID-appropriate behaviour and a consensus that the viral pandemic has left Indian shores, ■ the new South African variant gives a serious wake-up call. There are as many people wearing masks as are consciously not wearing them. The fact that the festive season did not lead to any viral surge even though all safety precautions were ignored has led to a false complacency that the worst is past us. Sadly, that is wrong. The WHO has declared the new variant, named Omicron, is a 'variant of concern'. That is to say, do not take any avoidable risk. Here is what the world knows about Omicron, which is not much. Omicron's prevalence is more than noticeable in South Africa. Botswana, Belgium, Hong Kong and Israel have also reported cases. The variant has landed in Europe too, with the UK reporting two cases. Scientists have no



idea if it can lead to a surge, but say that it carries a high re-infection risk. Initial research has shown that the variant is associated with mutations that indicate it can be highly transmissible and increasingly infective. Omicrons' risk potential is being tested in a laboratory setting to check the efficacy of existing vaccines in containing its infection. The important question awaiting an answer is whether Omicron can evade the immune response.

The answer should better come from a scientific laboratory than from a population infected through ignorance or complacency. What does this

mean for India which has just announced its phase-wise policy of opening up the skies? Not much if the Government strictly follows the screening of passengers coming in from abroad and decrees automatic guarantine for two weeks without exception. The health ministry has listed the countries reporting the new variant in the highrisk category. The Ministry should now revise its order of allowing resumption of flights to these countries irrespective of bilateral air bubble agreements. India has also to ensure that hesitancy, complacency or logistical problems no longer hamper the vaccination process. Scientists are insisting now, more than ever, that vaccination is critical to protect the aged and those with comorbidities as well as healthy individuals who have fully returned to normal activities. Both groups run a high risk of hospitalisation and death if they are not fully vaccinated. Till Friday, over 120 core doses were administered of which only a third, 42.62 crore, were second doses. This figure has to pick up and fast. Secondly, the latest studies show that one of the vaccines available in India, the home-made Covaxin, is only 50 per cent effective against symptomatic COVID-19 disease. Many surveys have come out in the past giving different efficacy figures. They range from 81 per cent to 77.8 per cent to 65.2 per cent. There would be scientific explanations for each of the figures no doubt, but that does not help the lay person who may be intimidated by them.

mid growing global concerns over the new COVID variant, a lot of heat and dust seems to be gathering intensity over India's political horizon, too. While Prime Minister Narendra Modi, stressing the need to be proactive in the wake of this scary development, has already directed the Government officials to review the stated plans for easing of international flight restrictions in the light of "emerging new evidence" against Omicron, labelled by the WHO as a "variant of concern", there are others politicians who are also exploiting this opportunity to add to their political muscle, especially ahead of the Assembly elections in five States early next year. While the Prime Minister's directive to the officials came a day after the Ministry of Civil Aviation announced the resumption of scheduled international flights beginning December 15 (after near-



ly 20 months of the Coronavirus-induced suspension), the Opposition leaders — like Delhi Chief Minister and Aam Aadmi Party's national convener Arvind Kejriwal have upped the game by urging Modi to stop the flights coming into India, especially from those countries which are in the grip of the new variant of the Coronavirus infection.

In what can only be termed a political statement, Kejriwal sought to pitch the nation's people against the ruling party at the Centre when he said that India had "recovered" with immediate effect" from the COVID-19 pandemic "with great difficulty". Of course, it must be underlined that the new variant, feared to have a high potential for another spike in mutations as unseen ever before, was detected in a handful of South African nations. In view of this breakout, a number of countries, including the European Union, have already suspended travel to the affected regions. In this light, there's an understated but expedient and dire need for the nation's people to be more cautious in following COVID-appropriate measures like masking up, maintaining personal hygiene and social distancing, besides ditching vaccine hesitancy and going for the doubledose inoculation. It can't be stressed enough that people, especially the young and frequent travellers, need to understand that this is not the time to be complacent or engage in any false sense of security. We, all of us, must understand that we need to stand united in the face of this looming new threat to the world's health and do everything in our control, and a bit more, to defeat this pernicious virus.

## Jinnah could never fight for Pakistan




Jinnah would not have enjoyed being the head of Pakistan for long. He delighted himself mixing with the elite, whether Parsee, Hindu or Muslim

1935, there were no politics in his life. And until 1928, he attended the plenary session at Calcutta and felt insulted; he had been a Congressman. So much so that Sarojini Naidu, the poetess politician had described Jinnah as the best ambassador of Hindu-Muslim unity. His heart was in his law and its practice. He was reputed to be the highest paid barrister in the British Empire. He had presided over a function in Bombay to welcome Gandhi when he finally returned to India in the year 1915. When Gandhi got up to reply, he began by saying that he was so happy because he was welcomed by a Mahomedan leader. Jinnah publicly showed his irritation, if not also his anger, at reference to his religion for no rhyme or reason

According to his brother Ahmed, they were culturally Parsee and not committed Musalmans. They did not pray and did not know how to offer namaz. They ate and drank what they liked. Mohammed Ali loved pork sandwiches and ate them openly. They enjoyed whisky soda in the evening before dinner. His wife, Ruttie, was a Parsee until she died; his only child married a distinguished Parsee called Neville Wadia.

Campaigning for the 1945/46 general elections, he had stopped to make a speech at Jalandhar. Pran Chopra, who later became Editor of The Statesman, was then reporting on the election campaign. In the middle of the speech, reported Chopra, the azan (call to prayer) was heard. So the crowd retired for namaz. Jinnah remained on the stage, sat down, reached out to his achkan pocket and pulled out his cigar and smoked until the crowd returned and later resumed his speech in eloquent English (Jinnah knew only English and Gujarati). How much the Jalandhar crowd understood, no one



## Why Gwadar protests against the CPEC?

ecently, sudden protests erupted in Gwadar against the China-Pakistan Economic Corridor Project. Slated to be an 'upliftment project' for the people of Pakistan, it has instead become a hallmark of Chinese expansionism resulting in crushing the rights of those very people who have hosted it. Due to Pakistan's fragile governance mechanisms, a weak economy marred with corruption; the situation has turned grave. The protestors were supported by the local political groups and NGOs that had genuine interests against the CPEC Project. The Head of the 'Give rights to Gwadar' rally, Maulana Hidayat ur Rehman, has often been speaking on the rights of the people of Gwadar. Further, the role of the National Party and Baloch Student Organisation also has to be duly recognized in raising their voices against injustice. CPEC goes much beyond the commercial corridor route. It has more penetrative, severe effects on Pakistani society.

First, the CPEC Project has a long belt of 'coastal enjoyment industry', which will supposedly have a vibrant nightlife with luxury hotels, spas, theatres, golf courses. Undoubtedly, the coastal land that would be appropriated for this purpose has nothing to do with Pakistan's small-scale farmers or fishers. Instead, the facilities will ensure 'entertainment' for the Chinese and Pakistani retired Army personnel at the cost of the fishing industry, which has a share of 2 percent in Islamabad's economy.


The news of the Pakistani government

giving licenses to the Chinese fishing trawlers has been around for quite some time now. It is in addition to the Chinese illegal and unregulated fishing in the Arabian Sea even during the critical spawning period. These trawlers possess state of the art technology to fish, process and store fisheries immediately, thereby making the competition with the local fish-ermen asymmetric in nature. These developments will surely leave behind a trail of unemployment and poverty,resulting in people moving towards drugs and human trafficking.

Second, the CPEC has given immense opportunities to grab huge pieces of fertile agricultural land of the farmers. As the world knows, Pakistan is by and large a praetorian state, i.e., with the Army having the upper hand in most of the government's decisions. CPEC aimed to cover all arts of food production and distribution in the agricultural sector, ranging from seeds and fertilizer manufacturing to storage and transportation. However, the Project is implemented through land acquisitions under the direct supervision of the Army. These acquisitions have been without proper compensations and sometimes even without the consent of their rightful owners. The usurped land is rented out further with 'land rights' to the Chinese enterprises. In other cases, the agricultural projects convert to Chinese private corporations forging joint ventures with

## **Omicron spreads to more countries; world on alert**

The new potentially more contagious omicron variant of the coronavirus popped up in more European countries on Saturday, just days after being identified in South Africa, leaving governments around the world scrambling to stop the spread.

The UK on Saturday tightened its rules on mask-wearing and on testing of international arrivals after finding two cases. New cases were confirmed Saturday in Germany and Italy, with Belgium, Israel and Hong Kong also reporting that the variant has been found

In the US, Dr. Anthony Fauci, the government's top infectious diseases expert, said he would not be surprised if the omicron variant was already in the United States, too.

"We have not detected it yet, but when you have a virus that is showing this degree of transmissibility ... it almost invariably is ultimately going to go essentially all over," Fauci said on NBC television.

be more resistant to the protection offered by vaccines, there are growing concerns around the world that the pandemic and associated lockdown restrictions will persist for far longer than hoped.

Nearly two years since the start of the pandemic that has claimed more than 5 million lives around the world, countries are on high alert. The "act first, ask questions later" approach reflected growing alarm about the emergence variant nearly two years into a pandemic that has killed more

than 5 million people, upended lives and disrupted economies across the globe.

While much remains to be learned about the new variant, researchers are concerned that it may be more resistant to the protection provided by vaccines and could mean that the pandemic lasts for longer than anticipated.

The Dutch public health authority confirmed that 13 people who arrived from South Africa Friday have so far tested positive for omicron. They were among 61 people who tested positive for the virus after arriving on the last two flights to Amsterdam's Schiphol airport before a flight ban was implemented. They were immediately put into isolation, most at a nearby hotel, while sequencing was carried out.

### SA slams 18 countries imposing travel bans on fears of Omicron

South Africa's top health federation on Sunday slammed the 18 nations which have imposed travel bans on the country on fears of the new potentially highly-transmissible variant of Covid-19, Omicron, saying the world must avoid such "knee-jerk reaction" if it wants "transparency" in the sharing of critical medical data.

The new Covid-19 variant B.1.1.529, first detected in South Africa, was on Friday designated as a "Variant of Concern" by the World Health Organisation (WHO), which named it "Omicron".

The decision by 18 countries to ban flights to and from South Africa was premature, as there is still not enough information on how dangerous the variant might be, Angelique Coetzee, Chairman of South African Medical Association (SAMA) said. Coetzee also defended the decision to announce the findings, pointing out that South Africa should be lauded and not vilified for this.

## **RBI** to aid of depositors

**CUSTOMERS OF 16 STRESSED COOP BANKS TO GET INSURANCE COVER** 

New Delhi: The customers of 16 stressed cooperative banks will get up to ₹5 lakh deposit insurance cover on Monday from the Reserve Bank of India's (RBIs) subsidiary DICGC as part of its mandate under a new law.

The Deposit Insurance and Credit Guarantee Corporation (DICGC) had earlier prepared a list of 21 banks but five, including Punjab Maharashtra Co-Operative Bank (PMC Bank), are out of the list as they are either in merger process or out of the moratorium.

The Parliament in August passed the Deposit Insurance and Credit Guarantee Corporation (Amendment) Bill, 2021 ensuring that account holders get up to ₹ 5 lakh within 90 days of the RBI imposing a moratorium on the banks. Following the enactment, the Government has notified September 1, 2021 as the date on which the provisions of the Act would come into force.

The mandated 90 days from the notified date comes to an end on November 29, 2021. The depositors of these banks, who have not yet submitted their claims, are advised to contact the respective banks, a public notice from DICGC

"The claims should be supported by officially valid documents of identity and written consent to receive the amount lying in credit of their deposit account (willingness declaration) subject to a maximum of ₹5 lakh along with alternate bank account details into which the said amount may be credited," it said.

Depositors submitting valid documents, as mentioned above, will be paid by credit to the alternate bank account specified by depositors or on their consent, to their Aadhaar linked bank account, it said.

For the second phase, the last date for submission of documents is December 10, 2021 while date of payment is December 31, 2021, it added. Besides PMC Bank, depositors of Hindu Co-Op Bank Ltd, Pathankot of Punjab, Rupee Co-Operative Bank Ltd and Needs Of Life

Co-Operative Bank Ltd from Maharashtra and Bidar Mahila Urban Co-Op Bank Ltd of Karnataka are out of this. It is to be noted that the RBI had in June given in-principle approval to a consortium of Centrum Financial Services and fintech startup BharatPe to acquire the stressed PMC Bank.

Clearing decks for the takeover, the RBI in October gave licence for small finance bank to the consortium. Recently, the DICGC said there may be a need to invoke the provisions of Section 18 A (7) (a) of the Deposit Insurance and Credit Guarantee Corporation (Amendment) Act, 2021.

As per the Section 18 A (7) (a) of the Act, if a stressed bank is under the resolution process, the period for disbursement of ₹5 lakh can be further extend-

Last year, the Government increased the insurance cover on deposits by five times to ₹ 5 lakh. The enhanced deposit insurance cover of ₹ 5 lakh came into effect from February (PTI)

One representative said it is to the tune of 50-60 per cent and the other senior official of another telecom operator mentioned 60-70 per cent. The Telecom Regulatory

Authority of India (Trai) had recommended a base price fixed at ₹492 crore per mega-hertz for spectrum in 3.3-3.6

Telecom operators interested in buying radio waves for 5G will have to shell out a minimum of ₹9,840 crore on panprice by more than half in the India basis to buy spectrum in 3,300-3,600 Mhz band as Trai telecom operator representative has suggested that it "should be put to auction in the block size of 20 MHz"

In May, the Government allocated spectrum to the telecom companies for trials across various locations for six months in the 700 Mhz band, 3.3-3.6 Gigahertz (Ghz) band and 24.25-28.5 Ghz band.

At present 5G trials are going on in the country. The Department of Telecom has extended the trial period to May 2022, or till the time spectrum auction results are out, whichever is earlier.

Petrol, diesel price to fall only on sustained drop in international oil prices

 $P^{\text{etrol and diesel prices will}}_{\text{be reduced only if the cur-}}$ rent drop in international oil prices is sustained for a few more days, as domestic retail prices are fixed on a 15-day rolling average, official sources said.

Global benchmark Brent crude oil prices remained largely range bound at around USD 80 to 82 per barrel, levels during November (till November 25).On Friday, November 26, prices fell by around USD 4 per barrel till Asian timestamp. However, subsequently after the opening of the US market, with the drastic sell off in Brent Futures, prices fell further by around USD 6 to close at ÚSD 72.91 a barrel at ICE London. Sources said, this seems like a knee jerk reaction from fears that the new Covid-19 variant discovered in Southern Africa might dampen economic growth and trigger another demand slump.

State-owned fuel retailers Indian Oil Corporation (IOC), Bharat Petroleum Corporation Ltd (BPCL) and Hindustan Petroleum Corporation Ltd (HPCL) revise petrol and diesel prices on a daily basis.

But this revision is based on the average benchmark international fuel rate in the previous fortnight. So, the price on Sunday is decided by the average in the previous 15-days.

Natural expectation from the drop in rates on Friday is that retail pump rates will also go down. But that is not how retail rates move. Since the international oil prices have been range bound in most of November, the drop on Friday when averaged out with the previous fortnight does not translate into any significant

Only when the fall in rates is sustained for a few more days will we see a reduction in retail petrol and diesel prices," a source said.

The lender has set the reserve price (on cash basis) at ₹ 95 crore for the sale process. For the prospective bidder to expedite the process of due diligence exercise and for verification purposes of the



buyer, the bank said it will make all possible efforts to bring copies of documents at one place. However, the bank at its

sole discretion may withdraw the account offered for sale, without assigning any reasons, it PNB has set December 8 as the last date for completion of due diligence exercise. The last date of submission of binding bids is December 9, while the date for opening of bids is fixed as December 10, 2021.

#### FPIs net buyers in Nov; invest ₹5.319 crore

New Delhi:Foreign portfolio investors (FPI) have pumped in a net sum of ₹5,319 crore in Indian capital markets despite a massive correction seen in equities over the last fortnight. In October, they were net sellers to the tune of ₹12,437 crore.As per depositories data, overseas investors put in a net ₹ 1,400 crore into equities and ₹3,919 crore into the debt segment between November 1-26. This translated into total net investment of ₹ 5,319 crore. "Since FPIs have been holding large quantity of banking stocks, they have been major sellers in this segment. Sustained selling has made banking stocks attractive from the valuation perspective," said VK Vijayakumar, Chief Investment Strategist at Geojit Financial Services. he Fast Moving Consumer Goods (FMCG) market will see further tapering down and decline in volumes, especially in the in-home consumption category due to a higher base effect, but there are some "silver linings" as some categories are maintaining higher penetration than the pre-pandemic level, data analytics and market insight firm Kantar said.

The December quarter of 2020, was one of the fastestgrowing quarters, with a 5.5 per cent growth and these high baseline numbers are likely to cause another steep drop in growth rates in the next quarter as well.

"As a result, by the end of 2021, the MAT (Moving Annual Total) growth will see further tapering down, and a decline in FMCG volumes, inhome is very much possible," said Kantar in its FMCG Pulse for November 2021.

However, it also added :"Despite this, we maintain that it is not a scary situation to be in, but rather a fact that

mirrors the strong consumption trend the country has been witnessing for quite some time now." The September quarter retreated marginally by 0.5 per cent against last year's same period, primarily led by urban India, which shrank by 2.6 per cent. "Rural is maintaining

growth, but at just 1.5 per cent," Kantar said, adding "as a result, the MAT September FMCG growth stood at 1.9 per cent, slower than the population growth." The average quarterly growth in the pre-pandemic 2019 was 2.1 per cent. MAT is the total sales fig-

ures, over the course of the previous 12 months. This is a rolling yearly sum, so changes at the end of each month with data from the new month added to the total and data from the first month of the period taken away.

In FMCG, some categories took as soon as the pandemic struck, and then there were other categories that struggled during lockdowns but emerged as fast winners after lock-

Categories like dish wash,

due to high base effect: Report spices and salty snacks witnessed step-growth, without losing their penetration in any quarter since the onset of the pandemic.

## WISDOM TO SURVIVE IN A HOPELESS WORLD

The absence of empathy is a far more dangerous thing than Covid-19 virus, author and mythologist DEVDUTT PATTANAIK tells Khushbu Kirti

all hope, shines on you that fee-ble and fading light ray. It seems like it is trying to show you something while it directs its very meager light, blinking on and off, on an unknown path. You squint your eyes to concentrate on what you are seeing. You are surprised because when you were in complete darkness, you thought all that there could be around you was emptiness, loneliness, and hopelessness and suddenly this thin, meek ray has, as if, resurrected you. A strange feeling is rising inside you like a little plant that grows above the ground through its invisible, yet strongly embedded roots. This feeling gives you power that you had lost a long time back. The light becomes stronger while you take more steps forward and you start feeling safer and more sure of yourself.

That's how hope works. It changes the way you see the world and instills into you a new kind of enthusiasm to not only survive but succeed. And when, recently, I received the opportunity to converse with one of the most renowned modern writers, Devdutt Pattanaik, about his new book, Hope: Wisdom to Survive in a Hopeless World, I was beyond excited. While mythology is extremely engrossing, Pattanaik has time and again shown to the world that it could be even more lucid and much more interesting. He has, often, made it a medium to render modern solutions

He writes, Do you want to run away? Are you anxious about money, your family, and your future? In this book, the author helps you to unravel your emotions and find a way to move from darkness into light.

Read on for excerpts from an exclusive interview with one of the leading mythologists in India:

Many congratulations on your recent release, Hope: Wisdom to Survive in a Hopeless World.

Tell us everything about it. How did the book come into existence?

So the book, Hope, came into existence in the latter part of the Covid lockdown. I think we all had gone through a lot, and had seen our lives change dramatically. The lockdown had put a lot of stress on many people. Many people lost jobs, lost family. We, ourselves, went

I told her stories from mythology and she felt that, maybe, we should put it together and get it published. That's how Hope came into

Well, yes, it is an outcome of all the things that we went through — the migrant crisis, the large number of deaths, people losing jobs. I heard sta-

All these things created a sense of despair and hopelessness. Besides, the news coming on the political and economic front was all very, very sad and depressing. And people, instead of working together with each other in bad times, seemed to be snarling at each other. And that was all causing a lot of sense of hopelessness. I felt the book Hope was the need of the hour.

**♦**While almost all ancient religions and faiths agree on hopelessness being tackled by the self or getting resolved from outside, what do you have to say about the thought process of the absurdists?

\*Existentialism, as a philosophy, accepts that life is meaningless and we

as its consequences.

Care to weigh in? But, what is hope? Hope is about trusting that there are opportunities for you out there in this world. And you feel hopeless when those opportunities are just going away from you. Now, I feel you create a world full of hope when you yourself give hope to people around you. Western philosophy, with words, is very self absorbed, it doesnt talk about the other so much. It talks about self realisation, self actualisation, but never talks about our relationship with others.

Only when we create an ecosystem of hope, give others hope, will others reciprocate and give hope to us. I think that is missing in todays conversation. We are so self absorbed. We expect life to give meaning to us and we expect others to take care of us. We don't realise that life is a give and take relationship - that every self exists in an ecosystem of others. We cannot exist without each other.

♦ You mentioned that Covid-19 is not our enemy, and I second you. However, whenever a catastrophe occurs, do you think hope is what gets us, as a collective entity, out of it?

You know, Covid is not the prob-lem. It is how humans react to Covid, which is the problem.

You know, in the Bible, we talked about the great flood and how all the animals huddled together on a boat, which is managed by Noah. And I think that the catastrophe is when we are on that boat and we, rather than supporting each other through this crisis, keep fighting with each other. That was the crisis, where politicians are not willing to admit that they had to take tough decisions. Where politicians were playing politics at a time of need, instead of making tools available. We created shutdowns without realising the consequences to the poor. You know, the rich have resources to survive, but the poor don't have those.

I think, empathy was missing. Those are far more dangerous things than the virus itself — the absence of empathy, the absence of support to people — and the absence of support not just of the state, but humans with each other. And, I think, that is the great catastrophe. Theres humungous burden on doctors and nurses, and no one seems

have to suffer from angst and despair to realise that they are human beings, too, and need our support. So, I think those are questions that we should ask

> ❖If aham brahmasmi or shivo hum hold true, does Sunahshepa save him-

Well, everybody asked me what happens to Sunahshepa. And yes, we would like to believe the gods came down and helped him, or he managed to help himself. But the problem of the story is about being abandoned, where he realises that the people who are supposed to protect him — his parents, the king, that is the state, — have abandoned him. And the God, instead of helping him, wants him as a sacrifice. In a world where everybody sees you, seeks to consume you and uses you for their benefit, you feel used and lost.

Instead of being taken care of, Sunahshepa realises he's being abandoned. I believe his story is to remind that there are people in this world who feel abandoned by us. Hence, it is not that we are Sunahshepa. Maybe, we are his father, mother, teacher, or, maybe, we are the God who's asking his sacrifice. So, we have to always be careful. Do we see ourselves as the victim in the story, the hero in the story or the villain in the story? And, not all stories have happy endings.

As a mythologist, what part of Indian culture do you feel needs utmost intervention on saving and preserving it?

As a mythologist, I don't believe cultures need preservation. Cultures evolve and transform over time. Everybody believes that the world is coming to an end, that culture is going to collapse. But, as I speak in my book, these are the good times and bad times we go through. We pass through heaven and hell constantly. Heaven is created when we help each other and hell is created when we hurt each other. And, therefore, what we need to focus on is our humanity. It is that which needs to be remembered, because that is the most precious thing about culture.

'We try to establish Swarga, full of opportunities, but ignore Naraka, full of threats that the children may have to deal with again and again in future.

he recent spate of violence against women being reported in the news makes it sound like a new occurrence. In media, the ideas of womanhood and empowerment are unrealistic and likely to create an unrealistic assessment of women's access to public space. Whereas, womanhood is not much of contested space in Indian small towns, cities and villages. Unlike metropolitan areas, like Mumbai and Delhi, where at least intellectually, the disparate identities and contentious spaces are hallmarks of 'modernising' societies. Yet in both, class continues to determine parameters of womanhood; more so than caste or religion. Class, though, is complex to decipher (like any other sociological construct). Education and employment interact with family resources to predict class as a status for women but not the quality of life.

The  $\bar{q}uality$  of life varies for women who are working and earning a wage. In the same way, women who work inside the household see differential returns and recognition of their labour ranging from being taken for granted, to appreciation and applause. Unfortunately, these nuances of distinction in women's lives have been subjected more to an outsider-gaze than an inward-looking exercise, at least in social policy. The 'western' sensitivity and sensibility has focused mostly on the inequity in gender relation mea-



## CREATING PUBLIC SPACES

Breaking the nexus of male privilege is essential to women's existence, says DR SHWETA SINGH



sured through resource consumption or categorising the social systems within which they are embedded. The stereotyping alienates, drawing an odd, unrelatable picture of women and

their communities. In comparison, local writing using local languages represents women and their concerns violence, drudgery, and aspirations for self and family — starkly, without



theorising much. So, they also don't lend themselves to the policy drafting board, too well.

Womanhood practise is a grouped norm. The so-called 'modern' norms are circulated by activism and feminism and social organising but remain confined to women in colleges or women in social work type of fields. But by their very nature, the activist, or the feminist, or the socially organised woman is different from the women living a life embedded in relationships. The socalled 'traditional' women are spread within families and communities and

other 'institutions of belonging'. Even though democratic systems are the most conducive to all forms of expressions of identity, some womanhood ideals gain more visibility. But they lack followers and so don't impact policy. That is why it is even more important to identify the commonalities in women's dreams and goals in a fastchanging Indian context.

The most important aspect of this common cause search in policy must begin within the functionality of women. It must be the exercise of rights and responsibilities by women in urban, rural, or in between spaces, keeping the context within which they operate daily. This context is impacted by women's perceived sense of freedom, mobility, social support and utility. The first cause for policy advocacy is therefore access to public spaces. Women expect and need to feel safe and have zero restrictions on their mobility while out of the house whether it is to go to school, to till the land early in the morning at a farm or to sit behind a desk at a call centre at night...or to visit places of worship or entertainment, to run chores like buying household essentials at the *kirana* shop or to window shop at the mall. Whether it is mobility by train, or bus or their two-wheelers women should be able to go wherever at whatever time. This mobility is a function of perceived safety and freedom as well as safety from violence and freedom from judgement.

The take-home from Nirbhaya event in Delhi was that women had experienced the lack of safety in Delhi across classes — women labourers, college students, older women, little girls in swanky homes or slums - were unsafe and at risk of sexual violence. While the perpetrators of violence could be men of any class — poor immigrant workers riding a bus at night or sleek imported car-owning sons of rich elites. Rates of violence against women are increasing, underreported and prosecution of perpetrators remains unpredictable. The complexity here is again that of status. The affiliation of perpetrators and criminals to a higher class or political parties or power centres (police, advocates, judges) in criminal justice systems modifies the process of justice and slows their conviction. Breaking this nexus of privilege is essential to women's very existence. Women can impact their locational reality or everyday life if they become a force on the local structure, local process, and national policy.

### RIGHTS OF **INDIVIDUALS**

Everyone deserves a life of self-respect and dignity, says Rajyogi Brahmakumar Nikunj ji

A recent article in an international magazine said that India is on the verge of becoming a developed nation. This might sound positive as it appears that we are at par with other developed countries of the world. However, on the other hand, we wonder as to how should we react to the news about frequent crimes against women like rapes and dowry deaths? Do incidents like these match up with the pace at which we are developing? A recent incident - that made headlines across the country was about a 24year-old pregnant woman, whose husband burnt her when she objected to his extra-marital affair — has revived the issue of bride burning again and has led to indignation, protests and condemnation. But hardly do people realise that the roots of this problem lie in defective social and moral values which give faulty outlook and wrong attitudes to the people regarding the place of women in society and that unless right values are inculcated in the people leading to rectification in their outlook and attitudes, the problem is unlikely to be resolved for years to come.

Presently, we find that a strong conflict is rife between two different value systems. On the one hand, some people justify the existing set of values, justifying it in the name of tradition. These are the people do not care if a value has higher moral content and realistically a better potential for leading society to higher social good. They consider a value mainly in terms of its having been observed by a



religious or cultural community over a long period even though it might have led to inequality, injustice and cruelty of one group towards another.

This conflict in value systems can be better illustrat-

ed by citing how different stands were taken on the question of the place and role of women in society when the request for allowing women rickshaw drivers and taxi drivers were made to the authorities. A similar thing happened when the makers of a women-oriented movie requested a film certificate from the Film Board. A news report in this connection, says that the examining committee of the Board, the revising committee, and the appellate tribunal, one after the other, recommended that the film be refused a certificate because it glorified woman's (the heroine's) servility to man as a praiseworthy quality and thus had an objectionable impact on society. They thought that the woman in the film was projected as a good woman because she was prepared to do anything and even to swear to be a servant while her husband openly pursued another woman. The Censor Board thought that this was a wrong thing even though the film showed that, ultimately, the husband repented. When the matter was taken to Court, the judgement took a different stand, based on a different set ine of the film, follows the hallowed traditions of a particular society." Thus, he gave more weight to tradition. On the other hand, the tribunal had held that the film, "tries to promote ideas which are not in keeping with values of the present-day society." What was up for consideration was not whether it was promoting justice and social good but whether it was upholding tradition or modernity. This despite the fact that the incidents of dowry deaths, such as the one mentioned above, illustrate only too starkly the insults and tortures a woman has to suffer today. The consideration of this aspect was rejected in the name of tradition or stressed in the name of modernity. This conflict regarding values is a barrier in taking effective steps towards the solution of the problem. The real solution, therefore, lies in moral and social reform which cannot be accomplished in isolation. It can form only a part of a comprehensive scheme for the outlook and the belief that fundamentally, men and women are souls and, that, each has a role complementary to the others. The society must also realise that there is a moral law in the world, which none - however high and influential — can violate with impuni-

ty. A person, who can go to the extent of extracting dowry from his wife and can indulge in wife-beating or wife-burning, is a mere degenerate who, in his daily dealings, can throw all moral norms to the winds. The first thing, therefore, is to reform this potential criminal rather than give him a girl in marriage. So, let us all make a strong resolve to educate our girls and sensitise our boys to burn this evil system from its roots and make a society where each soul has a right to live with dignity and self-respect.

One can only imagine the plight of the rural communities here during the peak Covid-19 outbreak. "Along with basic facilities, the Valley should have a strong healthcare and road infrastructure. The Chenab Valley is known for its resourceful forest. Although the admin-

istration does not hesitate to use the resources of the forest, in return, even basic services are not provided to the people of the region," rued Ishtiyaque Dev, a veteran journalist from Doda.

Recently, it was announced that the road infrastructure in Jammu and Kashmir is all set to get a major boost as Union Minister of Roads Transport and Highways, Nitin Gadkari will lay the foundation stones of 25 National Highway projects worth ₹11,721 crore. But con-



necting highways is not going to help the problem of people residing in areas tucked away in difficult geographic locations. Their ordeals are real and require real, immediate solutions at the local level.

Somi Raj, a local social activist, stressed that the administration should accelerate the development work in the valley. 'Clean water, schools, employment and other fundamentals should be made available so that in the next few years there

would be no difference between other developed areas and Chenab valley," said Somi. According to him, schools and universities should be built within the region so that students do not have to migrate to Jammu, Srinagar or Delhi to pursue higher studies. The poor condition of schools is one of the topmost concerns for the locals. Nishat Qazi, a social worker from the region, said, "We had heard that the concerned authorities were going to take the required action to improve the condition of schools. For a brief time, locals had developed hope in their otherwise hopeless lives. But to our dismay, it never turned multiple requests have been odged with the administration but to no avail.

He also pointed out that although there are several power projects in the region, households still struggle to access electricity. As per a report published last year, several villages in the valley do not receive electricity at all, despite the fact that there are at least four power projects that have been commissioned while two more are under construction.

"Over the years, different administrations have served their tenure, but the people here never received access to basic facilities. The villagers are used as a mere vote bank. Once elections are over, they stop existing," said Meraj. In such a situation, these social advocates and workers wonder who is going to find solutions to the problems faced by the people of Chenab valley. Or if there is a solution at all.

More than 90 per cent children below 15 years of age are breathing toxic air and the figure goes to as high as 98 per cent in low and middle income countries as compared to

50 odd per cent in developed nations Citing the reason for children being disproportionately more susceptible to the effects of air pollution, he explained 'They breathe more rapidly as well as they also live closer to the ground, where some pollutants reach peak concentrations and absorb more pollutants"

## IYER, SAHA SET UP INTRIGUING FINAL DAY

ebutant Shreyas Iyer showed his ice-cool temperament under pressure to stand tall with a fine half-century which placed India in a commanding position as they set up a stiff victory target of 284 for New Zealand on the fourth day of the

opening Test here on Sunday.
India declared at 234 for 7 for an overall lead of 283 and gave the Black Caps four tricky overs to face under fading light during which they managed four runs and lost opener Will Young to Ravichandran Ashwin.

With that scalp, Ashwin became the joint third highest wicket-taker in Indian cricket with Harbhajan Singh (417 wickets).

The highest ever fourth innings chase by a visiting team in India is 276 by Viv Richards' West Indies against the Dilip Vengsarkar-led India in 1987 at the Feroz Shah Kotla, which placed

statistics on the home team's side. The honours for India on the day were shared by Iyer (65 off 125 balls), who became the first Indian to score a hundred and fifty on debut and the plucky Wriddhiman Saha (61 not out, 126 balls), who battled stiff neck to make an invaluable contribution which will certainly count a lot in the final context of the match.

Axar Patel (28 not out) then conjured another 67-run eighthwicket stand with Saha to slowly take the match out of the Black

Caps' grasp.

If New Zealand are still in the match, credit must go to their tireless seam bowling duo of Tim Southee (22-2-75-3) and Kyle Jamieson (17-6-40-3), who showed an exhibition of top class bowling on an unresponsive track.

However, it will now depend on how much time it takes for India's spin troika to roll over New Zealand, whose openers showed a lot of gumption on the second afternoon and third morn-

Also if skipper Williamson can do something mind-blowing with the willow, there might just be a great contest on the cards.
