# 20 die in TN rain fury

Normal life in Chennai hit, airport closed for 5 hours

Tamil Nadu has been witnessing incessant rain since Wednesday, leading to death of 20 people, with normal life in Chennai and suburbs coming to a standstill. However, the Government is yet to come out with any death figures. The Airport Authority of

India (AAI) suspended the arrivals at Chennai Airport from 1.15 pm to 6 pm. However, the service was resumed later in the day.

Several roads in Chennai were inundated on Thursday. The traffic police closed at least seven roads and 11 sub-

ways, and created diversions across the city for commuters. Due to waterlogging on rail tracks, some suburban trains were suspended while others were delayed.

The Regional Meteorological Centre has forecast that the metro and suburbs are likely to receive moderate to heavy rainfall during the next 24 hours and this is likely to aggravate the situation.

S Balachandran, head, RMC, told *The Pioneer* that Tamil Nadu received 54 per cent rainfall more than the normal level during the North East monsoon. "Chennai has fall than normal level," he said. In the next 24 hours, thun-derstorms with scattered heavy

to very heavy rainfall are expected in Chennai, Kancheepuram, Tiruvallur and Ranipet. Thunderstorm with heavy rain can be expected in heavy rain can be expected in Tirupattur, Vellore, Vellore, Villupuram and Chengalpattu. Strong winds of 40-45 kmph likely over Chennai and suburbs.

At the time of going to Press, there was an announcement from the RMC that the intensity of rain would come down by Friday morning.

Last two days of rain inunreceived 77 per cent more rain- dated 1.5 lakh acres of standing crops in Cauvery Delta districts, known as rice bowl of Tamil Nadu. Chief Minister M K Stalin has rushed a team of Ministers to Thanjavur to take stock of the situation.

Massive relief operations are underway in Chennai and suburbs to help the people got stranded in the floods. The storm water drainages that carry the excess water from the seven reservoirs that feed the metro have been chocked and this is being seen as the reason for water logging and flooding of the main thoroughfares and ring roads.

Pravin Pillai, a resident of Indira Nagar, a high end residential premises, said he has been held up in the house because of the flooded roads and could not move out anywhere for buying essential items.

"We did not expect this kind of rain though the weather bureau had forecast of heavy downpours," said Pillai.

The Chief Minister is taking stock of the situation on a round-the-clock basis and has deputed a team of ministers to lead and supervise the rescue lead and supervise the rescue and relief measures undertaken by the national disaster response force.

Governor RN Ravi, himself a former IPS officer, spoke to the NDRF and conveyed to the Centre about the kind of relief works underway in the flood affected areas.

Video images of a woman police inspector in the suburbs carrying a person on her shoulders to an autorickshaw went viral.

The inspector was seen carrying the 28 -year-old man on her shoulders to a waiting autorickshaw and asking the driver to take him to the nearest hospital caught the attention of the police chief who instantly complimented the officer.

# Punjab adopts resolution against move to extend BSF jurisdiction

#### **Terms it 'insult'** to Punjab Police

Punjab Vidhan Sabha on Thursday adopted a resolution against the Centre's notification extending the jurisdiction of the Border Security Force from 15 to 50 km along the Indo-Pak international border in the State, calling it an "insult" to the State police force and seeking its withdrawal.

The House urged the State Government to take up the matter with the Centre and get the notification withdrawn.

The resolution was unan-The resolution was unanimously passed by the House "rejecting" the Centre's order in the absence of the only two BJP MLAs — Arun Narang and Dinesh Babbu — who left the House just before the Deputy Chief Minister-cum-Home Minister Subhinder Singh Minister Sukhjinder Singh Randhawa was to move the resolution.

Notably, the Central Government had the previous month amended the BSF Act to authorise the border guarding force to undertake search, seizure, and arrest within a 50 km stretch, up from the exist ing 15 km, from the international border in Punjab, West Bengal and Assam.

ir quality deteriorated from Athe higher end of the very poor to severe category on Thursday According to the System of Air Quality and Weather

Forecasting and Research (SAFAR), the overall air quality index (AQI) settled at 411 micrograms per cubic.

Delhi will not get any

respite from pollution as pollution monitoring agency, SAFAR, a unit of Ministry of Earth Sciences (MoES), said that air quality is likely to deteriorate further and it may touch the higher end of severe category. Though the reason for the high concentration of pol-lutants in the city's air is slow dispersion of particles due to meteorological factors, stubble burning impact is also significant.

"It is likely to be in the upper end of very poor' to 'severe' category for the next two days. The effective fire count was reduced to 3914 today. Today's share of crop residue burning is about 26 per cent in PM2.5," SAFAR said.

According to MeT, at 12.6 degree Celsius, Thursday morning was the coldest of the season with the mercury falling below 13 degrees for the first time. Values of Suspended Particulate Matters (SPMs) on the National Ambient Air Quality Index (NAAQI) also recorded many folds higher than prescribed standards of WHO and IMD.

## India, Russia to discuss Af To review strategic,

# **Defence relations**

India and Russia will review the entire gamut of strategic and Defence ties here next month during the summit between President Vladimir Putin and Prime Minister Narendra Modi. Afghanistan is also likely to figure prominently during the talks as both the

countries are major stakeholders there. The summit is held every year and Putin had visited India last time in 2018 and Modi went there the next year. This highest level exchange is a testimony to the time-tested ties between the two countries for more than five decades, sources said here on Thursday. The summit could not be held last year due to the ongoing corona pandemic. At

least 20 summits have taken place so far. On the forthcoming visit, likely on December 6, the sources said Putin is likely to arrive here for a day-long visit

on December 6 or 7 and hold bilateral talks with Modi. Besides exploring ways to further strengthen Defence and strategic ties, Afghanistan is also likely to be accorded priority during the summit, they said.

India participated in the Moscow format of talks on Afghanistan in September and Russian National Security Adviser took part in a conclave here on Wednesday hosted by Indian

National Security Adviser Ajit Doval. Given this situation, Putin and Modi are likely to hold extensive talks on the Afghanistan issue and role of Pakistan. The Delhi Declaration on Wednesday appealed that the Afghan territory should not be used for spreading international terrorism and

radicalisation. The two leaders will also review the ongoing fight against corona pandemic. Russia's Sputnik V vaccine is being produced in India, and during the second wave, Moscow had sent humanitarian support to New Delhi.

## AAP lodges complaint against actress for seditious remark

 $M_{\text{actress Kangana Ranaut's}}^{\text{iffed with Bollywood}}$ statement that India got true Independence freedom 2014 and that the freedom that the country got in 1947 was "bheekh" (alms), the Aam Aadmi Party (AAP) on Thursday lodged a complaint with the Mumbai police seek-ing registration of an FIR for sedition and other offences.

Hours after BJP leader Varun Gandhi slammed the actress that Kangana had "insulted" the memory of India's freedom fighter, AAP's national executive member Preeti Sharma Menon lodged a complaint with the police against Kangana for her allegedly seditious comments. "Submitted an application to @MumbaiPolice requesting action on Kangana Ranaut for her seditious and inflammatory statements on @TimesNow,

tweeted.

Simultaneously, requested Maharashtra Chief Minister Uddhav Thackeray to intervene and take up the matter with the Centre for withdrawal of "Padma Shri" awarded to Kangana in view of her "seditious" public comments made in an interview at the "Times Now Summit-2021" "Celebrating India@75, shaping India@100", which was telecast from 7 pm to 9 pm on

Preeti quoted Kangana as having claimed during the "Times Now" interview that India did not achieve Independence in 1947, that what India got in 1947 was "bheekh" ( woh Azaadi nahi thi, woh bheekh thi) and that the real Independence was

achieved in 2014 ( when Narendra Modi became the Prime Minister).

This abdominable statement not only discredits the Indian freedom struggle & its revered leaders but it is also extremely inflammatory in its nature, and tantamount to treason. It is more infuriating that such a seditious claim was made on national television, by a recipient of one of the highest civilian awards—the Padma

"It is unquestionable that Kangana Ranaut has hurt the sentiments of countless Indians, by demeaning the millions of lives laid down for our nation to attain freedom, and that her claim subverts the spirit which the prestigious Padma Shri embodies," she

"As a citizen of this state, I request you to please apply to the Central government to recall the Padma Shri bestowed upon Kangana Ranaut in the light of a seditious statement made by her on national television," the AAP leader added

In her complaint lodged with the police, Preeti has rooted for booking Kangana for alleged offences under sections 504 (Intentional Insult with intent to provoke breach of peace), 505 (statements conducing to public mischief) and 124A (Sedition) of Indian Penal Code.

Earlier in the day, BJP leader Varun Gandhi came down heavily on Kangana through a tweet that he put out in Hindi: "Insulting the sacrifice of Mahatma Gandhi sometimes, praising his killer sometimes, and now the disdain for the sacrifices of Mangal Pandey, Rani Laxmibai, Bhagat Singh, Chandrashekhar Azad, Netaji Subhash Chandra Bose and lakhs of freedom fighters. Should I call this thinking madness or treason?".

The ED investigated money trails for ascertaining and identifying the Proceeds of Crime (POC) and accordingly "Empress Mall at Nagpur" was provisionally attached under the provisions of PMLA which was subsequently confirmed by the Adjudicating

A prosecution complaint (chargesheet) under Prevention of Money Laundering Act has been filed before the Special Court, PMLA, Mumbai and the court has already taken cognizance of the money laundering offence on January 22, 2021.

As a result, in addition to a decrease in first-dose coverage of measles vaccine from 86% in 2019 to 84% in 2020, only 70% of children globally received their second measles vaccine dose last year, according to the new MMWR report - far below the 95% coverage needed to protect the population.

Researchers also reported a deterioration in measles surveillance, as WHO's global network of measles and rubella laboratories received the lowest number of specimens for measles testing since 2010, despite large measles outbreaks occurring in

"Large numbers of unvaccinated children, outbreaks of measles, and disease detection and diagnostics diverted to support Covid-19 responses are factors that increase the likelihood of measles-related deaths and serious complications in children," CDC Global Immunization Director Kevin Cain, MD, said in the statement. "We must act now to strengthen disease surveillance systems and close immunity gaps, before travel and trade return to prepandemic levels to prevent deadly measles outbreaks and mitigate the risk of other vaccine-preventable diseases."

According to the MMWR report, from 2000 to 2010, coverage of first doses of measles-containing vaccine increased globally from 72 per cent to 84 per cent and peaked in 2019 at 86

Annual rates of measles cases decreased 88 per cent from 2000 to 2016, from 145 cases per 1 million population to just 18. The rate rebounded in 2019 to 120 but then dropped again

Annual measles deaths decreased by 94 per cent from 2000 to 2020, from 1,072,800 to 60,700, with an estimated 31.7 million measles deaths averted, the researchers said.

On her part, Amruta - in her notice served on Malik referred to various "defamatory" tweet and photographs put out by the latter linking her to an alleged drug peddler Jaideep Rana, who purportedly financed the video song titled "River March" rendered by the former Chief Minister's wife Amruta with Sonu Nigam.

"Rana was hired by the creative team of 'River March' that Mr Rana was hired by them and our client or her family had no association with him. This fact has already been clarified by 'River March' that Mr Rana head. During the event photographs with the entire team and others who were present were taken. Our client states that her husband, being the then chief minister of the state, had participated in the event to promote the campaign which was of social importance," lawyer Hitesh Jain stated in his notice sent to Malik on behalf of Amruta Fadnavis.

Among other things, Amruta asked Malik to delete the defamatory tweets within

48 hours of the receipt of the notice and tender unconditional apology by addressing a news conference, failing which she would initiate legal proceedings against the Maharashtra Minister under section 499 and 500 for defamation. In the notice issued on

behalf of Malik's son-in-law Sameer Khan, his lawyer R I Ansari referred to a statements made by Fadnavis telecast on ABP News: "Aata Nawab Malik anche Jaavayi hey drugs sakat sapaadle aahe" ( Now Nawab Malik's son-in-law was found with drugs in his possession" and "Jayncha Gharish drugs saapadtat tyanchi party kay honar aahe" ( In whose house drugs were found what will will happen to his party). Sameer Khan stated that

the allegations made by Fadnavis were "baseless and without any merits". "The chargesheet filed by the (NCB) does not support even a single allegation levied by you. The Panchanama dated 14/01/2021 (filed by the NCB) clearly says that the house was searched and no contraband or suspicious substance was found in my client's house or under his possession. But which source you obtained such a false, frivolous and baseless report is better known to you," Ansari told Fadnavis on behalf of his client Sameer Khan in the

Meanwhile, amid reports that the ED has raided seven places in Pune and one place in Aurangabad in connection with the Pune Waqf Board land scam, Malik said that he as the Minority affairs minister welcomed the ED's action, as his ministry --under which the Waqf Board falls -- has already initiated "clean-up' measures.

Talking to media persons, Malilk said: "Media reports are claiming that Nawab Malik is in trouble as ED has taken up some cases pertaining to his ministry. As per the SAFAR's index, Particulate Matters (PMs) 10 and 2.5 were recorded at 387 and 237 micrograms per cubic.

In the short range air pollution forecast, values of both particles are expected to be 445 and 272 for Friday and 368 and 225 for Saturday!

An AQI between 201 and 300 is categorised as "poor", between 301 and 400 "very poor" and over 400 is "severe". At 8 am, at least 21 air quality monitoring stations were in the severe range, with Anand Vihar the worst (453).

Ghufran Beig, founder and project director at SAFAR, said local wind speed, which was hovering between 8-10 km/hr, was also expected to drop. "A combination of strong transport-level winds, along with calm wind speed over Delhi is likely to see 'severe' air again. If the farm fires remain the same, the share of stubble burning will start increasing again from Thursday as winds from Puniab and Haryana will pick up. Meanwhile, Delhi will see calm wind conditions and this can trap these pollutants locally," he said.

Environment Minister Gopal Rai also conducted a surprise visit at the Ghazipur landfill in East Delhi and directed the MCD to present an action plan for a foolproof fire control mechanism to avoid future instances of week-long

"The current progress of landfill disposal, is very poor and impractical and the East MCD is severely lacking in its work," Rai said.

"Given the current levels of

continuous instances of stubble burning from all around contributing to it, the 'Anti Burning Campaign' has been started Campaign' has been started today. The main goal of this is to help cut down on any source of pollution from within the city where open burning of waste, landfills, and the like is taking place. This campaign will run for a month till December 11. Around 10 dif-December 11. Around 10 different departments with a team of 550 people have been given the responsibility to see this campaign through," Rai said.

In response to enquiries about the disposal of the Ghazipur landfill, Rai said, "The MCD engineers and DPCC scientists have recently presented a report that despite orders by the National Green

Tribunal regarding the disposal of the landfill, only 5.5 per cent of the area has been cleared over a span of 2.5 years. At this rate, the disposal of the entire landfill looks al of the entire landfill looks tough in my opinion, which they have predicted will take a long cumbersome 13 years, which is completely impractical and unjustified. So the current progress is definitely poor. To accelerate it the MCD needs to come up with a solid action. to come up with a solid action plan. We will also hold a meeting concerning this matter to figure out why the disposal is getting stalled so much."

He concluded saying he would remind the Centre and State Governments to hold an emergency meeting at the earliest. "Don't know why they are avoiding it", he said.

An AQI between zero and 50 is considered 'good', 51 and 100 'satisfactory', 101 and 200 'moderate', 201 and 300 'poor', 301 and 400 'very poor', and 401 and 500 'severe'. The IMD has forecast a

clear sky with mist or shallow fog in the city in the coming days. Officials said the minimum and maximum temperatures are likely to fall further in the next few days.

## Rajesh Bawana gang shooter held after shootout

After a brief exchange of fire, the Delhi Police nabbed a sharp shooter of the Rajesh Bawana gang and two of his associates in outer Delhi's Bawana on Thursday morning.

The alleged sharpshooter has been identified as Manbir alias Rancho (24), a resident of Pooth Khurd Village and he was also declared a 'Bad Character' by the Bawana police station. Police said that ĥe sustained a bullet injury in his right leg in the encounter and was admitted to a hospital

In retaliation, our police team also opened fire and after a brief encounter, apprehended all three of them. A bullet hit Manbir on his right leg near the knee area and he was rushed to a hospital," said the DCP.

## **NATIONAL ACHIEVEMENT SURVEY** Sisodia urges Edu Min Pradhan to postpone it

Delhi Deputy Chief Minister Manish Sisodia has written to Union Education Minister Dharmendra Pradhan, urging him to postpone the National Achievement Survey (NAS) scheduled on Friday in schools across the country to assess learning levels. Sisodia, who is also Delhi's Education Minister, said the data collected in the survey will not be "reliable" as schools have not completely opened after a prolonged closure due to Covid-19, and the exercise will be a "wastage" of time and money.

"Students have gradually started coming to schools after one and a half year. I believe at this time we should focus on social, mental and emotional well being of students.

A big number of students have not returned to schools, there should be an effort to bring them back rather than formulating a policy on basis of a survey done when schools are half open," Sisodia said in the letter. "I humbly request you that the survey should be stopped for now and conducted later at a time when situation turns normal. The purpose of the survey will be served then only and data will be reliable. To conduct the survey at this time will be wastage of time and money and if a policy is formulated on basis of this survey, the results can be fatal,"



## Rajasthan CM meets Sonia amid Cabinet expansion buzz

PNS NEW DELHI

Rajasthan Chief Minister Ashok Gehlot on Thursday met Congress president Sonia Gandhi after Rahul Gandhi and Priyanka are said to have asked him to expand his Cabinet in the next few days to end a long-standing feud with rival Sachin Pilot by accommodating his loyalists. The push also comes as the Congress has somewhat sorted out the Punjab muddle.

AICC sources said Priyanka Gandhi had reportedly urged Gehlot to accommodate Sachin Pilot's supporters in his Ministry.

Sources confirmed Gehlot's meeting with Sonia Gandhi was on "expanding the Rajasthan Cabinet and appointing chairmen of state corporations".

The party high command will decide on the Cabinet reshuffle in Rajasthan. Ajay Maken has all the information on it. We want good governance to continue in the State," Gehlot told reporters after the meeting.

Sources said the Congress leadership wants the reshuffle to take place immediately, in keeping with a major promise to Pilot when he agreed to drop his rebellion more than a year

Besides Priyanka Gandhi, other Congress leaders like KC Venugopal and Rajasthan



in-charge Ajay Maken were present at a meeting at Rahul Gandhi's home in Delhi where Gehlot was reminded about the long-delayed cabinet changes. Rahul Gandhi was not in the meeting however, sources said.

Last year, Pilot camped in Delhi with 18 MLAs for weeks as he felt short-changed and sidelined by Gehlot in the Rajasthan Congress. Three MLA's had broken from Sachin to avert a repeat of the Madhya Pradesh situation when Jyotiraditya Scindia joined the BJP and made the Congress government lose its majority. These MLA's are also expected to be compensated with a ministerial berth

and other posts.
In 2018, when the Congress won the Rajasthan election, Pilot was credited with the party's win but had to settle for the post of Gehlot's deputy leading to a revolt within two factions of party.

In September this Pilot met Rahul Gandhi and Priyanka Gandhi on several occasions. Sources in party said the party high command Gandhis want Pilot to take charge of Gujarat ahead of elections in the State next

## India slams Pak for declining Af conclave invite



India on Thursday slammed Pakistan for playing spoilsport by refusing to attend a conclave here on Wednesday to discuss the situation in Afghanistan.

The conclave of the National Security Advisors (NSA) issued a Delhi Declaration urging that Afghan soil should not be used for spreading international terrorism and radicalisation. Eight countries, including India, took part in the meet. The other countries were Russia, Iran and five Central Asian countries which share the border with Afghanistan.

India had invited Pakistan also but it declined to come on the pretext that New Delhi had not invited the Taliban. Iran had held such conclave in 2018 and 2019 but Pakistan did not attend. China, which attended the two earlier events, did not participate in Delhi conclave claiming "scheduling issues." It, is however, taking part in a parallel conclave on Afghanistan on Thursday in Islamabad besides the US and Russia.

As regards Pakistan's nonparticipation here, ministry of external affairs spokesperson Arindam Bagchi highlighted that India has been extending support to Afghanistan for

many years but the situation on the ground has become "very difficult" over the last few

He criticised Pakistan's decision to not attend Delhi Regional Security Dialogue on Afghanistan, saying it shows Islamabad's attitude regarding the crisis in the war-torn coun-

In an apparent reference to Pakistan, he said there have been difficulties in providing humanitarian assistance to Afghanistan due to a lack of unimpeded access.

He highlighted that India has been extending support to Afghanistan for many years but the situation on the ground has become "very difficult" over the last few months. Pakistan has ,so far, denied India to send food to Afghan through road from Attari.

"One of the key elements which we've seen in previous meetings was the need for unimpeded, unhindered access for humanitarian assistance providers...There have been difficulties due to lack of unimpeded access," Bagchi added.

He said that the "very serious humanitarian situation" in Afghanistan was discussed at length during the meeting of NSAs of eight regional countries, including India, Russia,

The Association for Democratic Reforms (ADR) in its latest report said that an analysis of their Income Tax Returns and donations statements filed with the Election Commission of India (ECI) shows that the sources remain largely unknown. At present, political parties are not required to reveal the name of individuals or organisations giving less than ₹20,000. As a result, a substantial amount of funds cannot be traced and are from 'unknown' sources," it

The ADR said that the

contribution reports of the AAP, IUML and the LJP are available \on the website, but the parties' donations data shows discrepancies as declared in their annual audit report and contribution report (donations above Rs 20,000) for FY 2019-20."During FY 2019-20, total income of regional parties from unknown sources amounted to Rs 445.774 crore and constituted 55.50 per cent of their total income as declared in their audit reports," it added.

Some of the top regional parties to declare highest unknown income include the TRS (Rs 89.158 crore), TDP (Rs 81.694 crore), YSR-C (Rs 74.75 crore), BJD (Rs 50.586 crore) and the DMK (Rs 45.50 crore). The ADR said the total income of political parties from known donors (details of donors as available from contribution report submitted by parties to the Election Commission) is Rs 184.623 crore, which is 22.98 per cent of the total income of these parties.

## SC agrees to hear plea by journalist seeking quashing of UAPA charges



The Supreme Court on Thursday agreed to hear a plea of two advocates and a journalist seeking quashing of a criminal case lodged under the harsh UAPA provisions against them for allegedly bringing facts through social media posts about the "targeted violence" against the minority community in Tripura.

A bench comprising Chief Justice N V Ramana and Tustices A S Bopanna and Hima Kohli was informed by advocate Prashant Bhushan that the two lawyers and the scribe who had gone there on a fact finding mission have been proceeded against by the Tripura police under the UAPA for their social media posts and an FIR has been lodged and a notice under the CrPC has

been issued to them.

"Why did not go to the High Court? You go before the High Court," the bench observed initially and later agreed to consider listing the plea after the lawyer said that besides seeking relief of quashing of the FIR, the plea also challenged the constitutional validity of some UAPA provi-"Please list it as these sions. people are imminently under threat," Bhushan said.

"Circulate the bundle. I will give a date (for hearing)," the CII said.

Advocates, Mukesh and Ansarul Haq, and journalist Shyam Meera Singh have been accused in the FIR lodged at the West Agartala Police Station under the IPC and the UAPA provisions for allegedly disseminating information about communal violence in the State.

#### **Jafri doubts** credibility of SIT

Zakia Jafri, widow of slain Congress MP Ehsan Jafri, told the Supreme Court on Thursday that the Special Investigation Team (SIT) which gave a clean chit to then Gujarat Chief Minister Narendra Modi in the 2002 communal riots should itself be investigated for rendering conclusions contrary to facts. Senior lawyer Kapil Sibal, representing Jafri, alleged that the SIT did not do 'investigation' but did a 'collaborative exercise' and its probe was fraught with omissions to protect conspirators. "The SIT was rendering

conclusions contrary to facts they were aware of. In fact, SIT should be investigated. It is true...I am not concerned with individuals. I am concerned with the process. I am only saying SIT địd not do its job. Ít was an act of protection. It did a collaborative exercise," said Sibal. He said that there was evidence in the form of electronic records including call data records of senior police officials and mobs identifying houses of Muslims, all of which pointed towards conspiracy.
But the SIT ignored all of it

and did not conduct any further investigation into the and the Magistrate and High Court too chose to overlook the same, he contended.

# **Kids' death in Gorakhpur: Suspended Dr Khan sacked**

Paediatrician Kafeel Khan of Gorakhpur's BRD Medical College and Hospital, who had been suspended in 2017 after the death of 70 children due to oxygen shortage, has been dismissed. a Government official said here on Thursday

Dr Khan has been sacked after being found guilty in the probe into the circumstances leading to the death of children in the hospital, UP Principal Secretary (Medical Education) Alok Kumar

As the matter is sub judice, the detailed information about Dr Khan's dismissal will be given to the court, Kumar added.

Dr Khan had been attached to the office of Director General Medical Education (DGME) after his suspension on August 22, 2017, in the wake of the children's death during the month.

Reacting to the report of Dr Khan's dismissal, Congress general secretary Priyanka Gandhi Vadhra termed his dismissal as malice-driven and aimed at harassing him.

Expressing surprise over the reports of his dismissal, Dr Khan,

been terminated despite the court giving him a clean chit earlier. "Principal Secretary Alok

Kumar had on Wednesday released a statement about my termination from the BRD Medical college," he said, adding he, however, has not received any termination letter as yet.

"They have no authority to terminate me. They should have taken orders from Uttar Pradesh Public Service Commission (UPPSC) (to suspend me)," he asserted in a statement on the reports of his termination.

"Among the eight people suspended in the lack of oxygen case in the hospital, the suspension of seven others except mine had been revoked. The court had punished all of them in one or the other manner but the honourable court had given me a clean chit on charges of medical negligence and corruption," Dr Khan claimed.

"I was suspended on August 22, 2017 in the case and on March 5, 2019, the Allahabad High court had asked the UP Government to end the inquiry and on April 18, 2019, the high court had given me

"When I was in jail, the UP government again set up an inquiry against me on February 24, 2020, and on August 6, 2021, the state government declared in front of the court that they are withdrawing the inquiry order of the then Chief Secretary Himanshu Kumar," Dr Khan said.

He also explained that even on Wednesday, the government had not told the court about his termination. "On November 10, 2021, there

was a date in the court but the government did not submit any papers regarding termination. The next court date is on December 7, 2021. I have no hope of justice from this government," Dr Khan added.

After Kafeel's dismissal, Congress general secretary Priyanka Gandhi in a tweet in Hindi said "Dr Khan's dismissal is driven by malice. Motivated by a hate agenda, the government is doing all this to harass him."
"But the Government should

keep in mind that it is not above the Constitution. The Congress party is with Dr Khan in his fight for justice," she said.

## Agartala municipal polls: TMC trying to woo SC/STs of Tripura

SAUGAR SENGUPTA KOLKATA

A part from targeting the Bengali voters the Trinamool Congress is also trying to win over the SC and STs of Tripura in the coming Agartala municipal elections and the State polls sources said adding the party has specific plans for the three different segments of the voters.

"The BJP has done nothing save spreading mutual hatred among communities ... they have attacked the opposition ... misled the youth and in the name of nationalism they have created communal disturbance ... the people of this State particularly those from Agartala have understood their policy and so they are gradually tilting towards Mamata Banerjee and the TMC," said party leader Rajib

Welcoming an Apex Court order directing the Tripura Government and the State Director General of Police to allow peaceful campaigning in the elections another TMC leader Shantanu Sen said "the order belongs to the people of Tripura who have been languishing under the BJP rule ... there is no democratic right in the State ... But if the people give us a chance then Tripura will see the same surge in their socio-economic life that have come in Bengal under the Mamata Banerjee regime."

Ruling that every party has a right to peacefully campaign in the elections the Court has asked the State Government to ensure security of the contestants directing the Director General of Police and the Home PTI | Secretary to file a compliance report.

Rajib Banerjee said "in Tripura the Government is indifferent, the police a silent spectator and the democracy is under threat ... only the court can save democracy here."

The order comes as a shot in the arm of the TMC which had been facing similar charges in Bengal leveled by the BJP.

On the TMC's chances of winning the elections the party leaders said "Mamata Banerjee has shown in Bengal that she is a fighter who pushed out the powerful Left Front through years of struggle ... she will do it in Tripura too and the people of this State know it well.

Earlier party Raja Sabha MP Sushmita Dev said that her party was targeting all section of the society "even the SC/ST voters are our voters..." She said "20 out of 60 seats are reserved for SC/ST and those voters are equally important. Biplab Deb Government has done nothing for Tripura ... they have only exploited the people and tortured the opposition ... the people are determined to throw them out ... and as the Left and the Congress are in a bad shape the people have decided to give Trinamool Congress a chance."

Reacting to the statements coming from the TMC's side senior Tripura BJP leader Nabyendu Bhattacharya said that "the TMC has been complaining of violence which is peculiar to their own regime in Bengal ... in Tripura they have no cadre which is why they are trying to get publicity through the media ... but they will not be successful in this dirty game ... The BJP welcomes them to fight democratically in this State."

## Mizoram plans to inoculate Myanmar refugees against Covid

Aizawl: The Mizoram Government is planning to administer Covid-19 vaccine to Myanmar nationals who have taken refuge in the State following a military coup in the neighbouring country in February, a health department official said on Thursday

Altogether 12,736 people of Myanmar are currently staying in various parts of Mizoram, particularly in districts bordering that country, according to the State police's record. The official said the authorities of those districts are gear-

ing up to vaccinate all the eligible refugees. East Mizoram's Champhai district has the highest number of Myanmar nationals at 7,291, followed by the southernmost Lawngtlai district at 1,746 and State capital Aizawl at 1,622. A large section of those who have taken refuge in the state belong to the Chin, also known as the Zo, community. They share the same ancestry and culture as the Mizos of Mizoram. They were mainly the residents of Chin, a State in Myanmar, which shares its Western border with

The majority of the Myanmar nationals are lodged in relief camps set up by villagers, while others live with their relatives in the state and some others in rented houses, police said. They are provided with food, utensils, blankets and other essential items by local people, NGOs and churches, officials said. Earlier, Mizoram Chief Minister Zoramthanga had written to Prime Minister Narendra Modi urging him to provide asylum to the Myanmar nationals on humanitarian grounds. The state government had also sent delegations to Delhi seeking assistance for those people.

However, the Centre is yet to give a response. India is not a signatory to the UN Convention on refugees.

## Akhilesh takes dig at Yogi on Kairana

**Muzaffarnagar (UP):** The people of Uttar Pradesh would have faced no problem, had Yogi Adityanath not migrated here from Uttarakhand, Samajwadi Party president Akhilesh Yadav said on Thursday.

Yadav took the dig at the Uttar Pradesh Chief Minister days after he promised compensation for the families of industrial town Kairana in adjoining Shamli district, who had migrated from here under the extortion threat.

Referring to Yogi's visit to Kairana, Yadav said, "He came and recalled exodus, the reality is that if there had not been the exodus of the CM from Uttarakhand, our five years would not have been wasted.'

Adityanath was born as Ajay Mohan Bisht in Panchur village of Pauri Garhwal in June 1972

before the formation of Uttarakhand out of Uttar Pradesh.

Addressing a public meeting in Kairana on Monday, Yogi had slammed the "Taliban mentality", saying it will not be accepted in the state. Referring to the 2013 communal riots in Muzaffarnagar, Adityanath had said the opposition did not act when houses of Hindus were being burnt and innocent youths killed in

The alleged exodus from Kairana was a key poll issue before the 2017 assembly elections as the BJP had claimed then that scores of Hindu families had left the town after receiving threats from criminals. The claim, however, was contested by

Addressing the 'Kashyap



mahasammelan' in Budhana area here, Akhilesh Yadav said the "Baba CM" does not understand anything and makes tall claims on law and order.

"Can anyone tell if police are indulging in murders anywhere in the country? I can give many examples of innocents being killed in UP," he said, recalling the Gorakhpur murder of a Kanpur trader and Kasganj custodial death of a youth and held BJP responsible for the same.

# **Growing role**

India calls for cooperation among regional countries to deal with the Afghan challenges

rom a small player, India becomes a mainstream one on Afghanistan affairs by hosting a meeting of Russia, Iran and CIS countries on the question of humanitarian aid and return of peace to that country. The Central Asian countries that attended the meeting included Kazakhstan, Kyrgyzstan, Tajikistan, Turkmenistan, and Uzbekistan. It was a meeting of National Security Advisors, but it is a mainstream initiative nevertheless in taking forward the resolution of the UN and other bodies about stability in Afghanistan since the Taliban forced themselves to power in August. The Delhi Declaration reiterated that Afghan territory should not be used for terrorist acts, sought an inclusive Government with representation from the "major ethno-political forces", unimpeded humanitarian assistance and cooperation against radicalisation, extremism and drug trafficking. The Declaration underscored the importance of peace in the country as it has impor-



tant security implications for the people of Afghanistan as well as their neighbours. The regional security dialoque is the third after Iran hosted the first two in 2018 and 2019. Through the Declaration, India called for closer consultations, greater cooperation and coordination among the regional countries to deal with the challenges Afghanistan poses.

That is the key takeaway from New Delhi: cooperation and coordination between regional countries. India hit the nail on the head by raising the issue. It is the lack of cooperation that has wasted all wellmeaning measures of the neighbours to date. The

regional powers have so far only been busy talking about themselves. Iran hosted a meeting of neighbours of Afghanistan but did not invite India. Russia, too, did not invite India to the extended Troika meeting involving China, Pakistan and the US in August. The snub was explained as the result of the divergence of views of Russia and India over Afghanistan with India against establishing any Government in Kabul by force and Russia insisting that the Taliban can counter the Islamic State better. India subsequently made it to the Moscow Format meeting hosted by Russia. Then came the New Delhisponsored event. It is to be followed by Pakistan, which declined India's invite to attend the NSA meeting, hosting yet another extended Troika meeting. China, which skipped the New Delhi meet, is attending. The outcome of all these meetings, there may be more to come in the future, is nearly the same. However, there is no evidence of any change in the attitude of the Taliban. They have not responded to any of the declarations about their Government. They have not made any commitment to severing ties with terror groups based in Afghanistan. The only issue they have responded to is about receiving humanitarian aid. New Delhi's emphasis on regional cooperation is a caution to countries that are putting themselves before others.

## Vaccine diplomacy

As international borders reopen to globetrotters, travel and economy look to take a flight, too

t comes as India's major diplomatic win as 96 countries have recognised the two Indian-manufactured COVID-19 vaccines — Bharat Biotech's Covaxin and AstraZeneca's Covishield. The WHO has so far included eight vaccines in the Emergency Use Listing (EUL) and two out of these happen to be Indian vaccines. This also assumes significance as the UK had earlier raised flags about the veracity of the CoWIN (Gol's web portal for COVID-19 vaccination registration) data and the vaccine certificates issued by it, though it was quick to reverse the decision after the 'vaccine certificate row' between the two countries. Under this certificate pact, these countries — including the UK, the US, Australia and many European and Middle



one step at a time and remain watchful.

East nations — have agreed to mutual recognition of vaccine certificates of travellers fully vaccinated with WHO approved vaccines. The list includes most of the important countries that trade with India. China and Pakistan, however, did not make it and that barely comes as a surprise. The Government continues to be in communication with the rest of the world so that beneficiaries of the world's largest COVID vaccination program are accepted and recognised, thereby easing travel for education, business and tourism purposes.

The relaxation certainly comes as hope for international travellers to and from India. Those who have been eagerly waiting for an international trip to one of these countries can let loose their wanderlust. However, the bigger picture is much more promising. The relaxation is expected to revive the saddened travel sector which eventually can boost the economy. As per the 'Migration and Development Brief' released by the World Bank, India was the largest recipient of remittances in 2020 with over \$83 billion. The World Bank, however, projects that remittances to India are likely to drop by 23 per cent to \$64 billion this year due to the impact of the pandemic. As more countries across the world recognise vaccines and open their borders to foreing travellers, workers and students, the decline might gradually reverse. However, at the same time, the citizens also must not forget that

t has been five long years since Prime Minister Narendra Modi announced on November 8, 2016, that the 500 and 1000 notes would not be legal tender from midnight. The brief telecast made a paradigm shift in the life of every Indian. Chaos and confusion followed the announcement. Long serpentine queues were seen outside of banks to change the notes. It was the moment of truth for India. More than 70 people lost their lives to exchange their notes.

We were told it was an attempt to dig out the black money from the system and stop terror funding. The other benefits enumerated included weeding out counterfeits and digitising the economy. Five years have gone by. Let's assess if the cherished goals have been achieved, as the Government is reluctant to do so. Was it at all a masterstroke? Was it a surgical strike on the black money or a strike on the Indian economy?

Demonetisation did away almost 95 per cent of the currency on a four-hour notice. It was chaotic with the Government changing the goal post every second day.

After some time Prime Minister Modi declared that he was no economist and that he had never claimed to be one but his intentions were good. In the same fashion, I can say that I don't hold a degree in economics but my intentions of revisiting the demonetisation are good. I approach demonetisation as a commoner. I saw and endured the months of upheaval that followed demonetisation.

I as any other countryman can vouch for one fact that black money or the unaccounted money is still there in the system. During the exchange period, some people made a killing by facilitating the exchange. For a fraction of the cost, the black became the new white. Innovative ideas to exchange the old notes were flying all over. You could do it by buying gold, booking railway tickets, buying petrol and so on. But common men saw their marriages broken, Indian elections cash rules. It jobs lost, cottage business shut stripped the Opposition par-

and their kin unable to get treatment in hospitals.

Next on the list was terrorism — the lesser said the better. Security experts would be better placed to tell if demonetisation led to any let-up in terrorism. 

## **DELHI HAS TO REACH OUT TO CENTRAL ASIA**

The Quad countries have a keen interest in ensuring a secure and safe Central Asia

ational security advisors of seven countries attended a high-level regional security dialogue this week on Afghanistan, hosted for the first time by India. This marks a significant step by India to place itself in the heart of influence in the theater of Afghanistan.

Pakistan, an invited party, along expected lines, chose to stay away from the meeting given its political and military differences with India, and its claim to right of ownership over Afghanistan's internal politics and governance. China, another key player was also invited, but chose to keep its partner-country Pakistan happy and stayed away.

The signal emerging is, China would like to increase its economic and technology presence in Afghanistan with Pakistan laying the groundwork and would try all it can to neutralize India's sphere of influence.

India has decades of diplomatic, economic, cultural assets in Afghanistan and has a significant concern with the evolving situation in the country, which is already starting to make its presence felt through heightened terror attacks and attempts. India has so far not provided official recognition to the new Taliban regime and has been demanding a united international approach on Afghanistan.



Historically, Russia has been a key player in this region, as many of the countries were part of erstwhile Soviet Union. However, in the wake of an expansive China its share has diminished. China, now is the dominant trade partner with Central Asia, while Russia is a distant second. India and the United States, despite being influential and large, have almost no trade relationship. This makes the situation complex as many of the countries in Central Asia are in a huge debt-trap with China.

This creates a situation for these relatively smaller countries to align without any influence on consensual international voices of peace and stability in Afghanistan. While these countries are aware security threats due to the Afghan chaos, they are also sensitive to the huge dominance of China finance in their key infrastructure projects

India did well to take the lead and host the regional security dialogue in New Delhi, at a time when some of these central Asian countries, as well as Iran and Russia are looking for fresh perspective, away from China influence.

India has to approach Afghanistan through this regional multilateral platform with a certain amount of diplomatic maturity as it tries to expand its scope of influence in the region. India needs to take this regional dialogue wider and louder by involving the European Union and US towards peace and stability in the region. Europe, which has so far relied on NATO alliances and therefore, the US, for monitoring Central Asia, is now waking up to the new realities after Washington exited Kabul.

The US has significant security and strategic interests to remain invested in the region, even though it does not want to be at the fore front anymore. This means China will have an opportunity to run its military and strategic objectives from Afghanistan and other parts of central Asia unchallenged while Indian security interests will be threatened. At some point of time, Pakistan would also like to use its influence over China to create security threats for India using Afghan non-state actors.

India is actively participating in developing a strong technological and economic alliance via the QUAD, which is more focused towards the Indo Pacific belt. The QUAD countries also have a keen interest in ensuring a secure safe Central Asia, while containing China's technological and economic dominance. The regional security dialogue for India is good beginning, it must follow up with increased presence in the Central Asia.

# Nature's call: Now's the time to answer



Protection of forests is critical not only to reduce emissions, but also to conserve biodiversity and to support sustainable development

here is a high concentration of greenhouse gas emissions in towns and cities where the populations are dense and per capita electricity consumption is high. It is therefore necessary for every town and city to have an urban forest. Úrban forest refers to planting trees in densely populated areas, like parks, streetways, and private properties.

Like any other forest, it captures and stores atmospheric carbon dioxide during photosynthesis to help mitigate climate change.It is also crucial to properly manage and log natural forest patches and protect them from construction and other development activities in order to maintain their carbon sink capabilities.

The implications of global warming, including sea-level rise, temperature changes, precipitation change and more frequent extreme weather events, made it crucial to examine greenhouse costs. Thus, the work by William Nordhaus (an American economist) such as the DICE (Dynamic Integrated model of Climate and the Economy), FUND (Regional Integrated model of Climate and the Economy) & PAGE (Policy Analysis of Greenhouse Effect) [which are a part of Integrated Assessment Models (IAM)] are used to estimate the social cost of carbon which is the present value of the net future harms caused by an additional ton of emissions in a particular year. The IAM model is a quantitative model that describes how the economy and the climate are interwoven world-

He also suggested that governments around the world should impose a carbon tax in order to combat negative externalities caused by greenhouse gas emissions. Furthermore, a carbon tax would provide additional revenue to the federal government that could be used to conserve and develop forests, thereby reducing the unequal impact of climate change on the affluent and the poor. The model concludes that attempts should be made to reduce emissions, even at economic cost.

Tropical forests are home to many unique species of animals and plants as well as provide food, medicine, and clean drinking water to the people. They regulate regional rainfall and prevent droughts and floods in the region. Thus, their protection from deforestation and degradation is critical not only to reduce emissions, but also to conserve biodiversity and support susunable development.

Spatial fragmentation affects mating patterns, gene flow and pollen dispersion within plant populations that are essential to maintaining genetic diversity. Presently, degradation and fragmentation of habitats are the leading causes of biodiversity loss in terrestrial ecosystems. Therefore, the people who rely on these resources are likely to suffer the most.

In the coming years, climate change will cause major ecological and economic disasters in coastal cities, where mangroves and water bodies are rapidly disappearing.

# TB crisis: Time for India to act

#### Early diagnosis of people possessing a high probability of having presumptive TB is an essential part of the case identification strategy

ontrolling tuberculosis is a disconcerting challenge for India. The decades' old unrestrained transmission of the disease has impacted millions of Indians leaving them with latent TB infection. A significant number of people being undernourished weakens their immunity making them prone to TB reactivation. The density of the growing urban infrastructure has facilitated in quick transmission of TB

across all economic spheres. India has undertaken activities to control TB for more than half a century, still, TB has been the country's most severe health condition. Nearly, 480,000 TB-related deaths happen every year and over 1400 every day. In addition to this, around one million



cases are undetected or inadequately diagnosed in India. These tragic losses occur

due to the existing poverty, lack of infrastructure and equipment and less knowledge. Fortunately, India is in a better position to deal with Tuberculosis now. The recent interventions and technological advancements for TB diagnosis have been effective in providing appropriate and timely treatment.

The National Strategy Plan 2017-2025 for TB elimination has obtained remarkable goals in strengthening the programme structure, support systems and implementation surroundings for controlling TB. This comprises compulsory notification of all TB cases, aligning the programme with public health services and



National Health Mission, onestop service for TB-HIV cases, tactical drug-resistant TB management and revaluation of partnership guidelines.

As per the India TB report 2021 published by the Ministry of Health and Family Welfare, NTEP (National Tuberculosis Elimination Programme) identified more than 4,11,000 patients. With these steps and measures NTEP almost covered the gap of enrolment of TB treatment. Notifications were sent to 18, 05,670 patients around that time, which is 11 per cent more than the anticipated numbers.

Early diagnosis of people ossessing a high probability of essential part of the case identification strategy. Patients with presumptive TB would be proactively identified and referred to the nearby diagnostic facility for suitable investigation. Patients attending both the private and the public sector institutions need to be periodically tested for TB symptoms by the healthcare facilitators. Passive case detection alone results in missed cases and late diagnoses. Enhanced medical outreach for detecting more TB cases are elementary for universal access.

TB screening has to be undertaken at all the points of contact with healthcare person-

nel among the key population, which include the socially and clinically vulnerable and deprived people. New diagnoshaving presumptive TB is an tics approved by WHO can be used in high burden resource

settings like India. RNTCP gained locationwise coverage in March 2006 and since then, case notification rates have increased up to the time where it remained stationary. The notification rates have decreased in many parts of India despite growing efforts examining symptomatic patients in the public sector. Steps for ascertaining TB notification from private medical centres have contributed to increasing the overall notification, but it's still incremental

Prevalent surveys suggested that not all people with chest groups for other national pro-

symptoms seek care and treatment and many do not pay attention to them. This proves that the health services' programme needs to draw special attention to create awareness about how to identify symptoms and seek treatment. Active case finding (ACF)

is one way to do the above mentioned. ACF is a providerinitiative with the main objective of early detection of cases by actively finding targeted segments and to begin prompt treatment. It must be noted that 'screening' is a vigorous procedure and prioritizing the approach of screening, vulnerable groups and screening interval will have a regular assessment done by the programme. While there is a clear definition of vulnerable target

Moreover, while the programme is capable of increase examining symptomatic patients by 50-60 per cent; it will result in added case finding substantially.

Analysing the social, economic, and political context of the operation of the TB programme has highlighted the insight and need to rapidly respond to the issues to address the unavoidable TB epidemic.

The consistent shortage of resources, indifferent private sector and a weak public health system add to the pre-existing challenges in Indian's medical infrastructure. Nevertheless, the research has shown that the NSP has huge underlying strengths, and they could be utilised for making an everlasting epidemiological impact.

#### US, S Korea discuss how to resume talks with N Korea

Korean diplomats discussed how to restart stalled talks with North Korea on Thursday, days after the North conducted artillery firing drills in its latest weapons tests.

US Assistant Secretary of State for East Asian and Pacific Affairs Daniel Kritenbrink was in Seoul for talks on security issues including North Korea, economic cooperation and other matters.

Kritenbrink and his South Korean counterpart Yeo Seungbae agreed on the importance of pursuing stability on the Korean Peninsula.

The two discussed ways to resume the talks with North Korea as quickly as possible, the South Korean Foreign Ministry said in a statement.

The US Embassy in Seoul tweeted that the two spoke about "how our Alliance can continue to promote the rulesbased international order in the Indo-Pacific & beyond." Since September, North Korea has conducted a spate of missile and other weapons tests, including the artillery drills last Saturday.

Some experts say North Korea aims to pressure the US and South Korea to recognise it as a nuclear state in the hope they will work to ease international sanctions on the North.

Nuclear diplomacy between Washington and Pyongyang largely remains stalled since early 2019.

## Biden announces effort to ID toxic air issues in veterans

WASHINGTON: President Joe Biden, whose son Beau was an Iraq war veteran, is using his first Veterans Day in office to announce an effort to better understand, treat and identify medical conditions suffered by troops deployed to toxic environments.

It centers on lung problems suffered by troops who breathe in toxins and the potential connection between rare respiratory cancers and time spent overseas breathing poor air, according to senior White House officials. Federal officials plan to start by examining lung and breathing problems but said they will expand the effort as science identifies potential new connections.

Biden planned to travel to Arlington National Cemetery ticipate in a wreath-laying ceremony and deliver remarks.

The new federal effort is also designed to make it easier for veterans to make claims based on their symptoms, to collect more data from troops who are suffering and to give veterans more time to make medical claims after symptoms such as asthma and sinus problems develop.

"We're discovering there is a whole host of lung conditions related to deployment," said Dr. Richard Meehan, an immunologist and rheumatologist. The retired U.S. Naval Reserve officer, who served in the Mideast during the 1990s and again in 2008, is co-director of the Denver-based National Jewish Hospital Center for Excellence on Deployment-Related Lung Disease.

# **States to forego** ₹44,000 crore revenue: Report

 $T^{\text{he states will forego around}}_{\stackrel{\scriptstyle 7}{\scriptstyle 44,000}\text{ crore of tax revenue after they reduced VAT on}}$ petrol and diesel in the reminder of the fiscal but higher central tax devolution of ₹60,000 crore will offset the losses, according to a report.

After months of calls for lowering the taxes on the fuels, the Centre on November 4 cut excise duty on diesel by Rs 10 a litre and by ₹5 on petrol. Following this, as many as 25 states and Union territories have lowered value-added tax (VAT) on these fuels.

The FY22 revenue loss of the states from tax cut is

around ₹44,000 crore, of which ₹35,000 crore is by way of lower VAT and the rest indirectly, Aditi Nayar, chief economist at rating agency ICRA, told reporters on Thursday.

But, the states are not actually losing money as they are getting ₹60,000 crore of additional revenue from the Centre as part of the higher-thanbudgeted tax devolution, she

While the Central excise reduction leads to no direct revenue loss to the states, the reduction of VAT, which is levied on an ad valorem basis, the excise cut will lower their VAT inflows by ₹9,000 crore,

## Auction for 5G spectrum likely in April-May 2022: Min Ashwini Vaishnaw

PTI ■ NEW DELHI

The auction for the 5G spectrum is likely to take place around April-May next year, Communications Minister Ashwini Vaishnaw said on Thursday While relief measures

announced in September this year for telecom operators marked the first set of reforms, the government will bring out a series of further reforms and "telecom regulatory structure should change in coming 2-3 years", Vaishnaw said.

Speaking at the 'Times Now Summit 2021', the minister said India's telecom sector regulation has to be benchmarked with the global best, and added that "so, we will come with a series of reforms in this, such that the global benchmark of regulations is achieved in India". On the timeline for 5G auctions, Vaishnaw noted that the Telecom

Regulatory Authority of India (Trai), which looks at the structure of auctions, is undergoing consultations on the matter.

"I think they will submit their report by February-mid is what we are thinking, maybe February-end, maximum to maximum March. Immediately after that, we will have the auc tions," he said.

The comment assumes significance as the Department of Telecommunications (DoT) was earlier hopeful of holding 5G auctions by the end of the current fiscal. Giving a specific timeline

for the upcoming auction will be difficult at this stage since much depends on the time Trai will take to finalise its views, the minister added. "But, today, our estimate is by April-May. was earlier estimating March But, I think it will take...Because consultations are complex, diverse opinions are coming...," he said.

## India's GDP to rise by USD 406 bn by 2050 in net-zero scenario

ndia's GDP will rise by USD 406 billion by 2050 and more than 43 million jobs will be created, as the Asia's third-largest economy leaps towards a netzero target, according to a report by Observer Research Foundation (ORF).

At the 2021 Climate Change Conference, also known as COP26, Prime Minister Narendra Modi outlined a net-zero emissions target by 2070 for India. Also, India is targeting to increase its low-carbon power capacity to 500 gigawatts (GW) by 2030, and meet 50 per cent of its energy requirements from renewable energy by 2030.

"India's net-zero carbon emissions target of 2070 is momentous and praiseworthy, but highly ambitious to say the least," an ORF statement

Structural changes and accelerants required to steer this transformation while balancing the twin goals of sustainability and development are detailed in the report 'Shaping Our Green Future: Pathways and Policies for a Net-Zero Transformation'.

The report, ORF said, is a compendium of essays that offers possible solutions to several pressing questions and aims to provide a roadmap for India's transition to a decarbonised and green economy.

"The net-zero pathway require committing to a legally binding net-zero target y a fixed year," said Jayant Sinha, Chairperson of the Standing Committee on Finance, in the report.

A legally binding net-zero target and supportive government policies can lead to massive investments in green technologies and equipment.

New Delhi: Markets regulator Sebi has amended rules to introduce silver exchange traded funds, a move that will expand the options available for investing in commodities through stock exchanges Currently, Indian mutual funds are allowed to launch ETFs (Exchange Traded Funds) tracking gold. The watchdog has amended the rules to enable the introduction of silver ETFs, according to a notification issued on Tuesday. Sebi said that a silver ETF scheme means a mutual fund scheme that invests primarily in silver or silver-related instruments which have silver as the underlying product. "Mutual fund schemes investing in exchange traded commodity derivatives may hold the underlying goods in case of physical settlement of such contracts," the regulator said.

The Union Civil Aviation Minister Jyotiraditya Scindia on Thursday launched the e-governance for Civil Aviation (e-GCA) online platform through which the Directorate General of Civil Aviation will provide 298 services including pilot licensing and medical examination. The online platform will provide services to various DGCA stakeholders such as Pilots, Maintenance Engineers, Air Traffic Controllers, Air Operators, Airport Operators, Flying Training Organisations, Maintenance and Design orga-

The launch of the e-GCA

nizations, among others.

project under DGCA was part of the Minister's 100-day plan for the aviation sector. The portal was developed by Tata Consultancy Services.

'Two hundred and ninety-eight services have been moved to the e-GCA platform - 99 in the first two phases and 198 in the next two phases. The first 99 cover about 70-75 per cent of what DGCA does including pilot licensing, medical examinations, permission to flying training organisations and connecting regional offices to the headquarters," he

The next two phases cover the remaining 30 per cent services of the DGCA, he said in his speech after launching the online platform 'e-GCA' here. "And through this transformation (DGCA to e-GCA), we have achieved a number of objectives of becoming a single window online service platform, eliminating procedural inefficiencies and automating regulatory reporting," he noted

On pilot licensing through the e-GCA platform, Scindia said, "In India, we have close to 17,860 CPLs (commercial pilot licenses). Add to that, there are almost 1500 helicopter pilot licenses. There are close to another 10,000 PPLs (private pilot licenses). So you are looking at a universe of almost 30,000 pilots".

The medical examination of pilots used to be a very cumbersome process in the old system, he noted.

## Tackling backto-school anxiety

Extending unconditional support can help children manage their stress with ease, says Dr Ankush Khanna sharing useful tips to overcome the same

 $B_{\text{common concern. Many}}^{\text{ack-to-school anxiety is a}}$ kids experience stress going to school after enjoying their summer or winter vacations, while some become anxious when they go to a new school for the first time. Now after a long Covid break where students spent months out of the traditional classroom and studied

tional classroom and studied online at home, going back to school might feel scary.

As schools prepare to reopen their doors, many children find it difficult to cope with this decision. Children are uniquely impacted during the uniquely impacted during the pandemic. They have stayed at home with their parents and might have been affected due to poor health, economic and social consequences. The pandemic has taken a toll on human health and some might have experienced the loss of loved ones. On the other hand, worrying about wearing masks and being unvaccinated can make children more nervous about joining back.

#### How to identify your child is anxious?

While the stress of returning to school is common in children, it is also important to address it. Being a parent or a guardian, one needs to identify the signs of anxiety in children and help overcome them. When a child is anxious, the majority of the time he/she will never express it in words. Instead, one needs to look for clues and observe changes in their behav-

Children who experience anxiety or feel nervous may appear more clingy than normost visible signs that can be less present in older children but commonly seen in primaryschool-aged children. Apart from this, children become restless and they can be seen facing difficulty concentrating. The changes in their eating and sleeping patterns can be seen and their complaints about stomach ache, upset stomach and indigestion increase.

Identifying anxiety in children is also crucial for parents. Untreated or unaddressed anxiety can increase the risk of poor concentration in children. This affects their performance, relationship with friends and teachers that might lead to other serious consequences.

#### Ways to deal with anxiety

The most effective way to overcoming anxiety is to make your child speak about what's troubling them. Without judging their point of view or feelings, listen to their concern that will make them feel better. Here are a few useful tips to deal with back-to-school anxiety:

#### ☐Make things familiar Children become anxious

when they enter into a complete strange or unfamiliar environment. Thus, as the school approaches, try to make your

child familiar with the environment they might experience on the first day of their school. Not being comfortable about their school environment can make them nervous and develop anxiety. It is better to tell them about new guidelines, rules and safety measures taken by the school to give them time to prepare for things that will be new for

#### ■Assure they are not alone

Spread positivity around the child and make them understand they will not be alone in following stringent safety rules. Other students and their friends will also be a part of the new environment and teachers will always be there to make them comfortable. Remind them of the time they spent in school in the pre-Covid era, enjoying their favourite activity with their loving friends and teachers. A feeling of reconnecting might help in easing their anxiety.

#### ☐Be present for them in need

Transitioning from home to school after a long break can be extremely difficult for children. Make an effort to be there with them at least in the initial days of school. Offer your support and provide counselling before they re-join. After coming back, give them time and listen to how their day went to make sure your child expresses his/her feelings and concerns.

#### □Promote healthy living

The best way to address and combat anxiety in children is by making them indulge in healthy habits. 

were brought to the table. The first one was the StayWoke lemonade, which resembled the taste of a virgin mojito minty lemony goodness minus the calories! The other drink was a Kaffir lime kombucha served in an elegant flute glass. This was extremely refreshing with a strong punch from the kaffir lime leaves, leaving a sweet and fragrant after taste.

This refreshing drink was paired with a slightly spicy and tangy Chicken ghee roast. Served in a beautiful black ceramic plate, the colours of the bright red chicken popped on the plate. The chicken was paired with fried South Indian papadam, garnished with coconut shavings. This South Indian signature dish had just the right amount of heat, tingling my taste buds gently. The tanginess from the tomatoes and strong flavour from the curry leaves and the mustard



seeds defined the dish. These bold flavours of the south made the dish near-perfect.

The next dish was the Avocado toast. This superfood has garnered a lot of attention in recent years but no restaurant makes their avocado toast the way Café StayWoke did. Served over either a sourdough or focaccia bread slice, the avocados were mashed combined with some cream cheese, finely chopped onions, coriander, topped with hemp oil and pomegranate seeds.

This version of the classic avocado toast caters to the Indian palate and showcases the versatility of an avocado. The sweetness from the pomegranate and crunchiness from the onions with a hint of gar-

lic worked well together. On the table next was the Keema appam which took me on yet another trip to South India. The chicken keema rested on a bed of appam, topped with a beautifully poached egg. As I ran my spoon over the egg, the deli-

cate white covering tore, giving way to the runny yolk that perfectly covered the keema. The appam was crispy on the outside yet light and fluffy on the inside. The keema, tossed in a variety of spices, had a strong flavour of the comforting curry leaves. The best part about this entire dish was the lightness of the meal. One can comfortably eat an entire plate and not be over-stuffed!

For the mains, I had the Vegetarian green Thai curry and the Orange chilli chicken. As for the Thai curry, the veggies are served separately for those who don't prefer a lot of veggies in their curry. The curry is served with kaffir lime rice, which adds a touch of freshness to the heavy and thick curry. The flavours of the Thai curry and rice is as authentic as it can get and is a must-try! On the other hand, the fragrant chilli chicken is more on the sweeter side with just a dash of heat. The chicken so soft and tender on the inside and crunchy on the outside, wrapped in the thick, shining orange glaze will have you craving more.

Finally, it was time to end my day with some dessert. I was served the signature Cloud pudding. Made with tender coconut, this dessert was a set and had the consistency resembling that of a panna cotta. Served on a banana leaf, this soft, gooey coconut deliciousness was the perfect

way to end a satisfying meal. At Café StayWoke, the vibe is relaxed, the food is delicious and the staff is courteous. If you're looking to have a good time with some delicious plates of food from around the world while soaking the sun and connecting with nature, this may just be the place for you.

## Convenience vs health

Against the backdrop of these fast-paced times, DR MINAL KABRA poses an important question; whether packaged foods are focussed on your well-being?

In the last few years, the Lonvenience food industry has shown rapid growth in India. About 79 per cent of Indian consumers prefer to have instant food due to time constraints as indicated by the recent survey conducted by the Associated Chambers of Commerce and Industry of India (ASSOCHAM). As per market reports, the convenience food segment is expected to show a volume growth of 5.8 per cent in 2022. This can mainly be attributed to a busier lifestyle, the growing number of nuclear families and more people preferring to work late hours. During the pandemic, as people started to work from home, the demand for convenience food spiked, and all estimates suggest the trend will continue to grow.

However, what changed after Covid is the consumers' tendency to be health-conscious of the food they consume. You see, most packaged food is loaded with preservatives, chemicals and highly unhealthy ingredients like refined flour and refined sugar. These ingredients not only help increase the shelf life of the food but also give them their addictive flavour that makes the consumer want more and more. So, while they do offer the convenience of carrying and eating wherever you wish, their health impact is alarming, to say the least.

Post-pandemic, most consumers are relooking at immunity and the role of food in building the same. The food industry in turn has reciprocated with the two overarching themes of products with better immunity and products with better nutrition for a healthy lifestyle.

But the big question is whether the products being pitched as healthy or immunity-boosting offer these benefits or are they just trying to ride the wave and manipulate the consumers? The answer is always writ-



ten on the package. The Food Safety and Standards Authority of India (FSSAI) mandates every manufacturer to specify the list of ingredients used to make any packaged product. And while most of us tend to not consider this key aspect of the package, that is where one should look to understand the health quotient of the offered product.

To put it generally, prefer millets over wheat, wholegrain flour over refined flour, jaggery or maple over refined sugar. Any product that has a list of chemicals and raising agents or names that you don't consider as natural food, should be avoided. Another hint is to look for shelf life as there is a limit to how long you can store a completely natural food without adding artificial preservatives. So anything that has a shelf life of over five months is bound to have artificial preservatives unless it is stored at sub-zero temperatures or in a well-designed tetrapack.

These guidelines would most probably eliminate most of the offerings of major multinationals

as their scale of operations make it necessary to have a longer shelf life and be more addictive. This specific gap has opened the gates for several young start-ups that cater to niche demands by making smaller batches and delivering them fresh through their websites or modern e-commerce platforms.



Opening the innings, Rizwan scored 67 off 52 balls during which he hit three boundaries and four sixes, while Zaman remained unbeaten on 55 off 32 balls with the help of three fours and four sixes Together with skipper Babar Azam

(39), Rizwan shared 71 runs for the opening stand before stitching 72 runs For Australia, Mitchell Starc picked

up two wickets for 38 runs.

Chasing, David Warner made 49, while Matthew Wade smashed a 17-ball unbeaten 41 and Marcus Stoinis was not out on 40 off 31 deliveries as Australia overhauled the target with an over to

Shadab Khan was the best bowler for Pakistan with figures of 4 for 26. Australia will now face New Zealand in the final on Sunday.

Mohammad Rizwan struck his third half-century of the tournament before Fakhar Zaman roared back to form with a 32-ball unbeaten 55 to power Pakistan to 176 for four in the second semifinal of the ICC T20 World Cup here on Thursday.

Openers Rizwan (67 off 52) and Babar Azam (39 off 44) shared a 71-run stand before Zaman ended the innings on a high with his unbeaten knock.

The last five overs yielded 59 runs for Pakistan.

Pakistan enjoyed their best powerplay of the tournament, racing to 47 for no loss in six overs after Australia put them in to bat.

Rizwan, who was down with flu ahead of the game, did not look at his best early on and Babar took the lead in attacking the Australian pace attack. The Aussies were looking for some swing early on but they were not able

The Pakistan skipper began with regal cover drive off a late outswinger from Josh Hazlewood. Babar, who had shown supreme form in the group stage, looked in sublime touch. Among the five regal boundaries he hit, his shortarm jab between deep midwicket and long-on stood out.



Leg-spinner Adam Zampa, who has been Australia's go to bowler in the middle overs, finally got the breakthrough Australia needed by having Babar caught in the deep with Pakistan reaching 71 for one in 10 overs. More than the ball, it was the pressure created by Zampa that led to the wicket.

Rizwan, who was dropped twice in the innings, got into the act after Babar's dismissal. The wicketkeeper batter grew in confidence as his innings progressed and once he he got his trademark half full half sweep shot right off Hazlewood, he looked much more dangerous.

Australia did well from overs 7-11, conceding only 28 before Rizwan changed Gears.

He decided to take the attack to the impressive Zampa in the 12th over which went for 14 runs and included a slog sweep for six.

Rizwan got his second six off Hazlewood two overs later, dispatching the seasoned pacer over deep midwicket.

Zaman, who did not have a lot of runs under his belt heading into the semifinal, hit a flat six over long off to gain confidence.

With Zampa completing his tidy effort, Pakistan were looking for a big over and that happened to be the 17th when Hazlewood was hammered for 21 runs, including a six off a free hit.

After Rizwan's dismissal, Zaman displayed his power hitting skills against Mitchell Starc, clubbing him for a six and four in a 15run over.

Six-hitting machine Asif Ali had a rare failure in the tournament as he was out first ball off Cummins.

Zaman finished the innings on an exhilarating note, depositing Starc for two massive sixes to take the team past 170.

Zampa (1/22 in four overs) was the pick of the bowlers for Australia while Hazlewood was the most expensive, leaking 49 runs in four overs.
