Centre gives Gurpurab gift to nation's Sikhs


Kartarpur Corridor to open today after 19 mths

PNS CHANDIGARH

xactly 19 months after the Ehistoric corridor linking Dera Baba Nanak in India's Gurdaspur district Gurdwara Darbar Sahib in Narowal, Pakistan, was closed in the wake of the Covid outbreak in March 2020, the Central Government on Monday announced its reopening for pilgrims on Wednesday

Punjab's politicians transcended political boundaries to welcome the announcement, which comes just two days ahead of the birth anniversary of the first Sikh Guru Nanak Dev that falls on November 19. Besides, Sikh leaders, activists also hailed the move.

Thanking Prime Minister Narendra Modi and Union Home Minister Amit Shah for the re-opening of the corridor ahead of Gurpurab, Punjab Chief Minister Charanjit Singh Channi announced that the



entire State Cabinet would pay obeisance at Kartarpur Sahib on November 18 as a part of the first delegation after reopening of the historic corridor.

"It's a happy moment that the Kartarpur Corridor is reopening and the prayers of the Sikh community are being answered. I had met Prime Minister Modi and Home Minister Shah as Chief Minister and had requested them. Now they've announced it. I thank them. The Punjab

Cabinet will be part of the first jatha for paying obeisance on November 18," said Channi.

Also hailing the Centre's decision, the Shiromani Parbandhak Gurdwara Committee (SGPC) — known as Sikhs' mini-parliament, also announced that it would send a group to Darbar Sahib Gurdwara in Kartarpur.

The group which will pay obeisance at the gurdwara on November 19, will be led by the SGPC president Bibi Jagir Kaur, besides a ragi jatha (group of

Gurbani singers) and other members of the gurdwara body. The SGPC has also appealed to the Sikh sangat to take part in the 'jatha' to celebrate Guru Nanak's 552nd birth anniversary at Kartarpur Sahib. Former Chief Minister

Captain Amarinder Singh also took to *Twitter* expressing his profound gratitude to Modi and Shah for the timely opening of the corridor. "It will provide a chance to thousands of devotees to pay obeisance at the holy shrine on the occasion of Gurupurab of Guru Nanak

Dev Ji," he tweeted. Shiromani Akali Dal (SAD) president Sukhbir Singh Badal said that he and former Union Minister Harsimrat Kaur Badal had written letters to the Prime Minister calling for the same. Lauding the decision, he added that the "sentiment of an entire community" had now been fulfilled.

Describing it as a "welcome step", Punjab Congress president Navjot Singh Sidhu said: "The reopening of the Corridor of infinite possibilities...invaluable gift for Nanak naam levas...May the corridor of the Great Guru remain open eternally to shower blessings on one and all....Sarbat da bhala'.

City Govt for WFH, weekend lockdown

Delhi-NCR's schools, colleges closed till further notice: CAQM

SAPNA SINGH NEW DELHI

In an emergency meeting on air pollution in Delhi on Tuesday, the city Government suggested a weekend-lockdown and work from home (WFH) for a week. Meanwhile, in a late night development the Commission for

Air Quality Management said that all schools, colleges and educational institutions in Delhi and nearby cities have been closed till further notice. Earlier, Environment Minister

Gopal Rai said a ban on construction and industrial activities was also recommended in the meeting with the Centre for Air Quality Management (CAQM), in which representatives of Punjab, Haryana, Rajasthan and Uttar Pradesh (UP) Governments participated. "The other States have also put forth their views and we are waiting for an official notification from the commission," Rai said.

With SAFAR, marking that the contribution of farm fires in PM 2.5 fluctuated between four to 48 per cent in November, Rai urged the Centre to clear its stand on pollution from stubble burning,

during the meeting.

The Centre's submission of two contrasting facts in the court has created chaos. It is shocking that the Centre has said that the contribution of stubble in pollution is four per cent on one page and 35 to 40 per cent on another page in the same document,"

"I looked into this and found that SAFAR, a Central Government organisation, was responsible for publishing the data and estimates from November 4-14. Diwali was on November 4th and SAFAR's assessment says that on November 4, the contribution of

stubble burning was 25 per cent. It was 36 per cent on November 5; 41 per cent on November 6; 48 per cent on November 7; 30 per cent on November 8; 27 per cent on November 9 and 10; 26 per cent on November 11; 35 per cent on November 12 and 31 per cent on November 13 and 14. If we were to consider the average of the data from

November 4 to November 14 it is around 31 per cent. This data is also from the Central Government, and the data which has been handed over inside the court is also from the Central Government," Rai said.

Pfizer to allow others to make its Covid pill

PNS NEW DELHI

n a major move that will also help India in its fight against Covid-19, pharma giant Pfizer Inc said on Tuesday it will allow generic manufacturers to supply its experimental antiviral Covid-19 pill to 95 low-and middle-income countries.

This will be done through a licencing agreement with international public health group Medicines Patent Pool,

said the company.

The voluntary licencing agreement between Pfizer and the MPP will allow the United Nations-backed group to grant sub-licences to qualified generic drug manufacturers to make their own versions of PF-07321332. Pfizer will sell the pills it manufactures under the brand name Paxlovid.

"We are extremely pleased to have another weapon in our armoury to protect people from the ravages of Covid-19",



said Charles Gore, Executive Director of the Medicines Patent Pool in a statement

Pfizer will waive royalties on sales in low-income countries. It will also waive them in the other countries covered by the agreement as long as Covid-19 remains classified as a public health emergency of international concern by the World Health Organisation, said the company in the statement here.

Pfizer Chief Executive Albert Bourla further said, 'We believe oral antiviral treatments can play a vital role in reducing the severity of Covid-19 infections... We must work to ensure that all people — regardless of where they live or their circumstances — have access to these breakthroughs." Continued on Page 2



CBI cracks down on online child abuse

77 places raided in 14 States/UTs in cases related to sexual exploitation

PNS NEW DELHI

In a coordinated crackdown against online content providers on child sexual abuse, the Central Bureau of Investigation (CBI) on Tuesday conducted searches at around 77 locations across India in 14 States/Union Territories in connection with 23 separate cases registered on Sunday against total 83 accused on the allegations related to online child sexual abuse and exploitation (OCSAE)

As per preliminary infor-

mation collected after the searches, more than 50 groups with 5,000 plus offenders are sharing child sexual abuse material. Initial estimates also suggest that nationals of around 100 countries spread across various continents may be involved in the racket. The searches were con-

ducted in Andhra Pradesh, Delhi, Uttar Pradesh, Punjab, Bihar, Odisha, Tamil Nadu, Rajasthan, Maharashtra, Gujarat, Harvana, Chhattisgarh, Madhya Pradesh and Himachal Pradesh.

"In a nationwide coordinated crackdown on crime related to online child sexual

abuse material, the CBI regis-

tered 23 separate cases on

14.11.2021 against 83 accused

on the allegations related to

online child sexual abuse and exploitation," the CBI said in a statement. The agency further said, "It was alleged that various syndi-

cates of individuals based in different parts of India and foreign countries were indulging in circulating, storing and viewing child sexual exploitation material (CSEM) through varsocial platforms/groups."

It was also alleged that

people were spreading CSEM by way of sharing links, videos, pictures, texts, posts and hosting of such content on social media groups/platforms and third party storage/hosting platforms, it said.



Gay activists hail SC approval to elevate advocate Kirpal as Delhi HC judge, call decision historic

India could get its first gay judge with the Supreme Court collegium approving the name of Saurabh Kirpal for the Delhi High Court was widely wel-comed on Tuesday, some in the LGBTQ community terming it historic and others describing it as a harbinger of an unbiased

The senior advocate moved a significant step towards becoming a Delhi High Court judge with the collegium, head-ed by Chief Justice of India N V Ramana, recommending his name, a decision deferred multiple times since 2018 for what many speculated was because of his sexual orientation. Recommendations are sent to the Centre for approval. It can send it back to the collegium. However, if the name is sent

back, the Centre has no option but to approve it.

The news of the likely elevation of 49-year-old Kirpal, who has spoken candidly about his gay status, was met with an emotive response from those in the gay community and also from celebrities, rights activists and others on social media and elsewhere. For author Sharif D Rangnekar, a friend of Kirpal, this recommendation is "incredibly huge" and will "inspire and motivate many people" in the community to live a dignified life. "I can't tell you how happy I am to get this news. It's Saurabh Kirpal's achievement definitely, all credit to him, but we are living in a community where there are so few people who are holding certain position or posts that carry a certain kind

of influence, that today this is

something we would want to own as well," Rangnekar, a former journalist and author of "Straight to Normal: My Life as a Gay Man", told PTI.

Saurabh could have chosen to sign off from India and gone to another country, and got more dignity. But he hung on here, he has not buckled under any pressure .. You never know how many more lawyers will now come out as queer, and not feel discriminated. It is indeed a historic moment for the community," he added.

Health Min suggests house stickers be given to notify fully vaccinated status of families

New Delhi: Union Health Minister Mansukh Mandaviya on Tuesday suggested that stickers for houses to notify completion of both doses of Covid-19 vaccines should be given to fully vaccinated families to encourage uptake of vaccine among the population.

The Minister made the sug-

gestion during a meeting on Tuesday with non-government organisations, civil society outfits and development partners to take the "Har Ghar Dastak" Covid vaccination campaign across the length and breadth of the country, according to a Union Health Ministry state-

Mandaviya noted that 'Jan-Bhagidari' (people's participation) is essential for such a mammoth exercise like India's vaccination programme.

"India stood tall in Covid-

19 crisis because of the initiative of non-Government organisations and civil society organisations which supplemented the efforts of the government to ensure that nobody went to sleep on an empty stomach during the Covid lockdown," he

The Minister also noted their contribution in ensuring that 80 per cent of the popula-tion and 40 per cent of the population received their first and second dose of the vaccine respectively, according to the statement.

Nation logs 8,865 new

,865 new coronavirus infections, the lowest in 287 days, taking the country's tally of Covid-19 cases to 3,44,56,401, while the active cases settled at 1,30,793, the lowest in 525 days, according to the Union Health Ministry data updated on Tuesday.

The number of deaths climbed to 4,63,852 with 197 fresh fatalities, according to the

data updated at 8 am.

The daily rise in new infections has been below 20,000 for 39 straight days and less than 50,000 daily new cases have been reported for 142 consecutive days now.

The active cases comprise 0.38 per cent of the total infections, the lowest since March 2020, while the national Covid-19 recovery rate was recorded at 98.27 per cent, the highest since March 2020, the Ministry said. A decrease of 3,303 cases has been recorded in the active Covid-19caseload in a span of

"The accident occurred on Sikandra-Sheikhpura National Highway-333 near Pipra village under Halsi Police Station when the SUV driver lost control over his vehicle and hit the truck coming from the opposite direction near Pipara village early on

"Six people, including the driver, were killed in the incident," Superintendent of Police Sushil Kumar stated.

Four injured were rushed to Jamui's Sadar hospital in critical condition.

The deceased have been identified as Laljit Singh, his two sons Amit Shekhar alias Nemani Singh and Ram Chandra Singh, daughter Baby Devi, niece Anita Devi and the driver Preetam Kumar.

Laljit was the brother-in-law of Om Prakash Singh, a senior Haryana Police officer. OP Singh is the brother-in-law of Sushant Singh Rajput.

The victims were returning to Jamui after attending the funeral of Geeta Devi, the sister of OP Singh.

A case has been registered and further investigation is underway, the SP added.

CBI cracks down on online child abuse

The searches were conducted at around 77 locations, including Tirupati and Kanekal (Andhra Pradesh), Delhi; KonchJalaun, Mau, Chandauli, Varanasi, Ghazipur, Siddharthanagar, Moradabad, Noida, Jhansi, Ghaziabad and Muzaffar Nagar (Uttar Pradesh); Junagarh, Bhavnagar and Jamnagar (Gujarat); Sangrur, Malerkotla, Hoshiarpur and Patiala (Punjab); Patna and Siwan Hisar (Haryana); Bhadrak, Jajpur and Dhenkenal (Odisha), Tiruvalure, Coimbatore, Namkkal, Salem and Tiruvannamalai (Tamil Nadu); Ajmer, Jaipur, Jhunjhunu and Nagaur (Rajasthan); Gwalior (Madhya Pradesh); Jalgaon, Salwad and Dhule (Maharashtra); Korba (Chhattisgarh) and Solan (Himachal Pradesh), on the premises of accused.

"A number of electronic gadgets/mobiles/laptops, etc. have so far been recovered during searches. It is revealed that some individuals were involved in trading of CSEM material," the agency said.

The CBI is coordinating with sister agencies through formal and informal channels. Searches and development of further leads is underway and investigation is continuing.

Globally, the importance of recognizing and combating online child sexual abuse has been acknowledged. Every year, a lot of children face abuse which becomes more horrific when online platforms are used. It is a challenge for all stakeholders, including law enforcement agencies. Cooperation amongst law enforcement agencies is paramount for tackling this menace, the agency said.

Court directs lodging of FIR against directors of air charter service company for cheating

Delhi court has directed Aregistration of FIR against two directors of a city-based air charter service company for allegedly failing to provide helicopter service to a man despite receipt of money, noting that the duo had an "inten-

tion to cheat". Additional Sessions Judge Anuj Agrawal passed the order on the revision petition filed by complainant Anis Ahmad against the magistrate's order rejecting his plea seeking registration of FIR against the duo and an employee for not providing the helicopter for his niece's wedding after taking the payment of Rs five lakh in

The complainant alleged that the director did not return the paid amount after cancelling the service and stopped taking his calls, following which he came to know that they have closed the office.

He further said that one of the accused also threatened him. He filed two complaints at Jamia Nagar Police Station and with the Deputy Commissioner of Police (DCP) in September and October 2019 but no

action was taken. Police later told the court that the dispute was civil and there was no inducement or cheating. Allowing the revision petition, the Additional Sessions Judge said, "It appears

that respondent No.1 and 2 being Directors were having an intention to cheat the revisionist (Ahmad) since the beginning as they did not come up with an explanation as to

why no services were provid-

ed to revisionist despite receipt

of the amount."
Further, there is nothing on record to suggest that they had requisite permission from the Competent Authority to provide the helicopter services to the complainant at the relevant time as promised, the

Investigation by police would be required for recovery of the cheated amount, for ascertaining if the respondent had requisite permission to provide the services as promised by them and for effective investigation," he stat-

The judge added, "Present revision petition stands allowed. The impugned order stands set aside. In a boost to indigenization, the Indian Navy will commission a guided-missile destroyer and a Kalvari-class submarine next week. These inductions will also add lethality to maritime prowess of the country at a time when China is flexing its muscle in the Indian Ocean and Indo-Pacific

The Navy has embarked on a long term plan for building warships and submarines within the country and at present nearly 40 such platforms are under various stages of construction in Indian shipyards.

Giving details of the latest commissioning, Vice Chief of Navy Vice Admiral Satish Namdeo Ghormade said here on Tuesday, the destroyer 'Visakhapatnam' will be commissioned on November 21 while submarine Vela will be inducted into the force on November 25. The two ceremonies will take place in Mumbai with Defence Minister Rajnath Singh commissioning Visakhapatnam.

Addressing a news conference, he said "We all know that the maritime environment is a complex one and it only increases with more number of players involved," he said.

India-US discuss Af situation, ways to spur assistance

Tndia and US on Tuesday held detailed discussions here on the situation in Afghanistan and wavs to accelerate humanitarian assistance to that country.

The review took place during the talks between newly appointed US Special Representative for Afghanistan Thomas West and Foreign Secretary Harsh Shringla. The US representative also called on National Security Advisor(NSA)Ajit Doval.

Giving details of the talks, sources later said the two sides also took stock of forward movement on Afghanistan after India last week hosted NSA level talks. Seven countries besides India including five central Asian countries and Iran and Russia participated in the day long conclave on November 10.

India had invited Pakistan but it declined to come on the pretext that New Delhi had not invited the Taliban. China also did not attend the meet quoting scheduling issues. However, it participated in another meet on Afghanistan hosted by Pakistan on November 11 in Islamabad.



The US and Russia also participated in that event.

As regards talks between Shringla and West, sources said the agenda included recently held Regional Security Dialogue of NSAs, movement of people in and out of Afghanistan, coordinating global efforts on humanitarian assistance, regional security issues and bilateral issues.

The issue of humanitarian assistance came in the backdrop of India urging Pakistan to allow Indian trucks to supply food grains and other essential items to Afghanistan through the land route. Initially, Pakistan dilly dallied and later Prime Minister Imran Khan said the issue can be considered favourably. India is reportedly ready with more than 50,000 metric tons of supplies which can be ferried to Afghanistan through the land route from Peshawar after entering Pakistan from Attari-Wagah border.

The United States (US) has L cautioned its citizens not to travel to naxal affected areas and Jammu and Kashmir due to terrorism and civil unrest and also within 10 kilometres of the India-Pakistan border due to the potential for armed

Meanwhile, the US Centers for Disease Control and Prevention (CDC) has also issued a Level 1 Travel Health Notice for its citizens travelling to India, saying the risk of contracting the infection and developing severe symptoms may be lower if one is fully vaccinated. In its advisory for Pakistan, the US urged its citizens not to travel to Balochistan province and Khyber Pakhtunkhwa (KPK) province, including the former Federally Administered Tribal and kidnapping, and also in the immediate vicinity of the Line of Control due to terrorism and

the potential for armed conflict. Maoist extremist groups, or "Naxalites," are active in a large swath of India from eastern Maharashtra and northern Telangana through western West Bengal, particularly in rural parts of Chhattisgarh and Jharkhand and on the borders of Telangana, Andhra Pradesh,



Maharashtra, Madhya Pradesh, Uttar Pradesh, Bihar, West Bengal, and Odisha. The Naxalites have conducted frequent terrorist attacks on local police, paramilitary forces, and government officials," the advisory said. The US government has limited ability to provide emergency services to US citizens in rural areas from eastern Maharashtra and northern Telangana through western West Bengal as US government employees must obtain special authorisation to travel to these areas, the notice said.

On Jammu and Kashmir, the US advisory said that terunrest are possible in the state of Jammu and Kashmir. "Avoid all travel to this state (with the exception of visits to the eastern Ladakh region and its capital, Leh). Sporadic violence occurs particularly along the Line of Control (LOC) separating India and Pakistan, and in tourist destinations in the Kashmir Valley: Srinagar, Gulmarg, and Pahalgam. The Indian government prohibits certain areas along the LOC," it "Indian authorities report

rape is one of the fastest-growing crimes in India. Violent crimes, such as sexual assault, has occurred at tourist sites and in other locations," it said. The advisory further stated that incidents of violence by ethnic insurgent groups, including bombings of buses, trains, rail lines, and markets, occur occasionally in the northeast. U.S. government employees are prohibited from traveling to the states of Assam, Arunachal Pradesh, Mizoram, Nagaland, Meghalaya, Tripura, and Manipur without special authorization from the U.S. Consulate General in Kolkata.

A local history of terrorism and ongoing ideological aspirations ments have led to indiscriminate attacks on civilians as well as local military and police targets. Terrorists may attack with little or no warning, targeting transportation hubs, markets, shopping malls, military installations, airports, universities, tourist locations, schools, hospitals, places of worship, and government facilities," the US advisory said for its citizens regarding Pakistan.

SC irked by Centre's response on framing pan-India policy

The Supreme Court on ■ Tuesday expressed strong displeasure over the Centre's response on framing a pan-India policy to implement the Community Kitchen Scheme and granted it three weeks to hold a meeting with States, saying that a welfare State's first responsibility is to "provide food to people dying due to hunger". A bench comprising Chief Justice NV Ramana and Justices AS Bopanna and Hima Kohli, hearing a PIL seeking directions to the Centre, states and Union Territories (UTs) to formulate a scheme for community kitchens to combat hunger and malnutrition, was irked with the Centre's affidavit as it was filed by an official of the level of an under secretary and did not divulge details about the proposed scheme and its roll out as sought.

"This affidavit does not indicate anywhere that you are considering framing a scheme. You are extracting information. It does not say what fund you have collected and what you are doing etc. We wanted a uniform model from the Centre. You have to ask the states... Not

to collect information like police," the bench said. 'You cannot ask for infor-

mation which is already available. Do you conclude your affidavit saying you will consider the scheme now. There is not a whisper in your 17-page affidavit," it said. The apex court then expressed anguish over the filing of the affidavit by an Under Secretary of the Únion Ministry of Consumer Affairs, Food and Public Administration. "This is the last warning I am going to give to the Government of India. Your Under Secretary files this affidavit. Why can not a Secretary level officer file the affidavit? You have to respect the institutions. We say something and you write something. This has been told several times earlier," the bench Initially, the matter was

being argued by Additional Solicitor General Madhvi Divan and later Attorney General K K Venugopal stepped in and assured the bench that a meeting would be held by the Centre and a decision taken on the issue and sought four weeks time from the bench. The top law officer said that something can be worked out within the frame work of the National Food Security Act.

"The question is simple, last occasion we made it clear unless and until states are involved the Centre can not do anything. So we directed the Centre to call the meeting and frame the policy. The issue is now, make a comprehensive scheme, identify areas where there's immediate need, so it can be uniformly implemented," the CJI said.

"See if you want to take care of hunger, no Constitution or law will say no... This is the first principle: Every welfare state's first responsibility is to provide food to people dying due to hunger," the bench said. Earlier, the bench had asked the Centre to come out with some policy decisions concerning the implementation of the Community Kitchen Scheme by taking into consideration similar schemes which are operational in different States. Advocate Ashima Mandla, appearing for the PIL petitioners, was asked by the bench to prepare a chart of all the

Discussions on between Singapore, India to resume commercial flights

PNS NEW DELHI

The discussions are ongoing L between authorities from Singapore and India for resumption of commercial flights between the two countries. Singapore is planning to allow quarantine-free travel for fully-vaccinated passengers from India and Indonesia from November 29. Singapore has already recognised both Covishield and Covaxin, the two main jabs used in India. The move is expected to benefit thousands of Indian students, professionals and workers, who have been unable to travel to Singapore because of Covid-related travel restric-

Sources said that discussions are on as only commercial scheduled passenger flights can be designated as VTL flights. Currently, the only chartered flights are allowed from Singapore to carry passengers to India under the Vande Bharat Mission (VBM). Since these flights are chartered repatriation flights, they cannot be designated as VTL

Currently, there are 13 countries, including Canada,

Australia and Germany, under Singapore's vaccinated travel lane (VTL) programme. Travellers under the VTLs are not subject to stay-home notice on arrival. Instead, they will be required to produce a negative pre-departure test taken within two days prior to departure and undergo an on-arrival PCR test.

Since India has started recognising vaccination certificates issued by Singapore. This means that fully vaccinated travellers from Singapore entering India will no longer need to undergo post-arrival tests home quarantine, they will just need to self-monitor for 14 days upon arrival. Last month, Singapore

began allowing the entry of travellers from six countries, including India. However, travellers will be subjected to the tightest of border measures, which involve a 10-day, stay-home notice period at a dedicated facility. "All travellers with a 14-day travel history to Bangladesh, India, Myanmar, Nepal, Pakistan and Sri Lanka will be allowed to enter or transit through Singapore from October 26," it

Hyderpora encounter under scanner

The counter terrorist operation conducted by the joint team of security forces at Hyderpora bypass in which one foreign terrorist was neutralised along with his local associate from Ramban late Monday evening has come under the scanner.

The family members of two local businessmen, also killed during the operation, Tuesday leveled serious allegations claiming the security forces killed their loved ones in cold blood and used one of the slain businessmen as a 'human shield' during the operation.

The family members also demanded their dead bodies but the local police authorities refused to hand over the same fearing law and order problem in the area. The final burial was organised by the police in the wee hours in a graveyard located in Handwara.

Rebutting these allegations, Inspector General of Police, Kashmir range Vijay Kumar in a press conference on Tuesday claimed one of the businessmen identified as Altaf Ahmad Bhat was killed in the crossfire while another doctor turned builder, identified as Mudasir Gull, working as an Over Ground Worker and harbouring terrorists in the area, succumbed to his bullet injuries after the encounter.

Reacting to the Hyderpora encounter, GOC 15 Corps Lieutenant General D P Pandey Tuesday said that Dr Mudasir, killed in the operation, was operating a fake unauthorised call centre. He further said that the security forces would not allow white-collar terrorism to prevail in J&K. "People must identify and question such elements which act behind to recruit and fund terrorism, he asserted.

Vijay Kumar also claimed "It is not sure whether the owner of a commercial complex Altaf Bhat, was hit by the terrorists' or the security forces' bullet. Terrorists were carrying pistols. The cause of the death would be clear after investigation. Referring to activities of Mudasir Kumar said he may have provided shelter to a foreign terrorist identified as Haider and his associates in the commercial complex. "He was harbouring and ferrying terrorists. Mudasir was also involved in ferrying



Haider from the site of the attack at Jamalata Srinagar, where a policeman was injured after a bullet hit him in the neck. He was an overground worker and was directly involved in harbouring terrorists", Kumar added.

Following these allegations several Kashmir based political parties, including the National Conference (NC), Peoples Democratic Party (PDP), CPI(M) and the Peoples Conference, demanded an independent judicial probe into the incident.

"Using innocent civilians as human shields, getting them killed in cross-firing and then conveniently labelling them as OGWs is part of the Government of India's rulebook now. Imperative that a credible judicial enquiry is done to bring out the truth & put an end to this rampant culture of impunity," former Chief Minister and PDP Chief Mehbooba Mufti tweeted. Former Chief Minister and NC leader Omar Abdullah demanded "an impartial and credible inquiry". "There are far too many questions being raised about the encounter and about the people killed. There have been numerous instances of fake encounters in the past and the questions raised about this encounter need to be answered swiftly and in a credible manner," he remarked.

Police also constituted a special investigation team (SIT), headed by a Deputy Inspector General (DIG) of Police. Kumar said, "SIT would probe the modus operandi of the hi-tech hideout at Hyderpora. "It will investigate the sequence of events and if the mobile phones and computers recovered from the encounter site had links with foreign countries, including the US".

Two pistols, two magazines, half a dozen mobile phones and a few computers were recovered at the encounter

border row in six areas by year-end Meghalaya on Tuesday announced that necessary measures would be taken to settle interstate border disputes in at least six areas by the end of this Addressing a joint press conference here, Assam Chief

Minister Himanta Biswa Sarma and his Meghalaya counterpart Conrad Sangma said border committees set up earlier to hammer out solutions will submit their reports by November "The committees will pre-

sent reports by November 30 before their respective state governments, which will then talk to all stakeholders. After that, a clear picture will emerge and a final statement will be issued," Sangma said. Three committees each

were formed by the Assam and Meghalaya governments in August after two rounds of talks between Sarma and Sangma over border disputes and their likely solutions.

Of the 12 points of dispute between the two states, six areas with relatively less critical differences have been taken up in the first phase, while the remaining locations will be attended to later.

"Going by the spirit and pace, we are looking to issue a final statement on these six areas by December 30," Sarma said, adding that the entire exercise is being monitored by Prime Minister Narendra Modi and the Union Home Minister Amit Shah. The two states will be

receiving guidance from the PM and the home minister before the final statement is issued, he underlined. The Assam CM fur-

ther said if conclusions are arrived at with regard to some of the disputed locations that are being taken up, the statement will be issued only on while discussions on the remaining sites will continue.

Assam, Meghalaya look to solve inter-State

The six disputed areas that will be attended to in the first phase fall under Kamrup, Kamrup Metropolitan and Hailakandi districts on the

Assam side, he added. Asked if the Meghalaya Government will try to resolve the disputes before next year's state elections, Sangma refused to set a timeline, but expressed confidence that solutions will emerge in most areas.

"It will be a huge achievement if we can do it before the elections, but I cannot comment about it at this moment. It is a challenging and sensitive issue. The people have bestowed a great responsibility on us. We will try and find solutions at the earliest," he maintained.

Both the chief ministers. however, said that much depends on the committees' reports, which will state if the boundary needs to be redrawn or simple clarifications will

"Redrawing of boundaries will require Parliament's intervention. We are trying to get clarity... Understand which area belongs to which side," Sangma

Backing his Meghalaya counterpart's statement, the Assam CM said, "To alter the boundary, Parliament's boundary, approval is necessary. Clarification (of borders), however, can be done by the states.' A decision on any actual change in the interstate boundary will depend on the "contour of the final statement", he added.

Sarma and Sangma visited Langpih or Lower Lumpi earlier in the day, with the Meghalaya leader describing the event as a "historic one" as it is for the first time that the chief ministers of the two states toured a disputed area together and interacted with people He also said that the "will of the people" will be among the important aspects that will be taken into consideration by the committees before making final recom-

mendations. "This was a long-pending visit. We went there and tried to give a message of positivity, friendship, goodwill and commitment to people on behalf of both the governments. We want to find an ami-

cable and long-lasting solution to the disputes," Sangma said. Sarma, on his part, maintained that Langpih is not among the six areas being pursued in the first phase, but t has been chosen for the joint visit as the states wanted to underscore that critical disputes in such areas can also be resolved with the right spirit.

Addressing the people of Lower Lumpi area, Sarma said that both the Governments have been making concerted efforts over the last six months to reach a mutually acceptable solution.

He said the two states have tentatively decided to Central implement Government schemes at Lumpi, with collective approaches by the deputy commissioners of Kamrup and West Khasi Hills districts, in consultation with public representatives of both sides.

"People living in the disputed border areas have immensely suffered in the last 50 years. Earlier, no government made such committed efforts for settling border disputes," Sarma added.

WB House passes resolution against extension of BSF's jurisdiction

Bengal became the second state after Punjab to pass resolution against what the ruling Trinamool Congress termed the BJP's "ravenous intention to grab Bengal via backdoor" by expanding the jurisdiction of the Border Security Force to 50 km from the previous 15 km into the international border. The House passed the resolu-

tion --- demanding the withdrawal of the notification by the Union Home Ministry extending the BSF's area of functioning --- with 121 Trinamool Congress members supporting it. BJP's 63 legislators opposed the resolution which said that the notification exceeded the provision of the BSF Act and that it would lead to coordination issues between the State police and

Bengal Parliamentary Affairs Minister Partha Chatterjee moved the resolution under rule 169 of conduct of business of the House. Later he told the media persons that the Trinamool Congress Government would always stand against any attempt by the Centre to destroy the country's federal prin-

He said, "in a federal structure the law and order is a State subject ... the police are responsible for maintaining law and order ... any decision to alter the status requires consent of the State Government ... but in this case the State Governments were kept in the dark and the BSF was given additional area without consulting the State Governments... If the notification is implemented, then 11 districts and 37 % of territory of the State will pass under the hands of

the Centre." He however said that the TMC had nothing against the BSF which did its duty in most patriotic manner. "We are protesting against the Centre's move to usurp power through backdoor," he said adding however that the State Government did not see it as a conspiracy against the State. He said "as the BJP could not grab power despite massive campaign ... as they were defeated badly in Bengal ... they are now trying to grab power by using the BSF which is controlled by the

The other two opposition parties Left and Congress which do not have any representation in the State Assembly too supported the TMC on the issue. Earlier on Monday Left Front chairman Biman Bose, wrote a letter to Chief Minister Mamata Banerjee asking her to oppose New

Delhi's "anti-federal "move. He called the Centre's notification an act that went against the federal structure. Pradesh Congress president Adhir Ranjan Chowdhury also opposed the notification.

State Opposing Leader Suvendu Adhikari however attacked the TMC leadership for "attacking the central para-military forces in most filthy manner... The BSF protects the country from the terrorists and foreign enemy so that we can sleep in peace but here this crooked Government and its leaders attacks the martyrrs using most unkind and filthy words against them," he said.

"Some leaders even said that the BSF in the border misbehave with women and even touch them inappropriately ... I wonder whether such words have been expunged the TMC-turned-BJP leader said adding he proposed an amendment seeking expansion of the BSF's jurisdiction from 50 lm to 80

"I said that the BSF's jurisdiction should be expanded to 80 kms and I will appeal to the Centre to consider the proposal seriously," he said adding at a time when Rohingyas had entered the State and terrorists were mushrooming the BSF should be given added power.

Zakia Jafri to SC: Stark collaboration between political class, bureaucracy and others during riots

Sibal told the bench that there are "glaring instances of collaboration" which are borne out from records but the SIT did not investigate on the alleged larger conspiracy

"So far as your grievance about collaboration of local police at the ground level, we can understand that and we will look into it. How can you say that about the SIT which was appointed by the court," the bench, also comprising Justices Dinesh Maheshwari and C T Ravikumar, asked Sibal. The bench asked Sibal whether the petitioner is "attacking" the manner of investigation done by the SIT. The senior advocate said, "Yes. That is

something which troubles me."

The bench then observed, "How can you attribute motives to the SIT? It is the same SIT which filed charge sheets and people were convicted. No such grievance was made in such cases and you appreciated the work done by the SIT in those cases.

"The expression 'collaboration' is a very strong term for an SIT constituted by this Sibal said grievances were raised also in the cases where charge sheets were filed and the records show collaboration of the state machinery. "I will demonstrate that after that national tragedy on Sabarmati Express, what happened was that instead of investigating the perpetrators of the crime, the investigators actually became collaborators to the crime. It is not that the entire police machinery was collaborating," Sibal said.

"There are glaring instances of collaboration that is borne out from the records. The bureaucracy, political class, VHP, RSS and others became collaborators. There was stark collaboration," he told the bench.

The SIT had the knowledge of a sting operation, which was used in another riots case in which accused were convicted, but they did not probe those people, Sibal said and asked whether the SIT was saving **PTI** | those persons.

Shah behind fall of Cong Govt in MP, tried to do it in Rajasthan: Gehlot

R ajasthan Chief Minister Ashok Gehlot on Tuesday accused Union Home Minister Amit Shah of being involved in the fall of Congress Government in Madhya Pradesh but failing to do it in Rajasthan last Gehlot made the allegation while referring to the

crisis over the stability of his Government in 2020 and said the Congress MLAs stayed in hotels for a long time but "the present government is in place only with the blessings of the people". "The Home Minister could not do anything," said

Gehlot, without naming Shah.

Gehlot who is himself battling an internal party feud led bs his former deputy Sachin Pilot for last one and a half years, said the Home Minister had a lot of arrogance over Madhya Pradesh but the people of Rajasthan shattered his arrogance.

"Is it a way to act in a democracy—bringing down governments?' he asked.

"In which direction the country is going? Nobody knows. Today the Constitution and democracy are in danger. The situation is very serious. Every person will have to think," the Chief Minister added.

Gehlot made the remarks while addressing a statelevel teacher award ceremony at Birla Auditorium in Jaipur. The Chief Minister also targeted the Centre over the rising prices of petrol and diesel.

He said when the Manmohan Singh-led UPA government was at the Centre, it did not allow the fuel prices to rise and kept its prices under check despite high crude oil prices in the international market.

But under the current NDA Government, the prices of oil and diesel have increased rapidly despite crude oil prices falling heavily in the international mar-And for the state's reluctance to cut down the VAT

on fuels despite the Centre slashing excise on diesel and petrol by ₹10 and ₹5 respectively, he cited the fall in the state's share of revenue due to the Centre's cutting down the fuel prices. "Now when the Centre has reduced the petrol and

diesel by ₹ 5 and ₹10, the revenue of the state gov-

ernment has automatically reduced by Rs 1,800 crore in the same proportion," said Gehlot. "Now we have demanded from the Centre that if inflation is to be reduced, you should reduce fuel prices by ₹10 and ₹15 more. They are making states com-

pete amongst themselves," he added. "So far, about one lakh government jobs have been given in Rajasthan and the process of giving about jobs is going on,"

Malik links Wankhede, Fashion TV head Kashiff with Russian drug mafia operating in Goa

TN RAGHUNATHA MUMBAI

In a sensational allegation, Maharashtra Minister and senior NCP leader Nawab Malik on Tuesday linked Mumbai Zonal head of Narcotics Control Bureau (NCB) Sameer Wankhede and Fashion TV head Kashiff Khan with the Russian drug mafia operating in Goa and that Kashif was "managing the show" on behalf of Wankhede there.

"Everyone knows, drug tourism is flourishing in Goa. The Russian mafia is running a drug business in Goa and Kashiff Khan is managing the show on behalf of Wankhede. Why was Kashiff Khan not detained? Why was his phone not checked? Why was he allowed to board the (Goa-bound) Cordelia Cruise. Wankhede has to answer all these questions," Malik said.

Malik was addressing a news conference here after he shared on his official twitter handle purported screenshots of WhatsApp chats between K P Gosavi and an informer from Delhi and alleged that they were planning to trap people who were going to attend the party on the Cordelia cruise ship.

"I have shared whatsapp chats between K P Gosavi and an informer from Delhi. He has given some names and photographs. On the basis of names and photographs, people (Aryan Khan and others) were detained. In those whatsapp chats where there were two names, Kashif Khan being one of the names. His photograph was also shared," Malik said. "Why was he (Kashiff Khan)

allowed to enjoy the party on the cruise. He is the main kingpin of the entire party. He had sponsored the party. He is in Goa today. There is a relation between Wankhede and Kashiff. There are lots of cases filed against Kashiff in the country. He is absconding from a court order. Why was Kashiff Khan not detained? Why was he allowed to board the cruise?. He (Kashiff Khan) runs the show on behalf of Wankhede in Goa," Malik said.

"There is a person named White Dubai, who runs the drug

racket in the country. I will talk about him in the coming days. The names of White Dubai and Kashiff Khan figure in Gosavi's whatsapp chat. The photographs of Kashiff Khan and White Dubai, Wankhede allowed the two to board the cruise. The drug went for two days on the cruise. Kashiff and White Dubai were behind the party. Even after their return, Kashiff and White Dubai were given safe passage," Malik alleged.

"Here are whatsapp chats between K P Gosavi and an informer which shows how they were planning to trap people who were going to attend the party on the Cordelia Cruise. This is Sameer Dawood Wankhede's private army therefore he has a lot to answer Malik had earlier tweeted.

"Re- posting the whatsapp chats between K P Gosavi and an informer for those doubting the authenticity of the same. K P Gosavi's number is visible here and open to verification, he is currentin the custody of Pune Police," Malik said in another tweet. Bollywood superstar Shah

Rukh Khan's son Aryan and seven others initially detained on the night of October 2 and later arrested on October 3, after the NCB officials busted a rave party and seized 13 grams of cocaine, 5 grams of MD (Mephedrone), 21 grams of Charas, 22 pills of MDMA (Ecstasy) and Rs 1.33 lakh in cash from Goa-bound Cordelia Cruises' Empress ship, off the Mumbai coast. Subsequently, 12 more persons were arrested in connection with the mid-sea rave party. It may be recalled that on October 25, 2021, the NCB had

ordered a vigilance inquiry against Wankhede after its Deputy Director-General, South West Region Mutha Ashok Jain submitted his report to the NCB headquarters saying among other things: ..As some of the contents of the affidavit relate to the vigilance matters, I am hereby forwarding the affidavit to the Director General of Narcotic Control Bureau and requesting for further action". A Special Investigation Team

(SIT), appointed by the NCB, is investigating the mid-sea drug bust case and five other cases "which have national and international ramifications".

The appointment of an SIT team comes in the wake of the NCB ordering vigilance probe into the "vigilance matters" relating to the ongoing investigations in the midsea drug bust case and summoning of Wankhede to its headquarters in the capital last week for a meeting with the top bosses. The two events were a fallout of the allegations made through an affidavit by "panch witness" Prabhakar R Sail - including the charge of Rs 8 crore extortion attempt -- in the mid-sea drug bust case.

What has embarrassed most is the manner in which is the fact that Bollywood superstar Shah Rukh's son Aryan and two other accused -- Arbaaz Merchant and Munmun Dhamecha - were granted bail by the Bombay High Court on October 28, while a special NDPS court granted bail to two accused ahead of the high court granting bail to Aryan and two and two others and it granted bail to nine others on October 30,

Pink ceiling

The Supreme Court collegium recommends Saurabh Kirpal's name as Delhi HC judge

ebastian Melmoth's was a life of misery that came to an end in a shabby Paris hotel in 1900. In his last years, Oscar Wilde could not survive the ignominy of being jailed for being gay in Victorian England. He fled to France at the end of a two-year rigorous jail term for being unnatural with his sexual preference. To escape being jeered when recognised, he changed his name. Homosexuality took everything away from him; the Victorian era purred in insolence. It is the era that is no longer with us today, but homosexuality is as normal as heterosexuality or queerdom. We have come a long, long way from not just that dark British period but our own skewed times that till 2018, when the Supreme Court of India read down Section 377 of the Indian Penal Code, criminalised homosexuality. Considering the United Kingdom decriminalised homosexual acts only in 1967, the



spirit of the Anglo-Irish playwright would have had to wait for over six decades after his death to heave a sigh of sexual relief. In that sense, the decision of the Supreme Court collegium to elevate Senior Advocate Saurabh Kirpal as a judge of the Delhi High Court comes barely three years after the quashing of Section 377 and marks the first act of the higher judiciary breaking the pink glass ceiling.

If the recommendation is approved, it is not that Kirpal will become the first gay judge of a High Court in India. Rather, the judiciary would in all wisdom have opened the doors to welcome a gay judge.

Kirpal comes from a distinguished family, his father having been the Chief Justice of India. From St Stephen's, he went to read law in Oxford. He completed his masters in law from Cambridge. He has specialised in civil, commercial and constitutional law. He is openly homosexual and speaks for LGBTQ rights. He was among the team of lawyers who worked on the landmark Navtej Singh Johar case that led to the Supreme Court decriminalising homosexuality. Kirpal has two peers in the UK. It was only in 2002 that the Britons appointed the first openly gay judge, Sir Adrian Fulford, to the High Court. Four years later came the turn of another openly gay judge, Sir Terence Etherton, to join him on the Bench. Kirpal was once quoted about the importance of a gay judge in India: "If there was a member of the LGBTQIA community on the Bench...[but also] for that young, gay child or that young trans child in school, there would be a feeling that they, too, could reach great heights.' For those who still believe being gay is sin, let us hear from Wilde: "...such a great affection of an elder for a younger man...such as Plato made the very basis of his philosophy.... It is that deep, spiritual affection that is as pure as it is perfect.... There is nothing unnatural about it."

The Govts are making tall claims without taking into account the ground reality

head of the scheduled hearing in the Supreme Court later today in the matter of toxic smog enveloping the Delhi-NCR, which comes soon after the apex court came down heavily on the Centre and the Delhi Governments for their lax and callous attitude in handling the health emergency, there are a few points worth a relook. To begin with, as per the Centre's own admission, stubble burning accounts for only four per cent of Delhi's air pollution in winters and seven per cent in summers. So why was this bogy raised pertaining to the upward spiral in pollution levels in Delhi and nearby States of Punjab and Rajasthan? Was it simply because these States are ruled by the Opposition parties, or was it a ruse to direct the suffering people's ire



towards the farming community that has been at loggerheads with the Centre's three "flawed" and "biased" farm laws, and 'fix' it? Any which way, the Centre's bluff has been called. Now, the role of the biggest stakeholder in the matter who has been making a lot of empty noise while being in the lookingbusy-doing-nothing mode, the Kejriwal-led Delhi Government, has also been exposed as sham.

The city Government had told the top court that it is ready to take steps such as "complete lockdown to control local emissions" contributing to Delhi's polluted air. It conveniently overlooked the harsh truth

of lakhs of daily-wagers who are still reeling under the aftereffects of the previous lockdown in which they lost their jobs as well as meagre savings. Instead of advocating such extreme measures, it should have diligently taken simpler steps to ensure that the marketplaces are not taken over by enthusiastic shoppers, their masks hanging loosely around their necks, assiduously hunting for items in the ongoing festive season. The pressure of the footfalls was such that sanitiser in bottles frequently evaporated at various sales departments; there certainly was no longer any worthwhile stress on its usage. The Government shut schools and instructed offices to allow employees to work from home but many workers don't have that privilege. For the thousands of sales and delivery agents, daily labourers and marketing executives, the stay-athome advisories hardly mean anything. The Delhi Government is barking up the wrong tree by extending deadwood campaigns such as 'Red Light On, Gaadi Off'. It's high time it drew up scientific plans to tame pollution and implemented these to the 'T'.

India-Maldives ties are still quite fragile

aldives is the world's ninth smallest country at 90,000 sq km, geographically dispersed with four lakh people inhabiting 200 of its 1,192 islands, with some used for agriculture and tourism. Its pivotal location in Channel 8 enables command over shipping routes from the Gulfs of Aden and Hormuz to Malacca Straits. Maldives belongs to the Sunni Shafi school wherein Islam is central and laws based on Shariah. It has the dubious distinction of having exported per capita highest numbers of Maldivians to the Islamic State (IS) in Iraq and Syria but all are believed to be dead. The IS's front organisation, Idharaa Khidmat-e-Khalq, established a toehold and sleepers might still be there. Its economy is tourism-based, contributing 56 per cent of the GDP.

Maldives follows an 'India First' policy since 2018 before it was considered 'lost to China'. Beijing is still heavily invested in Maldives and owns Finalu island, where it is building hotels. Former President Abdullah Yameen had changed the Constitution for this. Maldives signed the first FTA with China and owes it \$1.4bn. Beijing is on the lookout for atolls — where Chinese expertise in land reclamation adds to space for strategic posts. China's String of Pearls was effectively demonstrated in Maldives as was the extension of Maritime Silk Route. It was due to Chinese pressure that India's GMR contract for building Male airport was can-celled. The contract was given by President Nasheed of Maldivian Democratic Party, which tilts towards India. But China has a strong base among the Opposition parties.

Internal developments will determine whether Maldives will be China or India First. While Yameen is in jail for corruption, the main Opposition Progressive Party of Maldives has been taunting MDP's president Solih for "selling" Maldives to India and started an 'India Out' campaign. The rift between Solih and Nasheed is a power struggle as the latter returned last month from Berlin and London after treatment fol- PLOTE mercenaries seizing lowing a terrorist assassination Male, New Delhi being the first

attempt. Nasheed, who has asked Solih to 'course correct' before it is too late following his pandering to religious extremism, has also been advocating the parliamentary system. Unity within MDP (there were reports of a likely split) will influence the outcome of the September 2023 elections.

The Opposition has been attacking the Government for allowing India a consulate in Addu atoll, calling it a possible "safehouse for Indian spies". India's refusal to take back two Dhruv helicopters based in Addu had caused an outcry. Addu is the second largest city with a population of 30,000 and a strategic outpost. Maldivian sensitivities on India's presence are interpreted as boots on the ground. The decision on Addu Consulate appearing in Indian media first also irked Maldivians. India is building a police training facility and Coast Guard harbour. The Government does not share details of agreements with India, citing national security. The 'India First' policy has led to anti-India rhetoric and even a threat to blast the Indian High Commission.

The India-Maldives relations are ancient with ups and downs. India's Operation Cactus (1988) to prevent

responder during tsunami 2004, Indian naval ships providing drinking water during the water crisis of 2014 and ongoing medical and vaccine supplies during the pandemic are some highlights. Nearly 85 per cent of the population is now double-jabbed. India has become the biggest donor with projects worth \$800mn being implemented across 34 islands. Total investment is now valued at a significant \$1.3bn. The Greater Male Connectivity project is the largest-ever Îndian enterprise in Maldives. It consists of a 6.4km bridge and causeway which will connect three populated islands. An air bubble has been created between the countries, involving 60 direct flights from five cities with Indian tourists being maximum and Chinese nearly zero. This has boosted receipts by 104.5 per cent after COVID had contracted the economy by 33.2 per cent.

Defence cooperation is central to bilateral relations. Political uncertainty in an environment of religious extremism will likely breed radicalisation. Arms and drugs smuggling, terrorism, piracy and environmental fragility are threats. Besides signing defence protocols with India, Maldives recently committed to the US and Japan for the Maritime Research and Coordination Integrated Defence Staff. The Centre. The India-Maldives-Sri

Lanka maritime pact will soon include Mauritius, Seychelles and Bangladesh. Indian Dorniers, Dhruv helicopters and coastal radars are suitably located for surveillance and maritime rescue operations. Maldivian military personnel train in India. Maldives recently hosted the Indo-Pacific Íntelligence Conference with US Pacific Command and was attended by 17 countries where Maldivian Chief of Defence Forces, Maj Gen Abdulla Shamal, praised India for providing assistance and expertise to meet military challenges, including non-traditional ones. A Maldivian officer is now posted at the Maritime Fusion Centre in Gurgaon. Interestingly, India has submitted a DPR on the erstwhile British strategic base at Gan island that the Chinese have

been eyeing for long.
After being edged out by China, India is back in business. But the situation is fluid due to political dynamics and religious extremism. India has to play its cards carefully to maintain its primacy in the face of Maldivian Opposition and Chinese opportunism.

NOT MANY OPTIONS TO CURB POLLUTION

Sir — It is laudable that the Supreme Court suo motu intervened in Delĥi's air pollution issue and expressed displeasure on the administration's handling of the pollution crisis. Unfortunately, it is to be realised that only when courts intervene on different issues the respective administrations start to act. All along, the Delhi Government was stating that stubble burning in Haryana, Chandigarh, UP and Punjab is one of the main causes of air pollution in Delhi and did not take concrete steps to prevent the air getting worse year by year. Meanwhile, the Centre has stated that stubble burning contributes only about 10 per cent to air pollution and there were other major causes such as construction activities, vehicular and industrial smoke etc.

The Delhi Government, of course, regulated traffic movement with its odd-even scheme but it did not serve the best purpose anticipated. The Delhi administration should immediately implement a ban on construction activities, reduce vehicles and suspend operation of unnecessary industries for a week to bring the air quality back to normal. It is high time that the Central Government works out modalities. If there can be an alternative second Capital in the southern part of the country, it will be of immense help in reducing pollution in Delhi, given the limited options we have.

WHY SHED TEARS FOR **TAX-DODGING SECTOR?**

A large segment of the informal sector can remain legitimately out of the tax net

he anniversary of demonetisation has prompted several analysts to assess its impact and outcome in the last five years. There is little disagreement about the short-term disruption of economic activities in the cash-dependent informal sector but opinions about the disruption continuing are sharply divided. Here is an attempt to make sense of the debate with facts and figures. Fresh currency that has come out in circulation since 2016 is much more than the money deposited in bank accounts post-demonetisation of 1000/500 notes. According to latest data from the Reserve Bank of India, 'Currency in Circulation' increased from ₹17.97 lakh crore on November 4, 2016 to ₹29.89 lakh crore on 5th November, 2021. 'Currency with the Public' increased from ₹17.01 lakh crore on Oct 28, 2016 to ₹28.26 lakh crore on Oct 22, 2021. ('Currency with public' is arrived at after deducting cash with banks from total currency in circulation.) Cash with public has shot up 211 per cent from ₹9.11 lakh crore since November 25, 2016. In value terms, the share of ₹500 and ₹2,000 banknotes together accounted for 85.7 per cent of the total value of banknotes in circulation as on March 31, 2021,



as against 83.4 per cent as on March 31, 2020. Printing of ₹2,000 notes has stopped in 2018-19.

If cash is back and has increased from ₹18 lakh crore to ₹30 lakh crore then who is holding this cash? During Demo, banks would have given back money to the person who brought it to them. So, whosoever offered cash got it back. Many people acted as cash mules for others so they must have got a cut in illegal note swap. The net result is that most people have got their money back while some poorer people would have got even extra income in the process. GST subsumes excise duty, sales tax, VAT, Service Tax etc. There were about 72 lakh registered tax payers in pre-GST regime under the taxes subsumed in GST but now GST has about 132 lakh registered tax payers despite change in registration norms leaving many earlier registered being exempt from GST registration. As many as 76.61 crore returns have been filed. So obviously many erstwhile informal sector producers and service providers are now formalised. This formal economy is producing everything that is needed by all consumers whether in formal or informal sector. So, if GST is picking up, it shows consumer demand picking up across all segments of consumers. As the GST registration data shows, formal sector is getting bigger, acquiring scale, acquiring market share and becoming richer. This is undeniable and desirable. This is incentive for formalisation. Why have grudge against it? All informal sector producers and service producers have standing invitation to resort to digital payments, build their sales profile, access formal credit from banks and digital lending startups, pay taxes and be counted as formal. A large segment of the informal sector can remain legitimately out of tax net because of exemption limits. If they are still dependent on cash, the only adverse inference is that they want to remain within exemption limits by resorting to cash sales. Any adverse plight of informal sector producers is the combined and cumulative effect of measures against tax Dodgers including Demo and GST. Once we accept black money as tax-evaded income, we would not shed tears for cash sale dependent, taxdodging informal sector producers.

The Manipur attack calls for recalibration



Such incidents in the Northeast are recurring with not only astonishing regularity, but also with the barbarity that separatists are able to muster

t has happened again. The doggedness with which insurgents from Myanmar have been targeting the security forces in Manipur has become almost a feature happening with uncanny consistency. If it was Sajik Tampak on June 4, 2014, when soldiers of the 6 Dogras were ambushed in the Sajik Tampak region of Manipur's Chandel district, it is the Commanding Officer of 46 Assam Rifles in the same state's Churachandpur district this time around.

The only brazen variation was that this time the militants did not even spare noncombatants including the wife and nineyear-old son of Col Viplav Tripathi, a progression in non-state action that is gradually approximating the methodology of terrorism. After all, even when United Liberation Front of Asom's sophisticated "Programmable Time Delay Device" killed innocent children on 15 August, 2004, in Dhemaji, post hoc analysis determined that it was clearly a mistake and later there was both penitence and punishment (for the perpetrators) by the ULFA leadership with Paresh Baruah apologising for the mistake on 13 December, 2009.

The NSCN, too, have never targeted non-combatants and there are anecdotal accounts that the organisation treated Sunday as a "Day of Forgiveness". But for all the unwritten ethical conduct of the past the contours of North East insurgency - hijacked by anti-India chaperons — is fast changing and the fact of the matter is that such incidents are beginning to recur with not only astonishing regularity, but also with all the barbarity that they are able to muster.

What can the Indian state do at this hour of darkness? It would probably send out twitters of defiance and censure, condole the action and then contemplate "surgical strikes" by which to erect yet another "blockbuster" in order to inform a beleaguered nation that "revenge had been sweet." Unfortunately, even the possibility of such reprisals has to a considerable extent been negated. Even when Aung San Suu Kyi was the State Counsellor of Myanmar she had cautioned the Indian government that she would not accept a repeat of New Delhi's chest-thumping violation of her country's ter-

Today, when democracy has been usurped by a stratocracy and New Delhi oping around for a Myanmar polic that is not only ambiguous, but fraught with grave security risks, the possibility of a hot pursuit policy into the safe havens of the Valley Based Insurgent Groups (VBIGs) in the country's Sagaing Division is next to impossible. In any event, even if there were to be yet another "surgical strike" against the perpetrators, the only message that would be relayed is to the electorate in Lucknow or Varanasi. It would neither bring back the blameless son of Col. Viplav Tripathi nor would it add to the morale of a noble force that has

been-without fear or favour-carrying out its duties in hostile terrain. This is despite the fact that most thinking personnel of the Assam Rifles or the Indian army for the matter are aware that the mandarins in Raisina Hill have never pondered over an overarching policy for the "enchanted frontiers" that might prevent such continual acts of aggression from belliger-ence that high policy has failed to comprehend.

After all, the security scenario in India's North East has far from healthy. The complacence with which cessation of hostilities with NSCN (K) was abrogated, the consequence of which was the 2015 attack on the 6 Dogra bravehearts, the manner in which a plethora of VBIGs were "permitted" to come to an agreement with the Myanmar army after the February 1, 2021, military takeover and the now almost definite collusion between the Chinese Ministry of State Security and insurgent groups such as the Manipur's People's Liberation Army (the insurgent outfit which is perhaps the likeliest of perpetrator of the November 13, 2021 ambush), point to not only failure of human intelligence (the most convenient casualty in the aftermath of such incidents), but the inability of New Delhi to grasp the realities of nonstate action in the North East which in some ways is far more serious than the ongoing one in Kashmir. For one, there are few rabidly anti-India, pro-Chinese representatives in the Indian

of the PLA (Manipur) and it is he who could be the person who planned the attack on 46 Assam Rifles alongside his Chinese min-

The most important reason is New Delhi's inability to match short-term goals with long-term imperatives. Counter operations, for instance, by their very definition play black — a disadvantage that determines its response. But as any sound chess player will surmise, advantages can easily be engineered after opening gambits have been traded. Unfortunately, for the North East, this has not been perceived as a possibility. Non-sensitive solutions that do not look beyond the immediately conceivable, non-comprehension of the dynamics that govern the North Eastern mind and the failure to set into action methodologies that are more than stimulus response are responsible for the ailments that continue to beleaguer

the enchanted frontiers But what should be the way ahead? As avid observers of the North East, the author has always felt that there should be a separate policy-making body for the region. Polemics apart, brass tacks demand that such an arrangement needs to be anvilled immediately. The vastness of India's landscape and responsibility has not quite provided adequate attention to the region, which is not to suggest that the frontiers have been

consigned to the flames of anonymity by New Delhi. In all probability it has not applied sufficient cerebration for the construction of a comprehensive structure that would resolutely attend to the essentials of the

The need of the hour is, therefore, the constitution of a North East Security Council under the Ministry of Home Affairs, which in its wider ambit would not only address traditional security issues like border management, illegal migration, drug-gun running, insurgency, Islamist terror, human and energy security (the listing above not being all-inclusive), but also development which is an important factor of security.

The formation of such a council would also decisively inform the expanse that makes up the North East that New Delhi is serious about the region's health. Indeed, the author had taken up the issue of the constitution of such a Council even when the Bharatiya Janata Party was not in ower. A robust blueprint had been drawn up and presented to the leaders of the dispensation inwaiting. But nothing was done. The untimely death of Col. Viplav Tripathi, his family and the soldiers of 46 Assam Rifles in Manipur by marauders who have not been able to be brought to heel would perhaps prod New Delhi onto serious introspection and even consideration of what is being recommended by way of a North East Security Council.

right now, India is facing a lull. The pandemic attack has hit over 220 countries and territories since 2020 January. The virus had infected almost 252 million people worldwide, and the number of deaths had reached five million. The most severely affected countries include the US,

Brazil, and India. India's first cases appeared in late January 2020 when three Indian students travelled to the southern state of Kerala

from Wuhan in China. According to the health ministry, there was a total of 3,44,37,307 cases in India and total deaths were 4,63,530

Health experts say that COVID-19 will not go away, and we have to live with it. They also predicted that the present lull could be the calm before the storm and a third wave is a distinct possibility. The national curve seems to have entered a declining phase now, after having peaked on May 6.

However, "We cannot take the current stable situation for granted, and we have to be mindful of the fact that the pandemic is going on and can take an untoward turn if we are not careful," Niti Ayog member Paul has cautioned.

Hospital admissions for Covid-19 patients rose 12% and admissions to intensive care units by 3%, it said.

US expresses 'concern' over delivery of Russia's S-400 system to India

The US has expressed its "concern" over the delivery of S-400 Triumf surface-to-air missile systems from Russia to India but it remains undecided on how to deal with the transaction, a senior Pentagon official said. The S-400 is known as Russia's most advanced long-range surfaceto-air missile defence system.

Though there is no official comment by the Indian Air Force on the deliveries, Russia's Director of the Federal Service Military-Technical Cooperation (FSMTC) Dmitry Shugaev told Sputnik news agency last week that the deliv-

Myanmar poll body charges electoral fraud

Bangkok: Myanmar's state election commission announced it is prosecuting the country's ousted leader, Aung San Suu Kyi, and 15 other senior political figures for alleged fraud in last November's general election. The announcement was published Tuesday in the state-run *Global New Light* of Myanmar newspaper and other official media.

Allegations of widespread electoral fraud were the main reason cited by the military for its Feb. 1 seizure of power that toppled Suu Kyi's government. Her National League for Democracy party was about to begin a second five-year term in office after its landslide victory in the polls. The armybacked Union Solidarity and Development Party suffered unexpectedly heavy losses.

Independent observers, such as the Asian Network for Free Elections, found no evidence of substantive irregularities in the polls, though they criticised some aspects. \overrightarrow{AP}

Two explosions rocked Uganda's capital, Kampala, early on Tuesday, killing at least three civilians in what police described as a coordinated attack by extremists.

Three suicide bombers also died in the blasts, police said. The explosions caused chaos in Kampala as terrified residents fled the city's center.

"The bomb threats are still active, especially from suicide attackers," police spokesman Fred Enanga said, blaming the blasts on the Allied Democratic Forces, an extremist group. The twin explosions

occurred within three minutes of each other. Both were carried out by attackers carrying explosives. A possible attack on a third target was foiled by police who pursued and disbomber, Enanga said.



Reliance Industries was the top loser in the Sensex pack, shedding 2.51 per cent. Among other losers, SBI sank 2.31 per cent, Ultratech Cement by 2.2 per cent, NTPC by 2.08 per cent and IndusInd by 1.8 per cent.

Pharma declined 1.63 per cent while Dr Reddy dropped 1.16 per cent. Private banks ICICI Bank and HDFC Bank fell 1.14 per cent and 0.61 per cent, respectively.

On the other hand, Maruti Suzuki soared over 7 per cent to become lead gainer among both Sensex and Nifty scrips. Mahindra & Mahindra rose by 3.44 per cent on BSE and over 2 per cent on NSE. Tech Mahindra, Bajaj Finance, Infosys and Bajaj Finsery also advanced.

Emotional and mental health of students, as well as teaching and non-teaching staff. has taken a toll in the pandemic, prompting institutes to come up with solutions to address this situation, says DR RICHA MISHRA



OVID-19 has had a continued toll on students' mental health due to a lack of physical accessibility to schools and colleges. With educational campuses closed, resources to manage mental health were also limited or unavailable, leading to a sense of confusion and uncertainty among students about their future. The lack of accessibility highlighted the need for educational institutes to prioritise how to care for student mental health both on and off-campus.

Positive thinking, effective coping strategies and remaining hopeful became challenging for school and college students due to the pervasive nature of the virus. The COVID-19 pandemic presented many challenges to educators and parents as well. Children already coping with mental health conditions have been especially vulnerable to the changes or the new normal after the COVID outbreak.

Closure of schools and colleges, physically distancing guidelines and isolation, and other unexpected changes exposed students to several insecurities. At such a time of distress, schools, colleges, and universities are addressing well-being in students with new and innovative

Effect of COVID-19 on mental health of students Be it, children, elderly or health professionals, every individual faced mental tension in COVID -induced lockdowns. School and college students experienced anxiety, distress, social isolation, and an abusive

environment. Difficulties with concentration Difficulties with concentration and attention, and unexpected headaches were also found among young students. As per some studies, post-traumatic stress disorder (PTSD) is closely related to depression and other psychological problems among students, the leading cause being COVID-19 recently.

In addition to this, lack of access

In addition to this, lack of access to friend groups, complete digital mode of learning and the various lockdowns affected the mental health of youth. Moreover, many students have been complaining that while education and training were given through digital mode, assessment of the same is being taken offline.

Most of the students have not been able to cope up with the education through online mode. Competitive exams added more pressure and anxiety, with young students dying by suicide. For example, Tamil Nadu saw several young students who died by suicide following the medical admission exam,

As per National Crime Records Bureau data, India has the highest rate of suicide in Southeast Asia, and

in 2019 alone, over 8,000 children between the ages of 14 and 18 died of suicide. It has further created an immediate challenge for schools, colleges, and policymakers to tackle depression and suicidal deaths among students.

Online classes and exams have
become the new norms for school
and college students. Although physical classes resumed after a long time earlier this year, schools and colleges were again closed after a more severe, second wave of the pandemic struck. The emotional and mental health of students, as well as the teaching and non-teaching staff, took a toll during the second wave of the pandemic, prompting educational institutes to come up with solutions to address the situation.

Many health experts have noted that concentrating on the mental health of children is more important rather than stressing them to do well in exams. This requires equal participation by parents and teachers. Apart from that, educational institutions should also help older students deal with the lack of surety in getting jobs and college admissions during the COVID-19 crisis.

Generally, students are not comfortable talking about their problems with their parents and professors. They feel that their problems can

only be understood by peers, but only be understood by peers, but their friends might end up giving them the wrong advice. Students at the age of 18- 25 face many issues like peer pressure of performing well on studies, looking attractive, drug abuse, harassment, family issues and some might have child-hood trauma

hood trauma.

While in India we do not have access to help for mental health, professional-level help at colleges can help the students cope up with their problems.

Students should also be kept apprised of the changes happening in the industry due to the pandemic, its impact and how to learn new skills and technology to be job-ready.

Adaptability, agility, and innovative thinking have emerged as key learning through these tough times, and they can help students to survive the pandemic ordeal. Regular webinars, talks, close group discussions and virtual one-on-ones have also helped students to gain a perspective and understand the situation better and deal better.

New realities of working from home and temporary unemploy-ment have made it difficult for parents to take care of their children, including young school and college students. A recent national survey showed that only 20% of school-aged children who were enrolled in the formal education system received remote education during COVID-19 induced school closures. School aged children were considered those between the ages

of 5 and 18. The survey was conducted by LIRNEasia, a regional think tank working on digital policy issues across the Asia Pacific, and ICRIER, a policy oriented economic policy think tank based out of New Delhi.

The 2021 survey showed that access to

ing in urban areas, from wealthier families, with more educated household heads, and in higher grades.

Many of the 20% who were able to access education during school closures did so through multiple channels. However, these students' experiences were heterogeneous. Only 55% of students (of this small group who received some education) participated in live (real time) online lessons, while 68% watched recorded video lessons and 75% had information and assignments communicated to their smartphones through channels such as WhatsApp. It is also noteworthy that

58% of these students also had contact with schools through offline channels, with information and assignments being physically delivered to their homes.

The other 80% of children, however, were left behind.

'The pandemic made the education gap worse, impacting students from disadvantaged households the most. But it wasn't just a connectivity problem - schools were caught off-guard and were not prepared to deliver online lessons in the first round of lockdowns. Luckily things did improve in the subsequent shut downs," says the CEO of LIRNEasia, Helani Galpaya.



¬he Common Admission Test (CAT) is a national-level examination conducted by The Indian Institute of Management. It is a mandatory exam for seeking admission into IIM or other prestigious B-schools. The exam is conducted annually in the last week of November. This year it is on November 28, 2021.

Almost two lakh aspirants appear for CAT every year and less than 2,000 aspirants score 99-plus percentile. This means that your preparation needs to be different to stand out and be in those 2000 candidates.

Over the years, it is observed that the people have the following strategies end up scoring 994 percentile.

BE FIRM ABOUT AIM

Since Day 1, be clear that your aim is scoring 99 percentile. Make up your mind of not settling even 0.1 percentile less than 99 percentile. Be firm and confident about yourself and just be optimistic that you can achieve it. Decide the IIM you want to get into and work towards scoring the percentile needed to get into the best IIM in the country.

PUSH YOUR LIMITS Work hard from the very

beginning. Go all out and study with all your heart. Solve a minimum of three-four mocks each day. While solving every mock, solve it like it is the actual CAT exam. After every mock check for the wrong answers and practice to not make the same mistakes. Push your limits and work as hard as you can. Work hard on the topics that you find tough. Keep practicing all the topics even the ones you are already good at. Be careful while solving each question and concentrate completely on it.

MAKE STRATEGIES

Study the exam pattern at first. Know how many questions you need to get right in each section to score 99 percentile. Try those strategies while practicing mocks. This will tell you which strategy is more accurate. Use the most tried and trusted strategy in the actual exam. A lot of time you will give to the section and how much maximum time you will spend on one question.

ANALYSE PERFORMANCE

After you practice, every time evaluate what you have done. Make a note of your mistakes. This will help you know which sections you are good at and which sections

need more practice.

Accordingly, try planning upon the questions you will prefer to attempt. This way you won't lose marks unnecessarily. Don't be overconfident about your strengths and don't be ignorant of your weaknesses. Strive hard to convert your weaknesses into strengths.

REMAIN CALM

TIME MANAGEMENT

Be quick with solving the problems. Don't waste much time on a particular question. If you are not sure about an answer, keep the question for later and solve it if you have time in the end. But while solving with speed, you cannot afford to make silly mistakes. Silly mistakes are a major reason for the low percentile. You need to be careful and alert with every question. Pakistan to host 2025 Champions Trophy

Messi, who has been bothered by a knee injury, will play in San Juan in a match that could earn the team a spot in next year's World Cup, Argentina coach Lionel Scaloni said Monday.

Hours later, the Brazilian Football Confederation said in a statement that Neymar "reported being insecure" about the possible injury.

"Because there's not enough time to perform more exams, the coaching staff decided to spare the player, who will not travel with the squad," the statement said.

Neymar's friend and rival, Messi, played only 15 minutes in Argentina's 1-0 victory over Uruguay on Friday. He also missed two Paris Saint-Germain matches because of the injury.

"A few days ago he was physically fit and at the end we decided that the best would be for him to play for a few minutes so he starts getting that good feeling," Scaloni

"For tomorrow (Tuesday), it is confirmed that he will play. We hope he finds himself in a good place.

The Argentines, second in the 10-team South American standings behind Brazil, can qualify with a victory. Brazil already has one of the four automatic qualifying spots from the region.

Brazil has not won in Argentina since 2009. Scaloni's main concern is in the midfield. Leonardo Paredes is recovering from an injury and could once again be replaced by Guido Rodríguez.

Beside Neymar, Brazil will be missing the suspended Casemiro, who could be replaced by Fabinho. Coach Tite also expects to test other players after beating Colombia 1-0, possibly using Matheus Cunha up front instead of Gabriel Jesus.
