Dissent notes over Data Bill

Several Opp MPs oppose it, report adopted 2 years after joint committee was formed

The Joint Committee of Parliament examining the Personal Data Protection Bill, 2019, has adopted its report on the Bill with several Opposition MPs, including those from the Congress, the TMC and the BJD, submitting their dissent notes. The report was adopted after almost two years of setting up of the joint panel, when the Bill was referred to it for further scrutiny and making recommendations.

It is learned that four MPs from the Congress and two from the Trinamool Congress and one from the Biju Janata opposed certain provisions of the panel's recommendations.

Congress leader and chief whip of the party in the Rajya Sabha Jairam Ramesh gave his dissent note to the committee on the Bill after the panel

adopted its report at its meeting here. The former Union Minister also lauded the democratic manner in which the panel functioned under PP Chaudhary's chairmanship for past four months. Besides Ramesh, Congress

MPs Manish Tewari, Gaurav Gogoi and Vivek Tankha submitted their dissent notes, along with TMC's Derek O'Brien and Mohua Moitra and BJD's Amar Patnaik. The report was delayed by

the panel as its former chairperson Meenakshi Lekhi was elevated as a Minister and Chaudhary was appointed as its new chairperson. The Bill was referred to the

JCP for scrutiny before it is taken up by Parliament for consideration and passage. Ramesh shared the information that the report has been adopted by the panel. "Finally, it is done... There are dissent notes



but that is in the best spirit of parliamentary democracy. Sadly, such examples are few and far between under the Modi regime," he said.

Ramesh said he was compelled to submit a detailed dissent note on the Bill as his suggestions were not accepted and he was unable to convince the members. "But that should not detract from the democratic manner in which the committee has functioned. Now, for the debate in Parliament,

he tweeted. Tewari and Gogoi also said

they had submitted their dissent notes to the Secretariat of the committee after the final meeting of the Joint Committee

on Data Protection. "We started in December 2019 and finished in November 2021," Tewari said.

"I have been constrained to submit a very detailed note of dissent since I do not agree with the fundamental design of proposed legislation. It will not stand the test of law," he said.

Tewari said his fundamental objection was that there is

an inherent design flaw in the bill's very construction. A Bill that seeks to provide blanket exemptions, either in perpetuity or even for a limited period, to the 'State' and its instrumentalities is ultra vires of the Fundamental Right to Privacy as laid down by a nine-judge bench of the Supreme Court, he said.

Tewari said he did not think the Bill in its present form, especially most of its exception and exemption clauses, including carve outs for governments that exempt these behemoths from the ambit of this legislation would stand the test of "vires" in a court of law.

"I, therefore, am constrained to holistically reject the Bill in its present form in entirety for this design flaw,"

On his reservations about the Bill that were part of his dissent note, Gogoi said there was a lack of attention being paid to harms arising from surveillance and an effort to establish a modern surveillance

Market in bear grip on farm reforms U-turn

Market benchmark Sensex crashed over 1,170 points to log its worst single-day drop in over seven months on Monday amid concerns over government's reform measures after farm laws repeal announcement and weak listing of country's largest fintech firm Paytm.

Extending its losses for the fourth straight session, the BSE gauge plunged 1,170.12 points or 1.96 per cent to settle the day at 58,465.89 — its lowest closing level in over two months. In terms of absolute single-session drop, this was the biggest fall since April 12 this year. Similarly, the NSE Nifty fell

348.25 points or 1.96 per cent to 17,416.55 — marking its lowest level seen after September 20.

Among top losers on the Sensex were, Bajaj Finance, Bajaj Finserv, Reliance Industries, NTPC, Titan and SBI - diving as much as 5.74 per cent.



Reliance Industries sank over 4 per cent, after the company shelved a proposed deal to sell a 20 per cent stake in its oil refinery and petrochemical business to Saudi Aramco for an asking of \$15 billion.

On the other hand, Bharti Airtel, Asian Paints and PowerGrid managed to clock gains.

One97 Communications, Paytm's parent firm, tumbled over 13 per cent to close at

1,360.30 a share on the BSE. Sectorally, BSE realty, energy, consumer durables, auto, oi

and gas, and finance indices fell up to 4.45 per cent, while telecom and metal indices ended with gains.

The repealing of the agriculture laws had an impact on the PSU stocks while the O2C deal not going through left a 4.5 per cent cut on Reliance,

The Central Consumer Protection Authority (CCPA) has issued notices to five e-commerce entities, as well as various sellers, for offering pressure cookers that are non-compliant with BIS norms. The notices were issued on November 18 to Flipkart, Amazon, Snapdeal, Shopclues, PaytmMall, and the sellers.

"CCPA has taken suomoto cognizance against e-



commerce entities found to be selling pressure cookers in violation to the Domestic Pressure Cooker (Quality Control) Order, 2020 issued by the Central Government under Section 16 (1) of the BIS Act, 2016 on 21st January 2020," the statement said on Monday. The notices were issued to both e-commerce entities as well as sellers of pressure cookers on those platforms. The notices were issued on November 18," officials said.

HC refuses to restrain Malik from sharing Wankhede info

Calcutta HC orders another **CBI** probe

In yet another embarrass-ment for the Bengal Government the Calcutta High Court on Monday directed a CBI probe into the alleged corruption in the recruitment of Group D staff by the School Service Commission.

Passing a strict order Justice Abhijit directed the CBI to investigate into the recommendation-based recruitment of 25 Group D staff and place a report by December 21. The probe could also take into its ambit the recruitment of another 500 employees who too had allegedly been appointed following recruitments from some shady quarters.

Éarlier the West Bengal

Board of Secondary Education in its affidavit told the High Court that it has provided appointment letters to the said employees only upon the recommendations of SSC.

Govt owes a lot more to farmers than half-baked apology, says Cong

Hitting out at the Centre, the Congress on Monday said it owes a lot more to the farmers of the country than a "half-baked apology" and the announcement that three "anti-farmer" laws would be repealed.

Every member of the Narendra Modi government must offer an "unreserved apology" to the farmers, to the people and to the nation, the opposition party said in a series of tweets.

The Congress' attack on the government came days after Prime Minister Narendra Modi announced the Centre's decision to repeal the three agriculture laws that had triggered year-long protests

Modi had also apologised to the people over his government not being able to "convince" a section of the farmers about the "truth" regarding the benefits

The Congress said after the "tragedy" that unfolded over the last one year, the government owes a lot more to "our farmers than a half-baked apology and claims of repealing the anti-farmer

Until Union Minister of State for Home Ajay Mishra is fired, the farmers will not have justice, the party added.

The minister's son, Ashish Mishra, is one of the accused in a case involving violence in Lakhimpur Kheri district of Uttar Pradesh, in which eight people including four farmers were killed.

"Day after day, state after state, they

brought out the full might of their police force, and for what end? To mercilessly beat peaceful farmers, protesting for their rights," the Congress wrote on Twitter, using the hashtag "DeshNahiBhulega" (the country will not forget).

"We haven't forgotten the vile and despicable words used against our farmers. Nothing this government does will make up for that," it said.

Meanwhile, citing a media report, Congress leader Rahul Gandhi targeted the government over alleged corruption in the transfer of money to Jan Dhan

"Kaun hai jo Jan ka Dhan 'khata' ja raha hai (Who is eating into people's money)?" he said in a tweet, using the

Pondy Govt seeks ₹300 cr from Centre as interim flood relief: CM

Puducherry Chief Minister N Rangasamy said here on Monday that he had written to Union Home Minister Amit Shah highlighting the havoc the recent flood caused in different sectors. including agriculture.

The Chief Minister told reporters after the inter-Ministerial team, deputed by the Centre to assess the damage in Puducherry and Karaikal, held discussions with him that he had sought Rs 300 crore as interim relief. He said Puducherry and Karaikal has had

unprecedented rainfall and as much as 7,000 hectares of paddy fields, horticulture crop and other farm produce have been affected.

Earlier, the team held discussions with the Puducherry Lieutenant Governor Tamilisai

ED attaches properties worth ₹42.36 cr of directors of Shree Mahalaxmi Corporation Pvt Ltd in bank fraud case

New Delhi: The Enforcement Directorate (ED) has provisionally attached 11 immovable properties worth ₹ 42.36 crore belonging to the directors of Shree Mahalaxmi Corporation Pvt. Ltd, a Kolkata based company, under the provisions of Prevention of Money Laundering Act (PMLA), in a bank fraud case.

The ED had initiated money laundering investigation on the basis of an FIR registered by CBI, Kolkata on March 28, 2017 and a chargesheet filed by the Central probe agency on December 30, 2019 under sections of Indian Penal Code (IPC) and Prevention of Corruption Act against the accused firm Shree Mahalaxmi Corporation Pvt. Ltd, its directors and others, for defrauding the State Bank of India (SBI) to the tune of

Aashish Jhunjhunwala, director of Ramsarup Industries, arrested in money laundering case

"Now, the Centre has to repeal the CAA as it is against the indigenous people of the Northeast. The AASU and North East Students' Organisation (NESO) are firm on our opposition to the CAA. It is related to the question of the identity of the people of the region," Bhattacharjya, also a NESO advisor, told PTI.

In response, Malik had on November 18 filed a detailed affidavit, challenging the maintainability of Sr Wankhede's suit. Among other things, Malik through his lawyer Arshad Shaikh

including caste certificate of 1974, passport and SLCs to show that the name of Wankhede's father was 'Dnyandev' and he belongs to the Mahar community. At the previous hearing, the

High Court had taken on record all the documents submitted by Malik, including the copy of the latter's School Leaving Certificate (SLC) which mentions that he was a Muslim and not Hindu Dalit as Sameer Wankhede has along been In his affidavit, Malik had told

the High Court that the SLCs Sameer Dawood Wankhede and his religion as Muslim, the letter by the health officer of the BMC's E-Ward had Wankhede's stated that in 1979 his father's name was Dawood K Wankhede and it was only in 1993 that the sub-registrar corrected his name.

In his affidavit filed before the High Court, Malik said that going by the BMC letter and documents, 'İt is clear that the name of Wankhede has been changed from Dawood K Wankhede to Dnyandev Kachruji Wankhede. However, there is no change in respect of religion and till date it is shown as Muslim."

On his part, Wankende's father filed his own set of documents to disapprove Malik's allegations. The documents that he produced before the court were digitised birth certificate issued by BMC and a caste certificate

After hearing the petitions on behalf of Malik by senior Advocate Atul Damle asked Advocate Arshad Shaikh for Wankende to his

Delhi court has framed Acharges of arson and rioting against a father-son duo for allegedly damaging and setting a mosque on fire, vandalism, and stone-pelting during the February 2020 riots.

Mithhan Singh and his son Jony Kumar are accused of allegedly being part of a violent mob that raised slogans "Jai Shree Ram" and damaged the mosque in Delhi's Khajuri Khas area on February 25, 2020, as per the complainant.

Additional Sessions Judge Virender Bhat framed charges under requisite sections against the two accused and explained it to them in vernacular in the presence of their lawyers, to which they pleaded not guilty and claimed trial in the case.

The judge, in an order dated November 20, also rejected the argument put forth by the counsel of the accused that they are entitled to be dis-

RK Jenamani, a senior scientist at the India Meteorological Department (IMD), said westerly winds gusting up to 25 kmph improved visibility to 3,200 metres.So far, Monday has been the only day in November when the Palam Observatory reported "visibility of more than 3000 metres and such strong winds", he said.

The Ministry of Earth Sciences air quality monitor SAFAR said the AQI was recorded in the lower end of the "very poor" category on Monday, a "significant" improvement from the day before due to the



low fire count and strong transport-level winds blowing from northwest direction dispersing pollutants.

These winds are likely to continue on Tuesday, leading to further improvement in the air quality to the 'poor' category (if no increase in fire count), it Local surface wind speed is also relatively high on Monday

and will remain so on Tuesday, it said, adding local and transport-level winds are likely to slow down from Wednesday and result in slight deterioration in the air quality. SAFAR said 909 farm fires accounted for six per cent of Delhi's PM2.5 pollution on Monday.

Dengue cases in Delhi mount to over 7000

STAFF REPORTER ■ NEW DELHI

With 1,851 fresh cases, the number of people affected from dengue has reached 7,100, according to a report released by municipal corporations on Monday.

As per the report, about 5,600 cases were recorded in November alone. Also, 167 cases of malaria and 89 cases of chikungunya have also been reported till 20 November this year in Delhi.

Dengue mosquito larvae breed in clear, standing water, while those of malaria thrive even in dirty water. Cases of vector-borne diseases are usually reported between July and November, but the period may stretch till mid-December.

Malaria, dengue and chikungunya are accompanied with high fever and therefore doctors feel that people might suspect that Covid-19.

On November 15, the city

had recorded a cumulative total of 5,277 dengue cases, making it the highest number of cases of the vector-borne disease recorded in the national capital in a year since 2015. In the previous years, the

total dengue cases reported were 4431 (2016), 4726 (2017), 2798 (2018), 2036 (2019) and 1072 (2020).

As per the report. In 2015, the city had witnessed a massive outbreak of dengue, when the number of dengue cases reported has crossed 10,600 in October itself.

99% of paramilitary personnel hit with Covid recovered

PNS NEW DELHI

Nearly 99 per cent of paramilitary personnel affected with Covid have recovered.

In numbers, out of the 88,198 Covid-19 infections in the paramilitary ranks since the outbreak of the pandemic last year, as many as 87, 634 patients have recovered. Only 217 patients continue to be currently active, including 23 persons who contracted the disease during the last 48 hours. The fatalities in the paramilitary ranks stand at 331 till now.

The total number of Covid-19 infections have increased by about eight percent from 81,216 cases as on June 4, to 88,198 as on Sunday. Likewise, the recoveries have improved by over 11.57 percent during the last five and a half

During the last 45 days, the number of active patients in the paramilitary ranks shrunk from 341 to 217 which is a decline of about 35 percent.

A total of 347 patients have died in the paramilitary ranks till now, including 131 in Central Reserve Police Force (CRPF)90 in the Border Security Force (BSF) and 83 in Central Industrial Security

Likewise, 23 patients of Sashastra Seema Bal (SSB) died due to the Covid-19 disease followed by 17 in the Indo-Tibetan Border Police (ITBP), two in National Disaster Response Force (NDRF) and one in National Security Guards (NSG).

Currently, 37 patients in the CRPF, 75 in BSF, 73 in CISF, 22 in SSB, six in ITBP and two each in NDRF and NSG are active cases of novel coronavirus infection.

On October 6, out of about 87,500 paramilitary personnel infected with Covid-19, 331 patients were active and 341 infected personnel had succumbed to the disease. The tally of active patients then had reduced by 90 percent during a four month period.

Out of the 87,415 cases of Covid-19 in these seven paramilitary forces, 86,743 patients had then recovered from the deadly viral disease.

As on June 4, 81,216 paramilitary personnel were infected with the coronavirus disease of which 77,486 patients had recovered and 320 patients

m ulers}$ should introspect everyday whether the decisions taken by them are good and also check if they have any bad characteristics, Chief Justice of India NV Ramana said on Monday. Addressing the 40th convocation of Sri Sathya Sai

Institute of Higher Learning in town Puttaparthi Anantapuramu district, Justice Ramana, quoting Mahabharata and Ramayana, said there are 14 bad qualities of rulers which

they should avoid.

"All the rulers in the democratic set-up, before beginning their routine work, should introspect whether they have any bad characteristics. Over 10,800 village panchayats in Guj to go to polls on Dec 19

PTI AHMEDABAD

Atotal of 10,879 gram pan-chayats across Gujarat would go to polls on December 19 to elect sarpanch and members, the State Election Commission (SEC) announced on Monday.

Of these, the five-year tenure of 10,117 gram panchayats is ending in December, while polls will be held in 65 panchayats due to splitting or dissolution of existing bodies, along with bypolls in 697 panchayats where seats fell vacant due to various reasons, said State Election Commissioner Sanjay Prasad.

"In all, nearly 2.06 crore voters will elect 10,284 sarpanchs and 89,702 panchayat members of these 10,879 gram panchayats. There are some 14,000 gram panchayats and 18,500 across the state. The last date of filing nominations is December 4 and that of withdrawal is December 7," he said, adding the model code of conduct connected to these polls was now in force.

"Polling will be held on December 19 between 7 am and 6 pm in over 27,000 polling booths. Counting of votes will be held on December 21. Due to the very high number of wards, polling will be conducted using ballot boxes instead of EVMs," said Prasad.

to Dalit boy in 48 hours To adopt humanitarian

approach

New Delhi: Asking IIT, Bombay to adopt a humanitarian approach, the Supreme Court on Monday directed the premier engineering institute to allocate within 48 hours a seat to a young Dalit boy, who missed out, as he could not deposit his fees due to the nonfunctioning of his credit card.

The apex court exercised its plenary powers to direct the IIT, Bombay for allocating a supernumerary seat to the young boy from Allahabad, saying it would be a travesty of justice if he is turned away from the portals of the Supreme Court.

A bench of Justices DY Chandrachud and AS Bopanna said, "This court has before it a young Dalit student, who is on the verge of losing a valued seat which has been allocated to him at IIT, Bombay, The travails of the appellant has taken him from Allahabad, where he is currently studying to Kharagpur and Bombay and eventually to the national capital. Having regard to the facts of the case, it would be a grave travesty of justice to the young Dalit student who has to finally move this court, is turned

vay from its portals.. The bench noted that if the petitioner Prince Jaibir Singh, who has secured 864 All India ranks in the SC category in the IIT entrance exam, is not admitted in this academic year, he will be ineligible to appear for further entrance examinations as he has appeared in two consecutive attempts.

"Hence, we are of the view that this is a fit and proper case where the exercise of jurisdiction under Article 142 of the constitution is warranted at the interim stage, in the facts which have appeared before the court. We accordingly direct the first and second respondent (IIT, Bombay) to ensure that the seat which is allocated to the appellant shall be allotted to him at IIT, Bombay. This shall be done without disturbing any other students, who have already been admitted", the bench said.

The top court said that the creation of supernumerary seats in the facts of the present case shall be subject to the admission of Singh being regularised if any seats fall vacant as a result of exigencies, which may arise in the course of the admission process.

"Parties shall act on the certified copy of this order and implement these directions within a period of 48 hours that is by November 24," the bench

During the hearing, the bench was informed by advo-

cate Sonal Jain, appearing for Joint Seat Allocation Authority (JOSAA) and IIT, Bombay that there are no more seats available in any of the IITs across the country as the admission process is complete and the

court can pass an order under Article 142 for allocating a

seat to Singh. The bench said, "Look at the background of the child. He has to borrow money from his sister after his credit card malfunctioned. Don't be wooden like this. We can pass an order under Article 142 but that may not be favourable for IITs. You can adopt a humanitarian approach and explore the possibilities. Explain this to the chairman".

The top court said that many seats get vacant after students take admission in different institutes to further their career in better options and IIT should look and allocate one such seat to this student.

"Something has to be done for this student. It is elementary common sense, which students would not like to get into IIT, Bombay and not pay Rs. 50,000 fees. It is obvious that he has some financial problems. He has to borrow money from his sister. These students study years after years for this exam. Look at their background," the bench said.

Ugly city

The degrading condition of urban poor is a challenge that the Govt must take heed of

■ ealth governance for the urban poor in India is chaotic at best, rendering them helpless, a study by the Azim Premji University in collaboration with a group of NGOs reveals. In a country where a third of the people living in urban areas are poor, mostly jobless, unable to get even a full meal a day, they are saddled with a disproportionate disease burden as well. The report draws attention to India's best-kept of secrets: Welfare programmes rarely take into account the factors that make people poor. They are all about ameliorating their situation, but not for rooting out the causes. Otherwise, the situation of the urban poor, for example, would not have worsened, as it has done, during the COVID-19 lockdown in 2020-21. The pandemic left the urban poor poorer, hungrier and without nutrition than those in the rural areas who had family or relatives, and impor-



tantly the public distribution system, to fall back on in the lockdown period, and were able to pass their days off without going hungry. Their fellows in the cities, in comparison, fared worse. They came to the cities to find jobs no doubt, but the lockdown messed with their lives, made them lose their jobs as workplaces closed down, there were no wages and so, they had no access to food. The soup kitchens and the largesse from NGOs and the Government did help them, but not to the extent of not losing out on nutrition and health. The urban poor rarely have access to the public

ration system and they ended up borrowing money for food. The rural poor had relatively better access to the social security schemes operating during the pandemic. Vulnerable groups among the urban poor, like families run by single women or people with disabilities and transgender people, fared badly, ironically at a time when India has had record food grain production.

The Azim Premji University report tells us how joblessness and hunger are now impacting their health. The lack of access to medical care for the urban poor is so bad that "the life expectancy among the poorest is lower by 9.1 years and 6.2 years among men and women, respectively, compared to the richest in urban areas". What is worse, the multiplicity of health care providers, and the lack of coordination between them, is playing havoc with the health of the poor. Thirty per cent of the urban poor have no access to public health facilities and have to seek private sources, adding to their financial stress. The Government must address the problem of lack of administrative efficiency dogging the health governance system even as it tries to implement social security measures to provide subsidised food and employment guarantee for the poor in the urban areas. The number of the urban poor is only going to increase in the coming days. It is for the Government to coordinate its efforts better.

dhe Allahabad High Court has rightly reminded Government about Article 44 of the Indian Constitution which is a Directive Principle of Policy, which was meant to be parallel to a fundamental right to be implemented in due course. This Article relates to a Uniform Civil Code or a common civil law. It is certainly not to be an imposition of Hindu law on all the communities. Yet, it has not been even drafted for a national discussion. To a lay Indian, this appears like a discrimination for two reasons.

All other non-Hindu communities like Christians, Parsees, Jews et al are happy with the civil law prevailing. Only Muslims are unhappy unless their civil rights under their law called sharia are allowed to be applied to the civil conduct of Muslims. Essentially, it boils down to marriage and succession rules, especially the former. All other subjects are happily applied to all, including Muslims; even the criminal law. Why this discrimination within a discrimination.

Sharia prescribes that if a person is charged for theft, the punishment is to chop off his hand. Muslims do not want this to happen. Possibly because the punishment is too harsh. Does the Indian Penal Code, originally drafted by Lord Macaulay, become superior to sharia because the former is more convenient? Article 15 of the Constitution begins with the prohibition of discrimination on grounds of religion, race, caste, sex or place of birth.

This Article, an exemplary one, is violated by Muslims themselves. A man is entitled to marry up to four wives but the wives cannot marry more than one husband. A husband can divorce his wife by swearing 'talaq, talaq, talaq' but a wife cannot do the same. For her, there is no talag and her privilege is confined to khul which she can resort to when the two spouses agree that nave become inimical to each other and their union no Arabia. In other words; Sharia longer serves the purpose of marriage. She can release herself what prevailed before.

COP26 TAKEAWAY IN THE DIVIDED WORLD

This is the first time that coal has been explicitly mentioned in any COP decision

n the recently concluded COP26 meet on climate change, the developed world as usual was harping on stopping use of coal and subsidies on fossil fuel ignoring the ground realities of the developing world that faces challenges of meeting the energy needs of developmental works and reduction of poverty. However, thanks to India and other developing nation the final agreement toned down the words and pledged to only reduce the use of coal and fossil fuel. As per the Paris agreement the developed world was supposed to provide \$100 billion annually by the year 2020 to the developing countries to meet their targets of adaptation and mitigation. The new technologies and innovative attempts require finances and unless it is done it will be a pipe dream to achieve targets. The Glasgow declaration is weak on promises especially on loss and damages though the developed countries now agreed to provide the 100 billion dollars by 2023. In reality, if the net-zero emission targets are to be achieved by 2050 to 2070 at least \$500 billion annually would be needed. Further, because of the intransigence of the developed world the scope for opening of adequate space for carbon trade is still an issue. The developed world



had failed to recognize and accept their historical responsibility for emissions in the past and on the contrary in each COP they pressurise the developing world to opt for impractical conditions. Thus, the question of equity and differential responsibility always gets side lined in these negotiations. From the Indian side there were some positive declarations by Prime Minister Narendra Modi on how Indian proposes to achieve the net-zero emissions by 2070. He announced the 'Panchamrit' concept while delivering the National Statement. The PM said the first agenda was to raise the non-fossil fuel-based energy capacity of the country to 500 GW by 2030. On mitigation, COP26 asks the countries to prop up their climate action plan for 2030 by next year and also propose to hold ministers' meetings to raise the ambitions (as it says!) of climate action plan for 2030

It asked the countries to to reduce usage of coal as a source of fuel, and abolish "inefficient" subsidies on fossil fuels. It called for a phase-down of coal, and phase-out of fossil fuels. This is the first time that coal has been explicitly mentioned in any COP decision. It also led to a big fracas at the end, with a group of countries led by India and China forcing an amendment to replace the word "phaseout" in relation to coal with "phase-down". On adaptation, it asked the developed countries to at least double the money being provided for adaptation by 2025 from the 2019 levels. The Paris agreement had been good for mitigation goals but silent on adaptation goals. Unlike mitigation efforts that bring global benefits, the benefits from adaptation are local or regional. On the insistence of developing countries this declaration has proposed a two-year programme to define global goal on adaptation. For loss and damages, it has been agreed to establish a dialogue on the insistence of developing countries. The carbon market vanished after the end of Kyoto Protocol. The Glasgow Pact has offered some reprieve to the developing nations. It has allowed these carbon credits to be used in meeting countries' first Nationally Determined Contributions till 2025. The climate change targets can only be met if the developed world accepts the reality and stops dillydallying. The Prime Minister and environment minister of need to take innovative actions to achieve the targets of net-zero emission by 2070. At the country level we need to integrate and converge the development process with ecological sustainability.

Directing the retail investor to G-security



Under this centralised system, customers will have a single point of reference to file their complaints, submit documents, track status and provide feedback

n November 12, 2021, Prime Minister Narendra Modi launched two innovative customer-centric initiatives of Reserve Bank of India — Retail Direct Scheme (RB-RDS) and the Reserve Bank-Integrated Ombudsman Scheme (RB-

The RDS is intended to give retail investors - mostly the middle class, employees, small businessmen and senior citizens - an option of 'directly' investing in their hard-earned savings/surpluses in Government securities, making capital markets 'easily accessible' and ensuring that the investment is 'more secure'. The RB-IOS is aimed at improving customer grievance redress mechanism.

What are the schemes? How do these propose to achieve the stated objective? What are the chances of success?

The RB-RDS is a 'one-stop' solution to facilitate investment by individual investors in Securities issued by the Centre such as treasury bills, dated securities, sovereign gold bonds and securities issued by State governments. Under the scheme, a retail investor can open and maintain the 'Retail Direct Gilt Account' (RDG Account) with RBI. It can be opened through an 'Online portal provided for the purpose. He/she needs to have a Rupee savings bank account maintained in India, PAN (Permanent Account Number) issued by the income tax department, any officially valid document to meet KYC norms and Valid email id and registered mobile num-

The 'Online portal' will enable the retail investor access primary issuance of Government securities as also invest in the secondary market by accessing the RBI's trading platform named Negotiated Dealing System-Order Matching Segment, or NDS-OM. NDS-OM is a screen based, anonymous electronic order matching system for trading in government securities in the secondary market. Investors will receive interest/maturity proceeds in their bank accounts linked to the RDG account. They will not have to pay any fee for availing facilities on the portal.

With these basics at the backdrop, let

All along, the Government securities or G-sec market was largely inaccessible to retail investors even as the market was dominated by institutional investors such banks, insurance companies, mutua funds, etc. with lot sizes of Rs 5 crores and higher. Earlier, regulators tried to popularize G-secs among the former through innovations such as NSE (National Stock Exchange) GoBid app or retail debt market (RDM) segment of the exchange. But these did not have the desired result due to lack of liquidity.

Accordingly, initiatives such as introducing non-competitive bidding in primary auctions, permitting bourses to act as aggregators or facilitators for retail investors and allowing odd-lot segment in NDS-OM

the promised interest. However, it does not automatically follow that retail investors will be enthused and come in droves. This is because the yield on G-secs currently at around 6.2 percent is significantly lower than the return a small investor gets from investment in a host of small savings schemes (SSSs). For instance, a

return of 8.3 percent from investing in Pradhan Mantri Vaya Vandana Yojana(PMVVY) or investment in Senior Citizens' Saving Scheme (SCSS)currently 7.4 percent.Even persons below 60 years of age have options such as public provident fund (PPF), national savings certificate (NSC) etc where the returns are higher (7.1 percent and 6.8 percent respectively) than those available on securities.

The sole reason behind higher return on SSSs is the subsidy extended by the Union Government on these instruments unlike G-securities where the interest rates are market determined. Considering that subsidy is given primarily to serve a larger welfare objective of protecting the vulnerable class (for instance, senior citizens who donot have regular source of income and are entirely dependent on return from their accumulated savings), it is unlikely that this will be with-drawn. Then, how will the RB-RDS gain traction?

Other than persons with limited savings who use the money for investing in SSSs or other instruments where exemption from income tax (subject to specified cap) is available, there exists a large pool of others - often referred to as high net-worth individual (HNIs) having huge surplus left even after fully exhausting the investment threshold under the former category Even as HNIs are normally crazy for high returns and go after equity shares, a large number of them would look for

'safer' and 'secure' options even if the return is less.

Investment in G-securities on the RB-RDS which is hassle free and easily accessible fully meets the requirement of such investors. It is good from the perspective of the Government also as it needs longsenior citizen gets an effective term capital to finance infrastruc-

ture projects such as expressways, highways, railways, ports and so on. However, it should avoid the temptation of extending tax benefit to retail G-sec holders; rather there is a case of removing extant tax benefits on debt mutual fund schemes, RBI floating rate bonds, SSSs, etc.for a level playing field.

The second initiative is crafted around the theme of 'One Nation-One Ombudsman' with one portal, one email and one address for the customers to lodge their complaints regarding deficiency in services provided by banks, nonbanking finance companies (NBFCs) and other entities regulated by RBI. With this, the extant three Ombudsman Schemes dealing with Banking, NBFCs and Digital Transactions respectively will cease to exist.

Under this centralized system, the customers will have a single point of reference to file their complaints, submit the documents, track status and provide feedback. Irrespective of the institution, the office/branch where the customer is maintaining his/her account, location, nature of the grievance and so on, all that he/she needs to do is to open his/her laptop and get things done - literally unshackling from the hassles under the existing arrange-

With large volumes of data stored under a centralized and integrated system, the authorities can also take timely action for preventing financial crime and catching cyber fraud using artificial intelligence (AI) and data analytics.

To conclude, both the initiatives of the RBI are major reforms, first offering a versatile platform to channelize people's savings for financing development needs and second, effectively address their grievances by improving services and protecting their money.

In developing countries, greater growth of the dairy sector can increase women's educational attainment and bridge the gap in sumption, which in turn will

gender inequalities. The dairy sector is thus a vital driver for helping India reach the SDGs enunciated in 2015 by the United Nations to transform the world and to protect the

planet we live in. Further, keeping in mind the nutritional value of milk, in the year 2018, an advisory was issued to all states to include milk in the Mid-day Meal Scheme and other nutritional programmes of anganwadis and in the ongoing schemes of health as well as Women and Child Development department to tackle malnourishment in the country. The Department of Food and Public Distribution was also requested to include milk in the PDS system. This is likely to increase milk conyield better returns for dairy farmers in the flush season.

India is self-sufficient in milk production, but only ten states in India produce 81 per cent of the total milk produced, and only nine states have achieved per capita availability of milk at par with the national level. The data shows that milk production in India is concentrated in a few states because of their robust dairy cooperative networks, and a higher remunerative price of milk received by the farmers in their respective states. In order to circumvent this, the Indian government needs to devise a suitable dairy development policy for enhancing milk production and procurement in the remaining potential districts and states. This implies that dairy promotion



5 dead, 40 injured after SUV speeds into Christmas parade

Ajoyous scene of marching bands and children dancing in Santa hats and waving pompoms turned deadly in an instant, as an SUV sped through barricades and into a Christmas parade in suburban Milwaukee, killing at least five people and injuring more than 40 others.

One video showed a woman screaming, "Oh my God!" repeatedly as a group of young dancers was struck Sunday. A father talked of "from one crumpled body to the other" in search of his daughter. Members of a "Dancing Grannies" club were among those hit.

The city of Waukesha posted on its social media accounts late Sunday that it could confirm at least five died and more than 40 were injured, while noting that it was still collecting information. The city's statement also noted that many people took themselves to hospitals. The city did not release any additional information about those who died.

A "person of interest" was in custody, Waukesha Police Chief Dan Thompson said, but he gave no details about the person or any possible motive. The investigation was ongoing, with assistance from the Wisconsin Department of

Justice.

ot long ago, Ferishta Salihi and her family had enough for a decent life. Her husband was working and earned a good salary. She could send several of her daughters to private schools. But now, after her husband lost his job following the Taliban takeover of Afghanistan, she was lined up with hundreds of other Afghans, registering with the U.N.'s World Food Program to receive food and cash that her family desperately needs just for survival.

"We have lost everything. said after her registration was complete. With her was her eldest daughter, 17-year-old Fatima, whom she had to take out of school. She can't afford to pay the fees at a private school, and the Taliban so far are not allowing teenage girls to go to public schools.

'I don't want anything for myself, I just want my children to get an education," Salihi said.

Afghanistan's economy craters, many stable, middle-class families like Salihi's have plummeted into desperation, uncertain of how they will pay for their next meal. That is one reason the United Nations is raising alarm over a hunger crisis, with 22% of the population of 38 million already near famine and another 36% facing acute food insecurity - mainly because people can't afford food. The economy was already

in trouble under the previous, U.S.-backed government, which often could not pay its employees. The situation was pandemic and by a punishing drought that drove up food prices. Already in 2020, nearhalf of Afghanistan's population was living in poverty. Then the world's shutdown

The Centre could better its The Centre could better its fiscal deficit at 6.6 per cent of GDP in this financial year on stronger-than-expected revenue buoyancy, even if the budgeted disinvestment target is not met, Fitch Ratings has

The international rating agency had last week kept the sovereign rating unchanged at 'BBB-' with a negative outlook, and said that the risks to India's medium-term growth outlook are narrowing with rapid economic recovery from the pandemic and easing financial sector pressures.

In an email interview with PTI, Fitch Ratings Director (Asia-Pacific Sovereigns) Jeremy Zook said the two key positive triggers that could lead to a revision of the outlook to stable are implementation of a credible medium-term fiscal strategy to lower debt burden

investment and growth rates without the creation of macroeconomic imbalances, such as from successful structural reform implementation and a healthier financial sector.

"We forecast that the central government will achieve a deficit of 6.6 per cent of GDP in the current fiscal year, largely as a result of stronger-thanexpected revenue buoyancy. Our forecasts assume that the government does fall short of its budget target for divestment," Zook said.

In the 2021-22 (April-March) Budget presented on February 1, the government had pegged the fiscal deficit, or gap between the Centre's expenditure and revenue, at 6.8 per cent of GDP or Rs 15.06

At the end of September, which is six months in the financial year, the fiscal deficit touched 35 per cent of budget

Revenue Secretary Tarun Bajaj has said the government's tax collection kitty will surpass budget estimates this financial vear on the back of good direct and indirect tax mop-up.
"After refunds also, we

have touched almost ₹6 lakh crore till October in direct taxes... It is looking good. Hopefully, we should exceed

"Though we have given a lot of relief in indirect taxes in petrol, diesel and edible oil, also there are some sunsets that have come in customs duty where the total benefit would be about ₹75,000-80,000 crore. But, still, I think we should exceed the budgeted estimates on both direct and indirect taxes," Bajaj told PTI.

India's two-wheeler sales likely to fall 1-4% YoY in FY22: ICRA

India's two-wheeler sales are expected to contract by 1-4 per cent year-on-year (YoY) in FY22 due to weak festive season performance, ICRA said on Monday.

"The entry-segment (75-110cc), which dominates 2W (twowheeler) sales in India, has remained subdued this year, reflecting extensive (and extended) impact of the second wave of the pandemic. The lacklustre festive season performance also highlighted continued wariness among the low-income population regarding big-ticket purchases," said Rohan Kanwar Gupta, Vice President and Sector Head,



Corporate Ratings, ICRA. "On the financial front, given the high operating leverage of the industry, subdued demand and elevated raw material costs are expected to keep the operating margins constrained for the two-wheeler OEMs (original equipment manufacturers) in the current fiscal," Gupta said. Besides, the agency said rural offtake has lagged urban, possibly due to moderated agri-sentiments caused by uneven monsoons and delayed harvesting across

ven before your baby can talk, he or she will show signs of hunger or fullness. Understanding your child's signs of hunger is important so that you can put him or her to the breast while he or she is still calm. This technique is called respon-

Here, you must watch out for any hints that your baby might give and respond promptly to him or her. In this type of feeding, you feed the baby in the right way and let him or her stop when they are full.

Responsive feeding is very important for the overall development and nourishment of the child. All you must do here is provide and the rest, your child will decide. Always keep an eye out for some sign of hunger too. The little ones have their own way of letting you know by becoming more active or alert or when they try to keep their eyes open.

Some of the other signs are when they put their hands to the mouth, turn their head towards the breast, have clenched hands and hands more drawn towards the mouth & chest or when you notice them crying when there is a delay in feeding.

Every crying child is not hungry and every hungry child does not necessarily cry. Every time the baby puckers or smacks lips doesn't mean the baby is hungry. It has to be correlated with the interval between the last feeds and the baby's urine output. Such action in a baby immediately or within one and half hours of last feed, with good urine output, rules out hunger. That's when it has to be ignored.

Signs that baby is full

When the stomach is full, the baby gets distracted easily and unlatch often, and slow down while suckling. The most common sign is that they relax their hands, open their fingers, and then try to spit. So, always keep an eye out for these signs. Myth: Baby is hungry; the feed is insufficient.

Reality: Hunger is the last reason for the baby to cry

Most mothers are confused about why their baby is crying when they are not hungry because hunger is the last reason for the baby to cry. But there are several other reasons why your little one may start crying. Some babies want body touch, and they want to be picked by their mom and dad. Sometimes the uncomfortable clothes/overwrapping and wet/ dirty diapers can lead to crying. During colds are the most common reason. Shed eyelashes mostly irritate the eye, or maybe it is infantile colic.

What to do when the baby cries?

One of the most common questions of parenthood is what to do when a baby cries? You may receive different answers, remember, everything is completely okay with your baby. So when your baby cries, don't panic and take a deep breath. Sometimes they need attention and love. Your baby might also be crying because of lack of sleep, noise, Just relax and try to find the real

A baby who is otherwise well between crying episodes, thriving well, and has no localized abnormality on physical examination doesn't need further evaluation. If your baby is crying without any reason, give your baby adequate skin-to-skin contact and practice kangaroo care with the mother or any family member. After that, learn to clothe the baby appropriately. Do not swaddle the baby too tight and try to watch for overheated surrounding temperature. Keep checking soiled nappies and practice skincare hygiene. Use saline nasal drops to clear the blocked nose. If you think your baby has fallen from anywhere, check for any

Colic is not a diagnosis. It is a clinical condition. Please consult a physician if necessary. Do not use any home remedies or herbal preparations for the same.

Practice Pearls There is no medicine to stop any baby from crying. Bottle feeding is not the answer to every crying baby. Try to understand your baby, give warmth and touch, and when it is needed. Finally, take the doctor's advice when needed.

to take care of spine

WFH set-up, DR SHUBHANG AGGARWAL tells us how

Thile working from home has many personal and professional benefits, it is also making you susceptible to spine related issues due to your poor posture during work. Since most of us are working long hours in this new set-up, the uncomfortable chair and no break within the work are all leading to back pain. Due to the space crunch in our homes, it's difficult to accommodate today's ergonomic office furniture. Therefore, one should be careful about their body posture while working from home. Ensure that none of the parts of the body is awkwardly bent or twisted. It's equally essential to move around periodically in order to promote circulation.

Posture

One needs to take care of his/her posture to relieve the stress from the elbows and neck. When we sit for a long time, our 'S' curve of the spine changes into 'C' curve, thereby putting more stress on your muscles, ligaments and tissues.

Adjust your seat

When you are working on a laptop, it's necessary to adjust your seat so that it can be comfortable for your eyes as well as your back. Your eyes should be lined up 3 inches below the top of your screen if using a desktop computer, or tilt your laptop screen back to 120 degrees. The screen should be at least an arm's length away. Make sure you're not sitting upright or hunching forward in your chair like a turtle. While sitting back in your chair, some of your body weight is being supported by the chair back and sit close enough to comfortably reach your keyboard and mouse. Change your position frequently

Don't get immersed in your work. Take small breaks. Instead, try to get up every 45-50 minutes, even if it's just to walk around the room. Stand after every half an hour, stretch and move around for a minute or two to promote circulation and relax muscles. You can also walk to get a glass of water or make tea or coffee for yourself. But don't try to work for hours on end standing up. Standing for extended periods of time also increase the risks of varicose veins. Our body comprises 360 joints and they all need to move in order for the proper circulation important

Exercises for a stronger back

Exercise can help strengthen and support your back. A scheduled walk, every day for 30 minutes, can do a lot to strengthen your lower back and the muscles that support your spine.

One needs to make exercise a priority. There are many great and effective home workouts that you can do with basic household items. These are just a few simple steps you can take to help relieve back pain. Remember that the more you can work in a neutral posture, and the more you can move around, the less the chance of any spinal injury. But, if you are still struggling with pain that interferes with your daily life, consider talking to a specialist.

Importance of radiology and medical imaging

Since time immemorial, Radiology or Diagnostic Imaging has played an important and central role in disease management, says DR SANDEEP SHARMA

n December 2019, China reported cases of an acute respiratory disease of unknown etiology in Wuhan, and a few weeks later, the outbreaks spread to many other countries with the World Health Organisation (WHO) declaring it as a pandemic (a disease, usually of an infectious nature prevalent across multiple continents or worldwide) on 11th March 2020.

The virus — SARS-COV-2 popularly known as COVID-19 or simply Coronavirus soon became the biggest healthcare crisis in most of our lives and the most significant geopolitical event of our generation in the modern history globally.

Since times immemorial, Radiology or Diagnostic Imaging has played an important and central role in disease management, with a wide choice of tools and techniques available for the detection, staging and defining treatment modalities for innumerable dis-

However, with the onset of COVID-19, there lacked any reliable and accurate (read: highly specific and highly sensitive) testing for early detection and containment of this

deadly infection.

The value of an imaging test relates to the production of results that are clinically workable either for establishing Diagnosis or for guiding management, or triage. Here, the critical role of chest

imaging including baseline X-ray and the High Resolution Computed Tomography (HRCT) of the Thorax or Chest became apparent as an overlooked imaging modality, a more sensitive and specific investigation compared to the Gold Standard RT PCR test (as per many studies conducted worldwide). HRCT Chest findings in

COVID-19 such as Ground Glass Opacities (GGOs), Consolidation, Crazy Pavement Pattern, Septal Thickenings etc and the CT Severity Scoring (CTSS) reveals the extent of damage to the lungs by the COVID-19 virus, a virus primarily affecting the lungs, which proved to be a useful tool to provide the physicians more options for accurate and better management in terms of determining severity, guiding treatment, managing complications and assessing treatment response especially in patients with a high clinical suspicion of COVID-19.

However, unavailability of CT Scan machines in rural settings and dedicated machines for COVID patients, moving patients to the machine/set-up especially those on oxygen support, difficulty in disinfecting the machines and following strict infection control protocols popped up as drawbacks to this imaging technique.

Other Radiology and Imaging investigations such as Chest X-RAYs (Bedside) provided the added advantage of portability and the provision to compare baseline images to latest images in order to study the progression of the disease and guide appropriate management with minimal exposure to radiation.

Using Chest X-Ray as a method of triage is believed to be more superior than the rapid testing kits in busy healthcare set-ups. Chest Imaging including X-RÂY and CT Scans also assist in detecting complications such as Pneumothorax, Pleural Effusion etc even before they manifest clinically. Also, patients unaware of underlying comorbidities such as chronic lung disease or

congestive heart failure could be detected with these conditions and managed better. Hence, Radiology or Medical Imaging plays an important auxiliary role in the diagnosis and management of COVID-19 patients, particularly in those most seriously affected. Economically, this pandemic

has detrimental effects and significant loss of revenues, as the Governments across the world have partially or completely shut down all non-essential services.

Due to these measures there had been significant reduction in all imaging scans as outpatient volume had been severely reduced to 10-20 per cent in comparison to pre-COVID times. Additionally, following these guidelines all non-emergent outpatient imaging scans including ultrasound, radiographs, CT, MRI and radiological interventional procedures were postponed, which resulted in sub-normal revenue for a minimum of 5-6 months affecting mainly the stand alone centres running with limited

A LEGEND IN THE MAKING

Traditional master craftsman SUDARSHAN SAHOO tells CHRISTY VARGHESE about a young child growing up in Puri, Odisha, who went on to receive the Padma Vibhushan earlier this month

rai Jagannath!" greets a strong voice on the other end of the phone call, quite unlike what we were expecting an 82-year old Sudarshan Sahoo to sound like.

We had a tough time getting hold of the celebrated sculptor, who works on stone, wood and other media, which was not a surprise considering that he was awarded the Padma Vibhushan, the second-highest award for civilians in India. However, once we got through to him, it was a delight speaking with the artist who is still going strong despite a career spanning seven decades and counting.

"No one admires flowers which grow in the jungle. They fall on the ground and whither, unseen by anyone. Thank you for being the voice of artists like me," expresses Sahoo; and it has to be said, moments like these are what inspire us. A word or two of warmth and support always goes a long way.

'He is a sculptor with seven decades of experience in stone and wood in classical style sculpture. He has been making constant efforts to promote Indian classical sculptures all over the world, declared Rashtrapati Bhavan ahead of awarding the artist with the Padma Vibhushan. Born to Dinabandhu and Srimati Sahoo, he has several awards and accolades to his name for his outstanding contribution towards India's arts and crafts such as the prestigious Padmashree in 1988, Liberty Bell National conferred by the Mayor of Philadelphia, USA in 1986, National Award for Stone Carving in 1981, Shreekhetra Shree in 1976). Additionally, he has been conferred with the honourary D.Litt degree by Utkal University of Culture, Bhubaneswar in 2011, Shilpguru Award and Kamaladevi Chottopadhya Award in 2003 and was declared 'Priya Odia' (Most adorable Odia) by ETV channel in 2012. To add to his long list of laurels, he has also been nominated for the illustrious Dharmapada Award by Odisha Lalit Kala Akademi in 2012 and was appointed as the Chairman of Odisha Handloom and Handicrafts Development and Promotion Council in 2018. Provided below are excerpts of the telephonic conversation:

But how did it all begin?

"I was born in a house which was half a kilometer away from Jagannath temple in Puri. For my parents, every day would begin with a darshan in the temple. My mother, in my younger years, would take me to the temple frequently. I have to tell you that I was


a doting only-son, apart from me, my mother was blest with four daughters. Like every other mother, she wanted me to grow up to be a fine young man. I can't say whether I was able to fulfill her expectations but with every visit to the temple I came a little closer to God.

The sculptures and other art forms present in the temple was something my mother would talk to me about, and I would bear in my mind what she had said. On my way back, I would often spy upon a group of sculptors next to our house, they would fashion beautiful sculptures from stones. I would watch them chisel away with wonder and at times I would pick up their instruments and try my hand at working on

It became a habit in my life to interact them. The sculptors' children were my friends and seeing my work everyone around me would compliment my craft. They inspired me to carry on working dedicatedly. This is just one of my stories from my childhood, and should tell you where it all

Do you remember how you became such a good scultor, the difficulties and good things you encountered along the way?

Of course! Making sculptures is all my life has been about, I remember every detail about it. I grew up poor. My father passed away when I was nine years old. As a widow, it was difficult for my mother to step outside home. Back then, our lives were ruled by some orthodox beliefs, one



of them being that it is extremely inauspicious to see a widow's face.

There was no means of earning any money and after passing fifth grade, I enrolled in the sixth grade but I could not pay the fees so I started working under Guru Moharana. He thought of me as his younger brother and would happily teach me everything he knew. Half of my time was spent as his apprentice and the other half was when I would try to hone my craft. I left the gurukul as 12 year old because I just had one goal — I wanted to earn as much as I could.

I would make anything and everything from small statues to carving small indoor mandirs. I remember I have made two 4-inch statues for as little as a rupee at one time, and mind you, this was the only

source of income for our family, back

Little by little, I don't know when I became a good sculptor. But I was extremely glad when people would appreciate my work. I think I was blessed by Lord Buddha, even as an eight or nine year old, I would draw on the blackboard. My teachers would scold me.

As a 19 year old, I used to earn well. However, those who belonged to the lineage of sculptors felt threatened by me I wasn't one of them, and they felt threatened by me since I did not hail from a family of artists and yet made better statues than them.

I was upset when I found out that they had approached my seller in the market, saying that they would not let him sell any statues that were made by me. Irrespective of how good my work was, if the person could not sell my statues, then what good was eeping them.

That is when Guru Moharana came to my aid back then. Telling me to make what I want, that he would sell them on my behalf. however, there is a twist to his kindness. One night, I spied on my statues that were marked for sale at his residence, to discover that my statues were cheaper than his. However, that led me to become an even better artist. I would spend hours spotting the intricacies of his work, which helped me improve.

That is when the people in my locality showed that they supported me by giving me money. The work I crafted with that money was so good that the Orissa Handicrafts body pur-

Photographers DINESH KHANNA, MUSTAFA QURAISHI and LEENA KEJRIWAL have come together to exhibit their work for the *Qawwali Photo Project* in IIC. TEAM VIVA discovers that this is the first time that this form of traditional devotional singing has been documented, as it exists today

The Qawwali Photo Project is the first-ever photo documentation and exhibition on Qawwali. It is an initiative meticulously conceptualised, where the untold story of Qawwali unfolds through the eyes of photographers. The practitioners are photo-documented with their performance art, their lives and their association with the Sufi shrines where they perform. The images of practitioners with their families, in their everyday lives and in their interaction with audiences and the pulsating connection of energy between them.

The Qawwals become the voice of the many prayers of the hundreds of devotees that throng the shrine, seeking grace. The Qawwals of the subcontinent have largely remained faceless, of course, a name and music that people associate with, but not the face of the man. This is what led to the formation of this project, say the people behind it, to show the real faces who lend their voices to this music. These musicians come from families where artistic knowledge and practice has been passed down for generations as a precious heirloom. Art is how they connect with themselves, their communities, and their sense of spiritual purpose. The technology at times dehumanises the music form, removes the human and only the sound becomes a memory. This project gives the image to the sounds, the identity to the people who give us the incredible music. The Qawwals.

Dinesh Khanna's stories traverse the important shrines of Delhi, Amritsar, Jaipur, Hyderabad and Ajmer and bring out the intricacies of traditions as an integral part of the music at the shrines. The their own lives as he follows them at various places. The Qawwals believe they are in service of the Sufi saints and would take their message of love forward. Dinesh explores them in resplendent colours and the darker tones of a bygone era, as they celebrate their performance art of Qawwali.

Mustafa Quraishi's photo story is shot in the two prominent shrines of Dewa Sharif and Safipur ironically linked to each other. Interestingly as an oral narrative, it is said that when Waris Ali Shah the saint from Dewa, was born, his father Qurban Ali Shah was 90 kilometres away in Safipur at the Shrine where he was informed with a famous prophecy that his son will become one of the biggest spiritual saints of the region. With equal aplomb, Mustafa explores the resistance at Delhi and the complete serenity and grandeur of the grace of Hazrat Šalim Chisti.





Leena Kejriwal's story captures the interesting deviation from the tradition, the presence of women Qawwali performers. In a largely androcentric performance art, it is important to document the women breaking barriers and participating in performing this music. The story continues where the Qawwals at the shrine of Hazrat Nizamuddin Aulia at Delhi are captured as they sing in their daily rituals not as a performance but as a prayer to their Pir. "Often, the Qawwal's families themselves do not have quality photographs of themselves or their forefathers who came before them. During the archiving of Qawwals when I would ask for images of leg-endary Qawwals from small towns there were no images, just some random passport pics or blurred images of their youth," shares Manjri Chaturvedi, the renowned Kathak dancer, who pioneered Am A Qawwal.

"You don't document us. We will document us."

It is a strong statement by Qawwals. The self-photographs we have received reveal something about the various characters of these men who are so integral to carrying on this generations-long androcentric performance tradition. Some are old, some are barely past boyhood. Seeing these pictures, we get a rare glimpse into their lives as viewed on their own terms.

At Vadehras the lotus pond studies are an Arcadian dream sequence. They are equivocal in tone and tenor. They could also symbolize detachment after the suffusion of a floating passion. 

CARRICK IN CHARGE

One of English soccer's best and possibly most underappreciated midfielders in recent years, Michael Carrick was known for his calmness, quiet authority and vision on the field. He'll need all of those attributes now he has been thrust into one of the world's biggest coaching jobs pretty much from out of nowhere.

Carrick, who only started his coaching career in 2018 and has never held a senior position, was named as United's caretaker manager following the firing of Ole Gunnar Solskjaer on Sunday.

In place until United finds another coach for the rest of the season, Carrick starts his new role with a crucial match away to Villarreal on Tuesday as the teams look to seal qualification to the knockout stage. They are both on seven points in Group F, two points clear of Atalanta with two games left. Carrick will need

2-year T20 WC cycle important for growth of cricket: ICC

The ICC on Monday asserted that a two-year T20 Word Cup cycle is important for the growth of the game as it is the format that is contested by all the members.

The global governing body last week announced the schedule of ICC events from 2024-2031 with a tournament slated to be played

every year.
"We've got different events in different formats. I think the decision to play T20 World Cups every two years is a conscious one to try and position T20 as the growth format of the game across all of our members," ICC CEO Geoff Allardice said, replying to PTI's query during a media round table.

'The tournament we've just finished in the UAE and Oman was the first one in five years which, given the amount of T20 International cricket being played and the fact that so many of our members are playing that format, is too long. Talking about the ICC Champions trophy which was last held in 2017 and will next be played in 2025, Allardice said the tournament is a "focal point" for ODI cricket midway the four-year World

Cup cycle.
"In terms of the Champions Trophy it's a very popular, well supported event. I think it's short and sharp and you know, high entertain-



provides a focal point for ODI cricket in the midway between the Cricket World Cup cycle of four years."

A Working Group was set up last week by the ICC to review the status of cricket in Afghanistan in the light of recent political developments in that country. ICC chair Greg Barclay asserted

that the body will continue to support Afghanistan as member of the ICC while encouraging them to continue to take an inclusive approach to

"At the moment Afghanistan are a full member of the ICC. Now, the position is that we want to continue to help them with the cricket programmes in the country, both men's and women's.

Shedding light on the investigation, Barclay said, "The ICC took a cultural assessment for two reasons. One, it's good governance to have an ongoing sanitary check into how the organisation is operating, which is what we did.

With English cricket being rocked by allegations of racism, the ICC maintained that it doesn't stand for discrimination of any kind.Former Yorkshire player Azeem Rafiq has alleged several former

wo-time Olympic medallist! I PV Sindhu and former world number 1 Kidambi Srikanth would look for a consistent show when they compete at the USD 850,000 Îndonesia Open starting here on Tuesday. Just days after their semifinal finishes at Indonesia Masters Super 750, the two top Indian shuttlers will begin their campaign at the World Tour Super 1000 event in their quest for title.

Sindhu, the reigning world champion, last reached the finals at the Swiss Open. She came close to the summit clash thrice by reaching the semifinals on three occasions, including her last two tournaments.

Last week, Sindhu's campaign was cut short by Japan's Akane Yamaguchi with a straight game win and the Indian will look to quickly recover from the loss.

The third seeded Indian will begin her campaign against

Japan's Aya Ohori and she is likely to face Canada's sixth seed Michelle Li in the quarterfinals if she can cross the early

Srikanth, who had claimed four titles in 2017, has regained some form with two back-toback semifinal finishes at Hylo Open and Indonesia Masters last week and he would be desperate to continue his good run and break his title draught.

Srikanth was outplayed by Anders Antonsen of Denmark last Saturday in the semifinals and he would look to put that disappointment behind when he faces HS Prannoy, who would be itching to settle the scores after being outwitted by his compatriot last week.

Prannoy, who was down with COVID-19 last year, showed glimpses of his earlier self when he notched up an upset win over Tokyo Olympics gold medallist Victor Axelsen of Denmark last week and he would hope to continue the momentum this week.
