Farmers dispute autopsy report, refuse to cremate

2nd post-mortem to be conducted, promises SP of Lakhimpur Kheri PREETAM SRIVASTAVA LUCKNOW

Upset over the inaction of the police in arresting Union Minister Ajay Mishra's son, who is accused of mowing down four farmers, the family of a 19-year-old farmer, who died in Lakhimpur Kheri during a protest on Sunday, has refused to cremate the body until they are provided the autopsy report which has not been made public.

They alleged that the postmortem report has been falsified. Meanwhile Lakhimpur Kheri SP Vijay Dhul promised that a second autopsy will be conducted in Bahraich.

Lovepreet Singh and three other farmers were among the nine killed in Sunday's violence during a protest against Ajay Mishra's visit. Four farmers were allegedly run over by a car in the convoy

"My son was crushed under a car. There has been no action against the person responsible. The administration is trying to cover up. He had left home saying he was heading out for a good cause," said Lovepreet's father.

Lovepreet's body has been kept in a casket and the entire family is waiting for the autop-

sy report. "When he was taken to the hospital, he called and said, "Please come quickly". 'When we reached' the

hospital, he was no more," said his distraught father. Farmers allege that the car

which mowed down Lovepreet was being driven by the Minister's son, Ashish Mishra.

"When my son fell down Teni's (Union Minister Ajay Teni Mishra) son shot him. We should get justice for this. They have even falsified the post mortem report. We should get justice for that," his father asserted.

Sources said the autopsy report did not mention injuries due to bullet wounds on any of the deceased farmers.

A senior doctor, who is part of the post-mortem panel

at the Lakhimpur district hospital, told some media persons that the causes of death in the autopsy reports include multi-

ple fractures after being run

over by a heavy object (like a

vehicle) and injuries suffered

due to assault. While the autopsy report has not been made public by the authorities yet, the families of the deceased said they will keep protesting until the reports are out.

In the meantime, farmers' leader Rakesh Tikait claimed that their protest would not end after Monday's agreement. In a tweet on Tuesday night, he said that they will again start their protest if the accused Minister was not sacked and that his son is not arrested.

Opp parties in Delhi discuss action plan

fter day-long detention, AICC general secretary Priyanka Gandhi Vadra and several other Congress leaders were arrested on Tuesday for trying to march towards Lakhimpur Kheri even as the Opposition parties in Delhi discussed an action plan to corner the Yogi Government over the violence in which four farmers were crushed to death on Sunday.

Besides Priyanka, State Congress president Ajay Kumar Lallu, Congress MP Deepender Hooda, national secretary Dheeraj Gurjar, Youth Congress national president BV Srinivas, party MLC Deepak Singh were taken into preventive custody.

Priyanka claimed that she had been detained for the last 28 hours without any order or FIR, which the Congress

alleged that drones were being used to monitor the movement of Priyanka at PAC guest house. Ćhhattisgarh

Minister Bhupesh Baghel tweeted a video of drones monitoring. "Who will take responsibility, whose drone is this and why," he tweeted.

Congress MP Deepender Hooda who accompanied Priyanka on way to Lakhimpur Kheri and is on detention, in a tweet said. "Those who mowed down farmers are free and we

are in detention for over 36 hours. Farmer families are mourning and the Government is celebrating in Lucknow. I wish to ask fellow Indians whether they will support those who ran over farmers or those

fighting against this violence." In Delhi, Shiv Sena leader Sanjay Raut met Congress leader Rahul Gandhi and asked for a joint Opposition action plan to take on the BJP both at Centre and State Uttar Pradesh. Continued on Page 2

Siding with the farmers on the violent accident that led to eight deaths in Uttar Pradesh's Lakhimpur district, BJP MP Varun Gandhi on Tuesday tweeted a viral video that appears to show farmers being run over by an SUV. Varun is the only BJP leader who has been publicly

backing the farmers, demanding and advocating their respectful treatment and has taken a position away from the official BJP line on the issue.

"This video will shake anyone's soul," the BJP leader wrote appealed "immediate arrests".

"In Lakhimpur, the video that shows cars running over farmers will shake anyone's soul. Police should take note of this video and identify the owners of the car, those sitting in the car and others involved to make immediate arrests," the BIP MP from UP's Pilibhit said in a tweet in Hindi.

The viral video — which has been shared by many in the Opposition — is yet to be verified by the police.

MP only BJP leader who has been publicly backing farmers



No arrests have been made in the Lakhimpur violence which has now become a national issue with all Opposition parties criticising the ruling BJP over the handling of the case.

Union Minister of State for Home Ajay Kumar Mishra's son Ashish Mishra is the only person named in the murder case. He has denied he was at the spot and claimed that he was attending a wrestling programme away from the place of the incident.

Just 41% of them felt it's good to get support for mental health problems

PNS NEW DELHI

Around 14 per cent of 15 to 24-year-olds in India, or 1 in 7, have often felt depressed, but the situation got worse for them during the ongoing Covid-19 crisis. And yet just 41 per cent were willing to take support, compared to an average of 83 per cent surveyed from 21 countries, according to UNICEF report on mental health "The States of the World's Children 2021" released by Union Health Minister Mansukh Mandaviya on Tuesday here.

"Fear. Loneliness. Grief. mental health." As the coronavirus pandemic descended on the world in 2019, these powerful emotions enveloped the lives of many millions of children, young people and families," the report



said. "In the early days especially, many experts feared they would persist, damaging the mental health of a generation. In truth, it will be years before we can really assess the impact of Covid-19 on our on our

The survey, carried out for UNICEF by Gallup in 21 countries in the first half of 2021, found that Indian youth are less willing to share their feelings of lowness.

"A median of 83 per cent of young people (15 to 24 years old) agreed it was better to deal with mental health problems by sharing experiences with others and seeking support; by contrast, only 15 per cent felt such problems were personal and should be dealt with on one's own," it said. "Among the 21 countries, India was the only exception, with only 41 per cent of young people supporting the sharing option."

Releasing the report, Minister Mandaviya said 'Mental health has widely been discussed in our Sanatan culture and spirituality. The mutual development of mind and body has been explained in our a healthy body. We are very happy that today UNICEF has released a global report on the mental health of children."

He added as the trend of nuclear family instead of joint family has increased in our society, mental health problems have become frequent in children. "Today parents are not able to give enough time to their child, so we need to talk about mental health," he said.

Mandaviya further said, To build a better and developed society, it is necessary to keep monitoring the mental health of children from time to time. For this, arrangements will also have to be made for better mental health of teachers in schools. Because, children trust their teachers

Registration delay of pyt vehicles to attract fine of 300/month, ₹500/m for commercial vehicles

PNS NEW DELHI

The Centre on Tuesday announced that the renewal of registration of vehicles over 15 years old is all set to be a very expensive affair from April 2022. The Centre announced to hike the renewal fees of such vehicles by eight times and introduced a penalty clause for the delay.

The renewal registration of a 15-year-old car will cost ₹5,000 compared to the existing ₹600. The charges for registration renewal of old bikes would be ₹1,000 compared to the current ₹300.

For a 15-year-old or more bus or truck, the owner will have to pay a fee of ₹12,500 compared to the current rate of ₹1,500, said a notification by the Road Transport and

Highways Ministry. Further, any delay in

renewing the registration of private vehicles would attract a penalty of ₹300 per month and ₹500 for commercial vehicles, and commercial vehicles would have to pay a daily penalty of ₹50. Owners of private vehicles

need to get the registration renewed every five years after 15 years. And once a commercial vehicle attains eight years, fitness certificate renewal

becomes mandatory every year. The prime aim of this new fee is to discourage people from keeping their old vehicles. The Government also intend to do away with the manual system of a fitness test, as this can be manipulated or rigged,"

Delhi Govt resends doorstep scheme file to LG for nod


DECISION ON CONTROL OVER ADMINISTRATIVE SERVICES

SC to set up Bench to hear Delhi Govt's plea

on Tuesday said it would set up a three-judge Bench to hear the AAP Government's plea on the contentious issue of who should control administrative services in Delhi. The plea arises out of a 2019 split verdict. On February 14, 2019, a twojudge Bench of Justices AK Sikri and Ashok Bhushan, both retired since, recommended to the Chief Justice of India that a three- judge Bench be set up to finally decide the issue of control of services in the national Capital in view of its split verdict

Justice Bhushan had ruled that the Delhi Government has no power at all over administrative services. Justice Sikri, however, made a distinction. He said the transfer or posting of officers in top echelons of the bureaucracy (Joint Director and above) can only be done by the Central Government and the view of the Lieutenant-Governor would prevail in case of a difference of opinion for matters relating to other bureaucrats.

"We have to constitute a Bench after the Dussehra vacation. The plea would be listed after Diwali break," a Bench of



Chief Justice NV Ramana and Justices Surya Kant and Hima Kohli told senior advocate Rahul Mehra who mentioned the Delhi Government's plea for urgent listing and hearing. Following a five-judge Constitution Bench judgment, police, land and public order were to be under the control of Government added. the Centre and the rest of the subjects, including the services, should remain under the Delhi Government, Mehra

"It is the matter pertaining to the issue of services which find mention in Entry 41 of list II of the Constitution. The two-judge Bench expressed

divergent views and the matter was before a three-judge Bench. Since the entire administrative control vests currently with the Centre, it is an important issue and impedes on the ability of the Delhi Government to govern and implement its policy," the counsel for the Delhi

Earlier, the top court, which was hearing pleas on six matters pertaining to a long-running conflict between the Centre and the Delhi Government, had given a unanimous order on the remaining five issues except the control over services.

Environment Minister
Gopal Rai said that 13 hotspots
were identified in Delhi last
year, this time 150 hotspots have been identified. A 21member team has been formed for the Green War Room. Through the Green Delhi app, citizens of Delhi can send a pollution-related complaint to the Green War Room based on which action will be taken.

Rai said that last year 27,000 complaints were received through the app, out of which more than 23,000 complaints have been resolved. The maximum number of complaints came from the Municipal Corporation of Delhi, the Delhi Development Authority (DDA) and the Public Works Department (PWD).

"The app serves as a central point of coordination through which residents of Delhi, when encountered with pollution, can convey the complaint to this war room enabling the Government to take further action.

AAP Govt launches | Free ration for **Delhiites sans** ration cards

Cabinet approved ₹48 crore for procurement

STAFF REPORTER ■ NEW DELHI

The Delhi Cabinet on Tuesday decided to continue providing free ration to people without ration cards. Under the chairmanship of Chief Minister Arvind Keiriwal, the decision has been taken and it is expected to benefit 40 lakh non-PDS beneficiaries in the city.

For this, the Cabinet

approved ₹48 crore for procurement, distribution and transportation of food grains. In this, ₹42 crore will be spent on the purchase of food grains. About ₹2 crore will be spent on transportation. While ₹3.6 crore will be paid to civil defense employees.

The Food and Supplies department has identified 100 places in different areas and 16,000 metric tonnes of wheat and 4,000 metric tonnes of rice would be required by the Delhi Government to provide free ration to 40 lakh non-PDS beneficiaries. The AAP Government will buy this quantity from the Food Corporation of India.

The rights group said Sadiqullah Abed, the Taliban-appointed chief of police for Daykundi, denied any killings had happened and only said that a member of the Taliban had been wound ed in an attack in the province.

The Taliban took control of Daykundi province on Aug. 14, according to the Amnesty report, and an estimated 34 former soldiers sought safety in Khidir district. The soldiers, who had government military equipment and weaponry with them, agreed to surrender to the

Mohammad Azim Sedaqat, who led the group's surrender, arranged to decommission the weapons in the presence of Taliban members.

On August 30, an estimated 300 Taliban fighters arrived in a convoy close to Dahani Qul village, where the security forces members were staying, some with family members, according to Amnesty's report.

As the security forces attempted to leave the area with their families, Taliban fighters caught up with them and opened fire on the crowd killing a 17-year-old girl named Masuma. One soldier fired back, killing a Taliban fighter and wounding another.

Delhi Congress slams UP Govt for detaining Priyanka IIT- Kanpur

Delhi Congress accused the Centre and the Uttar Pradesh Government of "violating" all democratic norms by detaining Congress leader Priyanka Gandhi for over 30 hours to prevent her from visiting the family members of the farmers who were murdered at Lakhimpur Kheri.

Delhi Pradesh Congress Committee president Anil Kumar said that the party organised demonstrations at BJP offices in all the 14 districts onTuesday to protest against the murderous attacks on the



Despite its depleting number of fighter jets, the IAF will be able to have the sanctioned 42 squadrons only after the next 10-15 years even though it has, of late, inducted several new planes, IAF chief V R Chaudhari said here on Tuesday.

Sounding this note of caution in the backdrop of ever present threat of a two-front war simultaneously with China and Pakistan, he also said the IAF will manage to have 35 squadrons only in the coming ten years. One squadron has 18 to 20 jets and the IAF, at present, has only 30 odd squadrons of fighter jets.

On the present situation at the Line of Control (LAC)in Eastern Ladakh, Chaudhari said China has built three airfields in that region on its side. However, it remains to be seen as to how their fighter jets will take off from high altitude.

 $T^{\text{he Election Commission}}_{\text{(EC) on Tuesday allotted}}$ new party names and symbols to Chirag Paswan and his uncle Pashupati Kumar Paras, days after the poll panel barred Lok Janshakti Party (LJP) factions from using the party name and symbol.

In separate letters to Paswan and Paras, the EC announced that the Lok Janshakti Party faction led by Chirag Paswan will be called LJP (Ram Vilas) and have the symbol of a helicopter, while the Pashupati Kumar Paras faction will be called Rashtriya Lok Janshakti Party and will have the symbol of a sewing

"Having considered the request, the Commission has allotted the name Lok Janshakti Party (Ram Vilas) for your group and has allotted the helicopter as the symbol to be allotted to the candidate set up, if any, by your group in the current by-election," read a directive issued by the EC to Chirag.

In another order issued to Paras, the EC said, "Having considered your request, the Commission has allotted the name Rashtriya Lok Janshakti Party for your group and has allotted the symbol 'Sewing Machine' to be allotted to the candidate set up, if any, by your group in the current by-elec-



The names and symbols have been allotted to both the parties to contest the upcoming bypolls to two assembly seats in Bihar. The elections will be held on October 30.

In an interim order on October 2, the EC had asked Paswan and Paras to choose interim names and symbols for the bye-polls by 1 pm on Monday. It had barred both the factions from using the name of LJP or its symbol "bungalow," till the dispute is resolved. It also directed both the factions to submit documents supporting their claim to represent the party by November 5. The poll body has yet to pass an order on which faction to retain the original LJP symbol.

Both Chirag and his uncle Paras had a few months back parted ways amid a dispute over the running of the party and are fighting for the right to

use the LIP name and its sym bol. In June, the Lok Janshakti Party had plunged into a crisis after five of its six Lok Sabha MPs rebelled against Chirag. The rebel MPs had told Lok Sabha Speaker Om Birla that they have chosen Paras as the party's leader in Parliament. The development, effectively a coup against Chirag, came less than a year after his father and former Union Minister Ram Vilas Paswan died in October. He was the founder of the Lok Janshakti Party.

After Birla named Paras as the leader of the Lok Janshakti Party in the Lok Sabha, Chirag had approached the Delhi High Court challenging the move.

The LJP was formed by former Union Minister Ram Vilas Paswan in 2000. Paswan, a heavyweight leader in Bihar politics, passed away in October 2020.

Terrorists kill 3 in Kashmir

In a series of attacks 'unidentified' terrorists shot dead three persons, including a renowned medical store owner Makhan Lal Bindroo near Iqbal Park area of Srinagar on

Monday evening.

According to police the first attack took place around 7.20 p.m, second after a gap of 30 minutes in which a nonlocal vendor was also shot dead near Madina Chowk, Lal Bazar area of Srinagar. The third incident was reported from Shahgund area of Bandipora where a civilian was shot dead from a close range.

According to the twitter handle of the Jammu and Kashmir police, "Terrorists fired upon Owner of Bindroo Medicate namely Makhan Lal Bindroo near Iqbal Park Srinagar. He was shifted to hospital where he succumbed to his injuries. Area cordoned off & search to nab the terrorists is going on".

In another tweet Kashmir Zone Police said, "Terrorists killed one non-local near Madina Chowk Lalbazar Srinagar. The deceased person has been identified as Virender Paswan resident of Bhagalpur Bihar, a street hawker, presently residing at Alamgari Bazar Zadibal. Search in the area is in

in Bandipora has been identified as Mohd Shafi Lone resident of Naidkhai.

These three back to back attacks came close on the heels of targeted killing of several policemen and leaders belonging to the minority community and political leaders.

According to reports, Makhan Lal Bindroo had not migrated from Srinagar even during peak militancy and stayed back.

Aakash Mehra, son of a famous Krishna dhaba owner, was shot at by a motorcycle borne terrorists in Sonwar area of Srinagar on Feb 17, 2021. He succumbed to his fatal injuries, 11 days later in the SMHS hospital in Srinagar.

Before him, a famous jeweller Satpal Nischal from Punjab settled in Srinagar for several years was killed from a close range in the first week of

LG Manoj Sinha condemned the attacks. 'Deeply anguished to hear about the terror attack on Shri Makhan Lal Bindroo, owner of Bindroo Medicate. I strongly condemn this cowardly act. M. Nerlikar, who sent them to the NCB's custody till Monday next. The new four arrests were

made in the case late on Monday and Tuesday, of them, the name had cropped up during the questioning of two arrested accused Aryan and suspects that the drugs used at the rave party held on a Goabound cruise ship on Saturday night might have been bought by the youngsters using cryp-

Meanwhile, informed sources in the federal anti-agency said that the NCB had arrested four persons linked to M/s Namas'cray Experience Private Limited, which organised a rave party on board the Goa-bound Cordelia Cruises' Empress ship. All the newly arrested persons

Canara Bank's ex-chief manager sent to 5 years in jail, 3 others get 3-yr RI

Pune-based Special CBI ACourt on Tuesday sentenced a former chief manager of Canara Bank to five years' rigorous imprisonment and three others company employees of two private companies to three years of rigorous imprisonment for allegedly defrauding the Bank by way of discounting of 246 bills against Letters of Credit (LCs) issued by it.

The CBI court handed out five years' rigorous imprisonment to S R Hegde, then Chief Manager, Canara Bank, Deccan Gymkhana Branch, and imposed a fine of Rs 1 lakh on him.

The court sentenced Ganesh Kolhe and Ganesh Gaikwad, then Account Assistants M/s. Varron Aluminium Pvt. Ltd. & M/s. Varron Auto Comp Pvt. Ltd., to undergo three years' rigorous Imprisonment. It imposed a fine of Rs. 1.5 lakh on Kolhe, while the judge levied a fine of Rs 1 lakh on Gaikwad

There needs to be more clarity from the Supreme Court on people's right to protest

■he ongoing farmers' protest demanding repeal of the three agricultural laws may see the Supreme Court lay down the parameters for people to exercise their right to protest. Justice AM Khanwilkar, hearing a petition of a farmers' organisation seeking permission to sit on a 'satyagraha' at Jantar Mantar in Delhi, asked how can there be a protest when the matter is *sub judice*. He meant that no reason for protest exists because the court had already stayed the three controversial laws and the Government has also assured that it will not give effect to it. Is the judge implying that people cannot exercise their right to protest when their challenge of the constitutionality of a law is being heard by the court? The second issue is that the protest is against the executive that brought in the farm laws and the demand is for repeal, while the petition is before the judiciary, which is an altogether separate



constitutional body. A former Chief Justice of India, Justice SA Bobde, while hearing a PIL for suspending the farmers' protests, had said: "We clarify that this court will not interfere with the protest in question. Indeed, the right to protest is part of a fundamental right and can, as a matter of fact, be exercised subject to public order." That the court refused to interfere with the protests when it was hearing a case about the farm protests shows that the issue of sub judice was not in the frame of the court's thought or reasoning at that time. Secondly, the court also clarified whether the

right to protest was part of a fundamental right. Thirdly, the court clarified that the reasonable restriction on that right is that it should be peaceful. Fourthly, in February 2020, in a case related to Delhi's Shaheen Bagh protests that lasted quite some time, the Supreme Court said: "...the law is facing constitutional challenge before this court but that by itself will not take away the right to protest of the persons who feel aggrieved by the legislation." That was the clearest ruling by the court on the sub judice question. It is only now that the matter has been aired by the court in the farmers' protest case. Since the court wants to frame legal questions on the issue, it is pertinent to note that questioning whether a group wanting the court to check the validity of the farm laws can simultaneously protest on the same issue will lead to the interpretation that the right to protest is mutually exclusive from the right to challenge the constitutionality of a law. While awaiting the court's indulgence, it must be pointed out that the farmers' protest is for total repeal of the laws and nothing else. That means the surest way to deal with the farmers' petition is to subject the constitutionality of the three farm laws to judicial scrutiny.

Cough, cough!

It's that time of the year again when Delhi suffocates due to smog and pollution

illi ki sardi' is infamous; yes, for its biting cold but especially for the pollution and smog that hang heavy in the air. After what seems like a respite from the COVID-19 pandemic, the Capital might again be headed for its annual date with the much-dreaded winter spell of smog and all the accompanying ailments. According to a March 2021 report by a Swiss organisation, IQAir, Delhi



happens to be the world's most polluted Capital city and the 10th most polluted city overall. Smoke from paraali (paddy stubble) burning in the NCR as well as harmful fumes and particles trapped in air only worsen the conditions. With little means to expel the toxic elements, Delhiites are forced to gasp for breath. Despite the severity of the situation, no significant progress has been made for decades. The brief implementation of the "oddeven" rule by the AAP Government, which the Supreme Court correctly tagged as a "half-baked solution", was never a practical solution in the long

run. Also, the monthly efficacy report of the "first" smog tower installed in Delhi's Connaught Place area is due later this month.

In view of the prevailing situation, Chief Minister Arvind Kejriwal has announced a 10-point "winter action plan" to make the air "breathable" this winter. It includes decomposer for paraali as an alternative to burning, keeping a check on construction and demolition sites under the anti-dust campaign, levying a hefty fine on burning waste, ban on crackers, likely installation of more smog towers and setting up India's first e-waste park for safe recycling and disposal. The next few weeks will foretell what all these measures end up in. Meanwhile, playing his old tune. Kejriwal alleges that the Central and the Governments of the neighbouring States did not take efficient steps against stubble burning which leads to air pollution in Delhi but the question remains did he equip Delhi enough? Kejriwal's basket of promises to woo Punjab voters ahead of the Assembly polls also did not mention anything about paraali. It's a question worth pondering that if he makes successful inroads into Punjab, would he deal with the situation there as sternly? He had said that the Pusa Decomposer was a perfect foil to stubble burning and hoped that "2020 would be the last year to suffer from air pollution"; now how that works out is to be breathed!

Attestation parades: Good, bad and ugly ASHOKKMEHTA

n the salubrious climes of Shillong, I am attending the attestation and passing out parade of the 192nd batch of recruits and veterans' reunion in Happy Valley where 58 Gorkha Training Centre is nestled among pine conifers and gentle slopes luxuriating in grass. Rain can be a spoilsport as Cherrapunji, the world's biggest recipient of rain, is just around the corner. Luckily, the parade was blessed with sunshine as 256 recruits passed through an archway of khukris to turn into Riflemen, who will join their battalions in East Ladakh to Arunachal Pradesh and Tangdhar to Thiruvananthapuram. Young Gorkhas performed drill with Omega precision, pride and pageantry, watched over by Colonels of the two Regiments — 5 GR and 8 GR and veterans from India and Nepal. Swearing on the Gita, recruits from Nepal and India took the oath pledging allegiance to security and integritv of India by obeying orders from their officers and commanders as authorised by the President of India even if it involved sacrificing their lives. The foundational structure of the oath is the Constitution of India although the word 'Constitution' does not figure. What appears in the oath is 'vidhan' (legislation), not 'samvidhan'. Wonder why?

On commissioning, officers take the same oath at military academies. Army chief MM Naravane, on taking over, said "the Army will be guided by the Constitution", implying its insulation from ideas and vision of political parties, especially the ruling establishment. Pointed deviations from the military's ethics and ethos have occurred through directions of political leadership. This infringement of military values is markedly visible since the BJP came to power with its vision of turning India into a Hindu Rashtra with a military that follows its tenets. The BJP has won over the majority of the military which acknowledges the impressive emphasis by the BJP on defence and national security even if the Government will not walk the talk on funding for modernisation. The Congress by contrast was a laggard on defence reforms and transforming the



archaic military structures.

In Shillong, the flavour at the attestation parade and associated ceremonies was strictly apolitical and secular. In the commentary accompanying the parade during the carriage of the Gita through the rank and file of recruits was this memorable passage: "We respect equally the temple, mosque and Church. In one hand is the *Gita* and in the other, the *Quran*." These words and deeds were quite the opposite of the attestation parade of recruits at the Artillery Centre, Deolali, recently. Artillery is a mixed-class all-India regiment where soldiers are drawn from all faiths.

At this parade, surprisingly, aarti was recited on the parade, with recruits and soldiers clapping in unison. On a prominent boulder on the parade ground was enshrined the symbol 'Om'. Together, aarti and 'Om' celebrate a single religion, smacking of majoritarianism. This was the first time ever that aarti was sung on an official parade, attracting adverse comments on social media. In Shillong, too, the aarti

was sung but in its proper place, the temple, representing the faith of the single class regiment of Gorkhas from India and Nepal. Owing to the shortage

of Indian-domiciled Gorkhas, some regiments are now recruiting Kumaonis and Garhwalis till the Indian-domiciled Gorkhas can fill up their quota of vacancies. The only deviation in Shillong from regimental traditions was the introduction of 'Bharat Mata ki jai' as the decisive chant ending all formal functions even after the national anthem.

The BJP has managed to infiltrate majoritarianism and Hindutva into the military. The Hindu-ised version of the procedure followed at the Artillery attestation parade could be a trial balloon to codify aarti in other mixed-class regiments of the Army. This must have had the backing of the military establishment. So far, neither the MoD nor Army Headquarters has commented on this serious breach of Army rules and procedures for attestation parades. It is a crafty method to influence faith and religion at the very inception of a soldier's military career and is bound to disturb the secular traditions of the Army.

The Gorkha attestation parade combines every four years the reunion of veterans and their families from India and Nepal. Reunions are a perfect stimulus for bonding between the old and new. Regimental traditions, ethics

and habits are therefore preserved. Regimental spirit is the strongest elixir. While Gorkhas are relaxed about religion and many are janjatis, they practise their religion and faith in the battalion mandir. Their officers are from across India: Sikhs, Hindus, Muslims, Parsis and Gorkhas. A Sikh or Parsi Commanding Officer will lead the mandir parade every Sunday. The mandir along with the religious teacher will

accompany the unit into battle.

While the military is on the threshold of path-breaking defence reforms, its leadership must not permit the creep of practices and procedures that will undermine its professional, secular and apolitical virtues. Politicisation will weaken the operational capacity and jointness of the Army, which is the sword arm of the nation. Discard the Deolali model; take the Shillong way.

Sir — We were baffled as to why the Supreme Court made the observations on the farmers' protests that it made. With all due respect, the riposte to its poser 'What is their protest for when the farm laws are stayed?' is that it is to persuade the Government to repeal the farm laws 'repeal' being the operative word. We need to draw a distinction between 'staying the implementation of a law' and 'repeal of a law'. And, the two words 'stay and 'repeal' are not interchangeable.

The farmers are not okay merely with suspending the laws for 18 months or the 'delay' in implementing the laws. The 'stay' won't make the laws any better. It is erroneous to say that the laws are not in place at the moment when they are just on hold. Sadly, recently the Supreme Court accused the farmers of 'strangulating' the city with their protests'. In a democratic setup, people are quite within their rights to protest against the laws enacted by Parliament. The only condition that can be set is that the protest should be peaceful and nonviolent. The mere fact that a matter is sub judice before a court cannot strip the people of their right to protest which the country's top court itself declared a fundamental right.

Modi era: The tectonic shift in Indian politics and governance



orn poor but rising to become Prime Minister of India, Narendra Modi's life journey defines the power of Indian day was not mere chance that propelled Modi to the highest office but the consequence of years of hard work, service and sacrifices that prepared him for the long journey ahead. On October 7, he would complete 20 years as an elected head of government. The two decades of the Modi era stand out for the tectonic shift they have brought about in Indian politics and governance. AsChief Minister of Gujarat, he faced innumerable challenges but tackled them with steely determination and compassionate zeal. The first was the devastation caused by the earthquake in Guiarat. He took that as an opportunity to lay the foundation to transform Gujarat into a world-class investment destination. During his tenure as CM, Modi introduced governance reforms focused on deepening inclusion and enhancing accessibility through technology. Under the 'SWAGAT' initiative, he would interact with people once



a month to resolve their issues. He would be joined by senior officers through video conferencing to ensure quick resolution of people's grievances. The programme was recognized by the UN as one of the best initiatives to enable people to reach the government through technology. After assuming prime ministership, Modi launched a multipurpose and multi-modal platform PRAGATI (Pro-Active Governance And Timely Implementation). In each session, PM reviews the status of projects and schemes to resolve any lacunae.

As CM, he began spending three days every year in villages where literacy rates were low and encouraged people to send girls to school. The push for girl child's education was further supported by his move to build separate toilets for girls in school on a massive scale. He launched the Jyotigram Yojna to push for a complete overhaul of the power sector in Gujarat. He set the target of 1000 days for 100 per cent electrification in all villages. In 2006, Gujarat was declared the first state to achieve 100 per cent village electrification. Post 2014, PM Modi found a bigger canvas to implement his vision for social transformation, making 'Jan Andolan' an integral part of his governance model. From Swachh Bharat Mission to India's fight against Covid-19, his unique style of connecting with the masses is prevalent in all his flagship schemes and initiatives. On every front, Narendra Modi has walked the talk, both as the CM and now as the PM. From the time he took oath as the CM, he shunned politics of divisiveness and spoke of development for all. If Vibrant Guiarat Summit catapulted Guiarat as a cynosure of global investors, 'Make in India' affirmed India's position in the global supply chain. During the pandemic, India displayed its rising prowess as it expanded its manufacturing capabilities to produce and export PPE kits, N95 masks and even came to the world's rescue exporting essential medical supplies to those in need. In a post-pandemic world, global chains are being restructured and India finds itself in a sweet spot, having a government that is primarily focused on creating a conducive environment for manufacturing sector to flourish. As CM of Guiarat, Narendra Modi spent considerable amount of time in understanding the gaps within the system as well as the ground realities. He deep dived into every aspect of governance, only to bring out the most innovative, technology driven, holistic solution to overcome years of inertia that impeded progress. He put in practice more than a decade of learning as he took office at the Centre. It is his 'tapasya' of 20 years that is leading to a national reawakening to see India's rise as a global powerhouse.

Exposing Pak's role in Taliban takeover

he swift takeover of Afghanistan by Taliban was a culmination of cunning and conspiratorial moves by Pakistan's Inter-Services Intelligence (ISI), outsmarting the American leadership on the one hand and planting its jehadi cohorts in the ranks of the Afghan national defence forces on the other, without an inkling of its designs to the allied forces or

the Afghan government.

In 2001, when the first edition of Taliban was ousted in Afghanistan post 9/11, the US forces did not have their boots on the ground immediately. Their only option was to conduct air strikes but it needed domination on the ground to capture and control the territory. So, the US entered into an agreement with anti-Taliban groups who would capture the ground and hand it over to the American forces.

From its bases in the CIS countries, the US air force conducted airstrikes at Taliban bases situated across the territories controlled by the anti-Taiban forces. The latter would then capture and hand over these aerially attacked areas to the Americans.
The anti-Taliban forces had a pre-con-

dition: Hand over power in Afghanistan to the military grouping once the American objectives, including killing Al Qaeda boss Osama bin Laden, were achieved.

However, the US put a rider that power cannot be shared or handed over to an armed group but can only be done in a democratic manner. The US ensured that Hamid Karzai was made President of Afghanistan in 2004.

To enter the governance mechanism put in place by the US, the armed groups formed political fronts that were headed by the insurgents. However, the US did not accept the insurgents as the leaders and put Karzai at the helm of affairs. All the insurgent groups opposed to Taliban accepted the leadership of Karzai who was from the royal lineage of Afghanistan with historical influence in the erstwhile Ottoman

For capturing Taliban-controlled territories, the anti-Taliban groups told the US that they do not have enough fighters to capture all of Afghanistan and sought recruitment to ramp up their strength. But the US could not have allowed recruitment of fighters.

At this stage, a second agreement between the US and such groups was reached for the raising of an armed force. Such insurgent groups were also allowed to join the officially raised armed forces and also recruit soldiers. The training support and weapons supplies were to come from

Between 2003 and 2005, the scheme of raising the armed forces continued and a one-lakh-strong force was formed. The anti-Taliban groups then told their US partners that this number was not enough as the Taliban too had a similar number of fighters. They wanted the Afghan national armed force to be doubled.

However, every insurgent group oppos-

Force's strength reaching 1.5 lakh. The Afghan government then allowed recruitment of another 50,000 men from areas other than those under the control of the insurgent groups backing the Kabul government, saying the move will boost employment. The US acquiesced. During 2005 and 2010, the

Afghanistan government held recruitment camps in the Khyber Pakhtunkhwa region of Pakistan populated by the Afghan refugees.

The idea was that the candidates from this region would have knowledge of the area and serve to contain the Taliban there. However, no background checks were made and recruitments were based on vetting by respective leaders of the various tribes they belonged to.

"In the process, the then Afghan government committed two mistakes, one being recruitment from an area in Pakistan and the other being lack of background checks of the candidates. Due to these two faults, the ISI got a breathing space for manipulation," said counter-terrorism expert and an Afghanistan watcher Ajmal Sohail.

The IŚI fabricated and provided refugee cards to Pakistani citizens of Pashtun origin and facilitated their recruitment in the Afghan national defence forces. The ISI move ensured free training and weapons to its men deployed in the Afghan regular force waiting for the final message from the ISI to act on its designs. At least 50,000 such Pakistani men were planted in the Taliban. These men were trained in the US and allied countries including India where they were exposed to the military training infrastructure, Sohail further said.

To register their presence, the Pakistanis on the rolls of the Afghan army conducted drone strikes on the fellow Afghan army men which was widely known as Green Beret attacks. This continued for twothree years between 2010 and 2014. Subsequently, the American forces identified the game plan of ISI and stopped such attacks, he said.

The ISI-Pakistan army combine also launched operations against Tehreek-e-Taliban Pakistan (TTP) that was opposed to it. This pressured the TTP cadres to flee to Afghanistan where they were targeted by the ISI's plants in the Afghan national defence forces. These 50,000 Pakistanis became influential in strategic planning.

Now, the ISI launched yet another propaganda warfare claiming that the Afghan army, being a blueeyed boy of the international community, may attack the Pakistan 15 years ensured both weapons and army. The Pakistani propaganda strengthening the Taliban in the area.

The Afghan army again requested for recruitment of another one lakh personnel in its ranks for which the US agreed. By this time, the Afghan army had become both complacent and corrupt, experts said. The US provided the funding and weapons but the recruitments never took place. So, out of the three-lakh-strong Afghan army, 50,000 men were planted by the IŚI and another one lakh was never

recruited. Out of the remaining 1.5 lakh Afghan army, a significant number of them were compromised by ISI's men in the Afghan army ranks, they said, adding this was the reason for Afghan forces melting quickly in the face of Taliban onslaught in August.

Having created a significant threshold of strength, the Taliban launched aggression early last year before the talks for the peace deal with the US began. The direct negotiations between the US and the Taliban led the Pakistan government to declare that it will not recognize the outcome of the talks.

Subsequently, tripartite meetings between the US, Pakistan, and Taliban were held in Doha for negotiations on the contours of the troops' withdrawal. Since the US had decided to withdraw its troops from Afghanistan, it was cornered and signaled an end of India's influence in Kabul.As part of the deal with the Taliban, the US would hand over bases to whichever side between the Taliban and Afghan national army wins.

"The ISI machinations for 10resources to the Taliban besides men trained by the US and its allies in its ranks. These factors helped the Taliban in capturing territory rapidly within a matter of just 10 days as against the Pentagon estimate of Kabul falling to the Taliban in 18 months," Sohail said.

In this backdrop, calls by American lawmakers for a US Congress report on the nexus between Pakistani agencies and Taliban leading to the fall of Kabul to the hardline group is more than

Macron wants G20 to pressure Taliban to give girls a future

rench President Emmanuel Macron said on Tuesday he wants the Group of 20 major economic powers to set conditions for recognising the Taliban, including ensuring women's and girl's rights.

So far under the Taliban, young Afghan girls have been allowed to return to primary school but older girls have been barred from going to high school and most women have not been allowed to return

Macron said on France-Inter radio that global powers should tell the Taliban: "You must absolutely give young girls in your country a future, and that is one of the things that we will look at before recognising you."
He said that allowing all

girls back to school is one of his concerns.

Macron also told France-Inter radio that he would raise the issue at the upcoming G20 summit in Rome later this month. Among other conditions for recognition, he said,

Chinese military activity near Taiwan | French report: 330,000 provocative & destabilising: US

Declaring that America's commitment to Taiwan was "rock-solid", the US has told China that it will continue to watch very closely the "provocative" and "destabilising" Chinese military activities near the self-ruled island.

Taiwan"s Defence Ministry said 56 Chinese warplanes made incursions into its air defence identification zone on Monday, the highest number since the island began publicly reporting such activities last

China views Taiwan as a breakaway province. However, democratic Taiwan sees itself as a sovereign state. Beijing has not ruled out the possible use of force to achieve unification Responding to questions

on the issue of Chinese warplanes frequently entering Taiwan"s air defence zone, White House Press Secretary Jen Psaki told reporters at her daily news conference on Monday that, "We remain concerned by the People"s Republic of China"s provocative military activity near Taiwan, which is destabilising risk miscalculations and undermines regional peace and sta-



"We urge Beijing to cease its military, diplomatic, and economic pressure and coercion against Taiwan, and we have an abiding interest in peace and stability across the Taiwan Strait," she said.

"That"s why we will continue to assist Taiwan in maintaining a sufficient self-defence capability. We maintain our commitments, as outlined in the three communiques, Taiwan Relations Act, and the Six Assurances," she said. America's commitment to

Taiwan is "rock-solid and contributes to the maintenance of peace and stability across the Taiwan Strait and within the region," Psaki said.

"We have been clear, privately and publicly, about our concern about the PRC"s pressure and coercion toward Taiwan, and we will continue to watch the situation very close-' she said.

Meanwhile, Department Spokesperson Ned Price told reporters that the US is very concerned by China's provocative military activity near Taiwan.

This activity is destabilis ing. It risks miscalculations and undermines regional peace and stability. We strongly urge Beijing to cease its military, diplomatic, and economic pressure and coercion against Taiwan," he said.

"Our commitment to Taiwan is rock solid. It contributes to the maintenance of peace and stability across the Taiwan Strait and within the region, and we'll continue to stand with friends and allies to advance our shared prosperity, security, and values. We will do that as we continue to deepen our ties with Taiwan," Price

major French report Areleased Tuesday found that an estimated 330,000 children were victims of sex abuse within France's Catholic Church over the past 70 years, in France's first major reckoning with the devastating phenomenon.

The president of the commission that issued the report, Jean-Marc Sauve, said the estimate, based on scientific research, includes abuses committed by priests and others clerics as well as by non-religious people involved in the church. He said about 80 per cent are male

"The consequences are very serious," Ŝauve said. "About 60 per cent of men and women who were sexually abused encounter major problems in their sentimental or

The 2,500-page document prepared by an independent commission comes as the Catholic Church in France, like in other countries, seeks to face up to shameful secrets that were long covered up.

The report says an esti-

two-thirds of them priests worked in the church during that period. Sauvé said the overall figure of victims includes an estimated 216,000 people abused by priests and other clerics.

Olivier Savignac, head of victims association "Parler et Revivre" (Speak out and Live again), who of the Association of the Ass probe, told The Associated Press that the high ratio of victims per abuser is particularly "terrifying for French society, for the Catholic Church." The commission worked for 2 1/2 years, listening to victims and witnesses and studying church, court, police and press archives starting from the 1950s. A hotline launched at the beginning of the probe received 6,500 calls from alleged victims or people who

said they knew a victim. Sauvé denounced the church's attitude until the beginning of the 2000s as "a deep, cruel indifference toward victims." They were "not believed or not heard" and sometimes suspected of being "in part responsible" for what happened, he deplored.

Russian film crew blasts off to make 1st movie in space

Russian actor and a film Adirector rocketed to space Tuesday on a mission to make the world's first movie in orbit. a project the Kremlin said will help burnish the nation's space

Actor Yulia Peresild and director Klim Shipenko blasted off for the International Space Station in a Russian Soyuz spacecraft together with cosmonaut Anton Shkaplerov, a veteran of three space missions. Their Soyuz MS-19 lifted off as scheduled at 1:55 p.m. (0855 GMT) from the Russian space launch facility in Baikonur, Kazakhstan and arrived at the station after about 3½ hours.

Shkaplerov took manual controls to smoothly dock the spacecraft at the space outpost after a glitch in an automatic docking system.

The trio reported they were feeling fine and spacecraft systems were functioning normally. Peresild and Klimenko are to film segments of a new movie titled "Challenge," in which a surgeon played by Peresild rushes to the space station to save a crew member who suffers a heart condition.

UK urged to tackle 'dirty money' after leaked Pandora papers

London:Britain's Conservative Government is facing calls to tighten the country"s defenses against "dirty money" after a massive leak of offshore data showed how London, in particular, is the destination of choice for some of the world"s richest and most powerful people to conceal their cash. The cache of almost 12

million files, which has been dubbed the "Pandora Papers," was published Sunday by the International Consortium of Investigative Journalists and its media partners, including Britain"s Guardian newspaper and the BBC. The U.K. and London

specifically are prominent in the data dump, with the documents showing how wealthy people around the world report-edly set up offshore companies to buy property and avoid taxes.

Foreign individuals identified as beneficiaries of these types of offshore accounts in London include Jordanian King Abdullah II, Azerbaijan"s President Ilham Aliyev and associates of Pakistani Prime Minister Imran Khan. Abdullah has denied any impropriety and Khan tweeted that his government would investigate anyone mentioned and take appropriate action if wrongdoing is found. Aliyev hasn"t commented.

Though the purchases are legal under British law, the latest revelations highlight the complicated — and often anonymous — financial practices wealthy individuals use to avoid tax, far removed from the everyday experience of most of

Biden lifts abortion referral ban on family planning clinics

Washington: The Biden administration on Monday reversed a ban on abortion referrals by family planning clinics, lifting a Trump-era restriction as political and legal battles over abortion grow sharper from Texas to the US Supreme Court.

The Department of Health and Human Services said its new regulation will restore the federal family planning program to the way it ran under the Obama administration, when clinics were able to refer women seeking abortions to a provider. The goal is to strengthen and restore" services, said HHS Secretary Xavier Becerra.

likely involve the Indo-Pacific and Western efforts to blunt China's growing there and elsewhere, NATO and other trans-Atlantic objectives involving the European Union, and counterterrorism cooperation in Africa's Sahel The official said Macron

and Blinken had agreed to use the spat as an opportunity to "deepen and strengthen coordination" and characterized the talks as "very productive," while allowing that "a lot of hard work remains ahead."

JERUSALEM: Israeli archaeologists have found a rare ancient toilet in Jerusalem dating back more than 2,700 years, when private bathrooms were a luxury in the holy city, authorities said Tuesday. The Israeli Antiquities

Authority said the smooth, carved limestone toilet was found in a rectangular cabin that was part of a sprawling mansion overlooking what is now the Old City. It was designed for comfortable sitting, with a deep septic tank dug underneath. "A private toilet cubicle

was very rare in antiquity, and of the excavation.

Animal bones and pottery found in the septic tank could shed light on the lifestyle and diet of people living at that time, as well as ancient diseases, the antiquities authority said.



Moody's upgrades India's outlook to stable

International ratings agency Moody's on Tuesday upgraded India's rating outlook to 'stable' from 'negative', saying a recovery is underway in Asia's third-largest economy and growth this fiscal will surpass the pre-pandemic rate.

Moody's Investors Service however kept India's sovereign rating at 'Baa3' - which is the lowest investment grade,

just a notch above junk status. The change in the rating outlook to 'stable' from 'negative', which was assigned in November 2019, reflected receding downside risks to the economy and financial sys-"An economic recovery is

underway with activity picking up and broadening across sectors," Moody's said. Following a deep contrac-

tion of 7.3 per cent in fiscal 2020 (ended March 2021), Moody's expects India's real GDP to surpass 2019 levels this

2022), rebounding to a growth rate of 9.3 per cent, followed by 7.9 per cent in the next financial year. "Downside risks to growth from subsequent coronavirus infection waves are mitigated by rising vaccination rates and more selective use of restrictions on economic activity, as seen during the second wave," it noted.

The US-based rating firm had in 2020 lowered India's rating from 'Baa2' with a 'negative' outlook, saying there would be challenges in policy implementation amid low growth and deteriorating fiscal position. In a statement on Tuesday, Moody's said "the decision to change the outlook to stable reflects Moody's view that the downside risks from negative feedback between the real economy and financial system are receding.'

With higher capital cushions and greater liquidity, banks and non-bank financial institutions pose much lesser risk to previously anticipated.

GST systems to periodically check monthly return filing compliance for e-way bill blocking

GST systems will periodically check status of monthly returns filed and taxes paid by businesses since August and block generation of e-way bill in case of non-compliance, GSTN has said.GST Network, the company that handles the technology backbone for goods and services tax, said the blocking of the electronic way bill generation facility has now resumed on the e-way bill portal for all the taxpayers. "Going forward, from the tax period August 2021 onwards, the system will periodically check the status of returns filed in form GSTR-3B

or the statements filed in Form GST CMP-08 as per the regular procedure followed before pandemic, and block the generation of EWBs (e-way bill) as per rule," it said. Last year, the Central Board of Indirect Taxes and Customs (CBIC) had suspended the blocking of electronic way (e-way) bill generation for non-filers to give them compliance relief during the Covid-19 pandemic.

In August this year, GSTN in advisory to taxpayers had said that the government has decided to resume the blocking of e-way bill generation facility on the EWB portal, for all the taxpayers from August 15

It is observed that in later ages 20 per cent have a higher risk of anxiety disorder and 40% face mood disorders. Going outdoors is highly beneficial for kids. Studies show that spending time with nature and in the green makes kids happier, attentive, less anxious, and they tend to be smarter than kids who stay


Poems for young adults

Hockey India withdraws from 2022 PTI ■ NEW DELHI

India on Tuesday pulled out of next year's Birmingham Commonwealth Games' hockey competition, citing COVID-19 concerns and UK's discriminatory quarantine rules for travellers from the country, a day after England's withdrawal from the junior men's World ilar reasons.

Hockey India President Gyanandro Ningombam communicated the federation's decision to Indian Olympic Association (IOA) President Narinder Batra in a letter.

Hockey India reasoned that there is only a 32-day window available between the



August 8) and the Hangzhou Asian Games (September 10-25). HI said it can't risk sending its players to the UK, which has been one of the worst affected by the coronavirus pandemic. "You will appreciate that the Asian games is the Continental qualification event for the 2024 Paris Olympic

Games and keeping the priority of the Asian Games in mind, Hockey India can not risk any members of the Indian teams contracting COVID-19 during the Commonwealth Games," Ningombam wrote.

Therefore, Hockey India will not be sending its men and teams to Commonwealth Games 2022 advance to kindly notify the Organisers to identify reserve teams." The possibility of this withdrawal arose a few weeks back when the IOA President said that HI had indicated to him that it was more keen on players being in top form for the Asian Games which is a

qualifier for the 2024 Paris

Olympics, Sources in the sports ministry had stated that efforts would be made to persuade HI to send second-string teams instead of pulling out alto-gether. Chess Champion Carsen adds one more feather to his cap

World Chess Champion and World No 1 Magnus Carsen added one more feather to his cap when he won the two-week Meltwater Champions Chess Tour that ended on October 4.

The Tour was organised in various legs and leagues with accumulation of cumulative points on the basis of performance in each part of it. The tour gave exposure to several talented youngsters to match their wits against the topmost legends from the International Chess. Wesley So of the USA cre-

ated a flutter by defeating Mangus Carlsen on some occasions but the latter still topped the score board from the start till

Here is an interesting game from the tour (Carlsen M vs Vachier Lagrave
