# Vax not foolproof shield PM Modi holds talks with against Covid-19: Study

Vaccination cuts down risk of death, severe illness: Lancet

PNS ■ NEW DELHI

Vaccinated or not vaccinated, in the open air or in the house, every individual remains vulnerable to the Covid-19, more so Delta variant, a study has said, suggesting that Covid-appropriate behaviour such as wearing a mask, social distancing is now the way of life for everybody.

Significantly, in several countries such as the USA and Russia, a large number of cases are still reported daily despite more than three fourths of the population getting both the vaccine jabs.

"Those who have got two Covid-19 jabs can be just as infectious as those who have not been vaccinated, even if they have no or a few symptoms. Also, the chance of them transmitting the virus to other unvaccinated housemates is about two in five, or 38 per cent. If all the housemates are fully vaccinated, the infection rate drops to one in four," said



the study published in The Lancet Infectious Diseases. It emphasised that Covid-appropriate behaviours such as wearing a mask, social distancing and testing remain important even in vaccinated individuals.

"Unvaccinated people cannot rely on those around them being jabbed to remove their risk of getting infected," the

study warned. Vaccines do an excellent job of preventing serious Covid-19 illness and deaths, but are less good at stopping infections, particularly since the emergence of the more infectious Delta variant which is dominant in the UK.

And over time, the protection offered by vaccines wanes and needs boosting with further doses. According to the study, which ran from

September 2020 to September

2021 and included 440 households in London and Bolton doing PCR Covid tests, people who are double jabbed have a lower, but still appreciable, risk of becoming infected with the Delta variant compared with

unvaccinated people.

Prof Ajit Lalvani of
Imperial College London, UK, who co-led the study, said, "The ongoing transmission we are seeing between vaccinated people makes it essential for unvaccinated people to get vaccinated to protect themselves from acquiring infection and severe Covid-19, especially as more people will be spending time inside in close

winter months.

"We found that susceptibility to infection increased already within a few months after the second vaccine dose so those eligible for booster shots should get them promptly?

"Our findings provide important insights into the effect of vaccination in the face of new variants, and specifically, why the Delta variant is continuing to cause high Covid case numbers around the world, even in countries with high vaccination rates," added co-author Dr Anika Singanayagam, also from the Imperial College.

"Continued public health and social measures to curb transmission such as mask wearing, social distancing, and testing thus remain important, even in vaccinated individuals?

"By carrying out repeated sampling from contacts, we found that vaccinated people could pass on the infection within households, including to vaccinated members Continued public health and social measures to curb transmission, such as wearing a mask, social distancing and testing, remain important even in vaccinated individuals, added Singanayagam.

# SC: Can't ask Govt to revaccinate for foreign travel, await WHO nod

PNS NEW DELHI

Await for the WHO's response on Covaxin approval, the Supreme Court on Friday said that it cannot play with the lives of people by directing the Centre to revaccinate people with Covishield to enable them to travel abroad during the Covid-19 pandemic. People who have taken both jabs of Covaxin cannot use the vaccination certificate to

travel abroad. The apex court was hearing a petition that said that Covaxin was not approved by the World Health Organization (WHO) and people here are facing difficulty in getting per-

mission to travel abroad.

"We cannot play with the lives of people by directing Centre to revaccinate. We don't have any data with us. We have read in newspapers that Bharat Biotech has filed an application with the WHO for recognition. Let us wait for the response of the WHO. We will take up this


Aryan will have to spend one more night in the prison before he returns to his home 'Mannat" on Saturday.

# **Ban on flights** abroad extended till November 30

The Directorate General of Civil Aviation (DGCA) on Friday extended the suspension of scheduled international passenger flights till November 30 due to the coronavirus pandemic."However, international scheduled flights may be allowed on selected routes by the competent authority on a case-to-case basis," it added.

Scheduled international passenger services have been suspended in India since March 23, 2020 due to the coronavirus pandemic. But special international flights have been operating under the

May 2020 and under bilateral "air bubble" arrangements with selected countries since July

India has formed air-bubble pacts with around 28 countries, including the US, the UK, the UAE, Kenya, Bhutan and France. Under an air-bubble pact between two countries, special international flights can be operated by their airlines between their territories with specific restrictions.

The circular also said the suspension does not affect the operations of international allcargo services and flights specifically approved by it.

### No total ban on use of firecrackers, fireworks containing Barium salts prohibited: Supreme Court

New Delhi: The Supreme Court on Friday clarified that there is no total ban on use of firecrackers and only those

fireworks which contain Barium salts are prohibited.

The bench of Justices M R Shah and A S Bopanna said however that no authority can be permitted violation of the directions issued by it and allow banned firecrackers under the guise of celebration. The apex court further asserted that celebration cannot be at the cost of the other's health. Under the guise of celebration, nobody can be permitted to infringe the right to health of others, guaranteed under Article 21 of the Constitution of India and nobody can be permitted to play with the life of the others, more particularly the senior citizens and the children, said the

"It is made clear that there is no total ban on use of firecrackers. Only those firecrackers are banned, as directed herein above, which are found to be injurious to health and affecting the health of the citizens, more particularly the senior citizens and the children," said the apex court adding that any lapse on part of States, agencies and UTs in implementing a ban on firecrackers shall be viewed very seriously. The Bench directed all the states/Union Territories to give due publicity through electronic/print media and local cable services to make the people aware of the directions issued by the court on manufacture, use and sale of banned firecrackers.

### Need rules-based order for Indo-Pacific that respects sovereignty, territorial integrity: EAM

New Delhi: As China has adopted an aggressive stance in the Indo-Pacific region, External Affairs Minister S Jaishankar on Friday said India has along called for a fair, balanced and rules-based stable international trade regime in

Making this point in his virtual address at the fourth edition of the Indo-Pacific Business Forum jointly hosted by India and the US, Jaishankar also said India believes that our common prosperity and security requires us to evolve, through dialogue, a common rulesbased order for the region.

In his speech, the minister said the order must respect sovereignty and territorial integrity, international law, as well as equality of all nations. It envisages that countries should have access to the use of common spaces on sea and in the air that would require freedom of navigation and over flights, unimpeded commerce and peaceful settlement of disputes in accordance with international law, he

Observing that the Indo-Pacific presents the example of globalization, emergence of multi-polarity and the benefits of rebalancing, Ĵaishankar said India views the Indo-Pacific as a free, open, inclusive region, which embraces all in a common pursuit of progress and prosperity that includes all nations in this geography as also draws others beyond who have a

Describing that the world was moving towards greater economic diversification and political multi-polarity the External Affair Minister noted that Covid-19 has given a much sharper impetus to those trends which has broadened the understanding of national security for most societies. It has taught us the importance of resilient and reliable supply chains, just as it has cautioned us against concentrated production.

Elaborating upon the issue, Jaishankar said India has taken the opportunities and challenges of the company of lenges of the Indo-Pacific very seriously. Listing some of the initiatives, he said it was reflected in the vaccine collaboration through the Quad grouping. He also referred to global efforts including the International Solar Alliance and the Coalition for Disaster Resilient

Jaishankar said India is now emerging out of the corona pandemic and seeing a strong economic recovery adding the country will continue to be a more dynamic and friendly busi-

### Army needs widened roads in Chardham project up to China border, Centre tells SC

New Delhi: The Centre Friday told the Supreme Court that its plea seeking recall of an earlier order of the court be urgently heard as Army needs widened roads in the Chardham highway project which goes up to China border due to problems faced there.

The strategic 900-km Chardham highway project aims to provide allweather connectivity to four holy towns Yamunotri, Gangotri, Kedarnath and Badrinath -- in Ūttarakhand.

A bench of Justices D Y Chandrachud and B V Nagarathna was informed by Attorney General K K Venugopal that the Ministry of Defence has filed an application seeking recall of an earlier order. "We want that application to be heard on urgent basis. Army needs widening of the border roads in northern sector due to the problems there," Venugopal said, adding that court had earlier said the width should not be more than 5.5 metres.

They, however, said way would be made for traffic to move in the coming days.

"The Sanyukt Kisan Morcha will take a decision and then proceed accordingly. We were sitting here for the last 12 months asking to go to Delhi. We were not being allowed. We will now go to Delhi to sell our harvest. First, our tractors will go to Delhi. The move vindicated their stand that they never blocked roads at the city border points," Tikait added.

The Delhi Police's decision comes days after a Supreme Court hearing that saw farmer unions argue that the police were responsible for the blockade at the city's borders. Multiple layers of iron and cement barricades, and at least five layers of concertina wires were put up last year, and further strengthened after the January 26 violence this year during the farmers' protest against the three contentious farm laws. In a video going viral on social media, JCB machines were seen removing blockades.

According to Priyanka Kashyap, the Deputy Commissioner of Police (DCP), East district, the process of removing barricades on NH-9 has been started and the temporary barricading is being removed to ease out vehicular movement.

"However, National Highway 24 was already open for traffic," she said. To stop the farmers from entering Delhi, the police had placed

He said that under the present mechanism a person vaccinated with Covaxin cannot register himself on the CoWIN portal to get the Covishield vaccine and a direction can be issued to the Centre in this regard. "We cannot pass a direction to administer another vaccine without any data. We understand your concern but let's wait for the WHO's response," the bench said. The apex court said that there is also concern that competitors may in the garb of the PIL try to take advantage of the litigation. Seth said that his PIL is purely a Public Interest Litigation as several students who go abroad to study are denied entries in various

The plea filed by Seth said that at the time of rolling out of Covaxin, the Government did not make the public aware that it was not approved by the WHO. It said that Bharat Biotech has submitted its application for approval as late as April 2021 and in May people came to know many countries are not allowing entry of those who are vaccinated with vaccines other than those enlisted in the WHO's emergency use list. # 12 held for running fake Govt portal, duping people

With the arrest of 12 people, including two women from Noida, the Special Cell of the Delhi Police has busted an illegal module that was running a fake online redressal system with the scamsters pretending to be Government officials. Police said that the syndicate has cheated around 3,000 victims Police said that the scam-

sters were duping those individuals, who tried to lodge a complaint regarding online cheating. "They charged the victims (already cheated) processing fees and subsequently stopped responding by blocking them," said police.

According to KPS Malthora, the Deputy Commissioner of Police (DCP), Intelligence Fusion and Strategic Operations (IFSO) unit of the Special Cell, inputs were received that some racketeers are employing various mechanisms to defraud the victims of online cheating by projecting themselves as Government officials on the fraudulently created web pages having similar nomenclature as of the Government complaint redressal system. "Further, a complaint was also received, wherein the complainant had alleged that while he was trying to complain about an incident of cheating, he came across a website, www.jansurkashakendara.in, claiming to be a crime reporting portal. He called on the mobile phone number provided on the website and on the pretext of lodging and enquiring his complaint, the alleged persons charged Rs 2,850 from him," said the DCP.

'Further, the accused persons have created some more similar websites with names Jan Shikayat Kendra, Grahak Suraksha Kendra, Nyaya Bharat and others," said the DCP. "Once the payment was

received, the complainant's number was blocked by the accused. A First Information Report (FIR) under Sections 419, 420 and 120B of the Indian Penal Code (IPC) was registered and investigation was taken up," said the DCP. "Whenever anybody is a victim of cybercrime, they should report it on the Government portal https://www.cybercrime.gov.in/ and call the helpline number 155260. No Government office charges any processing fee for putting Government machin-ery in action," the DCP added.

"During investigation, police team found seven more similar complaints registered at National Cyber Crime Reporting Portal. One FIR was also found registered in Karnataka. The bank account details of the payment gateways and was collected and analysed. During scrutiny, it was revealed that the fraudsters have received Rs 1.74 crore in the past year," said the DCP.

### DRDO, IAF flight-test bomb that can hit target up to 150 kms

 $\mathbf{I}^{\text{n}}$  a significant development towards self-reliance in niche technology, the DRDO and IAF team jointly on Friday flight tested indigenously developed Long-Range Bomb successfully from an aerial platform. The bomb can hit a target between a range of 50 kms and 150kms.

This crucial test came two days after India successfully launched Surface to Surface Ballistic Missile Agni-5 capable of striking targets at ranges up to 5,000 kilometres with a very high degree of accuracy.

Replying to a question on whether there will be any infrastructural changes in view of women joining the NDA, he said that infrastructure will be slightly changed as per the requirements, but the training would remain the same.

CISF to protect Power Grid substation in Anantnag

# CRPF to hold physical course for overweight staff

The CRPF has decided to initiate a four-week physical course for overweight subordinate officers and iawans after subjecting them to a number of medical tests before enlisting them for the weight management programme.

The syllabus for overweight personnel for subordinate officers and other ranks (jawans) has been prepared and the Training Directorate of the Central Reserve Police Force (CRPF) has circulated it to all the formations to organise the fitness programme at the Sector

Besides the activities mentioned in the syllabus, measures recommended by the Medical Directorate will also be adopted before starting the course to rule out any

The Medical Directorate has advised that the course should be gradual and physical activity must be increased gradually. All such personnel should be provided one packet of electral powder daily to overcome electrolyte imbalance and they should be subjected to at least undergo electrolyte test on a weekly basis. In addition to these, running/long distance route marches should be started in the early morning to prevent heat stroke.

Tests like blood sugar, CBC, ECG, lipid profile, KFT and LFT of the overweight personnel should be undertaken. In addition, TMT test



sonnel above 40 years old. Personnel must be asked about irregular heartbeats and about treatment history of such an ailment, the Medical Directorate has advised.

The syllabus will cover a range of exercises like walk, road run, heat exercise, ground work, strengthening arms/abdomen and circuit physical training among oth-

The training module will also include long distance march, yoga, aerobics/zumba and athletic competition.

The course will also emphasise on issues like fitness, balanced diet and calories, body mass index, weight gain and obesity and eating correctly, concept of cardio and aerobic exercises besides others such aspects like mus-cle building and bodybuild-

The trainees will also be imparted lessons on the effects of alcohol, smoking, tobacco and drugs. and motivational counseling as also modules on body physiology and metabolism.

The month-long course will entail 192 periods of 40 minutes each, subdivided into eight periods daily for 24 days in a month with a sixday weekly cycle.

## Pilots' body seeks reversal of pay cuts

This has been a long stated demand of pilots and they say that as other airlines have returned to pre-COVID salaries, they should also be remunerated appropriately.

"The massive pay cut of up to 60% for Air India pilots has dramatically diminished our livelihoods. Looking at the current aviation industry standards, the continuation of the pay cut does not merit any justification,' read the letter.

# Covid patients report symptoms affecting ears, reveals study

PNS NEW DELHI

Many Covid-19 patients have reported symptoms affecting the ears, including hearing loss and tinnitus. Dizziness and balance problems can also occur, suggesting may be able to infect the inner ear, said a new study from MIT and Massachusetts Eye and

It has provided evidence that the virus can indeed infect cells of the inner ear, including hair cells, which are critical for both hearing and balance. The researchers also found that the pattern of infection seen in human inner ear tissue is consistent with the symptoms seen in a study of 10 Covid-19 patients who reported a variety of ear-related symptoms.

The researchers used novel cellular models of the human inner ear that they developed, as well as hard-to-obtain adult human inner ear tissue, for their studies. The limited availability of such tissue has hindered previous studies of Covid-19 and other viruses

that can cause hearing loss. "Having the models is the first step, and this work opens a path now for working with not only SARS-CoV-2 but also

other viruses that affect hearing," says Lee Gehrke, the Hermann L.F. von Helmholtz Professor in MIT's Institute for Medical Engineering and Science, who co-led the study published Communications Medicine.

former associate professor at Harvard Medical School and former chief of otology and neurotology at Massachusetts Eye and Ear, who is now the Foundation Bertarelli Professor and chair of the Department

Otolaryngology - Head and Neck Surgery at Stanford University School of Medicine, co-led the study. Minjin Jeong, a former postdoc in Stankovic's laboratory at Harvard Medical School, who is now at Stanford Medical School, is the lead author of the paper.

Before the Covid-19 pandemic began, Gehrke and Stankovic began working together on a project to develop cellular models to study infections of the human inner ear. Viruses such as cytomegalovirus, mumps virus, and hepatitis viruses can all cause deafness, but

### PCV brought under universal immunisation plan

Pneumococcal Conjugate Vaccine (PCV), which pro-tects young children from pneu-monia, meningitis and blood infections caused by Streptococcus pneumoniae bacteria, has been brought under the ambit of the Universal Immunisation Programme

Launching the nationwide rollout of the vaccine as a part Union Health Minister Mansukh Mandaviya on Friday said the move aims to reduce the child mortality rate by 60 per

"In India, around 16 per cent of deaths in children occur due to pneumonia. The nationwide rollout of PCV will reduce child mortality by around 60 per cent," he stated.

Speaking on how the nation-wide rollout of PCV under UIP will significantly reduce the instances of child mortality due to pneumonia, Mandaviya said, "It is for the first time in the country that PCV will be available for universal use. Pneumonia is a leading cause of death among children under-5 years old, globally and in India. Pneumonia caused by pneumococcus is the most common cause of severe pneumonia in children.

The Minister also released communication and awareness packages on PCV to create widespread mass awareness.

# CCI manipulating cotton prices: Traders

otton Corporation of India, a public sector undertaking and designated as Mini Rathna Company, has earned the wrath of the textile industry as well as that of the farmers for knowingly or unknowingly dancing to the tunes of cotton traders and some multinational companies and thereby causing havoc on the country's economy.

Raja M Shanmugham, president, Tirupur Exporters Association, has sent an urgent message to Prime Minister Narendra Modi listing the hardship caused to the cotton farmers and textile industry by the cotton traders-MNCs-CCI cartel which he alleged is manipulating the market through unjustifiable manner.

"This ploy has the potential to destabilise the textile industry which is the only labour intensive industry in the country. If the textile industry in India loses its competitiveness, we will be wiped out from the sector and it would be like a death blow to millions of workers their families, Shanmugham told The Pioneer.

He said that cotton traders and some MNCs were indulging in hoarding as well as manipulating the price of cotton to suit their convenience. "A few MNCs play a hatched game against the interest of our textile industry by way of hoarding a huge stock during the cotton yielding season by using their very low cost of international fund. Further, MNCs make use of CCI procured cotton stock also in their favour by booking in advance with CCI on a huge volume basis by making CCI establishment itself knowingly or unknowingly to sail with their hatched game plan of creating an artificial demand in the market and make available a staggered supply of cotton to the contextile mills,"

Shanmugham said in his letter to the Prime Minister. The industrialist said that desi textile industry should get the preference during the sale of cotton procured from Indian cotton

'That is the only leverage we have in this highly competitive industry. Our demand is that traders and MNCs should be barred from trading in Indian cotton. The MNCs procure raw cotton to ease out the Indian textile industry out of the race. The CCI should allocate the cotton procured from Indian farmers to our own industries. The interests of the industry as well as that of the cotton farmers should be protected," said Shanmugham. The TEA wants the

Government to issue a directive to the CCI to protect the interest of farmers and act as a facilitator or catalyst to accelerate the growth of value chain of textile industry. "Textile Mills are consisting of Small, Medium and Large enterprises and the CCI should supply cotton directly to the above segments relating to their capacities instead of fixing a higher benchmark to the quantities, which only benefit to either Corporates or MNCs in cotton trade," said the TEA P Chengal Reddy, advisor to

A report, prepared by ADR, focuses on donations declared by regional political parties during the financial year 2019-20, as submitted by the parties to the Election Commission."The top five parties, which declared the highest donations in FY 2019-20 are Shiv Sena, AIADMK, AAP, Biju Janata Dal and YSR-C. Out of these parties, SHS, BJD and Yuvajana Sramika Rythu Congress Party declared a decrease in their donations, while the AIADMK and the AAP declared an increase in donations in comparison to 2018-19," the report


Maximum donations in cash were declared by the Indian Union Muslim League, which collected Rs 4.63 crore, followed by Tamil Nadu's Pattali Makkal Katchi with Rs 52.20 lakh, LJP with ₹6 lakh, Nagaland and Manipur's Naga People's Front with ₹3.92 lakh and the Dravida Munnetra Kazhagam (DMK) with ₹29,000.

The report said 16 regional parties have declared receiving 1,026 donations worth ₹24.779 crore without PAN details.Out of 53 regional parties analysed, only two had submitted their donation reports to the Election Commission in the stipulated time period and 28 others had delayed their submission by a minimum of six to 320

There are 23 regional political parties who have defaulted on the submission of their donation reports to the EC during 2019-20, till date.

# Fair play

The State's tendency to charge anyone under the UAPA is facing sustained legal challenge

pushback is discernible from the judiciary against the inappropriate use of the draconian Unlawful Activities Prevention Act, 1967. The State banking on UAPA to arrest and charge anyone with terrorism is facing a sustained legal challenge. On Thursday, the Supreme Court granted bail to a Kerala youth held under UAPA since 2019 for Maoist links, saying mere association with or support to a terror organisation, the CPI-ML (Maoist) in this case, is "not sufficient" to prove the offence. The "intention of furthering the activities of a terrorist organisation" is missing, the court pointed out. The NIA court, which originally gave bail to the accused, did not prima facie find any evidence in the charge sheet showing this "intention". The Kerala High Court, which set aside the bail order, did not record this *prima facie* finding, the Supreme Court observed. Giving bail in UAPA cases is a cumbersome affair as the court has to satisfy itself that



there are reasonable grounds to believe that the charge of terrorism against the accused is prima facie not true. In this case, both the NIA court and the apex court came to that conclusion. It is not often that such a conclusion comes about. A prima facie analysis tests the judge's perspicacity to weigh evidence filed by the prosecution and defence. That is possible more in civil cases than UAPA cases because the evidence in the former is mostly documentary. Moreover, a Supreme Court judgment in 2019 said that a court cannot go into the merits of a case or scrutinise the admissibility of evidence when deciding on bail.

As a result, in most cases, bail is ruled out. In the case of Stan Swamy, who was old, not in good health, hardly a flight risk and where the court had the power to place enough restrictions on him, bail was still not granted. One can only hope the court found a prima facie case against him. The pushback began in a startling case of judicial activism this June when the Delhi High Court gave bail to three student activists on the ground that protests, like inflammatory speeches and roadblocks, were not terrorist acts under UAPA. The court rejected the prosecution case built around WhatsApp messages and statements of witnesses who later turned "approvers" and said that tough penal laws could not be applied to ordinary protests which should be dealt with under ordinary criminal laws. The Supreme Court did not intervene in the High Court bail order while not treating it as a precedent. The court rightly felt the issue had "pan-India ramifications" and it had to "decide" on the "many questions involved" for the "good of the entire country". The judiciary has so far been restrained in ensuring that draconian provisions, arbitrarily used, do not come in the way of granting bail to the accused. That is changing. It is time to hold the State to higher standards and disallow it to get away with questionable prosecutions.

# **Farming for votes**

The situation has turned against the Congress in Punjab and the AAP looks to take advantage

he Congress party was in the driver's seat in Punjab's politics when Charanjit Singh Channi, the party's Dalit face, was appointed the Chief Minister just last month. Apparently, the picture has changed over the last few weeks and the grand old party's Punjab prospects might need a booster shot to get back on course. The two main reasons causing worry to the grand old party are former Punjab Chief Minister Captain Amarinder Singh and AAP national convener and Delhi Chief Minister Arvind Kejriwal, and the latter seems ready to harvest all the electoral benefits arising out of the prevailing political atmosphere. While the BJP's significance in the State is pretty limited — its vote share declined from 8.21 per cent in 2007 to 5.4



per cent in 2017 — the Captain, who has met Union Home Minister Amit Shah thrice since tendering his resignation, can render heavy damage to the Congress prospects as he is said to enjoy considerable influence over Jat farmers. Punjab's politics has lately been driven by personal prospects; earlier Navjot Singh Sidhu was acting like an "unguided missile" and now the Captain has become a wounded lion who'd give it all to make the Congress pay for "humiliating" him. Further, Kejriwal, who's on a two-day visit to Punjab, his second visit to the State this month in the run-up

to the Assembly elections early next year, has already fortified his party's position after it emerged the second-largest party in the 2017 Assembly elections.

Clearly, it's all against the Congress in Punjab and how its leaders attempt to protect one of the only three party-ruled States is the synopsis of Indian politics. Just like Ayodhya is the launchpad of Uttar Pradesh's political spectrum, farmers have become the epicentre of Punjab politics and Kejriwal is playing just the right strings. His current Punjab visit too has freebies, this time only calculated ones. Making a bold promise, he said on Thursday: "After April 1, 2022, the farmers and labourers in Punjab will not be forced to commit suicide due to crop failure. This is my promise and Kejriwal does what he says." He also promised to make agriculture profitable, of course if voted to power. With the Congress in a confused state and the farmers' agitation heading into its first anniversary, the AAP's electoral prospects in Punjab have increased. But whether it translates into storming the fort remains to be seen.

# Bumpy road ahead for Afghan Govt



Will a bitterly divided Taliban be able to deliver an orderly Government, especially in the wake of the factional feuds intensifying since Aug-Sept?

ill the Taliban be able to provide stability and peace to Afghanistan? The deep fault lines within, that are now apparent, warrant the question. Time was when the Ameerul-Momineen (Commander of the Faithful) Mullah Mohammad Omar's word was law for the Taliban. Nevertheless, there were factions within the Islamist militia, which emerged in 2015 when it came to be known that Mullah Omar had died on April 13, 2013, but the fact was kept a secret and Mullah Akhtar Mansour was running the organisation in his name. Mansour, who became the successor in July 2015, was killed by a US drone strike on May 21, 2016, following which Sheikh Haibatullah Akhaundzada became Ameer-ul-Momineen.

The continuing factional tussles intensified sharply during the exercise in Government formation that followed the Taliban's takeover of Afghanistan, with capital Kabul falling to it on August 15, 2021. The first indication of this was the fact that Zabiullah Mujahid, Taliban's chief spokesman, announced a caretaker Government with 33 Ministers as late as September 7, 2021. The need to reconcile conflicting claims for shares of ministerial berths clearly made for the delay, which was over three weeks. The argument that the Taliban were not ready with a list of ministerial nominees because they could not anticipate their lightning victory, will not wash. Their peace treaty with the US, signed on February 29, 2021, which came in the midst of their violently extending their sway over progressively wider chunks of Afghan territory, was widely regarded as paving the way, wittingly or unwittingly, for their not-so-distant accession to power in Afghanistan. This and the fact that they themselves were confident about victory, should certainly have prompted them to have the blueprint for a Government and a list of potential Ministers ready — particularly when Pakistan was regularly providing them with guidance.

It is now clear that the Taliban had neither such a list nor a blueprint for governance ready. Hence the factional struggle in which the

main contenders were the faction identified with Mullah Abdul Ghani Baradar, dominant in Kandahar, and the one headed by the Haqqani family active in the Paktia, Paktika and Khost provinces in eastern Afghanistan close the Pakistan, as well as northwestern

Media reportage as well as the train of events are revealing. Tolo News, a 24-hoursseven-days-a-week Afghan news channel, reported on September 3, 2021, that Taliban co-founder Mullah Abdul Ghani Baradar (who headed the Islamist militia's political office in Doha) would lead the Government-to-be in Afghanistan. It also said that Mullah Mohammad Yaqoob, Taliban co-founder Mullah Mohammad Omar's son, and Sher Mohammad Abbas Stanekzai would hold senior positions in the Government. As it turned out, it was not

Mullah Abdul Ghani Baradar but Mullah Mohammad Hassan Akhund who was to "caretaker" the Government announced by the Taliban on September 7, 2021. Mullah Baradar was named his deputy along with Moulavi Abdul Salam Hanafi, a prominent Uzbek member of the negotiating team. Mullah Mohammad Yaqoob got the Defence portfolio. Stanekzai






## **FIRST COLUMN** WHY THE COP26 ISN'T **LIKELY TO DELIVER**

Presidents Xi Jinping and Vladimir Putin are not even showing up for the conference

he world is on a catastrophic pathway to 2.7°C of heating, said UN Secretary General António Guterres. "There is a high risk of failure of COP26." That's the global climate summit that meets every five years to plot a course away from climate disaster. And it really isn't looking good. COP26 starts on October30 in Glasgow but much that should already have happened has not happened. The draft texts are only half-done due to the pandemic. Neither China's President Xi Jinping nor President Vladimir Putin of Russia is even showing up. This meeting is the last chance to keep average global temperature below +1.5°C. That target was adopted at the last summit in Paris in 2015. Reaching that Paris goal, however, would require a 45 per cent reduction in carbon dioxide emissions by 2030. That's not unthinkable if we treated this as an existential emergency but the grim fact is that we have never yet managed to cut global emissions at all. "We are not going to get to a 45 per cent reduction," admitted a UN official, "but there must be some level of contributions on the table to show the downward trend of emissions." Why would a conference full of highly educated, well informed and mostly well-intentioned people behave like this? They're not wicked people, and almost all of them do know the truth. They just cannot afford to get too far ahead of the people they lead. A



majority of citizens in almost every country worry about global heating, but dramatic change isn't possible because it hasn't reached their 'pain threshold' yet. That phrase acquired its political meaning during the American war in Vietnam.

The idea was that a gradually escalating US bombing campaign would make the North Vietnamese government stop trying to reunite the country by force when the damage to North Vietnam reached its 'threshold of pain'. 'Operation Rolling Thunder' lasted three years, but it never did find the Hanoi regime's pain threshold. Similarly, the accumulating damage to people and property done by various sorts of wild weather has not yet reached the population's pain threshold anywhere except for a few low-lying island countries that are already close to going underwater. On our current track, we will irrevocably commit to +1.5°C by 2029 or 2030, but the time lag with CO2 means that the immediate effects of even that abject failure might not be severe enough to shock a critical mass of people into action. So. what can usefully be done while we wait for the heating to reach our collective pain threshold? The best hope at the moment is the Global Methane Pledge, whose supporters promise to cut their methane emissions by 30 per cent by 2030. Methane has accounted for at least a third of the warming so far, but it allows for a quick partial fix for two reasons. It stays in the atmosphere a far shorter time than CO2 - eight years instead of 200 - so emission cuts show quick results. And one source of methane in particular is cheap, low-hanging fruit: the fossil-fuel industry. Just stop flaring unwanted gas and fix all the leaks in almost 3 million km. of gas pipelines, and the 30 per cent cut is a done deal. Not only that, it will practically pay for itself, since you can burn the saved methane. It will produce carbon dioxide, of course, but that's a 200-year problem and we need results now. Almost forty countries have already made the methane pledge. We could even delay +1.5°C down into the 2030s, and something else might turn up by then. Grasping at straws, perhaps, but what's the better option? (Gwynne Dyer's new book is 'The Shortest History of War'. The views expressed are personal.)

# 100 crore jabs: Govt system can deliver



The record must not lull us into a sense of complacency. The warlike effort must continue so that there is no possibility of the pandemic striking back in the form of a third wave

ctober 21, 2021 was a momentous day when India achieved the remarkable figure of 100 crore (onebillion) vaccinations. Next to China this is the highest in the world and it has been made possible by untiring coordinated efforts over the last 10 months. The whole exercise of vaccination has been done in a campaign mode. The credit for this must, undoubtedly, go to the political will from the top at the Center and the States and the effort put in by the entire Government system with its civil service and health care administration providing the leadership and the healthcare workers taking care of the last mile delivery.

We got off to a slow start in January

and there was also the debatable issue of vaccine--maitri whereby around six crore doses were exported to other countries. However, the drastic second wave of Coronavirus sent the entire country into a state of shock bringing forth the realization that the only way out was to vaccinate the eligible population with both doses at the earliest possible to prevent further disaster through the third wave.

Accordingly, the Prime Minister gave a clarion call for vaccinating the entire adult population by December 31. Initially, the progress was slow and there was a lot of cynicism about India's ability to achieve this ambitious goal. There was the policy issue of vaccine being procured by the States which led to a lot of problems and the policy was revised to have the procurement done by Government of India. This was indeed a very positive policy amendment without which this 100-crore figure would never have been realized.

There were a lot of people who doubted the capacity of the government system to deliver. Concerns were raised about the availability of vaccines, the transportation of vaccines to the remotest areas, the existence of a cold chain, the availability of trained vaccinators, the actual conduct of the vaccination, the record keeping, the wastage of vaccines and many other similar issues. No doubt, delivering vaccine to every part of the country was by no means an easy task and required high level coordination, team spirit, motivation, inspiration, decision making, communication and leadership

The vaccine manufacturers had to be ven the demand well in time so that the could augment their facilities and schedule their production accordingly. They had to be given necessary financial assistance from the Government and a mechanism developed where payment for vaccine bought could be made on time so that there is no disruption in the flow. Thereafter the existing cold chain and other infrastructure used for the massive child immunization programmeshad to be made ready to receive and handle the Covid vaccines.

Vaccination centers had to be setup

employees and officers to run these centers and ensure hassle free vaccination. The problem was far more acute in the rural areas where the basic infrastructure is not of the same level as the cities. The entire exercise was managed through a Cowin portal developed by the national health authority through which you could fix your appointment for vaccination and also get the certificates. There was some debate about the usefulness of Cowin for those not having access to internet facility but the issues were ironed out and the result is that 100 crore vaccinations has been reached. Such a vast and complex gov-

ernance exercise involving coordination at various levels is a huge task and due credit must be given to the entire team to have achieved it. In my 38 years of experience as a civil servant the only exercise that canbe a parallel to this is the conduct of nationwide elections. The Prime Minister had rightly said that vaccination would have to be done in the election mode. Just like elections all arms of the government had to work together to make this vaccination possible. It required a lot of daily coordination between Government of India and the State Government. Thereafter the leadership had to be

given by the political executive at the state level and prompt decision making by the policy planners like the Secretary and Director. Finally, it was the district where action took place under the leadership of the District Magistrate and the Chief medical officer.

The last-mile delivery was made possible by the health workers including Asha and Anganwadi workers. In rural areas vaccination had to be taken to the door step of the people. I could witness a tremendous sense of enthusiasm amongst all concerned with the vaccination process. My personal experience of vaccination was also very good as I found that the vaccination centers were being managed very efficiently with full courtesy and protocol. There was vaccine hesitancy in quite a few people and a lot of communication was required to convince the citizens to come forward for the vaccination. The point I want to make is that very often people have a negative perception about government offi-

cers and employees. This vaccination drive has shown the entire government system in positive colors. The entire system has risen to the occasion in response to the challenge of the pandemic in a most professional and effective manner. To a large extent the government must take the blame for not being able to anticipate the coming of the second wave and then not being able to respond adequately to it. There was a definite failure to provide oxygen,

ICU beds and medicines during the height of the second wave. However, with the success of the vaccination so far, the government system has been able to redeem itself to a large extent.

The battle is not over and the momentum has to be continued to meet the target of vaccinating the entire adult population by December 31. We must celebrate attaining the 100 crore figure but it must not lull us into a sense of complacency. The war-like effort must continue so that there is no possibility of the Pandemic striking back in the form of a third wave. There are lessons to be drawn from the success story of vaccination for the future overhaul of the public health system which is in urgent need of being modernized and upgraded.

The Center as well as the States will have to focus on spending a larger portion of their expenditure on health care. More Doctors, nurses and paramedics are required necessitating the opening of more educational institutions to cater to this demand. District hospitals need to be converted into centers of excellence and primary health care centers made operational. The pandemic has exposed the poor State of health infrastructure in the rural areas which needs to be addressed on priority. The success of the vaccination drive has shown that this is possible and the same leadership, team spirit and motivation are required to transform the public health sector.



The police official said he confessed to placing the Quran on the lap of the idol of Hanuman, a central character in the epic of Ramayana, before stealing the club from the idol's

Moradi, 83, was one of 10 children born to a Jewish family in Kabul. At age 16, she ran away from home and married a Muslim man. She never converted to Islam, maintained some Jewish traditions, and it was no secret in her neigh-

"She never denied her Judaism, she just got married in order to save her life as you cannot be safe as a young girl in Afghanistan," Moradi's daughter, Khorshid, told the AP from her home in Canada, where she and three of her siblings moved after the Taliban first seized power in Afghanistan in the

Despite friction over her decision to marry outside the faith, Moradi said she stayed in touch with some of her family over the years. Her parents and siblings fled Afghanistan in the 1960s and 1980s. Her parents are buried at Jerusalem's Har Menuhot cemetery, and many of her surviving siblings

But until this week, she had not spoken to some of her sisters in over half a century.

"Yesterday, I saw my sisters nieces and nephews after around 60 years through a video call. We spoke for hours," Moradi said. "I was really happy, I saw their children and they met mine." "They said it's like she came back from the grave," Khorshid said. During the first period of Taliban rule, from 1996 until the 2001 USled invasion, Moradi tried to maintain a low profile. But she risked her life by hiding Rabbi Isaak Levi, one of the few remaining Afghan Jews, from

## Retail inflation for industrial workers eases to 4.41% in September

"Year-on-year inflation for the month (September) stood at 4.41 per cent compared to 4.79 per cent for the previous month (August 2021) and 5.62 per cent during the corresponding month (September 2020) a year before," a labour ministry statement said.

Similarly, it stated that food inflation stood at 2.26 per cent against 4.83 per cent of the previous month and 7.51 per cent during the corresponding

The All-India CPI-IW (Consumer Price Index-Industrial Workers) for September, 2021 increased by 0.3 point and stood at 123.3 points compared to 123 points

in August 2021. On one-month percentage change, it increased by 0.24 per cent with respect to previous month compared to an increase of 0.62 per cent recorded between corresponding months a year ago.The maximum upward pressure in current index came from fuel and light group contributing 0.21 percentage points to the total change. However, this increase was

largely checked by rice, apple, petrol for vehicle, etc, putting downward pressure on the index.DPS Negi, Principal Labour and Employment Advisor said in the statement that the increase observed in index is mainly due to items like cooking gas, fire wood and poultry/chicken, mustard oil, sugar-white,

## Centre's fiscal deficit touches 35% of Budget estimates at Sept end

The Union Government's I fiscal deficit has worked out to be ₹5.26 lakh crore or 35 per cent of the budget estimates at the end of September 2021, as per the data released by the Controller General of Accounts (CGA) on Friday.

The deficit figures in the current fiscal appear much better than the previous financial year when it had soared to 114.8 per cent of the estimates mainly on account of a jump in expenditure to deal with the Covid-19 pandemic.

In absolute terms, the fiscal deficit or gap between expenditure and revenue was ₹5,26,851 crore at end of August, the CGA said.

For the current financial year, the Government expects the deficit at 6.8 per cent of GDP or ₹5,06,812 crore.

As per the data, the central government's total receipts stood at ₹10.99 lakh crore or



55.6 per cent of corresponding budget estimates (BE) 2021-22 up to September, 2021. The total receipts were 25.2 per cent of the BE of 2020-21 during the corresponding period of last

financial year. Of the total receipts, the tax revenue was ₹9.2 lakh crore or 59.6 per cent of BE. The tax revenue was only 28 per cent of BE of 2020-21 in the year ago period. The CGA data further said central government's total expenditure at the end of the first half of the fiscal year stood at Rs 16.26 lakh crore or

46.7 per cent of current fiscal's

Of the total expenditure, out of ₹13,96,666 crore was on revenue account and ₹2,29,351 crore was on capital account. ## Forex reserves decline by USD 908 million to USD 640.1 bn

The country's foreign exchange reserves declined by USD 908 million to USD 640.1 billion in the week ended October 22, RBI data showed.

In the previous week ended October 15, the reserves had increased by USD 1.492 billion to USD 641.008 billion. The reserves had touched a lifetime high of USD 642.453 billion in the week ended September 3,

In the reporting week ended October 22, the dip in the reserves was due to a fall in foreign currency assets (FCA), a major component of the overall reserves, and in the gold reserves, Reserve Bank of India's (RBI) weekly data released on Friday showed.

FCA declined by USD 853 million to USD 577.098 billion in the reporting week, the data showed.

Expressed in dollar terms, the foreign currency assets include the effect of appreciation or depreciation of non-US units like the euro, pound and yen held in the foreign exchange reserves.

## At least 40 cr individuals don't have any financial protection for health: Niti Aayog

PTI ■ NEW DELHI

Tn the absence of low-cost health insurance products, at least 30 per cent of India's population or 40 crore individuals are devoid of any financial protection through insurance, according to a report released by Niti Aayog.

The report titled 'Health

Insurance for India's Missing Middle' said that expansion of health insurance coverage is a necessary step and a pathway in India's effort to achieve universal health coverage (UHC).

"At least 30 per cent of the population, or 40 crore individuals – called the missing middle in this report - are devoid of any financial protection for health... In the absence of a low-cost health insurance product, the missing middle remains uncovered despite the ability to pay nominal premiums," it said.

According to the report, the 'missing middle' is a broad category which lacks health insurance, positioned between the deprived poorer sections, and the relatively well-off organised sector.

The report pointed out that Ayushman Bharat -Pradhan Mantri Jan Arogya



Yojana (AB-PMJAY) launched in September 2018, and state government extension schemes, provide comprehensive hospitalisation cover to the bottom 50 per cent of the population – around 70 crore individuals. Around 20 per cent of the population – 25 crore individuals – are covered through social health insurance, and private voluntary health insurance.

"The remaining 30 per cent of the population is devoid of health insurance; the actual uncovered population is higher due to existing coverage gaps in PMJAY and overlap between schemes. "This uncovered population is termed as the missing middle," the report said. The report noted that missing middle is not a monolith - it contains multiple groups across all expenditure quintiles.

# Horticulture production hits record high at 329.86 million tonnes

India is expected to have the highest ever horticulture production of 331.05 million tonnes in 2020-21, as compared to 320.47 million tonnes over previous year. The demand for ĥealthy foods had increased overall consumption of spices in the country and also in the export markets served by India which reflected in the increase in production of spices, vegetables, medicinal and aromatic crops. "Aromatic and medicinal crops have registered a growth of 6.2 per cent with estimated production of



0.78 million tonnes this year as compared to 0.73 million tonnes previous year.

"During the current year, 8,951 hectares area for exotic fruits and 7,154 hectares area for indigenous fruits will be brought under cultivation," Union Agriculture Minister Narendra Singh Tomar said addressing a conference to commemorate the international year of fruits and vegetables. 



# LEGENDS OF THE REVOLUTION

Post the success of Sardar Udham, SHOOJIT SIRCAR and VICKY KAUSHAL reveal that recreating the Jallianwala Bagh sequence was tough. By KHUSHBU KIRTI

fter *Uri: The Surgical Strike*, actor Vicky Kaushal's career had soared everyone's expectations of him. It will be safe to say that not only did he successfully fulfill those expectations, but also rendered to his audiences a new avatar to

Sardar Udham, the biopic of the revolutionary Sardar Udham Singh who is renowned for assassinating Michael O'Dwyer in London, avenging the 1919 catastrophe of Jallianwala Bagh massacre carried out by the latter's orders. The tragedy that took place in Amritsar had absolutely shaken the roots of the rebellion that was led by the country. The film is directed by Shoojit Sircar, popular for directing award-winning films like *Madras* Cafe, Piku, Vicky Donor, and so on.

While the Jallianwala Bagh sequence is one of the most iconic scenes, it can easily be assumed that a lot of work went into it, both emotionally and physically. On setting up and recreating the impactful scene, Shoojit began, "The Jallianwala sequence is actually the fulcrum of the entire event of our independence move-ment. It is the central point from where everything else germinated, because openly firing at unarmed people was a brutality that Indians could never imagine. It led to the birth of many Indian revolutionaries from 1919 until 1947. Some people thought the scene was perfect, some thought it was indulgent. But, I feel, it had

what he was planning to create or recreate, for that matter. "Nobody was clear on this. There was no particular script that was supposed to be followed," he added.

On speaking about the challenges they lem was that we couldn't shoot in the blood-bath. Thus, the prosthetics had to verted into a museum. We had to find a place which looked like a huge prison, where people were, like objects, stuffed like inmates. Of course, then there was the actual massacre to show. It was a

were completely dazed, because there was so much blood. We couldn't eat proper-

The complexity of the emotions that

entire blood-bath happening in front of him, went through is something that no one can ever feel. Talking about his character living the Jallianwala scene, Vicky expressed, "We would shoot continuously, without taking breaks in between shoots. I did not know where the cameras were located either. I just had to perform. We just kept executing scenes. Where Udham picks up bodies, that scene wasn't rehearsed. It was an uncanny experience. Udham, for whom this was a horrendous tragedy, would sometimes drag, pick or pull the bodies over his shoulders. He wasn't used to this and I had to feel the same."

He continued, "Having said that, it was

physically exhausting but at the same time, it was doing something to us on an emotional level, too. As an actor, I knew it was not going to be easy. However, what I did not know was that while acting, I would constantly picture what people who actually went through this would have felt. Whenever the thought of Udham Singh, a kid who actually had to make sense of this night, would kick in, it would numb me down. It would remind me that whatever we are trying to do might be difficult but it would still only be probably 10 per cent of what happened in reality. Even after returning to the hotel, it would not be like people would get back to their lives, chitchat and enjoy a wholesome dinner. Instead, we would all be a bit subdued, along with being tired. It was difficult to sleep at times, because my mind would keep picturing how the scenario would have been for people who were there at that point of time."

"I guess there was something there, "I guess there was something there, some energy, that kept us going. We just kept shooting. We didn't let ourselves indulge in that space. We kept shooting and I'm just glad we got through it," the *Raazi* actor ruminated.

Recently Vicky had uploaded a post saying 'Sirf naam nahi ek soch hai' on the name that Idham had come up

on the name that Udham had come up with when he surrendered himself -Ram Mohammad Singh Azad. Elaborating on that, he said, "Ram vision, that the freedom fighters saw then. There was an idea behind tattooing the name on his forearm. He wanted to surrender and that was the name not become about religion. He didn't want anybody to blame Hindus, or Muslims, or Sikhs, particularly, for the murder. But it was a free Indian who did

Any fan of Sircar's work would notice that there would always be a lingering message to his films. On asking him what he wanted to convey through Sardar Udham, since it felt like it was more than just the portrayal of truth, he answered, "As a country, that diversity and unity is the fibre that holds us all together. I am from Kolkata, Vicky is from Punjab, you might be from Lucknow — what is it that connects us all? Unity in diversity. I believe that, that is what this film is also trying to convey. And that rattled the British. I think that is also what happened on the fateful day, at Jallianwala Bagh. Three days before the massacre, it was Ram Navami and the procession there was attended by all Muslims and Sikhs. The rally was attended by people of all religions, that unity was so disturbing to the British that they decided to attack, out of sheer frustration. This was the backstory of the massacre. The message of equality is also very much prevalent?

On the lines of how Vicky personally perceived the character of Udham, whose life-story was an inspiration to all, he confessed, "I, personally, saw Sardar Udham as a pure soul. Anybody would get highly affected by something like that, which is the aftermath of the tragedy. But for me, I found him to be a pure soul because to keep something like that for 21 years in his heart, and still having clarity of thought is huge. Suffering through the pain and angst, and yet processing it for so long, to be clear and not blame someone is commendable. He did not hate the Britishers but hated the ones who represented the evil of colonialism and imperialism. For me, that is why, he is a hero. Not just a person full of vendetta or vegeance, but he had a thought and an ideology. He faced what no human should go through, yet he had the maturity to keep hatred aside from his objective. He just wanted to carry an action to make the world aware of what was happening in India, to tell them what kind of atrocities his countrymen were going through. This year, the event will bring together an array of over 40 speakers from across the world like Aaditya Thackeray (Minister of Tourism, Environment and Protocol, Maharashtra), Dia Mirza (actor and climate change crusader), Rajiv Kumar (economist and current vice-chairman of Niti Aayog), Sumant Sinha (founder, chairman and CEO of Renew Power), Al Gore (Nobel laureate), among others.

Among the others who are scheduled to speak at TEDx Gateway is Dr Jennifer Holmgren, a clean energy expert who views carbon as an opportunity. As the CEO of LanzaTech, she believes that if recycled, it can become a great source of energy to fuel the new world. Prior to LanzaTech, she was the VP and GM of the Renewable Energy and Chemicals business unit at UOP LLC, a Honeywell Company.

In the next few months, you will be able to wear sports clothes, dresses and fragrances made from carbon waste. And in the United States of America, Europe and the United Kingdom, we are building the infrastructure to produce sustainable aviation fuel to help transform the aviation industry. In the

US, in partnership with LanzaJet,

we will produce a combined 1 billion gallons of sustainable aviation fuel in the by 2030. Technology will continuously evolve, but the reality is that we can produce just about anything from waste emissions.

☐Your organisation, LanzaTech, endeavours to open carbon capture and reuse facilities across the



globe. What are the requirements for seamlessly implementing them globally, and would such technology be realistic in a country like India?

Absolutely! We have created a model we can scale in every region across the globe because we use distributed waste-based feedstocks and can use wastes that are specific to each country. In India, we are doing it with the critical partnerships with organisations like the DBT- IOC Centre for Advanced Bio-Energy Research and Indian Oil Corporation Limited. In addition, we see India as having plentiful waste feedstocks available across multiple sectors and we have partnerships to turn agricultural waste to ethanol and to convert that ethanol into products that our brand customers want. I know that the task ahead is the challenge of our lives and we need to try everything to bend the carbon curve. Innovation and new approaches to using carbon, especially atmospheric carbon will

At LanzaTech, we are closing the carbon cycle and creating a pathway to net-zero using cuttingedge synthetic biology, engineering and artificial intelligence and coupling that with a natural process that has been around for centuries involving fermentation. Instead of

yeast, we are using microbes that have also been around for years. So, we can all do our part to use the technology we already have and use a process we are already familiar with, with waste resources currently at our disposal, and create new pathways to preventing further damage.

■What steps should the human race implement to make the farfetched dream of net zero emissions by 2050 a reality?

We really should have the ambition for 2030. 2050 is too late. People need to be carbon smart and start asking questions about

where the carbon in their life comes from. Producers need to look at their supply chains, governments need to look at their policies. We must all rethink carbon and find ways to reuse the carbon that is already above ground. Until we stop extracting new carbon, we are never going to reach that goal.

■With climate change slowly heating the earth, how long would it take to reach a point of no return?

Unfortunately, we are at that point already. The science is clear, and the storms, floods, fires, and heat are not warnings, they are part of the reality we now face. Extreme weather events are everywhere and are impacting multiple facets of our lives. The urgency of the climate crisis requires swift and ambitious action to reduce emissions through all possible sustainable pathways. Carbon capture and reuse is a great example of a way we can contribute to the solution. It is through inno-vation like this that we can prevent any further damage to our planet, but I am afraid that there has been much damage already and people will continue to suffer around the world. We need to act now and we need to act decisively.



# SOLITARY ROADS TO SELF-DISCOVERY

Wandering through Ladakh, Gaurav Singh realises that no matter how far you may travel, you cannot run away from issues that you struggle with daily













hen anyone thinks of the mountains, what usually comes to mind is lush green serenity. My love for the blue pine and the Himalayan cedar is such that it draws me to retire to the magnificent Himalayas every few months. However, I let go of my obsession with the beautiful lush terrain this time around and chose a rather rugged mountainous experience, somewhere between the Kunlun Mountains in the north and the Himalayas in the south. Tactically placed on the ancient trade route, it has for ages been one of the most prosperous trading pillars via which transport of gold, indigo, and opium was shared across the Silk Road. You might know by now, I am talking about the land of high passes, Ladakh. A dream destination for those willing to explore in isolation.

### Are barren mountains beautiful?

Let me start with addressing the elephant in the room. How does it feel to be hugged by miles and miles of empti-

ness and nothingness? Honestly speaking, I was awestruck even before I landed in Leh. As soon as the desert-like landscape shows itself from the airplane window, something just shifts within you. Vast patches of just sand and military bases coloured in pop in the middle play tricks on you. Vegetation plays hide and seek but shows the most beautiful signs of life amidst pitch-barrenness. To be honest, it takes a bit, especially for someone in love with lush green, to end up liking what you see. But once you start seeing the changing terrain, it clicks with you, and you gradually get intoxicated by the piercing beauty of this magical land.

### How to prepare for Ladakh and the first few days

We have all heard about the famous altitude sickness and acclimatisation required once you enter Ladakh. And all of that is true. The altitude sickness is natural and takes one to three days to pass, during which you will feel mild to moderate headaches, shortness of breath, and fatigue. Diamox is the

magic pill that can help you through this turbulence, but that is pretty much it. Any rational person would recommend you to take the pit stop in Leh for at least the first two days.

On day one, I remember stepping out on Mall Road, which gives you a peek into the city's cosmopolitan nature. As much as it seems like the place is trying hard to fit into this depressing narrative of being a "global city", it showcases its innate cultural characteristics to those willing to see it. You'll see women by footpaths selling fresh vegetables, shopkeepers offering you the purest form of pashmina, cafes overcrowded with tourists and the Jama Masiid — down the street — with Indo-Iranian folks gathering for prayers. I distinctly remember being awestruck and embarrassing myself by asking one elderly gentleman about his eyes. I discovered that the secret behind the deep blue was him tracing his lineage to Alexander the Great. Before this, my only knowledge of Ladakh came from Andrew Harvey's riveting Journey In Ladakh, a book, that almost instantly

made me dream of being there one day. However, going there and experiencing the culture and beautiful way of life which bears a close resemblance to how they might have lived centuries ago is the strongest memory I want to preserve and defend.

### The lay of Leh

LEH has many exciting things to offer, irrespective of how varied your interests may be. There is a relaxed cafe culture with a mix of rooftop and indoor dining + drinking experiences. If you are an art and culture geek, I recommend places like the Central Asian Museum and the Ladakh Arts and Media Organisation. For shopping, Leh is just like other popular Indian hill stations, so try not to raise your expectations too high. But, I do recommend picking up handmade lip balms with an apricot extract from local vendors near Mall Road and making a customary appointment at Jigmat Couture for some beautiful Ladakhi clothing. Not to forget the exotic culinary experiences that the city offers — whether it

is the most succulent thukpas and the lipsmacking butter tea with a side of tingmo, khambir and apricot jam. Also, I would consider it a sin if you do not try jimpo, a natural Sea Buckthorn Berry Juice.

### Further afield in Ladakh

Once you acclimatise, Ladakh is your playing field. One can choose to do the typical Tso Moriri, Khardungla Pass, Pangong, Nubra sort of touristy places or you can be a backpacker and explore hidden gems like Turtuk, Chumathang, Stok, and Basgo. Either way, the journey from Leh to any of these beautiful villages is breathtaking. Apart from a few famous towns/villages, Ladakh isn't your everyday backpacking destination as hostels are rare and travel isn't the cheapest, especially thanks to COVID-19. Also, do remember that while venturing beyond Leh, you will require special inner line permits, which usually take a day to obtain.

I would walk daily to visit new villages; most times, localities seemed empty. Usually, it was just me walking with my backpack and a gazillion thoughts about existentialism for company. Is it just I, or does everybody become a bit more philosophical in the mountains?

Here it would only be fair to talk about the architecture of the houses and old establishments. While some appeared to be Buddhist and Bhutanese, others gave hints of the streets of Kashmir and some even showed remnants of the Mughal era. Though it is another melancholic contrast that hits me the worst every time I travel (almost anywhere). The cross between the intriguing ancient village and the crass ingenuity of tourist hubs, the complete mismatch, breaking the symmetry and equilibrium of a beauti-

### Traveling with a friend

As opposed to my ideal trips, which involve me, my backpack, my AirPods and a book, this time I ended up travelling with a dear friend, Vineet. Of course, when you choose to do this, trips usually tend to become less lonely and the fact that you can share the wonders you are witnessing, with someone close, helps you enjoy the overall experience. There are times when you will have differences over food, places to visit and things to do but finding a balance and doing things shared and solo while traveling with someone is the sweet balance that we achieved and felt proud of accomplishing. What's also useful is that you can divide tasks. For some places, my

friend would make the itinerary and, in other places, I would run the day's agenda. This gives you space to check out from daily logistics and sit back to soak the place in. For someone like me, it is crucial to have downtime — a breathing space where I do not want to interact — and when that sort of understanding is developed between two friends to give each other the room when they need it, travel/life becomes effortless. Also, I feel a long(ish) trip together is the perfect test of friendship. You see parts of the other person that you would not see otherwise by virtue of being together 24x7. All that helps in strengthening the bond further.

On a lighter note, having a friend around makes it very easy for you to get pretty pictures of yourself. Far beyond vanity, it is an exercise that helps you get to know each other better (for example, how a bad photo can ruin your mood for hours, just kidding). Hey, at least you no longer have to stand there contemplating and choosing the right person who you would shyly request to take a photo of you. Right?


### Comfort in solitude

No people, no network, no trees, no animals. It is like being in a no man's land. It brings a detachment from the outside world. Every time you climb up to a pass, you feel like you are levitating/floating in the air as if you have traveled to a different dimension the atmosphere and scenery add up to create this alternate reality. For me, Ladakh just invoked all that and, at times, it became overwhelming to see myself so clearly stripped away from all the filters and excuses that take over so quick-

But while you do that, please keep your conscience clear, know that you have to be extra careful when you hit the road and, for the love of whoever you may believe in, do not litter and pollute a place you are visiting. Go explore Ladakh. I promise you will come back filled with gratitude, love, and niceness that would take a while to shake off.



# WEST INDIES VIRTUALLY KNOCK OUT B'DESH BY 3 RUNS

efending champions West Indies kept alive their slender hopes of making the semifinals while virtually knocking Bangladesh out of the T20 World Cup with a narrow three-run win here on Friday.

Asked to set a target for the third consecutive time in the tournament, West Indies

other results go in their favour. Bangladesh began the chase on a poor note, losing openers Mohammad Naim (17) and Shakib Al Hasan (9), who was limping, in the first six overs. But gradually picked up the momentum with wicketkeeper batter Liton Das (44 off 43) taking the initiative.

West Indies, like Bangladesh, were sloppy in the field and the two-time champions were also guilty of missing as many as three run out opportunities.

With 50 need off the last six overs with six wickets in hand, skipper Mahmudullah (31 not out) and Das looked to be in control, converting ones into twos while also hitting boundaries regularly.

Dwayne Bravo (1/36) produced a conducive 17th over. giving away just three runs. In the first ball of the penultimate over, he was hit for a six by Mahmudullah but the veteran all-rounder proved his mettle by getting rid of danger-man Das in his final ball.
