PM TO VISIT ITALY, THE UK FROM OCT 29 TO ATTEND G20, CLIMATE SUMMITS

Punited global approach in dealing with the situation in Afghanistan and combating challenges of climate change and the coronavirus pandemic at the two-day G-20 Summit in Italy beginning October 30, people familiar with the development said on Sunday. The prime minister will be travelling to Rome and Glasgow from October 29 to November 2 to attend the 16th G-20 Summit and the World Leaders' Summit of COP-26 respectively, the Ministry of External Affairs (MEA) said.

GOVT DRAWS UP PLANS TO PROMOTE SITES ASSOCIATED WITH NETAJI

he Centre has drawn up plans to promote sites across the country associated with Netaji Subhas Chandra Bose through curated tours as part of events to commemorate the anniversary of the formation of the Azad Hind government, officials in the tourism ministry said. On October 21, 1943, Bose had announced the formation of the provisional government of Azad Hind in occupied Singapore. He had launched a struggle to free India from British rule under the banner of the provisional government in exile during the latter part of the Second World War.

EDIBLE OILS: CENTRE TO HOLD MEETING WITH STATES TODAY

he Centre on Sunday said it is monitoring the prices of cooking oils as demand rises during the festive season and will hold a virtual meeting with states on October 25 to review action taken by them on its stock holding limit order. On October 10, the Centre had imposed stock limits on traders of edible oils and oilseeds, barring certain importers and exporters, till March 31, in a bid to control domestic prices and provide relief to consumers. State governments and union territories were to decide the stock limit to be imposed on edible oils and oilseeds after taking into account the available stock and consumption pattern of that particular state or UT.

Naidu's team to meet Prez, YSRCP leaders Chief Election Commissioner

The political fight between the ruling YSRCP and Opposition TDP that has intensified in the last few days will be shifted to the national capital Delhi. Even as the TDP chief N Chandrababu Naidu led entourage is getting Naidu-led entourage is getting ready to fly to Delhi to meet President Ram Nath Kovind, YSRCP leaders are also making arrangements to meet the Chief Election Commissioner (CEC).

The political fireworks that were ignited by the objectionable remarks of TDP spokesperson Kommareddy Pattabhi Ram and the angry reaction from the YSRCP cadre a few days ago refuse to die down.

Naidu's appointment with the President has been confirmed for Monday afternoon. He will demand the imposition of the President's rule in Andhra Pradesh citing anarchism unleashed by the YSRCP govern-

On the other hand, YSRCP wants CEC to ban TDP stating that it is not fit to be a political party. Municipal Administration



Minister Botsa Satyanarayana has dropped enough hints in this regard two days ago and said the party would approach the CEC seeking a ban on TDP as the Opposition party has been hatching conspiracies against the people. He likened TDP to the

banned CPI (Maoist). Naidu's team is also said to be trying for the appointment of Union Home Minister Amit Shah. 'Janagraha Deekshas' across the

Union Home Minister Amit Shah Sunday said the "discriminatory' Article 370, which gave special status to Jammu and Kashmir, was scrapped because of personal efforts of Prime Minister Narendra Modi to fulfil the dream of Jana Sangh founder Syama Prasad

Mookerjee.

In his first public rally in J&K after the August 2019 revocation of its special status, Shah said Modi restored the grassroots democracy and started a new phase of development in J&K where lakhs of people faced injustice under the garb of Article 370.

"After a long gap, I have come to meet my brothers and sisters in Jammu. I was a bit tense because of the inclement weather and was not sure of meeting you. But by the blessings of the Mata Vaishno Devi, the sun came out and we came together," the home minister said at a public rally here.

Heavy rains on Saturday had cast a shadow over Shah's scheduled public meeting. However, an improvement in the weather allowed the rally to go through and it was attended by thousands of people who raised high pitch pro-BJP slogans."Today is the birth anniversary of Pandit Prem Nath Dogra, a leader from J&K who worked for the total integra-



tion of the state with India along with Mookerjee by raising the slogan of 'ek nishan, ek vidhan and ek-pradhan'," the home minister

"On August 5, 2019, the Modiled government took a historic decision and revoked the discriminatory article 370 paving the way for the development of lakhs of people of J&K who have faced injustice over the years," he

Pakistan brought to an end India's near-three-decade domination of them in the world stage in the most convincing fashion, embarrassing their arch-rivals by 10 wickets in the Super 12 stage of the T20 World Cup here on Sunday. Intent on breaking their run of

losses, Pakistan restricted India to 151 for seven after electing to field in the T20 showpiece's blockbuster

Pakistan then made light work of the target of 152, completing the win with 13 balls to spare.

Skipper Babar Azam stroked his way to 68 while his opening partner, Mohammad Rizwan, smashed 79 as the Indian bowlers struggled to contain the two batters.

100 cr vax doses claim 'false': Sanjay Raut

Shiv Sena MP Sanjay Raut has alleged that the claim of administration of 100 crore vaccine doses against COVID-19 in the country was "false" and not more than 23 crore doses were given to eligible citizens so far.

Addressing a party meeting at Nashik in Maharashtra on Saturday, Raut said he would give proof that the 100 crore vaccination claim was "false".

"How much will you lie?" the Raiya Sabha member asked, without taking any names.

"In the last fortnight, 20 Hindus and Sikhs have been killed, 17 to 18 soldiers have been martyred, China is creating problems in Arunachal Pradesh and Ladakh, but we are celebrating 100 crore vaccination, which is not true," the Shiv Sena's chief spokesperson claimed. Who has counted these numbers? he

When contacted, Maharashtra BJP spokesman Keshav Upadhye said Shiv Sena leaders are used to making baseless claims.

If there is a difference in service delivery, people will pan service to VIP patients with photo-op as PR spin. It won't be regarded as exemplary healthcare. For, when the common man goes to such hospitals, the problems start right at the entrance. All said and done, Khammam district Additional Collector Snehalatha has done something really appreciable.

Loyalty beyond a limit can be bad

Political heavy weights can sometimes unwittingly upset the plans of officials who are too loyal to them. With the transfer of GVMC Commissioner G Srijana, rumours are rife that it will cut to size a senior YSRCP leader, who wields a lot of influence in north Andhra.



Goals –2020'.
"Merely training the panel lawyers will not be sufficient. The solution to the problem is that some of the senior advocates must take legal aid as a matter of choice and keep on appearing for matters pro bono so that the man who comes through the door of legal aid service clinic is assured that it is not going to be a matter which is botched up and a quality legal aid will be extend-

ed to him," Justice Lalit said. Stressing the importance of empowering the poor and downtrodden, he said legal aid to the poor does not mean it is of poor level and it has to be of better quality and stan-

Stressing the need to empower women, the judge said women should be empowered to such an extent that she may run shoulder to shoulder with everyone of us.

Justice Lalit commended the efforts of the Karnataka State Legal Services Authority with respect to the establishment of the off-campus legal services clinics and release of a graphic novel to spread legal literacy in the state.

Arrested Pak terrorist killed, 3 security personnel injured

An arrested Pakistani terrorist was killed, while three security personnel were injured on Sunday when militants opened fire on a joint search party of the Army and police inside a forest in Poonch district of Jammu and Kashmir, officials said. Heavy firing and explosions were reported from Bhatta Durrian forest of Mendhar which along with nearby forest areas adjoining Surankote (Poonch) and Thanamandi in Rajouri district is witnessing a massive search operation, the officials said.

The operation, which saw nine Army personnel losing their lives in separate ambushes in Surankote and Mendhar on October 11 and 14, entered the 14th day on Sunday.

A police spokesperson said two policemen and an Army jawan along with a prisoner Zia Mustafa, a Pakistani terrorist affiliated with the Lashkar-e-



Toiba (LeT) were injured in firing by terrorists in Bhatta Durrian forest this morning.

"Detenue Mustafa was taken to Bhatadurian for identification of terrorist hideout during the ongoing operation in which three Army jawans and a JCO were martyred (on October 14). "During the search when the team approached the hideout, terrorists again opened fire on the joint team of police and Army personnel in which two policemen and an Army jawan

sustained injuries," the

spokesperson said.

The police said Mustafa also sustained injuries and he could not be taken out from the site due to heavy fire.

"During the subsequent operation additional reinforcements were sent and the body of Mustafa has been retrieved from the encounter site," the spokesperson said, adding the operation (to neutralise the hiding terrorists) is in progress and legal process has been initiated in connection with the killing of the Pakistani terrorist.

43 pc teachers unhappy with online mode of teaching in pandemic: Survey students (28 per cent), emotional issues expressed by the PNS NEW DELHI journal -- Children First:

Around 43 per cent of teachers said they were not satisfied with online teaching during the pandemic while nine per cent of them expressed complete dissatisfaction with the mode of education, according to a

A total of 220 school teachers participated while 20 people, including eight teachers, were interviewed for an online survey published in the Delhi Commission for Protection of

Journal on Children's Lives. A majority of teachers (43

per cent) expressed that they were not satisfied with teaching online and nine per cent of the participants were not at all happy with it, the survey said.

The key issues that the teachers identified as the teaching went online due to the pandemic were absenteeism (14 per cent), children with special needs not being considered (21 per cent), low attention span of

students (19 per cent), and no assessment or assignment completion by the students (10 per cent).

The participating teachers and students also stated that online emotional support and group engagements by the counsellors and social workers helped children to be more expressive and participatory in online education.

The teachers stressed that the involvement of parents

Ganga's quality improves to bathing standards: NMCG DG PNS NEW DELHI

Ganga's water quality has significantly improved since 2014 with the entire length of the river having more dissolved oxygen than the prescribed minimum level, and 68 out of 97 monitoring locations compliant with bathing standards in terms of biochemical oxygen

demand, a senior official said. In an interview to PTI, National Mission for Clean Ganga Director General Rajiv Ranjan Mishra said 32 out of 53 locations monitoring biochemical oxygen demand (BOD) were compliant with the primary water quality criteria for bathing in 2014, whereas in 2021 the total monitoring stations increased to 97, out of which 68 monitoring locations were found compliant with BOD criteria for bathing.

BOD represents the amount of oxygen consumed by bacteria and other microorganisms. The greater the BOD, the more rapidly oxygen is depleted in the stream, which means less oxygen is available to higher

forms of aquatic life. Mishra said the dissolved oxygen level of the Ganga has also improved. "At present, the entire length

of Ganga has more dissolved oxygen (DO) than the prescribed minimum level of 5 mg/l. The river water quality has shown improvement between 2014 and 2021," he said. The water quality of Ganga is assessed as per primary water quality standard for outdoor bathing in terms of dissolved oxygen (=5mg/L), BOD (=3mg/L) and faecal coliform (FC) (=2500 MPN/100ml) and (pH) (6.5-8.5).

Mishra said the steps taken to improve the water quality include abatement and control of source pollution by establishment or upgradation of wastewater treatment plants for the towns located on Ganga main

stem and its tributaries, construction of crematoria, surface cleaning activities, solid waste management on the riverbanks and floodplains and refraining trash from drains falling into river Ganga by installation of trash racks at the mouth of

"The outcome of these projects has started showing significant results and the water quality of river Ganga will further improve as more and more projects are operationalised," he

Mishra said in Uttarakhand up to Haridwar, the river is meeting class A criteria, which is the highest level i.e., it meets

DO, BOD and FC criteria. "The NMCG's efforts towards cleaning of the river have been targeted towards meeting bathing quality criteria for river water. Out of the 351 polluted river stretches identified by the Central Pollution Control Board (CPCB) in India, no stretch of river Ganga falls in the top three

priority categories," he said. Noting that the cleaning of river Ganga is a continuous

process, he said many initiatives have started yielding results and the water quality of the river will further improve as more and more projects are commissioned.

Mishra said during the Covid-triggered lockdown, there was visible improvement in the quality of Ganga water.

"It mostly happened due to the shutdown of industrial activities and also no solid waste disposal on ghats as people were not able to visit the ghats and other public places. But at the same time, we also have to realise that the sewage generation continued to take place, which was treated at sewage treatment plants (STP), several of them came during the last few years. They were monitored closely and ran without any disruption," he www.dailypioneer.com

New Kashmir

Amit Shah has extended his hand; it's now time for the youth to reciprocate

■ nion Home Minister Amit Shah is on his first visit to Kashmir after the abrogation of Article 370. From his point of view, he pressed all the right buttons on his first day in Srinagar. He wants calm in the region that is like a becalmed ship in the last two years. Shah kicked off the visit by chairing a security meeting. Two aspects of the Valley's disquiet were jarring: Continuing violence despite heavy security presence and radicalisation of local youth. The Minister was worried that the unending violence was undoing the Government's efforts to stabilise the situation. He was probably told in return that with the terrorists targeting ordinary individuals, it was difficult to give protection to every citizen. The toll has already crossed 30. Shah later interacted with people at the Raj Bhavan, addressed youth and visited the house of a slain police officer. His wife was given a Government job. As outreaches go, the visit is a serious outreach



campaign of the Centre in Kashmir by the Home Minister himself. It comes at a time when recent violence is threatening to stall Delhi's attempts at rapprochement, the usual pressures from the international community and the snide remarks from Pakistan. The Government would not want the ongoing exercise of constituency delimitation to be delayed. It has perhaps set an agenda for itself wherein the constituencies would first be subjected to delimitation, favouring the Jammu region as Kashmir complains or rectifying its under-representation as Jammu counters, after which elections would be held.

The formation of the next Government will reveal which region has an edge and that may determine future State politics. Like he announced in the Parliament, Shah also said in Srinagar that the return of statehood would be taken up thereafter. The Government is of the view that the Kashmiri youth should be persuaded to join the national mainstream as the region returns to a new normal. Nearly 70 per cent of the State's population is under the age of 35. Shah said he was in Srinagar to make friends with the Kashmiri youth, assuring them of all help for education, employment and development. It is not yet known how these youth have reacted to the Home Minister's persuasion. That is the key. They are being asked to forget all of the past and embrace a "new era in Kashmir". The "era" was brought in on the back of decisions like the internet ban and curfew that were necessary to foil a plot to provoke Kashmiris, as the Home Minister explained. Tourism is flourishing and there is no curfew now, he said, even as Srinagar was enveloped in one of the toughest security blankets with the use of drone cameras, detention of hundreds of people, including youth, and seizure of hundreds of motorcycles in preparation for the Minister's visit. Shah amplified his aspirations in earnest. It is up to the aspirations of the youth to match his.



Under fire

The Oppn is sharpening its claws to take on the BJP, especially in Punjab and Goa

he BJP is coming under increasingly ferocious attack from various guarters ahead of next year's Assembly elections in five States. The ruling party at the Centre has its Government in UP, Uttarakhand and Goa and is a governing alliance partner in Manipur while Punjab currently has the Congress Government



the Congress. Going into the elections, it is one of the few States where the beleaguered party is still considered to be on a better footing than its rivals. The open, long-drawn power struggle between Navjot Singh Sidhu and then Chief Minister Capt Amarinder Singh has not really done the Congress any good turn. Following the acrimonious duel, the party high command was forced to opt for Dalit leader Charanjit Singh Channi as the Chief Minister. All eyes are now on the leadership to see how the forced change and the sulking Captain affect its fortunes: Will it manage to retain power despite the

bad blood within and anti-incumbency, or whether the AAP will concretise its hold

or if the BJP will turn out to be the dark horse?

According to poll pundits, the BJP faces a tough competition only in Punjab and is set to romp home comfortably in the other four States. However, there is a silent storm brewing against it over the coastal horizon of Goa, too. While TMC supremo Mamata Banerjee has since July's 'Martyrs' Day' event started making an outreach to the electorate there, her nephew and TMC national general secretary Abhishek Banerjee has now made a shriller pitch for the party's all-out debut in Goa, saying they will register a win in the State. The AAP is also pulling out all the stops in both Punjab and Goa to fulfil Arvind Kejriwal's aspiration to go national. However, all said and done, the impact of the BJP's mammoth poll machinery can't be underestimated, whenever it starts rolling full throttle. There already is speculation in the media that Goa Chief Minister Pramod Sawant may be replaced soon for the party to contest the election on a clean slate. Besides, hundreds of the RSS cadres have fanned across the State and are working silently to ensure that the BJP stages a comeback. Time will tell which party's calculations hit the bull's-eye at the hustings.

Educate to achieve attitudinal changes-

he strength and resilience of Indian democracy receive widespread appreciation. For the outside world, it is amazing that a Prime Minister loses House confidence by one vote, and accepts it without even asking for a recount. But the fading away of the Independence struggle-genera tion has led to severe erosion of values, the impact of which is visible all around. The violence and murder in Lakhimpur Kheri, lynching of a young Dalit person in Rajasthan and the barbaric killing of a young man at the Singhu border are among the instances of avoidable loss of life in a civilised society. Is it not a shame that blatant discrimination is practised even in ex gratia payment to victims? This is not the democracy that MK Gandhi and numerous other luminaries fought for. Selfish motives, shortsighted goals and vested interests are denting India's image globally. Gandhi found everything in India attractive as "India has everything that a human being with highest aspirations could aspire for". He found India "fitted for religious supremacy of the world, and that India is a karmabhumi, not a bhogbhumi. He was convinced that India's mission was different from that of others.

On October 20, 1927, he said about Hindu dharma: "I have found it to be the most tolerant of all religions known to me. Its freedom from dogma makes a forcible appeal to me inasmuch as it gives the votary the largest scope for self-expression. Not being an exclusive religion, it enables the followers of that faith not merely to respect all the other religions, but also to admire and assimilate whatever may be good in other faiths." Gandhi did not mean that "everything in India that attracted" him included abhorrent practices like untouchability, dowry, child marriages, and much more. He loved India, its diversity, its culture, and lamented its downfall over the centuries because of foreign invaders and internal deficiencies. He was very clear in his priorities for resurgence of a new India: Education for all, dignity for all. As one goes through his writings that indicate his vision for India, political freedom was only

This was the level of transparency he had set for those who were to take over the reins of power after India's Independence. He preached only what he could practice. His approach, as is well known by now, attracted global interest only because he became a unique example of courage, bravery and commitment to conviction. Billions the world over were convinced during his lifetime that only the Gandhian way could extricate mankind – and our planet — from the clutches of distrust, bigotry, racism, caste prejudices, terrorism, fundamentalism and much more that jeopardised the very human existence. The global foundation for a world of peace was to be laid in the pragmatic implementation of the universalisation of education which, Gandhi thought, was the only ray of hope for the suffering masses. The Hind Swaraj he penned in 1909 is

Violence must totally vanish from Gandhi's land. One is convinced that the solution lies in reverting to Gandhi and re-articulating his thoughts in the current idiom. While those in power have the obligation to find immediate solutions, the long-term strategy must focus on education, right from the early days to universities. Attitudinal transformation can be possible only through Gandhian vision, the essence of which he had presented to the nation in the 'Basic Education', which he thought was his most significant contribution. Why Gandhi was so enamoured by this idea? He wanted education to draw the best out of "head, hand and heart". This, he thought, was the best way to transform a lay learner into a full-grown personality. It is indeed laudable that with literacy below 20 per cent at Independence, India is touching 80 per cent and, that too, when population growth has has also led to certain aberrations in teaching and learning, most prominent being the concentration on "head", and neartotal neglect of "hand and heart". The consequences are before us. The 75-year experience must put the system on

the right path. The manner in which the National Education Policy-2020 lays focus on character building, value inculcation and recommends the integration of academic and vocational education clearly indicates the impact of Gandhian education philosophy. Sadly, the philosophy that Gandhi and his colleagues had articulated was simply ignored by the earlier decision makers. No effort was made to bring forth a model of education rooted in Indian culture and, at the same time, committed to new knowledge. This formulation would be complete when synchronised with Gandhi's writing in the Young India issue of June 3, 1926: "The highest form of freedom carries with it the greatest measure of discipline and humility. Freedom that comes from discipline and humility cannot be denied; unbridled license is a sign of vulgarity injurious alike to self and one's neighbours." To re-emphasise, education

AI CAN'T TAKE OVER JOURNALISM

Sir — As industries are being affected by the age of automation, it is feared that journalism could be next. But this everbusy field needs more human power for reporting and publishing news and stories than machines. The profession involves much more than mechanisation. Publishing houses might soon opt to switch journalists with Artificial Intelligence robots and applications to minimise human hands. But clearly, AI involved works can account for only about 10 per cent of the total function in journalism. Another key aspect of journalism is that it involves a lot of emotional intelligence. For example, a journalist visiting a flood-ravaged area or a fire-affected spot and speaking to people who are rendered homeless, can never be compared with a robot's workmanship.

It is important to remember that journalism is more than just the sum of its parts and the profession's human character cannot be automated, as journalists provide more than just information. As former journalist and professor at the University of Minnesota Rodrigo Zamith aptly sums up, "Accuracy requires proper verification. Robots cannot get it right every time."

FIRST COLUMN **LEBANON IS A SHIP WITH MANY HOLES**

Lebanon has gone from being a middle-class country to a very poor one in last five years



ff the Lebanese coast about 60 km north of Beirut a 104-metre battleship stands vertically, with her bow and some 30 metres of her length plunged into the mud. The seabed is 140 metres down, but you can even scuba-dive on the stern if you are a technical diver. The ship is a bit like Lebanon, for reasons I'll explain later.

Five years ago Lebanon still looked like a middle-class country with a lot of poor people. Now it looks like a very poor country with a few rich people. Indeed, even the civil war of 1975-1990 did less damage to the economy, though it destroyed several hundred thousand lives and much of the country's infrastructure. The current disaster's roots are in that war. It drove the Lebanese back into the relative safety of their own sectarian communities, Christian, Sunni Muslim, and Shia Muslim, and warlords arose to protect those communities. By the end of the war in 1990, they were the new political and financial elite, with well-paid militias to enforce their will on their own communities — and they didn't go back to their day jobs. They became a corrupt and nepotistic club.

That system was visibly coming apart by the 2010s. There simply wasn't enough money to share out among the elites. Lebanon pro-



duces almost nothing, not even enough food for its own people, and its imports are paid for with remittances, foreign aid, and loans. With not enough money coming in to sustain their immense patronage networks, the elites started taxing the poorer sections, and in 2019 something snapped. Suddenly Beirut's streets were full of protesters demanding fundamental change.

Lebanon is a former French colony, so French President Emmanuel Macron flew in and offered the Lebanese government £11 billion in return for structural reforms that would root out the corruption at the heart of government. But the elites who benefit from that system are the government, in practice, so of course they said no, thanks. Then came the massive explosion in Beirut's port district last year. That got the International Monetary Fund involved, offering Lebanon huge loans if the corrupt system is reformed, but it's likely that the government will turn them away again.

It's getting close to the edge. Last Thursday Hezbollah staged a mass protest in Beirut, demanding the removal of the judge presiding over the inquiry into who was responsible for importing the 2,750 tonnes of fertiliser that caused last year's port blast. When the march entered a Christian district at least one sniper opened up on it. Seven Shias died, and the crowd (some of whom were armed) tried to storm Christian neighbourhoods in retaliation. And still the Lebanese political class refuses to bend.

So why does that political class resemble the captain of HMS Victoria, the defunct battleship that did a nose-dive in 1893? Because the officer commanding the British Mediterranean Fleet, Vice-Admiral Sir George Tryon, was one of the most stubborn men in history. He ordered a very complex manoeuvre in which two parallel lines of battleships would make simultaneous U-turns towards each other, winding up going in the opposite direction but with the parallel lines much closer together. And he got the distance wrong.

Everybody else on the bridge could see the ships were actually going to collide, and several of them spoke to Tryon about it, but he ignored their advice. The ship that was going to ram him also queried his orders, but he persevered. So they collided, and the admiral went down with his ship.

Think of Lebanon's political class as Admiral Tryon, and the coun-

Artificial Intelligence in counter-terrorism

Security agencies need unhindered data access to predict future radicalisation apart from the spread of fake news that supplements ulterior agendas

n 2015, the IS declared its expansion to include the Khorasan region, which includes the modern political boundaries of Iran, Central Asia, Afghanistan, and Pakistan. Since early 2020, the IS-K has been regularly publishing its 'Voice of Hind' in the Kashmir Valley to radicalise the youth and destabilise the Valley. The scope of the IS-K has expanded to India and Bangladesh. The killings of non-Kashmiris and Hindus in the Valley, apart from the pre-planned vandalising of the Durga Puja pandals in Bangladesh, point out the increasing tentacles of IS-K working in tandem with the Taliban. The developments call for the incorporation of new methods in the domain of counter-terrorism.

The most prominent measure that can be adopted is the pre-detection of the people with terror intent. The current usage of drones, sting operations and informants do not suffice under the prevailing circumstances. Artificial Intelligence (AI) can immensely help the forces and reduce their vulnerabilities. AI technologies are being used actively by many nations for policing and counter-terrorism operations with offensive weaponry. The objective here is to make accurate predictions and adopt an approach to 'what will happen' rather than 'what happened'? The government should recognise the legal entity of the AI technologies for counter-terrorism operations. It should become legally obligatory for the telecommunications service providers to mirror the conversations of suspected terrorists in sensitive zones such as Kashmir, Punjab and West Bengal, apart from the other border areas.

Security agencies should have unhindered data access to predict future radicalisation apart from the spread of fake news that supplements the ulterior agendas. Tracking the financial transaction information and the travel patterns of suspected individuals apart from identifying sleeper cells that purchase dual-use explosive materials are some of the methodologies followed. To enhance the efficacy of the existing methods and check further radicalisation apart from the exposure to other hybrid warfare tactics such as fake news, the surfing data of institutes of higher education should be monitored.

New indigenous platforms supporting the Google and Yahoo search engines that identify potential recruits through scanning their internet browsing history should be encouraged. These surveillance centers and their servers should be under the strict vigil of the central police forces or the armed forces. Google has developed the redirect method, which uses search algorithms, keywords, and phrases frequently used by people with violent tendencies.

The second step for pre-detection can involve reversal through psychological and mindset change throughsoft counterradicalisation measures that can be locally tailored through AI. Such novelty has to be brought about in counter-terrorism operations. For instance, Saudi Arabia has

'Sakina' programme is one such example of Saudi Arabia.

According to the reports, one of the most preferred recruitment platforms of IS is Facebook and Twitter, wherein the IS, through its tweets and re-tweets, can create a closed online micro-community around the recruit or the targeted recruit. As the communication between recruit and the handling agency develops, end to end encryption platforms like WhatsApp and Telegram are used for private 'dark' conversations to compel the individual to commit violent crimes.

The problem lies in 'one standard encryption' policy throughout the country, making no distinction between an 'operational' area and a 'peace' area. À counter move can perhaps be possible wherein sensitive areas are out of bounds for these encrypted platforms due to national security. Privacy perhaps should only be allowed in 'peace' areas. where there are no immediate threats to national security. As new threats such as Talibanization of Pakistan and re-radicalisation of the Valley emerge, it becomes imperative for the government to adopt novel law enforcement tools to counter them.

At the level of land-based counter-terror operations, where troops operate at the level of small teams, methods have to be revolutionised. Besides the satellite data providing real-time intelligence, thermographic cameras can be installed in the forests apart from operational developments of the ter-

surveillance from UAVs. In the bordering villages, various AI-enabled cameras with monitoring at two undisclosed locations (to avoid sabotage) can immensely help the security forces. Cameras fitted with Facial Recognition (FR) features can help locate any suspicious 'entry' in sensitive areas.

In the cities, especially around the festivals, crowd scanning with multiple AI tools for locational tracking and thwarting terrorist attacks can be done. In some critical areas, the government can also introduce identity cards with biometric chips that have data of iris, facial expressions, and fingerprints.

The tools of AI can be customised even for regular policing in case the terrorists intermingle with the crowd. For instance, China uses Hikvision and Cloud Walk while the US depends upon Pred Pol in cities like Los Angeles for counter-terrorism and policing. Also, gunfire detection software-American agencies to detect shooting by using acoustic sensing tech-

nology to deter crimes. Even the minute details of the number and the types of weapons in possession of the terrorists and other anti-national elements can be ascertained if specific biologically inspired AI surveillance mechanisms involving high-speed data processing can be used for preventive search operations and threat elimination. The same technologies can also be effectively used during counter-terrorism operations to overview, monitor and report the rorists to the security agencies.

Third, the Indian industries using 'dual use' AI should be brought within the domain of a new initiative of 'civil-military interface' in which certain companies can be roped into implanting AI technologies to the existing indigenous weapons under the supervision of DRDO. For instance, indegenous guns or rifles can be experimentally mounted with low weight AI cameras or biometric systems with an ability to detect and eliminate potential terrorists if they use a ring of human shields to escape or launch attacks on the forces.

For this, establishing an AI intelligence cell in the armed forces and civilian intelligence agencies with active coordination can probably solve the issues in implementing such novel methods. Agencies have to be working in tandem with detailed distinctions and overlaps of their duties and responsibilities to ensure that there is no 'conflict of Shot Spotter is also used by the interest' which can potentially hamper the counter-terrorism strategies The larger aim of the AI intelligence cell of the Indian army should be to increase its own operability domestically and develop an ability to be able to work with the AI divisions of our allies such as Israel, the US, and Japan apart from the others. Finally, equal importance has to be given to the increasing role of perception management through regular media briefings by the army to raise the social acceptance of the government security measures. Citizen surveillance and alertness also have to be encouraged to thwart the terrorist attacks.

India to seek undelivered Qatar gas PNS NEW DELHI

India will bargain for supply of undelivered gas quantities of past years when it negotiates renewal of its multi-billion dollar LNG import deal with Qatar, an official said.

Petronet LNG Ltd's 7.5 million tonnes a year liquefied natural gas (LNG) import deal with Qatargas is ending in 2028. Renewal, if any, has to be confirmed 5 years ahead of

Talks for renewal will start next year and will be conditioned on Qatargas delivering in 2022 the 50 cargoes or shiploads of LNG that weren't taken in 2015, Petronet Director-Finance V K Mishra said.

India in 2015 had not taken delivery of the cargoes as it renegotiated the pricing of the long-term supply contract after prices hit double-digit.

Qatar had then agreed to revise the pricing formula subject to India buying an additional 1 million tonnes per annum of LNG.

438 infra projects show cost overrun of Rs 4.3 lakh crore

As many as 438 infrastructure projects, each worth Rs 150 crore or more, have been hit by cost overruns totalling more than Rs 4.3 lakh crore, according to a report.

The Ministry of Statistics and Programme Implementation monitors infrastructure projects worth Rs 150 crore and above.

Of the 1,670 such projects, 438 reported cost overruns and 563 were delayed.

"Total original cost of implementation of the 1,670 projects was Rs 21,66,048.11 crore and their anticipated completion cost is likely to be Rs 25,96,907.70 crore, which reflects overall cost overruns of Rs 4,30,859.59 crore (19.89 per cent of original cost)," the ministry's latest report for September 2021 said

According to the report, the expenditure incurred on these projects till September 2021 is Rs 12,54,512.40 crore, which is 48.31 per cent of the anticipated cost of the projects.



that the number of delayed projects decreases to 380 if delay is calculated on the basis of latest schedule of completion. Further, for 808 projects neither the year of commissioning nor the tentative gestation period has been report-

Out of the 563 delayed projects, 100 have overall delay in the range of 1-12 months, 120 have been delayed for 13-24 months, 216 for 25-60 months and 127 projects have delays of 61 months and above. The average time overrun in these 563 delayed projects is 47 months. Reasons for time overruns as reported by various project implementing agencies include delay in land acquisition, delay in obtaining forest and environment clearture support and linkages. Delay in tie-up for project

financing, delay in finalisation of detailed engineering, change in scope, delay in tendering, ordering and equipment supply, and law and order problems are among the other reasons. The report also cited state-wise lockdowns due to COVID-19 as a reason for the delay in implementation of these projects.

Petrol, diesel prices hiked for fifth consecutive day

Petrol and diesel prices on Sunday were hiked for the fifth straight day by 35 paise per litre each, pushing pump rates to new high across the country. The price of petrol in Delhi rose to its highest-ever level of Rs 107.59 a litre and Rs 113.46 per litre in Mumbai, according to a price notification of stateowned fuel retailers.

In Mumbai, diesel now comes for Rs 104.38 a litre, while in Delhi, it costs Rs 96.32 per litre.
This is the fifth consecutive

day of the price hike. There was no change in rates on October 18 and 19, prior to which prices were hiked by 35 paise per litre each on four straight days.

While petrol has already hit the Rs 100-a-litre mark or more in all major cities of the country, diesel has touched that level in over one-and-ahalf dozen states and UTs from Jammu & Kashmir to Tamil Nadu. West Bengal on Sunday became the latest state to have the nation's most used fuel above that level. Purulia, Krishnanagar,

Baharampur and Cooch Behar districts of the state had diesel above Rs 100-a-litre mark. Prices differ from state to

Diesel rates have been increased by Rs 7.70 per litre in 24 hikes since September 24.

Prior to that, the petrol price was increased by Rs . 11.44 a litre between May 4 and July 17. The diesel rate had gone up by Rs 9.14 per litre during this period.

Rentals of retail space up 11-17%

Rentals of high-street retail are inching back to pre-COVID levels in Delhi-NCR on the back of revival in business, as rents in upscale Khan Market, South Extension and Connaught Place have risen 11-17 per cent during July-September compared to the previous quarter, according to Cushman and Wakefield. "Rentals inching back to pre-COVID levels as market activity strengthens," global proper-ty consultant Cushman and Wakefield (C&W) said in its report 'Marketbeat- Delhi-NCR, Retail Q3 2021' (July-September). The Delhi-NCR ket recorded improved retail activity during the September quarter, the consultant said, adding that early signs of recovery could be seen with a pickup in retail leasing.

"With rentals inching back to pre-COVID levels and accommodation on commercial terms narrowing, the only direction for retail in the coming months is upwards," said Vibhor Jain, Managing Director, North, Cushman & Wakefield. "Increased vaccination and a low caseload have certainly played an important role in the return to normalcy and higher consumer confidence," the report said. In South Extension I & II, the rent rose by 16.7 per cent quarter on quarter (Q-o-O) to Rs 700 per square feet during the third quarter of the current calendar year.

most populated country, with a majority of its people between the age group of 10 to 24. This means that the country is at a relative advantage as young adults constitute a greater percentage of job seekers, thereby having the potential to boost

its economy. However, for the past decade, India's

Shakib becomes T20 World Cup's highest wicket-taker

Bangladesh's premier all-rounder Shakib Al Hasan on Sunday became the leading wicket-taker in the history of T20 World Cups, surpassing former Pakistan skipper Shahid Afridi when he dismissed Sri Lanka's Pathum Nissanka during their Super 12 match here.

Shakib entered the game with 39 wickets in 28 matches. Having produced a matchwinning spell (4/9) against Oman in the preliminaries, Shakib, one of the world's leading all-rounders, found himself among the wickets in the team's first Super 12 game, against Sri

Afridi picked 39 wickets in 34 matches.

Shakib went past Afridi's record when he used his vast experience to get the better of Nissanka with a flighted deliv-

Two balls later, Shakib bowled Avishka Fernando for his 41st wicket in the tourna-

With Bangladesh having made the Super 12s and guaranteed to play at least five matches, it was only a matter of time before the left-arm spinner bettered Afridi's record.

Shakib is also the current highest wicket-taker in T20Is.

Asalanka's unbeaten win against B'desh

Young left-hander Charith Asalanka smashed an unbeaten 80 off 49 balls while fellow southpaw Bhanuka Rajapaksa made a quickfire half-century as Sri Lanka beat Bangladesh by five wickets in their T20 World Cup Super 12 Group 1 match here on Sunday.

Sri Lanka suffered a midinnings mini batting collapse but recovered in time to chase down the target of 172 with seven balls to spare, thanks to brilliant half centuries from Asalanka and Rajapaksa (53 off 31 balls) with the duo stitching 86 runs in quick time for the fifth wicket in jus 8.4 overs.

The 24-year-old Asalanka, who has played just eight ODIs and four T20Is before Sunday's match, held the Sri Lanka innings together, hitting five fours and as many sixes in his entertaining unbeaten knock.

the 30-year-old Rajapaksa smashed three fours and as many sixes in his 31-ball innings as Sri Lanka reached 172 for 5 in 18.5 overs. However Bangladesh

would certainly be disappointed with their shoddy outfieldas Litton Das dropped regulation catches of Rajapaksa and Asalanka denying his team a shot at victory.

Bangladesh got the breakthrough with the fourth delivery itself as left-arm spinner Nasum Ahmed got rid of opener Kusal Perera (1) who failed to read a flatter and quicker

delivery and was clean bowled. Despite the early jolt, Sri Lanka were on the ascendency with Asalanka getting the

boundaries with ease. He hoisted Nasum for two sixes in the third over and then punished Coming in the 10th over, Mahedi Hasan for another maximum to take Sri Lanka to

54 for 1 at the end of powerplay. But Shakib Al Hasan triggered a mini batting collapse with two wickets — that of Pathum Nissanka (24) and Avishka Fernando (0) - in four balls. Mohammad Saifuddin

then dismissed Wanindu Hasaranga (6) as Sri Lanka lost three wickets in 10 balls for the addition of nine runs.

Sri Lanka were 80 for 4 at the halfway mark and set-batter Asalanka, who reached to his fifty off 32 balls, kept them in the hunt. He was going great guns by hoisting Mahmudullah for two sixes in the 14th over.

Sri Lanka needed 46 from

the final five overs but Asalanka and new batsman Rajapaksa decisively titled the balance of the game in their favour. Rajapaksa smacked three sixes in a sensational show of batting pyrotechnics in the 16th over bowled by Saifuddin from which Sri Lanka took 22 runs.

Earlier, opener Mohammad Naim and Mushfiqur Rahim cracked impressive half centuries to steer Bangladesh to a competitive 171 for four.

Joining forces in the eighth over when their side was struggling at 56 for two, Naim and Rahim stitched a quick 73-run stand in 8.3 overs to keep the momentum going.

Naim hit six boundaries in

his 52-ball 62-run knock while Rahim remained unbeaten on 57 from 37 balls with the help of five fours and two sixes.

F3 to hit theatres on February 25 next year




