Yogi balances caste equation in Cabinet

Ahead of polls CM inducts 3

OBCs, 2 Dalits, 1 ST & 1 Brahmin

In a move to balance the caste equation in his Ministry ahead of next year's Assembly election, Uttar Pradesh (UP) Chief Minister Yogi Adityanath expanded his Cabinet on Sunday by inducting seven new faces, which included three OBCs, two Dalits, one ST and one Brahmin.

Jitin Prasada (Brahmin), Chhatrapal Singh Gangwar (Kurmi), Paltu Ram (Dalit),

Sangita Balwant Bind (OBC), Sanjeev Kumar (ST), Dinesh Khatik (SC) and Dharmvir Prajapati (OBC) were inducted into the Cabinet at a simple

Jitin took oath as Cabinet Minister while the others were sworn-in as Minister of State (MoS). The oath was administered by Governor Anandiben Patel at a function in the Gandhi

Bhavan.There were 53 Ministers in the UP Cabinet earlier and seven more were inducted on Sunday as per the constitutional limit, out of which there are now 24 Cabinet Ministers including the Chief Minister.

The Cabinet was expanded for the first time on August 22, 2019 and several new faces were included then, while some were dropped. There were 56 members in the Cabinet at that time. Three Ministers died due to Covid-19, which included the Minister of State Vijay Kumar Kashyap, who died recently, while Minister Chetan Chauhan and Minister Kamal Rani Varun died in the first wave of the Corona

A younger Cabinet takes shape in Punjab

Channi tries to infuse youth, caste balance in State Cong

The old order came to an end in the Punjab Congress with the induction of young and new faces into the Cabinet in an apparent attempt to infuse enthusiasm and youth in the party, just about three months before elections, while ensuring a social, caste and regional balance.

Six days after he took over the party reins amid a changed political situation, Punjab Chief Minister Charanjit Singh

Channi on Sunday introduced his 15-member Council of Ministers, inducting seven new faces while retaining eight from the previous Cabinet. However, the re-entry of Rana Gurjit Singh, who stepped down following his alleged involvement in a mining scam less a year after becoming the Minister in 2018, has attracted a lot of criticism, not only from rivals but from within the party

The new Cabinet, formed with the approval of the party high command, especially Rahul Gandhi, has three below-50 Ministers — indicating the party's effort to bring in a generational shift by giving the youth a chance to perform with just about three months in hand. Amarinder Singh Raja Warring, 43, is the youngest

Minister in the Channi

Cabinet, while 78-year-old Tript Rajinder Singh Bajwa is the oldest.

While constituting the Cabinet, which took about three days of hectic deliberations with the high command and Channi's back-to-back trips to the national Capital special attention has been paid to strike a balance between all castes, sections, and regions. Besides, an attempt has been made to placate the legislators close to the former Chief Minister Captain Amarinder Singh, while also paying off for the loyalty to the party.

In all, eight of the 15 Ministers, who took oath of office on Sunday, were retained by Channi. It has been learnt that the Raj Bhawan has to issue an ultimatum to the Puniab Government to share the list of the MLAs to be sworn-in.

The sub-stations to be dedicated include one substation of 220 KV voltage, 6 sub-stations of $132\,\mathrm{KV}$ voltage and 9 sub-stations of $35\,\mathrm{KV}$ voltage. Their total cost is Rs. 287 crore 33 lakh. The total cost of 13 sub-centers 33/11 KV for which bhumi pujan will be performed is Rs 34.47 crore. In future, more than 42,000 consumers of 11 districts will be

Two held in Delhi Rohini Court shootout | Police issues advisory ahead

The Special Cell of Delhi ■ Police on late Saturday night has arrested two persons in connection with the shootout at Delhi's Rohini Court in which three men including jailed gangster Jitender Mann alias Gogi were

The accused has been identified as Umesh Yadav and

On Friday, Rahul and Jagdeep alias Jagga from Gogi's rival gang dressed as lawyers, entered the courtroom of Judge Gagandeep Singh, and fired upon gangster Gogi, killing him there. Police personnel opened fire on the two assailants in retaliation as the lives of people in the courtroom and court complex were in danger, police said.

According to sources, during interrogation of Umesh

and Vinay it was revealed that arrested from a flat in north-Rahul and Jagdeep, who shot dead Jitender Gogi inside the Rohini court and were then killed in police retaliatory fire, had planned to surrender after assassinating the gangster.
"The accused reached the

court in a car at 10 AM on Friday and the initial plan was that four persons, dressed as lawyers, would go inside the court, kill Gogi and then surrender before a judge. However, one of them was wearing a black jeans and because of this, Yadav and the person who was wearing the black jeans did not go inside the court, the sources said, adding that Rahul and Jagdeep went through with the plan," said the

"Efforts are on to apprehend the person in the black jeans and his identity is yet to be revealed," said police.

Yadav and Vinay were

west Delhi's Haiderpur area and it belonged to the former, police said.

Gogi was a rival of Tillu, another gangster, and according to police, their gangs have been at war for many years.

Tillu, Sunil Rathee and Naveen Bali, all chiefs of different criminal gangs, are behind this incident, the sources said, adding that they are all in jail.

The person who was wearing the black jeans was sent by Bali. Rahul was an associate of Rathee and Jagdeep an associate of Tillu, sources said.

The sources said that on September 15, Yadav received a call from Tillu that two persons will come to him on September 20.

that Gogi will be produced at the Rohini court on September 24 (Friday), the sources said.

On Friday, they were informed that one more person will join them around 10 am outside the court. This person was the one wearing black jeans, they said.

The Delhi Police's Special Cell has Yadav in custody while Vinay's custody was given to the Prashant Vihar police station around 3 AM on Sunday, the sources said.

Police said they will try to take into remand Tillu, Rathee and Bali, who are all in jail, to interrogate them regarding the incident. The Special Cell has recovered a pistol from Yadav which Tillu gave him around five to six months ago.

The source of the weapon has been traced to Tillu and investigation will reveal the other details, they said.

On Sunday, Gogi's postmortem was conducted at the Maulana Azad Medical College, police said, adding that the postmortem of Rahul and Jagdeep will be conducted on Monday, most likely in the same hospital.

According to an FIR registered in connection with the Rohini court shootout, Sub-Inspector Vir Singh, who was part of the security team engaged in the exchange of fire, in his statement said several innocent people could have lost their lives if there was no immediate retaliation against the two assailants.

Singh said that since the duo were firing indiscriminately, and it was not possible for the police team to nab them "physically", especially when the judge, court staff and advocates were inside the courtroom, and anyone could

immunization (SNID) round of Pulse Polio 2021-22 was launched by Haryana Chief Minister Manohar Lal Khattar in district Karnal on Sunday aiming to administer polio drops to 25.7 lakh children of

Approximately 13.21 lakh (51 percent) children under 5 years of age were administered polio drops on the same

Speaking on the occasion, the Chief Minister said that Haryana has reported no case of polio since January 2010 and no polio case has been found in India since January 2011.

Therefore, India has been declared polio-free on February 11, 2014. But India's neighbouring countries Pakistan and Afghanistan are still getting polio cases, due to which the polio eradication campaign is being run repeatedly in India,"

An official spokesperson of the Health Department said that in most of the districts,

Taking a cue from Arunachal Pradesh, where the 'Airgun Surrender Abhiyan' has started delivering results with over 2,000 weapons given up voluntarily since its launch in March, the Centre has decided to roll out similar drive across the country with the help of retired forest workers and representatives of social organisations for wildlife conservation. Urging people not to hunt animals and birds, Union Minister of State for Environment Ashwini Kumar Choubey said that retired forest workers, representatives of social organisations among others will be roped in for the 'air gun surrender campaign' to be launched soon across the

He described Arunachal Government's campaign as an important initiative to save animals and birds from poaching and for their conservation. He said that it is giving very positive results and said that it will be started across the country and States will also be requested for this. The Minister was speaking at an event in Itanagar a few days ago where



some people from Arunachal Pradesh surrendered their air guns in front of the Union Minister. Hunting of wild animals is illegal in India though it is part of the culture of many tribal communities in the

Andhra Pradesh environment and forests minister Mama Natung, who masterminded the initiative, said "We want to raise awareness about conservation. Arunachal covers an area of 83,743 sq km, out of which 80% is covered with forests where we have some 500 species of birds and animals. perhaps many more undiscovered. If we keep killing them, our forests will disappear,"

Choubey agreed and said, air guns do not require any license. "In such a situation, many people in our country hunt birds through air guns in every district and village. Due to this, the number of many birds is rapidly decreasing," he

The programme was launched on March 17 at Lumdung village in East Kameng district where 46 air guns were surrendered. In return, the person got a certificate of appreciation.

CBI to include cyber fraud plaint by deceased seer to unearth demise conspiracy

The CBI, which is probing the death of Mahant Narendra Giri, has decided to include a cyber fraud complaint lodged by the seer, as part of its wider investigation to unravel the possible conspiracy behind the demise of president of Akhil Bharatiya Akhara Parishad.

Giri, who headed the Akhil Bharatiya Akhara Parishad, had on September 6 lodged an FIR with the Daraganj police, alleging that a fake Twitter account had been created in his name. The seer headed the ABAP, the largest body of Sadhus in the country, till he was found hanging by his disciples at Baghambari Mutt in Prayagraj on September 20.

Earlier, the 18-member spe cial investigation team (SÎT) constituted by the Uttar Pradesh government to probe Mahant's death was investigating the cyber fraud allegations before the CBI took over the case.

The agency will match the Mahant's signature and hand-writing in the police complaint with those in the purported suicide note, recovered from his room.

Government Examiner of Questioned Documents,

The purported suicide note had mentioned that the seer was mentally disturbed and upset with one of his disciples.

The CBI team probing the

death case has already retrieved the complaint lodged in connection with cyber fraud FIR registered at the Daraganj police station in Prayagraj district of Uttar Pradesh for further

enquiry, they said. The CBI had on Friday taken over the probe into the death of the Mahant following a notification from the Centre and subsequently dIspatched a team of investigators to

The UP police had registered a case under Indian Penal Code sections relating to abetment to suicide against one of his disciples Anand Giri who was nabbed from Haridwar and brought to Prayagraj for questioning.

Anand Giri was expelled from the Math earlier this year on charges of indiscipline. But he later apologised to the Mahant who forgave him and took him back into the Math.



7.9% children suffered from cancer between 2012-19: Report

Of the 6.10 lakh cancers reported between 2012-2019 under the National Cancer Registry Programme (NCRP), at least 7.9 per cent were found in children below 14 years, according to a report, "Clinicopathological Profile of Cancers in India: A Report of Hospital Based Cancer Registries, 2021" prepared by the Indian Council of Medical Research.

Leukaemia accounted for nearly half of all the childhood cancers in both genders in the 0-14 years age group (46.4 per cent in boys and 44.3 per cent in girls). The other common childhood cancer in boys was lymphoma (16.4 per cent), while in girls, it was malignant bone tumour (8.9 per cent), said the report.

It consolidates data collected during the period across 96 hospital-based cancer registries under the National Cancer Registry Programme (NCRP). The data pertains to all diagnosed and treated cases of confirmed malignancies reported to these centres across The country registered

13,32,207 cases of cancer during 2012-19. Of these, 6,10,084 were included for analysis, based on the completeness and quality of data. Childhood cancers rank ninth as a leading cause of childhood diseases at the global level, accounting for 11.5 million of the Disability Adjusted Life Years (DALYs).

In India, according to a recent NCRP report, the proportion of childhood cancers (0-19 years), relative to cancers in all age groups, was found to range from 1 per cent to 4.9 per cent. Delhi reported the highest age-adjusted incidence rate (AAR) of 203.1 per million in boys and 125.4 per million. Apart from childhood can-

2 LeT ultras killed in encounter

¬wo Lashkar-e-Taiba (LeT) Two Lasinary Inch. killing of a local BJP leader Waseem Bari and his family members were eliminated by the joint team of the security forces during fierce gunfight in Watrina village of Bandipora district on Sunday

Bari along with his father and brother were shot dead last year in July inside his home in Bandipora

The anti terrorist operation was launched in the general area of village Watrina late Saturday night on the receipt of pinpointed human intelligence about the presence of LeT terrorists in the area.

According to a police spokesman, "the first contact with the terrorists was established in the wee hours of Sunday after which the hiding terrorists were given repeated opportunities to surrender but they refused and fired indisforces. In the ensuing gunfight two terrorists were killed and their bodies were retrieved from the site of the encounter". According to a police spokesman, the killed terrorists have been identified as Azad Ahmad Shah and Abid Rashid Dar @ Hagani. The killed terrorist Abid Rahid Dar was a Pakistani trained terrorist who had crossed over the Wagah Border in April 2018 and had infiltrated back in the year

Yogi announces ₹25 per quintal hike in sugarcane purchase price

Lucknow: In a major decision barely months ahead of the upcoming 2022 Assembly elections, Uttar Pradesh Chief Minister Yogi Adityanath on Sunday announced a ₹25 per quintal hike in the purchase prices of sugarcane in the State.

The decision of the Yogi Adityanath government also assumes significance, as it came barely a day before the "Bharat Bandh" called by the Samyukt Kisan

Addressing a meeting of farmers here organised by the BJP's Kisan Morcha, Adityanath said, "The Government has decided that the variety of sugarcane for which ₹325 per quintal was paid to farmers, that price has been increased to ₹350, which will be paid to farmers.

"The Government has also decided to increase the price of ordinary sugarcane variety, to ₹340 (per quintal) up from ₹315 (per quintal). The Government has also decided to the hike the value of the "anupyukt" (less yielding) variety of sugarcane by ₹25 per quintal.'

Elaborating about the benefits,

Adityanath said that this will enable the sug arcane farmers to increase their income by 8 per cent, and will be a transformation in the lives of 45 lakh farmers.

He also said that 119 sugar mills will be operated, and they will be linked with ethanol. The new sugar season starts from next month. When contacted, UP"s Sugarcane Development and Sugar Mills Minister Suresh Rana told PTI, "In Uttar Pradesh, there are three varieties of sugarcane --- early, ordinary and rejected. The early variety constitutes 97 per cent of the sugarcane cultivated (in the state), followed by 2.7 per cent of the ordinary variety and the rejected variety, which constitutes barely 0.3 per cent."

"The MSP (minimum support price) of

the early variety has been increased from ₹325 per quintal to ₹ 350 per quintal. Similarly, the MSP of the ordinary variety has been increased to ₹340 per quintal from ₹315 per quintal. Covid-climate crisis leads to sharp rise in child marriages in Sundarbans

New Delhi: Shackled by poverty in a home that came under water when Cyclone Amphan barrelled into her village and left penniless by the pandemic, the hapless mother married off her 15-year-old daughter - their story emblematic of the Covidclimate crisis in the Sundarbans that has seen a sharp rise in the number of child marriages.

It was May last year, recalled Rashmi Devi. With only a tent as cover for her seven-member family following the super cyclone and no money for food, the marriage proposal for her young daughter seemed like a godsend.

"We could barely manage one meal every day and the decision to get her married seemed

right at the time. In my mind I thought there will be one less mouth to feed and she will get more than just salt and rice to eat," the mother told PTI over the phone from Canning in the Sundarbans that falls in West Bengal's South 24 Parganas dis-Sixteen months later, the decision doesn't seem so right.



Modi has had a good trip to the US, with markers among UNGA, Quad and magnates

rime Minister Narendra Modi is back in India, having wound up his three-day visit to the US, after attending the first in-person Quad Summit, meeting other world leaders and addressing the UN General Assembly as its first speaker. It is in stark contrast to his earlier visits that were marked by hype, festivities and fanfare. This time round, the political dispensation in the US has changed from the much-friendly Trump Administration. Modi met US Vice-President Kamala Harris, Australian counterpart Scott Morrison, Japanese PM Yoshihide Suga and the CEOs of five multinational companies. The Australian and Japanese PMs are in the US for the Quad Summit (A virtual Summit was held in March this year). This diplomatic and military arrangement is widely viewed as a response to increased Chinese economic and military power. Addressing the Summit, Modi said Quad would act as a "force for global good" and "will establish peace and



prosperity in the world", he added. The culmination of the visit was, of course, the Prime Minister's speech at the UN General Assembly that was high on rhetoric but piercingly aimed at China and Pakistan. Modi also addressed the Afghanistan situation and, without naming Pakistan, cautioned it against using Afghanistan for fomenting trouble. Modi said "regressive mindsets were giving terrorism a political meaning"; a statement that may be interpreted as "don't use terrorism as a tool of diplomacy and changing the geopolitics of the region". For good effect, he underlined the need to be alert against any country using

Afghanistan's vulnerability for "selfish interests".

The context was that Pakistan PM Imran Khan had made direct and scathing attacks on India, insisting that the two nuclear powers have to "behave, else the consequences would be grave". Modi, without naming either China or Pakistan, hinted that terrorism as a State policy was not a good idea and the countries should refrain from doing so. He also mentioned the accomplishment of the Indian presidency at the UN Security Council last month. Modi also referred to the issue of the "origins of the COVID virus" and the cancellation of the World Bank's "Ease of Doing Business Index", both of which have been laid at China's door for a lack of transparency by the global institutions. He also emphasised the need for cooperation, saying he represented India as the "mother of all democracies". Earlier, at a meeting with Kamala Harris, both sides emphasised safeguarding democratic values and upholding human rights in respective countries. Modi also offered condolences to the pandemic victims. Overall, it was a well-crafted speech and well delivered though his "chaiwala" reference is better avoided as it has become rather clichéd. Though Modi also had a meeting with President Joe Biden, it was more to do with protocol than anything else. The personal chemistry between them was clearly missing.

Dev is the quintessential romantic ever since he graced the screen, to this day and forever

he Peter Pan of Indian cinema may have faded away 10 years ago, but not before leaving an indelible imprint on the hearts, minds and romantic doctrines of millions. He kept in thrall at least three swooning generations, who swore by his charisma, never-say-die spirit and debonair style. The soigne star — part of the unassailable troika comprising thespian Dilip Kumar and simpleton Raj Kapoor, who ruled



the silver screen for over three decades — is best remembered for essaying Raju's character in Guide. The 1965 movie, which was Dev's first outing in colour and simultaneously shot in Hindi and English, was arguably a better show than even the muchhyped Sholay: The thinking masses adored it; it was much ahead of the times for addressing an issue like extramarital affair; and the one point that everyone claims worked for Sholay — that the characterisation was so good the audience still remembers each character — holds good for Guide too. After all, who doesn't remember the voluble and exploitative Raju,

the beautiful Rosie, the jealous-repentant-revengeful Marco, Raju's friend Gafoor and

even the bit players?

His magnetism was such that youngsters took to puffing on cigarettes after watching him lip-sync Main zindagi ka saath nibhata chala gaya (Hum Dono). The number was voted the "best inspirational film song" in a survey by one of the top two national dailies a few years back. Since the time Gregory Peck influenced his mannerisms to developing an inimitable style of his own, Dev had had many an infatuation. His first famous affair was with Suraiyya, who was elder to him, but her grandmother forbade the alliance. Suraiyya never got married. With his swaying walk and impeccable dressing sense, it was no surprise that girls swooned over him. The Mayor of Bombay had to issue an appeal against the star appearing in public wearing a black suit after a girl fainted and fell from a multi-storey in the melee to catch a glimpse of the star. Dev looked so dashing that even Madhubala had to be content with the No. 2 slot in terms of grabbing eyeballs in Kala Paani (1958). Dev didn't just spend his life, he lived. And loved. As the penultimate scene of Guide shows, after all the excesses, it all boils down to: "Na deen hai, na duniya, sirf main hoon .. Main hoon .. Sirf main ... ". Long live, Dev saab!




From a carefree, merry-making and well-fed nation, our neighbour has run out of foreign exchange, having overborrowed from China

ince 1964, I have been in touch with Sri Lanka intermittently. At the time, I was told that the butter and ice-cream they ate came from New Zealand. Many vegetables were also imported, including from India. A few days ago, I read that Colombo has declared a national "food emergency". What their people eat as a habitual diet will now be from ship to mouth. The country has run out of foreign exchange; its Government overspent on development by borrowing from China, a greedy lender. The takeover of Hambantota port by the lender was a signal that what Sri Lanka could not pay back China in cash, it is having to fork out in kind, namely real estate at the cost of its sovereignty.

Two characteristics of the Singhala people I have noted are (One) they love life and enjoy themselves when the going is good. Two, they are a little suspicious of Indians, because of the Tamils. They fear that someday a situation may arise whereby India may take over Sri Lanka. Given identical lending terms by India and China, they would prefer the latter. The presumption is that the yellow giant is far away whereas India is next door along with its Tamils. The food emergency is the result of the focus on today, tomorrow and the day after will take care of themselves". Truly, Sri Lanka has good

guns but no bread. Right after its independence, Sri Lanka (then Ceylon) has not insisted on growing its staple food on a sufficient scale. In the early days and for years, the country concentrated on tending its tea gardens, rubber and copra trees. The foreign exchange earnings were so plentiful that there used to be a picnic of imported goods. The first painful pinch was felt in 1964 when NM Pereira was the Finance Minister and he went to Parliament to pass very stringent laws. After working a whole career, on retirement, foreigners were henceforth allowed to remit only ₹75,000 for Indians and 50,000 for others. The discrimination was severe. Had the Indian High Commissioner not been very helpful, my father-in-



Although I must confess, the management at New Delhi was no better. In 1990, the Indian treasury had run out of foreign exchange. In order not to fail commitments overseas, the Government sent many crates of gold to banks in London. Fortunately, in 1991, India was gifted with a decisive Prime Minister PV Narasimha Rao who liberalised and globalised Indian economy. He thus brought about an economic revolution.

A small country is vulnerable both economically as well as politically. Its Government must play very cautiously. Sri Lanka liberalised before India and recovered from the cave-in of 1964 that is described above. But any significant decline in foreign exchange earnings should be taken seriously. Otherwise, trouble can surround the economy before giving the Government a chance to draw in the reins. The picture of tea industry has been rather sad

everywhere, be it Sri Lanka or South India. But to Sri Lanka, it makes a big difference. The price of a plain to medium tea was ₹2/kg (though earlier the weight was in pounds) in 1939. By now it should have been in step with the inflation, ₹600 to 800. But it is only the equivalent of ₹200 (Indian).

Garments are another Sri Lankan activity. When there is prosperity, it can earn good foreign exchange. On the other hand, when there is a crisis like the current one caused by COVID, there can be a slump in demand. People, short of money, can do without buying clothes for, say, a year or more. These are the kind of things that look like having brought trouble for Sri Lanka. More so, because the country has borrowings to return. Tourism is another cause of the crisis. It was the largest single foreign exchange earner for Sri Lanka. Due to COVID, it is substan-

Ín the interim, Sri Lanka virtually ignored India, probably embarrassed by its passionate affair with China. After the yellow giant claimed Hambantota, perhaps things changed somewhat. The current Indo-Sri Lanka ties have improved. India may offer food grains, wheat, rice and all else available. And India may consider swap loans whose return would be in Sri Lanka rupees. India can buy only Sri Lanka goods with the returned money against the swap loan. Sri Lanka has described traditionally as the Emerald Isle. It is indeed a beautiful country with sea on

its periphery. People, especially from the Western world, find it irresistibly attractive. The beaches are out of this world and monuments of Buddhism are also engaging, whether Anirudh-apuram, Pollanaruha or Sigiria. The Emerald Isle also has a charisma which few other equally beautiful places have. Its infrastructure for the keen tourists is praiseworthy with its many five-star hotels, its transportation et al.



FIRST COLUMN TIGRAY: SPARTA IN AFRICA

Tigray's army has already covered about a third of the distance to Ethiopia's Capital

e have to deal with anyone who's still shooting," said Getachew Reda, spokesman for the Tigrayan forces, last month. "If it takes marching to Addis to silence the guns, we will." In fact, Tigray's army has already covered about a third of the distance to Addis Ababa, Ethiopia's capital, since it took back its own provincial capital, Mekelle, in late June.

The fighting has been bloody, for the Ethiopian army is much larger, but the Tigrayan army is more professional and determined. Not only has it liberated all of Tigray except the far west, but it has also seized around one-third of neighbouring Amhara.

Seven million Tigrayans defeating the army of a country of 110 million people may seem odd, but Ethiopia is a patchwork quilt of dif-



ferent ethnic groups, languages and religions that was held together in the past by a centralised monarchy or dictatorship backed by ruthless military force. Until quite recently, it was Tigray that pro-

The Tigrayans earned that job by being the most effective guerrilla force in the long struggle to overthrow the former Communist regime, the Derg. They parlayed that role into an ethnic dictatorship that lasted from 1991 until just a few years ago. But the other ethnic groups then united to instal a new prime minister, Abiy Ahmed, who started to dismantle that corrupt autocracy.

He did it, but the Tigrayan military elite withdrew to their own homeland and sulked. It was a well-armed sulk, for almost half the Ethiopian army was based in Tigray, and it consisted largely of ethnic Tigrayans. When it became clear that Abiy's project to destroy the old ethnic pecking order was not negotiable, they rebelled.

This was all pretty inevitable, but then the Ethiopian prime minister decided to invade Tigray and end the problem for good. The Tigrayan army pulled out of the province's cities for a while, and by last November Abiy Ahmed declared the war over. But the Tigrayan leaders were just mobilising their forces, and in June they counter-attacked. The Ethiopian forces broke and ran, and most of Tigray was liberated without a fight.

If it had stopped there, some sort of Ethiopian state would have survived, albeit with a semi-detached Tigray, but Abiy then made the serious mistake of resorting to a blockade to starve the Tigrayans out. By now many people in landlocked Tigray are close to famine, but their leaders have countered with an invasion of Amhara province.

They are now within striking distance of the roads that carry 95 per cent of the Ethiopia's import and export traffic between Addis Ababa and the port of Djibouti. Their success has also emboldened the Oromo Liberation Army, a rebel army seeking autonomy or even independence for Ethiopia's largest ethnic group, to make an alliance with the Tigrayans.

If Abiy makes a quick deal with the Tigrayans that ends the blockade and recognises their independence and borders, he may have enough troops and credibility left to suppress the Oromos and other ethnic insurgents who will soon come out into the open. If not, Ethiopia probably splinters, and it's Yugoslavia all over again.

And what would the Tigrayans do next? Some of them are confident enough to dream of invading Eritrea and taking down President Isaias Afwerki, who sent troops to help Abiy invade Tigray.

Some of the Tigrayan elite may even be speculating about uniting the two countries. After all, half the Eritrean population speaks the same Tigrinya language, and joining the two together would give Tigray access to the sea, which sometimes comes in handy.

Does AUKUS cast a shadow over Quad?



With a vision of deterring China and ensuring free international waters, there should not be any doubt that AUKUS will cast a shadow over Quad

he decision to form AUKUS came two weeks of the US withdrawal of troops from Afghanistan. It displays the geopolitical resolve that the US has to counter the Chinese threat in the Indo-Pacific region, which is increasing with each passing day. Many experts now think that AUKUS might strategically and tactically sideline Quad. That is not the case. The objectives, either stated explicitly or otherwise, are the same. Chinese expansionism has driven this new military alliance, but both Quad and AUKUS complement each other if seen strategically.

With India and Japan, there are essential constraints that make them more susceptible to the Chinese threat. Apart from the common factor of geographical proximity to China, both aspire to become permanent members of the UNSC. An upfront, direct military alignment against China might adversely affect those aspirations. Individually, India has also to deal with an unholy alliance of China, Pakistan, and the Taliban. Apart from this, it is concerned about Russia's shifting foreign policy priorities towards a Sino-Pak alliance. On the other hand, Japan faces issues such as the dependence on raw materials and food supplies and ageing workforce apart from its Article 9 clause that prohibits the re-armament of Tokyo.

The emerging arrangement seems to present before the world a ring of defence, paving the way for future multilateral alliances against Chinese expansionism. A very look at the map of the oceans will give us a common understanding that the South China Sea, Pacific Ocean, and the Indian Ocean taken together are very difficult for either of the powers to defend by themselves. There have to be multiple security arrangements for a strong defence. In the present circumstances, if India and Japan decide to institutionalise a military alliance with the help of the US, Beijing might resort to increasing its aggressive-ness either in the SCS or on the Indo-China border, a purpose which then might be self-defeating.

Thus, strategicmanoeuvrability is probably a part of the solution. India and Japan together can possiblyhold back China on account of their non-participation in any military bloc while simultaneously keeping up the ante against its hegemonic diplomacy. For this reason, India's oint pattie commands need to be operationalised soon. The absence of any institutionalisation will also give time for both India and Japan to modernise their maritime assets. India, in particular, needs to speed up on the interoperability within its forces. France then plays an essential role for India and Japan, apart from other European countries, followed by Israel.

Concerning Japan, it has to gradualmove beyond its circumstantial clause that led Tokyo to adopt a 'peace constitu-tion'. From "self-defence", it has to evolve a "maritime defence" force to handle

Beijing. The move might instigate some powers like South Korea to put forward their anti-Tokyo stance. However,time demands that those countries that are not compatible with each other bridge their strategic differences and work for a common cause, especially when they have a shared substantial threat and are covered under the US security umbrella. Thus, an expansionist China allows them to resolve their differences and work

for a common goal.

British and American submersibles, anti-ship missiles and other striking capabilities would deter China from threatening the countries. In case of severe provocations and open hostilities, the second layer, the AUKUS, can be a deterrent and a defender at the same time by providing a tactical cover-up for essential sea routes in the Southern and Eastern Indian Ocean apart from the Pacific Ocean and the South China Sea. It then might try to divertattention to the Malacca Straits against India or Japan, but the Indian Navy would present a formidable force there, thus making its 'Malacca Dilemma' a reality. Additionally, the 'five eyes' intelligence sharing mechanism aiso increases the concerns for China.


Nevertheless, without any institutionalised alignment, it might be difficult for China to go in for the first move against a'non-militarily aligned' country such as India and Japan and create more complexities. In case of severe threats and imminent attacks, the two might not hesitate to join AUKUS formally. Joint sea denial strategies then have an essential role to play in the upcoming multilateral security

arrangements. Thus, it would not be wrong to envision a consortium of powers guarding the entire Indo-Pacific region, with each player understanding its role and responsibilities well. It is for this reason that both India and Japan have together welcomed the new alliance AUKUS.

One can easily recall that in 2010, Yang Jiechi, China's then foreign minister, on his trip to the ASEAN summit in Hanoi, commented, "China is a big country, and you are small countries, and that is a fact". Today, the time is ripe to reverse the 'big fish-small fish' syndrome. China has reiterated that the Quad will find no support within the Asia Pacific countries. Beijing perhaps fears the expansion of Quad to include other democratic, "like-minded countries" such as Vietnam, the Philippines, South Korea, and Taiwan. All of them have coastlines and have been harassed by China for long. Other pertinent issues such as Chinese illegal fishing, climate change and natural disasters also underline the need for security overlaps with the other countries. Hence, Quad +4 can be envisioned. The small countries with other. Having a joint shared vision the support of various extra-regional powers have to make formations via unwritten multilateral security arrangements.

The scope of an expanded Quad can include joint technical cooperation and military exercises to increase the interoperability of the forces between themselves andwithin their forcesto counter the military challenges before them. As states have security and economic convergences, an understanding can be built to 'strategically encircle' China and keep it guessing on multiple fronts. In essence, the Quad then remains the strategic linchpinof navigational freedoms marked by a "free, open, transparent and inclusive Indo-Pacific region" apart from focussing on other new and emerging technologies such as artificial intelligenceapart from climate change.India and Japan thus will have a more significant role from here onwards.

Developments in Afghanistan, China-Pakistan's unconditional support to Taliban and the shifting sands of alliances in the Asian region strongly indicate that the time for multilateral re-alignments and acknowledgement of the reality has arrived. AUKUS fulfills this purpose and consequently occupies the space of an"institutionalised security alliance" having a formalised treaty, ready for action either as a deterrent or more if the situation demands. The 'friendly' nuclear submarines will detect and intercept the Chinese nuclear submarinescollecting essential data of the Indo-Pacific Ocean. In this direction, Quad and AUKUS are entirely complementary to each of freedom of the high seas and a common challenge of deterring China, there should not be any doubt that AUKUS will cast a shadow over Quad. Apprehensions concerning this new approach should not be viewed from the prism of China. Instead, it should be taken as a part of comprehensive diplomacy not only for deterrence against China's compulsive 'cabbage policy' but also for the peace and security in the Indo-Pacific region and beyond.

Two sides of the cooperation argument

Considering the high stakes involved, the tussle to control the cooperative sector has become the core of politics in Gujarat and Maharashtra

The recent decision of the BJP Government to constitute a new Ministry of Cooperation under the charge of Union Home Minister Amit Shah had mixed reactions. It was hailed by Government supporters as "the new entity which would help cooperatives across states progress as a true peoplebased movement reaching the grassroots". On the other hand, the opposition camp termed it as a "sinister move to highjack the cooperative movement for political gains".

After formation of the Ministry, the first ambitious move was to come out with a national framework for strengthening the cooperative movement in the country but the Supreme Court on July 20 said that cooperatives is a

Some experts in cooperative affairs find justification in the formation of a separate Ministry and the Reserve Bank of India monitoring on the grounds that in the absence of regulations, there have been allegations of scams in several cooperatives. America has enough vax for boosters, kids' shots

With more than 40 million doses of coronavirus vaccines available, US health authorities said they're confident there will be enough for both qualified older Americans seeking booster shots and the young children for whom initial vaccines are expected to be approved in the not-too-distant future.

The spike in demand expected following last week's federal recommendation on first significant jump in months. More than 70 million Americans remain unvaccinated despite the enticement of lottery prizes, free food or gifts and pleas from exhausted health care workers as the average number of deaths per day climbed to more than 1,900 in recent weeks.

Federal and state health authorities said current supply and steady production of more doses can easily accommodate those seeking boosters or initial vaccination, avoiding a repeat of the frustratingly slow rollout of Covid-19 vaccines across the country early this year.

Russia says it is in sync with US, China, Pak on Taliban

Sergey Lavrov said the four countries are in ongoing contact. He said representatives from Russia, China and Pakistan recently traveled to Qatar and then to Afghanistan's capital, Kabul, to engage with both the Taliban and representatives of "secular authori-- former President Hamid Karzai and Abdullah Abdullah, who headed the ousted government's negotiating council with the Taliban.

Lavrov said the interim government announced by the Taliban does not reflect '"the whole gamut of Afghan society ethno-religious and political forces — so we are engaging in contacts. They ongoing."
The Taliban have promised

an inclusive Government, a more moderate form of Islamic rule than when they last ruled the country from 1996 to 2001 including respecting women's rights, providing stability after 20 years of war, fighting ter-

rorism and extremism and stopping militants from using their territory to launch attacks. But recent moves suggest they may be returning to more repressive policies, particularly toward women and girls.

"What's most important .. Is to ensure that the promises that they have proclaimed publicly to be kept," Lavrov said. "And for us, that is the top priority.

At a wide-ranging news conference and in his speech afterward at the UN General Assembly, Layroy criticized the Biden administration including for its hasty withdrawal from Afghanistan.

He said the US and NATO announced the creation of an

Alliance For Multilateralism "even though what kind of structure could be more multilateral than the United Nations?

The United States is also sidestepping the UN, he said, pointing to the recent US announcement of a "Summit for Democracy" despite, Lavrov said, US President Joe Biden's pledge this week "that the US is not seeking a world divided into opposing blocs."

"It goes without saying that Washington is going to choose the participants by itself, thus hijacking the right to decide to what degree a country meets the standards of democracy," Lavrov said.

"Essentially, this initiative quite in the spirit of a Cold War, as it declares a new ideological crusade against all dissenters.

Lavrov was asked for Russia's reaction to UN Secretary-General Antonio Guterres' warning last week that the world could be plunged into a new Cold War potentially more dangerous than the lengthy one between the US and the former Soviet Union unless the United States and China repair their "totally dysfunctional" relationship.

He replied, "Of course, we see the tension tightening in relations between China and the United States.'

The speeches may be scripted, but the UN General Assembly can sometimes be the only direct window into the regional challenges that command global concern.

On Saturday, world leaders were speaking on behalf of some of the most unstable and unsettling current conflicts.

That includes India's fight over the Kashmir region with bitter rival Pakistan, Haiti's domestic crises spilling into a migrant crisis at the US-Mexico border and questions about the Ethiopian government's role in reported starvation deaths in the Tigray region.

Haiti Prime Minister Ariel Henry didn't shy away from addressing his country's turmoil following a major earthquake and the assassination of its president, Jovenel Moise, in recent months — alluding to but not directly addressing reports that may implicate Henry himself in the murder.

'Í want to reaffirm here, at this platform, my determination to do everything to find the collaborators, accomplices and sponsors of this odious crime. Nothing, absolutely nothing, no political maneuver, no media campaign, no distraction, could deter me from this objective: rendering justice for President Moise," Henry said in a prerecorded speech.

"It is a debt to his memory, his family and the Haitian

Henry pointedly said that inequalities and conflict drive migration. But he stopped short of directly criticizing Washington, whose treatment

NATO member Turkey was kicked out of the F-35 programme and defence officials were sanctioned after it bought the Russian-made S-400 missile defence system. The US strongly objects to the use of Russian systems within NATO and says it poses a threat to the F-35s. Turkey maintains the S-400s could be used independently without being integrated into



sanctioned Turkey in 2020 for its purchase under a 2017 law aimed at pushing back Russian influence. The move was the first time that the law, known as CAATSA, was used to penalise a US ally. But Erdogan "Of course, of course, yes,"

Erdogan said after stating Turkey would make its own defense choices, in response to Brennan's question on whether

Turkey would buy more S-400s. Before departing New York, Erdogan told journalists that relations with President Joe Biden hadn't started well despite what he called his good work with previous US leaders during his 19-years at Turkey's

India needs 4-5 'SBI size' banks: FM

India needs 4-5 "SBI size" banks to meet the growing needs of the economy and industry, Finance Minister Nirmala Sitharaman said on

Addressing the 74th Annual General Meeting of the Indian Banks' Association (IBA), she said the industry needs to imagine how Indian banking has to be in the immediate and long-term future.

As far as the long-term future is concerned, she said it is going to be largely driven by digitised processes and there is a need for seamless and interconnected digital systems for a sustainable future for the Indian banking industry.

"Although I did say that in the amalgamation process, your systems have spoken to each other, there wasn't a problem of those amalgamating banks. And, I remember the banking secretary at that time, Rajiv Kumar, telling me that we have ensured that the amalgamating banks do have their systems in such a way that they can align with each other," she said.

Mega consolidation was announced in 2019 when Kumar was the financial services secretary but was implemented by his successor Debasish Panda effective April 2020. As part of the mega con-

solidation exercise, Oriental

Bank of India were merged into Punjab National Bank; Syndicate Bank into Canara Bank; Andhra Bank and Corporation Bank into Union Bank of India; and Allahabad Bank into Indian Bank.

Following the consolidation, there are now seven large public sector banks and five smaller ones. There were as many as 27 public sector banks (PSBs) in 2017.

Kumar, now an Election Commissioner of India, was instrumental in laying a digital pipeline that was leveraged during the pandemic to transfer money into accounts of crores of the vulnerable and needy with a click of button.

The finance minister said banks, whether public or private sector, cannot work in digital silos and systems should be speaking to each other.

"So, I would think that's one of the areas in which you would give some more time and make sure that bridge crossed," she said.

Appreciating the efforts of bankers to carry out smooth consolidation exercise during the challenging time of the pandemic, the Finance Minister said it did not cause inconvenience to the customer and there was no aberration.

Paying homage to bankers who lost their lives in the line of duty during the pandemic, the finance minister urged IBA to help and support the families of the deceased.

"I do pay my humble homage to those who have served, but also suffered because of the pandemic but unfortunately couldn't survive it. I am sure the IBA will do everything that it takes to support their families, and keep them spirited and morally sound because the loss is irreparable," she said.

Many districts lack bank branches despite high economic activity: FM

Union Finance Minister Nirmala Sitharaman on Sunday said despite the huge thrust on financial inclusion and high economic activity, there are districts in the country not having any banking resence at all.

She asked the lenders to get their act together and open either a full-fledged brick-andmortar branch or an outpost rendering banking services, wondering how banking presence eludes even pockets which have high economic activity.

It can be noted that policymakers have been focusing on financial inclusion for over a decade and also had set a target of ensuring banking presence in every village with a population of over 2,000 people. A few years ago, the RBI had liberalised branch opening norms for banks.

"Even today, there are very many districts in which even big panchayats don't have a physical bank...There are very many districts in which not even one banking institution is

physically present," Sitharaman said, speaking at the 74th annual general meeting (AGM) of the industry lobby group Indian Banks' Association

(IBA). She exhorted the IBA members to digitally map all the districts to see the areas having low coverage for themselves and accordingly make provisions for either a physical branch or an outpost.

"You should be able to see the centres of economic activity. Be it a completely rural pocket but if the economic activity is strong there, wouldn't you think there should be some kind of presence?," she asked. Making it clear that she is

not against digitisation, which has paid tremendous cost benefits to lenders in terms of outreach, Sitharaman wondered how there can be parts of country which do not have even a single brick-and-mortar branch.

The minister cited the case of a highly persuasive lawmaker who has been making appeals for a bank branch in an area witnessing high agricultural-related trading.

The Reserve Bank of India (RBI) has lowered the country's growth projection for the current financial year to 9.5 per cent from 10.5 per cent estimated earlier, while the World Bank has projected India's economy to grow at 8.3 per cent in 2021.

On the stock market boom at a time when economic growth has slowed down, Bhanumurthy said it is common to say that stock markets do not reflect the real economy.

"However, this time around, sustained surge in the stock indices do not suggest such disconnect," he said.

Bhanumurthy, however, added that one may see some corrections when large central banks in the world start tightening when the inflationary pressures build up and the same

could happen in India as well.

On recent calls for using the huge forex reserves for infrastructure development or recapitalisation of public sector banks, the economist said the reserves are largely hot money that are required to maintain stability in the forex market.

"In such conditions, using reserves for any specific purposes such as financing or recapitalisation of public sector banks could only end up in weakening external accounts, he observed.

Asked if high retail and wholesale inflation is a matter of concern, he said going by the recent trends in both Consumer Price Index and WPI inflation, there are diverg-He said indeed continu-

ously high WPI inflation is a worrying factor because it could have pass-through impact of CPI even with a long lag. Stating that the Monetary

business leaders were largely in line with the overall results of PwC's Global Crisis Survey 2021, showing only minor areas of significant divergence in views and insights.

Chip shortage delaying launches, makers taking measures to mitigate risks: CEAMA

The domestic appliances and L consumer electronics industry, facing shortages in components such as semiconductors and chips, expects the situation not only to last through 2022 but also to stretch into 2023, said the Consumer Electronics and Appliances Manufacturers Association (CEAMA).

Several manufacturers, using chips as inputs, are now facing bottlenecks in their capacities and expect a delay in launches of new products, said the CEAMA.

Moreover, shortage of chips, coupled with rising ferrous products, has also offset the softening of prices happening in the sector after some of the commodities like resins and chemicals have shown . President Kamal Nandi.

"The industry might run short of controllers owing to shortages of semiconductors and other electronic components. Keeping in mind the surge in demand during festive, we have taken appropriate measures to mitigate the nearterm risks," CEAMA President Kamal Nandi told PTI.

riedrich Nietzsche had once said, "He who fights his own demons, must take care he doesn't become one." Enigma — The Fallen Angel, an award winning short-film, explores exactly this the dark, hidden recesses of the mind. It revolves around the intermingled lives of Richa and Myra. Besides winning innumerable awards at festivals, the short film qualified for the Oscars and will be screened in November in LA.

Actress Ananya Sengupta recently won two consecutive international film awards for the category of 'Best Actress' and 'Best Supporting Actress' for her short-films Enigma — The Fallen Angel and Silver Gandhi at Port Blair International Film festival and Golden Sparrow International Film festival, respectively.

Read on for excerpts of the inter-

□Your latest short film *Enigma- The* Fallen Angel has won widespread acclaim. Give us an overview of the

Firstly, I'm so glad for the interview. I do not think I've achieved much to deserve this (laughs heartily). Previously, I was a model and I didn't feel proud of myself for the same, because you're doing what other people are telling you to do and it is not like you are exhibiting your talent in it. It didn't seem consistent and I was not invested in it. Modelling is about posing, looking good and thin. You do not have much work. So, at the moment, I'm doing



a couple of short films, and Telugu films to showcase my acting skills. They were doing festival rounds and, luckily, one of my short-films has been spotted.

Enigma- The Fallen Angel has been made by a production called Dreamcatchers who are based in Pune. They are super passionate filmmakers. The trailer of the film itself looks so international because of the way that they have made it. So, this film is about a girl who has schizophrenia, hallucinates, and lives in her own world. She, then, returns to reality and realises that the world is still sad. It has a supernatural air to it and since the duration of the film is hardly 30 minutes, I'll leave it to the audience to watch it. I am proud of the film and the journey and I see these things that I am doing right now as stepping stones to what I actually wish to

□And what is it that you wish to achieve?

My plan is to do mainstream cinema and movies. Being a newcomer, when you don't have a back-up, and people always want to know what you've done. They want to cast you on the basis of your profile. I do not come from a film background, and so I cannot say I'm so-and-so's daughter or sister. I have to speak through my work. I'm trying to garner content to show to the makers. So I want to become 'already some-

□The film qualified for the Oscars screening at LA in November, which is probably the highest accomplishment for a film. According to you, why aren't more people talking

Yes, I understand that not many people have recognised it but people are noticing it in the Marathi film industry. We have plans to take it



ahead with press releases and bytes soon. But, honestly, I have seen people get confused between nomination and qualification when it comes to Oscars. We have been qualified for the screening, which is a big deal in itself, and I'm hoping gradually more spectators will notice.

□Films making a mark internationally, are we still looking for validation from the west?

I think we are always trying to do that. I remember Aamir Khan trying hard for Lagaan to get that credit in the West but couldn't exactly receive it. I remember Aishwarya Rai doing Pink Panther, but she couldn't last long either. She is the absolute queen and we all love her but it still did not work. Others have attempted to send their films for Oscars, too. This may have certainly happened in the past, but I do not think we're doing that anymore because I would like to believe we are now aware where we

□You won the best actress award, at Port Blair Film Festival, for this particular role. We're excited to know about your character in the film. How did you relate

I am playing the role of the 'mystery girl' in *Enigma*. The film belongs to the supernatural genre so I'm not sure if the audience will relate to my character, unless you watch it twice. I'm not trying to be greedy here but I feel it's just one of those films that you gotta watch twice to understand well.

□What, according to you, is the USP of the short film? Why should more people watch it?

I think everyone has a different perception and there would be numerous USPs when it comes to different opinions. Personally, I feel if a film clicks with you, it just does. That's what I look for and appreciate when I watch cinema. For this one, particularly, the content is very different. It is dreamy and fantastical. It is, altogether, a different world.

Everyone wishes to become the ruler of the gang. It is based in Mumbai and also revolves around this Maharashtran girl from Dadar who has grown up in slums. There are cops and gangs involved. It is quite an interesting story. It is produced under the banner of SN Reddy and directed by Ajay Andrews, and features Ashmit Patel, Adhyayan Suman and Ranga Jinu.

In the untitled film, my role is opposite Naveen Chandra. The film is directed by Srinivasa Raju. They're commercial mainstream films and I'm very excited for both.

☐You seem to play diverse roles in various languages. Is it difficult to shift from one to another, more so because of the language change?

(Chuckles before proceeding) It is too difficult, it really is. I can learn Russian and Spanish but I cannot learn Tamil and Telugu, for the love of God! They are complicated but obviously, like we know, practise makes you perfect. With practise, I got better at it or, at least, I can say I could pull it off. People, surprisingly, loved my performance. I was super anxious since I did not know these languages but I'm glad it all worked out.

□Can you tell us about your character in Highdose?

Yes. Highdose is a web-series directed by Marathi director Dilip Vasudev and produced by Shonali films, and is supposed to be released this year. It is being shot at a very large scale.

I am playing the character of Revati, a free-spirited young girl. She is a kind-of drug-addict and is troubled due to her past troubles caused by her parents' separation at a very young age.

RURAL INFRASTRUCTURE IN SPOTLIGHT

Villagers in remote areas of the country stared at a healthcare disaster during the pandemic, says RAJESH NIRMAL

round 65.5 per cent of India's total population resides in rural A total population resides in some of areas. Tucked away in some of the remotest corners of the country, these areas are often characterised by poor development infrastructure. Unavailability of and inaccessibility to health-care services is the most crucial gap. In terms of accessing health-care benefits, there are certain barriers faced by the rural population, especially women. In current Covid times, these barriers have multiplied, making the lives of the rural populations even more challenging.

During the different phases of lockdown, people who can access smartphones, the internet, and correct information, could reach out to doctors for online consultation. On the other hand, more than half of the rural population continued to rely upon the medicines they identify only by their colour, mostly available at the local medical stores. "Almost everyone in our village depends on these locally available medicines. We have a habit of curing sickness without visiting any doctor. As the nearest government hospital is eight to 10 km away from our village, no one has time and other resources to be spent on hospital visits," shared 34-year-old Laalti Devi from Rampur Babuan village, Sultanpur district in Uttar Pradesh.

Laalti, whose husband migrates to the city in search of work, informed that in his absence, she looks after the family. "In such a scenario, if anyone from my house gets sick, we get medicine from the medical store and follow the instructions given by the pharmacist," she said. Visiting private hospitals is not an option for the rural poor who find it difficult to make ends meet.

During both the first and second wave, the majority of district hospitals were converted to Covid facilities, further limiting the access of villagers in

case of emergencies. According to Laalti, during the horrific waves of the pandemic, people feared even thinking about visiting the hospitals. They are still afraid that they will get infected with Covid if they will visit hospitals. They are also frightened that they may be forced to get vaccinated if they will visit the government health-care facil-

Sharing her experience regarding obtaining medical treatment during the

pandemic, Laalti informed, "Last year, I had developed certain health complications. With my husband not around, I had no one to seek advice from. The fear of Covid was such that I decided to wait. After the lockdown was lifted and my husband managed to return, we went to the hospital for treatment. The infection, however, had spread because of the delay in treatment.

47-year-old Prabha Devi, another local resident of the village, had to

undergo uterus removal surgery. As the hospitals were full of Covid patients, she could not utilise the services of government hospitals. "I wanted my aunt to undergo surgery in the district hospital, but I was not capable of that kind of hustle. Due to Covid, people with other health complications were not being treated properly. Doctors were overwhelmed with the Covid cases," shared Sandeep, a relative of Prabha

"Taking all the factors into consideration, my family had decided that even if they had to take a loan or sell our fields, my treatment will be done at a private hospital because they could not put my life at stake," rued Prabha Devi.

Not every woman is lucky to have access to financial resources to get their illness treated. They keep suffering in silence. One of the reasons that prevent rural women from receiving institutionalised health-care is the unavailability of hospitals in their villages. This year, the Finance Minister has, however, allocated \$4.185 or and \$1.00 ed ₹ 64,185 crores towards strengthening health services in rural India. Besides, ₹ 35,000 crores have been set aside to tackle the pandemic, which is planned to be spent on primary, secondary, and tertiary health-care. Overall, there has been a 137 per cent increase in the national budget as compared to last year. It is, however, not only the infrastructure that needs to be strengthened.

The issue of health-literacy among the rural populations, especially women, also needs to be addressed as it impacts their ability to apprehend health information provided by frontline workers like ASHA. Due to poor health literacy, women feel reluctant to seek healthcare as they fear communicating with healthcare providers. Additionally, low health literacy impacts the implementation of government initiatives.

Drawing upon the experiences of the villagers, especially women, it is quite clear that a strong health-care network must be established in rural areas. Using the budget allocated by the union government, the local administration should devise a special program where the doctors and medicines should be accessible to villagers, and a strong healthcare work-force should help address the health illiteracy gap in these

ately, the United Nations Development Programme L(UNDP), the Economic and Social Council of the UN (ECOSOC), and also other similar institutions, which are working for development have also veered round to the point that the notion of development would be faulty unless our focus is on the people because it is the people for whom all developmental

However, looking from all the aspects, the plans, programmes, and parameters of development that are charted by various UN agencies and other similar institutions; it seems that they aim only or mainly at the economic development and physical and mental wellbeing of the peo-

ple and, therefore, their major thrust now is the provision of basic necessities, such as water and food, employment, literacy, health-care, pollution-free environment, and so forth, to the developing or backward areas. Thus, even in this new paradigm, the development of proper attitudes and outlooks of the human individual is missing or has not been given the



attention it deserves. Therefore, there seems to be some lack of realisation that, although all the aforementioned kinds of development are necessary, these are not enough to bring real and durable security and peace. If people have parochial, communal, selfish tendencies that give them a narrow sense of self-identity, and a sectional loyalty, based on ethnic, racial, communal, casteist, and national background, they will let loose the divisive forces and will commit violence and destructive acts thereby bringing to nought all hard efforts made for development. Also, we all see many signs of insecurity and restlessness even in highly developed countries, some of which are known as gun-running societies.

Now, if there is reasonable security and safety there, why do the citizens of that country, in such large numbers, require guns and pistols? Again, why does a high percentage of people have to go in for treatment at the hands of psychiatrists in these nations? Why do they drink so heavily or take sleeping pills? Why is there a lot of mental tension amidst affluence? Why is there a large number of cases of divorce, rape, child abuse, domestic violence, and drug addiction? Why is there a high incidence of corruption even in high places in these highly developed countries? Aren't the developed countries, with a high percentage of literacy and, at least, with some degree of economic security, wordo so many people commit suicide or murders? Does all this not show that there may still be deep restlessness in society even when there is a high degree of development and economic security? Does this not lead us to conclude that the basic requirement or the essential accompaniment to all development and progress is the development of the proper attitudes, outlook, and mindset and the moral sense of the human individual?

Therefore, it is significant to include ethical consciousness in the development paradigm. Again, when we talk of sustainable development, we generally mean that our developmental processes should not degrade the physical environment and that we should be considerate and careful in using the non-renewable resources so that we leave enough for the coming generations. But, does the present high rate of population growth, alongside the Law of Entropy, leave enough scope for such a sustainable development? Again, have we ever re-examined our various methods to stabilise or reduce the population growth? Our debates are generally centred around abortion, contraceptives, and so on, but in these cases, we hardly think of reforming the beliefs, attitudes, and evil impulses of individuals and people through value education. This is really the crux of the whole problem of development. So, if we want to achieve our dream, we need to act now by coming together and developing a spirit of cooperation, a sense of responsibility, and sharing of mutual concerns. Remember, if we fail to act now, it will impoverish our current and future generations.

NEW STUDY ON WOOLLY-NECKED STORKS

Astudy carried out by Aornithologists indicates the woolly-necked storks prefer irrigation canals over wetlands

They found a large breeding population in the Jhajjar and Rohtak districts of Haryana. These districts

have witnessed agriculture for over a century, with the Western Yamuna canal network established before the era of the Mughals. Storks are large birds that have attracted enormous mythological and scientific attention over centuries

"Our work on nesting woolly-necked storks published in a paper was conducted between 2016 and 2020 where we located 298 nests of this species, the largest data set in the world for this species." lead researcher K S Gopi Sundar, cochair of the IUCN Stork, Ibis, and Spoonbill Specialist group,

He added that they entirely nested on either single trees in crop fields, or on the row of agroforestry trees planted along irrigation canals



o address the environmental crisis caused by the marine oil spills, the researchers at the Indian Institute of Technology, Guwahati (IIT-G), have developed a highly porous and water repellent superhydrophobic cotton composite material that can selectively absorb oil from the oil-water mixture.

AIR POLLUTION LEADS TO SELF-HARM

Children, exposed to high levels of air pollution, are up to 50 per cent more likely to self-harm later in life, suggested a study that adds to evidence of a link between air pollution and mental health problems

Researchers from the University of Manchester in

England and Aarhus University examined that 1.4 million kids are under the age of 10 in Denmark, and those exposed to a high level of nitrogen dioxide were more likely to selfharm in adulthood than

"Our findings indicate that higher levels of air pollution exposure are linked with poor mental health outcomes," a lead author and a research fellow at Manchester University, Dr Pearl Mok. said

"Although air pollution is widespread, it is a modifiable risk factor, and we, therefore, hope our study findings will inform policymakers who are devising strategies to combat this problem," he added...

IIT-J: NEW WAYS TO GENERATE ELECTRICITY

Researchers from the Indian Institute of Technology, Jodhpur (IIT-J) have demonstrated for the first time that plant-based microbial fuel cells (MFCs) can generate power profitably from wastewater compared to algae-based systems.

The increasing generation of large amounts of domestic wastewater has necessitated the development of newer treatment methods that are energy efficient and scalable.

The researchers at the Environmental

Biotechnology lab at IIT-J led by associate professor. department of Bioscience & Bioengineering, Dr Meenu Chhabra said, "A microbial fuel cell (MFC) is a device that uses microbes to convert organic matter in wastewater directly into electrical energy." In MFCs, live microbes act on the waste organic matter to release the electrons that are extracted with an external load, thereby generating power


