Taliban look up to 'best friend China' to rebuild country

Describing China as its "most important partner", the Taliban have said they look to Beijing to rebuild Afghanistan and exploit its rich copper deposits as the war-ravaged country faces widespread hunger and fears of an economic collapse.

Taliban spokesperson Zabihullah Mujahid said the group supports China's One Belt, One Road initiative that seeks to link China with Africa, Asia and Europe through an enormous network of ports, railways, roads and industrial parks. "China is our most impor-

tant partner and represents a fundamental and extraordinary opportunity for us because it is ready to invest and rebuild our country," Geo News quoted Mujahid as saying in an interview to an Italian newspaper on Thursday.

The Supreme Court on Friday stayed for a week Kerala Government's decision to conduct offline exams for Class XI from September 6 amid rising cases of Covid. "There is an alarming" situation in the State owing to Covid-19, observed the apex court, adding that "cases in Kerala are about 70 per cent cases of the country. Children of this age cannot be exposed to this risk."

Meanwhile, the night curfew slapped on Kerala since last Sunday has failed to yield any result as the number of new patients diagnosed with Covid-19 continue to remain high. On Friday, out of the 1.63 lakh samples sent for testing, 29,322 persons were found to be infected with Covid-19, said a release by Health Minister

Veena George.

The Test Positivity Rate remained high with 17.91 per cent while the pandemic claimed 131 lives taking the death toll in the State till date to 21,280. The State also saw 118 health workers falling prey to Covid-19.

SC to Govt: Frame guidelines on Covid death certificates by Sept 11

Court frowns at delay in action over its **June 30 order**

PNS NEW DELHI

The Supreme Court on Friday expressed displeasure over delay in framing guidelines for issuance of death certificates to the families of those who died of Covid-19 and directed the Centre to do so and file compliance report

by September 11.

"We passed the order a long time back. We have already extended the time once. By the time you frame the guidelines, the third phase will also be over", a bench com-prising Justices MR Shah and Aniruddha Bose observed.

Solicitor General Tushar Mehta, appearing for the Centre, assured the apex court that everything is under con-



Advocate Gauray Kumai Bansal, who has filed the petition, submitted that under the pretext of consideration things should not be delayed as the top court has already granted four-week extension to the Centre on August 16 to frame guidelines for ex-gratia compensation and now it is seeking more time. Advocate Sumeer Sodhi, who appeared for some of the applicants, said extended time for the first direction passed on June 30 is getting

over on September 8. The bench said it is for the Centre to take decision on compensation within that peri-

od of time and today it was adjourning the matter only for the purpose of compliance with other directions. "Put up on September 13 as Solicitor General seeks time to enable earlier order and place on record compliance report of other directions issued by this court on June 30, 2021. Compliance report to be filed with the registry on or before September 11," the bench said.

The apex court had in its June 30 verdict directed the National Disaster Management Authority (NDMA) to recommend within six weeks appropriate guidelines for ex-gratia assistance on account of loss of life to the family members of persons who died due to Covid-19

The Centre had moved an application seeking some more time to frame the guidelines on the ground that the exercise which was in active consideration of the NDMA was at an advanced stage and requires a little more in-depth examina-

mid debate whether or not A mid debate whether students should be sent to schools in view of impending third wave of the coronavirus pandemic in India, a study by University College London and Public Health England has found that even as children rarely become severely ill due to the infection, at least one in seven infected kids may have

lingering symptoms. The study found that 11to-17-year-olds who tested positive for the virus were twice as likely to report three or more symptoms 15 weeks later than

those who had tested negative. Researchers surveyed 3.065 kids in England who had positive results in a PCR test between January and March,

and a control group of 3,739 who tested negative over the same period.

Among those who tested positive, 14 per cent reported three or more symptoms such as unusual tiredness or headaches 15 weeks later, compared with 7 per cent reporting symptoms by that time among the control group.

The researchers said while the findings suggested as many as 32,000 teenagers might have had multiple symptoms linked to Covid-19 after 15 weeks, the prevalence of long Covid in the ige group was lower than some had feared last year.

The findings were a preprint which had not been peerreviewed. The authors said any decision to extend vaccination to 12-15-vear-olds in Britain was unlikely to be based on this study as there was not enough data on whether vaccination protects against long Covid-19.

First desi N-missile tracking ship **Dhruv puts India in super league**

In an effort to enhance its nuclear missile and satellite tracking capabilities, India is likely to commission next week its first ship 'INS Dhruv' with the latest gadgets to detect incoming hostile missiles. With this induction, India will join the select group of nations such as France, UK, Russia, the USA, and China that have such vessels.

The 15,000-tonne ballistic missile surveillance ship was built by the Hindustan Shipyard in collaboration with the Defence Research and Development Organisation (DRDO) and the National Technical Research Organisation (NTRO). The ship is likely to be launched on Visakhapatnam, sources said

lance systems onboard are powered by 14 MW by INS Dhruv itself. The ship was codenamed VC 1118. Its commissioning into the service was delayed for some months due to the corona pandemic, sources said. Built as part of the Make in India initiative, the

Govt slashes prices of 39 vital medicines tine replacement therapy.

With an aim to provide relief to patients, the Government has slashed prices of about 39 drugs, including anti cancer drugs, anti diabetes, anti viral and antibacterial drugs, antiretroviral drugs, anti-TB drugs, and drugs used in Covid treatment, as it revised the National List of Essential Medicines (NLEM).

The commonly-used drugs which have been brought under price control include anti-cancer like Azacitidine and Fludarabine antiretroviral such as Dolutegravir, Darunavir+Ritonavir, new generation TB medications such as Bedaquiline and Delamanid, anti-allergy Montelukast, anti diabetes drugs like Teneligliptin

and Insulin Glargine, and tobacco cessation and addic-

tion treatment drugs like nico-

The Special Cell of Delhi Police has arrested a 58 year-old man allegedly involved in supplying arms and ammunition to criminals and Naxalites.

The accused has been identified as Ram Krishna Singh alias Master, a resident of Bhojpur in Bihar.

According to Pramod Singh Kushwah, the Deputy Commissioner of Police (DCP), Special Cell, the accused Ram Krishna Singh was arrested from Delbi's was arrested from Delhi's Nizamuddin area Wednesday.

"Post Covid this year, Singh revived his chain of gangsters and criminals and since June, he has sold over 300 cartridges and 10 pistols to criminals of Delhi/NCR. He has been pre-



viously involved in allegedly trafficking arms and supplying them to criminals in Bihar, Delhi and NCR besides to Naxalites in Odisha and Gadchiroli in Maharashtra,"

200 live cartridges to deliver it to criminals based in Delhi and NCR," said the DCP.

"Accordingly, a trap was laid and in the evening, our team spotted Singh coming towards the spot and they immediately surrounded him and apprehended him with a bag containing pistols and cartridges," said the DCP.

"Singh has further revealed that he purchases a pistol of .32 bore at a lower rate and further sold it to criminals of Delhi/NCR at a higher rate," said the DCP.

"He procured illicit cartridges from one of his contacts based in Firozabad, Uttar Pradesh and the sold it to criminals of Delhi/NCR. Further investigation is on to identify all the forward and backward linkages of this arms and ammunition network," the

In 2018, Singh was nabbed by Delhi Police's Special Cell along with 407 live cartridges and it was during his stay in Tihar jail that he developed contacts with gangsters and criminals and as per their demand, he started supplying arms and ammunition to criminals based in Delhi/NCR, said the DCP.

Singh, who is a B.Com graduate used to teach in private schools of Bihar after he came in contact with a criminal of his area in 2015, he joined him in trafficking of arms and ammunition to make easy money. Initially, he kept his network in Bihar but due to high demand from criminals and Naxalites of various States, he extended his realm up to Odisha, Maharashtra and other States including Delhi/NCR.

"I can't explain how I feel. my first Paralympic Games and I am waiting to see what lies ahead," he said after the superb performance.

The youngster had battled Covid-19 last year and desperate to train amid the lockdown, he had dug up a pit and filled it with soft mud to create a nat-

ural mattress for him to land. T64 classification is for athletes with a leg amputation, who compete with prosthetics

in a standing position. T44, the disability classification that Kumar belongs to but is eligible to compete in T64, is for athletes with a leg deficiency, leg length difference, impaired muscle power or impaired passive range of

His impairment, which is congenital, affects the bones that connect his hip to his left leg.Then came Lekhara and scripted history for the second time.The 19-year-old trailblazer claimed the 50m Rifle 3 Position SH1 bronze to add to an unprecedented gold she had secured earlier in the Games.Lekhara, also competing in her debut Games, qualified second for the event with a score of 1176, including 51

In the fiercely contested finals, Lekhara totalled 445.9 to finish ahead of Ukraine's Iryna Shchetnik, who let slip her grip on the medal spot with a poor third shot of 9.9 in the elimination.

She had become the first Indian woman to win a Paralympic gold by claiming the top honours in the 10m air rifle standing SH1 event. That was also the first ever shooting medal that India had won in the Games.

"It was a tough final but I'm happy to have made it into bronze. I could have done better than this. It's just what was paralysed below the waist after a car accident in 2012, said about her performance.

Prior to her, Joginder Singh Sodhi was the lone Indian to win multiple medals in the same edition of the Games when he fetched one silver and two bronze medals in the 1984 Paralympics. His silver came in shot put, while the two bronze medals were won

An economics scholar from the Punjabi University, Patiala, Singh collected three shoot-off wins on the day starting with his triumphs

in the opening rounds. The last of his three shoot-off wins came against Korean Kim Min Su in the bronze play-off. The 31-year-old was leading 5-3 before the Korean clinched the fifth set shooting a perfect 10 to force a shoot-off where the Indian responded in style against Kim's 8 for a 6-5 (26-24, 27-29, 28-25, 25-25, 26-27) (10-8) win. In the semifinals, Harvinder lost to world number 10 Kevin Mather of the USA 6-4 in an intense five-setter (25-28, 24-24, 25-25, 25-24, 24-26). Harvinder, who hails from a small village Guhla Cheeka near Kaithal in Haryana, was stretched to the fullest in the first two rounds, but he showed tremendous resilience to overcome his fancied opponents via shoot-offs.

In the first round of 32, Harvinder squandered a 4-0 lead against

Stefano Travisani after shooting a 7 in the third set as his Italian rival made it 5-5 (27-24, 26-22, 26-27, 25-25, 25-27) to force a shoot-off.

Harvinder clinched the issue -- 6-5 (10-7) -- in style, shooting a perfect 10 in the tiebreaker as his rival managed

In the last-16, Harvinder pipped former world number one Bato Tsydendorzhiev of Russia, once again by the thinnest of margins 6-5 (8-7).

Harvinder effected a specdown to bring the match on an even keel 5-5 (26-28, 23-26, 29-26, 23-21, 28-28) and force a shoot-off where he edged out his Russian opponent 8-7.

In the quarters, he swept aside 49-year-old three-time Paralympian Maik Szarszewski of Germany 6-2 (25-21, 28-23, 25-28, 26-23) dropping just one


NLEM list are Alteplase (clot buster), Atenolol (anti-hypertension), Bleaching Powder, Cetrimide (antiseptic), Erythromycin (antibiotic), Ethinylestradiol+Norethisteron e (birth control), Ganciclovir antiviral), Lamivudine+Nevirapine+Stav (antiretroviral), Leflunomide (antirheumatic), Nicotinamide (Vitamin-B) among a few others, said an official from the Ministry.

Talking about the list, a senior official stated, "Some of these drugs have been discontinued, new therapies and higher options have been launched. Due to this fact it was essential to delete them." ICMR deleted 16 odd drugs from the record. However, not all-important drugs will come under price capping, he added. At present, around 374 medicines are part of NLEM which are subject to price controls. About 18 per cent of the drugs sold in India are under price controls.







In a step to further strengthen defence and strategic ties, India and the United State of America(USA) have inked a pact for co-operation in the development of Air-Launched Unmanned Aerial Vehicle (ALUAV).

Project The Agreement(PA) for ALÚAV was signed on July 30 under the overall framework of the Defence Technology and Trade Initiative (DTTI) between the two countries, the Defence Ministry said here on Friday.

Describing the pact as a major step towards deepening defence technology cooperation between India and the US, officials said here, the agreement falls under the ambit of the Research, Development, Testing and Evaluation (RDT&E) agreement between the two sides that was first signed in 2006 and renewed in January 2015.

IFFCO MD MONEY-LAUNDERING CASE **ED** attaches assets worth ₹13.34 cr of **RJD MP Amarendra**

PNS ■ NEW DELHI

Enforcement Directorate (ED) has provisionally attached assets in the form of fixed deposit receipts (FDR) worth Rs13.34 crore belonging to Rajya Sabha MP from RJD Amarendra Dhari Singh, under the Prevention of Money-laundering Act in the ongoing investigations against IFFCO MD US Awasthi and

The ED had initiated money laundering investigation on the basis of an FIR dated May 17 registered by CBI under the provisions of the Indian Penal Code (IPC) and Prevention of Corruption Act against US Awasthi, MD of IFFCO and others, for criminal conspiracy, cheating and criminal misconduct.

"Money laundering investigation conducted by ED has revealed that there had been siphoning of funds amounting to Rs 27.79 crore related to criminal activities. Such proceeds of crime were laundered by way of projecting the same as consultancy income, first in the hands of entities under the control of Dubai-based

Chartered Accountant Rajiv Saxena (an accused in Agustawestland case) and subsequently in the hands of entities controlled by India based Chartered Accountant Alok Kumar Agarwal and thereafter in the form of cash to Amarendra Dhari Singh," the agency said in a statement.

Based on the investigation conducted so far by the ED, proceeds of crime have been quantified to the tune of Rs 27.79 crore, which had been used by Amarendra Dhari Singh on his own, it said.

ED had also filed a Prosecution Complaint (chargesheet) before Special Court on July 30 against six accused including Amarendra Dhari Singh and Alok Kumar Agarwal. In its order on August 7, the court has held that there was sufficient evidence on record to take cognizance of the offence under PMLA. The Court further held that all accused persons knowingly assisted/were knowingly involved in acquisition of proceeds of crime and hence were liable to be summoned for the said offence and proceeded to issue summons to the accused

etail edible oil prices in the Rcountry are not coming down anytime soon. And even if they do, the Centre on Friday made it clear, there "would not be any dramatic decline".

Retail prices of edible oils in India, wĥich imports 60 per cent of its requirement, have shot up to 64 per cent in the past just one year, in line with the global developments.

Union Food Secretary Sudhanshu Pandey on Friday said, "However, looking at the declining trend shown in prices of edible oils for December month in the futures market, it looks like retail prices will start declining. But, there won't be any dramatic decline as there is still global pressure". The arrival of new crops and a likely drop in global prices should help in softening of edible oils' retail prices in the country, he said.

Citing reasons for the sharp rise in domestic edible oils prices, the secretary said one major reason is that prices have gone up in the international markets as many countries are aggressively pursuing the biofuel policy using their own resources. For instance, Malaysia and

Indonesia, which are major suppliers of palm oil to India, are using palm oil for their biofuel policy. Likewise, the US is diverting soyabean for biofuel making, he said. Moreover, palm oil and soyabean oil are the top-two oils in terms of share in the Indian market. Palm oil is about 30-31 per cent, soyabean oil is 22 per cent.

Swamy urges PM to speed up prosecution of high profile corruption cases

Citing huge delays in prose-cution of high profile corruption cases, BJP leader Subramanian Swamy on Friday urged Prime Minister Narendra Modi to form an inter-departmental monitoring mechanism in the prosecution proceedings.

WB post-poll violence: 2nd Kerala: Covid CBI chargesheet in 2 days

Acting fast after taking charge the CBI, investigating the graver offences post Assembly elections on Friday submitted a second chargesheet, this time in a North 24 Parganas murder case where a BJP supporter JP Yadav was bombed to death on June 6 by alleged Trinamool Congress miscreants.

This is the second chargesheet filed in two consecutive days with the first one being filed by the Central Agency in a Rampurhat murder case in Birbhum district.

"Four persons have been named in the chargesheet," a CBI source said adding more investigations were being conducted against other persons who had been named by the com-

The CBI is acting upon the orders of the Calcutta High Court which earlier directed a twopronged probe deputing the central agency to investigate the graver offences whereas asking a Special Investigating Team of the State police to inquire into other offences.

In a related development former Calcutta High Court Chief Justice Manjula Chellur had agreed to supervise the SIT investigation into the "other" post poll "offences." According to sources unavailability of a retired Supreme Court Judge, for supervising the SIT probe — as was directed by the High Court — Justice Chellur was appointed for the task.

More than a hundred cases of murder, loot, rape and arson was reported post Assembly elections that saw Chief Minister Mamata Banerjee and Trinamool Congress roaring back to power for the third time in a row.

In the post poll violence an allegation of which was summarily rejected by the Chief Minister hundreds of BJP, Left, Congress and Trinamool Congress workers were attacked and their properties looted leading the Opposition BJP and the Left to raise demands for impartial probe accusing the State police of active connivance with the ruling party assailants.

Meanwhile, the TMC leadership which had already filed a petition in the Supreme Court against the High Court order continued to react strongly wondering why only the SIT and not the CBI was being monitored by the judiciary.

"Everyone knows how all the institutions have been saffronised by the BJP— from CBI to EC to NHRC and others -in that case where is the guarantee that the CBI will not conduct biased investigation ... CBI's bias is a well-known fact so why only the SIT and not the CBI will be monitored by the Court," Sukhendu Shekhar Roy TMC Rajya Sabha MP said.

The night curfew slapped on Kerala since last Sunday has failed to yield any result as the number of new patients diagnosed with Covid-19 continue to remain high. On Friday, out of the 1.63 lakh samples sent for testing, 29,322 persons were found to be infected with Covid-19, said a release by health minister Veena George.

The Test Positivity Rate remained high with 17.91 per cent while the pandemic claimed 131 lives taking the death toll in the State till date to 21,280. The State also saw 118 health workers falling prey to Covid-19.

Thrissur diagnosed 3530 persons on Friday and remained at the top of the table of districts with high patients. Ernakulam (3435), Kozhikode (3344), Kollam (2957) were the districts with highest number of Covid -19 patients.

Across the State, 2.46 lakh patients are undergoing treat-

ment for Covid-19. The Government's move to reopen schools in the State and conduct examinations for Class XI suffered a set back as the Supreme Court on Friday stayed the move of the LDF Government in this regard in the backdrop of the increasing number of Covid patients in the State.

The apex court took note of the unabated increase in the number of Covid-19 cases in the State and asked the administration whether the Government of Kerala has taken into account the 30,000 cases being recorded per day. "As we could not get satis-

Bengaluru: Karnataka's Leader of Opposition Siddaramaiah on Friday urged the state government to withdraw its decision to implement the new National Education Policy, while refusing to take part in the discussion on the subject.

"A letter has been written from the office of the Minister of Higher Education informing the implementation of new National Education Policy and requesting the appointment of Leader of Opposition to discuss regarding the same. It is to be noted that the government has already decided and inaugurated to implementation the said policy from the current academic year, without any discussion with the students, teachers, education experts or opposition. It is not correct to call for discussion now after inaugurating the implementation," he said

"Policy change in matters like education and health are not small issues. Detailed deliberations should have been initiated democratically before drafting such issues which have wide implications. Governments of many developed countries take the complete responsibility of health and education but here in India the government is trying to wash away the responsibility, the former Chief Minister said.

Siddaramaiah further noted that India has a high student to teacher ratio which should come down for the benefit of students. Also, the government allocation for education as a percentage of GDP is very low. Noting that NEP also recommends the allocation to education to be at 6 per cent of GDP, he said that then Karnataka should allocate about Rs

"There are many objections and concerns about NEP. It violates federal arrangements and infringes upon the autonomy of states over education and universities. It promotes privatisation leading to inequality and social injustice. The intention is to indoctrinate students with the idea of communalism through education. NEP is unscientific and will push lakhs of students to darkness," the Congress leader contended.

Government should have discussed and debated these issues before the implementation. NEP decides the future of many students shaping the next 70-80 years. Education is a tool for social elevation for many marginalised sections. Has BJP implemented NEP to prevent this elevation of social status among marginalised sections?" he

NIA files chargesheet against 10 accused

The National Investigation Agency (NIA) on ☐ Friday filed a charge-sheet against 10 ed constables, in the sensational case involving the recovery of an explosive-laden SUV the residence of industrialist Mukesh Ambani in south Mumbai and the subsequent suspected murder of the vehicle owner Mansukh Hiran. In a voluminous charge-sheet filed in a

Special NIA Special Court here, the NIA charged the ten accused - including dismissed Assistant Sub-Inspectors Sachin Waze, Riyazuddin Kazi, yesteryear encounter-specialist Pradeep Sharma, convicted constable Vinayak Shinde – with various offences under various sections of Indian Penal Code for murder, cheating, conspiracy and also various sections of the Arms Act, Explosive Substance Act and the Unlawful Activities (Prevention) Act. Apart from Waze, Kazi, Sharma and Shinde,

the others who have been named in the chargesheet are: Naresh R. Gor, Sunil D. Mane, Santosh A. Shelar, Manish V. Soni, Anand P. Jadhav and Satish T. Mothkuri.

The NIA has based its charge-sheet on three FIRs it registered in connection with the twin incidents. While the first FIR registered at the

Gamdevi police station relates to the recovery of a Mahindra Scorpio Vehicle on Carmichael Road, Mumbai during the intervening night of February 24 and 25, 2021 with 20 Gelatine Sticks Mukesh Ambani.

The second FIR registered with at the Vikhroli Police Stationn relates to theft of the seized Mahindra Scorpio vehicle, while the third FIR registered at Mumbra police station relates to the recovery of Mansukh Hiran's body from the nearby creek on March 5, 2021.

"During the investigations, incriminating evidences came to fore against the ten arrested accused involved in various stages of conspiracy of placing explosive laden Mahindra Scorpio vehicle, its theft and commission of murder of Mansukh Hiran," the CBI said in a state-

The IPC sections invoked against the accused in the case relate to criminal conspiracy, destroying evidences to escape the consequences, negligence with explosives, abduction with intent to kill, extortion with threats of death or physical harm, grabbing property, criminal breach of trust by public servant, forgery and forging documents of electronic evidence to pass them off as genuine, possession of a fake seal to commit forgery, common intentions, etc.

Modi Govt should reveal NMP objectives: PC

Slamming the BJP-led Government over its National Monetisation Pipeline (NMP) decision, former Finance Minister and senior Congressman P Chidambaram on Friday demanded an assurance from the Narendra Modi amount of ₹6 lakh crore, when realized, "will not be used for partly financing the fiscal deficit of ₹5.5 lakh crore in 2021-22 or for retiring old

Posing as many as 20 questions to the BJP-led NDA Government over the NMP, Chidambaram also sought an assurance from the Modi dispensation that the expected sum of ₹6 lakh crore would not be merged with general revenues and will not be used for general expenditure.

In a series of other questions on NMP, the former Finance Minister wanted to know if the Government floated a consultation paper on NMP "Did Government consult the workers or the trade unions or other stakeholders before announcing the NMP? When and where did these

consultations take place? Will the government make public the outcome or the minutes of these consultations?," he asked, while speaking to media persons here.

Chidambaram demanded to know as to why did not the government discuss the NMP in Parliament and posed to consult the Opposition parties or discuss the NMP Parliament. Charging that Prime Minister Narendra Modi's oft-

repeated claim of "nothing was

done in 70 years" stood

exposed, Chidambaram said: The NMP will wash away what has been done in the last 70 years". The NMP was not announced in the Parliament. It was announced after the session ended. There was no

consultation paper. There were no meetings with trade unions. Nor were there consultations with political parties," he said. Chidambaram ridiculed Modi by saying that "he is the only Chief Executive in the world who has never interact-

ed with the press". 'The Prime Minister has in the last 7 years never interact-

climate change vulnerable districts in the country are in the five States of eastern India - Assam, Bihar, Jharkhand, Uttar Pradesh and Odisha. Outlining this, scientists on Friday called for the urgent need to put in place a multi-hazard warning system, implement local action along with better coordination at inter-agency, inter-ministerial and Centre-State levels to combat the

global warming-induced threat. "Overall, eight States in the country viz., Jharkhand, Mizoram, Odisha, Chhattisgarh, Assam, Bihar, Arunachal Pradesh, and West Bengal, all in the Eastern India are found to have higher vulnerability. However, out of country's 100 most vulnerable districts, 70 per cent are in Assam, Bihar, Jharkhand, Uttar Pradesh and Orissa," said Dr Akhilesh Gupta, Senior Adviser and Head, Policy Coordination & Programme Management Division, and a climate change expert at the Department of Science and Technology (DST).

He was speaking at the inaugural session of the two-day policy dialogue on 'Localizing Climate Resilience Agenda: Vision 2050 and 2100' under CAP-RES

DST-GOI Project on Friday here.
"As projected by the recent Working group-I report of IPCC, the global temperature which has already increased to 1.1 degree C above the pre-industrial era level

wave.
"Monsoon may become more erratic. There may be more frequent droughts and floods. The Indian seas may witness the more sea-level rise. There has already been increase in sea level in last two decades.. With the increase of carbon dioxide content in the oceans, the sea water may become more acidic, and so on" Dr Gupta pointed out at the programme organized by National Institute of Disaster Management (NIDM), Ministry of Home Affairs and DST in collaboration with Deutsche Gesellschaft fur Internationale Zusammenarbeit (GIZ)

"Next two decades are going to be very crucial. IPCC's working group report gives the starkest of warnings for global climate impacts. The two-degree rise in global temperatures may come earlier than expected. It may have a huge impact on India, especially on agriculture, health and water security. India is confronted with a challenge of addressing such impacts," he

"Science and technology is a major tool to fight the menace of climate change. Of late, hazards are not happening in isolation but in combination with two or more. There is urgent need to put in place a multi-hazard warning system, along with better coordination at inter-agency, inter-ministerial and Centre-State levels. India made some excellent progress in climate action both in adaptation and mitigation areas," he pointed out. Maj. Gen. MK Bindal, Executive

Director, NIDM, MHA, warned that the danger mark has been reached, rapid access to information is needed to protect lives and livelihood and the use of STI is key to fight climate change problems.

'The sixth IPCC report has pushed the button to act now, and it is time to act locally. Good policies need to be translated into action. We are working with state governments for localising action plan," said Christiane Hieronymus, Head of Economic Cooperation & Development, Embassy of the Federal Republic of Germany while Prof V K Sharma, Vice Chairman, Sikkim SDMA said that, "We will have to do something at local level, at the municipal level with regional and local approach and also at the panchayat level." Dengue and viral fever cases wreaking havoc in UP

Aligarh: Viral Fever and dengue have started wreaking havoc in the district. It spread as an epidemic in the cities like Mathura, Firozabad, Aligarh and Hathras. More than 60 person have lost their lives due to this. About 2000 people are admitted in hospitals of these district and 150 new patients arrived in the OPD of Malkhan Singh District Hospital of Aligarh for treatment. More than ten percent are suffering from viral fever. Two dengue patients are admitted in the hospital, who are undergoing treatment. So far five cases of dengue have been found in the Aligarh district. Chief

Superintendent Dr. Ramkishan said that out of the total patients, more than 10 percent

patients are coming with fever. Fewer cases of dengue and malaria have been reported so far. At present, two dengue patients are admitted in the hospital, who are undergoing treatment. Fever patients are also reaching the Pt. Deendayal Upadhyay Joint Hospital. CMO Dr. Anand Upadhyay informed that medicines have been made available at all CHCs and PHCs of the district. Spraying of chemicals has been ordered. So far five cases of dengue have been found in the district. The Health Department team is

Right path?

Is the farmers' protest making any tangible mark or are they being misled?

he farmers' protest in and around Delhi since November 26 is in limbo. They are no closer to getting their demands for repeal of the three farm laws realised than when the protest began. The protest itself has expanded from Sikh farmers of Punjab to now include farmers from western Uttar Pradesh. Over these months, the protest appears to have transformed from an agricultural protest to a political protest to what is now being perceived as an electoral protest. That does not necessarily reflect badly on the farmers because in the absence of any Government response other than more rounds of talks, the farmers have been left with no option but to use current issues to peg their protests on, to keep themselves and their demand relevant. When it began last November, the focus was on the repeal of the three laws. The farmers received sympathy from across the country. The protest sites near Delhi attracted constant media and political



attention. The euphoria over the first invitation for talks by the Government gradually dissipated as both sides could not reach a common ground. The protests took a political tone in the process, as the anger of the farmers against the Government turned into disillusionment with the Bharatiya Janata Party. The protests also focused on the BJP Governments in Haryana and Uttar Pradesh. Over time, and as the Government refused to surrender to the farmers' demands, the protests narrowed down their focus to turn electoral, to teach a lesson to the BJP in the forthcoming Assembly elections in 2022.

Since then, the protests have adopted a revised strategy. The farmers announced a "Mission UP, Uttarakhand", aimed at impacting the electoral prospects of the BJP Governments in these States. In an unadvertised manner, the farmers took their protests to Punjab as well, attacking the BJP and the Akali Dal and not the ruling Congress. If a week ago the farmers protesting against the BJP meeting in Haryana's Karnal were lathicharged, they faced the lathi in Moga, Punjab, this week. The farmers were charged with disrupting an Akali Dal rally by party chief Sukhbir Singh Badal who was launching his 100-day "yatra" across Punjab ahead of the elections next year. The protests are taking a political colour not of the farmers' making; they are being "used" by political parties for their own ends. In UP, the BJP plans to hold farmer outreach programmes in the form of "kisan panchayats". This is expected to drive a wedge in the community along party lines. In Punjab, the Congress openly claims credit for the farmers' protests. Social activists like Yogendra Yadav are giving the protests an entirely different spin: "The question now is not what the farmers can secure for themselves (but) whether they can lead the larger battle for saving the very idea of India." If the farmers remain convinced about the genuineness of their demand, they should begin to distinguish between leading and being led.

Due attention

Paralympics in India has finally come of age and sportspersons are getting noticed

India's participation in the Paralympics remained gloomy until the 2016 Rio Paralympics in which the Indian contingent was represented by 19 athletes, the most since India's If first participation in 1968. In that tournament, India recorded its best ever medal haul (four), including two golds. Moving on to the in-progress Tokyo Paralympics 2020, India sent 54 athletes, almost thrice the number sent in the last edition, who have clinched 13



medals (and counting), broken the world record in javelin thrice and brought the much-needed respect and recognition to the Paralympics which has been missing in India. The tournament has made the country proud, but more importantly, it has given hope to the specially abled people in India who account for 2.21 per cent of the total population. However, how fair is it for the State Governments to announce massive financial rewards and Government jobs to para athletes only after they bring home 'the glory'? Why doesn't the Government understand that financial support before the competition is much more critical than the 'reward' that follows. The

idea behind Paralympics was not to glorify the specially abled, but to make them feel able and included; however, para athletes were not given due recognition until recently.

Various national sports bodies have tried to distance themselves from the Paralympics, citing "financial overburdening" and "complexities involved in organising tournaments". The Paralympics Committee of India (PCI), set up to promote and contribute to the development of sport opportunities and competitions, was suspended by the International Paralympics Committee (IPC) in 2015 for undermining the development of the Paralympic Movement in India. The committee was again banned in 2019 by the Ministry of Youth Affairs and Sports (MYAS) for misgovernance. PCI has been insensitive towards para athletes, however, the Paralympics in India has seen improvements after the 2016 Rio Paralympics because the Government finally gave it due attention. Cricket in India has always been pampered and cricketers have reaped the most out of it, leaving little for other sports. But the Tokyo Olympics and the Tokyo Paralympics brought a shift of spotlight from cricket to other important sports. The para athletes train to compete in events which are held once in four years, therefore, it is important for the Central and State Governments to provide resources and infrastructure that motivate more such people to participate.

UP's progress and Yogi's dynamism

ndia's largest State Uttar Pradesh, also its most politically vibrant, has also moved in the field of development the fastest. Be it in the layout of highways, appointments to Government services, providing employment to the people, increasing investments, improving law and order, encouraging tourism and pilgrimage, as well as expanding the small and medium enterprises sector, Uttar Pradesh is making waves.

Since Independence, one never heard that this State had moved in the area of development It is surprising that New Delhi did not bother, perhaps ignoring the fact that UP is one-fifth of India. If, therefore, UP leaps in progress, the country races ahead in terms of development. Evidently, for the powers-that-be in India's rajdhani, UP was treated as a bank of 84 Lok Sabha seats (80 now) and a sure-shot ticket to parliamentary majority at the Centre, but nothing more. In fact, a chief former ruling dynasty was reported to have voiced an opinion in favour of keeping Uttar Pradesh backward and fragmented.

The State today in 2021 is a

vastly changed place. From the backwaters of most economic indices, it today has moved to becoming India's second-richest in terms of Gross State Domestic Product (GSDP), which stands at \$268 billion, behind only Maharashtra now. This, under Yogi Adityanath has been an achievement despite the ravages of the COVID-19 pandemic. In the ease of doing business, a crucial global benchmark, UP, which languished at 16th position in the country in 2016, has moved up to the second rank among India's

Law and order, the most important prerequisite for any development activity to flower, was never a strong suit in Uttar Pradesh before Adityanath took over. Any economic or capital investment in the State remained a dream. The scenario after Yogi's coming to office in March 2017 is a sharp contrast. Over the past four-and-a-half years, 137 criminals have been liquidated in police action, while close to 3,000 criminals were injured; nearly 37,000 accused have been booked under

the Gangster Act and over 500 under the National Security Act. The Yogi administration has also hit criminals hard by targeting their finances; in the State Government's drive against the mafia, their illicit property worth more than ₹1,500 crore has either been attached or demolished. Along with action against the mafia, the Yogi administration has also provided protection to And a vastly improved law

and order has begun to pay off in the realm of development. Here too, figures speak for themselves. The State's development data reveals that over the years, UP has received investment proposals worth ₹66,000 crore from both foreign and local investors. The administration has acted promptly on these proposals. More to the point, companies from Japan, Canada, Germany, Hong Kong, the UK, the US, Taiwan and South Korea are lining up to invest in UP; one company has left from China to set up operations in Agra. It is also significant that the Government is ensuring that the flow of investment is not confined to the State's bigger cities, but is also being channeled to smaller towns like Etah, Amroha, Mirzapur, and so on.

Apart from the fresh proposals for investment, MoUs worth ₹4.68 lakh crore have been signed at investors' summits, of which 371 proposals worth close to ₹3 lakh crore are already functional, generating employment for up to 5 lakh people. Here, one must make mention of the work being done by this Government on the defence industrial manufacturing corridor, which has already drawn up to 14 MoUs. The aim is to transform Uttar Pradesh into a hub of capitalintensive manufacturing, which the defence industry invariably entails.

Farmers have much to be happy about in Yogi Adityanath's Development schemes and programmes, for their longterm success, also need the health of the rural economy to be robust. The Adityanath policy of transparent purchase of wheat and paddy, as also his continuous supervision of purchase centres, has been successful. The example of paddy should suffice; the State Government has purchased a record 60 lakh metric tonne of the grain against a slated target of 55 lakh metric tonne. Payments made to the State's farmers have been touching new records as

well. The Government has stepped up its efforts to double the income of the State's farmers. Nearly ₹33,000 crore have been transferred to the accounts of the nearly three crore farmers under the Pradhan Mantri Kisan Samman Nidhi Yojana, plus separate transfers under crop insurance schemes. The modernisation of 20 sugar mills in the State, along with the reopening of the Pipraich, Munderwa and Ramala sugar mills, is a particularly significant milestone in the Yogi administration's agriculture

policy. Uttar Pradesh under Yogi Adityanath is clearly not the "Bimaru" State it was once derided as, but a State on a rapid march upwards. This is important for the State, which is one-fifth of India. Being backward is bad enough, but if one-fifth of the frame is sick, the rest of the body cannot in any way be healthy. Moreover, the Narasimha Rao-initiated 1991 reforms did not benefit UP. This makes UP's march under Adityanath all the more remarkable.

Discrimination in waste disposal ignores minority communities of the world

here have been many cases of racism throughout the world but the concept of environmental racism is a lot different and an emerging and widespread issue that needs to be addressed and a remedy suggested. Environmental Racism refers to a practice by which the minority communities of the world are ignored and are forced to live in an area that is surrounded by industrial or toxic materials, industrial waste factories, landfills, and other polluting sources. In other words, minority groups, such as coloured people, are discriminated against, and the environment around where they liveis generally toxic, surrounded by industries or waste disposal facilities. The policies are often discriminated against them. The word "Environmental Racism" was first used in the United States but now it is used worldwide as cases are increasing daily. "Environmental Racism" was coined in 1982 by Benjamin Chavis, previously executive director of the United Church of Christ (UCC) Commission for Racial Justice. Chavis defined the term as racial discrimination in



environmental policymaking, the enforcement of regulations and laws, the deliberate targeting of communities of colour for toxic waste facilities, the official sanctioning of the life-threatening presence of poisons and pollutants in our communities, and the history of excluding people of colour from the leadership of the ecology movements. During the civil rights moments, environmental racism started to gain critical attention and people began to get concerned about their residential areas or neighbourhoods and this led to the beginning of the demand for Environmental Justice. No one wants landfills, industrial waste, dumping of wastes, etc., around their residential colonies but the majority of these policies in the US were against the people of colour and. Therefore, a majority of the landfills were concentrated near areas where the Latino-Americans, African-Americans or low-income groups are housed. Civil rights moments and Environmental Justice joined hands and impacted the United States immensely. People become more concerned about their living environment. The environmental justice movement became a huge protest movement and people from minority communities started to fight for their rights. The Environmental Justice movement started to gain strength during the presidency of Bill Clinton. There have been many cases of environmental racism in the United States, where 70 per cent of the population lives near waste or dumping lands. It can be said that a major portion of contaminated sites exist in the low-income neighbourhoods. "Cancer Alley" is the most polluted area of the United States and it lies along the famous Mississippi River, affecting mainly the communities of colour. Environmental Protection Agency surveys show that non-white Americans mostly face air pollution from industries, oil fumes, smog, etc. They cause problems of the heart, lung cancer, asthma, and other non-communicable diseases because of inhaling poor quality of air. The National Centre for Environmental Assessment's scientists confirmed that the African Americans in the United States face 1.5 times more dust particles or poor air quality than white people. At present, it is considered that race and not poverty alone should be considered as the main variable for studying environmental effects on poor communities. Surveys have been showing since 1983 that only 25 per cent of the wastelands are constructed near where white Americans live while the rest come up near the housing projects of minority communities. In 1990, many environmental justice leaders signed a public petition against the 10 big environmental groups for racial bias in policy development and the presence of only whites on their boards. This led to some of these organizations including people of colour or the poor in their workforce. Continued pressure led to the creation of the US Office of Environmental Equity.

The MBS impact on geopolitics

ohammed bin Salman is described as a Machiavellian reformer, visionary, revolutionary and reactionary. Itis fair to say that because of these eye-catching traits ofhis political activities that MBS, as he is popularly known as, is being keenly noticed in Saudi Arabia and beyond.

The Kingdom of Saudi Arabia had long been known for two things: oil and Islam — and lately for its Crown Prince. The oil-rich Kingdom has witnessed wide-ranging changes, and the man driving them is the visionary son of King Mohammed bin Salman. His admirers describe him as a hard-working, businessminded leader with no stomach for corruption and a burning desire to modernize the country while avoiding the trappings of royalty. On the other hand, his critics view him as power-hungry, 'immature', and someone unaware of the dangers of reforming too much too fast. Such views are hardly surprising given the rush for reform across the Kingdom since MBS was appointed as the crown prince.

MBS is already his country's de facto

ruler, and perhaps the most powerful person in the Middle East region. It was only after his father was appointed as the Crown Prince in 2012 that he began to accumulate power. The following year, MBS became the head of the Crown Prince Court and soon was made the Minister of Defense. Muhammad Bin Salman was also appointed as the Deputy Crown Prince and took over the Council of Economic and Development Affairs. There was no stopping the ambitious prince. Now in charge of the war in Yemen and Saudi Arabia's economy, his importance as a policymaker became clear the following year when he unveiled an ambitious and wide-ranging plan to bring economic and social change to the Kingdom and end its "addiction" to oil. The destination goal for Salman was to be the most powerful man in Saudi Arabia and that meant assuming the title of Crown Prince.

After his anointment as Crown Prince, he started making moves that would shock not only the conservative Saudi Wahabbi clerics but also the world as a whole. In an interview, when he was asked what was his concept of moderation, the Prince replied: "Of course, this is a broad term. All Muslim jurists and scholars have been talking about the concept of moderation for over a thousand years. So, I do not think I am in a position to clarify this concept, as much as I can ... abide by the Saudi constitution, which is the Quran, the Sunnah, and our basic governance system and to implement it fully in a broad sense that is inclusive of everybody. This leads me to another question, namely the space Sharia occupies in the State. Meaning, on the level of the constitution, the judiciary, the public space, and the level of freedoms of individuals. As I said earlier, our constitution is the Quran, has been, still is, and will continue to be so forever."

Crown Prince is clear about the sensitive matter: "We are simply reverting to what we followed — a moderate Islam open to the world and all religions. 70 per cent of the Saudis are younger than 30, honestly, we won't waste 30 years of our life combating extremist thoughts, we will destroy them now and immediately."

In 2016, to prepare for the kingdom's economic future, Crown Prince Mohammed bin Salman laid out a road map for the country, known as Vision 2030. The plan was to transform Saudi Arabia by liberalising social norms and improving Government services. In his words, "We seek to be proud of our country, and allow the latter to contribute to the development of the world, whether on the economic, environmental, civilisational, or intellectual levels." Such ambitious transformation projects come with very high realisation costs. The country has plans to transform the capital Riyadh into an economsocial, and cultural hub by 2030 at the cost of \$800bn along with the planning of a new city NEOM at an estimated cost of \$500bn. Several other multi-billion-dollar projects are planned to be completed by 2035.

Under MBS, Saudi Arabia's tech scene has seen a dramatic transformation. The Saudi Government is pushing huge amounts of capital into the industry and attracting foreign investors in a bid to become the new eco-

Crown Prince is aiming to spend over \$7 billion dollars within the next 10 years across the public and private sectors to diversify its economy away from oil. And his plan seems to be working: in the last year, Google signed a \$10 billion agreement with oil giant Aramco; Amazon has committed huge business in the country, and Huawei is set to open its largest flagship outside of China in Riyadh. The growing social cachet attached to the tech industry is a trend that can be attributed, in part, to Crown Prince's own fascination with Silicon Valley. To raise funds for economic diversification, Saudi Arabia has issued debt, drawn down its fiscal reserves and VAT a form of sales tax. The kingdom can also continue to draw from its reserves, which stood at \$130bn at the end of the second quarter of 2021. Nevertheless, privatisations are likely to gain new momentum

The momentum for this relationship began during the visit of Prime Minister Narendra Modi to the Kingdom in April 2016, during which he was presented with the Sash of King Abdul Aziz, the highest civilian decoration awarded by King Salman. The momentum increased with the crown Prince's visit to India, during which he and Modi discussed prospects for bilateral cooperation in all fields, along with other issues of mutual interest. And the confirmation of India as one of the Kingdom's strategic partner countries under Vision 2030, complete with a proposal to set up a highlevel partnership council.

Rockets in the Stratosphere

The typical rocket launch dumps the same amount of CO2 into the atmosphere as one airliner does in the course of a trans-Atlantic crossing

f you're worried about your 'carbon footprint' - a concept foisted on the world in 2004 by British Petroleum to persuade people that their own behaviour, and not giant oil companies like BP, is causing the climate problem - then you definitely should not sign up for a sub-orbital space flight. Besides, you probably can't afford it (\$250,000 pp).

Millions of people can afford it, however, and since the Branson/Bezos 'space race' last month tickets for suborbital flights are selling fast. These are commercial ven-

tures, after all. There are only three more flights scheduled for Jeff Bezos's 'Blue Origin' rocket before the end of the year, and two more for Richard Branson's 'VSS Unity', but both



men clearly intend to ramp up to more frequent flights. (Branson predicts 400 flights a year.) The era of mass space tourism is just around the

Well, what did you expect? The travel and tourism industry accounted for 10.7 per cent of world GDP in the last normal year (2019), so nowhere is safe, including the stratosphere. And like every other tourist destination, the stratosphere suffers some environmental damage from all the tourists passing through. The key question, so far unanswered, is: how much?

Hardly any at the moment. The typical rocket launch dumps the same amount of CO2 into the atmosphere as one airliner does in the course of a trans-Atlantic crossing.



four passengers aboard each of those sub-orbital flights, their individual carbon footprints are huge - but more than 1,700 commercial jets cross the Atlantic on the average day.

Most rockets, including Elon Musk's 'Falcon Heavies' and most of the big Chinese and Russian vehicles, burn a mixture of kerosene and liquid oxygen and produce an exhaust plume little different from that of jet aircraft: mostly carbon dioxide and water. But the total fuel used annually by all the world's rockets is less than one percent of that burned by commercial aircraft.

Moreover, some of the newer rockets, like Bezos's 'New Shepard', most European launch vehicles, and the last stage of the new Long March rockets, use Liquid Hydrogen and Liquid Oxygen, which leaves only water and a few traces of other chemicals. So far, so relatively harmless except that all the other rockets leave black carbon ('soot') in the upper stratosphere, where airliners don't fly.

The commercial aircraft do leave soot in the lowest part of the stratosphere, where its effects are reasonably well understood. It warms the lower stratosphere. It presumably does that in the upper soot generator with stratos-

parts of the stratosphere too.

The annual orbital rocket traffic is surprisingly low: a record 1,283 satellites were put into orbit last year, but only 104 rocket launches were used to put them there. (Another ten launches were failures, but failures tend to happen before rockets reach the stratosphere.) This means the prospective 'tourist' launches represent a four- or five-fold jump in the stratospheric traffic.

Bezos's launches get a ass because he's not burning kerosene and leaving soot behind. Branson's rocket, however, is powered by a 'hybrid engine' that burns hydroxyl-terminated polybutadiene (synthetic rubber), with nitrous oxide as an oxidiser. You can think of it as a pheric capability. And 400 flights a year.

So, the Branson rocket should be closely monitored for its impact on the stratosphere, and how that might affect the climate. The impact could be insignificant, but it will be a much bigger contributor to stratospheric pollution than its size suggests. And what of space flight in general?

There will certainly be more orbital flights as time goes on, but most satellites are now very small packages that can be packed together on a single launch. Moreover, there is a clear move towards using liquid hydrogen rather than kerosene as a fuel, despite hydrogen's current high price, and a longer-term aspiration to use high-energy biofuels that

are carbon-neutral.

Aviation as a whole remains a significant part of the warming problem, producing more than 3 per cent of global CO2 emissions, and the solutions are expensive or technically difficult. Biofuels can eventually address the carbon dioxide emissions, but at least half the aviation-linked warming is not CO2. Its heat reflected back to the ground by contrails.

The remedy for that is to in the lower atmosphere, where contrails rarely form but that puts planes back down in the turbulence, which passengers do not like. Planes could be designed that would counter that turbulence (ducted flow and computer-driven instant response), but there's no sign of it yet.

Forex reserves surge to record \$633.5 bn

he country's foreign exchange reserves soared by USD 16.663 billion to touch a lifetime high of USD 633.558 billion in the week ended August 27, mainly due to an increase in Special Drawing Rights (SDR) holdings, RBI data showed.

On Wednesday, RBI had said the International Monetary Fund (IMF) made an allocation of SDR 12.57 billion (equivalent to around USD 17.86 billion at the latest exchange rate) to India on August 23, 2021.

SDR holdings are part of the foreign exchange reserves of a country. IMF makes the general SDR allocation to its members in proportion to their existing quotas in the Fund.

In the reporting week ended August 27, 2021, the country's SDR holdings rose by USD 17.866 billion to USD 19.407 billion, as per weekly



Bank of India (RBI) on Friday. India's forex kitty had declined by USD 2.47 billion to USD 616.895 billion in the previous week ended August 20,

Foreign currency assets (FCAs), a major component of the overall reserves, dipped by USD 1.409 billion to USD 571.6 billion in the reporting week, the data showed.

Expressed in dollar terms,

the foreign currency assets include the effect of appreciation or depreciation of non-US units like the euro, pound and yen held in the foreign exchange reserves.

The BSE Sensex scaled the 58,000-mark for the first time on Friday, buoyed by a rally in market heavyweight Reliance Industries as investors remained in risk-on mode amid positive macroeconomic data and sustained foreign fund inflows

Rising for the second straight day, the 30-share benchmark climbed 277.41 points or 0.48 per cent to its lifetime closing high of 58,129.95.

It touched an intra-day record of 58,194.79.

The Sensex has taken just sessions to go from the 57,000-level to 58,000. The index closed at fresh all-time highs in five of the previous six

Similarly, Nifty advanced 89.45 points or 0.52 per cent to its all-time closing peak of 17,323.60. During the session, it touched a record of

It was a scintillating week for the benchmarks, with the Sensex rallying 2,005.23 points or 3.57 per cent, while the Nifty surged 618.40 points or 3.70 per cent.

Reliance Industries was the top gainer in the Sensex pack on Friday, darting up 4.12 per cent after its chairman Mukesh Ambani outlined an ambitious green energy roadmap, including a '1-1vision' to bring down the cost of hydrogen to under USD 1 per 1 kg in 1 decade.

Titan, Tata Steel, Bajaj Auto, Maruti, Dr Reddy's and Asian Paints were the other prominent winners, spurting up to 2.59 per cent.

Maruti Suzuki closed 1.06 per cent higher even as the country's largest carmaker announced a recall of 1,81,754 units of various models to replace faulty motor generator

Rupee settles 4 paise higher at **73.02** against US dollar

The Indian rupee settled with a marginal gain of 4 paise at 73.02 against the US dollar on Friday, even as the domestic equities continued their record-setting spree. At the interbank forex mar-

ket, the local unit opened at 73.05 against the greenback and witnessed an intra-day high of 73.01 and a low of 73.15. It finally ended at 73.02 against the American currency, registering a gain of just 4 paise over its previous close.On a weekly basis, the local currency has appreciated by 67 paise against the US dollar. According to HDFC Securities' Dilip Parmar, spot USD/INR facing resistance around 73.15 and holding support at 72.90. "Expectations of dollar inflows from many corporates' fund raising also weighed on the pair. In near term, spot USD-INR is expected to consolidate before heading towards 72.

Industry body Dipa disappointed over non-implementation of Trai recommendation on infra

Digital infrastructure industry body Dipa, erstwhile Taipa, on Friday expressed disappointment over non-implementation of Trai's recommendations since 2015 to enhance the scope of infra-structure providers. Telecom Regulatory Authority of India (Trai) has again recommended to Department of Telecom on August 31 that its recommendations dated March 13, 2020 to enhance the scope of infrastructure providers should be decided by the department and the matter should be finalised within three months.

"We thank the Authority (Trai) for once again underlining the need for Enhancement of Scope of IP-1' and this time prescribing timelines also for its implementation i.E within 3 months as the same is pending despite numerous follow-ups with DoT," Dipa Director General TR Dua said in a statement.

Infrastructure Providers

(IP-1) provide infrastructure assets such as dark fibre, right of way, duct space and tower on lease, rent-out or sale basis to telecom operators on mutually agreed terms and conditions.

Trai has recommended that the registered IP-1 companies be allowed to own, establish, maintain, and work all such infrastructure items. equipment, and systems which are required for establishing Wireline Access Network, Radio Access Network, and Transmission Links.

The regulator also suggested that the scope of IP-1 registration should include, but not limited to, right of way, duct space, optical fiber, tower, feeder cable, antenna, base station, in-building solution (IBS), distributed antenna system (DAS) etc within any part of India.Dua said that once the recommendations are implemented, it will go a long way in not only addressing the capex and opex requirements but also improving the financial health of the sector.

cars have been transporting people around the city since the late 19th century. The cars run on tracks and are moved by an underground cable along three routes. Visit the Rock: Alcatraz, the notorious former prison, is located on an island of the same name in the middle of San Francisco Bay. Some of the United States' most notorious criminals were incarcerated there. Though several tried, no inmate ever made a successful escape from 'The Rock'. The

neof the nicest prison was closed in the 1960s and stories about Alcatraz are legendary. A visit today is fascinating. Recorded cell-house tours are available which allow visitors to learn about the prison as they explore the buildings and grounds. To reach the island, take an Alcatraz Cruises ferry from

See the Sea Lions:

Here is a suggested list of the top 28 things not to miss home to PIER 39, a festive waterfront marketplace, that is one of the city's most popular attractions. A community of California sea lions has taken up residence on the docks in the PIER 39 Marina and visitors line the nearby railing to watch their antics. From there, it's a short walk to area attractions such as the San Francisco Dungeon and Madame Tussauds, the Museum of 3D Museum, Ripley's Believe it or Not! Museum, the historic Boudin Bakery and multiple food options, including crab vendors selling walk-away crab and shrimp cocktails.

Go on a Walking Tour: The best way to see and experience the place is on foot. Wild SF Walking Tours offers a food crawl, a tour of the a Haunted San Francisco Ghost Tour. Go Behind the Scenes at Oracle Park, the home of San Francisco Giants. You'll have access to the player's dugout, luxury suites and more. There are walking tours for foodies, too. Local Tastes of the City Tours lets you learn about the food history and culture in neighbourhoods such as North Beach, Chinatown and others. During the stops along the way, one can taste all the unique foods originating from different cultures.

See a Show: From rock and pop to hip hop and jazz, San Francisco is a hub for every music genre. Tokyo: A congenital impairment notwithstanding, 18-year-old Paralympics Silver medallist Praveen Kumar was such a sports freak in his school days that he googled on internet to find out how to take up para athletics and take part in the showpiece.

Praveen, a son of a poor farmer at a village near Jewar in Gautam Buddha Nagar district, clinched Silver medal in the men's high jump T64/T44 event of the Paralympics by setting a new Asian record of 2.07m.

"My school life was

Responding to Table Tennis Federation of India's show cause notice, Manika strongly denied that she brought disrepute to the game by refusing Roy's help.

According to TTFI sources, the world number 56 stated she would not have been able to focus on her match if someone who asked to her indulge in match-fixing months earlier was sitting by her side.
"Besides the need to avoid


