Gujarat gets low-profile CM

BJP brass chose lightweight Patidar Bhupendra Patel for top job

 $T^{\text{he BJP's central leadership}} \\ \text{on Sunday "hand-picked" a} \\ \text{lightweight Patidar and first-}$ time MLA Bhupendra Patel known to be a *protégé* of former Gujarat Chief Minister Anandiben Patel — as the new Chief Minister of Gujarat in place of Vijay Rupani who resigned a day earlier, after holding the post of the State's Chief Minister for close to four years. The choice of Patel surprised many State leaders and the front runners for the top post, including Nitin Patel, the Deputy Chief Minister, again lost the race.

A builder by profession, Bhupendra Patel staked his claim to the Chief Minister's Office on Sunday in front of State Governor Acharva Devvrat and will be sworn in on Monday

According to sources, Patel's familiarity with the Gujarat business fraternity, a core voter base of the BJP, may also work in his favour.

While Patel was elected the leader of the Legislature Party after a meeting at Gandhinagar, it is well-known in the State BJP's political circles that his appointment was finalised beforehand by Prime Minister Narendra Modi and Union Minister Amit Shah. In choosing a first-time MLA and

a low-profile face as the Chief Minister, Modi has made it clear that the elections in his home State will again be contested in his name and that the vote for the BIP would be a vote for Prime Minister Modi and for the Union Government.

oning for the Chief Minister's post with the backing of the outgoing Chief Minister Anandiben Patel but Shah is understood to have favoured

Union Minister Narendra Singh Tomar made the announcement after Patel's

Patel won from the Ghatlodiya constituency in 2017 Gujarat Legislative Assembly elections, defeating Shashikant Patel of the Congress by a record margin of 1,17,000 votes, the largest for any constituency in Gujarat for the BJP in that election.

He is the former Chairman of the Ahmedabad Urban Development Authority and has also been Chairman of the AMC Standing Committee. In the 2017 Assembly elec-

tions, the BJP was down by 16 seats, winning only 99 seats in the 182-member House. The Congress fought tenaciously collecting 77 seats in what many saw as a close contest, with the latter increasing its vote share in the State.

The 2022 Assembly polls

may be more challenging for the BJP which has to face a 27year anti-incumbency and the Aam Aadmi Party (AAP) a new entrant in the fray. The AAP had won 27 seats in the Surat Municipal Corporation. Continued on Page 2

'Skip Covid jab, increase death risk by 10 times'

CDC cites three studies on role shots play in saving lives

PNS NEW DELHI

People who are not vaccinated against the Novel Coronavirus disease are ten times more likely to die from the infection, compared to those who have taken the shots, the US' Centers for Disease Control and Prevention (CDC) said citing three new studies that emphasised the importance of Covid shots in preventing death rates.

The studies appeared in the agency's Morbidity and Mortality Weekly Report.

The findings showed that the currently available Covid-19 jabs provide strong protection for most people against hospitalisation and death, even during the Delta surge. However, higher hospitalisation and death rates are observed in older age groups, regardless of vaccination status.

For the study, the CDC analysed data on more than 6,00,000 Covid-19 cases, hos pitalisations and deaths among people 18 years of age and older, by vaccination status, reported from April 4 to July 17 in 13 States and cities.

Tndia will get this month the Ithird set of Swiss bank account details of its nationals under an automatic exchange Switzerland and this will include for the first time the data about real estate properties owned by Indians there. officials said on Sunday.

Marking a key milestone in the Indian Government's fight against black money allegedly stashed abroad, India will get this month the complete information on flats, apartments and condominiums owned by Indians in Switzerland as also on earnings made from such properties to help it look into tax liabilities associated with those assets.

The move assumes significance on the part of Switzerland as well as the European Alpine nation is trying hard to reposition itself as a key global financial centre while warding off the long-persisting perception about the Swiss banking system being an alleged safe haven for black

Nitish skips but JD(U) to attend Opp rally

KC Tyagi to represent party in Sept 25 show at Jind

While Bihar Chief Minister Nitish Kumar has expressed his inability to attend the much-hyped Jind rally called by INLD stalwart Om Prakash Chautala for non-BJP and non-Congress parties, Nitish's party JD(U) will be represented by senior leader and former Rajya Sabha member

KC Tyagi.

JD(U) president Rajiv
Ranjan Singh alias Lallan said the Chief Minister was busy so he would not be able to visit Jind on September 25, though the JD(U) would be sending national general secretary KC Tyagi as its representative.

The response comes days after INLD leader Abhay Chautala announced that Nitish, along with top Opposition leaders, would attend the mega rally in Haryana to commemorate the birth anniversary of former Deputy Prime Minister Chaudhary Devi Lal.

JD(U) said the Bihar Chief Minister has the deepest personal regard for Devi Lal and he was willing to attend, but the



State is facing several challenges on the ground like Covid, floods and local politics.

Lallan said under the prevailing circumstances, Nitish could ill-afford to go out of the State. He might, at most, make short trips to the national Capital if the situation war-

Abhay Chautala, along with his father and former Haryana Chief Minister Om Prakash Chautala, is organising the Kisan Panchayat where leaders like Samajwadi Party patriarch Mulayam Singh

Yaday, former Prime Minister HD Deve Gowda and Siromani Akali Dal leader Parkash Singh Badal are expected to be pre-

Chautala had initially claimed that Nitish had confirmed his presence for the meeting, which had led to a political storm in Bihar since the JD(U) is the biggest constituent of the NDA after the BJP. It is being speculated that the JD(U) strongman, whose party had been given short shrift by the BJP in the recent Union Cabinet expansion, might have decided to attend the Jind programme to express his disgruntlement.

The rally was being viewed as a precursor to the formation of a non-BJP, non-Congress Third Front. NCP leader Sharad Pawar, West Bengal Chief Minister Mamata Banerjee and NC leader Farooq Abdullah have also been invit ed to the rally.

Confirmation about the participation of all invitees is yet to come as all the announcements so far have been made by the INLD.

Indians with low antibody levels may get 3rd shot

Although the World Health Organisation (WHO) has asked its member nations to put on hold booster doses of Covid-19 till more countries catch up with vaccination, India may consider giving a ple who have low antibody lev-

"The move is being contemplated as over 20 per cent of the inoculated population has failed to develop antibodies against SNRS-CoV2," Director of the Bhubaneswarbased Institute of Life Sciences (ILS) Ajay Parida has indicat-

Around 23 per cent of the faculty members of a research unit here were found to be antibody negative during a recent study after two doses of the

vaccine. "Though the antibody level is 30,000 to 40,000 in some Covid-infected people, it is below 50 in a significant number of vaccinated individuals. If the antibody level is 60 to 100, then we can say the person is antibody positive," he said to a news agency.
The ILS is a part of the

Indian SARS-CoV-2 Genome

Consortium (INSACOG), a network of 28 laboratories across the country equipped to sequence genomes of the coro-

navirus for emerging variants. Further, the antibody level is seen to come down after four to six months in many people, who have been vaccinated with two doses

The booster dose is essential for people having low or negative antibodies despite full vaccination, Parida said. Stating that the efficacy of Covishield and Covaxin is about 70 per cent to 80 per cent, which means around 20 to 30 per cent of the vaccinated population may not develop antibodies, Parida said the clinical study is in its final stage for approval of a booster dose.

Zawahiri surfaces in 9/11 20th anniversary video

Al-Qaida leader Ayman al-Zawahiri appeared in a video marking the 20th anniversary of the September 11, attacks, months after rumours of his death

The SITE Intelligence Group that monitors jehadi websites said the video was released on Saturday. In it, al-Zawahiri said that "Jerusalem will never be Judaised," and praised al-Qaida attacks including one that targeted Russian

troops in Syria in January. SITE said al-Zawahiri also noted the US Military's withdrawal from Afghanistan after 20 years of war. It added that his comments do not necessarily indicate a recent recording, as the withdrawal agreement with the Taliban was



Al-Zawahiri made no mention of the Taliban's takeover of Afghanistan and the capital Kabul last month, SITE added. But he did mention a January 1, attack that targeted Russian troops on the edge of the northern Syrian city

Rumours have spread since

late 2020 that al-Zawahiri had died from illness. Since then, no video or proof of life surfaced, until Saturday.

"He could still be dead. though if so, it would have been at some point in or after January 2021," tweeted Rita Katz, ŚITE's director. Al-Zawahiri's speech was

recorded in a 61-minute, 37second video produced by the group's as-Sahab Media oundation. In recent years, al-Qaida

has faced competition in jihadi circles from its rival, the Islamic State (IS) group. IS rose to prominence by seizing large swaths of Iraq and Syria in 2014, declaring a "caliphate" and extending affiliates to multiple countries across the

Kozhikode crash: A sad tale of pilot in a hurry

The probe report of the Kozhikode plane crash has revealed that the pilot was in a hurry to return to Kozhikode as he had to operate a flight to Doha the next morning.

"There was only one

Captain against 26 First Ófficers on the posted strength at Kozhikode. The pilot was on standby duty the next day but due to the non-availability of Captains at Kozhikode, he was assigned the Doha flight for August 8", the probe report said. According to the report, the events of AXB 1344 crash replicated the Mangalore crash of 2010. "Ten years later, on 7 August, 2020, it was once again a similar tabletop aerodrome, the same airline, the same type of aircraft that landed off an 'unstabilised approach' and touched

down past half the runway and

resulted in another major dis-

The report said that the pilot's actions and decisions were "steered by a misplaced motivation" to land back in Kozhikode to operate a flight to Doha the next morning. The unavailability of a sufficient number of Captains at Kozhikode was the result of Air India Express Limited's (AIXL) faulty human resource policy which does not take into account

operational requirements while assigning a permanent base to its Captains," the report said. These are among the find-

ings of the Aircraft Accident Investigation Bureau (AAIB) report that delved into the accident on August 7 last year when the Boeing 737-800 aircraft overshot the table top runway and fell to a depth of about 110 feet below the runway elevation and broke into three pieces. Two



pilots and 19 passengers, including three infants, lost their lives as the plane coming from Dubai with a total of 190 people on board crashed.

'This last-minute assignment of eighth morning flight to Doha put additional pressure on the pilot in command (PIC) to land back at Kozhikode in time on seventh evening," the report added. Had the flight been diverted, the pilot would have exceeded his Flight Duty Time Limitation and would not have been available for the morning flight.

The probe report also pointed out that due to low visibility and "suboptimal performance" of windshield wiper in the rain, the pilot probably experienced visual illusions causing errors in distance and depth perception.

Noting that in the last ten years, AIXL had two major accidents and a number of nonfatal accident/serious incidents, the AAIB said most of them were a result of continuation of unstabilised approach and total disregard to the repeated calls from the First Officer to "Go Around", both being serious breach of Standard Operating Procedures.

Among other aspects, the probe report has flagged that AIXL did not have provision for child/infant restraint system and they rely solely on lap-held infants without any supplemental restraint. Out of the ten infants on board, three sustained fatal injuries, three had serious injuries and four escaped unhurt. The cockpit voice recorder recording revealed that the pilot carried out an unusually detailed briefing of an experienced flight officer regarding windshield wipers. The transcript points out that the pilot was perhaps apprehensive about

the reliability of the windshield

wiper, the report said.

Over 2,400 dengue cases in MP so far this year: Health official

M ore than 2,400 people were infected by dengue in Madhya Pradesh so far this year and out of them, 95 were currently undergoing treatment in various hospitals of the state, an official said on Sunday.

The admission rate of dengue patients in hospitals was around 20 per cent, MP programme officer (for control of vector-borne diseases) Dr Himanshu Jayswar told PTI.

"More than 2,400 people have been infected by dengue in MP so far since January 1 this year," he

He said the highest number of 800 people were infected by the mosquito-borne disease in Mandsaur district this year and out of them, 150 were admitted to hospitals.

The admission rate of dengue patients in Mandsaur hospitals was 20 per cent, he said.

Jabalpur reported the second highest 325 dengue cases since January 1, the official said, adding that the remaining cases were reported from the state capital Bhopal, industrial hub Indore, Agar Malwa, Ratlam districts and other places.

On deaths caused by dengue, he said four co-morbid patients have so far died due to the mosquito-borne viral infection.

Any person suffering from fever, bodyache, rashes, joint pain or retroorbital pain (behind the eye) should consult a doctor within 24 hours, he added. The

Jabalpur Municipal Corporation, one of the oldest civic bodies of MP, was imposing a fine of Rs 200 on the owners of houses where the larvae of mosquitoes causing dengue were found, another official

As per reports from different parts of MP, medical teams and squads of civic bodies were visiting dengue-prone areas across the state and taking steps to destroy the larvae of such mosquitoes.

Maha logs 3,623 new cases, 46 Covid deaths

n a clear indication of a flattening Covid-19 curve in Maharashtra, the daily Covid-19 deaths dropped below the 50 mark for the third consecutive day on Sunday, while the infections remained well below 5,000 for more than 10 consecutive days.

After it recorded 44 and 35 deaths on Friday and Saturday respectively, Maharashtra logged 46 deaths on Sunday.

Similarly after recording 4,174, 4,219, 4,154 and 3,075 on Wednesday, Thursday, Friday and Saturday respectively, the State registered 3,623 new cases on

There has been a near consistent drop in the number of daily deaths during the past nine days. After the daily deaths dropped to 52 on August 30 (Monday), the daily fatalities remained below 100 mark for five more days during the last eight days -55 deaths on September 2, 92 deaths on September 3, 64 deaths on September 4, 67 deaths on September 5, 37 deaths on September 6, 86 deaths on September 7, 65 deaths on September 8, 55 deaths on September 9, 44 deaths on September 10, 35 deaths on September 11 and 46 deaths on September 12.

With 46 fresh deaths reported on Sunday, the total number of deaths in the state increased from 1,38,096 to 1,38,142, while the total infections -- with 3,623 new cases - went up from 64,94,254 to 6,49,78,77.

As 2,972 patients were discharged from the hospitals across the state after full recovery, the total number of people discharged from the hospitals since the second week of March last year increased from 63,02,816 to 63,05,788. The recovery rate in the State dropped from 97.05 per cent to 97.04 per cent.

The total "active cases" in the State rose from 49,796 to 50,400. The fatality rate in the State stood static at 2.12 per

Pune with 13,018 active cases emerged as the first in the state in terms of maximum number of "active cases" in the state, while Thane with 7,979 cases stood second in the state, followed by Satara (5,637) Ahmednagar (6027) and Mumbai (5,244).

Of the 5,59,79,898 samples sent to various laboratories across the state so far, 64,97,877 have tested positive (11.61 per cent) for Covid-19 until Sunday.

Captain pays tribute to soldiers of historic Saragarhi battle

Minister Amarinder Singh on Sunday paid tributes to the soldiers of the historic Saragarhi battle on its 124th anniversary.

The Chief Minister digitally paid obeisance in Gurdwara Saragarhi during the state-level martyrdom day

In his address, he also recalled the valour of the 22 soldiers of the 36th Sikh stationed near Samana ridge (now in Pakistan), who laid down their lives after a fierce battle following an attack by nearly 10,000 Afghans on September

Giving the background, the Chief Minister said in order to quell the disturbances columns of the then British Indian Army were sent by General Lockhart.

Of these, 36th Sikh comprising 21 Sikh soldiers and a cook, was assigned the task of defending Saragarhi an observation post to ensure that the communication between Fort Lockhart and Fort Gulistan is not disrupted.

"On September 12, 1897 morning, Pathans of Afridi and Orakzai tribes in huge numbers attacked the Saragarhi post. The Pathans demands for surrender were rebuffed strongly by Havaldar Ishar Singh. "Soon the attack ensued, prompting Ishar Singh to send a signal to his superior Colonel

Houghton who asked them to hold positions," said Singh, adding the battle continued till mid-afternoon and every Sikh soldier fired 400-500 rounds of ammunition.

The Chief Minister further said all the efforts to send help to the besieged soldiers were unsuccessful owing to a large number of tribal Pathans.

At last, Sepoy Gurmukh Singh sent the last signal to Colonel Houghton and picked up the gun to fight. None of the soldiers surrendered and all were martyred. The CM further said it is also a matter of pride that the statue of Havaldar Ishar Singh is being unveiled today in Wolverhampton in the

6 temples of different deities in Ram temple's final blueprint

Avodhya (UP): Six temples of different deities will be constructed on the Ram Janmabhoomi temple complex, according to the final blueprint prepared by the Ram temple construction committee.

The construction of the foundation of the Ram temple is in full swing and is expected to be completed by October-end or first week of November, Ram Mandir

According to the final blueprint, six temples of different deities will be constructed in the

Ram Janambhoomi premises. The deities include Lord Surya, Lord Ganesha, Lord Shiva, Lord Durga, Lord Vishnu and Lord Brahma.

These six temples of deities will be build along the outer periphery of the Ram temple but within the premises. Along with worshipping Lord Rama, worshipping these deities is also very important in Hindu dharma, Mishra told PTI.

The construction of the base the Ram temple will start from the end of October or from the first week of November after the completion of the filling of foundation,

For in-situ setting of stones in the structure of the grand temple,



four tower cranes will be installed

The filling of the excavated foundation area of 1,20,000 square feet and 50 feet deep was expected to be completed by the end of October. Now, the temple Trust has decided to construct four additional layers on the founda-

tion area to bring the foundation to 107 meters above the sea level. he said. Earlier, in the foundation where 44 layers of engineered fill material was to be used, has now been increased to 48 layers, the Ram Mandir Trust member said. According to sources, after the completion of the foundation filling, the casting of the sevenfoot raft will be done again. This in which cement will also be used. So far, cement was not being used in engineered field material, but stone dust and fly ash was being used.

According Janmabhoomi Trust General Secretary Champat Rai, cement absorbs more heat, which will increase the heat in the atmosphere. To avoid this, minimum use of cement is being done.

The plinth of the super structure of the Ram temple is to be constructed with the 3.5 lakh cubic feet stones from Uttar Pradesh's Mirzapur, contract for the cutting and setting of the Mirzapur-based private firms, he

government as a measure to permanently solve the refugee status of the commu-

Thousands of the Bru tribal people have been living in relief camps in Tripura since 1997. Stating that the fall of Kabul to the Taliban last month may have a "serious bearing" on the security situation in India, the ground forces and their intelligence setup have been asked to update both their strategy, tactics and combat syllabus on the new "geo-political situation in central and south Asia and its grave security implication on India's borders and the hinterland."

The directive issued by the security establishment a few days back also envisages a scenario where infiltration from across the border from Pakistan on India's west and illegal entry of terrorist operatives from open fronts in the east may increase including that by foreign terrorist fighters.

Officials in the central security forces and intelligence wings acknowledged the new developments that have taken place in the neighbourhood after the Taliban swiftly took over almost all provinces of Afghanistan last month following the US military retreating from their 20-year war in that country launched after the 9/11 terror attacks in 2001 in their country.
A senior officer told *PTI*

that the existing training module of border guarding forces

like the BSF and SSB, state police units and those involved in counter-terrorist duties like the CRPF and Jammu and Kashmir Police have an existing title "changing dynamics of border management".
"This included informa-

tion on the Taliban as well but it was not updated. That is being added through opensource authentic information and others available in a classified manner to us and the focus is the developments of the last twenty years that took place in the aftermath of the 9/11 attacks," the officer said. "Senior and top commanders of the security forces may know most of the things about Afghanistan and Taliban situation but they draw their operational strength from the troops or the constable standing on the ground. "These real-world data show that vaccines remain highly effective at reducing Covid-19 related hospitalisation and emergency department visits, even in the presence of the new Covid-19 variant," said researcher Shaun Grannis from Indiana University in the US, as per the news report.

For the study, the team analysed more than 32,000 medical encounters from nine States during June, July, and August this year, when the Delta variant became the predominant strain.

The third study which looked at the effectiveness of Pfizer-BioNTech and Moderna found that the mRNA vaccines were 87 per cent effective in preventing hospitalisations and remained highly effective even during Delta's predominance. Vaccine effectiveness in preventing Covid-related hospitalisation dropped to 80 per cent among adults aged above 65 years compared with 95 per cent among those aged between 18 and 64 years.

Based on the outcome of the clinical trial, the ICMR may approve the booster dose. NEW DELHI: The national Capital has reported 22 new cases and zero fatalities due to Covid-19 on Sunday while the positivity stands at 0.04 per cent, according to the health bulletin issued by the Delhi Government.

61,968 tests were conducted a day ago to detect COVID-19. It included 47,028 were RTPCR, CBNAAT and TrueNat tests while 14, 940 were rapid-antigen tests. 44 patients were discharged in a day. Inter-State drug syndicate busted, 3 held, heroin worth ₹2 cr seized

NEW DELHI: With the arrest of three men, the Crime Branch of Delhi Police has busted an inter-State syndicate of drugs involved in supplying heroin in the national Capital. Police said that a total of 1.1 kilogram of fine quality heroin worth over ₹ 2 crore in international market has been recovered from the possession of the accused.

The accused have been identified as Hukam Chand (45) and Rohit (32), both residents of Sultanpuri and Shahid Khan (58), a resident of Bareilly district in Uttar Pradesh (UP).

"During interrogation, Chand disclosed that he procured the heroin from Rohit. Later, on August 18, Rohit was apprehended from Sultanpuri area. His car was seized and 100 grams of heroin was also recovered from it," said the DCP.





Threat to India from Af-Pak terror groups real, imminent

The threat to India from the I terror groups from Afghanistan-Pakistan region like the Haqqani Network and Islamic State Khorasan Province is real and imminent. The Haqqani Network, a project of Pakistan's Inter-Services Intelligence (ISI), has ostensibly made inroads into the Islamic seminaries in the country in an apparent bid to attract gullible youth to join its fold for taking forward Islamist agenda in the subcontinent.

According to a video recording of the seminar, Hamid-ul Haque Haqqani, a radical scholar and Vice Chancellor of Darul Uloom Haqqania, Akora Khattak, Khyber Pakhtunkhwa, Pakistan addressed an online conference at Darul Uloom Deoband, Saharanpur in Uttar Pradesh on December 7 last year as part of a three-day conclave that began on December 6, 2020, the anniversary of the demolition of the erstwhile Ramjanmbhoomi-Babri Masjid

Hamid-ul Haque Haqqani is also the Chairman of the Difa-e-Pakistan Council of which Lashkar-e-Tayabba chief Hafiz Sayeed is a founder chairman. Haggani is the son of Sami-ul Haq who is considered the Father of Taliban. After his father's assassination, Haqqani also became chairman of Jamiat Ulema-e-Islam, Pakistan.

The clamour for supporting the Taliban regime from a cross-section of individuals of a particular community and Muslim clerics giving call to segregate education for girls and boys in line with the Talibani exhortations could be an outcome of the outreach by the Haqqani Network.

Darul Uloom Haqqania is the alma mater of top global terrorists of the world. The Darul Uloom Haqqania, also referred to as Haqqania University, has the notorious distinction of producing several global terrorists like the founder of Taliban, Mullah Omar, Lashkar-e-Tayabba chief Hafiz Sayeed and Jaish-e-Mohammad boss Masood Azhar among others. Mullah



Mohammad Yakoob is the Defence Minister of Afghanistan under the current Taliban regime in Kabul.

The main campus radicalizes an estimated 4,000 students every year. The seminary has 10 campuses in the Af-Pak

The online address by Haqqani was facilitated by the

vice chancellor of Darul Uloom Deoband, Saharanpur, Arshad Madani is also the President of the Arshad faction of the Jamiat Ulema-e-Hind, an outfit of Muslim clerics, since the split of the parent organization in 2008.

Post-takeover Afghanistan by Taliban last month, Madani gave a call for segregating education for girls

and boys including by non-Muslims in order to propagate the Talibani ideology. Following his call and Taliban's ascent in Kabul last month, a number of leaders from several States exhorted recognition of the Taliban regime. Their direct or indirect linkages to the Haqqani Network could not be

The Haqqania seminary's

outreach is part of terror group Al Qaeda's project Barre Sagheer (subcontinent) movement for radicalisation of the countries in the region like Afghanistan, Pakistan, Bangladesh and India for further expansion of Islam in these countries and push radicalisation. The movement was aimed at identifying seminaries and winning over clerics, especially in India who could exhort the Centre to recognize the Taliban regime following withdrawal of the US forces.

Counter-Terrorism Expert Dr Rituraj Mate said, "The Haqqani Network being a designated terror group by both the UN and the US has no business to engage its terror seminary with any Indian educational institutions, including the Darul Uloom Deoband."

The Haqqani Network has

been seeking to get Indian Muslim clerics on board for its Barre Sagheeer project for over nine months. In January this year, ADG (Law and Order) Prashant Kumar had denied Haqqani's activities in the State. The Barre Sagheer move-

from Afghanistan sooner or later. The movement's objective was to identify like minded outfits of clerics and bring them under one umbrella to ramp up radicalization and subsequently create Taliban-like movements in the South Asian region, initially through overground sympathisers. The other objective was to elicit a united voice of these outfits of clerics to express solidarity with Taliban in getting international recognition after the exit of the US and allied forces from Afghanistan.

While Hamid ul Haque Haqqani addressed the students of Darool Uloom Deoband, the authorities in the State and the Centre could not take cognizance of the nefarious interaction between the Deoband seminary and the jihadi Haqqania University of Pakistan as an enquiry into the linkages was never initiated.

Inadvertently, a section of the media also played into the hands of the Haqqani conspiracy by hyping up the propaga-tion of the hardline Islamist world view of separate educa-tion for boys and girls through the exhortations by clerics like Madani on certain television news channels following the

Taliban onsalught in Kabul.

Germany-based counterterrorism expert of Afghan origin Ajmal Ŝohail said, "The Haqqani Network had influenced the educational institutions in Afghanistan in a similar manner by radicalizing the students in large numbers before the swift takeover of Kabul by Taliban on August 15 amid the US troops' withdrawal that was ongoing then."

Response from Director General of Police, Uttar Pradesh, Mukul Goel and ADG (Law and Order), Prashant Kumar could not be elicited despite messages.

Air courier service for ferrying paramilitary personnel resumes

The Union Home Ministry has resumed the air courier service for ferrying the paramilitary personnel proceeding on leave or joining duties in Jammu and Kashmir as also the

The services were discontinued from September 1 following non-receipt of approval Ministry. The air courier service was initiated after the Pulwama terror attack.

The Ministry accorded approval for seven months from September 1 till March 31

"İt is requested to resume air courier service on all approved routes of NE (Northeast) and J&K Sectors w.e.f. from 16th Sept 2021as per scheduled days and time. A confirmation may please be communicated to this HQr," reads a communication titled "Resuming of Air Courier Service for CAPFs personnel" issued on Friday by the BSF to Senior Manager (Commercial), Marketing planning of Air

On February 21, 2019, the Ministry had allowed extension of air travel in respect of nonentitled personnel of CAPFs, AR (Assam Rifles) and NSG deployed in the Kashmir Valley



to travel by air. The order allowed the facility of air travel to the jawans and other rank officers who were otherwise not entitled to travel by air.

The order came following deadly terror attack on a CRPF convoy on February 14, 2019 in Pulwama which took a toll of 40 paramilitary lives. The terror attack by Pakistan-based Jaish-e-Mohammad (JeM) had led the Indian Air Force to carry out an aerial raid at Balakot's jehad factory of the

The CAPFs include Assam Rifles, Border Security Force (BSF), Central Reserve Police Force (CRPF), Central (CISF), Indo-Tibetan Border

Police (ITBP), Sashastra Seema Bal (SSB) and National Security Guards (NSG).

Apart from being safe, the air courier service for the jawans and other non-gazetted officers of the paramilitary forces significantly cuts down on the travel time on both the routes-from Jammu to Srinagar and back and from Jammu to Delhi and back.

The air courier facility is available from Jammu to Srinagar and back on official (on termination/commencement at base point at Jammu). The service is also available from Delhi to Srinagar Industrial Security Force and back on official duty

The Court has also to consider the likelihood of the applicant interfering with the witnesses for the prosecution or otherwise polluting the process of "It is further observed that

it is rational to enquire into the antecedents of the man who is applying for bail to find out whether he has a bad record, particularly a record which suggests that he is likely to commit serious offences while on bail," the bench said.

The top court said that while granting of bail, the factors among other circum-stances which are required to be considered are -- the nature of accusation, the severity of punishment in case of conviction and the nature of supporting evidence, reasonable apprehension of tampering with the witness or the apprehension of threat to the complainant; and prima facie satisfaction of the court in support of the charge.

SC to hear pleas seeking independent probe into Pegasus row

The Supreme Court is scheduled to hear on Monday a batch of pleas seeking an independent probe into the alleged snooping on certain people in India involving Israeli spyware Pegasus.

A three-judge Bench headed by Chief Justice NV Ramana had on September 7 had granted more time to the Centre to decide on filing a further response on the petitions after Solicitor General Tushar Mehta said that due to some difficulties he could not meet the officials concerned to take a decision on the filing of the second

The Centre had earlier filed a limited affidavit in the apex court saying the pleas seeking an independent probe into the Pegasus snooping allegations are based on "conjectures and surmises or on other unsubstantiated media reports or incomplete or uncorroborated material"

On August 17, the top court had issued notice to the Centre on the pleas, making it clear that it did not want the Government to disclose anything which compromises national security.

In its short affidavit filed in the court earlier, the Centre had

said the position on the issue has already been clarified in Parliament by Information Technology Minister Ashwini Vaishnaw.

With a view of dispelling any wrong narrative spread by certain vested interests and examining the issues raised, the committee of experts, it had said. The top court, while issuing notice on the pleas, had said that it did not want the government to disclose anything related to the national security and had asked the Centre what is the "problem" if the competent authority files an affidavit before it on the issue.

"Our considered response is what we have respectfully stated in our last affidavit. Kindly examine the issue from our point of view as our affidavit is sufficient," the law officer had told the bench, adding, "The Government of India is before the highest

Covid jabs can reduce anxiety too

here's yet another reason to **1** take the Covid-19 shots. If the Covid pandemic has affected mental health, researchers have indicated that the vaccines meant to kill the infection can also bring down anxiety and boost mental health. In other words, reducing risk of death and hospitalisation from infectious disease is not the only benefit of vaccination.

A team of researchers at the University of Southern California has found evidence suggesting that people who were vaccinated against Covid-19 experienced less stress afterward and saw resulting improvement in their mental

They found that people



cent reduction in the likelihood of feeling just mildly depressed.

The team estimates that based on their data, it is likely that one million people have felt reductions in mental distress after being vaccinated. The findings are published in

The researchers further

suggest that their data indicates that getting vaccinated against Covid-19 does more than just protect people from infection it also greatly reduces the fear and anxiety people feel about their likelihood of being

For the study, the team sent

out more than 8,000 surveys to people across the country with questions geared toward gauging how the pandemic was impacting the mental health of people in general and impacts on their mental health after receiving a Covid-19 vaccination. Data from the surveys showed that the majority of people queried have been experiencing some degree of anxiety and depression as a result of the pandemic. In yet another study that

appeared in Psychiatry Research Trusted Source last October, a team of researchers outlined the characteristics of Covid-19 anxiety syndrome, naming avoidance, compulsive symptom-checking, worrying, and threat monitoring (combined)

India's Covid-19 vax coverage surpasses 73.82 cr

With the administration of 72,86,883 vaccine doses in the last 24 hours, the country's Covid-19 vaccination coverage surpassed the cumulative figure of 73.82 crore as per provisional reports till 7 am on

In the meantime, the country on Sunday reported a gradual decline in daily Covid-19 cases with 28,591 infections recorded in the past 24 hours, which pushed the nationwide tally to 33,236,921, while the death toll climbed to 442,655 with 338 fresh fatalities.

According to the Union Health Ministry, active cases are at 6,595 to stand at 384,921 during the same period. Active cases constitute 1.18% of total



cases while the national Covid-19 recovery rate stands 97.6%, the Ministry said. Kerala accounted for the highest followed Maharashtra. Currently, Kerala

has a total of 2,38,201 active cases while Maharashtra has 49,796. Other states, such as Uttar Pradesh, Gujarat, Madhya Pradesh, Rajasthan have also seen improvement in

'Sena will contest in UP, Goa'

In its intent to take on its erstwhile saf-fron alliance partner and current bitter rival BJP electorally, the Shiv Sena on Sunday announced that it would contest "80 to 90" seats in Uttar Pradesh and 20 seats in Goa in the 2022 State Assembly elections in the two

After Shiv Sena's Uttar Pradesh unit president Thakur Anil Singh went to town saying that his party would contest 403 seats in the northern state to "teach a lesson" to the BJP, Sena's chief 🔖 spokesperson and MP Sanjay Raut made a formal announcement that his party would put up candidates in "80 to 90" constituencies in the UP Assembly elections to be held in early

"We are in talks with several organisations and parties to cobble electoral alliances. Some farmers organizations in Uttar Pradesh have told us that if the Sena contests the polls, they would support us. Even some small parties have offered to support... We intend to contest anywhere from 80 to 90 seats in Uttar Pradesh," Raut said.

Alluding to the Sena's plans in Goa, Raut said: "Like in Maharashtra, we are planning to experiment the Maha Vikas Aghadi (an alliance comprising Shiv Sena, NCP and Congress) in the forthcoming Assembly elections in Goa. As of now, I cannot talk much



about it. Talks are on among the MVA constituents. You will get to know more about it in the coming days. As Shiv Sena, we intend to contest 20 seats

Earlier, in a statement issued after the meeting party's office bearers, UP Shiv Sena Secretary Vishwajeet Singh said that the Sena - in its effort to "teach a lesson" to BJP -- would contest "almost all the seats" in Uttar Pradesh in the forthcoming Assembly elec-

"Jungle Raj has prevailed under Chief Minister Yogi Adityanath during the past four-and-half years. Law and order has broken down in the state. Sisters and daughters are not safe in the

"The Yogi Government is indulging in harassment against the Brahmin

community," UP Sena chief Anil Sinha said. "There is no medical infrastructure in the state to fight Covid-19. New vocation in the state is to burn the bodies of the people who die of Covid-19. Even after the Supreme Court verdict, the Yogi government has not announced 15 fees cut in schools. Fee is being collected from students even in schools which are closed due to Covid-19,"

'The people are suffering because of rampant unemployment and price rise. The Yogi government is meting out a step-motherly treatment to farmers and Youngsters," Sinha added.

This is not for the first time that the Shiv Sena, a regional party that came into existence way back in 1966, is contesting the State Assembly polls outside Maharashtra. In the past, the Sena had contested the State Assembly polls in states like Goa, Karnataka, Delhi,

Bihar, West Bengal and Jammu & Kashmir. However, its electoral performance in all these states was

Given that the Congress' General Secretary Priyanka Gandhi has gone on record saying that it was open to having electoral tie-ups with like-minded parties in Uttar Pradesh, there is strong possibility that the Sonia Gandhi-led party and the Sena will have a seat-sharing arrangement for the Assembly polls in the northern State.

TMC criticises UP Govt for using pic of Kolkata flyover in its advertisement

Uttar Pradesh Government's advertisement carrying a purported image of a Kolkata flyover to drive home its development initiatives has created major controversy with the Trinamool Congress on Sunday lashing out at the Yogi Adityanath Government for "acting like a Thagi (trickster) and not like a "yogi" (saint) by hoodwinking the people of that State with false publicity in order to win elections.

Reacting to the incident TMC national general secretary Abhishek Banerjee --- who is currently facing the Enforcement Directorate heat in a money-laundering case --- promptly wrote "Transforming UP for ... Yogi Adityanath means stealing images from infrastructure seen in Bengal under Mamata (Banerjee's) leadership and using them as his own! Looks like the DOUBLE ENGINE MODEL' has MISERABLY FAILED in BJP's strongest state and now stands EXPOSED for all!."

Senior Trinamool MP Derek O Brien congratulated the UP Chief Minister for "finally acknowledging the good works being carried out by our Chief Minister Mamata Banerjee."

Heaping more sarcasm he said 'Yogi ji can take more of such advertisements from Bengal," adding "while Mamata Banerjee has constructed 5,100 km or rural roads as compared to UP's 1680 km." He further listed the alleged low corruption data of Bengal saying "while Bengal registers only 0.2 percent of the corruption all over India Yogi ji's UP accounts for 3.2 percent of the national average.

Similarly while Bengal had created 97,000 work days for the members of Scheduled Caste the figure for UP is 67,000 work days he said adding "while UP has 57,000 hospital beds, Bengal has 86,000," and calling upon the UP Chief Minister "to take away all these advertisements of Bengal to hoodwink the people of his State."

TMC national vice president Mukul Roy who left the BJP to return to his old party after the State elections wrote "Mr Narendra Modi is so helpless to save his party that other than changing CMs, he has also had to resort to using pictures of growth & infrastructure seen under Mamata Banerjee's leadership, as his own." Curiously the CPI(M) leadership promptly jumped in to clarify that theadvertisements shown "neither belongs to the socalled developmentprojects of Yogi or Mamata Banerjee ... one RTI and government records will show that these projects belong to the Left era ... Mamata Banerjee only named them."

The national newspaper which carried the advertisement however issued an immediate corrigendum regretting the inadvertently included cover collage of the advertorial. "A wrong image was inadvertently included in the cover collage of the advertorial on Uttar Pradesh produced by the marketing department of the newspaper," it wrote.

When reminded of the corrigendum being issued by the said newspaper senior TMC leader Arup Chakrabarty alleged "the newspaper must have been coerced by the BJP to accept the said mistake ... otherwise it would have to face the same fate of Dainik Bhaskar."

He said apart from non-performance the BJP had been coercing the entire media of the country into silence. "Unprecedented and undeclared media censorship is going on in Bengal ... look at how the newspapers in Tripura are being shut down just because they are highlighting the attacks on the TMC and Abhishek Banerjee in that State."

'Love, narcotics Jihad to destroy Hindus, Christians'

KOCHI: The statement by Mar Joseph Kallarangatt, the Bishop of Palai, warning the laity, especially the Christian youth, against Love Jihad and Narcotics Jihad has embarrassed the ruling CPI(M) and the Opposition Congress alike in Kerala.

The Bishop, while addressing a religious congregation at the famous Marth Mariam Archdeacon Pilgrim Church at Kuravilangadu in Kottayam district on Wednesday came down heavily on Love Jiahd and Narcotics Jihad which he described as the new modus operandi employed by a section of the Islamic community in the State to destroy the Hindu and Christian religions and families. He said Lok Nath Behra, the then Chief of Kerala Police, had warned the authorities how Kerala was being used by terrorists to recruit jihadi fighters for the establishment of an Islamic republic.

Though the Bishop spoke at length about Love Jihad and Narcotics Jihad in his address, even Deepika, the mouthpiece of the Catholic Church had ignored the report. It was Janmabhumi, the organ of the BJP which highlighted the speech which has led to a furor

Chief Minister Pinarayi Vijayan, in his televised press meet, lambasted the Bishop and feigned ignorance about the term Narcotics Jihad. "I am hearing it for the first time. Perhaps, the Bishop may be asked to explain what he meant by it," Vijayan had said.

V D Satheesan, leader of the Opposition, criticized the Bishop for making irresponsible allegations. Many Islamist organisations went to the extend of demanding the arrest of the Bishop for his attempts to create rift between the minority communities. 

The amendment Bill may contain provisions on separation of NPS Trust from PFRDA, hike in foreign direct investment (FDI) limit for the pension sector to 74 per cent from the existing 49 per cent, among others, sources said.

In March, Parliament approved a Bill to increase FDI limit in the insurance sector from 49 per cent to 74 per cent. The Insurance Act, 1938 was last amended in 2015 which raised FDI limit to 49 per cent, resulting in foreign capital inflow of

Cabinet may take up amendments to PFRDA Act soon ₹26,000 crore in the last 5 years.

With the amendment, sources said, powers, functions and duties of NPS Trust, which are currently laid down under PFRDA (National Pension System Trust) Regulations 2015, may come under a charitable Trust or the Companies Act.

The intent behind this is to keep NPS Trust separate from the pension regulator and managed competent board of 15 members. Out of this, the majority of members are likely to be from the government as they, including states, are the biggest contributor to the corpus.

Finance Minister Nirmala Sitharaman had announced to separate NPS Trust from PFRDA with appropriate organisational structure, keeping in view the wider interest of the subscribers and to

maintain arm's length relationship of NPS Trust with the regulator.

The Trust was established by PFRDA for taking care of the assets and funds under NPS. The proposal to separate the two job roles has been under consideration for the last

PFRDA was established for promoting and ensuring the orderly growth of the pension sector with sufficient powers over pension funds, the central record keeping agency and other intermediaries. It also safeguards the interest of members.

The National Pension System (NPS) was introduced by the government to replace the defined benefit pension system. NPS was made mandatory for all new recruits to the central government service from January 1, 2004, (except the armed

forces in the first stage) and has also been rolled out for all citizens with effect from May 1, 2009, on volun-The Government had made a

conscious move to shift from the defined benefit, pay-as-you-go pension scheme to defined contribution pension scheme, NPS, due to rising and unsustainable pension bill.

The transition is aimed at freeing the limited resources of the government for more productive and socio-economic sectoral develop-

PFRDA, which runs two flagship schemes NPS and Atal Pension Yojana (APY) under its fold, is targeting to reach an AUM (asset under management) of ₹7.5 lakh crore by the end of the current fiscal year.

7L Maha farmers inform insurance firms about crop damages

Mumbai: More than seven lakh farmers in Maharashtra have called up insurance companies during the current monsoon season to inform about crop damage due to excessive rainfall, officials said.

Representatives of crop insurance companies need to personally visit the farms and assess the damages, and based on their report, the farmers will get the insurance amount, they

"A total of 2,56,985 were received till August 1 from farmers across Maharashtra intimating about extremely heavy rains that led to damage of crops. The number of such calls increased to 4,15,747 by September 1 and reached 5,53,491 on September 9. In last two days, the number of such calls reached over seven lakh," state agricultural commissionerate's chief statistical officer Vinaykumar Awate told PTI.

The figures could increase further as the data of calls made during the weekend will be updated in the system on Monday, the official said.

Besides crop damage, the farmers also informed about washing away of their farm soil, damages caused to cattle sheds and other issues, he said. The number of such calls

from farmers jumped drastically after heavy rains lashed the state's Marathwada region last week, he said. To a query, the official said.

"We held a meeting with officials of the Union Government last week and discussed the issue. The central govern-ment has increased its technical support to help us accept more number of such calls in the wake of the excessive downpour in the Marathwada region and north Maharashtra."

He said earlier, there were glitches in the system as the

rise in the number of such calls from farmers would clog the phone lines or servers would be down. "But, with the help of the Union Government, we have managed to address these issues. Apart from phone calls, other options are also available which farmers can use to register their names with the insurance companies for damage survey," he added.

Since the introduction of the crop insurance scheme for farmers, it is necessary for the insurers to record every such call from cultivators. Farmers can call up a num-

ber given by the insurance company, send an e-mail or call up the local revenue officer to inform about the crop damage. They can also inform their local bank branch, which further updates about their intimation call on the common portal to the state agriculture

IIFT moves up one place to 25th in NIRF ranking

New Delhi: The commerce Ministry's Indian Institute of Foreign Trade (IIFT) has moved up one place to 25th rank under management category, in NIRF ranking 2021.

The ranking under National Institutional Ranking Framework (NIRF) was released by Union Education Minister Dharmendra Pradhan recently.

In the last year's ranking, IIFT had climbed five places to 26th spot from 31st in 2019. It was at 23rd rank in 2018, 30th in 2017 and 81st in 2016. NIRF was launched in 2015

The accused, Mohan Chouhan (45), hailing from Jaunpur in Uttar Pradesh, worked as a driver and lived on the pavement in the same area. He was identified with the help of CCTV footage of the area and traced within a few hours of the incident. Mumbai Police Commissioner Hemant Nagrale earlier told reporters that the crime came to light when the watchman of a company located on Khairani Road in Sakinaka called the police control room and said a man was seen thrashing a woman.

Police reached the spot within 10 minutes and found the victim inside a parked tempo. As her condition was serious, they decided to take her to hospital in the same vehicle so as to save time. They got the key of the tempo from the watchman and drove her to Rajawadi hospital in suburban Ghatkopar, the official had

Maharashtra Chief Minister Uddhav Thackeray had termed the incident as a "blot on humanity", and ordered that a charge sheet in the case must be filed within a month. He had also directed that measures should be taken to

make the city safer for women.

'No' means 'no'

Another shame, as 'Mumbai's Nirbhaya' case, is showing our society the filthy mirror

ocial progress in any society can be measured by how many men stop when a woman says no. Doing the measuring in India is problematic. It is a sickening Sunday, the newspapers full of news of rape. A man in his 30s allegedly raped a mentally challenged girl in Maharashtra's Palghar. A 45-year-old was sentenced to life imprisonment for raping a seven-year-old in Hamirpur in Uttar Pradesh. The body of a young national level kho-kho player was found dumped in Bijnor, also in UP, her face bruised, clothes pulled down. Her family claims that she was raped. And in India's financial capital of Mumbai, a 'Nirbhaya' was enacted by a depraved man. He allegedly raped a mother of two and brutalised her with a rod afterward. She died, unable to even give a dying statement. Since the infamous 'Nirbhaya' rape case in Delhi of 2012, the police and political machin-



ery are quick to initiate action for fear of people's anger. It is a different matter that for every rape case in which arrests are made, there could be several that would have been ignored or sought to be hushed up. The issue at hand is not about the filing of FIRs, arrest of the accused and taking the case to trial. It is about the mindset. Minal Arora's lawyer Deepak Sehgal tells the court in the film, Pink: "The single word, no, is a complete sentence in itself." What nobody seems to explain is why it is so difficult to understand that sentence then.

The rapists of 'Nirbhaya' were hanged to death. The fear of capital punishment does not seem to have acted as a deterrent. Instances of rape have not reduced since 'Nirbhaya'. A high degree of perversion leaves its signature in most sexual assault cases. Cases of post-rape violence on the victim are becoming common. Rape, these days, inevitably leads to murder. It is not just about the rapist killing the victim because he wants to remain unidentified. There is an element of depravity that is being exhibited more and more, with the victims' private parts horribly attacked after the initial violation. That indicates the work of a deranged man who seeks more than sexual gratification in a woman. Society and the constitutional bodies need to wake up. Probes, committees and candlelight vigils are not going to work. We, as a people, have to debate our growing insensitivity to how women are treated. Even the judiciary is not exempt from this affliction. The order of the Nagpur Bench of the Bombay High Court is still fresh in everybody's mind, that a man groping the breast of a child does not prove his sexual intent unless there is a "skin-to-skin contact". Such orders disillusion victims who know that they can be denied justice if they fail to meet bizarre conditions. Our society will progress the day a man can tell a woman he will stop if she says no.

New leader

Months ahead of the Gujarat polls, the BJP has chosen to rope in a new Chief Minister

n a surprise move, Gujarat Chief Minister Vijay Rupani has resigned, saying that his resignation is in line with the BJP's policy of giving equal opportunity to all workers. The installation of Bhupendra Patel as the new CM unfolds a new chapter in the politics of Gujarat, which is to go to polls in about 15 months. The resignation, though unexpected, was perhaps on the cards as rumours of Rupani's impending resigna-



tion were floating even in June when Hardik Patel had hinted that the CM may be shown the door. That time, however, the rumours proved to be just that and there was no change of guard in the State. However, three months on, the party has replaced Rupani with Patel as the new Chief Minister ahead of the Assembly elections. There is substance to Hardik's jab that if the party was happy with Rupani's work, why did it feel the need to replace him? He further alleged that the BJP does not have faith in its Chief Ministers. Now, that is largely true if we look at the pan-India picture. Rupani is the fourth BJP Chief Minister to step down in recent

months. BS Yediyurappa resigned as the Karnataka CM in July and, in Uttarakhand,

Tirath Singh Rawat quit four months after replacing Trivendra Rawat.

Rupani had succeeded Anandiben Patel on August 7, 2016, when she was asked to step down. He continued as the Chief Minister after the BJP's win in the 2017 State elections. Though he has categorically denied that he had any differences with State BJP president CR Paatil, there is bound to be some reason behind the resignation. His performance as the Chief Minister was not topnotch while handling the COVID crisis. Rupani comes from the Jain community, which is insignificant from an election perspective. Moreover, people's unease over the COVID mismanagement, industrial slowdown leading to unemployment and price rise, and the Opposition parties getting space could also be reasons for the soft-spoken Rupani's departure, who was often dominated by the bureaucracy. Speculation was rife that his successor would be a Patidar, which has rung true. Besides, Patel — a first-time MLA from Ghatlodiya who holds a diploma in civil engineering — is considered close to Anandiben. All eyes would now be on the new Chief Minister, who would be the BJP's face and steer the party in the elections.

t is extraordinary that the security and intelligence representatives of the US, Russia and Great Britain had to arrive in New Delhi simultaneously last week and possibly had joint meetings. The gentlemen concerned are CIA chief William Burns, Nikolai Patrushev of the KGB and Richard Moore of Britain's M16. India's National Security Advisor (NSA) Ajit Doval was

Such a meeting was unprecedented and indicates how seriously these powers have reacted to the Afghan crisis. To add to it all, China has announced an aid package of \$31 million to the new regime in Kabul, thus declaring whose side it is on, whether terrorists or otherwise.

One wonders how an associate of terrorist States and a member of the United Nations and, that too, a permanent member of its Security Council is being allowed to get away with such behaviour. On the one hand, the US and the UK publicly condemn terrorism and, on the other, sit with China on the same Security Council. By doing so, are they not legitimising terrorism? Was the recent Delhi mega meet arranged in order to persuade India on any reasonable terms to join the coalition to keep the Chinese out of Afghanistan? If at all New Delhi happens to be thinking along these lines, it must recall that Britain failed three times in the 19th century to defeat Afghanistan. Russia, then the Soviet Union, fought for nine years to dominate Afghanistan through proxies backed by its own soldiers. Russia's Afghan adventure was an undiluted failure.

Thereafter, the US took its turn, not once but twice. Both times, it has had to retreat with its tail between its legs. A few American GIs are still in the Afghan theatre. Incidentally, going further back into history, Mughal Emperors Shah Jahan and Aurangzeb had bitter experiences in Afghanistan. Prior to them. Akbar the Great did manage to subdue Afghanistan. The moral of this history is to think, think and think before commit-

ting Indian soldiers on the same soil. It is true that Afghanistan owes a great deal to India; the debt began with Mahmud of Ghazni, Shahbuddin Ghori and subsequently Ahmed Shah Abdali. In fact, to say something unusual, the era of the use of foot soldiers to conquer territory is over. The infantry is needed to hold territory after it is captured. This is the era of aircraft, missiles and drones.

If people desire to flee Afghanistan, Pakistan would be the first country they would turn to. The next would perhaps be India, either through the Kashmir Valley or the deserts of Rajasthan through the Jaisalmer area; it still remains unfenced. The trust of this submission is that New Delhi must make sure that Pakistan does not become the Bangladesh of yesterday, teeming with infiltrators.

America's latest concern would be Afghanistan's enormous mineral wealth, which still lies untapped. Washington would hate to see it simply fall into the lap of China. For its part, Russia too would not like China to grow more dominant. Any Chinese ascendancy in Afghanistan would mean a bigger shadow of the dragon in Central Asia, whose borders touch Russia's

The elephant in the room is Recep Érdogan's Turkey, which has spontaneously got interested in Afghanistan. Erdogan has no money to spend, but makes up for it by the enormity of his ambition. The seat of the Caliph of Islam has been considered vacant since Mustafa Kemal Pasha, the Ataturk, abolished the Caliphate in 1924, and exiled its last incumbent. Occupying this seat would make Erdogan the leader of all Sunni Muslims in the world, spiritual as well as temporal. He has not hesitated to jostle with the King of Saudi Arabia to demonstrate that he is more Islamic than the Arabs.

Another reason for Erdogan to get involved in Afghanistan and to flirt with Pakistan is to possibly obtain a few of the latter's nuclear weapons so that, if the need arises, he could blackmail either Russia or Europe, or both. Erdogan has been harbouring Ottomanesque ambitions for long. Under him, Turkey has all but abandoned its quest to become a European country. Quite to the contrary, its long-practised secularism now seems in danger of being washed away in the rising tide of neo-Islamism. Such a neo-

Ottomanesque acquiring nuclear weapons will undoubtedly be a nightmare for Europe and the whole world. The silent equations being pursued with Delhi could be a pointer.

Hitherto, there was no great relationship between Turkey and Afghanistan. Erdogan and his predecessors had maintained Turkey in such a manner that it was part of Europe. In fact, Kemal Ataturk had consistently felt that the future of Turkey lay in Europe. He asked his people to dress up like Europeans and follow the European way of life. He converted the alphabet of the Turkish language from the Arabic script to Roman in three months, also having the Quran written in Turkish. Ataturk was undoubtedly a visionary.

This visionary plan has been disturbed due to the outbreak of the 'Fourth World War' between Islamic jihad and five continents. In other words, Islamic terrorism has made Turkey unwelcome in Europe and, hence, its new endeavour is to spread tentacles in Central and South Asia.





FIRST COLUMN SCOLIOSIS: A LOUSY PANDEMIC FALLOUT

PARIDHI **OJHA**ack pain is a well-known source of discomfort in adults, but it is also being diagnosed more frequently in children lescents. Most recommendations of the contraction of lescents. Most parents donot expect otherwise healthy children to complain of back pain-a problem generally associated with middle age or later. However, studies have found back pain occurs in between 14 per cent and 24 per cent of children and adolescents.

Prolonged sitting in front of computers due to pandemic-forced online learning is likely to further stress and cause musculoskeletal changes in the body. Some reasons why back pain may be common in kids include higher average body weight, obesity, intensebut infrequent sporting activities, and crucially, increased screen time,

Determining the severity of back problems remains a challenge, especially whether a pain requires medical attention or is just a simple strain, and knowing when expensive specialised imaging tests might be helpful. There are warning signs to look out for, to aid in under-



standing whether a back pain problem in an adolescent may be more serious. While poor posture or muscle strains can lead to prolonged pain, at the simplest level, if any pain lasts for more than a few days or gets progressively worse, then it is imperative to seek medical counsel.

Scoliosis is a deformity of the backbone (spine). Scoliosis refers to a condition where the spine has a side-to-side curve, and the curve of the spine measures 10 degrees or more. A normal spine appears straight when looked at from behind. But a child with scoliosis has a spine with an S or C shape. The child may thus look like he or she is leaning to one side. The curve can happen on the right or left side of the spine. Or it can happen on both sides in different sections. Both the middle (thoracic) and lower (lumbar) spine may be affected.

Scoliosis usually causes no pain, so symptoms can often go unnoticed. Parents or caregivers should watch for the following signs in their child: uneven shoulders, constant leaning to one side, uneven leg length, prominent shoulder blade(s), an uneven waist, or elevated hips.

A majority of children with back pain have symptoms that result from muscle or ligament injury, without any structural abnormality. Some of the back pain warning signs to look out for more serious problems include:night pain (especially pain that awakens your child from sleep), symptoms of generalized illness (fever, chills, malaise, weight loss), symptoms persisting beyond several weeks, symptoms in very young children, leg pain, numbness, or weakness. These warning signs donot necessarily denote a serious problem, however, they are a good screening test to determine if more evaluation should be pursued. For example, muscular back pain can persist for months.

Back pain in children and adolescents is not unusual and is becoming more common over time. Part of this is due to changes in the activities of children, and part is due to changes in the conditioning of children. If your child is experiencing back pain, especially if it is associated with the warning signs mentioned, it is worthwhile to have him or her be seen by a physical therapist. Initiating proper treatment, and ensuring the symptom improvement, can help to ensure problems donot become chronic.

The good news, for kids and parents alike, is that the vast majority of children with complaints of back pain find relief that tends to be lasting. While back pain can interfere with sports and day-to-day activities, with appropriate treatment, these children almost always return to full mobility and cessation of discomfort.

Perils surrounding 'gunpoint diplomacy'



A 'peace deal' with an organisation still on the UN's terror list is a precedent of grave concern that opens up a Pandora's box for the world community

he international community has witnessed a paradigm shift in global security and geopolitics during the last three weeks. With the deal between the US and the Taliban and the subsequent capture of Kabultoincreasing convergences between some states and the Taliban, international politics will never be the same again. There would be profound changes in the manner in which diplomacy and inter-state relations would henceforth be conducted.

The most immediate question is whether state representatives can sign peace agreements and deals with terrorist organizations knowing their intentions to seize territories through violence and terror mechanisms? Primarily, we have heard of an "understanding" between different players, but a "peace deal" with an organization still on the UN's terror list is a precedent of grave concern that opens up Pandora's box for the world community.

Today, through various sources such as Qatar and Pakistan, the Taliban is sending messages that negotiations and engagements mustbegin if the world does not want Afghanistan to be the terror hub. Such statements certainly are not in the form of requests and amount to tactical blackmail to seek recognition and financial aid with the ulterior motive of infiltrating various international and regional organizations. The example of Pakistan has proven that financial flows do not sway away the actors (both state and non-state), facilitating their sinister agendas such as Jihad.

In proverb terms, the wolf feels the need to wear the sheep's clothes. The dilemma that the world faces currently is that the Taliban has taken control over the territory unlawfully and forcibly, and to function as a "legitimate" heir, it has to present itself to the world as a de jure entity. China, Pakistan, Russia, Iran and others have been sent an invite to the "government formation" process in which atleast half of the "ministers" are designated terrorists pushing forward the agenda of radical Islam and Jihad. The pressures on the international community, especially the donor countries like India and Japan, to initiate diplomacy, aid and trade with the Taliban and assess them on their 'acts' will only bolster the the hounds".

The countries must come out of the paradoxicalmentality of financing and aiding the failed states like Pakistan and Violent Non-State Actors (VNSA) like the Taliban in Afghanistan in expectation ofstability in the region. While the US concludes that force is not the predominant factor in deciding the future course of actions, the same power of force would be encouraged if such VNSA is either "engaged" or "aided". Acceptance of the blackmail, as in this case, is not a

The issue of "recognition" or "cooperation" to the Taliban Afghan in return for their display of actions in "compliance with the international norms" is thus tricky. There is a difference between what India expects and what the other powers expect from the Taliban. We are primarily left to fend for ourselves. Even the slightest show of "normalcy" or "diplomacy" will affect India. What will happen a year or two from now is in the realm of the unknown. Even on some conditions, an "engagement" with the Taliban will be to it, having domestic consequences and create wrong precedents. Suppose India opts for talks with the Taliban, a few months down the line, we might seethe Taliban representing Afghanistan sitting across the Table in UNGA or other regional organizationscommenting upon our internal matters. Would not India be then tricked by China and Pakistan in the same way as the US was downplayed? Sometimes, not making a decision is much more desirable than taking decisions prompt-

ly under coercion, aslater times can seldom reverse them.

Second, the feeling of being left out on the part of US allies will affect future alliances. In the current problem, India's immediate interests weresidelinedwhen the US left Afghanistan, leaving behind a cache of arms thatmay have already been transported to Pakistan only to be used against Indian interests in areas bordering Pakistan. As the vested interests of China and Pakistan "blossom" with the support of Iran and Russia, a pertinent question is how India would deal with the issue. Some backdoor communications channels (not diplomacy) have to be maintained at a fundamental level until the last Indian citizen exits Afghanistan. We must learn to differentiate between negotiations for evacuations and recogniz-

ing a form of "government".

Third, as the US introspects its policies, there are chances that it might adopt an approach of 'democratic realism'that Charles Krauthammer suggested in 2004 that commits its "blood and treasure" only at places of "strategic taken as a diplomatic recognition necessity". In such a case, what strategic and tactical commit-India needs to be demonstrated? If India is considered an ally, the onus of proving itself a credible partner lies on the US. The same standards are applicable for Russia

Further, diplomatic engagements now seem to be turning towards a new kind of power relations devoid of any long-term commitments. In trends like this, countries do not hesitate to extend their outreach through VNSA.

Further, adverse powers also team up for short-term or long-term gain, and, in the process, either sideline or resolve their existing issues. When China and Pakistan have shed their cloak of pretence, and the US is not going ahead with its previous "policing role" for advocating democracy, New Delhi should adopt an Indocentric approach as a solution to this new great game.

From India's perspective, we should question whether Afghanistan becomes a terror hub of different factions of proxy organisations or will it serve as an exclusive ISI extension working solely against India? Owing to the geopolitics, the Haqqanis have been included in the so-called "government". There is no doubt that the Indian interests would be affected. Taliban's "spokesperson" Suhail Shaheen has already stated that Kashmir is next. The Taliban stated that it would not 'interfere" between Pakistan and India a few days later. The two statements released within a week have no credibility. Which statement can India trust? Moreover. why should India trust the Taliban if Pakistan's active role is already viaenceas

The consequences of the churning of the Afghan problem will probably start appearing when it becomes the new epicentre for emerging rivalries and partnerships. The world might witness more chaos and terror, but not for long as resistance will come up against such tendencies. They might be in the form of alliances, partnerships, or at the international forum, but certainly, "gunpoint diplomacy" would not continue for long.

The disappearing wetlands of India

These water bodies are falling prey to real estate mafia on the one hand and becoming dumping ground for waste on the other

he presence of wetlands in urban India is almost taken for granted. These stagnating marshes and bogs are instinctively seen as dumping grounds for construction and other waste material. Almost every city and town in India probably has that wetland which is suffocating under eutrophication thanks to proliferating water hyacinth and algae.

As the water body and the life forms in it fight a losing battle, the final nail in the coffin is served by the real estate mafia who nibble away slowly but steadily at the wetland till enough land is cleared up to be encroached. Thus, in this manner another wetland in India would have died a silent death.

India has 7,57,060 wet-

lands that are ostensibly protected by the Wetland (Conservation & Management Rules) 2017 but unfortunately the enthusiasm of the rules doesnot extend beyond the paper as illegal acts continue to wreak havoc on wetland across India.

The size matters too, the smaller the wetlands the lesser their chance of survival. In fact, 5,55,557 wetlands out of the 7,57,060 are smaller sized wetlands and hence at a greater risk of disappearing swiftly. But smaller wetlands are by no means environmentally irrelevant as they support almost the same scale of aquatic life and rich biodiversity as the big wetlands.

Historically, India was a water surplus nation due to the widespread availability of wet-



lands, but these water bodies were eventually sidelined in favour of piped water supply so as to gain control over an important natural resource such as water

Though this act of colonizing water resources provided power and cash to humanity, but it sealed the fate of wetlands forever and resulted in the beginning of water scarcities.

It is critical for India to understand the role played by wetlands to enhance water venate these water bodies so that water scarcity is replaced with water security.

Apart from being a valuable water resource, wetlands play an essential role in conserving environment and keeping climate change in check. These underestimated water bodies can absorb carbon, replenish groundwater

and prevent floods. They also play a vital role in attracting a variety of wildlife including migratory birds due to which the region around the wetland develops a very healthy balance of human existence and flora and fauna.

The wetlands provide good moisture content in the air which in turn plays a critical role in reining in ication levels. All these factors

resources availability and rejuair pollution.

Let alone metropolises, the wetlands in smaller cities in India are facing woeful times. Uttarakhand in northern India is an apt example where over 70 per cent of the 994 documented wetlands are facing extinction due to delayed conservation. The 2.62-hectare Niranjanpur wetland in Dehradun lying in a coveted real estate location is fast falling prey to builder mafia on one hand and becoming dumping ground for domestic and construction waste on the other. As the construction waste and rubble gradually reach the wetland floor, the process of the water body drying up begins. This is accelerated by the lack of rains and ever-increasing eutropheventually pave the way for real estate builders to approach the dried-up wetland area and

usurp the prime property. These conditions are fast becoming normal for most of the wetlands in India and unless remedial measures are undertaken on priority basis, the nation will lose some of the best and oldest natural water bodies. In order to make an immediate difference, the government must commission a satellite-assisted remote sensing-based wetland census proiect to authentically draw up a data of current number of wetlands across India. The last such wetland census exercise was done in 2013 and the data is too old considering the pace of climate change and anthropogenic activities which have changed the ground situation very much since then.

In addition to this, all the available data concerned with wetlands must be digitally inventoried. This will help ear-mark wetlands and their buffer zones on public domains and, therefore, assist planners and the public to steer clear of the same when undertaking developmental activities. This in turn will stop encroachment in the name of development.

The government must also undertake immediate measures to cut off the nutrientrich domestic waste seeping into wetlands as it assists in the growth of algae and water hyacinth. Finally, a nationwide wetland de-siltation project will aid in restoring the lost glory of the wetlands and halt their disappearance.

Drones target northern Iraqi airport after 2 month lull

AP BAGHDAD

Explosives-laden drones targeted Irbil international airport in northern Iraq late Saturday where US-led coalition troops are stationed with no reports of casualties, according to security forces and officials in Kurdish-run region.

Kurdistan's Counter-Terrorism Service said at least two drones carrying explosives targeted the airport. It said the attack did not lead to any casualties. Lawk Ghafuri, spokesman for the semi-autonomous northern region, said the explosives struck outside of the airport and dismissed reports the attack had impacted flights. He said the airport remained open and an investigation was ongoing by Kurdish authorities.

The attack is the first following a two month lull in drone and rocket attacks to target the US presence in Baghdad and military bases across Iraq. On July 8, rockets landed in and around the heavily fortified Green Zone in the Iraqi capital Baghdad, which houses the US Embassy. It caused mater-

ial damage but no casualties. Until recently the attacks were a frequent occurrence. The US has blamed Iranbacked militias for attacks. More recently, the attacks have become more sophisticated, with militants using drones instead of Katyusha rockets.

US forces will end their combat mission in Iraq by the end of this year, but will continue to train and advise the Iraqi military.

Japan, Vietnam sign defence transfer deal amid China worries

Tokyo: Japan can now give defense equipment and technology to Vietnam under an agreement signed on Saturday, as the two countries step up their military cooperation amid worries about China's growing military influence.

Japan's Defense Minister Nobuo Kishi said the deal elevates their defense partnership "to a new level" and that Japan and Vietnam plan to deepen defense ties through multinational joint exercises and other means.

Details about the transfer of specific equipment, including naval vessels, will be worked out in subsequent talks, the ministry

said. Kishi's meeting with his Vietnamese counterpart, Phan Van Giang, in Hanoi coincided with a two-day visit to the Vietnamese capital by Chinese Foreign Minister Wang Yi.

He wrapped up his visit by saying China plans to donate 3 million doses of its coronavirus vaccine to Vietnam.

The agreement comes two weeks after the US Vice President Kamala Harris travelled to Vietnam to strengthen ties with the Southeast Asian

During the tour, Harris urged countries to stand up against "bullying" by China in

the South China Sea.

India expected to grow 10% during current fiscal

Says NCAER Director General Poonam Gupta

The Indian economy is expected to grow around 10 per cent during the current financial year on the likelihood of fewer Covid-19-linked supply disruptions and buoyancy in the global economy, said Poonam Gupta, director general of economic think-tank NCAER.

The real challenge, however, would be to sustain a growth rate of 7-8 per cent in years to come, she said.

"We could see annual growth in the ballpark range of about 10 per cent. The reasons for this perceived optimism are: fewer supply disruptions; increased pent-up demand in the traditional and contactintensive services; and a buoyant global economy.

"Even so, if two pandemic years are taken together, there would be a very small net growth. In other words, the economy at the end of 2021-22 would be only slightly larger than at the end of 2019-20," Gupta said.

Gupta is the first woman director general of NCAER. Before joining the think-tank, she was the lead economist at



the World Bank. She was also the Reserve Bank of India Chair Professor at NIPFP, and a Professor of Macroeconomics at ICRIER.

On the challenges being faced by the Indian economy, she said the first one is to recover from the impact of COVID-19 and the second is to sustain post-COVID-19 growth rates of at least 7-8 per cent.

India has done rather well during the COVID-19 pandemic, primarily because of the rapid pace of vaccination, Gupta said, adding, "Currently, ensuring rapid and widespread vaccination is the best progrowth policy that any country can implement."

India's economic growth surged to 20.1 per cent in the April-June quarter of this fiscal, helped by a low base in the year-ago period, amid a devastating second wave of the COVID-19.

The gross domestic product (GDP) had contracted by 24.4 per cent in the corresponding April-June quarter of

The RBI expects the GDP growth at 9.5 per cent in 2021-22 consisting of 21.4 per cent in the first quarter; 7.3 per cent in Q2; 6.3 per cent in Q3; and 6.1 per cent in Q4 of 2021-22.

On a question related to private investment picking up in India, Gupta said that one of the biggest economic challenges that India has faced in the past decade has been an anaemic private investment.

The data, she said, show that the rate of investment declined from a peak of 36 per cent of GDP in 2007 to 27 per cent in 2020. A large part of this decline is on account of the slowdown in private invest-

She noted that the Economic Survey 2017-18 had shown that the investment cycles often tend to be longdrawn. Notwithstanding even this cross-country experience, India's downturn in the realm of private investment has been longer drawn than anticipated. as it has now stretched into a second decade.

Sebi notifies certification requirements for distributors, staff of portfolio mgmt services

apital markets regulator Sebi has put in place certification requirements for associated persons engaged by portfolio managers as distributors or employees having decisionmaking authority related to fund management.

These persons need to obtain certification from the National Institute of Securities Markets (NISM), the regulator said in two separate notifications dated September 7.

The associated persons, engaged by a portfolio manager as a distributor of the PMS, and associated persons functioning as principal officers of a portfolio manager or an employee having decisionmaking authority related to fund management, will have to obtain certification from the NISM by passing the certification examination.

The portfolio managers will have to ensure that that all associated persons who are distributors of the portfolio management services (PMS) and who are principal officers having decision-making authority related to fund management, as of September 7, 2021, obtain the certification within two years, Sebi said. It further said a portfolio

manager, who engage or employ such associated person after September 7, 2021, will have to ensure that such person obtains certification within one year from the date of their However, an associated

person, who being a distributor of the PMS has obtained a valid AMFI Registration Number (ARN) or NISM certification, will be exempted from the requirement of obtaining such certification. Earlier in March, the Securities and Exchange Board of India (Sebi) notified new regulations for portfolio managers about

their qualifications. The move was expected to help recognise "the postgraduate programme in the securities market of not less than one year offered by NISM" as an eligible qualification for portfolio managers. With regard to qualification for the portfolio manager, Sebi had said a portfolio manager needs to have a professional qualification in finance, law, accountancy or business management from a

Delivering her address at the centenary celebrations of the city-based Tamilnad Mercantile Bank here, Sitharaman said even during Covid-19 pandemic with the use of digitisation through banking correspondents, the government's financial disbursements were distributed to the needy after verifying their details.

"Prime Minister (Narendra Modi) was clearly aware that banking is important and did not hesitate that there can be accounts with zero balance, if they were opened under the Jandhan Yojana scheme (launched in 2014). But he ensured that every one must hold a bank account and be able to transact through a RuPay card," she said.

Stating that the government distributed Rs 1,500 in three installments to the needy through their bank accounts during the Covid-19 outbreak. she said there are lot of changes happening in the banking sector at a "fast pace" through digi-

"There is no necessity to open a branch in a place which does not have a bank. Today, to reach a bank account of the people who live there, all kinds technologies are available...Even sitting from Tuticorin one can serve the banking requirements of people living in small villages through technology", she said. The way forward for any

bank, particularly for a bank like Tamilnad Mercantile Bank, to be more efficient, is to adopt complete technology related solutions', she said.
"Today financial technolo-

gy is the biggest area and using that we can able to populate data into forms. It may be Income Tax or GST related. Auto-populating data (of a consumer) has been very useful (today)," she said.

Auto-populating data can be done only through 'digitisation' and the management of TMB should think of greater use of digitisation, she said.

hen we think of the date November 26, 2008, it takes little time for our mind to conjure the horrific imagery of what transpired during the 26/11 attacks, as the incident has come to be known among the masses, when 10 members of Lashkar-e-Taiba wreaked havoc in Mumbai.

While numerous renditions, in cinema and literature, have emerged of what happened that night, no one really gave much thought to what healthcare workers were dealing with in the aftermath of the 26/11 attacks. Working on the aforementioned premise, Mumbai Diaries 26/11 shares the perspective of the doctors who had to treat both the victims and the terrorists.

Shreya Dhanwanthary, who essays the role of a field reporter, Mansi Hirani, in the series, expresses that while she has played a journalist in the past, with her portrayal of Padmashri-winning financial journalist Sucheta Dalal in Scam 1992, this felt a new experience altogether.

Read on for excerpts of the interview:

□Tell us a little about what's in store for viewers that sets the series apart from other representations of what took place on November 26, 2008, like Ram Gopal Varma's The *Attacks of 26/11?*

There have been many angles that covered this particular event that just about every Indian is familiar with, but I don't think there has been anything around the viewpoint of the doctors, people who were working at hospitals that night.

Mumbai Diaries 26/11 is all about different forces that collided at this particular hospital, during those attacks. We are trying to give a different perspective to what happened, which might be new, yet harrowing at the same time.



The frontline workers, their life is what is being shown

Yes, exactly. Most of us were not even familiar with that term before the pandemic reached India. On a regular day itself the hospital goes through a lot of horror but be it a private or a government hospital. But this is set in the backdrop of 26/11 so the horror is manifold.

□So, the series highlights how doctors had to go beyond the call of duty on that fateful

I think they do that every day, every night, regardless of whether there is something to uphold in the background or not. In every sense of the word, members of the healthcare sector are genuine lifesavers.

And in the series, we have tried to reflect how they are carrying on with their job, irrespective of what's happening around them. That is a testament of their grit and what they can do.

□What can the audience expect from your role and what, according to you, is the like a fresh wound in the minds of a lot many fellow citizens of our country. I have to remind you that Scam 1992, was even further back in the past. Reliving the past is a part of the experience of being in such productions.

□After a role in The Family Man, then Scam 1992 and now Mumbai Diaries 26/11, you've come a long way. To what do you attribute your career-graph which is now pointing upwards?

Yes, I have come a long way, but I have a longer way to

While people would think that hard work paves the path to success, I disagree. Hard work cannot beat working smartly. I have to be honest and admit that at times I ask my parents, 'why couldn't you have done a film when you were younger, it would have made matters easy for me'.

I think talent pays a bigger role in this industry than hardwork, because that probably is the difference between smart work and hard work.

Hard work isn't always equivalent to good work. You can really work hard all your life for something, and still not be good at it. Hard work cannot signify how good you are at something, it just simply stands for how hard you worked, unfortunately.

Now that I have said this, you might think it is all about applying yourself, but no. There are so many different factors at play. You need to be passionate about what you are doing. There are so many people who literally work hard every day. Visit any construction site, labourers are engaging in back-breaking hardwork. Make no mistake, they do it because that is the way society is built. They don't have access to the opportunities that we do, hence they continue toiling, day in and day out, without having anything to show for it.

It is very easy to say that hardwork se kisi ko mauka mil jaata hai. In India it is pretty easy to see what hard work gets you, and what other opportunities can do for you..

□How do you try to stay relevant to the modern audience with the characters you choose?

(laughs heartily, before responding) I don't think I have properly arrived in the industry, it is too early for me too think about my relevance in the industry.

I haven't really given much thought to how relevant or irrelevant is a character before accepting that role. Ever since I could read, I've been reading books. Stories have always been my truest, closest and constant friends. When I get my hands on a script I read it like a story, bearing in mind the thought whether I feel like flipoing the page, whether I am hungry to know what comes next. If I genuinely like a script, I read it again.
This time, from the per-

spective of my character, tracing all the nuances. Again, you can't really control how the story may pan out. When its written to when it is released, if it does release, they are multiple filters, that a script may go through, right from the creation of the script to editing of the script, to improvisations and additions that may happen during production, and then some more editing in post-production. And these are things which I cannot control, the only bits that I have some influence over is my performance of the character, provided I like it. That is my only concern, at this point in my life.



Her mother, who had transitioned to daily-wage work, lost all her income and the family was unable to buy food. There were similar messages of hunger from other victims of sex trafficking and their children. The anti-sex trafficking NGO, Apne Aap, launched the #1MillionMeals drive as a rapid response. Its efforts were meant to be a stop-gap till the government set up systems in place for vulnerable women and children. However, it had to continue the food drive indefinitely as there is still no system in place.

Apne Aap has distributed more than 12 million meals among half a million vulnerable women and girls in eight states of India between March 2020 and June 2021. Its intended goal was a million meals for 10,000 victims of sex trafficking and their children in 100 days. It has exceeded its initial target 12 times over and is continuing even after 500 days.

The beneficiaries include people who experience marginalisation on account of their caste, gender, occupation and geographical location. Many of them also face intersecting discrimination. Many of these individuals depended on precarious occupations besides victims of sex trafficking and included agricultural labourers, sharecroppers, fishermen, veg-etable sellers, basket-makers, cotton carders, street performers, snake-charmers, cattle herders, coal-miners, plough-cultivators, tea garden labourers and construction site labourers. Some excerpts from an interview:

♦What was the initial idea behind the foundation?

To end sex trafficking by creating choices for girls at risk in marginalised communities. We focussed on ending inter-generational prostitution among identified criminal tribes by educating their children and helping their prostituted mothers exit brothels by getting government IDs and accessing government welfare like food, housing and health care.

Initially, the founding 22 prostituted women had four dreams: a) school for their children b) a job with dignity c) a room of their own d) old-

Apne Aap rented a room in a Municipal School in a red light area and hired a teacher. Slowly, when the children were ready for school, we formed an Apne Aap mothers circle and together talked and begged the local principal to admit the children.

THE LAST GIRI

An SOS call at the start of lockdown spurred Apne Aap International to reach out to marginalised communities at the bottom of the pyramid. RUCHIRA GUPTA, founder, tells Saimi Sattar that the #1MillionMeals continues to reach out to people

Today, the organiation has helped thousands of children finish school, graduate from college and find jobs. They are looking after themselves and their mothers.

♦How has it transformed?

With time we named our approach the '10 Asset Approach'. An Apne Aap woman or child became independent as they gained 10 assets over a period of one or two years. The assets were a 1) a safe space like access to a community centre 2) education 3) self-confidence through story telling, dance, kung fu karate 4) political knowledge and ability to talk to authorities 5) government IDs like BPL cards and caste certificates 6) government welfare like ration card, Indira Awas Yojana 7) bank accounts

8) IGP and small business training 9) legal knowledge and support like testifying in court, filing police complaint 10) friendship circles of Apne Aap self-action groups of at least 10 members and the larger network.

This made the women and children stand on

their feet and learn how to negotiate without putting them into a home or institution. It changed the place where they lived. This was a slow process but longer-lasting and transformative too. There are red light areas which have

become non-red light areas in Bihar due to this effort. The traffickers are in jail, children in school and college and mothers have taken over the houses, turned them into homes and are daily wage earners running small businesses and accessing government welfare.

♦What has been the reach of the programme? In numbers and area.

We've worked in Bihar, Delhi, Maharashtra and West Bengal. We've helped more than 20,000 women and children exit prostitution systems since we began work in 2002. We've reached the most vulnerable communities who were labelled as criminal tribes under British and were so marginalised that prostitution became their only livelihood.

Recently, when Covid hit in 2020, we found that many of the women had lost all income from daily wage work, their children were sent back from school to the red light area and they slowly began to starve.

We launched a #1MillionMeals food drive. In the last 18 months, we have served more than half a million women and children from red-light areas, refugee camps and migrant camps more than 12 million meals.

Who are the volunteers who have come forward to take on the task?

The maximum volunteers have come forward from the student community. I've had a constant stream of volunteers from Ahmedabad University, Jadavpur University, Delhi University in India and Oxford University in the UK. From the US, volunteers from NYU, Hunter, Stanford, Yale, Harvard and University of Washington. The ones who provided on-the-ground support have been retired business owners mostly older women who are helping with our income-generation training like supervising sewing circles.

How is it put into operation?

approach #1MillionMeals is through something called The Human Chain which was created through WhatsApp group starting from factory owners to the girls in the redlight areas, with merchants, transporters, celebrity amplifiers, warehouse owners, NGO leaders, student volunteers, our team of Apne Aap managers and community mobilisers and finally the beneficiaries whom I call 'The Last Girl'. For me, she is the 13-year-old in a brothel.

♦What have been the obstacles in implementing the programme, if

Logistical issues caused by the lockdowns, like no transportation, shortage of food, a health risk for our workers and constant need for money or food donation. We also faced some corruption and discrimination along the way.

♦Women cannot be considered a monolith. The problems, I am sure, would have changed depending on the area, age and more. How do you find a customised solution?

The victims of sex trafficking in Kolkata needed food in the form of dry ration most, whereas migrant women needed cooked meals as they were walking along the highway from Delhi. In some cases women needed cash, and in others, they needed to rent a room. In the Sundarbans, they wanted material to rebuild their homes after a bad storm. At other times we had to provide oxygen concentrators.

♦What does the post-pandemic world mean for women in the workforce?

It's going to be a tough world if we don't create special economic stimulus packages for the most marginalised women and girls. Send them cheques so that they can make their own decisions on how to restart their lives or manage the crisis they are in. Our government can certainly afford it. Otherwise, the economy will suffer.

If the bottom third suffers, we will all suffer. Covid has taught us that we are interconnected. No lockdown or wall or police control could stop the virus from travelling from one country to another, rich to poor areas, man to woman, adult to children, black to white or upper caste to poor caste. So if someone continues to live in a dirty area with no sewage, remember that the mosquito that breeds there will bite us all. We are linked not ranked.

> (PTSD). Domestic violence affects not only a woman's physical and mental health, but also of her children. Counseling the survivor of domestic violence and her inlaws, according to Dr Singh, can be a productive way to bring things under control. Behavioral and cognitive therapy are useful in these treat-

> Rural women lack access to redressal mechanisms and counselling services. In many cases, they would consider it acceptable to be hit by their partners and continue to pretend to be a 'good wife'.

For the most part, patriarchal tradition and culture are to be blamed. Patriarchy has been in place for thousands of years, laying the groundwork for men's entitlement to power over women. The impact has been such that over years, women have become the perpetrators of

patriarchy.

While some women attempt to fight against what they have endured, lack of support from family or administration can lead to a never-ending cycle of suffering. The need of the hour is to educate women about their legal rights and make legal services accessible to women so that they can put a strong fight against the perpetrators of domestic violence.





hose who engage in Tregular exercise may lower their risk of developing anxiety by almost 60 per cent, finds a new study.

The study, published in the journal *Frontiers* in Psychiatry, indicated

that a group with a more physically active lifestyle had an almost 60 per cent lower risk of developing anxiety disorders over a follow-up period of up to 21 years.

Anxiety disorders, which typically develop early in a person's life, are estimated to affect approximately 10 per cent of the world's population and has been found to be twice as common in women compared to men.

The study is based on data from almost 400,000 people in one of the largest ever population-wide epidemiology studies across both sexes

The authors found a noticeable difference in exercise performance level and the risk of developing anxiety between male and female skiers.

CHEWING-GUM MAY RELIEVE GUT PROBLEMS

hewing gum after heart Usurgery may kickstart the digestive tract, helping patients feel better and potentially be discharged sooner than those who don't use this generally safe and

simple intervention, finds a new study. According to the researchers, postoperative gum chewing is an effective and inexpensive intervention that helps improve how patients feel after surgery.

For the study, presented at the 18th Annual Perioperative, the team involved one group comprising 341 patients who underwent surgery between 2017-2020 and took part in the sugarless chewing gum protocol after their operations. A second group, which included 496 patients,

received similar heart surgeries between 2013-2016, but did not chew gum after their procedures. It was found that only 0.59 per cent of the gum-

chewing patients had confirmed postoperative ileus, while 3.43 per cent in the non-gum chewing group developed postoperative ileus.

MODERNA'S VACCINE IS MOST EFFECTIVE

Moderna's vaccine for Covid-19 is significantly more deffective against the Delta variant of the SARS-CoV2 virus than Pfizer or Johnson & Johnson, suggests a new study. The study, published in Morbidity and Mortality Weekly

Report, suggests that Moderna was 95 per cent effective at preventing hospitalisation among adults ages 18 and older. For the study, the team

analysed more than 32,000 medical encounters from nine states during June, July and August 2021, when the Delta variant became the

predominant strain. They found that Pfizer was 80 per cent effective at preventing hospitalisation among adults ages 18 and older. While Johnson & Johnson was 60 per cent effective.

The results showed that unvaccinated individuals with Covid-19 are 5-7 times more likely to need emergency department care or hospitalisation. It was also found that vaccine effectiveness is lower for people 75 years and older, which has not been shown in previous research.





18-year-old qualifier Raducanu wins her maiden Grand Slam title after beating Fernandez in US Open final

Britain's 18-year-old Emma Raducanu became the first qual-ifier to capture a Grand Slam title by defeating Canada's 19-year-old Leylah Fernandez on Saturday in the US Open women's final.

Raducanu, ranked 150th, was the first British woman in 44 years to win a Slam crown after beating 73rd-ranked left-hander Fernandez 6-4, 6-3 to take the \$2.5 million top prize. "I knew I would have

to dig deep," Raducanu said. "It was an incredibly difficult match but I thought the level was really high. I had to play some of my best tennis." Not since Virginia

Wade in 1977 at Wimbledon had a British woman taken a Slam singles title, with Raducanu the first Briton to claim the US Open crown since Wade in 1968. Queen Elizabeth II

was among the first to pay tribute to Raducanu's remarkable win.

"It is a remarkable achievement at such a young age, and is testament to your hard work and dedication," the British monarch

said in a statement. Wade and British men's tennis legend Tim Henman were among a sellout crowd of 23,700 that created an electric atmosphere at Arthur Ashe Stadium in the first-ever women's Slam final between unseeded players.

"It's an absolute dream. You just have visions of yourself going up to the box, hugging everyone, celebrating. For that moment to actually

Ricciardo wins Italian Grand Prix

 $D_{\text{Formula One Italian}}^{\text{aniel Ricciardo won the}}$ Grand Prix on Sunday as the Australian took advantage of Lewis Hamilton and Max Verstappen's dramatic crash which eliminated both championship rivals.

Ricciardo was followed by his McLaren teammate Lando Norris in the British team's first win since the 2012 Brazilian GP, while Valtteri Bottas inherited third, despite starting in last place, due to a five-second time penalty for Sergio Perez.

Red Bull's Verstappen still leads seven-time world champion Hamilton by five points at the top of the drivers' standings as they both finished in the gravel following their crash halfway through the race.

Ricciardo, whose father is from Italy, was delighted with not only his first win since Monaco in 2018 but also McLaren's first one-two finish in 11 years, greeting the fans in Italian with a huge smile on his

"To lead literally from start to finish, I don't think any of us expected that. There was something in me on Friday, I knew something good was to come," said Ricciardo.

"To not only win but to get

McLaren to be on the podium it's huge, let alone one-two... For once I'm lost for words."

The 32-year-old promised "total attack" after starting second on the grid and capitalised on the most dramatic moment of an eventful race when Hamilton re-entered the Monza track from the pit lane.

Vertsappen tried to dart past Hamilton just after the Briton's pit stop but ended up with his back wheel rolling over the top of his rival's Mercedes, narrowly missing Hamilton's head. Both drivers then slid into

the gravel and were forced to retire from the race, which Hamilton was hoping to make his 100th Grand Prix victory. Vertsappen was reportedly furious at Hamilton, saying his

rival gave him "no space" in a crash which will be investigated by officials after the race The pair then gave each other the blame in their post-

race comments, with Hamilton saying he had given way in a similar position to Verstappen earlier while the Dutchman insisted Hamilton "pushed" him into the trackside sausage kerb.

Ricciardo then powered to victory backed up by his teammate Norris who was also in good spirits after an impressive second-placed finish.
