

HC seeks replies on plea to de-recognise AAP

he Delhi High Court on Monday sought a response of the Centre, the Delhi Government and the Election Commission (EC) on a plea seeking de-recognition of the Aam Aadmi Party (AAP) alleging that it promoted Ganesh Chaturthi using public money which is contrary to the Constitution of a secular countrv. A Bench of Chief Justice D N Patel and Justice Amit Bansal made it clear that it was issuing notices to the Centre, Delhi Government and EC and not to the Chief Minster and other Ministers of the State.

The counsel for the authorities sought time to seek instructions and file replies after which the court listed the matter for further hearing on

Petitioner and advocate M L Sharma said he was seeking direction to de-recognise AAF as a political party and remove Chief Minister Arvind Kejriwal and other Ministers from the Constitutional office due to alleged deliberate breach of the Constitution and the Representation of People's Act



in the interest of general public.

The plea was opposed by senior advocate Rahul Mehra, representing Delhi government, saying it was a totally motivated and mischievous petition, coloured as a public interest litigation (PIL) and needs to be missed with heavy costs.

He also said the decision was taken to prevent religious congregations amid the COVID-19 pandemic and as the Delhi government had prohibited setting up of pandals to prevent overcrowding, the chief minister had merely requested the media to cover the celebration for citizens' participa-

tion from their residences. Mehra said government facilitating religious celebrations is not new and it is done every time during the Kumbh Mela and Amarnath Yatra, and it is the solemn duty of the state to protect public health.

dismissed Sharma's plea seeking to declare as illegal the Delhi government's move of organising Ganesh Chaturthi from state treasury and releasing advertisement, saying the petition was filed hurriedly and without doing proper homework and granted him liberty to file a fresh plea with proper averments.

AAP to initiate process of making Pusa bio-decomposer on Sept 24

 $T^{\text{he Delhi Government will}}_{\text{start preparing Pusa biodecomposer, a scientifically}}$ method to turn pollution contributing stubble into manure from September 24. The microbial solution will be ready by October 5, Environment Minister Gopal Rai said on The Monday. Delhi Government will provide this solution free to city farmers to spray in 4,000 hectares of paddy farmlands. A 25 members' committee of city Government will coordinate with the farmers for this initiative. While the Aam Aadmi Party (AAP) Government has urged the national Capital's neighboring States also to follow the Pusa techniques to combat pollution caused due to half burnt particles of crop residues, the city Government is waiting for an interaction with the Union Environment Minister Bhupendra Yadav in

this regard. Rai, addressing the media, said that his Union counterpart is yet to give time for a meeting on the use of Pusa biodecomposer in states.

It is pivotal to mention here, according to SAFAR's



observation on stubble burning pollution data, at least 33 percent pollution in city is mainly due to the burning of paddy crop husk. The concentration of harmful particles has been observed abnormally high starting from September end till November when meteorological factors remain unfavorable for Delhi's atmosphere due to thermal inversion.

Meanwhile, Rai illustrated about the scientific method that was used in previous year also. "Stubble burning pollution engulfs North India like a blanket; can't get freedom from it without other states acting on it," Rai said, "farmers just need to fill a form giving details about their land; Delhi government provide it free for

As the third-party audit has also been done on Pusa technique to combat stubble burning pollution, Rai said, "the solution will be prepared at the Horticulture Department

Nursery in Kharkhari Nahar. The preparations will take place centrally at this location and by the 29th of September we will double the quantity of the solution. By 5th October, the bio-decomposer will be ready to be sprayed. We will provide the spray from this location to wherever it is required in Delhi. Last time, the process started on 5th October, this time it will be completed by then. The spray will then be readily available for the farmers.

With the help of state agriculture department and trac-tors, the spray will be sprinkled in core paddy cultivation areas in north-west and south Delhi.

"About 10 litres of spray is required for an acre of land. For this much spray 4 capsules developed by the Pusa Institute are needed. The capsules are mixed with 250 gram Jaggery(gud),150 gram Ğram Flour(besan). The mixture is then cooked and stored for 5 days after which the quantity of the solution is doubled. About 25 lacs were spent last year in the process all over Delhi last year. Now that the area has doubled, the cost will also double but it is extremely costeffective as a solution to curb air-pollution," Rai added.

With 95 cases of dengue reported in the last week, the total number of people infected with this vector borne disease has reached to 348 this year, according to a report issued by civic bodies on

According to the report released on Monday, 71 cases of malaria and nearly 148 cases of chikungunya have also been reported till August 21 this year. The number of dengue cases for January 1-August 7 period is also the highest this year since 2018 when the count had stood at 64 in that same duration. Out of the total cases of

dengue, 34 patients were infected in other States but diagnosed in Delhi after investigation while the hospital did not provide address of eight other patients, the report said. Similarly, out of total cases of malaria, nine people were infected in other states and diagnosed in the nation-

Right kidney, part of lung removed due to post-Covid mucormycosis

Doctors at Sir Ganga Ram Hospital have successfully operated a "first known case of mucormycosis" in which the patient's right kidney and a portion of his left lung were severely infected with black fungus post Covid-

The surgery was recently conducted by a multidisciplinary team of doctors at the hospital to remove patients' right kidney and a portion of his left lung, hospital authorities said on Monday. The patient (34) from

neighbouring Ghaziabad was brought to the hospital with post-Covid illness, which included breathing difficulties, blood in sputum and high grade fever

"We were shocked to see that Mucor had not only penetrated nasal cavity but also his left lung and the right kidney. Both the portion of the lung

and the kidney had been severely damaged and there was a fear of further spread. Therefore an emergency removal of mucor infected areas was planned," said Dr Ujjwal Parakh, Senior Consultant, Department of Chest Medicine, Sir Ganga Ram Hospital.

"Since Mucor is a fast spreading disease and could have further damage to other organs. As a life saving procedure, immediately a part of his left lung and the entire right kidney was removed after complicated surgery which lasted for six hours and the patient was saved,"the hospital said in a statement.

According to Dr Manu

Gupta, Consultant, Department of Urology at the hospital "It was a complicated case in which Mucor had penetrated part of the lung and kidney. Time was of the essence in this case to save the patient as other organs could have been affected. The involvement of the kidney was total, and the kidney had become non functional. During surgery the fungus was found almost spreading to the liver, and the large intestine. Thus with great difficulty, the kidney could be removed without injuring the adjacent organs. This case is being reported in medical literature as the first case in the world after Covid

infection." Talking about the cases, Dr Ujjwal Parakh said "He is recovering well and would be on oral antifungal medicine for a few more weeks. Patient has been discharged after 45 days of prolonged antifungal therapy. He is doing well

Delhi reported 28 cases of the infection on Sunday and 41 on Saturday. On Friday, it reported 55 Covid cases and one death. There are 379 active cases in Delhi, of which 116 are in home isolation.

The government has taken steps to increase the number of hospital beds and accommodate up to 37,000 cases a day and become self-reliant in terms of oxygen supply.

'Vaccine Maitri' to resume

India to export surplus Covid jabs in Oct: Health Min

PNS ■ NEW DELHI

Vaccine Maitri' is all set to resume from the fourth quarter of October, with the Union Minister of Health, Mansukh Mandaviya, on Monday announcing that the export of vaccines would be done in order to fulfil India's commitment towards COVAX, in line with the country's motto Vasudhaiva Kutumbakam."

Addressing the media, the Union Health Minister, however, stressed that vaccinating its own citizens remains the topmost priority of the Government. He also said that cumulative doses administered so far across the country have crossed 81 crore and the last 10 crore doses were administered in just 11 days.

"Surplus vaccines will be used to fulfil our commitment to the world for the collective fight against Covid-19. COVAX is co-led by Gavi, the Coalition for Epidemic Preparedness Innovations (CEPI) and the World Health Organisation (WHO)," the Minister said

Highlighting the importance of indigenous research and production of Covid vac-

cines in India, he said, "It is due to the relentless efforts and guidance of Prime Minister Narendra Modi that India was simultaneously undertaking research and production of Covid vaccines in line with the global developments."

India's vaccination drive has been a role model for the world and it is marching ahead. "More than four times we have crossed the one crore-mark since the vaccination drive was commenced on January 16", he

He said that more than 30 crore doses will be produced in October and more than 100 crore vaccines will be produced in the coming quarter.

When India was facing a shortage of Covid-19 vaccines for the domestic market in the backdrop of the ferocious second wave, the 'Vaccine Maitri' initiative came to a halt in April.

As part of the 'Vaccine Maitri' initiative earlier this year, India had supplied over 66 million doses of Covid-19 vaccines to more than 70 countries. ZERO CEASEFIRE VIOLATION IN KASHMIR THIS YR 60-70 foreign terrorists active: Army

MOHIT KANDHARI I JAMMU

In the absence of successful infiltration bids by heavily armed terrorists from across the Line of Control (LoC) and sustained antiterrorist operations the total number of 'active' foreign terrorists has drastically come down below 70 in the Kashmir region.

Due to the constantly declining number of foreign terrorists, the leftover commanders active in Kashmir valley have reworked their strategy of carrying out only 'hit and run' attacks on the security personnel and political representatives with the help of local recruits.

Sharing his assessment of the

ground situation in the backdrop of unrest in Afghanistan, General Officer Commanding (GoC) of the Army's Srinagar-based 15 Corps or Chinar Corps, Lt Gen D P Pandey Monday said, "there has been no ceasefire violation along the LoC in Kashmir since the reiteration of the agreement between the armies of India and Pakistan in February this year". The Chinar Corps Commander said there have been some infiltration attempts, but unlike previous years they have not been adequately supported by ceasefire violations.



Referring to the police reports, Lt-Gen Pandey said, "around 60-70 foreign terrorists who are basically Pakistanis are likely present in the Kashmir valley. Their strategy is to not carry out any terrorist attack, but motivate the local youth to action and give them arms so that they are killed in encounters. It benefits them in a way that when a young boy from our country, our Kashmir, is killed, his family becomes angry with us. This is their strategy and they do not carry out operations and work from behind," he added.

The GoC, however, said there is a change in the mindset of the peotralised or apprehended, or will have He said the security forces have

been reaching out to the families of the youth who have joined mili-

"We have to ensure that they (families) reach out to their young ones who have been misled and they should be allowed to surrender by motivating them to be a responsible citizen of the country. There cannot be a better opportunity as of today to ensure that they can fall back to civil society, he said.

The senior army officer said those people within Kashmir who are "misleading" the youth to pick up arms must be exposed.

"We must expose the people who are within Kashmir who are ensuring that while their children are studying in good schools, colleges, have good jobs or businesses, but the youth which is misled who is not from such an affluent background, not so well-educated picks a weapon and dies.

Earlier, the GOC Chinar Corps felicitated students of the first and the second batch of the Army's Kashmir Super 30 (Medical) course who are now successfully undergoing the MBBS and other courses after clearing the NEET.

Sixty-two-year Rajanitai – as she is known in the state political circles -- is currently the All India Congress Committee (AICC) in-charge for Jammu and Kashmir. She was elected unopposed to the Rajya Sabha in 2013. In 1996, Patil had won the Beed Lok Sabha seat in Maharashtra for the

She had replaced AICC general secretary and former Maharashtra chief minister Shushil Kumar Shinde as the in-charge for Himachal in September, 2018 Patil enjoys close rapport with the Gandhi family, especially party president Sonia Gandhi. Informed party sources said that

Mumbai court grants bail to Kundra

TN RAGHUNATHA MUMBAI

Five days after a comprehensive supplementary chargesheet was filed by the police against him in the alleged pornography content case, a Mumbai Metropolitan Magistrate granted bail to Bollywood actress Shilpa Shetty's husband and businessman Raj Kundra in the much-discussed sensational case against a bail bond of ₹50,000.

After finding merit in the arguments made by his lawyers Niranjan Mundargi and Prashant Patil, Chief Metropolitan Magistrate SB Bhajipale granted bail to Kundra in the alleged pornography content case.

The Magistrate also granted bail to Kundra's company Viaan Industry's IT head Ryan Thorpe on similar grounds in the same case.

On September 15, the Crime Branch sleuths of the Mumbai police filed a 1,467-page supplementary charge sheet against Kundra and Ryan.

Among other things, Kundar's lawyer Mundargi argued that his client had been made a "scapegoat" in the case and there was no evidence against him in the charge sheet of him being actively involved in the creation of alleged questionable content.

Supplementing the arguments made by Mundargi, Kundra's another Prashant Patil told the court that that the primary chargesheet did not contain a single allegation against his client nor was there any allegation in the supplementary chargesheet to suggest that the victims had interacted with him or had they been approached by Kundra for filming of the obscene videos.

Kundra's lawyers made a case for his bail by saying in his application that since the Mumbai Police had already filed a chargesheet, it was clear that the investigations against him were over and that he was now entitled for bail.

Kundra's lawyers also argued in the court that after the first charge-sheet was filed against nine other accused in the case, eight were released on bail. He went on to seek bail on grounds of parity with the other accused released

They also told the court that Kundra was associated with a company which owns the apps,

Opposing the bail pleas of Kundra and Ryan, the Public Prosecutor told the court that the charge-sheet had been filed against Kundra and Ryan could not be the reason for granting them bail.

HotShot and Bollyfame for only 10

However, after hearing both the sides, Chief Metropolitan Magistrate Bhajipale granted bail to both of them against a bail bond Kundra, who was arrested

along with Ryan July 19 in connection with a complaint registered by the Crime Branch in 2021, has been booked under Sections 292, 293 (sale of obscene material) under the Indian Penal Code, Sections 66E, 67, 67A (transmission of sexually explicit material) under the Information Technology Act and provisions of the Indecent Representation of Women (Prohibition) Act.

Kundra, who lives in Mumbai with his wife Shilpa Shetty and two

children, had earlier told the cour that there was no evidence to link him against the HotShot App and was being made a 'scapegoat'. He had submitted to the court that he had been falsely implicated in the case while the Cyber Cell was making an attempt to connect him with

Kundra, who is the founder Viaan Industries Ltd, and his United Kingdom-based brother-inlaw Pradeep Bakshi, the Chairman of Kenrin Group, London, have been named masterminds of the porn content racket.

In April this year, the police had filed its first charge-sheet in the case against nine persons originally accused. After subsequent investigations, the police arrested two more accused, including "Kundra

Earlier, nine persons had been arrested. They comprised television actress Gehna Vashisht (32) Yasmin Khan (40) Monu Joshi (28) Pratibha Nalavade (33) Atif Ahmed (24), Dipankar Khasnavis (38), Bhanusurya Thakur (26) Tanvir Hashmi (40) and Umesh

"International relations theory tells us that a change in power equations of this nature causes friction. While India welcomes a multipolar world, this should be predicated on a mul-

tipolar Asia," he observed. Thirdly, this rebalancing is taking place in the context of an international system that is being severely tested. The main pillars of this system, the United Nations, the Bretton Woods Institutions and the world trade edifice, the G7, and the network of regimes and

structures that were built on this foundation, were constructed after the Second World

These treaties and agreements are what an analyst has called the "mainstream concepts of globalization." They are the intellectual and structural pillars of the world order as we commonly understand it. Defence Ministers of India and US on Monday reviewed their bilateral defence and strategic ties and took stock of the situation in Afghanistan.

Rajnath Singh and Lloyd Austin came days before the summit between Prime Minister Narendra Modi and President Joe Biden in Washington on September

The two heads of state will also participate in the first in person Quad summit there the same day along with Australian Prime Minister Scott Morrison and Japanese Prime Minister Yoshihide Suga. Biden is hosting the summit at the White House.

The focus of the Quad summit and Modi-Biden bilateral talks is likely to be Afghanistan, Indo-Pacific in the context of China flexing its maritime muscle and the ongoing fight against the Corona pandemic.

Incidentally, talks between Rajnath and Austin came in the backdrop of formation of Australia, US and UK grouping called AUKUS last week to counter China's growing military prowess.

Giving details of Rajnath's talks with Austin, defence ministry officials



said the telephone call was made by the US Secretary of Defence.

Both the leaders discussed bilateral and regional matters, including developments in Afghanistan. They discussed defence cooperation and looked forward to working closely.

The two ministers also exchanged views about combating terrorism in the region. Both sides appreciated the mutual cooperation in the recent evacuation operations in Afghanistan and agreed to remain in regular contact in view of the evolving situation.

While two ministers have talked on the phone in the past few months, Austin also visited India in March this year to hold bilateral talks with

He had said after the talks then India is committed to further strengthen its robust defence partnership with the US. He also urged the US defence equipment manufacturing industry to make good use of the liberalised forin the defence sector.

US Defence Secretary Austin reiterated Singh's words on strengthening ties, stating that his visit was primarily to convey the Biden-Harris administration's message about the commit-ment to America's allies and partners.

Kids with high exposure to PM2.5, NO2 more at risk of self-harm

Children exposed to high levels of air pollution are up to 50 per cent more likely to selfharm later in life, suggested a study that adds to evidence of link between air pollution and mental health problems. Researchers from the

University of Manchester in England and Aarhus University examined 1.4million kids under 10 in Denmark and found that those exposed to a high level of nitrogen dioxide were more likely to self harm in adulthood than their peers, the Daily Mail report-

And people in the same age group exposed to above average levels of fine particulate matter (PM2.5) were 48 per cent more likely to subsequently self-harm, revealed the study published in the journal Preventive

Nitrogen dioxide is mainly produced by cars, while PM2.5 is mainly emitted by burning diesel



and petrol, which is most commonly used for shipping and

These two pollutants are among those most commonly linked with causing harm to physical health, such as heart and lung diseases, by getting into the bloodstream and causing inflam-

"Our findings add to the growing evidence-base indicating that higher levels of air pollution exposure are linked with poor mental health outcomes," lead

was quoted as saying.
"Although air pollution is widespread, it is a modifiable risk factor and we therefore hope our study findings will inform policymakers who are devising strategies to combat this problem," Mok added.

author Dr Pearl Mok, a research

fellow at Manchester University

While the researchers have not explained the mechanism for how these pollutants can cause mental health problems, they say high pollution levels could trigger inflammation in the brain, leading to mental health conditions, the report said.

Childhood is a 'sensitive time for brain development', so youngsters may be particularly susceptible' to negative effects from toxic particles in the air, they

Further, the team found that some 32,984 people (2.3 per cent) harmed themselves in the study period, with cases higher among women, those whose parents had mental illness and individuals from poorer families.

Exposure to an average of 19 microgram/m3 or more of particulate matter each day was associated with a 48 per cent higher chance of self-harming later in life, compared to children exposed to an average of 13 microgram/m3 per day or

And for every 5 microgram/m3 increase in exposure above 19 microgram/m3, the risk of self harm rose by 42 per cent, said the study.

Sidhu, a proxy Punjab CM: BJP

Doubting the 'Dalit focus' of the Congress in Punjab in choosing Charanjit Singh Channi as the new Chief Minister, the BJP on Monday said the State president Navjot Singh Sidhu, a Jat Sikh, is the proxy CM".

As the Congress shifted and shuffled with its top leadership in the poll-bound Punjab and decided to appoint a Dalit Chief Minister, BJP described the move as a mere political tokenism.

BJP General Secretary Gaurav Bhatia maintained that the real face of Punjab during next year's elections would not be a dalit Channi but Sidhu and quoted Congress-in-charge Harish Rawat to say so.

BJP's National Secretary and MP Vinod Sonkar challenged Congress leadership to declare that Channi will be Chief Minister for five-year post-elections.

He alleged that the Congress has made Channi Punjab chief minister for a few months merely to grab Dalit votes as part of its conspiracy, and cited previous instances of the party giving the key position to a leader from the community only for a short tenure.

Sonkar gave examples of Congress appointing Sushil Kumar Shinde, a dalit, as CM in Maharashtra but post-election declaring Vilas Rao Deshmukh as CM in the state.

Similarly, he cited the appointment of Jagannath Pahadia in Rajasthan who was

replaced by Shiv Charan Mathur after the poll success in the state. Sonkar alleged that it was

The Enforcement Directorate (ED) has arrested Vinod Chaturvedi, Managing Director of Usher Agro Limited and other group companies under the Prevention of Money laundering Act in a case related to cheating and siphoning of bank loans of over ₹915 crore.

The money laundering investigation was initiated on the basis of FIR lodged by the Banking Securities and Fraud Cell of the CBI, Mumbai registered on January 4, 2019 against Usher Agro Ltd., Vinod Kumar Chaturvedi, Manoj Pathak and others.

It has been alleged in the FIR that the group has taken loan from consortium of banks and has siphoned off

"During investigation, Proceeds of Crime have been identified and quantified to the tune of ₹915.65 crore. Further, investigation revealed that promoters have formed 15 shell companies and had carried out bogus transactions with these shell companies," the ED said in a statement.

"Also, the group companies have carried out bogus transactions with DHFL group companies. During Investigation, Vinod Chaturvedi was non-cooperative and did not divulge any information," it further said.

The arrested accused was produced on Saturday before the Special Court that remanded him to five-day custody. Further investigation is under progress, it added.

Realignment

Saudi Arabia is discussing with India the impact of the Taliban's return to power

he media is told that Saudi Arabia's Foreign Minister, Faisal bin Farhan Al Saud, is in New Delhi to review the bilateral Strategic Partnership Council Agreement of 2019. The real story is what both are discussing about the Taliban's return to power in Afghanistan and the question of recognising their interim Government. The Saudi Minister's visit is significant for two reasons. One, that the Kingdom which influences global oil policy through petrol and the Islamic world through its status as the Holy Territory should consult India on Afghanistan is significant in itself. Two, the visit caps India's exercise to contact countries involved in the Afghan affair before formally articulating its policy on Afghanistan in the United Nations General Assembly. The policy sees a clear link between the Taliban's links with terror groups, the questionable role of Pakistan and recognition of a non-inclusive interim Government. Prime Minister Narendra Modi has said



as much at the recent SCO meeting that the world should "thoughtfully" and "collectively" decide on recognising the new setup given its lack of inclusivity, the possibility of the Taliban's return to power encouraging other extremist groups to seek power through violence and the fear of drugs, arms and human trafficking. The Saudi-India talks are being held in the backdrop of the former's stand on the Taliban and terror that appears to be at variance with India's.

Before his Delhi visit, Al Saud had said the interim Taliban Government was a "step in the right direction towards achieving security and stability, reject-

ing violence and extremism, and building a bright future in line with these aspirations". He sought to balance it by adding that the choices of the Afghan people about their future should be without "external influences". Given their longstanding and friendly ties, India and Arabia may see this statement in light of Saudi Arabia's regional compulsions. These compulsions could probably be dictated by Arabia noticing the growing influence of Qatar, Pakistan and Turkey in the Afghan affairs. Pakistan has previously differed with Arabia over foreign policy and even questioned the latter's claim to leadership of the Islamic world. The Saudis have been neutral on Kashmir of late. Their relations with Qatar have also been going through a lean patch. The relations with Turkey are improving only now, after a public spat over the assassination of journalist Jamal Khashoggi. These three countries, Pakistan in particular, may find it difficult to convince the world community that they told the Taliban that a precondition to the recognition of their Government is the severance of their links with terror groups and an assurance to disallow them to operate from inside Afghanistan. While ties with Arabia can help rebalance India's geopolitics in the region, India's closeness to the United States provides the Kingdom the chance to regain its place on the global antiterror table in light of the thick ties it had with the Taliban before 9/11.

ightwatchman' is an age-old concept in Test cricket where a batsman of lower ability is sent out to bat ahead of the top order batsmen to stick around in difficult batting conditions and leave when the conditions are favourable for them. The same seems to be the case with the newly appointed Punjab Chief Minister Charanjit Singh Channi as he replaced Captain Amarinder Singh in an all-out shocker. Punjab has the largest Dalit



population among all States, which the Congress seeks to stimulate but the 'gamble' to appoint Channi could go either way. The overwhelmed Channi called Rahul Gandhi "a revolutionary leader" to thank him for this move; however, Channi's remark would prove true only if the Congress fights the 2022 Assembly elections under him after Harish Rawat took no time to indicate that Navjot Sidhu would be the face of the Congress in the polls. The infighting after the Captain's dismissal may not necessarily abate as many anticipate. The power-hungry PCC chief is likely to put the screws on the new Chief Minister to remind him "who's the boss".

The multiple attempts at image enhancement by changing State and Union Cabinet Ministers by the BJP and now by the Congress only solidify the high command order followed by parties. With the latest dismissal, five Chief Ministers from four States -Uttarakhand, Karnataka, Gujarat and now Punjab — have been abruptly replaced since March before completing their term. This image-building cum image-correcting manoeuvre is a recent phenomenon and justifies how modern problems require modern solutions. Chief Ministers have been known to serve complete and oftentimes multiple terms. Prime Minister Modi himself served as the Gujarat Chief Minister for over 13 years; however, the gamble of dismissing a Chief Minister for failed governance rather than addressing the failure has emerged convenient and politically rewarding. After the Punjab fiasco, all eyes are on the Congress-ruled Rajasthan and Chhattisgarh where Ministers have been defying the Congress leadership. Congress leader Sachin Pilot wants his position to be restored and given the top post in Rajasthan while TS Singhdeo wants the concept of rotational Chief Minister to be honoured in Chhattisgarh. Frequent changes in State leaderships would yield nothing but social and political catastrophes and hence the question remains if the new phenomenon would become the new normal?

Okay to force palm oil on ghee culture? NDRA SHEKHAR SINGH



Traditionally, our subcontinent has found sustenance in ghee and other healthy oils. But now palm oil is being forced on our plates

ur subcontinent is 'ghee land'. Since the time of nomadic Arya's yagnas to Mughal biryanis, taste, health and, for Hindus, even the sacred is accessed through this yellowish clarified liquid. But it's not only ghee, every bio-region has its own oil. Mustard, castor and, more recently, groundnut and cottonseed oil are on our thalis. India is abundant in edible oil's diversity. So, why has the Government invested ₹11,040 crore to expand palm oil plantations to another 6.5 lakh hectares (ha)? Let's examine this move.

To the agri economist's eye, it's a numbers game - reduce imports, promote "cheaper" oil, create more agro industry and earn agri dollars; it's a win-win for all. But what about the small and medium farmer, biodiversity and environment; perhaps our "agri experts" are missing the bigger picture.

But first let's discuss African palm oil tree and palm oil production. This tree is foreign to India and agronomically suited to tropical islands only. It has a 25-year cycle, with the yields declining with age. Malaysia and Indonesia brag about increasing production based on their agroclimatic disposition. Here, too, the production ratios vary. Palm oil trees can't be pollinated by bees or Indian pollinators, these require the Weevil Beatle or mechanical alternatives. Being suited to tropical climates, this tree requires a lot of water: 80 gallons per tree and, if the palm fruit is not processed within a day, it goes rancid. In simple terms, it has a much shorter shelf life than mustard or other

Globally, palm oil plantations have led to deforestation from Brazil to Indonesia, land conflicts with the indigenous people, culling of animals like orangutan, Sumerian tigers and given the consumers a plethora of cardiovascular diseases. Some experts state that palm oil even causes The fact that Wilmar as the

this could be the fact that palm oil economy is highly dependent on industry. Small farmers or oil millers can't extract palm oil by themselves. Industrial plants are required to extract the oil, and the industry is lopsided towards corporations. Small farmers contribute 40-50 per cent of the total oil from Indonesia region but keep in mind the 22-hectare farms (considered "small farms" in that country). Despite this, fication issues which further prevent these "small farmers" from increasing their income.

It was estimated that over 12 per cent of small farmer incomes are spent on certifi-cations and licenses in Indonesia. Overall, palm plantations are a Big Ag business affair, with farmers getting only crumbs from the pie.

So if Indonesian farmers can't get profits, how can Indian farmers? Also, keep in mind that the average land holding is below one acre and the situation in the Northeast is even more dire as these States are already reporting deforestation and falling prices of palm oil. Farmers in the Northeast region are shifting back to traditional crops or other fruits to increase their income. The supply logistics there due to poor infrastructure have added to the problems with palm oil.

Palm oil has no direct use in the food culture in the NE and, if expanded, can destroy the forest-farmer relationship. Currently the forests during the summer months transform into food forest for the indigenous people and farmers; they supplement their diet by adding wild forest industrial palm oil plantations, all native forests will be

will also absorb all the water in the area, disturbing the hydrological balance and water availability for the

Overall, if palm oil is pushed on India, small farmers will be the worst hit. And especially those growing tra-ditional oilseeds like mustard, castor and groundnut. In the current scheme, the Government has highly subsidised palm oil plantation from saplings to growing or processing. Our tax rupees are being used to implant a foreign oil economy in India with the help of a few corporations. The big players have already come forward to support this

Finally, India is at a crossroads. Should we invest this huge resource to promote indigenous oilseeds and edible oils that give us health, taste and benefit our farmers, or allow Big Ag designs to penetrate deeper? We can't have good oils for the elite and push unhealthy, hexanesoaked palm oil on the poor.

FIRST COLUMN AUKUS: A NEW ALLIANCE IS BORN!

This 'alliance' has not been gestating for very long

Inhen the 9/11 happened in 2001 and the US armed forces went on full alert, National Security Adviser Condoleezza Rice got on the direct line to Moscow and told Vladimir Putin not to worry: the United States was not going to attack Russia. Putin replied that he understood, and was standing Russian forces down. When Donald Trump claimed in late October that the election was being stolen, and again after the attempted putsch on 6 January, Gen. Mark Milley, chairman of the Joint Chiefs of Staff, called his Chinese counterpart, Gen. Li Zuocheng of the People's Liberation Army, to reassure him that the United States would not attack China. Rice and Milley were both grown-ups, trying to keep their people safe but operating in an international system that still runs by the rules of our hunter-gatherer ancestors. This is how wise leaders



most of the time, but sometimes they get distracted or confused. And the notion of distraction brings us smoothly to the alliance of the week, AUKUS (rhymes with 'caucus'), which has been cobbled together since the fall of Kabul last month to draw attention away from the shambles attending the American retreat from Afghanistan. You could tell that the three wise leaders involved hadn't spent a lot of time negotiating the nature and role of the new US-UK-Australian alliance, because Joe Biden couldn't even remember the name of the Australian prime minister, Scott Morrison.

There they were, each in his own capital with the other two on screens, and Biden managed to thank Boris Johnson by name, but when it came to Morrison the US president had to fake it: "And I want to thank that fella from Down Under. Thank you very much pal. Appreciate it. "You may say it's just a brain fart, and you might even be right, but there are other indications that this 'alliance' has not been gestating for very long. Consider the case of the French submarines. The French foreign and defence ministers spoke with their Australian counterparts as recently as 30 August and declared: "Both sides are committed to deepen defence industry cooperation and enhance their capability in the region. Ministers underlined the importance of the future submarine program." (In 2016 Canberra agreed to spend \$66 billion to build a dozen French-designed submarines.) It's not unknown for a sovereign state to rat on an international deal, but it's bad form to pledge undying loyalty to a deal just two weeks before ratting on it. When Australia announced last Wednesday that it will build at least eight nuclear submarines using American and British technology instead, French foreign minister Jean-Yves Le Drian called it "a stab in the back." Then there's the fact that the US, the UK and Australia will spend the next 18 months trying to fill in the details of how this nuclear submarine deal and the alliance it serves will actually work. The Chinese responded to the creation of AUKUS just as foolishly, with the state-owned 'Global Times" warning that Australian troops are "likely to be the first batch of Western soldiers to waste their lives in the South China Sea." The US and NATO pull-out from Afghanistan was long foreseen and no big deal, but everybody has lost the plot. Even if we must now talk about 'sides' in the Asia-Pacific region (and we really shouldn't), eight Australian nuclear submarines in fifteen years' time isn't going to make the slightest difference. It's short-term gesture politics of the worst kind, and a number of people deserve to be spanked.

Asset monetisation: Will it take off?



The biggest bottleneck is the cumbersome procedures involved in striking such deals and the accompanying bureaucratic red tape

n her maiden budget presented to Parliament on in 2019, Finance Minister Nirmala Sitharaman laid a roadmap for catapulting the Indian economy to \$5 trillion by 2024-25, its most crucial component being investment in infrastructure to the tune of a mammoth ₹100,00,000 crore (\$1.4 trillion) over a period of five years. Thirty-nine per cent each of this amount was to come from the Centre and States and the balance from the private sector.

The Centre's contribution works out to around ₹40,00,000 crore over five years or ₹800,000 crore per annum. Against this, the revised estimate (RE) for capital expenditure during 2020-21 was ₹439,000 crore. Even assuming that all of this was on building infrastructure, it is just about half of what was required. For 2021-22, the Budget allocation is ₹5,54,000 crore or 70 per cent of what is

This is when the Modi Government kept a generous fiscal deficit (FD) target for these years. From 2022-23 onward, it is committed to return to fiscal discipline aiming to reach 4.5 per cent in 2024-25. That means it will not be able to sustain even the capital spending of 2020-21 or 2021-22. The mandarin in finance ministry are well aware of this. So, they are looking for alternative ways.

One of these is monetization of public assets — both green-field projects as well as brown-field in areas such as roads, highways, railways, ports, power transmission lines, gas pipelines and so on. It involves 'transfer of revenue rights to a private player for a specified period of time say up to 20 years or more in lieu of an upfront (or periodic) payment defined by a 'concession/contractual framework. This way, the Government intends to unlock value and leverage the proceeds from sale of 'revenue rights' for investing in new projects.

It intends to garner over ₹600,000 crore from this exercise. Prima facie, this looks great as with this much money in hand and assuming debt-equity ratio of 4:1 (a jargon for borrowing ₹4 for every one rupee of a person's own money), it can arrange for funding worth ₹24,00,000 crore. If the Government can rope in a private partner contributing an equal amount under a joint venture (JV), projects worth ₹4800,000 crore can be exe-

Since the arrangement only involves selling of the 'revenue rights' and ownership of the asset continues to be with Government, it cannot be dubbed as privatization per se. So, it also escapes any criticism that invariably goes with the mere whisper of any move to sell public assets lock, stock and barrel.

But, chartering the course - as delineated above-is easier said than done.Let us face some harsh realities.

A private firm interested to take an asset say,a road under the proposed

return on the capital he gives to the Government upfront. To get there, it will conduct due diligence to fully satisfy itself about the quality of the asset and its capability to generate a good income (revenue minus expenses) stream during the contract term; enjoy full flexibility in operating the asset that would include inter alia fixing charges for the services rendered by it — free from any outside interference.

The second point can be a bone of contention. When the Government or its agency runs a public utility, it is prone to offering the services at subsidized rates; for instance, fixing passenger fare in case of railways or toll tax (expressway) or power tariff at below the cost of making these available. It also involves offering services on routes which are not lucrative. The under-recovery arising there from is normally paid from the budget. The unpaid amount if any, remains on the balance sheet of the agency to be eventually cleared as and when funds are released from the exchequer.

When the asset is transferred to a private operator, he would like to take it free from any of these encumbrances. He would also seek full immunity from any untoward incident (for instance, protestors laying siege on toll plazas at national highways during farmers' agitation). In fact, the bidder will insist on inclusion in the concession/contractual framework, all safeguards necessary to protect his interest during the pendency of the lease period.

If the Government is unable to give these assurances, the deal will come unstuck. In case the bidder decides to go ahead sans these safeguards, he will build in a very high rate of return in his financial calculations to compensate for all the associated risks leading to a very low bid amount for the asset. In either case, the asset monetization program will turn out to be a damp squib. The proof of the pudding is

In August 2021, the Government had put up for auction 109 railway passenger routes offering rights to run passenger services for 35 years hoping to garner ₹30,000 crore. The exercise ended up in a fiasco as the bidders backed out 'citing rules favoring the national transporter, lack of a truly independent regulator, curbs on route flexibility and other unresolved

In early 2019, the Prime Minister's Office (PMO) had proposed to the National Highway Authority of India (NHAI) to stop construction and instead, focus on monetization of the assets already built. The PMO had recommended auction of all completed projects under the so-called toll operate and transfer (TOT) model. Under this, private companies were to take over completed roads for 10 to 20 years and make an upfront payment to the NHAI. Two years on, there is hardly any progress.

Things are unlikely to change overnight.

To conclude, what appears to be an attractive proposition on the face of it, is not so in reality. The biggest bottleneck is cumbersome procedures involved in striking such deals and accompanying bureaucratic red tape. Moreover, an overarching stipulation that' the ownership of the asset remains with the Government' makes the typical babu's role even more excruciating. In the name of protecting state interest, he or she goes on increasing the clauses in the agreement — to a point of vexing the bidder.

There is dire need to bring about a drastic change in the way Indian bureaucracy works. Prime Minister Narendra Modi should drive bureaucrats to be 'resilient' and 'pragmatic' in their approach. This could help in untangling many a knot and improve investor confidence.

The Government also needs to reform the way subsidies in India are administered. Currently, this is done by pricing services or utilities, viz., passenger fare, power tariff, toll tax at below the cost of making these available or the market price. This must stop. Instead, it should give subsidy 'directly' to the beneficiary as income support and leave suppliers to fix tariff based on market forces.

any a time, deliverv of justice in high LV I profile corporate cases is curious and subject of debate. The interplay of jurisprudence, facts, merits and delivery of justice in such cases is always debated. In the past few years, one such high profile commercial dispute is Ratan Tata Vs

Cyrus Mistry Many opine that the apex court's decision was not wellfounded for a variety of reasons. Not in the least because it casts aside the well settled law that directors owe fiduciary duties to the company and not to the shareholders nominating them. The main argument is Supreme Court has entered into the domain of fact-finding of National Company Law Appellate

foremost a court of law. Its jurisdiction under Section 423 of the Companies Act, 2013 is to decide "questions of law" emanating from the orders of the NCLAT. Identical provisions are found in many statutes and serve an important objective of shutting out appeals that do not involve questions of law from engaging the Supreme Court's precious judicial time.

The Supreme Court is not expected to, and indeed should not, get embroiled in the facts of a particular case or re-appreciate the evidence afresh. But that is exactly what the apex court has done here and without any sound legal basis. The result is that a



golden opportunity to lay down legal principles that corporate India can be guided by, has been missed.

While it may be argued that questions of fact and questions of law are sometimes mingled, it is wrong to say there is no distinction between the two. A simple example, in the context of this

case, will make the distinction findings of fact only if the of fact of the NCLAT called overlooked this well-settled clear. Whether Cyrus Mistry was removed because of his lack of performance (as the Tatas claimed) or because he resisted interference by a super board (as the SP Group claimed) is a question of fact as indeed is the question whether the manner of his removal and the methods employed for this purpose lacked probity. The NCLAT answered both questions in the SP Group's favour.

The Supreme Court was required to evaluate what was the legal effect of the NCLAT findings. Did they make out a case of oppression in law and, if they did, whether the reliefs granted by the NCLAT were justified, as a matter of law? A court of law can interfere with the explaining why the findings

findings were either based on no evidence or were perverse, i.e., the finding was so shocking that no reasonable fact could have been arrived at on the basis of evidence before it. Ironically, the Court acknowledged this to be the correct test but abandoned the principle altogether.

Supreme Court's decision is replete with findings/ comments on the list between the parties. Each of these findings/comments fall within the domain of pure questions of fact that are not matters the Court ought to have waded into. The Court has re-appreciated the evidence de-novo and, in the process, disturbed

for interference.

Tribunals like the NCLAT exercise the jurisdiction that High Courts formerly did. Challenge to the constitutional validity of provisions that make NCLAT the final factfinding body was repelled bya Constitution Bench of five judges of the Supreme Court in a landmark case of Madras Bar Association v Union of India. In this case, the apex court found it perfectly reasonable that the NCLAT (comprising judicial members on par with the judge of High Court) was empowered to decide all questions of fact and law whereas an appeal

Supreme Court would lie only on questions of law. But the judgment has

practice. What could explain this deviation from established principle of judicial reticence of a court of law to the trier of fact (fact finding by jury or judge by evidences)? Part of the problem lies in the Court perhaps viewing this high-profile corporate case more as a battle between two personalities – a patriarch and his anointed successor — rather than an issue involving the rights and duties of a majority and minority shareholders of India's biggest corporate house. Simply the apex court considered emotional issues rather than looking into the facts found by the appellate tribunal, which is not a good symptom for corporate governance in professional ways.

US launches mass expulsion of Haitian migrants from Texas

AP DEL RIO (US)

The US is flying Haitians camped in a Texas border town back to their homeland and blocking others from crossing the border from Mexico in a massive show of force that signals the beginning of what could be one of America's swiftest, large-scale expulsions of migrants or refugees in decades.

More than 320 migrants arrived in Port-au-Prince on three flights Sunday, and Haiti said six flights were expected Tuesday.

In all, US authorities moved to expel many of the more 12,000 migrants camped around a bridge in Del Rio, Texas, after crossing from Ciudad Acuña, Mexico.

The US plans to begin seven expulsion flights daily on Wednesday, four to Port-au-Prince and three to Cap-Haitien, according to a US official who was not authorized to discuss the matter publicly.

Flights will continue to depart from San Antonio but authorities may add El Paso, the official said.

The only obvious parallel for such an expulsion without an opportunity to seek asylum was in 1992 when the Coast Guard intercepted Haitian refugees at sea, said Yael

Refugees International whose doctoral studies focused on the history of US asylum law.

Similarly large numbers of Mexicans have been sent home during peak years of immigration but over land and not so

Central Americans have also crossed the border in comparable numbers without being subject to mass expulsion, although Mexico has agreed to accept them from the US under pandemic-related authority in effect since March 2020. Mexico does not accept expelled Haitians or people of other nationalities outside of Mexico, Guatemala, Honduras and El Salvador.

When the border was closed Sunday, the migrants initially found other ways to cross nearby until they were confronted by federal and state law enforcement.

An Associated Press reporter saw Haitian immigrants still crossing the river into the US about 1.5 miles (2.4 kilometers) east of the previous spot, but they were eventually stopped by Border Patrol agents on horseback and Texas law enforcement officials.

As they crossed, some Haitians carried boxes on their heads filled with food. Some removed their pants before

"In Haiti, there is no security," said Fabricio Jean, a 38year-old Haitian who arrived in Texas with his wife and two daughters.

ISIS terrorists claim attacks on Taliban

Cairo: The extremist Islamic State group has claimed responsibility for a series of deadly bombings targeting Taliban vehicles in eastern Afghanistan. The claim, published late Sunday on the militant group's media arm, the Aamaq news agency, signals a growing threat to the Taliban by their long-time rivals.

At least eight people, including several Taliban fighters, were killed in the attacks on Sunday and Saturday in the provincial city of Ialalabad, an IS stronghold.

The Taliban seized control of Afghanistan in a blitz campaign last month, overrunning the capital of Kabul while U.S. And NATO were in the final phase of withdrawing their troops. **AP**

Vaccinated people from countries like India can now travel to the US with proof of their vaccination before they start flying for the United States, White House officials said. "Today we're announcing a new international air travel system. This new system includes strict protocols to prevent the spread of Covid-19 from passengers flying into the United States, protecting Americans and making international air travel safer," White House Covid-19 Response Coordinator Jeff Zients told reporters during a virtual news

The United States, he said, with science and public health as its guide, has developed a new international air travel system that both enhances the safety of Americans here at home and enhances the safety of international air travel.

"Most importantly, beginning in early November, foreign nationals flying to the United States will be required to be fully vaccinated and they must show proof of vaccination prior to boarding a US bound airplane," he said.

Responding to a question on the existing quarantine requirements and travel ban from countries like India, Brazil, United Kingdom, China, Iran and South Africa, Zients said early November the United States will move to this new and much stricter global system. "It will require for nationals to be vaccinated, to prove they're vaccinated, and then to go to the testing and contract tracing regimens," he said.

"That's right, for (fully) vaccinated travellers it is not required to be a quarantine going forward," he said in response to another question.

Nearly six billion Covid-19 vaccines have already been administered globally, he said, adding that the US is leading the effort to get even more shots and arms across the

The Sensex plunged 525 The Sensex plunged 525 points while the Nifty finished below the 17,400-mark on Monday, reflecting the sombre mood in global markets ahead of a flurry of central bank meetings which are expected to provide cues on the imminent tapering of massive stimulus measures.

A sharp drop in the rupee added to the woes, traders said, adding that worries over the fate of Chinese real estate major Evergrande and its impact on the world's second largest economy pulled down global commodity prices.

Sliding for the second consecutive session, the 30-share BSE Sensex ended 524.96 points or 0.89 per cent lower at

The broader NSE Nifty tumbled 188.25 points or 1.07 per cent to close close at

Tata Steel was the top loser on the Sensex chart, crashing 9.53 per cent, followed by SBI, IndusInd Bank, HDFC, Dr Reddy's, M&M and UltraTech Cement.

The HDFC twins and Tata Steel accounted for over half of the benchmark's losses.

In contrast, HUL, Bajaj

India, Bajaj Finance and RIL managed to close in the green, climbing up to 2.84 per cent.

Govt clears sugar export subsidy worth ₹1,800 cr this season

The Centre has so far cleared ₹1,800 crore in subsidy to sugar mills for undertaking a mandated export of 6 million tonnes of the sweetener in the 2020-21 season-ending this month, according to a senior Food Ministry official.

The Government had to offer export subsidies during the last three seasons to reduce surplus stocks and help cashstarved sugar mills clear cane payments to growers on time. It offered subsidies for the export of a fixed quota of sugar. "About ₹3,500 crore budget was allocated towards export subsidy for the ongoing season. Out of which, ₹1,800 crore has been spent on clearing the subsidy claims," the official told PTI.

The balance subsidy will be paid to mills soon, once the funds are released from the finance ministry, he said.

The official said mills have already exported the entire quota of 6 million tonnes set for the current 2020-21 season. They have also exported sugar without subsidies taking advantage of the firm global trends.

This has encouraged mills to clear ₹8,300 crore cane price dues to farmers so far in the current season, against the total

said, adding that the balance will also get cleared by the mills.

Exports were undertaken smoothly even as the govern-ment slashed subsidies on sugar exports for the current season from ₹6,000 per tonne to ₹4,000 per tonne because of firm international prices.

On the pending subsidy claims of the 2019-20 season, the official mentioned that Rs 5,000 crore subsidy claims were cleared so far. The balance of Rs 1,200 crore will be paid to mills in the next two months.

Going forward, the government has decided not to offer subsidies in the new season 2021-22, beginning October onwards, as the international sugar prices are ruling firm -owing to likely shortage of the cane crop in the world's largest sugar producing nation Brazil.

Recently, Food Secretary Sudhanshu Pandey in a press briefing had said there was no need for subsidies for undertaking sugar exports in the 2021-22 season.

According to the ministry, the country's sugar production is likely to remain flat at 30.5 million tonnes in the next 2021-22 season as more sugarcane will be diverted for ethanol making.

illions of people all over the world suffer from Alzheimer's disease which makes it a global crisis. In India, more than 5.3 million have some form of dementia (a condition in which memory, communication, thinking and social abilities tend to deteriorate), most of which result from Alzheimer's disease. According to a report published by the Alzheimer's and Related Disorders Society of India (ARDSI), the number of people suffering from Alzheimer's disease is expected to reach 7.6 million in India. The disease mainly affects the elderly where a combination of environmental and genetic factors usually lead to its inception. While there is no cure available for this disease, medication and cognitive retraining in the early phases can help slow its progression.

The present population of India is estimated to be around 1.39 billion with the elderly population expected to touch 13.1 per cent in 2031. With demographic ageing, India will have to bear the brunt of dementia which will only go up as the years pass on. In 2015, there were nearly 4.1 million persons in India aged over 60 years who had dementia. This is estimated to rise to 6.35 million by 2025 and 13.33 million by 2050. The proportion of dementia within the age group of 60-75 years is expected to rise steadily over the coming decades which will further have a devastating impact on the healthcare system of the country. With a lack of awareness, priority and treatment for Alzheimer's in India, India will face the right direction.

Scientists have identified different variants of genes that increases the possibility of developing Alzheimer's disease. parents affected with Alzheimer's. While it is still not completely understood as to what causes Alzheimer's to run in families, genetics, lifestyle and environmental factors may all play a part. Cardiovascular Disease

The health of the brain is closely associated The chances of developing the disease to the health of the blood vessels and heart. The

heart pumps blood which provides nutrients and oxygen to the brain. Thus, factors that lead to cardiovascular disease also may be linked to a higher risk of developing Alzheimer's such as obesity, diabetes, smoking, high cholesterol and high blood pressure.

• Traumatic Injury to the Brain

The risk of developing Alzheimer's disease increases to a certain extent after a severe or moderate traumatic brain injury, like an injury of the skull or blow to the head that causes loss of consciousness for more than 30 minutes.

Treatment and support

Presently, there are no treatments available to stop the brain damage caused by Alzheimer's disease. However, different medications are available that can temporarily help improve the symptoms of dementia. These medications primarily work by increasing neurotransmitters in the brain. Research is underway to find better ways to treat Alzheimer's and other progressive dementias. Currently, lots of pharmacologic treatments and therapies are also being worked upon to focus on stopping the brain cell death associated with Alzheimer's disease.

The use of behavioural interventions can go

a long way in improving the quality of life for both people with Alzheimer's and their caregivers and families. This may include:

*Treating coexisting medical conditions * Improvement in the mood by participating in activities

* Behavioural interventions that can help *Engaging the affected person in conver-

*Involving the person in regular exercise activities like swimming, walking, etc.

Considering the present situation of Alzheimer's disease in India, it is imperative to carry out a thorough pan-India investigation into the current incidence and burden of Alzheimer's. It is also the need of the hour to provide genetic testing services for the Alzheimer disease's gene (APOE-e4) and fund clinical trials. As Alzheimer's can have a variety of risk factors including genetic, environmental and lifestyle, clinical trials specific to the country are required without relying on those conducted in developed nations. A better knowledge of risk factors would likely influence patients and family members to seek treatment early and allow healthcare professionals to detect the disease early on.

Dementia amidst pandemic

During the time of COVID-19, people with dementia faced various difficulties such as disruption of medical services. DR VIVEK NAMBIAR talks about other challenegs also faced

¬he Brazilian study published in 2021 showed that there is three times increased mortality in patients of covid if they have concurrent dementia. A similar picture has been seen in England and Wales that there was a significant high death among dementia patients. So, COVID and dementia is a challenge. Even though COVID affects elderly people, they are still prone to Alzheimer's because their brain is vulnerable to the virus and further immunological damage. Also, they will have other concurrent illnesses like pneumonia, and all this can make these people more prone to death. So, the mortality of Alzheimer's disease is much more when they get COVID-19 infection.

On the other hand, if we look at the age wise prevalence of dementia about 2% of people belonging to the age group of 60-70 have dementia. Also, when 70 progresses to 80 - 90 years, there is 20% prevalence of dementia and

34% of prevalence of dementia in

people above the age of 90 years.

Thus, it is very evident that with

the rise of age, prevalence of

dementia increases and the majority of these dementias are Alzheimer's disease.

A pre runner of dementia is called minimal cognitive impairments (MCI). MCI is a condition where certain membrane impairment does not amount to the disruption of normal life. This type of mild cognitive impairment is actually the start of brain deterioration for memory faculty. So, there will be certain difficulties in the memory, language, reasoning, and personality in these patients. so gradually it will gain momentum and one third of the people can progress to dementia and one third will remain in the same state of mild impairment without social disruption and others will sometimes improve also, so the annual conversion rate of the MCI to dementia in community samples is about 10%. The prevalence of MCI in Indian studies is about 14-25%. This is what numerous studies across India from 2007-2019 show. But, out of this, only 10-15 % progress to dementia. They can get good medical atten-

tion to begin with and can identi-

fy the cause of dementia, if they can have medication to prevent the progression from MCI to the complete dementia.

The percentage of elderly people population is high in Punjab, Karnataka, Andhra Pradesh, and Kerala. In 2021, the percentage of people with dementia is extremey ĥigh in Maharashtra, West Bengal, and Andhra Pradesh. The number of elderly people with MCI likely to develop dementia in one year is maximum in Andhra Pradesh, Uttar Pradesh, and Maharashtra.

Proper neurological assistance and diagnosis of dementia is of paramount importance because when somebody experiences memory impairment consistently and starts disrupting his normal life, then they should consult a proper specialist to assess the function, conduct various memory tests and if it is found to be low, then he has to undergo proper evaluation.

Then there will be hormone deficiency hypothyroidism, nutritional deficiencies and sometimes liver diseases can make our memories slow and patients get confused. At times, a simple CT scan will prove especially useful to identify subdural hematoma. Subdural hematoma is caused by a head injury strong enough to burst blood vessels. This can cause pooled blood to push on the brain.

These all are treatable to considerable extent and there is substance abuse like alcohol, heavy metal poisoning, which all can cause dementia. The identification of these potentially reversible things will really help to change the life of people who are affected by memory impairment. And in patients who have been diagnosed with dementia, there are several medications to reduce the progression of dementia and improve the quality of life. The major challenge of the health care system in India would be to support these upcoming enormous numbers of dementia people with various disabilities. The number of care homes even in metropolitan cities is much insufficient to cater the enormous number of potentially disabling patients.

Gathered at the second Sepsis Summit India 2021, organised by the leading health awareness institution Integrated Health & Wellbeing (IHW) Council, they emphasized on the need for awareness and early diagnosis as well as controlling the rampant use of antibi-

"Sepsis is the most preventable cause of death. Affecting nearly 50 million and killing almost 11 million out of them annually, sepsis takes life every 2.8 seconds. More people are vulnerable to sepsis than to cancer or cardiovascular diseases because it can be caused by many common diseases such as dengue, malaria, UTIs or even diarrhoea. Among most of the deaths caused in the ongoing COVID-19 pandemic, some can be attributed to this dysregulated immune response. A significant burden of sepsis cases comes from middle income countries of which India is a part," said Mr Kamal Narayan, CEO, Integrated Health and Wellbeing (IHW) Council.

The World Health Organization defines sepsis as a syndromic response to infection that killed nearly 11 million people worldwide in 2017, and accounted for about 20 per cent

of all global deaths.

Then I imagine love, I think of big gestures or poetic words encased in romantic sonnets. There is an automatic film of bright hues that slides in front of my eyes which makes me view everything through rose-tinted glasses. Let alone experiencing the feeling, but the very thought of it sends my stomach affluter with an incomprehensible feeling of joy. But can we imagine love any other way? Well, on a breezy Sunday evening,

Written by actor-cum-playwright Manav Kaul, *Chuhal*, a strange tale of love blossoming between two dissimilar individuals, was brought to life by the Alternative Space Project. And Í, being the hopeless romantic I am, was awestruck to see a kind of love I never knew could exist.





BCCI's sexual harassment policy brings players within its ambit

The BCCI on Monday ratified a comprehensive Prevention of Sexual Harassment (POSH) policy which also brings the Indian cricketers within its ambit. Until now, the BCCI did not

have a specific policy to deal the matters of sexual harassment. The policy is also applicable to office-bearers, members of Apex Council and IPL Governing Council besides the cricketers from senior to U-16 level. In a nine-page document in possession of IC shall be a woman employed

four member Internal Committee will be formed to investigate sexual harassment complaints. It did not name the members during its Apex Council meeting on Monday. "The presiding officer of the

Workplace ("Presiding Officer")," reads the policy.

"2 members of the IC will be selected from among the employees, preferably who are committed to the cause of women or have experience in social work or have legal

"1 member of the IC will be selected from a Non-Governmental Organization or association committed to the cause of women or a person familiar with issues relating to sexual harassment ("External Member"). At least

IC will be women." The complainant must file the complaint within three months from the date of incident and the IC will give seven working days to the accused to respond to the allegations. The respondent gets 10 days to respond.

The ICC gets 90 days from the date of complaint to complete its inquiry and forward its recommendations to the BCCI which will act on it within 60 days. The complainant or respondent can go to court if they are not satisfied with BCCI's verdict.

England too calls off Pak tour over security concerns

London: England on Monday called off next month's men's and women's tours of Pakistan, three days after New Zealand abandoned their whiteball series in the South Asian country over security concerns. The England and Wales Cricket Board (ECB) arrived at the decision to withdraw after deliberating over the weekend, pulling out of what would have been the country's first tour of Pakistan since 2005. The England men's team had been due to play back-to-back T20 Internationals on October 13 and 14 as part of their preparations for the World Cup that starts in the UAE the following week, while the women's side were scheduled to play two T20 Internationals and three ODIs.


utes later when he crossed for Karim Benzema to score off his shoulder, Xinhua reports.
