India warns UK of tit for tat on Covishield stand

UK quarantine rule for Indians 'discriminatory', says New Delhi

PNS NEW DELHI

Taking strong exception to the UK Government not recognising the Covishield vaccine and mandating even those Indians who received both its doses to undergo 10 days of self-isolation after their arrival to that country, India on Tuesday termed it as a "discriminatory policy" and warned of a "reciprocal" action.

Sounding this stern note, Foreign Secretary Harsh Shringla also said External Affairs Minister S Jaishankar discussed the issue with his British counterpart Liz Truss in New York on Monday. The issue was likely to be resolved soon following certain assurances, Shringla said. "Urged early resolution of quarantine issue in mutual interest, Jaishankar tweeted after he

Enunciating India's position, Shringla said the UK decision to not recognise Covishield is a "discriminating policy" thereby creating trou-



to England.

In an announcement on Monday, the UK said Indian travelers, who have received both doses of the Covishield, will be considered unvaccinated and will have to undergo self-isolation for 10 days there.

'The non-recogition of Covishield is a discriminating policy and impacts our citizens travelling to the UK. The External Affairs Minister has raised the issue strongly with

ble for the Indians travelling the new UK foreign secretary," Shringla said.

Adopting a tough stance, he also cautioned the UK that India is well within its rights to resort to reciprocal action over the new Covid rules.

Addressing a news conference here, the Foreign Secretary said, "The basic issue is that, here's a vaccine -Covishield — which is a licensed product of a UK company manufactured in India of which we have supplied five million doses to the UK at the

if we don't get satisfaction we would be within our rights to impose reciprocal measures."

The new UK rules said the current "traffic light system" of red, amber, green countries based on levels of Covid-19 risk will be replaced by one red list of countries from October 4 India is currently on the amber list and the expanded list of countries whose vaccines are recognised in the UK does not include India.

The British Commission in New Delhi has said the UK is working with India on ways to resolve the issue of the Covid-19 vaccine certification issued by Indian authorities.

"We are engaging with the Government of India to explore how we could expand UK recognition of vaccine certification to people vaccinated by a relevant public health body in India," a British High Commission spokesperson

"The UK is committed to opening up international travel again as soon as is practicable and this announcement is a further step to enable people to travel more freely again, in a safe and sustainable way, while protecting public health," okesperson added.

13 High Courts to get new Chief Justices

SC Collegium elevates 8, transfers 5

PNS NEW DELHI

The Supreme Court Collegium on Tuesday officially released its recommendations that would see as many as 13 High Courts getting new Chief Justices, with eight being elevated and five incumbents getting transferred.

This apart, the Collegium also recommended the transfer of 17 High Court judges. The recommendations need the Centre's assent.

The Collegium, headed by Chief Justice NV Ramana and consisting Justices UU Lalit and AM Khanwilkar, recommended the elevation of Justices Rajesh Bindal, Ranjit V More, Satish Chandra Sharma, Prakash Srivastava, RV Malimath, Ritu Raj Awasthi, Aravind Kumar and Prashant Kumar Mishra as Chief Justices of the High Courts of Allahabad, Meghalaya, Telangana, Calcutta, Madhya Pradesh, Karnataka, Gujarat Andhra Pradesh respectively.

In another statement, uploaded on the SC website, the apex court provided the list

 ■ death of Akhada Parishad chief Mahant Narendra Giri remains unresolved even after 24 hours even as some disciples of the Mahant, including Chhote Mahant and Yoga guru Anand Giri, besides some local politicians and property dealers, have been detained for interrogation

Amid the clamour of a probe by the CBI or by a sitting judge of the High Court into the matter, the UP Government ordered an SIT investigation into the incident.

Initially, police did not release the alleged suicide note on the pretext that it was being examined thoroughly by the forensic team to ascertain whether or not it was written by the Mahant, but by evening officials of the Home department released the suicide note in Lucknow.

2 Army pilots die as Cheetah crashes in **Patnitop area**

 $T_{\text{Army's Aviation Wing suc-}}^{\text{wo pilots of the Indian}}$ cumbed to their injuries after crashed in Shivgarh Dhar area near Patnitop tourist resort in Udhampur district possibly due to bad weather on Tuesday.

Locals who evacuated the oilots, along with the Jammu & Kashmir Police rushed the injured pilots to a nearby motorable road from where they were shifted to a military hospital.

According to a Jammu-based Defence PRO, Lt Col Devender Anand, "During a training sortie in Patintop area on Tuesday, Indian Army Cheetah Helicopter crash-landed in Shiv Garh Dhar area in Udhampur district. Both the pilots were critically injured during helicopter crash landing, evacuated to the nearest medical facility but later succumbed to their injuries".

The officers who sacri ficed their lives in the line of duty have been identified as Major Rohit Kumar and Major Anuj Rajput.

NDA to open doors for women in 2022

Covid spread on wane, R-Value sinks to below 1

The R-value, which reflects the Covid pandemic, has dropped to below "1" in most States in India. However, it continues to hover above "1" in Mumbai, Kolkata, Chennai and Bengaluru.

It dropped in almost all the regions to 0.92 by mid-September after spiralling over 1 in August-end, according to researchers. The R-value of Delhi and Pune are below 1.

The R-value was 1.17 at the end of August. It declined to 1.11 between September 4 and September 7 and since then it has remained under 1.

'The good news is that India's R-value has continued to be less than 1, as is that of Kerala and Maharashtra, the two States having the highest number of active cases," said Sitabhra Sinha of the Institute of Mathematical Sciences, Chennai. Sinha is leading a team of researchers who calculate the R-value.

R-value of Mumbai stands at 1.09, Chennai 1.11, Kolkata 1.04, Bengaluru 1.06. The Reproduction number or R refers to how many people an infected person infects on average. In other words, it tells how

'efficiently' a virus is spreading. After the devastating second wave that saw hospitals and health infrastructure being

overwhelmed by the patients infected with SARS-CoV2 coronavirus, the R-value started to decline. During the March-May period, thousands of people died due to the infection, while lakhs were infected. Continued on Page 2

India, France to 'act jointly' to keep **Indo-Pacific stable**

New Delhi: India and France have agreed to "act jointly" in the Indo-Pacific to keep the region stable, rules-based and free of any hegemony, the French president's office said on Tuesday after Emmanuel Macron held a telephonic conversation with Prime Minister Narendra Modi amid Paris strong criticism of Australia-UK-ŬS (AUKUS) partnership and Australia's cancellation of a \$40 billion French submarine According to a statement

released by the Prime Minister's Office here, Modi and Macron reviewed the increasing bilateral collaboration in the Indo-Pacific region and the important role that the India-France partnership plays in promoting stability and security in the Agencies

Trudeau's party wins Canada vote, fails to get majority

Toronto: Prime Minister Justin Trudeau's Liberal Party secured victory in parliamentary elections but failed to get the majority he wanted in a vote that focused on the Covid but that many Canadians saw as unnecessary. Trudeau entered Monday's

election leading a stable minority Government that wasn't under threat of being toppled but he was hoping Canadians would reward him with a majority for navigating the pandemic better than many other leaders. Still, Trudeau struggled to justify why he called the election early given the virus, and the opposition was relentless in accusing him of holding the vote two years

Woman gets no berth in Taliban interim Cabinet

Kabul: The Taliban expanded their interim Cabinet by naming more Ministers on Tuesday, but failed to appoint any women, doubling down on a hard-line course despite the international outcry that followed their initial presentation of an all-male Government lineup earlier this month.

The international community has said it will judge the Taliban by their actions, and that recognition of a Talibanled Government would be linked to the treatment of women and minorities. In their previous rule of Afghanistan in the late 1990s, the Taliban, who adhere to a harsh interpretation of Islam, had barred girls and women from schools, work and public life.



Committee to draft Air Marshal VR new curriculum framework formed

The Centre on Tuesday started the process to revise NCERT textbooks by setting up a National Steering Committee for drafting the guiding document that will inform the changes in the school curricu-

The 12-member committee, which has a three-year term, will be headed by former ISRO chief K Kasturirangan, who also headed the drafting committee of the National Education Policy (NEP) 2020.

The document, known as the National Curriculum Framework (NCF), was last prepared in 2005. The NCF lays down broad guidelines for school syllabus and text-

Prime Minister Narendra Modi had announced last year that school students will study under a new curriculum drawn from the NEP by 2022. Ministry of Education said that the NCF will be drafted "as per the perspectives of the NEP".

"As per the perspectives of the NEP 2020, the Committee will develop four National Curriculum Frameworks- i.e., the National Curriculum Framework for School Education, National Curriculum for Early Care and Education. National Curriculum Framework for Teacher Education and National Curriculum Framework for Adult Education," the statement detailing the terms of references of the committee said.

Traditionally, the state governments also follow the NCF in revising their respective school curriculum by involving the State Councils of Educational Research and Training (SCERT) which draw up the State Curriculum Frameworks (SCF). The newly constituted NCF has also been directed to draw inputs from the SCFs.

Chaudhari to be new IAF chief

New Delhi: The Government on Tuesday announced that Air Marshal V R Chaudhari, presently Vice Chief of IAF, will succeed RKS Bhadauria, who retires on September 30.

Chaudhari was commissioned into the Fighter stream of Indian Air Force on in December, 1982 and has held various Command, Staff and Instructional Appointments at various levels including the present one as Vice Chief of Air Staff.

He has flying experience of more than 3,800 hours of flying on a wide variety of fighter and trainer aircraft, including missions flown during Operation Meghdoot and Operation Safed Sagar. Chaudhari is an alumnus of National Defence Academy(NDA) and Defence Services Staff College(DSC), Wellington.

As an Air Vice Marshal, he has been Deputy Commandant, Air Force Academy, Assistant Chief of Air Staff Operations (Air Defence) and Assistant Chief of Air Staff (Personnel Officers). He has also held important appointments of Deputy Chief of the Air Staff at Air Headquarters overseeing capital procurements and Senior Air Staff Officer at Eastern Air Command. He was the Air Officer Commanding-in-Chief of Western Air Command before taking over the present appointment as Vice Chief in July this

This is beginning of the change of current line of Service Chiefs with the Navy Chief Admiral Karambir Singh set to retire end November and Army Chief Manoj Naravane in service till April 2022. Incidentally, all the current chiefs are from the same batch of the NDA.

Black fungus: 3,900 people in Karnataka infected so far

Sudhakar on Tuesday said 3,900 people in the state have been infected by black fungus

"Mucormycosis, also known as black fungus infections, are found after recovery from Covid-19 and 3,900 people have been infected in the state so far," Sudhakar said.

Responding to a question raised by Congress MLA from Bhalki, Eshwara Khandre,

in the assembly, he said, considering the treatment for the black fungus infection being costly, the government has decided to provide free

"96,060 vials of Liposomal amphotericin (the drug required for black fungus) has been procured, and 51,000 have already been distributed to districts," he added

Regarding shortage in supply of drugs for black fungus in Bidar district, the Minister said there is no shortage of Liposomal amphotericin, but there is shortage of Posaconazole.

'As many as 6,800 Posaconazole tablets we have procured and 6,704 has been sent to districts, but we need more, already indent has been raised, in 3-4 days once we get, it will be sent to districts including Bidar," he added. PTI

Gui HC asks Rlys to give details on impact of railway line passing through Gir Sanctuary on Asiatic lions

Ahmedabad: The Gujarat High Court on Tuesday directed the Indian Railways to file a detailed affidavit on the impact of the proposed broad-gauging and electrification of railway track passing through the Gir Sanctuary on the Asiatic lions and other wildlife in the region. The division bench of Justices N V Anjaria and A P Thaker observed that the measures to protect the Asiatic lions, the pride of not just Gujarat but the entire Asia, is not only expected from the Gujarat government, but from all the authorities who operate within the sanctuary area.

The bench directed the Railway authorities to file an affidavit exhaustively dealing with all aspects of the impact the railway line passing through the Sanctuary has had.

The court was hearing a civil application on the impact of the proposed broad gauging and track electrification of the railway lines and laying of pipelines for gas, oil and opti-

The Railway authorities are expected to make their stand clear by furnishing on oath details about the present railway line passing in the area, the frequencies thereof, the density of passengers, mishaps, if any, which have occurred involving lions because of the running of the trains, the court said in its order.

Assam orders enquiry into **Bodoland** encounter

Guwahati: Assam Government on Tuesday ordered an enquiry into the killing of two alleged United Liberation of Bodoland (ULB) militants by policemen, a day after a 12-hour bandh to protest the death brought life in the four districts of the Bodoland Territorial Region (BTR) to a standstill.

An order issued by Assam Government said Divisional Commissioner of Lower Assam Iavant Narlikar has been directed to inquire into the circumstances leading to the death of two suspected ULB militants in an encounter with the police at Ultapani in Kokrajhar district on September 18.

Narlikar was tasked to submit the report within 15 days. The killing of the two suspected militants evoked widespread protests in the BTR with a 12-hour bandh called by All Bodo Peoples (ABP) shutting down normal life in Monday.

BJP has put J&K on sale, divided people on religious lines: Mehbooba

Accusing the BJP of "dividing" Jammu & Kashmir on religious lines, PDP president Mehbooba Mufti on Tuesday alleged that the Union Territory has been put on sale by the central government.

Jammu & Kashmir has been put on sale by the government for the people from outside. They want us to become bankrupt in order to make us dependent on (people from) other states," Mufti told reporters here.

The Peoples Democratic Party (PDP) chief claimed all projects which were launched

during her tenure as the chief minister of the erstwhile state have been halted by the BIP-led government at the Centre.

"The contracts of liquor businesses under the excise policy have been given to outsiders. Liquor will be consumed by the people of Jammu and Kashmir but the profit will be go to outsiders," she alleged.

She claimed all big projects, including mining contracts, have been allotted to outsiders.

Mufti, who is supporting the Jammu traders' call for bandh on Wednesday against the opening of Reliance retail stores in the city, said the shops will destroy small businesses.

The apex court was hearing a plea filed by advocate Kush Kalra which has raised the issue of exclusion of eligible and willing female candidates from joining the prestigious NDA solely on the ground of sex which allegedly is a violation of fundamental right of equality.

The plea said the authorities allow unmar-

ried male candidates having adequate 10+2 qualification to take the 'National Defence Academy and Naval Academy Examination, but eligible and willing female candidates are not allowed to take the examination on the sole ground of their sex and without any reasonable or justifiable explanations within the Constitution.

It alleged that this act of discrimination is a dishonour committed by the concerned authorities to the Constitutional values of equality and non-discrimination.

The petition stated that UPSC conducts the 'National Defence Academy & Naval Academy Examination' and as per eligibility criteria, any unmarried male candidate with the required educational qualification and aged between 15-18 years can appear in it. The plea said the candidate, on qualifying

the examination and on successful completion of training at the NDA and subsequent training at the respective academy of the service the cadet opts for, gets commissioned into the service as a permanent commissioned officer by the age of 19-22 years old. This opportunity to take the NDA and Naval

Academy Examination at the age of 15-18 years, with the eligible academic qualifications is not available to eligible and willing female candidates and the sole reason for this categorical exclusion is on the basis of their sex, the plea said.

DUE TO MEDICAL OXYGEN SHORTAGE DURI

HC gives AAP nod to set up probe panel

¬he Delhi High Court on The Delni riigii court on Tuesday said it saw no difficulty in the constitution of a high powered committee (HPC) by the AAP Government to probe the deaths caused by an alleged medical oxygen shortage dur-ing the second wave of Covid-19 pandemic.

The court, dealing with a plea to operationalise the HPC, noted Delhi Government's stand that the committee would not attribute any fault to any hospital and any compensation will be paid and absorbed by the Government alone.

It further recorded that as per Delhi Government, the criteria for determining compensation will be open to scrutiny and its task would not overlap with that of a subgroup constituted by the Supreme Court on allocation and utilisation of oxygen. "In light of the aforesaid,

we see no difficulty in the HPC constituted by GNCTD in discharging its assigned role," said a bench of Justices Vipin Sanghi and Jasmeet Singh which opined that it was not necessary to await the order of the Supreme Court in relation to the grant of ex gratia com-



pensation in terms of guidelines issued by National Management Authority (NDMA).

'The intent of the GNCTD in issuing the May 27 order (on constitution of HPC) is not to grant ex gratia amount to Covid-19 victim. A perusal of the order would show that the purpose is to examine each complaint/ representation received by the committee in relation to the death of a Covid-19 patient due to lack of oxygen... We do not think it is necessary for us to await the order of the Supreme Court with regards grant of ex gratia compensation to be paid to a victim as decided by NDMA," the court stated.

The court clarified that in case an amount larger than what is being paid presently as ex gratia compensation is fixed by the NDMA, the "same would also be payable to the

The court went on to record that after keeping its decision to constitute a HPC in abeyance, the Delhi government has "expressed its intention to reinstate" it, however, "due to the difference in opinion (with regards the scope of its mandate) between the council of ministers and the LG, the stalemate is continuing."

During the course of the hearing, the bench said that it would "permit it (HPC) to go on" only if the Delhi government clarifies that the compensation would be paid by hem, without fixing any liability on the hospitals.

The issue here is a legal issue. Can you determine a

mittee (and) fix liability on a third party, which not only puts financial liability but tarnishes professional reputation," the court questioned.

"(If) you say you will fix liability, you are entering into the domain of judiciary and medical council. You can't do it," it added. Senior counsel Rahul Mehra and lawyer Gautam Narayan, representing Delhi government, clarified that the HPC was only a "fact-finding committee" which would not attribute any fault or negligence to a hospital and "compensation was purely

going from the government". Compensation of up to Rs 5 lakh would be calculated by the HPC on the basis of an objective criteria decided by it which would be open to a challenge by any party, the court was informed.

Kejriwal promises 80% pvt jobs in Goa for Goans

NEW DELHI/GOA: Aam Aadmi Party (AAP) national convener Arvind Kejriwal on Tuesday announced that the AAP will bring in a law to reserve 80 per cent private jobs in Goa for Goans.

No liquor vends to open in 105 of 272 municipal wards in Delhi from Oct 1

PTI ■ NEW DELHI

With new retail licences coming into force from mid-November, no liquor vends will open in 105 of the 272 municipal wards of Delhi from October 1, officials said on Monday. Under the new excise pol-

icy of the city Government, retail liquor sale licences have already been allocated to the highest bidders in 32 zones, each having around 10 wards and 27 liquor vends.

The bidding process for the 32 zones, concluded by the excise department in two phases in August and September, earned a revenue of over Rs 8,900 crore to the government.

The Aam Aadmi Party (AAP) government in the national capital has decided to liquor vends after September 30. There are a total of 849 liquor vends in the city, a majority of which are run by three agencies of the Delhi gov-

The excise department, in an order issued earlier this month, allowed the Delhi government-run liquor vends to continue with the retail sale of liquor till November 16 after furnishing the requisite licence fee.

The firms that have been given licences in the 32 zones under the new excise policy through bidding will start retail sale from November 17, the order said. The officials said there are

around 80 wards in the city without any liquor vend. In 26 wards, there are presently only privately-owned liquor vends that will close down from October 1, they added.
"Practically, the 105 wards

in the three municipal corporations in the city will have no functional liquor vend after September 30," an officer said. The closure of privately-

owned vends from October 1 may lead to a "temporary shortage" of liquor as only the government-run liquor stores will prior to November 17, the officials said.

The new excise policy seeks an equitable distribution of liquor stores in the city by segmenting it into 32 zones. Currently, the spatial distribution of liquor vends is skewed with some wards having as many as 10 liquor vends and others having none, the officials added.

Kejriwal has been tweeting daily updates on air quality on his official handle.

"The move is indicative of the Kejriwal government's efforts to combat winter air pollution levels this year on a war footing by taking togeth-

er all stakeholders, including

people of the city as well as neighbouring states," said a government functionary.

The air quality tweets by

the chief minister make people aware about the issue of pollution and emphasise the need for timely action to take the steps to check it, he said.

Delhi faces high levels of air pollution with onset of winters, the season coinciding with paddy straw (parali) burning in the fields in Punjab, Haryana and Uttar Pradesh.

The Delhi government is pressing for adoption of a biode-Institute and demanding that the Centre direct states to support their farmers for using it.

Earlier, Kejriwal said that a third party survey by the central government agency WAPCOS has found that use of biodecomposer is effective in getting rid of crop residue and thereby prevent its burning by the farm-


Various student groups have urged Jamia Millia Islamia to reopen its campus in view of the improved Covid-19 situation in Delhi.

dent groups like the All India Students' Association (AISA), Campus Front of India, Students' Islamic Organisation of India (SIO), Students' Federation of India and others have demanded that the campus of Jamia Millia Islamia be reopened at the earliest.

"For almost two years since the establishment of a lockdown due to the coronavirus pandemic, students have been facing serious problems due to closure of schools, colleges and university campuses. At a point in time, it was necessary to close all campuses due to increasing Covid cases and health issues. But now, the sit-

uation has totally changed. "Most of the institutions and public places have already



opened and with adequate sanitisation and social distancing, people have started using all the public facilities," the statement said.

An official of the varsity, however, said it was decided in a meeting that students of courses like Bachelor of Physiotherapy (BPT) and science courses which require practical work should be allowed to access libraries and laboratories.

It was also decided that PhD students who have to submit their thesis by the end of the year be allowed to enter the campus, provided they have received at least one dose of anti-Covid vaccine, he said.

He also requested to depute one police personnel in each police station as the nodal officer to ensure that no breeding takes place in their premises. "The "Malkhanas" of most of the police stations are notorious for breeding of dengue mosquitoes because old vehicles, old utensils and other seized items retain rainwater. The National Investigation Agency (NIA), in conjunction with Jammu and Kashmir police, and CRPF, conducted searches on Tuesday at eight locations in Anantnag, Baramulla, Kulgam, Srinagar, Doda and Kishtwar districts of the Valley in connection with the probe into J&K Bathindi IED recovery case.

The case was initially registered by Jammu and Kashmir police on June 27 at Bahu Fort police station in Jammu district relating to recovery of 5 kg IED from a Lashkar-e-Taiba terrorist in Bathindi, Jammu.

The conspiracy by LeT was aimed at causing an explosion in Jammu using the IED. The NIA had re-registered the case on July 19.

The NIA had earlier arrested three persons in this case.

"Investigation revealed that Pakistan based handlers of proscribed terror outfit LeT and their associates based in

India's foodgrain production likely to touch 150.50 M tonne in ongoing kharif season

PNS NEW DELHI

The Ministry of Agriculture on Tuesday said India's foodgrain production is likely to touch a record 150.50 million tonne in the ongoing kharif season on better rice output amid good monsoon. In the kharif season of 2020-21 crop year (July-June), the foodgrain output comprising rice, pulses and coarse cereals stood at a record 149.56 million tonne. Total production of kharif rice during 2021-22 is estimated at 107.04 million tonnes. Record production is pegged in rice, sugarcane and cotton. However, production of coarse cereals and oilseeds is estimated to be lower marginally during the kharif season of this year. Presently, India received 810.6 mm rain-838.9 mm, a deficiency of just three per cent so far. The monsoon has not started withdrawal so more rain is expected in the coming days.

Releasing the first advance foodgrain production estimate for the ongoing kharif season, Union Agriculture Minister Narendra Singh Tomar said: "A record foodgrain production is estimated at 150.50 million tonne in kharif season." Bumper crop

Seven get life imprisonment for burning alive Dalit sisters in UP

special SC/ST court on Monday award-Aed life imprisonment to seven people for setting two sisters belonging to the Dalit community on fire in Uttar Pradesh's Moradabad in 2010.

The sisters were burnt alive in Kothiwal Nagar on December 18 by a mob protesting a double murder for which their brother was accused.

In a 26-page order, special SC/ST court judge Sandhya Choudhury found the seven accused guilty on the basis of evidences produced by Additional District Government Counsel (ADGC) Anand Pal Singh and charged them under the SC/ST (prevention of atrocities) Act.

Sateesh Madan, Sagar Bhandula, Banti Malik, Asha Sachdeva, Amarjeet Kaur, Vinod Kajkad and Sania Kohli were convicted by the court and a penalty of Rs 1 lakh each was imposed on them. They were sent to districts jail Moradabad, Singh said.

On the day of the incident, a mob gathered outside the house of Rajo and set it ablaze. While she escaped unhurt, her daughters Gita (22) and Monu (20) were burnt alive in the ensuing fire.

Rajo's son Rakesh, who worked as a sweeper, was accused of murdering a 30year-old woman and her eight-year-old daughter during a robbery on December 9, Subsequently, Rakesh and his brother Rajesh were arrested by police.

Maha CM asks Guv to request Centre for spl session

Turning the tables on Maharashtra Governor Bhagat Singh Koshyari over his request to convene a two-day special Legislature session to discuss the ghastly Sakinaka rape and murder incident, Chief Minister Uddhav to convene a four-day session of Parliament to discuss similar atrocities against women across the country where even the Sakinak incident could be In a fresh "war of words"

broke out between him and the Governor – this time over the Sakinaka brutal rape and murder incident, the chief minister for joining the Opposition BJP's clamour for a Special Legislature session to discuss the issue. He said that the Governor echoing the Opposition's sentiments in a manner he was doing was "detrimental" to the Parliamentary democratic sys-

Turning down indirectly the Governor's requests for a

Special Legislature session to discuss the Sakinaka rape and murder incident, Uddhav stated in his four-page letter to Koshyari: "We share the sentiments expressed by you over the atrocities against women in the context of the Sakinaka fined to Sakinaka alone, but involves the entire nation. The victim women in the entire country are looking up to the

"We request you as the Governor to take up the matter with Prime Minister Narendra Modi and Union Home Minister Amit Shah so that they can convene a special Parliament to discuss atrocities against women in the country. At this session, the Sakinaka incident can also be discussed," the Chief Minister wrote.

The Chief Minister was responding to a letter from the Governor seeking a two-day special session of the State Legislature to discuss the Sakinnak incident, Uddhav hit out at Koshyari politely for writing a letter over the incident after a women political (read BJP) met him. "Today you're holding the

constitutional post as the Governor. But, we know you grew up as a political worker. (You should know) The responorder and also protecting women and ensuring their rights lies with the government headed by a chief minister. Aligarh (UP): The body of an 8-year-old dalit girl was found from a field near Kishangarh village here, police said on Tuesday. According to police, the girl had left for school at around 8 am on Monday. Shortly before noon her school bag was spotted by some passers-by who raised an

When it was found that the girl had not reached school, her family started searching for her and found her body in the field. The victim's family alleged that she was sexually assaulted before being killed.

Meanwhile, the agitated family members and villagers blocked traffic on the Tappal-Lalpur road for over two hours and refused to hand over the body to police for conducting post-mortem. Senior police officials reached the

spot late Monday night and managed to persuade them to hand over the body. A panel of doctors conducted the postmortem examination at midnight. SSP Kalanidhi Naithani told reporters

Monday night that forensic experts were investigating the scene of the crime. "Any comment on the cause of death can only be made after the post-mortem

ort is received," he said. Security in the area has been beefed up as a precautionary step, he added.

Sexual harassment of children at UP ashram: Court examines child helpline incharge

Muzaffarnagar (UP): A court here examined the incharge of a childcare helpline on Tuesday in connection with the 2020 case of sexual harassment of four children at an ashram in this district. In July last year, a team of the childcare helpline and police had rescued 10 children hailing from Tripura, Mizoram and Assam from the ashram in Shukartal here. Medical examination had confirmed that four of the children, aged between seven and 10 years, were sexually assaulted.

Incharge of the helpline, Poonam Sharma, was examined by the Protection of Children from Sexual Offences (POCSO) court here on Tuesday. Special judge (POCSO Act) Sanieev Kumar Tiwari adjourned the hearing in the case till October 12. The accused owner of the ashram, Swami Bhakti Bhushan Govind Maharaj and his disciple Krishan Mohan Das were also present in the court.

Police had registered a case under Indian Penal Code sections 323 (voluntarily causing hurt), 377 (unnatural offences), 504 (intentional insult with intent to provoke breach of the peace) and sections 5/6 of the POCSO Act.The ashram owner and his disciple were subsequently arrested.

Maharashtra: Minor gangraped in Parbhani; commits suicide

A 16-year-old girl was allegedly gang-raped by three persons, and died after consuming poison following the attack in Maharashtra's Parbhani district, police said on Tuesday. Two minor boys were among the accused apprehended for allegedly raping the girl, who consumed poison on September 14 and died while undergoing treatment at a hospital on Monday evening, an official said.

According to the police, the alleged incident took place in Sonpeth area on September 12, and the girl consumed poison two days later, the official said. In her statement to the police on September 18, the girl said that she had attempted to take her own life as a result of the rape, he said.

One of the accused was known to the victim and the trio had also stalked her two years ago, he said.

Based on the victim's complaint, the police registered an FIR against the trio under relevant sections of the IPC and Protection of Children from Sexual Offences (POCSO) Act, the official said, adding that further probe is underway. www.dailypioneer.com

The UK's decision to quarantine even vaccinated Indians has stirred a hornet's nest, and doubts

There is consternation in India after the UK said that travelling Indians, even if fully vaccinated with Covishield, will have to undergo quarantine for 10 days. The rule is part of new guidelines as travel restrictions are being eased from October 4. The Indian Opposition leaders termed it bizarre and racist. The Indian Government asked the UK to resolve the issue at the earliest. In the melee that followed, there was no immediate response from the one agency that should have been the first to question it the Indian Council of Medical Research or the National Expert Group on Vaccine Administration for COVID-19. The first thing the country needed to know was whether the UK guideline cast any doubts about the efficacy of Covishield. This is because the maximum vaccine doses being given in India are of Covishield. Over 230 million doses have been administered so far. No such clarification was forthcoming. Leading micro-



biologist and virologist Gagandeep Kang told this paper that there is nothing wrong with Covishield. "It is fine," she asserted. The scientist's assurance, however, does not reduce the worries of hundreds of Indian students planning to commence studies in the UK or waiting for the travel restrictions to end to return to their places of study. Why is the UK making an exception to Covishield? Is it not a fact that Covishield is the biologically identical version of Vaxzevria, the European brand name for the AstraZeneca vaccine? The only difference between the two is that Covishield is manufactured in India by the Serum Institute.

It is claimed that the entire controversy stems from some technical issues in the CoWin certification process. Earlier, the UK had a system that slotted countries into three lists for purposes of allowing entry. From October 4, there will be only one list; travellers from a country omitted from it will have to be guarantined for 10 days even when fully vaccinated if that vaccine is not in that country's approved vaccines list. If so, the question arises why the Serum Institute of India did not ensure that Covishield was in that list? If the UK follows the approval procedure of the European Medicines Agency (EMA), the body for scientific evaluation, supervision and safety monitoring of medicines in the European Union — even though it is out of the EU — the Indian manufacturer should have applied for approval. The EMA approved only four COVID-19 vaccines so far: Comirnaty, Moderna, Vaxzevria and Jansen. The Serum Institute's Adar Poonawalla did say in July that he had taken up the issue of exclusion of Covishield from the approved vaccines list at the highest level. The British Government also said in the same month that the UK health regulator had approved the Serum Institute's vaccine, but that EMA was yet to give its nod. The EMA website says it is currently reviewing the following vaccines: NVX-CoV2373, CVnCoV, Sputnik V, Vero Cell and Vidprevtyn. Where is Covishield?

The Govt must not rush into sending COVID doses abroad before inoculating all Indians

he Union Government's decision to resume exporting and donating the "surplus" COVID jabs beginning October, after a three-month hiatus since it was launched on January 20, has raised eyebrows in the political and healthcare circles, with several people taking a swipe at it in private as to what else could be expected of an "insensitive dispensation" which didn't even dare acknowledge hundreds of deaths caused



by the paucity and unavailability of oxygen in several hospitals across States during the second wave of the COVID-19 pandemic. Union Health Minister Mansukh Mandaviya had on Monday announced that India's vaccine manufacturers were expected to produce more than 30 crore doses in October for the domestic drive and that the surplus supply would be used to fulfil the country's commitment towards the global fight against COVID. All this is being envisaged despite the fact that a large number of Indian citizens, especially in the young adults bracket, is still bereft of the benefits of inoculation. For example, even in Uttar

Pradesh, where Prime Minister Narendra Modi had in Varanasi praised Chief Minister Yogi Adityanath this July for his "dexterous tackling" of the COVID-19 pandemic and the "successful" vaccination drive, the situation on the ground is such that the State Government is unable to provide adequate number of jabs to people.

At one such ongoing drive in the State earlier this month, meant especially for media personnel and their immediate family members, the first-dose vaccine-seekers were turned away with the explanation that, for now, only a limited number of jabs were available for those awaiting their second shot. There were not enough vials or trained staff to inoculate all hopefuls, especially those queuing up for the first shot. If this is the state of affairs in the country's most populous State, and also the one which is governed by the party that also rules at the Centre, one can easily imagine how things must be panning out in the nation's remote areas or in those States that are being run by the Opposition parties. The threat of the pandemic's third wave is still very much looming and the powers that be must ensure that all Indians are vaccinated well before the Government considers exporting even the "surplus" jabs or acts upon lofty thoughts like 'Vasudhaiva Kutumbakam' and 'Vaccine Maitri'.

India's wavering stand on Taliban



India will do well to reposition itself geopolitically to ensure Afghanistan becomes a neutral State and buffer to Chinese penetration of South Asia

ndia has always wavered on the recognition, reconciliation and reintegration of Taliban. This goes back to more than a decade ago when India categorised it into 'good' Taliban and 'bad' Taliban and reluctantly agreed to reconciliation and integration of 'good' Taliban. At the London conference in January 2010, attended by 69 Foreign Ministers including India's SM Krishna to find a political solution in Afghanistan, India's 'good' and 'bad' Taliban were replaced by the innovative "non-hardcore rebels". When the Americans signed the Doha peace accord, the deal was titled "Agreement between USA and Taliban which calls itself the Islamic Emirate of Afghanistan". The MEA has neither modified its position on Taliban nor its undisguised revulsion for it.

Engagement with the Taliban similarly has been a story of twists and turns. At the Raisina Dialogue in 2018, Army chief Gen Bipin Rawat, when asked whether India should talk to the Taliban, without batting an eyelid replied in the affirmative: "We have talked to rebel groups earlier." The very next day, GoI issued a clarification noting that Gen Rawat had spoken in his personal capacity and his views did not reflect those of the Government. It is not clear precisely when the back channel or direct talks started with the Taliban but earlier this year, Qatar's Foreign Minister confirmed that engagement with Taliban had taken place in Doha. The first known public contact with the Taliban occurred in Moscow when two retired Indian officials attended as observers the Troika Plus engagement with Taliban of the US, Russia, China and Pakistan in 2020. Rumours of Indian contact with Taliban go back to 2017/18. Many columnists, including myself, have advocated for years that India should officially engage with the Taliban. But that did not happen.

India has rested on its laurels of being voted by multiple polls in Afghanistan as the most favoured nation. Nearly 70 per cent of Afghans polled for India, way ahead of other countries. India's contribution to development and capacity building is simply outstanding. India has completed or

projects in 34 provinces in Afghanistan, utilising upwards of \$2bn of the \$3bn allotted to the latter. Hundreds of students are studying in civilian and military institutes and will remain in India till the completion of their assignments. India is second home to many Afghan leaders, something Taliban has resented. The Taliban have asked India to return to complete its unfinished projects. KEC International and Kalpataru Power Transmission will complete their infrastructure projects when the green flag is shown. WAPCOS, which completed Salma Dam, is not sure about its return. Tata Motors and Hyderabad-based BSCPL Infrastructure exited in

Mixed messages from Taliban suggest that Indian business and the embassy should not be in any hurry to return to Kabul as some diplomats and political leaders have advocated. Evacuation of Indians and Afghan nationals of Indian origin has been the priority. In April 2020, India withdrew its consulates from Herat and Ialalabad, scaled down the Kabul Embassy the same year, closing the old Chancery and moving into the new embassy in the green zone. On July 11, India with-

and, a month later, Mazar-e-Sharif. India has quit Kabul to Pakistan's glee. This tragic predicament has been created by India's persistence with "wait and watch" over the years even after signing the strategic protocol with Afghanistan in 2011. Little effort was made to convert goodwill into political and strategic influence despite military assets in Tajikistan. More lately, India put all its eggs in the US basket though a last-ditch effort was made to salvage relations with Iran and Russia. The Americans say: "We do not look at Afghanistan through the Indian prism." Strategic patience has failed, leaving India out in the cold.

At the second SCO summit last week, Prime Minister Narendra Modi stated that India was in no hurry to recognise Taliban. This was the first official statement by the Government. He also observed that the Government was not inclusive and had come up without negotiations but India would be ready to provide humanitarian aid and join any regional/global initiative to help people of

The neutrality project has been attempted by, among others, the UN and will not work due to Pakistan's interference. China is likely to become the lead player in Afghanistan, securing its strategic corridor to the Indian Ocean via Pakistan. The China-Pakistan-Taliban nexus will constitute a new threat for India from Af-Pak.

India has lost its privileged intelligence cooperation with Afghanistan's National Directorate of Security and leverage over Pakistan. At the UNSC, while presiding over it in August, India could have done a lot more on its three statements on Afghanistan, including Resolution 2593. New Delhi must find its feet and wings to claim its legitimate place in the Hindukush where the new Great Game is only just beginning.

FIRST COLUMN BREASTFEEDING IS THE BEST FEEDING

Adequate breastfeeding to infants can reduce the mother's diabetes and cancer chances

ndia ranks at 79 out of 98 countries that have policies and programmes for protection, promotion and support of breastfeeding and infant and young child feeding. An international study estimates that India could prevent 100,000 child deaths and more than 37 million episodes of diarrhoea and pneumonia if breastfeeding was adequate. Other benefits include reducing obesity and increased IQ in children, reduced cancers and Type 2 diabetes in women who breastfeed. But the infant and young child feeding practices are far from optimal. The NFHS-5 data revealed that 88 per cent women deliver in hospitals, 51 per cent are able to begin breastfeeding within an hour of birth, 61.9 per cent breastfed exclusively during 0-6 months, 56 per cent received timely complementary feeds at 6-8 months and only 16.1 per cent received adequate diet during 6-23 months. It shows 26.9 per cent children are underweight, 31.9 per cent stunted, 18.1 per cent wasted and 5.5 per cent obese. The World Breastfeeding Trends Initiative (WBTi) measures support to women



for breastfeeding on 10 parameters. India lags behind 78 countries. The 10 parameters include governance and funding, support to women in hospitals, the enforcement of relevant infant feed legislation, maternity protection, and counselling services for the pregnant and breastfeeding mothers. India scored 1.5 out of 10 because it does not have an officially adopted policy, which hinders a dedicated plan of action and attached budgets. Giving priority to the policy and having coordination mechanisms can change the game.

The Government did launch the Mothers' Absolute Affection programmebut early breastfeeding has gone down by 2.5 percentage points because of dwindling quality of care in the hospitals and increasing caesarean sections. Other challenges are lack of enforcement of the law that controls marketing, inadequate human resources, overburdened health facilities, weak monitoring and evaluation mechanisms, and inability to involve private hospitals. India can bridge these gaps by institutionalizing lactation professionals in each hospital providing maternity services and assessment and monitoring of the hospitals against a benchmark of WHO' sprogrammes. Involving key organizations working in this field and public health organizations, Association of Healthcare Providers of India (AHPI) can make a difference. There is a lack of readiness for supporting women and children during the disasters that occur frequently in the country. The National Disaster Management Plan, 2016 made a provision for 'baby foods' without even addressing its safety during feeding. It did not address the supply issue for supporting breastfeeding. This has changed now but remains to be implemented as per the revised plan of 2019. To bridge this gap State and district administration can prepare at least 50 breastfeeding/lactation counsellors, who will act as responders to provide emotional support to women with young infants to breastfeed and reduce the risk of artificial feeding. Ensuring adequate funding and coordination is another area that needs to improve. Funding estimates include approximately ₹5 lakh for each hospital, about ₹1 crore per district for human resources. Additional funds are needed for adequate, good quality and diverse diets for children. The private sector should be asked to make provisions and focus on maternity packages. In 2022, WBTi will do its sixth assessment and it is an an opportunity for India to jump the rank by investing in critical and foundational intervention in child health and nutrition.

Deforestation in India during British rule



The British aimed to corner a fair share of India's lucrative trade and considered small patches of forests as wastelands as these were not a source of revenue

lthough there is an abundance of writing on the history of deforestation in India, the absence of an objectively written history is painfully felt by one who intends to gain an impartial perspective of Indian forestry and its causes of degradation and deforestation.

The approaches of current writers are not uniform, and they have biases and leanings. For example, most Indian historians view the British as timber pirates, land thieves, and soil wreckers. In their opinion, there used to be a harmonious relationship between the community and the forest and no significant deforestation had taken place prior to British rule. The British were lauded for unifying the subcontinent, settling rights and concessions to the communities, and demarcating the reserve forest boundaries with a skilled foresters praised throughout the developing world. Both views are subjective assess-

ments. In fact, the motivation of the British was never altruistic, although they left behind a cadre of well-trained and organized forestry professionals. The reason might have been to keep the geese alive which were laying golden eggs for them. European invasions and conquests of India were originally motivated by trade in highly prized commodities such as silk, textiles, spices, jewels, which found their way to Europe via trade in these goods, mostly via the sea from small king-doms to giant empires. The primary objective of the East India Company was to gain a substantial share of this lucrative trade and then to raise revenue in every way possible. The East India Company was also supported by the British monarchy. Thus, the increasing collection of wealth from peasants and cultivators, coupled with the deforestation to get more land tilted. In reality, it nei-ther began nor ended with the British. It may be recalled that deforestation in north India was the primary cause of the shift from Indus Valley civilization to Gangetic plain in ancient India.


During the reign of Ashoka (268 to 232 BCE), the subcontinent was united under a single ruler. At the time of Ashoka and Chandragupta Maurya, the so-called golden period of Indian history, the forests were the property of the state. Hence, those claiming that the forests were managed by local communities are far from historica fact. After Ashoka, the empire collapsed under invasion from the north and the nomadic invaders burned forests for pasture. This regime was followed by Islamic revival when India again became united. It was only in the second half of the 16th century that Akbar cemented Mughal dominance that had begun in the previous one. The Mughals came from the desert and had no particular interest in forests except for their game. During this time, the British used their South American colonies to acquire silver so they

Britain gradually swallowed the subcontinent in stages, through a series of treaties and annexations backed by military support. When compared with local rulers' revenue, the silk and spices trade seemed small to British traders. They started searching devices by grabbing some of these revenues and expanding them. India by that time had a non-uniform mass of subsistence cultivators living in village communities. The responsibility for collecting revenue in cash or in kind lay with big landlords (zamindars) or the government's designated employees. It was the peasant producers' responsibility to till their land and share their produce with the king either in cash or in kind. Revenue in kind was established during Akbar's regime.

In deccan Maharashtra, small cultivators grew cotton, wheat, indigo, opium, oilseeds, and tobacco for cash sale. The villages had small patches of forest interspersed throughout them, which helped to maintain their productivity. British authorities considered all these patches as wastelands because they did not give revenue, regardless that they were the source of fuelwood, fodder and medicinal plants that shifting cultivators and villagers relied on for their subsistence. Because they came from temperate zones, they were unfamiliar with the land ecology of the tropics, nor did they have any grasp of the role of forests in sustaining and maintaining the productivity of the land.

The Indian Forest Act of 1927 affected the lives of forest-dependent communities.The penalties and procedures in this Act aimed to extend state control over forests and to diminish the rights of people to use forests. The rules were stricter and the depart-

Dietrich Brandis was appointed Inspector General of Forests by the government in 1864 for laying

the foundation of the Indian Forest Department. Most of the upper-level staff were British who received their training at the Royal Engineering College at Cooper's rural poor. Hills. To manage the forests, Brandis thought of training the people in the science of conservation as well as introducing a legal system. Brandis then set up the Imperial Forest Service in 1864. Indian Forest Act was brought in accordance with Lord Dalhousie memorandum. In 1855, Lord Raj was sown. Dalhousie circulated a memorandum on forest conservation proposing that teak be treated as state property, and its use strictly regulated. The Forest Act 1865 was amended twice, in 1878 and 1927. The Forest Act 1878 classified the forests as reserved, protected and village forests. The best forests were called "reserved forests," and the villagers could not take anything from these forests except as permitted under the Act. Villagers could take wood for

ment was given police powers. Brandis developed his forest management model based on his experiences with German and European forests. However, forest in the Indian continent were very diverse in their species composition, unlike the temperate forest. Each acre of tropical forest is home to dozens of tree species and thousands of micro-organisms

forming a complex food web that maintains the food chain for a sustainable ecology. This was a prerequisite for the livelihood of the

World history is littered with farmer's revolts against reserving forests for sustainable management, whether in France, Britain, or Mexico. The poor man's overcoat is a European expression which reflects the dependence of the rural population and artisans to ensure their survival. It is also a hard reality that, if it is left to itself these public goods will be ruined, as someone rightly said, "everybody's property is nobody's property". However, there are examples in the world where the public has been educated through the proliferation of books and pamphlets authored by prominent intellectuals urging the public to assist the government in protecting forests. Japan, which was never colonized, adopted a dif ferent strategy to regenerate its devasted forest that was based on public awareness.

In the end, it all came down to public awareness, which is a necessary component in all these lessons to save the Forests. However, widespread public awareness can only be achieved through environmental education and demonstration projects, for which India is still far from its milestone.

Without mentioning China directly, Biden acknowledged increasing concerns about rising tensions between the two nations. But he said, "We are not seeking a new Cold War or a world divided into rigid blocs."

The president noted his decision to end America's longest war last month, in Afghanistan, and set the table for his administration to shift U.S. Attention to intensive

The Taliban expanded their interim Cabinet by naming more Ministers and Deputies on Tuesday, but failed to appoint any women, doubling down on a hard-line course despite the international outcry that followed their initial presentation of an all-male gov-ernment lineup earlier this

The international community has said that it will judge the Taliban by their actions, and that recognition of a Taliban-led government would be linked to the treatment of women and minorities.

In their previous rule of Afghanistan in the late 1990s, the Taliban, who adhere to a harsh interpretation of Islam, had barred girls and women from schools, work an public life.

At a news conference Tuesday, Taliban Government Zabihullah spokesman Mujahid held out the possibility of adding women to the Cabinet at a later time, but gave

no specifics. He also said the Taliban are preparing rules for allowing teen-age girls and women to return to schools and jobs in line with Islamic law, but did not say when that might happen.

technical skills.

He bristled at international conditions for recognition, saying there was no reason for withholding it. "It is the responsibility of the United Nations to recognize our government (and) for other countries, including European, Asian and Islamic countries, to have diplomatic relations with us," he said.

tional support as they grapple with the daunting challenges of governing a nation shredded by four decades of conflict. Seventeen Indo-Canadians, Sincluding NDP leader Jagmeet Singh and Defence Minister Harjit Sajjan, won Canada's Parliamentary elections on Tuesday with Liberal Party leader and Prime Minister Justin Trudeau returning to power in the snap polls.

Canadians gave 49-year-old Trudeau's Liberal Party a victory in Monday's parĺiamentary elections, but his gamble to win a majority of seats failed and nearly mirrored the result of two years ago.

The Liberals won the most seats of any party. Trudeau's Liberals were leading or elected in 156 seats — one less than they won in 2019, and 14 short of the 170 needed for a majority in the House of Commons, according to Canadian media reports.

This is Trudeau's third fed-

eral election win, but his critics say the poll was a waste of time. The Conservatives have held onto their main opposition status and are expected to win about 122 seats, BBC reported.

Sebi drops adjudication proceedings against RIL

Alleged incorrect financial disclosures matter

PTI ■ NEW DELHI

Markets watchdog Sebi has disposed of adjudication proceedings without imposing any penalty on Reliance Industries Ltd in a matter related to alleged incorrect disclosure of diluted earnings per share in its financial results

more than 13 years ago. Sebi decided not to impose any penalty for the alleged violations mainly on two grounds, including that the amendment to the relevant law that made incorrect disclosure of information by a list-

ed company punishable came into force prospectively from March 2019.

Besides, the regulator mentioned about its pending appeal before the Supreme Court against a Securities Appellate Tribunal (SAT) order.

The quarterly financial statements submitted by Reliance Industries Ltd to the NSE for six consecutive quarters beginning June 2007 to September 2008 contained the same figures for basic as well as diluted Earnings Per Share (EPS) despite existence of share warrants, according to Sebi.

RIL had issued 12 crore warrants to its promoters on April 12, 2007 which were convertible within 18 months with an exercise price of ₹1,402 per warrant entitling its holders to subscribe to equivalent

number of equity shares. On October 3, 2008, the company's board of directors allotted 12 crores equity shares of ₹10 each to the allottees, upon exercise of warrants.

In a 39-page order, dated September 20, Sebi said the amendment with regard to furnishing false, incorrect or incomplete information, docu-

Amazon spends ₹ 8,546 cr in legal expenses during 2018-20 to maintain presence in India

U^S e-commerce giant Amazon, which is said to be investigating alleged bribes paid by its legal representatives in India, spent a staggering ₹8,546 crore or \$1.2 billion in legal expenses for maintaining a presence in the country during 2018-20, sources said.

Sources aware of the firm's public account filings said entities of Amazon - including Amazon Retail India Pvt Ltd, Amazon Seller Services Pvt Ltd, Amazon Transportation Services Pvt Ltd, Amazon Wholesale (India) Pvt Ltd, and Amazon Internet Services Pvt Ltd (AWS) - paid Rs 3,420 crore in India during 2018-19 and Rs 5,126 crore during 2019-20 towards legal fees.

Amazon is locked in a legal tussle over the takeover of Future Group and is facing a probe by the Competition Commission of India (CCI). While the company declined to comment on the legal fee issue, traders body CAIT claimed that Amazon spending 20 per cent of its revenue on lawyers was questionable.

GORALLY COMPETITION

There is a growing demand to reshape business education in the country due to digitalisation. PROFESSOR KIRTI SHARMA tells how Indian B-schools can prepare students to become globally competitive

lot of times when I read about business and business education related articles these days both online and in mainstream print media, some of the keywords which I come across are: sustainable, impactful, society, talent, value, nurturing, entrepreneurial, creativity, distinctive, excellence, research, policy, practice, decision-makers, leaders, performance, culture, digital, AI-M/C learning, autonomy and design-thinking. This made me think what should be the ingredients and the recipe to make an Indian student compete in a globally competitive environment?
This further brings me back to

the basic essence of gaining a business degree. In a generalised manner most people have two primary goals when they come to a B-school – "I want to be wealthy" and "I want to make some difference in the world which matters". The current generation is more concerned about the second one, hence this makes it almost mandatory for Indian B-schools to have a relook towards the traditional curriculum to more contemporary curriculum.

In the medical colleges, doctors teach students and senior post graduate students teach juniors, similarly in a Law school – practicing lawyers teach the budding lawyers. But in a B-school, not all the faculty have experience with hands-on leadership and decision-making in the indus-

try. Hence there is a need to address these challenges in the Indian B-school education and curriculum. I would like to propose the following six solutions for Indian B-schools to prepare their students to be globally competitive where the future is shaped by technology and innova-

Technology focus: B-schools don't have an option anymore to not have technology related topics across functional courses. We are living in the era of Ed-tech, health-tech, HRtech, Fin-tech etc. As we witness technology's increasing pervasiveness, the same should cut across all functional domains in a B-school like marketing, finance, operations, strategy, economics, public policy and of course information manage-

Industry-institute immersion: To overcome the limitation of faculty not having hands-on leadership or decision making experience, curriculum should allow to have this intervention beside mandatory summer-internship. This will also help to get them exposed to various problems and improve their analytical

Incubation centre: There is a GOI MSME incubation scheme under which they provide financial support to Institutions to develop Entrepreneurial and Managerial skills. B-schools can provide an opportunity to innovate new prod-

Business schools should introduce new contemporary electives as per the global skill demand like electives in machine learning application in marketing and finance, block-chain service, healthcare marketing and real estate management

ucts and ideas. In fact this can be introduced as a 'course of independent study' and can be assessed. This will give freedom to students to craft their own learning and growth tra-

jectory. **Boot camps:** We have seen the technology bootcamps becoming popular among recruiters. Almost every company today is becoming a technology company. Hence B-

schools should include Boot camps focusing on specific skills to replace traditional methods of teaching concepts like product development, value creation, delivery models to name a few. Hence, B-schools, which can offer a few Boot camps in the wide-range of courses will create a competitive edge for their stu-dents as these will have sanctity because of the assessment criteria and will be part of the degree at

completion. AI-data science focus: From banks, restaurants, government office to hospitals every business has some or the other sort of technology cutting across. Hence, Indian B-schools should include some input across functional domains of marketing, finance, operations and strategy. Some such topics should include: Artificial Intelligence, Machine learning applications, block-chain, cyber-security, e-commerce implementation, innovations etc. Field courses should be included where students who wish to get into a specific industry can understand the real problems and use of technology in those industries such as production units of FMCG or medical equipment, banks, refinery,

power company.

Specialised electives: Business schools should introduce new contemporary electives as per the global skill demand like electives in machine learning application in

marketing and finance, block-chain service, healthcare marketing, food innovation, real estate management and private equity management and doing business with India to name a few.

There is a growing demand to reshape the business education in India in this digital era. Almost one-third of the world population is Gen Z. These are also the future work-force and leaders.

The B-schools should focus beyond just advertising and scholarships to create a global competitive edge for students. It requires courage to chart new routes, which can vary for different B-schools owing to their capabilities, resources and location. But due to digital technologies this is not impossible. India has an advantage that we are in the midst of the whole economic activity. Doing business with India is a popular course across summer-schools in Europe and the US. Students should have a competitive edge as they are sitting right there to see how business is growing in India, how new unicorns are taking birth in India. So, one of the most important advantages Indian B-schools have is that they are located where the action is. This is the right time when business schools need radical innovations if they have to stay rel-
