# Sidhu keeps Cong's pot boiling for 'Punjab sake'

## Quits as PCC chief; 3 resign in solidarity

A fter the lull, the storm! Just when the Congress in Punjab was striving to bring about some stability by balancing power, caste and regional equations, "super Chief Minister" Navjot Singh Sidhu on Tuesday triggered political tremors in the State by quitting as the Punjab Congress president. Another Cabinet Minister Razia Sultana stepped down in solidarity.

Within hours of Sidhu's resignation, PPCC treasurer Gulzar Inder Chahal and general secretary Yoginder Dhingra too resigned from their posts. The two were recently appointed in the State

Congress unit. Sidhu announced his resignation minutes after the allocation of portfolios to the and this was Ministers apparently the last straw! In a cryptic resignation letter to party supremo Sonia Gandhi that come in less than three months of taking over the



party reins, Sidhu wrote, "The collapse of man's character stems from the compromise corner. I can never compromise on Punjab's future and the agenda for welfare of Punjab. Therefore, I hereby resign as president of Punjab Pradesh Congress Committee. Will continue to serve the

Congress."
The tremors, activated by Sidhu's surprise resignation announced via Twitter, were felt some 250 kilometres away in New Delhi also with the party high command putting its head together to resolve the new crisis. It has been learned that Congress senior central leaders, including KC Venugopal and State party affairs in-charge Harish Rawat, held an emergency meeting to discuss the developments in the

# LAC under review after China's foray

### More than 100 **Chinese troops** intruded over 4 km inside **Uttarakhand**

PNS NEW DELHI

Security forces are reviewing their operational readiness and deployment pattern on the Line of Actual Control (LAC) in Uttarakhand after the Chinese intruded into the Indian territory in last week of August. They also reportedly tried to damage a makeshift

bridge on the Indian side. The LAC in Uttarakhand and Himachal Pradesh facing China is known as central or the middle sector while the Ladakh front is known as western sector and the LAC in Arunachal Pradesh and Sikkim is called eastern sector.

The transgression in rahoti district of Barahoti district of Uttarakhand took place when more than 100 Chinese troops intruded more than four kms inside the Indian side on horseback. They were in the area for more than two hours and returned after trying to dismantle a bridge, sources said here on Tuesday.

There was no face-off with



the Indian troops, including the Army and the Indo-Tibetan Border Police (ITBP). The Indian forces rushed to the site after learning about the transgression, sources said, adding the local commanders were now reassessing their patrolling patterns and deployment.

Barahoti region has seen transgressions in the past few years but no serious incident resulting in face-offs took place. This area saw the first intrusion in 1954. The incident in August saw the Chinese coming through Tun La (pass).

The ITBP and the Army guard the nearly 450 km LAC in Uttrakhand. Officials claimed transgressions take place in Barahoti due to difference of perception about the LAC. The Chinese and Indians have exchanged maps in the central sector some years

moved since then. The incident

Uttarakhand rang alarm bells in the Indian security establishment as the face-offs in eastern Ladakh persist for the last one and half years. The two sides have held 12 rounds of Corps Commander-level talks since trouble erupted in May last year. The talks saw the two armies withdrawing their troops from Pangong Lake and

Gogra.

However, troops are facing each other on three other flash points and the 13th round of talks in the next few weeks may see some forward movement sources said. Moreover, the Chinese have started preparing for winter months by erecting shelters at some places near the flash points in Eastern Ladakh,

## **Army captures** young product of Pak Army's terror factory

The Indian Army on Tuesday once again exposed the Pakistan Army's connivance in abetting infil-tration inside the Indian territory after it successfully captured a 19-year old Lashkar-e-Tayyeba terrorist, trained by Pakistan Army personnel inside one of the terror factories across the Line of Control (LoC)

The young terrorist who hailed from district Okara in Pakistan Punjab during preliminary investigation revealed how Pakistan Army regulars are imparting training to a fresh crop of terrorists in the terror factories and army personnel in the forward posts desperately trying to push a large group of infiltrators inside the Indian territory.

According to a senior Army officer, who supervised the entire operation on ground zero in Baramulla on Tuesday told reporters, "A 19-year-old Pakistani terrorist, Ali Babar Patra, son of Late Mohd Lateef R/O Dipalpur, District Okara Punjab (Pakistan) had decided to surrender before the Indian Army after one of his close associates was eliminated by the Indian patrol while foiling a major infiltration bid in the

### North Eastern Space Applications Centre helping in flood control: Amit Shah

New Delhi: Union Home Minister Amit Shah on Tuesday said that the North Eastern Space Applications Centre (NESAC), a wing of the ISRO, has been helping the government in flood control through space technology.

Addressing an event on the Foundation Day of the National Disaster Management Authority (NDMA), Shah said that a big new experiment has been initiated in the Northeast where a society has been formed to harness space science through the NESAC, which was set up by the Department of Space and the North Eastern

"We have started using the space technology in disaster management by doing advance planning from last year," he said. The Home Minister said in the Northeast, the Brahmaputra is often flooded, but the topography there is such that it is very easy to transfer the

thousands of hectares before it floods. He said if a lake can be built, the chances of flooding will be reduced by 40 per cent.

"The NESAC is working to find such type of location and it has also been successful. So far, 19 locations have been found, where big lakes will be built and energy will not be used to send water there as water will reach through topography. This is a new beginning and we have taken it one step further," he said. The NESAC helps aug-

ment the developmental process in the Northeast by providing advanced space technology support. The home minister said

## 459 rescued in two days in Osmanabad district, water released from Manjara dam

**Aurangabad:** As many as 459 people were rescued from floodaffected areas in the last 48 hours across Osmanabad district of Maharashtra and the National Disaster Response Force (NDRF) even deployed a helicopter to reach those stranded in floodwaters, officials said

Water was released from Manjara dam during the day, causing flooding in downstream villages and parts of neighbouring districts, they said.

Six persons including two children were rescued by the NDRF by deploying a helicopter at Dautpur village in Osmanabad tehsil, while ten persons were similarly rescued from Saundane Amba village in Kalamb tehsil.

The Osmanabad-Ausa road was blocked as water was flowing over the Kamegaon-Samudrawani bridge.

cued from a house in Wakadwadi village of Kalamb tehsil. Some 125 persons were rescued in Ramwadi, 114 in Irla, 35 each in Ter and Borkheda and 90 in Dautpur, the official said. Balaji Kamble (30), resident of Irla, was washed away and search was on for him. At least 20 big and 17 small cattle perished in the floods while 80 huts were damaged. Two teams of NDRF participated in the rescue operations.

The collector of the neighbouring Latur district, Prithviraj B P, told PTI that a family of three including a child was reportedly stranded at Pohregaon in Renapur tehsil of the district, but rescue teams could not reach the spot due to the bad weather and low visi-

While the OFB was set up in 1979,

the history of the Board dates back to 1775. During 1775, British authorities accepted the establishment of the Board of Ordnance in Fort William, Kolkata. This marks the official beginning of the Army Ordnance in India.

In 1787 a gun powder factory was established at Ishapore which started production from 1791 (at which location Rifle Factory was established in 1904). In 1801 a Gun Carriage Agency at Cossipore, Kolkata (presently known as Gun & Shell Factory, Cossipore) was established and production started from 18th March, 1802. This is the first Industrial establishment of Ordnance Factories which has continued its existence till date, according to OFB website. While the British set up 18 ordnance factories, the rest have come up post-Independence.

and saw a suspicious-looking person on a scooter, following which he was intercepted.

"Police checked and found the scooter was stolen from Kirti Nagar area. During interrogation, he confessed to snatching many mobile phones and robbing of 2.5 kg gold articles from the Subzi Mandi police station area in North Delhi," said the senior police official.

"He committed robbery with his two associates by using a countrymade pistol and a knife, on a motorcycle. He also confessed to committing over 100 snatchings in different parts of Delhi, especially in west, outer, central and north districts, the official said.

# **PM launches climate** resilient 35 crop types

Prime Minister Narendra Modi on Tuesday launched 35 crop varieties with special traits — developed by the Indian Council of Agricultural Research (ICAR) — to address the twin challenges of climate change and melautrition. The change and malnutrition. The new crop varieties were dedicated to the nation through a video conference organised at all ICAR institutes, state and central agricultural universities and Krishi Vighyan Kendra.

Addressing farmers and other stakeholders through video conferencing after the launch, Modi said climate change is a big challenge not only for the farm sector but also for the entire ecosystem, and efforts needed to be stepped up to address the problem. Modi called for collective efforts and continuous intensive research to deal with the climate change, which is adversely impacting the output of agriculture and allied sectors, thereby causing huge losses to farmers.

In the last six-seven years, science and technology are being used on a priority basis to solve the challenges related to agriculture, he said, adding that the joint efforts of farmers and scientists will give better results. Modi also said that modern technology and new farming tools are at the core of future farming and stressed on use of drones and sensors to collect high-quality farm data and real-time

"Indian agriculture has always remained scientific. The synergy between agricul-



ture and science should continue as it is important for India in 21st century," Modi said in his address. "Our focus is very high on more nutritious seeds, adaptable to new conditions, especially in changing climate," he said, adding that 35 new crop varieties will address the problem of climate change and help in the Government campaign to make India malnutrition free. Expressing concern over challenges of climate change, Modi said, "Not only agriculture, climate change is a big challenge to the entire ecosystem."

The 35 crop varieties with special traits like climate resilience and higher nutrientcontent were developed by ICAR this year. These include a drought tolerant variety of chickpea, wilt and sterility mosaic resistant pigeonpea, early maturing variety of soybean, disease resistant varieties of rice and biofortified varieties of wheat, pearl millet, maize and chickpea, quinoa, buckwheat, winged bean and

Modi said, "More than 1,300 seed varieties have been

developed. Today, 35 more crop varieties have been dedicated to farmers. These crop varieties or seeds will address the challenge of climate change and malnutrition."

Modi also interacted with five farmers from different States. In his interaction with Zaitoon Begum of Ganderbal (Jammu & Kashmir), Modi asked about her journey of learning innovative agricultural practices and how she trained other farmers and how she is working for the education of girls in the Valley. He also mentioned that even in sports, girls from J&K are doing well. The Prime Minister stressed that the needs of farmers with small holdings are the Government's priority and that they are getting all the benefits directly. In all he spoke to five

farmers one-by-one. Talking to Kulwant Singh, farmer and seed producer from Bulandshahr (Uttar Pradesh), Modi asked him how he was able to produce a diverse variety of seeds. The Prime Minister praised Singh for processing his crops and doing value-additions.

The Enforcement Directorate has provi-Enforcement sionally attached assets worth ₹578 crore (GBP 57 million) of Wadhawan Global Capital (UK) Ltd (WGC-UK), a company owned by Kapil Wadhawan and Dheeraj Wadhawan under the provisions of the Prevention of Money Laundering Act in DHFL-UPPCL fraud case.

The attached assets are in the form of investment made by Wadhawans through WGC-UK in UK-based com-

The ED had initiated a money laundering investigation on the basis of an FIR registered by Lucknow police against some officials of Uttar Pradesh Power Corporation Ltd. (UPPCL) under the sections of the Indian Penal Code for illegal investment of GPF and CPF funds of the employees of the UPPCL into a private company namely DHFL in sheer violation of the Government Notification and directives, the agency said.

The ED investigation revealed that DHFL in connivance with UPPCL officials had illegally received ₹4,122.70 crore of GPF and CPF funds of UPPCL employees in fixed deposit in DHFL,

Out of this total investment of Rs 4,122.70 crore by UPPCL in DHFL, ₹2267.90 crore of principal amounts of provident fund (GPF+CPF) of UPPCL is still outstanding to be paid by DHFL.



had been received by the DHFL during the period, where DHFL was engaged into disbursement of high value loans to its promoter related companies. Indian intelligence agencies have warned that more infiltration attempts will be made by the terrorists in Jammu and Kashmir as a large numbers of them have been hiding at the launch pads located in Pakistan occupied Kashmir(PoK).

Quoting the latest reports sent to the government, sources said that there has been an exponential rise in the number of ultras in these launch pads in the last 45 days, and the security agencies have also intercepted the chats of these militants in Pashto language. This also indicates the likely presence of Afghani mercenaries sent by the Pakistan's Inter-Services İntelligence (ISI), the sources said.

The sources also said that around 200 ultras are ready to infiltrate the Line of Control (LoC) from the launch pads in PoK on the behest of the ISI.

The sources in the defence forces have also confirmed that three infiltration attempts were made during the last 10 days in Uri sector itself.

The officials in the security forces said that attempts have been made in Uri, Baramula and Poonch sectors too in the past few days, raising concerns of the security forces.

The young terrorist who hailed from district Okara in Punjab (Pakistan) during preliminary investigation revealed how the Pakistan Army regulars are imparting training to a fresh crop of terrorists in the terror factories and army personnel deployed in the forward posts desperately trying to push a large group of infiltrators inside the Indian territo-

According to a senior Army officer, who supervised the entire operation on ground zero in Baramulla on Tuesday told reporters, "a 19-year-old Pakistani terrorist Ali Babar Patra, son of Late Mohd Lateef R/O Dipalpur, District Okara Punjab (Pakistan) had decided

Army after one of his close associates was eliminated by the Indian patrol party while foiling a major infiltration bid in the Uri sector on September

The Army officer said in the last week, a total of seven terrorists have been neutralised and one terrorist apprehended, including five along the LC.

During interrogation the young terrorist also revealed that the route taken by the terrorists to infiltrate was from Sawai Nala Terrorist Camp to Hallan Shumali Launch pad to Jabri, leading into Salamabad Nala. In 2016, the terrorists who had carried out a suicide attack on Uri Garrison had used the the same route via Salamabad Nala before sneaking inside the Indian territory.

Sharing details of the operation a senior army officer in Baramulla told reporters, "during the infiltration attempt on September 18-19, while two terrorists were crossing the LoC, own patrolling party established contact with them. Taking advantage of the thick undergrowth, four terrorists



ran back towards the POK side of LC while remaining two terrorists managed to sneak in".

The Army officer said,

"Additional forces were inducted and multiple patrols were launched in the suspected areas and the getaway routes were blocked. ## Police brutality in Gorakhpur claims trader's life

**Lucknow:** Alleged police brutality in Gorakhpur led to the death of a 36-year-old trader from Gorakhpur. The victim was allegedly thrashed by the police after he questioned the cops for checking his hotel room late on Monday. The cops, however, claimed that they used no force and that the youth was drunk and he died after he fell on the floor.

Later, after the local residents staged a demonstration, Senior Superintendent of Police of Gorakhpur, Vipin Tanda, suspended half-a-dozen policemen, including the local station house officer (SHO). Reports said that Manish Gupta (36), a businessman hailing from Barra locality of Kanpur, reached Gorakhpur on Monday along with his two friends, Pradeep Singh and Hariveer Singh, to visit the zoo and also for darshan at Gorakhnath Math. They checked into in a hotel on Taramandal Road in Ramgarhtal area of Gorakhpur.

Their close friend Chandan Saini also lives in Sikriganj area of the district.

Reports said that around midnight on Monday, a police team led by local SHO reached the hotel and barged into the room of these traders and asked them to show their identity cards and give the reason for staying in Gorakhpur. The situation took an ugly turn when Manish questioned the policemen for disturbing them in late hours, saying that they were not terrorists. His friends claimed that on this, the cops assaulted Manish. When the cops left, the friends took Manish to a hospital where he was pronounced dead. ## Gadkari reviews construction work of all-weather Zojila, Z-Morh tunnels



Addressing media persons on the occasion the Union Minister said that extensive road networks in the Himalayan Region will help boost the tourism sector in the

## Sakinaka rape and murder case: Mumbai Police files chargesheet within 18 days

Having completed the investigations into the much-discussed Sakinaka rape-and-murder within just 18 days of the incident, the Mumbai Police on Tuesday filed a comprehensive chargesheet against the prime accused for allegedly raping and murdering a 32-year-old woman in the small hours of September 10.

Confirming the development, Mumbai Police Spokesperson and DCP Chaitanya S said: "We have filed a 346-page chargesheet before the Dindoshi Court, within 18 days of the crime". Among other things, the police have invoked

Sections pertaining to rape and murder and relevant provisions under the SC/ST atrocities act against the lone arrested accused Mohan Chauhan It may be recalled that within hours after the horrific incident which had caused a nation-wide

furore, the accused Chauhan was arrested as he was attempting to flee to his native place Jaunpur in Uttar Pradesh. A jobless driver, Chuahan allegedly raped and

killed the victim woman in a fit of rage over some monetary disputes. The chargesheet provides the details of the sequence of events, the causes and other aspects

leading to the heinous crime. The incident took place at an isolated spot in Sakinaka in north Mumbai. Chauhan allegedly perpetrated sexual assault on her, later brutalized her by thrusting an iron rod into her private parts

An alert local security guard called up the Mumbai Police Main Control Room around 3 am that morning and a Sakinaka Police Station team rushed there and immediately shifted her to Rajawadi Hospital, where she succumbed after over

After serious cognisance of the shocking incident, Maharashtra Chief Minister Uddhav Thackeray had ordered the city police to complete the investigations within a month and file a chargesheet in the case immediately afterwards.

On their part, the Mumbai police completed the investigations in a record 18 days and filed its charge-sheet in the court within 18 days.

The charge-sheet contains the statement of the watchman, other witnesses who had seen the victim and the accused together, the medical teams which attempted to save her and the relatives of

Following the Sakinaka incident, the Mumbai Police has implemented a series of measures to ensure the safety of women and girls, especially at night, strengthening of existing patrolling and detection methods, etc.

In a letter written to Maharashtra Governor Bhagat Singh Koshyari, the Chief

Minister had last week had said that the State Government had arrested the culprit behind the Sakinaka incident within ten minutes of the police arriving at the crime scene. He said that his Government had taken various steps to do justice to the victim girl in the Sakinaka incident.

## CBI files chargesheet against six for Calcutta HC okays Sitalkuchi post-poll violence death

New Delhi: The CBI has filed a chargesheet against six persons, said to be TMC workers, in connection with the killing of a man during post-poll violence at Sitalkuchi in West Bengal's Cooch Behar district.

All the six chargesheeted accused accused residents of Cooch Behar district. The agency filed the chargehseet before the court of ACJM, Mathabhanga, Cooch Behar, the

The CBI had registered this case on August 27 on the orders of Calcutta High Court. Following the High Court order dated August 19, the agency took over the investigation of the case, earlier registered at Police Station Sitalkuchi in Cooch Behar district as FIR No. 104/21 dated May 5, 2021 on a complaint against unknown

"It was alleged that the unknown persons who, according to the complainant, started beating her husband arbitrarily with an iron rod and fired bullets at him. He was rushed to Dinhata Hospital where he died during treatment," the agency said in a statement.

Sources said the CBI findings in the case are in sharp contrast to the allegations levelled in the State police FIR. The wife of the deceased had claimed that her family was a Trinamool Congress supporter and her husband was shot dead by "BJP goons".

The six chargesheeted accused are Tahidul Mia, Haridas Barman, Madan Barman, Naba Kumar Barman, Shyamal Barman and Arabindo

New Delhi: The Government has further extended the suspension on commercial international flights till October 31, 2021. In a circular issued by the Director General of Civil Aviation (DGCA) on Tuesday, however, said the restriction will not be applicable for international all-cargo operations and flights specifically approved by the DGCA. Also, international scheduled flights may be allowed on selected routes by the competent

authority on case to case basis. "In partial modification of circular dated 26-06-2020, the competent authority has further extended the validity of circular issued on the subject cited above regarding Scheduled International commercial passenger services to/from India till 23:59 hrs IST of 31st October, 2021. This restriction shall not apply to international all-cargo operations and flights specifically approved by DGCA," the circular reads

Last month, the DGCA had extended the suspension on scheduled international commercial passenger flights till 30 September.

To check the spread of the Covid-19 infection, commercial international flights were suspended since March 23, 2020. Special international flights were also operating under the 'Vande Bharat Mission' since May 2020 to bring home thousands of Indian nationals stranded abroad due to the coronavirus lockdown.

Amid pandemic, India has formed air bubble pacts with 27 countries including the US, the UK, the UAE, Kenya, Bhutan and France. Under an air bubble pact between two countries, special international flights can be operated by their airlines between their

## Ban on global flights extended | ED grills Maha ex-Min Anil Parab for 8 hours

Directorate (ED) on Tuesday grilled Maharashtra's former Transport Minister and Shiv Sena leader Anil Parab for eight-long hours in connection with the allegations of corruption made against him by incarcerated police officer Sachin Vaze.

The development came a day after the ED raided the residence of Shiv Sena's former MP Anandrao Adsul and his son Abhijit Adsul in connection with a complaint of alleged scam worth ₹980 crore in the City Cooperative Bank Ltd,

here. Talking to media persons outside the ED's office after the questioning by the investigating agency, Parab said that he had replied to all the queries posed to him by the ED sleuths.

"I am answerable to an authority like the ED and I am not bound to reply to any individuals (the media). If called again, I shall definitely go and cooperate with them," Parab said.

On whether the ED was satisfied with his answers, Parab said he was not in a position to comment on this.

The ED investigations relate to an allegation that Vaze had made in April this year that the minister had asked him to collect Rs 50 crore to close a preliminary inquiry against Saifee Burhani Upliftment Trust (SBUT).

It may be recalled that in a four-page hand written letter to the Special Judge of the NIA court on April 7, 2021 Vaze – who is currently in the central investigating agency's custody in the twin SUV planting and alleged Manshukh Hiran murder cases - had claimed that Parab had called him July-August, 2020 to his official

bungalow and look into a complaint concerning the Saifee Burhani Upliftment Trust (SBUT), which was under preliminary enquiry and asked him to bring the SBUT trustees to him for negotiations about the enquiry.

"He (Parab) also insisted to initiate primary talks to get Rs.50 crore from the SBUT in order to close the said enquiry. I had expressed my inability to do any such things as I do not know anyone from the SBUT and also I did not have any control over the enquiry," Vaze had contended in his letter to the NIA court.

### HC junks bail plea by Rana Kapoor's wife

Mumbai: The Bombay High Court on Tuesday rejected a bail plea filed by the Yes Bank founder Rana Kapoor's wife Bindu, her daughters Roshini Kapoor and Radha Kapoor-Khanna, and a former bank senior executive Rajiv Anand, in the financial irregularities pertaining to the Dewan Housing Financials Ltd. (DHFL) cases.

While rejecting their bail pleas, Justice Bharati Dangre observed that the petitioners faced serious offences which have "resulted in serious dent to the financial health of the State' and defrauding the public at large.

The court further said that such 'heinous' offences seem to be "occurring in plenty" leading to "stultifying overall growth of the nation...and causing tremendous impairment to the economy of the nation".



## Phew!

The scare of the third wave may not be pressing but the need for precautions does not wane

The debate in India is slowly but surely shifting from the next wave to the no wave of the COVID-19 pandemic. Whether it is empty rhetoric or for real, the country is certainly in a mood to break the shackles of lockdown but with safety precautions still in place. The faster pace of vaccination has much to do with the buoyed spirit as also the consistently reducing number of fresh cases in States, save a few. There is palpable relief as people are finally in full pursuit of economic activity. Only the educational institutions have not fully re-opened across the country. Children under 18 are yet to get vaccinated and there is worry about infection stalking them outside their homes. Schools are now offline in some States, but attendance is quite low in private schools. The people and the authorities are gearing up for the festival season that begins next month: The people to shop and enjoy,



the authorities to prevent the season from turning into a super spreader. A serosurvey conducted by the Indian Council of Medical Research in Odisha between August 29 and September 15 showed that at least 73 per cent of the State's population and over 93 per cent of health workers have developed antibodies against the virus. Also, no marked difference was found in post-vaccination seroprevalence in rural and urban areas and no difference in antibodies in men and women.

The results are encouraging. Given the massive vaccination exercise, the presence of antibodies,

and the absence of new variants or mutations of the virus, scientists are willing to stick their necks out to say that the next wave may not be national but will be made up of local waves. Their logic is that the majority of the Indian population may by now have protection through vaccination or natural infection and that the presence of new cases indicates sustained transmission at the district or State levels which are witnessing local waves. If so, the challenge before the Union and State Governments is that much more. They claim to have the infrastructure ready to deal with a new wave. Simultaneously, they will have to prepare for a post-pandemic situation. The vaccination process has to be completed. The vaccination of children has to begin. The question of a booster dose for the infirm and people with comorbidities has to be settled. Serosurveys have to be conducted at timed intervals. Fresh testing must continue to identify the presence of new variants. As of now, the WHO has two variants of interest — Mu and C.1.2. The former, first identified in Colombia, has the potential to evade antibodies. Even if a new wave does not strike, India will have to throw itself into the global race to develop a new generation of vaccines that fully blocks transmission. That is the only way to affect a closure to the saga of this virus.

The 'Bharat Bandh' on Monday led to hue and cry in various parts of the country as the farmers called for a nationwide strike against the three contentious farm laws passed just about a year ago. Farm leader Rakesh Tikait claimed that it was a success. He said it was okay if the public experienced a "little inconvenience", let one day be in solidarity with farmers who have been experiencing troubles for the last 10 month



which looks good on paper. The farmers' movement has received international attention and Monday's protest, too, was covered by international media. It worked as a deterrent on the Government's image-building drive. Tikait had also tweeted to US President Joe Biden, urging him to "focus" on the farm laws ahead of PM Modi's US visit. The farmer unions had previously staged a high scale Mahapanchayat early in September when thousands of pro-farmers charged towards Karnal's Mini Secretariat to stage a gherao which unsettled the BJP Government. Tikait is scheduled to address another Kisan Mahapanchayat in Chhattisgarh's Gariaband district on

Tuesday. But the question remains whether the more antagonistic approach with protests like the Mahapanchayat and now the 'Bharat Bandh' would actually work in favour of repealing the farm laws or would they make matters worse?

The UP Government had on Sunday announced an increase in sugarcane's State Advised Price (SAP) by ₹25 per quintal for all the three varieties of the crop to woo farmers in view of the Assembly polls due next year. However, Chief Minister Yogi Adityanath's bid was not received well as Tikait called the hike a "big joke on farmers". The Assembly polls in multiple States are scheduled for 2022 and the farmer outfits seek to build pressure on the Centre. The BJP Government has more on Stake and now that the Prime Minister has returned from the US after attending strategically important meetings, a "small" dialogue with farmers can follow for the sake of peace in the country. The Centre also must realise that simply changing the CMs won't do. The Opposition parties, willingly or unwillingly, are likely to fuel the 'movement' at least until next year's polls. The need to address the contentious farm laws issue is a critical one which has grown from a 'bandh' in Punjab in September last year to a near-total 'Bharat Bandh' on Monday.

# The third way could be the way forward

long with the recent Cabinet expansion, Prime Minister Narendra Modi has introduced a Ministry of Cooperation. Earlier, on a visit to Amul Dairy at Anand, he had called this the third way; the Prime Minister probably meant limited corporations, partnerships/proprietorships and now also coopera-

Why are cooperatives, or cooperative institutions, important? One, they enable the direct participation of people in entrepreneurial activity. Two, the trust of the ben-eficiaries. The cooperative movement commands trust even in the developed West. An International Labour Organisation (ILO) report says that during the 2008 global financial crisis, cooperative banks reported only seven per cent of the total losses and write-offs in the Western banks. In contrast, banking giants like the Lehmann Brothers suffered huge meltdowns. Cooperative banks form 20 per cent of Europe's banking system. More than 60 per cent Americans trust the country's credit union banks, as compared to commercial ones.

The Cooperative Society Act was enacted in 1912. The Anand Milk Union Limited, which today is a global Indian brand by the name of Amul, was started in 1946, under the direction of Sardar Vallabhbhai Patel. Cooperative societies are working from New Zealand in the east to the US in the west.

But it is in India they have a seminal role to play. Let us take the saga of Amul, the country's best known and most successful cooperative institution. Under Sardar Patel's initiative, dairy farmers of the then Kheda district of Gujarat organised themselves to form a dairy cooperative in order to directly undertake sale and processing of milk collected from member dairy farmers of the district. Amul has made a world of dif-

erence, to not only India's dairy farming, but also the country's socioeconomic life. Figures tell this story like nothing else. During the two decades between 1950 and 1970, milk production grew by a bare one per cent annually; per capita availability of milk actually decided by an equivalent percentage in the same period. Various State Governments in the decade of

the 1960s tried different strategies to develop dairying, including establishing dairies run by their own departments. Cattle colonies were set up to enhance milk production, but were concentrated in urban areas and not in the milk sheds or cattle graz-

It was Operation Flood implemented by the National Dairy Development Board (NDĎB), which revolutionised dairy development in India. Beginning in 1970, the NDDB replicated Amul's successful model. Here, individual farmers are joined in village-level dairy cooperative societies (DCS), which in turn are joined in Statelevel marketing federations. The Amul pattern in each state has decentralised milk production by small milk producers, milk procurement by village-level dairy cooperative societies, centralized milk production by district-level unions and marketing of milk and milk products by the State federations.

Primary milk producers govern this entire federal cooperative structure to ensure that the higher tier organizations cater to the lower tiers and the gains at all levels flow back to the milk producers in significant measure. The Anand model enabled Operation Flood, making India the world's largest producer of milk at more than 100 million tonnes annually, val-

Milk today reaches more than 750 towns and cities of the country through the National Milk Grid Network. The number of women's cooperatives has grown significantly. The cooperative model has empowered them in ways that were inconceivable decades ago. Women dairy cooperatives, with further branching out into animal husbandry, are another success story of this movement.

The cooperative movement has seen one of its great successes in Maharashtra and Karnataka, particularly the former. In Maharashtra, the cooperative movement has been embraced by the States' rural and urban folk alike.

It has also spawned acrossthe-board success in the production of sugar and in the banking sector. In rural Maharashtra, it is cooperative banks that hold the sway and are the preferred banking institutions to deposit money. The cooperative movement in this State has also morphed into the political sphere. The sugar cooperatives in the State have become the prima donna of political influence and power.

One cannot also deny that many cooperative banks have floundered or are struggling. This is because they have shied away from professionalising their management. Instead,

many have opted for what is sometimes derisively referred to as the "Lalu model of management". In other words, family members or cronies have been appointed in the top decision making posts. But this does not diminish the importance of the cooperative movement.

But to come back to the third way; namely, the cooperative approach can enable a farmer of even a couple of hectares of land-holding, or his urban counterpart, to be a partner in entrepreneurship. The apex cooperative and its management need to be honest as well as imaginative. Depending on the product, it can be a manufacturing or a marketing exercise, while the cooperatives at the field level would supply the input, like milk in the case of Amul. It is a marvellous idea for a country with a large population and comparatively little land. The proprietorship/partnership model is the second way for the middle rung of entrepreneurs, while the first way is of the limited company model.

## **FIRST COLUMN NO COERCION TO REDUCE POPULATION**

Promote education among girls and awareness about family planning

he announcement of the new population policy - Uttar Pradesh Population (Control, Stabilization and Welfare) Bill, 2021 — by Chief Minister Yogi Adityanath on the eve of World Population Day in July has opened a Pandora'sbox and provided fresh ammunition to the opposition in the backdrop of the state legislative elections scheduled early next year. Some of the birth control measures in the Bill are coercive in nature. While recommending a two-child policy per couple, the state offers both incentives and disincentives. Government servants following the two-child norm would get two additional increments during their service apart from maternity or paternity leave for 12 months with full salary and a three per cent increase in the employment contribution fund. Those who fail to follow the norms



would be debarred from contesting local bodies polls, would not be eligible to apply for government jobs, would be deprived of promotion, if in service, and would not get the benefits of subsidies.

This move should have been welcomed, especially when since 1990s 12 other states have experimented with some form of a two-child policy. However, Chattisgarh, Himachal Pradesh, Madhya Pradesh and Haryana have since revoked the norms. These states also had strong disincentives. So, why are the opposition parties making so much noise? The main reason is the timing of this announcement just before the elections and the apprehension that the Muslim community is being targeted. The announcement has, once again, brought to the fore some pertinent questions about India's population growth and its policies. First, is population explosion such a major issue? Second, is there a need to adopt coercive methods as proposed in the UP bill? Third, would the adoption of the suggested measures be an effective step in solving the problem? Fourth, is the Muslim population growing so rapidly that it willlead to overtaking of Hindus in numbers over a period of time? And lastly, what is the best option available to control the population? We need to provide convincing answers to these relevant questions. Undoubtedly, increase in population is a serious issue. India's population will surpass China's by 2027. About the need for coercive methods, Union Minister of State for Health and family Welfare, Ashwini Kumar Choubey, has categorically denied that there is a push to impose a two-child norm. Thirdly, a two-child norm, it has been seen, has resulted in rise of sex-selective and unsafe abortions. Moreover, to contest local body elections, some men went to the extent of divorcing their wives or gave up their children for adoption to avoid disqualification. Fourthly, according to the 2011 census, the highest number of Muslims in the country - over 38 million — live in Uttar Pradesh. However, the community still accounts for less than 20 per cent of the state's population. As per official data, between 2001 and 2011, Hindus grew at two percent annually while Muslims grew at 2.5 per cent. A finding of the Population Foundation of India reveals that while the Hindu growth rate declined by 5.6 percentage points in the last two decades, for Muslims, the decline was even faster, at 6.1 percentage points during the same period. So, what is the best course available to solve the problem of population explosion? In India, Total Fertility Rate for women with more than 12 years of education is 1.7 compared to 3.1 for the illiterate. So, the way out is promoting education among girls, awareness about family planning, easier access to contraception, incentivizing late marriages and child births and promoting participation of women in workforce.

# Maintaining the ecological balance



The objective of environmental laws is to conserve, sustain and manage the environment without which the 'right to life' remains inconceivable

ou must show it is a ministry for environment and not just of environment", chastised the Supreme Court as recently as in June, 2021, when the Ministry of Environment, challenged the order of the National Green Tribunal (NGT) finding faults with a government notification of 2017, diluting effluent discharge norms for the sewage treatment plants. The Court bemoaned the constant dilution of environmental standards and refused to stay the NGT order.

In a landmark judgement passed on August 31, 2021, the Court refused to interfere with the judgment of the Allahabad High Court directing the demolition of the 40-storey twin towers constructed by a real state major in Noida in contravention of the environmental and other building bye-laws.

The Court has through such judgments expanded the ambit and the scope of article 21 which declares that "no person shall be deprived of his life or personal liberty except according to procedure established by law..." The Court overruled its judgment in AK Gopalan vs the State of Madras (1950) and in Maneka Gandhi vs the Union of India (1978) and held that "the procedure" under Article 21 has to be fair, just and reasonable and would also have to be tested with Article 14. In their latest judgement in KS Puttaswamy vs Union of India, a nine-judge bench unanimously held the right to privacy as an integral part of fundamental rights. In the same judgment, it also upheld the minority view of Justice HR Khanna in the ADM Jabalpur case (1976) who had held that "right to life is inalienable" and that it existed before "the advent of the Constitution".

The right to life is guaranteed and not granted. The enjoyment of the right to life is inconceivable without safe and sustainable environment. And the courts ensure this connection between the two. Article 142 empowers the Court to pass such decree or order as may be necessary to render complete justice. Under this Article, the Court can "fashion new tools, forge new methods, innovate new strategies and evolve a new jurisprudence" so as to render complete justice. It has done precisely that to respect the link between environment and right to life.

The objective of environmental laws is to conserve, sustain and manage the environment so that life remains sustainable. The Constitution casts an obligation on the State to protect and improve the environment and to safeguard the forests and wildlife, rivers and lakes and also to have compassion for living creatures. The 42nd Constitution Amendment removed forests and wildlife from the State List of the Constitution and included them in the Concurrent List. Article 48A, a Directive Principle of State Policy, and Article 51A, both inserted by the 42nd Amendment, cast an obligation on the State as well as




Article 21. Public health and ecology were held to be priorities under Article 21. In TN Godavarman Thirumulkpad case (1995), the Court ruled that no forests, national park or wildlife sanctuary can be de-reserved without its explicit permission and that no on-forestry activity will be permitted in a national park or wildlife sanctuary, among others. The Court also imposed complete ban on cutting trees and moving timber from the north-eastern states and felling of trees in Uttarakhand, Himachal, J&K and the hilly areas of West Bengal. In MC Mehta vs Kamal Nath (1996), the Court held that leased forest land was situated on the bank of river Beas being fragile, cannot be converted into private ownership. The Court quashed the lease and passed order to pay the compensation for restitution of environ-

legal Action Etc. case (1996), the Court held that the industries producing chemicals like Oleum and Sludge Phosphate which caused damage to nearby villages were responsible for the damages on the principle of polluter pays. In Vellore Citizens Welfare Forum case (1996), observing that the river Palar was the main source for drinking and bathing for the people nearby, the Court granted the relief sought by the petitioners.

The Court directed to maintain ecological balance in Narmada Bachao Andolan vs Union of India (2000). In KM Chinnappan and T. N. Godavarman Thirmalpad vs Union of India (2002), the Court ruled that the "the State and the cit-

izens are under obligation to protect and improve the environment, including forests, lakes, rivers, wildlife and to have compassion for living creatures". In the Research Foundation for Science Technology National Resource Policy vs Union of India and Another (2005), the Court read procedural guarantees into Article 21, that is, the right to information and community participation for protection of environment and human health. Almitra H. Patel & Ors. vs Union of India & Ors. is a case that comprises of a series of a petitions made before the Supreme Court in 1996. In compliance of the directions of the Court, rules were evolved for the management and handling of hazardous wastes. In yet another case – MC Mehta vs Únion of India the Court passed an order in December 2015 for diversion of commercial vehicles coming from the adjoining States so as to bring down pollution level in Delhi and also directed that all manner of commercial taxies run on CNG.

The judgements of the apex Court have fostered sound environmental jurisprudence, reminding us of the deep veneration and gratitude of the Vedic seers to Mother Earth for sustaining life. The Prithvi Sukta of the Atharva Veda, exhorts for keeping the Earth free from human pressure so that it is able to nourish us. The Court has broadened the horizon of the right to life and conjoined it with environment by enunciating sound principles like, the polluter pays, the precautionary principle, inter-generational equity, the public trust principle, etc.

# Still awaiting a permanent seat in the UNSC

### Though the United States and other countries talk of reforms in the United Nations, the world body's reform movement has been at a snail's pace

ndia has been in quest of a place at the UN high ■ table for a long. The issue has arisen again during last week's bilateral meeting in Washington between US President Joe Biden and Prime Minister Narendra Modi.

India has been lobbying for the Security Council's expansion and has staked its claim for a place. At least four American Presidents -George Bush, Barack Obama, Donald Trump, and now Joe Biden - have openly declared their support to India's candidacy. In November 2010, Barack Obama said he looked forward to India becoming a permanent member of a reformed UNSC. Trump, too, backed India's claim. Now, Joe

Biden has joined the list, also reiterating his support for India's entry into the Nuclear Suppliers Group. However, no sign of UN reforms so far. India was elected as a nonpermanent member of the powerful Security Council for two years in June 2020. She served eight two-year terms earlier.

As a UN founder member, we have a strong case. India has the world's secondlargest population and is the world's largest democracy. The country has been consistent in its contribution to the UN peacekeeping missions and has sent close to 200,000 troops, including an all-women force in 2007. Should India become a permanent member, it would have the ability to shape a range of



regimes. Last September, frustrated at the snail's pace of the reform movement, Modi, while addressing the UNGA, asked, "Till when do we have to wait?" Currently, the Council does not represent the developing world and global needs — with the importance of policy resting with the Permanent Five (P-5) - US, UK, Russia, China, and France. Any one of them could sabotage any proposal with their veto power. Four

UNSC. They have bilaterally expressed support for its candidature. But none of the P-5 is in any hurry to relinquish their veto-wielding seat on the Council. India, Brazil, South Africa, Germany, and Japan are solid contenders for permanent membership of the Council, forming a G-4 pressure group.

The story of India's claim

to the Council goes back to Prime Minister Jawaharlal Nehru's time. His critics, then and now, accuse him of sacrificing India's national interest on the grounds of international morality. Reports claim that back in 1950, the US quietly sounded New Delhi about replacing Taiwan on the Council. Nehru demurred

out of the five permanent and suggested that it should new permanent members, its members back India's claim to go to the People's Republic of primacy may be challenged China. Similarly, he is reported to have declined Soviet Russia's modest proposal in 1955. Nehru wrote to his sister Vijayalakshmi Pandit, "India, because of many factors is certainly entitled to a permanent seat in the Security Council but we are not going in at the cost of China". He obviously did not visualize China's future growth.

Going by the trend, the world body is not in a hurry for reform. Though the US and other countries talk of reform, it is not a priority for the UN. Every UN Secretary General has pleaded for reform. Former SG Kofi Annan (2015) has aptly said if the UNSC does not appoint

primacy may be challenged by some of the new emerging countries. He noted that the Council has thus become an organization that can pass strong resolutions against weak countries and weak resolutions against solid countries. This indicates the helplessness of the UN in dealing

with P-5 on the subject. This brings us to whether the UN has performed its role in the past 75 years. Critics point out that several authoritarian rulers have used conventional weapons against innocent citizens on the UN watch. Moreover, the UN resolutions are non-binding. The World Body was supposed to prevent conflicts and war, yet over 80 clashes have started since its inception. The US Presidents, from Bush to Trump, have all criticized the UN for its functioning. UN is also facing a resource crunch because members, including the US, do not pay their contribution

Despite all complaints and criticism, the UN is currently the only international organization where leaders from different countries come together to work out some of the world's problems. The Taliban banned barbershops in a southern Afghanistan province from shaving or trimming beards, claiming their edict is in line with Shariah, or Islamic, law.

The order in Helmand province was issued Monday by the provincial Taliban govern-ment's vice and virtue department to barbers in Lashkar Gah, the provincial capital. "Since I have heard (about

the ban on trimming beards) I am heart broken," said Bilal Ahmad, a Lashkar Gah resident. "This is the city and everyone follows a way of living, so they have to be left alone to do whatever they want."

During their previous rule of Afghanistan, the Taliban adhered to a harsh interpretation of Islam. Since overrunning Kabul on Aug. 15 and again taking control of the country, the world has been watching to see whether they will re-create their strict governance of the late 1990s.

Some indication came on Saturday, when Taliban fighters killed four alleged kidnappers and later hung their bodies in the public squares of the western city of Herat.

"If anyone violates the rule



(they) will be punished and no one has a right to complain, said the order issued to the barbers. It wasn't immediately clear what penalties the barbers could face if they don't adhere to the no shaving or trimming

During the Taliban's previous rule, the conservative Islamists demanded that men grow beards. Since being ousted from power following the US-led invasion in 2001, many men have opted for no or cleanly trimmed beards.

Barbershop owner Jalaluddin, who like many Afghans goes by only one name, said he hoped the Taliban would reconsider their

"I request our Taliban brothers to give freedom to people to live the way they want, if they want to trim their beard or hair," he said. "Now we have few clients coming to us, they are scared, they don't want to trim their hair or beards, so I request them let people free, so we have our business and people can freely come to us."

barbershop Another owner, Sher Afzal, also said the decree hurts the bottom line. "If someone comes for a haircut. they will come back to us after 40 to 45 days, so it is affecting our business like any other businesses," he said.



# Thunberg chides leaders for 'blah, blah, blah' on climate

Y Nakate and Greta Thunberg chastised global leaders on Tuesday for failing to meet funding pledges and for delivering too much "blah blah blah" as climate change wreaks havoc around the world. They even cast doubt on the intentions behind a youth climate gathering where they were speaking in Milan.

from 180 countries were invited to Italy's financial capital for a threeday Youth4Climate summit that will send its recommendations to a major United Nations climate summit in Glasgow, Scotland, that begins October 31. But participants are demanding more accountability from leaders and a bigger official role for young people.

"They invite cherry-picked

young people to pretend they are listening to us," Thunberg said. "But they are not. They are clearly not listening to us. Just look at the numbers. Emissions are still rising. The science doesn't lie.

"Leaders like to say, We can do it.' They obviously don't mean it.

But we do," the Swedish activist said. Nakate, a 24-year-old activist

from Uganda, said pledges of 100 billion euros (\$117 billion) a year to help countries particularly vulnerable to the impact of climate change has not materialized, even as wildfires in California and Greece and floods in Germany and Belgium show that "loss and damage is now possible everywhere."

"In fact, funds were promised by 2020, and we are still waiting," she said. "No more empty conferences. It's time to show us the money. It's time, it's time, it's time. And don't forget to listen to the most affected people and areas."

Nakata dramatically underlined how climate change is affecting the African continent, "which is ironic given that Africa is the lowest emitter of CO2 emissions of any continent except Antartica."

Just last week, she said she saw police taking away a body that had been washed away by violent storms in the Ugandan capital of Kampala, while others searched for more victims. Her mother told her that one man dragged off by the water had been trying to save the goods he was selling from being

Nakata collapsed in tears after her emotional speech, getting comfort from Thunberg, who followed her to the podium that was too tall

for her small stature. Thunberg, who coalesced the global protest movement Fridays for Future, optimistically said it wasn't too late to reverse climate trends. But she has clearly heard enough from leaders, whom she said have been talking for 30 years while half of all carbon emissions have occurred since 1990, onethird since 2005.

'This is all we hear from our so-called leaders: Words. Words that sound great but so far have led to no action. Our hopes and dreams drown in their empty words and promises. Of course we need constructive dialogue, but they have now had 30 years of blah, blah blah. And where has this led us?" she said.

The three-day Youth4Climate Summit will be followed by a twoday pre-COP meeting before Glasgow aimed at finding common ground on sticking points among countries, which range from the world's big carbon emitters to developing nations that are lagging both economically and techno-

Sebi's board on Tuesday cleared a proposal for setting up a gold exchange wherein the yellow metal will be traded in the form of electronic gold receipts and the bourse will help in having a transparent domestic spot price discovery mechanism.

The instruments representing gold will be

called Electronic Gold Receipts (EGRs) and will be notified as securities, Sebi Chairman Ajay Tyagi said at a press conference after the board meeting.

EGRs will have the trading, clearing and settlement features akin to any other securities," he Any recognised stock exchange, existing as well

as new, can launch trading in EGRs in a separate segment. The denomination for trading of EGR and conversion of EGR into gold can be decided by the stock exchanges with the approval of Sebi. The gold exchange, encompassing the entire

ecosystem of trading of EGR and physical delivery of gold, is expected to create a vibrant gold ecosystem in India, Sebi said. According to the regulator, the exchange would be a national platform for buying and selling EGRs

with underlying standardised gold in India and also create a national pricing structure for gold. The gold exchange is expected to offer a host of benefits for the value chain participants as well

as for the entire gold market ecosystem such as efficient and transparent price discovery, investment liquidity, assurance in the quality of gold etc," Seb

## Petrol, diesel prices hiked **MORE TO COME AS CRUDE NEARS USD 80/BARREL**

PTI ■ NEW DELHI

Petrol price on Tuesday was hiked by 20 paise per litre and diesel by 25 paise as international oil prices neared USD 80 per barrel mark for the first time in three years.

The price of petrol was hiked to  $\overline{\P}$ 101.39 a litre in Delhi from ₹101.19 and to ₹107.47 per litre in Mumbai, according to a price notification of state-owned fuel retailers

Diesel rates went to ₹89.57 a litre in Delhi and ₹ 97.21 in Mumbai. Prices differ from state to state

depending on the incidence of local taxes. This is the first price increase in petrol in more than two months and the fourth in case of diesel.

The increase followed interna-

tional oil prices rising for the fifth consecutive day and global benchmark Brent heading for USD 80 per barrel.

Tuesday was the first increase in petrol price since state-owned Indian Oil Corp (IOC), Bharat Petroleum Corp Ltd (BPCL) and Hindustan Petroleum Corp Ltd (HPCL) on September 24 resumed daily price revisions, ending the pause in rates that had effected since September 5.

In four price increases since September 24, diesel rates have gone up by 95 paise per litre. This negates three-fourths of the Rs 1.25 a litre cut in prices that happened between July 18 and September 5.

Before this, diesel price was last increased on July 15. The last increase in petrol rate was on July 17.

The 34-year-old Ali, a spin bowling all-rounder, announced retirement from the longest format of the game on Monday. "First and foremost, it goes without saying that Mo's (Moeen) career speaks for itself and what he has achieved," Root was quoted as saying by ESPNcricinfo.Com.

#### 'FOREIGN COACHES DECISION AFTER N'TL C'SHIP' The Wrestling Federation of India (WFI) on Tuesday said it will decide on

the extension of existing foreign coaches attached with prominent wrestlers and other coaches for the next Olympic cycle only after the National Championship in November. Georgian Shako Bentinidis is attached with Tokyo bronze winner Bajrang Punia while Russian Kamal Malikov trains Ravi Dahiya, who became the new super star of Indian wrestling after winning a silver in the Japanese capital. WFI also has to decide if a foreign coach is required at the national camp for women wrestlers as the federation has not yet approached any trainer from overseas since American Andrew Cook was sacked.

#### SUPER LEAGUE CASE: UEFA TO REMOVE SPANISH JUDGE UEFA on Tuesday took legal action to remove the judge from a Spanish

court case thwarting the attempt to punish Barcelona, Real Madrid and Juventus for their involvement in the ill-fated Super League breakaway. The move could eventually lead to disciplinary action restarting against the rebel clubs after it was abandoned on Monday night. "UEFA has filed a motion for the recusal of the judge presiding over the current proceedings as it believes there are significant irregularities in these proceedings," European football's governing body said in a statement. "In line with Spanish law — and in the fundamental interests of justice -UEFA fully expects the judge in question to immediately stand aside pending the full and proper consideration of this motion.

#### ITALY TO PLAY ARG IN EUROPE-S AMERICA TITLE GAME European champion Italy will play Copa America winner Argentina next

year, helping their governing bodies UEFA and CONMEBOL build closer ties amid power struggles with FIFA over the future of soccer. UEFA confirmed plans on Tuesday to stage the first of three planned editions of the inter-continental game in June at a venue to be confirmed. Naples has been suggested as a possible venue in the stadium now named for Argentina great Diego Maradona. Maradona became an icon in the city for helping Napoli win its only two Serie A titles in 1987 and 1990. "The agreement reached by the two organizations currently covers three editions of this match between the respective continental winners," UEFA said in a statement, adding the deal includes "opening of a joint office in London." UEFA and CONMEBOL are defending the traditional four-yearly schedule of their continental championships and the World Cup from a FIFA-driven plan to play the World Cup every two years.

#### **FIVE COUNTRIES QUALIFY FOR WOMEN'S ASIAN CUP** Indonesia joined four other countries, including first timers Iran, in

qualifying for the AFC Women's Asian Cup to be hosted by India in January-February next year. Indonesia topped Group C in the qualification tournament in Dushanbe, Tajikistan on Monday to ensure their fifth appearance in the tournament while Iran emerged Group G winners for their debut participation. Former champions Thailand, South Korea and Philippines also qualified for the 12-team continental women's showpiece to be held in India for the second time after 1979. The tournament, which will also serve as final stage of Asian qualification for the 2023 FIFA Women's World Cup in Australia and New Zealand, will be held in Mumbai, Navi Mumbai and Pune from January 20 to February 6. South Korea, who had finished third in 2003 as their best performance, will be making their 13th appearance after topping Group E, while Philippines won Group F for their 10th participation. Thailand, who won the 1983 edition, topped Group H for their 17th appearance in the tournament. Three other teams -- winners of Group A, B and D -- remain to qualify for the tournament in which India is the automatic qualifier as host side. The country will be making its ninth appearance in the tournament.
