Govt OK's big telecom reforms

Allows 4-year moratorium on dues, 100% FDI, PLI scheme for auto, drones

major reforms in telecom sector by handing out a four-year moratorium on payment of dues. The Cabinet also approved 100 per cent FDI (Foreign Direct Investment) in telecom via the automatic route. The Government also came out with a ₹26,058 crore production-linked incentive (PLI) scheme for auto, autocomponents and drone indus-

The four-year moratorium in the AGR (Adjusted infrastructure. Earlier, 100 per Gross Revenue) dues is a major relief to telecom players Vodafone-Idea, facing acute financial problems, and Airtel. They have a combined dues of more than ₹80,000 crore.

The Cabinet meeting chaired by Prime Minister Narendra Modi also approved a slew of measures in spectrum usage charges, sharing of spec-trum and 100 per cent FDI in telecom sector.

Briefing reporters on the decisions taken by the Cabinet, Telecom Minister Ashwini Vaishnav said nine structural reforms for the telecom sector were approved. The definition

of AGR, which had been a major reason for the stress in Union Cabinet on the sector, has been ratio-malised by excluding non-telecom revenue of telecom com-

- In another significant decision, the Cabinet cleared 100 per cent foreign direct investment (FDI) in the telecom sector through automatic route, which will encourage greater participation of players. However, all safeguards will apply, Telecom Minister Ashwini Vaishnaw said
- The Cabinet also rationalised definition of AGR by excluding non-telecom revenue of



- telecom players from payment of statutory levies
- Bank guarantees have also been rationalised, while interest rates too have been modified with removal of penalties
- For future spectrum auctions, no bank guarantees will be needed. Also the spectrum tenure has been increased from 20 years to 30 years. Surrendering of spectrum will only be allowed after 10 years, the Cabinet decided

It is estimated that over a period of five years, the PLI scheme for the automobile and auto components industry will lead to fresh investment of over ₹42,500 crore, incremental production of over ₹2.3 lakh crore and will create additional employment opportunities of over 7.5 lakh jobs, Thakur said. The PLI scheme for automobile and drone industries is part of the overall announcement of PLI schemes for 13 sectors made earlier during the Union Budget 2021-22, with an outlay of ₹1.97 lakh crore.

The scheme for the auto sector envisages overcoming the cost disabilities to the industry for the manufacture of advanced automotive technology products in India. The incentive structure will encourage industry to make fresh investments for the indigenous global supply chain of Advanced Automotive Technology products, Thakur said. The scheme for the auto sector is open to existing automotive companies as well as new investors who are currently not in automobile or auto component manufacturing business. The scheme has two components — Champion OEM Incentive scheme and Component Champion Incentive scheme.

The Champion OEM Incentive scheme is a "sales value linked" scheme, applicable on battery electric vehicles and hydrogen fuel cell vehicles of all segments, he said.

Tata Sons, SpiceJet bid for Air India

rata Sons and SpiceJet's Ajay Singh have emerged as bidders for the Air India disinvestment on the last day for putting in the financial bid on Wednesday.

If Tata buys Air India, the history will come full circle and this will mark the return of the airline to a group after 67 years which had built and nurtured it into one of the world's finest airlines until grasping and sloppy Governments run it into the ground.

Taking to Twitter, Department of Investment and Public Asset Management (DIPAM) Secretary, Tuhin Kanta Pandey, said the disinvestment process now moves to the concluding stage. "Financial bids for Air India disinvestment received by Transaction Adviser. Process now moves to concluding stage," Pandey tweeted.

The financial bids will be evaluated against an undisclosed reserve price and the bid offering the highest price above that benchmark would be accepted. The bid will be initially examined by the transaction advisor before the recommendation is sent to the Cabinet for approval.

If Tata wins, Al will return to it after 67 years



According to reports, a Tata Sons spokesperson has confirmed that Tatas have submitted a financial bid for Air India. Though Tata Sons have confirmed their participation in the financial bid, sources said the promoter of domestic carrier SpiceJet, Ajay Singh, also reported to have placed the bids for Air India disinvestment. Tata Group was among the multiple entities that had put in initial expression of interest (EoI) in December 2020 for buying the Maharaja.

Tata, who founded Air India in 1932, is seen among the front-runners for getting the airline back. The Government nationalised the airline in 1953. Tatas operate a premier full-service carrier, Vistara, in partnership with Singapore Airlines.

India assails 'failed State' Pak, | Stage set for GST **OIC** for Kashmir rant at UNHRC

Tndia on Wednesday castigated Pakistan and the OIC for raising the Kashmir issue Human Rights Council, saying it does not need lessons from a "failed state" and the "epicentre of terrorism" and chided the 57nation bloc for "helplessly" allowing itself to be held "hostage" by Islamabad.

At the 48th session of the UNHRC, India mounted a blistering attack on Pakistan, saying it has been globally recognised as a country openly supporting, training, financing and arming terrorists including UN proscribed terrorists as a "matter of state

India's response was delivered by Pawan Badhe, the first secretary in its permanent mission in Geneva.

Exercising the right to reply to comments made by Pakistan and the Organisation



of Islamic Cooperation (OIC) on Kashmir, Badhe said India does not need lessons from a "failed state" like Pakistan which is the "epicentre of terrorism and worst abuser of human rights".

He also said the OIC has helplessly allowed itself to be held hostage by Pakistan, which holds the chairmanship of their Geneva Chapter, to "subserve its own agenda".

Badhe said it has become

a habit for Pakistan to misuse the platforms provided by the council to propagate its "false and malicious propaganda" against India.

"The council is aware of

Pakistan's attempts to divert the council's attention from serious human rights violations being perpetrated by its government, including in the erritories occupied by it." he

"India, as not only the world's largest democracy but a robustly functional and vibrant one, does not need lessons from a failed state like Pakistan which is the epicentre of terrorism and worst abuser of human rights,"

he said. The Indian diplomat said Pakistan has failed to protect the rights of its minorities, including Sikhs, Hindus, Christians and Ahmadiyas.

"Thousands of women and girls from minority communities have been subjected to abductions, forced marriages and conversions in Pakistan and its occupied territories," Badhe said in his statement.

Food delivery aggregators may be taxed

In the first physical meeting Isince COVID-19 pandemic broke out in March 2020, the 45th meeting of the Goods and Service Tax Council in Lucknow will be presided over by Union Finance Minister Nirmala Sitharaman and some crucial issues are likely to figure prominently in it.

The 44th GST Council meeting took place via video conferencing on June 12 wherein some key issues were addressed and GŚT rates on several items crucial in the fight against the pan-demic were slashed till September

The GST Council meeting in Lucknow, starting on Friday, is likely to take up the issue of tax evasion by restaurants and online food delivery operators and these firms may have to pay GST on Continued on Page 11 | services supplied by them. As per

the estimates of the fitment committee of the GST Council, Rs 21 were evaded by these firms and the panel recommended food aggregators be classified as e-commerce operators and pay GST on behalf of the restaurants concerned.

The fitment panel suggested that the changes come into effect from January 1, 2022, and food delivery aggregators be allowed to make suitable changes in their software. The other kev issues that the

GST Council will take up would be related to compliance and may be taken up notifying a common comprehensive e-portal gst.gov.in for registration, paying tax, and filing returns.

India records 11.8% rise in cybercrimes in 2020

m ndia}$ recorded 50,035 cases of cybercrime in 2020, marking 11.8 per cent surge in such offences in contrast to 2019.

As many as 578 incidents of "fake news on social media" were also reported, according to official data released on Wednesday by the National Crime Records Bureau.

Among the States, the maximum 11,097 cybercrime cases were reported in Uttar Pradesh followed by Karnataka (10,741), Maharashtra (5,496), Telangana (5,024) and Assam (3,530), it showed.

However, the crime rate was highest in Karnataka with 16.2 per cent followed by Telangana (13.4 per cent), Assam (10.1 per cent), Uttar Pradesh (4.8 per cent) and Maharashtra (4.4 per cent), the data revealed.

The rate of cybercrime of fake news on social media,



(incidents per lakh population) also increased marginally from 3.3 per cent in 2019 to 3.7 per cent in 2020 in the country, according to the NCRB data.

In 2019, 44,735 cases of cybercrime were recorded, while the figures stood at 27,248 in 2018.

In 2020, 4,047 cases of online banking fraud, 1,093 OTP frauds and 1,194 credit/debit card fraud were reported. A many as 2,160 cases related to ATM were reported in 2020.

972 related to cyberstalking or bullying of women and children, 149 incidents of fake profile and 98 of data theft n

2020, the data suggested.

In terms of motive, the maximum 60.2 per cent cyber crimes lodged in 2020 were done for fraud (30,142 out of 50,035 cases), the NCRB, which functions under the Ministry of Home Affairs, stated.

It was followed by sexual exploitation with 6.6 per cent (3,293 cases) and extortion 4.9 per cent (2,440 cases), the data showed.

The Income Tax (IT) department on Wednesday conducted searches at six locations linked to Bollywood actor and philanthropist Sonu Sood in connection with allegations of tax evasion in a deal struck between the actor's company and a Lucknow-based real estate firm. The simultaneous searches were conducted in Mumbai and Lucknow.

Coming on the heels of Sood's meeting with Delhi Chief Minister Arvind Kejriwal, who declared him the brand ambassador for his Government's mentorship programme for school students in the Capital, the searches by the IT officials raised eyebrows in the political circles.

Forty-eight-year-old Sood, whose humanitarian work during the Covid-19 triggered lockdown period has earned him a lot of goodwill among the people across the country, has so far not commented on the raging speculation about his joining the AAP and contesting the Punjab Assembly polls.

UP government fixes MSP for paddy

Pradesh government has fixed the minimum support price (MSP) for paddy at Rs 1,960 per quintal besides approving a proposal to set up 16 medical colleges under the public-pri-vate participation (PPP) model in districts which do not have medical colleges. The government has also decided to set up an office of Anti-Terrorist Squad (ATS) in Mau. The decision regarding this was taken in the cabinet meeting chaired by Chief Minister Yogi Adityanath

A government spokesman said that the support price of the common variety of paddy had been fixed at Rs 1,940 per quintal and the support price of Grade-A at Rs 1,960 per quin-

"In Kharif marketing year 2021-22, the period of purchase of paddy in Lucknow division's Hardoi, Lakhimpur and Bareilly, Moradabad, Meerut, Saharanpur, Agra, Aligarh, Jhansi divisions would be October 1, 2021 to January 31, 2022, and Lucknow division's district Lucknow, Sitapur, Rae Bareli, Unnao, and Chitrakoot, Kanpur, Ayodhya, Devipatan, Basti, Gorakhpur, Azamgarh, Varanasi, Mirzapur and Prayagraj divisions from November 1, 2021, to February 28, 2022," he said.

Milestone: UP crosses 9 cr | Two intruders held **Covid vaccination mark**

Setting another record, UP's Covid vaccination coverage breached the nine-crore mark on Wednesday. The state has administered a total of 9.01 crore anti-COVID-19 vaccine doses so far since the launch of the nationwide vaccination drive in January.

past other Indian states in attempting to mitigate the anticipated third wave of COVID-19 through vaccination," a government spokesman said here on Wednesday. UP administered over

3,61,787 doses of vaccine by 7pm on September 15 taking the total tally to 9,01,51,915. The focused Covid vaccination drive in the state has ensured that more than 1,53,61,007 people are fully vaccinated in the state while more than 7,47,90,908 people have taken the first dose.

Uttar Pradesh took almost 100 days to touch the figure of one crore vaccinations. It then took 45 days to cross the twocrore mark and 59 more days to reach five crore. The state then took 14 days to reach six Hamirpur, Hardoi, Hathras,



"Uttar Pradesh is racing then 11 more days to cross seven crore vaccinations on August 28. It took just nine more days to go past the eightcrore mark on September 7. The state crossed the landmark of administering nine crore Covid vaccine doses on September 15.

Meanwhile, UP reported 19 fresh coronavirus positive cases on Wednesday as 34 districts became free of the deadly virus with no fresh or active case and only nine out of the 75 districts witnessing fresh cases in the last 24 hours.

No fresh and active case in Aligarh, Amroha, Ayodhya, Azamgarh, Ballia, Balrampur, Banda, Basti, Bahraich, Bhadohi, Bijnor, Bulandshahr, Chandauli, Chitrakoot, Etah, Farrukhabad, Fatehpur, Gonda, crore vaccination mark and Kanpur Dehat, Kasganj,

Mahoba, Moradabad, Pilibhit, Pratapgarh, Rampur, Saharanpur, Shamli, Shravasti, Siddharth Nagar, Sultanpur and Sonbhadra indicates complete elimination of the fatal virus from nearly 45 per cent of the state.

"Despite fresh cases being the state with the highest population density in the country, the Yogi-led state has also been registering a steady decline in the number of active Covid cases in comparison to several other sparsely populated states such as Delhi, Maharashtra, Kerala, and Tamil Nadu. The active caseload in Uttar Pradesh stands at 182," a government spokesman said here on Wednesday. Becoming self-reliant in

terms of producing the life-saving fluid, as many as 409 of the 555 oxygen plants have been established and are functional while work on the rest is going on in Uttar Pradesh. Twentyfive oxygen plants were already functional in the state before the government took the step of setting up more at a rapid pace to ensure the availability of sufficient medical oxygen in view of any possible future requirement.

Lucknow (PNS): The security staff of Lok Bhawan nabbed two intruders when they were entering the building while impersonating the representatives of Union minister Kaushal Kishore. Those arrested were identified as Pankaj Gupta and Mazhar Amir Farooqui, both of Para police station area. The accused entered the Lok Bhawan in a car and claimed to be representatives of the minister. They also showed a letter to the security staff but it was found to be fake. Inspector Anil Singh said the accused were challaned under Section 419/186 of IPC (cheating by impersonation and for voluntarily obstructing public ser-

vant from discharging duty). As per reports, two youths entered the Lok Bhawan in the morning. The security staff spotted them on growing suspicious and interrogated them. The youths tried to impress upon the cops by dropping the name of the minister and also showed his letter head.

The security staff called the police and a team reached the scene. The police interrogated the accused who were later taken into custody for the offence. The security officer of the Lok Bhawan lodged a case in this connection.

However, the incident exposed the loopholes in the security arrangements at the Lok Bhawan. Sources said the youths entered the Lok Bhawan but they were not questioned at the gate. However, they were later spotted and quizzed. "The accused told the police during interrogation that they were not stopped at the gate. It shows that they were frequent visitors to the Lok Bhawan," one source

Meanwhile, taking a strong

note of a a viral audio in which a police outpost incharge in Banthra was heard settling an issue related to a group clash by asking a group to give money to the other party, Commissioner of Police DK Thakur removed the S-I and asked the ADCP to take up the probe. S-I Rajesh Mishra, who was holding the charge of Harauni police outpost, was heard talking to a youth, identified as Chamka. The S-I asked him to get the issue resolved if Rs 15,000 was paid to the opposite party. The issue came to the notice of the CP and he asked his subordinates to initiate action. Subsequently, the S-I was removed from his post. A spokesman said the probe of the case was given to the ADCP (Central).

Team of incident commanders to check spread of dengue

District Magistrate Abhishek Prakash has constituted a team of 24 incident commanders to contain the spread of dengue in Lucknow where 23 fresh cases were reported on Monday.

The DM said the incident commanders would work in the offices of their respective areas, commercial shops and residential quarters and take action against the property owners if larvae were found.

Aedes mosquitoes, responsible for dengue, breed in clean water and bite in the day time. The patients suffer from high fever, abdominal pain and vomiting. Patients with these symptoms need to be tested for dengue immediately.

The DM said if any patient tests positive, the treatment should be started immediately and if the platelet count goes down, platelet should be transfused and in case of internal bleeding, arrangements should be made for blood transfusion. The DM said no laxity in treatment would be tolerated.

Four arrested for duping job-seekers

Lucknow (PNS): With the Gomtinagar and Priya Verma arrest of four accused, including two women, on Wednesday, the Krishna Nagar police claimed to have busted a gang that had duped several people of huge amount of money, while impersonating CBI officers.

Those arrested were identified as Rahul Singh aka Aryan of Krishna Nagar, Mukesh Tiwari of Aliganj, Kavita Nayal Joshi of of Aliganj.

The police recovered two fake ID cards of CBI, a pistol, eight mobile phones, documents, a US dollar and Rs 2,610 in cash. The team was led by inspector Alok Rai. The arrests were made following the investigation of a case in which a job-seeker was duped in recent past. The police said the accused used to contact people through social media platforms while impersonating CBI officers. They would ask people not to share the chat with any other person. Once they trapped a gullible person, they would take money from them for providing them jobs.

The police said the accused knew about the heads of different departments and the recruitment process, using which they would win the trust of their targets.

Pain mgmt key while dealing with child cancer patients at RMLIMS

Lucknow (PNS): Pain management has become the focus while dealing with child cancer patients at Ram Manohar Lohia Institute of Medical Sciences and there are various therapies being practised for the

Paediatric surgeon Dr Shrikesh Singh that in the old school of thought, pain management was not given so much attention but now they dealt with it quickly. He said that they use infusion therapy which was giving paracetamol in high doses and local anaesthesia. "This was the main focus in the west and now it has become a part of the treatment in north India. Pain is the only memory a child has and hence it is important to treat it," he said.

Regarding the emotional handling of the child cancer patient, he said parents' counselling is very important. He said RMLIMS is the only institute with all the facilities of cancer treatment. "We have a linear accelerator, surgical oncology and provisions for chemotherapy. We can treat all the patients, whether medical, surgical or those requiring radiotherapy. So as far as treatment is concerned, we can treat a complete spectrum of cancers," he said.

He added that at RMLIMS, they are operating all kinds of cancers such as kidney cancer & blood cancer, and there is a multimodality of treatment like in some of the cases surgery is followed by chemotherapy while in others, chemotherapy is good enough. He further said that if the child cancer patients arrive at an early stage, the success rate is almost 100 per cent. "If there is a lump in the abdomen and there is a tumour in any part of the body, it can be treated in time. The non-malignant tumour, if not treated properly within a certain time, can turn malignant. The message we give to the society is that is there are symptoms which are not normal such as constant fever, rapid weight loss, rapid weight gain, vomiting and blood in the stool. If these symptoms appear, a paediatrician should be immediately contacted so that proper investigations can

ABMU to conduct entrance tests for nursing students

Lucknow (PNS): Atal Bihari Medical University (ABMU) will conduct the entrance tests for nursing students for the first time in the state. Giving this information, Vice-Chancellor AK Singh said the entrance examination is being conducted to regulate the standard of students going to nursing colleges. "We are focusing on nursing and have taken a decision to have a test for all the nursing colleges. The forms are available and 9,000 aspirants have already registered for both government and private nursing colleges. We expect around 15,000 candidates to apply and the minimum academic qualification for them is Intermediate with Physics, Chemistry and Biology," he said. He added that the university was given the charge because it is the academic controlling authority for all the colleges. The examinations will be held in the first and second week of November this year.

"There are entrance examinations for all courses and hence the aim is to have more meritorious students joining and not extraneous factors," he said.

Meanwhile, he said the university has given its consent to over 600 courses, giving it to new colleges and starting the process of affiliation to the university. Regarding the infrastructure development of the university, he said the building is coming up in Chak Ganjaria and the construction of basement has started. "It is an affiliating university and in the second phase, the medical colleges will start the classes. The purpose of affiliating medical colleges, dental colleges and paramedical colleges is to streamline education and have a certain minimum standard," he added.

Cash, valuables stolen from house

Lucknow (PNS): Cash and ornaments worth several lakh were stolen from a house in Thakurganj police station area. As per reports, Nafis Ahmad of Baraura Husainbadi, along with his family, had gone to Hardoi for some work after locking his house on September 11. AAP releases first list of 100 probable candidates

Four drown in village pond in Chitrakoot

PNS LUCKNOW ragedy hit Chitrakoot when four

I out of the five girls who went to graze buffaloes on the banks of the pond at Bausra village in Mau police station area, drowned. The victims included two real sisters. The girl present on the shore informed the family about the incident. The district magistrate has assured the bereaved families of government assistance.

On Tuesday afternoon, real sisters Budhrani Nishad (12) and Parvati Nishad (11) daughters of Ramprakash, Savita Nishad (10) daughter of Brijlal of Bausra village, Gauri Nishad (12), daughter of Sonu Nishad and Kiran Nishad (12), daughter Josh Kumar from Maheva Ghat in Kaushambi had gone to graze buffaloes near Baisa pond on Patori road.

According to eyewitnesses, two girls slipped and fell in the pond due to light rain in the afternoon. Gauri said that everyone started bathing in the pond at around 4:30 pm when their clothes became dirty.

Kiran and Parvati went to the middle of the pond and started drowning. Budhrani and Savita went to save them and they too started drowning. Gauri got scared and somehow came out and went home and informed others about the incident. The family members of the girls and hundreds of villagers ran

towards the pond. Within two hours, the villagers took out the four girls and rushed them to the Mau community health centre where the doctors pronounced them dead.

District Magistrate Shubhrant Kumar Shukla and Superintendent of Police Dhaval Jaiswal also consoled the families of the victims and assured them of government assistance. The police sent the bodies for postmortem. The victims were the students of class four and five. Meanwhile, due to intermittent

rain for two days, the wall of a house collapsed in Fatehpur district on a woman and her son. The victims were pulled out with the help of villagers from under the rubble but by then the son had died. The woman has been admitted to the hospital in a serious condition. The incident took place early Wednesday morning.

Amita alias Guddi, wife of Sarvendra Tiwari, a resident of Goharari village of Chandpur police station area in Fatehpur, was sleeping with her 13-year-old son Raunak when the wall of their house suddenly collapsed on Wednesday morning. Both Guddi and Raunak were buried under the rubble for an hour.

With the help of the villagers who came to know about the matter, the family members pulled both out but by then Raunak had died.

Make all roads pothole-free by Oct 20: Tandon

UP Minister for Urban Development and Minister In-charge of the district Ashutosh Tandon has instructed all the departments concerned to make the roads pothole-free (Gaddha-Mukt) by October 20 in every condition. Taking a serious note of it, Tripathi asked the jail superintendent to submit an application in the concerned court for his bail.

ATS now searching for Zeeshan's aides, friends

Mohd Zeeshan Qamar, a resident of GTB Nagar of Kareli police station area in Prayagraj, was given the responsibility of blasts in many cities, including Prayagraj. He returned to the city after taking the training in Pakistan. Anti-Terrorism Squad (ATS) and security agencies have received these and other shocking information. In such a situation, now the search has started for Zeeshan's associates, close friends and those in contact with him.

Soon, other people preparing to join Zeeshan's nefarious intentions will also be tracked. It is also being ascertained that apart from Zeeshan, who else had gone to Pakistan, when and how. Passports and other documents of suspects will also be checked. Sources said that when Zeeshan came back after 15 days of training in Pakistan, he started expanding his network under the

module. Soldiers of the Pakistan army had given him training to operate ammunition and weapons. He was also asked to deposit RDX based Improvised Explosive Device (IED), grenades, pistols and cartridges. It is believed that Zeeshan had kept the IED in a Naini's poultry farm only on the behest of his masters. He was preparing to collect more weapons. It was also said that the National Investigation Agency (NIA) officials will also interrogate him in Delhi. At present, apart from the ATS, the intelligence agency is also keeping a close watch on

suspicious people in Kareli and the surrounding area. Sources said that several devices, including a laptop, pen drive, hard disk and mobile phones, have been recovered from Zeeshan's possession. A diary has also been found, in which some mobile numbers are marked. Now the security agencies will scan the laptop and mobile phones, after which further action will be taken. The activities of his other family members and friends are

also being monitored. Zeeshan, who lives in GTB Nagar C Block, did MBA from Sam Higginbottom University of Agriculture, Technology and Science (SHUATS), Naini. He is the only son in the house. His father Mohd Qamar used to work in Saudi Arabia but returned a year ago. He has three sisters who are married. Relatives said that Zeeshan also went to Saudi Arabia about one-and-a-half years ago.
After coming back from

Saudi Arabia, he used to sell dates online. Qamar told the police that on Tuesday morning that some soldiers came to his house in police uniform and civvies and took Zeeshan along with them. After that nothing was known about him. However, in the evening, when the information about his arrest was received, everyone from the family to locals were shocked. The family members

also distanced themselves from

Police sources said that the ATS team has taken the remains of the discarded IED along with Zeeshan to Delhi. There it will be examined to assess its potential. Along with this, Zeeshan will also be questioned about when and from where the equipment was purchased for him. Along with the IED remains, Zeeshan has also been taken to Delhi by ATS.

It may be pointed out here that the ATS team raided the house of Zeeshan, a block resident of GTB Nagar. After nabbing Zeeshan from there, in search of some of his companions, the ATS went to Karamat Ki Chauki and other localities, but no one was found. Then the team returned to Wasiabad where some of the people present in the Afzalul Madrasa were quizzed. The ATS then reached the house of Maulana Dr Shamsur Rahman, a few steps away from the madrasa

Key accused nabbed in Bansal murder case

formed a gang. Abrar also confirmed that Dr Bansal had paid Rs 55 lakh to Alok Sinha to get his son admitted to a PG course of medical science. When Sinha could not get a seat for Dr Bansal's son, the doctor asked him to return the

Later, he lodged an FIR and Sinha was arrested. While in jail, Sinha met mafia Dilip Mishra and Akhtar Katra, and

a plan was chalked out to eliminate Dr Bansal, Akhtar Katra was given a 'supari' for Rs 70 lakh, and he gave the task to Maksood, Yasir and Shoeb. Dr Bansal was shot dead at his Jeevan Jyoti Hospital on January 12, 2017. After the incident, Abrar kept hiding in different mosques and madrasas. He was in Prayagraj to meet a lawyer and was nabbed by the

HC nixes PIL seeking demolition of small temples in Vindhyachal

The Allahabad High Court refused to entertain a PIL seeking stay of demolition of small temples within the campus of Maa Vindhyavasini Devi Temple complex in Vindhyachal, Mirzapur, falling within the under-construction Temple temple corridor.

Dismissing the PIL filed by one Arun Pathak of Mirzapur, ivision bench comprising Acting Chief Justice Munishwar Nath Bhandari and Justice AK Ojha said, "The temples in the premises of Maa Vindhyavasini Devi Temple are private temples, thereby public interest litigation

would not be maintainable." In the PIL, the petitioner had sought from the court a direction to the state government and concerned authorities not to damage/demolish certain temples within the campus of Maa Vindhyavasini Devi

ernment's counsel informed the court that in the year 2006 also, a PIL was filed, seeking similar directions restraining demolition of small temples inside the temple campus. This PIL was dismissed on March 30, 2007, while observing that the temples in the premises of Maa Vindhyavasini Devi Temple were private temples and thereby PIL would not be maintainable. The state counsel apprised the court about the previous order and the temple project and pleaded that the PIL was not maintainable.

The court said that the PIL filed earlier also was dismissed by the court on March 30, 2007, saying that the PIL against the private temple is not maintainable. On this basis, the court dismissed the petition as not

Afghanistan to be main focus of PM's address at SCO meet



The current situation in Afghanistan and the scourge of terrorism is likely to figure prominently during Prime Minister Narendra Modi's address to the Shanghai Co-operation Organisation(SCO)heads of state summit in Dushanbe, Tajikistan on Friday.

He will participate virtually in the high-profile conclave and underline the dangers of terrorism in the presence of Pakistan Prime Minister Imran Khan, Chinese president Xi Jingping and Russian President Vladimir Putin. External Affairs Minister S Jaishankar will travel to Dushanbe to represent India at the SCO meet.

Modi's speech comes days before he travels to the US to take part in the first in-person Quad summit hosted by US President Joe Biden there next week. The Prime Minister will also hold bilateral meetings with Biden in Washington and address the annual session of the United Nations General Assembly(UNGA)in New York the next day on September 25.

Jaishankar will take part in meetings of the SCO expected to extensively deliberate on the Afghan crisis and its internal as well as external implica-



tions, people familiar with the

matter said. The 21st meeting of the SCO Council of Heads of State will be held on September 17 in Dushanbe in a hybrid format. The meeting will be chaired by the President of Tajikistan Emomali Rahmon. Prime Minister Narendra Modi will lead the Indian delegation and address the plenary session of the summit via video-link," the Ministry of External Affairs(MEA)said here on Wednesday. "At Dushanbe, India will be represented by External Affairs Minister S Jaishankar," it said in a state-

The MEA said the summit will be attended by the leaders of the SCO member states, observer states, secretary general of the SCO, executive director of the SCO regional anti-terrorist structure, the

president of Turkmenistan and other invited guests.

In Dushanbe, Jaishankar will attend a meeting on Afghanistan of the heads of state of the SCO and the Collective Security Treaty Organisation.

It will be the first SCO summit being held in a hybrid format and the fourth summit that India will participate in as a full-fledged member of the

Jaishankar is also likely to hold a series of bilateral meetings at the Tajik capital city with his counterparts from Iran and Tajikistan among others. Chinese Foreign Minister Wang Yi, Russian Foreign Minister Sergey Lavrov, Iranian Foreign Minister Hossein Amir Abdollahian and Pakistani Foreign Minister Shah Mahmood Qureshi are expected to be in Dushanbe for the SCO meetings. However, there is little possibility of Jaishankar meeting his Chinese and Pakistani counterparts, sources said.

The SCO, seen as a counterweight to NATO, is an eightmember economic and security bloc and has emerged as one of the largest trans-regional international organisations. India and Pakistan became its permanent members in 2017.

Of the total crimes against women last year, the maximum 1.11.549 were under the category "cruelty by husband or relatives", while there were 62,300 cases of kidnapping and abduction also, it showed.

Besides rape, there were 85,392 cases of "assault to outrage modesty" and 3,741 cases 32,033 in 2019, 33,356 in 2018 of "attempt to commit rape", There were 105 cases of

acid attack logged across the country during 2020, it added. The NCRB data suggested that on an average 80 murders were reported daily in 2020 in the country. A total of 29,193 fatalities were reported during the year, an increase of one per cent over the total 28,915 murders in 2019, with a daily average of 79 killings during the

year, the data revealed. Cases of kidnapping and abduction, however, went down by over 19 per cent in 2020 as compared to 2019.

There were a total 84,805 lodged cases of kidnapping and abduction in 2020 as against 1,05,036 in 2019, according to the NCRB statishighlighted.
Delhi logged 472 murder cases in 2020. Of the total murder victims in the country, the maximum 38.5 per cent belonged to the 30-45 years age group followed by 35.9 per cent in the 18-30 years category, the NCRB stat-

Delhi registered 4,062 kid-napping and abduction cases during 2020.

The NCRB stated that there were 88,590 total victims in 84,805 cases of kidnapping and abduction in the country last year. Of these, the majority 56,591 victims were children while the remaining were adults, it added.

Get that jab

In the fight against COVID-19, our line of defence must be to vaccinate the kids

s educational institutions re-open tentatively in India, parents are worried that unlike most of them, their children are not yet vaccinated against the COVID-19 virus and they may be vulnerable to infection at school. The concern is natural and understandable but clear-cut answers to their queries are not forthcoming. The States, the Centre, the state task forces, the national task force, and the host of experts need to be on the same page and clarify by when can children be expected to get the jabs, if they would be divided into age groups for the purpose, and whether the healthy among them need immediate vaccination at all. Paediatricians say healthy children are at low risk from the virus but there is no unanimity on whether it is safe for them to attend school unvaccinated. The United Kingdom is still disinclined to vaccinate healthy children in the 12-15 years age group. The doses will only offer



a marginal benefit and the labs can instead be diverted to vulnerable adults and children with co-morbidities, like chronic heart, lung and liver conditions, it argues. The British committee's hesitation arises from the concern over a rare side effect of heart inflammation from the Pfizer and Moderna vaccines. In India, out of 44 crore children, around 12 crore are in the 12-17 age group. The national COVID-19 task force is of the view that children with comorbidities should receive priority jabs, meaning thereby that healthy children are not at high risk. In any case, even though over 19 States have re-opened

schools and the rest will shortly decide on sending children back to classes, there is no indication that the vaccine for children will be available in the coming few weeks.

The ZvCoV-D vaccine has received Emergency Use Authorisation for use in 12-17 years and the field trials are on. Bharat Biotech says its Covaxin for children has tested safe in trials. Biological E's Corbevax has got the approval to conduct trials on children above five years. Covovax vaccine of Serum Institute and Novavax is conducting trials at the moment. Johnson & Johnson has applied for trials in children in the 2017 years age group. Scientists are hedging their bets on child vaccines. They say they are absolutely safe, but add a rider that the risk-benefit ratio needs to be weighed carefully. They say that infections in children are nearly always mild or asymptomatic. However, there is no doubt they still need vaccinations just as they have already been immunised against various diseases. Where do they stand on the priority list, is the question. It is not an easy question to answer as two arguments pull the Government in the other direction. One is the obvious need to prioritise vulnerable adult and children's groups. Two, how far to heed the observation of the World Health Organisation that by vaccinating their children, some countries will deprive frontline workers and high-risk of poor countries of vaccines.

Taking wings

If all goes well, the debt-ridden Air India could have a new owner by December end

he Union Government has finally found bidders for the sought-after Air India disinvestment after Tata Sons and SpiceJet promoter Ajay Singh submitted their financial bids to the transaction adviser on Wednesday as the process now moves to its concluding stage. The new owner will be entitled complete stake in Air India and Air India Express and a 50 per cent stake in the ground handling capacity of the Air India



SATS Airport Services (AISATS). Besides, as per Air India's Expression of Interest shared in January, out of the airline's total debt of ₹60,074 crore as on March 2019, the bidder would be required to absorb the "signing debt" of ₹23,286.5 crore. The rest would be transferred to Air India Assets Holding Ltd, a special purpose arrangement. Tata Sons had in 2001 expressed their interest in acquiring the Indian Airlines which JRD Tata had founded in 1932 as Tata Airlines. The proposal was not received well by the Government back then. But times have changed and the Government now views Tata as the frontrunner in the disinvestment bid which

was delayed due to the pandemic. Therefore, Union Aviation Minister Jyotiraditya Scindia had made it clear that September 15, 2021 would be the last day for submitting the bid

and would not be changed. The Government's previous attempt at the bidding failed badly in 2018 after not even a single bid was received for the airline. It had offered 76 per cent stake but higher crude oil prices, insane debt and, of course, the "involvement of the Centre" were some of the reasons the bid failed. Now after having tweaked the offer, it has managed to attract two bidders. Disinvestment is just a safer alternative to the word privatisation, and the Government's promise to "facilitate air travel even for a person wearing hawai chappal (slippers)" seems arguable under this umbrella. Also, Air India has not only been a commercial air travel facility but also holds strategic importance to India. During the COVID-19 pandemic, when Indian citizens were stranded in different parts of the world, only Air India was in operation and evacuated thousands of Indian and foreign nationals. Air India would not remain the same once the private players get hold of it. Air travel can no longer be viewed as a luxury but a common amenity that is intrinsically part of our day-to-day connectivity as the last-mile auto or rickshaw trip.

The national theatre of absurd



The public mood these days borders beyond logic; moodiness and absurdity rather than rationalism is the new norm

t is time to sit back and relax. It is time to watch the theatre of the absurd. The country which is now run on theatrics is turning into one. The dictionary meaning of the phrase aptly describes what we are witnessing right now: "A theatre in which conventions of plot and theme are distorted to convey the irrational and fictive nature of reality. It leads to isolation of humanity in a meaningless world." We are all watching it play right here right now!

People are trying hard to create a country where absurdity is the norm rather than the exception; in the zeal to outsmart opponents, stupidities galore. We are turning ourselves into laughing stock. The latest fad — nationalism — is now reaching a feverish pitch. Nothing is sacrosanct; not even your flawless past and it applies to all and sundry · individuals, organisations and now even the home-grown companies. Even the ones touted as ne pride of the country are not spared. One posturing against ne Hindutva joint family can lead you in trouble. The onus would be on you to prove your innocence.

The latest to fall is Infosys. The company that led India's make in India" campaign has hit the quagmire. Even before Prime Minister Narendra Modi coined the "local pe vocal" slogan, Infosys was at it and is now being dubbed "anti-national". That is if we are to believe *Panchjanya*, the RSS mouthpiece. This is hilarious as well as a sad commentary of the state we are in. The selfstyled nationalists are not only shouting nationalism but also handing out certificates of nationalism. God forbid, if you falter on your promise to deliver a project on time, you join the rank and file of anti-nationals. Reminds one of the scientists in Stalin's Russia who could not deliver on tight deadlines and ended up in Gulag.

Timeline goes — Infosys gets a contract of ₹4242 crores to roll out a new income tax portal. It fails to deliver on time and problems dog the system. The Minister calls Salil Parekh, the CEO, something transpires and the meeting fails in fiasco. Lo and

behold, in a couple of days, Panchjanya comes out with the story branding Infosys as anti-national. Please draw your own conclusions and spare the writer.

The nationalists' brigade indeed has come a long way. First, they started small branding anti-Hindutva ideologues as "love jihadis", "urban Naxals" and what have you. Now anti-national is in. The latest is branding corporate which don't bow as anti-

The Infosys case is an eye-opener. It is a \$100 billion company. A reputed company which employs more than two 2.5 lakh people become anti-national overnight. Infosys ranked number 3 on 2019 Forbes' World's Best Regarded Companies list. Surely for argument's sake, it doesn't matter if it is the big company, it can still indulge in anti-national activities. But then it is not an underground company.

Go arrest them all and seal the premises. That is how easy it is. But that is not the idea. The idea is to armtwist and make it fall in line. Now the onus is on the individual or the company to prove that it is not anti-

A couple of weeks back, Union Commerce and Industry Minister Piyush Goyal targeted the Tata Group. He said that its business practices went against national interests. Yet another well established corporate paying the price of being not conforming to the Government's dictates.

Recently, the Twitter CEO donated generously to an RSS-supported NGÓ. To put it in perspective, Jack Dorsey, CEO of Twitter, donated \$2.5 million in his personal capacity to Sewa International, an affiliate of the RSS. Dorsey's announcement sparked off controversy on Twitter itself but that proved nothing more than a storm in a teacup. What is interesting is that the grant came at a time when Twitter had suspended accounts of the right-wingers for hate speech. It included an account of actress Kangana Ranaut's. NOW IS THE NEED FOR A REALITY CHECK

Almost all of the global women's movements have dried up in the dreary desert sand of disinterest

here are many ways in which decision-making can be structured or planning can be done. There are many ways in which the struggle for the control of the decision-making processes takes place. Ultimately, those who emerge victors in the various competing ways of doing something carry the day. The articulate in the group become cheer leaders and those who care or dare to oppose are either eliminated or left to languish or perish. This happens in matters big and small. The last few weeks have seen the emasculation of an army which was proclaimed to be one of the finest equipped in the world. The current ruling elite in Afghanistan have made no bones about their distaste for matters such as democratically elected governance. They are in control and some of the mightiest powers in the world are ready to encourage this regime. Clearly the jury has not even convened, let alone 'be out' for a decision. The international system has yet again proved



its ineptness in sufficiently holding out values and making worthwhile moves to push for them. Even the so-called cause of women's rights in Afghanistan has not echoed much in any significant part of the world. Staunch proponents of gender equality can be seen occasionally demonstrating in some city, somewhere. Indeed, counter collectives reportedly have gathered of women in Afghanistan proclaiming, in effect, that the country's establishment's views on the status of women is indeed correct and must prevail. Philosophy has little scope to sort out a seemingly contentious views especially when there are few listeners. The international bodies including the United Nations are observing a thundering silence on this issue. Almost all of the global women's movements have suddenly dried up in the dreary desert sands of abject disinterest.

This is the story not just of women's rights. It is also the story of other human rights. The existence in Unina of alleged concentration camps, meant for certain religious minorities, is another subject of popular global neglect. Globally, even their co-religionists are rarely raising any attention about this. This is in sharp contrast to other kinds of concerns that are being raised. One wonders whether 'politics' predominantly determines what is flagged for attention and what is not. Like the gender movement, the cause of human rights for all, including minorities, is conspicuously marked by selective outrage. In the meanwhile, the expenditure on armaments amongst the so-called super powers continues to escalate. Some media channels have been showing the might of certain super powers to link power of artificial intelligence and incredible destructive capacity of nuclear devices. The powerful nations write their own rule books. In the last three decades or so, proclaimed aggression has been practiced to eliminate the so-called 'weapons of mass destruction' and more. Reportedly, the armorial dash was for control of oil resources. The sheer ability to cover up crass commerce with lofty principles of progress seems to be the hallmark of many powerful. The time has come to realise some of the underpinning driving the truth of our times. Unless the truth is placed, squarely, on the table, any reversal of this sorry logic — where the powerful grab what they want with or without attempts at camouflage — is likely to continue.

Import duty cutback on Tesla is no good

Lower duties on EVs will incentivise companies to merely import from foreign markets and sell in India, and that does not add value to the Indian economy

roposed import duty concessions for the import of electric cars manufac-tured by Tesla, an American electric car manufacturing company, is in public debate, having linkages with the domestic automobile industry. Whereas lobbying efforts are on for this proposal, the domestic automobile industry is vehemently opposing the same.

The American electric car company has sought lowering of import duty to 40 percent from the current 60 percent on fully assembled electric cars priced below \$40,000 and 60 percent from the current 100 percent on vehicles valued above that amount. The interesting part of the story is, there is no tangible offer from the company to begin manufacturing of this car in the

From newspaper reports it is being learnt that several ministries of the government have supported Tesla's proposal to lower import tariffs. Today, the Indian automobile industry is worth ₹8.2 lakh crore. Nearly 49 percent of manufacturing GDP comes from this sector, which constitutes 7.1 percent of overall GDP. The sector provides direct and indirect employment to nearly 3.7 crore people. It exports nearly \$27 billion worth of automobile products in different segments. It provides 15 percent of the total GST collected, apart from catering to the needs of the country with regard to vehicles of different types and in different segments. Along with this, a substantial auto components manufacturing sector has simultaneously developed, with significant production, employment and exports.

Today, electric vehicles account for less than one percent of the annual car sales. The Government of India has been giving a big push to the manufacturing of electric vehicles (EVs) in the country aiming to reduce dependence on the imported fossil fuels and to reduce carbon foot prints. To achieve this objective of manufacturing EVs, import duty on EV parts and components, batteries, etc., is kept between 10 and 15 percent, which is much less than import duty on components for conventional automobiles. Using this duty concession, the established Indian companies and start-ups have started creating local value additions in the country. Efforts are also being made towards long-term localisation program.

Looking at the push given by the gov ernment to EVs, it seems that India will soon be able to start meeting domestic requirements of these vehicles. If the past is any guide, we understand that protection given to the domestic automobile sector has been the key to the development of this sector, which today is not only meeting the domestic requirements, but is also exporting automobiles to the rest of the world. It is also successfully procuring most of the components from within the country. It is notable that the Indian auto components Industry is also worth ₹3.95 lakh crore. The Indian auto component turnover constitutes 2.3 per cent of GDP and provides employment to five million people and exports to

India's luxury car market is relatively very small. In the year 2019-20, the total number of luxury cars sold was 40,637, which was down to 19700 during the COVID-hit 2020-21. This is because a very small section of the population can afford these luxury cars beyond rupees ₹15 lakh or, say, \$20,000. And a very miniscule segment of the population can afford to buy cars beyond ₹30 lakh. If duty concession is given to Tesla, those who can afford will obviously buy imported Tesla electric cars and there will hardly be anyincentive for the company to establish a manufacturing facility in India; and the country would be deprived of capacity creation in EVs.

India has launched a flagship Production Linked Incentive (PLI) scheme to give a boost to domestic production of goods for which, so far, the country is dependent on foreign nations. Thirteen sectors have been included in this scheme. Prior to this, the phased manufacturing programme (PMP) was launched. It is a known fact that in telecom and IT hardware sectors, Indians lost the opportunity to become a manufacturing hub due to faulty policies of lowering of tariffs, and dumping by China and other countries. Thanks to PMP earlier and now PLI scheme, this sector has started showing some gains in domestic manufacturing.

If we reduce tariff on fullyassembled electric cars and cars of who have also started staking

- would we not be committing the same mistake of the past and miss the bus in manufacturing and technology development of electric vehicles, which we are looking forward to?

First, any reduction in custom duty on EVs will incentivise companies to merely import from the foreign markets and sell in the Indian market. This will not help in any value addition to the economy and such a move would jeopardise India's efforts to increase domestic

manufacturing. Secondly, domestic automobile companies and start-ups are consistently investing in R&D and product development and contributing to the growth of the sustainable economy. Rather than creating a disturbing policy atmosphere of favouring imports of electric cars, it would be appropriate to support and leverage the local component ecosystem by longterm policy of the central and State Governments.

Thirdly, Ola company backed by venture capitalists has launched its first electric scooter, with more than one lakh bookings on a single day. Ola and other two-wheeler(Original Equipment Manufacturers) OEMs are on the verge of setting upstate-of-the-art manufacturing plants. Any tariff reduction for Tesla will discourage

future endeavours in this direction. Fourthly, we should not also forget that Tesla's business model other companies, say, Volkswagen company does not give any opportunity to the domestic auto compo-

have a massive amount of internal manufacturing technology that we built ourselves.... It's like okay, what are the things we want to make, design a machine that will make that thing, then we make the machine." Firstly, we do not need lowering of tariffs on assembled cars; we rather need leveraging fiscal and non-fiscal support for EVs. Lowering GST, registration fee, permit fee, road tax, PLI, tightening of regulations to motivate shift to EVs are some such measures.

Secondly, rather than discouraging investment in Research and Development by allowing direct imports of EVs, we should create an environment to increase investment in R&D. If we allow Tesla Cars to be imported with tariff reduction, we would be hampering the development of the EV ecosystem.

Thirdly, we must leverage the fastest growing unified market in the world to our advantage of long-term technology building in and by Indian companies. There is a larger opportunity and value capture in developing notyet-mature technologies such as EVs. For example, we could have been leaders in mobile phones if we had developed our capabilities in India for mobile phones in the early 2000s. We require this technological foundation to cater to global markets in the future, and increase the exports by the automobile sector to record highs; and in any case not reduce import duty on Tesla cars.

Taxing the new-age digital companies

Foreign digital companies sell goods in India but do not pay taxes as they are not physically present in the country and that is a key concern Agreement (DTAA) India has international taxation laws.

igital technology has not only changed the way the world works, it has also made inroads into the country's taxation system.

For years, any company which is a resident of India came under the purview of taxation laws. However, a company need not now be a resident of a country to engage in economic activity. Technology and internet have made it possible a company to be present in one country and operate in another. This has caused concerns for countries where the consumers are located as they are deprived of their share of tax collection due to archaic laws requiring physical presence of companies to levy taxes.

This inconsistency has led to an urgent need to amend

eral attempts have been made by international organisations to derive some common consensus, particularly by Organisation for Economic Co-operation Development (OECD) under Base Erosion and Profit Sharing (BEPS) Action Plan I, which recommended certain interim opportunities to tackle tax challenges arising out of the new age digital economy.

One such option is the concept of 'significant economic presence' (SEP) that could be defined in two ways. First, any transaction in respect of any goods, services, or property carried out by a nonresident with any person in India, including provision of download of data or software



in India, if the aggregate of payments arising from such transaction or transactions during the previous year exceeds ₹2 crore. Secondly, systematic and continuous soliciting of business activities or engaging in interaction with 300,000 users in India. The concept of SEP was introduced within the ambit of 'business connection', which is an on-going and continuous business relation between any

profit of a non-resident entity. According to the recommendation of BEPS Action Plan 1, a non-resident enterprise would be taxable if it has a SEP in that country, engaged in a focussed, continuous and sustained engagement with the economy with the help of

technology and automation. Interestingly, India has been one of the early movers in this direction. As amending the existing tax laws is a timetaking process, a committee was set under the guidance of the Central Board of Direct taxes (CBDT), the apex tax administrative body in India, that recommended, in 2016, an equalization levy of six percent as a viable option for India in online advertising and ancillary services. Later on, by

two enterprises resulting in the 2020, the domain was extended to include online sale of goods and services. This will become effective from 2022 onwards.

> internet giant, selling goods worth millions of dollars in India, is presently not taxed as an enterprise because it is not physically present in India. With the introduction of the concept of SEP, Alibaba would be taxable for the sales made in India. In addition, according to the second condition of SEP, the mere act of soliciting business from Indians and not even actual sales can subject any enterprise to taxation in. This brings companies driven by information feeds and news like Facebook and Instagram, and social networks and other engagement-

based platforms, like Whatsapp, WeChat and Tiktok, under the ambit of Indian taxation rules, subject to their incomes or user base For example, Alibaba, the

crossing the prescribed thresh-The SEP is also applicable to any liaison office set up in India as they are also involved in the continuous soliciting of business, bring them under its purview. This may push several foreign companies to set up their wholly owned subsidiaries to circumvent these conditions and to take advantage of lower tax rate of 25 percent as compared to 40 percent tax rate for foreign companies.

Overall, the business connection and significant economic presence will be applicable subject to the Double Avoidance Taxation

with the home country of the business enterprise in question. DTAAs generally have specific clauses defining the conditions under which a host country can tax foreign companies located in their countries. And since DTAAs override any domestic tax regulations, it would be complicated taxing foreign companies in situations when the concept of significance economic presence in not mentioned in the same. However, such a move shows the intent of India to tax companies in this new age of digital technology. A global consensus in determining the commonly accepted thresholds for defining significance economic presence will go a long way in taxing new age digital companies.

Govt approves ₹26k crore PLI scheme

The Union Cabinet on Wednesday announced a Production-Linked Incentive (PLI) scheme for the drones and drone component industries that offers an incentive of 20 per cent of the value addition made by a manufacturer of drones and drone components. The PLI scheme for drones and drone components spread over three financial years, will lead to investments worth ₹5,000 Crore, increase in eligible sales of ₹1500 crore and create additional employment of about 10,000 jobs.

Minister of State for Finance Anurag Thakur on Wednesday announced that the Cabinet has approved the PLI scheme for drones and drone component industries, saying that ₹120 crores to the drone industry under the budgetary provision for the PLI

scheme for drones with clear revenue targets and focus on domestic value addition is key to building capacity and mak-ing these key drivers of India's growth strategy.

The PLI for Drones and Drone components industry, will over a period of three years, lead to investments worth ₹5,000 Crore, increase in eligible sales of ₹1500 crore and create additional employment of about 10,000 jobs," the Government said in a state-

In big bang reforms, the Union Cabinet on Wednesday approved a relief package for the telecom sector that includes a four-year moratorium on payment of statutory dues by telecom companies as well as allowing 100 per cent foreign investment through the automatic route. The Cabinet also approved

Relief measures will enable telecom industry to achieve Digital India goals: Ambani

Reliance Industries Ltd (RIL) Chairman Mukesh D Ambani on Wednesday said the latest reforms and relief measures will enable the telecom sector to achieve goals set under the Digital India mission.

The Cabinet has announced several reforms for the telecom sector, including redefining adjusted gross revenue (AGR) that will now include revenues earned only from telecom services. The government calculates various levies on AGR.

"The telecom sector is one of the prime movers of the economy and the key enabler for making India a Digital Society, I welcome the Government of India's announcement of reforms relief measures will enable the industry to achieve the goals of Digital India. I thank Prime Minister (Narendra Modi) for this bold initiative," Ambani said.

RIL's telecom arm Jio said the government's telecom sector reforms will encourage it to bring newer and greater benefits to the customers.

Telecom Minister Ashwini Vaishnaw said that as part of the reforms in the telecom sector, the Cabinet has allowed a four-year moratorium on all dues that telecom operators have to pay to the government, including

and spectrum purchased in past auctions excluding the March 2021 auction.

The government has given the option to telecom operators to pay the interest amount arising due to deferment of payment by way of

The minister said 100 per cent FDI (foreign direct investment) in telecom via the automatic route was approved by the Cabinet. Earlier, automatic investment routes were limited to 49 per cent level and approval from concerned authorities was required for foreign investment beyond the 49 per cent

The Cabinet has approved the allocation of spectrum through an auction for a period of 30 years compared to the 20year period prevalent at pre-

future auctions.
"We look forward to working working with the Government of India and other industry players in reaching all the goals and milestones of the Digital India vision, so that we can collectively make every sector of the economy productive and enhance the ease of livannual payments of dues arising for every Indian," Jio ing out of the AGR judgment said.

"We keep getting terror alerts, but as far as this case is concerned, Mumbai and Maharashtra are safe," Agrwal said.

According to the ATS chief, Shaikh took a train from Mumbai Central for Hazrat Nizamuddin in Delhi on September 13 and he was Kota in Rajasthan on Tuesday. "It was their case and operation Agrawal said. "We are coordinating with Delhi

The number of people who recovered from the infection since Tuesday was 25,588 which brought the total recoveries to 42.09.746 and the number of active cases to 1,90,750, a State Government release said. While the release said that 97,070 samples were tested in the last 24 hours, it did not state what the Test Positivity Rate was.

However, 17,681 fresh positive cases, reported in the last 24 hours, out of 97,070 samples tested during the same period, gives a figure of more than 18 per cent.

Thiruvananthapuram recorded the highest with 2,143 fresh cases followed by Kottayam (1,702), Kozhikode (1,680), Ernakulam (1,645), Thrissur (1,567), Palakkad (1,558), Malappuram (1,372), Kollam (1,348), Alappuzha (969) and Kannur (967), the release said. Of the new cases, 97 were health workers, 47 from outside the state and 16,656 infected through contact, with the source of the contact not being clear in 881 cases, it said.

There are currently 5,61,239 people under surveillance in various districts, of whom 5,33,190 are in home or institutional quarantine and 28,049 in hospitals. PTI

Bengal extends corona restrictions till Sept 30

Kolkata: The Bengal Government has further extended the pandemic restrictions to September 30 allowing limited relaxations on traffic movement and other facilities.

Pakistan Govt open to pardon TTP members

The Pakistan Government would be "open to giving" a pardon to members of the banned Tehreek-i-Taliban Pakistan (TTP) if they promise not to indulge in terrorist activities and submit to the country's Constitution, Foreign Minister Shah Mahmood Qureshi

Qureshi made the remarks during an interview with Britain's online newspaper 'The Independent' and the video of the interview was posted on social media by the state-run Associated Press of Pakistan on

Wednesday, Dawn reported. Voicing concern about the reports of TTP figures being released from prisons in the ating problems for us over here, it will affect innocent lives and we don't want that."

Pakistan is fighting a major domestic insurgency in the form of local Taliban offshoot the Tehrik-i-Taliban Pakistan, or the TTP, as well as al-Qaeda and the ISIS.

Qureshi said if the new Afghan setup could use its influence and talk to the TTP, and "if [the TTP] are willing to mend fences and not take the law into their hands and not get involved in terrorist activities and they submit and surrender to the writ of the Government and the Constitution of Pakistan, we are even open to giving them a pardon."

'But as long as they do not come and start undertaking terrorist activities [in Pakistan]. That is our concern," the minister emphasised. Qureshi termed as "positive" the Afghan

His comments come days after President Arif Alvi suggested during an interview with Dawn News that the Government could consider giving an amnesty to those TTP members who had not remained involved in "criminal activities" and who laid down their weapons and agreed to adhere to the Pakistani Constitution. For years, the TTP unleashed deadly attacks on urban centres across Pakistan from their bases along the Afghan border.

China backs Taliban's demand to America to unfreeze Af's assets

hina on Wednesday supoported the Taliban's demand that the US should unfreeze Afghanistan's assets and said that America has no legitimate reasons to do so as the Chinese envoy to Kabul called on acting Afghan Foreign Minister Amir Khan Muttaqi and congratulated the interim Government.

According to reports from Washington, the US has frozen about \$9.5 billion in assets belonging to Afghanistan's central bank and stopped shipments of cash to Kabul, in a bid to keep the Taliban Government from accessing the money.

Chinese Foreign Ministry spokesman Zhao Lijian told reporters here that the US has no legitimate reasons to freeze Afghanistan's assets.

Asked about the Taliban's demand that the US should unfreeze Afghanistan's assets stating that they belong to the people of Afghanistan and the interim Government will take a legal action possible to get the funds released, Zhao said, "I think that the (Taliban's) spokesperson is right".

"The assets belong to Afghanistan and should be spent for the Afghan people.
"The US should not freeze

them without justification. The US should face up to the legit-imate demand of Afghanistan, abandon pressures and sanctions and stop creating obstacles to the economy, livelihood and peace and reconstruction in Afghanistan," Zhao said. After the Taliban's seizure of

power in Afghanistan last

month, the International Monetary Fund and the World Bank halted their aid to the wartorn country which largely depends upon the flow of foreign funds. According to reports from Kabul, Afghanistan's economy is near collapse even as the United Nations has made hectic efforts to galvanise global efforts to rush food and essential supplies.

Over \$12m seized from ex-officials as cash crunch hits Afghanistan

Kabul: Afghanistan's central bank said on Wednesday that the Taliban had seized more than \$12 million in cash and gold from the homes of former Government officials, as it called for all transactions to be made in local currency.

A foreign exchange crunch in the aid-dependent country threatens the Taliban's rule one month after they seized power. Most government employees have yet to return to work and in many cases salaries had already not been paid for month's — leaving millions scrambling to make ends meet. Even those with money in the bank are struggling, as branches limit withdrawals to the equivalent of \$200 a week with customers having to queue for hours.

And while remittances have resumed from abroad, customers awaiting funds at international chains such as Western Union and MoneyGram complained on Wednesday that branches they visited had run out of cash.

Afghan female footballers evade Taliban, reach Pak

Thirty-two women football players from Afghanistan, who were facing threats from the Taliban, have reached Pakistan along with their families after the Government issued emergency humanitarian visas to evacuate them, according to a media report on Wednesday.

The footballers belonging to the national junior girls' team had been originally due to travel to Qatar, where Afghan refugees have been housed at a facility for the 2022 FIFA World Cup, but were left stranded after a bomb blast at the Kabul airport that killed 13 US service members and at least 170 Afghans on August 26.

These women were facing threats from the Taliban due to their involvement in the sport, Dawn newspaper reported.
The Taliban took control of

Afghanistan in August. These women football players had since been in hiding to evade the Taliban, according to the

She insisted she was "groomed and taken advantage of and manipulated" and that her role with the terror outfit was only to be a 'mother and a wife".

"The reason I came to Syria was not for violent reasons. At the time I did not know it was a death cult, I thought it was an Islamic community I was joining," she said.

"I am willing to go to court and face the people who made these claims and refute these claims, because I know I did nothing in IS but be a mother and a wife. These claims are being made to make me look worse because the government do not have anything on me," Begum said with reference to claims terrorist acts

UK bans Chinese envoy from Parl; angry Beijing condemns move

Khalistanis gaining ground in US: Report

India's appeals to curb them fall on deaf ears

Pakistan-backed Khalistani separatist groups, banned by the Indian Government, are quietly gaining ground in the US, a top American think tank has warned, ruing that Washington has so far remained indifferent to the appeals made by New Delhi to curb their destabilising anti-India activities.

The US-based Sikhs for Justice (SFJ) is a pro-Khalistan group. In 2019, the Indian government banned it for its alleged anti-national activities.

The SFJ had pushed for Sikh Referendum 2020 as part of its separatist agenda. It openly espouses the cause of Khalistan and in that process challenges the sovereignty and territorial integrity of India. The outlawed group's primary United States.

objective is to establish an "independent and sovereign country" in Punjab.

In its 'Pakistan's Destabilization Playbook: Khalistani Activism in the US' report published on Tuesday, the Hudson Institute examines the conduct of "Khalistan and Kashmir separatist groups within the United States" to investigate their support by

The report looks at these groups' ties to militant and terrorist outfits in India, and the possible detrimental effects of their activities on US foreign policy in South Asia. The report demonstrates

that "like Pakistan-based Islamist terrorist groups, the Khalistan groups can emerge under new names."

"Unfortunately, the United States government has shown no interest in violence committed by Khalistan activists, even though the Khalistan campaign's most ardent supporters are located in western countries such as the United

Earlier in September, Civil Aviation Minister Jyotiraditya Scindia had confirmed that the deadline for financial bids for Air India will remain September 15. The strategic sale of Air India was approved by the Cabinet committee on Economic Áffairs in February 2019. The Covid-19 pandemic had delayed the proposed sale of the airline.

So far, only the two bids have been made for the airlines with Tata Group being the frontrunner in the Centre's divestment plan. This is the third attempt of the government to divest its stake in Air India after 2001 and 2017. The Tata Group was also at the forefront of buying a stake in the national carrier when the Government decided to sell its stake in 2001 and 2017 respectively.

The Government has been trying to find a buyer for Air India and earlier the Government was up for selling a 76 per cent stake. Now, the Centre is selling 100 per cent stake of Air India, including Air Îndia's 100 per cent shareholding in AI Express Ltd and 50 percent in Air India SATS Airport Services Private Ltd.

The stake sale process which begun on January 2020, faced delays due to the Covid-19 pandemic. In April 2021, the Government asked potential bidders to put in financial bids.

As per the Air India EoI floated by the Department of Investment and Public Âsset Management (DIPAM) in January 2020, of the airline's total debt of Rs 60,074 crore as of March 31, 2019, the buyer would be required to absorb Rs 23,286.5 crore. The rest would be transferred to Air India Assets Holding Ltd (AIAHL), a special purpose vehi-

Air India has been in losses ever since its merger with domestic operator Indian Airlines in 2007. Currently, the airline controls over 4,400 domestic and 1,800 international landing and parking slots at domestic airports as well as 900 slots abroad. Currently, Air India has a debt of around Rs 43,000 crore of which Rs 22,000 crore will also be transferred to the Air India Asset Holding Limited (AIAHL). Besides, the bidder would get 100 per cent of the

low-cost arm Air India Express and 50 per cent of AISATS, which provides cargo and ground handling services at major Indian airports.

He also slammed the OIC for raising the Kashmir issue at the council, asserting that the group has no locus standi to comment on the internal affairs of the country.

"We once again regret and reject the reference made by the OIC to the Union Territory of Jammu and Kashmir which is an integral part of India," Badhe said.

SC fumes at tribunal appointments, says Govt 'cherry-picked' names

PNS NEW DELHI

In a strong indictment of the Government over non-filling of vacancies at the tribunals across the country, the Supreme Court on Wednesday said the manner in which appointments have been made clearly indicates

"cherry-picking" of names. Chief Justice NV Ramana and Justices DY Chandrachud and L Nageswara Rao came down heavily on Centre and told Attorney General KK Venugopal about their displeasure on the appointments in tribunals, especially on displacing of National Company Law Appellate Tribunal (NCLAT) Chairperson and appointing new person and non-adherence to the

apex court's recommendations. The apex asked the Centre to make appointments within two weeks to the tribunals which are Datar, representing the petition-

facing severe crunch of presiding officers as well as judicial and technical members, and apprise it of reasons if persons from the recommended list are left out in the process.

The appointment letters which have been issued clearly indicate they have selected cherry picking three names from the select list and others from the waitlist, ignoring others in the select list. In service law, you can't go to the waitlist ignoring the select list. What kind of selection and appointment is this?" the bench asked Attorney General KK Venugopal, who assured the bench that the Centre would make appointments in two

It will be from the list of persons recommended by the search and selection committee.

Senior advocate Arvind

er Congress MP Jairam Ramesh, said that for the ITAT, the search cum selection committee selected 41 people but only 13 have been chosen on basis which "we don't know".

"This is nothing new. Every time it is the same story," the bench said. The CJI said the Supreme Court judges undertook an elaborate exercise to shortlist the names during the Covid and the entire efforts are going in

"We travelled across the country. We spent a lot of time. During Covid, your Government requested us to conduct interviews as early as possible. We wasted so much time," the CJI expressed exasperation. The CII commented that as per the latest appointment the members will have tenure of only one year and said, "Which judge will go to join this job for one year?'

On the issue of non-accep tance of names recommended by the selection committee, Venugopal said the Government has the power not to accept the recommendations made. are a democratic country in which rule of law is followed and we are working under the Constitution. You can't say that I don't accept," the CJI said.

'What is the sanctity of the process if the Government has the last word? Selection committee undertakes an elaborate process to short-list the names," the bench said. There are around 250 posts lying vacant in various key tribunals and appellate tribunals across the country, the CJI

Digital health technologies are the vehicles of change and awareness for ensuring a good night's sleep, says DR SIBASISH DEY

The ongoing pandemic has spurred the adoption of digital health technologies across the country. People far and wide have resorted to online consultations and remote monitoring tools to treat diseases. The government of India also launched the National Digital Health Mission to advance the healthcare ecosystem and fuel the adoption of telemedicine and telemonitoring.

Digital healthcare tools and techniques enable remote monitoring of patients, bridging the accessibility gap between the doctor and the patient. They also help reduce the impact of the dismal doctor-patient ratio in India, which currently stands at 1:1445 (one doctor for every 1445 patients). The ideal ratio, as prescribed by the World Health Organisation (WHO), is 1:1000. Overall, digital healthcare and the data collected helps the medical community to predict health problems, develop effective solutions and advance medical research. Digital healthcare has also given sleep awareness an exponential boost. More people willingly are undertaking sleep tests and subsequent therapies today.

But why should sleep be monitored?

Sleep is one of the most important biological processes that help the body to function properly. It allows the body enough time to rest and aids in healing and repairing blood vessels, muscles, and even the heart. When we sleep, memory consolidation happens. Our thoughts and experiences are organised and stored in our memory for quick recall at a later stage. Productivity during the day is better, while reaction to various challenges is faster and more effective. Even though sleep has multiple benefits, a good night's sleep is not common amongst most people, given today's erratic lifestyle and working



Though our work schedules and lifestyle highly impact our sleeping patterns, negligence is the biggest cause of unhealthy sleep cycles. We respect the importance of food and exercise in our lives but do not give sleep the attention it deserves. Ironically, sleep tends to be way more critical. Polysomnography, the study of sleep, requires a sleep laboratory. It is expensive and a tedious process, so people do not willingly undertake it. The introduction of digital solutions for sleep disorder testing and treatment has given manageable and easy to apply devices that are now available in the comfort of our homes. They are user friendly, cost-effective, and enable remote monitoring of the patient. For example, continuous Positive Airway Pressure (CPAP) therapy has proven to be an effective connected treatment option for sleep-disordered breathing, commonly known as Obstructive Sleep Apnea (OSA), at home. Administered with the help of a modest size device,



it pushes air into the patient's breathing system with a calibrated pressure that opens the obstructed airway.

Similarly, testing of sleep disorders has transitioned from sleep labs to our bedrooms with simple wearable devices. The easy access and increasing awareness about overall well-being have also encouraged people to undertake sleep tests even on experiencing mild symptoms of sleep disorders. India's medical fraternity has also begun considering sleep disorders as a possible cause of multiple chronic ailments such as hypertension and cardiovascular issues and have started recommending sleep testing and therapy to

The road ahead

Even though digital healthcare solutions have pushed sleep awareness, the need of the hour is also a nationwide awareness campaign about the various types of sleep disorders and

the consequences. An erratic lifestyle and long working hours resulting from the pandemic have put our health at significant risk, making it essential to monitor our sleep hygiene.

A healthy sleep cycle impacts our overall well-being in numerous ways. Apart from keeping our productivi-ty in check, it also improves our cardiovascular system, blood pressure, mental health, keeps obesity in check, and multiple other things. The key takeaway here is that we must practice a healthy sleep routine. If anyone experiences morning headaches, daytime fatigue, and other associated symptoms, they should consult a sleep-specialist. A night of sound sleep leads to a healthy mind and a healthy body.

artin Luther King Jr once said, "A visit to India was not just tourism but a pilgrimage..." And not just him, but travellers like Marco Polo, Christopher Columbus, Tavernier, Francois Bernier were so fascinated by the grandeur and attraction of real Índia. Today, we might have moved beyond, but the essence of that Indianness is still visible in our villages. Rural India holds the potential to change the face of India's economy and with 65 per cent of us living across seven million villages, rural India is a force to reckon with. With a maddening rush to urban areas and the rat race to go cosmopolitan, we are ignoring the real India we grew up in. If atma nirbharta is the ultimate goal, then, building a self-sustaining rural economy is the key. Undoubtedly, rural tourism is one of such bright avenues.

For the first time India has come up with a draft of the national strategy for the development of rural tourism. If executed well, it would create several job opportunities and sources of livelihood in rural areas.

A proper governance structure and institutional mechanism at the national and state level will help to address the most persistent factors ailing the tourism sector — coordination. With this direction and political will, it is expected that the hidden opportunities for tourism in India's hinterlands would see the light of the day.

Another remarkable feature is the adoption of a cluster-based approach. This will ensure that the natural and cultural heterogeneity of India is leveraged, which cannot be accomplished in the case of blanket schemes. What would be interesting to note is how clusters that should not disturb their natural potential vis-àvis the administrative boundaries would be identified. In short, the rural tourism strategy has emphasised all key aspects of tourism such as model policies and best practices, digital technologies and building clusters, providing marketing support, creating capacity of stakeholders, governance, and institutional framework.

Most of all, the policy has come at an opportune time, when the global tourism industry is gasping for a fresh start. The burden of protocols, the fear of contagion, and the lack of preparedness have crippled the sector. However, what must also be noted is that tourism is something that is innate to society and cannot be contained for long.

The pandemic has redefined

The pandemic has redefined many things along with the existing structures. It might feel sudden, but



the shift was imminent nonetheless. However, the pandemic-ridden psyches of urban India have brought forth interesting insights. People are desperately looking out for an urban and digital detox. Having spent the last two years digitally caved up, there is an urge to move from mechanical cities to a more earthy lifestyle without compromising one's health.

However, we have witnessed that these city dwellers planned short trips to rural offbeat locations which were already overburdened with tourist footfall, draining their originality and exclusivity. This trend highlights the dire need for a policy intervention to ensure tourist dispersal to lesser-known but equally attractive destinations.

Across the globe, tourist disper-

sal has become a priority. Nations are taking concrete steps to divert tourist traffic to the least-visited destinations and rural areas. For instance, nations like Australia and New Zealand have national level policies and strategies for encouraging tourist dispersal across the nation.

Another important aspect is the

Another important aspect is the need to overcome financial bottlenecks in the implementation of the strategy. For instance, countries like Sweden, Germany, and so forth have



public spending on rural tourism within their rural development programs. On the other hand, we have China's case where a major government policy has ensured the unhin-

dered flow of funds and prioritisation. Now that India is heading towards strategic rural tourism, we can expect bigger gains. The strategy addresses all the pain points of tourism in India, be

it lack of coordination, work in silos, a scattered skill ecosystem, and skewed private participation. Interestingly, the strategy embeds tourism as a component of rural development. With this, we depart from the current scheme of things where random rural tourism projects are undertaken across the nation without a strategic direction or accountability for other states and

departments

Distinctively, the strategy note mentions that the process of identification of rural tourism clusters should be broad-based, involving stakeholders from Government, industry, NGOs, rural community and local businesses. This would be a progressive step in acknowledging the critical role of private stakeholders and local communities especially rural youth in tourism development. However, a formal mechanism would be needed to elicit this cooperation in real terms.

Even globally, local communities are the fulcrum of rural tourism policies. Countries like France, Austria, and the United Kingdom have a longestablished tradition of farm tourism, giving impetus to farming communities and their livelihood. Then, there are countries like Cambodia and Costa Rica where rural communities have been made key stakeholders for tourism development. Tortuguero village of Costa Rica is a rare example of how an entire population was involved in travel-related activities, with sea turtles conservation at the epicentre. Conservation efforts, policy changes, and behavioural changes made the village a globally recognised ecotourism hub.

This brings us to another important aspect, environmental protection. While sustainability remains at the heart of rural tourism, this is one area that is missing from the draft strategy document. Before embarking on any rural tourism plans, it is extremely important to chalk out an ecotourism strategy.

ecotourism strategy.

The success of the strategy would greatly depend on how the centre, states and all the private stakeholders can strike a synergy and overcome all the administrative bottlenecks. Tourism is one area which is spread across multiple domains and ministries and thus cannot function without appropriate convergence.

The rural tourism strategy is nevertheless a step in the right direction. For any nation, tourism is a story of its culture and its originality. Undoubtedly, our villages, some pristine and untouched, still hold that unique cultural and natural wealth. They are the reflection of our past and our Indianness.

As Mahatma Gandhi rightly said, "The future of India lies in its villages. If pampered and tended to, our villages can lead India as a global tourist destination, thriving on its sheer originality and Indianness."

"Matches will be played at Dubai, Sharjah and Abu Dhabi with limited seating available keeping in mind the COVID protocols and UAE government regulations," it added.

It will be the first time since 2019 when the IPL will be played in front of an audience.

Last year, the league was played behind closed doors in the UAE while the first half of the 2021 edition was also played inside a strict bio-bubble. Although the league organisers did not specify the exact number of fans who would be let in but sources said their presence would be 50 per cent of the stadium capacity.

"Fans can buy tickets starting September 16 for the remainder of the tournament on the official website www.Iplt20.Com. Tickets can also be purchased on PlatinumList.Net," the league organisers said.

Have deepest concerns on 'place of boxing' in Olympics: IOC

The International Olympic Committee on Wednesday "restated its deepest concerns" on boxing's place in the 2024 Paris Olympics, citing "unresolved" issues with the International Boxing Association's governance structure, financial situation and the scoring system even as the AIBA promised to "exceed" the laid down criteria.

In a letter addressed to AIBA President Umar Kremlev, IOC Director General Christophe De Kepper said the Olympic body's Executive Board has asked him and its Chief Ethics and Compliance Officer to "follow up" on the situation. The AIBA responded by saying that it is doing every-thing that that IOC expects from it

"AIBA has been working on comprehensive reform for some time now and is grateful for the IOC's public acknowledgment that a step forward has certainly been taken in terms of good governance...," the AIBA stated in an e-mail to PTI, responding to the IOC letter. In the fourpage communication, IOC expressed dissatisfaction with the work done by the AIBA to address concerns related to its governance, finances and the refereeing and judging system that has been under intense scrutiny since the 2016 Rio Olympics.

"On the basis of the above, the IOC Executive Board restated its deepest concerns and reiterated its previous position regarding the place of boxing in the programme of the Olympic Games Paris 2024 and future editions of the Olympic

Games," the letter stated. The AIBA said it would do more than what has been mandated to regain the IOC's con-

fidence. "Wide-ranging reforms are already underway in terms of financial integrity, good governance and sporting integrity, including all the areas mentioned by the IOC and more,"

the AIBA said. "Independent experts are involved in each of these sec-tors. AIBA is confident these reforms will see AIBA meet and even exceed the criteria laid down by the IOC for reinstatement." The IOC said while it acknowledges that AIBA has taken "a step forward in the direction of better governance" but several concerns remain

Lukaku seals Chelsea win over Zenit to start CL defence

Lukaku darted into space in the penalty area, evading the defense, to meet a cross from Cesar Azpilicueta and head it into the net in the 69th minute against the Russian champions.

That is why he is here," Chelsea manager Thomas Tuchel said. "It is another step ahead, because winning and another clean sheet is super important for the belief and for our process. We are not finished, but are in a good place to improve."It added to the three goals — including two in Saturday's win over Aston Villa — Lukaku has already scored in the Premier League this season.
