UP has seen complete transformation under BJP rule, asserts CM

A sserting that his government reinforced rule of law in the state, provided good governance and delivered in a transparent man-ner, a buoyant Uttar Pradesh Chief Minister Yogi Adityanath said that the Bharatiya Janata Party would return to power with over 350 assembly seats in the 2022 Assembly elections.

"We delivered on all promises we made before coming to power in 2017, catering to all sections, including youth, women, farmers and the poor without any discrimination on caste or religion basis," the chief minister claimed while addressing a function on com-pletion of four-and-a-half years of his government on Sunday. He said every individual of

the state was happy as his gov-ernment evolved a transparent development model, based on which the party was confident

Adityanath minced no words while stating that "we had inherited a state which was mired in corruption in recruitment process, where appearement of certain sections was the mainstay of governance and the poor and deprived sec-

Launching a broadside against the opposition for unleashing a misinformation campaign, Chief Minister Yogi chief minister said that it was a matter of pride for all that Uttar Pradesh had now emerged as the leader on many counts, so much so that the state of Uttar Pradesh secured the top position in the country in implementation of 44 gov-

The chief minister, while listing the achievements of his government, was livid how the state was earlier consigned to communalism and appease-ment which prevented the most eligible lot of society from get-ting benefits of the welfare schemes. "The habitual crimi-nals and mafia were directly under government patronage during the previous regime and the period between 2012 and 2017 witnessed riots every three-four days," he pointed out and added, "My government may well boast of having not a single riot during the last four-and-a-half years, the crimi-nals were shown their place and the property of mafia, acquired through unscrupulous manner,

worth over Rs 1,800 crore was either seized or demolished."

He said that during previous governments, there used to be a scramble among ruling party leaders for making their own houses but his government delivered for the people and provided as many as 42 lakh houses for the poor under PM Awas Yojana.

Yogi Adityanath said that there was a time when the investors were wary of coming and investing in Uttar Pradesh. "My government held the first-ever Investors' Summit in 2018 which assured the state investments of over Rs 3 lakh crore which was quite an achieve-ment considering the fact that the state affairs were in a shambles till 2017.

Channi, 58, a three-time MLA from Rupnagar's Chamkaur Sahib will be sworn in as Punjab's first Dalit Chief Minister on Monday. His elevation is significant given the fact that Dalits form around 31 per cent of Punjab's population. The Dalit population is in the same range in neighbouring States of UP and Uttarakhand. Party sources said Channi's deputies may be from the Sikh and Hindu communities.

5L visitors to get free visas in bid to help tourism, aviation sectors

PNS NEW DELHI

in the country. India may soon reopen its doors for foreign tourists for the first time in one-and-a-half year. The first five lakh foreign tourists will be issued visas free of cost in an attempt to revive the tourism, hospitality, and aviation sectors hit by the pandemic since March 2020, when a nationwide lockdown was announced.

Senior Home Ministry officials are in talks with the stakeholders to decide the expected date and modalities for reopening of the borders for foreign tourists. A formal announcement is expected to come within the next ten days. The decision is due to the declining Covid-19 cases in the country.

The officials said free visa to the tourists will be issued till March 31, 2022 or the issuance of five lakh visa, whichever is earlier. The total financial implication for this would be ₹100 crore. "The free visa move is

expected to incentivise short-Δ mid a decline in Covid officials said. "The cost for a month-long e-tourist visa is country-specific but is around \$25. A year-long multiple entry e-tourists visa charge is around \$40," it further reported. The etourists visa remained suspended from March 2020 due to the Covid pandemic. The Home Ministry officials

also said the tourists will be allowed with certain conditions like those vaccinated will be allowed to enter the borders. The reopening will take place in a phased manner to understand the response and implications of the move, another official said. India is among many countries that have started opening up for

Scheduled international passenger services have been suspended in India since March 23, 2020, due to pandemic. But special international flights have been operating under Vande Bharat Mission since May 2020 and under bilateral "air bubble"

arrangements with select countries since July 2020. India has formed air-bubble pacts with around 28 countries, including the US, the UK, the UAE, Kenya, Bhutan, and France.

The Union External Affairs Minister S Jaishankar on Sunday urged his Saudi Arabian counterpart Prince Faisal bin Farhan Al Saud to resume direct flights between India and Saudi Arabia, which remains suspended owing to pandemic. UAE has relaxed norms for travellers from India. As per Government data, foreign tourist arrivals during the period January — April, 2021 were 376083 as compared to 23,57,877 in January - April 2020 registering a negative growth of 84.0 per cent.

In one of the biggest drug Directorate of Revenue Intelligence (DRI) has reportedly seized two shipping containers with heroin worth an estimated ₹9,000 crore from Mundra Port in Gujarat's Kutch district.

The contraband originated from Afghanistan and the cargo was camouflaged between bags of talcum powder in the two containers that landed at Mundra Port in Gujarat on Tuesday. The containers were

imported from Afghanistan to Mundra Port allegedly by Vijaywada-based Ashi Trading Sources said the Indian

firm had reportedly declared the consignment as "talcum powder". The exporting firm has been identified as Hassan Hussain Ltd., based in Kandahar, Afghanistan.

Jaishankar, Saudi Foreign Min discuss ties, developments in Afghanistan

Saud to meet Modi today in first visit since virus outbreak

PNS NEW DELHI

India and Saudi Arabia on Sunday reviewed the entire gamut of bilateral ties and the current situation in Afghanistan during External Affairs Minister S Jaishankar's talks with his Saudi counterpart Prince Faisal bin Farhan Al Saud.

The two leaders also took stock of the situation in the Gulf and the Indo-Pacific during the extensive talks besides India urging early resumption of flights to Saudi Arabia, the External Affairs Ministry (MEA) said later.

The visiting dignitary will meet Prime Minister Narendra Modi on Monday before ending his three-day visit to New Delhi. Al Saud arrived here on Saturday evening. It is the first ministerial visit from Saudi

Arabia to India since the outbreak of the pandemic.

Given the strong ties between the two countries, the two Foreign Ministers, meanwhile, also explored ways to further expand bilateral ties in areas of Defence and security, trade, investment and energy. Incidentally, Army chief General MM Naravane became the first Indian Army head ever

to visit Saudi Arabia last year, thereby signifying the growing relations between the nations.

On the talks between Jaishankar and Al Saud, sources said the former called for further relaxing restrictions on travel from India to the Gulf nation while appreciating the country for the support provided to the Indian Continued on Page 6

Won't attend classes till schools for

girls reopen

n a country that has seen the human rights of women being trampled ever since the Taliban came to power in Afghanistan, there is a sliver of hope that there is still some resistance left in the people of the embattled country. This resistance to the regressive ways of the Taliban has come from a group of Afghan boys who have refrained from going to school in solidarity with the girls of the country who have not yet been recalled to school.

This startling development comes at a time when women employees in the



Afghan boys stand up for girls' right to study

Kabul city Government have been told to stay home, with work only allowed for those who cannot be replaced by men. This announcement detailing the latest restrictions on women by the new Taliban rulers, was made by the interim Mayor of Afghanistan's capital on Sunday.

While most of the boys

went to school, some boys

staved home to express solidarity with the girls and said that they wouldn't show up until the schools for girls were opened. "Women make up half of society ... I won't show up at school until the girls' school opens," Rohullah, an 18-year-old student in class 12, reportedly told the Wall Street Journal.

The Taliban Ministry of

Education had on Friday ordered the reopening of secondary school for boys while the reopening of girls' schools was still a mystery. "All male teachers and students should attend an educational institution," said a statement released late on Friday. Taliban spokesman Zabihullah Mujahid told the local Bakhtar News Agency on Saturday that an arrangement was underway to reopen girls' secondary school, but he did not give a date. Meanwhile, the United

Nations has stated that it is "deeply concerned" about the future of girls' school educa-tion in Afghanistan. "It is important that all girls, including older girls, be able to resume education without further delay. To do so, female teachers need to resume education," he said. The Taliban said it would not implement fundamentalist policies like the last rule, but the future of women's rights and freedoms

Yogi cites prevalence of rule of law as one of his biggest achievements

∼hief Minister Yogi Adityanath on Sunday described restoration of law and order as one of the biggest achievements of his government. Speaking on the occasion of completion of four-and-ahalf years of his government at a ceremony held at Lok Bhawan, Yogi Adityanath said that if investors were ready to invest in UP today, women felt safer and the benefits of the government schemes reached the poor and the needy, it was because of the prevalence of rule of law in the state, which had been missing from the state for past several years.

"Not a single riot has taken place in the last four-and-a-half years of our government, which had become a routine affair occurring every three-four days between 2012 and 2017," he remarked.

Taking a dig at previous governments, Yogi pointed out that while his government had handed over 42 lakh houses to the poor in the last four-anda-half years under the PM Awas Yojana, the previous governments were busy demolishing government buildings and building their own luxury houses. "There was a competition among leaders to build their own luxury houses," he quipped. "Transfer and posting of officers had become an industry during the previous governments to make money.



Dr Sahu said they will have an urgent general body meeting to decide the course of action. "This decision does not benefit patient care as elder doctors are not capable of the desired level of patient care because of vari-

ous physical and mental issues related to ageing. They are not having new energy and modern vision to improve the institute and hospital quality and services," he said. He pointed out that new methods of teaching and training for improving teaching courses are lacking in older faculty with increasing age.

"Old faculty's increasing age will debar new faculty from acquiring administrative skills and the second line will never be prepared to take care of hospitals. New faculty members' posts will not be created and new students will not get a chance for faculty jobs. Besides, nowhere in the rest of the states has this been practically implemented. Overall, increasing the retirement age of faculty only leaves old hands and brains who are not medically and physically fit to take care of patients, teaching and research work effectively. We strongly condemn this decision of the government," he

Dr Sahu said the government, in the larger interest of public and young doctors' future and career, should not increase the retirement age and also implement rotational headship of each department so that all faculty members should get administrative experience,"

No connection of poultry farm owner with terrorism found

A man who was detained for alleged links with Pakistansponsored terrorism, was released on Saturday night after thorough interrogation by the investigating agencies. He was identified as Shahrukh. Explosives, including IED, were allegedly recovered from his poultry farm in the trans-Yamuna area of Dandi. Zeeshan had been arrested from a poultry farm in Dandi with explosives and IED. The owner of the poultry farm is Shahrukh of Kareli area, so he was also on the ATS radar. The police claimed to

idence on Saturday morning for investigation. The family members of Shahrukh are of the view that when Shahrukh came to know about the incident and was told that the police had launched a manhunt for him, he reached the police station and surrendered to prove his innocence.

91,822 JABS ADMINIS-TERED IN PRAYAGRAJ: The Sangam city has set a record for the highest vaccination in a single day as 91,822 iabs were administered to people of all age groups on Sunday. The vaccination campaign was held at 343 sites and Sangam city recorded the highest turnout of recipients across the state. 15 cattle mowed down by rail engine

As many as 15 cattle were mowed down by a speeding electric engine on Kanpur-Jhansi railway track near Bahabalpur village under Gajner police station of Kanpur Déhat late Saturday night.

According to reports, farmers often leave their cattle for grazing near the railway track. Around 10 pm on Saturday, some stray cattle were grazing on the railway track when an electric engine arrived. On seeing the cattle on the track, the engine pilot blew the horn and the cattle started running here and there. Some of them ran on the track ahead and were mowed down by the engine one-by-one. The engine driver applied the brakes and informed the officials of the nearby Lalpur railway station about the incident. A railway team reached the spot and examined the engine. After removing the remains of the cattle from the track they allowed the engine to proceed for its destination. On Sunday morning, the villagers were stunned to see the mass killing of cattle. They said such an incident took place there for the first time. Lalpur Station Master Shivpal said there was no damage to the engine. The Kanpur-Jhansi Intercity was, however, delayed by a few minutes, he added. It may be recalled that the Kanpur-Jhansi and Delhi-Howrah railway tracks pass through the Kanpur Dehat area. Due to this, inci-dents of cattle being hit by trains are often reported there. A few days ago, after a bull was hit by the speeding Mahabodhi Express train at Jhinjhak, the overhead equipment line was damaged, disrupting the movement of railway traffic up to Delhi. Earlier, a cattle was hit by the Vande Bharat train.

1.20 L deaths due to negligence in road mishaps in 2020: NCRB 41,196 cases of "hit and run" "deaths due to negligence of

▼ndia recorded 1.20 lakh cases of "deaths due to negligence relating to road accidents" in 2020 -- 328 people losing their lives every day on an average -- despite Covid-19 lockdowns, according to Government

As many as 3.92 lakh lives have been lost in three years in deaths due to negligence related to road accidents, the National Crime Records Bureau (NCRB) revealed in its annual 'Crime India' report for 2020.

While 1.20 lakh such deaths were recorded in 2020, the figures stood at 1.36 lakh in 2019 and 1.35 lakh in 2018, the data showed.

The country also logged 1.35 lakh cases of "hit and run" since 2018, the report of the NCRB, which functions under the Union Home Ministry,

In 2020 alone, there were

cases in 2019 and 47,028 in 2018, the report showed.

On an average, there were 112 cases of "hit and run" reported across the country every day in the past year, according to the data.

The cases of causing "hurt" by rash or negligent driving on public way stood at 1.30 lakh in 2020, 1.60 lakh in 2019 and 1.66 lakh in 2018, while the cases of "grievous hurt" stood at 85,920, 1.12 lakh and 1.08 lakh, respectively, the data showed.

Meanwhile, 52 cases of deaths due to negligence relating to rail accidents were recorded across the country in 2020, from 55 in 2019 and 35 in 2018, the report showed.

During 2020, India also logged 133 cases of "deaths due to medical negligence", up from 201 in 2019 and 218 in 2018, the NCRB data

There were 51 cases of

there were 147 cases in 2019 and 40 in 2018, according to the report.

Another 6,367 cases of 'deaths due to other negligence" were reported across the country in 2020, up from 7,912 in 2019 and 8,687 in 2018, it showed.

The NCRB stated in the report that the country remained under complete lockdown from March 25, 2020 till May 31, 2020 due to the Covid-19 pandemic during which the movement in public space was 'very limited".

The cases registered under

crimes against women, children and senior citizens, theft, burglary, robbery and dacoity have therefore declined, whereas Covid-related enforcement has resulted in increase of cases registered under 'disobedience to order duly promulgated by public servant (Section 88 IPC)', under 'Other IPC Crimes' and under 'Other

Security forces to use pump action guns to kill low-flying drones

S ecurity forces that guard vital sinstallations, airports and even their own camps have been directed to use rubber bullets bearing pump action guns to neutralise low-flying drones till an appropriate technology is found to thwart such aerial attacks, official sources said.

Also, forces like the Border Security Force (BSF) have recently installed an improvised iron pole mounted light machine gun (LMG) observation post at some of its border deployments against Pakistan to take a 360 degrees aim and shoot down drones or unmanned aerial vehicles (UAVs) flying at a high altitude, they said.

A latest blueprint prepared by central security agencies to counter the emerging drone threat has been reviewed by PTI and it directs security forces to use PAGs (pump action guns) that are already available in

their armoury for "neutralising any low-flying UÁV".

Following the directive, the central forces deployed for internal security have begun allocating PAGs their

vulnerable to drone threats, including those deployed for anti-Naxal operations. "Till a complete technology solu-

tion is found for effectively checking and neutralising a drone attack, the security forces have been asked to use what is available with them, like the Those who do not have adequate

Centre seeks report from AP on ₹960 cr loans from foreign agencies

Amaravati: The Centre has sought a report from the Andhra Pradesh Government on ₹960 crore received as loans from foreign agencies for various Externally- Aided Projects (EAPs) remaining unutilised.

The departments that are supposed to get these funds for executing the projects have drawn a blank, while payments running into hundreds of crores of Rupees are yet to be made to contractors on works done so far. The EAPs now remain

derailed because the state is unable to draw further loan amounts from the external agencies due to poor progress of the works and non-clearance of payment (dues).

The Department of Economic Affairs (DEA) under the Union Finance Ministry has taken a strong view and written a letter last week seekingan explanation from the state Finance Department on the issue

"The overall position of utilisation of advances extended by various authorities is not so encouraging as a very heavy amount of advance is lying in the accounts of Government of Andhra Pradesh.

As on September 7, the amount released as advance is USD 124.65 million, roughly equivalent to ₹ 960 crore," the DEA pointed out in its letter to the Principal Finance Secretary. The DEA also noted that

utilisation of the loan amount "is not so high", which indicated a "situation wherein the interest cost is increasing but the project execution is at a slow pace". Also, officials of the DEA

personally called up top offi-

cials of different state depart-

ments and "gave us an earful" over the sorry state of affairs, a senior bureaucrat said. 'We are being bombarded with queries on the status of works and utilisation of funds

(advanced by foreign agen-

cies), but our report card is filled with only blanks. They gave us money but we can't tell them we actually don't have it," the bureaucrat observed.

On the one hand, the state government has been scampering for loans but, on the other, the loans secured were obviously not being spent for the intended purpose, he told

Efforts to contact the Principal Finance Secretary for clarification on the subject did not bear fruit. The YS Jaganmohan Reddyled YSRCP's victory march that had begun in 2019 polls, by bagging 151 out of 175 Assembly segments and continued in the polls for urban and local bodies, Tirupati Lok Sabha bypoll two years later is near complete on Sunday as the ruling party registered a historic and landslide win in the Parishad Polls while crushing Opposition TDP and

Indian industry to produce 2 more entire rockets: DoS

Bengaluru: The Department of Space (DoS) plans to realise entirely-built rockets — GSLV-Mk III and SSLV from Indian industry partners, in addition to PSLV, according to a top official of its commercial arm NSIL.

NSIL (NewSpace India Limited) has received three bids -- HAL-L&T, BEL-Adani-BEML, and BHEL, in response to the request for proposal (RFP) floated by it for end-to-end production of PSLV (Polar Satellite Launch Vehicle). "We are now going through the techno-commercial evaluation (in respect of the three bids)", NSIL Chairman and Managing Director, Radhakrishnan D, told PTI here. He said the process will be completed within the next two months with one of the bidders bagging the contract. The selected bidder will be responsible for realisation of five numbers of PSLV. Immediately after selection of the bidder to produce the entire PSLV, NSIL will release Expression of Interest (EOI) for end-toend production of another operational rocket -- GSLV-Mk III (Geosynchronous Satellite Launch Vehicle) -- in a similar

fashion, Radhakrishnan said. "I am targeting before the end of this year (to release EOI for GSLV-Mk III)",

NSIL also has plans to realise SSLV (Small Satellite Launch Vehicle), being developed by the Indian Space Research Organisation (ISRO) with the first development flight expected by this year-end, through Indian industry partners. "We are waiting for the first mission (of SSLV) to happen successfully", Radhakrishnan said. "This (SSLV) will be an ideal can-

didate for industry production". SSLV is a three-stage all solid vehi-cle and has a capability to launch up to 500 kg satellite mass into 500 km low earth orbit (LEO) and 300 kg to Sun Synchronous Orbit (SSO).

The new generation compact rocket has been designed to meet "launch on demand" requirements in a cost-effective manner for small satellites in a dedicated and rideshare mode, according to officials of Bengaluru-headquartered ISRO. PTI

According to officials, a memorandum of understanding has been signed between the food & public distribution department and CSC, to enable ration card services through 3.7 lakh CSCs across the country. The partnership is expected to benefit over 23.64 crore ration card holders across the country who can now visit their nearest CSC and update their card details, do Aadhaar seeding, get a duplicate print of their card, check the status of avail-



ration card holders, citizens who want to apply for a new ration card can also now visit their nearest CSC to put in the request application.

CSC e-Governance Services India Managing Director Dinesh Tyagi said, "Following our partnership with the department of food and public distribution, our village-level entrepreneurs (VLEs) who run CSCs will be able to reach out to those without

ability of ration and register ration cards and help them get Apart from the existing system and various government schemes for free ration.

> Moreover, the online services of CSC will also be made available at fair price shops that include PM welfare schemes, G2C services, education and skilling courses, financial services, health care and utility bill payments services. For this, ŚC will undertake training and capacity building of fair price shop dealers on providing these services, Tyagi added.

India logs 30,773 new **Covid cases, 309 fatalities**



India has reported 30,773 new Covid-19 cases, 13.7 per cent lower than Saturday and 309 deaths in a span of 24 hours, the Union Health Ministry said on Sunday. The per cent, it added.

With a decline of 8,481 active cases, the country's active case load stands at 3,32,158, the ministry data showed. Active cases currently account for 0.99 per cent of the total cases in India.

The death toll has further climbed to 4,448,38 with 309 daily fatalities, while active caseload declines to 3.32 lakh

Meanwhile, 38,945 more people were discharged in the last 24 hours, taking the total recoveries in the country to

Also, 15,59,895 tests were conducted on Saturday, taking the total cumulative tests conducted so far to 55,23,40,168 the government said. The daily positivity rate has been recorded at 3 per cent for the last 20 days, according to the ministry data.

The weekly positivity rate has been recorded at 2.04 per cent. It has been below 3 per cent for the last 86 days, the ministry said.

A total of 80,33,75,147 vaccine doses have been administered so far, said the Union health ministry in an official statement released on Saturday. It further stated that out of these 80 crore, the last 10 crore Covid-19 vaccine doses were administered in just 11 days.

More than 77.25 lakh (77,25,076) vaccine doses were administered till 7 pm on Saturday. From these, 40,87,704 were inoculated as first dose and 36,37,372 were administered as second dose to eligible

India's Covid-19 tally had crossed the 20-lakh mark on August 7 last year, 30 lakh on August 23, 40 lakh on September 5 and 50 lakh on September 16. It went past 60 lakh on September 28, 70 lakh on October 11, crossed 80 lakh on October 29, 90 lakh on November 20 and surpassed the one-crore mark on December 19 last year.

December 2018. "Majboot ko majboor, mamuli ko magroor kiya jaye... baad hi khet ko khaay, uss fasal ko kaun bachaye!" Sharma had tweeted after Punjab Chief Minister Amarinder Singh resigned on

In the resignation letter, the OSD said he has been active on Twitter since 2010 and has not tweeted beyond party lines.

Sharma said he never posted any political tweet after being given the responsibility of OSD

However, he sought an apology if his tweet hurt the party high command and the

state government in any way.

The Delhi police had registered a case against Sharma in March on Union Minister Gajendra Singh Shekhawat's complaint.

Deferments by courts causing unnecessary burden on us: SC

PTI ■ NEW DELHI

The Supreme Court has observed deferments by courts cause unnecessary burden on it as it granted interim protection from arrest to a man whose anticipatory bail application is pending before the Allahabad High Court for the past seven months.

A Bench of justices S K Kaul and M M Sundresh granted the relief while noting that the Allahabad high court has not taken any view on the anticipatory bail application pending before it.

"We do believe that such deferments are only causing unnecessary burden on this Court rather than being dealt

with at the appropriate level.
"The petitioner was never arrested during the investigation, however, he joined and cooperated with the investigation. In such a scenario, on the charge-sheet being filed, there is no need to arrest the petitioner and produce him before the Court in view of the legal position now enunciated by us," the bench said.

The top court made the observation while hearing a plea by an accused seeking anticipatory bail in a criminal bench said.

case. In pursuance to cognisance taken by the Special CBI Court Ghaziabad against the petitioner, a summons was issued against him. On receiving the sum-

mons, the petitioner applied for anticipatory bail on January 16, 2021 which was declined on January 28. The petitioner then filed an

application for anticipatory bail before the High Court on February 3, 2021. The top court noted that

Govt yet to take call on 68 names sent by SC collegium for appointment as HC judges

The Government is yet to take a call on the recommendations made by the Supreme Court collegium on appointing a total of 68 judicial officers and advocates as judges of various High Courts, sources aware of the procedure for appointment to the higher judiciary have said.

Between August 8 and September 1 this year, the apex court collegium had processed over 100 names recommended by various high courts and had finally sent 68 names to the government for appointment as judges to 12 High Courts.

The Government is yet to take a call on the names recommended by the SC collegium headed by Chief Justice of India N V Ramana, the sources said. Out of the 68 names, two

from Karnataka and one from Jammu and Kashmir have been sent for a third time, while 10 others have been recommended for a second time. The rest are fresh recommendations. Prior to these recommen-

dations, in a historic decision on August 17, the SC collegium had sent nine names, including three women, for elevation as judges of the Supreme Court.

The names were cleared



swearing-in as apex court judges on August 31.

Govt to launch telemedicine project at AIIMS, Raipur



With Covid-19 pandemic accelerating the adoption of digital health technologies, the Government will on Monday launch a telemedicine project at AIIMS, Raipur in Chhattisgarh to ensure safe access and deliver specialized medical services right at the doorsteps of the members of the fisheries cooperatives in the State. Union Minister for

Fisheries, Parshottam Rupala, will inaugurate the telemedicine facilities to be implemented under the central sector flagship program Pradhan Mantri Matsya Sampada Yojana (PMMSY) through the National Cooperatives Development Corporation

fisheries cooperatives in the Northern State.

Proposed as a startup activby AIIMS, Raipur for next three years, the project which is a joint effort of the Centre, the State, NCDC and AIIMS Raipur, is being launched in a pilot mode from five centres ---PHC Patan (Durg district), PHC Saja (Bemetara), PHC Ratanpur (Bilaspur), PHC Dhamtari (Chamtari) and AIIMS Raipur (Raipur). Later, it will cover more districts.

NCDC MD Sundeep Nayak said that in the pandemic, it's a difficult time for the people particularly poor who are not able to access healthcare. However, "the use of telemedicine has emerged as a critical tool to improve the (NCDC), for members of the provision of health services.

With the launch of the facilities, the Government aims to bridge health disparities among fishermen and fisherwomen communities associated with their respective cooperatives in the State," he said.

The decision to launch the telemedicine facility was taken after it was found that many members from the cooperatives were shying away from availing medical services either because of living in far off areas, poverty or due to Covid fears.

Dr Nitin Nagarkar said that AIIMS, Raipur had already been conducting teleconsultation services for the benefit of the public, mainly residing in the tribal regions of the State. This activity was also further enhanced during this ongoing Covid pandemic.

The Chief Ministers in several States are a harried lot, unsure of their longevity in office

ost Chief Ministers in India today are a harried lot. Captain Amarinder Singh, for instance, felt "humiliated" by the way he was told to go. He resigned as the Punjab Chief Minister but is still with the Congress. Now "they can name as CM anyone they want", he said, betraying his hurt. He is the first Congress Chief Minister in recent years to be sacked in a machination typical of the party. It is déjà vu of the 1980s and 1990s when the Chief Ministers in Congress-ruled States called themselves State guests, certain that the "high command" would any day parachute their replacements. The *modus operandi* has not changed. The only difference today is that the Congress is left with very few Chief Ministers to replace. Three, to be precise. Such is the fear of the parachuting business, even the Chief Ministers with the majority of MLAs supporting them are apprehensive. The Punjab example would surely have stirred some



fears in Chhattisgarh and Rajasthan. The BJP is not far behind when it comes to playing the replacement game. Vijay Rupani, Trivendra Singh Rawat, Tirath Singh Rawat and BS Yediyurappa were asked to resign in Gujarat, Uttarakhand and Karnataka. In Assam, Sarbananda Sonowal was asked to shift to Delhi, giving the job to Himanta Biswa Sarma after the Assembly elections. After Narendra Modi came to power, as many as 22 Chief Ministers were handpicked and sent to the BJP-ruled States, confirming who the Chief Ministers are beholden to.

A Chief Minister's post, as these incumbents would have realised by now, is not dependent on their abilities to govern or garner the backing of legislators. It entirely depends on the party leadership's primary intent of winning elections and, thereafter, tackling dissent. Many of these Chief Ministers share certain characteristics. Not all of them are leaders in their own right or have a mass base or caste-based support the party cannot ignore. Many are novices where party politics is concerned. Nearly all of them are of seasonal utility for their leadership. On the other hand, those who have these abilities make Chief Ministers of a different kind. Two kinds, actually. One, like the late YS Rajasekhara Reddy of Andhra Pradesh, the mass-based leader who was not overawed by the "high command" because he wielded the power to singlehandedly deliver the State to the Congress in two successive elections. He made a satrapy of the party in the State, took care of the party's national coffers and brooked no interference from Delhi. The other kind is the regional satrap, who branched out from a national party only to wipe its presence from a State, introduced a brand of individualised politics and who is her/his own "high command". These Chief Ministers, whether in Telangana, West Bengal, Odisha or Tamil Nadu, are in a position to eventually introduce the principle of heredity in their States; thus no less powerful or dynastic than their former "high commands".

Jumping ship

Babul Supriyo joining the TMC is likely to boost the party's prospects rather than his own

t happened rather suddenly, with nobody even in the BJP's Bengal unit and political pundits knowing about it. The BJP's star campaigner and once Prime Minister Narendra Modi's blue-eyed boy joined the Trinamool Congress. He joined the party in the presence of its national general secretary Abhishek Banerjee and sent shockwaves in the Bengal BJP. Though he had withdrawn from "active politics" after being



removed from the Environment Ministry, no one anticipated such a move. He had hinted that he would also resign his Parliament seat. This, however, was averted after JP Nadda persuaded him to continue as the Member of Parliament from Asansol. More than anything else, it is going to cause a demoralising effect on the BJP. The TMC hardly gains anything from inducting Babul Supriyo in its ranks. Reason — Babul may have overshot his political expiry. He lost by over 50,000 votes in the recent Bengal elections when he fought on the BJP's ticket. Nevertheless, the TMC

might be thinking of sending him to the Rajya Sabha. Arpita Ghosh, a Rajya Sabha member of the TMC, has been made to resign by the party. Babul Supriyo might be the new TMC entry into the Rajya Sabha.

After a spectacular victory in the Assembly elections, the TMC's ambitions are soaring and it is spreading its wings to fly higher. On the one hand, it is trying to make a mark in national politics by courting various national parties and, on the other, it is making inroads into nearby States like Assam and Tripura. Babul Supriyo may not be important for the TMC in the byelections for vote-catching where Mamata Baneriee would be seeking people's mandate but he can certainly be a trigger for others to leave their party and join the TMC. Four MLAs have already left the BJP and joined the party. It is a huge perception victory and morale booster for the TMC's workers. It could even boost the party's prospects in Assam and Tripura, where the TMC wants to fan out. An additional advantage is Babul's Asansol parliamentary seat which, after his resignation, is going to fall into the lap of the Trinamool Congress. However, this 'shifting loyalty syndrome' does no good to the people or the cause of democracy. It shows the leaders in poor light; actually, it is tantamount to cheating and stealing people's mandate.

he creation of the UN on October 24, 1945, was an outcome of aspirations of anguished humanity hat has suffered WWI and WWII, and gone through unprecedented sufferings, devastation and destruction. It is vionce, terrorism, fundamentalism, distrust and a vulgar pursuit of destructive weaponry all around. The human mind has been studied seriously by modern sciences; it has its intuitional comprehensions contained in ancient treatises. Swami Vivekananda was perfectly logical and scientifically accurate when he mentioned: "The true basis of education is the study of the human mind infant, adolescent and adult. Any system of education founded on theories of academic perfection, which ignores the instrument of study, is more likely to hamper and impair intellectual growth than to produce a perfect and perfectly equipped mind." Obviously, the damage has been inflicted on enerations that have been educat ed and evaluated on much sought after academic excellence, confined to a curriculum, textbooks and examinations that expect reproduction of the answer as "given in the textbook". limited to rote learning and learning for examinations, and marks were the only measure of the level of the learner's excellence. It has to be replaced by conceptual understanding and critical thinking in a learning environment characterised by nourishing of inherent curiosity and creativity.

That could attract the whole world towards Indian institutions once again.



CONSUMERS EASY PREY TO FOOT THE BILL

A reduction in retail fuel prices is possible if additional excise duties are rolled back

etrol and diesel prices have remained close to Rs. 100 for about 10 weeks since July 8, 2021. The impact of this has been on fuel inflation (Wholesale Price Index) which averaged at more than 25 percent for the last five months.

The international crude oil price, however, reveals a different picture. Brent crude oil prices fell from \$77.16 to \$65.18 between July 5 and Aug 20, a reduction of over 15 percent. In layman's terms, the price of petrol in India could have been decreased to ₹85.

Back in 2017, the Oil Marketing Companies (OMCs) were given a free hand to follow dynamic fuel pricing to make their operations more efficient. Why the OMCs have stopped daily price revisions is a mystery. Is it because they are still controlled by the government which has a majority stake in them?



The RBI has also warned that high prices would trigger higher inflation which would affect growth. But it seems the government has decided to continue milking the cash cows — the consumers.

While protection of consumers' interests necessitates government interventions, a reduction of the high prices seems to be far from reality. In May last year, the government imposed additional excise duty on both petrol and diesel, which included road and infrastructure cess - an additional revenue worth ₹1.6 lakh crore. Since the country was forced into a pandemic-induced lockdown, it made commonsense as well as economic sense, then. The fiscal situation was

However, since May 2020, the total taxes on petrol have crossed ₹50 per litre. It was a paltry ₹9.48 per litre when the BJP government replaced UPA II in 2014. Is the government still expecting the fiscal situation to be similar to last year's? Let's look at the GST data which might give a clue in support of this.

Back in April 2020, when India was under a complete shutdown, the GST revenue collections fell to ₹32,294 crores from ₹97,597 crores. However, from March to August 2021, the GST collected has been ₹6,98,257 crores. This was a jump of more than 50 percent compared to the same period in the previous year.

The USD/INR exchange rate also has been favourable to import bills of crude oil. The exchange rate corrected from a peak of ₹77.10/ USD in April 2020 to ₹72.26/ USD in March 2021. It now is ranging between ₹73 to ₹75.

A reduction in retail prices is unquestionably possible. All that needs to be done is to roll back additional excise duties. At present, the total excise duty on petrol exceeds ₹37 per litre. The other alternative is to bring the petroleum products under GST.

Since the government has remained stubborn after numerous pleas for a reduction in the petrol and diesel prices, a set of new questions arise: Is the government planning to put up a surplus budget in February 2022? Is it anticipating a severe third wave and lockdown similar to last year? Larger subsidy amounts are likely to be given to the poor?

Let's evaluate another argument. Higher prices would reduce consumption of the fossil fuel and help reduce global warming. But we need to reduce dependency on personal vehicles and move to largescale adoption of public transport. But mass-rapid transport systems are not effective. If the government wants to promote electric vehicles, then we do not have the technology, capacity to produce in large quantities, and required infrastructure for re-charging battery-run vehicles.

'Cabbage tactic' to seize waters



India should be wary of China using the 'cabbage tactic' in the Indian Ocean region the same way it tries to grab islands in the South China Sea

his week will witness Prime Minister Narendra Modi meeting in person with the leaders of Australia and Japan, apart from the US, a move that holds significant importance and may perhaps change India's foreign policy contours. The meeting comes in the backdrop of Australia's alliance with the UK and the US - AUKUS -- which aims to provide

nuclear submarines to Canberra.

Quad and AUKUS objectively overlap with India's maritime security interests in the South China Sea (SCS). Almost 50 per cent of India's global trade transits through the SCS region. The governments of Quad focus on the freedom of navigation on high seas as a legitimate right.Beijing has actively adopted a "cabbage tactic", which is multi-layered, to increase its leverage by capturing the SCS. This vital trade route also happens to be a potential source of natural resources such as hydrocarbons. For this purpose, it builds artificial islands by claiming its "historic rights" and then legislate-unusual domestic laws on it to excrete its "sovereignty" over them. The "cabbage tactic" is used to take control of an island by surrounding it in multiple layers of fishing boats, coast guard ships and Chinese naval and military ships to cut off the island from outside support. The more significant motive, of course, is occupying as much space as possible by threatening other countries.

The UN Convention on the Law of the Sea (UNCLOS) does not have a provision to address the issues regarding construction, maintenance and militarization of artificial islands beyond ta state's "territorial waters". Article 60 (1) of the UNCLOS allow for artificial islands only in the Exclusive Economic Zone. Artificial islands of China beyond its territorial waters are thus farcing.
The International Court of Justice

asserted the same in its 2016 arbitration, which Beijing refuted. The Chinese maritime domestic laws conflict with the UN Convention on the Law of the Sea and sharply violate the maritime rights of the other states. The UNCLOS provides the vital 'freedom of 'navigation' and 'right to innocent passage' on the high sea, i.e., area outside internal waters, the territorial sea, the contiguous zone, the exclusive economic zone and the continental shelf of a state to regulate their maritime trade and movement for peaceful purposes such as helping the other states in distress, scientific exploration, etc.

Chinese intentions can be ascertained by examining its 1992 Law of the PRC. Article 14 emphasized the option of using a "hot pursuit" against a foreign ship if it enters its territorial waters or the contiguous zone. Further, Article 15 insists that baseline of its territorial sea would be "established" by itself, a move

hinting towards its future expansionism.

Later, in 2011, China submitted in the UN a Note Verbale on the SCS speaking about its "indisputable sovereignty over the islands in the South China Sea and the adjacent waters". Nonetheless, the terms "historic rights" and "adjacent waters" do not appear in UNCLOS, and there is no recognition. Further, the use of illegal terms serves the purpose of the Chinese Communist Party (CCP) by expanding the scope of its 'grey zone tactics' and hence are a distraction to the well-established international norms and principles. China zealously guards the SCS, which was recently evident when China illegally stopped a German warship from

Accompanied by the regularisation of such words, its mention of phrases like 'offshore defence', 'distant sea defence' and its 'interests aboard' truly reflect its hegemonic behaviour that is set to expand to the Indian Ocean Region (IOR). Its nuclear submarines are regularly sighted in the IOR and the Arabian Sea by the Indian Navy. The presence of Chinese submersibles is a clear-cut violation of Article 20 of UNCLOS, which states that "in the territorial sea, submarines and other underwater vehicles are required to navigate on the surface and show their flag". China may be collecting critical undersea hydrological data from the IOR to plan action in case of a limited conflict or a full-blown open war with India. Such moves are a detriment to India's core security objectives. China counters its presence by putting forward a lame excuse with its nuclear submarines to counter the piracy in the Gulf of Aden. One can only wonder how a nuclear submarine can counter piracy.

On the contrary, in the SCS, China explicitly maintains that all the naval vessels of the other countries and research ships seek prior permission before they enter the territorial waters of China. The same duplicity has been evident in its recent amendment to China's Maritime Traffic Safety Law. It now includes five types of vessels- "submersibles, nuclear-powered vessels, ships carrying radioactive materials, ships carrying bulk oil, chemicals, liquefied gas or other toxic substances" that need to report minute details to the Chinese authorities. The cargo ships are thus now questionable and more prone to sabotage through "hot pursuits".

Further, Article 11 of the same law asserts that "Non-military vessels of foreign nationality may not enter the internal waters". Additionally, the "military vessels of foreign nationality may not enter the territorial waters". Thepertinent question that arises is what are the limits of its "territorial waters"? As per the UNCLOS, itextends upto 12 nautical miles from the baseline of a coastal state. In the case of Beijing, will it start measuringsuch limits from the artificial islands that it has builtin the SCS? Then in such a case, the Spratly and Paracel Islandsrepresent a "sea grab", similar to a land grab. Does it not then amount to infringing the freedom of navigation of other states? Such illegal occupation affects the trade routes and supply chain lines. Such dual standards need to be exposed and at various regional and multilateral levels.

China's land reclamation activities in Feydhoo Finolhu Island leased out to Beijing by the Maldives in 2016 are China's emerging footprints in the IOR. This comes in addition to its military intelligence and surveillance activities in the Coco Islands and Greater Coco islands of the Eastern Indian Ocean. The existing geostrategic realities of Chinese hegemonic intentions in the IOR are visible through China's OBOR and its attempts to remould the Asian security order in its favour. China's recent outreach to the Taliban in Afghanistan can increase its tactical manoeuvrabilityon land. On the other hand, Chinese nuclear submarines, illegal fishing, and surveillance activities in the IOR are set to become a significant threat to Indian security interests.

Suppose China would be successful in having land-sea dominance encircling India, in such a case, it will not only threaten India's immediate and longterm security interests, but it will also adversely affect India's economic and cyber security. China might use the "cabbage tactic" in the Indian Ocean Region in the same way as in the South China Sea. In this direction, the nation should appreciate the establishment of the Andaman Nicobar Command and the re-orientation of the battle commands, which will have joint operability of the Army, Navy and the Air Force. In the present circumstances, India's further shift towards QUAD and AUKUS shouldn't be a surprising development and should be welcomed by the nation.

Why do we need nurses with disabilities?

Misconceptions about the capacity of students with disabilities to function in the clinical components of nursing education deter such applicants

From this year onwards, B.Sc.(Nursing) admissions will be made through NEET, which were conducted last Sunday. I received a panic call from the father of a young girl who was considering nursing admission but she had three missing fingers in her non-dominant hand and a curvature in her spine. The father was concerned about the National Testing Agency's urgent public notice for B.Sc. (Nursing) course aspirants in NEET 2021, which cited an Indian Nursing Council (INC) letter stating that disability reservation is only allowed for physical disabilities of 40-50 per cent and of the lower extremity. It is strange, because how could this be possible after the enactment of the Rights of

Persons with Disabilities Act (RPDA), but INC has published a gazette notice announcing this clause as well as revising its nursing curriculum for the first time since 1947. It will be implemented beginning with the new batch. Unfortunately, the dis-

criminatory National Medical Commission (NMC) standards for applicants with disabilities were framed by a single, non-disabled expert from this subject from a premier institution in India, who decided the ablest requirement of "both hands intact" as a musthave for MBBS admission. The Delhi High Court will be hearing a case of a girl with an amputated arm who passed the NEET exam last year but was denied MBBS admission to Lady Hardinge Medical



College, causing her to lose an academic year. Thankfully, the Supreme Court and the Goa High Court have already granted MBBS admission to girls with an amputated arm in Gujarat and Goa, respectively.

The INC does not need to repeat NMC's embarrassing gaffes. The INC's new curriculum mentions the keyword "dignity" six times, whereas NMC's patented competencybased Medical Education Curriculum does not. In the Convention on the Rights of cent, INC's counterpart has Persons with Disabilities, which India has ratified, and in the preamble of the RPDA, dignity is a key component.

Learning disability is now a specified disability under the new law, and it is included in the 5 per cent reservation in higher education. But where are the dyslexic doctors and nurses in India? In India, you will only see nurses who are "one-legged" or "both legs disabled." Yes, this is the vocabulary used by the Ministry of Social Justice and Empowerment and the Ministry of Health to identify, stereotype, and 'otherize' us in

employment. After my litigation in the Delhi HC, which pushed NMC to allow persons with disabilities of more than 80 per

accepted disabilities other than lower limb and surely those above 50 per cent (INC's benchmark)

In a recent SC decision on reasonable accommodation in the instance of a doctor with dysgraphia, Dr Vikash Kumar v. UPSC, the highest court criticised an earlier order that barred blind and deaf candidates with a disability of more than 50 per cent from becoming judges. The statutory Councils are still unaware of this historical judgment on substantive equality in the RPDA era.

Leslie Neal-Boylan who has written multiple books and journal articles on nurses with disabilities has defied the myth that there are patient safety concerns. The same

myth has been refuted in 2014 illness or disability. They adapt by the American Association of Colleges of Nursing's white paper which identified outdated admission standards; misconceptions about the capacity of students with disabilities to function effectively in the clinical components of nursing education; and, lack of a comprehensive understanding of issues related to patient safety as barriers that deter applicants with disabilities. The Royal College of Nursing in the UK too also issued a range of employment options for nurses with severe ill health or dis-

abilities in 2020. We don't need superhuman robots in health care; instead, we need compassionate and caring nurses with disabilities who understand what it is like to live with a chronic

demonstrate empathy and are brilliant co-workers. We may be rejecting many brilliant applicants who could be outstanding nurses like the renowned Nightingale if we limit our profession to those without disabilities. I hope the INC will look into the representation of health professionals with disabilities which are endorsed by 22 nurses with disabilities from AIIMS New Delhi, Bhopal, Jodhpur, Jhajjar, NIMHANS and Delhi Government hospitals. If INC is serious about implementing the high pedestal ethos of diversity indicated in their new curriculum, they must act and collaborate with nurses with disabilities.

'Delhi-Mumbai E-way to fetch ₹1,500 cr per month'

PTI ■ NEW DELHI

The Centre will get toll revenues worth ₹ 1,000 to 1,500 crore every month once the much-awaited Delhi-Mumbai Expressway becomes operational in 2023, Union Minister Nitin Gadkari said on Sunday and described state-

owned NHAI as a "gold mine" for generating income.

Steering the ambitious drive to expand the country's road infracture for the past road infrastructure for the past seven years, a confident Gadkari also asserted that National Highways Authority of India (NHAI) will rake in annual toll income to the tune of ₹1.40 lakh crore in the next five years from the current level of ₹40,000 crore.

Gadkari, who just completed a whirlwind tour to assess the progress of the Delhi-Mumbai Expressway that will pass through four states apart from the national capital, said the national highways infrastructure is a world-class success story.

"Once the Delhi-Mumbai Expressway is completed and opened for the public, we will get at least ₹1,000-1,500 crore as toll revenues every month,"



he told PTI in an interview.

Delhi-Mumbai Expressway is likely to be completed by March 2023 and is being built as part of the first phase of the 'Bharatmala Pariyojana'.

The eight-lane expressway, covering Delhi, Haryana, Rajasthan, Madhya Pradesh and Gujarat, is expected to halve the commute time between the national capital and the country's financial hub from nearly 24 hours to 12 hours.

Against the backdrop of concerns being flagged about NHAI being saddled with high level of debt, the Union Road Transport and Highways Minister pointed out that the nodal agency has received 'AAA' rating and all its road projects are productive.

'AAA' is one of the highest credit ratings and indicate robust financial position.

"NHAI was not in a debt trap, and it will never be in debt trap in future. It is a gold mine, and is on strong footing... In the next five years, NHAI's toll income will rise to Rs 1.40 lakh crore per year from current toll income of Rs 40,000 crore," Gadkari noted.

In March, the Departmentrelated Parliamentary Standing Committee on Transport,
Tourism and Culture had
expressed its displeasure over a
whopping Rs 97,115 croredebt servicing liability on NHAI.

Recently, the minister informed Rajya Sabha that total borrowings of NHAI increased to Rs 3,06,704 crore at the end of March this year from Rs 74,742 crore in March

While noting that investments in the infrastructure sector will create employment and accelerate the country's economic growth, Gadkari said, "We (NHAI and the ministry) are working on projects worth lakhs of crores".

When the economy is on a decline, "then economics tells us that there is a need to increase investments in infrastructure", he added.

PM will take a call on further infra investments in Afghanistan: Gadkari

With Afghanistan coming under the control of the Taliban, Union Minister Nitin Gadkari on Sunday said a final decision on continuing infrastructure investments in the war-torn country will be taken by the Prime Minister along with the External Affairs Minister after considering the prevailing situation.

Gadkari, who is helming the Road Transport and Highways Ministry, also said that while many infrastructure projects in that country have been completed by India, some are yet to be completed.

Last month, the Taliban seized control of Afghanistan ousting the previous elected leadership which was backed by the West.

"We have built a dam (Salma dam)... We have worked in areas of water resources in Afghanistan," Gadkari said while responding to a query on whether India will make further investments in the now Taliban-controlled

Prime Minister Narendra Modi and External Affairs Minister S Jaishankar will take a decision on whether India will now invest in infrastructure projects in Afghanistan or not, Gadkari said.

"As a friendly country, we had discussions with Afghanistan government officials for building some roads (also)... Good that I did not start construction of roads (in Afghanistan)... The situation there is of concern," he told PTI in an interview.

India has invested around USD 3 billion in different welfare and infrastructure projects in Afghanistan.

On Friday, Modi said the global community should decide "collectively" and "thoughtfully" on recognising the new setup in Afghanistan in view of questions over its acceptability as the change of power was not "inclu-

Small cars too need adequate number of airbags to ensure safety, says Min

Union Minister Nitin Gadkari on Sunday said that small cars, mostly purchased by lower middle-class people, should also have an adequate number of airbags and wondered why auto makers are providing eight airbags only in big cars bought by rich

In an interview to PTI, the Road Transport and Highways Minister also emphasised that his appeal for more airbags in small economy cars was to ensure safety and prevent possible deaths in accidents.

His remarks come against the backdrop of the automobile industry raising concerns that high taxation and stricter safety and emission norms for vehicles have made their products

Mostly, lower middle-class people buy small economy cars and "if their car won't have airbags and when accidents happen, then it may result in deaths. So, I appeal to all car manufacturers to provide a minimum of six airbags across all variants and segments of the vehicle," he said.

While acknowledging that additional airbags in small cars will increase their cost by at least Rs 3,000-4,000, Gadkari also said, "in our country, poor

Labour codes unlikely to be implemented this fiscal

The four labour codes are unlikely to be implemented this fiscal in view of slow progress on the drafting of rules by the States and also for political reasons like elections in Uttar Pradesh, a

The implementation of these laws assumes significance because once these are implemented there would be reduction in take-home pay of employees and firms have to bear higher provident fund liability.

"The Ministry of Labour is ready with the rules under the four labour codes. But the states have been slow in drafting and finalising those under new codes. Besides, the government is not keen to implement the four codes due to political reasons, which are mainly elections in Uttar Pradesh (due in February 2022 onwards)," the source

The four codes have been passed by Parliament. But for implementation of these codes, rules under these must be notified by central as well as state governments for enforcing those in respective jurisdictions.

"It is likely that the implementation of the four labour codes may be dragged beyond this fiscal year," the source said.

Once the wages code comes into force, there will be significant changes in the way basic pay and provident fund of employees are calculated. labour ministry had envisaged implementing the four codes on industrial

relations, wages, social security and occupational health safety & working conditions from April 1, 2021. These four labour codes will rationalise 44 central labour laws.

The ministry had even finalised the rules under the four codes. But these could not be implemented because many states were not in a position to notify rules under these codes in their jurisdictions

Labour is a concurrent subject under the Constitution of India and therefore both the Centre and states have to notify rules under these four codes to make them the laws of the land in their respective jurisdictions.

According to the source, some states have worked on draft rules on four labour codes. These states are Uttar Pradesh, Bihar, Madhya Pradesh, Harvana, Odisha, Punjab, Gujarat, Karnataka and Uttarakhand.

Under the new wages code, allowances are capped at 50 per cent. This means half of the gross pay of an employee would be basic wages. Provident fund contribution is calculated as a percentage of basic wage, which includes basic pay and dearness

The employers have been splitting wages into numerous allowances to keep basic wages low to reduce provident fund and income tax outgo.

The new wages code provides for provident fund contribution as a prescribed proportion of 50 per cent of

m M}$ ost of the merchant bankers who had submitted bids for facilitating strategic sale of LIC-controlled IDBI Bank indicated a timeframe of one year to complete the elaborate process, sources said.

During a presentation before the Department of Investment and Public Asset Management (DIPAM) held recently, most of the eligible transaction advisers gave a timeframe of 50-52 weeks to undertake several stages of the privatisation process of IDBI Bank, market sources said.

However, the Government intends to complete the transaction during the current fiscal itself. Thus the merchant banker has to find a buyer in about 26 weeks or six months.

According to market sources, as many as seven bids -- Deloitte Touche Tohmatsu India LLP, Ernst and Young LLP, ICICI Securities Ltd, JM Financial Ltd, KPMG, RBSA Capital Advisors LLP and SBI Capital Markets Ltd --

DIPAM on behalf of Government of India had floated a tender in June inviting bids from transaction advisors from reputed professional consulting firms or investment bankers or merchant bankers or financial institutions for facilitating and assisting strategic disinvestment of IDBI Bank. The last date for submission of bids was July 13. KPMG placed the lowest bid of Re 1, and was selected as the transaction adviser, market sources said, adding, the firm will assist the government in the sale for Re 1.

Vi claims to record peak 5G speed of 3.7 gbps during trials in Pune

Debt-ridden telecom operator Vodafone Idea on Sunday claimed to have recorded a peak speed of 3.7 gigabit per second (gbps), highest by any operator in India, during 5G trials in Pune.

The company also claimed to have recorded 1.5 gbps download speed in the midband spectrum in Gandhinagar and Pune.
Vi (Vodafone Idea) has

been allocated high-frequency bands like 26 gigahertz (Ghz) by the Department of Telecommunications (DoT), along with the traditional 3.5 GHz spectrum band, for 5G network trials.

"In Pune city, Vi has deployed its 5G trial in a lab set-up of an end-to-end captive network of Cloud Core, new generation Transport and Radio Access Network.

"In this trial, Vi has achieved a peak speed in excess of 3.7 Gbps with very low latency on the mmWave (millimetre wave) spectrum band," Vi said in the statement.

The DoT had approved applications of Reliance Jio, Bharti Airtel and Vodafone in May, and MTNL later. The permission has been granted for six-month trials with telecom gear makers Ericsson, Nokia, Samsung and C-DOT.

Decision to correct inverted duty structure to cut tax burden of leather industry: CLE

The decision of the GST Council to correct inverted duty structure on leather footwear from January 1, 2022. would help reduce tax burden of the sector and boost domestic manufacturing of manmade fibre (MMF) fabrics and gar-

ments, CLE said on Sunday. Council for Leather Exports (CLE) Chairman Sanjay Leekha said GST (goods and services tax) on leather footwear worth less than ₹1,000 is 5 per cent and over that value, the tax is 18 per cent, but the GST on inputs for these footwears ranges up to 18 per

"We have suggested rationalisation of the tax on these footwears," he said.

The GST Council in its meeting on September 17 agreed to correct inverted duty structure on footwear and textiles from January 1, 2022.

He said that the inverted duty structure has been an issue with the industry and that the Council had made recommendations to the government for the elimination of this anomaly that has been resulting in input tax credit accumulation blocking crucial working capital for businesses. It creates a tax structure

where the rate on inputs is

higher than that on the outputs

and this increases the effective

rate of taxation of the sector.

Govt receiving max FDI proposals in 3 depts from nations sharing land border with India

New Delhi: The Government has received maximum foreign direct investment (FDI) proposals in three departments electronics and IT, industry and internal trade, and heavy industries -- from countries sharing land border with India, an official said.

In April 2020, the Government had made its prior approval mandatory for foreign investments from countries that share land border with India to curb opportunistic takeovers of domestic firms following the Covid-19 pandem-

Countries which share land borders with India are China, Bangladesh, Pakistan, Bhutan, Nepal, Myanmar and Afghanistan. As per that decision, FDI proposals from these countries need government approval for investments in India in any sector.

The major sectors under which these FDI proposals mainly came included manufacturing of heavy machinery, automobile, auto components; computer software and hardware; trading, ecommerce, and manufacturing of light engineering and electrical, the official said.

Besides, these three departments, the ministry of new and renewable energy and department of pharmaceuticals have also received several proposals from these countries, the official added. **PTI** | for the first time on Thursday.

President Joe Biden revealed last week a new alliance including Australia and Britain that would deliver an Australian fleet of at least eight nuclear-powered sub-

Morrison blamed the switch on a deteriorating strategic environment in the Indo-Pacific. He has not specifically referred to China"s massive military buildup, which has gained pace in recent years.

"The capability that the Attack class submarines were going to provide was not what Australia needed to protect our sovereign interests,"



Morrison said.

They would have had every reason to know that we have deep and grave concerns that the capability being delivered by the Attack class submarine was not going to meet our strategic interests and we have made very clear that we would be making a decision based on our strategic national interest," he added, referring to the French government.

KABUL: Witnesses say an explosion targeted a Taliban vehicle in the provincial city of Jalalabad, the second such deadly blast in as many days in an Islamic State stronghold.

The Taliban and IS extremists are enemies, and fought each other even before the Taliban seized control of Afghanistan last month.

Witnesses say Sunday's blast targeted a vehicle of the border police, which is now run by the Taliban. Initial reports said five people were killed, including two civilians, among them a child. The Taliban were not immediately available for comment about possible casualties among their ranks.

Female employees in the Kabul city government have been told to stay home, with work only allowed for those who cannot be replaced by men, the interim mayor of Afghanistan's capital said Sunday, detailing the latest restrictions on women by the new Taliban rulers.

The decision to prevent most female city workers from returning to their jobs is another sign that the Taliban, who overran Kabul last month, are enforcing their harsh interpretation of Islam despite initial promises by some that they would be tolerant and



In their previous rule in the 1990s, the Taliban had barred girls and women from schools, obs and public life.

In recent days, the new Taliban government issued several decrees rolling back the rights of girls and women. It told female middle- and high school students that they could not return to school for the time being, while boys in those grades resumed studies this

Female university students were informed that studies would take place in gender-segregated settings from now on, and that they must abide by a strict Islamic dress code. Under the U.S.-backed government deposed by the Taliban, university studies had been co-ed, for the most part.

On Friday, the Taliban shut down the Women's Affairs Ministry, replacing it with a ministry for the ``propagation of virtue and the prevention of vice`` and tasked with enforcing Islamic law.

On Sunday, just over a dozen women staged a protest outside the ministry, holding up signs calling for the participation of women in public life. `A society in which women are not active is (sic) dead society,'' one sign read.

The protest lasted for about 10 minutes. After a short verbal confrontation with a man, the women got into cars and left, as Taliban in two cars observed from nearby. Over the past months, Taliban fighters had broken up several women's protests by force.

Trailblazing tourist trip to orbit ends with splashdown

 $F^{our\ space\ tourists\ safely}_{ended\ their\ trailblasing\ trip}$ to orbit Saturday with a splashdown in the Atlantic off the Florida coast.

Their SpaceX capsule parachuted into the ocean just before sunset, not far from where their chartered flight began three days earlier.

The all-amateur crew was the first to circle the world without a professional astro-

The billionaire who paid undisclosed millions for the trip and his three guests wanted to show that ordinary people could blast into orbit by

themselves, and SpaceX founder Elon Musk took them on as the company's first rocket-riding tourists. 'Your mission has shown

the world that space is for all of us," SpaceX Mission Control

"It was a heck of a ride for us ... Just getting started," replied trip sponsor Jared Isaacman, referring to the growing number of private flights on the horizon.

SpaceX's fully automated Dragon capsule reached an unusually high altitude of 363 miles (585 kilometers) after Wednesday night's liftoff. Surpassing the International Space Station by 100 miles (160 kilometers), the passengers savoured views of Earth through a big bubble-shaped window added to the top of the capsule.

The four streaked back through the atmosphere early

Saturday evening, the first space travellers to end their flight in the Atlantic since Apollo 9 in 1969. SpaceX's two previous crew splashdowns — carrying astronauts for NASA - were in the Gulf of Mexico.

Within a few minutes, a pair of SpaceX boats pulled up alongside the bobbing capsule. When the hatch was opened on the recovery ship, health care worker Hayley Arceneaux was the first one out, flashing a big

smile and thumbs up.
All appeared well and

happy.
Their families were waiting near the scene of Wednesday night's launch from NASA's Kennedy Space Center.

This time, NASA was little more than an encouraging bystander, its only tie being the Kennedy launch pad once used for the Apollo moonshots and shuttle crews, but now leased by SpaceX.

The restructured electoral process guarantees a vast majority of the Elections Committee will be largely pro-Beijing candidates, who are likely to choose a chief executive and nearly half of lawmakers who are aligned with the ruling Chinese Communist Party."Today's Election Committee elections are very meaningful as it is the first elections held after we have improved the electoral system to ensure that only patriots can take office," Hong Kong leader Carrie Lam said.

Vladimir Putin's party set to retain parliamentary majority after polls

President Vladimir Putin's party was set to retain a majority in parliament as Russia Sunday concluded a three-day election in which most Kremlin critics were barred from running.

The vote comes in the wake of an unprecedented crackdown on the opposition this year, with Russian authorities jailing Putin's best-known domestic foe Alexei Navalny and banning his organisations as "extremist". In the lead-up to this week-

end's vote, all of his top allies were arrested or had fled the country, with anyone associated with his groups kept from running in the parliamentary and local polls scheduled to close at 8:00 pm Sunday across 11 time zones.

"These essentially aren't elections. People in effect have no choice," 43-year-old businessman Vladimir Zakharov told AFP in Russia's second city Saint Petersburg.

Radical Pak cleric booked after Taliban flags hoisted at women's seminary

Dakistan police have registered a case against a prominent radical cleric and several others after the flags of the Afghan Taliban were found hoisted on the top of a women's seminary here run by him, according to a media report on

The white flags of the Afghan Taliban were spotted on the rooftop of the Jamia Hafsa, a women's madrasa in the capital, on Saturday, Dawn newspaper reported. After receiving information, the district administration

sent a police contingent, including an anti-riot unit, which cordoned off the seminary. A case was registered against Maulana Abdul Aziz who is the cleric of the famous Lal Masjid (Red Mosque) -- his collaborators as well as seminary students under the Anti-Terrorism Act (ATA) and different sections of the Pakistan Penal Code (PPC), the report said.

Officers of the capital administration said Aziz openly threatened the police, who arrived at the seminary to remove the flags, with dire consequences by using the name of the Afghan Taliban. Some people affiliated with the seminary, including

Aziz, also displayed weapons.

The seminary students and teachers also challenged the police and taunted them with remarks, sparking tension in the area. "Area cleared, flags commissioner

removed, case registered," the deputy Islamabad wrote on his Twitter handle. This was the third time since August 21 the Afghan Taliban flags were hoisted on the seminary. Earlier, at least five white flags were found installed on the rooftop of the seminary. (Whenever I protested and tried to lift myself from my inferiorities, I realised the smallest attempts to uplift myself... were a step in the direction of elevating and inspiring the entire

The Hindi poet, who was intri-cately linked to the New Poetry Movement of the 20th century, was born in the pre-independent India's Faizabad. The poet would have turned 94 yesterday. Often called the 'meditative poet' for his deep rumination on the present with regard to myth and history, Kunwar Narayan is highly regarded for his poetry that is a unique amalgamation of the simple and the complex.

His intellectual calibre was par excellence, clearly evident from the fact that he translated works of French symbologists like Mallarme, Valery, and poets like Cavafy, Borges.

Not many of modern Indian readers would know this but the seminal writer was an ardent traveller who also met high dignitaries like Pablo Neruda, Nazim Hikmet Ran, and Anton Slonimskie on his first trip to Europe, China and Russia in 1955 itself. He is read widely and is famous for blending an international modern sensibility with a deep grounding in Indian history, thought and tradition.

Narayan, thus, won numerous prestigious awards in his lifetime like the Sahitya Akademi Award, Jnanpith award in 2005 and the Padma Bhushan in 2009, and so many more. The writer was internationally recognised as he won the Warsaw University's honorary medal, Italy's Premio Feronia, et al.

The litterateur, who studied English Literature at Lucknow University, has a *nazaqat* and *nafasat* that can be spotted in his writings, very native to Lucknow. He wrote for almost six decades and his poems are



(From dot to dot, if he ran in a straight line, the psace would seem split into two clear halves...). He conveys that, ultimately, we start from one point, which is

our own perception. However, when we move ahead in life, cross the line, and see other perspectives, we begin to understand the other side and find ourselves in

absolutely new places and circumstances. There are certain crossroads, but there is an idea that lies between what is right and what is wrong, too. Mithya lies in between satya (truth) and asatya (untruth), Narayan cogitated in the poem.

Kunwar Narayan's son Apurva Narayan translated numerous poems of his into English. Apurva's book of translations No Other World was published from India and England. A Cambridge University alumni, Apurva's personal interest is in literature, too.

His poems embody a rare purity and a profound humanism. In a section titled *Humanesque*, by Apurva, is highlighted the poem When One Can't Remain Human. Therein, the poet writes about the limits of being human, 'If times are bad, one can't remain human. Yet

all he aspires to is to become a human being. A master of philosophical poems, Narayan ventured the realm of universal thought. In the

his personal limitations as a human being. It is not surprising to learn that one of his major themes is about becoming human. In his popular poem Falcon, he describes the falcon who has a God-like view, who analyses how futile human activities are. and how insecure humans are even while living out of danger, on the still ground, unlike the falcon.

Since his first book in 1956, his personal qualities that of nobility gentle nature, are reflected in his characters. His oeuvre spans across various genres - stories, criticism, translations, jottings and writings on cinema and art, essays, poetry, and epic

There can be witnessed a healthy outlook towards love in his poetry. The poet used vivid, simple, and emotional imagery, and figures of speech. He also made natural use of *Khadi boli* in his writings. He was fond of exploring the absurd, and touching upon intimate details in his work.

What characterises Narayan's poetry is the graceful and delicate balance between thought and language, structure and content; his fluent words render meaning to abstract ideas. His themes also engulf social reality. In poems like Ayodhya, he reality. In poems like *Ayodhya*, he wrote of the city of Ayodhya that he knew very well, having spent some part of his precious childhood there and witnessing the Hindu-Muslim riots in 1992. 'O Rama! Life is a bitter fact and you are an epic,' he expressed. Narayan shared about places like Kafka's Prague and Krakow places like *Kafka's Prague*, and *Krakow Zoo*. In *Nalanda* and *Bakhtiyar*, he mentioned the tyrant and conqueror who destroyed the renowned Buddhist centre of learning.

very summer, Jetun Bibi, who is $70\,$ years-old, and several other peo-ple migrate from Kalakote tehsil, Rajouri district of Jammu to the higher altitude pasturelands of Sonamarg, Ganderbal district of Kashmir, which is at 8,960 feet.

"Chettiar and Deghani villages in Kalakote tehsil are home to about 50 families from the Gujjar-Bakarwal community. Every year, in March, we start our trek towards Sonamarg along with our livestock. We carry our belongings and pass through the Pir Panjal range while making several stops en route. Around late October, we start returning to the plains," Jetun said.

While seasonal migration is the lifestyle of such nomadic tribes, these six months are a difficult time for the community as it affects their develop-

community as it affects their development. They live in pasturelands without basic amenities. During the monsoon, they take shelter under trees in the forest or tarpaulins/polythene. They face threats from wild animals. Moreover, staying away from populated regions means that their children will not get any education. They face the challenges of a low literacy rate, lack of livelihood options due to limited skills and knowledge, poor sanitation, vulnerable weather conditions, low social and economic status. affecting the nomadic tribes residing in the remote regions of Jammu and Kashmir

increased in the last 19 months due to the pandemic.

Whatever their children could avail from seasonal/ mobile schools is no longer accessible. Without smartphones or access to the internet at higher altitudes, they are unable to attend online classes. According to census-2011, up to 1.5 million Gujjars and Bakarwals live in Jammu, Kashmir, and Ladakh. Most of them are deprived of basic facilities.

Dwindling livelihood



depend on pastoral farming and smallscale agriculture, they earn by selling leather, wool, meat, and dairy products. However, due to Covid protocols, these communities have been struggling to survive. They hardly manage to sell As these nomadic tribes largely their animals at a lower price. The

nationwide lockdown has affected their traditional businesses. Now, they are more prone to food deprivation and other essential commodities.

During these dire times, some welfare organisations in the union territo-

nomadic populations. Poonch-based Sarimastan Tribal Gurjar Welfare Foundation, which works for the welfare of the Gujjar Bakarwal tribe in Jammu and Kashmir, supported them during the lockdown. "We made every effort to provide rations and medicine to these people. Our volunteers travelled several kilometres on foot to reach their camps," Asad Nomani, the president of the organisation, expressed.

The pandemic has affected each member of the Gujjar and Bakarwal communities equally. According to Asad, the government authorities have extended immense support to provide relief to the people of the community. For those unwilling to visit hospitals or Covid care centres, 'corona care' kits were distributed door to door. Although the health department made efforts to conduct tests, distribute Covid relief hampers and create awareness about the virus, they had to face strong resistance from the tribe.

Challenges in establishing vaccine

While the vaccination drive has been launched in every nook and corner of the country, reaching out to the nomads residing in the higher altitude of Jammu and Kashmir is difficult. So, conducting tests and establishing vaccination centres is quite challenging. It is also not feasible for them to travel long distances for tests or vaccination at the health centres. On the other hand, vaccine hesitancy among the tribal population has exacerbated the problem.

"For vaccination, when we reached Murrah, a remote area in Surankote tehsil of Poonch, the women started running away. They believed that the vaccine would lead to death within two years or might cause infertility. The unmarried girls feared they would never conceive after the vaccination," Dr Nusrat Bajad, who is currently serving at a primary health centre in Chandimarh in Poonch, shared.

She shared that the healthcare workers were attacked and intimidated by the locals when they tried to address their concerns. Under such dire circumstances, it gets difficult to persuade young girls and women for vaccination. "All these problems occur due to lack of awareness among tribal people, especially women," Dr Bajad added.

It is important to safeguard these nomadic tribes from the outbreak of Covid-19. One cannot be sure that they have access to various government programmes such as immunisation drives and other development plans. It is important to make the vaccination centres available to them at higher altitudes. -Čharkha Features





The study states that MPs found in water, sediment and biota from the Sal estuary are dominated by fibres (55.3 per

suggests a variety of sources of MPs, including domestic sewage, effluents from industries and laundry

The research also found transparent spherical beads in the water of the river along with sediments containing polypropylene, polyamide, polyacrylamide and polymers.

The most commonly found MPs were plastics which were black in colour that may have come due to abrasion of tyres on the road surfaces as regular wear and tear.

Enduring a forgettable outing in the first half of this year's IPL, two-time former champions Kolkata Knight Riders would look for reversal of fortunes when they resume their campaign against Royal Challengers Bangalore in the second phase of T20 league here on Monday.

While Virat Kohli's RCB is third in the eight-team standings with 10 points from seven games, 2012 and 2014 champions KKR are languishing at the seventh spot with just two wins out of seven ties.

And Eoin Morgan-led KKR would be hoping to make a turnaround, just like 2014 edition when they won nine games in a row to claim the title.

KKR chief mentor David Hussey also exuded optimism about scripting a turnaround, despite a nightmarish first half.

"All we have to do is win this ... We have done it before and so we can do it again... I feel we have the squad to do it also. You qualify for the finals and whole competition starts again," the Australian said.

But it would be easier said than done for KKR as they face RCB, a formidable outfit, whose captain Kohli would be gunning for success with the bat after announcing his decision to quit as India's T20 skipper following the T20 World Cup which will be held after the IPL in UAE.

Even though KKR leads in head-tohead record against RCB, winning 18 and losing 13 out of 28 fixtures played between the two sides, the 38-run defeat against Kohli's team in the first half of the event in Chennai would be fresh on their players' minds. KKR's two wins earlier this year came against two under-performing sides — Punjab Kings, who are placed just a rung above them, and bottom-placed Sunrisers Hvderabad.

KKR would be relying heavily on the pair of Subhman Gill and Nitin


