

Ukraine war dominates Modi-Biden discussion

Prime Minister Narendra Modi and US President Joe Biden in a virtual meeting on Monday agreed that the US and India will continue to hold close consultation on how to deal with the situation arising out of the Russia-Ukraine war.

Biden said India and the US share a strong and growing major defence partnership and hailed India's "humanitarian support" towards the people of war-ravaged Ukraine. On his part, PM Modi said as the world's two largest and oldest democracies, the two countries are natural partners.

"Our talks today are taking place at a time when the situation in Ukraine remains very worrying," Modi said, adding that India hopes that ongoing talks between Russia and Ukraine will pave way for

peace Modi said India has appealed to Russia and Ukraine to have direct talks between the

Enunciating India's stand in the ongoing conflict, Modi told Biden, "I have spoken with Presidents of both Ukraine and Russia over the



Presidents of the two countries telephone, several times. I not only appealed to them for peace but also suggested President Putin to hold direct talks with the Ukrainian President. Detailed discussions were held over Ukraine, in our Parliament."

The two leaders, who met in person in Washington last year for the Quad heads of State summit, will meet again on May 24 in Japan this year.

Pakistan Parliament on Monday elected unopposed Shehbaz Sharif as 23rd Prime Minister of the country, bringing to an end the political uncertainty that had gripped the nation since a no-confidence motion was introduced against his predecessor Imran Khan on March 8.

Shehbaz in his inaugural speech on Monday raised the issue of abrogation of Article 370 in Kashmir and alleged that the people in the Valley were bleeding and Pakistan will provide them with "diplomatic and moral support" besides raising the matter at every international fora.

Shehbaz, 70, was the only candidate left in the race after former Foreign Minister Shah Mahmood Qureshi announced that his Pakistan Tehreek-e-Insaf party will boycott the voting and staged a walkout.



Tomar meets Railway Minister Vaishnav

Pradyuman Singh Tomar called on Union Railway Minister Ashwini Vaishnav and Civil Aviation Minister Jyotiraditya Scindia in New Delhi. He urged Vaishnav to provide at least 12.5 rakes per day for the supply of coal for thermal power plants operating in Madhya Pradesh. Scindia also requested the Railway Minister to take necessary

action in this regard.

Energy Minister Tomar said that the thermal power plants in the state have a generation capacity of 4570 MW. For these 26 days coal storage requirement is fixed. He told the Union Railway Minister Vaishnav that sufficient coal is available with the coal companies, but due to shortage of railway rakes for transportation, adequate lifting is not being done. For transportation of

coal in Madhya Pradesh,

12.5 rakes are required per day, whereas at present only 8.6 rakes are available. Due to shortage of rakes, 15 thousand 600 metric tonnes less coal is being received per day. The Congress has convened a L meeting of its general secretaries and in-charges on Tuesday to work out the modalities for the Chintan Shivir, which could either be held in Rajasthan or Chhattisgarh. The senior leaders of the

party will meet the general secretaries for the coordination of the much talked about conclave likely later this month to decide the future course of the grand old party which has been failing to prove in successive elections since the 2014 general elec-

tions After the party's drubbing in the recent assembly elections in five states, top Congress leaders will soon meet at a 'Chintan Shivir' to deliberate on measures

for reviving the organisation at the grassroots level and address fresh challenges.

Both, the Rajasthan Chief Minister Ashok Gehlot and his Chhattisgarh counterpart Bhupesh Baghel have offered to host the conclave in their respective states. AICC sources said the party leadership may finally settle for Jaipur because of its proximity to Delhi.

During the last meeting of the Congress Working Committee, when the party leadership faced fresh demands for organisational overhaul in the wake of defeat in five states, it was decided that the party will hold another CWC meet after the Parliament session and finalise details of the Chintan Shivir.

The CWC had said that the recent results in assembly elections are a "cause of serious concern" for the party.

The brainstorming session at conclave will chalk out a strategy for course correction to reverse the trend of electoral defeats as the party is now in power in only two states of Rajasthan and Chhattisgarh and is part of the ruling coalition in Maharashtra and Jharkhand. The continous tussle

between the old guard and the younger generation has also taken a toll and the issue is likely to be discussed.

Several leaders have suggested immediate corrective measures to revamp and restrengthen the organisation at all levels. Congress chief Sonia Gandhi also held several meet-

ings with party leaders in the past few days, including those of the G23 who have been critical of the leadership and have demanded organisational overhaul.

On Monday, Rahul urged all Indians to stand together to secure a just and inclusive India, saying hate and violence are weakening the country. The Congress leader also spoke about his conversation with a Dalit youth who had tried to commit suicide after violence against Dalits in Una in Gujarat. Citing the conversation, he reportedly said, "If **BJP's attack came** after communal

my sister had been assaulted I would have stabbed and killed her tormentor before dying," he added.

Speaking to newspersons, BJP's national spokesperson Sambit Patra described Rahul a "chunavi Hindu" and alleged that he pretends to be a Hindu. The BJP leader thereafter went on asking if Rahul does not believe in reincarnation, then how can he believe in Ram.

Patra said the purported conversation of Rahul (with dalit) showed that the Congress leader has faith neither in the Constitution nor in the judiciary, he said.

On violence in a number of states during Ram Navami processions, he said it is natural that such incidents will happen when senior leaders like Rahul and Thackeray make remarks linked to their "appeasement"

On Rahul claiming that he had no interest in power despite being born in its midst, the BJP spokesperson said these remarks are aimed at

politics.

"provoking" people and "ques-tioning" Ram's existence underline his desperation. The "family" can go to any

electoral benefits. Patra also condemned Thackeray for his jibe at the BJP that what issue the ruling party would have raised if Lord Ram was not born. Opposition leaders can find thousands of reasons to attack the BJP but this is "petty politics", he said.



elecom regulator Trai on Monday recommended a 35 per cent cut in the reserve price for prime 5G spectrum requencies in 3300-3670 MHz oand, at ₹ 317 crore per MHz.

Releasing its much-awaited recommendations, Trai said that all available spectrum in the existing bands of 700 MHz, 800 MHz, 900 MHz, 1800 MHz, 2100 MHz, 2300 MHz, 2500 MHz and the new spectrum bands of 600 MHz, 3300-3670 MHz and 24.25-28.5 GHz, will be put to auction.

"To provide flexibility to the telecom service providers, block size of 10 MHz for 3300-3670 MHz band and 50 MHz for 24.25-28.5 GHz band recommended. Spectrum to be assigned in a contiguous manner," Trai said in a statement. In all, the reserve price

across various bands works out to be nearly 39 per cent lower than that suggested last time, sources said. For the prime 5G

frequency of 3300-3670 MHz band, all-India reserve price adds up to Rs 317 crore per MHz, which is over 35 per cent lower than the Rs 492 crore/MHz suggested by Trai last time. The base price for coveted 700 Mhz band works out to be Rs 3,927 crore per Mhz, which is 40 per cent lower than that proposed last time. The Telecom Regulatory Authority of India (Trai) said that for the long-term growth and sustainability of the telecom sector, infusing liquidity and encouraging investment, the telecom service providers should be allowed easy pay-

ment options, including part payment with flexibility of moratorium. The spectrum auctions are slated to be conducted in 2022, to facilitate the rollout of 5G

mobile services within 2022-23, by private telecom providers. The next generation 5G will usher in ultra highspeeds and spawn new-age services and business models.

Lambasting the opposition parties for "finding politics in every small incident" the Chief Minister said "some people have developed a habit of raising a hue and cry over every small incident like they are doing in the case of Nadia where a minor was allegedly gang-raped... but who would say whether she was raped or whether she was pregnant or whether she had been slapped by someone or things like that

while the incident happened last Monday and the girl died next day why was it reported on Saturday when she had already been cremated ... and why no postmortem was done ... why are these questions raised when all evidences are gone ... is it because you can create theories ... still we have arrested the person named in the FIR?

Banerjee also claimed quoting the police that she had information that the victim had an affair with the accused and "the police cannot do anything if you fall in love because this is not Hathras."

Curiously, the girl was not only not taken to a hospital and no postmortem was done after

her death but also she was cremated without any death certificate. The Opposition parties immediately hit back recalling

how the Chief Minister had made similar insensitive statement after the Park Street rape case when about a decade ago when she called it a state-managed drama and her party colleagues it an affair between a "service provider and her client."

Bengal Pradesh Congress president Adhir Chowdhury immediately hit back wondering why the Chief Minister was defending the rapists. "Is Mamata Banerjee the advocate of the rapists ... is she trying to save them as they are from the TMC ... it has already been proved in Bengal that all crime is linked to TMC and all theft is done in her name ... she is the crown of the thieves and the empress of all the thieves."

The incident took place last Monday in the Shyamnagar locality of Gagna panchayat of Hanshkhali block in Nadia district when the girl was invited to a party --- at the house of the accused. She was allegedly drugged and then gang-raped by her tormentors.

On why the family did not call up the police or why they would not visit a hospital, locals who raised a hullabaloo after coming to know about the incident, said the perpetrators of the crime had warned them

against doing so. "They told the family that they were free to call a doctor but should not go to a hospital or call the police or else the whole family would be burnt alive ... so the petrified kin refrained from taking to a hospital," said a local adding that they gathered courage to lodge a police complaint after an NGO supported them.

Meanwhile, even as the State witnessed protests at various places more gang-rapes were reported from Kakdwip in South 24 Parganas and Raiganj in North 24 Parganas sources said.

Arms, drug haul: ED attaches ₹3.59 cr assets of 4 Lankan nationals

 $T_{(ED)}^{he Enforcement Directorate}$ attached properties worth Rs 3.59 crore including six landed properties 12 vehicles, cash and bank deposits belonging to four accused in a money laundering case related to seizure of drugs and arms from Sri Lankan nationals in a boat of that country. This apart, the ED has also arrested two accused persons on money laundering charges for allegedly operating 'unions' on "PP Poker Online Gaming App" and placing ille-gal bets and gambling on the same platform.

On March 18, 2021, the Indian Coast Guard intercepted one Sri Lankan fishing boat named 'Ravihansi' near Minicoy Island, Lakshadweep within the territorial waters of India

On rummaging the boat, it was found that the boat was carrying a huge quantity of contraband articles (300.323 kilograms Heroin) along with five assault rifles and one thousand ammunitions of 9 mm calibre.

Subsequently NIA, Kochi took over the investigation and registered an FIR and filed a charge sheet against Sri Lankan nationals and others. The properties of Suresh Raj A, Satkunam alias Sabeshan,

Ramesh A and Soundararajan alias Sounder have been attached under Prevention of Money Laundering Act.

The ED initiated a money laundering investigation on the basis of FIR registered by the NIA.

The probe also revealed that the sale proceeds of the said drugs was intended to be used purchasing the next confor signment of drugs and also for revival of proscribed terrorist organization LTTE, the ED said in a statement. Investigation further

revealed that Suresh and Satkunam were involved in similar crime earlier with the active support of Ramesh and Soundarajan.

Through these activities, the accused allegedly siphoned huge money through secret networks, causing loss to the Government exchequer.

Meanwhile, Hardeep Singh and Ankur alias Rahul Khanna, the accused in the drugs and arms cae, were produced before the Special Court, PMLA, Mapusa and the court granted 8-day ED custody.

Investigation by ED revealed that Singh and Khanna, are operating twothree Unions namely, Checkraise, Mini-India and Russian Poker on PP Poker Online Gaming App.

Left alone?

Faced with a shrinking footprint, the Left Front is trying to reinvent itself

s it the beginning of the last hurrah for the famous symbol of Soviet-Chinese communism in India? The reference is to the All India Forward Bloc — a constituent of India's Left Front — deciding to remove the hammer and sickle from its party flag. The party founded by Subhas Chandra Bose inserted the communist symbol in the flag in 1948. Till then, it was a red flag with the image of a leaping tiger. Its National Council admitted that people noticed the symbol and mistook it for a communist party rather than a socialist party. The propaganda may have blocked the Bloc's growth as an independent socialist party, the Council felt. The decision is a silent acknowledgement of a growing realization within the Left that the basic character of the Indian working class has changed, thanks to technology and personal aspirations of the capitalist kind. The Bloc's decision is perhaps the inevitable result of the Left's introspection as it licks the political wound of its near-decimation electorally in 2019. The Left Front, which won 59 seats in 2004, was reduced to 12 in 2014 and just five in 2019. It was wiped out from West Bengal and Tripura for the first time. It barely managed to survive in Kerala. With a vote share of barely seven



per cent, it is no surprise that the Left Front is talking about course-correction. The dismal performance in 2019 led CPI general secretary Sudhakar Reddy to call for a merger of the two biggest Left parties - the CPM and CPI. The Front faces marginalisation and reunification is the alternative, he said.

The merger idea was first voiced in 1986, but there is an edge of desperation to it now. Two Front constituents, Forward Bloc and Revolutionary Socialist Party, are already part of the Congress-led UDF in Kerala. The CPM, which resists the merger idea, is jettisoning communism, at least in Kerala

where Nava Keralam, the new doctrine of Chief Minister Pinarayi Vijayan, talks about wooing investors and private capital and disciplining trade unions. So, where did the Left go wrong? Was it the loyalty to the Soviet Union or China that it could not convince the Indian masses about? Was it the lack of a meeting point between the imported communist doctrine and the Indian socio-cultural reality? Did it get caught between a classless utopia and caste-influenced realism? Some say the Left united people by raising fundamental issues but failed to convince them about its ideological position. Now, it is distanced from imported communism and faces an uproariously nationalist right-wing onslaught. The Left has its relevance but has to reinvent itself - not as a doctrinal platform — as one to lead the lower class aspirations against the vagaries of caste, patriarchy, social inequalities and the cold capitalist order. A practical Left is in the making already, if the inclusion of a Dalit in the CPM politburo for the first time ever is anything to go by.



Stalin's TN is in a league of its own?

Going by his arbitrary demands list to the Centre, it seems that MK Stalin doesn't consider Tamil Nadu to be part of the Indian Union

amil Nadu Chief Minister MK Stalin was in New Delhi last week for shopping, making friends and influencing people. Fresh after holidaying in petro-rich West Asian countries, Stalin carried a shopping list in the form of a memorandum to the Prime Minister. The Thalapathi (Tamil for Commander) wanted the Centre to provide essential commodities and life-saving drugs to Sri Lankan Tamils, who have been severely hit by an economic crisis. He also wanted the Modi administration to ensure political and civil rights to Eelam Tamils.

The retrieval of Katchachatheev islet, which was handed over to Sri Lanka by former Prime Minister Indira Gandhi, also figures in the memorandum. The islet's transfer saw the international maritime boundary between the countries undergo a change. The treaty had stipulated that Indian fishermen could use Katchachatheev to take rest and dry their fishing nets. But Tamil Nadu fishermen started misusing the islet by fishing (bottom trawling) which made the Sri Lankan fishers furious.

Stalin's demand that the Centre provide free medical and food aid to Tamils in north and northeast Sri Lanka brought back memories of Operation Poomalai (Flower Garland in Tamil). On June 4, 1987, a fleet of the IAF's AN-31 military transport aircraft airdropped food and medicines in the Jaffna peninsula, much to the anguish of Sri Lanka. Tormented by terrorism unleashed by the Liberation Tigers of Tamil Eelam (LTTE), Sri Lanka's defence forces had laid siege to Jaffna peninsu-la, the stronghold of LTTE. Colombo had declared a total blockade over Jaffna to flush out the terrorists. Then Prime Minister Rajiv Gandhi ordered Operation Poomalai to mark India's solidarity with the island nation's Tamil population. The Sri Lankan Government accused India of violating its sovereignty. The incident exposed India's links with LTTE, which was out to disintegrate the island nation. The relations between New Delhi and Colombo plunged to an abyss and old mutual trust is yet to be telling the Madras High Court



restored. Is the Tamil Nadu leader on a mission to make the Centre undertake another misadventure?

When the LTTE took control of Elephant Pass, the narrow route that links mainland Sri Lanka to Jaffna, the Indian Government didn't do anything to help Colombo. A Sri Lankan presidential aide had told this reporter that at all critical moments, it was either Pakistan or China that offered military hardware free of cost to the island nation.

The DMK's dream project of a separate Dravidian Nation incorporating Tamil Nadu, the north and northeast of Sri Lanka is still on agenda. If more southern States join the DMK, it would make Stalin happy. Though the Katchachatheev islet was ceded to Sri Lanka in 1976, neither the DMK nor M Karunanidhi, the party's president till he breathed his last in 2017, spoke against it. It was Jayalalithaa who approached the Supreme Court in 2011 to challenge the Centre's decision and, not to be left behind, Karunanidhi too filed a petition. Mukul Rohatgi, then attorney general of India, told then Chief Justice RM Lodha on August 26, 2014, that Katchachatheev could be that there was no instance of Tamil Nadu fishermen getting arrested by Sri Lankan Navy from the Indian side of the maritime boundary.

These two instances prove the fallacy of the DMK's politics over Sri Lanka issues. Members of the Sri Lankan defence forces are not allowed in Indian defence establishments in Tamil Nadu. Cadets and officers from Sri Lankan Army, Navy or Air Force are not welcome in elite establishments like Officers Training Academy, Chennai, Flight Instructors Training Institute at Tambaram and the Defence Services Staff College, Wellington. The brotherhood among the uniformed fraternity has taken a beating because of the policies being pursued by regional forces like DMK and AIADMK. "The forces-to-forces ties are a must for mutual security and safety," said Captain Hariharan Balakrishnan of the Indian Navy.

The DMK's insistence that the Union Government should go ahead with the construction of the Sethusamudram Shipping Channel through Palk Bay itself was enmeshed in mysteries. Only ships with 25,000 Dead Weight Tonnage ed only in super carriers with 1.5 lakh tonne DWT or more. Ships with 25,000 DWT could be used only for gun-running and drug trafficking, according to veteran mariners.

Yet another demand by Stalin was for doing away with the National Eligibility Cum Entrance Test (NEET) for admission to undergraduate and postgraduate courses in medical and dental colleges in Tamil Nadu. The NEET was introduced by the Supreme Court's Constitution Bench following the decision of the UPA Government in which the DMK was the second largest constituent. Nobody has bothered to ask Stalin what is so unique about Tamil Nadu that the State be excluded from the ambit of NEET?

Is the DMK trying to convert Tamil Nadu into a Kashmir of South? It has asked the Prime Minister not to accord approval for Karnataka's proposal to build the Mekedatu dam deep inside that State across the Cauvery. Tamil Nadu also wants the Centre to not heed Kerala's wish to build a new dam in place of the 126-year-old Mullaperiyar Dam. If the existing dam bursts, 35 lakh people across five southern districts of Kerala would perish.

tion of party members, is yet to imbibe this advice. There is no need to search for an answer to the party's stagnation. The CPM, which ruled three States at one stage, is now confined only to Kerala. Even its Kerala success can be attributed to the absence of a strong Congress leadership in the State. The political resolution introduced and discussed threadbare at the party congress is proof of its failure to make inroads into India's hinterland. The party commissars have failed to identify the root cause of the CPM's rot. While they lament about the growth and consolidation of "Hindutva Fascist forces" in the country, the leadership is clueless

about means of preventing it. Allegations like communal-corporate nexus, imperialism, "legalising political corruption" and "imposing full-fledged authoritarianism" have lost their sheen.

It is time the comrades approached the people with a concrete action plan to defeat the "communal" elements. While the party welcomes an alliance featuring Left, secular, democratic and socialist forces to take on the "communal" party, it is silent on the role of the Congress in such an arrangement. No political force in India is capable of taking the BJP by the horns without the help of the 'grand old party'. If the CPM is sincere in its efforts to defeat the BJP, it should forge an alliance under the leadership of the Congress. The INC is the only political party in the country which has not aligned even once with the so-called Hindutva forces. The Congress might have lost a few polls since 2014 but that is no proof of the party's weakness. If there is one political entity in the country with a pan-India presence, it is only the Congress. The CPM, which has declared that it would "go to any extent" and "shake hands with even the devil" to forge an alliance against the BJP, should judge the ground reality well before venturing out to fight the "communal" BJP.

A GLORIOUS CHAPTER FOR US JUDICIARY

Sir — With the elevation of Justice Ketanji Brown Jackson as the first black woman justice of the Supreme Court, the US has added a significant chapter. It is touted to be a bold and positive step not only towards realising the country's ideals but also diversifying the court. She will be sworn in when Justice Stephan G Breyer retires this summer. By nominating her, President Joe Biden has fulfilled his vow to bring in a black woman at the helm. At a time when the US is beset by racial bias, lack of diversity and under-representation in courts, it marks a significant departure from established norms.

There have been only two black judges in the Supreme Court so far. Jackson also becomes only the sixth woman to become a Supreme Court judge, making it the most gender inclusive Bench in the top court's history. 

FIRSTCOLUMN **CAUSES OF SRI LANKAN ECONOMIC CRISIS**

The island nation needs an export-oriented approach for revival

C ri Lanka is facing its worst economic crisis since its independence. It is in dire need of foreign exchange reserves to repay the past debt and import essential goods. There is a state of chaos with power cuts extending upto 12 hours, a shortage of essentials in hospitals, a lack of paper to conduct school examinations, and no fuel at gas stations. From 1983 to 2009 the 25 years of civil war in Sri Lanka caused a massive impact on its foreign exchange reserve. The war was predicted to have cost \$00 billion which is nearly five times as much as the Sri Lankan GDP (2009). The shortage of foreign exchange reserves in the country is due to the short-sightedness of the ruling Government. Sri Lanka has a huge public debt of about 110 per cent of its GDP. The Sri Lankan rupee has gone to a record low value against the US dollar. This is due to large tax cuts



by the government, which affected government revenues and fiscal policies. To cover the deficit in the budget the government started to print more money, which further increased its inflation rate from 15.1 per cent to 18.7 per cent. Sri Lankan rupee was 299.95 vs US dollar on April 5, 2022. Experts conclude that the country's higher imports of essential goods (sugar, pulses, cereals, and pharmaceuticals) are one of the reasons for the falling foreign exchange reserve. In 2019 the then newly-formed government promised to revive the growth of the Sri Lankan economy and reduce Value Added Tax (VAT) on the ground that a lesser tax rate would attract more consumer expenditure which would pay the incurred deficit to them. But the pandemic disturbed the cycle of increasing consumption expendi-ture and led to a failure of tax cuts in VAT.

This caused a severe reduction in govern-ment revenue. In April 2021, in order to revive the falling foreign exchange reserve, President Gota-baya Rajapaksa announced a complete shift to organic farming banning all chemical and inorganic fertilizers. A part of the nation's economy is spent on importing chemi-cal fertilizers. Instead, it caused a negative effect on the economy, causing huge eco-nomic losses. The decision toshift organic farming in the coming decade was a good idea but the overnight shift impacted negatively. Transforming the production of tea and other agricultural products to organic farming led to lower yields that resulted in a loss of \$425 million. Sri Lanka which was self-sufficient in rice production ended up importing rice within six months. Tea was a major item of export which contributed 16.57 per cent of total export income, but no longer. Negative effects on the economy, continuous protests and rising food prices made the government reverse its decision in November 2021. The Easter Sunday bombings in 2019 and the Covid pandemic led to a downturn in tourism that accounts for 12.9 per cent of GDP. The sector didnot show any signs of recovery till November 2021, when the government removed the quarantine meas-ures for vaccinated visitors. The war between Russia and Ukraine further accelerated the weakening economyas 25 per cent of the tourists come from Russia and Ukraine. Sri Lanka is also facing a labour shortage. In 2018, Malik Fernando, head of the industry body of the Tourism Skills Committee said the country needs 100,000 more tourism sector employees within the next three years. At present, Sri Lanka has \$2.3 billion foreign reserves. This is insufficient to pay for-eign debt obligations of 7\$ billion and the International Sovereign Bond (ISB) payment of \$1 billion for 2022. The World Bank, however, hopes the economy will revive although there will be many challenges.

GST: Should States' compensation stay?

ess than three months from now June 30, 2022 will be an important milestone under the national Goods and Services Tax (GST) regime that was launched on July 1, 2017.

In the follow-up to The Constitution (One Hundred and First Amendment) Act, 2016, that introduced the GST, the Union Government had also introduced The GST Compensation Act, 2017. It provides for compensation to the States for five years (2017-18 to 2021-22) for the loss of revenue to be calculated as the difference between their actual collection (including transfer of their share in indirect tax collected by the Centre) and the amount they would have got with annual growth at 14 percent over the 2015-16 level under the erstwhile dispensation (Central Excise Duty (CED)/service tax/sales tax/Value Added Tax (VAT) plus other local taxes).

To discharge this obligation, the Centre also passed an amendment to the GST Compensation Act (2018) to levy a cess on the so-called demerit goods (those which fall in the highest tax slab of 28 per cent - other slabs being five per-cent, 12 per cent and 18 percent besides the exempt category) such as automobiles, tobacco, drinks and so on with a proviso to use the proceeds for compensating States. The cess was to remain in force for a period of five years in sync with the commitment to compensate States for that period.

The rationale behind keeping these arrangements in place for five years was that at the end of this transition, i.e., June 30, 2022, the GST dispensation would have acquired the much-needed "vitality" and "resilience" to yield sufficient resources for the States to meet their budgetary requirements within a prudential limit set under the Fiscal Responsibility and Budget Management Act (FRBM) thereby obviating the need for any extra support beyond this deadline.

Even as this deadline is few months away, States have been pestering the Central Government to continue the compensation for five years(earlier they had made a similar request to the 15th Finance Commission). The grounds on which their demand is based are: (i) they continue to face shortfall in tax revenue and (ii) COVID - pandemic has severely impacted their revenue - both their own well as tr

At the beginning of FY 2019-20 thus, there was a surplus of about ₹47,500 crore (21,450+26,000) in the cess pool. During 2019-20, the shortfall was ₹165,000 crore against which the cess proceeds were ₹95,000 crore.This resulted in a deficit of ₹70,000 crore. Even after using surplus from the previous two years, the unmet deficit carried forward to the next year was ₹22,500 crore. During FY 2020-21, the short-

fall in tax revenue zoomed to ₹300,000 crore; courtesy, the devastating effect of Covid pandemic on economic activity and resultant dip in tax collection of both the States and the centre. Against this, cess proceeds were only ₹65,000 crore (a plunge of almost 40 percent over the previous year), leading to an unmet deficit of ₹235,000 crore. To make up for this gap as also the unmet deficit of 2019-20, the Centre, in consul-tation with Reserve Bank of India (RBI) set up a special window for-borrowings at "low" rate of interest and transfer the funds to states as back-to-back loans. Under this crore w

the 'special window' for transfer to not cut ice as 2021-22 being almost the States. This takes the total borrowings to ₹320,000 crore which could increase further to accommodate any mismatch during April - June, 2022.

In view of above, even though as per the extant law, the compensation arrangement has to end on June 30, 2022, it will have to continue if only to service this loan. In turn, this requires that the cess on demerit products will have to continue till such time all loanrelated liabilities are fully extinguished. This will require further amendment to the GST Compensation Act (2018) to provide for levy of the cess for the extended period.

While, this part has been agreed upon (in fact, this is 'builtinto' the arrangement for borrowings under the 'special window'), the States want that compensation should continue for another five years to 'make up for the shortfall in tax revenue that they woud face during this period, i.e., upto June 30, 2027'. This is an abhorrent proposition.

free from the COVID (thanks to a mammoth vaccination covering almost all age-groups) has been exceptionally well in terms of GST collections which are expected to touch a record ₹1500,000 crore. From hereon, both the Centre and the States should look forward to better the performance; hence no need for support.

But, even during 2021-22, the States faced shortfall of ₹150,000 crore which the Centre is compensating. This is baffling. It may have to do with the formula for determining the shortfall. Under it, the target revenue (TR) is arrived t by applying annual growth at 14 percent over the 2015-16 level of tax revenue under the erstwhile dispensation. TR gets unduly inflated due to (i) the base itself being high (that regime was characterized by high tax rate); (ii) compounding effect of the percentage growth which is maximum in the fifth year (for instance,@14 percent, ₹100will become ₹193).

The aberration of 2021-22 should not be allowed to obliter-The raison detre behind giving ate the view of the Union governfuture. Put simply, having already been under the new regime for five years (albeit with support) and tax collections under GST - both by the Centre and States - improving and the economy expected to gain momentum in the coming years, there is no justification to continue with the compensation.

allopolyploid) species.In allopolyploid plants, multiple homoeologs (pairs of genes produced by speciation and recombined by allopolyploidization within the same genome) independently contribute to the phenotype. Induced random mutagenesis performed by irradiation or treatment with chemicals to create random mutations produces only plants with a single mutation in one or another homoeologs. It is doubtful that a double mutation will occur in a particular region of the genome. Time-consuming mating and backcrossing procedures require combining different mutations into one genotype. SDN can target multiple gene copies or gene variants (such as alleles) simultaneously. This is especially useful for polyploids. SDNs can also be specially

designed to target specific nucleases to individual alleles.

Site-Directed Nuclease techniques are of three types, SDN-1, SDN-2 and SDN-3. Out of these SDN-1 and 2 don't contain any trace of foreign DNA. However, in SDN-3 foreign DNA may be present. To alter market-oriented traits, site-specific nucleases (SDNs)are increasing rapidly.SDN has expanded the potential for researchers and breeders worldwide to alter the genome of a target organism in very difficult or impossible ways achievable with traditional breeding techniques. Conventional breeding relies primarily on the crossing and selecting offspring with the desired characteristics, sometimes combined with induced non-targeted mutations.

Russia said on Monday that it destroyed air defense systems in Ukraine over the weekend, in what appeared to be a renewed push to gain air superiority and take out weapons Kyiv has described as crucial ahead of a broad new offensive in the east.

Moscow's initial invasion stalled on several fronts as it met with stiff resistance from Ukrainian forces, who prevented the Russians from taking the capital and other cities.

The failure to win full control of Ukraine's skies has hampered Moscow's ability to provide air cover for troops on the ground, limiting their advances and likely exposing them to greater losses.

Russian Defense Ministry spokesman Maj. Gen. Igor Konashenkov said the military used cruise missiles to destroy four S-300 air defense missile launchers on the southern outskirts of the central city of Dnipro. He said about 25 Ukrainian troops were also hit



AP JALALABAD (AFGHANISTAN)

Basheer was a young Taliban fighter bare-bly out of his teens when the Islamic State group took over his village in eastern Afghanistan, nearly eight years ago. The militants rounded up villagers identified as Taliban and killed them, often beheading them, forcing their families to watch. Basheer escaped and lived in hiding during the following years when IS controlled several districts in Nangarhar province. Over time, he rose in the Taliban ranks.

Now known as Engineer Basheer, he is the Taliban intelligence chief in eastern Afghanistan, with a leading role in the campaign to crush IS. He hasn't forgotten the atrocities he saw in his home district of Kot. "I can't explain their cruelty in words, whatever comes into your mind, they have done more than that," he told The Associated Press in a recent interview at his headquarters in Jalalabad, the capital of Nangarhar.

Since coming to power in Afghanistan eight months ago, the Taliban have touted their success in repressing the Islamic State group, but the militants have expanded into neighbouring Pakistan, stepping up attacks there. Analysts say IS has morphed into a borderless terrorist group, one of the



deadliest in a region that has spawned many violent, radical organisations.

In northwest Pakistan, the impact is brutally clear. The remains of an IS suicide bomber are still visible on the once ornate walls of a mosque, weeks after he blew himself up, killing more than 60 worshippers as they prayed. IS identified the bomber as an Afghan from Kabul.

The March 4 bombing at the Kusha Kisaldar Shiite mosque in the old city of Peshawar stunned Pakistanis, deepening their fear of the resurgence of terror attacks

in their country, after a steady decline in the past decade.

The rise in attacks began last year and is accelerating, said Amir Rana, executive director of the Pakistan Institute of Peace Studies, an independent think tank that monitors militant activity in Pakistan.

By late March this year, Pakistan had seen 52 attacks by militants, compared to 35 in the same period last year, according to the institute's data. The attacks have also gotten deadlier. So far this year in Pakistan, 155 people have been killed in such attacks, compared to 68 last year.

The worst have been claimed by a ruthless Islamic State affiliate, known Islamic State in Khorasan Province or IS-K. Meanwhile, IS attacks appear to have declined in Afghanistan. IS-K first emerged in 2014 in eastern Afghanistan. By 2019, it held significant territory in Nangarhar province and had pushed into neighboring Kunar province. The U.S. Military waged a massive air campaign against it, including targeting a suspected IS hideout with America's largest conventional bomb, known as the "mother of all bombs."

But IS survived, and it presented the greatest security challenge to the Taliban when they seized power in Afghanistan last August.



Israel troops kill Palestinian in French duel: Macron vs Le Pen fight for presidency West Bank, fourth in 24 hours

sraeli forces have shot and killed a Palestinian man near the city of Bethlehem in the occupied West Bank, the Palestinian health ministry said early Monday, the latest in a growing wave of violence that has erupted during the Islamic holy month of Ramadan.

The Israeli military said it opened fire at a man throwing a firebomb at an Israeli vehicle driving on a West Bank highway late on Sunday.

The shooting raised to four the number of Palestinians killed in the past 24 hours, among them an unarmed woman who was shot and killed at a military checkpoint near Bethlehem.

Ramadan this year converges with major Jewish and Christian holidays. Protests and clashes in Jerusalem during Ramadan last year boiled over into an 11-day war between Israel and Gaza militants.

Israel has stepped up its military activity in the West Bank after Palestinian assailants killed 14 Israelis in four deadly attacks inside Israel in recent weeks.

At the same time, it has taken a series of steps to try to calm the situation, including granting thousands of



Palestinians from the Hamasrun Gaza Strip permits to work inside Israel.

Palestinian health officials identified the man killed in the latest shooting on Sunday as 21-year-old Muhammad Ali Ahmed Ghoneim.

The official Palestinian news agency Wafa reported that Mohammed Zakarna, 17, died on Monday after he was wounded by Israeli fire in the West Bank city of Jenin a day earlier

Israeli forces patrolled Jenin, considered a stronghold of Palestinian militants, on Sunday as soldiers investigated the home of an attacker who killed three Israelis in a mass shooting last week. The army

Macron met with area residents, many of whom criticized his proposed pension changes which include raising the minimum retirement age from 62 to 65. Denain's mayor, Anne-Lise Dufour-Tonini, told reporters she will vote for Macron 'with no hesitation" in the second round, but intends to push for him to adopt more "leftist proposals.

On her third attempt to become France's first woman president, Le Pen was rewarded Sunday for her years-long effort to rebrand herself as more pragmatic and less extreme. Macron has accused Le Pen of pushing a dangerous manifesto of racist, ruinous policies.

Sebi comes with new guidelines to evaluate risk value of gold, gold-related instruments

New Delhi: Sebi on Monday came out with a new framework for evaluating risk level of commodities -- gold and goldrelated instruments -- in which mutual funds are permitted to invest on risk-o-meter.

In a circular, the markets regulator said it has been decided that investment in such commodities by the mutual fund schemes will be assigned a risk score corresponding to the annualized volatility of the price of such commodities.

The annualized volatility will be computed quarterly based on past 15 years' prices of benchmark index of a commodity and risk score for such commodity will be categorized in four levels ranging from "moderate" to "very high", Sebi said in a circular.

Mumbai: India's domestic air passenger traffic is estimated to have grown by around 59 per cent year-on-year to 84 million in FY22, although it is still about 40 per cent lower as compared to the pre-pandemic level, credit ratings agency Icra said on Monday.

It also expects elevated Aviation Turbine Fuel (ATF) prices, aggravated by geo-political issues, to remain a near-term challenge for the indus-try and will be a key determinant of profitability for the sector.

On a sequential basis, domestic passenger traffic spiked about 37 per cent to 10.6 million in March, driven by a near to normalcy in airline operations owing to waning of impact of the pandemic, Icra said.

The passenger traffic on local air routes was 7.7 million in February 2022, it added.

Traffic growth in March this year stood at 35 per cent as compared to over 7.8 million in the year-ago month, it said.

Airlines' capacity deployment for March 2022 registered a growth of 12 per cent at 80,217 departures as compared to over 71,548 depar-tures clocked in the same month of last year, ICRA said.

Domestic departures logged 42 per cent growth in March this year over the previous month, driven by increased pace of vaccination and rapid abatement of the third wave of COVID-19, which allowed for quick lifting of travel restrictions, the ratings agency said. "Domestic passenger traffic for FY2022 is

estimated at around 84 million, y-o-y growth of 59 per cent, marginally higher than our estimate of 80-82 million, although it is around 40 per cent lower than pre-COVID levels," Vice



President and Sector Head of Icra Suprio Banerjee said.

For March this year, the average daily departures were at around 2,588, higher than the average daily departures of around 2,308 in March 2021, and notably higher compared to around 2,023 in February 2022, he said

The average number of passengers per flight during March this year was at 132, against an average of 135 passengers per flight in February, Banerjee said.

According to Icra, one major positive devel opment is resumption of scheduled international operations from March 27 after a hiatus of almost two years.

ATF prices have surged by around 93 per cent year-on-year in April this year, given the elevated crude oil prices, geo-political issues arising from Russian-Ukraine war, the ratings agency said. The rising ATF prices continue to play a spoilsport for the industry and will pose a serious threat to the sector's earnings in FY23 it said.



Industrial mishaps on rise


Workers at construction sites, crowded warehouses, manufacturing plants, and metalworking plants use a variety of tools and machinery to complete their tasks. These machines, ranging from table saws and nail guns to forklifts and compactors, help workers complete a variety of tasks more quickly, efficiently, and safely when used properly. However, if employees are not properly trained, fail to follow necessary safety precautions, or machine malfunctions can result in serious injuries, and in the worst-case scenario, the injuries can be fatal.

According to the Geneva-based IndustriALL Global Union, which signifies more than 50 million workers in 140 countries in the mining, energy, and manufacturing sectors, seven accidents per month in 2021 will result in permanent disabilities and severe injuries. Last year, more than 162 workers died in industrial accidents in India, highlighting the recent rise in the number of accidents in industrial and commercial establishments.

Factory accidents are quite common in Delhi/NCR. Workers' limbs getting caught in the machines are unfortunately common, causing people to lose limbs and may even be fatal in some cases. Amputation of a bodily part, such as a finger, toe, hand, foot, arm, or leg, can be a life-changing trauma that impacts the capacity to move, work, socialise, and maintain independence. Persistent pain, phantom limb sensation, and psychological and emotional stress may all impede recovery. Limb-salvage surgeries in such **Workplaces** cases are complicated and require clin-

Workplaces should focus on preventing hazardous situations rather than performing band-aid fixes every time one occurs cushed limb which involves fixing broken bones, and repairing injured blood vessels and muscles, tendons and nerves. The fundamental goal of a limb salvage surgery is to preserve sensation, viability, and function and minimise disability. A combination of orthopaedic, plastic, and reconstructive surgeries is required.

One occurs tive surgeries is required. A similar case of an Industry accident was brought at Manipal Hospital, Gurugram where a 34year-old industry worker's right forearm was caught up in a machine at a factory in Gurugram. It was a case of near-total amputation of the forearm with an open fracture of both forearm bones along with damaged radial and ulnar arteries and all extensor and flexor tendons cut. A team of doctors from orthopaedic and plastic & reconstructive departments performed an 8-hour surgery wherein they fixed the bone fractures and repaired the arteries, veins, tendons, nerves and covered the skin loss raw areas with skin grafting. Timely intervention and treatment saved his limb from amputation.

he World Parkinson's Day

is observed on April 11 every year to disseminate information about the health condition and understand the disease better. Parkinson's Disease (PD) or also called Parkinson's is a progressive ner-vous system disorder that affects movement. Currently, it afflicts more than 10 million people worldwide. India is home to nearly 0.58 million persons living with PD as estimated in 2016, with an expected major increase in prevalence in the coming years. This is expected to cause enormous strain on the economy as well as the already overburdened healthcare services in the country.

The PD symptoms usually emerge slowly, and as the disease rsens, non-motor become more common. Presently, there is no cure for this neuro-generative disease, but one should not lose their heart as with proper care, few changes in the lifestyle and medicines, it can be managed well and progression can be slowed down, says Dr M V Padma Srivastava, Chief, Neurosciences Centre, AIIMS, Delhi Talking to The Pioneer Health, she said that since PD majorly impacts those above 60 years old and given that the life expectancy is on increase, the disease is projected to affect over 12 million people by 2040.

or become impaired, they produce less dopamine, which causes the movement problems of PD. Various researches are going on to know what causes cells that produce dopamine to die, she adds.

There's more. People with PD also lose the nerve endings that produce norepinephrine, the main chemical messenger of the sympathetic nervous system, which controls many functions of the body, such as heart rate and blood pressure. The loss of norepinephrine might help explain some of the non-movement features of Parkinson's, such as fatigue, irregular blood pressure, decreased movement of food through the digestive tract, and sudden drop in blood pressure when a person stands up from a sitting or lying-

you are speaking more softly. Or masked faces are some of the major signs."

Also, PD can change the way a person walks. One may experience motor symptoms like freezing and trouble balancing. So if one sees more than two signs, it's time to consult the doctor.

Dr Srivastava says that like any other disease, management of PD is very similar — like exercise, disciplined lifestyle, healthy diet and stress free life. Like we know exercise is an important part of healthy living for all, but for people with PD exercise and diet are like medicine, help them live a fuller maintain and improve mobility, flexibility, strength and gait speed. It is advised that people with PD should perform exercises 45 minutes to one hour after medications

A fter the recent incidence of Hollywood actor Bruce Willis being diagnosed with a medical ailment called Aphasia Disorder, and deciding to step away from his acting profession, the disorder has taken the netizens by a storm.

This is a disorder involving the specific area of the brain's cognitive functions to diminish, causing partial speech/language impairment. People usually tend to lose track of what they want to say, form complete sentences, or unintentionally utter irrelevant words, resulting in gibberish. Due to their jumbled statements, such people also have difficulty in understanding others or have trouble comprehending others.

Aphasia is a cognitive condition that affects a person's ability to comprehend language and express themselves verbally and in writing. This is caused by disorders that damage the brain's language centres (or their connections), which is normally the left side of the brain in the dominant hemisphere.

What causes aphasia?

The condition is caused due to an injury, trauma or any other medical condition that damages one or more areas in the brain. While it is a known fact that stroke is one of the most common and prevalent reasons for brain injury, where a clot, ruptured blood vessels cut off the blood supply to the part of the brain, leading to loss of brain cells. Other causes of brain injury include severe head injuries, brain tumours, gunshot wounds, brain infections, and degenerative neurological diseases like Alzheimer's disease.

What are the red flags?

The red flags of Aphasia disorder includes when a person speaks in short, jumbled or respond with incomplete sentences, which is difficult for the responder to understand. Apart from speech impairment, patients may also face complications in writing sentences and relevant words, and usually end up drafting something that doesn't make sense and that too in the wrong order. In such conditions, the patient should seek immediate medical consultation to prevent further brain damage or

future complications.

These surgeries can be complicated and require a lot of precision and experience because repairing the bones and injured blood vessels during the critical period is a race against time. Not only was this patient's forearm saved from amputation but he also regained useful functioning and hopefully should be able to return to work soon.

But with timely intervention and clinical expertise, these cases can be addressed, and the limb and livelihood of these injured workers can be saved. We also hope factory owners take measures to make workplaces a safe space for their workers. These injuries also result in loss of wages, exorbitant med-

These injuries also result in loss of wages, exorbitant medical bills, and pain and suffering. Many of these workers are the sole breadwinners of their families, loss of a limb can mean loss of livelihood. This can affect the mental health of the worker and their families. Stress responses can develop over time, and some workers may require additional support. After the first debriefing session, perspectives may shift, and additional sessions may be required to focus on new aspects of the incident or stress reactions.

Critical incidents are also known to bring up a variety of personal issues for workers. To avoid further difficulties, short-term counselling may be required. Where counselling sessions reveal additional or more complex needs, it may be necessary to refer a worker to an appropriate service for additional assistance.

Workplaces should focus on preventing hazardous situations rather than performing band-aid fixes every time one occurs. Preventing workplace accidents by providing thorough training to all new employees, regardless of experience can help. Even if it takes a little longer for workers to start generating work, they will be protected from harm.

She says that symptoms start gradually, sometimes starting with a barely noticeable tremor in just one hand. Tremors are common, but the disorder also commonly causes stiffness or slowing of movement.

In a nutshell, there are over 40 symptoms, from tremors and pain to anxiety and every individual's experience is different.

"Tremor in hands, arms, legs, jaw or head, small handwriting, loss of smell, trouble sleeping, dizziness or fainting, stooping or hunching over, trouble moving or walking, constipation, a soft or low voice. For instance, sometimes you might think other people are losing their hearing, when really when they are at their best.

Surgery to place microelectrodes for deep brain stimulation (DBS) has been used to reduce motor symptoms in severe cases where drugs are ineffective, says Dr Srivastava.

She also suggested the patients of PD try building a few hobbies into their routine that will give them a break from dwelling on the disease. Or find some activities to keep themselves busy. On our part as a society, she said, it's time people start discussion to demystify and humanize the disease. More the people understand the PD, the more dignified the people with Parkinson's will feel, she concluded. Is it treatable? In patients with Aphasia Disorder, the treatment is determined by the underlying cause of the problem. For instance, in those with a history of stroke attack, brain infection, or dementia, patients need to be investigated for the root cause and get the right treatment, and speech treatment benefits the patients greatly.

Good speech therapy and neuro rehab treatment are critical in all cases of aphasia recovery. Children and young adults have a better chance than adults at fully recovering. In persons suffering with aphasia, prompt identification, early intervention, and proper medical management, combined with good post-treatment counselling, can help to reduce damage and improve recovery possibilities.

◆TB eradication has been talked about for years. Why can't we tackle it yet?

There are two things that need to be enhanced. First, stigma is still playing a huge part as a hindrance to TB eradication. If we have to address this, the health system alone can't be held responsible. Second, in order to eliminate the disease, we have to involve many departments – at the district and panchayat levels. Earlier, this was not the case. Now, the stakeholders are thinking of joining hands.

Why are we always dependent on the Governments to solve our problems?

It is not as if people are not going for TB treatment. It may be another thing that they may go to a quack or a private hospital for their treatment. The TB tests are free of cost. The problem arises when the patients end up going to a quack and there are wrong diagnoses. This delays the treatment.

Historically, TB patients were kept outside the villages or in sanatoriums. This is still ingrained in the minds of people and is hampering proper

•Are we lacking in creating awareness about TB?

It entails people's participation, people's involvement when it comes to TB eradication. Everyone needs to be involved – irrespective of whether the person is a patient or caregiver or a neighbour. In other words, it has to be a people's movement rather than a health department's.

Take polio for example. Each and every member of the society was involved from the health departments across the country to even Rotary Clubs and Asha workers. Everyone was involved and came together to help each other. This is what we need for TB elimination.

INBRIEF IHW Council holds its 2nd Diabetes in Pregnancy summit

Doctors, healthcare experts, and noted diabetologists stressed on the fact that Gestational Diabetes Mellitus, a form of diabetes occurring during pregnancy in women, poses a major health problem in India.

They took part at the Integrated Health and Wellbeing Council's 2nd virtual edition of Diabetes in Pregnancy Summit. The e-summit was hosted by the IHW Council supported by Asian Research and Training Institute for Skill Transfer (ARTIST for Her).

Celebrated diabetologist Prof (Dr) V Seshiah, who, way back in the 1970s, first coined the concept of Spot Test for pregnant women, meaning, any pregnant woman coming to the hospital at any stage of pregnancy, fasting or non-fasting, should be subject to a blood sugar test, says, "We have reached a point where the diabetes can be termed as an epidemic. It is estimated that by 2045, 783 million people around the world will have diabetes, a whopping 54 per cent increase from 463 million in 2019. Currently, every one in seven adults living in India have diabetes. The ever-increasing prevalence of diabetes points to the fact that every pregnant woman must be screened when she is hospitalised."

A frantic 11 minutes early in the second half saw Levante score one penalty in the 52nd minute through Jose Luis Morales before missing a second in the 55th, this time Roger Marti stepping up, only to be denied by Marc-Andre ter Stegen. Pedri came off the bench in

the 56th minute and three minutes later Barcelona equalised, Pierre-Emerick Aubameyang heading in Ousmane Dembele's cross to score his 10th goal for his new club.

Xavi's side have a game in hand over Real Madrid, Sevilla and Atletico Madrid, with Atletico three points behind in fourth after losing on Saturday away at Mallorca.

Pedri scored a brilliant winner against Sevilla last weekend and while the midfielder was initially rested against Levante, Barcelona were transformed after he came on.

Chelsea face 'incredibly high' challenge to stay in CL: Tuchel AP MADRID

helsea manager Thomas Tuchel said his team need Ca "fantastic script" to overturn a two-goal deficit against Real Madrid on Tuesday and qualify for the Champions League semi-finals.

Reigning European champions Chelsea have been destabilised by the enforced sale of the club after the British government sanctioned owner Roman Abramovich for his close links to Russian President Vladimir Putin following the invasion of Ukraine.

Chelsea's 3-1 defeat in the first leg at Stamford Bridge last week followed a surprise 4-1 home defeat to Brentford in the Premier League, although Chelsea got back on track with a 6-0 thrashing of Southampton this weekend.

"It is one of the biggest challenges to perform away at the Bernabeu," Tuchel said.

"It is even more difficult if you have to earn a certain result, if you need to win with a minimum of two goals or better or maybe a three-goal difference, that makes it almost impossible and very, very difficult but still it is worth trying. "We need nothing else than a fantastic script if we want

to overcome this," the German said.

"The task is incredibly high and the challenge is incredibly high given the circumstances of the first leg and where we play and against whom we play and at what stage we play this kind of match.

'It's always allowed to dream and it is sometimes important to imagine things and to dream about it but it will not shift the focus from the fact that we need to deliver and we need to be ready tomorrow."

Tuchel said he believed Chelsea face a "huge disadvantage" as 13-times European champions Real have been able to make five substitutions throughout their domestic season.

He said he believes that difference was one of the reasons his players failed to show the physical edge to their game in the first leg when Karim Benzema dominated the Chelsea defence to score his second hat-trick of this season's competition.

"We face a huge disadvantage in terms of physicality because Real Madrid has a whole year with five changes and we play the most demanding league, we play the most matches throughout the season and throughout 2022 so it is not always easy to play a physical game," Tuchel said.

"We are a team that needs the physicality, the sharpness, the commitment and the investment to be a special team. We could not implement that enough in the last match.

Five substitutions will be allowed in the Premier League from next season.

"I miss competition," the Serbian tennis star said on Sunday on the opening day of the clay-court season at the Monte Carlo Masters.


"I still feel motivation to be on the tour and compete... and try to challenge the best players in the world for the biggest titles.'

His opening match in Monaco is scheduled for Tuesday.




Manohar, who got three lives, hit five boundaries and one six in his short stay and particularly launched into T Natarajan (2/34) in the 18th over,
