India, US discuss Ukraine war fallout

Won't set any 'red line' for India on energy imports from Russia: US

India and the US discussed the ramifications of the ongoing war in Ukraine during a telephonic conversation between Secretary of State Antony Blinken and his Indian counterpart S Jaishankar late on Wednesday. The two leaders reviewed regional priorities, the worsening humanitarian situation in Ukraine and promoting a free and open Indo-Pacific.

"Just completed a useful conversation @SecBlinken. Reviewed the progress on our bilateral cooperation. Discussed developments pertaining to the Indo-Pacific, Ukraine, and the global economy," Jaishankar tweet-

"The two leaders spoke to review regional priorities, including the worsening humanitarian situation in Ukraine and our shared efforts to promote a free, open, secure, and prosperous Indo-Pacific, in

which the sovereignty and territorial integrity of all states is respected," State Department Spokesperson Ned Price said.

Meanwhile, visiting US Deputy National Security Adviser for International Economics, Daleep Singh, on Thursday said the USA will not set any "red line" for India on its energy imports from Russia but does not want to see a "rapid acceleration".

"Friends don't set red lines," Daleep Singh told reporters. As against purchase of 16 millions barrels oil in 2021, India has bought at least 13 million barrels of Russian crude oil since

Russia's invasion of Ukraine.

The discussion between Jaishankar and Blinken took place hours before Russian Foreign Minister Sergei Lavrov arrived in New Delhi to hold talks with the Indian leadership on Friday.

It is the first visit by a Russian Minister to India since the military operations began in Ukraine on February 24. India and Russia are likely to discuss issues like rupee-rouble trade and procurement of oil at discounted prices. The two sides are also likely to take stock of the ongoing weapons supply, including S-400 missile, to

Blinken wrapped up a tour of the West Asia, North Africa, and India on Wednesday, making an impassioned appeal to Algeria to limit its ties with

"The countries of North Africa and the Middle East(West Asia) have experienced themselves the consequences of Russia's military campaigns before," Blinken

India and the US have been in touch over the Russian invasion of Ukraine. The US Deputy NSA Daleep Singh arrived in India on Wednesday on a two-day visit

Hours after his arrival, Singh held talks with Commerce Minister Piyush Goyal. Singh is known to be a key architect in designing the US sanctions against Russia over its invasion of Ukraine.

The visiting US official also met Foreign Secretary Harsh Shringla on Thursday and discussed India-US economic cooperation and strategic partnership. "Look forward to working together on global issues of mutual interest, including in G20," Ministry of External Affairs Spokesperson Arindam Bagchi said.

Defiant Imran won't resign, ready to face no-trust vote

In slip of tongue, Pak PM says 'threat letter' from US to topple Govt



Adefiant Pakistan Prime Aminister Imran Khan said on Thursday that he will not resign despite losing the majority and insisted that he will play till the last ball and face the vote of no-confidence in the National Assembly on Sunday which will decide where the country will go.

In a live-address to the nation, 69-year-old Khan also discussed a 'threat letter' and termed it as part of a foreign conspiracy to remove him as he was not acceptable for following an independent foreign policy. He named the US as the country behind the threat letter in what appeared to be a slip of tongue.

Khan's address came at a critical juncture of his political career when he lost majority after defection from his Pakistan Tehreek-e-Insaf (PTI) party. Two of his allied parties also withdrew their support and joined the ranks of the Opposition.

'The nation should decide where the country should go...I always played until the

last ball. I will never resign," he said. "Those against me should have resigned...they should not have sold themselves for Calling the rebel lawmak-

ers as "traitors", Khan said that they will be branded as such for the rest of their lives as he pleaded them to come back and foil the attempt to topple his government. "I will fight against the con-

spiracy and will never let it succeed," Khan said as he vowed to face the no-trust vote in the

assembly on Sunday. His speech came hours after Deputy Speaker Qasim Suri abruptly adjourned the

National Assembly session till Sunday after Opposition lawmakers demanded an immediate vote on the no-trust motion. The resolution against the

embattled premier was tabled by Leader of the Opposition in the National Assembly Shehbaz Sharif on March 28. Khan needs 172 votes in

the lower house of 342 to foil the Opposition's bid to topple him. However, Opposition claims it has the support of 175 lawmakers and the PM should immediately resign. No Pakistani Prime

Minister has ever completed a full five-year term in office.

Also, no Prime Minister in Pakistan's history has ever been ousted through a no-confidence motion, and Khan is the third premier to face the chal-

lenge.

Khan talked at length about the "threatening letter" which he said was an official communication by Pakistan's ambassador and showed that the opposition leaders were in contact with that country as it was written before the noconfidence move

"They (officials of other country) said that if no confidence succeeds then things will be fine...but if Imran Khan remains in power, relations will deteriorate and you (Pakistan) will have to face problems," Khan said, quoting from the document.

Khan said the foreign official knew the ones who would come into power after him would have no issues taking orders from the external forces "But what is most disturbing is that our people, who are sitting here, are in contact with foreign powers," he said, as he referred to the "three stooges" — Pakistan Muslim League-Nawaz president Shehbaz Sharif, Pakistan Peoples Party co-chairman Asif Ali Zardari and Jamiat Ulema-e-Islam

UK for more robust economic, strategic, defence ties with India

Delhi, London exhort respect for territorial integrity, sovereignty

As conflict persists in Ukraine, India and Britain on Thursday called for upholding principles of sovereignty, territorial integrity and international law Britain also national law. Britain also favoured more robust economic, strategic and defence ties with India given the unstable global order.

These were the main takeaways from the talks between External Affairs Minister S Jaishankar and visiting British Foreign Secretary Elizabeth Truss. The talks took place a day before Russia's Foreign Minister Sergei Lavrov discusses the entire gamut of the Ukraine conflict and India-Russia ties with his Indian counterpart on Friday. He may also call on Prime Minister Narendra Modi.

AAP gains most in RS polls, BJP wins 5, Left 2, Cong 1

on Thursday, the AAP booked Punjab, the BJP won five, the Left two, and the Congress one. BJP's tally has now gone up to 102 in the 245-member RS.

With this, the Congress may now lose its status of Leader of Opposition by July this year, when another round of biennial elections for the Upper House will be held. The Congress lost three of its seats two from Assam and one from Himachal. The retirees include the party's deputy leader in the House, Anand Sharma, who was elected from Himachal Pradesh.

As 72 RS members retired, voting took place for three seats in Kerala, two in Assam, and one in Tripura. In Assam, with the two Congress MLAs voting in favour of the BJP, the ruling party won both the

seats. The Congress suspended its defectors from the party.

In the Rajya Sabha elections for 13 seats across six States bagged two seats and the UDF one. LDF candidates P Santosh the CPI and AA Rahim of the CPI(M) registered a comfortable victory.

The BIP has already won the lone Rajya Sabha seat from Nagaland unopposed. BJP leader S Phangnon Konyak won the seat becoming the first woman to enter the Upper House from the State. Nagaland is the only State in the country

without an Opposition.

BJP candidate Manik Saha won the lone RS seat in Tripura bagging 40 first preferential votes, Left candidate Bhanu Lal Saha got just 15 votes.

The results for two seats of Assam RS polls had to be delayed after the Congress moved the EC seeking to invalidate of votes of 5 NDA MLAs alleging they publicly revealed their ballot papers. But, the EC rejected the demand.

Govt shrinks AFSPA areas in North-East

In a major decision that will impact sentiments in the North-East, the Union Government on Wednesday areas" under the Armed Forces Special Powers Act (AFSPA) in the States of Nagaland, Assam, and Manipur. The decision will considerably reduce areas under the AFSPA effective April 1, 2022.

"In a significant step, GoI under the decisive leadership of PM Shri @NarendraModi has decided to reduce disturbed areas under Armed Forces Special Powers Act (AFSPA) in the States of Nagaland, Assam, and Manipur after decades," Home Minister Amit Shah said in a tweet.

Justifying the move, the Home Minister said the reduction in areas under AFSPA is a result of the "improved security situation and fast-tracked development due to the consistent efforts and several agree-



ments to end insurgency and bring lasting peace in North East under the leadership of Modi". The decision has been taken after decades of AFSAPA use in the North-East region which, in recent years, saw considerable normalcy with several extremist groups, including Bodo, ULFA and NSCN(IM) signing peace accords with the

Wildlife traffickers use 'air' to escape checks

Attempts to smuggle 70K exotic animals in 10 yrs, 140 seizures from airports reported

Wildlife traffickers are bla-tantly exploiting the shorter travel time and extensive reach that the aviation sector offers. A new study has revealed that in ten years since 2011, about 70,000 native and exotic animals — in many cases their body parts and derivatives like Red Sandalwoods — were attempted to be smuggled from 18 air-

Chennai airport was most frequently misused to move illegal wildlife products speedily with significantly fewer transit losses, said the report "High Flying: Insight into wildlife trafficking through India's airports" which was released recently here by the TRAFFIC India.

At least 140 wildlife seizure incidents were reported from the airports during the period. "It is the tip of the iceberg. The seizures reflect the ongoing trafficking and not an actual representation as most of the illegal wildlife trade goes unchecked and unreported," said Dr Saket Badola and Astha Gautam, authors of the study.

The report noted that all kinds of nefarious tricks were used to traffic the contrabands. "Checked luggage and personal baggage, concealment of wildlife contraband within passenger clothing, footwear, and other wearable and through the wrong declaration of protected species, all of which makes detection cumbersome for enforcement agencies were

most common tactics," it said. What was more concerning was that many of the seized species are categorised as threatened on the IUCN Red List and listed in the Convention on International



Trade in Endangered Species of Wild Fauna and Flora (CITES) Appendices.

"For instance, the Indian Star Tortoise is listed as vul-nerable on the IUCN Red List. However, traffickers clearly disregard the threatened status and international CITES rules in Appendix I prohibiting its trade as the Indian Star Tortoise was the highest number of native species seized between 2011 and 2020," said the report.

Among the species groups seized (including both Indian and exotic species), reptiles were the most encountered group during the stated period (46 per cent), followed by mammals (18 per cent), timber (13 per cent), and species from the marine environment (10 per cent). The highest number of native species seized included the Indian Star Tortoise, followed by the Black Pond Turtle Geoclemys hamiltonii while the highest number of nonnative species seized was Red-

Eared Slider Turtle, followed by

the Chinese Pond Turtle Mauremys reevesii, said the 12page report based on the analysis of the seized wildlife items in the last ten years.

Similarly, several flora species, including Agarwood Aquilaria malaccensis, Red Sanders Pterocarpus santalinus, Sandalwood Santalum album, and medicinal and aromatic plants (MAP) like Kuth Saussurea costus roots were seized at the airports.

Chennai International Airport recorded the highest number of wildlife seizure incidents, followed by Chhatrapati Shivaji International Airport, Mumbai, and Indira Gandhi Airport, New Delhi."Illegal wildlife trade through airports is a major conservation threat magnified by the growth in the airline sector. It is important for enforcement agencies to prioritize bringing an end to wildlife trafficking," said Dr Badola, who also heads TRAFFIC's India Office

Sonia alleges budget cut for rural jobs; Min says it rose to ₹1L cr

Congress president Sonia Gandhi on Thursday expressed concern about the budgetary cut for MGNREGA, saying all the State Budgets have a negative balance in their accounts to the tune of ₹5,000 crore which has led to delays in payments to workers. Sonia's contention was countered by Union Ministers Giriraj Singh and Anurag Thakur who said her assess-ment was "far from the truth".

Raising the issue during the Zero Hour, Sonia said MGN-REGA which was joked about did help the poor during Covid-19 and played a positive role. She urged the Centre to make adequate allocations to the welfare scheme and ensure payments within 15 days.

Rural Development Minister_Singh and I&B Minister Thakur hit back at Sonia, accusing her of politicising the issue and claimed that her remarks were "far from the truth".

"The issue raised by the honourable member is far from the truth. The budgetary allocation for MGNREGA in 2013-14 (UPA years) was ₹33,000 crore, whereas under Prime Minister Narendra Modi it had reached ₹1.12 lakh crore. No need to show us the mirror," Singh said. Thakur also said that dur-

ing 2013-14, a sizeable amount in the MGNREGA budget was not reaching the beneficiaries, but today beneficiaries receive the amount directly to their

UAPA Tribunal confirms Govt's J&K Police seizes 5-year ban on Zakir Naik's IRF hawala money for

the Unlawful Activities (Prevention) Act (UAPA) has confirmed the Centre's decision declaring Islamic Research Foundation (IRF) as unlawful and imposing a five-year ban on the organisation set up by fugitive Zakir Naik who is accused of inspiring Muslim youths in India and abroad to commit terror acts.

The one-member tribunal, which was constituted by the Government last year to consider whether there was sufficient cause for declaring IRF as an unlawful association, said in its order dated March 9 that there was "sufficient cause" behind the imposition of the ban on the association.

The then Delhi High Court Chief Justice D N Patel, who was the presiding officer of the tribunal, stated that he was "in full agreement" with the submissions made by Solicitor General Tushar Mehta, who appeared for the Centre, and there was material to show that IRF was indulging in unlawful

The tribunal observed that IRF involved in activities which not only incites and encourages the youth to undertake the

intent to threaten the sovereignty, unity, integrity and security of India but also causes disaffection against the country and there is every reason to conclude that the organisation be declared as an unlawful association.

The IRF was first banned under the Unlawful Activities (Prevention) Act, 1967 (37 of 1967) by the central government on November 17, 2016. The ban was extended for five years on November 15, 2021. In a notification, the Union

home ministry said the central government had constituted a tribunal consisting of Justice D N Patel, Chief Justice of the High Court of Delhi, on December 13, 2021 for adjudicating whether or not there was sufficient cause for declaring the IRF as an unlawful associ-

"Whereas, the said tribunal in exercise of the powers conferred by sub-section (3) of section 4 of the said Act (UAPA), passed an order on the March 9, 2022, confirming the declaration made in the said notification," it said.

It further said that a perusal of the evidence showed



that the "actions and conduct of Dr Zakir Naik, who is admittedly heart and soul of IRF, are prejudicial to the national interest of India".

"This tribunal is of the view that there are sufficient reasons and causes for declaring the Islamic Research Foundation as an unlawful association and consequently, this tribunal confirms the Notification dated 15.11.2021, issued by the government of India for the imposition of ban on IRF for a period of five years with effect from the date of the aforesaid notification, i.E. 15.11.2021," said the order which was published by the home ministry on March

The tribunal rejected IRF's submission that after the impo-

sition of a ban in 2016, it did not undertake any activity that is prejudicial to the national interest of the country and stated that "it appears that IRF and its office bearers have continued to indulge in unlawful activities which are detrimen-

tal to the national interest". "Upon perusal of relevant evidence submitted by central government, it is apparent that not only Dr. Zakir Naik continues to be active on social media but he also continues to propagate his activities in various Gulf countries. It can be safely stated from the perusal of the evidence, that actions and conduct of Dr. Zakir Naik, who is admittedly heart and soul of IRF, are prejudicial to the national interest of India,' the order said.

In a written statement public relations officer of the Jammu zone police headquarters said, "On the basis of a specific input that some unknown people are going to receive 'hawala' money at Jammu, several checking points were established. On suspicion police arrested one person namely Mohammad Shareef Shah (64 years) R/O Syed Pora, Larnoo, Kokernag, Anantnag, from Gandhi Nagar area and recovered 6 lacs & 90 thousand from his possession".

The police spokesman further said, "On questioning Shareef Shah disclosed that he

was tasked by Jatinder Singh @ Babu Singh, Kathua (Chairman of Nature - Mankind Friendly Global Party) to collect money from one Omer at Srinagar. After receiving money from Omer, Shareef came to Jammu and was caught". During preliminary inter-rogation Shareef disclosed

names of his local and foreign associates, Javed and Khatib residents of PoK and Faroow Khan of Torronto. Police spokesman said, "the accused Mohd. Shareef is also admin of a secret whatsapp

group having members from different places including In addition, three more persons identified as Gurdev singh R/o Jammu, Sidhant Sharma r/o Kathua and Mohd. It comprises comprehensive plans for the relationship over the next ten years and also serves as a useful instrument to actively monitor and pursue priorities.

A major step in this direction was taken last year when Prime Minister Narendra Modi and his British counterpart Boris Johnson launched the India-UK Enhanced Trade Partnership that aims to more than double bilateral trade by 2030. "I think the roadmap 2030 has progressed quite substantially. So, a lot to be done. In all of this, we have had geopolitical situations, quite apart from the Covid which had its impact earlier during the delegation-level talks with Truss," Jaishankar said.

On her part, Truss said it is a vital time in global security in the wake of Russia's illegal invasion of Ukraine. It is essential to respect the principles of sovereignty, territorial integrity, and international law.

"It is very important for the UK that we are improving our economic, security and defence relationships because we are living in a more unstable world. That's why we are strengthening our work with India," she added.

Truss also said she was

happy to visit New Delhi for the third time in a year and review the progress made on the Roadmap 2030" venture.

Jaishankar said there was a lot of work to be done and lauded the setting up of the Strategic Futures Forum. On Ukraine situation, Jaishankar said Chinese Foreign Minister Wang Yi was in India last week and the two ministers discussed the scenario in the war-afflicted

Also, he said "our own relationship (with China) is not exactly going through its best period. But the Chinese have their own analysis of what's happening in Ukraine".

He made these observa-tions at the India-UK Strategic Futures Forum. "What we saw happening in Afghanistan last summer had a very strong impact certainly in India, which wasn't the same in Europe. People didn't necessarily relate to the coming of the Taliban the same way or identify with the people affected in the same way," he said.

Speaking at the same

forum, Truss said India and the UK lead the world in areas like the number of Unicorns, the number of people involved in the tech industry. Both freedom-loving democracies will help lead the world.

Delhi aims to be EV capital of India

Kejriwal flags off electric autos; 500 women among 3,500 drivers to get livelihood

STAFF REPORTER ■ NEW DELHI

ith the aim to make Delhi the Electric Vehicle (EV) capital of the country, Delhi Chief Minister Arvind Kejriwal on Thursday flagged off electric autos at the IP Depot. The Chief Minister said that with the launch of e-auto, 3,500 drivers, including 500 women, would now have livelihoods.

"Before flagging off the autos, Kejriwal also inspected every new auto and understood what benefit the consumers would get from these. He sat in the auto of a woman driver and asked her to drive around in order to assess whether women drivers would be comfortable driving the new e-autos. He later called the woman driver to the stage and appreciated her for her driving skills in front of the occasion, Kejriwal said that for the first time, electric autos were being launched in Delhi,

Keeping the situation of pollution in Delhi in mind, we are gradually initiating a paradigm shift in vehicles from fuelbased to electric ones. In this direction, these electric autos have been introduced, which will now regularly operate throughout Delhi," said Kejriwal. "As a symbolic geswomen driving these e-autos were handed their official documents. The expression of bliss on their faces was truly heartwarming. They were extremely delighted to be receiving their papers, and the responsibility to run these autos," said the CM. "On one hand, a number of people are getting employment as a result of this initiative.

Today, a quota of some 3,000-4,000 e-auto drivers has been released. 3,500 have been issued their LoI's today, and they will now be able to operate e-autos on Delhi's roads 3,500 families will now have a livelihood, and Delhi will now have a large fleet of e-autos

available for public use," said the CM. "Within the first year of the implementation of the EV Policy, electric vehicles accounted for around 10 per cent of the total vehicle sales. This shows that there is a great amount of enthusiasm among Delhi's public regarding this revolution in the transportation sector. It also proves that our EV Policy is a noble one, and its implementation is being received well," the CM added. Elaborating on the system

of e-autos, Delhi's Transport Minister Kailash Gahlot said, "We have developed a singlewindow system and partnered with DSL for the software. The purpose of this portal is the streamlining and efficient functioning of application as well as loan issuing process - all one has to do to secure a loan is register on the portal, and all required formalities are fulfilled via this portal itself."

"A subsidy of Rs 30,000 is being provided on every e-auto by the Delhi Government and there is an additional five per cent rebate on loan rates. If one looks at our EV Policy, our goal at least one charging point is present within every three kilometre radius," said Gahlot.

'59% owners of registered EVs given subsidies'

The Delhi Transport Department said that around 59 per cent of the owners of 1,39,945 registered Electric Vehicles (EVs) in the national Capital have been provided subsidies under the Delhi Electric Vehicle Policy.

The transport department said as many as 57,796 owners of eligible EVs have not been provided subsidies due to various reasons. The department has cited three main reasons for the non-provision of subsidies that includes non-eligibility of vehicles under the Delhi Electric Vehicle Policy and the non-furnishing of proper documents by the owners.

Erosion of coastlines to hit livelihood IMD issues severe heat wave

Frequent cyclones and sea level rise besides anthropogenic activities such as construction of harbours, beach mining and building of dams are taking a toll on the country's coastline, the Government said Parliament on Thursday, indicating the livelihood threats looming large on the fisheries communities depending on resources from the sea.

The Government has cited an analysis for the period between 1990-2018, revealing that at least 33.6 per cent of the 6,632 km long coastline of mainland is under varying degree of erosion.

Dr Jitendra Singh, Union Minister of Science and Technology, said the National Center for Coastal Research (NCCR), has been monitoring the shoreline erosion since 1990 using remote sensing data and GIS mapping techniques. "Of the total 6,632 km long Indian coastline of the mainland which has been analyzed from 1990 to 2018 and it is noted that 33.6% of

while the Odisha government decided that morning classes will be held for classes 1-8 from 6.30-10.30 am from April 2. Students of classes 9-12 will attend school from 7-11.30

"During April, there will be above normal maximum temperatures over northwest and central India, whereas normal to below normal maximum temperatures are likely over the south peninsular India, eastern parts of central India and extreme southern part of northeast India,' Mrutyunjay Mohapatra, director general of IMD said while releasing forecast on Thursday. In its advisory, IMD has alerted the Power Ministry to keep a regular check on power cuts and ensure proper electricity

People have been advised to stay indoors and avoid sun exposure as much as possible as heatwave could lead to severe to moderate health concerns for vulnerable people. The Labour Ministry has also been advised to follow the

involving labourers outdoors to escape the direct exposure to the sun. To improve public safety and minimise the risk of fire incidents, the Fire Department has been suggested to be equipped and alert. Rajasthan, Madhya Pradesh, Haryana, Uttar Pradesh, Himachal Pradesh and Maharashtra are continuing to witness maximum temper-atures hovering between 39-42 degrees during the last few

The IMD declares a "heatwave" when the maximum temperature is over 40 degrees Celsius and at least 4.5 notches above normal. A "severe" heatwave is declared if the departure from normal temperature is more than 6.4 notches, according to the IMD.

On the contrary, thunderstorms will bring rains over south peninsular India, keeping a check on the maximum temperatures. The prevailing La Nina conditions are likely to continue till July or even August, according to IMD.

"I had said that when elections will be over, the prices of petrol and diesel will be rising and had asked people to fill up their tanks," he further said.

Rahul shared on Twitter etrol rates in countries in the Indian sub continent. "Petrol Rate in Indian Rupees (Rs) Afghanistan: 66.99. Pakistan: 62.38. Sri Lanka: 72.96. Bangladesh: 78.53. Bhutan: 86.28. Nepal: 97.05. India: 101.81. Don't ask questions to the 'Fakir', who shares knowledge on the camera. Loots India while carrying a bag full of 'jumlas' (rhetoric)," Rahul Gandhi said in a tweet in Hindi, using hashtag "MehangaiMuktBharat". The

former party chief said this level of price rise in petrol and diesel has been unprecedented, while accusing the govern-ment of stealing the money from the poor and handing it over to industrialists.

UP exam paper leak: Govt orders random verification

7 more arrested, cancelled exam now on April 13

While the gang involved in leakage of UP Board's English question paper of Intermediate exam is yet to be busted by the Special Task Force, the State Government on Thursday asked the district authorities to make random verification of paper bundles kept under tight security and submit their findings by

Saturday evening.
The Class 12 English examination was cancelled in 24 districts on Wednesday after the paper was leaked and Chief Minister Yogi Adityanath has ordered stringent action, including invoking the National Security Act, against the culprits.

The cancelled exam will now be held on April 13, an official statement had said.

Issuing a circular in this regard on Thursday evening, Additional Chief Secretary (Home) Awanish Kumar Awasthi said that the local authorities of all the districts, including districts magistrates, police commissioners, district police chiefs, district inspectors of school, etc should make random check of at least 20 per cent of centres in each district where question paper bundles



were kept under tight security. He said that these officials

would verify whether the seal on the bundles were not tampered with in any way and in case any suspicion arose, they would initiate immediate legal proceedings and appraise the UP Board of Higher Secondary so that they may also take necessary action.

Áwasthi also directed the officials that for each random checking, the officers should cross-verify the seals and later send a detailed report to the government by 7 pm on Saturday of the findings made

He said this measure was taken to ensure that no paper leakage could take place from now onwards besides if any discrepancies were found, timely action could be taken so that the exams were not cancelled at the last moment.

Meanwhile, seven more people, including two local journalists, were arrested on Thursday in connection with the leak of Class 12 English paper of the UP Board, police said. Deputy Superintendent of Police (Rasra) Shiv Narayan Vyas said seven more people

were arrested in connection with the case by Nagara police on Thursday.

Those arrested include two local scribes, Digvijay Singh and Manoj Gupta, he said.

The officer noted that altogether 24 people have so far been arrested in connection with the incident. Police have lodged three separate FIRs in Ballia City Kotwali, Nagara and Sikandarpur police stations on Wednesday in this regard.

Chit fund case: ED attaches assets of West Bengal-based journalist

ssets worth Rs 5 crore of a Assenior West Bengal-based Chattopadhyay, and his family members have been attached under the anti-money laundering law in connection with an alleged chit fund scam, the Enforcement Directorate (ED) said on Thursday.

The federal probe agency issued a provisional order under the Prevention of Money Laundering Act (PMLA) for attaching bank accounts and duplex flats situated in and around Kolkata.

The action pertains to the ED probe into the transactions of the ICore group of compamoney-laundering case, taking cognisance of an FIR lodged by the Central Bureau of Investigation (CBI) against the group and others.

"ÎCore group companies ran a chit fund scam and the group illegally raised a huge

amount of money from lakhs of gullible investors by promising unrealistic returns," the agency alleged in a statement.

Chattopadhyay, it said, "personally and through his company Disha Productions and Media Private Limited, has received proceeds of crime to the tune of Rs 9.83 crore from the ICore group in the guise of business investment in the company".

Apart from the ICore group, Chattopadhyay also received funds from other chit fund companies such as Saradha Group through the same modus operandi and had come under the ED scanner previously in the Saradha group case, the agency said.

Ensure drugs are not sold without prescription: Maha Minister to officials

Maharashtra Minister of State for Food & Drugs Administration Rajendra Yadravkar has said he has ordered his department's officials to crackdown on chemists selling medicines without prescription from a

Talking to PTI, he said, "The orders were given yesterreceived a complaint about sale of drugs from a local pharmacist without a formal prescription of a doctor. Such practices are against the law and should be banned."

"I have asked FDA officials to carry out searches and cross verification of sale of drugs from pharmacies in the state. The FDA will also prod drug sellers to demand prescription before selling medicines," he

There have been some cases where scheduled drugs which are not easily available and are allowed to be purchased only if prescribed by a physician, were sold across the counter at pharmacies, the minister said.

"No pharmacist was demanding prescription for such drugs. It was shocking and serious as well," the Minister said. In a shocking incident in Hapur, two brothers suffocated to death after inhaling poisonous gas and later their sister also tried to end her life in depression while in a separate incident in Barabanki, four persons, including two scribes, were killed in a road accident.

In Hapur, two real brothers died of suffocation in a room of a sheet printing factory in Pilkhuwa, a handloom town of Hapur district.

Disturbed by the information of losing both her brothers, the sister of the victims hanged herself to end her life. She was rushed to a hospital where her condition remains

Reports said that both the and 24-year-old Aslam, had gone to get sheets chemically washed in the sheet printing factory located in Mohalla New Arya Nagar of Pilkhuwa on Wednesday. When they reached the room to get the drying sheets, they fell unconscious

allegedly due to leakage of some poisonous gas. When they did not come out of the room for a long time, the other employees went to the room and saw both lying dead. The deceased were natives

of Chittauda in Garh, and were living in Shivaji Nagar of Pilkhuwa for the last 10 years. According to information

received, chemicals are used in the factory to make the colours fast on the sheets. The sheets are kept in a closed room for the colours to dry. As the door was closed. poisonous gas emanating from the films had filled the room.Police later sent the bodies for post-mortem.

Meanwhile, when the news of the death of Naved and Aslam reached their sister, she also tried to commit suicide by hanging herself. She was admitcondition. While the police are investigating the matter, DSP Pilkhua Dr Tejveer Singh said the bodies were sent for postmortem and police were making investigations to initiate legal action against the facto-

However the advisory in respect of health and hygiene protocols including wearing of mask at all times, "hand hygiene and sanitisation of public places would continue to be strictly observed until further orders."

The Government brings to an end the Disaster management Act which would no longer be invoked, lifting all curbs on political and public gatherings including wedding parties etc, government sources

The State had not witnessed corona related deaths in past several deaths and the number of infections were limited to between 40 and 42 a senior Government doctor said adding however "the people should keep a strict vigil in view of curbs on the interna-

tional flights being lifted ... and also in view of infections returning in some European and other countries including

The Government order would come into force past midnight, sources said. The last time the State Government extended the restrictions was early this month.

"It is good that all offices both Government and private would start functioning with normal strength after about two years ... but in all the offices santizers and masks would be made mandatory," a government secretary said.

Aspecial Narcotics Drugs
And Psychotropic Aand Psychotropic Substances (NDPS) Act court on Thursday granted 60 days' extension to the Narcotics Control Bureau (NCB) to file a charge-sheet in the much-discussed drug-bust case, in which Bollywood superstar Shah Rukh Khan's son Aryan Khan and others are accused.

Allowing a plea made by Special Public Prosecutor Advait Sethna citing "compelling reasons" for seeking more time to file a charge-sheet in the case, Special NDPS Judge V V Patil granted two months' additional time to file the charge-sheet in the case. Under the NDPS Act, the

NCB gets 180 days for filing a charge-sheet in a case and in the mid-sea drug bust case, involving Aryan Khan and others, the deadline for filing the charge-sheet was to expire on April 2.

On March 28, the Special Investigation Team (SIT) of the NCB had moved the NDPS Court, seeking 90 days' additional time to file the charge-sheet in the case stating among other things that it was yet to record the statements of 15 key suspects were yet to be examined for "fair and logical conclusion of the investigation".

There are in all 20 accused in the case. The NCB told the accused did not turn up for investigations resulting in an

unintentional delay.

It may be recalled that the NCB had arrested Aryan Khan, Arbaaz Merchant, Munmun Dhamecha and five others on October 3, after its officials busted a rave party and seized 13 grams of cocaine, 5 grams of MD (Mephedrone), 21 grams of Charas, 22 pills of MDMA (Ecstasy) and Rs 1.33 lakh in cash from Goa-bound Cordelia Cruises' Empress ship, off the Mumbai coast. Subsequently, the NCB arrested 12 more persons in connection with the mid-sea rave party.

In its plea filed before the special court seeking additional time to file the charge sheet, the NCB had stated: that it was yet to examine panch witness Kiran P Gosavi as it was awaiting permission to interrogate and record his statement and that some of the accused purportedly gave wrong passwords of mobile, laptops and tablets which had resulted in the delay in the extraction of data and forensic examination.

The NCP also told the court that it was trying to find out details of contacts and addresses of the two Nigerian nationals arrested in the case and that the money trail and consideration paid for purchasing drugs was underway
The NCB stated that it had completed its investigation against Mohak Jaswal, Gomit Chopra, Nupur Satija, Abdul

Kadar Shaikh, Chinedu Igwe and Okoro Uzeoma, while its investigation against others was still underway. On their defence lawyers in the case opposed the Prosecution's plea seeking an extension in time to file chargesheet, contending that the NCB's application for time

extension was an excuse to continue keeping the detained accused behind bars. They urged the court that the NCB be directed to file a chargesheet now and that it could file a supplementary charge-sheet While seeking rejection of the Prosecution's application, the defence lawyers also told the court that the NCB's application was not compelling enough to be granted

Global axis

New Delhi has emerged as the station of choice for notable world leaders

he fighting is in Ukraine, thousands of kilometres from India, but New Delhi is the destination for world leaders to rein in invader Russia. Wonder why, unless they all need to be personally reassured of India's backing to their foreign policies on certain parts of Asia, like the Indo-Pacific, that are undergoing a concern-filled rejig after Vladimir Putin's aggression. The visits are simply numerous. Japanese Prime Minister Fumio Kishida visited New Delhi to announce an increased investment target in India and ended up pitching for greater ties between the two countries for a free and open Indo-Pacific particularly when the world was "disturbed over Ukraine". His Australian counterpart Scott Morrison held a virtual meeting with Prime Minister Narendra Modi and remarked that while the QUAD was distressed over Ukraine, "our focus is very much on Indo-Pacific". China's Foreign Minister Wang Yi arrived next. India hosted him despite his unwarranted remarks on Kashmir, perhaps to send a message that it is having to deal with China's border standoff on its own and yet face pressure on Ukraine. Then comes the visit of Russian Foreign Minister Sergey Lavrov. He is probably more bothered about India's purchase of discounted Russian crude and arranging a rupee-rou-



ble payment system in view of the western sanctions. German National Security Advisor Jens Plotner, here Wednesday, said Germany understood India's challenges and saw no reason for Europe to "preach and teach" New Delhi over its position on the Ukraine issue.

He could not have been less diplomatic about India's stand on Russia, considering Germany too has an ongoing arrangement for importing Russian gas (though it is trying to cut back on it). But he put the finger on the pulse when he said Putin's logic that historically Ukraine belonged to the Soviet Union could encourage somebody as big as Russia in Asia to follow suit. As if on

cue, US Secretary of State Antony Blinken spoke with Foreign Minister S Jaishankar on, according to the latter's tweet, "developments pertaining to the Indo-Pacific, Ukraine and global economy". As members of the QUAD, the US and India, along with Japan and Australia, had met on more or less a similar agenda in early March. The conversation is to be followed by US Deputy National Security Adviser Daleep Singh to prepare ground for the '2+2' ministerial dialogue in Washington next month but his presence at this juncture has a meaning. He is the second American official, after US Under Secretary of State for Political Affairs Victoria Nuland, in this part of the world. Foreign Ministers of Austria and Greece were also in India last week. Last but not the least, British Foreign Secretary Elizabeth Truss brings a message to New Delhi about supporting the western stand on Ukraine. The diplomatic tours notwithstanding, the point remains that India's neutral stand on Russia and open sympathy for Ukraine have not diminished New Delhi's importance when it comes to the west's standpoint on the Indo-Pacific.

Sticky wicket

Imran's fate as the Pakistan PM is all but sealed but he's fighting on

ven as India becomes increasingly influential globally and a virtual hub for world leaders from across the spectrum to have a stopover here in New Delhi, the mood and situation in Islamabad grows from worse to despondent. It's barely an escape yet for Prime Minister Imran Khan after facing immense heat to resign ahead of the no-confidence vote as he has reportedly lost majority in the National Assembly. Putting up a brave face in his late-night address to the nation, however, he called it "a defining moment" for Pakistan. A squeamish Imran alleged that the "foreign hand" was



behind the act of sabotaging his Pakistan Tehreeke-Insaf Government. He also blamed the "three stooges working at the behest of foreign powers" – meaning key Opposition leaders Pakistan Muslim League (Nawaz) president Shehbaz Sharif, Pakistan People's Party chairman Bilawal Bhutto-Zardari and Pakistan Democratic Movement chief Maulana Fazlur Rehman. Accused of mismanaging the economy and foreign policy, particularly by way of damaging relations with the US, Imran indicated he won't be cowed: "I won't resign; I will play till the last ball."

The situation had started unravelling when Army chief Qamar Javed Bajwa had a difference of opinion with Imran on appointing the new chief to Pakistan's powerful spy agency, the ISI. Interestingly, Imran himself has been seen to be too cosy with the Army Generals despite his promise of ushering in a 'Naya Pakistan' that would be free of corruption and nepotism following his election win in 2018. Meanwhile, Shehbaz Sharif, whose brother and former Prime Minister Nawaz is in selfexile in the United Kingdom after being convicted in a corruption case he claims is politically motivated, is the man most favoured at the moment to become the next Premier of Pakistan. Even PPP chairman Bilawal has endorsed Shehbaz's name. Already, a few independent lawmakers as well as Imran's allies Balochistan Awami Party and the Muttahida Qaumi Movement-Pakistan have withdrawn support to Imran's Pakistan Tehreek-e-Insaf Government. Shehbaz's road map in office is to improve Pakistan's ties with the United States and the European Union, ostensibly to match and counter India's influence in these spheres. In what could possibly be a shape of things to come, he has also claimed that the otherwise ubiquitous Pakistan Army has been "staying neutral" ahead of the confi-

dence vote, which is good news for him at least for the time being.

Deuba's visit to rev up ties with India



After hitting a rough patch during Oli's tenure, there's plausible hope that Indo-Nepal relations will grow stronger for mutual development

mid the ongoing contest Abetween China and the United States on asserting their position in Nepal over Challenge Millennium Corporation (MCC) and Belt and Road Initiative (BRI), Nepalese Prime Minister Sher Bahadur Deuba is arriving in India on a three-day visit today. It will be his first visit to India since taking over as the Prime Minister in July 2021. Meanwhile, Deuba and Narendra Modi had held talks in Glasgow on the sidelines of the Climate Summit in October 2021. The meeting evoked interest as it indicated a reach-out moment between the countries.

The visit comes in the backdrop of strained India-Nepal relations in the last three years. Since July 2021, Deuba has made attempts to improve bilateral ties; in fact, a Nepali Congress delegation led by former Foreign Minister Prakash Sharan Mahat visited India in October to prepare the ground for this visit and met BJP president JP Nadda and Foreign Minister S Jaishankar. In August, Vijay Chauthiwala, the head of the BJP's foreign affairs cell, visited Nepal and held talks with Deuba, UML Chairman KP Oli and Maoist Party Chairman Prachanda, among others.

Backdrop: With the formation of a Communist Government in Nepal in 2018, the bilateral ties touched the nadir in recent history. Kalapani became the most contentious issue which ex-Prime Minister Oli chose to politicise instead of resolving it diplomatically. Oli's anti-India centric ultra-nationalist outlook proved to be a political stunt to consolidate his position vis-à-vis Prachanda, who had been demanding Oli's resignation. Meanwhile, despite India's multiple requests to resolve the border row, the Kalapani issue was used as a tool by almost all political parties to make electoral

Connectivity and Energy on Cards: Among many likely agreements and MoUs, connecand energy are high on the cards. For a landlocked Nepal, access to the third world through land and sea routes is only

through India. Nepal conducts its third-country trade through India. Meanwhile, on a few occasions, diplomatic tensions interrupted the movement of people and goods at the India-Nepal border. During the Madhesi Andolan in 2015, the border was partialclosed after protesters blocked the transit points with India. Thousands of trucks from India, laden with emergency supplies of petroleum, medicines and pulses, were stuck for months.

To ease the supply of such products, India has executed several connectivity projects with Nepal. In 2020, India successfully delivered the first cross-border petroleum pipeline with Nepal, which is one of the firsts in South Asia and stands as a role model for regional cooperation. In October 2021, the two countries signed an MoU on railway connectivity to connect Kathmandu with Raxaul. It will serve as a lifeline for Nepal's cross-border public and container transportation. Despite Oli's best efforts to tarnish India's image, the latter has continued to extend a helping hand to the Himalayan nation.

On the energy front, Nepal has rich hydropower potential. However, this sector has large

ly been ignored due to an unstable political and economic environment. For over three decades, India has been pushing to tap its hydropower potential on a mutual basis. In 1996, the countries signed an ambitious and economically viable Pancheshwar Multipurpose Project aimed at producing more than 5,000 MW. However, the project is stagnating in political indul-gences. During Modi's first visit to Nepal in 2014, the project was expected to receive a big push but India's efforts fell prey to a lack of interest from Nepal. Even after 26 years, no joint Detailed Project Report (DPR) has been prepared. For Nepal, Bhutan must serve as a fine example of benefitting from India's technical expertise in power production and encashing the end product by exporting it to India. With renewed scope for cooperation in the hydropower sector, the joint DPR may get tabled during the current visit.

Geo-Strategic Relevance: The previous Communist Government in Nepal brazenly danced to China's tunes. With Oli as the Prime Minister, China received maximum encouragement and began to openly intervene in Nepal's domestic and foreign The Chinese

Communist Party delegations to Nepal in the last three years have demonstrated their outreach. However, with Deuba at the helm, there is a clear sign of rapprochement towards India. Also, with the entry of the US through MCC in Nepal, China is realising the loss of ground. The recent visit to Nepal by Chinese Foreign Minister Wang Yi in the backdrop of the parliamentary ratification of the MCC development grant worth \$500 million by the US is clearly seen as competition to BRI and its ill-intended expansionist agenda in Nepal.

Therefore, India as an allweather development partner of Nepal and the US as an emerging one present a strong challenge to Chinese manoeuvrings.

Conclusion: PM Deuba's visit to India is a welcome step. However, despite the ongoing bilateral cooperation, developments on resolving the Kalapani issue will be looked at closely. Also, Deuba has a short stint at hand, considering the parliamentary elections by the end of this year. Yet, any progress in bilateral ties will be a clincher in future course.

India faces a tricky situation as it is the largest economy in the grouping



BIMSTEC is a complex acronym for the Bay of Bengal Multi Sectoral Technical and Economic cooperationamong 7 countries and Southeast 1. Technical and Economic cooperationamong 7 countries in South and Southeast Asia. The length of the acronym apart, a rudderless leadership in the past from seven countries which constitute BIM-STEC has ensured that it never got the clout, that regional platforms like ASEAN have. BIMSTEC held its fifth summit in Sri Lanka this week. It as a platform for economic growth, prosperity and trade for the region was conceived to be a carve out from SAARC and ASEAN, given the apprehensions, many of the participating countries have with the two blocks. Five members of SAARC and two members of ASEAN form the seven countries which constitute BIMSTEC currently. In the 25 years of existence, the summit, in Sri Lanka for the first time, tried to provide an architectural framework for BIMSTEC. It has for the first time insti-



tutionalised the future roadmap, by agreeing to have yearly foreign affairs minister's meeting and summits every two years. The member-countries are home to nearly a quarter of the human population and have nearly \$4 trillion combined GDP. They have a huge potential for growth and large market potential, as has been evidenced by nearly doubling of Bangladesh and Nepal's GDP during the period BIMSTEC has been in existence. Sadly, BIMSTEC had no role to play in this growth story because unlike ASEAN, it doesnot have a free trade agreement amongst its members. One of the issues discussed in Colombo was a quick conclusion to a free trade agreement for bringing increased prosperity to citizens. However, the legacy challenges of mistrust amongst BIMSTEC partners and the rise of non-democratic forces in national politics (Myanmar) could stall the process. The political leadership addressing BIMSTEC cooperation have to realise that pushing a free trade agreement is going to be a domestic exercise, where their own political opponents would create roadblocks.

This is a tricky situation for India as it is the largest economy in the grouping and has a unique share of voice amongst the partners(without China or Pakistan presence). India is also not part of any regional economic cooperation framework such as Regional Comprehensive Economic Partnership (RCEP). This leaves India with the only choice of forging many bilateral trade and economic cooperation agreements with the regional players, leaving out potential access to large seamless free trade market. In this regard India needs to emulate the Indo-Pacific Economic Strategy being currently collated by President Joe Biden led US government, as a tool for increasing access and influence in the region. The nuanced contours of the US strategy are still under developmenthowever a broad statement of purpose, vision, goals and clear threats have been identified. India has always maintained a bipartisan, strategically nonaligned approach towards its foreign policy. However, defining avision, mission and its proposed approach towards Indo Pacific region could help in achieving the targets and open up new inroads for regional cooperation. India needs regional partners such as BIMSTEC and ASEAN for its goal of achieving a \$5 trillion economy. These countries also form and influential axis in India's overall Indo-Pacificstrategy, QUAD framework and current government's focus on neighbourhood first policy. China is a constant threat to the democratic sovereign countries in South Asia. It has used economic and militarycoercion to undermine the sovereign status of many nations in the Indo Pacific belt of Asia. The only bulwark against China for many of these smaller countries is an economically powerful, democratic India, which vouches for a rules-based global order. India will have to don the mantle of being the elder sister in BIMSTEC without being overtly assertive.

Address root cause of train accidents

While focusing on safer coaches to limit fatalities, thorough investigations into accident causes and implementation of corrective measures mustn't be ignored

eaders would recall that nine passengers died and nearly forty were injured following the derailment of several coaches of Up Bikaner-Guwahati Express on January 13 at Domohani in Mainaguri area of West Bengal's Jalpaiguri district. The derailment caused many of the twelve coaches which derailed, to capsize or climb over another coach. This accident had brought into focus once again, the issue of avoidable fatalities in an accident by switching over to a safer coach design on all faster services such that even if a derailment does occur, in spite of all the precautions and measures, the damage it causes to the affected coaches should be so controlled that it causes minimal casualties.
Indian Railways (IR) principally

employs two types of coaches — the old ICF-type and the newer LHB-type. The latter coaches are designed with a coupler, which gets strongly interlocked with the coupler of the adjacent coach, preventing relative sideways and vertical movements of the coaches with respect to each other and, therefore, coaches do not climb or capsize, even if there is a derailment. The ICF-type coaches have no such restraining arrangement, causing them to mount each other or capsize individually when subjected to a thrust in case of a derailment. At the same time, the more recent Vande Bharat Train 18 type coaches are even safer with their semi-permanent type couplers, anti-climbing feature and safer structural designs. I had recommended in this column that ICF-type coaches should be scrapped in a greater haste and to increase the pace of manufacture of LHB- and Train-18- type coaches to replace them. It is possible, thanks to some measures taken by railway production units, particularly Integral Coach Factory since 2016, that IR can be geared to manufacture more than 9000 coaches per year. Once we replace the ICF coaches on faster services in a period of 3 to 4 years, the balance can be relegated to inferior services which can then complete their full useful life without putting lives of passengers to any significant danger of fatalities in case of an accident.

The coach production programme issued by IR has a plan for manufacturing 8429 coaches, falling short of the possible 9000 or more. Although it is not explicitly spelt out, it would help faster a good step towards improving safety. The pitfall is that this plan envisages 1200 . Vande Bharat Train sets and another 52 Cargo-liner and freight EMU coaches whereas the actual achievement would be far less. Even if IR manages to manufacture around 500 against these 1252, it would not be a mean achievement, considering that not one coach of Vande Bharat coach has been built since their first turn-out in October 2018, more than three years back. It is strongly hoped that the shortfall of these 700+plus coaches would

There have been some instruc-

tions which give the impression that some officers are trying to jump the gun and attempting to divert the issue. First, in a knee jerk reaction, a top Railway Board executive passed bizarre instructions immediately after the accident, calling out for Loco Pilots to check the condition of traction motor mounting while taking over charge and even during halts in the middle of a train-run, never mind that a routine check by a Loco Pilot can hardly detect a failure of fabrication or weld, and it unnecessarily stresses them out. There may be need to institute a one-time examination of this fitment on all locomotives of this series on a pit by maintenance within the purview of a Loco Pilot would be without the benefit of a locomotive standing on an inspection pit. after the last trip inspection whereas it should have undergone inspection after 4,500 km as per stipulations. It would appear that the trip inspection time interval has been kept at 4500 km as a matter of supreme caution by IR whereas modern locomotives, not today but for more than two decades, are good for working 30 to 40 thousand kilometres without any inspection. In fact, many locomotives on IR easily work for this range of distance without any checks and even if we assume that these passenger locomotives need closer examination, there can never be a case to examine their traction motor mounting every 4500 kilometres. Experts say that overdue schedule running of the locomotives, per se, cannot be the cause of an accident and our operations are such that overdue running is frequently unavoidable. The matter can certainly be taken up for systematic improvements but linking staff but it is not a defect which is it with the derailment would only tend to obfuscate the real cause of

US, Filipino forces hold combat 7 hurt in Arkansas drills on beach facing China

ith assault weapons ready, US and Filipino marines sprend from the sprend from port helicopters to defend an island from potential aggressors in a war exercise and show of American firepower staged on Thursday in the northern Philippines.

The exercise - held in far-flung Claveria town across the sea from China and Taiwan - fits into a strategy unveiled in February by the Biden administration to considerably broaden US engagement in the Indo-Pacific region by strengthening a web of security alliances and partnerships, with an emphasis on addressing China's growing influence and ambitions.

Watched by invited journalists, the mock combat ended with the allied forces successfully securing the island before it could be seized by invaders in a clear warning to would-be aggressors in a region with multiple trouble spots.

"We should indeed improve our preparation for external aggression," said Philippine regional military commander Maj. Gen. Lawrence Mina, who spoke with reporters as the marines took combat positions on the sandy beach and a narrow trench under the scorching summer heat.

"It's high time because we never know if we'll get embroiled in the unfolding events that we're hearing in the international scene," he said. "At least we're ready."

The beach landing and coastal defense maneuvers were part of one of the largest combat exercises in years between the longtime treaty allies that began Monday and would include live-fire drills, aircraft assaults, urban warfare and civic projects mostly in northern and the western Philippines, which faces the disputed

South China Sea.
Col. Timothy Brady Jr., who heads the US 3rd Marine Littoral Regiment, said he was "very pleased" with the outcome of the mock beach maneuvers, which started in the nearby coastal town of Aparri.

"Certainly, the objective of what we're doing is demonstrating the strength of the alliance as well as the commitment to



regional security," Brady said.

Called Balikatan - Tagalog for shoulder-to-shoulder - the annual exercises will run up to April 8 with nearly 9,000 navy, marines, air force and army troops, including 5,100 American military personnel, to strengthen their joint fighting capabilities and readiness "for real-world challenges," according to US and Philippine military

First staged in 1991, the Balikatan exercises are anchored on the 1951 Mutual Defense Treaty, which commits the United States and the Philippines to come to each other's aid in case of an attack.

When President Rodrigo Duterte took office in 2016, he threatened to scale back US military activities in the country as he nurtured closer ties with China and Russia but walked back on many of his threats, including a move to abrogate a defense pact that would have restricted American forces from largescale combat exercises in

In Nashville, Tennessee, panelling fell five stories from the side of a downtown hotel Wednesday evening and onto a roof of a building below.

The fire department warned the debris could become airborne as high winds continued, and some hotel guests were moved to other parts of the building due to concerns that the roof would become unstable. No injuries



were immediately associated with the collapse.

A warehouse roof collapsed as the storms moved through Southaven, Mississippi, near Memphis, police said. The building had been evacuated and no injuries were reported.

The Mississippi Senate suspended its work as weather sirens blared during a tornado watch in downtown Jackson. Some employees took shelter in the Capitol basement.

Rander P. Adams said his and his wife, Janice Delores Adams, were in their home near downtown Jackson when severe weather blew through during a tornado warning Wednesday afternoon. He said their lights flashed and they heard a loud whistling noise.

As his wife tried to open their front door, a large window exploded a few feet from her.

The glass broke just as if someone threw a brick through it," he said. "I advised her then, Let's go to the back of the house." Adams said the storm toppled trees in a nearby park, and a large tree across the street from their house split in half. "We were blessed," he said.

"Instead of falling toward the house, it fell the other way.

China, Solomons ink draft of controversial security pact

China and the Solomon Uslands have signed a draft version of a security pact that could see Chinese police and other forces take up duties in the Pacific Island nation, drawing concerns from traditional partners New Zealand, Australia and the United States. The Solomon Islands government on Thursday said the draft agreement had been initialed by representatives of the two sides and will now "be cleaned up and await signatures of the two countries' foreign ministers."

The agreement aims to 'respond to Solomon Islands' soft and hard domestic threats.

Solomon Islands will continue to roll out the implementation of its national security strategy and uphold its foreign policy of Friends to all and enemies to none," a government news release said.

Solomon Islands Prime Minister Manasseh Sogavare on Tuesday rejected concerns that regional safety would be jeopardized by the treaty.

Sogavare called such concerns "utter nonsense," adding that "I find it very insulting ... To be branded as unfit to manage our sovereign affairs." China has likewise dismissed questions about the agreement.

In its statement, the Solomon Islands said it would continue to "work with all partners in providing a safe and secure nation where all people are able to co-exist peacefully. It thanked Australia, Papua New Guinea, New Zealand and Fiji for committing personnel to safeguard security on the islands.

Under the terms of the

draft agreement, China could send police, military personnel and other armed forces to the Solomon Islands "to assist in maintaining social order" and for a variety of other reasons. It could also send warships to the islands for stopovers and to replenish supplies, leading to speculation about the possibil-ity of China establishing a naval base on the islands.

Deepening concerns, the draft agreement stipulates that China would need to sign off on any information that is released about joint security arrangements, including at media briefings.

The Solomon Islands, home to about 700,000 people, switched its diplomatic allegiance from Taiwan to Beijing in 2019 - a contributing factor to riots in November last year between residents of different islands within the country.

Australian police have been in the capital, Honiara, maintaining peace since then under a bilateral security treaty established in 2017. It provides a legal basis for the rapid deployment of Australian police, troops and associated civilians in the event of a major security challenge. Chinese police are already on the islands conducting a training mission.

New Zealand Prime

Minister Jacinda Ardern described the possibility of Chinese military forces stationed on the Solomon Islands as "the potential militarisation of the region." Australian Prime Minister Scott Morrison said reports of the pact were "a reminder of the constant pressure and threats that present in

Khashoggi murder: Prosecutor seeks end to trial in Turkey



The prosecutor in the case ▲ against 26 Saudi nationals charged in the slaying of Washington Post columnist Jamal Khashoggi made a surprise request Thursday that their trial in absentia be suspended and the case be transferred to Saudi Arabia.

The panel of judges made no ruling on the prosecutor's request but decided that a letter should be sent to Turkey's Justice Ministry seeking its opinion on the possible transfer of the file to the Saudi judicial authorities, the state-run Anadolu Agency reported. Trial was adjourned until April 7.

The private DHA news agency reported that the prosecutor told the court that in a letter dated March 13, the Saudi chief public prosecutor's office requested that the proceedings in Turkey be transferred to the Kingdom and that international warrants issued by Ankara against the defendants be lifted.

Today, and Rossiya Segodnya who control news agency Sputnik.

"Putin's war on Ukraine is based on a torrent of lies. Britain has helped lead the world in exposing Kremlin disinformation, and this latest batch of sanctions hits the shameless propagandists who push out Putin's fake news and narratives," said UK Foreign Secretary Liz Truss, who is in India on Thursday for talks.

We will keep on going with more sanctions to ramp up the pressure on Russia and ensure Putin loses in Ukraine. Nothing and no one is off the table," she said.

Qatar's WC gets real as Doha hosts tourney draw

¬he countdown towards the most controversial World Cup in history really begins on Friday as the draw for Qatar 2022 takes place in Doha, less than eight months before the start of the tournament itself.

As pandemic restrictions ease, some of football's biggest names will be there for the draw at a Doha convention centre among the skyscrapers of the city's West Bay district, as holders France and their rivals find out who they will face in the group stage of the first World Cup to be held in November and December.

The dust has still not settled on qualifying, with final matches the three berths to be decided in play-offs in June.

Seedings for the draw are based on the latest FIFA world rankings published on Thursday, and the seven highest-ranked qualifiers, including France, are in Pot One along with the host nation, despite Qatar being one of the lowest-ranked participants.

The tiny Gulf state of under three million people stunned the planet when it won the right to host the World Cup at a vote in 2010, leading to accusations of vote-buying -- which were hotly denied -- and questions over the country's suitability.
Off-field issues

The obvious issue was the extreme heat in June and July, when the World Cup is traditionally held, and so the decision was taken to move the tournament to the northern

hemisphere winter. Then there has been the criticism of the working con-



ditions of hundreds of thousands of migrant labourers in the country, including those who built the stadiums. That led to the threat from some

countries of a boycott.

For all the issues, there is excitement as a World Cup approaches, and FIFA announced on Wednesday that over 800,000 tickets had been snapped up so far.

Seven of Qatar's eight World Cup stadiums are brand new. Most will be reduced in size after the tournament, while one will even be dismantled altogether.

This week organisers have been eager to show off the gleaming infrastructure as the world's media descend on

There will though be inevitable questions about the fate of the migrant workers, however much FIFA and local organisers would prefer the talk to be solely about football.

Even the draw itself cannot be separated from bigger issues beyond football.

Russia's invasion of Ukraine threw the European play-offs to decide the final three of UEFA's 13 qualifying places into some

Russia were suspended from all international football until further notice, preventing them from featuring in the

Ukraine's play-off semifinal against Scotland was postponed until June, with the winner of that match facing Wales for a place in Qatar.

England will certainly be there, with their manager Gareth Southgate dismissing talk of a boycott.

Canada will be there too, for their first World Cup since 1986, but Italy are the biggest absentees from the draw after their disastrous defeat by North Macedonia last week ruled them out again, just like in 2018.

Their next chance to qualify will be in 2026, by which time the World Cup will have been expanded to a bloated 48

For all the controversy surrounding Qatar's World Cup, at least it features 32 sides, split into eight groups of four, surely the perfect number for football's global showpiece.



Mexico, USA clinch World Cup berths

The United States and Mexico booked their tickets to the World Cup finals in Qatar on Wednesday after securing the results needed to claim the last two automatic qualifying places from the CON-CACAF region. The USA were beaten 2-0 by Costa Rica in San Jose to finish third in the standings while Mexico eased past El Salvador 2-0 in Mexico City to finish second overall.

Costa Rica finished qualifying in fourth place and will face New Zealand in a playoff for a World Cup berth. Canada, who completed their successful qualifying campaign with a 1-0 defeat in Panama on Wednesday, had already qualified for the World Cup on Sunday.

Both the US and Mexico had all-but sealed qualification after wins on Sunday meant only a freak set of results in Wednesday's final round would see either side relegated to a playoff place.

Costa Rica needed to beat the US by six goals or more in San Jose to have a chance of qualifying. Two second-half goals in

eight minutes by Juan Vargas and Anthony Contreras raised hopes of a miracle for the home fans, but the United States regrouped to close out the game, qualifying ahead of Costa Rica on

In all, Lewis hit six fours and three sixes as first-timers LSG recorded their maiden win in the lucrative league. Badoni hit two maximums, which turned out to be crucial in the context of the final result. Earlier, leg-spinner Ravi Bishnoi (2/24) did a tremendous job with the wet ball in difficult conditions, even as Robin Uthappa turned back the clock with his beautiful yet brutal assault to propel CSK to a strong total.

"The CAC takes the call and if they felt Ramesh would do better than Raman, it was their call. The board can't interfere," the source said.

mance from us, something we were searching for a little bit. Really chuffed that the girls have brought their best cricket when everything's on the line," said England skipper Heather Knight referring to their comeback after a disastrous start to their tournament campaign.
