Russia welcomes India as mediator

Modi bats for end to Ukraine row; Russia hails India for its free foreign policy

PNS NEW DELHI

Visiting Russian Foreign Minister Sergey Lavrov met Prime Minister Narendra Modi on Friday evening and held detailed talks about the Ukraine situation.

A press release from the Prime Minister's Office said Modi called for an end to violence even as Lavrov briefed him on the situation in Ukraine, including peace negotiations. The meeting lasted for 40 minutes.

The meeting came after the Russian Foreign Minister and his Indian counterpart S Jaishankar held a comprehensive discussion on the Russia-Ukraine conflict.

Modi's meeting with the Russian Foreign Minister is significant. The Prime Minister has not met any other visiting

"Prime Minister reiterated his call for an early cessation of violence, and conveyed India's readiness to contribute in any way to the peace efforts," said the press statement.

sustained dialogue and diplomacy to end the Ukraine conflict even as Russia praised it for following an independent foreign policy and promised to supply whatever India wanted

Nitish won't go anywhere, to stay as CM, says JD(U)

'Kumar's RS entry news fake, he will complete his 5-yr tenure'

The Janata Dal (U) has vehemently denied reports that Bihar Chief Minister Nitish Kumar has any intention to move to the Rajya Sabha or take up any other Constitutional posts and hand over the reins of power to the BJP in Bihar.

"Kumar will complete his five-year-tenure and is not going anywhere," senior lead-ers of the JD(U) asserted on Friday

The clarification came after a section of media sought to interpret Kumar's casual remarks made during an informal interaction with journalists two days back that he would not contest the next Lok Sabha polls and the Rajya Sabha was "the only House" he has not been a member of.

His remarks gave grist to the rumour mills that were churning stories for several weeks that Kumar would move to the Rajay Sabha and then be put up as NDA vice-presiden-

Imran: Powerful country backing **India angry over** my Russia visit

A head of Sunday's no-trust motion against him, Prime Minister Imran Khan on Friday said a "powerful country", which is supporting India, is angry with Pakistan because of his recent visit to Russia to meet President Vladimir Putin.

Addressing the Islamabad Security Dialogue, Khan emphasised that an independent foreign policy was crucial for the country, and said the reason why Pakistan could not touch its peak potential was its dependency syndrome on other powerful nations. "A county without an inde-

pendent foreign policy remains unable to secure the interests of its people," he said.

Khan said taking independent decisions while keeping

high the interests of a nation was extremely important rather than submitting to the will of other countries in exchange for

foreign aid.

Referring to the US, Khan said a "powerful country" had expressed displeasure over his recent visit to Russia. "On the other hand, it is supporting its ally India which imports oil from Russia," he rued.

Khan's comments came a day after Pakistan summoned the acting US envoy in Islamabad over a "threatening" letter and an alleged "foreign-funded plot" against the Pakistan Tehreek-e-Insaf (PTI) Government led by Khan.

Parliament breached Constitutional norms on MCD Bill: Delhi Speaker

Delhi Assembly Speaker Ram Niwas Goel on Friday took exception to the passage of a Bill in Parliament to reunify three Municipal Corporations of Delhi (MCD)

into one. "It was against the spirit of Constitution and federal structure for Parliament to interfere in the subject of local bodies," he said. Addressing a Press conference here, Goel said, "The

Centre should have not proposed the unification Bill at the time when the State Election Commission was going to announce the poll schedule." The trifurcation of the

civic body was done during the former Chief Minister Sheila Dikshit regime, and it was done through a democratic process. The Malhotra Committee had recommended splitting it into five corporations. In the Delhi Assembly,

the Amendment Bill was brought, and it was divided into three civic bodies," he said.

"As a Speaker, I have my protocol, but it seems this move of reunification has been done only to delay the municipal polls," Goel said. Without naming anyone, the Speaker said for the past 11 years they enjoyed the trifurcation of the civic bodies. Now, when the elections were about to happen, they feared defeat and found a

way to escape, he said. "In the history of politics, those parties who tried to delay the elections got wiped out at the time whenever polls took place in the State or Centre, Goel added.The Speaker also criticised the DDA, the Delhi Police and the Service Department for their failure to

reply to the Assembly queries. Goel said they will approach the court to ensure these departments are answerable to the State Government.

hief Minister Yogi Adityanath on Friday directed the Home department to set priorities under the 100day action plan and take action expeditiously. Yogi Adityanath said that from April 2, under Mission Shakti Abhiyan, women's safety should be monitored more effectively and actively by conducting special campaigns in schools, colleges, markets and crowded places.

The chief minister was addressing a high-level review meeting convened in connection with the 100 days action plan of the Home department at his official residence here late on Thursday night.

He said that security, law and order and good governance were the priority of the state government. As per the chief minister's directive, security arrangements should be further improved at all the religious centres and important places of the state.

Besides, in the coming one year, proper establishment of police lines should be ensured in all the districts. Police officers of all levels should do foot patrolling daily and the patrolling of PRV-112 should be conducted effectively on a regular basis and the traffic system should be made more effi-

A clean environment stations and proper arrangement for seating and drinking water should be made for the general public. Public grievances should be dealt with priority. The image of the police in the general public should be further improved.

The chief minister said that taking strict action against criminals and mafia, demolition and confiscation of illegal properties should be ensured. He said no concession should be made to mining, liquor, animal, forest and land mafias, including professional crimi-

Yogi said all senior officers should make field visits. At Ayodhya, Adityanath also offered prayers at the Hanumangarhi temple and paid a visit to the construction site of the Lord Ram tem-The chief minister also visited the Balrampur district later and offered prayers in three temples there.

He will have a night halt at the Devi Patan temple there and leave for Siddharthnagar on Saturday. A report from Gorakhpur, meanwhile, said CM Adityanath will observe a nine-day fast during "Chaitra Navratri" beginning Saturday and will perform special puja there for peace, prosperity, health and happiness in the state and nation.

In the temple town, Adityanath asked the Municipal Corporation not to take commercial tax from temples and other religious shrines.

Better Covid mgmt, vax drive prevented Omicron wave in India: Health Min

Better Covid-19 management and a massive vaccination drive prevented the Omicron wave in India while it caused numerous deaths in other countries, Union Health Minister Mansukh Mandaviva told the Lok Sabha on Friday.

Responding to a supple-

mentary question in the house on the role of ICMR Mandaviva said the ICMR has from time to time guided the map.
While reviewing the country and helped in vaccinerelated research leading to India having its own indigenous vaccine. "It was under Prime Minister Narendra Modi's guidance that India saw best Covid management and largest vaccination drive... While Omicron caused numerous deaths in other countries, India sailed through Omicron wave because of vaccination, Mandaviya said during Question Hour.

India faced Omicron threat in December 2021-January 2022. However, the impact of Omicron in India was considered less severe compared to the earlier Delta variant. The cumulative vaccine doses administered incountry so far under nationwide COVID-19 vaccination drive has exceeded 184.31 crore.

Punjab Govt's one-sided resolution on Chandigarh has no meaning: Khattar

Hitting back over the issue in which the Punjab legislative Assembly passed a resolution to transfer Chandigarh to the State, Haryana Chief Minister Manohar Lal Khattar said on Friday that Chandigarh is and will remain the capital of both States.

Talking to the media in Gurugram, Khattar said that apart from the issue of Chandigarh, there are several other differences between Haryana and Punjab.

He said that the Central Government has decided to implement the Central Service Rules in the interest of the employees of Chandigarh. He alleged that the Punjab Government is misleading the public on this issue.

"The Chandigarh employees would be greatly benefited by this decision. Earlier, the employees had to depend on the Punjab government for every order.

If there were orders from the Center for allowances or other benefits, earlier Punjab used to issue notifications. After this it would be applicable in Chandigarh," Khattar said. Now the notifications that the Center will make will

be directly applicable to the

employees.

He said that the Punjab government has not yet given the benefit of the 7th Pay Commission to the employees whereas Haryana had implemented it in 2016 itself. The employees were also deprived of this till now, but now after the implementation of the new rules, they will get its benefit.

Khattar informed that Punjab, Haryana, Himachal Pradesh and Chandigarh came into existence through the Punjab Reorganization Act passed in the year 1966.

There is a provision in this Act that 60 per cent of employees of Chandigarh will be from Punjab and 40 per cent of employees will be from Haryana. Since that time Chandigarh is the capital of Haryana and Punjab," he said.

The CM said that not only Punjab and Haryana but the people of Himachal Pradesh should also ask for their shares in Chandigarh.

"In one case, the Supreme Court had also given Himachal Pradesh the right to over 7.19 per cent of Chandigarh's land the Punjab Reorganization Act. It is a different matter that Himachal Pradesh has made its capital in Shimla," Khattar said.

and China. US President Joe Biden is yet to make a customary call to Prime Minister Khan since he assumed office in January 2021. He said for its own interest, Pakistan's elite threw the nation to the altar and put its selfrespect at stake. Last month, Pakistan abstained from voting in United Nations General Assembly (UNGA) resolution calling on Russia to stop the war against Ukraine, and urged that the conflict be resolved

through dialogue and diplomacy. Khan has been claiming that the Opposition's no-confidence motion against him was the result of a "foreign conspiracy" because of his independent foreign policy and funds were being channelled from abroad to oust him from The 69-year-old embattled

With sanctions imposed against Russia and its impact on trade and defence on India, Lavrov said Russia has developed a system to engage in trade in national currencies with countries like India and efforts to move away from the dollar-based payment system will intensify. He said Russia is exploring ways to bypass impediments for bilateral trade with its allies and partners.

Lavrov said a Rupee-Rouble payment system for trade with India was put into place earlier and it could be strengthened further. "More and more transactions will be done using national currencies and bypassing the dollar-based system," he told reporters.

Asked about Îndia's plan to buy discounted Russian oil, Lavrov said Moscow is ready to provide anything that New Delhi wants to buy.He said Russia is committed to continuing with India its cooperation in the defence sector. Russia is the biggest supplier of defence equipment to India and Lavrov said the two countries would

use a Rupee-Ruble mechanism to trade oil, military hardware and other goods. "I have no doubt that a way would be (found) to bypass the artificial impediments which illegal unilateral sanctions by the West create. This relates also to the area of military-technical cooperation," he said.

"If India wants to buy anything from us, ready to discuss and reach mutually acceptable cooperation. We will be ready to supply to India any goods which it wants to buy from us. We are ready to discuss. Russia and India have very good relations," Lavrov said.

Asked how Moscow can support New Delhi to meet security challenges, he said, "Talks are characterised by relations which we developed with India for many decades. Relations are strategic partnerships...This was the basis on which we have been promoting our cooperation in all areas."

NCLT allows Govt to take over Gymkhana club

The National Company Law Tribunal (NCLT) on Friday allowed the Ministry of Corporate Affairs to take over ed as the directors who will manage the affairs of the Company. In a 149-page order passed by a two-member bench of the NCLT, headed by President Justice Ramalingam

Further, the Tribunal asked the present administrator or any other person, who are in charge of the affairs of the club, to "hand over the charges to the newly appointed directors forthwith". "The new directors of the general

government in terms of this order shall file a report before this tribunal immediately after taking over charge of the club,"

The order also allowed the prayer of the central government to nominate 15 persons to be appointed as Directors on the General Committee of the club. Earlier, the NCLT had allowed the ministry to nominate 15 persons as directors on the club's general committee as well as manage the affairs of the club. In April 2020, the gov-

ernment through the Ministry of Corporate Affairs had moved NCLT seeking to supersede the club's general committee.

In its petition before the NCLT, the ministry said that pursuant to several complaints Delhi Gymkhana Club Ltd were inspected by it under Section 206(5) of the Companies Act.

During the course of the investigation, the ministry alleged that there was rampant mismanagement by the General Committee of the Club, in violation of the Articles of Association and the Companies Act. The ministry has also alleged that the general committee of the Club was acting on behalf of a few chosen members.

It was also alleged that the membership of the club is being given in a completely partial and undemocratic manner and several other violations of the Companies Act were also alleged by the Union of India. According to the allegations, 30.34 per cent of

Club has been incurred towards catering consumables, wine, beverages and cigarettes. On the other hand, the Delhi Gymkhana Club objected to the maintainability of the petition on the ground of want of opinion by the Government of India under Section 241 of the Companies Act and that there is no public interest as it is restricted to the cause of few members of the club.
The NCLT found that the

club is generating no income from any sports activities which is the primary objective of the club as per its memorandum of Association. Delhi Gymkhana Club was incorporated on July 14, 1913 as a non-profit company with the objective to promote sports and pastimes under license from the Central Government.

HC asks Delhi Police to file probe status report

BJYM attack on residence of CM **Arvind Kejriwal**

 $D_{ ext{the Delhi High Court on}}^{ ext{elhi Police was asked by}}$ Friday to file a status report in connection with the alleged attack by Bharatiya Janata Yuva Morcha (BJYM) workers on the residence of Delhi Chief Minister Arvind Kejriwal earlier this week.

A Bench of Acting Chief Justice Vipin Sanghi and Navin Chawla, hearing a petition by AAP MLA Saurabh Bhardwaj concerning the incident, granted time to Delhi Police to file its status report in connection with the ongoing investigation in a sealed cover. "Some took law into their hands. An element of fear was sought to be created. That is evident. The police force was inadequate...They did try to stop them but they were outnumbered," the court observed. Delhi Police, represented by Additional Solicitor-General Sanjay Jain, told the court that the police has registered an FIR on its own in relation to the attack and is taking all steps to

address the safety concerns.

He added that all the evidence, including the CCTV footage from cameras around the Chief Minister's residence as well as the arterial roads towards it, would be preserved.

"Delhi Police will set up a meeting with the Chief Minister's secretariat. We don't know if they are feeling any apprehension," said Jain who claimed that instant petition was "misconceived."

He added that eight people have already been arrested in relation to the case and an investigation is underway. Senior advocate Abhishek Manu Singhvi, appearing for the petitioner, urged the court to issue a notice on the petition and pass a direction for the preservation of CCTV footage of the incident. Senior advocate Rahul Mehta, also appearing

for the petitioner, objected to the registration of an "unnamed" FIR when there are videos to show the presence of a Member of Parliament. "This is too premature," the court stated.

Bhardwaj, in his petition through advocate Bharat Gupta, has sought the constitution of an SIT to probe the alleged attack and argued that the vandalisation of the official residence of the Chief Minister appears to have been carried out with Delhi Police's tacit complicity.

"On March 30 several BJP goons, in the garb of a protest, launched an attack on official residence of the Delhi Chief Minister. Videos and photographs show that these goons casually walked through the security cordon (maintained by Delhi Police), kicked and broke boom barrier, broke CCTVs cameras with lathis, threw paint on gate of residence and almost climbed over gate, while Delhi Police personnel simply looked on, doing little to stop the protestors," the plea alleged.

Khattar inaugurates Huda City Centre underpass, flyover, FOBs

Gurugram: Haryana Chief Minister Manohar Lal Khattar inaugurated the Huda City two-foot overbridges (FOB) built near the Signature Tower and Iffco Chowk on Friday. Meant to reduce traffic snarls at the Huda City Centre junction, the projects were opened to the public on the same day.

The underpass, built at a cost of Rs 52.52 crore, is 750m long and will pave the way for a seamless commute from the Signature Tower to Subhash Chowk, while the 269.5-metrelong flyover will improve connectivity between Hussain Marg and the sector road.

"This is another achievement and a proud milestone for Gurugram. The Huda City Centre is one of the busiest and most important traffic junctions of the city which sees heavy vehicle flow and pedestrian



movement. The new underpass and flyover will facilitate a smooth traffic stream at this critical location and eradicate traffic congestion and jams," Khattar The Gurugram Metropolitan Development Authority (GMDA) official said the underpass has two lanes designed for vehicular speed of 40 kmph. "The underpass and the flyover will reduce the move-

ment of vehicles and there will be less congestion. A FOB will also provide for smooth movement of pedestrians," he said. Khattar also inaugurated the water supply distribution net-work of Zone-8 from Sector 111 to Sector 115 in Gurugram. The project which cost approximately Rs 10 crore will by 2031 provide safe drinking water to over 93,000 residents in area.

Delhi High Court allows re-opening of Nizamuddin Markaz for Ramzan prayers shall be permitted to be No Tablighi activities, offered on the ground floor and

lectures allowed, only prayers can be offered, says court

The Delhi High Court on Friday allowed the re-opening of certain areas of the Nizamuddin Markaz, where the Tablighi Jamaat congregation was held in March 2020 amid the Covid-19 pandemic and has remained shut since then, to enable devotees to offer prayers during the month of Ramzan.

Justice Jasmeet Singh, who was hearing a plea by the Delhi Waqf Board seeking a direction to open mosque for the holy month, clarified that no "Tablighi activities" and lectures can take place on the premises and only prayers can be offered. "It is directed that for Ramadan, namaz and religious

four floors at Masjid Bangle Wali. This arrangement is only for the month of Ramzan culminating with Eid Ul Fitr," ordered the court. "Religious prayers and namaz (are allowed) but no Tablighi activities. Let's not dilute it. There will be no lectures. Prayers can be made. But no lectures," the court stated. It added that the instant

permission was in continuation of the March 16 order which imposed various conditions for reopening of the premises for Shab-e-Bharat. The court further directed

installation of CCTV cameras at the entry, exit and stairs of each floor of premises and said that it shall be responsibility of markaz management to ensure that cameras are fully functional during period of Ramzan. For Shab-e-Bharat, court had removed the 100person limit for one floor and said it has been agreed that

management of the mosque will ensure that Covid-19 protocols and social distancing will be followed while allowing devotees to enter the mosque to offer namaz. Lawyer Rajat Nair, appearing for Delhi Police and Central Government, opposed the grant of permission to offer prayers on fourth floor and said that mosque was only restricted to ground floor which is borne out of site plan. "If there are more floors,

there is more space... If there is a reason (to oppose opening of fourth floor), tell us. More surface area, better it is. More area is always conducive," the court remarked The judge stated that as per

joint inspection report, the fourth floor was part of the masjid area and present observations are only prima face and subject to adjudication. The Central Government lawyer also said that no "Tablighi activities" and lectures can be permitted in markaz and only prayers are allowed.

Army truck driver held for running over cyclist

NEW DELHI: A day after a 26-year-old man died allegedly after being run over by a vehicle when he lost control of his bicycle and fell on the road, the Delhi Police has arrested an army truck driver on Friday.

The driver has been identified as Sepoy OM Prakash (46), a resident of Jind district in Haryana.

Kanwar Arora was allegedly run over by the army truck in a posh central Delhi area on Thursday after he lost control of his bicycle, fell down and came under the rear wheel of the truck of Sena Bhawan.

'Need to create umbrella institution'

Time to bring **CBI, SFIO** and ED under one roof: CJI

Chief Justice of India Justice NV Ramana on Friday said there is an immediate requirement for the creation of an independent umbrella institution, so as to bring various agencies like the CBI, SFIO and ED among others under one

roof,
"Unfortunately, our investigative agencies still do not have the benefit of being guided by a comprehensive law. Need of the hour is the creation of an independent and autonomous investigative agency," the CJI said.

He suggested the creation of an overarching umbrella functioning of police agencies as also regaining public trust.

Justice Ramana articulated this in an address at the 19th DP Kohli Memorial Lecture "Democracy: Role and Responsibility of investigative agencies" and also backed modernization as well as accountability of the investigative agencies. Kohli was the founder

director of CBI.

Underscoring reform and modernization of the police apparatus, Justice Ramana said, "Reform of the police system is long overdue in our country. The Ministry of Home Affairs has itself recognized the glaring need of the same in the "Status Note on Police Reforms

"Police reforms have been on the agenda of Governments almost since independence but even after more than 50 years, the police is seen as selectively efficient, unsympathetic to



the under-privileged. It is fur-ther accused of politicization and criminalization. In this regard, one needs to note that the basic framework for policing in India was made way back in 1861, with little changes thereafter, whereas the society has undergone dramatic changes, especially in the post independence times," he quoted from the Home Ministry's

Two decades on, EMRS scheme yet to be completed

Many schools under the Eklavya Model Residential Schools (EMRS) scheme, which was started in 1997-98, are yet to be completed even after more than two decades, a Parliamentary panel has pointed out.

The project was launched to impart quality education to Scheduled Tribes (ST) children in remote areas to enable them avail of opportunities in high and professional educational courses and get employment in various sectors.

Of the 288 schools sanctioned in 1997-98, only 244 schools could be made functional. A data furnished by the Ministry of Social Justice and Empowerment showed that the construction work of only 202 schools has been completed till date and the construction work of 20 schools is yet to begin, whereas construction work of 66 schools is targeted to be com-

original target, which aimed

that 452 new Eklavya Model Residential Schools (EMRSs) including 12 Eklavya Model Day Boarding School (EMDBS) would be set up in the remaining 462 sub-districts by the year 2022 is nowhere near completion and the target year stands revised as

2025 now.
"Out of 452 schools proposed to be sanctioned as per the phasing plan between 2018-2019 to 2021-2022, only 350 schools could be sanctioned and the remaining 102 schools are remaining to be sanctioned as the location for these schools is yet to be finalised. The construction work of only 100 schools could begin till date whereas the construction work of 332 schools is to begin by March 2022, which has just passed", the data showed.

Parliamentary Standing Committee on Social Justice and Empowerment, headed by Rama Devi, tabled its report on Friday, it is disappointing that very few schools have their own build-

been made functional from own buildings. 103 schools are functioning from alternate buildings since 2018-19 till

The report said that the Committee was quite apprehensive with regard to the achievement of target even by March 2025 as construction of 252 schools is yet to begin. The Committee have been made to believe by the Ministry that after establishment of National **Educational Society for Tribal** Students (NESTS) on revamping of the Scheme.

"The Committee are surprised to note that 3 States namely Bihar, Tamil Nadu and West Bengal have still not signed MoŬ and are reluctant to shift to CBSE Board and are insisting on continuation of State Board Curriculum in the schools set up in their States whereas the norms stipulate that all the EMRSs set up are to be affiliated with CBSE in order to grant better sum per child studying in these schools,"

BJP crosses 100-seat mark in Upper House

All Congress parliamentarians in the Lok Sabha as well as the Rajya Sabha will attend the meeting in the central hall of Parliament scheduled on April 5. While Sonia is being noticed as being vocal and raising issues herself frequently after facing the heat of party colleagues over massive assembly poll debacle recently, this is the first meeting of the Congress Parliamentary Party after the assembly elections Earlier she had convened a

meeting of Congress Working Committee to discuss on the poll debacle and to own up the responsibility for the humiliating defeat. While another round of CWC is to be held anytime this month, a Chintan Shivir has also been proposed later this month or early next month. In between a meeting of the State Congress chiefs and general secretaries were conducted last week to develop strategy to strengthen the party and to do a series of protest on

price rise across the country. The CWC had unani-

mously decided that party president Sonia Gandhi should continue in the post till organisational polls after she expressed readiness to "make any and every sacrifice" in the party's interest.

Meanwhile the party has extended the March 31 deadline for its nationwide membership drive to April 15. The membership drive that started on November 1 last year is both in online and physical mode and was to continue till March 31. The membership has crossed 1.2 crore, according to a party source.

"The Congress president has approved the proposal of the AICC GSs and Incharges for extension of the special membership drive for 15 days. The drive will now close on April 15, 2022, without affecting the schedule of Organisational Elections approved by the CWC," AICC general secretary, organisation, KC Venugopal said.

'Unlike other schools with students from the immediate and extended

locality, all 136 Army Public Schools are enrolled primarily with wards of Indian Army personnel, who have been transferred-in from another location," he explained in a written

Due to the nature of service, Indian Army personnel are transferred frequently, at short notice, and mostly in the middle of the academic calendar and at times in field locations away from their families, the minister noted.

14.6% dropout rate at secondary level in schools: UDISE+

The Unified District Information System for Education Plus (UDISE+) 2020-21 latest annual report has mentioned dropout rate for secondary level education to 14.6 per cent. At the peak of the covid pandemic with school closures, 247 million children were affected in India.

Besides there has also been a rise in School Dropout Rates of girls in India which pose an alarming situation as per a report by UNICEF. "With the current situation, we might be risking a lost generation of children who may never return to school. The impact on girls is disproportionately worse," said Yasumasa Kimura, UNICEF India Representative. It further said at least 38 per cent of respondents

of a poll conducted on International Women's Days said they knew of a girl who had dropped out of school. While 33 per cent youth respondents said that the girls who had dropped out were engaged in domestic work, 25 per cent reported that the dropouts had got married.

'This is indeed a matter of grave concern. It is critical that we work towards transitioning all children back into learning. UNICEF is supporting the Government of India in back-toschool campaigns, awareness and outreach initiatives and learning recovery programmes at schools and in the communities. We must not only bring children back to school but also focus on putting strong remedial learning initiatives in place to ensure retention and continuity of learning," said Kimura.

Only 10 State ready to set up courts in rural areas: Baghel

Friday informed that only forward 10 States have come forward to set up courts in rural areas under the Gram Nyayalaya Act to provide access to justice to people at their doorsteps.

At present, a total of 258 Gram Nyayalayas (rural courts) are functioning even as notifications had been issued for the setting up of 476 Gram Nyayalayas, he added.

The Gram Nyayalaya Act 2008 stipulates for establishment of courts at intermediate panchayat level to provide access to justice to people at their door steps.

The minister said it is not mandatory for the states to implement the Act.

"It (implementation of the

Act) is advisory," he said. Sarangi had sought to know from the government about the steps being taken to set up Gram Nyayalayas in the country, stressing that there is an "urgent need" to increase the capability of the country's justice delivery system.

Major floods increased in 3 yrs in India

ARCHANA JYOTI ■ NEW DELHI

In what could be called as the impact of climate change and is a cause of concern for the authorities, the number of States in the country reporting extreme floods have increased in just the last three years.

More worrying is that even States from Southern India are becoming prone to this weather unpredictability induced by global warming.

The data tabled in

Parliament by the Union Ministry of Jal Shakti recently reveals that in addition to existing flood prone States Assam, Bihar and Uttar Pradesh, extreme floods (water level above previous Highest Flood Level) were witnessed in Kerala, Karnataka, Tamilnadu, Andhra Pradesh, Telangana, Odisha. Maharashtra, Chhattisgarh, Madhya Pradesh and Rajasthan due to excess to large excess rainfall in these states combined with extreme-

ly heavy rainfall in short dura-

Sharing these disturbing facts, Minister of State for Jal Shakti, Bishweswar Tudu in a written reply in Lok Sabha said that floods are natural calamities that the country faces almost every year, in varying degrees of magnitude.

The occurrence of floods can be attributed to various factors, including wide variations in rainfall both in time and space with frequent departures from the normal pattern, inadequate carrying capacities of rivers, river bank erosion and silting of river beds, landslides, poor natural drainage in flood prone areas, snowmelt and glacial lake out-bursts, etc."

The Central Water Commission (CWC), which is the nodal agency entrusted with the task of flood forecasting and early flood warnings, has issued flood forecasts for 331 forecasting stations (199 river level forecast stations & 132 dam/ barrage inflow fore-

"These stations cover 20 major river basins in 23 States & 2 Union Territories," said the Minister According to experts, climate change has already started worsening the frequency, intensity, and impacts of some types of extreme weather events. For example, sea level rise increases the impacts of coastal storms and warming

can place more stress on water supplies during droughts. A report from the World

Meteorological Organization (WMO) in last August said a disaster related to a weather, climate or water hazard occurred every day on average over the past 50 years - killing 115 people and causing USD 202 million in losses daily.

It pointed out that the number of disasters has increased by a factor of five over the 50-year period, driven by climate change, more extreme weather and improved reporting. But, thanks to improved early warnings and disaster management, the number of deaths decreased almost

CBI gets custody of Deshmukh, Waze in corruption case

¬wo special courts here on Friday granted CBI the custody of former Maharashtra Home Minister Anil Deshmukh, his two aides and dismissed police officer Sachin Waze for investigation in a corruption case registered against

NCP leader Deshmukh (71) and his aides Sanjeev Palande and Kundan Shinde are currently in judicial custody in a money laundering case being probed by the Enforcement Directorate (ED). They are lodged in the Arthtur Road jail in the city.

The Central Bureau of Investigation had filed an application before additional sessions judge D P Singhade for their custody.

The judge on Thursday issued a letter of request to the special Prevention of Money Laundering Act court, which hears ED cases, to transfer Deshmukh and the other two to the custody of the CBI.

The CBI had also sought the custody of Sachin Waze. Waze was arrested in March 2021 by the National Investigation Agency in the Antilia bomb scare-Mansukh Hiran murder case. Following which, judge D P Singhade had sent a similar letter of request to the special NIA

Waze is currently in judicial custody at Taloja Jail in neighbouring Navi Mumbai. The special PMLA and NIA courts on Friday directed, in separate orders, the superintendents of respective jails to hand over the custody of the four accused -- Deshmukh, Palande, Shinde and Waze -- to the CBI.

Param Bir Singh had alleged that Deshmukh, then home minister, had given a target to police officers to collect Rs 100 crore per month from restaurants and bars in the city.

Deshmukh denied the allegations but stepped down from his post after the Bombay High Court directed the CBI to register a case

Incidentally, the Supreme Court on Friday rejected a plea by the Maharashtra government challenging an order of the Bombay High Court dismissing its petition seeking an SIT to probe the corruption case against Deshmukh.

Ultras taking refuge in masjids, madrassas: Security forces

The top brass of the Indian Army and officers of Jammu and Kashmir police on Friday flagged the issue of terrorists taking refuge in masjids and madrassas prior or after the act of committing terror activities in an attempt to create communal dis-turbance during a joint security conference at

The recent terror attacks on civilians and security forces personnel were also discussed in detail during the crucial security meeting.

According to a Srinagar based Defence spokesman, "the alarming trend of the terrorists taking refuge in Masjids and Madrassas prior or after the act of committing terror activities in an attempt to create communal disturbance was discussed during the conference".

The security Conference was chaired by the rity related issues in the Valley. It was attended by all senior Army including GOCs, Sector Commanders and COs as well as senior police officers in Kashmir Division including the IGP, DIGs North, Central and South Kashmir, SSPs and SPs of all districts.

While the cordon was being tightened, the terrorist lobbed a grenade on the security forces causing injuries to two soldiers of the Indian Army, who were subsequently evacuated to 92 Base Hospital, Srinagar".

"Fire continued to be exchanged throughout the night into the intervening morning of 01 Apr 22. The terrorist was subsequently neutralized. A thorough search of the house was conducted in the morning and on finding no other terrorists, the operation was called off. Warlike stores have been recovered from

The slain terrroist has been identified as Muneeb Ahmad Sheikh son of Shah Mohd Sheikh resident of Tak Mohalla Shopian, affiliated with proscribed

As per police records the killed terrorist was a categorized terrorist and part of groups involved in several terror crime cases including attacks on Police/SFs and civilian atrocities. Meanwhile, security forces also busted a terror module of proscribed terror outfit JeM by arresting 03 terrorist associates in Pulwama. According to a police spokesman the terrorist associates have been identified as Owais Altaf son of Altaf Hussain Ganai resident of Jandwal, Aqib Manzoor son of Manzoor Ahmad Mir resident of Gudoora and Waseem Ahmad Pandit son of Gh Mohammad Pandit resident of Karimabad Pulwama.

Preliminary investigation revealed that the arrested trio was involved in providing logistics and transportation to terrorists in the district, police spokesman added.

Class XII English paper leak case: 8 more arrested

Eight more people, including the alleged mas-termind in the Class 12 English exam question paper leak case, were held on Friday, taking the total number of arrests to 34, the Uttar Pradesh Police said. The UP Board's English language exam

paper was cancelled in 24 districts on Wednesday after the paper was leaked, prompting Chief Minister Yogi Adityanath to order stringent action, including invoking the National

Security Act, against the culprits.

Among the Friday arrests, the alleged mastermind, Mulayam Chauhan, and three of his accomplices were nabbed by the police in Nagra and four others by a team in Sikandarpur.

Confirming the arrests, Deputy Superintendent of Police at Rasra, Shivnarayan Vaishya, said, "A team of Nagra police has arrestmastermind behind the English question paper leak. A total of seven other suspects have been arrested by our teams. They will be produced before a magistrate.'

The police teams had earlier arrested 26 peo-

ple, including Ballia's District Inspector of Schools Brajesh Kumar Mishra and three jour-

The DIoS and one of the arrested journalists, Ajit Ojha, were sent to judicial custody on Wednesday after they were produced before the chief judicial magistrate. The remaining accused were produced before the judicial magistrate on Thursday and they were remanded to 14 days' iudicial custody.

Police have lodged three FIRs at the Ballia City Kotwali, Nagra and Sikandarpur police stations. The fresh exam will be held on April 13, according to an official statement.

Meanwhile, controversy also arose over the arrest of some journalists in the paper leak case as some locals claimed that the cops also held the whistleblower. The locals claimed that Digvijay Singh and

Ajit Kumar Ojha, the journalists working with news of the paper leak of the English subject of Intermediate, forcing the authorities to cancel the paper. The local administration, however, arrested those journalists, accusing them of being involved in the gang which leaked the paper.

BSP expels three leaders

The Bahujan Samaj Party has expelled its three leaders, including a former legislator, for indulging in indiscipline, a party leader said on Friday.

BSP's Mathura district president Yogesh Kumar said twotime MLA Rajkumar Rawat and two other BSP leaders, SK Sharma and Sonpal, were expelled from the party on Thursday.

Kumar, however, did not mention the period of the expulsion of the three leaders.

Kumar said these leaders did not even attend the party's recent meeting in Lucknow, convened to examine the reasons for electoral losses

He said Rawat was elected from the Gokul assembly constituency in 2007 and the Govardhan assembly con-

stituency in 2012.

Sharma had joined BSP just before elections and had contested the recent assembly poll from the Mathura constituency while Sonpal had contested from Chhata constituency.Sharma, however, claimed he had resigned from the BSP membership on March 11 itself.

Centre returns UP Govt proposal on Scheduled Castes list review

The Union Government has **⊥** returned the proposal for inclusion of 'Koli/Hindu Julaha community' in the Scheduled Castes list of Uttar Pradesh as a synonym of 'Kori'.

The UP Government had sent the proposal over a year ago to the Centre. Official sources said the

Centre had returned the proposal for review by the state government. The Centre examined the proposal in accordance with

the laid down modalities and it was not supported by the registrar general of India (RGI). Sources said the proposal had been returned to the state

government with a request to review or further justify the recommendation in the light of observations of the RGI.

The RGI has laid down modalities for deciding claims

for modification - inclusion, exclusion, correction - in the lists of Scheduled Castes under which the state government concerned has to initiate the proposal with full justifications. Only the Union government has the authority to include or delete any caste and tribe from the list of Schedule Castes and Scheduled Tribes. Several numerically small

castes included in Other Backward Classes list have been demanding their inclusion in SC list. Mulayam Singh Yadav-led Samajwadi party government in 2004 had included 17 OBC castes in SC list. And then it made the recommendation to the Union Home ministry.

The then government had also amended the UP Public Services Act and included the 17 castes in SC list. This law provides for the reservation of OBCs and SCs in government

services, educational institutions and other state supported institutions and other bod-

The next government headed by Mayawati's Bahujan Samaj Party had repealed the amendment in the Act.

The Union government had rejected the proposal of Mulayam Singh Yadav government citing the data from anthropological studies, saying these 17 castes do not qualify the terms laid for determining untouchability.

Several organisations representing various castes listed under OBC had also approached the Allahabad High Court for their inclusion in Scheduled Caste list. The Allahabad High Court, in a recent order in March, had directed the UP government to decide within four weeks about the inclusion of Rajbhar and a few other castes in the SC list.

SC pulls up ED for sealing properties, asks probe agency to take remedial measures

Oil slick

India defends its decision of doing business with Russia in self-interest

■ ew Delhi sees through the blow-hot-blow-cold posturing of the West over its stand on Russia. That the posturing continues and takes on patronising tones is irkon Russia. That the posturing continues and takes on particular some. India's stand is consistent and reflects three things: Primacy to national interest, concern for disrespect of Ukraine's territorial integrity and honouring longstanding relationships with all. It is in neither camp — the West's or Russia's. It does not support war and calls for resolving the crisis through dialogue. India's Prime Minister has had conversations with all dramatis personae in l'affaire Ukraine. And yes, it is in India's national interest to buy discounted fuel from Russia. And yet, the West is playing bad-cop-good-cop with India. March began with US President Joe Biden using the word "shaky" to describe India's position on Russia. Last week, it was US Under-Secretary of State for Political Affairs Victoria Nuland telling India that it is important to the US that India joins it in re-evaluating "where we are with Russia" and "it's important that we do it together". Now it is Deputy NSA for International Economics Daleep Singh saying there are "consequences" to countries that actively "attempt to circumvent or backfill the sanctions". However, in Washington, State Department spokesperson Ned



Price is singing a different tune. He admits that countries have "their own relationship with the Russian Federation". It is a fact of geography and that "is not something that we are seeking to change". The US is only interested in seeing that "the international community is speaking in unison", he insists.

On the rupee-rouble trade, Price's reply was priceless: "That is all well and good. We understand that." India finally seems to have decided to call a spade a spade, understandably because this one-sided diplomatic sparring is neither positive nor reassuring. Foreign Minister S Jaishankar told visiting UK Foreign

Secretary Liz Truss that India is watching for some time "what looks almost like a campaign on this issue" — with reference to India buying discounted Russian oil. He minces no words pointing out that Europeans are among the biggest buyers of Russian gas while India's purchases are minimal. The message India seems to have conveyed is why single out India when Europe is doing the same thing. The fact is that it is the US and Europe that are caught on the wrong foot over Russian gas. Sanctions have impacted domestic gas prices in the US (which faces midterm elections shortly). The US is releasing a million barrels of oil daily to fight the spikes and domestic inflation. In Europe, Germany cannot wean away from Russian gas, sanctions or no sanctions. Russia is threatening to cut off gas supply if European buyers do not pay in roubles. Germany, in turn, is thinking of rationing gas supply internally. Technical difficulties stop the US from replacing Russia as the supplier. And the UK is thinking of permitting fracking again. So, the problems clearly lie elsewhere, not with India.

Need for caution

Baffling as it sounds, the PMs of India and Pakistan have been threatened hours apart

ow, this is as spooky as it gets. Within hours of each other, we were confronted with two confounding news items, both related to the health and well-being of Indian Prime Minister Narendra Modi and his Pakistani counterpart, Imran Khan. The pieces of dark news sent shockwaves not only through the Indian subcontinent but across the world. Understandably, Indian security agencies went into a tizzy after the Mumbai branch of the National Investigation Agency (NIA) received an anonymous email threatening to "bombard" Narendra Modi and "kill more than 20 million (Indian)



people". The email's author, who claimed that the plan was ready and just waiting to be put into action, purportedly said that he would commit suicide so that the conspiracy could not be exposed. There's already hush-hush talk of at least 20 sleeper cells — who are said to be in the possession of 20kg RDX having been activated since February 28 for the 'job'. This is not the first time the security apparatus has received mail threatening

to eliminate Modi. In 2020, the NIA had received a three-word email that issued a direct threat to the PM, stating "Kill Narendra Modi". In 2018, too, a plot to assassinate the Prime Minister in a "Rajiv Gandhi-type" attack was revealed in a letter to the Pune Police.

Meanwhile, India's "independent foreign policy" came in for some fulsome praise by none other than the embattled Pakistan Premier who said the country is "looking for its best interests", referring to India's move to buy Russian crude at subsidised rates as the energy market suffers due to the ongoing war in Ukraine. However, hours earlier, Pakistan's Information Minister Fawad Chaudhary said their security agencies have reported a 'plot' to carry out Imran's assassination. Interestingly, this development comes just a day after the Pakistan Prime Minister said that a foreign nation had sent a message that he needs "to be removed" or Pakistan will suffer consequences, lending credence to claims that there was a conspiracy to assassinate the Pakistani Premier over his refusal to "sell the country". A no-confidence vote against Imran's Pakistan Tehreek-e-Insaf Government is scheduled in the National Assembly for April 3. A few leaders of both the countries have already been assassinated, so there's an urgent need to bring to book troublemakers who plan to disrupt peace on the subcontinent.

Bangladesh still in throes of terrorism



The Sheikh Hasina Government has largely been successful in bringing the culprits to book but the threats of violence are far from over

dhe Sylhet Anti-Terrorism Special Tribunal sentenced four persons to death for killing writer-blogger Ananta Bijoy Das, in Sylhet, Bangladesh, on May 12, 2015. Of the four -Abul Khaer Rashid Ahmed Abul Hossain alias Abul Hussain, Haranur Rashid and Faisal Ahmed — Abul Khaer is in custody. The rest are absconding. The judgment is significant. It focuses on the violent challenge that extremist Islamist terrorist organisations pose to Bangladesh and its secular, democratic humanist civil society, including bloggers who are often atheists decrying religion.

Militant fundamentalist Islamist parties like the Jama'ate-Islami Bangladesh (Jama'at) and associated organisations like Razakars, al-Badr and al-Shams, which collaborated with, and participated in, the horrific atrocities perpetrated by the Pakistani Army during the 1971 Liberation War, crawled into the woodwork, as some of their leaders fled abroad, after Bangladesh's liberation on December 16, 1971. They resurfaced following Sheikh Mujibur Rahman's assassination on August 15, 1975, and were actively promoted by the regimes of the two military dictators, Generals-turned-President Ziaur Rahman and HM Ershad, and the pseudo-civilian Governments which wielded power periodically, that followed. The support continued under the two Governments headed by Prime Minister Khaleda Zia (1991-96 and 2001-06) — the second in coalition with the Jama'at.

The elements clustered around the Jama'at and allied organisations received a boost from the Mujahideen's victory over Soviet forces occupying Afghanistan (December 27, 1979 to February 15, 1989) and the victory of the Taliban, which was formed in 1994 and came to rule almost the whole of Afghanistan from September 1997. Organisations like the Harkat-ul-Jihad-al-Islamiladesh (HUIIB), Jamaat-ul-Mujahideen Bangladesh (JMB) and Jagrata Muslim Janata Bangladesh (JMJB) unleashed



violence on a massive scale that shook Bangladesh.

The United States and other western countries, which had become extremely uneasy since the late 1990s over the medieval, retrogressive polices of the Taliban Government in Afghanistan, and the al-Qaeda's terrorist strikes against the US and other western countries, pressed hard on Begum Zia's Government to act. More serious efforts followed the ascent to power of the second Awami League-led Government, with Sheikh Hasina as Prime Minister, in 2009. The resultant measures caused some subsidence in lawlessness, and the terrorist organisations to go underground.

Two terrorist organisations that rose to salience in their place and made their existence known are Ansar-al Islam, earlier known as Ansarullah Bangla Team, affiliated to Al Qaeda in the Indian Subcontinent (AQIS), and Daesh affiliated to the parent Islamic State in Iraq and Syria (ISIS). They have played a major role in the murder of bloggers, which began with the killing of Ahmed Rajib Haider in Dhaka on February 15, 2013. The attacks on bloggers

followed a series of developments that began with an amendment of the Crimes International (Tribunals) Act of 1973 enacted for investigation into the activities — and prosecution of — persons guilty of genocide, crimes against humanity, war crimes and crimes under international law, during the Liberation War. The Act was amended in 2009 and two International Crimes Tribunals were established in 2010 and 2012 respectively to try war criminals and collaborators. Jama'at and allied organisations, whose leaders had collaborated with the Pakistanis and perpetrated unspeakable atrocities themselves, sprang into violent opposition which grew in spread and intensity as sentences were announced.

Others, however, felt that the sentences were not harsh enough. Matters came to a head when Abdul Quader Mollah, assistant secretary, Jama'at, was sentenced to life imprisonment on February 5, 2013, on six counts of crimes against humanity. While the Jama'at reacted violently, largescale protests broke out demanding the death sentence to Mollah and others convicted of war crimes. Raising these demands, thousands of people,

a majority of them students and youth, began collecting at Dhaka's Shahbag intersection. The gathering became massive and the movement spread to other parts of Bangladesh. Finally, Bangladesh's Supreme Court overturned the verdict and sentenced Mollah to death. He was hanged in a Dhaka jail on December 12, 2013.

Opponents of the war crimes trials responded with murder. As seen above, machete-wielding activists of the Ansarullah Bangla Team (subsequently Ansar-al Islam), killed blogger Ahmed Rajib Haider, who had been active in the Shahbag gathering, in Dhaka on February 15, 2013. Other killings followed. Those murdered included not only bloggers but LGBT activists, Shias, Hindus academics indeed, all opposed to religious bigotry and supportive of humanism, secularism and rationalism. Professor Ali Riaz wrote in 'Bangladesh: Islamist Militancy, Democracy Deficit and Where to Next?' in Al Jazeera (June 28, 2016), "At least 49 people have been killed in the last 17 months." The objective was simple — to create a climate of terror in which nobody would speak out against the warped worldview of fundamentalist terrorists and allied organisations.

Resolute counter-terrorist operations, galvanised by the dastardly attack on the Holey Artisan Bakery in Dhaka on July 1, 2016, in which 20 persons, including 18 foreigners and women, were savagely killed along with five terrorists killed by Bangladeshi Army commandos, have caused the violence to ebb. Nevertheless, it continues — the anti-Hindu riots from October 13 to 19 last year, during which at least 11 persons, including seven Hindus, were killed, was clearly the work of Islamist terrorist organisations. Sheikh Hasina's Government, which took stern action, needs to be vigiiant.

If India and Pakistan can agree to disagree on several controversial issues and display wise nuclear diplomacy, what ails major nuclear powers - US and Russia — from exercising nuclear diplomacy without using Ukraine as a pawn? Yes, India and Pakistan have been fairly controversial as permanent enemies. There are issues, particularly Kashmir, they are least likely to ever agree upon. Not surprisingly, when they chose to pursue their respective nuclear proliferation drives, United States and American media in general opposed them strongly. The United States was acutely apprehensive of India and Pakistan taking to MAD (Mutually Assured Destruction) path by pursuing nuclear



proliferation drive. US failed to secure both India and Pakistan's signature to the Nuclear Non-Proliferation Treaty (NPT). It may be noted that Pakistan stayed away from being a signatory to NPT on the ground that India was not inking it. India and Pakistan are certainly well-versed at hurling verbal missiles at each other, a trait frequently indulged in as part of their respective national electoral campaigns. Certainly, regional history is not devoid of bilateral conflicts they have actually indulged in and/or have been at the verge of resorting to. What stands out significantly is that nuclear diplomacy has restrained the two from being engaged in actual conflict.

The highlight of this diplomacy was the six-point accord reached between the then Indian Prime Minister Rajiv Gandhi and Pakistani President Zia-ul-Haq in December 1985, during latter's visit to Delhi. It was inked during Indian Prime Minister's visit to Islamabad in December 1988. The two countries agreed in principle not to attack each other's nuclear installations. The agreement came into force on 27 January 1991. Under the agreement, the two countries, on first January of every calendar year, are to inform each other of Nuclear Installations and Facilities to be covered by the agreement. The first such exchange of lists took place on January 1, 1992. This year marked the 31st "consecutive exchange" of such lists. True, the same thirty-one years have witnessed tensed Indo-Pak ties over Kargil "war" in 1999 and Mumbai terror strikes (November 2008). They did not however reach the stage of any open conflict. Indo-Pak nuclear diplomacy, resting on their bilateral understanding of nuclear deterrence defies fears raised earlier about their nuclear-status leading to MAD in South Asia. Russia cannot be spared criticism for its moves against Ukraine. Neither can these be justified by citing incidents of American indulgence in more aggressive moves in name of Arab Spring and its Afghanistan policy.

Diplomatically speaking, importance of a superpower's role should rest in limiting escalation of bilateral, multilateral and other differences to stage of any crisis. As the sole superpower, the US is expected to display greater diplomatic wisdom. United States is apparently more concerned about ensuring decrease in power and strength of Russia as well as that of its key ally China. Language used by Washington as well as American media appears to be more focused on hurling diplomatic missiles at Russia and its leaders. United States is certainly targeting Russia with probable purpose of securing Kremlin's diplomatic isolation and strengthening its own diplomatic stature. Prospects of this decreasing suffering of Ukrainians are virtually non-existent. Russia has not yet lost diplomatic support of its allies. Till Ukraine-crisis lasts, the Ukrainediplomacy cannot be viewed as a success. If India and Pakistan can wisely exercise nuclear diplomacy, why can't United States and Russia display greater diplomatic wisdom regarding Ukrainecrisis?

Yogi must plan well to fulfil promises

opulism is a global phenomenon, especially in democratic countries; and it gets disproportionately amplified during elections. By definition, populism could be summed up as catering to the basic needs and aspirations of the common people. It is characterised with public announcements even if it means giving scant attention to the underlying fiscal prudence or economic viability. Nonetheless, populism entails a cost. The schemes and projects drafted in populist rhetoric could be made possible only through adequate funding and planning.

The 2022 Uttar Pradesh assembly elections were no different with regards to the time-tested populism template. In India, populist announcements are known to have played a key role in determining polling outcomes. The electorate are believed to gravitate to a political party which makes superlative and fancy pre-poll promises.

Now that Yogi Adityanath 2.0 Government has re-taken the reins of UP, the tough task of walking the tightrope between fiscal mathematics and populist waitlist has befallen the monk chief minister.

By doing simple calculations based on the 2022 UP manifesto of the ruling Bharatiya Janata Party (BJP) or 'Lok Kalyan Sankalp Patra', it is evident that the new Government would require a substantial budgetary allocation of more than ₹50,000 crore to fulfill its string of populist announcements and sops. Interestingly, the opposition parties especially the Samajwadi Party (SP) and Congress had also promised the moon to the UP voters. However, their defeat at the hustings saved them from the complexities of drawing up an action plan to fulfill the respective election plank.

Meanwhile, the schemes included in the BJP manifesto pertained to all key sectors viz. agriculture, social security, dairy, sugarcane, infrastructure, skill development, employment etc. The estimated expenditure on these heads would be in addition to the common public welfare programmes being run by the state Government.

Sample this: The BJP, in its manifesto, had promised to pump in Rs 25,000 crore in developing a robust network of cold chain and warehouses for the grading of major horticultural crops so that farmers get remunerative prices. The scheme would be known as Sardar Vallabhbhai Patel Agriinfrastructure Mission. Similarly, ₹10,000 crore will be spent on another mega infra spent on facilitating farm irrigation.

To further sweeten the deal, the saffron outfit had promised to undertake a massive ₹5,000 crore modernisation scheme to upgrade the state sugar mills. This is aimed at enriching the UP sugar value chain given the fact that more than 4 million farm households are directly associated with the sugarcane farming and allied activities. Since, the manifesto was hammered out in the backdrop of the farm stir, the document reflected an evident agricultural footprint.

Hungary elections: Fooled again?

Can the Opposition unite in time to defeat Victor Orban?

ussian President Vladimir Putin may not be able to save himself, but he may already have saved another despot, Hungary's Prime Minister Viktor Orbán. There's an election in Hungary next Sunday, and it looks like Orbán may actually win it. A month ago he was trailing the opposition badly, but then Russia invaded Ukraine.

Hungary is one of the newmodel 'soft' dictatorships that look like democracies to the average passer-by. After all, there are no secret police, you can criticise the government publicly, and they actually count all the votes in the elections. Sometimes they find a few extra votes as well, but Orbán really has won three more or less fair

elections in a row Yet he actually is a dictator

('The Viktator', some people call him) despite the free elections. They don't need to be rigged in advance, because Orbán controls almost all the media that the voters get their information from. And he doesn't even need to win a majority of the votes, because the election districts are gerrymandered in his favour He eliminated the 'liberal'

media by making them unprofitable (no government advertising, expensive lawsuits, etc.), and then getting rich friends to buy them up at bargain prices and sing his praises in them. Over 90% of the Hungarian media are pro-Orbán, although there is no

formal censorship. Orbán's greatest success was extending citizenship to over a million ethnic Hungarians who live as minorities in surround-



Hungarian social benefits. They may never have been to Hungary, but they make up one-tenth of the electorate, they take the money - and 95% of

them vote for Fidesz. In the media, there is a ceaseless torrent of hate propaganda against minorities (Jews, Roma, and gays) and especially immigrants. For a dozen years the country has been told that

Fidesz is their only defence against an Islamised Hungary where real Hungarians would be an oppressed minority, although no sane Muslim would ever voluntarily choose to live there.

A depressingly large number of Hungarians, mostly older, poorly educated or rural, believed the whole package, but Orbán's victories also depended on the fact that the opposition parties were chronically at war with one another. This time he many as the United Kingdom

was in serious trouble, because all six of them had managed to come together and back the same candidate

They couldn't agree on much else, so the challenger they chose was a rather colourless centre-right politician called Péter Márki-Zay. Nevertheless, enough people were fed up with the cronyism and the lies that by a month ago Fidesz and the opposition alliance were running neck-and-neck. And then

Russia invaded Ukraine. That should have been a disaster for Orbán, who rivals Donald Trump in his fanboy adulation of Putin. He even had to slam into reverse gear and let 450,000 Ukrainian refugees into the country. That's only a fifth as many as Poland has taken, but it's thirty times as

has accepted so he's safely in the middle of the European pack.

He was just as quick in switching his foreign policy narrative. Instead of holding off the Muslim hordes, now he was keeping Hungary out of the war in Ukraine. "The opposition has lost its mind," he said in rally

on 15 March. 'They would walk into a cruel, bloody and protracted war and they want to send Hungarian troops and guns to the front-line. We can't let this happen. Not a single Hungarian can get caught between the Ukrainian anvil and the Russian hammer.

It's all nonsense, of course. The opposition coalition never said any such thing, and Hungary is a member of the NATO alliance, which constantly declares that under no circumstances will it get directly involved in the war in Ukraine. Hungary couldn't send troops into Ukraine even if it wanted to.

But it worked. By mid-March Fidesz was leading the opposition alliance by a clear 8%, although more recent polls have shown Orbán's lead narrowing. For a people with a reputation for being clever, even cunning the only people who can go into a revolving door behind you, and come out of it in front of you' - Hungarians are embarrassingly naive.

Could this be a clue to why some countries get seduced by these manipulative would-be autocrats while others do not? Are Americans more naive than the Canadians? Are Russians more easily fooled than Ukrainians? Food for thought, but I've said enough.



Strike on Russian oil depot reported as talks resume

Emergency relief and evacubesieged Ukrainian city of Mariupol remained in doubt Friday following reports of Russian interference, while Russian officials accused Ukraine of flying helicopter gunships across a border between the two countries and striking an oil depot.

The governor of Russia's Belgorod region said the alleged airstrike caused multiple fires and two people were injured. A Kremlin spokesman said the incident on Russia's territory could undermine negotiations between Russian and Ukrainian representatives that resumed by video link Friday. "Certainly, this is not something that can be perceived as creating comfortable conditions for the continuation of the talks," Kremlin spokesman Dmitry Peskov replied when asked if the strike could be viewed as an escalation of the war in Ukraine.

It was not immediately possible to verify the claim that Ukrainian helicopters targeted the oil depot or several nearby businesses in Belgorod also reported hit. Russia has reported shelling from Ukraine before, including an incident last week that killed a military chaplain, but not an incursion of its airspace.

The negotiations follow a meeting of Russian and Ukrainian delegations in

Ukraine reiterated its willingness to abandon a bid to join NATO and offered proposals to have its neutral military status guaranteed by a range of foreign countries.

The head of the Russian delegation, Vladimir Medinsky, wrote on social media that Moscow's positions on retaining control of the Crimean Peninsula and expanding the territory in eastern Ukraine held by Russia-backed separatists "are unchanged."

The International Committee for the Red Cross said complex logistics were still being worked out for the operation to get emergency aid into Mariupol and civilians out of the city, which has suf-fered weeks of heavy fighting with dwindling water, food and medical supplies.

"We are running out of adjectives to describe the horrors that residents in Mariupol have suffered," spokesperson Ewan Watson said Friday during a U.N. Briefing in Geneva.

'The situation is horrendous and deteriorating, and it's now a humanitarian imperative that people be allowed to leave and aid supplies be allowed in."

He said the group sent three vehicles toward Mariupol and a frontline between Ukrainian and Russian forces but two trucks carrying supplies were not accompanying them. Dozens of buses organised by Ukrainian authorities to



bring people out of the city had not started approaching the dividing line, Watson said.

On Thursday, Russian forces blocked a 45-bus convoy attempting to evacuate people from Mariupol after the Russian military agreed to a limited cease-fire in the area, and only 631 people were able

to leave in private cars, the Ukrainian government said.

Russian forces also seized 14 tons of food and medical supplies trying to make it to Mariupol, Deputy Prime Minister Iryna Vereshchuk

The city has been the scene of some of the worst suffering of the war. Tens of thousands of residents managed to leave in the past few weeks through humanitarian corridors, reducing the population from a prewar 430,000 to an estimated 100,000 by last week. But continued Russian attacks have repeatedly thwarted aid and evacuation missions

"We do not see a real desire on the part of the Russians and their satellites to provide an opportunity for Mariupol residents to evacuate to territory controlled by Ukraine," Petro Andrvushchenko, an adviser to the mayor of Mariupol, wrote Friday on the Telegram messaging app. In the past few days,

in its war aims, said that its "main goal" now is gaining complete control of the Donbas, where Mariupol is located. The Donbas is the predominantly Russian-speaking industrial region of eastern Ukraine where Moscowbacked separatists have been battling Ukrainian forces since 2014 and have declared two areas as independent republics.

Western officials said there were growing indications Russia was using its talk of deescalation in Ukraine as cover to regroup, resupply and redeploy its forces for a stepped-up offensive in the east.

Russian forces have subjected both Chernihiv, a besieged and blockaded city in northern Ukraine, and the capital of Kyiv to continued air and ground-launched missile strikes despite Moscow saying Tuesday it planned to reduce military activity in those areas.

Elsewhere, Ukrainian forces have retaken the villages of Sloboda and Lukashivka, which are south of the besieged northern city of Chernihiv and located along one of the main supply routes between the city and Ukraine's capital, Kyiv, according to Britain's Defense Ministry.

Ukraine has also continued to make successful but limited counterattacks to the east and northeast of Kyiv, the ministry said. Ukrainian President Volodymyr Zelenskyy warned that Russian withdrawals in the

were just a military tactic to build up strength for new attacks in the southeast.

"We know their intentions," Zelenskyv said in his nightly video address to the nation. We know that they are moving away from those areas where we hit them in order to focus on other, very important ones where it may be difficult

Hours later, Belgorod gov-ernor Vyacheslav Gladkov wrote on Telegram early Friday that the fire at the oil depot "occurred as a result of an airstrike from two helicopters of the armed forces of Ukraine, which entered the territory of Russia at a low altitude." The depot run by Russian energy giant Rosneft is located about 35 kilometers (21 miles) north of the Ukraine-Russia border.

Separately, Ukraine's state power company, Energoatom, said Russian troops pulled out of the heavily contaminated Chernobyl nuclear site in northern Ukraine early Friday after receiving "significant doses" of radiation from digging trenches in the exclusion zone around the closed plant.

The International Atomic Energy Agency said it could not independently confirm the exposure claim. Energoatom gave no details on the condition of the soldiers it said were exposed to radiation, and it did not say how many were affected. There was no immediate comment from the Kremlin.

hina on Friday renewed its ∠criticism of Western sanctions against Russia, as top European Union officials sought assurances from Beijing that it would not help Moscow circumvent the economic measures imposed in response to the invasion of Ukraine.

The Chinese Foreign Ministry also laid blame for the war in Úkraine at least partially on the United States for pushing to expand the NATO military alliance closer to Russia's borders. Twenty-one of the EU's 27 countries are also NATO member states.

At a virtual summit, European Council President Charles Michel, Commission and EU foreign policy chief Josep Borrell were seeking signs from Chinese President and Communist Party leader Xi Jinping and Premier Li Keqiang that Beijing would help to end the war.

China disapproves of solving problems through sanctions, and we are even more opposed to unilateral sanctions and long-arm jurisdiction that have no basis in international law," Foreign Ministry spokesperson Zhao Lijian said at a daily briefing as they met.

Zhao said when it came to Ukraine, Beijing would not be forced to "choose a side or adopt a simplistic friend-or-foe approach. We should, in particular, resist the Cold War thinking and bloc confronta-

"As the culprit and leading instigator of the Ukraine crisis, the ŬS has led NATO to engage



expansion in the last two adding that NATO membership almost doubled from 16 to 30 countries, and pushed "Russia to the wall step by step".

China says it is not taking sides in the conflict but it has declared a "no limits" partnership with Russia and refuses to condemn the invasion. Beijing routinely amplifies Russian disinformation about the conflict, and does not refer to it as an invasion or a war in keeping with Russian practice.

Prior to the summit, EU officials said they would look for signs Beijing is willing to cooperate on bringing an end to the war. The meeting takes place amid rising negative sentiment within the bloc fuelled by China's aggressive foreign policies and trade practices.

Underlying the EU's expectations for China is the possiChinese companies that undermine measures taken against Russia. EU officials point out that 13.7% of China's total trade is done with the 27nation bloc, and 12% with the United States, compared with just 2.4% with Russia.

Officials said they also wish to emphasise the impact the war is having on the availability of fertiliser and global energy and food prices, which are hitting the poorest countries in Africa and the Middle East hardest.

Other topics include China's travel ban on members of the European Parliament: Beijing's economic boycott of EU member Lithuania over its Taiwan relations; the fate of a stalled investment agreement; and civil and political rights under China's authoritarian Communist Party regime.

Protests at SL Prez house over economic crisis, 45 arrested

t least 45 people were arrested and a curfew briefly imposed in most parts of Colombo city after hundreds of protesters gathered outside the residence of Sri Lankan President Gotabaya Rajapaksa demanding his resignation for failing to address the worst economic crisis in the island nation.

A foreign exchange crunch in Sri Lanka has led to a shortage of essential goods such as fuel. Cooking gas, and power cuts that last up to 13 hours a day. On Thursday protesters shouted slogans, directing their ire against what they perceive as the Rajapaksa regime's gross

mismanagement that has exacerbated Šri Lanka's foreignexchange woes.

They also demanded President Rajapaksa's resignation. According to the police, in the protest several, including five policemen, were injured while vehicles were set on fire as a spontaneous expression of public anger over the current economic crisis turned violent.
"As of now 45 people have

been arrested. Five policemen were injured while a police bus, a Jeep and two motorcycles were burnt. The protesters had also caused damage to a police water cannon truck," a senior police official said.

A curfew was imposed at midnight on Thursday covering most parts of the Colombo district and the suburban police division of Kelaniya but was lifted at 5 am on Friday morning.

In the Kelaniya area, protesters had blocked the main Colombo-Kandy road.

Sri Lanka is currently experiencing its worst economic crisis in history. With long lines for fuel, cooking gas, essentials in short supply and long hours of power cuts the public has been suffering for weeks.

Rajapaksa has defended his overnment's actions, saying the foreign exchange crisis was not his making and the economic downturn was largely pandemic driven where the island's tourism revenue and inward remittances waning.

China deal won't include military base, says Solomon Islands

Seeking to counter international fears over its new security alliance with China, the Solomon Islands said Friday it won't allow China to build a military base there.

But that insistence will do little to ease concerns about the pact from the nation's traditional partners that include New Zealand, Australia and the United States.

The leader of neighbouring Micronesia added his voice to those expressing trepidation by invoking the bloody battles of World War II and warning that the pact could again see the South Pacific region become a battleground for much larger powers.

The Solomon Islands government said Thursday a draft agreement of the new security pact had been initialed by representatives from the Solomons and China and would be "cleaned up" and signed.

In a statement Friday, the Solomon Islands government said that "contrary to the misinformation promoted by anti-government commentators" the agreement did not invite China to establish a military base.
"Government is conscious

of the security ramification of hosting a military base, and it will not be careless to allow such initiative to take place under its watch," the statement said.



The statement seemed to more emphatically rule out

the possibility of a base after Prime Minister Manasseh Sogavare had earlier told parliament it had no intention of asking China to build a base.

Sogavare said his nation sought only peace and pros-perity, citing its foreign poli-cy mantra: "We are friends to all and enemies to none." He said it wasn't a secret deal but a sovereign issue.

Under the terms of the draft agreement, China could send police, military personnel and other armed forces to the Solomon Islands "to assist in maintaining social order" and for a variety of other rea-

It could also send warships to the islands for stopovers and to replenish supplies, which had led to speculation about the possibility of China establishing a naval base on the South Pacific islands.

Micronesia President David Panuelo wrote a letter to Sogavare saying Micronesia had "grave security concerns" about the "novel and unprecedented" arrangement.

He said the two small nations had become battle grounds during World War II and that it could happen again as China, the US and Australia asserted themselves in the

"We need to be very cautious here because the Chinese are incredibly aggressive, the tactics that they're deploying into small island nations are quite remarkable," he told Sky

New Zealand Prime Minister Jacinda Ardern this week described the possibility of Chinese military forces stationed on the Solomon Islands as "the potential militarisation of the region." And the US State Department said Washington did not believe China's security forces and methods needed to be export-

Chinese Foreign Ministry spokesperson Wang Wenbin said Thursday that "relevant parties should see the China-Solomon Islands security cooperation objectively and rationally and stop making irresponsible remarks".

'Attempts to provoke,

obstruct and undermine China's friendly relations with the island countries is not popular and will not succeed," Wang told reporters at

a daily briefing.

"China-Solomon Islands cooperation does not target any third party and is not in conflict with Solomon Islands' cooperation with other countries. Instead, it complements the existing regional cooperation mechanisms in a positive way," he added.

The Solomon Islands, home to about 700,000 people, switched its diplomatic allegiance from Taiwan to Beijing in 2019 - a contributing factor to riots in November last year between residents of different islands within the coun-

Australian police have been in the capital, Honiara, maintaining peace since then under a bilateral security treaty established in 2017. It provides a legal basis for the rapid deployment of Australian police, troops and associated civilians in the event of a major security chal-

lenge.
Chinese police are already on the islands conducting a training mission.

The Federated States of Micronesia is home to about 100,000 people. It has diplomatic relations and considers itself a "friend" of China, as well as having a close relationship with the US under a compact of free association.

GST collection rises to all-time high of ₹1.42 lakh cr in March

to an all-time high of Rs 1.42 lakh crore in March as the fiscal year-end frenzy to meet targets saw strong sales and crackdown on evasions brought in more taxes.

The Goods and Services Tax (GST) collection rose 15 per cent annually in March, the finance ministry said on Friday.

With the record collection, the Centre's GST mop-up has exceeded the revised budget target of Rs 5.70 lakh crore set for the previous fiscal ended March 31, 2022

The previous high for collection of revenues from goods sold and services rendered was in January 2022 at over Rs 1.40 lakh crore.

The average monthly gross GST collection in the last quarter (January-March) stood at Rs 1.38 lakh crore, against the average collection of Rs 1.10 lakh crore, Rs 1.15 lakh crore and 1.30 lakh crore in the first, second and third quarters, respectively.

"Coupled with economic recovery, anti-evasion activities, especially action against fake billers have been contributing to the enhanced GST. The improvement in revenue has also been due to various rate rationalization measures undertaken by the Council to correct inverted duty structure," the

ministry said in a statement.

The gross GST revenue collected in March 2022 was Rs 1,42,095 crore, of which Central GST was Rs 25,830 crore, State GST Rs 32,378 crore, Integrated GST Rs 74,470 crore (including Rs 39,131 tlements is Rs 65,646 crore for



crore collected on import of goods) and cess was Rs 9,417 crore (including Rs 981 crore collected on import

During the month, revenues from import of goods were 25 per cent higher while the revenues from domestic transactions (including import of services) were 11 per cent higher than the revenues from these sources in March 2021.

Total number of e-way bills generated in the month of February 2022 was 6.91 crore as compared to 6.88 crore in January 2022 despite being a shorter month, which indicates recovery of business activity at faster pace, the ministry said.

The government has settled Rs 29,816 crore to Central GST and Rs 25,032 crore to SGST from IGST as regular settlement. In addition, the government has settled Rs 20,000 crore of IGST on ad-hoc basis in the ratio of 50:50 between Centre and states/UTs in March.

"The total revenue of Centre and the States in the month of March 2022 after regular and ad-hoc setSGST. Centre also released GST compensation of Rs 18,252 crore to States/UTs during the month," the ministry said.

Deloitte India Partner M S Mani said the record GST collections have also been aided by the strong sales activity of corporates in March as they raced to close the fiscal with high topline growth. This had a direct bearing on GST, which is a transaction tax.

"While state-wise variations exist in terms of the growth in GST collections, it would be interesting to see an analysis linking the statewise GDP growth with the GST collections during the same period,'

NA Shah Associates Partner Parag Mehta said with further reduction in e-invoicing limits to Rs 20 crore from Rs 50 crore, there is bound to be substantial increase even in subsequent months.

"Further in the month of March normally there is also a exercise being conducted by trade to regularise the mistakes etc and deposit the taxes which leads to higher recovery," Mehta added.

Mumbai: Continuing their downward trajectory for the third consecutive week, the country's foreign exchange reserves declined by USD 2.03 billion to stand at USD 617.648 billion in the week ended March 25, RBI data showed on

in the week ended March 18, the forex kitty had declined by USD 2.597 billion to USD 619.678 billion. It had plunged by USD 9.646 billion to USD 622.275 billion in the week ended March 11.

During the reporting week, the fall in the reserves was mainly on account of a decline in the foreign currency assets (FCA), a major component of the overall reserves, as per weekly data by the Reserve Bank of India.

FCA dropped by USD 3.202 billion to USD 550.454 billion in the week ended March 25.

Expressed in dollar terms, the foreign currency assets include the effect of appreciation or depreciation of non-US units like the euro, pound and yen held in the foreign exchange reserves.

Gold reserves increased by USD 1.23 billion to USD 43.241 billion in the reporting week, the data showed.

The special drawing rights (SDRs) with the International Monetary Fund (IMF) dipped by USD 44 million to USD

Biden tapping oil reserve for 6 months to control gas prices

Washington: President Joe Biden is ordering the release of 1 million barrels of oil per day from the nation's strategic petroleum reserve for six months, the White House said Thursday, in a bid to control energy prices that have spiked after the U.S. And allies imposed steep sanctions on Russia over its invasion of Ukraine.

The White House said Biden is also calling on Congress to impose financial penalties on oil and gas companies that lease public lands but aren't producing. And he intends to invoke the

Defense Production Act to encourage the mining of critical minerals for batteries in electric vehicles, part of a broader push to shift toward cleaner energy sources and reduce the use of fossil fuels.

The actions demonstrate forcefully that oil remains a key vulnerability for the U.S. At home and abroad. Higher prices have hurt Biden's

approval domestically, while also adding billions of oil-export dollars to the Russian war chest as it wages war on Ukraine.

The release of reserves in the U.S. Would create pressures that could reduce oil prices, though Biden has already twice ordered releases from the strategic reserves without causing a meaningful shift in oil markets.

Part of Biden's concern is that high prices have not - so far - coaxed a meaningful jump in oil production. The planned release is a way to

increase supplies as a bridge until oil companies ramp up their own production, with administration officials



estimating that domestic production will grow by 1 million barrels daily this year and an additional 700,000 barrels daily in 2023.

The markets reacted quickly with crude oil prices dropping about 4% on Thursday morning to under \$104 a barrel.

Still, oil is up from roughly \$60 year ago, with supplies failing to keep up with demand as the world economy has begun to rebound from the coronavirus pandemic.

That inflationary problem was compounded by Russian President Vladimir Putin's invasion of Ukraine, which created new uncertainties about oil and natural gas supplies and led to retaliatory sanctions from the U.S. And its allies.

Biden has been in talks with allies and partners to join in additional releases of oil, such that the world market will get more than the 180 million barrels total being pledged by

Americans on average use about 21 million barrels of oil daily, with about 40% of that devoted to gaso-

line, according to the U.S. Energy Information Administration. That total accounts for about a fifth of total global consumption of oil.

Domestic oil production is equal to more than half of U.S. Usage, but high prices have not led companies to return to their pre-pandemic levels of output. The U.S. Is producing on average 11.7 million barrels daily, down from 13 million barrels in early

Republican lawmakers have said the problem rests with the Biden administration being hostile to oil permits and the construction of new ipelines such as the Keystone XL.

Democrats have countered that the country needs to move to renewable energy such as wind and solar that could reduce the dependence on fossil fuels and Putin's leverage. Sen. Steve Daines, R-Mt., blast-

ed Biden's action to tap the reserve without first taking steps to increase American energy production, calling its "a Band-Aid on a bullet wound.? Daines called Biden's

actions "desperate moves? that avoid what he called the real solution: "investing in American energy production,? especially oil and gas." Biden needs to stop appeasing the woke green activists and get oil and gas leases going again," Daines said.

The Biden administration has countered that increasing oil output is a gradual process and the release would provide time to ramp up production. It also wants to incentivise greater production by putting fees on unused leases on government lands, something that would require congressional approval.

Sebi slaps ₹51 lakh penalties on 18 entities in ATL case

New Delhi: Sebi on Thursday imposed penalties totalling Rs 51 lakh on 18 entities, including individuals, for misutilisation of IPO funds and certain other lapses with respect to the shares of Acropetal Technologies Ltd (ATL).

ATL raised Rs 170 crore through an initial public offering (IPO) in February 2011. Sebi initiated a preliminary investigation into the company's IPO in February 2012 and later an extensive probe was conducted to ascertain whether there were any violations of regulations.

The probe, which included several entities, revealed a prima facie non-utilisation of IPO proceeds, deviation from disclosures made to NSE and BSE regarding the proceeds' utilisation and non-disclosure of material information, among

The investigation was concluded and the action was approved by the competent authority on March 27, 2017.

According to a 136-page order, Sebi said that ATL, its Chairman and Managing Director Ravi Kumar Doraiswamy are liable for imposition of penalties totalling

Further, the company has been slapped with a separate fine of Rs 2 lakh for providing wrong quarterly disclosures to NSE and BSE regarding utilisation of IPO proceeds.

Sahaj can be filed by an Rs 50 lakh and who receives income from salary, one house property and other sources interest, etc). ITR-4 can be filed by individuals, HUFs and firms with total income up to Rs 50 lakh and having income from business and profession.

ITR-3 is filed by people having income as profits from business/ profession, while ITR-5 is filed by LLPs.

While the ITR-1 form has been kept broadly the same as last year, the new addition to



the form was the inclusion of income from a retirement benefit account maintained in a foreign country for the calcu-

It also seeks details on whether or not the said retirement benefit account was maintained in a notified country under section 89A of the I-T Act. Taxpayers can also claim relief from taxation under section 89A on this income.

Meanwhile, rates of LPG used by commercial establishments like hotels and restaurants, was increased by Rs 249.50 to Rs 2,253 per 19-kg cylinder. However, prices of cooking LPG used in household kitchens were not changed. Rates of such gas were hiked by Rs 50 to Rs 949.50 per 14.2-kg cylinder on March 22.Likewise, there was no change in the price of petrol and diesel on Friday. Prior to the second pause in 11 days, auto fuel rates had gone up by Rs 6.40 per litre.

While jet fuel prices are revised on 1st and 16th of every month, LPG rates change once a month. Petrol and diesel prices are revised daily based on equivalent rates in the international

The increase in ATF price comes on back of the steepest ever hike 18.3 per cent (Rs 17,135.63 per kl) effected on March 16. ATF in Mumbai now costs Rs 111,690.61 per kl, while it is priced at Rs 117,353.71 in Kolkata and Rs 116.583.71 in

Fuel prices have been increased in India because energy prices globally have risen on back of supply concerns following Russia's invasion of Ukraine and demand returning after being hit by the pandemic. India is 85 per cent dependent on imports to meet

Jet fuel, which makes up for almost 40 per cent of the running cost of an airline, has this year surged to new highs. ATF prices have increased every fortnight since the start of 2022. In seven hikes beginning January 1, ATF prices have been increased by Rs 38,902.92 kl or almost 50 per cent.



 $R^{a s h i d}$ Khan has a fast bowler's mindset in a spinner's body with an uncompromising attitude when it comes to ripping his googlies and leg-breaks off the surface at nearly 100 kmph.
At 23, the Afghan spinner

is the most sought-after T20 freelancer on the global league circuit with 436 wickets in 312

Having started the season with an impressive 1/27 for Gujarat Titans, Rashid is extremely hopeful that he can replicate his Sunrisers Hyderabad form for the Hardik Pandya-led franchise.

So is Rashid an aggressive

fast bowler or 'scientist' ready to pull off new tricks?

"I am a spin-fast bowler because of the pace at which I bowl. It is very hard to spin the ball at that pace and for that I think that it requires a different kind of skill-set," Rashid

"The speed at which I bowl is somewhere between 96 kmph to 100 kmph. It is hard to generate turn at that pace but I would rather bowl at that speed than bring it down to 70 75 kmph.

"I have always been a big fan of bowling quick leg spin. I have just been trying different experiments with my bowling in the nets and it's really helping," he added.



The term 'mystery spinner'

is a loosely used jargon to describe any slow bowler that batters find difficult to read over a consistent period of time. "I don't always consider

myself a leg-spinner because, spinners use a lot of wrists and I don't use my wrists that much. I just use top of my fingers and so I am a finger spinner as well in that sense," he said. The 'mystery' comes from
