Imran names ex-CJ as caretaker PM

Pakistan apex court adjourns hearing by a day on rejection of no-confidence vote

PTI ■ ISLAMABAD

 $P_{\hbox{Gulzar Ahmed was on}}^{\hbox{akistan's former chief justice}}$ $Monday \ nominated \ for \ the$ office of the caretaker Prime Minister by incumbent Imran Khan, amid ongoing political crisis in the country. Former information minister and senior leader of the Pakistan Tehreek-e-Insaf party Fawad Chaudhry said that the premier made the decision after approval from the party's core committee.

The announcement comes after President Arif Alvi sent letters to Prime Minister Khan and Leader of the Opposition Shehbaz Sharif on Monday seeking suggestions for the appointment of a caretaker Prime Minister. "In response to the President's letter, after consultation and approval by the PTI Core Committee, Prime Minister Imran Khan has nominated Pakistan's former chief justice Gulzar Ahmed for the post of caretaker Prime

Minister," Chaudhry said. Meanwhile, Pakistan's

Supreme Court on Monday adjourned the hearing by a day but promised to give a "reasonable order" in the high-profile case about the rejection of a no-confidence motion by the Deputy Speaker of the National Assembly and the subsequent dissolution of Parliament.

In his letter, President Alvi told them in case they do not agree on the appointment within three days of the dissolution of Parliament, they shall forward two nominees each to a committee to be constituted by the Speaker, comprising eight members of the outgoing Assembly, or the Senate, or both, having equal representa-tion from the Treasury and the Opposition.

The Constitution has empowered the President to appoint a caretaker Prime Minister in consultation with the Prime Minister and the leader of the Opposition in the outgoing National Assembly, the President's Secretariat said in a statement.

Under Article 224-A(1) of the Constitution of Pakistan, a caretaker government is set up to organise elections in the country. Khan will continue as the PM till the appointment of a caretaker PM. So far Shehbaz Sharif has refused to take part in the process, terming it

try's worst economic crisis. President

Rajapaksa on Monday fired Basil Rajapaksa from his post and invited the Opposition parties to join a unity Cabinet to tackle the raging public anger against the hardships caused by the economic crisis.

On Sunday, all 26 Cabinet Ministers submitted letters of resignation after thousands of people defied a countrywide state of emergency and curfew and joined street protests denouncing the government.

Shah allays Opp fear over Criminal Procedure Bill

Law will ensure police remain 2 steps ahead of law-breakers: Home Minister

PNS NEW DELHI

The Criminal Procedure (Identification) Bill will ensure that police and investigators remain two steps ahead of criminals, Home Minister Amit Shah said on Monday, urging the Opposition not to have any apprehension over the draft law.

Replying to a discussion on the Bill in the Lok Sabha, he said the Opposition members raising human rights concerns must also show concerns over the human rights of those tar-

geted by criminals.

The Bill will act as a defender of human rights of crores of law-abiding citizens, he said, adding that this Bill intend to implement new technologies in the identification of convicts and undertrials in heinous crimes, terrorism, narcotics and atrocities against

women.
Lok Sabha passed Criminal Procedure (Identification) Bill by voice vote, rejecting the amendments proposed by Opposition MPs. Referring to

concerns of some Opposition members over the misuse of data collected under the proposed law, Shah said the world is using database and "we too will have to use it", moving ahead with time.

The database has been in use for two-and-a-half years to solve crimes, including automobile thefts, he said. The Union Home Minister said data will be stored in a protected hardware and those who send samples (for matching) will be sent results and data will not be shared".

He said the Bill has been

brought in to ensure that police and investigators remain two steps ahead of criminals. There should be no apprehensions, he added. Next-generation crimes cannot be tackled with old

techniques, he said.
"We have to try to take criminal justice system to the next era," Shah added. Asserting that the BJP does not indulge in vote-bank politics, he said the Prevention of Terrorism Act was a law in national interest and was repealed for the sake of 'appeasement".

Nitin Agarwal, elected as SP MLA in 2017, had switched loyalty to the BJP, and later he was elected as Deputy Speaker in December last year as a "Samajwadi Party" MLA Agarwal is now Minister of State (independent charge) for Excise. Shivpal on Monday, much to the chagrin of the SP, tweeted a "chaupai" (couplet) from Ramcharitmanas, creating a buzz in political corridors.

Through his tweet, Shivpal described Lord Ram as the best teacher for family and nationbuilding, giving wind to speculation of his switching over to the BJP.

n order to strengthen health systems in Delhi and across the country, the AAP Government inaugurated the 'Centre for Healthcare', 'Allied Medical and Paramedical Sciences' (AMPS) at the Delhi Skill and Entrepreneurship University (DSEU) on Monday.

The centre was inaugurated by Deputy Chief Minister Manish Sisodia. The centre will provide industry-relevant world-class education in

ments including the paramedical domain. Speaking at the occasion, Sisodia said, "If someone would study the history of DSEU, they will come to know that DSEU is the fastest-growing university of India. It has redefined skill-education in India today. There is a mindset deeply ingrained in our society that skill education is always a last resort." Of 2.5 lakh students passing out from Class 12, only 1 lakh are able to make it to good colleges and others suffer to get admission in a good course. In such a situation DSEU is changing the mindset of people towards skill-education very responsibly and has made it a matter of pride," he said.

"Today DSEU launched two new and unique courses in the field of healthcare. Students can take admission for three years in a course but they can finish it whenever they want. They can take diploma certificates in a year also and they will have a number of job opportunities avail-

these courses. These courses at DSEU have been designed according to the aspirations of students," he said.

Chairperson of Delhi Vidhan Sabha's Education Committee and AAP MLA, Atishi said, "In just two years, DSEU has established itself as one of the most prominent State universities and is providing world-class skill education to people of Delhi."

"The need for these programs was felt when Delĥi as well as the whole country was struggling during the second wave of the Covid pandemic, with the shortage of skilled healthcare professionals. If we look at the figures, today in India there are only 44 healthcare professionals available for every 10,000 people, which is 25 per cent of what WHO recommends.

11 new dengue cases

The national capital has reported 11 new cases of dengue, taking the total number of people infected with the vector borne diseases in Delhi to 83 this year.

According to reports released by all three municipal corporations, 14 cases of malaria were also reported in the city till April 2, this year. However, four cases reported in Delhi were from other states and one case address is not provided by

In the years prior to 2021, the total dengue cases reported were 4431 (2016), 4726 (2017), 2798 (2018), 2036 (2019) and 1072 (2020), as In 2015, the number of

dengue cases reported has crossed 10,600 in October itself, making it the worst outbreak of the vector-borne disease in the national capital since 1996.

The number of dengue fatalities logged in 2021 was the highest in the national capital since 2016, when the officially reported death count was 10. Delhi had recorded two deaths due to dengue in 2019, four in 2018, and 10 each in 2017 and

In view of rising cases, the East Delhi Municipal Corporation (EDMC) has prepared an action plan in compliance with the directions of High Court of Delhi for prevention of vector borne dissaid a senior

"The civic body has prepared a short-term plan for 2022-2023 which includes a detailed action plan for the period from January to December 2022. The roles and responsibilities of all the stakeholders including those depart-

ed ones, have been delineated for specific actions in source reduction of breeding, taking care of unavoidable water and rainwater collection in their jurisdictional areas," said a senior official.

"EDMC has also prepared a long term plan, composed of activities specific for each month, where timely execution of control and preventive measures has been specified. Advanced initiatives like active community participation through Public Private Partnership with RWAs of group housing societies, labour intensive anti-larval spray is being transformed into mechanization through procuring six jet machines mounted on vehicles will be purchased," informed a senior official.

"The plan also includes details of supervisory staff in municipal wards of both Shahdara South and North zone and officials of the public health department. Based on the vector borne diseases situation during the year, high risk municipal wards have been earmarked," a senior official

BJP slams Govt over mohalla clinics claims

Pelhi (Bhartiya Janta Party) BJP on Monday slammed AAP-led Delhi Government over its claim that 93 per cent of people are satisfied with the performance of its mohalla clinics, terming the claim as just an illusion to mislead the people'. BJP Spokesperson Praveen Shankar Kapoor said that the AAP leaders are busy in spreading false propaganda and motivated campaign to divert people's attention from the core issues.

"The Government on Sunday issued a statement claiming that 93 percent people are satisfied with the performance of its mohalla clinics but it did not tell when the survey was done and who conducted it," he said.

Highlighting the unhygienic conditions prevailed all around these clinics, he said "These establishments are functioning without appropriate medical staff and the shortage of essential medicines has made it worse. The most intriguing part is that only one doctor deployed to attend around 120 patients in a shift."

Earlier piloting the Bill, Shah said Government's intention to bring the Criminal Procedure (Identification) Bill is to strengthen the law and order and internal security of the country. The Bill seeks to provide legal sanction to the police to take physical and biological samples of convicts as well as persons accused of crimes, he said.

'A lot of the concerns will be addressed with the sending of that prison manual. It has various provisions relating to subjects such as rehabilitation of prisoners, making them part of the mainstream again, limiting the rights of jail officials, maintaining discipline, security of jails, separate jails for women and open jails," Shah said. He urged the members to not see the Bill in isolation but in consonance with the model prison manual that will be introduced later.

Noting that the Bill would replace the Identification of Prisoners Act, 1920, Shah said that the current law has become irrelevant from various perspectives such as the preing crime in courts and strengthening law enforcement agencies. The Bill will not only help in overcoming the problems being faced under the present law but also give strength to evidence gathering, he

Till the powers to prove

crime in courts are not enhanced, in a way it will be impossible to maintain and strengthen the law and order situation and internal security of the country, the Home Minister said, adding that the change in the law is already much delayed. He said that in 1980, the then Law Commission had also recommended revisiting the present law. "After we came to power, we discussed with States and views have been sought on it,' Shah said.

Noting that members expressed a lot of Opposition at the time the Bill was being introduced, Shah said concerns were expressed from the point of view of human and personal rights by them. Their concerns are legitimate but these are already accounted for in this Bill, he said. "If we do not bring about the required changes in the law, we will lag behind in providing courts with the evidence to prove a crime, conviction rate will not increase and in a way help would not be provided in investigations," Shah said.



The Directors are directed to take all actions for restructuring the company in terms of the Memorandum and Articles of Association and take over corrective measures which are in violation of the Memorandum and Articles of Association and of the Companies Act, 2013," the order said. The tribunal on Friday ruled that there was sufficient evidence of misman-

scathing judgment, it said that there were "irregularities of a grave nature of the conduct and affairs" of the club, contrary to the Memorandum of Association. The NCLT on Friday

allowed the Ministry of Corporate Affairs to take over the control of the Delhi Gymkhana Club by nominating 15 people to be appointed as the Directors who will manage the affairs of the Company.

In a 149-page order passed by a two-member Bench of the NCLT, headed by president Justice Ramalingam Sudhakar and Member Narender Kumar Bhola said there was "sufficient a case of mismanagement for the affairs of the club on a petition moved by the Ministry of Corporate Affairs under Sections 241 and 242 of the Companies Act, 2013 alleging that the affairs of Delhi Gymkhana Club were being conducted in a manner preju-

dicial to public interest.

The tribunal had allowed the Ministry to nominate 15 people as Directors on the club's general committee as well as manage the affairs of the club. In April 2020, the Government through Ministry of Corporate Affairs had moved NCLT seeking to supersede club's general committee.

14-point 'Summer Action Plan' on cards: Min Rai

Tn order to tackle pollution in The national Capital on the lines of the 'Winter Action Plan', the Delhi Government will prepare a 14-point 'Summer Action Plan' to deal with the problem, Environment Minister Gopal Rai said on

Rai held a joint meeting with the environment department, the DPCC, the DDA, the MCDs, the fire departments, DUSIB, revenue and all departments concerned on

The Minister said that both long-term and immediate solutions would be implemented from April to September under the 'Summer Action Plan.' The next meeting has been scheduled for April 11 and all departments have been instructed to present their action plans with-

Rai said, "Pollution has always posed a major challenge to Delhi's environmental conservation. The Aam Aadmi Party (AAP) Government in Delhi under the leadership of Chief Minister Arvind Kejriwal, has taken a great deal of measures to reduce the effect of pollution in the State."

As a result of all effective measures taken by the AAP Government to mitigate the problem, a sizable decrease ĥas been recorded in Delhi's pollution levels, he said.

"The level of pollution in Delhi have been studied and surveyed by several agencies like the CSE, TERI, and others, and it has been reported that the sources of the pollution include 31 per cent internal State activities, which is Delhi's own pollution, and 69 per cent is attributed to the surrounding sources of pollution around Delhi-NCR, which has a significant impact on the people

Five shooters of Jhatedi, Bishnoi gang arrested



Special Cell nabbed the men involved in firing at Dwarka businessman after raids at Sri Ganganagar, Hanumangarh

The Special Cell of Delhi I Police has apprehended five shooters of the notorious Kala Jhatedi and Lawrance Bishnoi gang after raids at Rajasthans Sri Ganganagar and Hanumangarh. Police said that these shooters were recently involved in an extortion and firing incident at a businessman in Delhi's Dwarka area.

The shooters have been identified as Sunil Kumar Meghwal (23), Chanderbhan Nayak (22), both residents of Hanumangarh, Deepak Kashyap (25), a resident of Gurugram in Haryana, Deepak (26) and Krishan Gopal Jharoda Kala in Delhi.

According to Pramod Singh Kushwah, the Deputy Commissioner of Police (DCP), Special Cell, on March 30, at about 7:10 PM, three armed shooters barged into the office of a real estate company in Mohan Garden area.

"The owner was given three slips on which 'Kala Jhatedi-One Crore' was written and the shooters also fired at him causing bullet injury in both his legs before fleeing. A case under relevant Sections of the law was registered at Mohan Garden police station," said the DCP.

"The Special Cell inde-pendently started the investigation and visited the spot where the police team studied the modus operandi of this gang with the help of CCTV footage and found that there were five shooters who had come on two bikes to execute the crime," said the DCP.

were received that jailed gangsters Kala Jathedi-Lawrence Bishnoi had hired shooters from Delhi, Haryana and Rajasthan to execute this crime of firing on a real estate businessman for extortion of Rs 1 crore," said the DCP.

"Based on the specific inputs, a police team conducted raids in Sri Ganganagar and apprehended one accused identified as Sunil Kumar Meghwal.

At his instance, raids were conducted in Hanumangarh and four more shooters of this gang were arrested," said the DCP.

"During interrogation, all the accused revealed that they had executed the shootout incident for extortion on March 30 in Mohan Garden at the instance of jailed gangsters Kala Jathedi and Lawrence Bishnoi," said the DCP.

revealed that Deepak Kashyap, Sunil Kumar Meghwal and Deepak, armed with sophisticated weapons had entered the office while Krishan and Chanderbhan waited outside on their bikes," said the DCP.

"As per their plan and in order to terrorise the businessman, the accused fired at the victim's legs. FIR against 2 Twitter handles, newsportal for communal hatred

n First Information Report An First information 2.1.

(FIR) has been registered by the Delhi Police against two Twitter handles of a journalist and a newsportal for allegedly inciting hatred between communities after they claimed manhandling of scribes during the controversial 'Hindu Mahapanchayat' event.

"An FIR under Section 505 (2) (Statements creating or promoting enmity, hatred or illwill between classes) of the Indian Penal Code has been registered in Mukherjee Nagar police station against some Twitter handles for tweets in circulation having content which could incite enmity, hatred and ill-will between two communal groups and investigation is taken up," said Usha Rangnani, the Deputy Commissioner of Police (DCP), Northwest district.

The Twitter handles belongs to journalist Meer Faisal @meerfaisal01, who works for a news portal, and another news portal "Article 14" (@Article14live), said police. In a tweet posted on Sunday, the journalist had alleged that he along with a fellow journalist were beaten up because of their "Muslim identity by Hindu mob".

The official Twitter handle of news portal "Article 14" had also posted a tweet the same day alleging that "five journalists, four of them Muslim, one on assignment for said news portal, were taken to Mukherji Nagar police station after a mob at the event discovered their religion, attacked them and deleted videos". Police, however, had denied any detention. This is fourth FIR registered in connection with the event and no arrest has been made so far, the officials said.

1.3 L CCTVs set up in 70 Assembly segments; max in Patparganj

The highest number of CCTV cameras were installed in Deputy Chief Minister Manish Sisodia's constituency Patparganj during the financial years 2020-21 and 2021-22 as the Public Works Department (PWD) spent around Rs 306 crore on setting up 1,31,792 cameras across Delhi's 70 Assembly segments, Government data showed.

The PWD, which is at the helm of the project, told the Delhi Assembly during the Budget Session last week that the maximum, a whopping 2,829 CCTV cameras, were set up in Patparganj constituency at 1,218 locations. This was followed by Bawana with 2,796 CCTV cameras at 1,204 sites and Rithala Assembly constituency which

has got third highest 2,668 CCTV cameras at 1,315 sites. However, the Gandhi Nagar constituency has none. The information was provided by PWD Minister Manish Sisodia in the House in a reply to Leader of Opposition Ramvir Singh Bidhuri's written question during the Budget Session last week.

Chief Minister Arvind Kejriwal's constituency New Delhi and Health Minister Satyendar Jain's Assembly segment Shakur Basti were on fourth and fifth spots respectively in terms of installation of maximum number of CCTV cameras."As many as 2,552 CCTVs were installed at 1,060 sites in New Delhi Assembly segment while 2,516 such cameras were set up at 1,218 locations in Shakur Basti constituency," the PWD Minister informed the House

3,697 DTC buses equipped with panic buttons, CCTV cameras

The Delhi Transport L Corporation (DTC) has equipped 3,697 of its buses with panic buttons and CCTV cameras, even as 43 vehicles in fleet lack these features, Government data showed. The Transport Department provided information in Delhi Assembly last week during its Budget Session.

In reply to another question by Bharatiya Janata Party (BJP) member Om Prakash Sharma, the department said DTC managed monthly savings of ₹2.32 crore in financial year 2020-21 while corporation's income in same fiscal was ₹454.42 crore. In reply to Aam Aadmi Party (AAP) MLA Pawan Kumar Sharma's question, Transport Minister Kailash Gahlot said, "CCTV cameras and panic buttons are installed in 3,697 DTC buses plying on city roads. However, 43 DTC buses do not have this facility as yet. The matter of installation of CCTVs and panic buttons in these 43 DTC buses is under consideration with Government." The Minister also said that

Citing and appreciating the teamwork shown by the secretaries during the COVID-19 pandemic, the PM said they should act as secretaries of the government of India and not merely as secretaries of their respective departments and should work as one team.

He directed the secretaries to give him feedback and suggest loopholes in policies of the government, including those which are not related to their respective ministries.

More than two dozen sec-

retaries expressed their views and shared their feedback with Prime Minister Narendra Modi, who heard them with an open mind, the sources said.

This was the ninth such meeting of the prime minister with secretaries since 2014.

Not just that, a statement of the book read that the dowry system could help marry off ugly looking girls.

Image of the excerpts of the page from the said textbook with remarks under the subtitle of 'Merits of Dowry' went viral on social media during the day. Twitter users called out the book, saying that it's appalling that such books are part of the curriculum for college-level

Rajya Sabha MP Priyanka Chaturvedi urged Pradhan to

remove such books from circulation. "I request you to remove such books from circulation. That a textbook elaborating the merits of dowry can actually exist in our curriculum is a shame for the nation and its constitution," she said in her letter to Pradhan urging him to immediately stop the circula-tion of the published text book titled 'Textbook of Sociology of Nurses'

The book, authored by TK Indrani, has claimed to elaborate on the merits of dowry and also take it off the curriculum. "It is appalling how such derogatory and problematic text remains in circulation and that a textbook elaborates the merits of dowry. It actually exists in our curriculum and is a shame for the nation and constitution. I have appealed to the minister to have the textbook off the curriculum as well as circulation and review all existing textbooks by a panel of

experts," she said on Twitter. Chaturvedi said it has been

found that a book called "Textbook of Sociology for Nurses" by author TK Indrani lays down "merits and advantages" of the dowry system. This book is part of the curriculum for the second year B SC students. The text book reading for the nursing students also claimed it has been prepared as per the Indian Jursing Council syllabus.

"One of the so-called advantages, as stated, is that because of the burden of dowry, many parents have started educating their girls, When the girls are educated or even employed, the demand for dowry will be less. Thus, it is an

indirect advantage," said Chaturvedi quoting the author.

cases of the fodder scam-Deogarh, Chaibasa, and Ranchi's Doranda treasury cases- and was waiting for judgement in the Dumka case.

The Rs 950 crore fodder scam took place in the Animal Husbandry department in undivided Bihar when Prasad was the Chief Minister. Prasad is in Ranchi jail after his sentence in Rs 89 lakh Deogarh treasury case on December 23, 2017.

 $E^{\text{lectoral trusts and companies in the manufacturing}}\,,$ power, oil, mining, construction, exports/imports and real estate sectors are among those which made donations to the tune of Rs 921.95 crore constituting 91 per cent of the total contribution to political parties from known sources in India in 2019-20. Of them, the ruling BJP got the major chunk of the donations worth Rs 720.407 crore from 2025 corporate donors. The Congress lagged far behind with Rs 133.04 crore from 154 donors while the NCP stood at third place with Rs 57.086 crore from 36

As per data compiled by the Association of for Democratic Reforms (ADR), Electoral Trusts were the biggest donors to the national parties, contributing a total amount of Rs 397.82 crore (a share of 43.15%). The manufacturing sector was the second highest overall contributor, contributing a total amount of

Rs 146.388 crore. With Rs 96.88 crore, the manufacturing sector was the second highest overall contributor in 2018-29.

BG Shirke Construction Technology Pvt. Ltd., was the top donor to NCP in 2019-20. Besides, ITC Limited, Panchshil Corporate Park Pvt Ltd, Muthoot Finance Ltd, Kalyan Jewellers, Modern Road Makers Pvt Ltd were also among the top donors list.

The data showed that these national parties have received the maximum corporate donations of Rs 921.95 crore in 2019-20 (during which the 17th Lok Sabha elections were held); followed by Rs 881.26 crore in 2018-19 and Rs 573.18 crore in 2014-15 (during which the 16th Lok Sabha elections were held).

Corporate donations received in 2019-20 constituted 24.62 per cent of the total corporate donations received between 2012-13 and 2019-20. However, between 2012-13 and 2019-20, donations by corporates to national parties increased by 1,024 per cent, with a drop in the percentage of corporate donations in 2015-

A total of 309 donations through which national parties received Rs 10.555 cr do not have address details in the contribution form; Rs 13.91 crore was received from 144 donations, which do not have PAN details included in the contribution form while Rs 16.19 crore of the Rs 16.215 crore or 99.85 per cent of such donations were without PAN and address details belonged to the BJP.

Among the top corporate donors was Prudent Electoral Trust. It donated to two national parties, the BJP and INC, 38 times each, a total of Rs 247.75 crore, of which Rs 216.75 crore went to the BJP in 2019-20.

After Bharat Biotech, SII slows down its Covid vax production

After Bharat Biotech announced that it is slowing down Covid-19 vaccines production, its Pune-based vaccine competitor Serum Institute of India (SII) too followed suit. The SII said that it had sufficient stocks to take care of both domestic and export demand and hence the current production is almost at a slow pace.

Both the vaccine manufacturers combined have accounted for over 98 per cent of Covid-19 vaccine doses administered in the country. So

far, 1.51 billion Covishield doses and 300 million Covaxin doses have been administered in India, which makes it 98.36 per cent of the 1.84 billion doses administered in the

States have withdrawn restriction on movement of people and not making the vaccination mandatory for venturing out in the public places, both companies have halted production of jabs at their facilities. Sources said that there were no fresh orders from the Government, and their supply commitments have ended as of March 31. SII has accumulated about 250 million doses of Covishield stocks at its Pune facility, while Bharat Biotech said it had completed all its

supply commitments. SII had indicated in December that it was halving However, as most of the the production of Covishield as it had a 500 million doses inventory at its facility. Half of these were finished doses, while the remaining was bulk doses that were not converted to formulation.

Bharat Biotech, had on Saturday said that it will temporarily slow down its Covid vaccine Covaxin's production across its manufacturing facil-

Report: Women in developing countries faced more anxiety, food insecurity during lockdown

Women in developing countries like India faced increased rates of depression and anxiety as well as food insecurity during the Covid-19 induced lockdown, according to researchers including those of Indian origin.

For surveyed women, moving from zero to average levels of lockdowns is associated with a 38 percent increase in depression, a 44 percent increase in anxiety and a 73 percent increase in exhaustion, according to the study from the University of California San Diego's School of Global Policy and Strategy.
"Women whose social position may make

them more vulnerable - those with daughters and those living in female-headed households – experienced even larger declines in mental health as a result of lockdowns," said the paper, to be published in a forthcoming issue of the Journal of Economic Development.

At least, 1,545 households were surveyed over the phone in various rural regions throughout Northern India. The surveys took place in fall 2019, before the pandemic and in August 2020, near the height of the first Covid-19 wave in India.

Threats have been received many times to blow up the Gorakhnath temple with a bomb. In 2010, there was an explosion near Bhim Sarohar Tal located in the Gorakhnath temple complex. However, investigation revealed that it was a Diwali firecracker bomb.

A few days ago, a Twitter handle user named 'Lady Don' had threatened a bomb blast in Meerut, the Vidhan Bhawan in Lucknow, and the Gorakhnath temple. The pivot?

Pawar has given the Congress a leg up by underlining its importance in Oppn space

as Sharad Pawar emerged as the pivot of a national anti-BJP front for the 2024 general elections? He did not hint at it but his assertion that a national alternative to the BJP is impossible without the Congress certainly raises his political stature. By affirming the continued relevance of the Congress to the Opposition space, he has made the 'grand old party' beholden to the 'grand old man' of politics. It is as if he gave Congress the reprieve from fellow anti-BJP parties that it was desperately seeking. The ageing politician cleared the air on certain critical political issues that may influence the future course of action of the anti-BJP constituents. For one, he evinced no interest in becoming the chairperson of the United Progressive Alliance (UPA), a post held by Sonia Gandhi since the UPA's formation in 2004. He is ready to "cooperate, support and strengthen" any attempt to provide an alternative bloc to the BJP but he would not lead it. Doors and options are rarely closed in politics, but that is not the issue here. What is, is Pawar's next statement. It was an admonition for the regional political forces which have been rallying support for an anti-BJP front, excluding the Congress. Citing the case of Mamata Banerjee, who



has been spearheading this movement, Pawar reminded them that while they are strong in their respective regions, the Congress is the only party that "has a pan-India presence". It has a "wide base" and "taking it along would be a practical decision".

If the regional satraps consider his advice "then something could happen", he said, referring to a united front. Facts bear Pawar out. In the 2019 elections, the Congress was either winner or runners-up on 262 seats (268 in 2014) and third or fourth in 141 others. In both elections, nearly 190 seats saw a bipolar contest between the Congress and the BJP. The

Maratha strongman's statement comes a week after Union Minister Nitin Gadkari hoped the Congress emerges as a stronger Opposition because that would help democracy. Gadkari had also pointed out that regional parties trying to take the place of a weakened Congress was not good for democracy. Reams will be written about the hidden meanings in the complementing statements of the two leaders. The Congress rout in the latest Assembly elections frustrated the regional forces. With both sides sticking to their stands, somebody had to come up with a face-saving argument for the regional forces while throwing a lifeline to Congress. Was Pawar that somebody? He did give a fillip to the Congress and it is up to Sonia Gandhi to return the favour one day. The presidential elections in July will tell us if Pawar's remarks have had any impact. The Congress may certainly use the reprieve to strike a chord with the internal dissidents and ready itself for its biggest decision: Who would be the next elected party president?

Trouble next door

India seems to be an oasis as one or the other crisis envelops all our neighbours

his is not to demean any of our neighbouring countries, which are all sovereign States with supposedly responsible Governments to take care of their domestic issues or strife. It is just meant to highlight the dichotomy between the state of affairs in our own country and that of the ones surrounding us on all sides, especially in the light of angry voices that claim that the quality of life and governance



in India has been steadily declining with time. Now, there are problems that a ruling dispensation should/can foresee and strategise for, and then there are some which are unpredictable, swift and calamitous. The Coronavirus pandemic would be an appropriate example of the latter, which left the entire world reeling under its impact with scant regard to the advancement of health infrastructure, economy or geographical placement. On the other hand, the chaos that we are witnessing in the countries adjoining India is the result of their own respective policy misjudgements or poor usage of governance tools: Take the example of Pakistan, Sri Lanka, Myanmar,

Afghanistan or even bigger, stable superpowers such as China and Russia. There's an ongoing political and constitutional crisis in Imran Khan's country; almost similar is the case with Sri Lanka which has had to resort to clamping the state of emergency and curfew. In Myanmar, the rule of the military, known locally as Tatmadaw Kyi, started in 1962, lasting up to 2011, and then resumed in 2021. Almost similar is the case of Afghanistan, which suffered under the Taliban rule from 1996 until October 2001 (soon after the Sunni Islamist nationalist movement's birth in the early 1990s), and which has taken back power in 2021 from a democratically elected Government after regrouping in Pakistan. Speaking of 'democratically elected' Governments, there's just one party's rule in China and one man's rule in Russia. The Russian head of State unilaterally decided on February 24, 2022, to launch a "special military operation" to invade Ukraine, where he now seems caught in a cleft stick. In striking contrast is the situation in India, where eligible citizens have been getting free ration for nearly two years now, and the rule of democracy is healthy and flourishing. Therefore, it would be best for the cynics and naysayers to stop criticising their own country and

take pride in what we have here, and what we symbolise to the world.

How pragmatic is the CUET move?




A common test for admission into Central Universities might just now seem appealing, but it could heavily impact learning in the long run

he recent introduction of a Common University Entrance Test (CUET) for admissions into 45 University Grants Commissionfunded Central Universities (CUs) has raised serious concerns. The move has come about as part of the National Education Policy, which proposes that the CUET, conducted in 13 languages, be made mandatory in 45 CUs to allow admissions using a single national-level test score. The UGC has also clarified that the test shall not disturb the existing scheme of reservations in individual universities.

While the policy would spare admission seekers the trouble of appearing for multiple entrance exams for UG admissions and, also, study for the otherwise attention-demanding Board examinations, the limitations of this standardised test are several. First, it eliminates the value of scores gained in Class XII, limiting the scores to be only a qualification benchmark or an eligibility criterion for taking the test rather than being the sole or even a co-determinant of merit. In simple words, the test, in a single stroke, leaves the Board examinations of Class XII, and even X, of no relevance at all. One of the biggest consequences, perhaps, will be on the learning values of students, which might be significantly hampered. The 'long form' learning that

textbooks and school education aim to provide will be highly neglected and rather be substituted by the urgent need to focus on the objective-type questions fielded in the CUET. It will restrict school education from involving students into any form of creativity and even the extracurriculars. The limited amount of reading or writing skills that are imparted to students in schools will now come down to sticking to only an MCQ-based learning format, heavily impacting subjective disciplines like the arts, social sciences and literature. Where is the room for exploration, creativity, interpretative and illustrative understanding, dealing with ambigu- a "landmark", and might ities or learning the skill of argu-mentation? Well, it's ironic that ing for students seeking



push the coaching industry to introduce new, cost-heavy hybrid courses from Class VI onwards to train students for objective learning at an early stage. The centres for JEE and NEET exams are huge examples of how entrance tests spawn the coaching industry as the hour's need. This, in turn, will replace natural intelligence with 'artificial' intelligence, literally speaking, given that the learning will be based on the recognition of pattern of exam papers and creation of several question banks, which would be available on the internet or practice books in abundance.

Knowledge will therefore be replaced by bits of surfacelevel information, leaving no room for cognitive and constructive learning. To top it all, the policy, introduced amid an atmosphere where education has already faced enough lag due to the COVID-19 pandemic, cannot de termed

These batches might, in fact, face worsening struggles in the longer run when, in a workplace environment, extensive work formats, detailing, structuring and interpretative and analytical skills are deemed mandatory for a job role.

Well, it may be argued that making the Board examination results non-decisive in this matter might be beneficial given the state of regional or state Boards, which involve trust deficit about academic quality and lack of consistent marking patterns. The disparity in the evaluation certainly makes it hard for those scores to be used as an equal parameter in all CUs. However, it is imperative to note here — isn't the strengthening of the State and regional Boards more important than getting rid of their already degraded existence and value? Why not incorporate a change which ensures that Board exams do not lose their value? What if by this move schools altogether lose their relevance as students and parents start relying more on coaching centres? Well, it's important to focus on students actually learning the course matter instead of them becoming fodder for the coaching industry.

Interestingly, the policy has been looked at by the critics through the prism of the Narendra Modi Ġovernment's 'one nation, one standard' motto. However, the Madhuri R Shah Committee in 1984 had recommended the introduction of a national merit examination or a common

eligibility test. Well, taking all these factors into consideration, the questions remain - In a country like India, which has a long way to go in making a mark in entry-level higher education and bridging economic and gender gap, is prescribing a single entrance test as a sole determinant of merit for the higher education system of India pragmatic? Is a hassle-free admission pattern causing hindrance to the quality of education? Will it in any way nourish a child's inner growth and prospering? Is it preparing the students for the real world and workplace challenges? (The author is an indepen-

SALARY FOR IRREGULAR APPOINTMENT

Sir — The Supreme Court has delivered a good judgment holding the State responsible for paying salary to employees in respect of irregular appointments also. A case in point is that a teacher worked for 24 years when his services were cancelled over irregular appointment. The Government viewed the appointment irregular since the employee was a relative of a member of the selection committee and hence his appointment was contrary to rules. The cancellation of the appointment may not be wrong. But ordering for the recovery of the amount paid as salary for the services obtained from him in 24 years goes against the spirit of justice.

Aggrieved by the development, the teacher moved the High Court and then the Supreme Court. The apex court has asserted that "the State cannot take any work from any employee without payment of salary". It also ordered to treat the date of cancellation of appointment as the date of retirement, with direction to pay consequential benefits upon retirement. It is unfair to treat the relationship with the selection committee member as disqualification for an appointed candidate as it amounts to denial of opportunity for a candidate for "the fault of being a relative" of the selection committee member. Another resolution seeking the transfer of Hindispeaking areas to Haryana in lieu of Chandigarh was moved by Baldev Singh Mann on October 31, 1985. On March 6, 1986, a resolution for implementation of the Rajiv Gandhi-Harchand Singh Longowal accord was moved by Om Prakash Gupta. Similarly, on December 23, 2014, another resolution was moved by Iqbal Singh Jhundan, and carried.

INDIAN RETURNEES FACE AN UNCERTAIN FUTURE

The return of Indian students back to the war-torn nation is highly unlikely

any factors contribute to Indian students landing in Ukraine for higher studies particularly in medicine, engineering and other professional streams: lower fees and cheaper living expenses, worldrecognised courses, ease of admission, relative proximity to India, English as medium of instruction, peaceful nature of the country, opportunities to move elsewhere from this gateway to Europe. All these factors make our students finalise Ukraine as their choice of destination. At last count, Ukraine admitted more than 63,000 students from 130 countries of the world. There are numerous consultancies and admission businesses that help students from different countries secure admission in the universities of Ukraine. According to Ukrainian government records, compared to any other country, India sends the largest number of international students to Ukraine. Indian Parliament was informed in June last year that



18,000 Indian students were enrolled in educational institutions in Ukraine, more than in Russia and France (16,500 and 10,000, respectively). Indian students stuck in Ukraine when the war commenced were naturally in a quandary as their career prospects were at stake. Thanks to the efforts of the Indian government, they have returned safe. The few still staying there are hopeful that the present crisis shall pass and normalcy will be restored soon. As big relief to the evacuee students, after earlier admission offers from Kazakhstan, Georgia, Armenia, Belarus and Poland, universities in Russia and Crimea have come to the fore to accept such students especially from medical streams at no additional cost and without entrance tests. In fact, 140 Indian students have already been directly enrolled in the Nicolae Testemitanu State University of Medicine & Pharmacy (SUMP), Moldova. At home, some chief ministers have shown willingness to accept the students from Ukraine. The apex medical regulatory body Indian Medical Association has agreed that the medical students from Ukraine can be adjusted in Indian medical schools as a onetime solution. If the proposal is accepted by the National Medical Commission, multiple functional difficulties are sure to crop up. The actual number of these students may be above 23,000. Even if authorities approved incremental seats beyond its already stretched capacity, teacherstudent ratio shall be adversely affected and lab and other necessary facilities in place may be in disarray. The students are also at different levels and not grounded in Indian curricula. That means, if somehow admitted, they shall face difficulty adjusting and quality of education may be compromised besides impinging on the prospects of domestic students who have qualified NEET. Further, certain universities of Ukraine are not in the approved list in India, and vice versa. Online study in medicine, as suggested by Ukraine, is counter-productive because practical classes are mandatory. Return of the students back to Ukraine is uncertain. The same is the case with China — the thousands of students who returned to India due to COVID-19 are still unable to go back and complete their courses due to denial of permission to international students and lack of visas. For the Ukraine-returned students, much depends on the stance India takes on the Russia-Ukraine tussle. Let us believe, best shall come out. In this context, it is worth noting how intercountry invasions not only devastate the target country to varying degrees but also enervate innocent people of other nationalities residing there. More than just a typically hegemonic move, the current Russian attack on Ukraine can be construed as a reprimand for some perceived or actual faultof significant magnitude by its one-time 'brother'. Given the secretive ethos of mighty Russian President Vladimir Putin and his known history of taking rash, independent decisions, it is difficult to foresee what

Tax buoyancy is a good omen



Efforts to boost tax revenue will come to naught if expenses, particularly on 'welfare schemes', are allowed to grow in an unsustainable manner

Tor years, the tax receipts of the Union Government have consistently fallen short of the target set in the respective year which together with the expenditure exceeding the target has led to fiscal slippage - a glamorous term for the fiscal deficit (FD). Against this dismal record in the past, 2021-22 will have the unique distinction of the tax collections - both direct and indirect - exceeding the target.

The total direct tax collection net of refund as on March 16, 2022 stood at around ₹1363,000 crore which is higher the budget estimate (BE) of ₹1100,000 crore by ₹263,000 crore. It was even higher than the revised estimate (RE) of ₹1250,000 crore - as given by the Finance Minister, Nirmala Sitharaman in the budget for 2022-23 - by ₹113,000 crore.

The gross tax revenue (GTR) net of refunds stood at ₹2050,000 crore till February 2. For the whole of current financial year ending March 31, 2022, this could be about ₹2650,000 crore which is higher the BE of ₹2220,000 crore by ₹430,000 crore. The collection is even higher than the RE of ₹2520,000 crore by

Of the ₹430,000 crore excess of likely actual GTR over BE, while ₹263,000 crore is the excess in direct taxes over its BE, the remaining ₹167,000 crore is primarily in GST collection. During 2021-22, while, gross GST collections have been in excess of ₹100,000 crore every month, in six months, it has even crossed ₹130,000 crore. The year is expected to end with collection of ₹1500,000 crore.

As per the Finance Commission (FC) formula, 41 percent of tax receipts of the Union government - excluding cess collections which are not part of the divisible pool - are shared with the States. After these mandatory transfers to the states, the amount remaining with the Centre could be around ₹1850,000 crore, compared with the corresponding BE of ₹1550,000 crore and RE of ₹1765,000crore.

The excess of ₹300,000 crore in actual net tax receipts by the Centre over the BE (1850,000-1550,000) has helped in making up for the slippage in other areas of revenue as well as expenditure. For instance, proceeds from disinvestment of Government's shareholding in public sector undertakings (PSUs) during 2021against BE ₹175,000 crore leading to a shortfall of ₹161,500 crore.

On the expenditure front, the actual outgo on fertilizer subsidy will be ₹140,000 crore against BE of ₹80,000 crore leading shortfall of ₹60,000 crore. Likewise, the actual payment on food subsidy is ₹286,000 crore against budget provision ₹243,000 crore implying a shortfall of ₹43,000 crore.

Even after providing cover for the slippages under the above three heads which add up to ₹264,500 crore, the excess net

tax collection of ₹300,000 crore would ensure that the FD for 2021-22 remains close to the target of 6.4 percent of GDP. But, the RE of FD mentioned by FM on February 1, 2022 is 6.9 percent. This is because the entire excess of net tax collection is not reflected in the RE. Once the un-reflected amount of ₹85,000 crore (1850,000-1765,000) is captured, actual FD will be close to budget-

Unlike in the previous years when shortfall in revenue from tax collections used to be made up by taking recourse to non-tax receipts such as dividend from PSUs and public sector banks (PSBs), proceeds from selling government shares in one PSU to another, appropriation of surplus generated by the Reserve Bank of India (RBÍ), proceeds from sale of spectrum for telecom services, etc., this time around buoyancy in tax collection is helping in balancing the budget.

This is the way forward as excessive reliance on non-tax getary exercise in an uncertain trajectory (for instance, dividend from a PSU depends on a host of factors specific to the undertakings and there is no certainty that it will deliver a target amount) but also, lead to undue interference in the working of an entity from where the Government is expecting the revenue. For instance, during 2017-18, ONGC, an upstream oil PSU was asked to buy 51.11 percent of its shares Hindustan

Petroleum Corporation (HPCL) forcing the former to borrow over ₹30,000 crore.

Looking at the reasons behind the exceptional buoyancy in tax revenue, it turns out that it is not just the recovery in economic activity (thanks to a muted third wave of Corona pandemic) but no less important is the 'increase in compliance'.

On the direct tax front, the IT department has successfully used technology to reach out to the assesses in non-intrusive ways; for instance, sending e-mail reminding them to file return if not already or generating an 'auto-populated' form - a form in which income of the assesses from various sources is pre-filled. In particular, intensive and extensive use of 'data analytics' and 'artificial intelligence' has prompted assesses to report their income accurately (when he is confronted with a particular figure 'so much capital gains made, there is no way, he can hide or under-state it) and pay tax.

As for indirect taxes, the ture with emphasis on driving all businesses to be a part of the network, truthfully report all transactions (generation of e-way bills, einvoices are mechanisms to make it happen) and prevent fraudulent input tax credit or ITC (an acronym for refund of tax paid by a supplier on purchase of inputs the most crucial provision under GST to prevent cascading effect

of tax on tax) claims. While, these efforts should be continued, there is also dire need to rationalize and simplify the GST system by reducing the number of slabs, doing away with certain exemptions and including petroleum products such as crude oil, natural gas, petrol, diesel etc. The GST Council should promptly take steps in this regard.

In the direct tax area, there is an urgent need to address the anomalies in PIT, CIT and the capital gains tax (CGT). In particular, the existing CGT is a highly differentiated tax structure with varying rates depending on the asset class, holding period, whether the asset is listed or otherwise and so on. It is prone to misuse and evasion. If, the structure is simplified to treat all capital gains irrespective of the source as an addition to assesses' annual income and taxed at the rate applicable to the relevant slab, the Government can rake in huge revenue.

No less important is the need

to rein in expenditure. Efforts to boost tax revenue will come to a naught if the expenses particularto grow in an unsustainable manner. Here, substantial savings are possible by restricting coverage, cutting costs, improving efficiencyetc. For instance, the decision to continue delivery of free food under Pradhan Mantri Garib Kalyan Yojana (PMGKY) for another 6 months- when the pandemic has subsided and the economic activity is gathering momentum - was totally uncalled for.

Ukraine accuses Russia of massacre, bodies strewn in city



Bodies with bound hands, close-range gunshot wounds and signs of torture lay scattered in a city on the outskirts of Kyiv after Russian soldiers withdrew from the area. Ukrainian authorities accused the departing forces on Sunday of committing war crimes and leaving behind a "scene from a horror movie."

As images of the bodies emerged from Bucha, European leaders condemned the atrocities and called for tougher sanctions against Moscow. In a sign of how the horrific reports shook many leaders, Germany's defense minister even suggested that the European Union consider banning Russian gas

Ukrainian officials said the bodies of 410 civilians were found in Kyiv-area towns that were recently retaken from Russian forces

Associated Press journalists saw the bodies of at least 21 people in various spots around Bucha, northwest of the capital. One group of nine, all in civilian clothes, were scattered around a site that residents said Russian troops used as a base.

They appeared to have been killed at close range. At least two had their hands tied behind their backs, one was shot in the head, and another's legs were bound. Ukrainian officials laid the

blame for the killings squarely at the feet of Russian troops, with the president calling them evidence of genocide. But Russia's Defense Ministry rejected the accusations as "provocation."

The discoveries followed the Russian retreat from the area after Moscow said it was focusing its offensive on the country's east. Russian troops had rolled into Bucha in the early days of the invasion and stayed up until March 30.

One resident, who refused to give his name out of fear for his safety, said that Russian troops went building to building and took people out of the basements where they were hiding, checking their phones for any evidence of anti-Russian activity before taking them away or shooting them.

Hanna Herega, another resident, said Russian troops started shooting at a neighbor who had gone out to gather wood for

heating.
"They hit him a bit above the heel, crushing the bone, and he fell down," Herega said.

Then they shot off his left leg completely, with the boot. Then they shot him all over."

The AP also saw two bodies, that of a man and a woman, wrapped in plastic that residents said they had covered and placed in a shaft until a proper funeral could be arranged.

"He put his hands up, and they shot him," said the resident who refused to be identified.

Oleksiy Arestovych, an adviser to Ukrainian President Volodymyr Zelenskyy, described bodies lying in suburban streets as a "scene from a horror movie." He claimed some of the women had been raped before being killed and the Russians then burned the bodies. In a video address, Zelenskyy said Russian soldiers who killed and tortured civilians were responsible for "concentrated evil."

Drug shortage persists in Russia after start of war

"Not a single pharmacy in the city has it now," a resident of Kazan told The Associated Press in late March about a blood thinner her father needs.

Experts and health authorities in Russia say the drug shortages are temporary - due to panic-buying and logistical dif-

ficulties for suppliers from the sanctions - but some remain worried that high-quality medicines will keep disappearing in the Russian market.

"Most likely there will be shortages. How catastrophic it will be, I don't know," said Dr. Alexey Erlikh, head of the cardiac intensive care unit in Moscow Hospital No. 29, and a professor at the Moscow-based Pirogov Medical University.

Reports that Russians could not find certain medications in pharmacies started surfacing in early March, shortly after Moscow unleashed a war on Ukraine, and sweeping sanctions left Russia increasingly isolated from the rest of the world.

Patient's Monitor, a patients'



rights group in the Russian region of Dagestan on the Caspian Sea, began getting complaints in the second week of

Ziyautdin Uvaysov, head of

the group, told AP he personally checked with several state-run pharmacies in the region on the availability of 10 most-wanted medications and "they didn't have a large number of these."

he asked about when supplies would be restocked, the pharmacies replied that "there aren't any and it's unclear when there will be." Despite assurances from authorities that hoarding of supplies was to blame for the quickly emptying shelves, reports about shortages persisted throughout March.
Vrachi.Rf, one of Russia's

biggest online communities for medical workers, surveyed more than 3,000 doctors in mid-March, and they said they had run into shortages of more than 80 medications: anti-inflammatory, gastrointestinal, antiepileptic and anticonvulsant drugs, as well as antidepressants and antipsychotics.

UK: Russia refocusing on Donbas region

 $B_{\text{says}}^{\text{ritain's}}$ Defence Ministry says Russia is continuing to build up both its soldiers and mercenaries in eastern Ukraine. "Russian forces are continuing to consolidate and reorganise as they refocus their offensive into the Donbas region in the east of Ukraine." the ministry said in an intelli gence update posted on social media Monday.

It says Russian troops are being moved into the area, along with mercenaries from the Wagner private military group. Overnight, the UK said Russia was still trying to take the southern port city of Mariupol, which has seen weeks of intense fighting.

Ukraine peace deals: Rounds of parlyes fail to reach a resolution

Another round of negotia-tions between Russia and Ukraine in Turkey has brought little progress towards a ceasefire, let alone a peace agreement. Based on statements by both Moscow and Kyiv, it appears that there is some consensus on the issues that need to be negotiated, but little on what the sides might consider acceptable solutions.

The current Ukrainian position is centred around two main issues: neutrality and territorial integrity. The former will require an amendment to the Ukrainian constitution that changes the current commitment to "the irreversibility of the ... Euro-Atlantic course of Ukraine" and instead provides for the country's permanent neutral status.

While the Ukrainian president, Volodymyr Zelensky, has already committed to a referendum on any agreement with Russia, this will not remove the need for a two-thirds majority in the Ukrainian parliament - the Verkhovna Rada - and a favourable opinion of the con-



stitutional court on whether the amendments are "are oriented toward the liquidation of the independence or violation of the territorial indivisibility of Ukraine". Both of these are required for constitutional amend-

stitutional amendments are allowed "in conditions of martial law or a state of emergency". On the one hand, the

referendum and the super-majority in the Rada will ensure that any approved deal will have the necessary support in Ukraine. On the other it limits the "bargaining space" that Zelensky has in his negotiations.

Neutrality will also require security guarantees. Again, this is something that both Russia and Ukraine agree on. But the two sides differ in how they view this.

Hong Kong leader Lam won't seek new term after rocky 5 years

Hong Kong leader Carrie Lam said Monday she wouldn't seek a second term after a rocky five years marked by huge protests calling for her resignation, a security crackdown that has quashed dissent and most recently a Covid-19 wave that overwhelmed the health system. Her successor will be picked in May, with the city's hard-line security chief during the 2019 protests seen as a likely choice.

"I will complete my five-year term as chief executive on the 30th of June this year, and I will also call an end to my 42 years of public service," Lam said at a news conference. The 64-year-old career civil servant said she plans to spend more time with her family.

Senate panel to vote on Jackson nomination to SC experience in her nine years on

AP ■ WASHINGTON

Democrats are launching a whirlwind of votes and Senate floor action on Monday with the goal of confirming Ketanji Brown Jackson as the first Black woman on the Supreme Court by the end of the week.

The Senate Judiciary Committee kicks off on Monday morning with a vote nomination to the Senate floor. Democrats will then wind

the nomination through the 50-50 Senate, with a final vote in sight for President Joe Biden's pick to replace retiring Justice Stephen Breyer. After more than 30 hours

The ministry said the country's merchandise import last month stood at \$59.07 billion, an increase of 20.79 per cent over \$48.90 billion in the year-ago period. It was up 87.68 per cent over \$31.47 billion in March 2020.

During March 2022, the value of non-petroleum exports stood at \$33 billion, registering a growth of 4.28 per cent over \$31.65 billion in the same month a year ago. Nonpetroleum exports grew by 74 per cent from \$18.97 billion in

Non-petroleum import stood at \$40.66 billion during March 2022, showing a rise of 5.26 per cent over \$38.63 billion in the year-ago month. It was up by 89.79 per cent from \$21.42 billion in March 2020, showed the data from ministry.

Report: India job market rebounds, witnesses 18.4% headcount growth across key sectors

With the country recovering from the third wave of Covid-19 and the economy gradually returning to nor-malcy, the job market witnessed an 18.4 per cent year-on-year growth in March led by travel and hospitality and energy sectors, according to a

Even as the job market has seen recovery, travel and hospitality sector has witnessed a robust recovery at 47.6 per cent growth in payroll headcount in March 2022 as compared to the year-ago period, according to a report by Allsec Technologies.

Travel and hospitality sector was the worst affected due to the pandemic-induced lockdowns over the last two years, the report added.

The report is based on inhouse data from Allsec Technologies, a comprehensive Business Process Services (BPS) provider that tracks the employment trends across various sectors. The overall movement from the previous year has been positive, with several industries showing progress in growing headcount, the

report noted. However, a comparison with pre-pandemic numbers indicates that travel and hospitality sector has not quite bounced back to pre-pandemic levels as it witnessed a 24.3 per cent de-growth in March 2022 as compared to March 2020, but is certainly on way to recovery, it said.

Energy sector followed with a 41.5 per cent annual increase in headcount this year as compared to March 2021. It has notably surpassed pre-pandemic levels with a 42 per cent growth in March this year as compared to March 2020.

On third spot was IT/ITes industry, which witnessed a 27 per cent uptick and logistics saw a 27.3 per cent growth, it

Industries such as finance

and food and beverages showed optimistic y-o-y trends with a growth of 16.6 per cent and 12.9 per cent, respectively, it added. While most sectors have recovered, healthcare (-8.3 per cent) and e-commerce (-1.5 per cent) have witnessed a marginal year-on-year drop in March this year. "We have seen an optimistic recovery pattern across industries this month.

Fin Min: India continues to remain 'highest receiver of FDI'

Union Finance Minister Nirmala Sitharaman on Monday asserted that India continued to remain "highest receiver of the FDI". Her assertion came after Congress member Shashi Tharoor maintained in Lok Sabha that there has been a decline in investments by foreign investors and sought to know the measures from the government to reverse

The Finance Minister also said Indian retail investors have created capacity to absorb the shock due to outflow of foreign funds from country's stock markets. Responding to a question asked by Congress member, she said foreign investments have to be gauged, not just by looking at FIIs and FPIs which by very nature depend on interest rates and they keep on "moving up and down."

"The FIIs and FPIs would

come and go. But, today the Indian retail investors have proven that even if they come and go any shock that may come in is now taken care of because of shock absorbing capacity that Indian retailers have brought into Indian market," she said during Question Hour. "We in House should stand up and appreciate Indian retailer who has invested a lot of confidence in markets today in India," she said. Tharoor had said that overseas investors has pulled out over Rs 1.14 lakh

crore from Indian market so far and wanted to know what measures government was taking to reverse it. "The FPI and FIIs obvious obviously going to be very typical of their very nature coming and going out. But, what's there to look at with fairness and objectivity is the inflow of the FDIs which is remaining unabated," the finance minister said in her

"India is the highest receiver of FDI since before covid and that continues very much significantly during covid and subsequently also," she said. "It is that which indicates if money, which is coming in, is staying invested in this country, thereby creating jobs and prospects for us, not by FIIs and FPIs," she said.

After Tharoor had put question to Sitharaman and she rose to answer it TMC member Saugata Roy sought to butt in to which finance minister took objection to and drew attention of the speaker. She said TMC member is a senior member and should first hear her out instead of taking small pleasure of interjecting her.

'IndAus ECTA will provide more trade opportunities'

The India-Australia Economic Cooperation and Trade Agreement (IndAus ECTA) inked last week will provide more trade opportunities for both countries and help in improving living standards, Australian High Commissioner to New Delhi Barry O'Farrell said here on Monday.

He also said Australia understands India's position. "An Indian Prime Minister 65 years ago outlined a sensible doctrine where he said India was not in business of condemnation but in business of creating conditions in which solutions can be found," Farrell said on India's stand on Ukraine Touching upon IndAus ETCA, he said "it means companies, farmers and technologists in India sell more to Australia and vice versa and that's good for nation.

It helps in living standards, jobs and this also guarantees peace and security in our region.'

He also said "Chinese do not own majority of critical minerals in Australia. We're soon to have a visit from Indian Government along with an organisation called KABIL







Not just a night problem



hile night blindness or nyctalopia is a condition that sounds like a vision problem in the night, the truth is that it can impact eyesight even during the day. In fact, even in the daytime, when one is in a poorly-lit indoor space or where there is dim light, one can experience this problem in the eye. In effect, night blindness involves poor adjustment of the eye in transitioning from well-illuminated surroundings to an improperly or dimly-lit place. A SYMPTOM, NOT A CONDITION

More specifically, it is not a condition in and of itself but instead a symptom of an underlying eye condition that one may have. And the symptom is not being able to see clearly and comfortably in the dark. And it takes unusually long to see clearly after moving from a lighted area to a less-lighted one. Also, when one is having problems driving at night, it indicates the possibility of night blindness. Or when one is facing difficulty in recognising faces in dim light. Some of the other symptoms may include cloudy vision, problems in seeing far away objects, reduced contrast sensitivity, headaches, eye pain, nausea and vomiting.

What happens to the eye in dimly-lit space? Typically, light travels through the cornea, the anterior chamber of the eye, the pupil, the lens and posterior chamber before striking the retina. When people with night blindness enter a low light area, the rod cells in the retina – which serve as photoreceptors and are responsible for converting light rays into electrical signals creating what the brain interprets as images because of some anomaly don't function properly. As a result, the person has problems seeing in the less-lighted area. **CAUSES**

Night blindness can be attributed to a wide range of eye conditions. These can be as follows: myopia, cataracts, vitamin A deficiency, glaucoma, Retinitis Pigmentosa, diabetes and usher syndrome. While in myopia, one has difficulty in seeing far into the distance, it is the clouding of the lens which leads to cataract. Due to vitamin A deficiency, there is a lack of pigments needed for photoreceptor cells to function properly. Then whereas glaucoma is caused by abnormal pressure in the eye damaging the optic nerve, Retinitis Pigmentosa entails retinal damage due thy and the consequent damage to blood vessels resulting in poor vision in dim light and at night. Usher syndrome is a genetic disorder characterised by hearing loss as well as Retinitis

SOME ARE TREATABLE, SOME AREN'T

Of course treatment would depend on the condition which is causing night blindness. So, myopia can be addressed through simple prescription glasses and cataracts can be treated with artificial lens or surgery. For vitamin A deficiency, food rich in this nutrient apart from supplements can take care of night blindness. Glaucoma is treated with eye drops, medications and in certain cases, may require surgery as well. In Retinitis Pigmentosa, low vision aids, UV sunglasses and gene and stem cell therapies are modes of treatment. Diabetes requires good control of blood sugar levels, and if a person's condition advances to diabetic retinopathy, injections and medications, laser surgery and vitrectomy are different ways of treatment.

Of these, the genetic conditions are nearly untreatable and therefore those having night blindness due to genetic diseases may have to live with it. However, there are eye devices and therapies that may help. Even individuals with untreatable conditions can benefit significantly from low vision aids, which help improve their quality of life immensely using special devices and gadgets.

First of all, one should consume food items rich in vitamin A. These could be carrots, broccoli, spinach, strawberry, milk, eggs and foods rich in omega-3 fatty acids such as mackerel and salmon. Maintain a healthy exercise and fitness regime which would keep both eye pressure and blood glucose levels in control. Look out for and manage chronic conditions such as diabetes and hypertension.

Lastly, one should get examined regularly by an eye doctor. At the slightest hint of having symptoms of night blindness, one should get a check-up done and make lifestyle adjustments in response to those symptoms. For example, one should avoid driving at night in case of certain conditions with severe night vision

impairment. In sum, if one has night blindness, one should remember that even in the daytime, one would have difficulty in seeing clearly in less lighted areas. So, it is not only a problem at night.

IMPROVE YOUR GUT HEALTH Switch to a more plant based

It would be good to switch to a diet that is more plant based. Plants are a good source of fibre, which serves as food for the good bacteria in the gut. Flber slows the digestion of carbohydrates and the absorption of sugar leading to more gradual spikes in blood sugar after a meal.

There is one particular kind of fibre called fermentable fibre that helps to reduce harmful bacteria as bacteria. Foods like oats, yams, beans and cashews are good sources of fermentable fibre.

Shift from saturated fats to unsaturated fats:

Replacing foods high in saturated fats like milk, butter and meat with unsaturated fats can reduce insulin resistance. Intake of saturated fat can promote the absorption of a compound called endotoxin from the gut.

When released into the bloodstream, endotoxin triggers inflammation which can cause damage to insulin receptors, thus leading to higher insulin resistance. This can aggravate type 2 diabetes. Some good sources of unsaturated fat are nuts, olives, seeds and tahini.

Get more exercise: A 2011 review of 11 studies

found that when compared to sedentary people, professional athletes had lower levels of certain gut endotoxins and more diverse microbiota. The exact reason is not known, but it could be that exercise reduces inflammation Researchers have found that moderate exercise for at least three hours a week is linked to greater numbers of healthy gut bacteria.

Manage Stress Effectively:
The gut-brain connection is very strong. In fact, the gut is known as the "second brain". Stress can trigger the release of certain hormones like cortisol. Studies carried out in animals have confirmed that lower levels of stress hormones are linked to a healthiclear whether having a healthier microbiome leads to less stress or if it is the other way around. It definitely cannot hurt to use techniques like deep breathing, meditation or yoga to cope with stress. This will ensure that your metab-

olism is as efficient as possible. Stay away from processed

Processed foods are generally high in added sugar, carbohydrates, refined grains and also contain artificial colours and flavours. It would be better to focus on whole foods like beans, nuts seeds, wholegrains, vegetables and fruits. Processed foods are also low in fibre and protein which can help stabilise blood sugar levels.

Rare cancer surgery gives a new lease of life

One of the rarely performed cancer surgeries - Appleby's procedure saved the life of a 54-year-old school teacher from Noida.

She was diagnosed with a large tumour in the pancreatic body that had extended to nearby major blood vessels. Due to the complexity of the tumour position that engulfed several arteries and veins in the abdominal cavity, the challenging procedure took over seven hours. This feat was successfully achieved by a team of GI and HPB oncosurgeon led by Dr Vivek Mangla, at Max Institute of Cancer Care, Vaishali.

The doctor blamed the wrong body posture behind the substantial increase in the multiple skeletal issues in the kids.

"The procedure itself is quite challenging, and to add to the complexity, the case needed a segment of the portal vein be removed with the tumour and the blood flow restored by means of joining the two ends of the veins together.

Though challenging, this procedure was the patient's only chance at having the tumour removed

The tumour could be completely removed successfully in a surgery lasting around seven hours performed by a team of doctors comprising surgeons, anesthesiologists, and radiologists," says

Ministry to spend ₹190 cr on training of athletes for CWG & Asian Games

Inion Ministry of Youth Affairs and Sports has finalised the Annual Calendar of Training & Competitions (ACTCs) for 33 Sports disciplines and earmarked a sum of ₹259 crores for the financial year 2022-23 as Assistance to various National Sports Federations (NSFs). Of this, as much as ₹190 crores will be spent on athletes for their training, foreign exposure, equipment and support staff for Commonwealth Games 2022 and Asian Games 2022.

The budget has been decided based on detailed discussions with 33 NSFs on their planned competition and training calendar for the year 2022-23, with special emphasis on the proposals regarding training and competition requirements of athletes participating in the upcoming Commonwealth Games (CWG)at Birmingham, UK in August, 2022 and Asian Games at Guangzhou, China in September, 2022. The Ministry, in active consultation with the NSFs, has carefully considered and approved every proposal made to further enhance the support being given to Indian athletes who are

bound for these two prestigious international events.

Besides the 33 federations whose CTCs have already been approved by the Ministry, ACTC consultation meetings with 3 more NSFs are in the offing and the budgets for them will also be finalised soon. Union Minister of Youth Affairs and Sports, Anurag Singh Thakur said that the Government has taken note of the plans and proposals for training and competitions submitted by NSFs for the year 2022-23, and particularly with regard to the forthcoming Commonwealth Games 2022, Asian Games 2022 and Para Asian Games 2022, and approved the ACTCs.
He further stated that the funds will

not be a constraint for the preparations of the athletes and that the Ministry will provide all necessary help and support to the players and NSFs. He also advised the players and teams to fully focus on their training, and put in their best performance and thereby make the country proud by winning maximum number of medals at the forthcoming events. Funding to NSFs under ACTC for 2022-23 has been done based on revised norms made effective from 1stMarch, 2022.
