Lankan crisis deepens as 50 lawmakers quit Govt

Sri Lankan President Gotabaya Rajapaksa's Government on Tuesday faced more trouble after the newlyappointed Finance Minister Ali Sabry resigned and dozens of lawmakers walked out of the ruling coalition amid nationwide protests over the country's worst economic crisis.

President Rajapaksa had appointed Sabry after sacking his brother Basil Rajapaksa, who was at the centre of anger within the ruling Sri Lanka Podujana Peramuna (SLPP) coalition

In a letter to the President, Sabri said that he took up the job as part of a temporary measure. "However, after much reflection and deliberation and taking into consideration the current situation, I am now of the view for Your Excellency to make suitable interim arrangement to navigate the unprecedented crisis fresh and proactive, and unconventional steps needs to be taken including the appointment of a new finance minister," Sabry said in the let-

He was among the four new ministers appointed by the President who dissolved his cabinet on Monday and sought to form a unity government.

18 Indian, 4 Pak YouTube news channels blocked

The fake news they spread could impact national security, foreign relations: I&B Min

Months after it blocked 35 YouTube-based news channels and two websites, the Ministry of Information & Broadcasting has now ordered the blocking of 22 YouTubebased news channels and multiple social media accounts, including four from Pakistan, alleging that they were spreading fake news that could impact national security, foreign relations and public order.

This is the first time that action has been taken against the Indian YouTube-based channels since the notification of the IT Rules, 2021 in February last year.

In a statement, the Ministry said that it issued an order on Monday to block 22 YouTube channels, three Twitter accounts, one Facebook account, and one news website.

They had a cumulative viewership of more than 260 crore, and were used to spread fake news, and coordinated disinformation over social media on "subjects sensitive from the perspective of national security, India's foreign relations, and public order".

and integrity of India, public order, etc. "Through the recent blocking order, 18 Indian and four Pakistan-based YouTube news channels have been blocked," the Ministry said, without naming them.

The blocked YouTube channels had a cumulative viewership of over 260 crore, the Ministry said, adding that they were spreading fake news and coordinated disinformation over social media on subjects sensitive from the perspective of national security, India's foreign relations, and public order. According to the Ministry,

multiple YouTube channels were used to post fake news on various subjects such as the Indian Armed Forces, Jammu and Kashmir, etc. "The content ordered to be

blocked also included certain anti-India content posted from multiple social media accounts operated in a coordinated man-

Sonia calls for unity at all levels in Congress

Road ahead for party more challenging than ever, Cong chief says and slams BJP for 'divisive agenda'

ongress president Sonia Gandhi on Tuesday called for unity at all levels in the organisation, while noting that the road ahead for the party is more challenging than ever before and the spirit of resilience of party workers is under severe test.

Addressing a meeting of the Congress Parliamentary Party (CPP), she also hit out at the BJP, saying the ruling party's "divisive agenda" has become a regular feature of political discourse in all States and that history is being "mis-



chievously distorted" to add

fuel to its agenda.

The CPP meeting, the first one being held after the party's debacle in recent Assembly elections in five States, was attended by former Prime Minister Manmohan Singh and former Congress chief Rahul Gandhi, besides all party MPs in both Houses of Parliament.

Referring to the party's performance in recent Assembly elections, Sonia said she is aware "how disappoint-

ed you are" as they have been both "shocking and painful". She said the CWC has met to review the performance and received many suggestions on zation. Many of these suggestions are pertinent and the party is working on them.

Sonia expressed concern over MSMEs being in a "most precarious condition" and no sign that commitments made to farmers are going to be fulfilled in any significant manner. She also noted that prices of cooking gas and oil, petrol, diesel, fertilizers and other essential commodities have risen to "unbearable" limits. She said the nationwide "Mehngai-mukt Bharat" campaign must be sustained.

She said in matters of governance, it is inevitable that some do the real work and lay the foundations while others claim the credit.

Not in India's interest to hike Russian energy imports, says White House

The White House has reiterated that it is not in India's interest to "accelerate or increase" imports of Russian while offering to work with New Delhi to help it reduce its reliance on imports from

Responding to questions on the visit of top Indian-American US advisor Daleep Singh to New Delhi last week White House Press Secretary Jen Psaki told reporters at her daily news conference on Monday that he explained both the mechanisms of the US sanctions and reiterated that any country or entity should be abiding by those.

At the same time Psaki said that reporting energy payments by India are not sanctioned and New Delhi's imports of Russian energy represent only one to two per cent of its total energy imports.



Singh, the US Deputy National Security Adviser, who played a key role in designing American sanctions against Russia, was in New Delhi last week against the backdrop of increasing disquiet among Western powers over India not criticising Russia over its attack Ukraine.

Pak's SC seeks record of proceedings of no-confidence motion

'Want to see validity of Dy Speakers' call to dismiss motion'

Pakistan's Supreme Court on Tuesday sought the record of the proceedings of the National Assembly conducted on the no-trust motion filed against Prime Minister Imran Khan before adjourning the hearing till Wednesday, prolonging the political and con-

stitutional crisis in the country. National Assembly Deputy Speaker Oasim Khan Suri on Sunday ruled that the no-confidence motion was linked with a "foreign conspiracy" to topple the Government and hence was not maintainable. Minutes later, President Arif Alvi dissolved the National Assembly on advice of the PM.

The SC within hours took suo motu notice of it and a five-member bench started hearing the case on Monday. The bench is headed by Chief Justice Umar Ata Bandial and includes Justice Ijazul Ahsan Justice Mohammad Ali Mazhar, Justice Munib Akhtar and Justice Jamal Khan Mandokhail.

During the second day of the hearing on Tuesday, the court directed the Government to present minutes of the proceedings in the National Assembly after the no-confi-

dence motion was presented. Chief Justice Bandial said that the court did not interfere in the matters and only wanted to ascertain the constitutionality of the steps taken by the deputy speaker for the dismissal of the no-trust motion and subsequent dissolution of the National Assembly.

UG admissions in DU through CU-CET only

xcept for the School of Except for the School of Open Learning and the National Collegiate Women's Education Board, admission to all undergraduate courses of Delhi University will only be the Central Common through Universities Entrance Test (CU-CET) 2022.

The admission process to university will be done through the CU-CET 2022 issued by the University Grants Commission (UGC) for all the 45 Central Universities of India. Till last year, admission to DU was done on the basis of cut-off marks in Class 12 board exams.

DU Vice Chancellor Yogesh Singh on Tuesday said, "It is mandatory for all candidates to appear in CU-CET-2022, including those seeking admission to supernumerary seats. The eligibility criteria will be decided on the basis of marks obtained in CU-CET."



reserved for minority colleges, 85 per cent of the marks for admission will be taken from the CU-CET and the remaining 15 per cent will be decided by the colleges, Singh said.

Admission to non-reserved 50 per cent seats will be purely on the basis of CU-CET, he said. "There are three sections of CUET 2022 in which the first section is divided into two parts. It consists of 13 languages in the first part and 20 languages in the second part. It is mandatory for the candidates to appear in at least one language for admission to Delhi University, out of both these

parts combined," Singh said.

■ now and continue business as usual, global temperatures will increase to 3.2 degrees Celsius above pre-industrial levels by the end of the century, bringing with it irreversible and cascading effects of global warming. Global temperatures are already at 1.1 degrees

However, in a ray of hope to the world which is already feeling the impact of climate change, the latest report of the United Nations Intergovernmental Panel on

tainable development.

Climate Change (IPCC) released recently has said the worst can be avoided within a decade if Governments across the world employ carbon dioxide removal (CDR) technologies and methods, make deep cuts in emissions through sus-



As per the IPCC report, global emissions can be halved Celsius above pre-industrial oy 2030 with major transitions in the energy sector, including a substantial reduction in fossil fuel use, highlighting that mitigation action needed to be taken now to limit global warming to 1.5 degrees Celsius.

The IPCC published the third and final part of its sixth assessment report — authored by Working Group 3 — on Monday. Like the two reports that preceded it, this report too reiterates that without deep

cuts in emissions, more extreme climate change will be inescapable, impacting the least developed countries the most. The years between 2010

and 2019 saw the highest emissions in human history (at 56 gigatonnes of carbon dioxide or its equivalent), and the window to adapt to and mitigate climate change is quickly narrowing, said the latest IPCC report.

In order to keep global temperatures to 1.5 degrees Celsius above pre-industrial levels, emissions would need to peak by 2025, and fall right after, with "rapid and deep" reductions following every decade till 2050. 'Modelled mitigation

strategies to achieve these reductions include transitioning from fossil fuels without Carbon Capture and Storage (CCS) to very low or zero-carbon energy sources, such as renewables or fossil fuels with CCS, demand-side measures and improving efficiency, reducing non-CO2 emissions, and deploying carbon dioxide removal (CDR) methods to counterbalance residual GHG emissions," said the report. The CCS refers to highly

contentious technologies that can trap and store carbon dioxide from the atmosphere. According to the report, relying on carbon capture and removal of "hard-to-abate residual emissions" is "unavoidable" if the world is to achieve its net-zero targets. Continued on Page 2

Attack on CM's house: Court nixes bail plea of 8

Delhi Court on Tuesday dismissed the bail Aplea of eight persons arrested by Delhi Police in a case related to the violent protest and vandalism outside the residence of Delhi Chief Minister Arvind Kejriwal recently.

The court denied relief to Chander Kant

Bharadwaj, Naveen Kumar, Neeraj Dixit, Sunny, Jitender Singh Bisht, Pradeep Kumar Tiwari, Raju Kumar Singh, and Bablu Kumar.

Noting that the protesters had no regard even for the directions issued by Delhi High Court which were communicated to them by the Delhi Police that no protest is allowed at the CM house, the Additional Session Judge Naveen Kashyap said that in the present case, it is not a simple case that they protested and ended their protest then and there.

"But as per the investigation carried and reply filed by the Police, despite telling protesters and their leaders, including the present applicants, they can protest at a particular place, they did not comply with the same," the court noted.

It noted that not at one stage but at three different security layers of barricades 1, barricade 2 and barricade 3, they violated the directions of the police officials concerned.

"Further, it may be noted that such pro-



testers had no regard even to the directions issued by High Court which were communicated to them, as per the reply of Delhi Police, that no protest is allowed at CM house, as they still continued with their protest," it said.

It added that "prima facie", it appeared that the accused persons even caused damage to public property and injured the police officials.

"Thus, prima facie it is clear that their fundamental right to peacefully protest is exceeded by them knowingly/intentionally," the court

Misogynistic text: DCW chief writes to Edu Minister

The Delhi Commission for Women (DCW) chief, Swati Maliwal on Tuesday wrote a letter to Union Education Minister Dhramendra Pradhan over a misogynist passage found in a nursing sociology textbook.

The passage which talked about merits and demerits of dowry and enlisted attractive dowry as a merit which helped in getting ugly girls married, went viral

DCW taking cognisance of media reports in the matter wrote the letter expressing disappointment and seeking strict action against the author glorifying the dowry system. It sought penal action against the concerned officials involved in approving the textbook for nursing students and also gave detailed recommendations to the Education Minister for making the curriculum "Gender Inclusive" and "Gender Sensitive"," said an DCW official.

DCW chairperson through her letter also highlighted that the incident was not an isolated one and pointed out the misogynist passage which was recently given by CBSE in the Class X Board Examination. The letter also went on to express grave concern regarding the affects of such passages glorifying dowry in books upon the minds of the young students.

"I was shocked to read the passage on merits of dowry listing attractive dowry as a merit which helps in getting ugly girls married. It's saddening that even in today's India, such regressive beliefs glorifying the evil of dowry are being taught in textbooks. Dowry has and continues to destroy many lives across the country and the accountability in the matter

must be set," said Maliwal.

UG admissions in DU through

The second section of the entrance exam consists of 27 domain specific topics. The third section is based on general knowledge which will be for admission to BA programme only. For admission to most of the programmes of DU, a candidate has to choose at least three subjects from the second section. The second section is classified as two lists B1 and B2. The candidates have to choose the subjects appropriately so that not more than one subject is selected at a time," Singh stated.

While explaining eligibility for admission to most of the BSc programme, Singh said it would be calculated on the basis of Physics, Chemistry, Mathematics or Biology. It is mandatory to obtain at least 30 per cent marks in any one language in CUET.

For admission to Bachelor of Arts, a candidate will have to appear in the entrance test in any one language from section one and in any three subjects from the other section. Merit will be calculated on the candidate in the same subject

and language," he said. "For admission to BA (Hons) Economics, it is mandatory for the candidates to take the test in Mathematics for CUET. Merit for this will be calculated on the basis of marks obtained in the chosen language, Mathematics and any two subjects. However, a candidate can appear for CUET in a maximum of 6 subjects, out of which one must be a language subject. Best score will be considered for admission in DU," he said.

Giving further information, Singh said for admission through Sports and Extra Curricular Activities (ECA), a candidate will have to appear for a performance-based test along with the CUET. Merit for this will be made on the basis of combined score of CUET and performance-based test.

"For BBA, BMS, BBE candidates will have to appear in any one language, Mathematics and as per section 3 of CUET. For BA, BVoc, BCom programmes (popularly known

as "Pass" courses), candidates have the choice of a language plus one subject and a general examination or a three-subject test," he said.

"For admission to linguistic programmes, candidates can choose a particular lan-guage at CUET or take a test in any other language. However, preference will be given to those appearing in the particular language and centralized e-counselling will be also done after the test," he added.

Minority colleges like Jesus and Mary, St Stephen's and Sri Guru Teg Bahadur Khalsa have 50 per cent seats reserved for minority communities. Haneet Gandhi, Dean (admissions), said candidates will be able to appear for the CUET only in those subjects which they have studied in class 12. The merit will also be calculated on the basis of a combination of only those subjects in which the candidate has appeared in the CUET, she said. There will be no disadvantage to anyone on changing the stream, Gandhi

Lankan crisis deepens as 50 lawmakers quit Govt

Main opposition leader Sajith Premadasa urged the government to pay heed to the protesters whom he said have suffered with hardships experienced recently.

Speaker Mahinda Yapa Abeyawardene summoned a meeting of the party leaders to decide on a two-day debate on the current economic and political crisis which will be held

on Wednesday and Thursday. The ruling coalition, which had won 150 seats in the 2020 general elections and went on to increase its numbers through defections from the Opposition, lost the support of at

The names of the 41 lawmakers to leave the coalition were announced by party leaders in Parliament. They have now become independent members, leaving Rajapaksa's government with fewer than the 113 members needed to maintain a majority in the 225-

member house. The government, however, claimed that it commands simple majority. Sri Lanka is currently experiencing its worst economic crisis in history. With long lines for fuel, cooking gas, essentials in short supply and long hours of power cuts, the public has been suffering for months. The ruling coalition commanded 157 votes out of 225 at the last vote held on the government budget. However, Rohitha Abeygunawardena, a SLPP lawmaker, said that the government was rock solid with 138 mem-

The President had invited the Opposition parties to join a unity Cabinet to tackle the raging public anger against the hardships caused by the economic crisis. But the Opposition parties rejected the offer.

Despite the declaration of the state of emergency and a weekend curfew, people joined the protests calling for the resignation of Rajapaksa throughout the island on Tuesday. Protesters even blocked the access roads to parliament.

The protests took place in all parts with a large crowd thronging opposite the prime minister's official residence here. In Parliament, several government members who were under siege from protests blamed planned action by the opposition groups to intimidate them in their homes.

It was observed that a significant amount of false content was published by the Indian YouTube channels related to the ongoing situation in Ukraine, and aimed at jeopardising India's foreign relations with other countries," it said.

The Ministry said that the blocked Indian ÝouTube channels were using templates and logos of certain TV news channels, including images of their news anchors to mislead the viewers to believe that the news was authentic. "False thumbnails were used, title and thumbnail of the videos were frequently altered to increase the virality of content on social media.

ED cracks down on Satyendar Jain's kin

Attaches assets worth ₹4.81 crore in a money laundering case

ssets worth Rs 4.81 crore Alinked to Aam Aadmi Party (AAP) Minister Satyendar Jain's family have been attached by the Enforcement Directorate (ED) in a money laundering case. According to officials, the attached immovable properties belong to Akinchan Developers Pvt Ltd, Indo Metal Impex Pvt Ltd, Paryas Infosolutions Pvt Ltd, Manglayatan Projects Pvt Ltd, JJ Ideal Estate Pvt Ltd, Swati Jain, Sushila Jain and Indu Jain. The attachment by the ED was made in a Disproportionate Assets (DA)

The ED had initiated a money laundering investigation based on an FIR registered by the Central Bureau of Investigation (CBI) against Jain and others under relevant

Code and Prevention of Corruption Act.

"Investigation by the ED has revealed that during the period 2015-16, when . Satyendar Kumar Jain was a public servant, the above-mentioned companies beneficially owned and controlled by him received accommodation entries to the tune of Rs 4.81 crore from shell companies against cash transferred to Kolkata-based entry operators through the hawala route. These amounts were utilised for direct purchase of land or for the repayment of loans taken for the purchase of agricultural land in and around Delhi," said an ED.

Jain is the Minister for health, power, home, PWD, industries, urban development, flood, irrigation and water in the AAP Government.

The money laundering case against Jain stems from an August 2017 FIR filed by the CBI against him and others on charges of alleged possession of disproportionate assets.

The CBI has claimed that



Jain purchased 200 bighas of agricultural land in the names of companies controlled by him in Delhi in five years preceding 2018 and "laundered black money" to the tune of several crores of rupees. It had alleged that Jain controlled these companies in the past either in the form of being one of the directors or by holding one-third of shares of these firms in his name or in the

MCD unification Bill cleared in RS amid Opp protests

 $T^{\text{he Rajya Sabha on Tuesday}}_{\text{passed a Bill to unify the three municipal corporations of}}$ Delhi with voice votes after negating all amendments sought by the Opposition. The Delhi Municipal Corporation (Amendment) Bill, 2022 was piloted in the Upper House of Parliament by Home Minister Amit Shah. The Lok Sabha had passed the Bill, which seeks to amend the Delhi Municipal Corporation Act of 1957, on March 30.

According to the Bill, the unification of the municipal corporations will ensure synergised and strategic planning and optimal utilisation of

Replying to the Rajya Sabha, Shah said it has been Delhi Government meted out step-motherly treatment to the civic bodies.

Shah said that it was a mistake to trifurcate the Municipal Corporation of Delhi (MCD) into three bodies in 2012 but added that they could still have functioned normally, had the Delhi Government not treated them in such a manner.

This Bill is in no way an attack on the federal structure," Shah said, allaying concerns raised by some Opposition members.

"The Centre has the power to amend the Bill. I am wondering why Chidambaram (former Home Minister P Chidambaram) is not here. I will try to speak to him tomorrow (Wednesday) provided he takes my call," said Shah on a when his and Chidambaram's photo exchanging pleasantries remained talk of the media.

Delhi is only a Union Territory and not a full State, he said, adding that Parliament has competence to frame laws for Delhi and that is why it has brought this Bill.

Dismissing the Opposition charge that the ruling dispensation at the Centre brought in the Bill out of fear of losing the civic elections, Shah said the BJP has no such phobia and is ready to contest the polls soon after delimitation.

"It is being alleged that the Bill has been brought due to fear of losing elections. But if elections are held after six months, will you lose," he asked Opposition members.

He said the BJP has no fear of losing or arrogance of victory and is fully geared up to contest the polls.

The three municipal corporations control around 1,400 sq km of the city and their smooth functioning is necessary for the citizens of Delhi and the country.

Call meeting of NCR States Mins on air pollution: Rai

Gopal Rai writes to Bhupender Yadav to form a joint plan to fight air pollution in city

n order to fight air pollution In order to light an pollulin the national Capital, Delhi Environment Minister Gopal Rai on Tuesday wrote a letter to Union Environment Minister Bhupender Yadav, urging him to immediately call a meeting of the environment ministers of NCR States and experts to form a joint plan to fight air pollution.

Citing a report by the Centre for Science and Environment (CSE), Rai said that around 31 per cent of the air pollution in Delhi comes from local sources and the rest is from outside.

"It is clear that all NCR States will have to work together to reduce air pollution in Delhi. I had on November 7, November 11 and December 3 urged you to call a meeting of NČR States. Once again, I request you to immediately convene a meeting of environment ministers of NCR States and experts to form a joint plan to reduce air pollution," said

Rai further said that the number of good and moderate air quality days in the city had increased and poor air quality days reduced in the last four years on account of the anti-air pollution steps taken by the Arvind Kejriwal-led Aam Р́arty (AAP) Government.

Earlier on Monday, Yadav had told the Lok Sabha that the Arvind Kejriwal Government has the responsibility of reducing pollution in the national

He was responding to a question by BJP MP from Delhi Parvesh Sahib Singh, who slammed the AAP Government for its alleged lackadaisical attitude towards solving Delhi's pollution probAddressing a press conference, Rai said on Monday: "I have repeatedly requested the Centre to tackle the air pollution issue at the regional level. It's not our problem alone. We have been taking steps to reduce pollution from local sources. We demand that the Centre conducts joint review meetings with the States on a monthly basis."

The Delhi Government had on Monday announced that it will prepare a summer action plan to fight pollution in the Capital on the lines of a similar plan being implemented in the winter.

Rai said the plan will focus on road dust, industrial pollution, open burning of garbage, fires at landfill sites, increasing green cover on the roadside, rejuvenation of water bodies, parks, sapling plantation, tree transplantation monitoring, phasing out of single-use plastics, development of an ecowaste park, city forests, urban farming among others.

The Delhi High Court on Tuesday issued a notice to the Centre on a Public Interest Litigation (PIL) filed by BJP leader Ashwini Kumar Upadhyay, seeking implementation of a 'Uniform Banking Code' for Foreign Exchange Transactions to control black money generation and Benami

A Division Bench of Acting Chief Justice Vipin Sanghi and Justice Navin Chawla asked the Ministry of Home Affairs, Ministry of Law and Justice and the Ministry of Finance to examine the matter and file a reply within four weeks. The matter is fixed for May 25

In his petition, Upadhyay has sought direction to ensure that Real Time Gross Settlement (RTGS), National Electronic Funds Transfer

(NEFT) and Instant Money Payment System (IMPS) are not used for depositing foreign Indian

Upadhyay submitted that the immigration rules for a visa are the same whether a foreigner comes in business class or economy class, uses Air India or British Airways, and comes from the US or Uganda. The petition states that a 'Uniform Banking Code' would help in controlling black money generation and benami trans-

He also urged that International Money Transfer is the only mode which should be permitted to be utilised for transfer of funds from foreign sources in Indian bank accounts as it will leave a stamp with regard to identify and source of the funds. It is submitted that Foreign

Inward Remittance Certificate (FIRC) must be issued and all international and Indian banks must send the link through SMS to get FIRC automatically in case foreign exchange is being deposited in the account as converted INR.

Moreover, only a person or company should be permitted to send Indian Rupees from one bank account to another bank account inside the territory of India through the RTGS, NEFT and IMPS and international banks should not be allowed to use these domestic banking transaction

As per the petitioner, the code will control the menace of bribery, black money, benami transaction, tax evasion, money laundering, profiteering, grain hoarding, etc. It will also control mafia activities including land mafia, drug mafia, liquor mafia, mining mafia, gold mafia, transfer-posting mafia, betting mafia, hawala mafias

EDMC has no cash, plan to solve problem: Atishi

The Aam Aadmi Party (AAP) MLA from Kalkaji, Atishi on Tuesday said that East Delhi Municipal Corporation (EDMC) does not have money, land or an adequate plan to solve the garbage problem of the Ghazipur landfill site.

Tuesday, Chairperson of the Environment Committee of the Delhi Legislative Assembly also sought explanations from the EDMC on what steps had been taken to clear the Ghazipur landfill site and prevent fires as well as the data on garbage management. The EDMC has no plan of action for remediation of legacy waste at the Ghazipur landfill site; how will the growth of the garbage mountain ever end?," Atishi asked. of legacy waste is lying at the landfill site which continues to be a long-standing problem for Delhi's residents and is leading to various health issues. The EDMC Commissioner said they have been able to clear only nine lakh tonnes of waste in the past 1.5 years. The Commissioner also pointed out that the Waste to Energy Plant located in Ghazipur hasn't been functioning since the bankruptcy of the private partner. The plant is undergoing renovations and is only expected to be operational

90% people feel most don't own masks: Survey

survey by LocalCircles, a Asocial media platform that raises people's voices revealed that as several states have decided to end the mask mandate amid the declining COVID-19 cases and 90 per cent respondents believe that most people either do not have a mask or are not wearing it properly.

According to LocalCircles, the survey received more than 30,000 responses from people residing in 349 districts of India. The respondents were asked questions to understand where things stand currently in regards to masking compliance as states remove the mask mandate".

As per the survey, 57 per cent of the respondents said that most of the people in their areas have a mask but don't wear it properly, while 22

As many as 11 per cent of the participants said, "Most don't even have a mask with them now". Only 7 per cent respondents said that most have a mask and wear it properly, while 3 per cent did not have an opinion, the survey found.

Around 68 per cent of the respondents were men while 32 per cent were women, it said, adding that 48 per cent of the respondents were from tier 1, 31 per cent from tier 2 and 21 per cent from tier 3, 4 and rural districts.

Also, of those who are wearing masks, 66.67 per cent are wearing a "cloth mask" which provides limited protection from the viral infection, the survey showed. Several states, including Delhi, Haryana, Telangana and Maharashtra, have lifted COVID-19 restrictions and made use of face masks optional in public places in view of the decline in COVID-19 cases

across the country.

Paramedical staff on strike for reinstatement of jobs PNS NEW DELHI at the session sites

Para medical staff like lab technicians, temporary nurses and computer data entry operators (CDEOS), who worked with the Delhi government for Covid-19 special duty, are feeling a neglected lot as they lamented that while they were declared as 'Corona warrior' during pandemic and as the infections have started declining, their services have

been abruptly terminated.
They have been protesting for the last six days near Delhi Secretariat, urging the State Government to reinstate their jobs or provide alternate jobs. The para medical staff from eleven zones across the city had congregated at the venue to seek justice for their demand.

"Hiring of additional manpower (Doctors, Nursing Personnel and CDEOS) for vaccination activity is not to be extended beyond March 2022. Due rationalization and utilization of this additionally hired manpower is to be done

at the session sites till 31st March 2022," an official order dated March 24 read.

At the venue, Kajal Sharma, ANM from South Zone said that they were employed on contract during Covid duty, initially for three months which was later extended renewed in a phased manner to ten more months for Covid vaccination programme. "But now they have suddenly asked us to not come to duty. Our demand is to adjust us in some other medical facilities such as mohalla clinics or dispensaries. After all we also have our families to fend upon."

Asim Raja, a lab technician from North district said that they were just given a day's notice through SMS. We should be adjusted in the Delhi Health Services as we have been playing an important role in the vaccination programme. We have been demonstrating for last six days but so far no one has come from the Government to listen or grievances, they rued.

Opp slams Govt in LS for 'chest thumping' for students' evacuation from Ukraine

With Union Ministers nar-rating the hardships and success in evacuating students from war-torn Ukraine in the Lok Sabha on Tuesday, Opposition MPs lamented that students were asked to chant slogans in favour of the Government and termed it as a self-defeating spectacle.

Initiating the debate on the issue, Congress MP Manish Tewari criticised the Government, saying he had never seen such "self-congratulatory ecstasy" as displayed during the evacuations.

India has a long history of conducting such evacuations and it has conducted 23 such evacuations since 1962-63, including from Burma, Kuwait, Lebanon, and Libya, Tewari said as he lauded the way students were brought back from the European nation.

"But I regret to say that I have never seen the kind of chest thumping and the kind of self congratulatory ecstasy that was at display during the recent evacuations. Making young students chant slogans in favour of the government in



airplanes by ministers of the government of India, I think it was a self-defeating spectacle,'

Tewari said, "I know friends from that side of the House leave no stone unturned and with every breathe try and criticise the first Prime Minister of India Jawaharlal

Shashi Tharoor asked the Government to use its influence to mediate a truce between Russia and Ukraine engaged in a war for over 40 days. He said that India should not shy away from taking a morally correct position in line with its foreign

Referring to the softlyworded statements on the Russia-Ukraine war at the United Nations, Tharoor said, We need to take a principled stand on such matters... With moral conviction." In this case, Russia has started the war, he said and added that India can-

not endorse Moscow's action.

On India getting a lot of military supplies from Russia, Tharoor said the country pays in "top dollars" and it was not a one-way relationship. The former Union Minister also expressed concern about the emerging Russia-China-Pakistan axis. With Russia becoming weak on account of sanctions, China will get an

upper hand and "it is a matter of great concern" for India, he Hitting back at Opposition

Over 5 lakh fell prey to coronavirus: Govt in RS

The Government on Tuesday I informed Parliament more than five lakh deaths have taken place so far due to the corona pandemic. However, no deaths occurred due to a shortage of oxygen, it said.

Giving these details in the Rajya Sabha, Minister of State for health Bharati Pravin Pawar also said 97 per cent population was administered the first dose of the anti-corona vaccine. Moreover, 85 percent of people got the second dosage of the vaccine.

Twenty states and union territories (UTs) have responded and none of them have reported confirmed deaths due to oxy gen shortage, the minister said during Question Hour.

As on 4th April, 2022, states/UTs have reported a total of 5,21,358 deaths due to Covid-19 in the country. The government of India maintains data of total cases and deaths due to Covid-19 reportstates/UTs on a regular basis," she told the Elders.

Replying +to supplementaries, Pawar said, "the Union government has requested states/union territories, and 20

states and Union Territories have responded and none of them have reported confirmed deaths due to oxygen shortage.' She said some states are even now updating and reporting deaths due to Covid-19 on the ministry's web portal.

Responding to a query by Shaktisinh Gohil(Congress) that the government had promised Rs 4 lakh as compensation for Covid deaths and why this money was not being given, Bharati said the government has issued guidenes transparently.

The country now has 300 plus laboratories, over five lakh oxygen supported beds, 1.5 lakh ICU beds, over 4,000 PSA plants, over 60,000 ventilators and all emergency facilities have been upgraded, Pawar said. She also said a new biosafety level (BSL)-3 mobile laboratory is also being added for the detection of new strains and viruses.

The Saradha group is alleged to have run a chit fund scam with operations spread in last year.

A bench of Justices Ajay Rastogi and CT Ravi Kumar said that Rule 2.2 of Madhya Pradesh Police (Non-Gazetted) Service Rules of 1997 clearly indicates that name has to be sponsored by the deceased Government employee or the survivor parent.
"Rule 2.2 of the scheme

clearly indicates that the name has to be sponsored by him/her, the deceased Government employee. Indisputedly, in the instant case the name of the petitioner has not been sponsored by her mother for the reasons best known to her. The question which has been raised by the petitioner is answered by rule 2.2 of the scheme of rules, needs no further consideration

ED attaches ₹11 crore assets linked to Raut in PMLA case

The Enforcement Directorate (ED) ticked off the ruling Maha Vikas Aghadi (MVA) once again on Tuesday, as it attached provisionally properties worth ₹11.5 crore belonging to three persons, including Shiv Sena leader Sanjay Raut's wife Varsha Raut, under the Prevention of Money. under the Prevention of Money Laundering Act (PMLA) in a case relating to the alleged irregularities in the Patra Chawl redevelopment project in

On the heels of it attaching Rs 6.45 crore worth properties of chief minister Uddhav Thackeray's brother-in-law Shridhar Patankar and 11.35 crore worth properties belonging to Sena's influential MLA Pratap Sarnaik, the ED attached immovable properties worth Rs 11,15,56,573 under PMLA in connection with the alleged irregularities in the Patra Chawl redevelopment project undertaken by Guru Ashish Construction Pvt Ltd at Goregaon in north Mumbai.

Apart from that of Varsha Raut, the other individuals -whose assets have been provisionally attached -- are businessman Pravin Raut, a relative of Sanjay Raut, and Swapna Patkar, wife of Sujit Patkar

Sanjay Raut.

The attached assets are in form of lands held by Pravin M Raut, former director of Guru Ashish Construction Pvt Ltd, Mumbai at Palghar, a flat at Dadar of Varsha Raut and plots at Kihim beach at Alibaug jointly held by Varsha Raut wife of Shri Sanjay Raut and Swapna Patkar, wife of Sujit Patkar," the

ED said in a statement.

The ED's action came as a follow-up of the arrest of Pravin Raut under PMLA on February 4 in connection with an alleged finding that Pravin had received Rs 100 crore from Housing Development and Infrastructure Ltd (HDIL) and "diverted" it to various accounts of "his close associates, family member, his business entities' including the family of Sanjay

Reacting to the attachment of properties belonging to his wife and close associates, Sanjay Raut put out a tweet: "Satyameva Jayate" (truth shall triumph).

Later talking to media persons, Sanjay Raut said: "I am not one to get scared, seize my property, shoot me, or send me to jail, Sanjay Raut is Balasaheb Thackeray's follower and a Shiv Sainik, he'll fight and expose everyone. I am not one to stay quiet, let them dance.

"If it is proved I have amassed property in an illegal manner, then I will donate the entire property to the BJP," the Sena MP said, while reiterating that the ED was acting at the behest of the ruling BJP.

In its investigations conducted on the basis of an FIR registered against Guru Ashish Construction Pvt Ltd by an executive engineer of MHADA, the ED found irregularities in the redevelopment of Patra chawl redevelopment project undertaken as per a tripartite agreement was signed between the Maharashtra Housing and Area Development Authority (MHADA) and Guru Ashish Construction Pvt Ltd, a subsidiary of HDIL.

Under the tripartite agree-Guru Ashish Construction Pvt Ltd was to provide flats to 672 tenants of the chawl, develop flats for MHADA and then sell the remaining area to private developers, develop flats for MHADA and thereafter remaining flats were to be sold by the developers.

However, the directors of

Guru Ashish Constructions, including Pravin Raut, allegedly misled MHADA and managed to sell the floor space index (FSI) to nine developers and collected Rs

901.79 crore without constructing the rehab portion for 672 displaced tenants or the MHADA portion.

"Further, Guru Ashish Construction Pvt Ltd has also launched one project namely Meadows and took the booking of amount (of) around Rs 138 crore from flat buyers. The total proceeds of the crime generated by directors of Guru Ashish Constructions Pvt Ltd through the illegal activities was approximately Rs 1,039.79 crore. A part of the proceeds were transferred to the close associates," the ED statement

The ED has also alleged that in 2010, a part of the proceeds of crime of Rs 83 lakh was transferred to Varsha Raut from Madhuri Raut, wife of Pravin Raut. "This amount was utilized by Varsha Raut for

is also revealed that after initiation of ED investigation, the amount of Rs 55 lakh was transferred by Varsha Raut to Madhuri Raut," ED said.

Tuesday's was the third major attachment of property linked to the Shiv Sena leaders. It may be recalled that on March 22, the ED had attached provisionally Rs 6.45 croreworth immovable properties belonging to a company owned by Maharashtra chief minister Uddhav Thackeray's brotherin-law Shridhar Patankar at Thane in an alleged money laundering case.

On March 25, the ED attached two flats and a parcel of land worth Rs 11.35 crore owned by influential Sena MLA Pratap Sarnaik at Thane in an alleged money laundering case relating to NSEL fraud.

⊣he Central and State investigating agencies were set on a collision course on Tuesday, as the Maharashtra Government set up a Special Investigation Team (SIT) to look into the allegations that the Enforcement Directorate (ED) was running a major "extortion racket" in the

In a development that came on a day when the ED attached properties worth Rs 11.15 crore worth belonging Shiv Sena MP and spokesperson Sanjay Raut's wife Varsha Raut and two other associates, Maharashtra Home Minister Dilip Walse-Patil set up an SIT to investigate allegations that the ED was "extorting" money from the builders and others at the behest of the ruling BJP at the Centre.

Walse-Patil said that Additional Commissioner of Police Viresh Prabhu would head the SIT probe. "We have set up a SIT to investigate these allegations. The SIT is headed by Additional Commissioner of Police Viresh Prabhu. We will give whatever time period required for its investigations".

Earlier, the Mumbai Police Economic Offences Wing (EOW), monitored by a Deputy Commissioner of Police, was conducting the investigations,

One Jitendra Chandralal Navlani, who is a director in seven private companies is acting as the keeper of the ill-gotten wealth and benami properties of ED officials and BJP leaders," Raut had alleged.

Raut had said that on February 28, he had submitted a detailed 13-page complaint to Prime Minister Narendra Modi and Rajya Sabha Chairman and Vice-President M Venkaiah Naidu and was awaiting action from the Centre.

"I have also given around 50 big names of people indulging in money laundering to the Enforcement Directorate (ED) with thousands page of documentary evidence. But, the ED has not yet any action on my complaint. It is ironically that the department responsible for preventing money laundering has itself become a money launderer," Raut said.

Peering into you

Delhi ranks first among the world's most surveilled cities, but what about privacy?

he remote glass eye watches you at 1,31,792 spots in the national Capital of Delhi. That is the number of CCTV cameras the Arvind Kejriwal Government has installed across the city's 70 Assembly segments. The highest number of cameras (2,829) is installed in Patparganj, the Assembly constituency of Deputy Chief Minister Manish Sisodia. The New Delhi constituency of Chief Minister Arvind Kejriwal comes fourth with 2,552 cameras. The Government has spent ₹306 crore so far on the project, according to a detailed report submitted to the State Assembly last week. Last August, Forbes India issued some data saying New Delhi ranks first among the world's most surveilled cities with 1,826.6 cameras per square mile. London comes second with 1,138.5 cameras. Chennai is third and Mumbai, 18th. At that time, Kejriwal tweeted that he felt "proud" that Delhi beat cities like Shanghai, New York and London with most CCTV cameras per square mile. Completing a work in time may be a matter of pride for him, but turning Delhi into a surveillance city could be a matter of concern for others. The CCTV camera network is expanding across India. Some reports say nearly 1.5 million cameras are spread among India's top 15 cities with Delhi leading the way, followed by Hyderabad,

Chennai and Indore. Before India smarts under criticism like China for having become a surveillance State, there is a need to check out a couple of issues.

One, whether the presence of the cameras has stemmed the crime rate? Two, whether or not the cameras are installed respecting the privacy of the citizens or is it a case of large-scale monitoring of people without their consent? Random surveys show that cities with a high concentration of cameras also figure high on the crime index and vice-versa. The cameras are useful more to deconstruct a crime rather than to prevent it. And there are increasing instances of people

petitioning the courts against the intrusion of these cameras into their lives. Urban psychologists say the Governments go into the surveillance mode to deter crime whereas surveillance is strictly a matter of policing. A classic example is the Telangana police that relies heavily on surveillance. Amnesty International has even alleged that the State police indulges in discriminatory policing by unwarranted use of both CCTV cameras and facial recognition technology. The cameras do have their uses so long as their use is regulated, controlled by due process and subject to oversight. It is pertinent to recall here that the Delhi Government was taken to court by parents and teachers associations some time ago when it decided to install CCTV cameras inside classrooms in Government schools. The Madras High Court recently rejected a Tamil Nadu police request to install cameras inside clubs and recreation centres to monitor suspected gambling activities. These instances underline the need for selectively operated surveillance systems that balance people's privacy against public interest and safety.

ers!) since the 1930s. It actually started in 1880, when the island got lost in the shuffle of the British transferring remaining Arctic territories to Canada. Due to the use of predominantly outdated, 16th-century maps, the small island was not explicitly included in the transfer, and as such wasn't even recognised until decades later. This 'war' lasted until 2005, when both the Nato allies agreed to resolve the dispute citing the presence of the Russian Army in the Arctic region. Speaking of Russia, there's another pertinent point flowing out of the contentious barrel. Since its "special military operation" in Ukraine on February 24, there's been an international boycott of Russian vodka,

from the US to Australia, as a means of protesting the invasion by targeting one of the most iconic products of President Vladimir Putin's country.

Returning to the issue at hand, the bad blood between Delhi and Gurugram is actually old wine in a new bottle, which started around mid-November last year when Delhi notified its new excise policy which allowed liquor vends to offer hefty discounts for the first time ever. People naturally went crazy and it resulted in hundreds of metres-long serpentine queues in violation of the COVID-19 guidelines before the AAP Government was forced to ban the strapping discounts on February 28. But the city Government's decision late last week to allow booze discounts up to 25 per cent has kicked off a fresh price war with Gurugram, which is obviously miffed at the challenge thrown its way in being called the 'cheapest liquor adda' in the NCR (liquor in Haryana does not have an MRP; it just can't be sold below the minimum price). Meanwhile, as the prudes throw up their hands in despair and anguish, the lesser mortals and the AAP Government are rubbing theirs in glee. A word of cau-

t is eminently clear why the Government has shown no sense of urgency in appointing a permanent Chief of Defence Staff (CDS) to replace late Gen Bipin Rawat, who was killed in an accident on December 9, instead of merely nominating an officiating one — Army chief, Gen MM Naravane, who has been given additional charge of CDS. Senior serving officers from the Integrated Defence Staff and Service Headquarters have been whispering that the Government has had its eyes fixed on Vice Chief of Army Staff, Lt Gen Manoj Pande, previously Eastern Army Commander, an engineer who belongs to the cosmopolitan city of Nagpur, otherwise famous for the headquarters of the Rashtra Swayamsevak Sangh (RSS). His father is a reputed academic from Nagpur University. Gen Pande was relocated as VCOAS on February 1 after two senior Lt Gens had retired.

The IDS officers point to the fact that the Government, which claimed resolve and boldness in appointing the CDS, the first in 70 years, went limp after Gen Rawat's death and let strategic issues in CDS ambit freeze and drift. While admitting that the controversial CDS paper on Integrated Commands was circulated to stakeholders and comments sought in six months, there were other key projects on the anvil which had the Rawat imprimatur and have since gone cold. They said one reason the Government was constrained in announcing the appointment of new Army chief was the restrictions imposed by the Election Commission and that the appointment would be made after March 10, when election results would be announced. But nothing like that happened because a Lt Gen senior to Gen Pande was still in service till March 31. Their most telling observation was that the CDS void had given an opportunity or Defence Secretary Ajay Kumar, whose portfolio became a tri-service team of advisors extremely restricted on the for- on international defence mation of Department of cooperation led by an IFS



Military Affairs, to resuscitate his remit and enlarge strategic space which he has ably done.

One can recall that when DMA was established, former Defence Secretary Sanjay Mitra said the Government can do without a Defence Secretary and that the military should have a role in formulation of defence policy. Currently, Kumar is the principal coordinating secretary of four other Secretaries in the MoD, which includes the multi-tasked CDS who is also Secretary DMA and is several notches above Defence Secretary in the Warrant of Precedence. Besides articulating defence policy, the Defence Secretary is responsible for capital acquisition, international defence cooperation and minor routine issues. Kumar recently acquired a defence advisor, Lt Gen (Retd) Vinod Khandare, who was previously military advisor to National Security Council Secretariat in the PMO and DG Defence Intelligence Agency. Kumar aiready nas

Senior officers fear that the longer the Government takes in appointing CDS, Kumar will make hay. In any case, Gen Naravane, who is popularly tipped to become the CDS, will not have the charisma, heft and experience of Rawat to preserve and promote military turf. The DMA threatens the traditional bureaucratic supremacy over the armed services.

On March 31, the last of the Lt Gens senior to Gen Pande retired, clearing the way for him to be appointed the COAS. By current reckoning, the Government will announce his promotion anytime after March 31 as the Army chief to take over from May 1, when Gen Naravane superannuates. The office of CDS will have been lying vacant for more than four months when a CDS could have been founder member of the pointed in a few weeks, had the Government shown the same alacrity it had while appointing one. It let

two Lt Gens go and waited for another Lt Gen, all senior to Gen Pande, to retire paving the path for his elevation. The Government has apparently taken a laidback approach in appointing a CDS showing unusual sensitivity in not dislocating the line of succession in the Army — a concern it ignored while appointing Gen Rawat as the Army chief when he superseded two senior Generals.

The real story, as officers explained, Government's fixation in making Gen Pande the COAS. He is capable, technically suave and the first Engineer officer ever to rise to assume the ultimate command. While Infantry, Armoured Corps and Mechanised Infantry are the three combat arms, Artillery and Engineers are combat support arms and their officers also make it to General cadre and Army chiefs. It is the Government's prerogative to select and appoint a service chief, especially the COAS. It is said that Gen Pande, owing to his background, was politically most acceptable and hence the nearly five-month delay. There is no consistency in Government's appointments policy. It follows what is appealing and best suited in the ruling party's interest. When Gen Rawat was appointed the Army chief over two other Generals, Government cited his exceptional operational experience in counter-insurgency, different operational theatres like J&K and North East and UN peacekeeping. Gen Pande may not be comparably gifted but managed seniority and in a way deep

DIFFERENTLY ABLED

The practice of societal indifference results in failure to tap their potential

he perception about persons with disabilities, the differently abled, is still discriminatory in today's society. Many "negative myths" and superstitions are prevalent. They are considered as objects of pity and disability is commonly associated with illness or disease. Consequently, their potential remains untapped and that is a great loss to the society. Ten per cent of the world population suffers from one or more disability. In India, it is difficult to find but the 2011 census says about 2.68 crore are differently abled. That comes to 2.21 per cent of the population. The media plays a major role in forming and molding the public perception about differently abled persons. However, despite the technological advancement and advent of digital media, mass media in India still remains inaccessible for persons with disabilities. Generally, the media depicts people with disability in accordance to the common stereo-



types such as the two extremes of "pity" and "heroism". Tracing the history of portrayal of people with disability in media, we find that since early days, the disability issues were projected through documentary films. The medical and nursing students were exposed to disability sector by showing them educational silent films on hospital patients with various disabling conditions. The films made on World War I veteran patients with symptoms of catatonia, extreme Post Traumatic Stress Disorder (PTSD) (shell shock) symptoms and many other such films are available for viewing even today. The disability conditions of World War I veterans inspired the prominent Minnesota politician and newspaper publisher, Michael J. Dowling (1866-1921) who was himself a quadruple amputee to further the cause of veterans with disabilities by make films on them. Way back in 1918, he filmed himself doing routine tasks and got the other films on disability screened for groups such as the American Medical Association. Immediately after World War II, when returning veterans with war related disabilities were being reintegrated into the society, it was found that media portrayals of disability became more normalizing and acceptable. However, during the mid-20th century, a backlash of intolerance towards disability was observed. Some researchers felt that this may have been related to society's reaction against any identifiable "difference" as a result of Cold War tensions. In the modern times, the arts, film, literature, television and other modes of mass mediafiction works are responsible for portraying stereotypical depictions of disability. These created images are frequently normalized through repetitions to the general audience. Once such a stereotype is observed and accepted by the mainstream public, it continues to be repeated in the media, maybe in slightly varies forms, but staying close to the stereotype. As a pioneering effort, the Community Radio Association of India in association with Blind Welfare Council, Dahod, Gujarat conducted a two-day National Orientation-cum-Training Workshop in March. The objective was to create awareness, identify emerging issues, trends and strategies for promoting the concept of inclusive society in the area of disability and human development through community radios, to provide insight and opportunity in the requisite skills for practicing community radio professionals in new era of digital information technology by using available accessibility tools and specific skills and techniques in radio production and discuss about making quality radio programmes on issues related to disability such as prevention, identification, intervention and rehabilitation of persons with disabilities. There is a need to organize many more workshops for media professionals and to prepare accessible information, educational and entertainment materials in digital format for children and persons with disabilities. The media houses, organizations and media professionals should come forward to understand and highlight the issues pertaining to the people with disabilities in the right prospective.

Yogi sets targets for the first 100 days



In a proactive decision for Government accountability, the UP CM says that from now on, Ministers will make presentations of projects during Cabinet meetings

n 2017, when Yogi Adityanath was declared a "surprise" Chief Minister of Uttar Pradesh, eyebrows were raised. Questions were asked how a Mahant of a temple, with no administrative experience, can run a state as crucial as Uttar Pradesh. Political pundits prog-nosticated that Yogi would be replaced with a "more seasoned" politician mid-way of the tenure. But this saffron-clad Mahant of Gorakshanath peeth (Mutt) not only completed his tenure but also led the BJP to a stupendous victory creating a history of a sort, as he became the first Chief Minister in over three and half decades to be re-elected after completing five years

When Yogi took charge in 2017, he was a bit shaky. His reliance on bureaucracy was palpable as he held his first cabinet meeting after almost a fortnight. In his 2.0 government, the confident Yogi not only held the meeting with the council of min-isters the very day he took the oath of office and secrecy but also held the cabinet meeting the next day where he announced the extension of the free ration distribution scheme for ration cardholders for the next three months. Chief Minister Yogi Adityanath held a meeting with all the principal secretaries and secretaries of the government and discussed the promotion of industrial investment in UP as well as the effective implementation of the development projects.

The demeanour of Yogi in his 2.0 government reflects the confidence he has gained from the first tenure. This is echoed by the way he set the agenda of 100 days for the State Government in which he focused on generating jobs, improving infrastructure, and attracting investments for the state. Chief Minister announced the holding of a grand ground-breaking ceremony in the next 100 days with a target to attract investment of ₹10 lakh crore. This ceremony will be held in Lucknow and is likely to be attended by Prime Minister Narendra Modi.

The Chief Minister had organized an Investors' Summit in Lucknow on February 21 and 22, 2018, almost a year after he was sworn in as Chief Minister for the first time. During that summit, he formulated an industry-friendly new industrial policy. The first investor summit was attended by the eminent industrialists of the country and 1065 MoUs worth ₹4.65 the presence of Prime Minister Narendra Modi. Within six months, in July 2018 the first ground-breaking ceremony was held in which projects worth ₹60,000 crore were started. During this summit, the Government had prepared a complete roadmap through the policy to promote industrial investment in UP. Then the Yogi Government had also promoted the One District One Product (ODOP) scheme to promote the traditional industries of every district. Later, the Union Government adopted this scheme and

As he has set a clear agenda for overnance, Yogi made the work difficult for the ministers as he made it clear during his first meeting that a Ministerial rank is not a matter of prestige alone, it comes with a big responsibility as well. He ordered that no minister will be allowed to leave Uttar Pradesh without taking permission from the Chief Minister. The CM has issued this instruction to prevent unnecessary visits of ministers to Delhi on the pretext of official work. Now if any minister goes out of UP for any work, he will have to tell why he is going and whether the tour is Government or personal. Besides he also suggested that they should not buy new cars or furniture for their office or home. The Rajya Sampatti Vibhag, (the department which looks after the renovation of the bungalows of ministers) has been asked not to go for unnecesbungalows for the minister. Yogi also declared that ministers will not be allowed to keep old staff. They will also not be able to hire a

personal staff of their choice. CM Yogi has given a target of 100 days to all the newly-elected ministers of the UP Government. The ministers are supposed to give a report to Yogi as to what they will do in the next 100 days. The focus in this report should be on what's new they can do in their

departments. Based on that report ministers will be asked to prepare a work plan which includes generating jobs and employment opportunities in different departments. Yogi Adityanath has set an ambitious target to fulfill as many as 10,000 vacant posts in government departments and create selfemployment opportunities for over 50,000 people in the state. All the departments have been asked to prepare the complete details of the vacant posts and place them

before Chief Minister's office. Yogi confirmed his commitment through a tweet on March 31 when he said that the State Government has given instructions to all the service selection boards to provide Government jobs to more than 10,000 youths of the state in the next 100 days. He has also set a target of providing 5 crore employment opportunities in UP in the next 5 years. In his meetings with the officials, the chief minister made it clear that he will keep a constant watch

In its first term, the Yogi Government had given 5 lakh government jobs in the first five years while over 2.5 crore people were given employment opportunities directly and indirectly through the schemes like MSME and ODOP. among others in the last five years. Tamil Nadu faces possible Lankan Tamil refugee influx

The refugee issue has become political with all the Dravidian parties sympathising and speaking for them

→he ongoing Sri Lanka crisis finds echoes across the Palk straits in Tamil Nadu as refugees have started arriving in the state over the past fortnight. Since the Eelam war ended in 2009, this is the first time that refugees have arrived on the Tamil Nadu coast.

Driven by hunger, the Tamil community has taken refuge with their Tamil brethren in India. About 16 of them landed in Rameswaram in Tamil Nadu in two batches. They are Sri Lankan Tamils who cannot face the untenable situation in the island country that is undergoing an unprecedented economic crisis, including severe food

shortage The elite 'Q' branch of the Tamil Nadu Police has increased its coastal security following the possibility of a massive refugee

influx from Sri Lanka.

Sri Lankan refugees fleeing to India is not a new phenomenon as Tamil Nadu had provided them shelter and food since the days of the Eelam War. These refugees landed in Tamil Nadu at different times, mainly to avoid violence. But today, they have left the island country for economic reasons and hunger. Some of them are still living in the state in shelters.

The second generation of refugee Tamils is also living in camps in the state. They have no identity, don't belong to any country, and are stuck in no man's land. The Tamil Nadu government provides them free education, health care, ration cards and a meagre allowance for their families. They hope to get Indian citizenship, while the older generation is open to



returning to Sri Lanka.

The Tamil refugee issue has become political with all the Dravidian parties sympathising and speaking for them. They also put pressure on the Centre for the Sri Lanka reconciliation process with the Tamils.

India has received refugees from many countries, including Tibet, Bangladesh, Afghanistan, Sri Lanka and Myanmar. According to UNHCR, there are

about 200,000 refugees in India. The tricky point here is that India is not a signatory of the UN Refugee Convention (1951) or its Protocol (1967), so the Tamil refugees face the problem of not

belonging to a country. This time too, Tamil Nadu chief minister M.K.Stalin has sought the Centre's approval for providing the Tamil refugees with humanitarian relief. During

his visit to Delhi last week,

Stalin revealed to the media that he had also spoken about the new arrivals running away from the Sri Lankan crisis. He has suggested that they could be accorded refugee status and rehabilitated. How far it is correct to send aid to a section of Sri Lankan is a question when the whole country suffers from hunger.

Tamil Nadu puts pressure on India's foreign policy towards Sri Lanka on three main issues. The other issue pending is the resumption of talks between India and Sri Lanka about the frequent detention and arrest of Tamil Nadu fishermen who stray into the Sri Lankan waters.

The third is retrieving Katchateevu, a small island Indira Gandhi ceded to Sri Lanka in 1974. The Tamil Nadu government has been insisting on its retrieval.

Stalin's Government announced in the State Assembly on August 27 a welfare package of Rs 317 crores, which includes rebuilding houses for the refugees. He proposes to set up a committee for looking after their welfare, including their return to Sri Lanka and citizenship for those who want to live in India.

On the education front, Stalin said the government would bear the tuition and hostel fees of 55 students and children of refugees. He announced hikes in cash support to the refugees that would cost the exchequer an additional Rs 21.49

Stalin's push is in addition to the Centre's help to Sri Lanka. External Affairs Minister S. Jaishankar, who was in Sri Lanka last week to participate in the

decision to help Colombo at this hour of crisis. India has been concerned about the growing Chinese influence in Sri Lanka as the Rajapakse brothers lean towards Beijing. China, too, has been competing with India for a better relationship and has invested millions of dollars in infrastructure and building harbours and airports.

While New Delhi should be concerned about the overall grim political situation in the neighbourhood, the refugee issue also needs some attention, or the trickle will become a torrent of rain in the coming days.

Russia preparing offensive in southeast: Ukraine

ussian forces on Tuesday were preparing for an offensive in Ukraine's southeast, the Ukrainian military said, as President Volodymyr Zelenskyy prepared to talk to the U.N. Security Council amid outrage over evidence Moscow's soldiers deliberately killed civilians.

Russian President Vladimir Putin's government is pouring soldiers into Ukraine's east to gain control of the industrial heartland known as the Donbas. That follows a Russian withdrawal from towns around the capital, Kyiv, which led to the discovery of corpses, prompting accusations of war crimes and demands for tougher sanctions on Moscow

Russian forces are focused on seizing the cities of Popasna and Rubizhne in the Donetsk and Luhansk regions and the Black Sea port of Mariupol, the General Staff said on its Facebook page.

Donetsk and Luhansk are

controlled by Russian-backed separatists and recognized by Moscow as independent states. The General Staff said access to Kharkiv in the east, Ukraine's second-largest city, was blocked.

"The enemy is regrouping troops and concentrating its efforts on preparing an offensive operation in the east of our country," the statement said. "The goal is to establish full

control over the territory of

Donetsk and Luhansk regions.' Zelenskyy, speaking from Ukraine, planned to address Security Council diplomats Tuesday amid demands for an investigation of possible war

Germany and France reacted by expelling dozens of Russian diplomats, suggesting they were spies. President Joe Biden said Putin should be tried for war crimes.

This guy is brutal, and what's happening in Bucha is outrageous," Biden said, referring to the town northwest of the capital that was the scene of some of the horrors.

Democratic, GOP Senate bargainers reach \$10B Covid agreement

AP WASHINGTON

Senate bargainers have reached agreement on a slimmed-down \$10 billion package for countering Covid-19 with treatments, vaccines and other steps, the top Democratic and Republican negotiators said, but ended up dropping all funding to help nations abroad combat the pandemic.

The compromise drew quick support Monday from President Joe Biden, who initially pushed for a \$22.5 billion package.

In a setback, he ended up settling for much less despite administration warnings that the government was running out of money to keep pace with the disease's continued - though diminished - spread in the U.S.


"Every dollar we requested is essential and we will continue to work with Congress to get all of the funding we need," said White House press secretary Jen Psaki. "But time is of the essence. We urge

Congress to move promptly on this \$10 billion package because it can begin to fund the most

Biden and Senate Majority Leader Chuck Schumer, D-N.Y., his party's lead bargainer, abandoned Biden's request to include \$5 billion to help countries - especially poorer ones - where the disease is still running rampant.

The inability of Biden and top Democrats to protect the additional spending they wanted came after the two parties gridlocked over GOP demands to pay for it by pulling back unspent aid from earlier pandemic measures. It also reflected the diminished political force that battling COVID-19 has this election year, two years into a pandemic that began with bipartisan support for throwing trillions of dollars at it.

Sen. Mitt Romney of Utah, the lead GOP bargainer, hailed the accord as one that would address "urgent COVID needs". He also trumpeted the measure's savings, which he said meant it "will not cost the American people a single

It was also not yet certain there would be the minimum 10 GOP votes needed for passage in the 50-50 chamber.



For the fiscal year ended 2021-22, the total auto industry retail sales grew by 7.21 per cent to 1,63,75,799 units, as compared to 1,52,74,314 units in the 2020-21 fiscal.

The near-term out-

look for the Indian auto industry continues to remain a challenge as the on-going Russia-Ukraine war and China lockdown does not hint towards a smooth path. Crude is on a boil and hence fuel prices have been raised by around Rs 10. This will continue to rise and further hit sentiments," Gulati noted.

Individual investors can use UPI for up to ₹5 lakh payment in public issues

New Delhi: Capital markets regulator Sebi on Tuesday said individual investors applying in public issues of equity shares and convertibles can use Unified Payment Interface (UPI) for application amount up to Rs 5 lakh.

Also, they have been asked to provide their UPI ID in the bid-cum-application form submitted with any of these entities -- syndicate member, stock broker, depository participant and registrar to an issue and share transfer

The new guidelines will come into force for public issues opening on or after May 1, 2022, Sebi said in a circular.

The decision has been taken after National Payments Corporation of India (NPCI) reviewed the systemic readiness required at various intermediaries to facilitate the processing of applications with increased UPI limit.

Ås on March 30, 2022, more than 80 per cent of Self Certified Syndicate Banks (SCSBs)/Sponsor Banks/UPI Apps have conducted the system changes and have complied with the NPCI provisions.

BANK CREDIT GROWTH LIKELY 8-10% THIS FISCAL Mumbai: The outlook for banks is expected to be stable amid

improvement in credit growth of 8.9-10.2 per cent and decline in provisions in the current fiscal, rating agency Icra Ratings said on Tuesday. Gross Non-Performing Advances (GNPAs) of banks are expected to decline to 5.6-5.7 per cent by March, 2023 as against an estimate of 6.2-6.3 per cent by March, 2022. "Icra Ratings expects outlook for banks to be stable in FY23, based on continued improvement in earnings driven by improved credit growth of 8.9-10.2 per cent in FY23 (8.3 per cent for FY22 (expected) and 5.5 per cent in FY21) and decline in credit provisions," the agency said in a report on Tuesday. Credit growth would come from non-food segment borrowing which continues to be driven by retail and MSME segments, and partially by co-lending arrangements with non-banking finance companies (NBFCs), it said. Losing four wickets in a space off 11 balls, RCB were in all sorts of trouble at 62 for four before Karthik (44 not out off 23 balls) and Ahmed (45 off 26) took the game away from the opposition with a 67-run partnership off just

Karthik eventually got the team



home in 19.1 overs.

It was RCB's second win in three games while it was the first loss of the season for the Royals after consecutive

At 55 for no loss in the seventh over, RCB were on course in the run chase before the game turned on its head with the Royals taking a flurry of
