Indian eco robust: FM; 8 die in Jabalpur Opp lists Govt 'failures' hospital inferno

Opp walks out during FM's speech on price rise debate

Finance Minister Nirmala Sitharaman on Monday asserted India is facing no risk of recession or stagflation as macroeconomic fundamentals of the economy are strong. Replying to a debate on the price rise in the Lok Sabha, she said the GST collection and the Purchasing Managers' Index (PMI) are indicating that the Indian economy is getting more robust.

The Opposition, on the other hand, accused the Modi Government of seriously damaging small-scale industries, increasing unemployment as well as blackmoney, besides holding the Centre's policies responsible for price rise due to which, it claimed, 25 crore households in the country are hit hard. The Opposition MPs led by the Congress staged a walkout during the FM's reply.

The FM pointed out that the GST collection rose 28 per cent to touch the second-highest level of ₹1.49 lakh crore in July. The GST, introduced in July 2017, touched a record high of ₹1.68 lakh crore in

This is the sixth time that the monthly GST collection crossed the ₹1.40-lakh-crore

Electrical short circuit reason for blaze; five hurt, 2 critical

major fire that broke out at A 30-bed private hospital near Damoh Naka under the Gohalpur police station area of Jabalpur around 2.30 pm on Monday claimed lives of eight people, including four patients. Besides all being charred to death, five others were injured, officials said.

Jabalpur Collector Dr Ilayaraja T said four patients, a caregiver and three staffers of New Life Multi-speciality Hospital, housed in a ground plus three-storey building, died in the fire which has been put

The Collector said there were 20 to 25 people in the hospital when the blaze started. Prima facie it appears an electrical short circuit caused the blaze, said Superintendent of Police (SP) Siddharth

Bahuguna.

Jabalpur MP Rakesh Singh assured that action will be taken against those responsible for the short circuit. He said, "First priority is to take out all those who are stuck and then action will be taken against those who are responsible for it. I am visiting Jabalpur tomorrow and this is a big incident. I am myself in touch with those who are admitted and with authorities.

Of the five injured two

were in critical condition and admitted to the ICU of the Government medical college in Jabalpur. Evacuation of patients and other people from the hospital was over and no one was trapped in the building.

"Our teams immediately arrived at the site of the fire. We have completed the search operation and no one is trapped inside. The first floor has been damaged completely," said Sanjiv Kumar Gupta, an NDRF official.

Madhya Pradesh Chief Minister Shivraj Singh Chouhan asked the Jabalpur Divisional Commissioner to enquire into the tragedy

Chouhan expressed grief over the tragedy and announced a compensation of ₹5 lakh each to the family of the deceased and ₹50,000 per injured person. "A very unfortunate and sad incident has taken place in Jabalpur. I am in constant touch with the district administration there. I have issued an order to the Jabalpur Commissioner to conduct an

The State Government formed a four-member panel under the chairmanship of Divisional Commissioner B Chandrashekhar to probe the hospital fire.

 $M^{ukesh\ Ambani's\ Reliance}_{\text{Jio}\ bagged\ nearly\ half\ of}$ all the airwaves in India's biggest ever auction of 5G spectrum, which received a record ₹1.5 lakh crore of bids. Reliance Jio bagged spectrum worth ₹88,078 crore.

Airtel made a successful

bid of ₹43,084 crore, while Vodafone Idea Ltd bought spectrum for ₹18,799 crore. Adani Group paid ₹212 crore for 400 MHz for their airport, sea port and power plants networks. Telecom Minister Ashwini Vaishnaw said of the 72,098 MHz of spectrum offered across 10 bands, 51,236 MHz, or 71 per cent, was sold.

Adani Group's spectrum will not be used for public telephony service. In all, bids worth ₹1,50,173 crore were



received, he said, adding the Government will in the first year get ₹13,365 crore. Barring the 1800 MHz band, for which Jio and Airtel engaged in fierce bidding, spectrum in all bands was sold at reserve (base) price, he noted.

The mop-up from the 5G spectrum, capable of offering ultra-high speed mobile internet connectivity, is almost double of ₹77,815 crore worth 4G airwaves sold last year and triple of ₹ 50,968.37 crore garnered from a 3G auction in

2010. Reliance Jio was the top bidder, offering a cumulative bid of ₹88,078 crore for 24,740 MHz of airwaves across five bands capable of offering speeds about 10 times faster than 4G, lag-free connectivity, and can enable billions of connected devices to share data in real-time.

It acquired the coveted 700 MHz spectrum that can provide 6-10 km of signal range with one tower and forms a good base for offering fifth generation (5G) services, in all 22 circles or zones in the country.

Adani group bought spectrum in the 26 GHz band, which is suitable for setting up a private network for end-toend communication in six Gujarat, Mumbai, States Karnataka, Tamil Nadu, Rajasthan and Andhra

The Delhi High Court has held that Union Minister Smriti Irani and her daughter are neither owners of a restaurant-cum-bar in Goa at the centre of a controversy nor a license was ever issued in their favour, and said statements by three Congress leaders against them seem to be "bogus with malicious intent."

Further saying that even the show cause notice issued by the Government of Goa was not addressed to Irani or her

family members, the high court said the three Congress leaders Jairam Ramesh, Pawan Khera, Netta D'Souza along with others conspired to "launch a tirade of false, scathing and belligerent personal attacks" against them. The Congress has alleged that the senior BJP leader and her daughter had links with the upmarket restaurant — "Silly Souls Café and

The high court said the statements made by the three Congress leaders are in the 'nature of slander and seem to be bogus with malicious intent' to intentionally subject Irani to a "great public ridicule" and "to injure the moral character and public image" of the minister and her daughter.

2nd Monkeypox case in Delhi as Nigerian with no foreign travel history tests positive

Delhi on Monday reported a second case of Monkeypox — India's sixth case — after a 35-year-old Nigerian man, living in the national Capital and having no recent history of foreign travel, tested positive for the infection. One person has already died of Monkeypox in Kerala

The Nigerian national is admitted to LNJP Hospital, the nodal hospital for treatment of the infection in Delhi. The Nigerian has had blis-

ters and fever for the last five days. His samples were sent to the National Institute of Virology (NIV) in Pune and

the report which arrived on Monday evening showed he was positive, an official source said. Two suspected patients of Monkeypox, who are of African origin, have been admitted to LNJP Hospital. Delhi on July 24 reported

the first case of Monkeypox. The patient was a 31-year-old man with no travel history. He was admitted to hospital with fever and skin lesions. The man had attended a stag party recently in Manali in Himachal Pradesh. A resident of West Delhi, the man was admitted to the Maulana Azad Medical College Hospital in the national Capital around three days

ago after he showed symptoms

of Monkeypox.

Tipplers had a hard time on Monday as most of the liquor stores and bars were closed in Delhi as private venders are reluctant to apply for the extension of licences for mere a month.

It was unofficially a "dry day" despite the Lieutenant Governor's approval to extend the new existing policy by a month till August 31. Many restaurants, bars and hotels in the city refused to serve liquor on Monday. The Excise Department

has sent an email to private liquor stores and vends saying the status of their licences has changed to expire from Sunday.

Meanwhile, the Deputy Commissioner of Delhi Excise in a circular issued on Monday said that in pursuance of order, "I am directed to convey the approval of the competent authority to revert to the previous regime of excise duty based policy (as was prevalent before November 17, 2021) with effect from September 1, The excise licences will be

issued by the Government on payment of a licence fee for the extended period. The private retail liquor

vends that apply for extension will operate till August 31. As the existing policy remained the same, so the number of dry days and discounts will remain till August end. According to private liquor

vendors, most of them are reluctant to carry on their business just for a month. "We have conveyed this to

Globally, only half of children living with HIV get life-saving treatment

lobally, only half (52%) of Children living with HIV are on life-saving treatment, far behind adults where three quarters (76%) are receiving antiretrovirals, as per data available by the recently released UNAIDS Global AIDS Update 2022.

Concerned by the stalling of progress for children, and the widening gap between children and adults, UNAIDS, UNICEF, WHO and partners have brought together a global alliance to ensure that no child living with HIV is denied treatment by the end of the decade and to prevent new infant HIV infections The alliance will run for

the next eight years until 2030, aiming to fix one of the most glaring disparities in the AIDS response. Alliance members are united in the assessment that the challenge is surmountable through partnership."The wide gap in treatment coverage between children and adults is an outrage," said UNAIDS Executive Director Winnie Byanyima. From page 1 "We will definitely raise the issue in Parliament, however there is very little time to force a discussion on it as the session is ending on August 12 and in between there is a weekend, the vice presidential election as well as the farewell for (outgoing vice president) Venkaiah Naidu," said an Opposition leader.

Also, some leaders said the parties have different stands on the issue with those based in the northern region demanding a complete withdrawal of the scheme, while some like the TMC asking that State Governments be freed of the liability to provide jobs for the Agniveers. Opposition leaders have

Reverting to old Excise Policy means failure of current one: L-G

Delhi's Lieutenant-Governor Vinai Kumar Saxena on Monday said that the Cabinet note of the Aam Aadmi Party (AAP) Government to discontinue the new Excise Policy and revert to the old policy points to the gross failure of the current Excise Policy. According to the Delhi Government's Cabinet note, the data shared

in the first quarter of the current fiscal 2022-23 has increased by 59.46 per cent in case of whisky and to 87.25 per cent in the case of wine as compared to the corresponding year 2019-20 but the revenue declined to Rs 193.95 crore per month.

Transport Min moves HC over clearance for trips abroad

Delhi Transport Minister Kailash Gahlot on Monday approached the Delhi High Court challenging the provision which requires State Government Ministers, including the Chief Minister, to seek political clearance from the Centre for foreign visits. The petition was filed in

 $D^{\text{elhi Chief Electoral Officer}}_{\text{(CEO)}}\,\text{Dr Ranbir Singh on}$ Monday called upon all the citizens of Delhi to link their Aadhaar Number with their Voter ID, aiming to establish the identity of electors and authentication of entries in electoral roll. He also said that the special camps will be organized at the booth levels in all assembly constituencies to facilitate the voter to link their Aadhaar numbers with voter

Addressing the media, Singh said that the elector can submit his or her Aadhaar number through both online and offline methods. Every person whose name is listed in the electoral roll may intimate

his Aadhaar number to the electoral registration officer in Form 6B. Singh briefed all recognized political parities about the amendments in the law and the steps taken by the Office of CEO to disseminate information and spread awareness about the linking of Aadhaar with Voter ID card.

"New voters can also enroll along with their Aadhaar Card as well as existing voters who have already enrolled in the voting list can also add their Aadhaar Card with their Voter

Identity Card voluntarily.

The programme shall be completed by 1st Apri, 2023. Efforts will be made to contact 100 per cent electors registered in the electoral roll to assist them in submitting Form 6B,"

While informing about the rocess of the online linking of Aadhaar, "An elector can submit Form 6B to link his or her Aadhaar number through online. For Online Submission, Elector may fill Form 6B on elector-facing apps or portal like NVSP and VHA either through self-authentication or submit Form 6B without selfauthentication, with necessary attachments," Delhi CEO said.

"For Offline Submission, the EROs shall deploy BLOs for House-to-House visit for collection of Aadhaar numbers in the hard copy of Form 6B. All offline submission of Form 6B shall be digitized by BLOs using GARUDA or by ERO using ERONET, within seven days of the receipt of the Forms," he informed

The decision to launch, Doctor on Wheels' scheme for routine medical check-up of construction workers at the work site itself and mobile creches with state-of-the-art facilities to provide day-care to the children of workers at the construction sites, was taken in the 39th board meeting of the Delhi Building and Other Construction Workers Welfare

Giving details about the schemes, the Delhi's Deputy Chief Minister, Manish Sisodia said that the Kejriwal Government's 'Doctor on Wheels' scheme for construction workers will facilitate routine check-up of workers at construction sites. "The AAP

government will also launch unique 'mobile creches' for children of construction workers at sites with aim to provide them better day-care facilities with modern services," said Sisodia, who also hold the

portfolio as Labour Minister. Earlier, the Delhi Government had launched a training program 'Kushal Karmi' for construction work-

ers for their upskilling.
"During the meeting, the progress of this skill program was reviewed also by Deputy CM. At present this program is being run in pilot phase with 200 construction workers at three construction sites and has shown good outcomes," said an official.

In the board meeting, it was also noted that during the first wave of COVID, a total of 1.18 lakh construction workers registered with the board were given an assistance amount of ₹10,000 each. "During this,

the government provided a total financial assistance of Rs 118 crore to the workers," said an official.

"However, during the second wave, the construction activities were stopped due to the lockdown but 3.17 lakh construction workers were given financial assistance of ₹158 crores.

Last year, construction work was also put on hold for some time due to rising pollution levels during winters. During this, an amount of

₹309 crore was distributed by the government in the account of ₹6.17 lakh construction workers," said the official.

Presently, Delhi Government is running 17 welfare schemes for construction workers and their families. Under these schemes, construction workers get ₹3 lakh to ₹5 lakh for house construction, ₹30000 as maternity benefit, ₹20000 loan and assistance, ₹5000 for buying tools, 1 lakh on natural death of workers and accidental death.



fielded former governor Jagdeep Dhankhar for vice presidential election. In her appeal to MPs, Alva wrote, "Today, Parliament is virtually at a standstill, with communication between members broken.

There is distrust, anger, and inability to debate issues of critical national importance without personal attacks and abuse. This diminishes Parliament and its members in the eyes of the people." "The time for change is

now. The reason election to the Vice President's post is not subject to a party whip and is by secret ballot, is to give members an opportunity to vote without fear for a candidate they believe will do justice to this critical position. A candidate who will be impartial, fearless, and run upper house in a manner befitting its stature."

Alva, a veteran Congress leader, said over these years she has worked for country with integrity and commitment. "My only aim has been to defend without fear, the Constitution of India....I believe I am that candidate, and I'm writing to ask you for your support and your vote on August 6th," she said in her appeal to the parliamentarians.

These districts are all in south Bengal the main support

"We have lost a number of

Mukherjee who used to handle three portfolios, Sadhan Pande and then Partha Chatterjee is presently in jail ... It is not possible for me to take charge of all the departments and so I have decided to bring in some new faces," Banerjee said after emerging from a Cabinet meet-We want some ministers to take organisational responsibilities and so some of them will be relieved," she said.

Opposition read the new decision as a "diversionary tactic" from the main issue.

In the meeting she is known to have warned the Ministers to remain watchful about their actions saying any act that would smear the face of the party and the government would not be tolerated.

This is apart from the deeds of at least 35 properties that had been recovered from

Apart from announcing a possible reshuffle the Chief Minister also declared the creation of seven more districts in

her apartments.

The new districts will be Ichamati district after the name of Ichamati River in Bongaon region bordering Bangladesh, districts will be culled out from North 24 Parganas that accounts for five parliamentary seats. Besides a new Sunderbans district will also be created by bifurcating South 24 Parganas which has four MP

The existing Murshidabad district bordering Bangladesh too will be broken into three districts of Behrampore, Murshidabad and Kandi districts. A new district will also be created in the jangalmahals of Bankura where a new Bishnupur district will come up by bifurcating the Bankura district. Besides, Ranaghat district will be created by bifurcating the Nadia district. The creation of seven districts will now take the total number of

"The creation of these districts will facilitate development and fulfil the dreams of many people in the State," the Chief Minister said adding "earlier we had 23 districts and now it will be 30... the State Cabinet has cleared the creation of these new districts ... we congratulate the people .. the decision was taken to ensure smooth administrative functioning."

Did Xi bully Biden?

The Biden administration doesn't appear to be supporting Nancy Pelosi's trip to Taiwan

he media is wondering whether Washington has blinked in its latest confrontation with Beijing. US House of Representatives Speaker Nancy Pelosi's trip to the Indo-Pacific region reportedly included Taiwan, leading to sharp reactions from China which regards Taiwan as its territory. On Sunday, however, it appeared that she may not visit the island nation. Her office issued a statement that the Congressional delegation she is leading would visit Singapore, Malaysia, South Korea, and Japan. Importantly, Taiwan did not appear in the list of countries. Being third in the line of succession to the US Presidency because of the office she holds, her visit to Taiwan, if it happens, would be a leg up for the nation which yearns for recognition from the world. Most countries, including the US and India, officially regard Taiwan as a part of China, even as they maintain relations with it as if it were a sovereign entity. It needs to be mentioned here that China is extremely sensitive to any state-



ment or event that hints at Taiwan's status as an independent nation. By the way, Pelosi won't be the first sitting US House speaker to visit Taiwan; Newt Gingrich, a Republican, did that in 1997. He went to Taipei days after he visited Beijing and Shanghai. Unsurprisingly, China's Foreign Ministry slammed Gingrich, but the response didn't go beyond condemnation.

However, when then-Taiwanese President Lee Teng-hui visited the United States in 1995, the dragon spat fire—quite literally. China fired missiles that fell into the waters around the island nation. It was only after the US flexed its muscles, moving a couple of aircraft carrier battle groups into the area, that

the crisis subsided. That was then; China was not as strong at that time as it is now; neither had it become a threat to global peace as it is today. President Xi Jinping has managed to blend two bellicose ideologies, nationalism and communism, into a deadly mix. US President Donald Trump was the first global leader to recognise that and act accordingly. This is the reason that in recent years, Taiwan has been visited by a large number of officials, both serving and retired, and Congresspersons have visited Taiwan. As it is, Beijing is incensed with Trump's legacy—and then came the reports of Pelosi's visit. Its reaction was similar to that of a Bollywood baddy: those who play with fire will perish by it. Xi is said to have warned US President Joe Biden in a telephonic conversation against "playing with fire" over Taiwan. Has Biden taken the warning seriously? We don't know yet, but former US secretary of state Mike Pompeo thinks so. He slammed Biden for not supporting Pelosi's visit to Taiwan. Hollywood has kowtowed to the Chinese Communist Party, as also the National Basketball Association, but it should not be the case where an American administration, Pompeo rightly said. But is Biden listening?

Monsoon session washout

The Government must ensure that the Upper House functions smoothly by accommodating the Opposition's point of view

t looks like the ongoing Monsoon session of Rajya Sabha is going to be a total washout. Two weeks after it started on July 18, it is yet to pass a bill and its productivity is just 16% so far. With ruckus dominating the proceedings there is hardly any meaningful activity taking place in the Upper house. The 23 members from various opposition parties have been suspended and still, there is no quarantee that the house would be able to conduct its usual business. In his remark, M Venkaiah Naidu expressed his disappointment saying that obstruction of proceeding in the house tantamounts to the destruction of parliamentary democracy. Indeed continuous adjournments, interruptions, and slogan shouting has lowered the dignity of the house. During

the 10 sittings, the Rajya Sabha functioned for 11 hours 8 minutes which is just over an hour in a session. The important bills could not be discussed like the Weapons of Mass Destruction Bill. There were No Zero Hour submissions and no Question Hour on six days during the first two weeks.

It is indeed a wastage of exchequer's money. The Chairman of the Upper House Naidu has said, the effective functioning of parliament is a collective responsibility of the government and the Opposition. The chairman has made apt remarks and indeed ensuring the smooth functioning of the house is the responsibility of both the government and the opposition. But the government must own

the larger share of responsibility to ensure the functioning of the house by allowing opposition more room and by giving it full opportunity to speak up. After all, the opposition is only trying to take up the people's issues like price rise, unemployment, and the like. The government should be more forthcoming and give it a patient hearing and reply to pacify their genuine concerns. But that is not happening. On several occasions, we see that the opposition does not get the chance to have a debate on its chosen issues. The chair unfortunately often sides with the government and wants to avoid the debate that the government is uncomfortable with. In this situation, the opposition does not have much choice; either it could play a shouting match or walk out in both situations it is the government wins. The democracy loses. If after the suspension of 23 opposition members bills are passed in their absence it would not be a fair debate but a sham.

the initial stages, it helped create and support academic and scientific organizations such as the Tata Institute of Fundamental Research, the Tata Institute of Social Sciences, The Indian Institute of Science, and the Tata Memorial Center for Cancer Research and Treatment. Charity seems to be in the veins of the Tata leadership since its foundation, precedent was set by JN Tata who recently was accorded with the recognition of "Greatest Philanthropist in the world" by Hurun's research and Edelgive foundation. Legislate to safeguard kids from 'dark web'



Studies point out to disturbing trends of growing exploitation of children amid legislative vacuum

yber/online" trafficking should primarily be understood as human trafficking, committed with the help of online networks using gadgets. This is a global malaise and since traf-ficking is a crime, this is covered under various international anti-trafficking instruments such as the 2000 'Palermo Protocol' and the 2005 'Council of Europe Convention on Action against Trafficking in Human Beings'.

It also falls under the 2001 'Council of Europe Convention on Cybercrime,' the first international treaty on crimes committed through the internet. Cyber/online trafficking involving children assumes a much larger significance and widespread implication for our social fabric. The crisis of child trafficking worsened in the country during the Covid-19 pandemic in 2020 and 2021. With schools and educational institutions shut down amid a spike in joblessness among households, traffickers became sophisticated with online/cyber tools, compounding the problems for law enforcement agencies.
India still doesn't have an appropriate

law designed specifically to handle the challenge of cyber/online child trafficking. The easy access to the 'Dark Web' that gives anonymity to its users due to sophisticated online tools has made it easier for traffickers to lure gullible and jobless parents to allow their children into multiple forms of abuse. Preying on vulnerable families by luring them with false promises of a new job, increased income, and better living conditions, became easier for traffickers, who indulged in such illicit activities during the pandemic. Parents and children remain ignorant of the perils of such allurements.

No wonder the illegal trade of child

labour continued to flourish across India despite strict lockdowns and little movement of people. The International Labour Organization (ILO) had revealed in June 2021 that around 160 million children were forced into labour, rising by about nine million in the last four years.


A study by the New Delhi-based independent think-tank, India Child Protection Fund (ICPF) in 2020 (https://www.icpf.org.in/reports) revealed disturbing facts related to cyber/online trafficking and the availability of 'child sexual abuse material (CSAM). The ICPF examined data from Pornhub, world's largest pornography website that revealed traffic from India increased by 95 per cent in March 2020 right after the imposition of national lockdown, as compared to pre-pandemic average traffic on their website. This increase was fuelled by Pornhub after it made its premium content free-of-charge during the lockdown.

A significant segment of this spike was attributed to the demand for child pornography content. The ICPF found the demand for child pornography material only on the public domain was an average of five million per month in 100 cities. A vast majority of individuals were inter-

The study further found the demand for specific content, where the person was interested in specific actions, age groups, locations, etc., was the highest in cities like - Kolkata, Siliguri, Howrah, Chandigarh, Guwahati, Indore, Bhubaneswar and Chennai. Another report of the Childline India Helpline from the national lockdown period in 2020 reconfirmed this trend of increased vulnerability of children to sexual abuse. The helpline received more than 92,000 SOS calls asking for protection from abuse and violence.

The ICPF in course of its study made several recommendations that will enable the law enforcement agencies to tackle the scourge of cyber/online child trafficking cases. It had recommended creation of a 'CSAM Tracker' through nationwide scale up of artificial intelligence tools. The tracker will track the hosting, sharing viewership and down-load of CSAM and link it with existing cyber security systems of the Government of India. Aggressive online campaign and educating parents and children on the relevance and modus operandi of online child sexual abusers, and on how to report the crime also formed parts of the recommendations.

The ICPF urged for creation of 'National CSAM Offenders Registry' for individuals found to be viewing such contents which will be made available to all internet service providers (ISPs). It urged individuals proven to be con-

suming, distributing or selling CSAM be denied personal internet services for a specified period of time. Mandatory pulling down of CSAM content and individuals by ISPs and social media platforms. The ICPF also advocated India to take the lead in establishing a legally binding international convention for international cooperation to eliminate the creation, hosting and viewership of CSAM.

The rise in the risk for the jobless households and their children is now multifold and requires institutionalization of special agencies armed with a law that is sufficiently equipped to handle such instances of online exploitation and trafficking of children. In this context, the Kailash Satyarthi Children's Foundation (KSCF) has proposed to create the 'Online Child Sexual Abuse and Exploitation (OCSAE)' to save children from exploitative situations.

The aim is to establish specialized policing units that are equipped and empowered to carry out effective investigations to prevent circulation of abusive materials online and stop cyber exploitation that leads into trafficking.

In the first two years 2021 and 2022, the KSCF partnered with Maharashtra and Kerala to identify and weed out cases of online exploitation and possible trafficking. The initiative yielded results in Kerala, where 472 FIRs were registered, which led to 67 arrests. Similarly, in Maharashtra, a 'Tactical Response Against Cyber Children Exploitation Unit (TRACE)' was set up as a pilot scheme. It was successful in retrieving a huge cache of online it goes viral online.


As part of its effort to root out the evil of CSAM, KSCF has iden tified "ICACCOPS software", which is a product of Internet Crime Against Children (ICAC), an international Taskforce involving various national governments to detect CSAM available online. Additionally, Kerala cyber police is developing the Grapnel tool with support from KSCF to monitor and crawl through the "Dark Web". It will collect data from websites, chat rooms and other sources to prevent and stop online exploita-tion and possible trafficking.

Apart from the two state gov-

ernments, multiple workshops have been conducted in schools in Mumbai to train children regarding cyber safety nets. The plan is to expand a similar network in Telangana, Rajasthan and Madhya Pradesh or Assam over the next three vears.

Here it is pertinent to note that law enforcement agencies are making efforts by carrying out operations to stop these illicit activities. For instance, in November 2021, the Central Bureau of Investigation (CBI) had carried out multiple raids across the country and seized child pornographic material and made arrests but much more remains to be done.

The Union government must view the rising epidemic of cyber/online child trafficking and legislate appropriate laws to handle the crisis. A law with multiple tentacles that can nab the suppliers and consumers of CSAM even in the 'Dark Web'. The key here is to prevent the online circulation of CSAM and nip it in its bud before

'not right time' for Gotabaya to return

It is not the right time for Gotabaya Rajapaksa to return to Sri Lanka as his presence here could inflame political tensions in the country which is grappling with the worst economic crisis in history, his successor Ranil Wickremesinghe has said.

Wickremesinghe was elected as the president through a parliamentary vote on July 20 after then-President Rajapaksa fled to the Maldives and then to Singapore when antigovernment protesters stormed the President's House. The six-time former prime minister, who was appointed the acting President after Gotabaya fled the country following a popular uprising against the Rajapaksa family, said in an interview with the Wall Street Journal on Sunday that the former president's return in the current situation could inflame political tensions among tens of thousands of protesters who blame the erstwhile powerful family for the current economic crisis.

Sri Lanka's cabinet spokesman Bandula Gunawardena recently said that Rajapaksa, 73, was not in hiding and was expected to return soon. Wickremesinghe, who remained in contact with Rajapaksa to deal with administrative handover issues and other government business, said the former president had not indicated about his planned return to Sri Lanka soon. "I don't believe it's the time for him to return," 73-year-old Wickremesinghe said, adding that the leader, who escaped Sri Lanka in the midst of the economic turmoil, had not "indicated" of returning soon. The new president said Sri Lanka had experienced the worst of its economic crisis and that restoring political stability would allow it to begin turning a corner, starting with finalising negotiations for an International Monetary Fund bailout that had stalled due to recent turmoil.

"I think we've already hit the bottom," Wickremesinghe said. "I can see the light at the end of the tunnel; it's how fast we can get to it." The president acknowledged that it would take months for Sri Lankans, who have been facing acute shortage of foreign currency leading to runaway inflation and long queues for essential items such as food, fuel, cooking being of its people, it added.



gas and medicines, to see their economic circumstances improve markedly.

The new Sri Lankan government faces the task of leading the country out of its economic collapse and restoring order after months of mass protests that forced President Rajapaksa to flee the country and resign. The Indian government assistance to Sri Lanka has reached almost USD 4 billion since January this year. Sri Lanka needs about USD 5 billion in the next six months to cover basic necessities for its 22 million people, who have been struggling with long queues, worsening shortages and power cuts. The main Opposition party Samagi Jana Balavegaya (SJB), however, said that invitations to form the all-party government must be extended to parties and not individuals.

TNA had officially supported Wickremesinghe's rival Dullas Alahapperuma in the parliamentary vote on July 20 to elect the successor to the resigned president Gotabaya Rajapaksa. But at least a few of their 10 MPs were believed to have favoured Wickremesinghe in the secret vote against the party's stand.

President Wickremesinghe is to ceremonially address Parliament on Wednesday where he is expected to make

his policy speech. Sri Lankan MPs on July 20 elected Wickremesinghe as the country's new president, with the majority of the vote coming from lawmakers repre-Rajapaksa's Sri Lanka Podujana country in June.

The 73-year-old President

was appointed for the rest of the term of Rajapaksa who initially fled to the Maldives and then to Singapore.

Rajapaksa is accused of mishandling the economic crisis, the worst since 1948. Wickremesinghe was earlier appointed prime minister by Rajapaksa in mid-May. He was tasked with reviving the economy by giving early solutions to fuel, cooking gas and power shortage problems, which triggered mass agitations against

Rajapaksa.
The government declared bankruptcy in mid-April by refusing to honour its international debt.

SC extends overseas travel ban on Rajapaksa brothers till Aug 4

Sri Lanka's Supreme Court on Monday extended until August 4 the overseas travel ban on former prime minister Mahinda Rajapaksa and his younger brother and former finance minister Basil Rajapaksa, who are widely blamed for the current economic crisis in the island nation.

A five judge bench of the Supreme Court led by Chief Justice Jayantha Jayasuriya announced the Monday's decision in a petition filed against the brothers of former President Gotabaya Rajapaksa by a group including former Chairman of the Ceylon Chamber of Commerce Chandra Jayaratne, former Sri Lanka swimming champion Julian Bolling, Jehan Kanagaratna and Transparency International Sri Lanka.

The direction was issued when a motion related to the petition requesting the court to issue an order for an investigation against the people responsible for the current economic crisis came up on Monday.

The petition claimed that three persons -- Basil, Mahinda and former Central Bank Governor Ajith Nivard Cabraal --- were directly responsible for the unsustainability of Sri Lanka's foreign debt, its debt default and the current economic crisis leading to an acute shortage of basic commodities such as food, fuel, and medicines.

On July 15, Sri Lanka's apex court had barred the trio from leaving the country till July 28, the report said.

Earlier this month, Basil was prevented from leaving Sri Lanka following protests from passengers and officials at the Bandaranaike International

Mahinda and Basil's broth-Gotabaya Rajapaksa, the former Sri Lankan President, arrived in Singapore on July 14 on a "private visit" from the Maldives after he fled his country to escape a popular uprising against his government's economic mismanagement.

Rajapaksa has been issued a new visa by Singapore, extending his stay in the country till August 11. Sri Lanka has seen months

of mass unrest over the worst economic crisis and many blame the former government led by Rajapaksa and his family for mishandling the island nation's economy.

1st ship carrying Ukrainian grain leaves port of Odesa

The first ship carrying Ukrainian grain set out Monday from the port of Odesa under an internationally brokered deal to unblock the embattled country's agricultural exports and ease a growing global food crisis.

The Sierra Leone-flagged cargo ship Razoni sounded its horn as it slowly departed with over 26,000 tons of corn destined for Lebanon.

Russian aggression has left port," Ukrainian Minister of Infrastructure Oleksandr Kubrakov said on Twitter.

Russia and Ukraine signed agreements in Istanbul with Turkey and the UN on July 22, clearing the way for Ukraine to export 22 million tons of grain and other agricultural goods that have been stuck in Black Sea ports because of Russia's invasion of Ukraine over five months ago. The deals also allow Russia to exports grain and fertilizer.

As part of the agreements, safe corridors through the mined waters outside Ukraine's ports were established.

Fuel tanker truck catches fire in Libya; 9 dead, 76 injured

fuel tanker truck caught Afire and exploded on Monday in central Libya, killing at least nine people and injuring 76 others, health authorities said.

The incident took place in the central town of Bent Bayya when the tanker truck overturned before catching fire and exploding, the staterun Libya News agency reported.

The agency said residents in the area rushed to collect leaked gasoline despite warnings of possible fire and explosion, causing the high

Pelosi starts Asian tour with speculation over Taiwan visit

S House Speaker Nancy Pelosi held talks with officials in Singapore on Monday at the start of her Asian tour, as questions swirled over a possible stop in Taiwan that has fueled tension with Beijing. While there have been no

official announcements, local media in Taiwan reported that Pelosi will arrive Tuesday night, becoming the highest-ranking elected US official to visit in more than 25 years. The United Daily News, Liberty Times and China Times — Taiwan's three largest national newspapers cited unidentified sources as saying she would arrive in Taipei after visiting Malaysia and spend the night.

Such a visit will spark fury in Beijing, which regards Taiwan as its own territory and has repeatedly warned of "serious consequences" if the reported trip goes ahead. "If Pelosi insists on visiting Taiwan, China will take resolute and strong measures to defend its sovereignty and territorial integrity," Chinese Foreign Ministry spokesperson Zhao Lijian said in Beijing, without giving details.

"Those who play with fire

will perish by it," Zhao said. "We would like to once again admonish the US that we are fully prepared for any eventuality and the PLA will never sit idly by." The People's Liberation Army is China's military.

The United States switched diplomatic recognition from Taipei to Beijing in 1979, but maintains informal relations with the island. Washington is obligated by the Taiwan Relations Act, a federal law, to

Minister Lee Hsien Loong, President Halimah Yacob and other Cabinet members.

Singapore's Foreign Ministry said Lee welcomed a U.S. Commitment to strong engagement with the region, and the two sides discussed ways to deepen US economic involvement through initiatives such as the Indo-Pacific Economic Framework.

Lee and Pelosi also discussed the war in Ukraine, tensions surrounding Taiwan and mainland China, and climate change, it said in a statement. Lee "highlighted the importance of stable U.S.-China relations for regional peace and security," it added, in an apparent allusion to reports of Pelosi's visit to Taiwan.

Pelosi has said she is visiting Singapore, Malaysia, South Korea and Japan in a tour to discuss trade, the COVID-19 pandemic, climate change, security and "democratic governance."

She is scheduled to be in Malaysia on Tuesday. A Parliament official, who was not authorized to speak to the media and declined to be identified by name, said Pelosi will call on Malaysian lower house speaker Azhar Azizan Harun. No further details were immediately available.

On Thursday, Pelosi is to meet with South Korean National Assembly Speaker Kim Jin Pyo in Seoul for talks on security in the Indo-Pacific region, economic cooperation and the climate crisis, Kim's office said in a statement.

It declined to provide further details about her itinerary, including when she is arriving in South Korea and how long she'll stay. Pelosi's schedule for Wednesday remains unclear and there were no details on

Chinese military celebrates 95th anniv; flexes muscles to deter US House Speaker's visit to Taiwan

China's People's Liberation Army (PLA), the world's largest military, on Monday celebrated the 95th anniversary, flexing its muscles to deter US House Speaker Nancy Pelosi's purported plan to visit Taiwan that has fuelled tension with

Beijing.
Pelosi confirmed on
Sunday she will lead a congressional delegation to Singapore, Malaysia, South Korea and Japan but was conspicuously silent about a possible stopover at Taiwan, the self-governing island that China claims as part of its mainland.

The proposed visit drew a fiery warning from President Xi Jinping in his last Thursday's phone conversation with his US counterpart Joe Biden, asserting that "those who play with fire will perish by it.'

Beijing sees official American contact with Taiwan as encouragement to make its decades-old de facto independence permanent.

Coinciding with its 95th Army Day celebrations on Monday, the two-million-strong PLA highlighted some of its latest achievements in weaponry and equipment development and realistic combat preparations to warn "Taiwan independence" secessionist and external interfering

The PLA revealed new progress has been made in its advanced weaponry and equipment, including its hypersonic missile, amphibious assault ship, aerial tanker and large destroyers, all of which are described by military analysts as having important roles to play if a conflict breaks out in the Taiwan Straits, state-run Global Times reported on



State broadcaster China Central Television (CCTV) on Saturday released a video titled "The capabilities of the Chinese troops shown in 81 seconds" showing the launch of a DF-17 hypersonic missile from a transporter erector launcher on a highway in a desert.

The missile can hit stationary and moving targets in the South China Sea, the Taiwan Straits and Northeast Asia, including aircraft carriers, Global Times report said.

While Pelosi's visit overshadowed PLA's anniversary, observers say the Chinese military is steadily gaining ascendency in the ruling Communist Party of China (CPC) especially under the leadership of Xi, who besides being the President and head of the CPC is also Chairman of the all-powerful Central Military Commission (CMC), the overall high-command of the PLA.

Xi, 68, who is widely expected to get an unprecedented third five-year term in power or perhaps for life at the key CPC Congress to be held in the next few months unlike his predecessors is the lone civilian in the CMC dominat-

ed by the top brass of the PLA. While Xi, since he took insisting that the PLA should mandatorily function under the CPC, which he said holds the gun, the military which remained his power base is gaining its influence in the 92million-member Communist

Observers say that the military functioned as a bloc in various key party bodies. Studies showed that PLA has two members out of 25 politburo members while in the Central Committee, the other influential body, the PLA accounts for around 20 per cent of the 205 permanent and 171 alternate members.

Speaking at a study session last Thursday, Xi said the Chinese military should be led by "reliable people" loyal to the ruling Communist Party to ensure its "absolute leadership" over the world's largest armed

"We must lay emphasis on political integrity when cultivating, evaluating and appointing personnel so that the party's absolute leadership over the military is implemented in the whole process of personnel work," Xi said. Xi emphasised that the

US seeks to expand ties with NZ amid **China worries**

The commander of the United States military in the Pacific said Monday he wants to expand and strengthen its ties with New Zealand.

The visit to Wellington by Adm. John Aquilino, head of the U.S. Indo-Pacific Command, comes as the U.S. Is looking to increase its presence in the region amid deep concerns over China's growing ambitions in the Pacific. They include most recently the Solomon Islands, where the U.S. And several Pacific nations expressed deep concern about a security pact the Solomons signed with China in April, which many fear could result in a military buildup in the region. Aquilino was greeted with a traditional Maori welcome ceremony and laid a wreath at the Pukeahu National War Memorial Park.

He spoke briefly to media ahead of meetings with top New Zealand defense force and government officials. "Our partnership runs very deep," Aquilino said. "We are

Myanmar leader announces extension of state of emergency



The leader of Myanmar's military-installed government on Monday announced the extension of its mandate to rule for another six months in preparation for an election it has said will be held next

The army seized power on February 1 last year from the elected government of Aung San Suu Kyi. It cited alleged fraud in the November 2020 general election, which Suu Kyi's National League for Democracy party had won in a landslide while the military-backed party did

Independent election observers said they found no evidence of substantive irregularities, and the army takeover was met with widespread non-violent protests around the country. Security forces used deadly force to disperse them, prompting armed resistance by the prodemocracy forces. The escalation of violence has since plunged Myanmar into what UN experts have described as a civil war.

Senior Gen. Min Aung Hlaing, head of the ruling State Administration Council, said in a broadcast speech Monday that the state of emergency declared after last year's takeover was extended because time was needed "to continue working to return the country to the path of a peaceful and disciplined multiparty democratic system and to hold multiparty demo-

cratic general elections." The military originally declared that new polls would be held a year after its takeover, but later said they There is considerable

doubt they will be free and fair, because most of the leaders of Suu Kyi's party have been locked up, and there is a large chance the party itself will be dissolved by the promilitary courts.

Min Aung Hlaing said the military had tried its "utmost to discharge (its) responsibilities" since it seized power. "However, terrorists based inside and outside the country and the people and organizations supporting them are committed to the utter devastation of Myanmar, instead of trying to nurture democracy in Myanmar," he said. While some opponents of military rule have employed tactics including assassinations and bombings, the military dubs almost all those opposing it as "terrorists."

UN experts and rights groups are more critical of government repression, which is reliably reported to include arbitrary arrests and killings, torture, and military sweeps that include air attacks and the burning down of entire

To ensure that there is no unfairness, threats or coercion in the coming election, armed conflicts must cease," said Min Aung Hlaing, in what appeared to be a reference to the government's ongoing military operations, which are carried out against ethnic minority groups as well as pro-democracy forces and their supporters.

To be able to hold the elections, we will accelerate the efforts by our public security system to stabilise the politics and security of the nation," he said.

"It is a radical vision but it is also a realistic one and there are some core principles that I'm simply not prepared to compromise on, whatever the prize," he said.

Under the proposals, his previously announced 1p cut to income tax in April 2024. A further 3p off by the end of the next Parliament, around 2029, will be paid for through economic growth.

Sounding a warning note and an indirect attack at his rival's tax pledges, the British Indian former minister added: "Firstly, I will never get taxes



down in a way that just puts pay for. And thirdly, I will always be honest about the challenges we face.

Spain fully backs Western Balkan integration into EU

"The EU cannot be conceived without the Balkans," Sanchez said at the news conference with Albanian counterpart Edi Rama. "Balkans' incorporation will strengthen and add EU members."



Lebanon, Israel closer to deal in maritime border dispute

T ebanon and Israel are get-Lting closer to reaching a deal in a more than a decadeold maritime border dispute between the two neighbors, a US Envoy and Lebanese officials said Monday Lebanon and Israel have

been officially at war since Israel's creation in 1948 and both countries claim some 860 square kilometers (330 square miles) of the Mediterranean Sea. Amos Hochstein, a senior adviser for energy security at the U.S. State Department who has been mediating between the two neighbors, expressed optimism after his meetings Monday in Beirut with Lebanon's president, caretaker prime minister and parliament speaker.

The joint meeting between Hochstein and the top leaders may indicate that a breakthrough could be near and that Lebanon's political leadership backs such a deal. "The atmosphere is positive and the gap of disagreements in this field is narrowing," Deputy Parliament Speaker Elias Bou Saab told reporters after the meeting. Hochstein arrived in Beirut



Following his last visit to Lebanon in June, Hochstein told the U.S.-funded Alhurra television that the Lebanese government took "a very strong step forward" by presenting a more united approach, and anticipated that there could be

progress to reach a settlement.
"I remain optimistic that we can make continuous progress as we have over the last several weeks," Hochstein said in brief comments after the 90-minute meeting at the presidential palace. He added that he looks

"forward to coming back to the region" and "being able to make the final arrangements." Parliament Speaker Nabih Berri described the talks as "positive."

Hitler's watch sells at Maryland auction for USD 1.1 million

A Maryland auction house has sold a wristwatch that once belonged to Adolf Hitler for USD 1.1 million.

Alexander Historical Auctions in Chesapeake City had estimated the value between USD 2 and USD 4 million, describing the watch as a "World War II relic of historic proportions." Newsoutlets report that Jewish leaders and others objected to the sale this week, saying it had little to no historical value. The auction house's president, Bill Panagopulos, defended the auction and said the buyer is a European Jew.

The watch features the initials AH and a swastika. The auction house said a French soldier who was in the first unit to close in on Hitler in May 1945 at his Berchtesgaden retreat seized it as spoils of war.

EU court limits national checks for migrant rescue ships

The European Union's top court ruled on Monday that national maritime authorities cannot impound ships involved in search-and-rescue work on suspicion that they might be overloaded due to the number of migrants they plucked from the sea.

The European Court of Justice ruling came in response to an appeal by German migrant aid group Sea-Watch.

Two of the German group's ships were forced to undergo inspections in Sicily in 2020 after disembarking migrants for taking aboard more people than they were authorised to carry.

Italian harbour authorities also considered that the ships were not certified for search-and-rescue missions.

But the court said that rescued people "must not be taken into account when verifying whether the rules on safety at sea have been complied with. The number of persons on board, even if greater than that which is authorised, cannot therefore, in itself, constitute a ground for a

The Luxembourg-based ECJ also said national port authorities have the right to inspect ships to assess whether rules on working conditions, health and safety, and the environment are being respected.

But it added that they do "not have the power to demand proof that those ships hold certificates other than those issued by the flag state", which in the case of the Sea-Watch vessels was Germany.

Sea-Watch described the court decision as a victory that means that port authorities can't arbitrarily detain ships and prevent them from doing their work.
"The ruling provides clear legal security for NGOs and is

a victory for sea rescue. In the future, ships will thus continue to do what they do best: Rescue people instead of being arbitrarily stuck in port," the organisation said in a tweet. Neither the EU nor any of its 27 nations are actively

searching for people in danger in the Mediterranean Sea, where more than 1,000 people have died or are missing so far this year, many of whom tried to reach Europe from North Africa in unseaworthy smugglers' boats.

But ships are bound by international law to respond to any distress call near them.

GST collection rises 28% to ₹1.49 lakh cr in July; 2nd highest ever

m mid}$ disquiet over imposition of the GST on several consumer products like milk, curd, pannier, etc., there is some good news for the Government. The GST collection has risen by 28 per cent to touch the secondhighest level of Rs 1.49 lakh crore in July on the back of economic recovery and steps taken to curb the tax evasion, the Government said on Monday.

The latest GST collection is in line with a trend of rising revenue for the Government in successive months. This is the sixth time that the monthly GST collection crossed the Rs 1.40lakh-crore mark since the inception of the GST and fifth month at a stretch since March 2022, the Ministry said in a statement.

The Goods and Services Tax (GST) collection stood at Rs 1,16,393 crore in the same

month a year ago. In-troduced in July 2017, the GST touched a record high of Rs 1.68 lakh crore in April, 2022.

During July, revenues from import of goods were 48 per cent higher and the revenues from domestic trans-actions (including import of services) were 22 per cent higher than the revenues

from these sources during the

same month last year.

Of the Rs 1,48,995 crore GST collected in July, the Central GST is Rs 25,751 crore, the State GST is Rs 32,807 crore, the Integrated GST is Rs 79,518 crore (including Rs 41,420 crore collected on import of goods) and cess is Rs 10,920 crore (including Rs 995 crore collect-

The Government has settled Rs 32,365 crore to the CGST and Rs 26,774 crore to the SGST from the IGST. The total revenue of the Centre and the States in the month of July 2022 after reg-ular settlement is Rs 58,116 crore for the CGST and Rs 59,581 crore for the SGST, it said.

During June 2022, 7.45 crore e-way bills were generated, which was marginally higher than 7.36 crore in May 2022. The growth in the GST revenue till July 2022, over the same period last year, is 35 per cent and displays a very high buoyancy, according to the statement.

"This is a clear impact of var ious measures taken by the GST Council in the past to ensure better compliance. Better reporting coupled with the economic recovery has been having a positive impact on the GST revenues on a consistent basis," it said.

India's manufacturing activity touches 8-month high in July on new orders, says survey

India's manufacturing sector Lactivity hit the highest level in eight months in July, driven by a significant rise in business orders, a monthly survey said on Monday.

The seasonally adjusted S&P Global India Manufacturing Purchasing Managers' Index rose from 53.9 in June to 56.4 in July, reflecting the strongest improvement in the health of

the sector in eight months. The July PMI data pointed to an improvement in overall operating conditions for the 13th straight month. In PMI parlance, a print above 50 means expansion while a score below 50 denotes contraction.

'The Indian manufacturing industry recorded a welcome combination of faster economic growth and softening inflation during July," Pollyanna De Lima, Economics Associate Director at S&P Global Market Intelligence, said.

output expanded at the fastest pace since last November, a trend that was matched by the more forward-looking indicator of new orders.

"Although the upturn in demand gained strength, there were clear signs that capacity pressures remained mild as backlogs rose only marginally and job creation remained subdued," Lima added.

The aggregate new order intakes rose substantially in July, recovering the growth momentum lost in June.

The readings are based on a monthly survey of businesses that are mainly into manufacturing activities.

"The latest increase was in fact the most pronounced since last November, with quicker expansions recorded in all three broad areas of the manufacturing industry," as per

the survey.

Despite the solid performance of the manufacturing industry, overall job creation remained subdued. A vast majority of firms (98 per cent) opted to leave workforce numbers unchanged amid a lack of pressure on operating capacity, it added.

Another factor that constrained hiring activity was future uncertainty.

According to the survey, despite improving from June's 27-month low, the overall level of business sentiment was muted in the context of historical data. In fact, 96 per cent of manufacturers forecast no change in output from present levels over the course of the

coming 12 months. It also noted that while companies stepped up input purchasing, job creation remained marginal amid an uncertain outlook and a general lack of pressure on oper-

ating capacities.
"With incidence of shortages diminishing, the rate of 11-month low in July, subsequently dragging down the rate of increase in output prices to the weakest in four months,"

Lima said. As per official daa, the retail inflation based on Consumer Price Index (CPI), which the Reserve Bank of India (RBI) factors in while

arriving at its monetary policy, has been above 6 per cent since January 2022. It was at 7.01 per cent in June. Experts believe the RBI may go in for its third consecutive policy rate hike by at least 35 basis points to check high

retail inflation. The RBI's rate-setting panel — the Monetary Policy Committee — will meet for three days from August 3 to deliberate on the prevailing economic situation and announce its bi-monthly review on Friday.

'Heatwave also pushed food inflation; expect CPI to come at 6.8% in FY23'

The heat wave in early 2022 was the key domestic factor responsible for pushing up food prices this year, a Crisil Ratings arm said on Monday.

Crisil Research pegged the headline consumer price inflation to come at 6.8 per cent in FY23 - marginally higher than the Reserve Bank's 6.7 per

the Reserve Bank's 6.7 per cent estimate - because of the pressures on the food front, been double that of FY22. The RBI has been blaming

the Russian invasion of Ukraine and the consequent surge in commodity prices for a bulk of the surge in inflation, which has consistently breached the upper end of the tolerance band set for it by the government. At present, food commands 39 per cent of the CPI basket.

"The recent rise in food inflation is mainly supply shortages-led, driven by both global (geopolitical conflicts) and domestic (impact of heat wave) factors," the Crisil Research note said.

"Our forecast of CPI inflation at 6.8 per cent is premised on food inflation at 7.0 per cent, which is double last fiscal's," it added.

ny said in a statement. The company's sales were driven mainly by compact cars, including Baleno, Celerio, Dzire, Ignis, Swift, Tour S, and WagonR, which rose to 84,818 units in July 2022 from 70,268 units in the year-ago month. Sales of mini cars -- com-



grew to 20,333 units last month, up from 19,685 units in July 2021. However, sales of utility vehicles -- including Brezza, Ertiga, S-Cross and XL6 -- were lower at 23,272 units compared to 32,272 units.

'The overall industry sales stood at over 3.42 lakh units last month as compared with 2.94 lakh units in July 2021. This is the highest wholesale figure we have ever seen in the industry," MSI India Senior Director (Marketing and Sales) Shashank Srivastava told PTI.

The previous best wholesales stood at 3.34 lakh units in October 2020, he said, adding, it has been possible due to better production as chip shortage eased a bit. The industry is expected to



(CWI) said on Monday.

Initially, it was delayed by two hours but the CWI later confirmed that the game had to be pushed back further. There was, however, no explanation for the inordinate delay.

It has happened despite a two-day gap between the first and second game.

"Due to circumstances beyond CWI's control, there have been significant delays in crucial team luggage arriving into St Kitts from Trinidad. As a result, today's match 2nd Goldmedal T20 Cup match is due to start at 12.30 pm (10 PM India time)," the CWI said in a statement.

Normally, between the Caribbean nations small ATR flights operate, and hence, unlike normal commercial airlines, which also carries the heavy duty cricket coffins of the players, these aircrafts do not have the same capacity.

The delays in transporting kits from one nation (Trinidad & Tobago) to another (St Kitts & Nevis) is pretty normal in the Caribbean, but a match being delayed because of this is a first for the

"We do not know why the kits haven't arrived as we don't have an official reason for it," a CWI spokesperson told PTI.

The match is scheduled to be played at the Warner Park.
