US avenges 9/11, kills Qaeda chief Zawahiri

Drone eliminates Zawahiri in Kabul; Taliban protest

Al-Qaeda's reclusive emir Ayman al-Zawahiri, who played a key role in the 9/11 attacks and later formed the group's regional affiliate in the Indian subcontinent, has been killed in a US drone strike in Kabul, in the biggest blow to the global terror network since its founder Osama bin Laden was eliminated in Pakistan in

Zawahiri, who assumed the leadership of al-Qaeda after the death of bin Laden, was killed in a drone strike carried out by CIA on Saturday evening at a house in a posh locality in the Afghan capital where he was sheltering to reunite with his family, US President Joe Biden said on Monday, declaring that "justice has been delivered and this terrorist is no more.

The 71-year-old Egyptian surgeon, on the FBI's Most Wanted Terrorist list, had a USD 25 million bounty on his head, was bin Laden's secondin-command during 9/11 attacks and took over as the head of al-Qaeda after his

He remained a visible international symbol of the terror group, 11 years after the US killed bin Laden during a raid in Pakistan's garrison city of Abbottabad in May 2011. "My fellow Americans, on

Saturday, at my direction, the United States successfully concluded an airstrike in Kabul, Afghanistan, that killed the emir of al-Qaeda, Ayman al-Zawahiri," President Biden said.

"I authorised a precision strike that would remove him from the battlefield, once and for all," Biden, still isolating due to a Covid-19 reinfection, said in a speech from a balcony of the White House.

According to officials, Zawahiri was on the balcony of a safe house in Kabul when the drone fired two Hellfire missiles at him. Other family members were present, but they were unharmed.

"He was deeply involved in the planning of 9/11, one of the most responsible for the attacks that murdered 2,977 people on American soil. For decades, he was the mastermind of attacks against Americans," said Biden, referring to the victims of the 2001 attacks in which hijackers crashed passenger jets into landmark buildings in New York and Washington.

"Now, justice has been delivered and this terrorist leader is no more. People around the world no longer need to fear the vicious and determined killer," Biden said.

'The US continues to demonstrate our resolve and our capacity to defend the American people against those who seek to do us harm. We make it clear again tonight, that

no matter how long it takes, no matter where you hide, if you are a threat to our people, the United States will find you and take you out," he said.

Biden said the precision strike targeting was the result of the "extraordinary persistence and skill" of the nation's intelligence community.

The strike comes one year after Biden ordered the withdrawal of US troops from Afghanistan, prompting Taliban forces to rapidly seize

control of the war-torn nation.

Price rise linked to global issues: Govt

Opp raps Govt for rising price of food items

The Centre on Tuesday asserted that the price rise and the inflation are linked to global development beyond the control of any country even as the Opposition parties during a debate in the Rajya Sabha appealed to the Government to acknowledge the problem and provide relief to the poor.
While members from the

Opposition benches raised concerns over the rising inflation in the country and its impact on the common man, members of the ruling BJP claimed that the inflation rate was only at 7 per cent and that too mainly on account of external factors such as the Russia-Ukraine war and global disruptions. They also hailed the Government for navigating the economy in the right direction in such a troublesome time.

Replying to the debate, Finance Minister Nirmala Sitharaman said while nobody is in denial about the price rise, India's macro-economic fundamentals are strong. "Indian economy, compared to the situation prevailing in many of our peer groups and in many of developed economies, is definitely much better," she

The Minister claimed the poor's consumption of any food item has not been taxed and 5 per cent GST has been

levied only on pre-packed, labelled items and not on those items sold loosely

"The more I listen to issues on the GST I am worried that the information is not reaching rather there is misinforma tion. There's no GST on cash withdrawals; GST is paid by the bank which takes the cheque books from its printer. It's a matter of record that all States agreed to the proposal of GST on pre-packaged items. There wasn't one person who spoke against it, there wasn't a single disagreement," the Finance Minister said.
"Debates are something

that we respect and want to participate and I am glad today that we had this debate. Every State taxed some or the other food items such as cereal, pulses, curd, lassi, buttermilk, "she said. The Minister said today's economic distress throughout the world needed to be looked at holistically

On the inflation, the Minister said ideally the inflation should be kept below 6 per cent. "The Government has a targeted approach to reach sections that desperately need help. We are not saying we will not do anything more," she said. Sitharaman said the RBI has registered its concern over the adverse effect of cryptocurrency on the Indian econ-

"At present, cryptocurrencies are unregulated in India. The Government has brought a comprehensive taxation regime for the transfer of virtual digital asset (VDA), including gifting of VDA Cryptocurrencies are by definition borderless and require international collaboration to prevent regulatory arbitrage Any policy framework on cryptocurrency can be effective only after significant international collaboration on evaluation of the risks and benefits and evolution of common taxonomy and standards," she

Rupee performance better than its peers, says Finance Min

It hasn't collapsed, comfortably placed: Nirmala Sitharaman

Amid weakening of the rupee against the dollar, Finance Minister Nirmala Sitharaman on Tuesday assert ed the Indian currency has not collapsed and it is actually finding its natural course.

Making this point in the Rajya Sabha after some members expressed concern over the depreciation of the rupee, she also said the Reserve Bank of India is continuously monitoring the situation and inter-

vening if there is volatility.
Fielding questions of the rupee versus dollar value comparison during the Question Hour, which functioned smoothly for the first time since the Monsoon Session began on July 18, Sitharaman said in fact the performance of the local currency is much

"It is comfortably placed,"

she quipped. "The RBI interventions are not so much to fix the value of the Indian Rupee because it is free to find its own course," the Finance Minister said, adding interventions that are happening from the RBI side are more for containing volatility that is happening between the Indian rupee and the US dollar and so on

DU to launch 'Competence **Enhancement' scheme**

 $T^{he\ Delhi\ University\ is\ planning\ to\ launch\ a\ scheme}$ 'Competence Enhancement' which will allow students from other universities or institutions to study various courses in the varsity from next year. The DU's academic council (AC) will discuss the implementation of the scheme during its meeting on Wednesday.

According to the agenda of the meeting, the scheme will enable people from "different walks of life" to enrol in the university to enhance their knowledge and understanding in any subject being taught in the varsity.

Admissions under the scheme will be merit-based and the candidates will be allowed to register for a maximum of two courses and eight

credit subjects in a semester. A candidate who fulfils

the eligibility criteria and prerequisites can register for the course, the agenda mentioned.

"In addition to the minimum eligibility criteria, one must be able to demonstrate a genuine interest and enthusiasm for the courses proposed to study. The candidate must have the time and commitment needed to study the course along with the students studying in regular mode," the agenda mentioned.

The number of seats in a course open for this scheme will be a maximum of 10 per cent of the total strength of the class of that course, the agen-

The registration of candidates for a specific course will be valid for a semester only.

The credits earned from the courses will be transferred to a student account in the Academic Bank of Credits.

The Academic Bank of Credit (ABC) is a virtual storehouse which will keep digitally stored records of academic credits secured by a student. At the end of the course, students will get a certificate.

The agenda stated that the scheme will fulfil the objectives of the new National Education Policy, which provides an opportunity for students to design their academic pathways by studying a variety of courses from different academic institutions.

The teaching and evaluation pattern of such students will be identical to that of a regular DU student.

Teaching or instructions shall be provided in the same mode and medium as that of regular students and evaluation pattern for these candidates shall be identical to that of regular students," the agenda read.

According to the agenda, a student who fails to pass or complete a course can re-reg-

24 Central Vista workers hurt as 2 buses collide

More than 24 labourers were injured on Tuesday after a private bus carrying them to the Central Vista project site collided with a DTC bus in central Delhi's Patel Nagar.

Police said four more people -- including the driver of the private bus and three passengers of the cluster bus -were also injured. Upon reaching the spot, police said they found that the bus carrying the labourers to the new Parliament building construction site had rammed into the DTC bus from behind at the main traffic light at Patel Nagar.

Police said the impact left a total of 28 people injured including the driver of the private bus, the 44-year-old Jagmohan. According to Shweta Chauhan, the Deputy Commissioner of Police (DCP), Central district, on Tuesday around 8:58 AM, information regarding accident of two buses at main Red Light Patel Nagar was received at Ranjeet Nagar police station.

"The police team on spot found that one orange color Cluster Bus was hit by white private bus from rear side and the injured persons were already taken to hospital by ambulances," said the DCP.

"On reaching Sardar Vallabh Bhai Hospital, Patel Nagar, total 28 passengers including the driver of private bus were found being treated there. Out of these, 3 injured were from cluster bus who left the hospital after first aid," said the DCP.

"Rest injured persons who are labours being taken to the construction site of new Parliament Building, including drive of offending private vehicle have been referred to RML hospital for MLC's and further treatment, they are being shifted to RML hospital," said the DCP. "The driver of offending vehicle is Jagmohan (44) and he is still unconscious. Legal action as per law is being taken," police said.

The government and RBI closely monitor the developments in the exchange rate of the Indian rupee, she said.

"The RBI regularly monitors the foreign exchange market and intervenes in situations of excessive volatility to curb it. It intervenes to maintain orderly conditions without targeting any specific level of the exchange rate. The Government and RBI calibrate macroeconomic policies on the exchange rate on a regular basis, the Finance Minister said.

Initiating the discussion, CPI (M)'s Elamaram Kareem said there has been a constant increase in prices of essential commodities in the last eight years of Modi Government. Despite record foodgrains, it is tragic testimony that farmers are fighting to get better prices and consumers are weighed down by high prices, he said, adding that the Government should have distributed the surplus stock to the poor through the public distribution system

Accusing the Opposition of doublespeak on the Goods and Services Tax (GST), former Union Minister Prakash Javadekar said the Opposition had "unanimously" agreed for 5 per cent GST on pre-packed food items in the GST Council Meeting, but when talking to media outside, the same tax became "Gabbar tax". For undertaking developmental work, he said funds are required. 'Money does not come by printing but by generating income," he

Sudhanshu Trivedi of the BJP said India's current inflation is around 7 per cent, which is one of the lowest in the world. There are 63 countries where the rate of inflation is over 10 per cent.

Refuting Javadekar's claims, TMC leader Derek O'Brien said rising prices of essential commodities coupled with imposition of the GST on pre-packed food items, which was not agreed by Opposition in the GST Council, and unemployment is affecting the poor badly. On top of it, rupee appreciation has put pressure on the economy, he said.

"We appeal to the Government as a constructive Opposition, first, you have to acknowledge the problem. If vou do not acknowledge the problem, how will you fix the problem?" he said.

The searches were conducted under the Prevention of Money Laundering Act (PMLA) to "gather additional evidence with regard to the trail of funds and they are against those entities who were involved in the National Herald-linked transactions", officials said, adding the action was undertaken in the wake of fresh evidence that emerged after the latest round of questioning of various people.

The National Herald is published by the Associated Journals Ltd. (AJL), and its holding company is Young Indian.

Condemning the raids, Congress general secretary Jairam Ramesh said in a tweet, 'The raids on Herald House, Bahadur Shah Zafar Marg, are a part of the continued attack against India's principal Opposition -- Indian National Congress. We strongly con-demn this vendetta politics

against those who speak up against the Modi Govt".

"This is political vendetta

to ruin the image of Congress... The party will not tolerate these kinds of actions by the Government," Leader of Opposition in Rajya Sabha Mallikarjun Kharge said, adding that the BJP-led Central Government wants to "suppress the voice of Congress and create fear". GOVT SETS UP 2 PANELS ON EXCISE POLICY; 130-140 PRIVATE VENDS, STORES REMAIN CLOSED

s the Delhi Government Anotified the order extending the existing excise policy for a month, a majority of restaurants and bars started serving liquor in the city while around 130-140 private vends and stores remained closed on Tuesday as they were reluctant to get licences just for a month.

Meanwhile, the Delhi

Government has formed two committees, including one for ensuring smooth transition from the existing policy to the old one. The other committee will formulate a new excise pol-

Top sources said that six zonal licensees have opted out of the extension and surrendered their licences, as a result of which, a total of 130-140 liquor vends will be closed now. This will further bring



330. A thin crowd was seen outside some of these vends which were opened in the early hours in different parts of the national Capital. A restaurant owner at Connaught Place said, "As the Government has extended the existing licence term for a month, we have decided to reopen it." Meanwhile, the Confederation

A private liquor vend

Government works out a permanent solution very soon, for the rest of the year and for years ahead, which regains the sense of stability, predictability, and tranquility so vital for

said Vinod Giri, director-general, CIABC while commenting on the Delhi Government's decision to allow private vends till August end. "Start-stop-start mode or very short-term extensions, like a month, just disrupt the supply chain, creating stock pile ups or stock outs that take time to regain shape and flow," Giri said.

Meanwhile, some shops selling liquor remained closed. "Since the shops were closed on Monday because there was no order on the extension till late Sunday night, many workers scattered. Also, stocks had been sold out as our licences had expired on July 31. So, shops will reopen after these things are taken care of," said a zonal

A few people were seen outside a liquor shop in Janpath area. The vend employees said the licences were being renewed and liquor would be

stocked before business resumes normally. "There is liquor on the shelves, but they are not selling it and asking us to come later," said a customer outside the vend. The four corporations—

the Delhi Tourism and Transportation Development Corporation (DTTDC), Delhi State Industrial and Infrastructure Development Corporation (DSIIDC), Delhi Consumer's Cooperative Wholesale Store (DCCWS), and Delhi State Civil Supplies Corporation (DSCSC) have geared up to ensure supply of liquor through vends managed by them.

Officials privy to the development said that preparations re underway to chalk out a plan for sale of liquor at Government-run liquor vends managed by the four corporations. "Things will get clearer in the coming days," they said.

Delhi Police not in favour of bars, restaurants remaining open till 3 AM

Police counsel submitted before Justice Yashwant Varma, that the agency was "saying no" to the extension of timings of operations beyond 1 AM. In its report filed in case, the police stated that in the meetings of the joint consultative group, its officials objected to bars being permitted to operate beyond I am on several grounds, including that demography of Delhi has a "unique character", there are several offices and residence of importance and city has "reflected ugly and irresponsible behaviour of people under influence of alcohol late

The report informed that women's safety was a big concern and given acute shortage of manpower in Delhi Police, operation timings of bars in restaurants and clubs should not be increased.

The report stated that it was suggested by police officials that since decision regarding increasing time for bars and restaurants was taken by Delhi government, the views of agency may be sent for re-consideration of timings by the competent authority.

Lack of police NOC delays preparations for demolition of Supertech's Twin Towers



 $F^{\text{ailure to get a No Objection}}_{\text{Certificate (NOC) from the}}$ Noida Police has led to delay in starting the initial work that needs to be done before the demolition of Supertech's Twin Towers can take place on August 21.

Explosives were to be planted in both the towers from August 2 to August 20 but the work could not start on the set date. The officials had marked around 10,000 pillars in the tower to commence the work of planting explosives and by August 20 about 3,700 kgs of explosive material was to the towers were supposed to be demolished on August 21, with the delay in placing the explosions, the final date might

According to information, the explosives did not reach Noida as the NOC could not be obtained from the Regional Office of the Explosive Controller located in Agra on Tuesday. Preparations are on in full swing to get the NOC.

Once it is issued, the explosives will be brought in two vehicles from Palwal to Supertech Twin Towers with a police escort at 4 A.M. on Wednesday. At the same time, gelatin rods will come in one vehicle and detonators in other vehicle. Every day 200 kg of explosives will be installed.

According to a senior official, the demolition of the twin towers located in Sector 93A of Noida is scheduled for 2.30 P.M. on August 21. The Supreme Court's deadline for the demolition of the nearly 100-metre tall illegal structures is August 28. The time from August 21 to 28 was kept as a buffer period.

As per the officials in the know of the developments, the charging - filling of explosives in columns of the skeletal structures – process was to begin on Tuesday and it would have taken around 15 days for the job to be completed safely. "However, the charging process could not begin as per the schedule. A couple of no objection certificates (NOCs) are still pending after which final preparations for the demolition process can begin," an official

According to sources, demolition firm Edifice hired by developer Supertech Group, was yet to provide replies to queries of the Central Building Research Institute (CBRI), whose approval is needed for the charging process "Once a few pending

reports are submitted to the CBRI and it gives its go ahead, the charging process would begin," a Noida Authority official said.

The Noida Authority would be officially reviewing the status of the project on August 6 after which the further course of action could be shared, the official added. Over 3,500 kgs of explosive will be filled within 9,400 holes

L-G slams ACB, Vigilance over delay in graft probes

Saxena asks officials for list of pending cases against Govt officials, reasons for delay

elhi Lieutenant-Governor (L-G) Vinai Kumar Saxena has taken a serious view of procedural lapses and delays by investigating agencies like the Anti-Corruption Branch (ACB) and the Directorate of Vigilance (DoV) in the course of an investigation into complaints/cases of corruption against Government officials. He has also expressed dis-

pleasure over administrative departments not furnishing or delaying comments sought by the investigating agencies in complaints against their offi-

As per a statement released by Raj Niwas, to know the reason behind the pendency of corruption cases, the L-G has called upon the officers concerned of the ACB for an



explanation regarding matters, which are pending for more than one year and directed the department to furnish a list of pending cases along with the reason of pendency. "Saxena also issued strict

instructions to the DoV and all departments concerned to consider all cases and complaints referred to them for comments and examination and directed them to ensure that the same are provided within a fixed time-frame after judicious application of mind," it said. "There were many cases of

investigation pending since 2012 till 2017, in others, the administrative departments had not furnished their comments and in some the DoV had submitted self-contradictory recommendations for grant of sanction," it read.
"Saxena advised the DoV

to ensure that requests from the ACB are submitted for his consideration only after due diligence by the administrative departments concerned against whose official the complaint has been made," the statement said. "The L-G also directed that the comments of the administrative department should be put on record without any failure and it should be ensured that the recommendations made by various agencies are to the farthest possible extent, not in variance of each other and are not self- contradictory," it said.

"The L-G has underlined that while this will ensure speedy disposal of cases on one hand it will also ensure justice to the complainant as well as respondent," the statement further added.

The L-G's move came in the wake of several cases of alleged corruption against Government officials that were put up to him and displayed serious non-application of mind and inordinate delays by the departments and agencies

4 workers fall to death from 17th floor, 1 hurt

They fell while fixing a tower crane at a construction site in Gurugram without adequate safety equipment

Gurugram: In a tragic incident, four workers were killed and another was critically injured while fixing a tower crane on the 17th floor of an under-construction high-rise building on Tuesday evening at Sector-77 of Gurugram. Officials said that the inci-

dent took place at around 5.00

PM at a construction site of

Emaar Plam Hills where a residential project is coming up. According to the police the contract of the project was given to JJRS Contractors. Of the five workers, four died on the spot and one was hospitalised in a critical con-

dition. "All the victims were natives of Bihar," police said. The accident occurred as the victims were fixing the tower crane used to transport construction materials to the top of the housing project. They were on the 17th floor and they slipped and fell. While four of them fell to the ground

and died, one of them fell on

the safety equipment on the

12th floor. He was injured and is undergoing treatment," Suresh Kumar, Assistant Commissioner of Police (ACP), Manesar said.

Kumar said prima facie police found that the required safety equipment which was installed on the 12th floor by the contractor was not adequate. A detailed investigation into the matter will be carried out. Further details of the victims are yet to be established, police said.

"The Duty Magistrate and a scene of crime team will soon visit the site and after a detailed probe, an FIR will be registered against the persons handling the project as per the pre-scribe law," Kumar added. The bodies of the victims have been placed in the civil hospital and their next of kin have



70 Monkeypox isolation rooms set up at 6 hospitals

Hours after the national Capital reported its third case of Monkeypox the Delhi Government decided to set up 70 isolation rooms across six hospitals, including three private hospitals, to tackle the Monkeypox situation. According to officials, 20

isolation rooms have been set up in Loknayak Jai Prakash (LNJP) Hospital and there are 10 isolation rooms each in GTB Hospital, Dr Baba Saheb Ambedkar Hospital, Kailash Deepak Hospital, MD City Hospital and Batra Hospital in the city.

Speaking about the preparations being made by the AAP Government, Deputy Chief Minister Manish Sisodia said that "not many cases of Monkeypox have been reported in India, yet we are ready with all the preventive measures in place." A 35-year-old man of African origin with no

recent history of foreign travel has tested positive for Monkeypox in Delhi, making it the country's eighth case and the city's third. "The Delhi Government is keeping an eye on the complete situation of Monkeypox infection and has done all the preparations to fight back. Looking at the current situation, isolation rooms have been set up in three Government-run and three private hospitals," said Sisodia. To provide immediate treatment to the positive and suspected cases of Monkeypox, the Delhi Government has prepared 20 isolation rooms in Loknayak Jai Prakash Hospital, 10 isolation rooms each in GTB Hospital and Dr Baba Saheb Ambedkar Hospital. Apart from this 10 isolation rooms each have been set up in

Government constantly monitoring rising cases of Monkeypox: Mandaviya

PNS NEW DELHI

Tn the backdrop of one more Monkeypox case reported from Delhi on Tuesday, taking the total infections to eight in the country and three in the national Capital, Union Health Minister Mansukh Mandaviya assured Parliament the Government was constantly monitoring the rising cases of monkeypox and there was no cause for panic. He said the disease is not

serious and the centre has issued guidelines to all states to prevent its spread. He also said disease is not serious and centre has issued guidelines to all states to prevent its spread. In a bid to allay the appre-

informed the Rajya Sabha, the Indian scientists had isolated monkeypox virus and an expression of interest was floated by Indian Council of Medical Research(ICMR)for producing the vaccine.

The minister informed House that 15 laboratories were activated all over country for testing monkeypox and more such facilities may be opened if need be.

Elaborating upon action plan to deal with the latest disease, he said eight cases have been reported so far in country and a national task force has been set up to monitor development of diagnostics and vac-

He also said five of the eight cases had foreign travel history. His statement came amidst a report that a 35-yearold man of African origin with

travel testing positive for infection in Delhi. The man was admitted to the Delhi government-run LNJP Hospital on Monday, doctors said, adding that he is in stable condition. The first monkeypox

patient in Delhi was discharged on Monday night. One patient has died in Kerala due to disease. In Parliament, Mandaviy said ICMR has successfully isolated the monkeypox virus and an expression of interest has been floated for research institutions, vaccine and diagnostic kits manufacturers in India to take virus strain for further research to develop a vaccine in country, he added.

He said central teams have of confirmed cases, to the affected districts to assist in control and containment efforts by state authorities. In response to a supplementary question, Mandaviya said government has relied on the experience of tackling COVID-19, to be alert and prepared in advance to prevent the spread of any disease.

He said when disease was first reported globally in May, India had already started preparing to tackle it. While the first case in India was reported from Kerala on July 14, the minister said much before that on May 1, 2022 the Centre had given guidelines to all states, and not just for international airports, on surveillance mechanism and contact tracing, how to collect samples from suspected cases and sending it to recognised laboratories for testing.

"Even the interventions being made by RBI are not so much to determine the value

Indian rupee. It is not for that. It is more to avoid the volatility and allow it to find its course."India, like many other countries, is not pitching its currency at a level extraneously. So the ways and which we want to strengthen...The RBI and the Ministry are fairly engaged in it," she said.

On suggestion made by Vivek Tankha(Congress)to allow the Indian workers to remit dollars into the Indian banks in countries like the UAE to boost the reserve, she said it is not an assurance that the Ministry of Finance will give but she can only pass on the suggestion to the RBI.

Ultra-processed foods associated with high risk of Dementia: Study

 $\mathbf{I}^{ ext{f you love gulping down high}}$ amounts of ultra-processed foods like soft drinks, chips and cookies having high fat, sugar and salt contents then, there are high chances that you may have a greater risk of developing dementia than those who eat the lowest amounts.

According to a study published in the journal Neurology, replacing ultra-processed foods in a person's diet with unprocessed or minimally processed foods was associated with a lower risk.

However, it mentioned that the study does not prove that ultra-processed foods cause dementia and only shows an association. "Our research not only found that ultra-processed foods are associated with an increased risk of dementia, but it also found replacing them with healthy options may decrease dementia risk," said researcher Huiping Li of Tianjin Medical University in

SUltra-processed foods are high in added sugar, fat and salt, and low in protein and fiber. They include soft drinks, salty and sugary snacks, ice cream, sausage, deep-fried chicken, yogurt, canned baked beans and tomatoes, among others.

For the study, the team identified 72,083 people from a large database containing the health information of half a million people living in UK. Participants were 55 and older and did not have dementia at the start of study

They were followed for an average of 10 years. By the end of the study, 518 people were diagnosed with dementia.

Woman hurls sandal at Partha for 'looting poor'

In an incident that can put arrested-and-then-deposed Bengal Minister Partha Chatteriee in the same league with some other top politicians both in India and the US, an angry woman on Tuesday morning hurled her sandal at the former general secretary of the ruling Trinamool Congress for "looting and depriving the poor people and making merry at the cost of public money."

The incident took place at Joka ESI Hospital in southern Kolkata where Chatterjee was brought by the Enforcement Directorate officers for a mandatory medical check-up. Subhra Ghorui a housewife who had come to the hospital for treatment suddenly hurled her sandal at the former minister before going back home barefoot shedding the other sleeper too by the road.

Luckily the footwear did not hit the senior politician, who along with his close aide Arpita Mukherjee were now being probed in the school level recruitment scam. More than Rs 50 crore in cash, jewellery and foreign currency apart from deeds of prime properties were recovered by the ED officials from the residence of Mukherjee. "I don't understand why

this man who has devoured crores of the common man, depriving them of their jobs is being brought in an air-conditioned car ... he should be brought here in ropes ... I was angry ... the anger suddenly soared when I saw him ... instantly I threw the sandal ... Unluckily it missed the target .. It would have been better had it landed on his bald head," woman said, adding she would have been more pleased to greet the leader with a garland of shoes.

Reacting to the incident the Trinamool Congress leadership said the "incident was

unfortunate as he is still not been proven guilty." Party general secretary Kunal Ghosh said "He is in ED custody and the agency is responsible for his security ... tomorrow if he is proven innocent then things will again flow in different directions."

BJP State president Sukanta Majumdar said "though I do not support this incident the TMC leaders should be cautious now ... they must stop syndicate and cut money politics or more such incidents would follow."

CPI(M)'s Chakrabatry said "the shoe was in fact hurled at Nabanna (state secretariat and Chief Minister Mamata Banerjee's office) ... more such incidents would follow ... more TMC leaders will face similar incidents if they do not mend their corrupt habits."

Meanwhile, in related development Arpita on Tuesday followed her mentor's



route disowning the crores recovered from her two apartments. However in doing so she tended to pass the ball in Chatterjee's court even as she said: "The money does not belong to me ... I am in no way connected to the money thus recovered ... I did not know how it came ... it came during my absence ... people used to come to my flat and deposit the cash and go without informing

Earlier Chatterjee too had said that the money did not belong to him apparently suggesting that the wads of notes recovered from Arpita's flat belonged to other persons -

Media should self-regulate, carry fair criticism: Delhi HC

Noting that it understands the freedom of speech "perfectly", the Delhi High Court said on Tuesday regulation. So, we expect you to regulation. media should self-regulate and carry late yourself and the standards of selfing displeasure over a newspaper article critical of a vlogger dragging his child into it. A Bench headed by Justice Siddharth Mridul pulled no punches, as it conveyed its unhappiness over the newspaper referring to the child of the social media vlogger, insisting children shouldn't become a victim of propa-

"You can say whatever you want to about him. But don't visit his family, saying that his child in all probability is going to be mentally challenged....The point is we are completely unhappy with any reference to that child," remarked the bench, also comprising Justice Amit Sharma. The Court's observations came in an appeal filed by the Hindustan Times about an article that appeared in the Mint newspaper against a single bench order.

"We understand freedom of speech

perfectly. But it is self-regulation and we are not saying so. A constitution bench muster," the court said. The court emphasised one should criticise the action and not the person.

"Please debate it but don't visit the children. By all means you find his comments distasteful, please go ahead and express yourself but don't take it any further than that," the bench noted. Drawing an analogy, Justice Mridul said whenever an order is passed by a court, the criticism has to be of the order and not the judges.

"We are informed, we don't know, that a lot is said about us (judges) and it is not limited to us. We don't appreciate that....You criticise the order. You don't criticise us. That is just and fair criticism," he said. The court was hearing an appeal by the newspaper challenging an order of the single judge directing it to take down the allegedly objectionable article. The lawyer appear-



was based on posting videos of his and his family on internet", and the article mentions the criticism that he has received from several others for his con-

The court noted that the article called the vlogger a "misogynist" and a "child abuser", and asked the appellant to approach the single judge with all the record. "We were a little disturbed that you refer to somebody's child. The child

shouldn't become a victim of any pro paganda. We can't have that. Say what you will about the man. Criticise his actions, his speech but don't visit his children with such remarks. It is troubling. That we found very offensive," the court said emphatically.

"Don't visit the children. They haven't done anything. Don't visit the family or the children, don't do that. That is something that in an appropriate case will have to be determined." it

"Once the road is constructed, it will pave the way for easy movement of pilgrims and, in turn, will lead to tourism promotion in Ayodhya," he added. The cabinet also approved

the proposal to expand the limits of Varanasi Municipal Corporation by including the entire area of Sujabad Nagar Panchayat and Ramnagar Nagar Palika Parishad in it. With the expansion of

the Varanasi Municipal Corporation limits, better basic infrastructure facilities will be available to the residents of the areas to be included in it," Urban Development Minister AK Sharma said.

he killing of Al Qaeda leader Ayman al-Zawahiri in a US strike in Afghanistan is surely a big blow to the terrorist group he headed since its founder Osama bin Laden's death in 2011. One good consequence seems to be the absence of a successor. For all we know, the outfit may choose, elect, or select a successor, but he would not have the importance that al-Zawahiri, bin Laden's comrade, had. US President Joe Biden expressed his satisfaction over Zawahiri's death, hoping that this would bring "closure" to families of the 3,000 people killed in America on September 11, 2001. He would also be hoping to gain some credibility in the matters pertaining to defence and security, especially after the messy and bloody exit from Afghanistan a year ago. As many as 13 American soldiers had died in it. The retaliation brought even more flak for the US leadership: it killed 10 innocent people, including an aid worker and seven children. So, Biden was



extremely cautious this time; he reportedly "asked detailed questions about what we [security officials] knew and how we knew it." This time the target was neutralised, with no collateral damage—till the time of writing these lines no damage was reported. Al-Zawahiri's death raises some questions and highlights a few facts that India should never lose sight of.

First, how come that a terrorist, carrying a reward of \$25 million on his head, was living in Kabul and the Taliban, who promised the US of not hobnobbing with Al Qaeda, didn't about it? The possibility that the rulers in Afghanistan were sheltering and harbouring him is very high. This

also gives the lie to the belief, held by many in New Delhi, that we can do business with the Taliban 2.0. The fact, however, is that what we have in Kabul is Taliban II, not Taliban 2.0. Just men will be men (as the tagline of an advertisement says), the Taliban will be Taliban. There is also a possibility, though: someone in the Taliban, and someone very high in the hierarchy, betrayed al-Zawahiri, for \$25 million is a huge sum by any reckoning. At any rate, this doesn't show them worth doing business with: you can deal neither with incorrigible jihadists nor with quislings. Then there is Pakistan, the permanent trouble maker in the region. Its propensity to indulge in mischief, even when on the brink of an economic catastrophe, is enormous. It is highly unlikely that nobody in Rawalpindi had even a hint about the Americans' plans to kill the top terrorist. Did they sell him to the US? Washington, after all, has a lot of say in the workings of the International Monetary Fund? A few billion dollars would be a lot of relief for the Pakistani economy. The lesson we can learn from the killing is that our neighbourood remains as dangerous a place as it ever was.

Hooch tragedy in 'dry' State

The loss of lives due to consumption of spurious liquor is deplorable. Despite tall claims, it flows freely across the country

t least 45 lives have been claimed by spurious liquor in Gujarat last week. Many are undergoing treatment in various hospitals as a result of consuming 'hooch', the illicit liquor brewed and sold by anti-social elements who enjoy political patronage. Politicians are vying with one another to prove that they are teetotalers and could not withstand the sight of liquor. Though Gujarat has declared itself as a dry State, spurious liquor is easily available. 'Prohibition' is an oxymoron term that has to be thrown out of the national narrative. The Government of India has issued license to liquor-manufacturing companies and they are operating efficiently. The Government that permits to manufacture and sale of liquor then asks people not to consume liquor!



its? All States in the country make a windfall selling liquor. Tamil Nadu's income from selling liquor for the year 2021-2022 stood at Rs 36,013 crore, an increase of Rs 2,202 crore from last year's income. Neighboring Kerala recorded a turnover of Rs 11577 crore in 2015-2016 while the figure shot up to Rs 14707 crore from 2019 to 2020. But the States treat the liquor business as a goose that lays golden eggs. States like Kerala and Tamil Nadu have "nationalized" liquor businesses.

The public sector is the monopoly liquor seller in most States. Tipplers stand in long queues in scorching sunlight or heavy downpour to get their

daily quota of spirits. They are forced to consume what the bureaucrats and politicians decide. Toddy tapping is banned in Tamil Nadu while arrack manufacturing is not allowed in Kerala. This has led to the mushrooming of bootleggers who illicitly brew low-quality spirits from hazardous substances. It has been proved that toddy and arrack are good for heavy-duty workers if consumed in moderation. The ban on toddy and arrack draws tipplers to dangerous drinks which cause irreparable damage to their bodies. Those desirous of consuming alcohol should get their quota and the liquor business should be opened up. The earlier the Government does it, the better for the nation as well as the people. The powers that be are not enthusiastic about fighting the cigarette industry and bringing down the habit of smoking while they go all out to throttle the liquor industry. This happens at a time when whisky manufactured by Indian companies is giving their foreign counterparts a run for their money.

Preventing scourge of child trafficking DHANANAJAY TINGAL



Strict laws are urgently required to stop child trafficking as new methods of the illegal trade challenge the existing system

he recent case of rescue of a 14-year old minor girl from a village in Kaithal district of Haryana in May this year highlights a morally and socially unsettling case of "child trafficking" that is on the rise. The minor from Jehanabad district in Bihar, was first drugged and trafficked from Patna railway station and was then sold to a 19-year old man for Rs. 1.7 lakhs. The dismaving story not only jolted the morality of the society but also underscored the vulnerability of minor girls of being trafficked at ease. The girl was rescued following an inter-state operation involving Bachpan Bachao Andolan (BBA), anti-human trafficking units (AHTU), police and district child protection units (DCPU) of Bihar and Haryana. Shockingly, it was found that the marriage was solemnized on fake identity cards showing false age.

In another case in August 2017, a 15-year old young boy from West Bengal Rehan (name changed) was trafficked to Delhi in lure of job and shelter. But he was sold to a factory owner in the outskirts of Delhi for forced labour. Rehan was forced to share a tin-roofed small shelter along with 20 other kids of his age. He and other boys were made to work for up to 18 hours a day without wages and rest. He was saved by BBA and other government agencies and a case was registered against the facto-

Such incidents highlight the magnitude of the problem of child trafficking and the increased threat to young girls from the most vulnerable sections of our society. Young children hailing from poor families in Bihar, Jharkhand, Assam, West Bengal, Odisha and the North-Eastern states are trafficked to metropolises and big cities in lure of jobs and better life and then pushed into prostitution, forced slavery and other illicit activities. Apart from these "source states", children from Nepal and Bangladesh are also trafficked. child suffers both physically Majority of children have been and mentally.

found to be trafficked by the Railways to the metropolises. Majority of the so-called

"placement agencies are unregistered and they hire ground agents to identify innocent children from these regions for trafficking. They sell the trafficked children to different categories of customers like - massage parlours/spa centres, rich families, prostitution rackets and escort services and families in Haryana as child brides.

These agencies cater to the interests of their customers with wide-ranging services including providing nurses, who are mostly untrained, house-maids, hotels and factory owners. In majority of cases age of the children are forged and they are forced to work as bonded labourers with unpaid wages, proper food and clothes, rest and health care. The rich and affluent believe that they have rescued the girls from drudgery and are obliging them by providing shelter and employment and enriching their lives. On the contrary, it has been observed in most cases, the financial condition of the victim's family remains same, while the trafficked

BBA has been campaigning against child trafficking since the early 1990's, when the terminology was not even used in the mainstream media to describe such incidents. It was in 1997, after BBA launched its "Mukti Caravan Abhiyan" in Bihar against child trafficking, the terminology came into common parlance. Village melas were organized where people participated in large numbers, these melas were used to gather information about missing children to track and identify their whereabouts. In 2007, Nobel Peace Laureate, KailashSatyarthi launched a "South Asian March Against Child Trafficking" from Kolkata to Kathmandu to raise awareness against the rising crisis. This was the first such march against child trafficking and brought the raging issue into the mainstream glare. Since its inception BBA has rescued over 1,00,000 children most of whom were trafficked from the source states to metropolises.

Additionally, the recent memorandum of understanding (MoU) with Railway Protection Force (RPF) in nas enabled in increase of raids leading to rescue of kids and arrest of traffickers. In the

last two months, BBA and RPF team's joint operations have succeeded in rescuing 338 children from traffickers. This has now lead the traffickers to change their mode of trafficking. The traffickers send private buses with tinted glass and curtained windows to source states to traffic children, in some cases trucks have also been used for trafficking. Women and couples are used to pose as parents of the children to hoodwink the government authorities. In worst cases, the trafficked girls are forced into selling their newborn infants to childless cou-

ples for lakhs of rupees. The need of the hour is strict law that not only stops this illicit trade but also prevents rise of child trafficking in future. It's an urgent appeal to the government pass the draft bill Trafficking in Persons (Prevention, Care and Rehabilitation) Bill, 2021 released during last year's monsoon session inviting comments and feedback. The bill among other provisions had widened the scope of the offences and also contains strict punitive action related to offences against child.


VOTER ID CARD DELIVERY IS LAUDABLE


IAF must appropriately crosscheck the rea-

TEACH RAMAYANA FOR ETHICS, MORAL VALUES

Management curriculum should include the Ramayana

he Ramayana, the most widely read Indian epic, is not just a scholarly narration of the life and times of Lord Ram but also a treatise on management principles, the most modern of the applied social sciences. It has lessons on politics, strategy, economics, commerce, values and ethics, leadership and even the recent subject areas like CSR.

Ramayana deals with all aspects of management practices in a very lucid, yet comprehensive manner. But it's quite a surprise that Indian business schools have not considered it as a text or even a reference in the course curriculum as suggested readings. This one piece of literature can offer valuable insights on different subjects that form the part of a typical business school curriculum.

While copious western literature finds place in a standard course structure of a business school programme, Ramayana that can offer vital clues to management practices to the students of business schools is found missing. Anyone who has gone through the text of Ramayana, either Ramcharitmanas by Goswami Tulsidas, or Valmiki Ramayana, would know that crucial management lessons are offered in this Indian epic through the actions of various role players like Lord Ram, his three younger brothers, his wife Sita and Hanuman.

The best part of Ramayana is that the main lead played by Lord Ram provides immensely valuable lessons on what ethical conduct is all about. Values and ethics these days are given great emphasis in the course content and form a significant portion of the curriculum in almost every business school as business organisations are emphasizing ethics and morality.



Raising the morality quotient has become a major concern today. It has become an important attribute of managerial quality gaining precedence over intelligence quotient. Lord Ram has led by example. He is an epitome of values and ethics and a role model to be emulated. He is also a picture of humility, commitment and character.

Humility, it may be recalled, is a highly thought after managerial quality. Similarly, his brothers also show what ethical conduct is all about. ese are the times when everyone is hankering for power and pelf. But here is a person who, despite being the legitimate heir to the throne, is magnanimous enough to let go of the authority to rule just to keep his father's words. The entire population of the kingdom wanted him to be the ruler. But he declined.

The beauty of the whole Ramayana is that his younger brother Bharat, who was given the throne, is equally unwilling to occupy the throne, because he thinks it was not legitimate.

Ramayana also contains some very crucial lessons on statecraft. In fact, the dialogue between Ram and Bharat in Ayodhya khand is a treatise on administrative wisdom. No aspect of administration has been left out in that discussion. The Valmiki Ramayana presents this aspect very comprehensively. Duty, sacrifice, integrity, values and righteousness is reflected in behaviour of all leading characters. Not only this, there are strategy lessons to be picked up on teamwork, project management, human resource management and warfare.

It will be an understatement to say that Ramayana is a text that contains lessons for management practitioners. In fact, Ramayana is a complete text on social sciences dealing with all dimensions. It is a handy reference material and needs to be included in the Management program.

Tier II, III cities gear up for digital revolution



Leading MNCs are embracing the idea of expansion in these cities due to multiple advantages, including cost-effectiveness, a large talent pool and low attrition rate

he world is witnessing the rise of 'New India', propelled by high aspirations, astonishing skilling, and unflinching diligence of millennials, who are the largest group of working population in the country. Besides the youth power, the growth story being scripted by India can be attributed to the swift penetration of the internet across the length and breadth of the country, which is stimulating digital revolution at an unimaginable pace.

People in the country, irrespective of their location, education, and age, are reaping the benefits of the digital storm, gaining immense thrust from tier-II and tier III cities. As tier-I cities have reached a point of saturation, now it becomes vital to boost the infrastructure of tier II & III cities, equipping them with all the required facilities to further augment the growth.

A report by IAMAI-Kantar ICUBE 2020 estimates that active internet users will grow by 45 per cent in India over the next five years and reach 900 million users by 2025, up from 622 million in 2020. Tier-II & III cities constitute a larger part of the population that is joining the digital world steadfastly for its day-to-day needs.

According to reports, rural India will have more internet users than urban India by 2025. As a result, the digital ecosystem would have to adapt to cater to the needs of this new demographic.

The estimates of the McKinsey Global Institute (MGI) Digital Adoption Index note that India is the second-fastest growing digital economy among the 17 leading economies of the world. A Nasscom report titled 'Future of Technology Services - Winning in this Decade' highlights that over 50 digital initiatives in diverse sectors such as finance and banking, healthcare, IT/ITES are fueling India's digital dream, while contributing eight per cent to the

Moreover, the Covid-19 pandemic too has accelerated digitization and tier-II and tier III cities are the strongest force behind this thrust in the digital economy of the country. Earlier, most of the business activities, especially IT/ITes, used to remain centered around metropolitan cities such as Gurugram, Bengaluru, Hyderabad, etc. With several conducive factors, including superior infrastructure and skilled workforce, tier-II and III cities have emerged as new loci of growth recently.

The groundwork laid by the Electronics Commission envisaged the creation of regional computing centers to spur software and intellectual capital development in India. The establishment of the National Task Force on Information Technology and Software Development and New Telecommunication Policy provided the roadmap further to catalyze the growth of the IT/ITes sector.

Meanwhile, a spate of infrastructure development has also made these cities the most sought-after destinations for IT/ITes

investments and other businesses. Likewise, the Digital India and Startup India campaigns, the JAM trinity, and Smart Cities Mission have also accelerated the transformation of these cities.

It is estimated that there are more than 61,000 recognized startups in India, across 55 industries, with 45 per cent of them located in tier-II and tier-III cities. The state governments have undertaken various initiatives to attract IT firms and provide a conducive ecosystem by establishing industrial clusters, SEZ, and various skill development initiatives to stay ahead in the digitization process.

Industry bodies such as Nasscom, Assocham, TIE have created access to financial assistance, mentorship, incubation, and network opportunities to support pathbreaking ideas from the hinterlands. According to an estimate by Zinnov, a leading management consultancy, about 976 MNCs have set up 1,257 Global In-house Centres (GICs) in India, out of which 68 GICs are in tier-II locations.

The relaxation in the Department Telecommunications' compliance guidelines, allowing IT firms to work from anywnere amid Covid-19, are also set to provide a fillip to this trend. Moreover, with an aim to foster an IT ecosystem in tier-II and III cities, STPI has launched the India BPO Promotion Scheme (IBPS). This scheme seeks to incentivize the establishment of 48,300 seats in respect of BPO/ITES operations across India. The government provides financial support of up to Rs 1 lakh per seat under two plans -India BPO Promotion Scheme and North East BPO Promotion

Scheme. The scheme is distributed among each state in the proportion of State and population with an outlay of Rs 493 crores. There are special incentives in the scheme to promote employment for women and specially-abled persons, the participation of local entrepreneurs, setting up operations in non-capital cities, etc.

Such a combination of the rising middle class, a shift in the consumption patterns and technological innovation augur well for tier-II and tier-III cities to emerge as growth engines of the Indian economy. The upcoming large-scale developments such as Delhi-Mumbai Industrial Corridor (DMIC), Metro Neo and Metro Lite, Haryana Orbital Rail Corridor will bolster connectivity and put tier-II and tier-III cities such as Sonipat, Jaipur, Dehradun, etc., on the infrastructure map.

On the technological front, the proposed roll out of 5G technology also augurs well for the IT/ITes industry in these cities. A Datacenter Policy is also in the pipeline that will escalate the digital transformation process in India. Also, the 'work from home' model amid the Covid-19 pandemic has set off a trend of reverse migration. As a result, firms are moving to tap talent in Indian hinterlands instead of workforce migrating to tier-I cities for employment. It has led to the emergence of the 'hub and spoke' and 'edge' model wherein tier-I cities serve as hubs while tier-II and tier-III towns form the spoke network, and the edge implies the work that can be done remotely. This model allows


ly lower costs in tier-II and tier-III cities, while retaining their clientele in tier-1 cities. Another emerging trend is the gig economy, wherein firms are looking to diversify their workforce through contract employees who impart flexibility and agili-

ty to their operational models. Moreover, leading multinational firms are embracing the idea of expansion in these cities due to multiple advantages, including cost-effectiveness, lower land and labour costs, availability of a large talent pool, and low attrition rate of the workforce. Besides serving as a consumer market, the cities such as Jaipur, Indore and Lucknow have emerged as education hubs, thereby generating skilled human capital employed in various firms.

Bolstered by these factors, tier-II and tier-III cities will emerge at the forefront of the digital revolution, with multiplier socio-economic impact in terms of employment generation, curbing migration to metropolitan cities, boosting the local economy, improving living standards, and bridging regional disparities in economic development.

This will also lessen the burden

of mega cities, which are facing problems due to limited resources and influx of people from around the corner of the country in the pursuit of quality life. However, it will be critical for these cities to sustain the digitization wave. Focusing on strengthening infrastructure, encouraging skill development among the youth, fostering an entrepreneurial ecosystem, and catalyzing innovation through groundbreaking ideas, and augmenting industry-academia collaborations, efforts will help these cities to reap tangible benefits of digitization.

Al-Zawahri killing: Taliban role under scrutiny

The Taliban had promised in the 2020 Doha Agreement that they would not harbour al-Qaida members

the US drone strike that killed al-Qaida leader Ayman al-Zawahri on the balcony of a Kabul safe house intensified global scrutiny Tuesday of Afghanistan's Taliban rulers and further undermined their efforts to secure international recognition and desperately needed aid.

The Taliban had promised in the 2020 Doha Agreement on the terms of the US withdrawal from Afghanistan that they would not harbour al-Qaida members. Nearly a year after the US military's chaotic pullout from Afghanistan, al-Zawahri's killing raises questions about the involvement of Taliban leaders in sheltering a mastermind of the 9/11 terror attacks and one of America's most-wanted fugi-

The safe house is in Kabul's upscale Shirpur neighbourhood, home to several Taliban leaders who had moved into mansions of former top Afghan officials of the toppled Western-backed government. The Taliban initially sought

to describe the strike as America violating the Doha deal, which also includes a Taliban pledge not to shelter those seeking to attack the United States-something al-Zawahri had done for years in internet videos and online screeds. The Taliban have yet to say who was killed in the strike.

Meanwhile, rumours persist of unease in the Taliban ranksparticularly between the powerful group known as the Haqqani network, which apparently sheltered al-Zawahri, and other Taliban figures.

"The killing of Ayman al-Zawahri has raised many questions," said one Pakistani intelligence official, who spoke on condition of anonymity to The

Associated Press as he wasn't authorized to speak publicly to reporters. Al-Zawahri took over as al-Qaida's leader after Osama bin Laden was killed in Pakistan in 2011, in an operation by US

Navy SEALs.

RUSSIA DECLARES UKRAINIAN MILITARY UNIT A TERROR GROUP

The Russian Supreme Court on Tuesday declared Ukraine's Azov Regiment a terrorist organization banned in Russia, a designation that may expose Ukrainian pris-oners of war held by Moscow to ter-

rorism charges.
Azov, which played a key part in the defense of the southeastern Ukrainian city of Mariupol, has been repeatedly portrayed by Russian officials and state media as a Nazi formation allegedly committing atrocities against Ukraine's civilians. No evidence has surfaced to back up these

The Azov Regiment is a unit within Ukraine's National Guard. It grew out of a group called the Azov Battalion, formed in 2014 as one of many volunteer brigades that rose to bolster Ukraine's underfunded and questionably led military in the fight against Russia-backed separatists in eastern Ukraine.

The Azov Battalion drew its initial fighters from far-right circles and elicited criticism for some of its tactics. Its current members rejected accusations of nationalism and radicalism. Russia's Prosecutor General's

Myanmar violence, Ukraine war loom **over ASEAN meetings AP** ■ PHNOM PENH

Coutheast Asian foreign Oministers are gathering in the Cambodian capital for meetings addressing persisting violence in Myanmar and other issues, joined by top diplomats from the United States, China, Russia and other world powers amid tensions over the invasion of Ukraine and concerns over Beijing's growing ambitions in the region.

The meeting in Phnom Penh of the Association of Southeast Asian Nations will see U.S. Secretary of State Antony Blinken and Russian Foreign Minister Sergey Lavrov together at the same venue for the second time in a month, though it's not clear whether the two will meet.

The two did not meet separately when they both attended the Group of 20 foreign ministers' meeting in Bali, Indonesia, in early July.

But they had their first direct contact since before

phone call Friday, when Blinken urged Moscow to accept a deal to release American detainees Brittney Griner and Paul Whelan and discussed other issues. Also attending is Chinese Foreign Minister Wang Yi. Many have urged Beijing

to use its partnership with Russia to push for an end to the conflict in Ukraine and to help promote peace and a return to civilian rule in Myanmar after a February 2021 coup sparked mass protests and an armed resistance. The meetings come at a time of tension between Washington and Beijing as the U.S. Pushes back against China's growing economic and military influence in the Asia-Pacific. Secretary-General Antonio Guterres sounded the alarm over the war in Ukraine, nuclear threats in Asia and the Middle East, and other tensions, warning that "humanity is just one misunderstanding, one miscalculation away from nuclear annihilation."

The warning came Monday as a pandemicdelayed conference opened to review the 50-year-old Nuclear Nonproliferation Treaty, which is aimed at preventing the spread of nuclear weapons and eventually achieving a nuclearfree world.

The threat of nuclear catastrophe was also raised by the United States, Japan, Germany, the U.N. Nuclear chief and many other opening speakers. Russia, which came

under criticism from some speakers, didn't give its address in its scheduled slot Monday but was expected to

UN Secretary-General Antonio Guterres announced Monday he will attend the 77th anniversary of the world's first atomic bombing in Hiroshima, "at a time of nuclear danger not seen since the height of the Cold War." Religiously observant from boyhood, he immersed himself in a violent branch of a Sunni Islamic revival that sought to replace the governments of Egypt and other Arab nations with a harsh interpretation of Islamic rule.

Al-Zawahri worked as an eye surgeon as a young adult, but also roamed Central Asia and the Middle East, witnessing Afghans' war against Soviet occupiers in that country, and meeting young Saudi Osama bin Laden and other Arab militants rallying to help Afghanistan expel Soviet troops.

He was one of hundreds of militants captured and tortured in Egyptian prison after Islamic fundamentalists' assassination of President Anwar Sadat in 1981. Biographers say the experience further radicalized him. Seven years later, al-Zawahri was present when bin Laden founded al-Qaida.

Al-Zawahri merged his own Egyptian militant group with al-Qaida. He brought al-Qaida organisational skill and experience honed underground in Egypt, evading Egyptian intelligence - that allowed al-Qaida to organize cells of followers and strike around the

Hellfire missiles: US' sought-after secret

AP ■ WASHINGTON

The US drone strike that killed al-Qaeda chief Ayman al-Zawahiri on the balcony of a safe house in downtown Kabul points to the use of secret Hellfire misciles by the CIA as there was no siles by the CIA as there was no explosion and according to American President Joe Biden "no civilian casualties" either.

Zawahiri, 71, who assumed Kabul at 6:18 a.M local time.

After the years of quietly assembling the suicide attackers, funds and plans for the Sept. 11 were optimal, I gave the final approval to go get him, and the mission was a success. None of his family members were hurt, and there were no civilian casualties," President Biden said on Monday while announcing the death of Zawahiri from the

White House.

Widely-known Hellfire missiles are specially designed, secret missiles used to conduct pinpoint airstrikes that kill terrorist leaders with no explosion, drastically reducing damage and minimising the chances of civilian casualties.

A Hellfire missile, which is a little more than five feet long and weighs just over 100 pounds (over 45kgs), typically leaves behind mangled, burned-out shells of vehicles, surrounded by

China on Tuesday reacted guardedly to the killing of al-Qaeda leader Ayman al-Zawahiri in a US drone strike in Afghanistan's Kabul, saying it is against all forms of terrorism but at the same opposed to "double standards" on counter-terrorism operations and at the "expense of sovereignty" of other countries.

'We saw relevant reports," Assistant Foreign Minister Hua Chunying told a media briefing here when asked about China's reaction to al-Zawahiri's death in a CIA drone strike in Kabul.

'China is always firmly against terrorism. We are actively involved in the international counter-terrorism operations," said Hua, who is also the spokesperson of the Chinese Foreign Ministry.

"At the same time, we believe there should be no double standards on counter-

terrorism and all forms of terrorism should be fought," she said.

'Counter-terrorism cooperation should not be conducted at the expense of the sovereignty of other countries," Hua

Áccording to Duncan, who represents South Carolina's 3rd Congressional District, the event is the state's largest annual gathering of Republicans, typically drawing more than 1,000 attendees.

"Mike Pompeo epitomises service to country and community over self," Duncan said touting Pompeo's "unwavering commitment to America first foreign policy and his willingness to stand up to adversaries like China.'

Last year, Pompeo headlined a fundraiser for the state Republican Party in South Carolina, home to the first presidential votes in the South.

His super PAC, which has raised nearly \$6 million, last month released a digital ad in South Carolina and Iowa another early-voting state where he has been making appearances - touting religious freedoms.

E-invoice to be mandatory for B2B deals for biz with turnover of ₹10 crore from October

ST registered businesses with annual turnover of Rs 10 crore or more will have to generate e-invoices for B2B transactions from October 1, the finance ministry said.

Currently, businesses with turnover of Rs 20 crore and above are required to generate electronic invoice for all B2B transactions.

The Central Board of Indirect Taxes and Customs (CBIC) on August 1 notified lowering the e-invoice threshold to Rs 10 crore and above from October 1. The GST Council, comprising



and states, had decided to implement electronic invoice in a phased manner.

Under Goods and Services Tax (GST) law, einvoicing for business-tobusiness (B2B) transactions was made mandatory for companies with turnover of over Rs 500 crore from October 1, 2020, which was then extended to those with turnover of over Rs 100 crore effective January 1,

From April 1, 2021, companies with turnover of over Rs 50 crore were generating B2B e-invoices, and the threshold was

brought down to Rs 20 crore beginning April 1,

Going forward, The CBIC plans to further lower the threshold for e-invoice generation to Rs 5 crore.

Deloitte India Partner MS Mani said this will further expand the GST tax base and provide more data to the tax authorities enabling better compliance.

"The progressive reduction of the e-invoicing threshold indicates that, over a period of time, einvoicing will become mandatory for all categories of GST taxpayers," Mani

RBI's financial inclusion index rises, shows growth across all segments

The RBI's composite financial inclusion index (FI-Index) capturing the extent of financial inclusion across the country rose to 56.4 in March 2022, showing growth across all parameters.

The index captures information on various aspects of financial inclusion in a single value ranging between 0 and 100, where 0 represents complete financial exclusion and 100 indicates full financial inclusion. "The value of FI Index for March 2022 stands at 56.4 vis-a-vis 53.9 in March 2021, with growth witnessed across all the sub-indices," the RBI said in a statement.

In August last year, the central bank said it has been conceptualised as a comprehensive index, incorporating details of banking, investments, insur-



ance, postal, as well as the pension sector, in consultation with government and respective sectoral regulators.

The FI-Index comprises three broad parameters -Access (35 per cent), Usage (45 per cent), and Quality (20 per cent) with each of these consisting of various dimensions, which are computed based on several indicators.

The FI-Index was constructed without any 'base year' and as such it reflects the cumulative efforts of all stakeholders over the years towards financial inclusion.

The country's FMCG industry reported a 10.9 per cent growth in terms of value in the June quarter, helped by a rise in consumption even though the rural markets remained sluggish in non-food

segments, says a report.

Data analytics firm NielsenIQ on Tuesday said the overall consumption has

revived as unit volume has increased on a sequential basis in the April-June quarter but on an annual basis, it had a negative growth of 0.7 per cent in the latest quarter under

During 2017-18, the write-off by banks stood at Rs 1,61,328 crore, he said. In all, he said, bank loans to the tune of Rs 9,91,640 crore have been written off in the last five years--2017-18 to 2021-22. He also said that "scheduled com-

mercial banks (SCBs) and all Indian financial institutions report certain credit information of all borrowers having aggregate credit exposure of Rs 5 crore and above to RBI under its Central Repository of Information on arge Credits (CRILC) database."

As per RBI, the CRILC data in respect of wilful defaulters is main-

Windies pacer takes 6 for 17 as hosts win 2nd T20I by 5 wickets to level series

Left-arm paceman Obed McCoy decimated a star-studded Indian batting line-up with sensational careerbest figures of 6 for 17 as the West Indies equalised the five-match series with a five-wicket victory in the second T20I

McCoy wreaked havoc in his two spells as India, after being put into bat, were bundled out for 138 in 19.4 overs on Monday.

The target was never going to be a problem for the West Indies batters as opener Brandon King smashed 68 off 52 balls but the hosts stuttered during the back-end before Devon Thomas' unbeaten 31 off 19 balls sealed it in his team's favour. He hit a six and a four off Avesh Khan.

It was Arshdeep singh, who bowled a lethal yorker to castle the dangerous Rovman Powell and set it up nicely for Avesh to defend 10 runs, but a no-ball off the first delivery derailed India's bid to pull off a heist.

Put into bat in a match that was pushed back by three hours due to late arrival of team kits, the Indians lost the momentum from the onset as skipper Rohit Sharma (0) was dismissed off the first delivery of the match.

Throughout the innings, the Indians were unable to gauge the pace and bounce of the Warner Park track, as McCoy mixed his variations well during a career-best spell.

It was the extra bounce from McCoy that reared up awkwardly taking off the shoulder off his bat and the short third-man was in action to gobble up the dolly.

Suryakumar Yadav (11) hit an audacious six over cover but Mccoy bowled one full, and the loosely attempted expansive drive, without any palpable footwork, was only going to turn into an edge and land up in the wicketkeeper's gloves.

Rishabh Pant (24 off 12 balls) was breathtaking during his stay and a flick



behind deep square leg for a massive six off McCoy left everyone in awe.

There was another six off Odean Smith behind fine leg, but left-arm spinner Akeal Hosein accounted for him with a delivery in which he altered the length, and the slight turn did him in. The mistimed pull landed into the deep mid-wicket fielder's hands.

CWI pushes back 3rd T20l against **India by 90 mins**

Cricket West Indies (CWI) on Tuesday announced a revised start time of the third T20I between India and the West Indies due to late finish of the second match, which was twice delayed because of luggage issues.

The third T20I was scheduled to begin 10:30 AM local time (8 pm IST) but has now been pushed back by one-and-a-half hours to 12 pm local time (9:30 pm IST).

The CWI said that the revised timing was rolled out keeping in mind adequate rest and recovery time for the players of both teams and also in consideration of the fact that the last two back-to-back matches will be held in Florida, US.

"Following the delayed start on Monday, the teams have agreed to start the third Goldmedal T20 Cup match at a later time to ensure that the players receive adequate rest and recover time for the back-toback matches in St Kitts and in consideration of the back-to-back matches to come in Florida," the CWI said in a statement.

In fact, CWI's statement also clears the air that the last two games will indeed go ahead in Florida, despite multiple reports that the matches could be moved out of the US state due to visa issues.

In an unprecedented scenario, the second T20I was initially delayed by two hours due to a delay in arrival of team luggage. It was further pushed back by another hour due to same issue.

England to play seven T20Is on 1st Pak tour in 17 years

England will arrive in mid-September and play four T20Is in Karachi, with the other three matches in Lahore, and then return in Dec for three Tests. England's last tour to the

country was in 2005 before Pakistan were forced to play international matches at neutral venues in the UAE following a 2009 attack on the Sri Lankan team bus in Lahore.

International cricket gradually returned to Pakistan in 2015 but suffered another set-

back when New Zealand pulled ODI in September last year, citing security alerts. A week later, England with-

drew its men's and women's teams from tours to Pakistan. Both tours were rescheduled

after the Pakistan Cricket Board (PCB) gave assurances over security. Pakistan successfully hosted Australia for the first time since 1998 earlier this year.

"We demonstrated our event planning and operational skills in the highly successful series against Australia in March-April this year and I am confident we will be able to replicate these when England visit us," said PCB director of international cricket, Zakir Khan.
