# 3 IAF officers axed for **BrahMos misfire into Pak**

Cruise missile sans warhead had landed in Pak on March 9, 2022

The Government on Tuesday dismissed three IAF officers from service for the BrahMos supersonic cruise missile "accidental firing" on March 9 this year. The missile had landed in Pakistan, However, there were no casualties there.

The three officers include a Group Captain, a Wing Commander, and a Squadron Leader. They had deviated from the standard operating procedure.

Announcing this major development, the IAF said, "A BrahMos missile was accidentally fired on March 9. A Court of Inquiry set up to establish the facts of the case, including fixing responsibility for the incident, found that deviation from the Standard Operating Procedures (SOP) by three



officers led to the accidental firing of the missile.
"These three officers have

primarily been held responsible for the incident. Their services have been terminated by the Central Government with immediate effect. Termination orders have been served upon the officers on August 23.

The missile was reportedly fired from a base in north India and it deviated from the course and landed 124 kms inside Pakistan in the Mian Channu area there. The missile

did not carry any warhead. The IAF had viewed the incident seriously and reviewed its standard operating proce-

The Defence Ministry was also briefed about the inquiry committee report submitted to it sometime in mid-April. Sabotage was ruled out.

With questions raised about the training and other allied procedures in handling such sophisticated missile system, Defence Minister Rajnath Singh had assured Parliament system is very reliable and

Pakistan had lodged a strong protest against the reported accidental firing of the missile and summoned the Indian Charge d'Affaires in Islamabad.

Backed by China, Pakistan also called for a joint probe. However, the US said it was an accident and the Indian Defence Ministry had given the

"We have no indication, as you also heard from our Indian partners, that this incident was anything other than an accident," State Department Spokesperson Ned Price had said. Pakistan termed the Indian Defence Ministry statement regretting the accident as a "simplistic explanation" while

calling for a joint probe.

Major General Babar
Iftikhar, the Director-General of the Inter-Service Public Relations (ISPR) of Pakistan, had claimed that an unarmed projectile launched from India entered the Pakistani airspace travelling 124 km and fell near Mian Channu. No loss of life was reported.

# BJP suspends Telangana MLA for Prophet barb

#### T Raja Singh granted bail after court finds lapses in arrest procedure

n a second successive case of **L**"disciplinary action" against its own party leader, the BJP on Tuesday suspended its Telangana MLA T Raja Singh for his controversial remarks in Hyderabad on Prophet Mohammad. Telangana is slated for Assembly polls in 2023. The BJP had earlier sus-

pended its national spokesperson Nupur Sharma for an alleged controversial comment involving the Prophet in a television debate. Multiple cases have been filed against Sharma for her comments.

Singh, known for his hard Hindutva views, was suspended by the party following protests against his purported comments leading to his arrest by the Telangana Police. The suspended BJP leader was remanded in 14-day judicial custody by the court. However, Raja Singh was granted bail within hours of arrest. The court ordered his release after

it noted that Section 41 of the Code of Criminal Procedure (CrPC) was not followed during the arrest.

A statement from Om Pathak, who is secretary of the BJP's central disciplinary committee, said, "You have mittee, said, expressed views contrary to the party's position on various matters, which are in clear violation of Rule XXV 10 (a) of the constitution of the Bharatiya Janata Party. I have been directed to convey to you that pending further enquiry, you are suspended from the party and from your responsi-bilities/assignments, if any, with

immediate effect." Pathak also asked Singh to

"show cause" within 10 days from the date of this notice as to why he should not be expelled from the party.

"Your detailed reply must reach the undersigned no later than 2nd of September 2022," Pathak said.

AIMIM chief Asaduddin Owaisi claimed Singh made derogatory remarks on Prophet Mohammed. "They have not learned a lesson from what Nupur Sharma has said. This is a continuation of what Nupur Sharma had said," he said. Continued on Page 2

# SC to hear plea to revoke remission to Bilkis' rapists

Challenging principles on basis of which remission granted to 11 convicts: Lawyer

The Supreme Court on Tuesday agreed to consid er a plea challenging the grant of remission by the Gujarat Government to 11 life convicts in the Bilkis Bano gangrape

The remission and the consequent release of 11 convicts on August 15 this year from Godhra sub-jail under the Gujarat Government's remission policy has sparked a debate on the issue of such relief in heinous cases.

A bench comprising Chief Justice NV Ramana and Justices Hima Kohli and CT Ravikumar took note of the submissions of senior advocate Kapil Sibal and lawyer Aparna Bhat against the grant of remis-



sion to the convicts serving life imprisonment in the sensational post-Godhra riots case.

We are only challenging the remission and not the Supreme Court order. The Supreme Court order is fine, My Lords. We are challenging the principles on the basis of which remission was granted," Sibal said while seeking an urgent hearing of the plea.

The lawyers were seeking an urgent hearing of the plea filed by CPI(M) leader Subhashini Ali, journalist Revathy Laul and activist Roop Rekha Rani.

The plea referred to the

sequence of events recorded in judicial files and said, "It is submitted that on such facts, no right thinking authority applying any test under any extant policy would consider it fit to grant remission to persons who are found to have been involved in the commission of

such gruesome acts. TMC MP Mahua Moitra too filed a separate petition in the SC against the release of the convicts, alleging the remission "completely fails to bolster either social or human justice and does not constitute a valid exercise of the guided discretionary power of the State.

### Uddhav-Shinde row: SC transfers case to Constitution bench

The Supreme Court on Tuesday referred to a fivejudge bench the petitions filed by the Shiv Sena (Uddhav) and Maharashtra Chief Minister Eknath Shinde raising several constitutional questions relatdisqualification.

The apex court ordered the listing of petitions before the Constitution bench on Thursday and directed the Election Commission not to pass any orders on the Shinde faction's plea that it be considered the real Shiv Sena and

granted the party's poll symbol. A bench headed by Chief Iustice NV Ramana said the batch of petitions raises important constitutional issues relating to the 10th schedule of the Constitution pertaining to disqualification, power of the Speaker and the Governor and judicial review. The apex court said the proposition of law laid down by the Constitution bench in the Nabam Rebia



case relating to the 10th schedule stands on contradictory reasoning which requires gap filling to uphold constitutional morality.

'The matters raise important issues which need consideration by a five-judge constitution bench. List the matter before the Constitution bench the day after tomorrow and the bench will decide about the symbol related to the Election Commission proceeding at the beginning," the bench also comprising Justices Krishna Murari and Hima Kohli said.

# NIA-IB team to visit Moscow to unravel ISIS fidayeen's plot

India is likely to send a joint Iteam of the Intelligence Bureau and the National Investigation Agency to Russia to investigate the arrested ISIS suicide bomber's links here.

The Russian authorities briefed National Security Adviser Ajit Doval during his recent visit to Moscow on the developments linked to the arrest of the suicide bomber. The joint team of the IB

and the NIA will seek to unravel the arrested bomber's possible links with the Indian sleeper cells that were planned to provide logistical support to him for eliminating a BJP leader over the Prophet slur.

The joint Indian team is expected to gather the details of the interrogation by Russian agencies and seek to find out if any Indian ISIS radical group is associated with the Telegram

app through which the arrest-

ed radical was indoctrinated by



The Russian Federal Security Service (FSB), sources said, is coordinating with the Indian agencies.

The joint team of the NIA and the IB will meet with Russia's intelligence agency, Federal Security Service, and collect all information on the ISIS terrorist's Indian links,

they said. On Monday, the Russian Federal Security Service (FSB) had announced that it had detained a suicide bomber, a member of the ISIS terrorist

a terrorist attack against an Indian politician for avenging the alleged insult to Prophet Muhammad.

and detained a member of the Islamic State international terrorist organisation banned in Russia, a native of a country in the Central Asian region, who planned to commit a terrorist act by blowing himself up against one of the representatives of the ruling circles of India," the authority had said in a statement on Monday.

The detainee was recruited by one of the ISIS or Daesh's leaders as a suicide bomber in Turkey, the statement added.

The FSB posted an interrogation video showing the suspect confessing that he was supposed to commit a terrorist act for remarks on Prophet Muhammad.

# Distressed farmer attempts suicide near Maha Assembly

Adistressed farmer from Osmanabad district in Maharashtra on Tuesday attempted to commit suicide by settling himself on fire in front of Vidhan Bhavan in south Mumbai, where the monsoon session of the Maharashtra Legislature is going on currently.

Identified as one Subhash Bhanudas Deshmukh, the farmer doused himself with kerosene and set himself on fire near the Inox gate of the State Legislature building. He sustained 30 per cent burn wounds. He was rushed to GT Hospital, where he is being treated.

The incident triggered instant protests within the State Assembly. The NCP-led Opposition staged a noisy walk out from the State Assembly to register its protest against measly financial assistance extended to heavy rain-affected farmers.

Senior Congress leader and state party Nana Patole came down heavily on the Shinde-led Sena faction- BJP



become an "insensitive" dispensation. "The farmer suicides have increased in the state because of insensitive manner in which is dealing with issues of farmers. The state government should give the farmer concerned adequate compensation," Patole said. On his part, chief minister Eknath Shinde had earlier announced that the state government has doubled the sum of compensation mentioned in

the National Disaster Relief

Force (NDRF) norms.

Shinde said that the state government would also extend assistance to farmers in places that had recorded less than 65 mm rains in 24 hours, but witnessed 33 per cent loss of actual sown soil. The people whose houses have been damaged during the rains, would a get Rs 15,000 as one-time assistance, the chief minister added.

Deputy chief minister Devendra Fadnavis said that the suicide attempt by the farmer was "unfortunate" and that the state government was monitoring the situation. He

said that the farmer concerned had attempted to commit suicide after a feud with his brother over a land dispute.

"Prima facie, the farmer suffered 15 to 20 per cent burn injuries. The incident is unfortunate and the government is monitoring the situation," Fadnavis said.

A senior police officer said: "Security personnel on duty rushed to the farmer who had set himself on fire. He doused the flames and rushed the farmer to the GT Hospital. He is conscious.

### Yemen jobs: Indian workers seek release of passports

Seeking release of their pass-ports, some Indians who were working in Yemen for the past several years on Tuesday told the Delhi High Court that their passports have been seized by the authorities due to a notification that travels to Yemen would seriously impair the conduct of foreign affairs of the Central government.

Meanwhile, the counsel for the Central government submitted that they are awaiting instructions from the department, a Bench of Chief Justice Satish Chandra Sharma and Justice Subramonium Prasad listed the matter for further hearing on September 1.

The petitioners said they belong to a financially backward category, and their social conditions compelled them to find some jobs in a country like Yemen which is vulnerable from a security point of view.

They said they are ready to swear an affidavit stating that he/she will not travel to Yemen until the Government of India lifts the travel ban.



The 23 petitioners, through advocate Subhash Chandran K R, sought to set aside a September 26, 2019 gazette notification of the Central Government on the ground that it was ultra-vires to the Constitution and as an alternative prayer, they sought the release of their passports.

As per the gazette notification, the passport or travel document issued by the Central Government is invalid for the travel of the holder to Yemen as it would seriously impair the conduct of foreign affairs of the Government of

It further states that any Indian national who travels to Yemen in violation of this notification, shall be liable for action under Section 12 of the Passports Act, 1967 and the passport shall be liable for impounding or revocation.

# Two killed, another injured as assailants open fire in Mundka

Two men were killed and another sustained injuries after two unidentified bike borne assailants opened fire on them in west Delĥi's Mundka area. The incident took place on Monday. The deceased have been

identified as Mangal (60) and Joginder (42) while the injured has been identified as Mohan Lal (62), all three residents of JJ Colony, Bakkarwala. According to Sameer arma, the Deputy

Sharma, Commissioner of Police (DCP), Outer district, teams from the crime and forensic science laboratory have inspected the spot of the incident and found six empty cartridges and three live car-



"A helmet belonging to one of the assailants was also found on a slab at the entry point of the street. The CCTV footage was analysed and two men in the age group of 25 to 28 years were seen coming from Bakkarwala village at 9.05 pm and after a few minutes, were seen running back," said the DCP.

"One of them was wearing a black cap and another had tied a muffler on his head, the DCP said. According to Lal, he along with Mangal had gone to Joginder's house where one more person was also present,

Around 9 pm, two men came there and asked about the residence of Satish -- Joginder's deceased father

As Joginder pointed towards the photo of his father, the assailants opened fire. Joginder and Mangal fell down while Lal ran inside the house, they said. A case under sections 302 (murder), 307 (attempt to murder) and 34 (common intention) and Arms Act has been registered at Mundka police station. Section 120B (punishment of criminal conspiracy) was also added in the case, police said.

Joginder was from the Sansi community and involved in three cases of the Excise Act, while his wife was involved in two cases of the Excise Act, police said. Mangal had a tent business and Lal is an e-rick-

#### 32-yr-old man arrested for 'cyber stalking' woman

Delhi Police has arrested a 32 year-old 'cyber stalker', who had allegedly created a Facebook profile of a woman by using her images along with obscene descriptions to harass her. The accused has been identified as Mahaveer Singh, a resident of Mahaveer Enclave. Two mobile phones used in the commission of crime were also seized, police said.

According to M Harshardhan, the Deputy Vardhan, Commissioner of Police (DCP), Dwarka district, the matter was reported by a woman who alleged that some unknown person had created two fake Facebook profiles of hers and had been posting her photos with "obscene" descrip-

"She also alleged that she has been receiving various sex-ually charged messages and pornographic photos by ran-dom people. Following the complaint, details of the fake Facebook accounts and virtual numbers were obtained and analysed, said the DCP.

On the basis of this investigation, one Mahaveer Singh was identified as a suspect and his house in Mahaveer Enclave in Delhi was raided by a team," said the DCP. "During interrogation, he

disclosed that his brother Manwar Singh used to live on the first floor of the victim's house on rent eight-nine years ago and he knew her since then," said the DCP.

"He liked her and searched her Facebook Id and messaged her, but she did not reply. He then created fake Facebook Ids using her photos and uploaded them," he said.

The accused is a vendor and used to sell plastic items in streets. He is physically handicapped, the DCP said.

RPC, AIIMS, and others, in well planned conspiracy, generated 'Proceeds of Crime' by committing cheating/fraud with RPC, AIIMS, New Delhi, the ED said in a statement.

"Investigations so far disclose that during the period of December 2020 to September 2021, Rs 13.43 crore have been embezzled and laundered and Proceeds of Crime was generated," it said.

The agency said Bijender Kumar was working as Junior Administrative Assistant, in RPC, AIIMS and he with the assistance of Program Assistant (Contractual) to Dr Atul Kumar, the then Chief of RPC, AIIMS, raised fake indents and created fake supply order in favour of Sneh Enterprises. Further, he created fake delivery challans including inspection note and got an amount of Rs 13.43 crore released to Sneh Enterprises, in lieu of illegal gratification, without delivery of any goods, which he invested in purchase

of two immovable properties at

Delhi for Rs 70 lakh. The proprietor of Sneh Enterprises, Sneh Rani, further transferred the amounts fraudulently received from AIIMS to her other bank accounts and made further payments to various parties. The aggregator will have to seek passengers only through web or mobile-based application, and



# 'Govt not taking decisions | Nations should respect others' sovereignty: India

China and Pakistan adopting double standards in fighting terrorism: India's Permanent Representative to UN

India has chided China and Pakistan for adopting "double standards" in fighting terrorism and emphasised that any "coercive or unilateral" action that seeks to change the status quo by force is an affront to the principle of common security.

Making this point, India's Permanent Representative to the United Nations (UN) Ruchira Kamboj also said all countries should respect each other's sovereignty and territorial integrity and respect international agreements. These remarks came in the backdrop of continuing standoffs at the border in eastern Ladakh for the last two years

between the armies of China and India. Also, China recently blocked a move initiated by Índia and US to impose UN sanctions on Abdul Rauf Azhar, the brother of Pakistan-based Jaish-e-Mohammed (JeM) chief Masood Azhar. Beijing has said it needs more time to assess the application to list Azhar as a global terrorist.

The Indian representative

enunciated the country's position while while addressing a United Nations Security Council (UNSC) meeting on the topic 'Promote Common Security Through Dialogue and Cooperation' on Monday. However, she refrained from naming China and Pakistan.

The UNSC meeting was convened at the behest of China, the presidentof the Security Council for August and a veto-wielding member of the 15-member Council.

In her remarks, Kamboj noted that one of the guiding questions posed by the Presidency for the meeting is what constitutes "common security?" "Common security

is also only feasible when all countries stand together against common threats such as terrorism and do not engage in double standards while preaching otherwise," Kamboj said in an apparent jibe towards China and its close ally, Pakistan. China has repeatedly blocked the attempts of India and the US at the UN to blacklist Pakistan-based terrorists.

Kamboj also took a veiled swipe at Beijing over its aggressive behaviour in the region. "Any coercive or unilateral action that seeks to change the status quo by force is an affront to common security.

Further, common security is only possible when countries respect each others' sovereignty and territorial integrity, as they would expect their own sovereignty to be respected,"

"Common security is also possible only if countries respect agreements signed with others, bilateral or multilateral, and do not take unilateral measures to nullify those very arrangements to those they

### SC holds Section 3(2) of Benami Transactions Act unconstitutional

The Supreme Court on Tuesday struck down one of the provisions of the Benami Transactions (Prohibition) Act of 1988, which provides for the punishment of a maximum jail term of three years or a fine or both for those indulging in 'benami' transactions. The apex court termed the provision "unconstitutional" on the ground of being "manifestly

"We hold section 3(2) of the Benami Transactions (Prohibition) Act, 1988 as unconstitutional," a Bench comprising Chief Justice NV Ramana and Justices C T Ravikumar and Hima Kohli said.

Section 3 of the statute deals with the issue of "Prohibition of benami transactions" and its impugned subsection (2) says: "Whoever enters into any benami transaction shall be punishable with imprisonment for a term which may extend to three years or with fine or with both.

The verdict came on the appeal of the Centre challeng-ing the Calcutta High Court judgement in which it was held that the amendment made in the 1988 Act in 2016 would

The ED initiated money laundering investigation on

the basis of an FIR dated through their individual pro-February 26, 2020 registered by CBI against SBBEL, its Directors Amar Chand Gupta and others as also other unknown public servants/persons on the allegations that directors of SBBEL conspired to misappropriate bank funds.

They were booked by the CBI for misappropriation of bank funds, criminal breach of trust, manipulation of books of accounts through fictitious entities and sister concerns of SBBEL and have routed funds through shell entities and siphoned off the funds from company's accounts for their personal gains causing loss to the tune of Rs 605 crore to the public sector banks during 2010 to 2017.

Investigation revealed that the bank funds sanctioned to SBBEL were transferred to personal bank accounts of directors of the firm by routing

#### Kids at increased risk of tomato flu: Lancet PIONEER NEWS SERVICE

With cases of tomato flu pouring from the States since the last few months, the Union Health Ministry on Tuesday released guidelines on testing, prevention and treatment of Hand, Foot, Mouth Disease, also known as tomato flu saying more than 82 chil-

tion by late July.
The guideline comes amid the warning by a recent study published in The Lancet Respiratory Medicine journal that says that young children are at increased risk of exposure to the disease, and if not controlled and prevented, the trans-

mission might lead to serious consequences by spreading in adults as well. The other flu affected areas of Kerala are Anchal, Aryankavu, and Neduvathur, said the Centre adding that the endemic viral illness triggered an alert to the neighboring states of Tamil Nadu and Karnataka.

Additionally, 26 children (aged 1-9 years) have been reported as having the disease dren under 5 in Kollam, Kerala in Odisha by the Regional Medical Research Centre in had been found with the infec-Bhubaneswar. "To date, apart from Kerala, Tamil Nadu, Haryana and Odisha, no other regions in India have reported the disease in their state/UT by the virus," said the ministry in the guidelines issued to all the States. The government said

that tomato flu may be a variant of the common HFMD that is common in school going children.It has also insisted that the virus is not at all related to SARS-CoV-2, monkeypox, dengue or chikungunya, adding that recent reports have sug-gested it to be Coxsackie A 17 that belongs to the group of enteroviruses. "The disease will best be

described as a clinical variant of viral hand, foot, and mouth disease, a common infectious disease targeting mostly young children aged 1-10 years and immunocompromised adults, and sometimes exposed immune competent adults," said the Centre. It added that the disease is a self-limiting illness and no specific drug exists

to treat it. In the guidelines, the government said that tomato flu is a viral disease and name 'Tomato Flu" comes from main symptom of this disease, the tomato-shaped blisters on several body parts.

Primary observed in children with tomato flu are similar to those of other viral infections, which include fever, rashes and pain in ioints and rashes on skin can also lead to skin irritation.

As with other viral infections, symptoms also include fatigue, nausea, vomiting, diarrhea, fever, dehydration, swelling of joints, body aches, and common influenza-like symptoms. HFMD is characterized by fever, sores in mouth, and a skin rash, as per norms.

# J&K admin focusing on developing 7 industrial estates in Jammu division

In order to cope up with the growing demand of Industrial land, the Union Territory administration in Jammu & Kashmir is focusing on developing 7 new industrial estates in the districts of Jammu division.

The main focus is on the promotion and Development of Industries to encourage new investments in Jammu Division and sustain existing ones.

At present there are 24 industrial estates in Jammu division, 19 managed by J&K Small Scale Industries Development Corporation Limited (SICOP) and 5 by Jammu & Kashmir State Industrial Development Corporation (SIDCO).

# Mondal case judge threatened with narcotic case slap

In a development reminiscent of the naxalite era of the 1970s, the special judge of the CBI court hearing Trinamool Congress strongman and party national executive member Anubrata Mondal's case has received a mail that threatens to implicate him and his family members in false narcotic cases should he not release Mondal on bail.

The leader who besides being close to Chief Minister Mamata Banerjee is also the TMC's Birbhum district president with additional charges of vast electoral units of areas of neighbouring Burdwan and Murshidabad. The TMC strongman was arrested early this month in connection with cow smuggling cases.

The letter allegedly written by one Bappa Chatterjee asks judge Rajesh Chakrabarty to release Mondal on bail failing which he would be implicated in "Ganja" (narcotic) cases, court officials quoting the Asansol judge said adding he had written a complaint to Registrar General of the Calcutta High Court drawing his attention in the matter.

Curiously Chatterjee has denied that the letter is his. "The letter is fake and the signature is false ... this is not my signature," said Chatterjee demand-

ing thorough investigation into the matter. Mondal, considered the uncrowned king of Birbhum and the neighbouring areas is known for his infamous "ganja case" threats to his opponents. Often he was seen asking police officials to frame his oppo-

nents in ganja cases.

Meanwhile in a related incident the police on Tuesday recovered 22 cows from inside a milk van in Purulia after the vehicle overturned on National Highway 60. The vehicle bearing an Úttar Pradesh Number had loaded 22 cows from Dganbad and skidded into a roadside ditch. As the locals opened its doors they discovered the vehicle stuffed with cows apparently being carried to border areas of Bengal for smuggling, sources. said.

The authorities intercepted another vehicle, this one a parcel van with two number plates one on the front side and another in its rear.

Demanding a thorough investigation into the case Bengal Opposition Leader Suvendu Adhikari said "after the arrest of kingpin Enamul Haq and Anubrata Mondal the cow smugglers of TMC have changed their method of smuggling ... they are discovering newer ways everyday ... this one was the newest when the animals were being smuggled in

# 7 accused in Birbhum murder case arrested

The arrested accused persons are Bikir Ali, Noor Ali, Sher Ali alias Kalo, Asif SK, Joshif Hossain, Jamirul SK alais

The CBI had registered this instant case on March 25 this year against 22 accused and others in compliance with the orders of the Calcutta High

It was alleged that at about 8.30 PM on March 21, 2022, Bhadu Shekh of Bogtui, Upa Pradhan (Deputy Pradhan) of Barshal GP was murdered by inflicting bomb injuries, at Bogtui Morh on NH-60, it said. After the incident, seri-Bogtui Morh on NH-60 and surrounding areas over the issue of the said murder. It was further alleged that the followers and associates of slain Bhadu Shekh, ransacked the houses of rival groups at village

Bogtui and set them on fire with a view to kill the persons inside and their family inmates. Seven persons were

charred to death and four other persons sustained severe burn injuries. Identities of the deceased persons could not be established. Later on, out of four injured victims, three died subsequently. The State police arrested 21 accused/suspected After taking over the inves-

tigation, a large team of CBI immediately Rampurhat. Vital physical and biological evidence were collected by the CFSL team.

The bodies recovered were completely charred beyond recognition. The biological

Few years back, Ram Gopal molested her sister too and on being confronted, he attacked her with an axe. The accused threatened the family with dire consequences if they informed police. The family informed the

police but no action was taken.

On Monday evening, Ram Gopal molested the girl again and later escaped. The girl narrated her ordeal to her sisters. Finally, all the four, along with their cousin, waited for Ram Gopal and as they saw him coming back and attacked him with sticks and rods, leaving him dead. SP (Rural) Dr Akhilesh Narayan Singh said the four sisters had been taken

into custody.

# **Limits of polarisation**

BJP MLA in Telangana allegedly blasphemes against Prophet Muhammad; arrested; suspended by BJP

elangana Bharatiya Janata Party MLA T Raja Singh's arrest in Hyderabad, following the allegedly derogatory comments about Prophet Muhammad, will trigger another round of political statements, allegations, counter-allegations, and protests. This is widely seen as the BJP's desperate bid to grow in the southern state. In general, the saffron party's presence in South India is limited, Karnataka being the only state where it holds office. The other four states—Telangana, Andhra Pradesh, Tamil Nadu, and Kerala—remain steadfastly distant from Hindutva. On its part, the BJP has peaked in northern and western states; for instance, it won 71 out of 80 seats in Uttar Pradesh and all 26 in Gujarat in the 2019 general elections. Bihar will be tough in 2024, and there will be challenges in other states too where the BJP is a dominant party; but, on the whole, there is not much that it has to do in northern and western states. In eastern states, the BJP has already made its presence felt,



and will like to maintain the momentum. In the south, however, the party has not been able to find any momentum. It was 14 years earlier, in 2008, that the BJP had formed its government in Karnataka. Against this backdrop, the saffron party's keenness to enter Telangana can scarcely be over-emphasised. Raja Singh's Prophet Muhammad remarks may be an expression of that keenness-or maybe impatience is the right word to describe the feeling.

After Raja Singh's, however, the BJP seemed to have realized its MLA has bitten more than what could be chewed, so it suspended him. It has served him a show-cause notice; he is supposed to reply in 10

days. This seems to be the replay of the Nupur Sharma episode; she was also suspended but hasn't been arrested, perhaps because she is not in a non-BJP state. All this is quite baffling. What is the BJP up to? It does not promote leaders like Sharma and Raja Singh because it has an abiding faith in free speech; it doesn't believe much in freedom of expression; when it comes to the Hindus' sensitivities, the saffron party bristles aggressively at the slightest provocation—even non-provocation. This makes it different from Rightwing parties in the United States and Europe. They fight against the radical Left's attempts to curb freedom of expression, but then they don't campaign for bans on the works of Leftists; neither do they indulge in violent activities at the books, movies, etc., which traduce Christianity, their country, the Western civilisation, etc. At the same time, when things go out of control—as in the aftermath of Sharma's remarks, when a number of Arab and Muslim nations lodged their strong protests against her remarks—the BJP becomes defensive. It must realize that religious polarlisation may not be a very rewarding political strategy in South India where the memories of Islam are not as bitter as in North India. At any rate, the law of diminishing returns also applies to polarlisation.

### Sigh of relief for students

Indian students studying in china can now go back to complete their courses

hat china has resumed issuing visas to Indian students after two years must be a big relief for the Indian students studying there. Thousands of students had to abandon their studies as covid struck and they were made to leave the country. Since then their studies have been in limbo as China refused to take them back. In fact, 23,000 odd medical students studying in China are still waiting here to go back to their respective universities in China. They had staged several dharnas and even demanded the government of India to allow them to complete their studies in Indian universities but that did not happen as rules do not permit it. Now that China announced its plan to issue visas to Indian students stranded here since their return two years back when COVID was at its peak and strict restrictions were imposed by China on foreign students. Now that COVID has wained it is also allowing Indian travelers for



other purposes including business. China's relaxing of the travel rules would mean that X1-Visa, will be issued to students to not only the students already enrolled but also new students. After much deliberations and insistence of MEA China agreed to issue visas to Indian students studying in China on a caseby-case basis and sought the names of those wanting to return immediately to pursue their studies. The new students would have to show an original admission letter issued by a university. The old students however can s submit a 'Certificate of Returning to Campus'issued by the university in China. Over 1,000 old Indian students have expressed the wish to return to re-join their studies. Two further facilitate the trav-

el Indian and Chinese officials are preparing a plan to resume flight operations.

This may end the woes of Indian students studying in China but the career of those students who were studying in Ukraine still remains uncertain. They have been running from pillar to post to convince the government of India to let them complete their studies in Indian universities which rules do not permit. The government of India should come up with a comprehensive plan for Indian students studying in foreign countries if their studies are interrupted due to no fault of theirs such as a pandemic or war. Most of these students are from middle-class families whose families have spent their lives saving to get their children good education abroad. The rules must be changed to allow these students to complete their courses in such exigencies.


# Pakistan's perennial existential crisis



Pakistan is as unstable as it was at the time of its independence. Its political class is largely to blame for its present state

akistan at 75 is at its chaotic best. It is at war with itself, deeper into political and economic holes. Writing in The Dawn on 14 August 2022, Mahir Ali said: "prompt and drastic measures are necessary to save Pakistan from virtual bankruptcy but our rulers seem to be content with obtaining foreign gifts to feed people and relying on heavier doses of foreign aid for maintaining some semblance of economic development". This Ali quotation is taken from a Pakistan Times editorial of 14 August 1958. Pakistan's many worries could go Sri Lanka's way, an issue that has been debated in the last few months. For the first time, its Army Chief, Gen Qamar Bajwa had to send an SOS to US State Department and traditional donors Saudi Arabia and UAE. Where China figures in this firefighting is unclear but it recently indicated that Beijing's relations with Rawalpindi are a lynchpin of Pakistan-China ties. On his last visit to Islamabad Foreign Minister Wang Yi especially traveled to Rawalpindi to meet Gen Bajwa. Chinese military spokesperson noted: "China and Pakistan are all-weather strategic partners, true friends and iron brothers that share weal and woe". After 1998, Pakistan acquired nuclear weapons. No one wants a nuclear Somalia is a common refrain. Pakistan approached IMF in

May for the 18th time in its short history. The current account deficit has increased from USD600bn in 2017 to USD3500bn in 2021; the Pakistani rupee is at its lowest ever against the USD at Pakistan Rs 240 with imports severely restricted and oil prices shooting up. Saudi Arabia has transferred USD 4bn including the amount for oil financing and rolled over an existing debt of USD4bn. Equally worrying is political instability, one of the reasons for economic turmoil. The PML-Nled coalition under Shahbaz Sharif which unseated Imran Khan in April in a no-confidence motion is on a sticky wicket after its political stronghold to interfere with the Army's



early elections. 75 years on, civil-military relations have institutionalized the role of the Army as the ultimate custodian of internal and external challenges. In Pakistan, the Army and bureaucracy became the primary institution of governance due to a weak Muslim

Directly or indirectly, the military has ruled Pakistan with a democratic façade aided by the judiciary. Knans attemp Punjab fell to Imran Khan's PTI. internal affairs cost him his job.

#### **INDIA'S BIG LEAP OF FAITH** IN HEALTHCARE

India has made substantial gains on health indicators

ince Independence, India has helmed many nationwide programmes with the specific purpose of uplifting its public healthcare system. The world has watched admirably as the nation toiled to control the tropical, communicable diseases such as polio, malaria, tuberculosis, smallpox, etc.

India's response to the outbreak of the Coronavirus has been a mix of statewide measures and public cooperation. India, indeed, has come a long way from where she stood in 1947 in terms of healthcare.

One of the notable measures of these programmes has been the sizable decline in mortality or death rates. One of the primary measures taken by India after independence was to launch several nationwide public healthcare programmes aimed to eradicate the curse of communi-

In 1947, as per an American Journal of Tropical Medicine and Hygiene report, out of the 330 million population over 75 million were estimated to suffer from malaria. By early 1960s, these cases remarkably dwindled to approximately 100,000 and this progress has been steady.

In fact, the latest World Malaria Report 2021 by WHO takes note of the fact that of the world's 11 highest burden countries for malaria, India



is the sole one to catalogue progress. India's success stories against polio and smallpox are tales for the ages. Polio was hyper-endemic even in the early 1990s but by 2014 we declared ourselves poliofree with no new reported case since January 2011.

We are also running the National Leprosy Eradication Program and are making noteworthy advancement in fighting cholera, tuber-

In 2022, our infant mortality rate is 27.695 deaths per 1000 live births, a 3.74 per cent decline from 2021. As per the National Health Family Survey-5, it has dropped in almost all states, with Assam recording the sharpest drop from 48 deaths (per 1,000 live births) to 32. India has also adopted the global maternal mortality ratio target of less than 70 deaths/100000 live births by 2030. In March 2022, the Registrar General of India declared that this rate had declined by another 10 points. Compared to the maternal mortality ratio at 2000/100,000 live births, which dropped to 1000 in the 1950s, we have really come far. Besides, India has enhanced the life expectancy of its citizens. In 1947, the average lifespan of an Indian citizen was about 32 years and today it stands at 70.19 years, a jump of over 100 per cent. It's also comparable to the UN-World Population Perspective that holds the average global life expectancy at

Since independence, we have seen the launch of innumerable relevant policies and schemes to improve public healthcare. Be it the National Health Mission and National Rural Health Mission that aim at improving mother and child health, or the Janani Suraksha Yojana that empowers pregnant mothers with necessary cash transfers and Janani Shishu Suraksha Karyakram that facilitates pregnant mothers to deliver in government hospitals at zero charge, almost all of these schemes have targeted India's healthcare pain points. The government has forever launched meaningful schemes such as Pradhan Mantri Swasthya Suraksha Yojana, Ayushman Bharat Pradhan Mantri Jan Arogya Yojana, and Pradhan Mantri Surakshit Matrutva Abhiyan to enhance the accessibility and availability of public healthcare facilities throughout the nation. Life expectancy is a key indicator of human development and healthcare facilities of a nation. And India has braved all kinds of challenges and leveraged better availability of cutting-edge technology, medicines and therapies to augment this indicator by over 100 per cent since independence.

# POCSO enforcement must for kids' safety

'Protection of Children from Sexual Offences Act, 2012,' came into being after detailed, prolonged deliberations

arents are often hesitant to file complaints when incidents of child sexual abuse occur. If the police do not extend cooperation, the possibilities of registering the complaint fade away further. Hence, the decision to withdraw the circular that mandated the Assistant Commissioner's permission to register a complaint is apt.

"Last November, we were visiting Ambejogai. It came to our notice that a minor girl had been sexually violated multiple times. The 13-year-old was pregnant for four months. At 10 am, we went to the police station to file a complaint. Not only did we face multiple obstacles, we had to also undertake several follow-ups. It was only at 10 in the night that the police finally registered a case under POCSO," said Tatvasheel Kamble, an active member of the Beed District Child Welfare Committee and

"It was morning by the time we got a copy of the FIR. I wonder, in my absence, would they have even registered the case? What would have happened to this young girl; I can't even begin to imagine it," Kamble added. Twenty four persons have been indicted in this case. Hearings are still going on, while a shelter home has accepted responsibility for the girl.

Even in the presence of a person, who's an active member of a system that claims to protect children from sexual violence, the registration of the crime took its own sweet time. Across districts, most activists share similar experiences.

On June 6, Mumbai's Police Commissioner, Sanjay Pandey had issued a circular, stating that it was mandatory to take permission from the Assistant Police Commissioner before filing a case under Protection of Children from Sexual Offences Act (POCSO). This circular was widely debated. Organisations working for children and women's rights were severely opposed to this order. In response, Pandey issued a revised circular on the 18th of June, that stated that if the complaint raised under POCSO doesn't seem suspicious or if a noteworthy offence seems to have occurred in the received complaint, the case needs to be immediately registered.

Pandey's revised circular comes with a context: often, cases are registered under POCSO or about molestation, which stem either from old feuds or animosities amongst complainants. Most often, eventually, the accused are acquitted. However, several years pass by before the case is solved. In the meantime, the accused face vilification. To avoid this complexity, the process mandated that the police first investigate the complaint and then a final order from the Assistant Commissioner would be a go-ahead for registering the complaint.

The police department claimed that the process aimed at preventing the misuse of POCSO. However, legal and social sectors vehemently opposed this order, expressing

their concern that the process of registering offences against children would become even more cumbersome and slow. And it is a fact. The Central Commission for Protection of Child Rights raised an objection against this circular and asked for its withdrawal. A public interest litigation was filed in the Bombay High Court. On the 11th of June, Sanjay Pandey tweeted about a possible reconsideration of this circular, and finally

on the 18th of June, a revised cir-

cular was issued. In almost 80 per cent of cases of sexual offences against children, the perpetrator is known to the child, revealed a report by the National Crime Records Bureau in 2013-15. Victims and their parents are confused, scared and distressed. They fear defamation. Cases are rarely registered, because of the system's procrastination or dissuasion. Unless they get appropriate and immediate help, parents most often withdraw their complaints. If the accused hold socially dominant positions or share close ties with powerful and affluent people, there's a significant possibility that they may pressurize the legal system.

The Supreme Court's judgment in the Lalita Kumari vs Govt. of UP & Others on November 12, 2013, proves pivotal in understanding the legal system's expected response. The case was about the abduction of a minor girl called Lalita Kumari in 2013. The judgment states that in cases, which are cognizable, once the

police receive a complaint, it is imperative that, without any delay, they register it and hand over a copy of the FIR to the complainant. In these cases, the police cannot delay in using their logical discretion for guiding the aggrieved complainant. There is no scope for slacking, because refusal to register complaints reduces public trust in the udiciary. This negatively affects the egal system.

The complaint filed by Lalita Kumari's father was not registered by the local police station. The family had to visit senior officials several times. If the case consists of a cognisable offence under CRPC 154, the police need to take immediate cognisance of it.

Here, filing an FIR after a preliminary investigation is unacceptable, as stated by the Supreme Court. Hence, activists say, the Mumbai Police Commissioner's circular dated 6th of June, 2022 proves to be an obstacle in conducting the due process under the POCSO Act.

Essentially, the Protection of Children from Sexual Offences Act, 2012, came into being after detailed and prolonged deliberation. In Indian society, where it is still impossible to speak about sexuality, it is even more gruelling to speak about sexual violence. Whenever an incident occurs at home, most families choose to operate in stringent silence around it. Hence, most incidents are quietly swept under the

POCSO specifically comes up

with provisions that aim to break this silence and address this violence. POCSO was first implemented in 2012. Clause 14 of this Act states that it is not mandatory for the child to visit the police station to file a complaint. In fact, police officers are supposed to visit the victim's house for statements, that too in civil clothes. It would be interesting to study to what extent

this clause has been implemented. The judiciary and the police systems are facing an acute shortage of human resources. Hence, the stack of delayed cases is only piling taller. It is important that the government and administration focus on reduc-

In highlighting the scope of the judicial process under POCSO, a provision under the Act states in the context of the hearings of POCSO cases, courts cannot use their discretion, nor special power granted to them. The Court is not entitled to reduce the years of conviction stipulated under the law either.

POCSO, Prevention of Child Labour Act, Right to Education Act, Prevention of Child Marriage Act are all pivotal to ensure children's rights are realized. During and after COVID-19, crimes against children have only increased. For example, in Maharashtra the percentage of child marriages has increased to 21.1 per cent. Maharashtra comes right after Bihar, Uttar Pradesh, Rajasthan and West

Bengal; this is worrying.

# Aurobindo's task of awakening spiritual India (II)

#### Sri Aurobindo felt that the main reason for the misery of man was his spiritual unconsciousness

fter coming out of the jail, Aurobindo gave a speech in a spiritual conference in Utarpada near Kolkata, now famously referred to as the Utarpada speech in which he clearly explained experiences and insights gained during his

stay in the jail He said, "Going to the jail and coming out of it were both a part of an existential plan. The purpose of jail life was to detach me from my strong attachment towards politics." His speech also related the vision he had of Lord Krishna in which Krishna had said, "India's main problem isn't political; it's spiritual. The prevailing foreign interference is simply a consequence of the spiritual cowardliness and lack of spiritual fervour. You'll have to revive and re-establish the authentic spiritual values of

Hindu wisdom in the world." It was his prison experience that propelled Aurobindo to take the bold decision to abandon politics in order to contin-

ue his spiritual journey. The chief disciple of Swami Vivekananda, Bhagini Nivedita, had become Aurobindo's political and spiritual assistant. She told him that the British were planning to re-arrest him and advised him to leave British India. It was Swami Vivekananda's love for Aurobindo that manifested in Nivedita's words. He got similar guidance from his inner self as well. Immediately, he left Bengal for the French colony of Pondicherry in South India via Chandranagar and arrived there

on April 4, 1910. In ancient times, the mystic

had also made Pondicherry his last destination. It was from there that he had propounded Vedic culture in South India. In Ramayana, there is a beautiful description of how Ram had met Agastya Muni.

In its initial days, the Ashram was very poor and Aurobindo lived there with three other seekers. There was only one lamp there under which all the activities were carried out once it got dark.

In 1912, Aurobindo wrote a very poignant letter to his friend, Motilal Roy, which depicted the state of poverty in the Ashram. The letter read, "There is only half a rupee left, while sixseven people are here. Immediately, send us 50 rupees."

In 1914, French couple Paul and Mirra Richards arrived in Agastya Muni of North India Pondicherry. Later the same



Mirra Richards became known as the Mother. As soon as she saw Aurobindo, she realised that he was the same Yogi that

she had been seeing in her visions throughout her life. Every Sunday, the Richards invited Aurobindo and his disciples for dinner. That was the only time in the week they would get to eat a full sumptuous meal and drink fine French wine. such eating habits. Don't evalu-

Despite his high yogic state of consciousness, and unlike ate a yogi through his habits.

most Indian yogis, Aurobindo used to eat non-vegetarian food and drink alcohol. As he came from a Bengali family and grew up in the West, this was a normal practice for him. Ramakrishna and Vivekananda also came from Bengali families and used to eat fish regularly as a part of their diet.

Even today, fish is accepted as a part of the daily meal in Ramakrishna Ashram. A devo-

tee of the South Indian enlightened master, Raman Maharshi, contemporary of Sri Aurobindo, had complained to him about Aurobindo's consumption of meat and wine. Raman had instead praised Aurobindo, "He was born in a Bengali family and grew up in the West, that's why he has

Aurobindo is in a very high state of yoga."

Later, Aurobindo, seeing that non-vegetarian food and alcohol was hindering his spiritual practice, quit both and turned vegetarian. Today all the Aurobindo Ashrams are fully vegetarian.

In 1920, the Mother divorced her husband and started to live permanently in the Ashram and took the full responsibility of running it. After this, Aurobindo confined himself in his room, while 24 November is celebrated as the siddhidiwas of Sri Aurobindo. It was on this day of 1926 that the supramind consciousness descended on him.

Aurobindo left his body on December 5th, 1950. He was buried four days later in the Ashram compound.

Aurobindo had refused the post of the president of the Indian National Congress in 1907 and later refused to become the first President of Independent India. Aurobindo felt that the main reason for the misery of man was his spiritual unconsciousness and made efforts throughout his life to uplift human consciousness and to make arrangements to descend the supramind consciousness to the earth In the last 24 years of his life,

Aurobindo came out of his room to give darshan to his disciples only four times a year. The time he spent alone in his room is steeped in mystery. He says, "Meditation is for those who can come out of the society and the world, and travel the lonely journey towards the unknown. (Concluded)

# Six months on, Ukraine fights war, faces painful aftermath

anyk Rak enjoys riding his bike, playing soccer and quiet moments with the family's short-legged dog and two white cats, Pushuna and Lizun.

But at age 12, his childhood has been abruptly cut short. His family's home was destroyed and his mother seriously wounded as Russian forces bombarded Kyiv's suburbs and surrounding towns in a failed effort to seize the capital.

Six months after Russia launched its invasion of Ukraine, and with no end to the conflict in sight, The Associated Press revisited Danyk as well as a police officer and an Orthodox priest whose lives have been upended by war.
"I want to be an Air Force

pilot'

Tears come to Danyk's eyes as his mother, Luda, recalls being pulled from the rubble, covered in blood, after shrapnel tore through her body and smashed her right foot.

Twenty-two weeks after she was wounded, she's still waiting to have her foot amputated and to be fitted with a prosthetic. She keeps the piece of shrapnel surgeons removed during one of her many operations.

Danyk lives with his mother and grandmother in a house near Chernihiv, a town 140 kilometers (nearly 90 miles) north of Kyiv, where a piece of tarp covers the broken bedroom windows. He sells milk from the family's cow that grazes in the nearby fields. A handwritten sign wrapped in clear plastic on the front gate reads: "Please buy milk to help my mother who is injured."



"My mother needs surgery and that's why I have to help her. I have to help my grand-mother too because she has heart problems," Danyk said.

Before schools reopen on September 1, Danyk and his grandmother have been joining volunteers several days a week clearing the debris from buildings damaged and destroyed in the Russian bombardment outside Chernihiv. On the way, he stops at his old house, most of it smashed to the foundations.

"This was my bedroom," he says, standing next to scorched mattress springs that protrude from the rubble of bricks and

Polite and soft spoken, Danyk says his father and stepfather are both fighting in the

'My father is a soldier, my uncles are soldiers and my grandfather was a soldier, too.

Huseinov was there for 16 days, organizing crossings where the elderly were carried along muddy pathways in wheelbarrows.

Reconstruction work has begun on the bridge, where mangled concrete and iron bars hang over the river. Clothing and shoes from those who fled can still be seen tangled in the debris.

"This bridge was the road from hell," says Huseinov, 34, standing next to an overturned white van still lodged into a slab of smashed concrete.

"We got people out of (Irpin) because conditions were terrible - with bombing and shelling," he said. "People were really scared because many lost their children, members of their family, their brothers and sisters." Crosses made from construction wood are still nailed to the railings of the bridge to honor those lost and the effort to save civilians. "The whole world wit-

nessed our solidarity," says Huseinov, who grew up in Germany and says he would never again take the good things in life for granted. "In my mind, everything has changed: My values in life," he said. "Now I understand what we have to lose." "Before the war, it was another life" The floor of the Church of Andrew the Apostle has been re-tiled and bullet holes in the walls plastered over and repainted but the horror of what happened in March lies only a few yards away. The largest mass grave in Bucha — a town outside Kyiv that has become synonymous with the brutality of

the Russian attack — is behind

people, including 30 women, and two children," said Father Andriy, who has conducted multiple burial services for civilians found shot dead or killed by shelling, some still only identified as a number while the effort to name all of Bucha's victims continues.

Many of the bodies were found before the Russians pulled out of the Kyiv region, Father Andriy said.

'We couldn't bury people in the cemetery because it's on the outskirts of the city. They left people, dead people, lying in the street. Dead people were found still in their cars. They were trying to leave but the Russians shelled them," said Father Andriy, wearing a large cross around his neck and a dark purple cassock.

That situation lasted two weeks, and the local authorities began coming up with solutions (to help) relatives and loved ones. It was bad weather and wild animals were discovering the bodies. So something had to be done." He decided to carry out burial services in the church yard, many next to where the bodies had been discovered. The experience, he said, has left people in the town badly shaken.

"I think that, neither myself or anyone who lives in Ukraine, who witnessed the war, can understand why this happened," he said.

"Before the war, it was another life."

"For now we are surviving on adrenaline," he said. "But I'm worried that the aftermath will last decades. It will be hard to get past this and turn the page. Saying the word forgive isn't difficult. But to say it from your heart — for now, that's not

# Russian attack fear grips Ukrainians on national day eve



On the eve of Ukraine's independence day and the half-year mark of Russia's invasion of its neighbour, there was increasing unease in the country on Tuesday that Moscow could be centering on specific government and civilian targets during the holiday.

The United States reinforced those concerns

when its embassy in Kyiv issued a security alert, saying it "has information that Russia is stepping up efforts to launch strikes against Ukraine's civilian infrastructure and government facilities in the coming days."

Over the weekend, Ukrainian President Volodymyr Zelenskyy already sensed a threat coming when he said in his daily address that "we should be aware that this week Russia may try to do something particularly nasty, something particularly cruel."

The warnings come on the heels of Russia's claim that Ukrainian intelligence was responsible for the car bombing that killed the daughthinker over the weekend.

That didn't prevent shelling close to Zaporizhzhia early Tuesday. Amid the death and destruction, there was one small point of light. All professional soccer was stopped in February, but a new league season starts on Tuesday in Kyiv. The Olympic Stadium will see the the opening-day meeting of Shakhtar Donetsk and Metalist 1925 from Kharkiv — teams from eastern cities that are fighting for their very existence.

No fans will be allowed in the 65,000-capacity downtown stadium for the kickoff at 1 pm local time, and the players must be rushed to bomb shelters if air-raid sirens sound

# Lanka to replace draconian counter-terrorism law

# With new national security Act

ri Lanka on Tuesday announced that it will soon replace the controversial Prevention of Terrorism Act (PTA) with a new security law, amid international condemnation over Colombo's use of the draconian counter-terrorism law to detain student activists

"PTA has been there since 1979. The justice minister informed the cabinet that a new National Security Act would be drafted by deleting the undesirable parts of the PTA. Cabinet spokesman and minister Bandula Gunawardena told reporters.

The development comes a day after the US and the European Union on Monday expressed concern over the detention of three student activists under its draconian counter-terrorism law for participating in protests, which led to the resignation of former president Gotabaya Rajapaksa.

Using laws that don't conform with international human rights standards - like the PTA - erodes democracy in Sri Lanka. We encourage the government to uphold the rights of the people to express their views," US Ambassador to Sri Lanka Julie Chung tweeted.

The European Union also voiced its concern.

"Concerned about reports on the use of the PTA in recent arrests as we refer to information given by the (Sri Lankan) government to the international community about the de-facto moratorium of the use of PTA, an EU statement said.

Sri Lanka's top human rights body has urged President Ranil Wickremesinghe to provide adequate protection to the family of his predecessor Gotabaya Rajapaksa as guaranteed by the Constitution and facilitate the former president's return to the crisis-hit country.

In a letter, the Human Rights Commission of Sri Lanka (HRCSL) on Monday said that it had received several complaints alleging that the former president had tendered his resignation under threat and coercion and the government had failed to provide adequate security to him during this period.

"And now, the ex-president and his family intend to return to the country. The complaint is based on the premise that the expresident and family cannot return to the country due to the prevailing threats they face and that it violates fundamental rights guaranteed under the Constitution for every citizen,"

The HRCSL also cited Article 14 (1) (i) of the constitution, which claims that "every citizen is entitled to the freedom to return to Sri Lanka."

"It is alleged in the complaint that Gotabaya Rajapaksa and his family, who are citizens of this country, are unable to return to the country due to prevailing threats to their lives," the rights body said.

"It is recommended that the Government of Sri Lanka takes all necessary steps to assess the threat situation and provide country, but he must be tried for allegations of misuse of funds since he does not enjoy legal immunity.

The Sri Lanka's Constitution allows privileges to former presidents, including personal security and an office with staff.

Malaysian ex-Prime Minister Najib Razak lost his final appeal on Tuesday in a graft case linked to the looting of the 1MDB state fund, with the top court unanimously upholding his conviction and 12-year prison sentence.

The loss means Najib will have to begin serving his sentence immediately, becoming the first former prime minister to be jailed.

The five-member Federal Court panel said it found the High Court judge was right in his judgment and that Najib's appeal was "devoid of any mer-

"This is a simple and straightforward case of abuse of

power, criminal breach of trust

and money laundering," said Chief Justice Maimun Tuan Mat, who read out the verdict.

"We are unable to conclude that any of the findings of the High Court, as affirmed by the Court of Appeal, were perverse or plainly wrong so as to warrant appellate intervention. We agree that the defense is so inherently inconsistent and incredible that it does not raise a reasonable doubt on the prosecution case," she said.

However, late recovery in banking, metal and auto shares helped the indices recover from the lows and snap the two-day losing streak.

From the Sensex pack, Mahindra & Mahindra rose the most by 3.78 per cent. Bajaj Finserv rose by 2.75 per cent, Titan by 2.6 per cent, Tata Steel by 2.38 per cent, State Bank of India by 2.12 per cent. Kotak Mahindra Bank, Sun Pharma and IndusInd Bank also

### India's crude oil production falls **3.8% in July**

 $\mathbf{I}^{ ext{ndia's}}$  crude oil production fell 3.8 per cent in July on lower output from fields operated by state-owned ONGC and private sector firms, government data released on Tuesday showed.

Production of crude oil, which is refined to produce fuels such as petrol and diesel, fell to 2.45 willion topped in fell to 2.45 million tonnes in July from 2.54 million tonnes a year back. The output was lower than the monthly target of 2.59 million tonnes, the data released by the Ministry of Petroleum and Natural Gas showed.

Oil and Natural Gas Corporation (ONGC) produced 1.7 per cent less oil at 1.63 million tonnes on lower output from western offshore. Fields operated by private firms saw a 12.34 per cent decline in production. But the oil production

during the first four months of the current fiscal that began on April 1 was only marginally



lower at 9.91 million tonnes as opposed to 9.96 million tonnes during April-July 2021. Oil Minister Hardeep

Singh Puri on August 4 tweeted that the declining trend in crude oil production has been reversed.

'We have already been able to reverse the declining trend in oil production from 2011-12 with an expected 29.7 million tonnes in 2021-22 to 30.8 million tonnes in 2022-23 & 34 million tonnes (estimated) in 2023-24, and are confident of rapidly ramping up the nation's oil production in the years to come," he had said. According to the ministry data, ONGC's oilfields in

Gujarat and Assam produced less oil while Vedanta's Rajasthan block had a lower output. Natural gas output was almost unchanged at 2.88 billion cubic meters in July but was 3.4 per cent higher during April-July at 11.43 bcm, according to the data released Tuesday.

ONGC's gas output was almost 4 per cent lower in July due to less gas production in the Daman field in Mumbai offshore. The country's 22 oil refineries processed 10.52 per cent more crude oil at 21.43 million tonnes as demand for fuel picked up.

Domestically produced

crude oil forms just 15 per cent of the processing at refineries, the rest being imported oil.

# Indian EV market to hit annual sales of 17 mn units by 2030: Report

India's electric vehicle market is expected to expand at a compounded annual growth rate of 49 per cent between 2021-2030, with the segment's volumes set to cross annual sales of 17 million by 2030, a new report said on Tuesday.

This projected growth is expected to be driven by factors such as rising fuel prices, entry of new players, advancement in EV technology, continued subsidy support from both the central and state governments as well as anticipated implementation of emission standards, India Energy Storage Alliance (IESA) said in its report.

The EV industry in India experienced one of the quick-



est recoveries from the pandemic-induced slowdown in 2020, the report observed, noting that the electric two-wheeler segment, accounted for 50 per cent of the total over 4.67 market followed by the low-

lakh EV sales in the domestic speed e-three-wheelers in 2021. However, other segments also showed notable increase

over the course of the year, it stated. The report said that with a Business as Usual (BAU) scenario, the Indian EV market would expand at a CAGR of 49 per cent between 2021 and 2030 and is predicted to reach annual sales of 17 million units by that time, with almost 15 million of those projected to be electric two-wheelers.

#### Pharma industry expects to report 7-9% revenue growth in FY23

Domestic pharma industry is expected to report moderate revenue growth of 7-9 per cent in the current fiscal, due to headwinds in export sales in the regulated markets and high-base effect in the domestic formulations business, as per rating agency CRISIL.

Operating profitability will shrink another 200-250 basis points (bps) after the 130 bps decline last fiscal due to continued pricing pressure in the US generics market, and high input and freight costs which offset moderate revenue growth, it said. The rating agency's estimates are based on a study of



184 drug makers that account for 55 per cent of the Rs 3.4 lakh crore-a-year sector revenue.

CRISIL stated that the domestic formulations market is expected to grow 7-9 per cent this fiscal, on a 15 per cent growth last fiscal, led by a 6-8 per cent average price increase allowed by the National Pharmaceutical Pricing Authority in March 2022 and on the back of new product

The implication of this order means that former captain Bhaichung Bhutia will have to come from a state unit in order to contest the election unlike earlier time when he announced either on filed as an eminent footballer.

Women's World Cup "cannot currently be held in India as planned.'

The country is scheduled to host the FIFA tournament from October 11-30.

It is the first time the AIFF has been banned by FIFA in its 85-year history.

On Monday, the Supreme Court modified its earlier orders to facilitate the revocation of the suspension and the holding of the Under-17 Women's World Cup in India.

"The day-to-day management of AIFF shall be exclusively looked after by the AIFF Administration led by the Acting Secretary General. The mandate of the Committee of Administrators appointed by the order of this Court stands terminated," the SC said in its verdict on Monday.

The three-member CoA, headed by former Supreme Court judge A R Dave, had been overseeing the affairs of the AIFF since the May 18 SC order. The other two members of the CoA are former chief election commissioner SY Oureshi and ex Indian football team captain Bhaskar Ganguly.

The top court also post-poned the August 28 elections of the AIFF by one week to allow a changed electoral college and the start of the nom-

ination process. The order came on a fresh clea filed by the Sports Ministry seeking modification of the May 18 and August 3 orders of the court after consultation with the FIFA



### Djokovic will not play in US Open: Reports

World No. 1 tennis player Novak Djokovic will miss the US Open, scheduled to be played from August 29, according to his official web-

Becoming the player with most men's Grand Slam singles titles is Novak Djokovic's ultimate career goal but it seems he has to wait until next year to fulfill his dream. The Serb won his 21st major title at Wimbledon in July, leaving him one behind Rafael Nadal's all-time men's record.

"There are no scheduled events at this moment," reads Djokovic's official website.

Djokovic's decision not to be vaccinated against Covid-19 has meant he has missed opportunities this year to add to his haul. The nine-time Australian Open champion was unable to play in Melbourne and could also be missing the US Open,

although he recently said he had his "fingers crossed" for the U.S. Open

According to a report in Forbes.com, the US Center for Disease Control and Prevention (CDC) demands a non-US citizen must "show proof of being fully vaccinated against Covid-19" before travelling by air from a foreign country.

The ruling stopped Djokovic from playing ATP Masters 1000 events at Indian Wells and Miami in March and April, along with last week's Cincinnati Open.
There had been hoping he

might be able to play in New York after the CDC earlier this month relaxed many Covid rules in the US.

"In the coming weeks CDC will work to align standalone guidance documents, such as those for healthcare settings, congregate settings at higher risk of transmission, and travel, with today's update," the organisation said.



"They should not change the approach (they have shown of late). Even when I was coach we discussed we were a bit timid at the top considering the players we had down the

"It is the right approach. You will lose a few games in between but if you start winning with this approach you can take that confidence in big games and use the same tactics," said Shastri in a press conference organised by Star Sports.

Virat Kohli will come back into the playing eleven after being rest-ed for the West Indies series, while K L Rahul returns after an injury lay

Can the two senior batters show the same aggression the younger players have shown in their absence? "Why not? They are very experienced players," said Shastri.

They have played enough IPL and T20s and it should not be tough for them to adjust. With Rishabh, Hardik, Jadeja there is enough depth in the middle and lower order to get the innings back on track if top order falls cheaply."

The return of Hardik Pandya, the all-rounder, has lent much needed balance to the Indian playing

"He is one of the most important cogs in India's wheel. You take him out, the balance goes awry. We missed him last year at the World Cup where he could not bowl. No



sess," Shastri said.

"He has to be watched very

closely. With the games coming up (before the T20 World cup), Bumrah and Hardik need to be observed very carefully to ensure there is no breakdown. They are your two important players." Shastri also backed Kohli to end his lean run in Asia Cup.

"I haven't spoken to him (recently). It is not rocket science. Mental fatigue can creep into the best in the world. This down time was not just needed for his body but to reflect," the 60-year-old said.

It is understood that for the time being, assistant coach Paras Mhambrey will be in-



charge of the team but a call on whether NCA head VVS Laxman will join the team in Dubai will be taken later.

"We haven't taken a call on whether VVS will be going to Dubai from Harare or not. A call will be taken accordingly and if required, he will join. Till then Paras Mhambrey will be in-charge. All other members are fit and left for UAE early in the day," a BCCI source said.
