CBI raids **RJD** leaders in land-for-Rly-jobs scam

The CBI on Wednesday conducted searches at 27 locations, covering two RJD Rajya Sabha members and an underconstruction mall in Gurugram allegedly linked to Bihar Deputy Chief Minister Tejashwi Yadav, in connection with a 14-year-old land-forjobs scam in the Railways.

During the operation which was spread across Bihar and Delhi-NCR, the agency's officers raided the premises of an RJD MLC and a former MLC of the party. The raids started before the newlyformed Mahagathbandhan Government of the ID(U), the RJD, the Congress, the Left, and other parties faced a trust

vote in the Assembly.

The CBI has alleged that Lalu Prasad as the Minister of Railways during the period 2004-2009, and his family members, had acquired land at throwaway prices from people in lieu of appointments in Group "D" posts in different zones of the Railways

In the FIR, the CBI has alleged that the job-seekers sold and gifted their land situated in Patna to family members of Prasad and a private company controlled by them. In the Assembly, Tejashwi

Yadav strongly refuted allegations of his links with the mall, saying it belongs to someone based in Haryana, and was inaugurated by a BJP MP.

People sitting in Delhi do not understand the spirit of Bihar. Intimidation does not work here. Sending three 'jamaai' (ED, CBI, I-T department) is not going to scare us. The BJP is looking like a wedding procession without the groom," remarked the young leader in an apparent dig at the BJP's inability to decide on who should be Opposition leader.

The CBI sources said the mall belongs to Yadav who has made investment in the project through a company.

The Registrar of Companies (ROC) details given on the Ministry of Corporate Affairs website show that Whiteland Corporation was incorporated on February 14, 2021 with two directors Viren Mehta and Krishan Kumar, both Gurugram residents. Later, Mehta was replaced by Sumit Chaudhary,

also from Gurugram.

ED finds 2 AK-47s in house of J'khand mining scam broker

Ranchi Police claim guns belong to cops

The Enforcement Directorate (ED) on Wednesday seized two AK-47 rifles from a house in Ranchi, belonging to Prem Prakash, an alleged middleman involved in dubious deals in the State, during raids as part of an ongoing probe into an alleged mining scam pegged at ₹100 crore. The probe agency also recovered 69 cartridges.

The news of recovery of the weapons from Prakash, who is said to be close to the people in the corridors of power in both the present and previous Governments, spread like wild-fire. The BJP left no time in attacking the JMM-led Government. BJP MP from Godda Nishikant Dubey tweeted, "According to sources, @dir ed has recovered AK 47

Govt should call all-party meet to end freebies: SC

The Supreme Court on Wednesday favoured an all-party meeting on the "serious" issue relating to the practice of political parties promising freebies.

The court said that until there is unanimity among political parties that freebies would destroy the country's economy and have to be stopped, noth-

ing can happen. "Why d doesn't Government of India call for an all-party meeting?" the top court asked.

There must be a debate. The issue is serious; there is no doubt about it. The question is, why do not all political parties meet and the Government of India can call for a meeting," it observed. The observations by a

bench comprising Chief Justice of India NV Ramana and Justices Hima Kohli and CT Ravikumar came on a plea against the promises of such handouts by the parties during election campaigns. Senior advocate Vikas

Singh, appearing for petitioner Ashwini Kumar Upadhyay, suggested that a retired judge of the apex court like former Chief Justice of India RM Lodha should be the chairman of the committee proposed to be constituted on this

However, Justice Ramana

or who is going to retire has no value in this country. That is the problem.

Advocate Bhushan said that he has filed an intervention on behalf of NGO "Centre for Public Interest Litigation".

Bhushan argued that they have said three kinds of freebies must be prohibited— those which are discriminatory or which violate fundamental rights; those which are against public policy; and those which are rolled out immediately before the election, like in the last six months before the polls, by the ruling party.

Solicitor General Tushar Mehta said there are political parties, which may not be in power in the State or at the Centre, and are rolling out such promises.

"The focal point is would the voter have an atmosphere where he can take an informed decision. It is not a question of ruling or losing a party. Can

you promise the moon to get elected?" Mehta said. As the bench asked why

the Government of India cannot call for an all-party meeting on the issue, Mehta said the political parties are already there before the apex court claiming that this is their right.
"There are some political

parties who think it is their fundamental right to offer freebies and have come to power by only offering freebies," the SG argued. The bench observed that the biggest problem is who will head the committee.

Senior advocate Kapil Sibal, whose assistance has been sought by the bench, had mooted the idea of setting up a panel of the statutory finance commission.

He had said as per the Fiscal Management Responsibility Act, if some freebies are given, then the benefit cannot go beyond 3 per

Toll charges on Yamuna Expressway hiked

Toll rates on the Yamuna Expressway between Greater Noida and Agra on Wednesday increased between ₹2.60 per kilometre and ₹18.80 per kilometre. The Yamuna Expressway Industrial Development Authority (YEIDA), which functions under the Uttar Pradesh Government and manages land along the 165-km-long expressway, made the announcement after its 74th Board meeting.

According to the new hikes, the toll rate for cars, SUVs, vans and light motor vehicles has been increased from ₹ 2.50 per kilometer to ₹2.65 kilometer. For light commercial vehicle, light goods vehicle or mini buses, it has been hiked from ₹3.90 per kilometer to ₹4.15 per kilometer, the YEIDA said in a statement. Toll rates for bus and trucks increased from ₹7.90 per kilometer to ₹8.45 per kilometer, it stated.

Toll for vehicles having three to six axles increased from ₹12.05 per km to ₹12.90 per kilometer, while that of large size vehicle and bigger vehicles changed from ₹15.55 per kilometer to ₹18.80 per kilometer, according to statement. "The concessionaire of expressway has spent ₹ 130.54 crore in works as per suggestions from the road safety audit of IIT, Delhi," YEIDA said.

The JD Tytler School, has also been asked not to admit any students for the 2022-23 academic session, and pay salaries and arrears of the staff till the school is in operation.

There was no immediate reaction from the school authorities. The decision has been taken based on the recommendations of the SC/ST Welfare Committee.

This order by the Directorate of Education (DoE) will be in effect from April 1, 2022. Vishesh Ravi, the chairman of the committee, said that according to the order issued by the Education Department on July 16, 2022, children have the

As per the letter written by the DTTDC to the NDMC, the new liquor policy will come into force with effect from September 1, as per which the four Corporations under Delhi government, namely DTTDC, DSIIDC, Delhi State Civil Supplies Corporation Limited (DSCSC), Delhi Consumer's Cooperative Wholesale Store Ltd. (DCCWS) will run liquor

Kejriwal flags off fleet of 97 electric buses at Rajghat depot

Delhi Chief Minister Arvind Kejriwal on Wednesday flagged off 97 electric buses from the Rajghat bus depot that took the number of such vehicles to 250. The CM said that nearly 80 per cent of the city's entire bus fleet will be completely electric by 2025.

The CM also announced that 8,000 e-buses are in the pipeline to arrive by 2025 and by November 2023, Delhi will have the highest number of ebuses in India with 1,800 ebuses

Kejriwal said that the city government is phasing out oldpolluting buses and replacing them with electric buses. Lockdown hero commits suicide

 $A^{55\text{-year-old}}$ Delhi based mushroom farmer, who bought flight tickets for his Bihar-based workers to send them home during the Covid-19 pandemic-necessitated lockdown, allegedly died by suicide at a temple in Tigipur Village. The deceased has been identified as Pappan Singh Gahlot, a resident of village Tigipur. According to police, the farmer left behind a suicide note, citing an illness as the reason behind taking the extreme

The body has been sent for post-mortem. The farmer is survived by his wife and a daughter. According to a senior police official, at around 5 PM, a police control room (PCR)



call was received at Alipur police station regarding hanging of a person in Shiv temple following which a policed team rushed to the spot. "When police team reached the spot, they found Pappan hanging from the ceiling fan in temple. His body was taken down. He had his house in front of the temple and he used to visit the temple daily," said the senior police official. "During initial enquiry, it was revealed that around 5 PM, the temple priest saw him hanging on the ceiling fan and the police was informed," said police official

privy to investigation.

"Police have also found a suicide note in which Pappan had stated that, due to blood pressure and sugar issue he had taken this step," he added.
"There is no doubt and foul play till now. The dead body has been preserved for autopsy in BJRM hospital.

The family is not suspecting any foul play too," said police official adding that inquest proceedings will be done accordingly. According to local villagers, Pappan, the farmer, was doing farming of mushroom for last 29 years.

SC: No tree to be felled in Mumbai's Aarey Colony

If any violation takes place, strict action will be taken, top court warns MMRCL

The Supreme Court on Wednesday directed the Mumbai Metro Rail Corporation Ltd (MMRCL) to strictly abide by its undertaking that no trees would be cut in Mumbai's Aarey colony and warned that any violation will result in strict action.

A three-judge Bench headed by Justice UU Lalit said he would hear the matter on August 30 after counsel for the Maharashtra Government sought time to collate docu-

"The counsel for MMRCL submits that her clients have already filed an affidavit that no trees have been or would be cut in any manner. The said undertaking by the MMRCL director has already been taken on record and MMRCL shall be strictly bound by the same," the bench also comprising Justices SR Bhat and Sudhanshu Dhulia said. Senior advocate Anitha Shenoy, appearing for the peti-tioner, alleged that clearing and levelling work is going on despite the apex court's order. The MMRCL had earlier told

Supreme Court that no trees have been cut in Mumbai's Aarey colony after October 2019. The apex court in 2019 had taken suo motu cognisance of a letter petition addressed to the then Chief Justice of India by a law student seeking a stay on the felling of trees in the Aarey colony. The Bombay High Court in October 2019 refused to declare Aarev Colony a forest and declined to quash the Mumbai Municipal Ĉorporation's decision to allow the cutting of over 2,600 trees in the green zone to set up a metro car shed.

As regards Afghanistan, the defence minister voiced India's full support to a peaceful, secure and stable Afghanistan, while emphasising to respect its sovereignty, independence, territorial integrity, national unity and non-interference in internal affairs. He urged all parties to encourage Afghanistan authorities to achieve national reconciliation through dialogue and negotiation and establish a broad-based, inclusive and representative political structure in the country.

He underlined the importance of United Nations Security Council (UNSC) resolutions in this regard. Rajnath said the Afghan territory must not be used to intimidate or attack any country by providing safe havens and training to terrorists and supporting their activities through financial

On the same day, representatives of Twitter India will also appear before the panel on the same issue, the notice reads. The IRCTC, which has more than 10 crore users, of which 7.5 crore are active users, has floated a tender to hire a consultant to monetise its passenger and freight customer data with the aim to generate revenue up to Rs 1,000 crore.

Sources in the panel said the issue will be taken up for discussion in the meeting with the IRCTC officials. The Railways has not offi-

cially commented on tender. However, highly placed sources said it will be withdrawn considering fact that government has withdrawn Data Protection Bill from Parliament. The Centre had on August 3 with-drew the long-awaited Personal Data Protection (PDP) Bill, 2019 to replace it with a new bill with a 'comprehensive framework' and 'contemporary digital privacy laws'.

Keep watch on long Covid patients: Study

Warning that the coron-avirus variants of concern from chronic, long-Covid patients can be more deadly, scientists have called for keeping a watch on such people. The study is published in Frontiers in Virology. Earlier studies have shown

that some immune-compromised people, such as those taking medication for other chronic disorders, have carried active Covid-19 infections for a year or even longer. Now the researchers have

stressed that it's critical to identify these people not only to help them get treated for Covid-19 but also to conduct genomic surveillance of the SARS-CoV-2 viruses that they



carry. "Rather than evolving from transmission chains of acute Covid-19 infections in hundreds of millions of people, our results show that the variants of concern come from rare cases when someone may have an active infection for months," said Daniel Weissman, a professor of biology and physics at Emory University in the US.

Viruses like SARS-CoV-2 continuously evolve due to occasional mutations in the genetic code that may occur when they replicate. "When a virus copies itself, it doesn't always make perfect copies,' said Weissman.

The World Health Organisation (WHO) defines a SARS-CoV-2 variant of conto cause infections even in those who are vaccinated or in those who were previously

"A key take-home message is that it is important to find these individuals who are chronically infected and provide support for them to recover," said Mahan Ghafari, first author of the paper and a postdoctoral researcher at the University of Oxford.

"In many cases, they may be asymptomatic and not even realise that they are infected with Covid-19 although they are actively shedding the virus, he added.

The WHO dubbed three variants of concern alpha, beta and gamma. The researchers have built a mechanistic, theoretical model to study the problem.

The resulting model rules out the theory that the variants of concern emerged from the sustained transmission of acute infections and fully supports the theory that each variant evolved within a single individual with a chronic infection.

Ayushman Bharat health cards to be co-branded with States' health schemes

Fairness needed

KCR must act against the trouble makers of all parties so that nobody can accuse of him being partisan

■he Bharatiya Janata Party (BJP) has been quick to suspend its Hyderabad MLA T Raja Singh for allegedly blaspheming against Prophet Muhammad. Now is the time for its rivals, especially Telangana Chief Minister K Chandrashekar Rao, to show that they place peace and communal amity above political interests. Consider the case of the influencer Syed Abdahu Kashaf, who claims to be a social and civil rights activist. He has not just used but also defended the use of the slogan, "Gustakh-E-Rasool ki ek hi saza, sar tan se juda, sar tan se juda" (There is only one punishment maligning the Prophet, and that is beheading. In a video, which Kashaf himself posted on Monday night, he is seen raising the violent sar tan se juda slogan. He was also haranguing people to protest against Raja Singh in Hyderabad outside the South Zone DCP office. In this protest, he told a news organization, he did not have any intention of doing anything unconstitutional; and yet he shouted the sar tan



se juda slogan, calling it his "religious belief." The problem with such people is that they can't detect the contradictions within themselves and between the mutually conflicting positions they hold simultaneously. The bigger problem is that there are a lot of people who hold similar views; a large section of people tend to agree with Kashaf, who is actually presenting the widespread Islamic stance on blasphemy.

KCR has become very critical of the BJP; he is indeed striving to become a challenger to Prime Minister Narendra Modi. So he has to be even-handed in dealing with all manner of trouble makers. A

Congress MLA reportedly said that he would take the law in his own hands if Raja Singh was not arrested. Raja Singh was arrested, though he secured a bail for himself soon after. Now is the time for KCR to assert that the law would be maintained at any cost, even if it means action against politicians of different parties. The Telangana Chief Minister should not be seen as tough on loose-talking BJP leaders and soft on the Muslim leaders who make inflammatory statements. It is a sad commentary on the state of affairs that politicians in all parts of India, whether it is Telangana or Uttar Pradesh, feel that maximum political mileage could be derived by milking emotive issues, even as a variety of issues—ranging from governance deficit and environmental degradation to unemployment—affect people. So, the BJP is trying to play the Hindu card in the southern states. In Karnataka, senior BJP leader and former chief minister BS Yediyurappa flagged off the Savarkar Rath Yatra in Mysuru, ostensibly to inform people about the Hindutva ideologue's views and principles. In Telangana, the BJP had to take a step back because of Raja Singh's remarks, but it is still all about emotive issues. KCR's response must be rational if he wants to be seen as a serious national player.

SISODIA IN DEEP TROUBLE



BUILD SMART HOMES TO OVERCOME HEATWAVE

Smart homes can help cut carbon emissions drastically

nonsider yourself lucky if you didn't face the recent heat wave. To _escape that, you either had to be abroad or be one of the eight per cent of households in India who afford to have air-conditioning. This is climate change, and we feel its impacts like storms and floods close to home. Devastated vegetables, grains and fruit crops bore the

Governments move slowly, but as consumers, we can act more nimbly to close the climate divide. We can begin with three things with changes in food, travel, and the spaces we live in. Let's see what we can do for the buildings and spaces we inhabit.

How much do buildings matter? Buildings contribute to about 40 per cent of the global greenhouse gas emissions. Temperatures within our cities will rise by 3-4°C. Our buildings need to be the first defence against such climate change events but only if we build them smartly.

For most people, a home is possibly the biggest life investment. So, being smart means building and operating your home to protect this investment and make it work for you.



Being smart means making new and existing buildings net-zero for energy and water, and building them for improved health and resilience. Going Net-Zero Energy involves minimising the energy use and using renewable energy like Solar PV to offset that minimal energy use. Since cooling and heating consume about 50 per cent energy, one can tackle this first by avoiding apartments with windows facing East and West directions where the low angle sun causes discomfort.

Large glass windows can be avoided, for the window area should be 30 per cent or less of the exterior wall, which should be shaded with balconies. Movable exterior screens can be added to let the sun in only when required. Thick or insulated walls should be opted, and AAC (autoclaved aerated concrete) blocks provide good thermal insulation.

Gadgets such as ACs, refrigerators and TVs should be three-star rated, while ceiling fans should be in all rooms. The ACs are kept at 25°C or higher with the ceiling fans on. The ACs can be programmed to higher temperatures after one falls asleep, or even turn it off.

Going 'Net-Zero Water' isn't easy, but most people can get 50-75 per cent of the way there. For this, aerators be used on taps, and waterient showerheads be installed, while there should be dual flush toilets. IAPMO's WEP-I star rating may be used as a guide

In the garden, water guzzling lawns are minimised and plant native/ adapted species be kept, which will boost the biodiversity of birds and

Efficient drip irrigation can also be employed, while also providing ponds or water baths for birds and animals to help them cope with climate change. Rainwater should be stored and used for washing and bathing, while recharge pits be built to recharge bore wells.

Buildings should be made healthy and climate resilient, which is a no-brainer, as it improves the long-term value of the property. Apartments and houses should have every room with good natural ventilation, while low-VOC (volatile organic compounds) be used which will improve indoor air quality.

Installing an inverter/ battery and connecting ceiling fans, lights, internet equipment and refrigerator to it can also be tried, with a solar photovoltaic system connected to the battery.

Sites in flood prone areas should be avoided, and floor levels be raised to avoid regular flooding, while all electrical be kept above the flood level. Underground tanks should be secured so that flooding does not contaminate water. Building elements should be tied down to secure from wind and storms.

Let big cats roar in far away jungles of India

ig cats are dispersing in new territories from their secured occupancy areas in India. Wildlife conservation is a practice to protect flora and fauna and their prime habitats. Today, 987 protected areas in India (national parks, wildlife sanctuaries, conservation reserves and community reserves), cover about 5.3

per cent of the nation's geographical areas.

These protected areas include five
Asiatic Lion Reserves in Gujarat, 52 Tiger Reserves in 18 states and 385 protected areas in 30 leopard states and Union Territories. Status of key wildlife species or apex predator as part of habitat is an indicator of health and resilience of natural ecosystems. Today, Management effectiveness evaluation indicates that the majority of the protected areas have poor conservation status due to intense biotic pressure, including progressing human-encroachment and inadequate management inputs.

In India, management effectiveness achieved high standards in about one-tenth of the protected areas, which support fascinating mega-species such as tigers, Asiatic lions, elephants, rhinoceros and a few other critically endangered species. In fact, management and financial inputs in these protected areas are much higher than the rest of similar regions in the country.

Globally, there are seven big cats - tiger, lion, jaguar, puma, leopard, cheetah, and snow leopard. Tiger, lion, leopard, and snow leopard are found in India.

Introduction of the fifth big cat Cheetah

in India in Rajasthan and Kuna National Park in Madhya Pradesh is at an advanced stage. Large scale poaching two decades ago had impacted tiger and leopard, but the constitution of the National Tiger Conservation Authority and National Wildlife Crime Bureau in 2006 provided effective support to their protection.

Numbers of big cats have declined consistently in Africa and Asia, but India has reversed the trend successfully by providing strict protection and secured habitats to them. In Asia, the number of big cats crashed in all countries, but increased in

Despite high human density and biotic pressure, the number of lions, tigers and leopards increased consistently in their secured habitats and started dispersing in new areas after their saturation in some of the Big Cat Reserves. At present, an Asiatic lion is found only in Gujarat in India although Asia Minor was prime land for this royal predator 150 years ago.

In 2018, out of the global population of 3,850 tigers, about 2,960 were found in India and the rest of 850 individuals in over a dozen Asian countries. Similarly, out of 22,000 Asiatic leopards belonging to eight sub-species, 18,000 adult and sub-adult of the Indian leopards were estimated in India and the rest of 4,000 leopards in about three dozen countries in Asia.

increased there. Over 1,350 big cats (lions and leopards) in the Lion Conservation Landscape in the four districts in Saurashtra have thrown a big challenge to management. With such a high concentration of big cats, man-leopard conflicts in the landscape are obvious, although a strong man-wildlife conflict response system has been placed there. Observing the present trend of lion's dispersion, the Government has planned to launch "The Project Lion" for the long term (2022-2047) by securing and consolidating habitats and protecting lions in the expanding distribution range in 10 districts of Saurashtra.

Tiger conservation had ups and downs since the declaration of the Project Tiger in 1973. A large-

scale poaching impacted the tiger. The supreme cat disappeared from a few of the tiger reserves and its number declined in other reserves. About 1,600 sub-adult and adult tigers (1411 in surveyed areas) were estimated in 2006. After the constitution of National Tiger Conservation Authority and National Wildlife Crime Bureau in 2006, scale of poaching was contained and tiger conservation was re-focused by expanding and consolidating tiger reserves. At present, tiger conservation activities intensified in 52 tiger reserves and compactness of the habitats improved by translocation and resettlement of villages from inside the core areas to other areas.

In 2018, about 2960 adult and sub-adult tigers were estimated in India which was about three-fourth of the global tiger population. Present ongoing counting of tiger, co-predators and prey using camera image capture and recapture method in 2022 indicates that tigers' number has further improved. At present tiger occupancy area is over 89,000 sq. km. of the prime

forests in 18 states of India. The Indian leopard, the activities, including creation of a network of medium and minor irrigation dams, expansion of sugarcane cultivation and tea-garden. Its number has consistently increased in 28 states and two Union Territories. In 2018, about 12,850 adult and sub-adult leopards were estimated in tiger landscapes in 18 tiger states.

If its number from all habitats in all leopard states and Union Territories are accounted for, the actual population would be over

18,000 adult and sub-adult leopards in India. In fact, only about onethird of the leopard population occurs in the protected areas in the countries and the rest in other forests and non-forests areas. It has been reported that a substantial number of the leopards breed in tea gardens, sugarcane fields, and prosopis thickets across the country. The present occupancy area of the Indian leopard may be over 310,000 sq. km., higher than the previous estimates.

One and a half dozen Tiger Reserves and five Lion Reserves in India are saturated with a number of super cats. Tigers and lions are dispersing in new areas, but getting suitable habitats to accommodate increasing numbers is a limitation. Another dark side of wildlife conservation is that the best forests in North East India and Dandakarany in four states - Chhatishgadh, Jharkhand, Odisha and Telangana have poor populations of tiger, leopard and other wildlife.

The Naxalite movement in these four states has depleted wildlife. If these areas are restored to their previous glory, it may not be difficult to manage a good smartest big cat, exploited various number of tigers and leopards in development and conservation India. If the present trend of recovery of the three big cats continues securing and managing 1,000 Asiatic lions, 5,000 tigers and 25,000 Indian leopards in the Indian jungle is possible under intensive conservation and protection activities, although manwildlife conflicts would turn into a serious management challenge.

To address emerging management challenges of manwildlife conflict, a strong conflict response system needs to be placed in the areas.

Democracy needs Govt, Opposition to be strong

The Opposition will need a leader with a pan-national appeal to challenge Modi. The sooner it gets united, the better

Prime Minister Narendra Modi has strengthened himself in the l himself in the last eight years to such an extent in his party and outside that the gap in popularity between him and other probable prime ministerial aspirants has become huge. He is all set for a third term in 2024.

About 53 per cent of respondents in the Mood of the Nation poll conducted by India Today and C Voter last week favoured Modi as the

next prime minister. The Opposition failed miserably in challenging Modi in 2014 and 2019. The recent presidential and vice-presidential elections also showed the Opposition's disarray, while the BJP has geared up its poll machinery. The focus has shifted from "Modi vs



Who" to "only Modi for 2024." So Modi had the field to him-

Interestingly, after Modi entered the national scene eight years ago, the campaignstyle became that of an American presidential poll. That is why there is so much talk about the 2024 polls when it is two years away.

Political forces could realign before the next Lok Sabha polls. Reaching a consensus on the prime ministerial candidate has been difficult, with the regional satraps pulling in different directions. Modi was a political leader who gave hope in 2014; he projected himself as a nationalist leader in 2019; and in 2024 would be launched as the most famous leader of India.

After his oath-taking, the ambitious Nitish took a jibe at Modi. He said, "Those who came to power in 2014, (read Modi) will they be victorious in 2024? I want all (Opposition)

to be united for 2024. The chances for Nitish were much brighter in 2015 when the Opposition defeated BJP in Bihar, and Nitish became Chief Minister. He left the Grand Alliance and joined hands with the BJP later. He is perceived as an oppor-

UKRAINE GIRDS FOR HEAVY ATTACKS AS IT MARKS INDEPENDENCE DAY

Ukraine nervously braced for what President Volodymr Zelenskyy warned could be especially brutal Russian attacks Wednesday as the country observed its Independence Day - and marked the war's six-month point - under conditions considered too dangerous to allow any major public celebrations in the capital.

Residents of Kyiv woke up to air raid sirens, but there were no immediate attacks

Kyiv authorities banned large gatherings in the capital through Thursday, fearing the national holiday might bring particularly heavy Russian missile strikes.

Independence Day commemorates Ukraine's 1991 declaration of independence from the Soviet Union.

"Russian provocations and brutal strikes are a possibility," Zelenskyy said in a statement. "Please strictly follow the safety rules. Please observe the curfew. Pay attention to the air sirens. Pay attention to official announcements. And remember: We must all achieve victory together.'

Last year, crowds turned out in Kyiv to watch a military parade marking 30 years of Ukrainian independence. This year, just a small number of residents gathered in the central square, where destroyed Russian tanks and artillery were put on display over the weekend, and the national anthem is played every

day at 7 a.m.
"I can't sleep at night because of what
I see and hear about what is being done in Ukraine," said a retiree who gave only her first name, Tetyana, her voice shaking with emotion. "This is not a war. It is the destruction of the Ukrainian people." In a holiday message to the coun-



try, Zelenskyy said: "Six months ago, Russia declared war on us. On Feb. 24, all of Ukraine heard explosions and gunshots. ... On Feb. 24, we were told: You have no chance. On Aug. 24, we say: Happy Independence Day, Ukraine!"

Ú.S. President Joe Biden announced he is sending nearly \$3 billion in new military aid to Ukraine that will enable its forces to fight for years to come. Biden said it will allow the country to acquire air defense and artillery systems and other

"I know this Independence Day is bit-tersweet for many Ukrainians as thousands have been killed or wounded, millions have been displaced from their homes, and so many others have fallen victim to Russian atrocities and attacks,

Biden said. "But six months of relentless attacks have only strengthened Ukrainians' pride in themselves, in their country, and in their 31 years of independence." European leaders likewise marked the holiday by pledging unwavering support for Ukraine and paying tribute to the sacrifices of its people.

German Chancellor Olaf Scholz

rebuked the Kremlin for its "backward imperialism" and declared that Ukraine "will drive away the dark shadow of war because it is strong and brave, because it has friends in Europe and all over the

A car bombing outside Moscow that killed the 29-year-old daughter of rightwing Russian political theorist Alexander Dugin on Saturday also heightened fears that Russia might intensify attacks on Ukraine this week. Russian officials have blamed Ukraine for the death of Darya Dugina, a pro-Kremlin TV commentator. Ukraine has denied any involvement.

Russian President Vladimir Putin's forces have encountered unexpectedly stiff Ukrainian resistance in their invasion, and the fighting has turned into a grinding war of attrition that has sent shock waves through the world

Russian Defense Minister Sergei Shoigu, speaking Wednesday at a meeting of his counterparts from a security organization dominated by Russia and China, claimed the slow pace of Moscow's military action was due to what he said was an effort to spare civilians.

Western leaders salute Ukraine on its Independence Day

European leaders pledged unwavering support for Ukraine as the war-torn country marked its Independence Day on Wednesday, coinciding with the six-month milestone of Russia's invasion.

Leaders paid tribute to the sacrifices and courage of the Ukrainian people, voiced their resolve to keep supplying Ukraine with weapons and reviled Moscow for its attack on the neighboring Eastern European nation.

In Britain, floral and musical tributes punctuated a show of solidarity as Ukraine commemorated its 1991 declaration of independence from the Soviet Union. they need," Johnson said. Johnson has been steadfast in his support for Ukraine since the invasion began. The prime minister, who will step down early next month, sought to deflect from scandals and criticism at home by positioning himself as the leader of the international effort to help Ukraine.

2 New York Democrats ousted from US House in primary losses

n a cluster of contentious Democratic primaries Tuesday, Ltwo New York incumbents were ousted from the U.S. House after redistricting shuffled congressional districts in one of the nation's largest liberal states.

Rep. Carolyn Maloney, a 15-term incumbent who chairs a powerful House committee, and Rep. Mondaire Jones, a first-term progressive who was one of the first openly gay Black members of Congress, lost their seats.

Maloney lost to her longtime colleague, Rep. Jerry Nadler, who became her rival as their longtime Manhattan congressional districts were merged.

Jones lost a packed primary in Manhattan and Brooklyn to Daniel Goldman, a former federal prosecutor who served as counsel to House

Democrats in the first impeachment inquiry against Trump.

In other races in the state, t he chair of the House Democrats' campaign arm, Sean Patrick Maloney, survived a primary challenge of his own from a progressive. Democrats kept a swing districts in a special election at least for a few more months.

In Florida races, an incumbent Republican narrowly defeated a far-right provocateur. Meanwhile, U.S. Rep. Matt Gaetz, a conservative firebrand, won his primary with the specter of a federal investigation looming over him.

South Korea's Truth and Reconciliation Commission has found the country's past military governments responsible for atrocities committed at Brothers Home, a state-funded "vagrants' facility" where thousands were enslaved and abused from the 1960s to

The landmark report on Wednesday came 35 years after a prosecutor first exposed the horrors at the facility in the southern port city of Busan and details an attempted cover-up of incriminating evidence that would have confirmed a statesponsored crime.

The commission's chairperson, Jung Geun-sik, urged South Korea's current government to issue a formal apology to survivors and explore ways to ease their suffering as he announced the initial results of its investigation into Brothers, including extreme cases of forced labor, violence and deaths.

The commission also called for the government to review the conditions at current welfare facilities around the country and swiftly ratify the United Nations convention



against enforced disappearances. The commission "confirmed that the direct and indirect exercise of government authority resulted in the forced confinement of people deemed as vagrants at Brothers Home and caused serious violations of human rights, including forced labor, physical assault, cruel treatment, deaths and disappearances," Jeung said in a news conference at the com-

The Reserve Bank, in a statement said the restrictions on the bank came into force from the close of business on

"Considering the bank's present liquidity position, no amount from the total balance across all savings bank or current accounts or any other account of a depositor, may be allowed to be withdrawn, but are allowed to set off loans against deposits...," it said.

The restrictions will remain in force for six months from the close of business on August 23, 2022.

The bank, without prior approval of RBI, cannot grant or renew any loans, make any investment, and accept fresh

The Reserve Bank also said the directions to the cooperative bank should not per se be construed as cancellation of banking licence by RBI.

Uber created economic value of ₹44.600 crore for Indian economy in 2021: Report

New Delhi : Ride hailing app Uber created an economic value of ₹44,600 crore for the Indian economy in 2021, a report commissioned by the company said on Wednesday.

The report, compiled by research firm Public First, measured economic impact in terms of Ubder's driver-partner payouts, indirect and direct impact of driver-partner spending on vehicles and induced impact of additional driver-partner income. "Uber created an estimated ₹44.600 crore in economic value for the Indian economy.

Uber produced ₹1.5 trillion in consumer surplus in 2021, which is equivalent to 0.8 per cent of GDP," Uber's 2021 India Economic Impact Report said.

According to the report, 96 per cent of riders find convenience as an important reason for using Uber.

"In a normal year, we estimate that Uber saves riders over 16.8 crore hours a year. In fact, as per Indian riders, ridesharing is the most significant transport innovation they have experienced in the last decade," the report said. The report estimates that driver-partners earn an additional ₹1,700 crore a year in higher income through Uber, or an average of 49 per cent more than their next best alternative type of work.

e doesn't find any particular pattern to his prolonged slump in form unlike 2014, but then to succeed in international cricket for as long as Virat Kohli has, it couldn't have happened without his ability to

counter adversities.

The former India skipper has gone without an international hundred across formats for nearly three years now but he feels that there isn't

much scope for course correction. The reason being that he isn't having any particular technical problem like one he had during England tour of 2014 when he was poking at deliveries on off-stump channel.

"I know where my game stands and you cannot run this far in your international career without having the ability to counter situations and counter conditions and counter different kinds of bowling. So, this for me, is an easier phase to process, but I don't want to put this phase behind me," Kohli said on Star Sports show 'Game Plan'.

He then spoke how a pattern of dismissals was detected on that tour and then after technical adjustments scored nearly 600 runs during the tour of 2018.

"What happened in England was a pattern, so something that I could work on and something that I had to kind of overcome. Right now, as you rightly mentioned, there is nothing that you can point out saying that the problem is happening here," Kohli noted.

However of late, Kohli has got out in every possible manner, to rising deliveries, to fuller balls, to swinging deliveries, to cutters, off-spin, leg-spin and left-arm spin.

Former Australian all-rounder Shane Watson feels Virat Kohli will be mentally and physically rejuvenated after a month-long break from cricket ahead of the Asia Cup, starting later this week.

Kohli is enduring his worst phase of career and has not scored a century in international cricket since November 2019.

The star batter will return to cricket after missing out the series against the West Indies and Zimbabwe.

"Having time off for him certainly, would (help him) just be able to regenerate mentally, physically, just be able to get away from the game of cricket," Watson said on the ICC Review Show.

"You could just see that his enery was a bit sapped, even during the IPL. You could tell, no matter how much he tried - he was always up and about, but you could see the light was just out a tiny bit," he
