Election panel has recommended disqualification of Soren as MLA, say media reports

"sealed" letter sent by the A Election Commission of India to the Governor of Jharkhand on the office of profit case against Chief Minister Hemant Soren suddenly increased the political temperature in the State on Thursday.

Amid unconfirmed media reports that the ECI has recommended disqualification of Soren from the membership of the House, Governor Ramesh Bais told the media at Ranchi airport upon his return from Delhi that he had no idea about the letter and its content.

He said he would be able to comment on the issue only after he went through the letter. The Governor was in Delhi for treatment of his wife at AIIMS Delhi and he returned to Ranchi only in the afternoon. However, even after hours of his arrival, there was no word from the Raj Bhavan on the issue.

Sources said the Governor may take up the matter on Friday and make public the contents of the said letter along

Middleman held in mining case

New Delhi: The Enforcement Directorate (ED) on Thursday arrested "middleman" Prem Prakash in connection with its ongoing money-laundering probe into an illegal mining case in Jharkhand.

Prakash was taken into custody under the Prevention of Money Laundering Act (PMLA) and is being produced before a Ranchi court where the federal agency will plead for his custody, officials said. This is the third arrest in the case. Earlier, the agency had arrested Pankaj Mishra, a political aide of Jharkhand Chief Minister Hemant Soren, and Mishra's associate and muscleman Bachhu Yaday.

Sonali's autopsy hints at murder, 2 aides arrested

The Goa Police on Thursday L evening arrested two asso-ciates of BJP leader Sonali Phogat after a post-mortem report mentioned that there were "multiple blunt force injuries" on her body. Both were booked for "murder".

Section 302 (murder) of the Indian Penal Code was added to the case related to the death of the 42-year-old leader, a senior police official told PTI here. Sudhir Sagwan and Sukhwinder Wasi, who had accompanied Phogat when she arrived in Goa on August 22, were named as accused in the case, he added.

Her brother Rinku Dhaka had filed a complaint against the two men at Anjuna Police Station on Wednesday.

A panel of forensic experts from the Goa Medical College and Hospital conducted the autopsy on her body on Thursday morning after her family agreed to the procedure. Dr Sunil Shrikant Chimbolkar of the Forensic Science Department of GMCH in his report reserved the opinion on the cause of death.

"The cause of death due to the best of my knowledge and belief is reserved pending chemical analysis. Histopathology and serological reports of the tissues pre-

served," the report said. "However there are multi-



ole blunt force injuries over the body. In view of the above, the manner of death is for the investigating officer to ascertain," it added.

Phogat, who hailed from Hisar in Haryana and found fame on TikTok, was brought dead to the St Anthony Hospital in Anjuna in North Goa district on August 23 morning.

The cause was given as a suspected heart attack. Goa Chief Minister Pramod Sawant told reporters in Panaji on Thursday that State Director General of Police Jaspal Singh was personally monitoring the investigation.

Two aspects of PMLA verdict need relook: SC

The Supreme Court on Thursday agreed to hear a review petition against its July 27 judgment upholding the Constitutional validity of the Prevention of Money Laundering Act, 2002 (PMLA). The court said two aspects of the PMLA — not providing an Enforcement Case Information Report (ECIR) and reversal of the presumption of innocence
— "prima facie" requires recon-

sideration.
"There is no need for elaborate arguments. We feel that only two aspects may be necessary to be re-looked into the judgment," said Chief Justice of India NV Ramana.

The bench, also compris-Justices Dinesh Maheshwari and CT Ravikumar, said the court is completely in support of the

prevention of black money and money laundering as the country cannot afford such

types of offences. Referring to the two aspects relating to not provid-ing ECIR and reversal of the presumption of innocence, the bench said after reading the judgment, "prima facie" it feels that these are the two issues

that require reconsideration.

The bench said that the object of the Act is noble and the offence of money laundering is serious. On July 27, the bench headed by Justice AM Khanwilkar upheld the PMLA rejecting around 200 petitions against the Act. The bench headed by CJI issued notice to the Centre on the review petithe Centre on the review peti-tion filed by Congress MP Karti Chidambaram, accused in the ED's cases along with his father P Chidambaram.

SC-picked panel indicts SSP for PM's security breach in Punjab

A Supreme Court-appoint-ed committee to probe the security breach during Prime Minister Narendra Modi's visit to Punjab in January has found that the Ferozepur SSP failed to discharge his duty though suf-ficient force was available. The committee headed by

former judge Indu Malhotra also told the top court that there should be an oversight committee for periodic revision and update of "Blue Book" and sensitisation courses for police officers engaged in security of the Prime Minister.

The five-member panel also told the Supreme Court that there was sufficient time with the SSP after then Punjab

Govt slaps curbs on wheat Modi for flexible work hours, says export to stem price rise

The decision of the Cabinet "will now allow a restriction on the export of wheat flour which will ensure a curb on rising prices of wheat flour and ensure food security of the most vulnerable sections of the society", an official statement said.

The Directorate General of Foreign Trade (DGFT) will issue a notification to this

Panel found malware in 5 phones, Pegasus use inconclusive: SC

The Supreme Court on Thursday said the technical panel appointed by it to probe the unauthorised use of Pegasus has found some malware in five mobile phones out of the 29 examined but it could not be concluded that it was due to the Israeli spyware.

After perusing the report submitted by former apex court Iustice RV Raveendran, Chief Justice NV Ramana also noted that the Central Government did not cooperate with the Pegasus probe. The SC decided to upload portions of the report on its website.

The three-judge bench said

three parts. One of the parts suggested amending the law to protect citizens' right to priva-cy and ensure the nation's cyber security. "They (panel) have observed that the Government of India did not cooperate. Whatever stand you had taken here, you have taken the same stand before the committee also," said the bench, also comprising Justices Surya Kant and Hima Kohli, said. Referring to a report of the technical panel, the bench said it was "little concerned" as it

"Export policy of wheat flour (atta) remains free but export shall be subject to recommendation of the inter-ministerial committee on export of wheat," the notification had said. When asked about the Cabinet decision, an official said earlier the export regime for wheat flour was "free" but now it is restricted. In 2021-22, India exported wheat flour worth USD 246 million. The exports stood at about USD 128 million during April-June this fiscal. Russia and Ukraine are the major exporters of wheat, accounting for around onefourth of the global wheat trade. The war between the two countries has led to global wheat supply chain disruptions, thus increasing the demand for the Indian wheat. As a result, the price of wheat in the domestic market has shown an increase.

The court will now hear the matter after four weeks.

"So far as the technical committee report is concerned and it appears that there is a request from the persons, who have given their phones, that the report not be shared...It appears that some 29 phones have been given and in five phones, they found some malware but it does not mean that it is a malware from the Pegasus...,"the CJI said.

The bench said the report of Justice Raveendran has suggestions on protecting the citizens' right to privacy, the future course of action, accountability, amending the law to improve privacy protection and the grievances redressal mechanism. It said that the report of the overseeing judge suggested some remedial measures and one is

that there should be "amendments in the existing laws and the procedures on surveillance and right to privacy."

"Second is enhancing and improving the cyber security of the nation," the bench said, adding that the report also suggested the "establishment of a mechanism for citizens to raise grievances of illegal surveillance." Noting that it was a "huge report", the bench said it will see what portion can be given and added that there was also a request not to release the report. "These are technical issues. So far as Justice Raveendran's report is concerned, we will upload it on the website," the CJI said. Senior lawyers Kapil Sibal and Rakesh Dwivedi urged the bench to release a "redacted report" to the litigants. When the bench said the Centre did not coop-

The technical panel, which included three experts on cyber security, digital forensics, networks, and hardware, was asked to "inquire, investigate and determine" whether Pegasus spyware was used for snooping on citizens and their probe would be monitored by Raveendran. The panel members were Naveen Kumar Chaudhary, Prabaharan P and Ashwin Anil Gumaste.

Justice Raveendran, who headed the monitoring panel, was assisted by former IPS officer Alok Joshi and cyber security expert Sundeep Oberoi in monitoring the inquiry of the technical panel. The top court last year ordered a probe into the allegations of the use of Israeli spyware by government agencies for targeted surveillance of politicians, journalists, and activists and appointed technical and supervisory committees to look into the Pegasus row.

The apex court, in its order, had said that the probe panel would be empowered to enquire and investigate what steps or actions have been taken by the Centre after reports were published in 2019 about the hacking of WhatsApp accounts of Indian citizens, using the Pegasus suite of spyware. Also whether any Pegasus suite was acquired by the Union of India, or any State Government, or any Central or State agency for use against the citizens of India.

An international media consortium had reported that over 300 verified Indian mobile phone numbers were on the list of potential targets for surveillance using the Pegasus spy-

The BJP also compared Kejriwal with Goebbels. Kejriwal and several of his spokesperson and senior leaders throughout the day claimed that the BJP has has kept aside Rs 800 crore to bring down the Delhi Government - Rs 20 crore per

Addressing the recent political developments and snubbing the rumours aside, Kejriwal reposed faith in his MLAs and said that he is extremely happy to see that not even a single MLA has bowed down to BJP threat.

At Rajghat, Kejriwal said nothing was recovered by the Central Bureau of Investigation (CBI) during its raid at Deputy CM Manish Sisodia's residence earlier this week. "Even mattresses and walls at my deputy Manish Sisodia's residence

were searched by the CBI, but not even a single unaccounted penny was found. A day after the CBI's raids, Sisodia was approached by the BJP with an offer of the chief minister's post and to betray Kejriwal. I am lucky to have Sisodia, who has no greed for the chief minister's post," Kejriwal told reporters.

Accusing Kejriwal of diverting the issue, party spokesperson Sudhanshu Trivedi and Parvesh Sahib Singh Verma said Kejriwal has not answered charges in the liquor scam and only brought baseless allegations against us.

"Kejriwal should talk about the liquor policy. But he is not saying anything about this. Instead, he has come up with his worn-out script," BJP MP Manoj Tiwari said in a separate video. AAP misleading public on liquor scam: BJP

BJP holds protests in 270 places in city, seeks resignation of CM, Deputy CM

The BJP-AAP clash over the Excise Policy probe intensified on Thursday with the saffron party comparing Chief Minister Arvind Kejriwal with Nazi propaganda Minister Goebbels.

The Delhi BJP hit out at the AAP saying its allegations were like a "movie script" meant to mislead the public on the "scam" in Delhi's now-scrapped Excise Policy 2021-22. BJP workers on Thursday staged a massive protest at 270 places in the national Capital, demanding the sacking of Deputy Chief Minister Manish Sisodia.

"This is a total flop show of the AAP. Kejriwal ji you have to speak on the Excise Policy but your silence on this issue says a lot. You always come up with the same old, worn-out movie script to divert public attention. Arvind, you have become a descendant of Goebbels, who used to think that if you keep telling the public a lie, they will start believing it as a truth," Tiwari said in a video. Tiwari said those who indulged in the "liquor scam"

Meanwhile, thousands of saffron party workers staged protests and shouted slogans such as "Manish Sisodia istefa do". They also burned an effigy with the face of Sisodia on one side and Kejriwal's face on

Addressing the protestors at RK Ashram, Gupta said that the AAP has no answers as it knows its deceptive promises to Delhiites have now been exposed. That's why AAP leaders are misleading people by talking about things other than the Excise Policy.
"The BJP has many ques-

tions including, if the Excise Policy was so good, why did the AAP Government take it back? Why was retailing allowed to the manufacturer? Why did they waive off Rs 144 crore of liquor mafia and then again, Rs 30 crore?" Gupta questioned.

Union Minister of State, Meenakshi Lekhi said that the

AAP Government had said before implementing the Excise Policy that it would increase the revenue of the national Capital by crores of rupees but the fact was that it only helped Kejriwal fill his pockets.

"Kejriwal used to say that if there is any corruption, he is a traitor to the country and so in light of this he should not remain in office. In such a situation, now what does he have to say about Satyendra Jain and Manish Sisodia, who have remained in the party and post even after being involved in corruption," she asked.

Leader of Opposition Ramvir Singh Bidhuri also demanded the resignation of Sisodia and said that the AAP's truth is in front of the people of the Capital. "They are playing a game of accusation and counter-accusation but by doing all this they cannot escape their sins.

The AAP Government will have to answer why liquor vends were opened in violation of the Master Plan and rules," Bidhuri said, adding that those who campaigned against corruption are now themselves trapped in it.

Rules for convening Assembly session must be followed, Bidhuri tells L-G

If AAP does not follow rules, then House should be dissolved: LoP

BJP leader and Leader of Opposition in Delhi Assembly Ramvir Singh Bidhuri on Thursday told Lieutenant-Governor Vinai Kumar Saxena that rules should be followed for convening the session of the Assembly and if the AAP does not follow the rules, then the Assembly should be dissolved.

The BJP leader demanded that the one-day special session called by the Government on Friday should be stopped and instead the Monsoon Session of the Assembly should be called for at least five days.

He further accused the AAP of making the Assembly an arena of politics and keeping all rules aside. He said the main agenda of the AAP Government will be Modibashing or Centre-bashing and they would not discuss the liquor policy "scam."

"In the past, whenever the Delhi Assembly session was convened, it ended with Modi Government bashing. Till date, Kejriwal is busy doing drama but he has not answered any query raised by the BJP," said Bidhuri. Earlier, Bihduri held a meeting with BJP MLAs ahead of the session to discuss the strategy in the House. The meeting was attended by all BJP MLAs including Mohan Singh Bisht, Vijender Gupta, Omprakash Sharma, Jitendra

Bidhuri said the one-day session of the Delhi Assembly has been called by breaking rules. "There have been Monsoon Sessions of all the Legislative Assemblies including the Parliament, but the Monsoon Session of the Delhi Legislative Assembly was not

The Kejriwal Government does not want to talk about the issues of the people, nor does it want to answer the questions of the people," he said

"Whenever the AAP needs to talk on any subject of its choice, it calls a day-long session of the Assembly. Surprisingly, neither questions nor answers are asked in the session and even members are allowed to raise short-duration discussions," said Bidhuri.

"Before convening the session, 15 days' notice should be given, and the members should be allowed to express their views. If AAP is determined to kill democracy like this, then Delhi Assembly should be dissolved," Bidhuri added

Appeal to use waste from 3 garbage dumping sites has paid off: L-G

 $T^{\text{he Municipal Corporation of Delhi (MCD) has received}}$ an order for more than 10,000 metric tonnes (MTs) of inert and Construction and Demolition (C&D) waste from private entities, out of which 8421.75 MTs has already been lifted from the

This comes following the directions of the Delhi Lieutenant-Governor Vinai Kumar Saxena to utilise the C&D waste inert at the three garbage dumping sites. According to the statement

released by the Raj Niwas, the idea was to address the issue of accumulated C&D and inert waste at the three dumping sites of the MCD by appealing to the industry, contractors, road constructing agencies, builders and individuals in Delhi-NCR to pick up and use this reusable waste free of cost.

"The appeal first made on July 21 and later on August 4 has borne fruitful and encouraging results with people of Delhi-NCR as well as various agencies warming up to the idea of recycling the C&D waste and inert for their own use and ordering 10,500 MTs in less than one month," it read.

'The L-G had also asked to other government agencies involved in building and road construction like Delhi Development Authority (DDA), Public Works Department (PWD), New Delhi Municipal Council (NDMC), and Central Public Works Department (CPWD), etc. to start using inert and C&D waste for their activities. DDA and PWD have already decided to use the same," it stated. "This exercise by MCD has effected a win-win situation for all stakeholders, which is resulting in three pronged benefits. While it is saving costs for MCD as well as people/agencies utilizing the waste, it is also ensuring that the height of the garbage mounds gets reduced,"

Property tax in Delhi may rise G and H unauthorised MCD's valuation panel has

recommended increase in 6 factors used to calculate annual value of property

In what could come as a set-**L**back to Delhiites, property BJP-ruled Corporation of Delhi (MCD) has come out with a plan to collect Rs 3,850 crore as revenue from house tax in the financial year 2022-23 and the fifth Municipal Valuation Committee (MVC) has recommended an increase in six factors which are used to calculate the annual value of a property.

In the financial year 2021-2022, the three civic bodies collected around Rs 2,000 crore. As many as 12 lakh households registered for property tax collection.

The MVC said in its recommendations made in an interim report to the MCD that an increase in the six factors used to calculate a property's value is needed due to inflation. The MCD has uploaded

the report on its website and issued a public notice inviting objections from the general public. Colonies in Delhi have been divided into eight categories from A to H. A and B category colonies comprise posh areas, C and D middle class neighbourhoods, E and F lower middle-class areas, and

the statement said.

"Encouraged by these results, the LG has directed the MCD to further augment engagement with concerned stakeholders and reiterate its appeal to them so that the process of off take of C&D waste and inert could be expedited. It may be noted that the LG himself is steering engagements with various government

colonies. The base unit area value for category A colonies is Rs 630 currently, Rs 500 for is Rs 630 currently, Rs 500 for category B, Rs 400 for catego-ry C, Rs 320 for category D, Rs 270 for category E, Rs 230 for category F, Rs 200 for catego-ry G and Rs 100 for category H. Theorem 1. H. The proposed values are Rs 800 for category A, Rs 680 for category B, Rs 550 for categoand Rs 370 for category E.

Additionally, the MVC has also recommended 1.1 and 1.2 as the 'age factor' for buildings constructed from 2010 to 2019 and 2020 to 2029, respectively. "The age factor is 0.5 for properties constructed in the 1950s, '0.6' for those in the 1960s and '1' for those built between 2000 and 2010.

According to a senior MCD official, the property tax department is the backbone of the civic body in terms of revenue generation. The civic body has planned a massive campaign in unauthorised colonies to create awareness about property tax, and ease the process of payment of property tax for

Delhiites. The MCD will conduct a door-to-door campaign in JJ colonies along with the form through which the people can easily file property tax. Besides, they will also distribute pamphlets about the tax.

In the financial year 2021-2022, the trifurcated South Delhi Municipal Corporation (SDMC) had the highest property tax collection worth Rs

1,081 crore.

Kanungo said that the CBRI is also satisfied with the planning and preparations done by demolition firm Edifice Engineering and its expert South African partner Jet Demolitions.

Manufacturers, dealers must collect used batteries against new ones, says Waste Mgmt Rules 2022

The Government on The Government the Thursday notified the Battery Waste Management Rules 2022 according to which it will be mandatory for manufacturers and dealers to collect used batteries against the new ones they sell.

A notification in this regard has been issued by the Union Environment Ministry which would supervise its implementation to ensure environmentally sound management of waste batteries. "Notification of these rules

is a transformative step towards implementation of the announcement made by Prime Minister Narendra Modi in his address to the Nation on Independence Day on 15th August, 2021 to promote circular economy in full earnest," an official from the Ministry said adding that the new rules will replace Batteries (Management and Handling) Rules, 2001.

The rules cover all types of batteries, viz. electric vehicle batteries, portable batteries, automotive batteries and industrial batteries.

The rules function based on the concept of Extended Producer Responsibility (EPR) where the producers (including importers) of batteries are responsible for collection and recycling/refurbishment of waste batteries and use of recovered materials from wastes into new batteries.

EPR mandates that all waste batteries be collected and sent for recycling/refurbishment, and it prohibits dis-

posal in landfills and incineration. To meet the EPR obligations, producers may engage themselves or authorise any other entity for collection, recycling or refurbishment of waste batteries.

The rules will enable setting up a mechanism and centralized online portal for exchange of EPR certificates between producers and recyclers/refurbishers to fulfil the obligations of producers.

Mandating the minimum percentage of recovery of materials from waste batteries under the rules will bring new technologies and investment in recycling and refurbishment industry and create new business opportunities," as per the legislation.

Online registration & reporting, auditing, and a committee for monitoring the implementation of rules and to take measures required for removal of difficulties are salient features of rules for ensuring effective implementation and compliance.

On the principle of Polluter Pays Principle, environmental compensation will be imposed for non-fulfilment of EPR targets, responsibilities and obligations set out in the rules.

The funds collected under environmental compensation shall be utilised in collection and refurbishing or recycling of uncollected and non-recycled waste batteries, said the official.

PM to grace Sept 2 commissioning of desi aircraft carrier INS Vikrant

Prime Minister Narendra Modi will preside over the ceremony on September 2 in Kochi to commission the first indigenously-designed and built aircraft carrier INS Vikrant into the Indian Navy.

With this induction, India will join the elite league of nations to have its own indigenously-made aircraft carrier. The other countries are US, UK, China and France.

Giving the details of the induction schedule, Vice-Chief of Navy Vice-Admiral SN Ghormade said here on Thursday the commissioning of the INS Vikrant, costing about ₹20,000 crore, will contribute in ensuring peace and stability in the Indo-Pacific region. Deliberations are on for constructing the second indigepresent, India has lone aircraft carrier INS Vikramaditya built by Russia as per the Indian Navy's specifications.

The commissioning of the aircraft carrier will be an "unforgettable" day as it will significantly enhance the country's overall maritime capabilities, Ghormade said.

He said its commissioning will be a historic occasion and that it is also a symbol of "national unity" as its components came from a significant 18 states and Union Territories. Moreover, the ship has 76 per cent indigenous components.

The aircraft carrier successfully completed the fourth and final phase of the sea trials last month. The ship has over 2,300 compartments, designed for a crew of around 1700 people, including specialised cabins to accommodate women officers. The ship weighs more than 43,000 tons and is the largest ship ever to

be built in India. It has a top speed of around 28 knots and a cruising speed of 18 knots with an endurance of about 7,500 nautical miles. The aircraft carrier is 262 metres long, 62 metres wide and it has a height of 59 metres. Its construction began in 2009. The ship is powered by four gas turbines totalling 88 MW

The ship also boasts of a fully-fledged state of the art medical complex with latest medical equipment facilities.

Ghormade said the aircraft landing trials on board INS Vikrant will begin in November and they will be completed by mid-2023, adding MiG-29K jets will operate from the warship for the first few years.

The Navy is in the process of procuring 26 deck-based aircraft and it has narrowed down on Boeing's F/A-18 Super Hornet and French aerospace major Dassault Aviation's

Taming ED

The Supreme Court will not reconsider its judgment on the Prevention of Money Laundering Act

he Supreme Court has rightly decided to reconsider its verdict on the Prevention of Money Laundering Act (PMLA), 2002. Reconsideration is over two issues: reversal of the presumption of innocence and sharing the Enforcement Case Information Report (ECIR). On July 27 this year, the three-judge Bench of the apex court, headed by Justice Khanwilkar, had upheld the PMLA. This meant a leg up for the Enforcement Directorate (ED) for its powers to arrest, search, etc., in money laundering offences were validated. While maintaining "the principle of innocence of the accused/offender is regarded as a human right," the Bench said "that presumption can be interdicted by a law" made by Parliament. It also said since an ECIR cannot be equated with a first information report or FIR, it was not mandatory to provide the ECIR in every case to the person accused. The court said that "it is enough if ED, at the time of arrest, discloses the grounds of such arrest." This decision was



widely criticised by the Opposition parties and jurists. Opposition leaders have long been complaining about the wide powers enjoyed by the ED; they have also been accusing the Narendra Modi Government of using the ED for political purposes—a charge that the Government and the Bharatiya Janata Party leaders have been denying vociferously.

While politicians will continue to hurl allegations at each other, a couple of facts need to be underlined. First, if the PMLA has become toxic and the ED unrestrained, it is not the doing of this regime alone. As the SC Bench said in its July 26 judgment, former finance minister Yashwant Sinha in his

December 1999 speech "set the tone for the years to come in the fight against money laundering." It also mentioned another former finance minister, P Chidambaram, whose speech in the Rajya Sabha in December 2012 explained the need for amendment(s) to the PMLA. But now the boot is on the other foot. Chidambaram himself is being investigated by the ED and the Central Bureau of Investigation. His son Karti Chidambaram, who is also being probed by the two agencies, wants the SC verdict to be reconsidered. Second, Opposition leaders just keep lamenting all the time about the abuse of Central investigation agencies; they never come out with something concrete. Nobody in the right frame of mind would say that these agencies should be misused, so their lamentations are of no utility; they must inform the people how they intend to make the functioning of these agencies efficient and impartial. Money laundering is a big problem, so also are corruption, terror, etc.; therefore, fight against such evils has to continue, but it should be in such a manner that there is no collateral damage in terms of political targeting. Just making bombastic statements and tweeting catchy one-liners will help neither politicians nor serve the cause of justice. Substantive action is needed.

The unfolding unfortunate developments are a blot on Kerala, rated as one of the States with high literacy rates. Cynics may take solace in the fact that the total literacy claimed by the State is nothing more than the ability of people to write down their name in their mother tongue and put a signature. That is the much-acclaimed 'total literacy' of the State! The Marxists, ruling the State uninterrupted since 2016, are on a mission to paint the academic institutions red by appointing card-holding cadres as faculty and vice-chancellors. This has led to deterioration in the standard of State universities. More than academic prowess, what

> matters in the State is one's political leanings and the people known in the party hierarchy. The Congress, the main Opposition, is equally to be blamed for the state of affairs. Both the LDF and the UDF are vying with each other in giving two hoots to the dignity of higher education.

The vice-chancellors are appointed not only on political lines but even on caste and communal lines. For example, the Calicut University was established in 1968 by the then EMS Namboodiripad-led Government to keep the Muslim League in good humour. Of the 11 vice-chancellors who served the university, eight were from the Muslim community. When the CPI(M) catered to the demands of Muslims,

could the Congress be a mute spectator? It carved out the Mahatma Gandhi University to appease the powerful Christian community. Of the 23 varsities in Kerala, 13 are owned by the State. The vice-chancellors and faculty members of these universities are appointed from among the relatives and associates of party leaders. The recent appointment of the wife of the Chief Minister's private secretary as an associate professor in Kannur University has opened a Pandora's box. The appointee had just 156 marks and did not meet the norms. Joseph Skariah, who scored 651 marks in the selection process, was sidelined in her favour. The State universities were also in the news for appointing wives and sisters of party commissars, ignoring any semblance of transparency and honesty. That is higher learning in Kerala!

f all the medical experts knew the background of medicine in India, the current controversy might not have taken place. Ayurveda suffered a decline in the late 19th century in the absence of research and development. For example, Susruta was as great a name as Charak and was often referred to as the father of Indian surgery. Charak had confined himself to pure medicine and mainly to gastronomy. It is said that he confined himself to gastronomy and the treatment of the alimentary canal without ever opening an abdomen. Ayurveda was the backbone of health care through ancient and medieval times, until the 19th century, because it was a discipline for ensuring longevity rather than merely treating the symptoms of illness. As scholars have claimed it was a science of life; not merely to cure the sick but also to make the healthy healthier; Chavanprash is an elementary example while Rasayana or rejuvenation is its advanced face.

Until Allopathy took long strides in the early decades of the 20th century, Ayurveda commanded its place. It had, for instance, Sarpina for treating high blood pressure while Allopathy had no answer except placing live leeches on the patients' forehead to draw out blood and reduce its supply. My grandfather died at the age of 45 because of nephritis which made his kidneys dysfunctional. His final treatment was four weeks each in Vienna and London; this was in 1933. There was no antiseptic not to talk of an anti-biotic.

this regard. Ayurveda must be given the credit for innovating the vocation of nursing. Both male and female nursing began centuries ago although the practice took a long time to spread. DROP QUAD ANCHOR FOR INDO-PACIFIC STRATEGY

India should work to align Quad for Indo-Pacific bond

*xternal Affairs Minister S Jaishankar was in Thailand last week, where he delivered a detailed lecture on India's Indo-Pacific vision. India has been highlighting its Indo-Pacific vision in diplomatic circles at multilateral and plurilateral platforms. However, this was perhaps the first time a roadmap and way forward plan was outlined for students, academicians, and other relevant stakeholders.

Jaishankar delivered the lecture at Chulalongkorn University in Thailand. The Indo-Pacific region as defined by India spans from eastern shores of Africa to western shores of America. This region contributes nearly 60 per cent to global GDP and most of the trade takes place through the sea routes.

At the end of World War II, the US emerged as the primary provider of security umbrella for the nations dotting the Pacific Ocean and a watery borderline emerged between the otherwise connected Indian and Pacific Ocean. India too has in the past many decades focussed more on inland continental security due to its regional concerns (Pakistan, China) and has been less focussed on the maritime domain as an important area



However, the aggressive stance of China in India's backwaters (Indian Ocean), its aggressive tactics in the South China Sea, its non-transparent binding financial support for infrastructure development in smaller nations, thereby threatening their sovereignty and a deterioration of relationship with the US has forced India to aggressively launch a multipronged engagement in the Indo-Pacific region.

Jaishankar highlighted that India's Indo-Pacific vision builds heavily on the stated foreign policy direction 'Act East Policy'. India has been vouching for security and growth for all in the region (SAGAR) and envisages a "free, open, inclusive, peaceful, and prosperous Indo-

This highlights the key priority areas for India's engagement with and beyond the region amid an aggressive China. Prime Minister Narendra Modi in 2019 announced Indo-Pacific Ocean's initiative during the East Asia Summit and outlined seven pillars of cooperation between the member countries, focused towards a safe, secure, open maritime region.

The East Asia summit (EAS) is an annual forum at a leadership level summit for 18 countries from East, Southeast and South Asia. The EAS is an important forum for dialogue for the Indo-Pacific region as it places ASEAN at its focal point of leadership and member nations, including the US, Japan, China, Australia, Russia, and India gets a platform for articulating their priorities for the region.

In India's vision of the Indo-Pacific, it envisages EAS members to pick on the seven pillars, and many like Australia, France, Singapore, and the UK have announced their willingness to lead the verticals.

At the plurilateral level, India has in May 2022 joined as the founding partner of the US-led Indo Pacific Economic framework (IPEF). This regional arrangement primarily aims to contain China's military economic influence in the Indo Pacific region. The four pillars of cooperation amongst the 14 member IPEF rests on trade, clean energy, supply chains and tax and anti-corruption.

While details regarding the IPEF, a basic text for agreement and negotiation between the members, are still some time away, India could use its relationship with the US to bring the forum and the EAS vision for the Indo Pacific region closer. It might be argued that given China and Russia's presence in the EAS, alignment between the IPEF and the EAS might be impossible, but it can still be worth a try.

The Quad should be propped up judiciously towards furthering India's Indo-Pacific strategy. It can assume a key role in the Indo-Pacific strategy.

MLAs quitting in last year of term unethical



The Telangana by-poll for Munugodu seat when Assembly polls are less than a year away defies logic

et another Assembly by-election in Telangana is in the offing. When Assembly elections are due in Telangana in about a year from now, Munugodu legislative constituency MLA resigned, causing perhaps an expensive by-poll on the exchequer, as well as on the contesting candidates and political parties. For reasons best known to them, some legislators in the recent past are choosing to resign from their respective seats at will and pleasure before completion of their terms and quit the party from which they were elected.

Political analysts term this trend as attempts to gain personal political benefit rather for any ideological preferences. This leads to a byelection for the seat vacated and sometimes a few months before the completion of tenure of legislature. If byelection is delayed, the elected MLA will be hardly left with six months or less to serve and may not even get a chance to sit in the House.

The legislator who resorts to resignation does not sense that it is a rare privilege and honour bestowed on him by the voters to sit in the prestigious legislative Assembly for a period of five years and resigning before completion of tenure is unethical, illogical and shirking the responsibility. It has also become a known practice that the individual who vacates the seat contests again on a different party ticket.

What is the rationale to resign and contest again is an unanswered question. Some national parties admit them overnight and offer party tickets with a one-point agenda of defeating the opponent, generally of a popular regional party. The morals of earlier days to give tickets after a long wait are no longer observed.

An individual normally resigns to a position he or she is holding in order to take a more challenging assignment and not for an equal or lower than the present one. Lack of opportunities for advancement and feeling disrespected in the present position are also the reasons for tendering resignation. This in effect is not happening in the resignations of the majority of legislators of late. Resigning in a professional and polite way on good terms rather than blaming the organization that he or she is leaving often in unparliamentary language has also become an unhealthy feature which is highly deplorable.

Unfortunately, the majority of legis lators who resort to resignation give reasons which are not palatable. For instance, differences with the party president or not being placed in a high position in the party, or not given a minister's berth or not getting an appointment with top leaders or not being recognized, etc., are not

ted the resignations. Five YSR Congress Party MPs resigned in April 2018 over the failure of the Centre to grant Special Category Status to Andhra Pradesh. These were examples of resignations for a cause and not for individual political gains. One of the best examples is that of Neelam Sanjiva Reddy who resigned twice in 1969 and 1977 as an MP to contest as President of India; that was a challenging assignment, once as congress candidate and afterwards as a consensus candidate.

India models its democracy in Britain. Resignation from the House of Commons has never been allowed in Britain in theory. Technically Members of Parliament sitting in the House of Commons are not permitted to resign from their seats but can only be disqualified or lose an election for which tnere is a weii iaid down procedure.

To circumvent this, MPs who wish to step down are instead appointed to an 'Office of profit under the Crown, which disqualifies them from sitting in Parliament. For this purpose, a legal fiction is maintained where two unpaid offices are considered to be offices of profit: Steward and Bailiff of the Chiltern Hundreds, and Steward and Bailiff of the Manor of North stead.

The US Constitution explicitly

provides for the resignation of senators, but, curiously, it does not say anything about resigning from the House of Representatives. If a vacancy occurs due to a senator's death, resignation, or expulsion, state legislatures empower the Governor to appoint a replacement to complete the term or to hold office until a special election can take place. The Governor of the represented state may immediately appoint a successor. Since special elections cost taxpayers, activists even suggested that the retiring member should cover the costs of the election.

Every rule of law can be traced to a statute or a judicial decision, but conventions cannot be traced to any particular regulation. There are clear consequences for a violation of a rule of law, but a breach of a convention attracts no consequence. A rule of law can be amended but a convention cannot be amended. Although there are conventions in the society, what determines whether a thing is properly done or not is not the convention but the prevailing rule of law as regards that subject matter.

The constitutional structure of India is based largely on the Westminster model of parliamentary system. Indian and the UK systems of traditions, conventions and procedures in a way are similar since both the countries follow parliamentary form of democracy. While India has adopted most of the rules, regulations and conventions of the United Kingdom Parliament, it has failed to follow the spirit and the basic tenets of constitutional morality and propriety of an elected member resigning his post in the middle of his

There is, however, always something new about Westminster and, hence, it is something that might be a good idea to adopt in India. Unfortunately, the conventions guiding resignations of lawmakers are not properly spelt out yet.
In the election law as it stands

now in India, there is no bar on a lawmaker resigning his or her seat before completion of tenure of Assembly or Lok Sabha and then contesting the byelection to fill up the vacancy caused by his or her resignation. It is high time that in India frequent resignations of legislators and Parliament members purely to gain political interests and without any ideological compulsions be avoided either by law on the British model or by convention.

This not only puts an end to

political hopping by those who frequently change parties but also helps in doing away with huge costs that are incurred for the frequent elections. Alternatively it may be considered to empower the Speaker to appoint a replacement to compiete the term of the legislator who resigned. Let the law also be amended so as not to allow a person to contest from more than one constituency. Further, the Election Commission should consider the British practice of no-resignation of a person once elected.

But will this ever happen in our country, which is supposed to be the largest democracy but where all the democratic, ethical and moral norms are slowly and steadily thrown to the winds?

How do we know when a recession has begun?

The US economy is contracting for the last six months. Can we say it is in recession? Some signs to ponder over...

he US government on Thursday updated its estimate of the U.S. economy's performance in the April-June quarter and confirmed what it had reported last month: That the economy shrank for two straight quarters.

Six months of contraction is a long-held informal definition of a recession. Yet nothing is simple in the post-pandemic economy. Growth may be negative, but the job market is strong. The economy's direction has confounded Federal Reserve policymakers and many private economists since growth screeched to a halt in March 2020 as COVID-19 struck and 20 million Americans were suddenly thrown out of work.

Even as the economy shrank over the first half of this year,

employers added 2.7 million The pain is being felt disproporjobs — more than in most entire years before the pandemic struck. In July, the economy added over a half-million more jobs. The unemployment rate sank to 3.5%, a half-century low. Robust hiring and exceedingly low unemployment aren't consistent with a recession.

While most economists and Fed Chair Jerome Powell have said they don't think the economy is in recession, some analysts still predict that an economic downturn will begin later this year or next.

Either way, inflation remains near its highest level in four decades, though gas costs and other prices have eased in recent weeks. Inflation is still so high that despite pay raises many have received, Americans' purchasing power is eroding. tionately by lower-income and Black and Hispanic households, many of whom are struggling to pay for higher-cost essentials like food, gas, and rent.

Compounding those pressures, the Fed is jacking up interest rates at the fastest pace since the early 1980s, thereby magnifying borrowing costs for homes and cars, and credit card purchases. As a result, regardless of whether a recession has officially begun, Americans have soured on the economy.

So how, exactly, do we know when an economy is in a recession? Here are some answers to such questions: WHO DECIDES IF IT IS A RECESSION

Recessions are officially declared by the obscure-sounding National Bureau of

economists whose Business Cycle Dating Committee defines a recession as "a significant decline in economic activity that is spread across the economy and lasts more than a few months.

The committee considers trends in hiring as a key measure in determining recessions. It also assesses many other data points, including gauges of income, employment, inflationadjusted spending, retail sales and factory output. It puts heavy weight on jobs and a gauge of inflation-adjusted income that excludes government support payments like Social Security. DO SOME PEOPLE KNOW IF IT IS COMING

Yes, because many people now feel more financially burdened. With wage gains trailing

Economic Research, a group of inflation for most people, higher prices for such essentials as gas, food, and rent have eroded

Americans' spending power. Walmart has reported that higher gas and food costs have forced its shoppers to reduce their purchases of discretionary spending such as new clothing, a clear sign that consumer spending, the leading driver of the economy, is weakening. The nation's largest retailer, Walmart has reduced its profit outlook and said it would have to discount more items like furniture and electronics.

SIGNS OF AN IMPENDING RECESSION

The clearest signal that a recession is underway, economists say, would be a steady rise in job losses and a surge in unemployment. In the past, an increase in the unemployment rate of three-tenths of a percentage point, on average over the previous three months, has meant that a recession will soon

Many economists monitor the number of people who seek unemployment benefits each week, which indicates whether layoffs are worsening. Weekly applications for jobless aid, averaged over the past four weeks, are just below 250,000, the highest level since last November. Though that is a potentially concerning sign, it is still a low level historically.

THE FED KEEP RAISING

The economy's flashing signals — slowing growth with strong hiring — have put the Fed in a tough spot. Chair Jerome Powell is aiming for a "soft landing," in which the economy

weakens enough to slow hiring and wage growth without causing a recession and brings inflation back to the Fed's 2% target.

But Powell has acknowledged that such an outcome has grown more difficult to achieve. Russia's invasion of Ukraine and China's COVID-19 lockdown have driven up prices for energy food, and many manufactured parts in the U.S.

Powell has also indicated that if necessary, the Fed will keep raising rates even amid a weak eco nomy if that's what's needed to tame inflation.

"Is there a risk that we would go too far?" Powell said recently. "Certainly there's a risk, but I wouldn't agree that's the biggest risk to the economy. The biggest mistake to make...would be to fail to

station attack in **Ukraine rises to 25**

■ he death toll from a Russian rocket attack as Ukraine observed its Independence Day has risen to 25, including an 11-year-old boy found under the rubble of a house and a 6year-old killed in a car fire near a train station that was the target, a Ukrainian official said on Thursday.

Russia's Defence Ministry said its forces used an Iskander missile to strike a military train that was carrying Ukrainian troops and equipment to the front line in eastern Ûkraine. The ministry claimed more than 200 reservists "were destroyed on their way to the combat zone."

The deputy head of the Ukrainian presidential office, Kyrylo Tymoshenko, did not say if the 25 victims he reported from Wednesday's attack all were civilians. A total of 31 people sustained injuries, he said.

The lethal strike in Chaplyne, a town of about 3,500 residents in the central Dnipropetrovsk region nonetheless served as a brutally painful reminder that Russia's military force is causing civilians to suffer and testing Ukraine's resilience after six months of a grinding war.

In Geneva on Thursday, the UN's human rights chief, Michelle Bachelet, decried the time since Russian President Vladimir Putin sent troops into the neighbouring country as "unimaginably horrifying." She called on Putin

Russia's invasion on Wednesday.

Tetyana Kvitnytska, deputy head of the Dnipropetrovsk regional health department, said

the people wounded in the attack suffered a range of injuries.

There are craniocerebral injuries, limb fractures, many patients with explosive and shrapnel injuries, burns," she said. "People were in a difficult condition, both physically and psychologically.'

Russian Defence Minister Sergei Shoigu, speaking Wednesday at a meeting of his counterparts from a security organisation dominated by Russia and China, said Russia was carrying out strikes with precision weapons against Ukrainian military targets, and "everything is done to avoid civilian casualties.

"Undoubtedly, it slows down the pace of the offensive, but we do it deliberately," he said. It was the second time Shoigu has made such

a claim; he said the same thing in late May. Elsewhere in Ukraine, three people were killed in the eastern region of Donetsk on Wednesday and one more was wounded, Gov. Pavlo Kyrylenko said on Telegram.

Nikopol, a city across the river from the Zaporizhzhia Nuclear Power Plant, came under more Russian shelling overnight, Valentyn Reznichenko, the governor of the Dnipropetrovsk region, said.

Death toll from train 'World's future being decided in Ukraine'

As his country celebrates its 1991 independence from the former Soviet Union, "everyone can see how much the world is dependent on our independence," Zelenskyy said.



S Korea signs \$2.25 bn deal with Russia nuclear company

Couth Korea has signed a 3 **S**trillion won (\$2.25 billion) deal with a Russian state-run nuclear energy company to provide components for Egypt's

first nuclear power plant. South Korea's government said Thursday the contract between the state-run Korea Hydro and Nuclear Power and ASE requires the South Koreans to provide turbine-related equipment and construction work for the plant being built in Dabaa, about 130 km (80 miles) northwest of Cairo on the Mediterranean coast.

ASE is a subsidiary of Rosatom, a state-owned Russian nuclear conglomerate.

A senior aide of South Korean President Yoon Suk Yeol said the negotiations were slowed by "unexpected variables," mainly Russia's war on Ukraine and the US-led sanctions campaign against Moscow over its aggression.

Choi Sang-mok, Yoon's senior secretary for economic affairs, said South Korea provided an explanation to the United States in advance about its plans to participate in the Dabaa project and that the allies will maintain close consultation as the work proceeds.

South Korea has been participating in economic pressure campaign against Russia orchestrated by the Biden administration, ending transactions with Russia's central bank and sovereign wealth funds and banning the exports

of strategic materials to Russia. Choi did not specify how the crisis in Ukraine and the sanctions on Moscow caused difficulties for the negotiations between Korea Hydro and Nuclear Power and ASE, which has a contract with Egypt to build four 1,200 megawatt reac-

He stressed there's no possibility that the technologies being supplied by South Korea to the project would clash with international sanctions against

"Any kind of issue can be met by various uncertainties, but those have all been resolved as of now, and that's why we were able to finalize the agree-

ment," Choi said. He expressed hope that South Korea's participation in the Dabaa project would help the country gain a foothold in future nuclear projects across Africa and also improve its chances to export to countries such as the Czech Republic,

Poland and Saudi Arabia. Korea Hvdro and Nuclear Power had been engaging in negotiations with ASE as the preferred bidder for the turoine-related project since December, before Russia's invasion of Ukraine in February this

Yoon's office said the participation in the Dabaa project is the country's biggest export of nuclear power technology since 2009, when a South Korean-led consortium won a \$20 billion contract to build nuclear power reactors in the United Ârab Emirates.

Yoon, a conservative who took office in May, has pledged to boost South Korean exports of nuclear power technology, which he insists were dented under the policies of his liberal predecessor, Moon Jae-in, who sought to reduce the country's domestic dependence on nuclear energy.

Yoon in a statement on Facebook said the deal reaffirms South Korea's "advanced technology and safeness and strong supply chains" in the nuclear power industry. His government has set a goal of exporting 10 nuclear power

Ukrainian fears run high over fighting near N-plant Russians are capable of intentionally

Tkrainians are once again anxious and alarmed about the fate of a nuclear power plant in a land that was home to the world's worst atomic accident in 1986 at Chernobyl. The Zaporizhzhia nuclear plant,

Europe's largest, has been occupied by Russian forces since the early days of the war, and continued fighting near the facility has heightened fears of a catastrophe that could affect nearby towns in southern Ukraine — or potentially an even wider region. The government in Kyiv alleges

Russia is essentially holding the Soviet-era nuclear plant hostage, storing weapons there and launching attacks from around it, while Moscow accuses Ukraine of recklessly firing on the facility, which is located in the city of Enerhodar.

"Anybody who understands nuclear safety issues has been trembling for the last six months," said Mycle Schneider, an independent policy consultant and coordinator of the World Nuclear Industry Status

Ukraine cannot simply shut down its nuclear plants during the war because it is heavily reliant on them, and its 15 reactors at four stations pro-



vide about half of its electricity. Still, an ongoing conflict near a working atomic plant is troubling for many experts who fear that a damaged facil-

ity could lead to a disaster. That fear is palpable just across the Dnieper River in Nikopol, where residents have been under nearly constant Russian shelling since July

The more immediate concern is that a disruption of electricity supply to the plant could knock out cooling systems that are essential for the safe operation of the reactors, and emergency diesel generators are sometimes unreliable. The pools where spent fuel rods are kept to be cooled also are vulnerable to shelling, which could cause the release of radioactive material.

Kyiv told the International Atomic Energy Agency, the UN's nuclear watchdog, that shelling earlier this week damaged transformers at a nearby conventional power plant, disrupting electricity supplies to the

Zaporizhzhia plant for several hours. These incidents show why the

IAEA must be able to send a mission to the Zaporizhzhia nuclear power plant very soon," said the agency's head, Rafael Mariano Grossi, adding that he expected that to happen "within the next few days, if ongoing

negotiations succeed". At a UN Security Council meeting Tuesday, UN political chief Rosemary DiCarlo urged the withdrawal of all military personnel and equipment from the plant and an agreement on a demilitarised zone around it. Currently only one of the plant's four power lines connecting it to the grid is operational, the agency said. External power is essential not iust to cool the two reactors still in operation but also the spent radioactive fuel stored in special facilities

"If we lose the last one, we are at the total mercy of emergency power generators," said Najmedin Meshkati, a professor of civil and environmental engineering at the University of Southern California.

He and Schneider expressed concern that the occupation of the plant by Russian forces is also hampering safety inspections and the replacement of critical parts, and is putting severe strain on hundreds of Ukrainian staff who operate the facility.

S military airstrikes in eastern Syria were a message to Iran and Tehranbacked militias that targeted American troops this month and several other times over the past year, the Pentagon said Wednesday

Colin Kahl, the undersecretary of defense for policy, told reporters that the US airstrikes overnight on facilities used by "the United States will not hesitate to defend itself against Iranian and Iran-backed aggression when it occurs.

He said the US decision to launch the strikes was based on both the nature of the militia attacks on August 15 at the al-Tanf Garrison, where US troops are based in the south, and the fact that, based on recovered drone parts, "we believe we have Iran dead to rights on attribution.'

Hours after the US strikes, two US military locations in northeastern Syria near large oil and gas fields were hit with rocket fire. According to US Central Command, the rockets hit near Green Village and the Conoco gas field in Deir el-Zour. One US service member was treated for a minor injury and has been returned to duty. and two others were under evaluation for minor injuries.



CENTCOM said US forces responded by destroying three vehicles and equipment used to launch some of the rockets, killing "two or three suspected Iran-backed militants."

The opposition war monitor the Syrian Observatory for Human Rights and Deir Ezzor 24 said the U.S. Airstrikes targeted the Ayash Camp run by the Fatimiyoun group made up Shiite fighters from Afghanistan. The war monitor reported that at least six Syrian and foreign militants were killed in the airstrikes, while Deir Ezzor 24 reported 10 deaths.

Deir el-Zour is a strategic province that borders Iraq and contains oil fields. Iran-backed militia groups and Syrian forces control the area and have often been the target of Israeli war planes in previous strikes.

In Iran, Foreign Ministry spokesman Nasser Kanaani issued a statement condemning the American strike "against the people and infrastructure of Syria." He denied Iran had any link to those targeted.

Iran routinely denies arming militia groups that target US forces in the region, despite weaponry linking back to them. Kahl said the US strikes

underscore that while the US continues to pursue negotiations with Iran to resume its compliance with the 2015 nuclear deal, those talks are not connected at all to America's willingness to take against when attacked.

The threats that they engage in against our people in the region or elsewhere, are not linked to wherever we end up on the nuclear deal," said Kahl. "It actually has nothing to do with our willingness and resolve to defend ourselves. And I think the strike last night was a pretty clear communication to the Iranians that these things are are all on different tracks

US: Airstrikes in Syria to Rohingyas mark 5th anniv of exodus to Bangladesh

Hundreds of thousands of Rohingya refugees on Thursday marked the fifth anniversary of their exodus from Myanmar to Bangladesh, while the United States, European Union and other Western nations pledged to continue supporting the refugees' pursuit of justice in international courts. Bangladesh is hosting more

than 1 million Rohingya refugees who fled from Myanmar over decades, including some 740,000 who crossed the border in August 2017 after the Myanmar military launched a "clearance operation" against them following attacks by a rebel group. The



safety situation in Myanmar has worsened since a military takeover last year, and attempts to send them back failed.

In March, the United States said the oppression of

Rohingya in Myanmar amounts to genocide after authorities confirmed accounts of mass atrocities against civilians by Myanmar's military in a widespread and systematic

minority. Muslim Rohingya face widespread discrimination in Buddhist-majority Myanmar, where most are denied citizenship and many other rights.

Bangladeshi officials have expressed frustration over the repatriation of the refugees to Myanmar after at least two attempts to send them back failed since 2017, but Prime Minister Sheikh Hasina said that their repatriation to their own land is the only solution to the crisis.

On the eve of the anniversary, Bangladesh Home Minister Asaduzzaman Khan said in a statement that his country wants the refugees to return to Myanmar safely.

More than a year after the Taliban takeover that saw thousands of Afghans rushing to Kabul's international airport amid the chaotic US withdrawal, Afghans at risk who failed to get on evacuation flights say they are still strug-gling to find safe and legal ways

out of the country.

Among those left behind is a 49-year-old interpreter who worked for a NATO contractor in 2010 accompanying convoys in Kandahar. Only six days after the Taliban reached the capital last August, they came looking for him. 'They come to my house

and they threatened my son and my wife (when) I was not at home. They (then) destroy my office," he told AP via WhatsApp referring to the place where he taught English. He asked that his name not be revealed for security reasons. This month, he was inter-

rogated by the Taliban again for more than two hours.

During the chaotic days of the US pullout, he had tried several times to reach Kabul Airport but, like many, failed to get through massive crowds made even more dangerous by attacks around the airport that killed dozens. He then tried to leave Afghanistan by crossing the land border with Pakistan but was stopped by the Taliban who demanded \$700 per person to cross - money he did not have. To make matters worse, his passport is no longer valid.

The number of monkeypox 🛘 cases reported globally dropped by 21% in the last week, reversing a month-long trend of rising infections and a possible signal the outbreak in Europe may be starting to decline, according to a World Health Organisation report issued Thursday.

The UN health agency reported 5,907 new weekly cases and said two countries, Iran and Indonesia, reported their first cases. To date, more than 45,000 cases have been reported in 98 countries since late April.

Cases in the Americas accounted for 60% of cases in the past month, WHO said, while cases in Europe comprised about 38%. It said infections in the Americas showed "a continuing steep rise". In early July, just weeks

before the agency declared the international spread of the disease to be a global emergency, WHO's Europe director said countries in the region were responsible for 90% of all laboratory confirmed cases of mon-British health authorities

patients was known, 45% were nfected with HIV.

WHO has recommended that men at high risk of the disease temporarily consider reducing their number of sex partners or refrain from group or anonymous sex.

Monkeypox typically requires skin-to-skin or skin-tomouth contact with an infected patient's lesions to spread. People can also become infected through contact with the clothing or bedsheets of someone who has monkeypox

Bank credit growth accelerates to 14.2% in June quarter: RBI data

m ank}$ credit growth accelerated to 14.2 per cent in the quarter ended June 2022 from 6 per cent in the same period of the previous year, RBI data showed on Thursday.

In the quarter ended March 2022, bank credit had expanded by 10.8 per cent.

The Reserve Bank of India (RBI) on Thursday released the 'Quarterly Statistics on Deposits and Credit of SCBs for June 2022'. This data is collected from all scheduled commercial banks (SCBs), which include regional rural banks (RRBs), small finance banks (SFBs) and payments banks (PBs).

"Credit growth has been broad-based: all the population groups (i.E., rural, semi-urban, urban and metropolitan), all the bank groups (i.E., public/private sector banks, foreign banks, RRBs and SFBs) and all the regions of the country (i.E., central, eastern, north-eastern, northern, southern and western) recorded double-digit annual credit growth in June

2022," as per the data. Aggregate deposit growth (year-on-year) has remained in the range 9.5 - 10.2 per cent

during the last five quarters. Metropolitan branches continue to account for over half of the bank deposits and their share increased marginally over the last one year.

The share of current account and savings account (CASA) deposits in total deposits has been increasing over the last three years (42 per cent in June 2020, 43.8 per cent in June 2021 and 44.5 per cent in June 2022).

As credit growth is outpacing deposit growth in the recent period, credit-deposit (C-D) ratio has been on the

rise, the data showed. In June 2022, C-D ratio stood at 73.5 per cent at all-India level (70.5 per cent a year ago) and 86.2 per cent for metropolitan branches of banks (84.3 per cent a year ago).

Based on in-depth interviews with 50 SaaS promoters and funders from early stage to Series E and beyond, the study highlights operational characteristics owing to which the Indian SaaS industry is growing at an accelerated pace, an EY statement said on Thursday.

Over 80 per cent of the SaaS promoters who contributed to the report feel there is the need to build a robust talent pool; 50 per cent of SaaS providers feel driving greater awareness for SaaS products continues to be a prerequisite for customer acquisition, it said. India is poised to become the global SaaS capital over the next few years, mainly driven by Small and Medium Businesses with a focus on large enterprises.

SaaS providers are also tomer acquisition, retention, and success strategies by upselling and cross selling to existing customers.

To enhance customer maturity levels, large delivery teams are being deployed to onboard, train and support customers throughout the product life cycle, it was stat-

One-third of the SaaS providers are being increasingly cautious with their go-tomarket strategy and mainly targeting niche segments to acquire marquee clients by understanding new digital buying preferences of the customers, following a digitalfirst approach and offering innovative pricing models.

Technology Sector Leader, EY India, Nitin Bhatt, said, "Macro-economic environment notwithstanding, the funding activity in the first two quarters of this year surpassed tĥe funding activity in 2021 – which was a breakout year with over USD 4.3 billion in funding for SaaS start-ups.'



In the end, the 26-year-old Ongbamrungphan, who has now won the last five matches against Saina, had seven match points as she sealed her quarterfinal berth.

The unseeded Indian duo of Arjun and Kapila had to toil hard for 58 minutes as it came from behind

to win the round of 16 clash against Terry Hee and Loh Kean Hean of Singapore 18-21, 21-15, 21-16.

Foreign citizens who have not been vaccinated against COVID-19 are currently unable to enter the US or Canada, and Djokovic has said he won't get the shots, even if that prevents him from playing in certain tour-

The US Tennis Association has

rules about vaccination status for this year's Open. There is no vaccine mandate at the tournament for players or their support teams — meaning that an unvaccinated American would be allowed to compete. Djokovic missed the Australian

Open in January after a protracted legal saga ended with his deportation from that country because he isn't vaccinated against COVID-19. He also sat out four significant tournaments in North America in 2022, including in Montreal and Cincinnati recently.

He did play in the French Open, where he lost in the quarterfinals to Nadal, and at Wimbledon, where Djokovic won the title.
