## **Pratibha leads HP CM** race; Gandhis to decide

Cong won in name of Virbhadra, so it should choose CM from family: Singh

After day-long parleys, a meeting of the Congress Legislature Party in Himachal Pradesh passed a resolution authorising the party high command to pick the CLP leader who will be the next Chief Minister of the State.

Sources indicated the "high command" means Congress' first family Sonia Gandhi, Rahul Gandhi, and Priyanka Gandhi.

president Congress Mallikarjun Kharge said views of newly-elected MLAs in Himachal Pradesh are being sought to bring out consensus on who will be their leader.

Sources said front runner for the top job is Pratibha Singh, Congress MP and the wife of former Chief Minister Virbhadra Singh.

While interacting with the media, she indicated she is in the race for the top job. Congress workers raised slogans in support of Singh, who is also the State party chief.

He added that "collective will of MLAs will be kept in mind and then observers will convey the same to the high command".

## Mayor from AAP as it got mandate, says BJP

#### **BJP** will play role of strong **Opposition, says** party Delhi chief

Taking U-turn from their position on the election of the Delhi Mayor after their defeat in the MCD polls, the Delhi BJP on Friday said the next Mayor will be from the AAP as it got the majority and the BJP will play the role of a "strong Opposition".

The AAP has got the peoples' mandate, so they can have their mayor. We extend them good wishes," Delhi BJP chief Adarsh Gupta said when asked if his party would contest the mayoral poll. He was addressing a Press conference with Leader of Opposition the Delhi Assembly Ramvir Singh

"The vote percentage of the BJP has increased by around three per cent since the last municipal corporation elec-tions of 2017 when the party got 36.08 per cent of the votes, Gupta added. He also said the BJP secured around 40 per cent of the votes, losing by just over 2 percentage points.

Despite the AAP's overwhelming win in the national Capital, the BJP had suggested that the mayor's election is still an "open game". It noted that Chandigarh, where the



BJP's IT department head Amit Malviya thanked Delhi people for reposing faith in the BJP and for giving more votes in the wards falling under Kejriwal's "corrupt" Ministers' constituencies.

He added in a tweet, "Now over to electing a Mayor for Delhi. It will all depend on who can hold the numbers in a close contest, which way the nominated councillors vote, etc. Chandigarh has a BJP mayor,

for instance." Hints dropped by other arty leaders, including Manjinder Singh Sirsa and Tajinder Pal Bagga, also gave rise to speculation that the BJP might go for the mayor's

"The AAP has been exposed in these elections due to anti-corruption campaign run by the BJP. The people of the Assembly constituency from Deputy Chief Minister Manish Sisodia and Minister Satyendra Jain have rejected them due to friendship with liquor mafia and hawala business respectively," claimed

However, Leader of Opposition Bidhuri said that the tall claims of Chief Minister Kejriwal that the BJP will shrink to only 20 seats once again turns to dust.

The MCD mayor is elected by all 250 councillors in the House, seven Lok Sabha and three Rajya Sabha members from the city, and 14 MLAs nominated by the Speaker of the Delhi Assembly.

## member's Bill on Uniform Civil Code

Bill will destroy social fabric: Opp; RS Chairman calls for division, Bill introduction OK'd with 63 votes in favour, 23 against

The introduction of a private ■ member Bill by a BJP member for the preparation and implementation of the Uniform Civil Code (UCC) across the country resulted in chaos in the Rajya Sabha on Friday. The Opposition members urged BJP MP Kirodi Lal Meena to withdraw the Bill and also asked Chairman Jagdeep Dhankhar to not accept the legislation as it will destroy the secular fabric of the country.

The controversial private member's Bill seeks to provide for a panel to prepare a UCC. BJP MP Kirodi Lal Meena moved for leave to introduce the Bill to provide for the constitution of the national inspection and investigation committee for preparation of a UCC and its implementation across India and for matters connected therewith during the private member's business.

However, Opposition members from Trinamool (TMC),Marumalarchi Dravida Kazhagam (MDMK), Rashtriya Janata Dadl (RJD), Samajwadi Party (SP), Communist Party of India (CPI), CPI (Marxist), Nationalist Congress Party (NCP), and Congress protested against the introduction of the Bill saying, if passed, it will "destroy" the social fabric and unity in diversity that is preva-

lent in the country. With the Opposition members seeking withdrawal of the Bill, Rajya Sabha Chairman Jagdeep Dhankhar called for division and the motion for the PNS BHUBANESWAR

and 23 against it. In the past, although the Bill was listed for introduction, it was not moved in the Upper House. The Bill envisages a collection of laws to protect the personal rights of all citizens without considering religion.

He further said, There is still time to refrain from making demonstrations of a temporary majority and inflict one sided opinion on a y secular and plural India."

MDMK MP Vaiko accused the ruling dispensation of "implementing one after another agenda of the RSS and the BJP", and said, "They have finished Kashmir. Now they have come to Common Civil Code." He said it is leading towards "disaster of the country and its disintegration and minority people are terribly

Similarly, Abdul Wahab Indian Union Muslim League (IUML) said the Bill been attempted to be introduced many times in the past and "this is a sort of provocation deliberately the BJP" and asserted that the UCC cannot be implemented

Leader of the House Piyush Goyal objected to the allegations of the Opposition members. "It is a legitimate right of a member to raise an issue, which is a directive principle of the Constitution... Let this subject be debated in the House. At this stage to cast aspersion on the Government, to use the names of the very members of the Constituent Assembly to try to criticise at the introduction stage is uncalled for," he retorted.

## Boys, fathers punished in Kangaroo court

#### Victim attempts suicide; 2 detained

**I**n a case of Kangaroo court justice in the capital city, two minor boys were forced to kneel down as punishment for allegedly passing comments

on some schoolgirls. Besides, the two boys, their fathers were also asked to kneel down and do sit-ups.

The incident occurred at Baramunda village under the Khandagiri police station on Thursday.

Later, one of the boys who were made to kneel down attempted suicide by consuming phenyl. He was admitted to the Capital Hospital in a critical condition.

Based on the complaint of the father of one of the boys, the Khandagiri police con-



ducted a midnight raid and picked up two persons from the village and interrogated

The complainant Suresh Taranga said his nephews, who are Class-X students of the Baramunda High School, used to spend their time near a gymnasium. They had an argument over some other boys over a petty issue. Later, a club president interfered and called a meeting of Baramunda vil-

nephew and brother to kneel down in the presence of others. When he reached the spot, he was also forced to kneel down on the road and asked to do sit-ups. A video of the incident was also shot and made viral, Taranga said.

The Khandagiri PS IIC said the incident was unfortunate and two persons have been detained. A probe was on to find out who made the video viral and action would be taken against those found

## HC directs senior cop for fresh training

**I**n a significant ruling, the Orissa High Court has directed an Inspector of Police to undergo fresh sensitisation training for one month at the Biju Patnaik Police Academy in Bhubaneswar for refusing to register an FIR in a murder

The inspector has also been banned from any field posting for one year, the High Court ordered, stating that the inaction shown by Inspectorin-Charge (IIC) of Infocity police station in Bhubaneswar Samita Mishra is highly deplorable. The court observed



that institutional lethargy has crept into the system.

The case, among other things, pertains to the alleged murder of one Anand Toppo (33), a childhood friend of former international hockey player Birendra Lakra. On February 28 this year, Birendra informed Anand's father Bandhana over telephone that Anand was found unconand he (Birendra) was taking him to hospital. But next day when Bandhana reached Bhubaneswar from Rourkela, he was told that Anand had committed suicide. Since there was no suicide note and injury marks were seen on Anand's body, Bandhana suspected foul play and blamed Birendra for the death of his

When his repeated pleas to police to register an FIR in this case went in vain, he approached the High Court in October to assign the investigation of the murder case to either CID, Crime Branch podent investigating agency accusing the Bhubaneswar police of shielding Birendra, who once served as a Deputy SP. ## 35,144 e-challans issued for MV Act violation

5,868 DLs suspended; 1,275 vehicles seized CUTTACK

The State Transport Authority (STA) has launched a two-month-long special enforcement drive from November 1 to promote safety, reduce accidents and fatalities throughout the State.

In November, a total of 35,144 e-challans were issued against vehicles who openly disregard Motor Vehicle (MV) licences (DLs) were confiscated for suspension and 1,275 vehicles were seized in a month.

The enforcement drive is focused on driving without helmet and seat belt, drunken driving, over speeding, use of mobile phone while driving, driving by juveniles, checking of road worthiness of the vehicle, wrong side driving, driving without registration mark and dangerous parking.

Fines have been imposed for various offences. A total of 9,416 challans were issued for In the ongoing drive, a total of 15, 661 challans were issued in November for driving twowheelers without helmet.

Due to continuous enforcement activities people are using helmets in the urban areas but are unfortunately avoiding wearing helmets on highways where protection is much more needed. Around 622 challans were issued for triple riding and 225 for wrong side driving. A total of 38 challans were issued for underage driving.

A total of 1,452 people were found driving without seatbelt and challan was issued accordingly. Similarly, a total of 1,423 people were detected driving under the influence of alcohol and were penalised as per the rules.

Total 719 people were fined for using mobile phones while driving. So far, 366 vehicles engaged in transporting school students in the State were penalised for flouting road safety rules.

## **Matter of concern in Sundargarh** Spears made with flambeau to drive away jumbos

SUNDARGARH

Residents of the villages in forest areas under Kutra block and Badagaon Range of Sundargarh spend sleepless nights every year to save their crops and lives from elephants' rampage. So, they have prepared spears with flambeau to tackle the jumbo menace this year.

"As forest officials are not proactive, we have been facing crop losses year after year. The Forest Department is not restoring water bodies in nearby areas and not growing sufficient trees for the elephants," locals alleged.

On the other hand, the making of spears with flambeau has raised serious concern among animal lovers.

After the inflammable

flambeau of a spear is ignited, the villagers throw it at the elephants to drive them away. It often pierces into the bodies of jumbos and causes burn injuries. The wounds caused due to hot iron head of the spear give intense pain; hence, the wandering elephants immediately leave a human settlement and return to their wild habitats. Even to the extent, the burn wounds develop severe infections leading to untimely jumbo deaths, an animal lover stated.

Amid the perennial issue of human-elephant conflict, many animal lovers have demanded action against wrongdoer villagers. They insist that the Forest Department should make arrangements to regularly drive away elephants straying

"The court after examining 15 witnesses and 15 exhibited documents pronounced the judgment today. The court further directed the District Legal Services Authority (DLSA) to pay a compensation of Rs 4 lakh to the victim," said Special Public Prosecutor Pranab Panda.

**≺**he BJD's landslide victory in the Padampur by-election by a margin of over 42,000 votes has not just left the BJP licking its wounds; it too has baffled the poll observers who expected the margin to be narrow, considering that the fight was neck and neck.

But ending all speculations, the BJD retained the seat and avenged on the BJP for the Dhamnagar defeat. Once again, the BJD and Chief Minister Naveen Patnaik reasserted that they are invincible and the Dhamnagar was just an aberration.

Winning the Padampur bypoll for the BJD was important for several reasons. Had it lost the election, the BJD would have suffered a blow that has the potential of upsetting its apple cart in the 2024 simultaneous elections. Numerically, a win or loss in Padampur would be immaterial for the BJD given its brute presence in

the Assembly, but its electoral prospects would have taken a huge

beating ahead. On the contrary, if BJP were the winner, it would strengthen a narrative it built after it won the Dhamnagar bypoll last month of a change Odisha is set to witness after 22 years of BJD rule, swaying the voters' mood in 2024. Probably, the last by-election before the 2024 elections which are less than one and a half years away from now, the Padampur verdict is sure to give a big boost to the BJD and demoralize the BJP if it does not focus on its deficiencies and amend

#### **STRATEGY**

Since the beginning of the campaigning in Padampur, the BJP adopted an aggressive posturing under the leadership of Union Minister Dharmendra Pradhan. The BJP went on levelling a litany of charges against the BJD

Government and CM Naveen Patnaik, concerning farmers' plight, crop insurance payment delay, apathy over railway line from Bargarh to Nuapada via Padampur, upgrading Padampur sub division to a district, distress migration and underdevelopment. But all it did was leaving no stone unturned to put the rival party and its supremo in dock, while washing its hand off the charges, though it was an ally of the BJD Government for nine years and has been in power in the Centre since 2014.

On the contrary, the BJD without complaining against the BJP at least at the scale of the latter, immediately came out with bounties for the people, be it announcement of several development projects worth hundreds of crores, farm input subsidy of Rs 200 crore, Padampur district by 2023, sops for workers in Kendu leaf sector or readiness to provide land for the Bargarh-Padampur-Nuapada railway

The BJD therefore acted smarter than the BJP in creating a positive atmosphere while the BJP only concentrated on negative campaigning. Consequently, the voters found the BJD more reliable. Though Union Agriculture Minister Narendra Singh Tomar released crop insurance money, but the timing was questionable. The farmers who had been long suffering due to constant dillydallying by the insurance firms to release money took it as sheer opportunism by the BJP to reap dividends in the poll-bound Padampur. The BJD added to fuel to the fire when Industry Minister Pratap Deb asked, "Was it necessary for MLA Bijaya Ranjan Singh Bariha to die for the Centre to release crop insurance dues?"

#### LEADERSHIP CLASH

Though seemingly BJP's Pardip Purohit was pitted against BJD's novice Barsha Rani Bariha, the attacking mood of Union Minister Dharmendra Pradhan was indicative of the BJP fighting the Padampur bypoll as a trailer of the

2024 elections. So, the actual fight was between Naveen of BJD and Dharmendra and Co of the BIP. Dharmendra, Union Ministers

Tomar and Railway Minister Aswini Vaishnaw ruthlessly harangued against Naveen and the BJD Government though Naveen was cool and on the defensive. While the BJP tried to disparage Naveen by projecting him as a habitual liar, Naveen in his one liner, "I believe in action not in words" won the heart of millions in his three rallies he addressed just for a day. The mandate he got proved none but Naveen is the tallest and most reliable leader in Odisha.

#### TIT-FOR-TAT

The raid politics by bringing in ED and State GST into the Padampur battleground misfired for the BJP. Many poll observers even ask if it was at all necessary. The ED all of a sudden raided four local businessmen who are supporters of the BJD at a time when the campaigning for the bypoll had attained a feverish pitch. A few hours later, the State GST raided a BIP office bearer and his relatives'

shops and business establishments in Bargarh district. Though the BIPsaid the ED's raid was perfunctory, but again the very timing and the

target strengthened the conviction that it was politically motivated.

The State GST raid against the BJP supporters followed suits, but since the ED raid came first and the GST raid was a backlash, the voters felt that the BJP was going to any extent to win the election.

The BJP used its most potent weapon to win the bypoll when it attacked BJD nominee Barsha on grounds of she being a daughter in- law of a family of Satyabadi in Puri district. Purohit claimed he was a native out and out while Barsha was not. Being married in Puri she would not stay in Padampur if she won, he said.

Bhubameswar MP Aparajita Sarangi too countered BJD on this front, while Sundargarh MP Jual Oram went two steps more by questioning if Barsha was any more a tribal after

her marriage in a non-tribal family. A series of jibes by one after another BJP leaders and a concomitant spectacle of a sobbing Barsha boomeranged for the BJP.

#### **CONGRESS VOTES**

Though the Padampur bypoll was mainly a fight between the BJD and the BJP, still Congress was a force to reckon with. In the 2019 election, the Congress had got over 32,000 votes. But this time, Congress's Satyabhusan Sahu lost his deposit by securing just over 3,000 votes. The BJP said the BJD managed the Congress votes as the vote share of BJP compared to the 2019 election was intact. But why couldn't BJP do it? May be the traditional Congress voters believed CM Naveen Patnaik, who promised to fight for the poor from 'Palli to Delhi.

## India vis-a-vis human rights in global context

ndia has successfully de fended the international pressure on it to ensure freedom of religion and to bring an end to the discrimination against human rights defenders and religious minorities during 41st session of Universal Periodic Review (UPR) held in Geneva. While appreciating the role of human rights defenders, journalists and activists in Indian democratic system, Solicitor-General Tushar Mehta also cautioned theactivities of these groups and individuals that they should be in conformity with the law of the land.

Earlier, the UPR has reviewed India for three times which took place in April 2008, May 2012 and May 2017. India has also proved itself a peace loving country and respecting individual rights in different situations at



different periods of time. The recommendations made by different international groups on Indian human rights situation may not be always appropriate to follow due to

pluralistic approach. Since its inception in April 2008, Human Rights Council's

Indian diversities and

UPR has been engaged in reviewing the track records of human rights promotion and protection initiatives of UN member States periodically. It has been found that, all the UN member States have been reviewed thrice within the first, second and third UPR cycles. It is expected that, the recommendations made during reviews, will be followed to respect the human rights in better ways by cementing the loopholes in different laws, policies and practices of the countries. The reviews are based on the documents like the information provided by the State, the reports of independent human rights experts and groups, the information given by human rights treaty bodies and other UN entities and the information provided by

national human rights regional institutions, organizations and civil society

Mostly, the human rights issues are multi dimensional; so the reports of both the Government and civil societies must highlight the core issues of human rights in particular areas and communities by looking at the pros and cons of the issues. The report must also have a mention as to why the Government officials and civil societies fail to implement different development schemes in those areas and failed to maintain law and order.

The perceptions of general public regarding the increasing number of cases in the National Human Rights Commission and different Human Commissions over the years

may not always mean that the law and order in the country has been worsening day by day. Rather it is one of the indications of increasing legal awareness among people and active participation of the media and civil societies. In 2020-2021, the NHRC had registered 74,968 cases of human rights violations, while in 2021-2022, it was as many as 1,11,082 such cases. While answering one of the questions in the Rajya Sabha in December 2021, the Home Ministry had stated that in 2018-2019, Rs 27, 67, 54,996 was recommended by the NHRC to be awarded as monetary relief in 713 cases. The figure was Rs 15, 06, 85,840 for 488 cases in 2019-2020. The NHRC has also reflected in its website that, in 2020-21, Commission recommended monetary

relief/ compensation in 436

cases amounting to Rs 78,725,000 and 537 cases were closed on the receipt of the compliance reports of the payment of relief amounting to Rs 31,47,13,810.

The arithmetic of cases, compensation, procedures, justice and finally human rights confuse the general public in a variety of ways. On the one hand, many of the filed cases are sub-judice in nature and on the other, solution mechanisms in the NHRC are delayed as they need clearance and approval from Government departments.

If we look at the other dimension of human rights, it is a matter of concern that, in the Human Development Index, India ranks 132 out of 191 countries and territories in the world. Since the inception of HDI calculation from the

year 1990, India has never come within 100 ranks. Being the second populous country and seventh largest country in the world, our country is yet to prove its stand to bring an all round development in the country. We are on backfoot in terms of industrialisation, urbanisation, dams and using mines and minerals which are symbols of high employment, per-capita income and better civic facilities. Displacement, rehabilitation, resettlement and loss of indigenous culture have been the core issues of tribal and ethnic assertions putting numerous questions on the human rights policies of the Reforms are necessary to

give justice but not at the cost of national interest. The welfare schemes launched by the Government on income generation, health and

hygiene, education and communication should reach the beneficiaries in true sense and spirit. Collective efforts with humanitarian approach are important for the protection and promotion of human rights. In conflict zones, the human rights reports must contain as to how often the victims are sandwiched by security personnel and naxals. The living conditions, availability of basic amenities like safe drinking water, food and ration supply, housing and livelihood in different projectaffected areas need to be addressed for the sustainability of human rights in letter and spirit. ## **Govt refutes India's poor rank in Global Hunger Index**

The report does not reflect India's true picture as it is a flawed measure of hunger, says Irani

As the Government on Friday in Parliament rejected the Global Hunger Index (GHI) 2022 report placing India at 107th place, Rajya Sabha Chairman Jagdeep Dhankhar urged members to analyse private studies as they can be based on inadequate data or dictated by interests of

He made this observation during the Question Hour in the Upper House when Union Minister Piyush Goyal was replying to a query raised by Jose K Mani(KC(M).

The Chairperson also appealed to members to go through these studies before referring to them while raising any issue. Mani said India's rank was 107 among 121 countries. Neighbouring countries such as Nepal, Pakistan and Sri Lanka are ahead of India in the index and only Afghanistan is behind, he noted.

Though the government has continuously questioned the methodology used in the index, the prevalence of hunger and poverty in the country is well seen, he said.

Stating that there were zero starvation deaths in the country, Goval replied that as regard the hunger index, the name itself is a misnomer.

## **CPI-M** tables Judicial Commission Bill in RS amid Collegium row

A mid the ongoing Collegium row in the country, the CPI(M)'s Bikash Ranjan Bhattacharyya on Friday introduced a private member Bill in the Rajya Sabha seeking to regulate the appointment of judges through the National Judicial Commission. However, it was opposed by AAP MP Raghav Chadha. The National Judicial introduced after the majority of voice votes were in favour of tabling it in the House.

Bhattacharyya moved bill that aims to regulate procedure to be followed by National Judicial Commission for recommending people for appointment as the Chief Justice of India and other judges of the Supreme Court and Chief Justices and other judges of High Courts.

The bill, if approved, will also regulate their transfers and to lay down judicial stan-dards and provide for account-

ability of judges, and establish credible and expedient mechanism for investigating into indi-vidual complaints for misbehaviour or incapacity of a judge of the apex court or of a high court and to regulate procedure for such investigation.

It also proposes for presentation of an address by parliament to the president in relation to proceeding for removal of a judge and for matincidental thereto. AAP member Chadha

pposed the bill, saying concept NJAC has come under consideration of Supreme Court three times in 1993, 1998 and

'All three times, while giving importance to independence of judiciary, the Supreme Court dismissed framework of NJAC. I have stood to oppose NJAC which my honourable colleague has introduced," Chadha said. "We are attempting to do a constitutional impossibility," Chadha said.

### Succession Act. Bacteria in saline water stop chilli fungus: Study

**ARCHANA JYOTI** ■ NEW DELHI

R esearchers from Goa have found that bacteria present in saline water such as salt pans can act as bio-control agents against fungus attacking chilli also known as red/green pepper, an essential component of Îndian cuisine. India is the largest pro-

ducer of chilli (Capsicum annuum) with about 1.7 million tonnes in the world, followed by Thailand and main-

According to M Pawaskar and S. Kerkar from School of Biological Sciences and Biotechnology, Goa University, Goa and KP Krishnan from Department of Arctic Operations, National Centre for Polar and Ocean Research, Goa, twenty one bacteria from 196 isolates showed an inhibitory effect on the growth of the mycelia of fungi that are agricultural common pathogens. The study is published in Current Science. These bacteria, from the Brevibacterium and Bacillus genera, did not show any toxicity in preliminary studies. They were also able to survive and thrive in soil under different ambient conditions, said the study. "The bacteria may serve as biocontrol agents against fungal pathogens in agriculture," the researchers said, suggesting that they can also act as plant growth promoting activity for the chilli.

Percentage wise, today, India contributes to 25 per cent of the world's total production of chillies with Andĥra Pradesh being the largest supplier fol-lowed by Maharashtra, Karnataka, Gujarat and Tamil Nadu. Because of its colour, flavour and pungency, chilli, also known as pepper, is an essential spice in Indian cuisine. The phytochemicals of pepper have a remarkable potential in the history of new bioactive compounds and natural ingredients for agro-food, cosmetic and pharma industry.

However, every year, a considerable loss in the yield of chilli is being observed due to factors including fungus, The authors have recommended further field trials to confirm synergistic effect of the bacteria on the environment, ascertaining their use as sustainable

## HM to meet Maha, K'taka CMs to resolve border row

Union Home Minister Amit Shah will meet the chief ministers of Maharashtra and Karnataka here on December 14 to soothe tempers on the border dispute between the two states, NCP leader Amol Kolhe said here on Friday.

Kolhe was speaking to reporters after a delegation of parliamentarians of the Maharashtra Vikas Aghadi (MVA) — Shiv Sena-NCP-Congress coalition — met Shah to air their grievances on the border dispute.

The MVA delegation also complained to Shah about the "insulting references" to Chhatrapati Shivaji Maharaj by Maharashtra Governor Bhagat Singh Koshiyari and some other BJP leaders.

"The home minister gave us a patient hearing and assured the MVA parliamentarians that he will call chief ministers of Maharashtra and Karnataka on December 14 and work towards finding a cordial solution to the issue," Kolhe, the Lok Sabha member from Shirur in Maharashtra, told reporters here.

On Thursday, the MVA parliamentarians had written to Shah warning that the Karnataka-Maharashtra border row had reached a stage where it could erupt into fullblown violence and had sought



his personal intervention.

In a letter to Shah, they claimed that "high-handed" actions by Karnataka had "hurt the sentiments" of the Marathispeaking people in the border districts at a time the matter was in the Supreme Court.

Karnataka-Maharashta border row escalated into violence after vehicles from both states were attacked and damaged in Belgaon and

Since its creation on May 1, 1960, Maharashtra has claimed that 865 villages, including Belgaon (now Belgavi), Karwar and Nippani, should be merged into Maharashtra. Karnataka, however, has refused to part with its territory.

The meeting came on a day the Maharashtra State Road Transport Corporation (MSRTC) partially resumed bus services to Karnataka from Kolhapur in southern Maharashtra after consulting local police authorities, an official said here.

The state-owned public transport body had suspended 382 out of 1,156 services to Karnataka, mainly between Kolhapur and Belagavi via ing people in an unjust manner.

## **Bad beginning**

The Veep should have better avoided criticism of the apex court in his Rajya Sabha speech

Jice-President Jagdeep Dhankhar has begun his tenure as Chairman of the Rajya Sabha with a combative note. In his maiden address in the Upper House, he expressed his displeasure over the fact that the National Judicial Appointments Commission (NJAC) Bill, unanimously passed by Parliament, was "undone by the Supreme Court." This was, according to him, a "severe compromise of parliamentary sovereignty and disregard of the mandate of the people." The remark was as uncharacteristic as it was avoidable. Uncharacteristic because when a person enters a high office, they prefer to say nice things and sound accommodative. Platitudes rather than barbed comments are heard on the first day. But it looks like Dhankhar is yet to shed his belligerence that he exhibited in Kolkata as West Bengal Governor. He became a thorn in Chief Minister Mamata Banerjee's side, incessantly slating her



government and its actions. It is widely believed that he has been rewarded for his bellicosity. At any rate, his elevation may have inspired other Governors to become more aggressive; one example is Kerala Governor Arif Mohammad Khan. But Dhankhar must realise that his statements will now be highlighted and scrutinised much more than they were earlier. He should have avoided criticism of the apex court in such strong words. He must remember that the executive, the legislature, and the judiciary are three integral organs of the system which have to work in tandem, not fight with each other.

This is not to say that the Supreme Court's decisions cannot or should not be criticised; they can

be and must be, for that is how a vibrant democracy functions. But the manner in which criticism is made is very important—more so when the person slamming an apex court verdict holds a Constitutional office, as Dhankhar does. Hinting that the top court of the land disregarded the mandate of the people was not just excessive but also in bad taste. We commented earlier that the Government's preference for the NJAC was justified. Three or half of the now disbanded NJAC comprised top judges only; two other members were also appointed in a manner in which government representation was in a minority. It looked like a reasonable system but the Supreme Court invalidated it in 2015. So, the collegium system continues. A few weeks ago, Law and Justice Minister Kiren Rijiju described the collegium system as "opaque." In fact, he claimed that a majority of judges agreed with him: "Judges are not happy with the collegium system today." He claimed that when judges select judges, there is politics. In fact, "the politics of us politicians is nothing to what goes on in the judiciary." By echoing the Government's position on an important issue, Dhankhar has not presented himself as an impartial Chairman of the Rajya Sabha who could hope to enjoy bipartisan support in the House. This is unfortunate.

## The ayurveda circle

Among ancient India's biggest gifts to the world,

we must embrace it emphatically first

nion Minister of State for Tourism Shripad Naik has rightly advocated the need for giving benefits of 'Avurveda' to the world. The 9th World Avurveda Congress is being organised by the World Ayurveda Foundation with support of the Union Ministry of AYUSH and Government of Goa. Prime Minister Narendra Modi will address the valedictory session on December 11. "It (Ayurveda) is not just medicine, it's our tradition. We need to give benefits of it to the world," he said. "Ayurveda has been facilitated by the setting up of a separate Ministry of AYUSH, credit of which goes to Modi" Naik added. He also said that the Modi government took Yoga to the world. And that is perhaps where he was off the mark. Indeed the AYUSH ministry was formed to give fillip to the alternative medicines especially Ayurveda but has it achieved its objective is rather questionable. More than 5,000 delegates and 200 delegates from

> 30 countries are attending the congress. Though conclaves like this do help, the minister and the government at large should understand that it takes more than just words to make a system popular. Equating it to Yoga would be wrong as Yoga was already popular in the west and the credit for that certainly does not go to the government.

The Ministry of AYUSH, is responsible for developing education, research and propagation of traditional medicine systems in India. The Department of Indian Systems of Medicine and Homeopathy (ISM&H) was made into a ministry by the Modi Government in 2014. But in its eight years there is hardly anything that AYUSH can be proud of. It start-

ed with much fanfare but has delivered nothing. It promised 100 AYUSH hospitals across the country were proposed, an Institute of Naturopathy in Pune at the cost of Rs 1,000 crore and posting 4,000 AYUSH practitioners across the country. Perhaps the AYUSH ministry can throw some light on the progress made. Somewhere the ministry lost its sense of direction and got embroiled in unnecessary controversies with its advisories which were not backed by scientific research. It failed to provide an infrastructure for alternative medicine and create awareness about the alternative medicines. The minister would do well to come up with a viable plan to provide facilities for the alternative medicines. Before that happens it would be just lip service to a great cause by the union ministers, nothing more.

## Common 'enemy No 1' is China



Our Asian neighbour, riding on the might of its economic muscle, doesn't mind being brazenly expansionist even at the cost of global peace

eorge Fernandes was perhaps the first Indian politician to call out the Chinese as 'enemy number one'. It had raised hackles, piqued debate and seen as a tad bit alarmist and premature, as the hyphenated relation with Pakistan was still consuming emotions. However, it didn't take long for the neologism of Zhongguo shiji or Chinese Century, to confirm George Fernandes's forewarning. The advent of Xi Jinping as the President of China in 2013 accelerated the portents of an expansionist and authoritarian Dragon that would threaten the peace of established global order. Back in the United States,

the erstwhile Soviet Union was the centrepiece of its military strategy till its implosion with the Revolutions of 1989. A brief run of the US as the solo hegemonic power in the 90s ensued. However, it was the George Bush administration which recognised the emerging realities with the Pacific Ocean emerging as the theatre of tensions and focus of deployment in Cold War 1.0.2, with China having supplanted the Soviet Union/Russia, as the primary enemy. Given the physical distance between the mainland of US and China, constraints of a viable and sustainable 'long-range power projection' became inevitable, and therefore the urgency for estab-lishing credible and strategic partnerships in the Indo-Pacific realm. This doctrinal evolution was the progenitor to the strategic conceptualisation of Sinocentric 'blocs' like QUAD (Quadrilateral – Japan, India, Australia and US) and *AUKUS* (Australia, UK and US), as indeed the 'Pivot to Asia' policy by the subsequent Obama Administration. Barack Obama was believed to have been sworn into the Oval Office as the 'first Pacific President'. But it was Donald Trump who transformed the US-China narrative into open hostility - Trump spoke of Chinese expansionism in the geopolitical and geo-eco-



ally calling Xi an 'enemy', escalating trade-wars, threatening Chinese allies like Pakistan and North Korea to even calling the Covid-19 virus as 'Chinese Virus', Trump opened the floodgates to China.

Incumbent Joe Biden administration has stayed the course on China and Biden himself described his conversation with Xi Jinping on the sidelines of the Group 20 summit at Bali as, 'very blunt with one another'. Even though it is the traditional cold war nemesis i.e., Russia, which is in a bloody conflict with the US-supported Ukraine, and is doing so in the midst of the earlier imagined theatre of Eastern Europe – US remains firm in holding the strategic view that it is China and not Russia (hence, Indo-Pacific theatre and not the European or the Middle Eastern region) that is going to be the 'enemy number one, going forward. Even the recently released 2022 China Military Power Report by the US Defense Department confirms China as, 'the most consequential and systemic challenge to the US national security and nomic realm that needed to be a free and open internationchecked, bluntly. From person- al system'. It went on to add

that Beijing was, 'the only competitor with the intent, and increasingly, the capacity to shape the international order. The dragon's intent is underscored by the fact that despite the crippling financial implications of the Covid pandemic, China has managed to double its nuclear arsenal to 400 from 200 warheads in 2020. Even their ballistic missile testing in 2021 has been more than the sum total testing done by the rest of the world!

Months earlier, the US Defense Department had released the 2022 National *Defense Strategy* where it had explicitly noted, 'The most comprehensive and serious challenge to US national security is the PRC's coercive and increasingly aggressive endeavor to refashion the Indo-Pacific region to suit its interests and authoritarian preferences.' Importantly for India, it had specifically covered the Indian concerns as the conflict on the Line of Actual Control (LAC) in the Summer of 2020 was one of the three specifically mentioned regions of concern, 'a broader pattern of destabilizing and coercive PKC benav ior that stretches across the East China Sea, the South

China Sea, and along the Line of Actual Control.

Today, the haunting commonality of China underwrites the brewing Indo-US equation, and they feel mutually comfortable and impelled enough to do joint Military Exercise a la Yudh Abhyas (literally, War Practice) in the near vicinity of the exact flashpoints which were wounded in the Indo-Chinese standoff, recently. Even differing responses on Ukraine, Pakistan or even unsettled trade issues between US and India have not stopped Joe Biden from describing India as 'indispensable partners' – and the indispensability of the said relationship is essentially cemented and predicated on the perceived threat perception from China. Towards the same, leniency of overlooking Delhi's legacy purchase of arms and oil from Russia, is par for course. Russia is a pale shadow of its past and China is the proverbial Dragon in the room for both Delhi and Washington DC to tame.



## **FIRST COLUMN DIGITAL NOMADISM: AN INSPIRATIONAL TREND**

Organisations should enter into agreements with nomads

usinesses have witnessed unprecedented trends during Covid times. One area that has seen a major revamp is the place of work for employees. The pandemic gave wings to an already fledgling idea of digital nomadism and changed employees' workstations forever.

Apart from the office, a digital nomad can work remotely from any place like a beach, a library or even a foreign country while traveling. According to a survey conducted by MBO Partners, this trend is fast rising. In the US alone, the number of digital nomads increased by 50 per cent to 11 million in 2020 and is expected to grow to a massive 35.7 million by 2025. It is interesting to note that the composition of this group changed from freelancers, independent consultants and entrepreneurs to regular, traditional, office goers with 9-5 work hours.

But who are these digital nomads? A research by Harvard Business Review finds that an average digital nomad is a digitally savvy, well-educated and highly skilled individual employed in tech industry, the creative arena, digital marketing and so on. Although digital nomadism became popular during the pandemic, this trend does not show any signs of slowing down. There are some ways in which employers can cater to this demand for flexible remote working facilities.



Firstly, the flexible policies that can provide freedom to employees can help companies attract talent. Many companies like Airbnb, 3M and Lift have taken cue and have developed and implemented adaptable remote working policies. The second most important requirement to promote digital nomadism is strong technological investments. To allow employees data access, many companies are using cloud-based technologies.

Thirdly, it is easier for companies with open office design concepts to step ahead and transform into a culture of digital nomadism. Although it is difficult for traditional companies with fixed 9-5 working hours and hierarchical seating arrangements to take a leap into remote working, companies which already open work spaces with different and new design elements like lounges, game rooms, project rooms and hotdesks, can help transition from flexible work style to nomadic work style.

So are companies in general ready with their policies to attract digital nomads? It is found that in spite of the growing trend of digital nomadism, only few organisations have formally designed policies for them. Therefore, digital nomads generally travel without their organisations knowing about it. In most cases, the immediate supervisor would have this information, but due to lack of concrete organisational policies would just turn a blind eye. However, this lack of clear policies can leave a firm open to any litigation or regulatory risks.

Generally, a person working in a particular location comes under the jurisdiction of that state/country, and the laws and regulations of the country apply to her irrespective of the location of the employer. So being present in another state or country, there is a possibility that digital nomads unintentionally end up creating the presence of the employer as a permanent establishment exposing it to an array of legal, regulatory, taxation laws and rules. Organisations should realise that the trend of digital nomadism is here to stay. To attract and retain employees, organisations should enter into agreements with digital nomads to clearly specify the terms and conditions of remote working.

Social media is playing an important role in the rise of digital nomadism. Owing to their strong social media presence, digital nomads communicate about their experiences through vlogs, blogs and Instagram accounts, making their lifestyle coveted. Although digital nomadism started out as a choice, it is more of an aspiration now. Organisations must adapt quickly and include the requirements of employees who want to enjoy being free to travel.

ndia's independence movement produced freedom fighters from a kaleidoscope of ideologies, from the radical left to the civilisational right. Why should the third generation leaders after independence abhor Hindu-right leaders of the freedom movement who suffered more than the most?

In Hindu thought, except the supreme Brahman even the manifested gods are not perfect, what to speak of humans. And freedom fighters like any human beings had their own follies and defects in their persona. Further, before the might of the State even the strongest break down. Many top leaders of all ideological shades too had at times cozied up to the colonial rulers to avoid adverse personal consequences. And as the British were most brutal to the freedom fighters from the Hindu-right, some of its leaders had to buckle to survive, for you can't fight war unless you are alive. Therefore, maligning them by selectively highlighting certain of their deeds out of context is both unfair and ungrateful.

In any case, what is it that we gain by vilifying those who fought for our freedom? Inexplicably, Vinayak Damodar Savarkar is the most prominent Hindu-right freedom fighter who remains the prime target of left-liberals. He was an atheist, a prolific writer, an ideologue, a powerful orator, and a firebrand revolutionary leader. He wrote 'The Indian War of Independence-1857' for its 50th anniversary and 'The Essentials of Hindutva' among many others. The British banned the former book even before it was published.

For waging war against the colonial government, the British sentenced him to 50 years of imprisonment and transportation for life. He was lodged in the infamous Cellular Jail in the Andamans. The punishment there was inhuman. It ranged from hard labour to extra hours on the grinding mill, to standing handcuffed for a week, to bar-fetters for six months, to confinement in solitary cells, to four days of starvation diet and to cross bars for 10 days, a punishment which compelled the

victim to keep his legs apart.
Savarkar endured all that inhuman torture for 11 long years, which others could not even imagine to be for 11 min-



utes. Based on his mercy petitions, AS OPPOSED TO which was a legal avenue available for all, he was shifted to Ratnagiri THE PRAGMATISM Jail and then released to be confined to only Ratnagiri district for OF HIS 15 years. With the waning of Communism in post 1980s, many leftists sneaked into Congress pastures, bringing their visceral hatred for anything Hindu, including Savarkar, and toxified minds of Congress leadership, including Rahul Gandhi. Their hidden agenda is to transform the Congress into a new Communist party.

For several decades the RSS-BJP used to loathe Gandhi, Nehru, and

several Congress leaders of freedom struggle, but it did not give them any political dividends. As they needed to deepen their political acceptability, they course-corrected and started appropriating leaders from other ideological streams. They built the world's tallest statue of Sardar Patel. They incorporated Gandhi and Ambedkar in their pantheon. They eulogise Indira Gandhi as Maa Durga.

They fete PV Narsimha Rao to gain cross political legitimacy for their own brand of reforms. They installed a statue of Bose under the India Gate canopy. After appropriating Swami Vivekananda, Tagore, Jaya Prakash Narayan, they are now even celebrating anti-Hindu Periyar and Jyotiba Phule. Sooner than later, they will also appropriate Nehru. The list is getting longer despite feeble protests of the Congress against BJP stealing their icons.

The results of the general elections, from 1951 to 2019, show that a party (not a coalition) could secure absolute majority only when Hindus consolidate for it. From never recover. 1951 to 1971, Hindus were solidly with the Congress for its inclusivity. Emergency distanced them but marginally. The dismal failure of the Janata Party experiment brought them back to the Congress in 1980. The last time Congress secured absolute majority was in 1984 as Hindus hugely consolidated in the wake of tragic assassination of prime minister Indira Gandhi.

Thereafter, it secured a near majority in 1991 due to Hindu consolidation in the phases of election

that took place after the terrible assassination of Rajiv Gandhi. The UPA rule from 2004 to 2014 badly alienated Hindus from the Congress as it was widely seen for the first time as anti-Hindu. As a result, Hindus massively rallied behind the BJP as never before, giving it absolute majority for the first time in its history in 2014 and repeated it in 2019. More importantly, the election data indicate that historically Hindus reposed faith in the Congress more than in any other party when it was centrist and not

anti-Hindu. Here is a lesson for the Congress. Prakash Karat is a top apparatchik of the Communist Party of India (Marxist) and was its national chief from 2005 to 2015. As opposed to the pragmatism of his predecessor Harkishen Singh Surjeet, Prakash Karat is extraordinarily rigid in ideology and virulently anti-Hindu and had no personal skin in the electoral game. No wonder, during his era the CPI(M) had the sharpest downfall from which it could

To recap, while on the one hand, Congress is losing its icons to the RSS-BJP, on the other its diatribe for no rhyme or reason against Hindu-right and historical pages 124 at 11 right and historical personalities like Savarkar is pushing Hindus away from it. Why is the Congress in selfdestructive mode?

Because the Congress leader-ship is in the intellectual grip of leftliberals, who have no skin in the electoral game. They are doing to the Congress what Prakash Karat did to the CPI(M).

## Highlight of COP27 was 'Loss and Damage Fund'

### Increasing climate risk around the globe requires a more strategic and broader approach to incorporate optimisation of consumption

→he 27th edition of the United Nations Climate L Change Conference or Conference of the Parties, COP27, concluded recently at Sharm El-Sheikh and made positive but limited progress.
The Egyptian COP27
Presidency has defined the

summit's four key goals. With mitigation, all parties, especially those in a position to "lead by example", are urged to take "bold and immediate actions" and to reduce emissions to limit global warming well below 2°C. With adaptation, parties have to ensure that COP27 makes the "crucially needed progress" towards enhancing climate change resilience and assisting the world's most

vulnerable communities. The goal of finance called

for making significant progress on climate finance, including the delivery of the promised \$100 billion per year to assist developing countries. With collaboration, the UN negotiations stuck to the consensusbased approach, as reaching an agreement will require "inclusive and active participation from all stakeholders".

Increasing climate risk requires a more strategic and broader approach to incorporate optimisation of consumption. Doing more with less, adopting circular economy principles and removing incentives for inefficient equipment, business models and lifestyles need to be at the forefront and centre of the

conversation. Inspiration needs to be drawn from the words of support most vulnerable

Mahatma Gandhi that "the world has enough for everyone's needs, but not everyone's greed". This applies not only to energy, but also conserving water, building materials, transportation, food and textiles. Definitive progress was made on the long-standing carbon market process, but many operational decisions were postponed for future negotiations.

Further, the negotiations remained confined to a relatively narrow agenda on fossil fuels and therefore missed the opportunity to comprehensively address all sources of GHGs.

While COP26 focused on mitigation, the highlight of COP27 was creation of the 'Loss and Damage Fund' to countries impacted severely climate disasters. Countries in Asia (India, Bangladesh, Vietnam, and Philippines), Africa (Kenya, Malawi, Chad, Niger), Pacific Islands (Fiji, Tuvalu, Kiribati) and Caribbean Islands (Haiti) are amongst the most vulnerable and impacted.

An area of particular attention is the inadequacy of current climate financing models. Global climate finance remains below the third of annual requirements. At COP27, negotiators deliberated on setting a 'new collective quantified goal on climate finance' in 2024, taking into account the needs and priorities of devel-

oping countries.
With millions of people in developing nations lacking access to reliable energy and

their energy requirements adds to the carbon emission.

Energy access will power the socio-economic aspirations of 2.8 billion people without electricity. For an equitable and inclusive green transition, a scaled-up and integrated approach is required to support the clean energy transition to distributed renewable energy and grid-based renewables and will reduce dependence on

Distributed renewable energy is relevant even for cities since they consume 60-80 per cent of energy and generate 70-75 per cent of GHG emissions. Hence, enabling energy transition will require significant effort in reforming

depending on fossil fuels for structure delivery. Technology convergence across electricity, telecom, and transport present newer opportunities for reducing carbon footprints, improving quality of life, reducing cost, and enhancing long-term sustainability. Underground utility systems, which are gaining global popularity, can be integrated with the master plans. Such an approach will require new regulations and institutional structuring to include energy as a part of urban planning. Thus, a strate-gic approach to urbanization presents a large opportunity, given a strong positive correlation between per capita

income and urbanisation. Last year, the Conference of Parties 26 (COP26) in Glasgow reiterated the global urban planning and infra- community's ongoing response

to the Paris Agreement to tackle the climate crisis while declaring a state of global emergency. The goal to achieve net-zero global emissions by 2050 while keeping the increase in global average temperature below 1.5 degrees Celsius in comparison to preindustrial levels was wellintentioned.

COP 27 balanced that with progress on adaptation and the creation of a loss and damage fund. Barbados Climate Envoy called the fund "a small victory for humankind". However, the overall ambition and, more importantly, action on all fronts need to be significantly and urgently scaled to achieve more significant victories in mitigating the global

## Winter of discontent for Russian troops

rith Russian troops digging trenches to prepare for an expected winter standoff, it would be easy to conclude that fighting will slow in Ukraine until after the ground thaws in the spring.

But evidence from the Ukrainian battlefields point to a different trajectory.

As a career US special forces officer who conducted field research on the 2008 and 2014 wars in Georgia and Ukraine, it is my view that this war has demonstrated that only one side, the Ukrainians, can execute effective combat maneuvers.

I believe that the Ukrainians will attempt to launch a largescale counteroffensive in late winter when the ground is still

The success of the counteroffensive showed that Ukraine's military was superior to Russia's in every category with the exception of size.

It had better doctrine, leaders, strategy, culture and will and it had just proved that it could effectively fight battles with a combination of artillery, tanks, soldiers and air attacks.

By September 12, 2022, Ukraine had liberated much of Kharkiv Oblast as Russian troops routinely fled from their

After liberating the entirety of Kharkiv Oblast in early Óctober 2022, Ukraine turned its attention to Kherson in the

This was a different fight, and in some ways Ukraine's military followed Chinese military strategist Sun Tzu's axiom of

"winning without fighting."

The Ukrainians were able to conquer much of the territory without using many troops on the ground.

Instead, Ukraine used longrange rockets supplied by the US and NATO allies to bombard Russian bases and supply lines that were previously unreach-

These attacks left Russian forces west of the Dnipro River in an untenable position.

Realizing this, Russia shockingly announced on November 9, 2022, that it was withdrawing from Kherson.

Two days later, Russia had completed its withdrawal from the west bank of the river.

WHAT TO EXPECT FROM RUSSIA

Over the course of the war, Russia has demonstrated little ability to conduct effective combat operations.

This is not something that Russia can change overnight or over the course of the winter.

Russia's best forces have been decimated throughout the conflict, and it is now increasingly relying on untrained conscripts. Likewise, Russia is exhausting much of its weaponry as international sanctions against them are limiting Russia's wartime production. Aside from Iran, few nations are providing military aid to Russia.

Russia's military is now less trained, has lower morale, and has significantly fewer weapons and less ammunition than it had at the beginning of the current

As a result, Russia lacks the ability to conduct large-scale attacks, and it is left with little option but to continue what it has been doing: conducting missile strikes against targets that are either defenceless or offer little strategic value.

Limiting Russia's options further, these strikes have been less effective as the war has progressed.

Early in the war, most of Russia's missiles made it through Ukraine's limited air defences.

With the help of western air defence systems, Ukraine was shooting down 50 per cent of Russian missiles in October and is now intercepting over 80 per cent of them. Winter should not affect these types of combat operations.

But snow will have an impact on Russia's already stressed and under-performing logistical system, and the cold will further lower - if that is possible - the already low morale of Russia's poorly outfitted and undertrained soldiers

WHAT TO EXPECT FROM **UKRAINE** 

As the smaller military, Ukraine cannot afford to take

Thus far, it has used a strategy of defending territory when it could, retreating when it should to preserve combat power, and attacking when the opportunities have presented themselves.

Ukraine effectively employed this strategy to defend Kyiv in the first month of the war and during the September 2022 counteroffensive to reclaim the Kharkiv and Kherson oblasts.

six months for Úkraine to

launch its counteroffensive? One reason is that Ukraine had to wait several months for promised Western aid to arrive

at its bases. In my view, a significant factor is the lengthy amount of time it takes to plan large counteroffensives and to position supplies, equipment and forces.

The fact that Ukraine conducted the counterattacks in succession suggests that Ukraine lacks the combat power to conduct two large-scale counterat-

tacks at the same time. Ukraine is going to need time to regroup, refit and plan for its next large-scale operation.

Thus, it seems reasonable that Ukraine will have to wait at least 30 to 45 days - maybe more - before it is ready to execute its next counteroffensive, which would be in the heart of winter.

While conducting an attack in winter may be difficult, offroad movement in the spring could become impossible, as the Russians discovered during their initial invasion in muddy and wet terrain.

It seems reasonable to conclude that Ukraine may wish to initiate its next counteroffensive while the ground is still frozen - and Russian troop morale is at its lowest point since the inva-

#### Bulgarian parliament OK's military aid to Ukraine

m ulgarian}$  lawmakers on Friday approved the country's first military assistance package to Ukraine involving a classified list of weapons prepared by the government.

The National Assembly voted 148-46 with one abstention in favor of the weapons to Kyiv following months of political squabbling on the issue in the Balkan NATO member state.

Bulgaria previously agreed to repair Ukrainian military equipment at its factories but refused to send weapons directly due to opposition from President Rumen Radev and the country's Moscow-friendly political parties. Along with Hungary, Bulgaria was the only European Union member country to initially refuse to give Ukraine weapons following Russia's invasion.

## US sending \$275 million in military aid to Ukraine package of aid includes 80,000

The US is sending an additional USD 275 million in military aid to Ukraine, including large amounts of ammunition and high-tech systems that can be used to detect and counter drones in its ongoing war with Russia, according to US

The total aid amount is packages the US has delivered, and it comes as many military officials and experts predict a reduction in attacks during the winter. NATO Secretary-General Jens Stoltenberg said Russia appears to be slowing its military activities to regroup and launch a new offensive when the weather warms.

The officials said the latest

It also includes systems to counter drones and air defences, along with more HUMVEES, generators and other combat equipment. Including the latest aid, the US has now committed more than USD 19.3 billion in weapons and other equipment to Ukraine since Russia attacked on February 24. The aid will be provided through presidential drawdown authority, which allows the Pentagon to take weapons from its own stocks and quickly ship them to Ukraine.

## **US** keeps eye on China's space activities for potential risks

¬he US is closely monitoring Chinese activities that L potentially threaten American assets in space as debris rapidly accumulates in low Earth orbit, the head of United States military operations in space said Friday.

Commander of US Space Command Army Gen. James Dickinson also cheered the overwhelming passage in the United Nations of a resolution that countries not conduct directascent antisatellite tests that create vast fields of space debris which endanger satellites and space stations.

Of the four countries that have conducted such ASAT tests, the United States was the only one that voted in favour, while China and Russia voted no and India abstained.

"We can't continue to contribute to the debris that we find in the space domain," Dickinson said in a telephone news conference with reporters in Asia. Most of that debris lies in crucial low Earth orbit, which has become "congested, competitive and contested," he said.

Even tiny shards of metal can pose a danger and the number of objects is growing ram-



Space Command is now tracking more than 48,000 in near Earth orbit, including satellites, telescopes, space stations and pieces of debris of all sizes, up from 25,000 just three years ago, Dickinson said.

China in 2003 became the third government to send an astronaut into orbit on its own after the former Soviet Union and the United States. Its program has advanced steadily

The Chinese space program drew rare international criticism after it conducted an unannounced test in 2007 in which it used a missile to blow up a defunct Chinese satellite, creating debris that continues to

The House gave final approval ■ Thursday to legislation protecting same-sex marriages, a monumental step in a decadeslong battle for nationwide recognition that reflects a stark turnaround in societal attitudes.

President Ioe Biden has said he will promptly sign the measure, which requires all states to recognise same-sex marriages. It is a relief for hundreds of thousands of couples who have married since the Supreme Court's 2015 decision that legalised those marriages and have worried about what would happen if the ruling were overturned.

In a statement after the vote, Biden called the legislation a "critical step to ensure that Americans have the right to marry the person they love." He said the legislation provides "hope and dignity to millions of young people across this country who can grow up knowing that their government will recognise and respect the families they build."

The bipartisan legislation, which passed 258-169 with 39 Republican votes, would also protect interracial unions by requiring states to recognise legal marriages regardless of "sex, race, ethnicity, or national origin." After months of negotiations, the Senate passed the bill

The bill is "a glorious triumph of love and freedom," Pelosi said, tearing up as she celebrated its passage.

In debate before the vote, several gay members of Congress talked about what a federal law would mean for them and their families. Rep. Mark Pocan, D-Wis., said he and his husband should be able to visit each other in the hospital just like any other married couple and receive spousal benefits "regardless of if your spouse's name is Samuel or Samantha."

Rep. Chris Pappas, D-N.H., said he was set to marry "the love of my life" next year and it is "unthinkable" that his marriage might not be recognised in some states if Obergefell were to be overturned.

## Ministries seized of duty structure issue: Niti VC

Niti Aayog Vice Chairperson Suman Bery on Friday said the Finance and Commerce Ministries are seized of the matter related to inverted duty structure, but did not elaborate pointing out that the next Union Budget was round the corner.

Finance Minister Nirmala Sitharaman will announce the tax proposals in the Union Budget 2023-24 which is scheduled to be presented to the Lok Sabha on February 1.

Replying to queries during the CII Global Economic Policy Summit 2022 here, Bery said Niti Aayog has been doing "some internal work" on the issue of inverted duty structures. Also, both the finance ministry and the commerce ministry are seized of the issue, he added.

"But you know, since we are approaching budget time, I don't want a headline that promises that this is going to be, you know, on the agenda. So I just say I hear you and I will take it back," the Niti

Aayog Vice Chairperson said.
Inverted duty structure
refers to taxation of inputs at
higher rates than finished products that results in build-up of credits and cascading costs.

Rising crude oil prices and relentless foreign capital out-flows further weighed on sentiment, traders said. The 30-share BSE Sensex

opened strong but came under severe selling pressure to close 389.01 points or 0.62 per cent lower at 62,181.67. Similarly, the broader NSE Nifty declined 112.75 points or 0.61 per cent to 18,496.60.

HCL Tech was the top loser in the Sensex pack, skidding 6.72 per cent, followed by Tech Mahindra, Infosys, Wipro, TCS and Reliance Industries.

On the other hand, Nestle India, Titan, Sun Pharma, Dr Reddy's, IndusInd Bank and ITC were among the gainers, advancing up to 2.24 per cent.
"Today's downfall in the

domestic market was sparked by IT stocks extending their losses after warning of a potential slowdown in business on global recession fears. This was further aggravated by banks losing their grip as PSBs suffered heavy sell-offs.

"However, global bourses were largely positive, although

## Sensex surrenders Inflows via mutual funds SIP hit fresh high at ₹13,306 cr in Nov

m lows}$  in the mutual fund industry through systematic investment plans or SIPs route rose to an all-time high of ₹13,306 crore in November, reflecting the growing maturity and confidence of investors.

However, inflows in equity mutual fund schemes plunged 76 per cent to ₹2,258 crore in November from Rs 9,390 crore in the preceding month, data released by the Association of Mutual Funds in India (Amfi) showed on Friday.

This was also the 21st straight month of inflows into equity schemes.

As per the data, flows through SIP was ₹13,306 crore in November, surpassing the previous high of ₹13,041 crore in October.

The inflows through SIPs have been above the ₹12,000crore mark since May. It was ₹12,976 crore in September, ₹12,693 crore in August, ₹12,140 crore in July, ₹12,276 crore in June and ₹12,286 crore in May. Before that, it stood at ₹11,863 crore in April.

With this, the total inflow has reached ₹87,275 crore in the first eight months of the current fiscal. This came following an inflow of over ₹ 1.24 lakh crore in the 2021-22 financial year.

The healthiest trend in the Indian equity market now is the steady increase in SIPs, which have touched a new record of



is a proven fact that SIPs are the most successful mode of investment for retail investors," VK Vijayakumar, Chief Investment Strategist at Geojit Financial Services, said. Increasing SIPs shows that

Indian equity investors are maturing, Vijayakumar said and suggested that SIP investors should not discontinue their investment when markets correct sharply.

S Ranganathan, Head of Research at LKP Securities, noted that foreign investors have been booking profits but domestic flows through SIPs are at lifetime highs, which reflects the growing maturity and confidence of the domestic investors.

## Sebi clarifies on 'schemes of arrangement' for entities with listed debt securities

PTI ■ NEW DELHI

apital markets regulator Sebi on Friday clarified on the framework pertaining to 'schemes of arrangement' for entities that have only listed their debt securities.

Scheme of arrangement is a court-approved agreement between a company and its shareholders or creditors.

Sebi, in November, had put in place operational guidelines pertaining to "scheme of arrangement" by entities who have listed their debt securities non-convertible debentures (NCDs) or non-convertible redeemable preference shares (NCRPS).

Under this, the entity that has listed NCDs or NCRPS and



which intends to undertake a scheme of arrangement or is involved in a scheme of arrangement would file the draft scheme with stock exchanges for obtaining a noobjection letter, before filing such scheme with any court or tribunal.

Further, the exchange would have to forward such draft schemes to the Securities and Exchange Board of India.

Sebi clarified that the operational guidelines issued in November would not apply to a scheme of arrangement which solely provides for an arrangement between a debt

listed entity and its unlisted wholly-owned subsidiary. However, such debt listed

entity would file the draft

scheme of arrangement with stock exchanges for the purpose of disclosure. Besides, stock exchanges would disseminate the scheme documents on their websites. Earlier, the regulator had

amended rules with respect to scheme of arrangement, involving merger, amalgamation among others, by entities who have listed their non-convertible debt securities or non-convertible redeemable preference


